Upper bounds for dynamic chromatic number of graphs in terms of the independent number

Abstract

A dynamic coloring of a graph G is a proper coloring such that for every vertex $v \in V(G)$ of degree at least 2, the neighbors of v receive at least 2 colors. In this paper we present some upper bounds for the dynamic chromatic number of graphs. We shall show that if G is an *r*-regular graph, then $\chi_2(G) \leq \chi(G) + 2\lfloor \log_2^{\alpha(G)} \rfloor + 3$ and if G is a graph and $\Delta(G) \leq 2^{\frac{\delta(G)-3}{2}}$, then $\chi_2(G) \leq \chi(G) + 2\lfloor \log \frac{\alpha(G)}{2\Delta(G) - \delta(G)} \rfloor + 3$ and in general case if G is a graph, then $\chi_2(G) \leq$ $\chi(G) + \alpha(G) + 1.$

1 Introduction

All graphs in this paper are finite, undirected and simple. We follow the notation and terminology of [\[6\]](#page-7-0). A proper vertex coloring of G by k colors is a function $c: V(G) \longrightarrow \{1, \ldots, k\}$, with this property: if $u, v \in V(G)$ are adjacent, then $c(u)$ and $c(v)$ are different. A vertex k-coloring is a proper vertex coloring by k colors. A proper vertex k-coloring of a graph G is called dynamic if for every vertex v with degree at least 2, the neighbors of v receive at least two different colors. The smallest integer k such that G has a dynamic k-coloring is called the *dynamic chromatic number* of G and denoted by $\chi_2(G)$. We denote a bipartite graph G with bipartition (X, Y) by $G[X, Y]$. Let G is a graph with a proper vertex coloring c. For every $v \in V(G)$, we denote the degree of v in G, the neighbor set of v and the color of v by $d(v)$, $N(v)$, and $c(v)$, respectively. For any $S \subseteq V(G)$, $N(S)$ denote the set of vertices of G, such that each of them has at least one neighbour in S. If c be a proper vertex coloring of a graph G, B_c is the set of vertices such that for each vertex $v \in B_c$, $d(v) \geq 2$ and the neighbors of v receive same color. Let $A_c = V(G) \backslash B_c$.

The following interesting conjecture was posed on the dynamic chromatic number of regular graphs.

Conjecture 1. [\[5\]](#page-7-1) For any r-regular graph G , $\chi_2(G) - \chi(G) \leq 2$.

It was shown [\[1\]](#page-7-2) that, if G is an regular graph, then $\chi_2 \leq \chi(G) + \lceil \frac{\alpha(G)}{2} \rceil + 1$, we prove that if G is an r-regular graph, then $\chi_2 \leq \chi(G) + 2\lfloor \log_2^{\alpha(G)} \rfloor + 3$ and if G is a graph and $\Delta(G) \leq 2^{\frac{\delta(G)-3}{2}}$, then $\chi_2(G) \leq \chi(G) + 2\lfloor \log \frac{\alpha(G)}{2\Delta(G) - \delta(G)} \rfloor + 3$ and in general case if G is a simple graph, then $\chi_2(G) \leq$ $\chi(G) + \alpha(G) + 1.$

It was shown [\[3\]](#page-7-3) that, if G is a claw-free graph, then $\chi_2(G) \leq \chi(G) + 2$. For every graph H on exactly four vertices, if G is an H-free graph, we study the upper bound of $\chi_2(G) - \chi(G)$.

Now we state some lemmas and theorem without proof.

Theorem 1. [\[4\]](#page-7-4) For a connected graph G if $\Delta(G) \leq 3$, then $\chi_2(G) \leq 4$ unless $G = C_5$, in which case $\chi_2(C_5) = 5$ and if $\Delta(G) \geq 4$, then $\chi_2(G) \leq \Delta(G) + 1$.

So if $\Delta(G) \leq 3$, then $\chi_2(G) \leq 5$.

Lemma 1. [The Lovasz Local Lemma [\[2\]](#page-7-5)] Suppose A_1, \ldots, A_n be a set of random events such that for each i, $Pr(A_i) \leq p$ and A_i is mutually independent of the set of all but at most d other events. If $4pd \leq 1$, then with positive probability, none of the events occur.

Lemma 2. [\[1\]](#page-7-2) Let $r \geq 4$ be a natural number. Suppose that $G[A, B]$ is a bipartite graph such that all vertices of Part A have degree r and all vertices of Part B have degree at most r. Then one can color the vertices of Part B with two colors such that the dynamic property holds for all vertices of Part A.

Lemma 3. [\[6\]](#page-7-0) Any maximal independent set in a graph G is a dominating set.

So if G is a graph, then G has an independent dominating set T .

2 Results

Before proving theorems we need to prove some lemmas.

Lemma 4. If G is a graph, $G \neq K_n$ and T_1 is an independent set of G, then there exists T_2 such that, T_2 is an independent dominating set for T_1 and $|T_1 \cap T_2| \leq \frac{2\Delta(G) - \delta(G)}{2\Delta(G)}|T_1|$.

Proof. For each $u \in N(T_1)$, define $f(u)$ as the number of vertices which are adjacent to u and are in T_1 . $\sum_{u \in N(T_1)} f(u)$ is the number of edges of $G[T_1, N(T_1)]$, so $\sum_{u \in N(T_1)} f(u) \geq |T_1| \delta(G)$.

Let $T_3 = T_1$, $T_4 = \emptyset$, $s = 0$, $i = 1$ and repeat the following procedure until $\sum_{u \in N(T_1)} f(u) = 0$.

Step 1. Select a vertex u such that $f(u)$ is maximum among $\{f(v)|v \in N(T_1)\}\$ and add u to the set T_4 and let $t_i = f(u)$.

Step 2. For each $v \in N(T_1)$ that is adjacent to u, change the value of $f(v)$ to 0. Change the value of $f(u)$ to 0.

Step 3. For each $v \in N(T_1)$ that is adjacent to at least one vertex of $N(u) \cap T_3$ and it is not adjacent to u, decrease $f(v)$ by the number of common neighbours of v and u in T_3 .

Step 4. Remove the elements of $N(u)$ from T_3 . Increase s by t_i and i by 1.

When the above procedure terminates, because of the steps 1 and 2, T_4 is an independent set and because of the steps 1 and 4, T_4 is a dominating set for $T_1\backslash T_3$. Now let $T_2 = T_4 \cup T_3$, because of the step 4, T_2 is an independent dominating set for T_1 .

Assume that the above procedure has l iterations. Because of the step 4, we have $s = \sum_{i=1}^{l} t_i$. Each vertex in $N(T_1)$ has at most $\Delta(G)-1$ neighbours in $N(T_1)$, so in the step 2 of the *i*th iteration, $\sum_{u\in N(T_1)} f(u)$ is decreased at most $t_i\Delta(G)$ and in the step 3 of the *i*th iteration, $\sum_{u\in N(T_1)} f(u)$ is decreased at most $t_i\Delta(G)$, so in the *i*th iteration, $\sum_{u\in N(T_1)} f(u)$ is decreased at most $2t_i\Delta(G)$. When the procedure terminates, $\sum_{u \in N(T_1)} f(u) = 0$, so:

\delta(G)|T_1| - \sum_{i=1}^{i=l} (2t_i \Delta(G)) \le 0,
$$

\delta(G)|T_1| - 2s\Delta(G) \le 0,

s \ge \frac{\delta(G)}{2\Delta(G)}|T_1|,

|T_1 \cap T_2| = |T_3| = |T_1| - s \le \frac{2\Delta(G) - \delta(G)}{2\Delta(G)}|T_1|.

Lemma 5. If G is a graph, $\Delta(G) \leq 2^{\frac{\delta(G)-3}{2}}$ and T is an independent set of G, then we can color the vertices of T with two colors such that for each $u \in \{v|v \in V(G), N(v) \subseteq T\}$, u has two different colors in $N(u)$.

Proof. Color every vertex of T randomly and independently by color red with a probability $\frac{1}{2}$ and by color *blue* with a probability $\frac{1}{2}$. For each $u \in \{v|v \in V(G), N(v) \subseteq T\}$, let A_u be the event that, u has not two different colors in $N(u)$.

Each A_u is mutually independent of a set of all A_v events but at most Δ^2 of them. Clearly, $Pr(A_u) \leq \frac{1}{2^{\delta-1}}$. By Local Lemma we have:

$$
4pd = 4\left(\frac{1}{2}\right)^{\delta - 1} \Delta^2 \le 1.
$$

So there exists a coloring with our condition for T with positive probability.

Lemma 6. Let c be a vertex k-coloring of a graph G , then there exists a dynamic coloring of G with at most $k + |B_c|$ colors.

Proof. Suppose that $B_c = \{v_1, \ldots, v_{|B_c|}\}.$ For each $1 \leq i \leq |B_c|$ select $u_i \in N(v_i)$ and recolor u_i by color $k + i$, respectively. The result is a dynamic coloring of G with at most $k + |B_c|$ colors.

Theorem 2. If G is a graph and $\Delta(G) \leq 2^{\frac{\delta(G)-3}{2}}$, then $\chi_2(G) \leq \chi(G) + 2\lfloor \log_{\frac{2\Delta(G)}{2\Delta(G)-\delta(G)}}^{ \alpha(G)} \rfloor + 3$.

Proof. Let $k = \lfloor \log \frac{\alpha(G)}{2\Delta(G)-\delta(G)} \rfloor + 1$. By Lemma 3, let T_1 be an independent dominating set for G. Consider the vertex $\chi(G)$ -coloring of G, by Lemma 5, recolor the vertices of T_1 by colors $\chi + 1$, $\chi + 2$ and obtain a coloring c_1 such that $B_{c_1} \subseteq T_1$.

Let $T_1' = T_1$. For $i = 2$ to $i = k$ repeat the following procedure:

Step 1. By Lemma 4, find an independent set T_i such that, T_i is an independent dominating set for T'_{i-1} and $|T_i \cap T'_{i-1}| \leq \frac{2\Delta(G) - \delta(G)}{2\Delta(G)} |T'_{i-1}|.$

Step 2. By Lemma 5, recolor the vertices of T_i with colors $\chi + 2i - 1$ and $\chi + 2i$ such that for each $u \in \{v|v \in V(G), N(v) \subseteq T_i\}$, u has two different colors in $N(u)$.

Step 3. Let $T'_i = T_i \cap T'_{i-1}$.

After each iteration of above procedure we obtain a proper coloring c_i , such that $B_{c_i} \subseteq T'_i$, so when the procedure terminates, we have a coloring c_k with at most $\chi(G) + 2\lfloor \log \frac{\alpha(G)}{2\Delta(G) - \delta(G)} \rfloor + 2$ colors, such that $B_{c_k} \subseteq T'_k$ and $|T'_k| \leq 1$, so by Lemma 6, we have a dynamic coloring with at most $\chi(G) + 2\lfloor \log_{\frac{2\Delta(G)}{2\Delta(G)-\delta(G)}}^{\alpha(G)} \rfloor + 3$ colors.

Theorem 3. If G is an r-regular graph, then $\chi_2(G) \leq \chi(G) + 2\lfloor \log_2^{\alpha(G)} \rfloor + 3$.

Proof. If $r = 0$, then the theorem is obvious. For $1 \le r \le 3$, we have $\chi(G) \ge 2$, by Theorem 1, $\chi_2(G) \leq 5$ so $\chi_2(G) \leq \chi(G) + 3$.

So assume that $r \geq 4$, we use a proof similar to the proof of Theorem 2, in the proof of Theorem 2, for each i, $1 \leq i \leq k$, we used Lemma 5, to recolor the vertices of T_i with colors $\chi + 2i - 1$ and $\chi + 2i$ such that for each $u \in \{v|v \in V(G), N(v) \subseteq T_i\}$, u has two different colors in $N(u)$. In the new proof, for each i, $1 \leq i \leq k$, let $A = \{v|v \in V(G), N(v) \subseteq T_i\}$ and $B = T_i$ and by Lemma 2, recolor the vertices of T_i with colors $\chi + 2i - 1$ and $\chi + 2i$ such that for each $u \in \{v|v \in V(G), N(v) \subseteq T_i\}, u$ has two different colors in $N(u)$. The other parts of the proof are similar. This completes the proof.

Before proving next theorem we need to define some notations. Suppose c is a proper vertex coloring of G, let $H_c = G[B_c], X_c$ is the set of isolated vertices in $H_c, Y_c = G[B_c \backslash X_c].$

Lemma 7. If c is a proper vertex coloring of G, then H_c is a bipartite graph.

Proof. Since the vertices of H_c are in B_c , so H_c has at most 2 different colors in each of it's connectivity components, so H_c is a bipartite graph.

Theorem 4. If G is a simple graph, then $\chi_2(G) \leq \chi(G) + \alpha(G) + 1$.

Proof. For $\chi(G) = 1$ the theorem is obvious and if $\chi(G) = 2$, then $\Delta(G) \leq \alpha(G)$ so by Theorem $1, \chi_2(G) \leq \Delta(G) + 2 \leq \alpha(G) + \chi(G)$. If $\alpha(G) = 1$, then $\chi_2(G) = \chi(G)$.

Suppose that G is the connected graph, otherwise we apply the following proof for each of it's connectivity components and also suppose $\chi(G) \geq 3$ and $\alpha(G) \geq 2$. Let c be a vertex $\chi(G)$ -coloring of G, such that $|B_c|$ is minimum. Every vertex in B_c has a neighbour in A_c , otherwise there exists $v \in B_c$ such that $N(v) \subseteq B_c$, then because $\chi(G) \geq 3$, by changing the color of v decrease the size of B_c .

Now, two cases can be considered:

Case 1. $Y_c = \emptyset$. In this case we have $B_c = X_c$. Since the vertices of X_c is an independent set, so $|X_c| \leq \alpha(G)$. By Lemma 6, there exists a dynamic coloring with $\chi(G) + \alpha(G)$ colors.

Case 2. $Y_c \neq \emptyset$. Let $T_c = \{v \in A_c \mid N(v) \subseteq Y_c\}$. Clearly $T_c \cup X_c$ is an independent set. Since $Y_c \subseteq H_c$ and by Lemma 7, Y_c is a bipartite graph. Properly color the vertices of Y_c by colors $\chi + 1$, $\chi + 2$ and retain the color of other vertices and name this coloring c'. Clearly $Y_{c'} \subseteq Y_c$. Since every vertex of Y_c has at least one neighbour in A_c and one neighbour in Y_c , so Y_c are the subset of $A_{c'}$. So $Y_{c'} = \emptyset$ and $X_{c'} \subseteq T_c \cup X_c$. If $|X_{c'}| = 1$, then the theorem is obvious, so assume $|X_{c'}| \geq 1$. Let $v \in X_{c'}$. Now we have two situations:

Case 2A. $N(v) \cap N(X_{c} \setminus \{v\}) = \emptyset$. So $N(v) \cup X_{c'} \setminus \{v\}$ is the independent set. So $|N(v) \cup X_{c'} \setminus \{v\}|$ $\{v\} \leq \alpha(G)$. Since $|N(v)| \geq 2$, $|X_{c'}| \leq \alpha(G) - 1$. By Lemma 6, there exists a dynamic coloring with $\chi(G) + 2 + (\alpha(G) - 1)$ colors.

Case 2B. $N(v) \cap N(X_{c'} \setminus \{v\}) \neq \emptyset$. Therefore there exists a vertex $u \in X_{c'}$ such that $N(v) \cap$ $N(u) \neq \emptyset$. Color one of the common neighbours of v and u, with color $\chi + 3$ and retain the color of other vertices and name this coloring c'' . Clearly $B_{c''} \subseteq X_{c'} \setminus \{v, u\}$. $|B_{c''}| \leq |X_{c'} \setminus \{v, u\}| \leq$ $\alpha(G) - 2$. By Lemma 6, there exists a dynamic coloring with $\chi(G) + 3 + (\alpha(G) - 2)$ colors.

Proposition 1 There exist an infinite number of graphs such that $\chi_2(G) = \chi(G) + \alpha(G) - 1$.

Proof. For each n, consider the graph G_n derived from K_{2n} by replacing the edges of a perfect matching with P₃. We have: $\alpha(G_n) = n + 1$, $\chi(G_n) = n$, $\chi_2(G_n) = 2n$, so $\chi_2(G_n) = \chi(G_n) +$ $\alpha(G_n)-1$.

Theorem 5. Let G is a connected graph. Each of the following holds (Figure 1).

(i) If G is an H₁-free graph, then $\chi_2(G) \leq \chi(G) + 4$.

(ii) If G is an H_2 -free graph, then $\chi_2(G) \leq \chi(G) + 6$.

(iii) If G is an H₃-free graph, then $\chi_2(G) \leq \chi(G) + 3$.

- (iv) If G is an H₄-free graph, then $\chi_2(G) \leq \chi(G) + 2$.
- (v) If G is an H₅-free graph, then $\chi_2(G) \leq \chi(G) + 2$.

(vi) If H is a graph, $|V(H)| = 4$ and $H \notin \{H_1, H_2, H_3, H_4, H_5\}$, then for each constant c, there exists a graph G that is an H-free and $\chi_2(G) - \chi(G) \geq c$.

Proof. (i) Since G is H_1 -free, we have $\alpha(G) \leq 3$, by Theorem 4, $\chi_2(G) \leq \chi(G) + 4$.

 (ii) If G has no edge, then the theorem is obvious. Assume G has at least one edge and T is a minimum independent dominating set. We have $|T| \leq 3$, otherwise assume that $|T| \geq 4$, we have $G\setminus T\neq\emptyset$ because G has at least one edge and for each $v\in G\setminus T$, v is adjacent to at least $|T| - 1$ members of T, because G is an H_2 -free, now assume that $u, w \in T$ and $v \in G\backslash T$, and $vu, vw \in E(G)$ define $T' = \{v\} \cup T \setminus \{u, w\}, T'$ is an independent dominating set and $|T'| = |T| - 1$. Properly color the vertices of $G \setminus T$ by $\chi(G)$ colors and color the vertices of T with 3 different new colors. Now we have the coloring c with $\chi(G) + 3$ colors such that $B_c \subseteq T$. By Lemma 6, we have $\chi_2(G) \le (\chi(G) + 3) + 3.$

(iii) If each vertices $v \in V(G)$ is in a triangle or $d(v) \leq 1$, then $\chi_2(G) = \chi(G)$, so assume that $v \in V(G)$ and $N(v)$ is the independent set and $u, w \in N(v)$. The distance of any vertex of G from v is at most 2, otherwise the vertex with distance more than 2 from v and $\{v, u, w\}$ form an H_3 . So we have $G = \{v\} \cup N(v) \cup N(N(v))$. Since G is an H_3 -free, for each $x \in N(N(v))$ we have $xu \in E(G)$ or $xw \in E(G)$. $T = \{v, u, w\}$ is the dominating set. Let c be a vertex $\chi(G)$ -coloring of G. Define the vertex coloring c' :

$$
c': V(G) \longrightarrow \{1, \ldots, \chi + 3\},\
$$

$$
c'(z) = \begin{cases} c(z) & \text{if } z \notin T, \\ \chi + 1 & \text{if } z = v, \\ \chi + 2 & \text{if } z = u, \\ \chi + 3 & \text{if } z = w. \end{cases}
$$

 c' is the dynamic coloring of G .

(iv) If each vertices $v \in V(G)$ is in a triangle or $d(v) \leq 1$, then $\chi_2(G) = \chi(G)$, so assume that $v \in V(G)$ such that $N(v)$ is the independent set and $u, w \in N(v)$. The diameter of G is at most 2 and for each $x \in N(N(v))$ we have $xu \in E(G)$, otherwise G has an H_4 as an induced subgraph. So $T = \{v, u\}$ is the dominating set. Let c be a vertex $\chi(G)$ -coloring of G. Define the vertex coloring c^{\prime} :

$$
c': V(G) \longrightarrow \{1, \dots, \chi + 2\},
$$

$$
c'(z) = \begin{cases} c(z) & \text{if } z \notin T, \\ \chi + 1 & \text{if } z = v, \\ \chi + 2 & \text{if } z = u. \end{cases}
$$

 c' is the dynamic coloring of G .

 (v) Proved in [\[3\]](#page-7-3).

(*vi*) If $H = H_6$, for each *n*, consider the connected graph G_n derived from K_{2n} by replacing the edges of a perfect matching with P_3 . G_n is H_6 -free, $\chi(G_n) = n$ and $\chi_2(G_n) = 2n$.

If $H \neq H_6$, let $G_n[X, Y]$ be a bipartite graph such that:

 $V(X) = \{v_1, v_2, v_3, \ldots, v_n\}, V(Y) = \{u_{i,j}|1 \leq i < j \leq n\},\$

 $E(G) = \{v_i u_{p,q} | i = p \text{ or } i = q\}.$

 $G_n[X, Y]$ is an H-free, connected and we have: $\chi(G) = 2$ and $\chi_2(G) \geq n$.

3 Concluding remarks and open problems

In Lemma 4 we proved if T_1 is an independent set for a graph G , then there exists T_2 such that, T_2 is an independent dominating set for T_1 and $|T_1 \cap T_2| \leq \frac{2\Delta(G) - \delta(G)}{2\Delta(G)}|T_1|$. Finding the optimal upper bound for $|T_1 \cap T_2|$ seems to be an intriguing open problem, we do conjecture the following:

Conjecture 2. There is a constant C such that for every r-regular graph with $r \neq 0$, if T_1 is an independent set, then there exists an independent dominating set T_2 for T_1 such that $|T_1 \cap T_2| \leq C$.

Theorem 6. If Conjecture 2 is true, then there is a constant C_1 such that for every r-regular graph G , $\chi_2(G) - \chi(G) \leq C_1$.

Proof. If $r \leq 3$, then by Theorem 1, $\chi_2(G) - \chi(G) \leq \chi_2(G) - 1 \leq 4$.

So, we can assume that $r \geq 4$. Consider a vertex $\chi(G)$ -coloring of G, by Lemma 3, let T_1 be an independent dominating set for G. By Lemma 2, recolor the vertices of T_1 by colors $\chi + 1$, $\chi + 2$ and retain the color of other vertices, name this coloring c. B_c is the independent set, by Conjecture 2, there is a constant C such that there exists an independent dominating set T_2 for T_1 and $|T_1 \cap T_2| \leq C$, by Lemma 2, recolor the vertices of T_2 by colors $\chi + 3$, $\chi + 4$ and retain the color of other vertices and name it c' . $|B_{c'}| \leq C$, so by Lemma 6, there exists a dynamic coloring with at most $\chi(G) + 4 + C$ colors. Let $C_1 = C + 4$, this completes the proof.

In Theorem 4 we proved if G is a simple graph, then $\chi_2(G) \leq \chi(G) + \alpha(G) + 1$ and in Proposition 1 we present an infinite number of graphs such that $\chi_2(G) = \chi(G) + \alpha(G) - 1$. For $G = C_4, C_5$, we have $\chi_2(G) = \chi(G) + \alpha(G)$. Are there an infinite number of graphs such that $\chi_2(G) = \chi(G) + \alpha(G)$?

Conjecture 3. If G is a simple graph, then $\chi_2(G) \leq \chi(G) + \alpha(G)$.
