Nonadiabatic holonomic multiqubit controlled gates

Previous schemes of nonadiabatic holonomic quantum computation were focused mainly on realizing a universal set of elementary gates. Multiqubit controlled gates could be built by decomposing them into a series of the universal gates. In this article, we propose an approach for realizing nonadiabatic holonomic multiqubit controlled gates in which a $(n + 1)$ -qubit controlled- $(n \cdot \sigma)$ gate is realized by $(2n - 1)$ basic operations instead of decomposing it into the universal gates, whereas an $(n + 1)$ -qubit controlled arbitrary rotation gate can be obtained by combining only two such controlled- $(n \cdot \sigma)$ gates. Our scheme greatly reduces the operations of nonadiabatic holonomic quantum computation.

Quantum computation is founded on quantum-mechanical principles, and is performed by unitary quantum gates. This creates its superiorities that are not available for classical computation. However, such superiorities rely on the ability to perform high-fidelity quantum gates. Two main challenges in achieving such high-fidelity gates are to reduce control errors of a quantum system and to avoid decoherence caused by the environment. To overcome these problems, various proposals of quantum computation with noise-resilience features have been proposed. A promising such proposal is nonadiabatic holonomic quantum computation.

Nonadiabatic holonomic quantum computation $[1, 2]$ $[1, 2]$ $[1, 2]$ is based on nonadiabatic non-Abelian geometric phases [\[3\]](#page-4-2). It is realized by using a quantum system with a subspace satisfying both the cyclic evolution and the parallel transport conditions. Consider a *N*−dimensional quantum system defined by $H(t)$, of which the evolution operator reads $U(t, 0) = \mathbf{T} \exp i \int_0^t H(t')dt'$. If there exists a time-dependent I -dimensional subspace $S(t)$ spanned by the orthonormal *L*−dimensional subspace S(*t*) spanned by the orthonormal vectors $\{|\phi_k(t)\rangle = U(t,0)|\phi_k(0)\rangle_{k=1}^L$ that satisfy the two conditions: (i) $\Sigma^L = |A(\sigma)|/A(\sigma)| = \Sigma^L = |A(\sigma)|/A(\sigma)|$ with π be tions: (i) $\sum_{k=1}^{L} |\phi_k(\tau)\rangle\langle\phi_k(\tau)| = \sum_{k=1}^{L} |\phi_k(0)\rangle\langle\phi_k(0)|$ with τ be-
ing the evolution period and (ii) $\langle\phi_k(t)|H(t)|\phi_k(t)\rangle = 0$ k l – ing the evolution period, and (ii) $\langle \phi_k(t) | H(t) | \phi_l(t) \rangle = 0, \ k, l =$ 1, ..., *L*, then the unitary transformation $U(\tau, 0)$ is a holonomic gate on the *L*−dimensional subspace S(0) spanned by $\{|\phi_k(0)\rangle\}_{k=1}^L$. This gate is only dependent on evolution paths
but independent of evolution details being robust against conbut independent of evolution details, being robust against control errors.

Nonadiabatic holonomic quantum computation is a gradual development of the early adiabatic geometric quantum computation [\[4\]](#page-4-3) based on Berry phases [\[5\]](#page-4-4), adiabatic holonomic quantum computation [\[6,](#page-4-5) [7\]](#page-4-6) based on adiabatic non-Abelian geometric phases [\[8\]](#page-4-7), and nonadiabatic geometric quantum computation [\[9,](#page-4-8) [10\]](#page-4-9) based on Aharonov-Anandan phases [\[11\]](#page-4-10). It shares all the holonomic nature of its adiabatic counterpart whereas avoiding the long run-time requirement. Due to the merits of both its robustness against control errors and its rapidity without the speed limit of the adiabatic evolution, nonadiabatic holonomic quantum computation has received increasing attention. Since its original proposal $[1, 2]$ $[1, 2]$ $[1, 2]$, many schemes of its implementation have been put forward based on various physical systems [\[12](#page-4-11)[–35\]](#page-4-12). Encouragingly, nonadiabatic holonomic quantum computation has been experimentally demonstrated with nuclear magnetic resonance [\[36,](#page-4-13) [37\]](#page-4-14), superconducting circuits [\[38–](#page-4-15)[43\]](#page-4-16), and nitrogen-vacancy centers in diamond [\[44–](#page-4-17)[49\]](#page-4-18).

These previous schemes of nonadiabatic holonomic quantum computation were focused mainly on realizing a universal set of elementary gates, e.g., two noncommuting one-qubit gates and a two-qubit entangling gate [\[50\]](#page-4-19). A multiqubit gate could be built by decomposing it into a series of universal gates. Particularly, a $(n + 1)$ -qubit controlled gate, as one important family of quantum gates being widely used in quantum information processing [\[52–](#page-4-20)[58\]](#page-5-0), needs to be decomposed into (2*ⁿ*+¹−3) two-qubit controlled gates [\[59,](#page-5-1) [60\]](#page-5-2). The decomposition becomes complicated as the number of qubits increases. It makes us attempt to find a new approach by which nonadiabatic holonomic multiqubit controlled gates can be realized with fewer operations, i.e., they can be more effectively performed without decomposing them into so many elementary gates. This is an interesting topic, as fewer operations imply less accumulation of control errors and less exposure time to decoherence, which results in higher-fidelity gates.

In this article, we propose a scheme to realize nonadiabatic holonomic multiqubit controlled gates. Our physical model is a set of ions trapped in a linear trap. Each ion has three levels corresponding to states $|0\rangle$, $|1\rangle$ and $|e\rangle$, which form a Λ configuration. The two lower states $|0\rangle$ and $|1\rangle$ play the role of a qubit, whereas the excited-state $|e\rangle$ acts as an auxiliary. The computational space for the $(n + 1)$ -qubit gate, denoted as S_{n+1} , is spanned by $\{|b_1b_2\cdots b_{n+1}\rangle, b_1, b_2, \cdots, b_{n+1}\}$ 0, 1}. We will show how to realize a holonomic $(n + 1)$ qubit controlled-($\mathbf{n} \cdot \mathbf{\sigma}$) gate, i.e. a controlled π -rotation gate, whereas a holonomic $(n+1)$ -qubit controlled arbitrary rotation gate can be realized by combining two of these gates. Here, $\mathbf{n} = (\sin \theta \cos \varphi, \sin \theta \sin \varphi, \cos \theta)$ represents the rotation axis, and σ is the Pauli operator. For simplicity, we use $U_{Cⁿ−n·\sigma}$ to denote the gate, which can be explicitly expressed as

with *I* being a 2×2 identity matrix. The main challenge of realizing this gate is how to achieve the multi-ion couplings that make the evolution of the qubits fulfill the two holonomic conditions (i) and (ii). By reducing the $(n + 1)$ -ion couplings into a series of experimentally achievable two-ion couplings

[\[61](#page-5-3)[–65\]](#page-5-4) and designing the Hamiltonian of the two-ion pairs, we resolve the challenge and realize the controlled operations on the target qubit.

*First, we show how to realize a nonadiabatic holonomic two-qubit controlled-(*ⁿ · σ*) gate,*

Consider two ions trapped in a linear trap. A pair of bichromatic lasers are applied to each ion to drive the transitions $|0\rangle \leftrightarrow |e\rangle$ or/and $|1\rangle \leftrightarrow |e\rangle$, as shown in Fig. [1\(](#page-2-0)a). For ion 1, we use a blue sideband laser with detuning $-(v + \delta)$ and Rabi frequency $\Omega_1(t)$ and a red sideband laser with detuning ($v - \delta$) and Rabi frequency $\Omega_1'(t)$ to drive the transition $|1\rangle \leftrightarrow |e\rangle$. For ion 2, we use a red sideband laser with detuning $v + \delta$ and Rabi frequency $\tilde{\Omega}_0(t)$ to drive the transition $|0\rangle \leftrightarrow |e\rangle$, and a blue sideband laser with detuning $-(\nu-\delta)$ and Rabi frequency $\tilde{\Omega}_1(t)$ to drive the transition $|1\rangle \leftrightarrow |e\rangle$. Here, *v* is the frequency of the vibrational mode for tranned ions, and δ is an additional of the vibrational mode for trapped ions, and δ is an additional detuning. In the rotating frame and with the rotating-wave approximation, the Hamiltonian of the two-ion system reads

in the Lamb-Dicke regime. Here, $|m\rangle$ *_i* (*m* = 0, 1, *e*) represents state $|m\rangle$ of the *j*th ion, *a* and a^{\dagger} are the annihilation and creation operators of the vibrational mode, and η is the Lamb–Dicke parameter that satisfies $\eta^2(n_v + 1) \ll 1$ with n_v
being the quantum number of the vibrational mode being the quantum number of the vibrational mode.

If the large detuning condition $\delta \gg \eta \Omega_1(t)$, $\eta \Omega'_1(t)$, $\eta \tilde{\Omega}_0(t)$, $\tilde{\Omega}_1(t)$, is satisfied, the single ion transitions $|0\rangle \leftrightarrow |e\rangle$ and $\eta \tilde{\Omega}_1(t)$ is satisfied, the single-ion transitions $|0\rangle \leftrightarrow |e\rangle$ and $|1\rangle \leftrightarrow |e\rangle$ are strongly suppressed whereas only the double- $|1\rangle \leftrightarrow |e\rangle$ are strongly suppressed whereas only the doubleion transitions $|10\rangle \leftrightarrow |ee\rangle$ and $|11\rangle \leftrightarrow |ee\rangle$ are allowed due to vibrational energy exchanging between two ions, as shown in Fig. [1\(](#page-2-0)b). In this case, the Hamiltonian in Eq. [\(3\)](#page-1-0) is reduced to an effective one [\[66\]](#page-5-5),

To obtain the two-qubit controlled- $(n \cdot \sigma)$ gate with $n =$ $(\sin \theta \cos \varphi, \sin \theta \sin \varphi, \cos \theta)$, we set $\Omega_{10}(t) = \Omega(t) \sin(\theta/2)e^{i\varphi}$

It shows that the role of the evolution operator $U(\tau)$ on the computational subspace is equivalent to

which can be recast as Eq. [\(2\)](#page-1-1) since $|00\rangle\langle00| + |01\rangle\langle01|$ = $|0\rangle\langle 0| \otimes I$ and $|D_2\rangle\langle D_2| - |B_2\rangle\langle B_2| = |1\rangle\langle 1| \otimes \mathbf{n} \cdot \boldsymbol{\sigma}$.

We now demonstrate that $U_{C^1-\mathbf{n}\cdot\sigma}$ is a holonomic gate, i.e., the two conditions (i) and (ii) are fulfilled. Equation [\(5\)](#page-1-2) clearly shows that a state initially residing in the computational space S_2 may evolve into the outside of the subspace during $t \in (0, \tau)$ but returns back to it at $t = \tau$, i.e., condition (i) is satisfied. Furthermore, with the aid of the relation $[H_{\text{eff}}(t), U(t, 0)] = 0$, it is easy to verify that $\langle \mu(t)|H_{\text{eff}}(t)|\nu(t)\rangle = \langle \mu|H_{\text{eff}}(t)|\nu\rangle = 0$, where $|\mu(t)\rangle = U(t,0)|\mu\rangle$, $|v(t)\rangle = U(t, 0)|v\rangle$, and $|\mu\rangle, |\nu\rangle \in S_2$, i.e., condition (ii) is satisfied too. Therefore, the unitary operator $U(\tau, 0)$ plays a holonomic gate on the computational subspace.

Second, we show how to realize a nonadiabatic holonomic three-qubit controlled-($\mathbf{n} \cdot \boldsymbol{\sigma}$ *)* gate,

For the three-qubit controlled gate, we consider three ions trapped in a linear trap. We need to use a piecewise timedependent Hamiltonian, i.e., we divide the whole evolution time τ into three intervals: $0 \le t \le \tau_1$, $\tau_1 \le t \le \tau_2$ and $\tau_2 \le t \le \tau$, in each of which a special Hamiltonian is chosen.

In the first interval, a red sideband laser with detuning $(v$ δ) and Rabi frequency $\Omega'_{1}(t)$ is applied to ion 1 to drive the transition Π and Θ and a blue sideband laser with detuning transition $|1\rangle \leftrightarrow |e\rangle$, and a blue sideband laser with detuning $-(v - \delta)$ and Rabi frequency $\tilde{\Omega}_1(t)$ is applied to ion 2 to drive
the transition $|1\rangle \leftrightarrow |e\rangle$. In this case, the Hamiltonian can be the transition $|1\rangle \leftrightarrow |e\rangle$. In this case, the Hamiltonian can be written as $H(t) = i\eta \Omega_1'(t)e^{-i\delta t}a|e\rangle_{11}\langle 1| + i\eta \tilde{\Omega}_1(t)e^{i\delta t}a^{\dagger}|e\rangle_{22}\langle 1| +$
H_c which is a special case of Eq. (3) with $Q_1(t) = \tilde{Q}_1(t)$ H.c., which is a special case of Eq. In the second interval, two lasers, one of which is with detuning $-(\nu + \delta)$ and Rabi frequency $\Omega_1(t)$, and another is with $(v - \delta)$ and $\Omega'_{1}(t)$, are applied to ion 2 to drive the transition $|1\rangle \leftrightarrow |e\rangle$ and two lasers, one of which is with detuntion $|1\rangle \leftrightarrow |e\rangle$, and two lasers, one of which is with detuning $-(v + \delta)$ and Rabi frequency $\tilde{\Omega}_0(t)$, and another is with

\int_0^{\tau_1} \Omega_{11}(t)dt = \frac{\pi}{2}, \int_{\tau_1}^{\tau_2} \Omega(t)dt = \pi, \int_{\tau_2}^{\tau} \Omega_{11}(t)dt = \frac{\pi}{2}, \quad (14)
$$

we have

$$
U(\tau,0)|D_3\rangle = |D_3\rangle, \quad U(\tau,0)|B_3\rangle = -|B_3\rangle,\tag{15}
$$

and except $\{|D\rangle, |B\rangle\}$, i.e. $\{|110\rangle, |111\rangle\}$, all the other computational basis $\{ |000\rangle, |001\rangle, |010\rangle, |011\rangle, |100\rangle, |101\rangle \}$ are unchanged in the whole evolution. Consequently, if we focus only on the computational subspace S_3 , the role of $U(\tau, 0)$ is equivalent to

$$
U_{C^2 - \mathbf{n} \cdot \sigma} = (|00\rangle\langle00| + |01\rangle\langle01| + |10\rangle\langle10|) \otimes I
$$

+ |D₃\rangle\langle D₃| - |B₃\rangle\langle B₃|, (16)

which is Eq. [\(9\)](#page-1-4) since $|00\rangle\langle00| + |01\rangle\langle01| + |10\rangle\langle10| = I^{\otimes 2}$ − $|11\rangle\langle11|$ and $|D_3\rangle\langle D_3| - |B_3\rangle\langle B_3| = |11\rangle\langle11| \otimes \mathbf{n} \cdot \boldsymbol{\sigma}$.

We now demonstrate that $U_{C^2 - n \cdot \sigma}$ is a holonomic gate. The above discussion clearly shows that condition (i) is satisfied. Furthermore, since $U(t, 0)$ commutes with $H_{\text{eff}}^{(k)}$ $_{\text{eff}}^{(k)}(t)$, $k = 1, 2, 3,$ it is easy to verify that $\langle \mu(t)|H_{\text{eff}}^{(1)} \rangle$ $\begin{cases} (1)_{\text{eff}}(t) |v(t)\rangle = 0 \text{ for } t \in [0, \tau_1], \\ 0 \text{ and } (v(t) |H^{(3)}(t)|v(t)) > 0. \end{cases}$ $\langle \mu(t)|H_{\text{eff}}^{(2)} \rangle$ (²)(*t*)|*v*(*t*)) = 0 for *t* ∈ [τ₁, τ₂], and $\langle \mu(t)|H_{\text{eff}}^{(3)}$
[τ₂, τ] where $|\mu(t)\rangle - I/(t_0)|\mu\rangle$ |*v*(*t*)) − $\begin{aligned} \n\mathbf{e}^{(3)}(t) |v(t)\rangle &= 0\\ \n&= II(t,0) |v\rangle. \n\end{aligned}$ for $t \in [t_2, \tau]$, where $|\mu(t)\rangle = U(t, 0)|\mu\rangle$, $|\nu(t)\rangle = U(t, 0)|\nu\rangle$, and $|\mu\rangle, |\nu\rangle \in S_3$. That is, condition (ii) is satisfied too. Therefore, the unitary operator $U(\tau, 0)$ plays a holonomic gate on the computational subspace.

Third, we show how to realize a nonadiabatic holonomic $(n + 1)$ -qubit controlled- $(\mathbf{n} \cdot \mathbf{\sigma})$ gate $(n \geq 3)$,

$$
U_{C^{n}-\mathbf{n}\cdot\boldsymbol{\sigma}} = \left[I^{\otimes n} - (|1\rangle\langle 1|)^{\otimes n}\right] \otimes I + (|1\rangle\langle 1|)^{\otimes n} \otimes \mathbf{n}\cdot\boldsymbol{\sigma}.\tag{17}
$$

To realize a nonadiabatic holonomic (*n* + 1)-qubit controlled- $(\mathbf{n} \cdot \boldsymbol{\sigma})$, we consider $(n+1)$ three-level ions trapped in a line trap, and divide the whole evolution into $(2n - 1)$ intervals: $0 \le t \le \tau_1$, $\tau_1 \le t \le \tau_2$, \cdots , $\tau_{2n-2} \le t \le \tau$.

In the first intervals, we take the effective Hamiltonian as,

$$
H_{\text{eff}}^{(1)}(t) = \Omega_{11}(t)|ee\rangle\langle11| + \text{H.c.},\tag{18}
$$

which acts on ions 1 and 2. In the *k*th interval $\tau_{k-1} \le t \le \tau_k$, $k = 2, 3, \dots, n-1$, we use the effective Hamiltonian,

$$
H_{\text{eff}}^{(k)}(t) = \tilde{\Omega}_{e1}(t)|1e\rangle\langle e1| + \text{H.c.},\tag{19}
$$

which acts on ions *k* and $k+1$. In the *n*th interval $\tau_{n-1} \le t \le \tau_n$, we use the effective Hamiltonian,

$$
H_{\text{eff}}^{(n)}(t) = \Omega_{e0}(t)|1e\rangle\langle e0| + \Omega_{e1}(t)|1e\rangle\langle e1| + \text{H.c.},\tag{20}
$$

which acts on ions *n* and *n*+1. In the *k*th interval $\tau_{k-1} \le t \le \tau_k$, $k = n + 1, n + 2, \cdots, 2n - 2$, we use the effective Hamiltonian,

$$
H_{\text{eff}}^{(k)}(t) = \tilde{\Omega}_{e1}(t)|1e\rangle\langle e1| + \text{H.c.},\tag{21}
$$

which acts on ions $(2n - k)$ and $(2n - k + 1)$. In the $(2n - 1)$ th interval $\tau_{2n-2} \le t \le \tau_{2n-1}$, we use the effective Hamiltonian,

$$
H_{\text{eff}}^{(2n-1)}(t) = (-1)^n \Omega_{11}(t) |ee\rangle\langle 11| + \text{H.c.},\tag{22}
$$

which acts on ions 1 and 2.

All these effective Hamiltonians can be realized by applying lasers on ions as those do in the two-qubit and three-qubit gates. In fact, the effective Hamiltonian in Eq. [\(18\)](#page-2-1) is the same as the one in Eq. [\(10\)](#page-1-5), the Hamiltonian in Eqs. [\(19\)](#page-2-2) and (21) is a special case of that in Eq. (11) , the Hamiltonian in Eq. (20) is the same as that in Eq. (11) , and the Hamiltonian in Eq. (22) has the same form as that in Eq. (10) but only with a different parameter value.

To obtain a nonadiabatic holonomic (*n*+1)-qubit controlled- $(n \cdot \sigma)$ gate with $n = (\sin \theta \cos \varphi, \sin \theta \sin \varphi, \cos \theta)$, we set $\Omega_{11}(t)$ and $\tilde{\Omega}_{e1}(t)$ to be real, and set $\Omega_{e0}(t) = \Omega(t) \cos(\theta/2)$ and $\Omega_{e1}(t) = \Omega(t) \sin(\theta/2)e^{-i\varphi}$ where $\Omega(t)$ is a time dependent pa- $\Omega_{e_1}(t) = \Omega(t) \sin(\theta/2) e^{-i\varphi}$, where $\Omega(t)$ is a time dependent pa-
rameter. In this case, the evolution operator can be expressed rameter. In this case, the evolution operator can be expressed as

$$
U(t,0) = U(t, \tau_{k-1})U(\tau_{k-1}, \tau_{k-2})\cdots U(\tau_1, 0), \qquad (23)
$$

for $t \in [\tau_{k-1}, \tau_k]$, where $U(t, \tau_{a-1}) = \exp[-i \int_{\tau_a}^t$
with $a = 1$ and $\tau = 0$ τ*a* $H_{\rm eff}^{(a)}$ $\begin{bmatrix} (a) \\ \text{eff} \end{bmatrix} (t') dt'$ with $a = 1, \dots, 2n - 1$ and $\tau_0 = 0$.

We let $|D_{n+1}\rangle = \cos(\theta/2)|1^{\otimes n}0\rangle + \sin(\theta/2)e^{i\varphi}|1^{\otimes n}1\rangle$ and
 \cdots = $\sin(\theta/2)e^{-i\varphi}|1^{\otimes n}0\rangle - \cos(\theta/2)|1^{\otimes n}1\rangle$ which span the $|B_{n+1}\rangle = \sin(\theta/2)e^{-i\varphi}|1^{\otimes n}0\rangle - \cos(\theta/2)|1^{\otimes n}1\rangle$, which span the span the span subspace as Span $\{1|\otimes n}0\rangle$ $|1^{\otimes n}1\rangle$. If we take τ_1 , τ_2 , \cdots same subspace as Span $\{|1^{\otimes n}0\rangle, |1^{\otimes n}1\rangle\}$. If we take $\tau_1, \tau_2, \dots, \tau_{n}$, and τ to satisfy τ_{2n-2} , and τ to satisfy

$$
\int_0^{\tau_1} \Omega_{11}(t)dt = \int_{\tau_{2n-2}}^{\tau} \Omega_{11}(t)dt = \frac{\pi}{2}, \quad \int_{\tau_{n-1}}^{\tau_n} \Omega(t)dt = \pi,
$$

$$
\int_{\tau_{k-1}}^{\tau_k} \tilde{\Omega}_{e1}(t)dt = \frac{\pi}{2}, k = 2, \cdots, n-1, n+1, \cdots, 2n-2, (24)
$$

there will be

$$
U(\tau,0)|D_{n+1}\rangle = |D_{n+1}\rangle, \ \ U(\tau,0)|B_{n+1}\rangle = -|B_{n+1}\rangle, \tag{25}
$$

and $U(\tau, 0)|S\rangle = |S\rangle$ for $|S\rangle \in \{|b_1b_2\cdots b_{n+1}\rangle, b_i = 0, 1\}$ except $|1^{\otimes n}0\rangle$ and $|1^{\otimes n}1\rangle$. If we focus only on the computational space, the evolution operator $U(\tau, 0)$ is equivalent to

$$
U_{C^{n}-\mathbf{n}\cdot\sigma} = \left[I^{\otimes n} - (|1\rangle\langle 1|)^{\otimes n}\right] \otimes I + |D_{n+1}\rangle\langle D_{n+1}) - |B_{n+1}\rangle\langle B_{n+1}|.
$$
\n(26)

Since $|D_{n+1}\rangle\langle D_{n+1}| - |B_{n+1}\rangle\langle B_{n+1}| = (|1\rangle\langle 1|)^{\otimes n}\otimes \mathbf{n} \cdot \sigma$, Eq. [\(26\)](#page-3-3)
can be recast as Eq. (17) can be recast as Eq. [\(17\)](#page-2-4).

Similar to the two-qubit and three-qubit cases, we can demonstrate that $U_{C^n-\mathbf{n}\cdot\sigma}$ is a holonomic gate. Indeed, the above discussion shows that a state initially residing in the computational space returns back to the computational space after the whole evolution. Furthermore, since $U(t, 0)$ always commutes with the instantaneous effective Hamiltonian for each time interval, it is easy to verify that condition (ii) is satisfied too. Therefore, $U_{Cⁿ−n·\sigma}$ is a holonomic gate.

So far, we have demonstrated how to realize a nonadiabatic holonomic $(n + 1)$ -qubit controlled- $(\mathbf{n} \cdot \boldsymbol{\sigma})$ gate. It is interesting to note that the well-known controlled-NOT gate and the Toffoli gate are the special cases of two-qubit and threequbit controlled- $(\mathbf{n} \cdot \boldsymbol{\sigma})$ gates at $\mathbf{n} = (1, 0, 0)$, respectively. Furthermore, we would like to point out that a nonadiabatic holonomic $(n + 1)$ -qubit controlled arbitrary rotation gate can be realized by combining two controlled- $(n \cdot \sigma)$ gates. Indeed, since $(\sigma \cdot n)(\sigma \cdot m) = (n \cdot m)I + i \sigma \cdot (n \times m)$, we have *^UCn*−n·σ*UCn*−m·σ ⁼ [*^I* [⊗]*ⁿ* − (|1ih1|) ⊗*n*] ⊗ *I* + (|1ih1|) [⊗]*ⁿ* ⊗ [n · m + $i\sigma \cdot (\mathbf{n} \times \mathbf{m})$] = $U_{C^n - [\mathbf{n} \cdot \mathbf{m} + i\sigma \cdot (\mathbf{n} \times \mathbf{m})]$. Hence, by properly choosing **m** and **n**, we can realize an arbitrary $(n + 1)$ -qubit controlled- $[(\mathbf{n} \cdot \mathbf{m})I + i \boldsymbol{\sigma} \cdot (\mathbf{n} \times \mathbf{m})]$ gate.

Before concluding, we would like to add a brief discussion on the feasibility of our scheme. Our scheme is based on the effective Hamiltonian $H_{\text{eff}}(t)$, which is derived from the Hamiltonian $H(t)$ under the large detuning condition, and we have ignored the decay from $|e\rangle$ to $|0\rangle$ and $|1\rangle$. Hence, the large detuning approximation and the decay may affect the fidelity of the controlled gates. To illustrate the feasibility of our scheme, we calculate the fidelity $F = \langle \psi(\tau)|\rho(\tau)|\psi(\tau)\rangle$ for the controlled-NOT gate and the Toffoli gate, where $|\psi(\tau)\rangle$ = $U_{C^n-\mathbf{n}\cdot\sigma}|\psi(0)\rangle$ is obtained by directly using our controlled gates, and $\rho(\tau)$ is obtained by resolving the Lindblad equation with Hamiltonian $H(t)$ [\[69\]](#page-5-6) and the Lindblad operators $L_k = \sqrt{\gamma_{e0}} |0\rangle\langle e| + \sqrt{\gamma_{e1}} |1\rangle\langle e|$. Our physical model is trapped
ione ⁴⁰Ce⁺ of which the two Zeeman split which $4S^{-1/2}$ ions ⁴⁰Ca⁺, of which the two Zeeman-split sublevels $4S_{1/2}^{-1/2}$ and $4S_{1/2}^{+1/2}$ are taken as qubit states $|0\rangle$ and $|1\rangle$ while $|e\rangle$ is encoded into $3D_{5/2}$ [\[63,](#page-5-7) [70\]](#page-5-8). The decay ratio of $|e\rangle$ to $|0\rangle$
and $|1\rangle$ is taken as $\alpha_{i} = \alpha_{i} = 1/(2\pi)$ with the life time and $|1\rangle$ is taken as $\gamma_{e0} = \gamma_{e1} = 1/(2\tau_f)$ with the life time τ_f = 1.2s [\[71\]](#page-5-9), and the Lamb-Dicke parameter and the additional detuning are taken as $\eta = 0.044$ and $\delta = 2\pi \times 50$ kHz [\[63\]](#page-5-7). For the controlled-NOT gate, we choose the laser parameters $\Omega_1(t) = \Omega'_1(t) = -\tilde{\Omega}_0(t) = -\tilde{\Omega}_1(t) = 2\pi \times 30$ KHz,
which are experimentally achievable and take $|\psi(0)\rangle = |10\rangle$ which are experimentally achievable, and take $|\psi(0)\rangle = |10\rangle$. For the Toffoli gate, we choose $\Omega_1(t) = \Omega'_1(t) = -\tilde{\Omega}_0(t) =$ $-\tilde{\Omega}_1(t) = 2\pi \times 30 \text{K} \text{Hz}$ in the second time interval, and $\Omega'_1(t) = \tilde{\Omega}_1 - 2\pi \times 30 \text{K} \text{Hz}$ in the first and third time intervals, and take $\tilde{\Omega}_1 = 2\pi \times 30 \text{K}$ in the first and third time intervals, and take $h\omega(0) = 1110$. Our numerical result shows that the fidelities $|\psi(0)\rangle = |110\rangle$. Our numerical result shows that the fidelities are 99.17% and 95.98%, respectively, for the controlled-NOT gate and Toffoli gate.

In conclusion, we have proposed an approach to realize nonadiabatic holonomic multiqubit controlled gates based on trapped ions by which a $(n + 1)$ -qubit controlled- $(\mathbf{n} \cdot \boldsymbol{\sigma})$ gate can be realized by $(2n - 1)$ basic operations, whereas a nonadiabatic holonomic $(n + 1)$ -qubit controlled arbitrary rotation gate can be obtained by combining two such gates. Comparing with the previous schemes of nonadiabatic holonomic computation in which a multiqubit controlled gate is built by using a large number of universal elementary gates, our scheme greatly reduces the operations of nonadiabatic holonomic quantum computation.

(3.1) in Ref. $[67]$, we have $\hat{h}_1 = i\eta \Omega_1(t)a^{\dagger} |e\rangle_{11} \langle 1|$, $\hat{h}_2 = i\eta \Omega_1'(t)a|e\rangle_{11} \langle 1|$, $\hat{h}_3 = i\eta \tilde{O}^*(t)a^{\dagger} |0\rangle$, $\langle e|$, $\hat{h}_4 = i\eta \tilde{O}^*(t)a^{\dagger} |0\rangle$, $\langle e|$ and $\langle e| = (1 - \epsilon)\rho - \epsilon$ $-i\eta \tilde{\Omega}_0^*(t)a^{\dagger} |0\rangle_{22}\langle e|$, $\hat{h}_4 = -i\eta \tilde{\Omega}_1^*(t)a|1\rangle_{22}\langle e|$, and $\omega_1 = \omega_2 = \omega_3 = \omega_4$
 $\omega_1 = \delta$. Substituting them into (3,10), we immediately obtain $\omega_4 = \delta$. Substituting them into (3.10), we immediately obtain $H_{\text{eff}}(t) = \Omega_{10}(t)|ee\rangle\langle10|+\Omega_{11}(t)|ee\rangle\langle11|+\text{H.c}+\text{Stark shift terms}.$ Noting that the Stark shift terms can be easily compensated by applying additional lasers [\[68\]](#page-5-11), we finally obtain the effective Hamiltonian in Eq.[\(4\)](#page-1-3). Similarly, we can obtain the one in Eq. [\(11\)](#page-2-3).
