Composition of locally solid convergences

Abstract

We carry on a more detailed investigation of the composition of locally solid convergences as introduced in [BCTvdW24], as well as the corresponding notion of idempotency considered in [Bil23]. In particular, we study the interactions between these two concepts and various operations with convergences. Some results from [KT18] about unbounded modification of locally solid topologies are generalized to the level of locally solid idempotent convergences. A simple application of the composition allows us to answer a question from [BCTvdW24] about minimal Hausdorff locally solid convergences. We also show that the weakest Hausdorff locally solid convergence exists on an Archimedean vector lattice if and only if it is atomic.

1 Introduction

This note is a continuation of the study of locally solid convergence structures on vector lattices. In the previous work [BCTvdW24] a definition of a composition of locally solid convergences was proposed. The corresponding notion of an idempotent convergence was considered in [Bil23]. Here we add more details pertaining to these two concepts. In particular, we show (Theorem 2.10) that if $E \subset F$ is an ideal of a vector lattice, and η, θ are two locally solid convergences, then $\overline{E}^{1,\eta\theta} = \overline{\overline{E}^{1,\eta}}^{1,\theta}$, which somewhat justifies the term "composition"; we also establish in Theorem 2.12 that composition is associative. In Corollary 2.3 and Theorem 2.6 we explore the topic of convergences which share decreasing null nets. We show (propositions 2.15, 2.17 and 2.18) that unbounded modification with respect to an ideal, a pull-back along a positive operator and the Choquet modification are "submultiplicative", and in particular preserve idempotent convergences (Example 2.23). Numerous examples of idempotent convergences are provided in Subsection 2.3.

We also present some applications of the concepts of composition and idempotency of locally solid convergences. In Section 3.1 we look at the minimal Hausdorff locally solid convergences. We show (Theorem 3.4) that the Choquet modification of unbounded order convergence is a minimal Hausdorff locally solid convergence on an

Archimedean vector lattice if and only if the latter is atomic, thus answering a question from [BCTvdW24]. Furthermore, another condition equivalent to atomicity is existence of the weakest Hausdorff locally solid convergence. Here the relevance of the notion of composition is a simple result (Lemma 3.1) which reduces the problem from the level of locally solid **linear** convergences to that of locally solid **additive** convergences, which are easier to deal with. In Section 3.2 we focus on the unbounded modification, and generalize some results from [KT18] by replacing locally solid topologies with idempotent locally solid convergences. In particular, Theorem 3.15 gives a fairly comprehensive characterization of when one unbounded convergence is stronger than another.

We remark here that a notion, similar to powers of relative uniform convergence was considered in [Fre78], but the author is not aware of any further developments in that direction.

1.1 Preliminaries

We refer to [Bil23] and [BCTvdW24] for the theory of locally solid convergences and to [BB02] and [OTvdW23] for more background on convergence spaces. Note that the source [Bil23] studies additive convergences (in which the addition and taking the additive inverse are continuous), while only linear convergences (in which scalar multiplication is also continuous) are considered in [BCTvdW24]. We need a slightly broader class of additive convergences, due to its somewhat higher flexibility. In particular, we will often rely on the following construction.

Example 1.1. Let F be a linear space and let $E \subset F$ be a subspace endowed with an additive convergence η . This convergence can be extended to F by declaring a net $(f_{\alpha})_{\alpha \in A} \subset F$ null if its tail is contained in E and is η -null there, and then defining $f_{\alpha} \to f$ if $f_{\alpha} - f \to 0_F$. One can show that the convergence η_F defined this way is indeed an additive convergence structure, and η_F is Hausdorff iff η is. Furthermore, η_F is the strongest additive convergence on F whose restriction to E is weaker than η (it is the final additive convergence with respect to the inclusion of E into F). Note that E is η_F -closed in F. Indeed, if $(e_{\alpha})_{\alpha \in A} \subset E$ converges to $f \in F$, there is α such that $f - e_{\alpha} \in E$, hence $f \in E$. If $E \subsetneq F$ then η_F is not linear, since $\frac{1}{n}f \neq 0_F$ whenever $f \in F \setminus E$.

In the sequel F is a vector lattice. We will not reproduce all the definitions necessary to define locally solid convergences. Instead, we will operate through the following result.

Theorem 1.2 ([Bil23], Theorem 2.1 and [BCTvdW24], Proposition 3.4). Assume that $\rightarrow 0_F$ is a non-trivial adjudicator on F_+ to 0_F which satisfies the following properties:

- A quasi-subnet of a net convergent to 0_F converges to 0_F ;
- If $(f_{\alpha})_{\alpha \in A} \subset F_+$ is convergent to 0_F , then $g_{\alpha} \to 0_F$, where $0_F \leq g_{\alpha} \leq f_{\alpha}$, for every $\alpha \in A$;
- If $f_{\alpha} \to 0_F$ and $g_{\alpha} \to 0_F$, then $f_{\alpha} + g_{\alpha} \to 0_F$.

Then, the convergence defined by $f_{\alpha} \to f$ if $|f_{\alpha} - f| \to 0_F$ is a locally solid additive convergence. It is linear iff $\frac{1}{n}f \to 0_F$, for every $f \in F_+$, and Hausdorff if $0_F < f \not\to 0_F$.

We call a convergence η stronger than θ (denoted $\eta \geq \theta$) if convergence with respect to η implies convergence with respect to θ . The set of all (additive or linear) locally solid convergences is a complete lattice: if Θ is a collection of convergences, a net converges with respect to $\bigvee \Theta$ if it converges with respect to each member of θ . On the other hand, if Θ is directed downward, then a net converges with respect to $\bigwedge \Theta$ if it converges with respect to a member of θ . In particular, the infimum of a decreasing net of Hausdorff convergences is Hausdorff.

Example 1.3. The discrete convergence, in which only eventually constant nets converge, is locally solid additive. \Box

It is easy to see (by Theorem 1.2 or directly) that if $E \subset F$ is an ideal and η is a locally solid additive convergence on E, then its extension η_F is a locally solid additive convergence on F. This means that we can always view our convergences defined on F, thus circumventing the issue which appears in [KLT18].

Example 1.4. For $e \in F_+$ the principal ideal F_e is endowed with the norm $\|\cdot\|_e$ defined by $\|f\|_e = \bigwedge \{\alpha \ge 0 : |f| \le \alpha e\}$. We will extend the convergence determined by $\|\cdot\|_e$ to the entire F (and keep the same notation). The resulting convergence is locally solid additive, and relative uniform convergence is precisely $\bigwedge_{e \in F_+} \|\cdot\|_e$.

Example 1.5. Let F be a normed lattice. If we "feed" the weak convergence to 0_F on F_+ into Theorem 1.2, we obtain the *absolute weak* topology aw. This is the weakest locally solid convergence stronger than the weak topology (which fails to be locally solid in most cases). In particular, aw is weaker than the norm topology. On the other hand, Dini's theorem (the proof of [MN91, Proposition 1.4.1] works for nets) asserts that a decreasing weakly null net on a normed lattice is norm-null.

A significant role in this article is played by monotone nets. Note that a directed upward subset of F may be viewed as an increasing net indexed by itself. Similarly, if $G \subset F$ is directed downward, it can be viewed as a decreasing net indexed by -G. In either case, the notation $G \to f$ means that G converges to f as a net indexed by G or -G. See [BCTvdW24] for some facts about the convergence of monotone nets. Here we reproduce one of them (the proof works for the additive case).

Lemma 1.6 ([BCTvdW24], Proposition 3.9). Let η be a locally solid additive convergence on F. Then, a decreasing net in F_+ η -converges to 0_F as soon as it contains (as a subset) a η -null net.

It is known ([vdW13, Proposition 2.7]) that the adherence of a solid / ideal with respect to an additive locally solid convergence is a set of the same type. We denote the adherence of $A \subset F$ with respect to convergence η by \overline{A}_{η}^{1} , and the closure – by \overline{A}_{η} . If η is clear from the context, it will be dropped from these notations.

We will call $G \subset F_+$ positively solid, if it is a lower set in F_+ , i.e. if $0_F \leq f \leq g \in G$ $\Rightarrow f \in G$. If on top of that G is \lor -closed (equivalently, directed upward), we call it a *lattice-ideal* of F_+ . For example, if $H \subset F$ is an ideal, then H_+ is a lattice ideal of F_+ . Dually, a \land -closed upper subset of F_+ is called *co-ideal* (a more standard term is *filter*, but we would like to avoid confusion with a filter **on** F, which is a subset of $\mathcal{P}(F)$). We will view lattice-ideals as increasing nets, and co-ideals – as decreasing nets.

Lemma 1.7. Let $G \subset F_+$ be positively solid and let $g \in F_+$. Then, $g \in \overline{G}^1$ iff there is $(g_{\alpha})_{\alpha \in A} \subset G \cap [0_F, g]$ such that $g_{\alpha} \to g$ and iff there is $(g_{\alpha})_{\alpha \in A} \subset G$ such that $(g - g_{\alpha})^+ \to 0_F$.

Proof. Clearly, the second condition is the strongest, whereas the last one is the weakest. On the other hand, if $(g_{\alpha})_{\alpha \in A} \subset G$ is such that $(g - g_{\alpha})^+ \to 0_F$, then $(g - g_{\alpha})^+ = g - g \wedge g_{\alpha}$ with $g \wedge g_{\alpha} \in G \cap [0_F, g]$, for every α . It then follows that $g = \lim_{\alpha} (g \wedge g_{\alpha})$. \Box

Combining this result with Lemma 1.6 we get the following.

Corollary 1.8. If $G \subset F_+$ a lattice-ideal, then $g \in \overline{G}^1$ iff $G \cap [0_F, g] \to g$.

Analogous result holds for co-ideals.

Corollary 1.9. If $G \subset F_+$ is a co-ideal, then $G \to 0_F$ iff $0_F \in \overline{G}^1$.

Proposition 1.10. If $G, H \subset F_+$ are positively solid, then $\overline{G \cap H}^1 = \overline{G}^1 \cap \overline{H}^1$. Same is true for solid subsets of F.

Proof. Monotonicity of adherence implies $\overline{G \cap H}^1 \subset \overline{G}^1, \overline{H}^1$. On the other hand, if $f \in \overline{G}^1 \cap \overline{H}^1$, there are nets $(g_\alpha)_{\alpha \in A} \subset G$ and $(h_\beta)_{\beta \in B} \subset H$ which converge to f. Due to continuity of \wedge we conclude that $G \cap H \ni g_\alpha \wedge h_\beta \to f$, hence $f \in \overline{G \cap H}^1$.

We now consider the case when $G, H \subset F$ are solid and $f \in \overline{G}^1 \cap \overline{H}^1$. It is then easy to see that $|f| \in \overline{G_+}^1 \cap \overline{H_+}^1 = \overline{G_+ \cap H_+}^1 \subset \overline{G \cap H}^1$. As the latter set is solid, we conclude that $f \in \overline{G \cap H}^1$.

Proposition 1.11. The adherence of a countably generated ideal is equal to its sequential adherence.

Proof. Assume that an ideal $E \subset F$ is generated by an increasing sequence $\{e_n\}_{n \in \mathbb{N}}$ and fix $0_F \leq f \in \overline{E}^1$, so that $E \cap [0_F, f] \to f$. We have that $E = \bigcup_{n \in \mathbb{N}} F_{e_n}$, and so for every $e \in E$ there are $m, n \in \mathbb{N}$ such that $e \leq me_n$. Taking $m \lor n$ leads to the conclusion that $\{f \land ne_n\}_{n \in \mathbb{N}}$ is co-final in $E \cap [0_F, f]$, hence converges to f.

2 Composition of locally solid convergences

Throughout the section, F is a vector lattice. Let η and θ be locally solid additive convergences on F. Following [BCTvdW24, Section 10] we define a new convergence $\eta\theta$ as follows: for a net $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ we will say that $f_{\alpha} \xrightarrow{\eta\theta}{\alpha} 0_{F}$ if there is a *controlling* θ -null net $(g_{\beta})_{\beta \in B} \subset F_{+}$ such that $(f_{\alpha} - g_{\beta})^{+} \xrightarrow{\eta} 0_{F}$, for every β . Let us summarize some basic facts about $\eta\theta$.

Proposition 2.1. Let η and θ be locally solid additive convergences on F. Then:

(i) $\eta\theta$ is a locally solid additive convergence, which is weaker than η .

- (ii) Every monotone θ -convergent net is $\eta\theta$ -convergent. If θ is order continuous, so is $\eta\theta$.
- (iii) $\eta\theta$ is Hausdorff iff both η, θ are.
- (iv) If one of η , θ is linear, then $\eta\theta$ is linear.

Proof. (i)-(iii) were proven in [BCTvdW24, Propositions 10.11-10.13] for locally solid linear convergences, but the proof goes through for the additive case.

(iv): Let $e \in F_+$. If η is linear, $\frac{1}{n}e \xrightarrow{\eta} 0_F$, hence $\frac{1}{n}e \xrightarrow{\eta\theta} 0_F$, according to (i). If θ is linear, $\frac{1}{n}e \xrightarrow{\theta} 0_F$, hence $\frac{1}{n}e \xrightarrow{\eta\theta} 0_F$, according to (ii). In either case it follows from Theorem 1.2 that $\eta\theta$ is linear.

Let us consider some alternative ways of describing the $\eta\theta$ -convergence. First, note that the controlling net can be replaced with any of its quasi-subnets. Moreover, let us show that this net can be assumed to be a co-ideal.

Proposition 2.2. Let η and θ be locally solid additive convergences on F. For a net $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ TFAE:

(i)
$$f_{\alpha} \xrightarrow{\eta \theta} 0_F$$
;

(*ii*) There are nets $(h_{\alpha\beta})_{\alpha\in A, \beta\in B}$ and $(g_{\beta})_{\beta\in B}$ such that $f_{\alpha} \leq h_{\alpha\beta} \xrightarrow{\eta}{\alpha} g_{\beta} \xrightarrow{\theta} 0_{F}$;

(iii) There is a θ -null co-ideal $G \subset F_+$ such that $(f_\alpha - g)^+ \xrightarrow{\eta} 0_F$, for every $g \in G$.

Moreover, for a filter \mathcal{F} on F we have $\mathcal{F} \xrightarrow{\eta \theta} 0_F$ iff there is a (decreasing) θ -null net $(g_{\beta})_{\beta \in B} \subset F_+$ such that $(|\mathcal{F}| - g_{\beta})^+ \xrightarrow{\eta} 0_F$, for every β .

Proof. (i) \Rightarrow (ii): If $f_{\alpha} \xrightarrow{\eta \theta} 0_F$, then $f_{\alpha} \leq g_{\beta} + (f_{\alpha} - g_{\beta})^+ \xrightarrow{\eta}_{\alpha} g_{\beta} \xrightarrow{\theta} 0_F$, where $(g_{\beta})_{\beta \in B} \subset F_+$ is a controlling net.

(ii) \Rightarrow (i): If $f_{\alpha} \leq h_{\alpha\beta} \xrightarrow[\alpha]{\eta} g_{\beta} \xrightarrow[\alpha]{\theta} 0_F$, then $(f_{\alpha} - g_{\beta})^+ \leq (h_{\alpha\beta} - g_{\beta})^+ \xrightarrow[\alpha]{\eta} 0_F$.

(i) \Rightarrow (iii): Let $G := \left\{ g \in F_+, (f_\alpha - g)^+ \xrightarrow{\eta} 0_F \right\}$. It is easy to see that if $h \ge g \in G$, then $h \in G$. If $g, h \in G$, then $(f_\alpha - g \wedge h)^+ = (f_\alpha - g)^+ \vee (f_\alpha - h)^+ \xrightarrow{\eta} 0_F$, hence, $g \wedge h \in G$. Thus, G is a co-ideal. As $(g_\beta)_{\beta \in B} \subset G$, Lemma 1.6 yields that $G \xrightarrow{\theta} 0_F$.

(iii) \Rightarrow (i) is trivial, and so we are left with proving the filter version. Let $\mathcal{F} = [f_{\alpha}, \ \alpha \in A]$, for some net $(f_{\alpha})_{\alpha \in A} \subset F$. Then, $\mathcal{F} \xrightarrow{\eta \theta} 0_F \Leftrightarrow f_{\alpha} \xrightarrow{\eta \theta} 0_F \Leftrightarrow |f_{\alpha}| \xrightarrow{\eta \theta} 0_F \Leftrightarrow$ there is a (decreasing) θ -null net $(g_{\beta})_{\beta \in B} \subset F_+$ such that $(|f_{\alpha}| - g_{\beta})^+ \xrightarrow{\eta} 0_F$, for every β . It is left to notice that $(|\mathcal{F}| - g_{\beta})^+ = [(|f_{\alpha}| - g_{\beta})^+, \ \alpha \in A]$, for every β .

It now follows that the only information passed down from θ are the decreasing θ -null nets, or even more precisely, θ -null co-ideals.

Corollary 2.3. Let $\eta, \eta_1, \eta_2, \theta_1, \theta_2$ be locally solid additive convergences on F. Then: (i) If $\eta_1 \ge \eta_2$ and $\theta_1 \ge \theta_2$, then $\eta_1 \theta_1 \ge \eta_2 \theta_2$.

(ii) If θ_1, θ_2 have the same null co-ideals in F_+ then $\eta \theta_1 = \eta \theta_2$.

Proposition 2.4. Let η be a locally solid additive convergences on F, and let Θ be a collection of locally solid additive convergences on F. Then, $\eta \bigvee \Theta = \bigvee_{\theta \in \Theta} \eta \theta$.

Proof. Clearly, $\eta \bigvee \Theta \geq \eta \theta$, for every $\theta \in \Theta$. To prove the converse assume that $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ is $\eta \theta$ -null, for every $\theta \in \Theta$. According to Proposition 2.2, $G := \left\{g \in F_{+}, (f_{\alpha} - g)^{+} \xrightarrow{\eta} 0_{F}\right\}$ is θ -null, for every $\theta \in \Theta$. It follows that G is $\bigvee \Theta$ -null, and so $f_{\alpha} \xrightarrow{\bigvee \Theta} 0_{F}$.

Example 2.5 (Essentially [Fre78]). We will show that if in F every countable disjoint set is order bounded, then $\operatorname{ru}^2 = \sigma o$. On one hand, $\operatorname{ru} \geq \sigma o$, hence $\operatorname{ru}^2 \geq \sigma o^2 = \sigma o$ (the last equality will be proven in Example 2.22). On the other hand, assume that $0_F \leq f_{\alpha} \xrightarrow{\sigma o} 0_F$, so that there is a decreasing sequence $(e_n)_{n \in \mathbb{N}} \subset F$ with $\bigwedge_{n \in \mathbb{N}} e_n = 0_F$ and such that

for every $n \in \mathbb{N}$ there is α_n with $f_\alpha \leq e_n$, as soon as $\alpha \geq \alpha_n$. By [AB03, Lemma 7.7] for every $m \in \mathbb{N}$ there is $h_m \in F_+$ such that $e_n \leq 2^{-n}h_m + \frac{1}{m}e_1$, for every $n \in \mathbb{N}$. Clearly, $\frac{1}{m}e_1 \xrightarrow{\mathrm{ru}} 0_F$; we claim that it is a controlling net for $f_\alpha \xrightarrow{\mathrm{ru}^2} 0_F$. Indeed, if $\alpha \geq \alpha_n$ we have that $(f_\alpha - \frac{1}{m}e_1)^+ \leq (e_n - \frac{1}{m}e_1)^+ \leq 2^{-n}h_m$, and so $(f_\alpha - \frac{1}{m}e_1)^+ \xrightarrow{\mathrm{ru}} 0_F$, for every $m \in \mathbb{N}$.

There can be various convergences which share decreasing null nets. In fact, we have the following general result.

Theorem 2.6. Let η_0 be the discrete convergence on F and let θ be a locally solid additive convergence on F. Then:

(i) A net $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ is $\eta_{0}\theta$ -null iff there is a (decreasing) θ -null net $(g_{\beta})_{\beta \in B} \subset F_{+}$ such that for every β there is α_{0} such that $f_{\alpha} \leq g_{\beta}$, for all $\alpha \geq \alpha_{0}$.

- (ii) $\eta_0 \theta$ and θ have the same decreasing null nets.
- (iii) $\eta_0 \theta$ is the strongest locally solid additive convergence on F in which every decreasing θ -null net is null.

(iv) If θ is linear and completely metrizable, then $\eta_0 \theta = ru$.

Proof. (i) follows from the definition. (iii) follows from (i) and [BCTvdW24, Lemma 3.7].

According to part (ii) of Proposition 2.1 every decreasing θ -null net is $\eta_0 \theta$ -null. According to (iii) $\theta \leq \eta_0 \theta$. This proves (ii).

(iv): Since ru is the strongest linear locally solid convergence on F (see [BCTvdW24, Proposition 5.1]), we only need to show that every decreasing θ -null is ru-null. It is well-known that if θ is metrizable, it is metrizable by a Riesz pseudo-norm. Let ρ be such and assume that a decreasing net $(f_{\alpha})_{\alpha \in A} \subset F_+$ is θ -null. There are $(\alpha_n)_{n \in \mathbb{N}} \subset A$ such that $\rho(f_{\alpha_n}) \leq \frac{1}{n^{2n}}$, so that $\rho(nf_{\alpha_n}) \leq \frac{1}{2^n}$, for every $n \in \mathbb{N}$. Let $e := \sum_{n \in \mathbb{N}} nf_n$, which exists due to completeness of ρ . It follows that $f_{\alpha_n} \leq \frac{1}{n}e$, hence $f_{\alpha_n} \xrightarrow{\mathrm{ru}} 0_F$. We can now use Lemma 1.6 and conclude that $f_{\alpha} \xrightarrow{\mathrm{ru}} 0_F$.

Example 2.7. Combining Example 1.5 with part (iv) of Theorem 2.6 yields that on a Banach lattice $\eta_0 aw = ru$.

Remark 2.8. It is not hard to show that $\eta_0(\eta_0\theta) = \eta_0\theta$, for any locally solid additive convergence θ on F. Hence, for θ we have that $\eta_0\theta = \theta$ iff $\theta = \eta_0\zeta$, for some locally solid additive convergence ζ on F. We will call convergences with this property *vertical*; they will be investigated elsewhere. Order, σ -order and relative uniform convergences are vertical. Note that for vertical θ we have that $\theta \ge \eta\theta$, for any η .

Example 2.9. Unsurprisingly, composition is not commutative. Let η be the norm convergence on a Banach lattice without a strong unit, and let θ be relative uniform convergence, which is strictly stronger than η . Since they have the same decreasing null nets, it follows that $\eta \theta = \eta \eta = \eta$ and $\theta \eta = \theta \theta = \theta$ (see [Bil23, Examples 2.5 and 2.6]).

2.1 Associativity of composition

We will now study the operation of adherence with respect to the composition of convergences.

Theorem 2.10. Let η , θ be locally solid additive convergences on F.

(i) If $H \subset F_+$ is positively solid, then $\overline{H}_{\eta\theta}^1 \subset \overline{\overline{H}}_{\eta\theta}^{-1}$ (adherences in F_+). If H is a latticeideal, then $\overline{H}_{\eta\theta}^1 = \overline{\overline{H}}_{\eta\theta}^{-1}$.

(*ii*) If $H \subset F$ is solid, then $\overline{H}_{\eta\theta}^1 \subset \overline{\overline{H}_{\eta\theta}^1}^1$. If H is an ideal, then $\overline{H}_{\eta\theta}^1 = \overline{\overline{H}_{\eta\theta}^1}^1$.

Proof. (i): Let $f \in \overline{H}_{\eta\theta}^{1}$. By Lemma 1.7 there is a net $(f_{\alpha})_{\alpha \in A} \subset H \cap [0_{F}, f]$ which $\eta\theta$ converges to f. Then, there is a θ -null co-ideal $G \subset F_{+}$ such that $((f-g)^{+} - f_{\alpha})^{+} = (f - f_{\alpha} - g)^{+} \xrightarrow{\eta} 0_{F}$, for every $g \in G$. According to Lemma 1.7 $(f - g)^{+} \in \overline{H}_{\eta}^{1}$, for
every $g \in G$, and as G is θ -null, we conclude that $f \in \overline{\overline{H}_{\eta\theta}^{1}}$.

We now assume that H is a lattice ideal and $f \in \overline{\overline{H}}_{\eta_{\theta}}^{1}$, so that there is $(f_{\beta})_{\beta \in B} \subset [0_F, f] \cap \overline{H}_{\eta}^{1}$ which θ -converges to f. Then, $g_{\beta} \xrightarrow{\theta} 0_F$, where $g_{\beta} = f - f_{\beta}$, for every β . For every β there is $(e_{\gamma}^{\beta})_{\gamma \in \Gamma_{\beta}} \subset [0_F, f] \cap H$ which η -converge to $f_{\beta} = f - g_{\beta}$. Hence, the net $((f - u - g_{\beta})^+)_{u \in [0_F, f] \cap H}$ is positive, decreasing and contains $((f_{\beta} - e_{\gamma}^{\beta})^+)_{\gamma \in \Gamma_{\beta}}$, which is η -null, therefore is itself η -null, according to Lemma 1.6. Thus, $f - u \xrightarrow{\eta \theta}{u \in [0_F, f] \cap H} 0_F$, from where $f \in \overline{H}_{\eta\theta}^1$.

(ii): Let $f \in \overline{H}_{\eta\theta}^1$. It is easy to see that then $|f| \in \overline{H}_{+\eta\theta}^1 \subset \overline{\overline{H}_{+\eta\theta}^1}^1 \subset \overline{\overline{H}_{\eta\theta}^1}^1$. As the latter set is solid, it follows that $f \in \overline{\overline{H}_{\eta\theta}^1}^1$.

Assume that H is an ideal and $f \in \overline{\overline{H}_{\eta_{\theta}}^{1}}$. One can show that then $|f| \in \overline{\overline{H}_{+\eta_{\theta}}^{1}} = \overline{\overline{H}_{+\eta_{\theta}}^{1}} \subset \overline{\overline{H}_{\eta_{\theta}}^{1}}$. Since the latter set is an ideal, we conclude that $f \in \overline{\overline{H}_{\eta_{\theta}}^{1}}$.

Analogously, using Corollary 1.9 one can get the following result.

Proposition 2.11. If $G \subset F_+$ is a co-ideal, then $G \xrightarrow{\eta \theta} 0_F$ iff $0_F \in \overline{G}_{\eta \theta}^{-1}$.

Theorem 2.12. Composition is associative.

Proof. Let η, θ, ζ be locally solid additive convergences on F. We first prove that $\eta(\theta\zeta) \geq (\eta\theta)\zeta$. Assume that $0_F \leq f_\alpha \xrightarrow{\eta(\theta\zeta)} 0_F$, so that there are $(g_\beta)_{\beta\in B} \subset F_+$ and a ζ -null $(h_\gamma)_{\gamma\in\Gamma} \subset F_+$ such that $(f_\alpha - g_\beta)^+ \xrightarrow{\eta} 0_F$, for every β , and $(g_\beta - h_\gamma)^+ \xrightarrow{\theta} 0_F$ for every γ . Let us show $(f_\alpha - h_\gamma)^+ \xrightarrow{\eta\theta} 0_F$, for every γ . Indeed, take $((g_\beta - h_\gamma)^+)_{\beta\in B}$ as a control net, and observe that for every γ we have

$$\left[(f_{\alpha} - h_{\gamma})^{+} - (g_{\beta} - h_{\gamma})^{+} \right]^{+} \leq (f_{\alpha} - g_{\beta})^{+} \xrightarrow{\eta} 0_{F}.$$

Next, we show that $\eta(\theta\zeta) \leq (\eta\theta)\zeta$. Assume that $0_F \leq f_\alpha \xrightarrow{(\eta\theta)\zeta} 0_F$ and let $(g_\beta)_{\beta\in B}$ be the controlling ζ -null net. It was established in the proof of Proposition 2.2 that $G := \left\{g \in F_+, (f_\alpha - g)^+ \xrightarrow{\eta} 0_F\right\}$ is a co-ideal. For every $\beta \in B$ we have that $(f_\alpha - g_\beta)^+ \xrightarrow{\eta\theta} 0_F$, and so there is a θ -null $(e_\gamma^\beta)_{\gamma\in\Gamma_\beta} \subset F_+$ such that $(f_\alpha - g_\beta - e_\gamma^\beta)^+ = ((f_\alpha - g_\beta)^+ - e_\gamma^\beta)^+ \xrightarrow{\eta} 0_F$. Hence, $g_\beta + e_\gamma^\beta \in G$, for every $\beta \in B$ and $\gamma \in \Gamma_\beta$. It now follows that $g_\beta \in \overline{G}_\theta^1$, for every $\beta \in B$, thus $0_F \in \overline{G}_{\theta\zeta}^{-1}$. According to Proposition 2.11, this implies that $G \xrightarrow{\theta\zeta} 0_F$. Therefore, G is a control net for $f_\alpha \xrightarrow{\eta(\theta\zeta)} 0_F$.

Let us describe how to take the composition of infinitely many convergences. The proof is a standard transfinite induction argument and relies on the fact that an infimum of a directed set of Hausdorff convergences is Hausdorff.

Proposition 2.13. Let n_0 be an ordinal, and assume that for every successor ordinal $n \leq n_0$ there is a locally solid additive convergence η_n on F. Define $\prod_{k=1}^n \eta_k$ inductively by $\prod_{k=1}^n \eta_k := \left(\prod_{k=1}^{n-1} \eta_k\right) \eta_n$, if n > 1 is a successor ordinal and $\prod_{k=1}^n \eta_k := \bigwedge_{m < n} \prod_{k=1}^m \eta_k$ otherwise. Then, $\prod_{k=1}^{n_0} \eta_k$ is a locally solid additive convergence. It is linear if at least one of η_n is and Hausdorff iff all η_n are. Moreover, $\prod_{k=1}^n \eta_k = \prod_{k=1}^m \eta_k \prod_{k=m+1}^n \eta_k$, for any m < n.

2.2 Composition vs. operations with convergences

In this subsection we obtain a series of similar results about the way various operations with convergences "commute" with composition. We start with the extension a la Example 1.1.

Proposition 2.14. If $E \subset F$ is an ideal, and η, θ are locally solid additive convergences on E, then $\eta_F \theta_F = (\eta \theta)_F$.

Proof. If $f_{\alpha} \xrightarrow{\eta_F \theta_F} 0_F$ then there is a θ -null net $(g_{\beta})_{\beta \in B} \subset E_+$ such that $(f_{\alpha} - g_{\beta})^+ \xrightarrow{\eta} 0_F$, for every β ; in particular $(f_{\alpha})_{\alpha \in A}$ is eventually in E, and so it is $(\eta \theta)_F$ -null. The converse implication is proven similarly.

We now look at how composition interacts with the unbounded modification.

Proposition 2.15. If $E \subset F$ is an ideal and η, θ are locally solid additive convergences on F, then $u_E \eta u_E \theta \ge u_E (\eta \theta)$.

Proof. Assume that $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ is $u_{E}\eta u_{E}\theta$ -null. Then, by Proposition 2.1 there are nets $(h_{\alpha\beta})_{\alpha \in A, \beta \in B}$ and $(g_{\beta})_{\beta \in B}$ in F_{+} such that $0_{F} \leq f_{\alpha} \leq h_{\alpha,\beta} \xrightarrow{u_{E}\eta} g_{\beta} \xrightarrow{u_{E}\theta} 0_{F}$. For every $e \in E_{+}$ we have $f_{\alpha} \wedge e \leq h_{\alpha,\beta} \wedge e \xrightarrow{\eta} g_{\beta} \wedge e \xrightarrow{\theta} 0_{F}$. Using Proposition 2.1 again we obtain $e \wedge f_{\alpha} \xrightarrow{\eta\theta} 0_{F}$. As e was arbitrary, we conclude that $f_{\alpha} \xrightarrow{u_{E}(\eta\theta)} 0_{F}$. Remark 2.16. Recall that θ and $u\theta$ have the same decreasing null nets. Hence, according to Corollary 2.3, $u\eta u\theta = (u\eta)\theta$. It is not clear whether $u_E\eta u_E\theta = (u_E\eta)\theta$, for any ideal $E \subset F$.

Next, we consider what happens with composition under a pull-back. If $T: F \to E$ is a positive operator, and η is a locally solid additive convergence on E, define the convergence η_T on F by $0_F \leq f_\alpha \xrightarrow{\eta_T} 0_F$ if $Tf_\alpha \xrightarrow{\eta} 0_E$ (this determines an additive locally solid convergence on F by Theorem 1.2).

Proposition 2.17. If $T : F \to E$ is a positive operator, and η, θ are locally solid additive convergences on E, then $\eta_T \theta_T \ge (\eta \theta)_T$. If T is a surjective homomorphism, then $\eta_T \theta_T = (\eta \theta)_T$.

Proof. Assume that $0_F \leq f_{\alpha} \xrightarrow{\eta_T \theta_T} 0_F$ so that there is a θ_T -null net $(g_{\beta})_{\beta \in B} \subset F_+$ such that $(f_{\alpha} - g_{\beta})^+ \xrightarrow{\eta_T} 0_F$, for every β . Then, $Tg_{\beta} \xrightarrow{\eta} 0_F$ and $0_F \leq (Tf_{\alpha} - Tg_{\beta})^+ \leq T(f_{\alpha} - g_{\beta})^+ \xrightarrow{\eta_T} 0_F$, for every β . This means that $(Tf_{\alpha})_{\alpha \in A}$ is $\eta\theta$ -null with the controlling net $(Tg_{\beta})_{\beta \in B}$.

Assume that T is a surjective homomorphism and $0_F \leq f_\alpha \xrightarrow{(\eta\theta)_T} 0_F$, so that there is a θ -null net $(e_\beta)_{\beta\in B} \subset E_+$ such that $(Tf_\alpha - e_\beta)^+ \xrightarrow{\eta} 0_F$, for every β . Since Tis surjective homomorphism, there is $g_\beta \in F_+$ such that $Tg_\beta = e_\beta$, for every β . It follows that $g_\beta \xrightarrow{\theta_T} 0_F$, and $T(f_\alpha - g_\beta)^+ = (Tf_\alpha - e_\beta)^+ \xrightarrow{\eta} 0_F$, for every β . Thus, $f_\alpha \xrightarrow{\eta_T \theta_T} 0_F$.

The final operation we consider in this section is the Choquet modification (see [BCTvdW24, Section 9]).

Proposition 2.18. If η , θ are locally solid additive convergences on F, then $c\eta c\theta = (c\eta) \theta \ge c (\eta\theta)$.

Proof. First, recall that θ agrees with $c\theta$ on monotone nets (see [BCTvdW24, Proposition 9.7]). Hence, according to Corollary 2.3, $c\eta c\theta = (c\eta) \theta$.

Assume that \mathcal{F} is a $(c\eta) \theta$ -null filter on F, so that there is a θ -null net $(g_{\beta})_{\beta \in B} \subset F_+$ such that $(|\mathcal{F}| - g_{\beta})^+ \xrightarrow{c\eta} 0_F$, for every β . Let $\mathcal{U} \supset \mathcal{F}$ be an unltrafilter. For every β , we have that $(|\mathcal{U}| - g_{\beta})^+$ is an ultrafilter on F that contains $(|\mathcal{F}| - g_{\beta})^+$, and so is η -null. As β is arbitrary, according to Proposition 2.2, $\mathcal{U} \xrightarrow{\eta \theta} 0_F$, and since \mathcal{U} is arbitrary, we conclude that $\mathcal{F} \xrightarrow{c(\eta \theta)} 0_F$.

The last three results motivate the following questions.

Question 2.19. Do we always have $c\eta c\theta = c (\eta \theta)$, $\eta_T \theta_T = (\eta \theta)_T$ and $u_E \eta u_E \theta = u_E (\eta \theta)$?

2.3 Idempotent convergences

The remaining part of the section will be devoted to the *idempotent* convergences, i.e. locally solid additive convergences η on F such that $\eta^2 = \eta$.

Example 2.20. It was observed in [Bil23, Examples 2.5 and 2.6, and Proposition 4.5] that order convergence along with any locally solid additive topology is idempotent, while relative uniform convergence is idempotent under the additional assumption that F has σ -property (every sequence is contained in a principal ideal).

Relative uniform convergence can be idempotent even without σ -property. Indeed, let $F = c_{00}$ which clearly does not have the σ -property. Since F is Archimedean, order convergence on F is weaker than relative uniform convergence. On the other hand, every order convergent net is eventually order bounded, hence finitely dimensional, and so order convergence coincides with the finite-dimensional convergence on F. As the latter is the strongest linear convergence on F (see [BCTvdW24, Proposition 7.12]), all three coincide. Since order convergence is always idempotent, it follows that relative uniform convergence is idempotent on F.

Question 2.21. Is it true that if X is a Tychonoff space such that ru is idempotent on C(X), then the latter has σ -property? Same question for $C^{\infty}(X)$, for X extremally disconnected.

Example 2.22. Let us show that σ -order convergence is also idempotent. Assume that $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ is such that there is a decreasing σ o-null net $(g_{\beta})_{\beta \in B}$ such that $(f_{\alpha} - g_{\beta})^{+} \xrightarrow{\sigma_{0}} 0_{F}$, for every β . Since $(g_{\beta})_{\beta \in B}$ is decreasing and σ o-null, it is not hard to show that there are $(\beta_{n})_{n \in \mathbb{N}}$ such that $\bigwedge_{n \in \mathbb{N}} g_{\beta_{n}} = 0_{F}$. For every $n \in \mathbb{N}$ let H_{n} be a countable set which witnesses $(f_{\alpha} - g_{\beta_{n}})^{+} \xrightarrow{\sigma_{0}} 0_{F}$. It is left to observe that $H := \bigcup_{n \in \mathbb{N}} (g_{\beta_{n}} + H_{n})$ witnesses $f_{\alpha} \xrightarrow{\sigma_{0}} 0_{F}$.

Example 2.23. The unbounded modification of an idempotent convergence is idempotent. Let η be an idempotent convergence on F and let $E \subset F$ be an ideal. Then, $u_E \eta \ge u_E \eta u_E \eta \ge u_E (\eta^2) = u_E \eta$, where the first inequality follows from part (i) of Proposition 2.1, the second one – from Proposition 2.15, whereas the last equality results from idempotency of η .

Analogously, using propositions 2.17 and 2.18 one can show that the Choquet modification and any pull-back of an idempotent convergence are idempotent. \Box

Example 2.24. It can be easily checked that the supremum of any collection of idempotent convergences is idempotent. \Box

Example 2.25. Any locally solid additive convergence can be "idempotentified". Let η be such a convergence, and let n_0 be the first ordinal of a cardinality larger than that of the set of all convergences on F. In the notation of Proposition 2.13, let $\eta_n = \eta$, for every successor ordinal $n < n_0$. Then, the decreasing net $(\eta^n)_{n \le n_0}$ of convergences has to stabilize by the cardinality reasons. It is then easy to see by Proposition 2.13 that η^{n_0} is idempotent. Also, it is the strongest idempotent convergence weaker than η .

The class of vector lattices with $\operatorname{ru}^{\omega_1} = \sigma o$ was investigated in [Fre78]. That paper also contains examples from this class which show that any countable ordinal might be needed to idempotify ru. In particular, it was observed there that for $F = \mathbb{R}^{[0,1]}$, we have $\operatorname{ru} > \sigma o = \operatorname{ru}^2$ (see also Example 2.5), which is the first explicit example of a non-idempotent locally solid convergence. Example 2.26. Let X be a convergence space. Recall that a net $(f_{\alpha})_{\alpha \in A} \subset \mathcal{C}(X)$ is continuously convergent to $f \in \mathcal{C}(X)$ if for every $x \in X$ and any net $(x_{\gamma})_{\gamma \in \Gamma} \subset X$ convergent to x, we have $f_{\alpha}(x_{\gamma}) \xrightarrow{\alpha, \gamma} f(x)$. Let us show that this convergence is idempotent. Assume that $0 \leq g_{\beta} \xrightarrow{c} 0$ and $(f_{\alpha})_{\alpha \in A} \subset \mathcal{C}(X)_{+}$ is such that $(f_{\alpha} - g_{\beta})^{+} \xrightarrow{c} 0$, for every β . Fix $x, x_{\gamma} \to x$ and $\varepsilon > 0$. We have that $g_{\beta}(x_{\gamma}) \to 0$, and so there are β_{0}, γ_{0} such that $g_{\beta}(x_{\gamma}) \leq \frac{\varepsilon}{2}$, for all $\beta \geq \beta_{0}$ and $\gamma \geq \gamma_{0}$. As $(f_{\alpha} - g_{\beta_{0}})^{+} \xrightarrow{c} 0$, there are α_{0} and $\gamma_{1} \geq \gamma_{0}$ such that $(f_{\alpha}(x_{\gamma}) - g_{\beta_{0}}(x_{\gamma}))^{+} \leq \frac{\varepsilon}{2}$, for all $\alpha \geq \alpha_{0}$ and $\gamma \geq \gamma_{1}$. Then, $f_{\alpha}(x_{\gamma}) \leq (f_{\alpha}(x_{\gamma}) - g_{\beta_{0}}(x_{\gamma}))^{+} + g_{\beta_{0}}(x_{\gamma}) \leq \frac{\varepsilon}{2} + \frac{\varepsilon}{2} \leq \varepsilon$, for all $\alpha \geq \alpha_{0}$ and $\gamma \geq \gamma_{1}$. Since ε was chosen arbitrarily, it follows that $f_{\alpha}(x_{\gamma}) \xrightarrow{\alpha, \gamma} 0$. Due to arbitrariness of $(x_{\gamma})_{\gamma \in \Gamma}$, we conclude that $f_{\alpha} \xrightarrow{c} 0$.

Remark 2.27. Let X be a Tychonoff topological space. One can show that $0 \leq f_{\alpha} \xrightarrow{c} 0$ iff for every $x \in X$ and for every $\varepsilon > 0$ there are an open neighborhood U of x and α_0 such that $f_{\alpha}|_U \leq \varepsilon$, for every $\alpha \geq \alpha_0$. Interchanging the middle quantifiers we arrive at *local uniform* convergence: $0 \leq f_{\alpha} \xrightarrow{lu} 0$ if for every $x \in X$ there is an open neighborhood U of x such that for every $\varepsilon > 0$ there is α_0 such that $f_{\alpha}|_U \leq \varepsilon$, for every $\alpha \geq \alpha_0$. It follows immediately that local uniform convergence is a Hausdorff linear locally solid convergence. It would be interesting to characterize for which X's, this convergence is idempotent. This is the case if X is locally compact, since then lu coincides with the compact-open topology.

From the monotonicity of the product, it follows that if η is idempotent and $\theta \ge \eta$, then $\eta \ge \eta \theta \ge \eta \eta = \eta$. If θ is vertical (see Example 2.8), and $\eta \ge \theta$, then $\theta \ge \eta \theta \ge \theta \theta = \theta$.

It follows from Theorem 2.10 that if F is endowed with an idempotent convergence, the adherence of every ideal in F is closed (and so equal to its closure). Indeed, if $H \subset F$ is an ideal, then $\overline{H}_{\eta_{\eta}}^{1^{-1}} = \overline{H}_{\eta^{2}}^{1} = \overline{H}_{\eta}^{1}$. Similarly, the adherence in F_{+} of any lattice-ideal of F_{+} is also closed. Moreover, if $G \subset F_{+}$ is a co-ideal, then $G \to 0_{F}$ iff $0_{F} \in \overline{G}$.

Proposition 2.28. For an idempotent convergence η and a net $(f_{\alpha})_{\alpha \in A} \subset F_{+}$ the set $\left\{g \in F_{+}, (f_{\alpha} - g)^{+} \xrightarrow{\eta} 0_{F}\right\}$ is an η -closed co-ideal.

Proof. Call the set in question G. It was proven in Proposition 2.2 that G is a co-ideal. Assume that $g \in \overline{G}_{\eta}^{1}$, so that there is a net $(g_{\beta})_{\beta \in B} \subset G$ converging to g. We have that $((f_{\alpha} - g)^{+} - (g_{\beta} - g)^{+})^{+} \leq (f_{\alpha} - g_{\beta})^{+} \xrightarrow{\eta} 0_{F}$, for every β . As $(g_{\beta} - g)^{+} \xrightarrow{\eta} 0_{F}$, and η is idempotent, we conclude that $(f_{\alpha} - g)^{+} \xrightarrow{\eta} 0_{F}$, thus $g \in G$.

We conclude this section by showing that any additive idempotent convergence has a closed "ideal of linearity".

Proposition 2.29. If F is endowed with an additive locally solid idempotent convergence, then $\{f \in F, \frac{1}{n}f \to 0_F\}$ is a closed ideal.

Proof. It is straightforward to verify that the set E in question is an ideal. To show that it is closed, let $f \in \overline{E}_+^1 \subset \overline{E}_+^{-1}$, so that $[0_F, f] \cap E \to f$. We have that $\frac{1}{n}f \leq \frac{1}{n}e + f - e \xrightarrow[n \in \mathbb{N}]{} f - e \xrightarrow[e \in [0_F, f] \cap E]{} 0_F$, and since the convergence is idempotent, it follows that $\frac{1}{n}f \to 0_F$, hence $f \in E$.

3 Some applications

3.1 Existence of the weakest locally solid convergence

In this subsection we will focus on minimal and weakest Hausdorff locally solid convergences, and close some gaps that were left open in [BCTvdW24, Section 10]. Throughout this section F is an Archimedean vector lattice. The following simple fact will come very handy.

Lemma 3.1. For every additive Hausdorff locally solid convergence on F there is a weaker linear Hausdorff locally solid convergence.

Proof. If η is an additive Hausdorff locally solid convergence on F, the product η ru is a convergence that satisfies the required properties due to Proposition 2.1.

Question 3.2. Find an explicit description of the strongest linear (locally solid) convergence weaker than a given additive (locally solid) one.

Corollary 3.3.

(i) Every minimal additive Hausdorff locally solid convergence on F is linear.

- (ii) Every minimal linear Hausdorff locally solid convergence on F is also a minimal additive Hausdorff locally solid convergence.
- (iii) The weakest linear Hausdorff locally solid convergence on F (if exists) is also the weakest additive Hausdorff locally solid convergence.

Proof. A minimal additive Hausdorff locally solid convergence has to be equal to the linear convergence from Lemma 3.1, and thus is itself linear. If η is a minimal linear Hausdorff locally solid convergence, $\theta \leq \eta$ is an additive Hausdorff locally solid convergence, and $\zeta \leq \theta$ is the linear convergence from Lemma 3.1, it follows from minimality that $\zeta = \eta = \theta$. The last claim is proven similarly.

It follows that the sets of minimal additive and linear Hausdorff locally solid convergences coincide. Therefore, we can speak of simply *minimal Hausdorff locally solid convergences*. Similarly we can speak of *the weakest Hausdorff locally solid convergence*.

It was proven in [BCTvdW24, Proposition 10.4] that if F is an atomic Archimedean vector lattice then the coordinate-wise convergence is the weakest Hausdorff linear locally solid convergence. Before proving a kind of a converse to this statement, we need the following concept.

Call convergences η , θ on a set X compatible if the diagonal is closed in $(X \times X, \eta \times \theta)$, and *incompatible* otherwise, i.e. there is a net which has two different limits with respect to η , θ . In particular, η is Hausdorff iff it is compatible with itself. Note that if η , θ are incompatible, and $\eta' \leq \eta$, $\theta' \leq \theta$, then η' , θ' are incompatible. In particular there are no Hausdorff convergences weaker than both η , θ .

Theorem 3.4. TFAE:

(i) F is atomic;

(ii) uo is a minimal Hausdorff locally solid convergence on F;

(iii) cuo is a minimal Hausdorff locally solid convergence on F;

(iv) There is a unique minimal Hausdorff locally solid convergence on F;

(v) F admits the weakest Hausdorff locally solid convergence.

Proof. (i) \Rightarrow (ii): If F is atomic, then the coordinate-wise convergence, which is the weakest Hausdorff locally solid convergence, coincides with uo (see [BCTvdW24, Corollary 10.5]).

(ii) \Rightarrow (iii) follows from cuo \leq uo.

(iii) \Rightarrow (iv): It was proven in [BCTvdW24, Proposition 10.9 and Theorem 10.13] that every minimal Hausdorff locally solid convergence has to be Choquet, and weaker than uo, hence weaker than cuo. Since the latter is minimal, it is the only minimal Hausdorff locally solid convergence on F.

 $(iv) \Rightarrow (v)$ follows from the fact that the set of all Hausdorff locally solid (linear or additive) convergences satisfies the conditions of Zorn's lemma (downward).

 $(v) \Rightarrow (i)$: We will show that if F is not atomic, there are two incompatible Hausdorff locally solid convergences on F. Since the weakest Hausdorff convergence would have to be weaker than both of them, it does not exist.

Let $e > 0_F$ be in the atomless part of F. Let $J : F_e \to C(K)$ be an injective homomorphism with a dense range such that Je = 1. It follows from e.g. [ABT24, Lemma 4.2] that K has no isolated points, and so according to [Hew43] there is a dense $L \subset K$ such that $M := K \setminus L$ is also dense. Let η be a convergence on C(K) defined by: $g_\alpha \xrightarrow{\eta} g$ if $g_\alpha(x) \to g(x)$, for every $x \in L$, i.e. it is the pointwise convergence over L. Let θ be the pointwise convergence over M (also on C(K)). Both of these convergences are Hausdorff linear locally solid (because they are induced by separating collections of Riesz semi-norms).

We can now pull-back the convergences η and θ along J (which is injective) and obtain Hausdorff linear locally solid convergences η_J and θ_J on F_e . Then, we extend these two convergences as explained before Example 1.4 to get Hausdorff locally solid additive convergences η_{JF} and θ_{JF} on F. It is left to show that η_{JF} and θ_{JF} are incompatible.

Let $A \subset L$ and $B \subset M$ be finite. Then, A, B are closed disjoint sets, and so according to Sublattice Urysohn Lemma (see e.g. [Bil24, Proposition 2.1]) there are $g_{A,B} \in JF_e \cap [0,1]$ such that $g_{A,B}(x) = 0$, for every $x \in A$, and $g_{A,B}(x) = 1$, for every $x \in B$. It follows that $g_{A,B} \xrightarrow{\eta} 0$ and $g_{A,B} \xrightarrow{\theta} 1$.

Let $f_{A,B} := J^{-1}g_{A,B} \in F_e$, for finite $A \subset L$ and $B \subset M$. We have $Jf_{A,B} = g_{A,B} \xrightarrow{\eta}_{A,B}$ O and $J(e - f_{A,B}) = \mathbb{1} - g_{A,B} \xrightarrow{\theta}_{A,B} O$, hence $f_{A,B} \xrightarrow{\eta_J}_{A,B} O_F$ and $f_{A,B} \xrightarrow{\theta_J}_{A,B} e$. This implies that $f_{A,B} \xrightarrow{\eta_{JF}}_{A,B} O_F$ and $f_{A,B} \xrightarrow{\theta_{JF}}_{A,B} e$, which makes η_{JF} and θ_{JF} incompatible.

Remark 3.5. We answered [BCTvdW24, Question 10.23] in the negative. Along the way we also proved that it is not true that every Hausdorff Choquet unbounded idempotent order continuous locally solid linear convergence is a minimal Hausdorff locally solid convergence. Indeed, cuo is Choquet by definition, order continuous since both

unbounded and Choquet modifications weaken the convergence, locally solid and unbounded by [BCTvdW24, Propositions 9.7 and 9.8], idempotent by Example 2.23, but is not minimal, unless F is atomic.

Question 3.6. Is to the supremum of all minimal Hausdorff locally solid convergences on F?

3.2 Applications to unbounded modification

Throughout this subsection F is an Archimedean vector lattice. Recall that the unbounded modification $u_A\eta$ of a locally solid convergence η on F by $A \subset F$ is defined by $0_F \leq f_\alpha \xrightarrow{u_A\eta} 0_F$ if $|a| \wedge f_\alpha \xrightarrow{\eta} 0_F$, for every $a \in A$. We denote $u\eta := u_F\eta$ and $u_a\eta := u_{\{a\}}\eta$, for $a \in F$. Let us reproduce some basic facts about this modification.

Proposition 3.7 ([Bil23], Proposition 3.1). Let $A \subset F$ and let η be a locally solid additive convergence on F. Then:

(i) $u_A\eta$ is the weakest locally solid additive convergence on F, which is stronger than (in fact coincides with) η on $[0_F, |a|]$, for every $a \in A$.

(ii) $u_A \eta = u_{I(A)} \eta$; if η is idempotent, then $u_A \eta = u_{\overline{I(A)}} \eta$.

It follows that the correspondence $A, \eta \mapsto u_A \eta$ is very far from being injective. In this section we revisit some results in the literature which either relax the definition of the unbounded modification, or explore the limitations of such a relaxation. In particular, some results available for locally solid topologies are true for idempotent locally solid additive convergences.

Proposition 3.8 (cf. [Tay19], Theorem 9.6). If η is an order continuous idempotent locally solid convergence and E is an order dense ideal, then $u_E \eta = u\eta$.

Proof. It is easy to see that E is dense with respect to order convergence, hence $u_E \eta = u_E \eta = u_F \eta = u_F \eta = u_\eta$.

Next, let us somewhat improve [Bil23, Proposition 3.3] and clean up its proof. The following lemmas are contained there already.

Lemma 3.9. Let η be an additive locally solid additive convergence on F. If $(f_{\alpha})_{\alpha \in A} \subset F$ and $e, f \in F$ are such that $f_{\alpha} \wedge e \xrightarrow{\eta} f \wedge e$. Then, $(e - f)^+ \wedge |f_{\alpha} - f| \xrightarrow{\eta} 0_F$.

Lemma 3.10. For every $e, f \in F_+$ we have $e \wedge (ne - f)^+ \xrightarrow{\|\cdot\|_f} e$ (and so $e \wedge (ne - f)^+ \xrightarrow{\mathrm{ru}} e$).

Proposition 3.11. Let η be an idempotent linear locally solid convergence on F, let $E \subset F$ be an ideal, and let $G \subset E_+$ be such that $\overline{I(G)}_{\eta} = E$. Then, $0_F \leq f_{\alpha} \xrightarrow{u_E \eta} f \in F_+$ iff $f_{\alpha} \wedge ng \xrightarrow{\eta} f \wedge ng$, for every $g \in G$ and $n \in \mathbb{N}$.

Proof. Necessity: If $f_{\alpha} \xrightarrow{\mathbf{u}_E \eta} f$, then by continuity of the lattice operations we have $f_{\alpha} \wedge ng \xrightarrow{\mathbf{u}_E \eta} f \wedge ng$, for every $g \in G$ and $n \in \mathbb{N}$. It is left to recall that $\mathbf{u}_E \eta$ agrees with η on each of $[0_F, ng]$.

Sufficiency: According to [Bil23, Proposition 2.4] the set $H := \left\{ h \in F : |h| \land |f_{\alpha} - f| \xrightarrow{\eta} 0_F \right\}$ is a η -closed ideal. By Lemma 3.9 this ideal

contains $(ng - f)^+$, for every $g \in G$ and $n \in \mathbb{N}$. Since η is linear, it is weaker than relative uniform convergence (see [BCTvdW24, Proposition 5.1]), and so H is relatively uniformly closed. As $H \ni g \land (ng - f)^+ \xrightarrow{\mathrm{ru}} g$, it follows that $g \in H$, for every $g \in G$. Thus, $E = \overline{I(G)}_{\eta} \subset H$ and so $f_{\alpha} \xrightarrow{\mathrm{u}_E \eta} f$.

Corollary 3.12. If η is linear idempotent and $h \in F_+$ is a topological unit (i.e. $\overline{F_{h\eta}} = F$), then for a net $(f_{\alpha})_{\alpha \in A} \subset F_+$ we have $f_{\alpha} \xrightarrow{u\eta} f \in F_+$ iff $f_{\alpha} \wedge nh \xrightarrow{\eta} f \wedge nh$, for every $n \in \mathbb{N}$.

We will now generalize some results from [KT18, Section 3], where the opposite problem is considered. Namely, what can be said about η, θ, E, H if $u_E \theta \ge u_H \eta$? Let us start with a fact similar to Lemma 3.10 (the proof is contained in the proof of [BCTvdW24, Lemma 11.4]).

Lemma 3.13. For every $e, f \in F_+$ we have $f \wedge ne \xrightarrow{u_e \parallel \cdot \parallel_f} f$, and so $f \wedge ne \xrightarrow{u_e ru} f$.

Proposition 3.14. Let $E \subset F$ be an ideal, and let $f \in F_+$. Then $u_E \| \cdot \|_f \ge u_f \eta \Rightarrow$ $f \in \overline{E}_{\eta}^1 \Rightarrow u_E \| \cdot \|_f \ge u_f (\| \cdot \|_f \eta)$. In particular, if η is idempotent and linear, then $u_E \| \cdot \|_f \ge u_f \eta \Leftrightarrow f \in \overline{E}_{\eta}^1 = \overline{E}_{\eta}$.

Proof. Let us prove the first implication. Fix $e \in E_+$. The set $[0_F, f] \cap E$ is an increasing net which contains $(f \wedge ne)_{n \in \mathbb{N}}$. By Lemma 3.13 the latter sequence $u_e \| \cdot \|_f$ -converges to f, and so $[0_F, f] \cap E \xrightarrow{u_e \| \cdot \|_f} f$, according to Lemma 1.6. Since e was arbitrary, we conclude that $[0_F, f] \cap E \xrightarrow{u_E \| \cdot \|_f} f$.

As $u_E \| \cdot \|_f \ge u_f \eta$, it follows that $[0_F, f] \cap E \xrightarrow{u_f \eta} f$. By part (i) of Proposition 3.7 $u_f \eta$ coincides with η on $[0_F, f]$, and so $[0_F, f] \cap E \xrightarrow{\eta} f$. Thus, $f \in \overline{E}_{\eta}^1$.

We now prove the second implication. Assume that $0_F \leq f_{\alpha} \xrightarrow{\mathbf{u}_E \|\cdot\|_f} 0_F$, then for every $e \in [0_F, f] \cap E$ we have $e \wedge f_{\alpha} \xrightarrow{\|\cdot\|_f} 0_F$. It follows that $f \wedge f_{\alpha} \leq e \wedge f_{\alpha} + f - e \xrightarrow{\|\cdot\|_f} f - e \xrightarrow{\eta} e \in [0_F, f] \cap E} 0_F$, where the second convergence follows from Corollary 1.8. Thus, by Proposition 2.2 we conclude that $f_{\alpha} \xrightarrow{\mathbf{u}_f(\|\cdot\|_f \eta)} 0_F$.

For the last claim, observe that if η is idempotent and linear, we have $\|\cdot\|_f \ge \eta$, from where $\|\cdot\|_f \eta \ge \eta^2 = \eta$.

Theorem 3.15. Let η , θ be locally solid additive convergences on F and let $E, H \subset F$ be ideals. Then:

(i) If θ is linear and $\mathbf{u}_E \theta \geq \mathbf{u}_H \eta$, then $H \subset \overline{E}_{\eta}^1$ and $\theta|_{[0_F,e]} \geq \eta|_{[0_F,e]}$, for every $e \in E \cap H$.

(ii) If η is idempotent, then $u_E \theta \ge u_H \eta$ whenever $H \subset \overline{E}_{\eta}^1 = \overline{E}_{\eta}$ and $\theta|_{[0_F,e]} \ge \eta|_{[0_F,e]}$, for every $e \in E \cap H$.

Proof. (i): Since θ is linear, for every $h \in H$ we have that $\mathbf{u}_E \| \cdot \|_h \ge \mathbf{u}_E \theta \ge \mathbf{u}_H \eta \ge \mathbf{u}_h \eta$. Proposition 3.14 now guarantees that $h \in \overline{E}_n^1$.

For every $e \in E \cap H$, η and θ coincide with $u_H \eta$ and $u_E \theta$, respectively, on $[0_F, e]$, which justifies the second conclusion.

(ii): Our assumption together with the extremal property of the unbounded convergence discussed in part (i) of Proposition 3.7 imply that $\mathbf{u}_{E\cap H}\theta \geq \mathbf{u}_{E\cap H}\eta$. It then follows from Proposition 1.10 that $H \subset \overline{E}_{\eta} \cap \overline{H}_{\eta} = \overline{E \cap H}_{\eta}$. Thus, using part (ii) Proposition 3.7 we conclude that $\mathbf{u}_{H}\eta \leq \mathbf{u}_{E\cap H}\eta = \mathbf{u}_{E\cap H}\eta \leq \mathbf{u}_{E\cap H}\theta \leq \mathbf{u}_{E}\theta$.

Corollary 3.16. If η is linear and idempotent and $A, B \subset F$, then $u_A \eta \geq u_B \eta$ iff $B \subset \overline{I(A)}$.

Note that $u_E \theta \ge u_H \eta$ can be only true for sequences (as opposed to all nets). For such an occasion we have the following generalization of [KT18, Theorem 3.3].

Proposition 3.17. Let η, θ be locally solid additive convergences on F and let $E, H \subset F$ be ideals. Assume furthermore that θ is linear and H is countably generated. If $u_H \theta \ge u_E \eta$ on sequences, then E is contained in the sequential η -adherence of H.

Proof. We may assume that $H = I\left(\{h_n\}_{n\in\mathbb{N}}\right)$, where $(h_n)_{n\in\mathbb{N}}$ is increasing. Fix $e \in E$. From Lemma 3.13, for $n \ge m$ we have that $h_m \wedge (e - nh_n)^+ \le h_m \wedge (e - nh_m)^+ \xrightarrow[n]{} 0_F$, hence $h_m \wedge (e - nh_n)^+ \xrightarrow[n]{} 0_F$, for every $m \in \mathbb{N}$. It then follows that $(e - nh_n)^+ \xrightarrow[n]{} 0_F$, therefore $e \wedge nh_n \xrightarrow[n]{} u_H \theta$, which according to our assumption yields $[0_F, e] \cap H \ni e \wedge nh_n \xrightarrow[n]{} e$. As η and $u_E \eta$ agree on $[0_F, e]$, we conclude that e is in the sequential η -adherence of H.

Let $E \subset F$ be a sublattice, and let $H \subset E$ be an ideal of F. For an additive locally solid convergence η on F we have $(u_H \eta)|_E = u_H(\eta|_E)$, i.e. in this case restricting to E commutes with unbounding by H. However, if $H \not\subset E$, in general we only have $(u_H \eta)|_E \ge u_{E \cap H}(\eta|_E)$. In particular, for the case H = F, in general we only have $(u\eta)|_E \ge u(\eta|_E)$. If the latter inequality is in fact equality, we will say that η commutes with E. Some sufficient conditions for this to occur were presented in [KMT17, Section 4] and [Tay19, Lemma 3.4]. We extend them in the following result.

Proposition 3.18. Let η be a locally solid additive convergence on F and let $E \subset F$ be a sublattice. Then:

- (i) If η commutes with E, and $H \subset E$ is a sublattice such that $\eta|_E$ commutes with H, then η commutes with H.
- (ii) If I(E) is a projection band, then E commutes with η .

(iii) If η is idempotent and $\overline{I(E) + E^d}_n = F$, then E commutes with η .

(iv) If η is idempotent and order continuous, then E commutes with η .

Proof. (i) is proven by unpacking the definitions. (ii) is proven similarly to (iii), and (iv) follows from (iii), since $I(E) + E^d$ is always dense with respect to order convergence.

(iii): If $0_E \leq e_\alpha \xrightarrow{\mathfrak{u}(\eta|_E)} 0_E$, then from [Bil23, Proposition 2.4] the set $H := \{h \in F, |h| \land e_\alpha \xrightarrow{\eta} 0_F\}$ is a η -closed ideal which contains E as well as E^d . From our assumption it follows that H = F, and so $e_\alpha \xrightarrow{\mathfrak{u}\eta} 0_F$.

Note that the conditions (ii) and (iii) are somewhat close to the necessary condition for E to commute with η established in [BCTvdW24, Theorem 11.7]: if η is linear, complete and commutes with an ideal E, then \overline{E}_{η}^{1} is a projection band.
