BICONSERVATIVE SURFACES IN ROBERTSON-WALKER SPACES

Abstract. In this paper, we mainly focus on space-like PMCV surfaces in Robertson-Walker spaces. First, we derive certain geometrical properties of biconservative surfaces in the Robertson-Walker space $L_1^n(f, c)$ of arbitrary dimension. Then, we get complete local classifications of such surfaces in $L_1^4(f,0)$, $L_1^5(f,0)$ and $L_1^5(1,\pm 1)$. Finally, we proved that a space-like PMCV biconservative surface in $L_1^n(f,0)$ lies on a totally geodesic submanifold with dimension 4 or 5.

1. INTRODUCTION

A biharmonic map $\psi : (M, g) \to (N, \tilde{g})$ between two semi-Riemannian manifolds is characterized as a critical point of the bienergy functional defined by

$$
E_2: C^{\infty}(M, N) \to \mathbb{R}, \quad E_2(\psi) = \frac{1}{2} \int_M \widetilde{g}(\tau(\psi), \tau(\psi)) v_g,
$$

where v_q represents the volume element of M and $\tau(\psi)$ denotes the tension of ψ given by $\tau(\psi) = \text{tr} \,\nabla d\psi$, [\[13\]](#page-19-0). It is well established that the mapping ϕ is biharmonic if and only if it satisfies the Euler-Lagrange equation

(1.1)
$$
\tau_2(\psi) := \Delta \tau(\psi) - \operatorname{tr} \widetilde{R}(d\psi, \tau(\psi)) d\psi = 0
$$

associated with the bi-energy functional, where $\tau_2(\psi)$ is said to be bi-tension of ψ , Δ and \widetilde{R} denote the rough Laplacian acting on sections of $\psi^{-1}(TN)$ defined by

$$
\Delta U = \text{tr}\left(\nabla.\nabla.U\right)
$$

whenever $U \in \Gamma(\psi^{-1}(TN))$ and the curvature tensor field of N, respectively, [\[8\]](#page-18-0).

On the other hand, a mapping $\psi : (M, g) \to (N, \tilde{g})$ that satisfies the condition

(1.2)
$$
\widetilde{g}(\tau_2(\psi), d\psi) = 0,
$$

which is weaker than [\(1.1\)](#page-0-0), is said to be a biconservative mapping. When $\psi = \phi$ is an isometric immersion, the equation [\(1.2\)](#page-0-1) simplifies to

$$
\tau_2(\phi)^T = 0,
$$

where $\tau_2(\phi)^T$ denotes the tangential part of $\tau_2(\phi)$. In this case, M is said to be a biconservative submanifold of N.

By examining the tangential component of $\tau_2(\phi)$, we can deduce the following well-known result from [\(1.3\)](#page-0-2).

Proposition 1.1. [\[10\]](#page-18-1) *Let* $\phi : (M^m, g) \to (N^n, \tilde{g})$ *be an isometric immersion between two semi-Riemannian manifolds. Then,* φ *is biconservative if and only if equation*

(1.4)
$$
m \nabla ||H||^2 + 4 \operatorname{tr} A_{\nabla^{\perp} H}(\cdot) + 4 \operatorname{tr} (\widetilde{R}(\cdot, H) \cdot)^T = 0,
$$

is satisfied.

The study of biharmonic maps between warped products was initiated by Balmus *et*. *al.* in 2007, [\[2\]](#page-18-2). In the following years, Roth obtained sufficient and necessary conditions for biharmonic submanifolds of Cartesian products of two non-flat Riemannian space-forms spheres in [\[12\]](#page-19-1). The study of biconservative surfaces in product spaces was started by Fetcu *et. al.* in [\[7\]](#page-18-3), where the main focus lies on surfaces in $\mathbb{S}^n \times \mathbb{R}$ and $\mathbb{H}^n \times \mathbb{R}$ with parallel mean curvature vector (PMCV). In [\[9\]](#page-18-4), this investigation extended to higher-dimensional submanifolds in $\mathbb{S}^n \times \mathbb{R}$ and $\mathbb{H}^n \times \mathbb{R}$.

On the other hand, PMCV surfaces of different Lorentzian spaces were researched in [\[1,](#page-18-5) [3,](#page-18-6) [4\]](#page-18-7) and some open problems about PMCV surfaces in Robertson-Walker spaces were presented in [\[5\]](#page-18-8). In this paper, we study space-like PMCV surfaces embedded in the Lorentzian warped product spaces. In particular, we complete the local classification of space-like biconservative PMCV surfaces in $L_1^n(f,0)$, $\mathbb{E}_1^1 \times \mathbb{S}^n$ and $\mathbb{E}_1^1 \times \mathbb{H}^n$ by proving Theorem [4.3,](#page-9-0) Theorem [5.3,](#page-11-0) Theorem [6.5,](#page-14-0) Proposition [6.3](#page-14-1) and Theorem [7.2.](#page-17-0)

In Sect. 2, we give some basic facts and equations of the theory of submanifolds, along with the notation that we are going to use throughout the article. In Sect. 3, we explore some geometrical properties of PMCV surfaces in a Robertson-Walker space $L_1^n(f, c)$ with arbitrary dimension. Sect. 4 and Sect. 5 are devoted to surfaces of $L_1^4(f,0)$ and $L_1^5(f,0)$, respectively. Furthermore, biconservative PMCV surfaces of $\mathbb{E}^1_1 \times \mathbb{S}^4$ are studied in Sect. 6. In Sect. 7, we consider some of global properties of biconservative PMCV surfaces in $L_1^n(f, c)$. As a conclusion, we show the substantial co-dimension of a biconservative PMCV surface is either 2 or 3.

2. Preliminaries

In this section, we give a brief summary of basic facts and equations of the theory of submanifolds, [\[11\]](#page-19-2).

2.1. Basic Formulæ and Definitions. Let $R^{n-1}(c)$ denote the $n-1$ dimensional Riemannian space-form with the constant sectional curvature c , i.e.,

$$
R^{n-1}(c) = \begin{cases} \mathbb{S}^{n-1} & \text{if } c = 1, \\ \mathbb{E}^{n-1} & \text{if } c = 0, \\ \mathbb{H}^{n-1} & \text{if } c = -1 \end{cases}
$$

with the metric tensor g_c and the Levi-Civita connection $\nabla^{R^{n-1}(c)}$. If I is an open interval and $f: I \to \mathbb{R}$ is a smooth, non-vanishing function then the Robertson Walker space $L_1^n(f, c)$ is defined as the Lorentzian warped product $I_1^1 \times_f R^{n-1}(c)$ whose metric tensor \widetilde{g} is

$$
\widetilde{g} = \langle \cdot, \cdot \rangle = -dt^2 + f(t)^2 g_c.
$$

The vector field $\frac{\partial}{\partial t}$ is known as the comoving observer field in general relativity, [\[3\]](#page-18-6).

Let $\Pi^1: I \times \mathbb{R}^{n-1}(c) \to I$ and $\Pi^2: I \times \mathbb{R}^{n-1}(c) \to \mathbb{R}^{n-1}(c)$ denote the canonical projections. For a given vector field X in $L_1^n(f, c)$, we define a function X_0 and a vector field X by the orthogonal decomposition

$$
X = X_0 \frac{\partial}{\partial t} + \bar{X},
$$

that is,

$$
X = X_0 \frac{\partial}{\partial t} + \sum_{i=1}^{n-1} X_i \frac{\partial}{\partial x_i} := (X_0, X_1, \dots, X_{n-1}),
$$

where $(x_1, x_2, \ldots, x_{n-1})$ is a Cartesian coordinate system in \mathbb{R}^{n-1} and we have

$$
X_0 = -\langle \frac{\partial}{\partial t}, X \rangle, \qquad \Pi^1_*(\bar{X}) = 0.
$$

First, we would like to express the Levi-Civita connection of $L_1^n(f, c)$. Occasionally, by misusing terminology, we are going to put $(0, \bar{X}) = \bar{X}$.

We are going to use the following lemma which can be directly obtained from [\[11\]](#page-19-2) (See also [\[3,](#page-18-6) Lemma 2.1]).

Lemma 2.1. *The Levi-Civita connection* $\overline{\nabla}$ *of* $L_1^n(f, c)$ *is*

(2.1)
$$
\widetilde{\nabla}_X Y = \nabla^0_X Y + \frac{f'}{f} \left(\widetilde{g}(\bar{X}, \bar{Y}) \frac{\partial}{\partial t} + X_0 \bar{Y} + Y_0 \bar{X} \right)
$$

whenever X and Y are tangent to $L_1^n(f, c)$, where ∇^0 denotes the Levi-Civita connection of *the Cartesian product space* $L_1^n(1, c) = I \times R^{n-1}(c)$ *.*

On the other hand, the Riemann curvature tensor R of $L_1^n(f, c)$ is as follows:

Lemma 2.2. [\[3\]](#page-18-6). The Riemannian curvature tensor \tilde{R} of $L_1^n(f, c)$ satisfies

(2.2)
$$
\widetilde{R}(\frac{\partial}{\partial t}, \bar{X}) \frac{\partial}{\partial t} = \frac{f''}{f} \bar{X}, \qquad \widetilde{R}(\frac{\partial}{\partial t}, \bar{X}) \bar{Y} = \frac{f''}{f} \langle \bar{X}, \bar{Y} \rangle \frac{\partial}{\partial t}, \n\widetilde{R}(\bar{X}, \bar{Y}) \frac{\partial}{\partial t} = 0, \qquad \widetilde{R}(\bar{X}, \bar{Y}) \bar{Z} = \frac{f'^2 + c}{f^2} (\langle \bar{Y}, \bar{Z} \rangle \bar{X} - \langle \bar{X}, \bar{Z} \rangle \bar{Y})
$$

 $whenever \Pi^1_*(\bar{X}) = \Pi^1_*(\bar{Y}) = \Pi^1_*(\bar{Z}) = 0.$

2.2. Surfaces in Robertson Walker Spaces. Consider an oriented space-like surface M in $L_1^n(f, c)$ equipped with the Levi-Civita connection ∇ and metric tensor g. For convenience, we denote the induced connection of $L_1^n(f, c)$ also by ∇ . The Gauss and Weingarten formulæ are given by

(2.3)
$$
\widetilde{\nabla}_X Y = \nabla_X Y + h(X, Y),
$$

(2.4)
$$
\widetilde{\nabla}_X \xi = -A_{\xi}(X) + \nabla_X^{\perp} \xi,
$$

defining the second fundamental form h , the shape operator A , and the normal connection ∇^{\perp} of M, where X and Y are tangent vectors to M and ξ is a normal vector to M. Note that A and h are related by

(2.5)
$$
\widetilde{g}(h(X,Y),\xi) = g(A_{\xi}X,Y).
$$

Moreover, the Codazzi equation

(2.6)
$$
\left(\widetilde{R}(X,Y)Z\right)^{\perp} = \left(\nabla_X^{\perp}h\right)(Y,Z) - \left(\nabla_Y^{\perp}h\right)(X,Z)
$$

is satisfied, where the covariant derivative $\nabla^{\perp}h$ of the second fundamental form is defined by

$$
\left(\nabla_X^{\perp}h\right)(Y,Z)=\nabla_X^{\perp}h(Y,Z)-h(\nabla_XY,Z)-h(Y,\nabla_XZ).
$$

Furthermore, since Lemma [2.2](#page-2-0) implies $\left(\widetilde{R}(X, Y) \xi\right)$ $\big)^\perp = 0$, the Ricci equation turns into

(2.7)
$$
R^{\perp}(X,Y)\xi = h(X,A_{\xi}Y) - h(A_{\xi}X,Y),
$$

where R^{\perp} is the normal curvature tensor, [\[3\]](#page-18-6).

The mean curvature vector field H of M is defined by

$$
H = \frac{1}{2} \text{tr} \, h.
$$

M is said to be PMCV if H is parallel along the normal connection, i.e., $\nabla^{\perp}H = 0$. Further, the first and second normal space N_1M and N_2M of M is defined by

$$
(2.8) \t\t N1M = \text{span}\{h(X,Y)|X,Y \in TM\}
$$

(2.9)
$$
N_2M = \text{span}\left\{h(X,Y), \nabla_Z^{\perp}h(X,Y)|X,Y,Z \in TM\right\},
$$

respectively.

On the other hand, we decompose $\frac{\partial}{\partial t}$ into its tangential and normal parts by

$$
\left. (2.10)\right. \qquad \qquad \left. \frac{\partial}{\partial t} \right|_{M} = T + \eta,
$$

where T is a tangent vector field and η is normal to M.

Remark 2.3. Assumptions. Because of Lemma [2.2,](#page-2-0) the Robertson-Walker space $L_1^n(f, c)$ has constant curvature if and only if the equation $\frac{f''}{f} = \frac{f'^2 + c}{f^2}$ is satisfied, [3]. In this $\frac{z+c}{f^2}$ is satisfied, [\[3\]](#page-18-6). In this case, every PMCV submanifold is trivially biconservative (see Proposition [1.1\)](#page-0-3). On the other hand, if $T = 0$ on a non-empty open subset O of M, then any component \mathcal{O}_1 of O is a horizontal slice, i.e., $(\mathcal{O}_1, g) \subset \{t_0\} \times_{f(t_0)} R^3(c)$. Hence, throughout this paper we have the following assumptions:

- $f''(t)$ $\frac{1}{f(t)}$ – $f'(t)^2 + c$ $\frac{f(t)}{f(t)^2} \neq 0$ for any $t \in I$,
- T does not vanish on M ,
- $\bullet \{e_1, e_2\}$ is an orthonormal basis for the tangent bundle of M , where e_1 is proportional to T ,
- All surfaces are connected and all vector fields are smooth.

We shall denote the coefficient of the second fundamental form by h_{ij}^{α} , i.e.,

$$
h_{ij}^{\alpha} = \langle h(e_i, e_j), e_{\alpha} \rangle = \langle A_{e_{\alpha}} e_i, e_j \rangle, \qquad i, j = 1, 2,
$$

where e_{α} is a unit normal vector field.

2.3. Surfaces in a Lorentzian Product Space. Now, consider the case $f = 1$ and $c = \pm 1$, i.e., M is a non-degenerate surface in the Cartesian product space $\mathbb{E}^1_1 \times R^{n-1}(c)$. Let $\hat{\nabla}$ denote the Levi-Civita connection of the flat ambient space \mathbb{E}_r^{n+1} with the metric tensor

$$
\tilde{g} = -dx_1^2 + cdx_2^2 + \sum_{i=3}^{n+1} dx_i^2.
$$

In this case, $\hat{\nabla}$ and $\tilde{\nabla}$ are related with

(2.11a) $\hat{\nabla}_X Y = \tilde{\nabla}_X Y - c \left(\langle X, Y \rangle + \langle X, T \rangle \langle Y, T \rangle \right) e_{n+1}$

(2.11b)
$$
\hat{\nabla}_X \xi = \tilde{\nabla}_X \xi - c \langle X, \eta \rangle \langle \xi, \eta \rangle e_{n+1}
$$

whenever X, Y are tangent to M and ξ is a normal vector field, where e_{n+1} denotes the unit normal vector of $\mathbb{E}_1^1 \times R^{n-1}(c)$ in \mathbb{E}_r^{n+1} . Furthermore, we have

(2.11c)
$$
\hat{\nabla}_X e_{n+1} = (X + \langle X, T \rangle T) + \langle X, T \rangle \eta.
$$

3. BICONSERVATIVE SURFACES IN $L_1^n(f, c)$

In this section, we are going to consider space-like PMCV surfaces in the Robertson-Walker space $L_1^n(f, c)$, where $n \geq 4$.

3.1. **Space-like surfaces.** First, let M be an oriented space-like surface in $L_1^n(f, c)$. In this case, by considering the decomposition [\(2.10\)](#page-3-0), we define the unit normal vector field e_3 and an 'angle' function θ by

(3.1)
$$
\frac{\partial}{\partial t}\bigg|_{M} = \sinh\theta\,e_1 + \cosh\theta\,e_3.
$$

Then, by considering Lemma [2.2,](#page-2-0) one can observe that the Codazzi equation [\(2.6\)](#page-2-1) becomes

(3.2)
$$
0 = (\nabla_{e_1}^{\perp} h) (e_2, e_1) - (\nabla_{e_2}^{\perp} h) (e_1, e_1),
$$

(3.3)
$$
\sinh \theta \left(-\frac{f''}{f} + \frac{f'^2 + c}{f^2} \right) \eta = \left(\nabla_{e_1}^{\perp} h \right) (e_2, e_2) - \left(\nabla_{e_2}^{\perp} h \right) (e_1, e_2).
$$

We are going to use the following lemma.

Lemma 3.1. Let M be a space-like surface in $L_1^n(f, c)$, where $n \geq 4$. Then, the equations

(3.4a)
$$
e_1(\theta)\cosh\theta e_1+\sinh\theta\nabla_{e_1}e_1-\cosh\theta A_{e_3}e_1 = \frac{f'}{f}\cosh^2\theta e_1,
$$

(3.4b)
$$
e_2(\theta) \cosh \theta \, e_1 + \sinh \theta \nabla_{e_2} e_1 - \cosh \theta A_{e_3} e_2 = \frac{f'}{f} e_2,
$$

(3.4c)
$$
e_1(\theta)\sinh\theta e_3 + \sinh\theta h(e_1,e_1) + \cosh\theta \nabla_{e_1}^{\perp} e_3 = \frac{f'}{f} \cosh\theta \sinh\theta e_3,
$$

(3.4d)
$$
e_2(\theta)\sinh\theta e_3+\sinh\theta h(e_1,e_2)+\cosh\theta \nabla_{e_2}^{\perp}e_3 = 0,
$$

are satisfied, where e_3 is the unit normal vector field defined by (3.1) .

Proof. Consider a space-like surface in $L_1^n(f, c)$ and let e_3 be the vector field defined by [\(3.1\)](#page-4-0). Note that Lemma [2.1](#page-2-2) implies

(3.5)
$$
\widetilde{\nabla}_{e_1} \frac{\partial}{\partial t} = \frac{f'}{f} (\cosh^2 \theta e_1 + \cosh \theta \sinh \theta e_3),
$$

(3.6)
$$
\widetilde{\nabla}_{e_2} \frac{\partial}{\partial t} = \frac{f'}{f} e_2
$$

and from [\(3.1\)](#page-4-0), we have

(3.7)
$$
\widetilde{\nabla}_X \frac{\partial}{\partial t} = X(\theta)(\cosh \theta \, e_1 + \sinh \theta \, e_3) + \sinh \theta \left(\nabla_X e_1 + h(e_1, X) \right) + \cosh \theta \left(-A_{e_3}(X) + \nabla_X^{\perp} e_3 \right)
$$

whenever X is tangent to M. By combining (3.7) with (3.5) and (3.6) , we get

(3.8)
$$
\frac{f'}{f}(\cosh^2 \theta e_1 + \cosh \theta \sinh \theta e_3) = (e_1(\theta) \cosh \theta e_1 + \sinh \theta \nabla_{e_1} e_1 - \cosh \theta A_{e_3}(e_1)) + (e_1(\theta) \sinh \theta e_3 + \cosh \theta \nabla_{e_1}^{\perp} e_3 + \sinh \theta h(e_1, e_1))
$$

and

(3.9)
$$
\frac{f'}{f}e_2 = \left(e_2(\theta)\cosh\theta e_1 + \sinh\theta \nabla_{e_2}e_1 - \cosh\theta A_{e_3}(e_2)\right) + \left(e_2(\theta)\sinh\theta e_3 + \cosh\theta \nabla_{e_2}^{\perp}e_3 + \sinh\theta h(e_1, e_2)\right),
$$

respectively. The tangential and normal parts of (3.8) and (3.9) give (3.4) .

We also need the following lemma.

Lemma 3.2. Let M be a space-like surface in the Robertson-Walker space $L_1^n(f, c)$. Then, *the mean curvature vector* H *of* M *satisfies*

(3.10)
$$
\operatorname{tr} (\widetilde{R}(\cdot, H) \cdot)^T = \left(\frac{f''}{f} - \frac{f'^2 + c}{f^2} \right) \langle H, \eta \rangle T,
$$

where T *and* η *are the vector fields defined by* [\(2.10\)](#page-3-0)*.*

Proof. We define a function H_0 and smooth vector fields $\bar{e_1}$ and \bar{H} by the orthogonal decomposition

(3.11)
$$
e_1 = -\sinh \theta \frac{\partial}{\partial t} + \bar{e_1},
$$

$$
H = -H_0 \frac{\partial}{\partial t} + \bar{H},
$$

from which we obtain

(3.12)
$$
\langle \bar{e_1}, \bar{e_1} \rangle = \cosh^2 \theta, \langle \bar{e_1}, \bar{H} \rangle = H_0 \sinh \theta,
$$

where we have $H_0 = \langle H, \eta \rangle$.

On the other hand, by considering Lemma [2.2,](#page-2-0) we obtain

$$
\widetilde{R}(e_1, H)e_1 = \sinh^2 \theta \widetilde{R}(\frac{\partial}{\partial t}, \bar{H}) \frac{\partial}{\partial t} + H_0 \sinh \theta \widetilde{R}(\bar{e_1}, \frac{\partial}{\partial t}) \frac{\partial}{\partial t} - \sinh \theta \widetilde{R}(\frac{\partial}{\partial t}, \bar{H}) \bar{e_1} \n-H_0 \widetilde{R}(\bar{e_1}, \frac{\partial}{\partial t}) \bar{e_1} + \widetilde{R}(\bar{e_1}, \bar{H}) \bar{e_1} \n= \frac{f''}{f} \left(\sinh^2 \theta \bar{H} - H_0 \sinh \theta \bar{e_1} - \sinh \theta \langle \bar{H}, \bar{e_1} \rangle \frac{\partial}{\partial t} + H_0 \langle \bar{e_1}, \bar{e_1} \rangle \frac{\partial}{\partial t} \right) \n+ \frac{f'^2 + c}{f^2} \left(\langle \bar{H}, \bar{e_1} \rangle \bar{e_1} - \langle \bar{e_1}, \bar{e_1} \rangle \bar{H} \right)
$$

By combining this equation with [\(3.12\)](#page-5-0), we get

(3.13)
$$
\widetilde{R}(e_1, H)e_1 = \frac{f''}{f} \left(\sinh^2 \theta \overline{H} - H_0 \sinh \theta \overline{e_1} - H_0 \sinh^2 \theta \frac{\partial}{\partial t} + H_0 \cosh^2 \theta \frac{\partial}{\partial t} \right) + \frac{f'^2 + c}{f^2} \left(H_0 \sinh \theta \overline{e_1} - \cosh^2 \theta \overline{H} \right).
$$

Note that [\(3.11\)](#page-5-1) and [\(3.12\)](#page-5-0) imply

(3.14)
$$
(\overline{H})^T = H_0 \sinh \theta e_1,
$$

$$
(\overline{e}_1)^T = \cosh^2 \theta e_1.
$$

By combining (3.13) with (3.14) , we obtain

(3.15)
$$
\left(\widetilde{R}(e_1, H)e_1\right)^T = 0.
$$

Similarly, we get

$$
\widetilde{R}(e_2,H)e_2 = \frac{f''}{f}H_0\frac{\partial}{\partial t} - \frac{f'^2 + c}{f^2}\bar{H}
$$

from which, along with [\(3.14\)](#page-5-3), we obtain

(3.16)
$$
\left(\widetilde{R}(e_2, H)e_2\right)^T = \left(\frac{f''}{f} - \frac{f'^2 + c}{f^2}\right) H_0 \sinh \theta e_1.
$$

Finally, we combine (3.15) and (3.16) to get (3.10) .

3.2. **PMCV Surfaces in** $L_1^n(f, c)$. Let M be a space-like PMCV surface in $L_1^n(f, c)$. By considering Proposition [1.1](#page-0-3) one can get that M is biconservative if and only if

$$
\operatorname{tr}\big(\widetilde{R}(\cdot,H)\cdot)^{T}=0
$$

which is equivalent to

(3.17) $\langle H, \eta \rangle = 0$

because of Lemma [3.2.](#page-5-7) Since η is time-like, [\(3.17\)](#page-6-0) implies that H is space-like at every point. Therefore, we have the following corollary.

Corollary 3.3. There are no marginally trapped biconservative PMCV surface in $L_1^n(f, c)$.

Proposition 3.4. Let M be a space-like surface in $L_1^n(f, c)$ and assume that $\eta \neq 0$. Then, M is a biconservative PMCV surface if and only if there exists a non-zero constant H_0 and *a unit normal vector field* e⁴ *such that*

(3.18)
$$
\nabla^{\perp} e_4 = 0, \qquad \langle e_4, \eta \rangle = 0,
$$

(3.19)
$$
A_{e_4} = \begin{pmatrix} 0 & 0 \\ 0 & 2H_0 \end{pmatrix},
$$

 A_{ξ} = $\int \gamma_{\xi} = 0$ 0 $-\gamma_{\xi}$ $\overline{ }$ (3.20) $A_{\xi} = \begin{pmatrix} \frac{1}{\xi} & 0 \\ 0 & -\gamma_{\xi} \end{pmatrix}$ whenever $\langle e_4, \xi \rangle = 0$,

where $\gamma_{\xi} \in C^{\infty}(M)$.

Proof. In order to prove the necessary condition, we assume that M is biconservative and PMCV. Considering vector fields e_1, e_3 defined by [\(3.1\)](#page-4-0). Then, there exists a non-zero constant H_0 and a unit normal vector field e_4 such that $H = H_0e_4$ and [\(3.18\)](#page-6-1). Let ξ be a normal vector field such that $\tilde{g}(\xi, e_4) = 0$ from which we have

(3.21)
$$
\text{tr } A_{\xi} = 0, \quad \text{tr } A_{e_4} = 2H_0.
$$

Note that because of $\nabla^{\perp}e_4 = 0$, we have

\langle \nabla^\perp_X e_3, e_4 \rangle = 0

whenever X is a tangent vector field. By combining this equation with $(3.4c)$ and $(3.4d)$ and taking into account [\(3.21\)](#page-6-2), we obtain

Therefore, we have (3.19) . Moreover, the Ricci equation (2.7) implies

By combining this equation with the first equation in [\(3.21\)](#page-6-2), we get [\(3.20\)](#page-6-1).

Conversely, if [\(3.19\)](#page-6-1) and [\(3.20\)](#page-6-1) are satisfied, then we have $H = H_0e_4$. Furthermore, (3.18) implies $\nabla^{\perp} H = 0$ and (3.17) . This completes the proof.

Next, by using this proposition, we obtain the following properties of biconservative PMCV surfaces.

Lemma 3.5. Let M be a space-like biconservative PMCV surface in $L_1^n(f, c)$ and $p \in M$. *Then the vector fields* e_1 , e_2 *and* e_3 *defined by* [\(3.1\)](#page-4-0) *satisfy*

 $h(e_1, e_2) = 0,$

(3.22b)
$$
\nabla_{e_1} e_1 = \nabla_{e_1} e_2 = \nabla_{e_2} e_1 = \nabla_{e_2} e_2 = 0,
$$

(3.22c)
$$
\frac{f'}{f} = \cosh \theta \gamma_{e_3}, \qquad e_2(\theta) = 0.
$$

Consequently, there exists a local coordinate system $(\mathcal{N}_p,(u, v))$ *such that* $\mathcal{N}_p \ni p$ *and*

(3.22d)
$$
e_1|_{\mathcal{N}_p} = -\sinh \theta \partial_u, \qquad e_2|_{\mathcal{N}_p} = \partial_v.
$$

Proof. Let M be biconservative and PMCV. Note that $(3.22a)$ directly follows from [\(3.19\)](#page-6-1) and [\(3.20\)](#page-6-1).

From (3.17) and (3.20) we have

(3.23)
$$
A_{e_3}e_1 = \gamma_{e_3}e_1, \qquad A_{e_3}e_2 = -\gamma_{e_3}e_2.
$$

The first equation in [\(3.23\)](#page-7-0) and [\(3.4a\)](#page-4-6) imply $\nabla_{e_1} e_1 = 0$. Moreover, the Codazzi equation [\(3.3\)](#page-4-7) and [\(3.22a\)](#page-6-3) imply

(3.24)
$$
\sinh \theta \cosh \theta \left(-\frac{f''}{f} + \frac{f'^2 + c}{f^2} \right) e_3 = \nabla_{e_1}^{\perp} h(e_2, e_2) + h(\nabla_{e_2} e_1, e_2) + h(e_1, \nabla_{e_2} e_2).
$$

By taking the inner product of both sides of (3.24) with e_4 and using (3.18) and (3.19) , we obtain

$$
H_0 \langle \nabla_{e_2} e_1, e_2 \rangle = 0.
$$

Thus, we have [\(3.22b\)](#page-6-3). From [\(3.4b\)](#page-4-6) and [\(3.22b\)](#page-6-3) we get the first equation in [\(3.22c\)](#page-6-3).

Finally, by considering [\(3.22b\)](#page-6-3) and [\(3.22c\)](#page-6-3), we obtain

Therefore, there exists a local coordinate system (u, v) such that $-\frac{1}{\sinh^2}$ $\frac{1}{\sinh \theta} e_1 = \partial_u$ and $e_2 = \partial_v$, which yields $(3.22d)$.

On the other hand, as a result of Ricci equation [\(2.7\)](#page-2-3), a surface has flat normal bundle if all of its shape operators can be diagonalized simultaneously (See [\[3,](#page-18-6) Proposition 3.1]). Hence, we have the following result.

Corollary 3.6. If M is a biconservative PMCV surface in $L_1^n(f, c)$, then it has flat normal *bundle.*

4. PMCV SURFACES IN $L_1^4(f,0)$

In this section, we are going to consider space-like PMCV surfaces in the Robertson-Walker spacetime $L_1^4(f, 0)$.

First, we obtain the following lemma by using Proposition [3.4.](#page-6-4)

Lemma 4.1. Let M be a space-like surface in $L_1^4(f, c)$ and $\{e_1, e_2, e_3, e_4\}$ be the orthonormal *frame field defined by* [\(3.1\)](#page-4-0)*. If* M *is PMCV and biconservative, then*

(4.1a) $\nabla_{e_1} e_1 = -\gamma e_3, \nabla_{e_2} e_1 = 0,$

(4.1b)
$$
\tilde{\nabla}_{e_1} e_2 = 0, \qquad \tilde{\nabla}_{e_2} e_2 = \gamma e_3 + 2H_0 e_4,
$$

(4.1c)
$$
\nabla_{e_1} e_3 = -\gamma e_1, \qquad \nabla_{e_2} e_3 = \gamma e_2,
$$

(4.1d)
$$
\nabla_{e_1} e_4 = 0, \qquad \nabla_{e_2} e_4 = -2H_0 e_2.
$$

Proof. Let M be PMCV and biconservative. Then, Proposition [3.4](#page-6-4) implies [\(3.18\)](#page-6-1), (3.19) , (3.20) and we have $(3.22b)$ because of Lemma [3.5.](#page-6-5) By combining (3.18) and (3.19) , we obtain [\(4.1d\)](#page-7-3). Since the co-dimension of M is 2, [\(3.18\)](#page-6-1) also implies $\nabla^{\perp}e_3 = 0$.

On the other hand, from (3.20) for $\xi = e_3$ we get

(4.2)
$$
A_{e_3} = \begin{pmatrix} \gamma & 0 \\ 0 & -\gamma \end{pmatrix},
$$

where we put $\gamma_{e_3} = \gamma$. Therefore, from [\(4.2\)](#page-7-4) we obtain [\(4.1c\)](#page-7-3). Note that by using [\(2.5\)](#page-2-4), (3.20) and (4.2) , we obtain the second fundemental form h by

(4.3)
$$
h(e_1, e_1) = -\gamma e_3, \qquad h(e_2, e_2) = \gamma e_3 + 2H_0 e_4.
$$

By combining $(3.22a)$, $(3.22b)$ and (4.3) , we get $(4.1a)$ and $(4.1b)$.

Next, we obtain a local parametrization for space-like biconservative surfaces.

Lemma 4.2. Let M be a space-like surface in $L_1^4(f, 0)$, $p \in M$ and $\{e_1, e_2, e_3, e_4\}$ be the *orthonormal frame field defined by* [\(3.1\)](#page-4-0)*. If* M *is PMCV and biconservative, then* p *has a neighborhood* \mathcal{N}_p *parametrized by*

(4.4)
$$
\phi(u,v) = \left(u, \frac{1}{af(u)}\sin av, \frac{1}{af(u)}\cos av, y(u)\right)
$$

and we have

(4.5)
$$
e_4 = \frac{1}{f} \left(0, -\frac{2H_0}{a} \sin av, -\frac{2H_0}{a} \cos av, c_2 \right),
$$

for some constants a, c_2 *satisfying*

(4.6)
$$
4H_0^2 + c_2^2 a^2 = a^2, \qquad c_2 > 0,
$$

where H_0 *is the mean curvature of* M *and* ϕ *is the position vector of* M.

Proof. Let M be space-like PMCV and biconservative. Then, because of Lemma [4.1,](#page-7-5) the equations appearing in [\(4.1\)](#page-7-6) is satisfied. Consider a local coordinate system $(\mathcal{N}_p,(u, v))$ described in Lemma [3.5](#page-6-5) near to p and let

(4.7)
$$
\phi(u,v) = (\mathcal{T}(u,v), \widetilde{\phi}(u,v))
$$

be the position vector of \mathcal{N}_p . Because of the definitions of e_1 and e_2 , from [\(3.22d\)](#page-7-2) we have $\frac{\partial}{\partial u}$ $\mathcal{T} = 1$, $\frac{\partial}{\partial v}$ $\mathcal{T} = 0$ which imply

(4.8) T (u, v) = u.

Note that the second equation in [\(3.22c\)](#page-6-3) implies $\theta = \theta(u)$ on \mathcal{N}_p .

By considering the first equation in [\(4.1b\)](#page-7-3), we obtain

$$
0 = \widetilde{\nabla}_{\partial_v} \partial_u = (0, \widetilde{\phi}_{uv}) + \frac{f'}{f}(0, \widetilde{\phi}_v)
$$

from which we obtain

(4.9)
$$
e_2 = \widetilde{\phi}_v = \frac{1}{f}(0, \alpha), \qquad g_0(\alpha, \alpha) = 1.
$$

where α is a smooth \mathbb{R}^3 valued function. Next, by considering Lemma [2.1,](#page-2-2) we use [\(4.7\)](#page-8-1)-[\(4.9\)](#page-8-2) to get

(4.10)
$$
\widetilde{\nabla}_{e_2} \widetilde{\nabla}_{e_2} e_2 = \frac{1}{f} (0, \alpha'') + \frac{f'^2}{f^2} e_2.
$$

On the other hand, by a direct computation using $(4.1b)$, $(4.1c)$ and $(4.1d)$ we get

(4.11)
$$
\widetilde{\nabla}_{e_2} \widetilde{\nabla}_{e_2} e_2 = (\gamma^2 - 4H_0^2) e_2.
$$

By combining $(4.9)-(4.11)$ $(4.9)-(4.11)$ we get

\alpha''(v) = \left(-\gamma(u)^2 \sinh^2 \theta(u) - 4H_0^2\right) \alpha(v).
$$

Consequently, we have $\gamma(u)^2 \sinh^2 \theta(u) + 4H_0^2 = a^2$ for a constant $a > 0$ and $\alpha'' + a^2 \alpha = 0$ from which we have

\alpha(v) = (\cos av, -\sin av, 0).

Finally, by a direct computation using $(4.7)-(4.9)$ $(4.7)-(4.9)$ and (4.12) we obtain (4.4) .

Next, we consider the first equation in [\(4.1d\)](#page-7-3) to get

-2H_0e_2 = \widetilde{\nabla}_{e_2}e_4 = \frac{1}{f}(0, N'_1(v), N'_2(v), N'_3(v))
$$

from which we obtain [\(4.5\)](#page-8-5) because of [\(4.9\)](#page-8-2) and $\langle e_2, e_4 \rangle = 0$.

Now, we are ready to prove the main result of this section.

Theorem 4.3. The Robertson-Walker spacetime $L_1^4(f,0)$ admits a space-like, biconserva*tive PMCV surface* M *with mean curvature* H_0 *if and only if* f *satisfies*

\left(a^2 - 4H_0^2\right) f^3 f'' - \left(f'^2 - \left(a^2 - 4H_0^2\right) f^2\right)^2 - f'^4 = 0
$$

 $for a constant a such that a²−4H₀² > 0.$ *In this case, M is locally congruent to the rotational surface*

(4.14)
$$
\phi(u,v) = \left(u, \frac{1}{af(u)} \sin av, \frac{1}{af(u)} \cos av, \frac{2H_0}{a^2c_2f(u)}\right),
$$

where c_2 *is a constant satisfying* (4.6) *.*

Proof. First, we are going to prove the necessary condition. Assume the existence of a space-like biconservative PMCV surface M in $L_1^4(f, 0)$. Then (3.17) is satisfied and we are going to consider a local coordinate system (u, v) described in Lemma [4.2.](#page-8-7) Note that (4.4) and [\(4.5\)](#page-8-5) implies

(4.15)
$$
a^2c_2f^2y' + 2H_0f' = 0
$$

because $\langle e_1, e_4 \rangle = 0$. By solving [\(4.15\)](#page-9-2), we get

$$
y(u) = \frac{2H_0}{a^2c_2f(u)} + c_3
$$

for a constant c_3 which can be assumed to be zero after a suitable translation. Therefore, we have (4.14) .

By using $(3.22d)$ and (4.4) we get

e_3 = \frac{1}{\sqrt{f'^2 - (a^2 - 4H_0^2)f^2}} (f', -ac_2^2 \sin av, -ac_2^2 \cos av, -2c_2 H_0)
$$

from which we obtain

\widetilde{\nabla}_{e_1} e_1 = \frac{f'^4 - (a^2 - 4H_0^2) f^3 f''}{f (f'^2 - (a^2 - 4H_0^2) f^2)^{3/2}} e_3.
$$

On the other hand, [\(3.22d\)](#page-7-2) and [\(4.6\)](#page-8-6) implies

(4.17)
$$
\widetilde{\nabla}_{e_2} e_2 = \frac{\sqrt{f'^2 - (a^2 - 4H_0^2)f^2}}{f} e_3 + 2H_0 e_4.
$$

By combining (4.16) and (4.17) , we get the mean curvature vector H of M by

H=-\frac{\left(a^2-4H_0^2\right) f^3 f''+2 \left(a^2-4H_0^2\right) f^2 f'^2-\left(a^2-4H_0^2\right){}^2 f^4-2 f'^4}{2 f \left(f'^2-\left(a^2-4H_0^2\right) f^2\right){}^{3/2}}e_3+H_0 e_4.
$$

Hence, (3.17) is equivalent to (4.13) .

The proof of the sufficient condition follows from a direct computation. \Box

5. PMCV SURFACES IN $L_1^5(f,0)$

In this section, we are going to consider biconservative PMCV surfaces in the Robertson-Walker space $L_1^5(f,0)$.

Let M be a space-like biconservative PMCV surface in $L_1^5(f,0)$. We choose the orthonormal frame field $\{e_1, e_2, e_3, e_4, e_5\}$, where e_1, e_2, e_3 are defined by (3.1) and e_4 is proportional to H, i.e., $H = H_0e_4$. Then, since e_4 is parallel, we have

(5.1)
$$
\nabla^{\perp} e_4 = 0, \qquad \langle \nabla_{e_1}^{\perp} e_3, e_4 \rangle = \langle \nabla_{e_1}^{\perp} e_5, e_4 \rangle = 0.
$$

Proposition [3.4](#page-6-4) implies

(5.2)
$$
A_{e_3} = \begin{pmatrix} \gamma & 0 \\ 0 & -\gamma \end{pmatrix}, \qquad A_{e_4} = \begin{pmatrix} 0 & 0 \\ 0 & 2H_0 \end{pmatrix}, \qquad A_{e_5} = \begin{pmatrix} \tau & 0 \\ 0 & -\tau \end{pmatrix},
$$

where, for simplicity, we put $\gamma_{e_3} = \gamma$, $\gamma_{e_5} = \tau$ and H_0 denotes the mean curvature of M. Note that (2.5) and (5.2) imply

(5.3)
$$
h(e_1, e_1) = -\gamma e_3 + \tau e_5, \qquad h(e_2, e_2) = \gamma e_3 + 2H_0 e_4 - \tau e_5
$$

and we have [\(3.22a\)](#page-6-3) because of Lemma [3.5.](#page-6-5) By using [\(3.22a\)](#page-6-3), from [\(3.4d\)](#page-4-6) we get

(5.4)
$$
\nabla_{e_2}^{\perp} e_3 = \nabla_{e_2}^{\perp} e_5 = 0.
$$

Moreover, [\(3.4c\)](#page-4-6) and [\(5.3\)](#page-10-1) imply

(5.5)
$$
\nabla_{e_1}^{\perp} e_3 = -\tanh \theta \tau e_5, \qquad \nabla_{e_1}^{\perp} e_5 = -\tanh \theta \tau e_3,
$$

where the last equation follows from (5.1) . By summing up the equations $(5.1)-(5.5)$ $(5.1)-(5.5)$, we obtain the following lemma.

Lemma 5.1. Let M be a space-like surface in $L_1^5(f, 0)$ with mean curvature H_0 and $\{e_1, e_2, e_3, e_4, e_5\}$ *be the orthonormal frame field defined by* [\(3.1\)](#page-4-0) and $H = H_0e_4$. If M is PMCV and bicon*servative, then*

(5.6a)
$$
\widetilde{\nabla}_{e_1} e_1 = -\gamma e_3 + \tau e_5, \qquad \widetilde{\nabla}_{e_2} e_1 = 0,
$$

(5.6b)
$$
\widetilde{\nabla}_{e_1} e_2 = 0, \qquad \widetilde{\nabla}_{e_2} e_2 = \gamma e_3 + 2H_0 e_4 - \tau e_5,
$$

(5.6c)
$$
\widetilde{\nabla}_{e_1}e_3 = -\gamma e_1 - \tanh \theta \tau e_5, \qquad \widetilde{\nabla}_{e_2}e_3 = \gamma e_2,
$$

(5.6d)
$$
\widetilde{\nabla}_{e_1} e_4 = 0, \qquad \widetilde{\nabla}_{e_2} e_4 = -2H_0 e_2,
$$

(5.6e)
$$
\nabla_{e_1} e_5 = -\tau e_1 - \tanh \theta \tau e_3, \qquad \nabla_{e_2} e_5 = \tau e_2.
$$

Next, by considering Lemma [5.1,](#page-10-4) we obtain a local parametrization of M.

Lemma 5.2. Let M be a space-like surface in $L_1^5(f,0)$, $p \in M$. If M is PMCV and *biconservative, then* p has a neighborhood \mathcal{N}_p congruent to the surface parametrized by

(5.7)
$$
\phi(u,v) = \left(u, x(u) \sin av, \frac{1}{af(u)} \cos av, y(u), z(u)\right),
$$

where $a > is a constant and x is given by$

(5.8)
$$
x(u) = \frac{1}{af(u)}
$$

and y*,* z *are some smooth functions satisfying*

(5.9)
$$
c_2y + c_3z - \frac{2H_0}{a}x = 0
$$

for some non-zero constants c_2, c_3 *such that*

(5.10)
$$
c_2^2 + c_3^2 + \frac{4H_0^2}{a^2} = 1.
$$

Proof. Let M be a space-like surface in $L_1^5(f, 0)$. Assume that it is PMCV and biconservative and consider a local coordinate system $(\mathcal{N}_p,(u, v))$ described in Lemma [3.5](#page-6-5) near to p. By the same method used in the proof of Lemma [4.2,](#page-8-7) we obtain

(5.11)
$$
\phi(u, v) = (u, \phi(u, v)),
$$

for a smooth \mathbb{R}^4 valued function $\tilde{\phi}$, where ϕ is the position vector of \mathcal{N}_p . Next, we use the second equations of [\(5.6b\)](#page-10-5)-[\(5.6e\)](#page-10-5) to get

(5.12)
$$
\widetilde{\nabla}_{e_2} \widetilde{\nabla}_{e_2} e_2 = (\gamma^2 - 4H_0^2 - \tau^2) e_2.
$$

By combining $(3.22c)$ and (5.12) we get

$$
\alpha''(v) + (\gamma(u)^2 \sinh^2 \theta(u) + \tau^2 + 4H_0^2) \alpha(v) = 0.
$$

Consequently, we have $\gamma(u)^2 \sinh^2 \theta(u) + \tau^2 + 4H_0^2 = a^2$ for a constant $a > 0$ and $\alpha'' + a^2 \alpha = 0$ from which we have

(5.13)
$$
\alpha(v) = (\cos av, -\sin av, 0, 0).
$$

By using (4.9) and (5.13) , we obtain (5.7) and (5.8) for some smooth functions y, z. Therefore, we have

(5.14)

\phi_u = (1, -x' \sin av, -x' \cos av, y', z').
$$

On the other hand, similar to proof of Lemma [4.2,](#page-8-7) we observe that [\(5.6d\)](#page-10-5) and [\(5.13\)](#page-11-2) imply

\frac{\partial e_4}{\partial u} + \frac{f'}{f}e_4 = 0, \qquad \frac{\partial e_4}{\partial v} = \frac{-2H_0}{f}(\cos av, -\sin av, 0, 0).
$$

By integrating these equations and using $\langle e_2, e_4 \rangle = 0$ we get

e_4 = \frac{1}{f} \left(0, -\frac{2H_0}{a} \sin av, -\frac{2H_0}{a} \cos av, c_2, c_3 \right),
$$

for some non-zero constants c_2, c_3 satisfying [\(5.10\)](#page-11-3). Finally, we consider [\(5.14\)](#page-11-4) and [\(5.15\)](#page-11-5) and $\langle e_1, e_4 \rangle = 0$ to get [\(5.9\)](#page-11-6).

Now, we are ready to prove the main result of this section.

Theorem 5.3. *Let* y, f *be some functions satisfying the system given by*

$$

$$
+2a^{4}b^{4}f^{8}f'y'^{4} + a^{8}c_{3}^{4}f^{4}f' + 2c_{4}^{2}f'^{5} = 0
$$

$$
a^{4}c_{3}^{2}f^{3}(f'y'' - f''y') - a^{2}b^{4}f^{6}y'^{3} + a^{2}b^{2}f^{4}y'(a^{2}c_{3}^{2} - 6c_{2}H_{0}f'y')
$$

$$
+f^{2}f'(2a^{4}c_{2}c_{3}^{2}H_{0} + (a^{4}c_{3}^{2} + 12a^{2}(c_{3}^{2} - 1)H_{0}^{2} + 48H_{0}^{4})f'y') - 2c_{2}c_{4}H_{0}f'^{3} = 0
$$

for some non-zero constants a, c_2, c_3 *satisfying* $b^2 = a^2 - 4H_0^2 > 0$ *, where we put* $c_4 =$ $a^2c_3^2+4H_0^2$. Then, the Robertson-Walker spaces $L_1^5(f,0)$ admits a space-like, biconservative *PMCV surface* M with the mean curvature H_0 parametrized by

\phi(u,v) = \left(u, \frac{\sin av}{af(u)}, \frac{\cos av}{af(u)}, y(u), \frac{2H_0 - c_2 a^2 f(u)y(u)}{c_3 a^2 f(u)}\right)
$$

 $Conversely, if a Robertson-Walker space $L_1^5(f, 0)$ admits a space-like, biconservative PMCV$ *surface, then* f *must be a solution of* [\(5.16\)](#page-11-7) *and the surface must be locally congruent to the surface given by* [\(5.17\)](#page-12-0)*.*

Proof. Let M be a surface in given by (5.7) , (5.8) and (5.9) for some non-zero constant a, c_2, c_3, H_0 satisfying [\(5.10\)](#page-11-3). Let e_1, e_2, e_4 be the vector fields given by [\(3.22d\)](#page-7-2) and [\(5.15\)](#page-11-5). We also consider the unit normal vector fields e_3 and e_5 given by

e_3 = \frac{1}{Vf\sqrt{V^2f^2 - 1}} \frac{1}{f} \left(V^2 f^2, x' \sin av, x' \cos av, y', z' \right),
$$

and

(5.19)
$$
e_5 = \frac{1}{Vf} \left(0, (c_2 z' - c_3 y') \sin av, (c_2 z' - c_3 y') \cos av, \frac{2H_0}{a} z' + c_3 x', -\frac{2H_0}{a} y' - c_2 x' \right),
$$

where we put

(5.20)
$$
V = x'^2 + y'^2 + z'^2.
$$

Then $\{e_1, e_2, e_3, e_4, e_5\}$ is an orthonormal frame field on M defined by [\(3.1\)](#page-4-0) and satisfying [\(5.6d\)](#page-10-5). Therefore, M is a biconservative PMCV surface if and only if $H = 2H_0e_4$. By using [\(5.18\)](#page-12-1) and [\(5.19\)](#page-12-2), we get

$$
A_{e_3}(e_1) = \frac{V(V^2fc_3^2 - 2) f'c_3 - V'fc_3}{(V^2fc_3^2 - 1)^{3/2}}e_1,
$$

\n
$$
A_{e_3}(e_2) = \frac{ax'c_3 + V^2f'c_3}{V\sqrt{V^2fc_3^2 - 1}},
$$

\n
$$
A_{e_5}(e_1) = \frac{f(ax'(c_2z'' - c_3y'') - z'(ac_2x'' + 2H_0y'') + y'(ac_3x'' + 2H_0z''))}{aV(V^2f^2 - 1)}e_1,
$$

\n
$$
A_{e_5}(e_2) = \frac{ac_2z' - ac_3y'}{V}.
$$

By considering [\(5.20\)](#page-12-3) and [\(5.21\)](#page-12-4), we observe that the equation $H = 2H_0e_4$ is equivalent to the system

$$

a^{2}c_{2}f^{2}y'^{2}z'afx'\left(c_{2}z''-c_{3}y''\right)+z'\left(ac_{2}\left(af^{2}x'^{2}-a-fx''\right)-2H_{0}fy''\right) +a^{2}c_{2}f^{2}z'^{3}-a^{2}c_{3}f^{2}y'^{3}++y'\left(ac_{3}\left(f\left(x''-af\left(x'^{2}+z'^{2}\right)\right)+a\right)+2H_{0}fz''\right)=0.
$$

Finally, we use (5.9) in (5.22) to get the system (5.16) .

.

6. PMCV Surfaces in Lorentzian Product Spaces

In this section, we are going to consider biconservative PMCV surfaces in the Cartesian product space $L_1^5(1, c) = \mathbb{E}_1^1 \times R^4(c) \subset \mathbb{E}_r^6$, where $c = \pm 1$.

Let M be a space-like surface in $\mathbb{E}^1_1 \times R^4(c)$ and assume that M is PMCV and biconservative. Consider the orthonormal frame field $\{e_1, e_2, e_3, e_4, e_5\}$ on M, where e_1, e_2, e_3 are defined by [\(3.1\)](#page-4-0) and e_4 is proportional to H, i.e., $H = H_0e_4$. By using $f = 1$, we consider [\(3.4b\)](#page-4-6) and [\(3.22b\)](#page-6-3) to get $A_{e_3}e_2 = 0$. Therefore, [\(3.20\)](#page-6-1) implies $A_{e_3} = 0$. Therefore, we have

$$
\gamma_{e_3} = 0
$$

and from [\(3.4a\)](#page-4-6) we obtain $e_1(\theta) = 0$. Consequently, the second equation in [\(3.22c\)](#page-6-3) implies

$$
\theta = \theta_0
$$

for a constant $\theta_0 \neq 0$. Next, we consider [\(3.19\)](#page-6-1), [\(3.20\)](#page-6-1), [\(6.1\)](#page-13-0) and [\(6.2\)](#page-13-1) with Codazzi equations (3.2) and (3.3) , to get

$$
(6.3) \qquad \qquad (\nabla_{e_2}^{\perp} \gamma_{e_5} e_5) = 0
$$

and

(6.4)
$$
\sinh \theta_0 \cosh \theta_0 c e_3 = \nabla_{e_1}^{\perp} (-\gamma_{e_5} e_5),
$$

respectively. From [\(6.3\)](#page-13-2) and [\(6.4\)](#page-13-3) we obtain

$$
\gamma_{e_5} = \tau_0
$$

for a non-zero constant τ_0 .

Remark 6.1. Before we proceed, we want to note that if M is a biconservative PMCV surface in a totally geodesic hypersurface $\mathbb{E}^1_1 \times R^3(c)$ of $\mathbb{E}^1_1 \times R^4(c)$, the equation [\(6.4\)](#page-13-3) turns into

$$
\sinh \theta_0 \cosh \theta_0 c e_3 = 0.
$$

Hence, it turns out that there are no space-like biconservative PMCV surface in the 4 dimensional Cartesian product space $\mathbb{E}_1^1 \times R^3(c)$ except the trivial case $T = 0$ or, equivalently, $\theta_0 = 0$.

Next we use $(2.11), (6.1), (6.2), (6.5)$ $(2.11), (6.1), (6.2), (6.5)$ $(2.11), (6.1), (6.2), (6.5)$ $(2.11), (6.1), (6.2), (6.5)$ $(2.11), (6.1), (6.2), (6.5)$ $(2.11), (6.1), (6.2), (6.5)$ in Lemma [5.6](#page-10-8) for the case $f = 1$ and $c = \pm 1$ to get following result.

Lemma 6.2. Let M be a space-like surface in $\mathbb{E}_1^1 \times R^4(c)$ with mean curvature H_0 and ${e_1, e_2, e_3, e_4, e_5}$ *be the orthonormal frame field defined by* [\(3.1\)](#page-4-0) *and* $H = H_0e_4$ *. If* M *is PMCV* and biconservative, then the Levi-Civita connection $\hat{\nabla}$ of the flat ambient space \mathbb{E}_r^6 *satisfies*

(6.6a)
\n
$$
\hat{\nabla}_{e_1} e_1 = \tau_0 e_5 - c \cosh^2 \theta_0 e_6, \qquad \hat{\nabla}_{e_2} e_1 = 0,
$$
\n(6.6b)
\n
$$
\hat{\nabla}_{e_1} e_2 = 0, \qquad \hat{\nabla}_{e_2} e_2 = 2H_0 e_4 - \tau_0 e_5 - c e_6,
$$

(6.6c)
$$
\hat{\nabla}_{e_1} e_3 = -\tanh \theta_0 \tau_0 e_5 + c \frac{\sinh 2\theta_0}{2} e_6, \qquad \hat{\nabla}_{e_2} e_3 = 0,
$$

(6.6d)
$$
\hat{\nabla}_{e_1} e_4 = 0, \qquad \hat{\nabla}_{e_2} e_4 = -2H_0 e_2,
$$

(6.6e)
$$
\hat{\nabla}_{e_1} e_5 = -\tau_0 e_1 - \tanh \theta_0 \tau_0 e_3, \qquad \hat{\nabla}_{e_2} e_5 = \tau_0 e_2,
$$

(6.6f)
$$
\hat{\nabla}_{e_1} e_6 = \cosh^2 \theta_0 e_1 + \frac{\sinh 2\theta_0}{2} e_3, \qquad \hat{\nabla}_{e_2} e_6 = e_2
$$

 f or some constants θ_0, τ_0 , where e_6 denotes the unit normal vector field of $\mathbb{E}^1_1 \times R^4(c)$ in \mathbb{E}^6_r and H_0 denotes the mean curvature of M in $\mathbb{E}^1_1 \times R^4(c)$.

Next, we get the following non-existence result.

Proposition 6.3. There are no space-like biconservative PMCV surface in $\mathbb{E}_1^1 \times \mathbb{H}^4$.

Proof. Assume that M is a space-like biconservative PMCV surface in $\mathbb{E}^1_1 \times \mathbb{H}^4$, i.e., $f = 1$ and $c = -1$. Then, by combining [\(6.6b\)](#page-13-5), [\(6.6d\)](#page-13-5) with the Codazzi equation [\(3.3\)](#page-4-7), we obtain

(6.7)

-\sinh \theta_0 \cosh \theta_0 e_3 = -\tau_0 \nabla_{e_1}^{\perp} e_5.
$$

However, the second equation in [\(6.6e\)](#page-13-5) and [\(6.7\)](#page-14-2) imply

which is a contradiction. \Box

Remark 6.4. The same result obtained for surfaces of the Riemannian product $\mathbb{E}^1 \times \mathbb{H}^4$ in [\[7,](#page-18-3) Lemma 3.1].

Now, we are ready to proved the main result of this section.

Theorem 6.5. Let M be a space-like surface in $\mathbb{E}_1^1 \times \mathbb{S}^4$. Then M is biconservative and *PMCV if and only if it is congruent to the surface locally parametrized by*

(6.8)
$$
\phi(u,v) = \left(-b_1u, \frac{\sqrt{b_1^2 + 1}\cos\left(\sqrt{b_1^2 + 2}u\right)}{\sqrt{b_1^2 + 2}}, \frac{\sqrt{b_1^2 + 1}\sin\left(\sqrt{b_1^2 + 2}u\right)}{\sqrt{b_1^2 + 2}}, b_2, \frac{b_3\sin\frac{v}{b_3}, b_3\cos\frac{v}{b_3}}{\sqrt{b_3^2 + 2}}, \frac{b_4\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}, \frac{b_5\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}, \frac{b_5\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}, \frac{b_6\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}, \frac{b_7\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}, \frac{b_7\sin\frac{v}{b_3}}{\sqrt{b_4^2 + 2}}\right)
$$

 $for\ some\ non-zero\ constants\ b_1,b_2,b_3\ satisfying\ b_2^2+b_3^2=\frac{1}{b_1^2+1}$ $\frac{1}{b_1^2+2}$.

Proof. In order to prove the sufficient condition, assume that M is biconservative PMCV and let $p \in M$. Then, by Lemma [6.2](#page-13-6) we have [\(6.6\)](#page-13-7). [\(6.6a\)](#page-13-5) and [\(6.6b\)](#page-13-5) implies $[e_1, e_2] = 0$. So, there exists a local coordinate system $(\mathcal{N}_p,(u, v))$ such that $\mathcal{N}_p \ni p$ and

e_1 = \partial_u, \qquad e_2 = \partial_v.
$$

This equation, the second equation in [\(6.6a\)](#page-13-5) and the first equation in [\(6.6b\)](#page-13-5) imply

(6.10)
$$
e_1 = \partial_u = (-\sinh \theta_0, \bar{e}_1)
$$

and

$$
(6.11) \qquad \qquad e_2 = \partial_v = (0, \bar{e}_2)
$$

for some smooth \mathbb{R}^5 -valued functions $\bar{e}_1 = \bar{e}_1(u)$ and $\bar{e}_2 = \bar{e}_2(v)$.

On the other hand, by using the second equations in [\(6.6b\)](#page-13-5), [\(6.6d\)](#page-13-5)-[\(6.6f\)](#page-13-5), we get

\hat{\nabla}_{e_2}\hat{\nabla}_{e_2}e_2 = (0, \vec{e}_2'') = (4H_0^2 + \tau_0^2 + 1)(0, \vec{e}_2).
$$

Since $\langle \bar{e}_2, \bar{e}_2 \rangle = 1$, up to a suitable rotation, we may assume

for some constant vectors $C_1, C_2 \in \mathbb{R}^5$, where we put $a = \sqrt{4H_0^2 + \tau_0^2 + 1}$. Since \bar{e}_2 is unit, $\{C_1, C_2\}$ is orthonormal.

Note that we have

for a \mathbb{R}^5 -valued function \bar{e}_4 . We use [\(6.6d\)](#page-13-5) and [\(6.13\)](#page-14-3) to obtain

which implies

\bar{e}_4 = \frac{-2H_0}{a}\sin avC_1 + \frac{-2H_0}{a}\cos avC_2 + C_3
$$

for a constant vector $C_3 \in \mathbb{R}^5$. By considering $\langle \bar{e}_2, \bar{e}_4 \rangle = 0$ and $\langle \bar{e}_4, \bar{e}_4 \rangle = 1$, we obtain $\langle C_1, C_3 \rangle = \langle C_2, C_3 \rangle = 0$ and $\langle C_3, C_3 \rangle = \frac{\tau_0^2 + 1}{a^2}$ $\frac{a^2+1}{a^2}$. Up to a suitable rotation in \mathbb{R}^5 , we may choose $C_1 = (0, 0, 0, 1, 0), C_2 = (0, 0, 0, 0, -1), C_3 = (0, 0,$ $\sqrt{\tau_0^2+1}$ $\frac{0}{a}$, 0, 0). Therefore, [\(6.11\)](#page-14-4)- (6.14) imply

(6.15)
$$
e_2 = \phi_v = (0, 0, 0, 0, \cos av, -\sin av),
$$

(6.16)
$$
e_4 = (0, 0, 0, \frac{\sqrt{\tau_0^2 + 1}}{a}, \frac{-2H_0}{a}\sin av, \frac{2H_0}{a}\cos av).
$$

Moreover, by a direct computation using [\(6.10\)](#page-14-5), [\(6.15\)](#page-15-1) and $\langle e_1, e_2 \rangle = \langle e_1, e_6 \rangle = 0$, we get

(6.17)
$$
e_1 = \phi_u = (-\sinh \theta_0, \phi'_1(u), \phi'_2(u), \phi'_3(u), 0, 0)
$$

for some smooth functions ϕ_1, ϕ_2, ϕ_3 satisfying

(6.18)
$$
\phi_1^{\prime 2} + \phi_2^{\prime 2} + \phi_3^{\prime 2} = \cosh^2 \theta_0.
$$

Note that $\langle e_1, e_4 \rangle = 0$ implies

$$
\phi_3 = b_2
$$

for a constant b_2 .

Next, by using (6.15) and (6.17) and considering (6.19) we obtain

(6.20)
$$
\phi(u, v) = (-u \sinh \theta_0, \phi_1(u), \phi_2(u), b_2, b_3 \sin \frac{v}{b_3}, b_3 \cos \frac{v}{b_3})
$$

for a non-zero constant constant b_2 , where we put $a = \frac{1}{b_2}$ $\frac{1}{b_3}$. [\(6.18\)](#page-15-4) turns into

(6.21)
$$
\phi_1^{\prime 2} + \phi_2^{\prime 2} = \cosh^2 \theta_0
$$

and from $\langle e_6, e_6 \rangle = 1$ we have

(6.22)
$$
\phi_1^2 + \phi_2^2 = b_0^2,
$$

where we put $b_0 = \sqrt{1 - (b_2^2 + b_3^2)}$. Because of [\(6.21\)](#page-15-5) and [\(6.22\)](#page-15-6), up to a suitable rotation, we may assume

(6.23)
$$
\phi_1 = b_0 \cos\left(\frac{u \cosh \theta_0}{b_0}\right), \qquad \phi_2 = b_0 \sin\left(\frac{u \cosh \theta_0}{b_0}\right).
$$

By combining (6.20) and (6.23) , we obtain

(6.24)
$$
\phi(u, v) = \left(-u \sinh \theta_0, b_0 \cos \left(\frac{u \cosh \theta_0}{b_0}\right), b_0 \sin \left(\frac{u \cosh \theta_0}{b_0}\right), b_2, b_3 \sin \frac{v}{b_3}, b_3 \cos \frac{v}{b_3}\right).
$$

By a direct computation, we obtain the mean curvature vector H of M in $\mathbb{E}^1_1 \times \mathbb{S}^4$ as

(6.25)
$$
H = \left(0, b_4 \cos\left(\frac{u \cosh(\theta_0)}{b_0}\right), b_4 \sin\left(\frac{u \cosh(\theta_0)}{b_0}\right), \frac{1}{2}b_2 \left(\cosh^2(\theta_0) + 1\right),
$$

$$
b_5 \sin\left(\frac{v}{b_3}\right), b_5 \cos\left(\frac{v}{b_3}\right)\right),
$$

where we put $b_4 = \frac{b_0^2 (\cosh^2(\theta_0)+1) - \cosh^2(\theta_0)}{2b_0}$ $\frac{1+1}-\cosh^2(\theta_0)}{2b_0}$ and $b_5 = \frac{b_3^2(\cosh^2(\theta_0)+1)-1}{2b_3}$ $\frac{\left(\frac{00}{11}\right)^{11}}{2b_3}$. Note that we have $\langle H, \eta \rangle = 0$. By a further computation using [\(6.9\)](#page-14-6) and [\(6.25\)](#page-16-0), we see that H is parallel if and only if $b_4 = 0$ which implies

(6.26)

b_0 = \frac{\cosh \theta_0}{\sqrt{\cosh^2 \theta_0 + 1}}.
$$

Finally, we combine [\(6.24\)](#page-15-9) with [\(6.26\)](#page-16-1) and put $b_1 = \sinh \theta_0$ to get [\(6.8\)](#page-14-7).

The proof of the converse follows from a direct computation.

7. Reduction of Co-dimension

In this section, we consider the substantial co-dimension of a biconservative surfaces in Robertson-Walker spaces with higher dimension.

Let M be an oriented space-like biconservative PMCV surface in $L_1^n(f, c)$, $n \geq 6$. Consider the positively oriented global vector fields e_1, e_2, e_3, e_4 and the function $\theta : M \to \mathbb{R}$ defined by [\(3.1\)](#page-4-0) and $H = H_0e_4$. Also, by considering Proposition [3.4,](#page-6-4) define the vector field ξ on M and a function $\gamma : M \to \mathbb{R}$ by

(7.1)
$$
\langle \xi, \eta \rangle = 0, \qquad h(e_1, e_2) = 0, h(e_1, e_1) = -\gamma e_3 + \xi, \qquad h(e_2, e_2) = \gamma e_3 + 2H_0 e_4 - \xi,
$$

where we put $\gamma = \gamma_{e_3} = h_{11}^3$.

We are going to use the following lemma.

Lemma 7.1. Let M be an oriented space-like biconservative PMCV surface in $L_1^n(f, c)$, $n \geq$ 6*. Then, we have two cases:*

Case 1. dim $N_1M = 2$ *at every point of* $M, \eta \in N_1M$ *and* $\nabla^{\perp}(N_1M) \subset N_1M$, Case 2. dim $N_2M = 3$ *at every point of* $M, \eta \in N_2M - N_1M$ *and* $\nabla^{\perp}(N_2M) \subset N_2M$.

Proof. Put $\langle \xi, \xi \rangle = \zeta$. First, we claim that either ζ is identically zero or it is nonvanishing on M. We combine $(3.22b)$ and (7.1) with the equations (3.2) , (3.3) , $(3.4c)$ and [\(3.4d\)](#page-4-6) to get

(7.2)
$$
e_2(\gamma) = e_2(\theta) = 0,
$$

(7.3)
$$
\nabla_{e_2}^{\perp} e_3 = \nabla_{e_2}^{\perp} \xi = 0,
$$

(7.4)
$$
\nabla_{e_1}^{\perp} e_3 = -\tanh\theta\xi,
$$

(7.5)
$$
\cosh \theta \sinh \theta \left(-\frac{f''}{f} + \frac{f'^2 + c}{f^2} \right) e_3 = e_1(\gamma) e_3 - \gamma \tanh \theta \xi - \nabla_{e_1}^{\perp} \xi
$$

from which we also have

$$
(7.6) \qquad \qquad e_2(\zeta) = 0,
$$

(7.7)
$$
e_1(\zeta) = 2\gamma \tanh \theta \zeta.
$$

Now, assume the existence of $p \in M$ such that $\xi(p) = 0$. By considering [\(3.22b\)](#page-6-3), we use a local coordinate system (\bar{u}, \bar{v}) on \mathcal{N}'_p starting from (u, v) such that $e_1|_{\mathcal{N}'_p} = \partial_u$ and $e_2|_{\mathcal{N}'_p} = \partial_v$. Then, because of [\(7.2\)](#page-16-3), [\(7.6\)](#page-16-4) and [\(7.7\)](#page-16-4), we have

$$
\zeta = \zeta(u), \ \gamma = \gamma(u), \ \theta = \theta(u), \qquad \zeta' = 2\gamma \tanh \theta \zeta, \ \zeta(0) = 0
$$

on \mathcal{N}'_p . This shows that $\zeta = 0$ on \mathcal{N}'_p . By the connectedness, $\zeta = \langle \xi, \xi \rangle = 0$ on M. This proves our claim. Since ξ is space-like by [\(7.1\)](#page-16-2), we have either $\xi = 0$ on M or $\xi(p) \neq 0$ for all $p \in M$.

Case 1. $\xi = 0$ on M. In this case, [\(7.4\)](#page-16-3) and [\(7.5\)](#page-16-3) turn into

$$
\nabla_{e_1}^{\perp} e_3 = 0,
$$

(7.9)
$$
e_1(\gamma) = \cosh \theta \sinh \theta \left(-\frac{f''}{f} + \frac{f'^2 + c}{f^2} \right)
$$

We note the first equation in [\(3.22c\)](#page-6-3) and [\(7.2\)](#page-16-3) ensures that γ is non-vanishing on M. So we have the Case 1 of the lemma because of [\(7.3\)](#page-16-3) and [\(7.8\)](#page-17-1).

Case 2. $\xi(p) \neq 0$ for all $p \in M$. In this case, [\(7.1\)](#page-16-2) implies $N_1 = \text{span} \{ \gamma e_3 - \xi, e_4 \}$ and $\eta \notin N_1$. Moreover, from [\(7.5\)](#page-16-3) we have

(7.10)
$$
\cosh \theta \sinh \theta \left(\frac{e_1(\gamma)}{\zeta} + \frac{f''}{f\zeta} - \frac{f'^2 + c}{\zeta f^2} \right) e_3 = \nabla_{e_1}^{\perp} \frac{1}{\zeta} \xi.
$$

 (7.3) , (7.4) and (7.10) yield the Case 2 of the lemma.

Now, we are ready to prove the main result of this section.

Theorem 7.2. Let M be an oriented space-like biconservative PMCV surface in $L_1^n(f, c)$, $n \geq$ 6. Then, there exists a totally geodesic submanifold N of $L_1^n(f, c)$ such that $M \subset N$ and dim N *is either 4 or 5.*

Proof. Let $p \in M$. We are going to consider the Case 1 and Case 2 of Lemma [7.1,](#page-16-5) separately. Note that by Corollary [3.6,](#page-7-7) M has flat normal bundle.

Case 1. In this case, N_1M and its orthogonal complementary $(N_1M)^{\perp}$ in the normal bundle of M are invariant under the normal connection. Since M has flat normal bundle, similar to the proof of [\[6,](#page-18-9) Lemma 1], there exists orthonormal vector fields $\xi_5, \xi_6, \ldots, \xi_n \in (N_1M)^{\perp}$ such that $\nabla^{\perp}\xi_{\alpha} = 0$ which yields $\nabla \xi_{\alpha} = 0$ for $\alpha \geq 5$.

Let $(\mathcal{N}_p,(u, v))$ be a local coordinate system near to p described in Lemma [3.5.](#page-6-5) Put $\bar{\mathcal{N}}_p = \Pi^2(\mathcal{N}_p)$. First, we claim that $\bar{\mathcal{N}}_p$ lies on a 3-dimensional totally geodesic submanifold \overline{N}_p of $R^{n-1}(c)$. Note that we have

$$
0 = \widetilde{\nabla}_{\partial_u} \xi_{\alpha} = \nabla^0_{\partial_u} \xi_{\alpha} + \frac{f'}{f} \xi_{\alpha},
$$

$$
0 = \widetilde{\nabla}_{\partial_v} \xi_{\alpha} = \nabla^0_{\partial_v} \xi_{\alpha}
$$

which imply that

$$
\xi_{\alpha} = \frac{1}{f}C_{\alpha}
$$

for $\alpha \geq 5$, where C_{α} satisfies

(7.11) $\nabla^0 C_\alpha = 0.$

On the other hand, because $\eta \in N_1M$, we have $\tilde{g}(C_\alpha, \eta) = 0$ which implies

(7.12) $g_c(\Pi^2_*(C_\alpha), X) = 0$

whenever X is a vector field in $R^{n-1}(c)$ tangent to $\bar{\mathcal{N}}_p$ and we have

(7.13)
$$
\widetilde{g}_c(\Pi^2_*(C_\alpha), \Pi^2_*(C_\beta)) = \delta_{\alpha\beta}.
$$

Thus, (7.12) and (7.13) yield that $\{\Pi^2_*(C_5), \Pi^2_*(C_6), \ldots, \Pi^2_*(C_n)\}\)$ is an orthonormal set of vector fields normal to \mathcal{N}_p in $R^{n-1}(c)$. Furthermore, from [\(7.11\)](#page-17-4) we have

$$
\nabla_X^{R^{n-1}(c)} \Pi_*^2(C_\alpha) = 0.
$$

Therefore, [\[6,](#page-18-9) Theorem] implies that $\bar{\mathcal{N}}_{p}$ lies on a 3-dimensional totally geodesic submanifolds \bar{N}_p of $R^{n-1}(c)$. Put $N_p = I \times_f \bar{N}_p$. Then, N_p is a 4-dimensional totally geodesic submanifold of $L_1^n(f, c)$ and $\mathcal{N}_p \subset \mathcal{N}_p$. This proves the local result.

The global result follows from being constant of dim N_1 on M similar to the idea of the proof of [\[6,](#page-18-9) Proposition 1]: If $q \in M$ and $\mathcal{N}_q \cap \mathcal{N}_p \neq \emptyset$, then we have $\mathcal{N}_p \cap \mathcal{N}_q \subset N_p \cap \mathcal{N}_q$ for a totally geodesic submanifold $N_q \ni q$. If $N_p \neq N_q$, then dim $N_p \cap N_q < 4$ which implies that dim $N_1 < 2$ at r whenever $r \in \mathcal{N}_q \cap \mathcal{N}_p$. However, this yields a contradiction. Hence, we have $N_p = N_q$. By the connectedness, $M \subset N^4$ and N is a totally geodesic submanifold of $L_1^n(f, c)$.

Case 2. In this case, similar to Case 1, we consider orthonormal vector fields $\xi_6, \xi_7, \ldots, \xi_n \in$ $(N_2M)^{\perp}$ which satisfies $\widetilde{\nabla}\xi_{\alpha} = 0$ for $\alpha \geq 6$. We get [\(7.11\)](#page-17-4), [\(7.12\)](#page-17-3) and [\(7.13\)](#page-18-10) for $\alpha \geq 6$. Since dim N_2 is constant on M , [\(7.11\)](#page-17-4), [\(7.12\)](#page-17-3) and [\(7.13\)](#page-18-10) for $\alpha \ge 6$ yield the same conclusion for a totally geodesic submanifold N^5 of $L^n(f, c)$. for a totally geodesic submanifold N^5 of $L_1^n(f, c)$.

By combining Theorem [7.2](#page-17-0) with Remark [6.1](#page-13-8) and Proposition [6.3,](#page-14-1) we get the following results:

Corollary 7.3. *A space-like biconservative PMCV surface in* $\mathbb{E}_1^1 \times \mathbb{S}^n$, $n \ge 6$ *is contained in a totally geodesic submanifold* N^5 of $\mathbb{E}^1_1 \times \mathbb{S}^n$.

Corollary 7.4. There are no space-like biconservative PMCV surface in $\mathbb{E}_1^1 \times \mathbb{H}^n$.
