

## DATASET LICENSE AGREEMENT

This license is a legal agreement between you and NVIDIA Corporation ("NVIDIA") and governs your use of the NVIDIA dataset as available under this license ("DATASET").

Description of the DATASET:

1. Urban Intersection and Highway Data: Approximately 12 hours of traffic videos synchronously captured from multiple vantage points at various urban intersections and along highways. Videos are 960p or better and most have been captured at 10 frames per second.
2. Metadata of Urban Intersection and Highway Data: Meta data includes GPS locations of cameras, natural language descriptions for vehicle tracks, camera calibration information and other derived data from videos.
3. Retail Dataset: Approximately 100,000 synthetic images of close to 100 objects available in retail stores, and approximately 10 minutes of videos capturing these objects.

You agree to use the DATASET only for purposes that are permitted by (a) this license, and (b) any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions.

**1. LICENSE.** Subject to the terms of this license, NVIDIA grants you a revocable, non-exclusive limited license to use the DATASET as follows:

- (i) For the duration of a challenge or event (including the AI City Challenge), you may use the DATASET solely for purposes of the challenge or event, which includes reading and learning from the DATASET, analyzing the DATASET, modifying the DATASET and generally preparing your submission including any underlying models,
- (ii) Upon the conclusion of a challenge or event or if NVIDIA provided you the DATASET outside of a challenge or event (if applicable) you may use the DATASET, including models developed using the DATASET, for non-commercial, academic purposes only, and

- a. You may not use the DATASET or any models developed using the DATASET for any commercial or production purpose.
- b. You may not remove copyright or other proprietary notices from any portion of the DATASET or copies of the DATASET.
- c. Except as expressly authorized under Section 1, you may not copy, sell, rent, sublicense, transfer or distribute the DATASET, or share with others.
- d. Unless authorized in writing by NVIDIA, you may not indicate or suggest that any content (including any models) created with the DATASET is sponsored or endorsed by NVIDIA.

**3. OWNERSHIP.** NVIDIA reserves all rights, title and interest in and to the DATASET not expressly granted to you under this license. The DATASET and the related intellectual property rights therein are and will remain the sole and exclusive property of NVIDIA or its licensors. The DATASET is copyrighted and protected by the laws of the United States and other countries, and international treaty provisions. NVIDIA may make changes to the DATASET at any time without notice, but is not obligated to support or update the DATASET.
