

# Privacy Policy For Intelliga Corporation

## Introduction

Intelliga Corp DBA Bland AI ("we," "us," "our," or "Bland AI") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our artificial intelligence phone calling system and related services (collectively, the "Service"). By accessing or using the Service, you agree to this Privacy Policy and our Terms of Service.
