High-visibilty two-photon interferen

We report on a two-photon interference experiment in a quantum relay configuration using two pi
ose
ond regime PPLN waveguide based sour
es emitting paired photons at 1550 nm. The results show that the pi
ose
ond regime asso
iated with a guided-wave s
heme should have important reper
ussions for quantum relay implementations in real onditions, essential for improving both the working distance and the efficiency of quantum cryptography and networking systems. In contrast to already reported regimes, namely femtosecond and CW, it allows achieving a 99% net visibility two-photon interference while maintaining a high effective photon pair rate using only standard tele
om omponents and dete
tors.

For the realization of quantum networks, interferen
e between photons produced by independent sources is necessary. Photon oales
en
e (or two-photon interferen

This effect has been extensively studied theoretically $[8, 9]$ $[8, 9]$ and experimentally, initially based on two photons coming from a single down onversion sour
e and therefore sharing a common past $[10, 11, 12]$ $[10, 11, 12]$ $[10, 11, 12]$ $[10, 11, 12]$. However, experiments involving truly independent photons represent an important hallenge for a
hieving longer quantum links by means of quantum relays $[13]$ $[13]$. In this frame, it has been demonstrated theoreti
ally that a two-photon interferen
e net visibility of at least 95% is required for practical implementations using urrently available photon pair sour
es and multimode quantum memories [14]. Reaching such a high visibility therefore appears to be a hard task sin
e a perfe
t syn
hronization between independent sour
es is ne
essary to prevent any kind of distinguishability between the interfering photons. Several papers focusing on the syn
hronization issue have demonstrated that entanglement swapping with fully independent sour
es is in principle feasible in the femtosecond [\[3,](#page-3-2) 4] and CW [\[5,](#page-3-4) [7](#page-3-6)] regimes. Unfortunately, beyond the fundamental interest, the reported interferen
e visibilities remain either far from 95% or show very low overall photon pair rate. For instan
e, the best visibility reported so far in the femtose
ond regime has been obtained by ompensating the syn
hronization-indu
ed temporal distinguishability by dramati
ally in
reasing the photons oheren
e time up to a few picoseconds at the expense of the overall brightness [4]. Since laser cavities can easily be synchronized to subpicosecond accuracy $[15, 16]$ $[15, 16]$ $[15, 16]$ $[15, 16]$, the study of the pi- \cos econd regime $[6, 17]$ $[6, 17]$, its associated filter bandwidths,

and the type of photon pair generators, be
omes of prime interest to ensure simultaneously a high degree of indistinguishability and a high overall brightness.

Here, we demonstrate that to a
hieve this, the pi cosecond regime should provide an efficient trade-off enabling near-perfe
t two-photon interferen
e and high effective photon pair rates, when associated with standard components available from the telecommunications industry. More precisely, we realized an experiment based on a single pi
ose
ond pump laser and two periodi
ally poled lithium niobate (PPLN) waveguides emitting paired photons around 1550 nm to approximate independent sour
es. We report the highest two-photon interferen
e net visibility, i.e. of 99%, ever demonstrated in a configuration extendable to quantum relays. Such a proof-of-prin
iple emphasizes why guided-wave te
hnology, in the pi
ose
ond regime, should lead to realisti quantum relay schemes, namely by offering an reducedonstraint solution for the syn
hronization issue when two ompletely independent lasers are employed. In the following, we briefly introduce the entanglement swapping based quantum relay s
heme and dis
uss why the picosecond regime is a valuable trade-off. We then focus on our experimental demonstration. Finally, we detail a omparative study of performan
e with similar reported experiments.

A basic scheme of a quantum relay based on entanglement swapping is given in FIG[.1](#page-1-0) (see aption for details). For long distan
e quantum ommuni
ation links, the preferred qubit arriers are photons at 1550 nm allowing the users, namely Alice and Bob, to take advantage of standard optical fibers for distribution purposes. Theoreti
ally, the two inner photons an ome from any type of source, provided they are identical at the beam-splitter (BS) (pre-selection) or at the detectors (post-sele
tion). From the experimental side, we have to compare their coherence time, $\tau_{\rm coh}$, to the time uncertainty, t_{uncert} , within which they are created (i.e. the pulse duration of the pump $laser(s)$ or are detected (de-

tector's timing jitters), which can be written as:

$$
\tau_{\rm coh} \ge t_{\rm uncert} \tag{1}
$$

Suitable bandpass filters are therefore employed to a
hieve optimal interferen
e visibilities. Up to now, this issue has been addressed using different approaches based on pulsed or CW lasers (see also Table [I](#page-3-17) for omparison).

On the one hand, the first experiments reported two independent crystals pumped by femtosecond lasers, since this regime allows working with broadband filters, i.e. on the order of a few nm $[2]$. However, the large photon bandwidths makes them more prone to hromati and polarization dispersions in optical fibers and leads to reported visibilities below 85% [\[18](#page-3-18)]. Moreover when two independent lasers are used, the two related laser cavities have to be properly syn
hronized so as to be identi cal within the pump pulse duration $(\sim 100 \text{ fs})$ [\[3](#page-3-2), 4]. This can be achieved using phase-locked loops or atomic clocks and dedicated electronics [\[19,](#page-3-19) 20]. Any remaining jitter between the two lasers has to be ompensated by narrowing the lters whi
h implies a substantial redu
tion of the pair production rate for equivalent powers [4].

On the other hand, the development of narrowbandwidth fiber Bragg grating (FBG) filters allows using two independent CW lasers stabilized against an atomi transition $[5, 6]$ $[5, 6]$. Since this regime does not provide any referen
e lo
k, the timing fun
tion is transferred to the oin
iden
e dete
tion after the BS. To ensure a high quality interferen
e, the photons oheren
e time has to be longer than the jitter of the detectors. Experimentally, this is made possible using a suitable ombination of low-jitter dete
tors (based on super
ondu
ting or up onversion te
hnologies), on the order of 70 ps, asso
iated with ultra-narrow FBG filters, on the order of 10 pm [5]. In such a situation, one gets rid of the synchronization but the pri
e to pay is rather high in terms of sensitive fluctuations of the filters central wavelengths, low experimental rates due to the narrow filters coupled to the randomness of entangling photons by coincidence detection, and high statistical fluctuations due to low count rates. All these issues prevent reaching high visibilities.

Between these two extremes, the picosecond regime appears to be an efficient compromise. First, the timing condition (1) is easily met by using FBG filters showing mu
h larger bandwidths than in CW, i.e. on the order of 100 pm [\[17](#page-3-16)]. Second, this allows taking advantage of off-the-shelf InGaAs avalanche photodiodes (APD). Last, when compared to the femtosecond regime, narrower bandwidths loosen the constraints on both pathlength stabilization for the interfering photons and laser synchronization to subpicosecond accuracy [\[15,](#page-3-14) [16](#page-3-15)] to obtain high-visibility Hong-Ou-Mandel interferen
e. All these key points motivate investigating this regime.

Assuming syn
hronization is fairly feasible, we therefore focused our efforts at increasing the overall spectral brightness by employing a picosecond pump laser assoiated with state-of-the-art waveguide sour
es emitting at tele
om wavelengths. As shown in FIG[.2,](#page-2-0) the pump laser (Coherent MIRA 900-D) provides 1.2 ps-duration, time-bandwidth limited ($\Delta\lambda_p = 0.25$ nm) pulses, at the wavelength of $\lambda_p = 768 \text{ nm}$ and at a repetition rate of 76 MHz. The pulses are sent to a BS whose outputs are dire
ted towards two 10 mm-long PPLN waveguides fabri
ated in our laboratory using the soft-proton ex
hange technique [\[21](#page-3-21)]. These devices are single mode at telecom wavelengths enabling only one nonlinear process to ocur avoiding any additionnal ba
kground noise within the bandwidth of interest whi
h is a key advantage ompared to four-wave mixing sources $[6, 17]$ $[6, 17]$ $[6, 17]$ $[6, 17]$ limited by Raman ba
kground photons. Both samples opto-geometri
al parameters were designed to produ
e identi
al degenerate paired photons at 1536 nm within a bandwidth of 50 nm when pumped at 768 nm in the picosecond regime. Since $\frac{1}{\Delta}$ conversion bandwidth $\left(\frac{\Delta \lambda_{spde}}{\Delta \lambda_{spde}}\right)$ $\frac{\Delta \lambda_{spdc}}{\Delta \lambda_{filter}} \geq 10^2$), experimentally, the two sour
es are simply independently stabilized at the temperature of 343 K to within 0.1 K.

From ea
h sour
e, we sele
t pairs of photons meeting the Fourier transform criterion using narrowband demultiplexers made of two optical circulators and a pair of FBG filters. These are set to reflect energy-matched pairs of wavelength at 1537.4 nm and 1534.6 nm, i.e. around degeneracy, associated with bandwidths of 800 pm and 250 pm, respectively. A slightly wider (800 pm) filter is used on the long wavelength (1537 nm) photons mainly to minimize overall losses. This filtering solution based on standard tele
om omponents provides a lever way to separate deterministi
ally the photons at the output of the waveguides and makes them ea
h available in a single mode fiber [\[5](#page-3-4)]. The $250 \,\mathrm{pm}$ filters bandwidth has been hoosen for two reasons : (a) it is narrow enough to accommodate the 1.2 ps-duration of the laser pulses and any possible jitter up to 4 ps due to laser syn
hronization and/or dispersion in the fiber; (b) it is large enough to

stabilize their entral wavelength using two independent proportional-integral-derivative temperature ontrollers.

To observe the two-photon interference, four-fold coin
iden
es are dete
ted thanks to four InGaAs-APDs (idQuantique 201) triggered by a Peltier ooled Si-APD (idQuantique 100) pla
ed on the path of an attenuated fra
tion of the pump beam. Sin
e these InGaAs-APDs are designed to handle a maximum triggering rate of 1 MHz, this te
hnique allows working at an average lo
k of 600 kHz randomly pi
ked from the 76 MHz laser repetition rate. In our case, faster InGaAs-APD would highly improve the overall coincidence rate as shown in Ref. [6]. The evolution of the effective four-fold coincidence rate is given in FIG[.3](#page-2-1) in whi
h a remarkable dip is obtained when the delay between the two inner photons is zero.

Using only 1 mW of mean pump power per sour
e, we obtained 4×10^3 two-fold coincidences per hour and per sour
e whi
h orresponds to about 0.05 photon per pulse. In terms of normalized brightness it means that our sources reach 1.6×10^3 pairs·s⁻¹·pm⁻¹·mW⁻¹ after the filtering stage. This brightness corresponds to the state-of-the-art for PPLN waveguides and is basically five orders of magnitude larger than that of bulk crystals $[21, 22]$ $[21, 22]$ $[21, 22]$ $[21, 22]$. When the two photons are made indistinguishable in time (δt) thanks to the adjustment of the retro-reflector (R) placed in front of one sample, a $93\% \pm 3\%$ reduction in the raw four-fold coincidence count is obtained. By correctly recording the accidental coinciden
es, we are able to demonstrate that the net visibility rea
hes 99%±3%. The full width at half maximum of the dip is approximately $\Delta \tau \approx 11$ ps, which is in good agreement with the coherence time of 14 ps expected from the filter bandwidths. This interference visibility is also extremely close to the maximum value of 99.9% calculated from the theory taking into account our filtering bandwidths, as properly outlined in Refs. $[8, 9, 18]$ $[8, 9, 18]$ $[8, 9, 18]$ $[8, 9, 18]$. Note that the very high stability offered by our guided-wave scheme allowed us performing 48h-long measurement leading to

more than 30 points evenly spread over the dip.

Table [I](#page-3-17) presents the ompared results reported in the literature for similar configurations which can be differentiated by four key points: (i) the type of nonlinear generators, (ii) the emitted photon wavelengths, (iii) the pumping regime and its asso
iated time un
ertainty, (iv) and, finally, the applied filtering bandwidths and their asso
iated oheren
e times. From a omparison between the reported results, we on
lude that the ombination of the pi
ose
ond regime and the single mode properties of the employed tele
ommuni
ation omponents is the most performant scheme. It allows matching efficiently the inequality [\(1\)](#page-1-1) and obtaining near-perfe
t two-photon interference. For practical long distance quantum communication, it is also interesting to compare the effective number of pairs available per second at Alice and Bob's locations. This figure of merit is calculated by normalizing the four-fold coincidence rates with respect to Alice and Bob's detector efficiencies. A comparison with similar configurations at telecom wavelengths indicates that the picosecond regime allows maintaining a high effective pair produ
tion rate equivalent to that of the femtose
ond regime but shows a mu
h higher visibility. One should also note the two orders of magnitude rate differen
e for equivalent sour
e te
hnologies and brightness between the CW and picosecond regimes. In addition, the best visibility reported in Ref. $[4]$ with photons in the visible comes from the fact that the filtering bandwidths are on the order of those necessary for the picosecond regime. Consequently, the overall brightness is very low considering the use of efficient Si-APDs. Finally, bright fiber sources are contaminated by intrinsic spontaneous Raman scattering noise, leading to accidental coincidences

and to reduced visibilities $[6, 17]$ $[6, 17]$ $[6, 17]$ $[6, 17]$.

The results demonstrated in this experiment are of broad interest sin
e the obtained net visibility is the best value reported to date for comparable configurations. According to reference $[14]$, this allows, for the first time, onsidering the possibility of using quantum relays in a
 tual quantum cryptography networks. In this context, where two synchronized picosecond lasers must be used. we not only expe
t results of the same order, thanks to
