Determination of two-photon exchange amplitudes from elastic electron-proton scattering data

Abstract. Using the available cross section and polarization data for elastic electron-proton scattering, we provide an extraction of the two-photon exchange amplitudes at a common value of four-momentum transfer, around *Q*² = 2.5 GeV² . This analysis also predicts the *e* ⁺ *p*/*e* [−] *p* elastic scattering cross section ratio, which will be measured by forthcoming experiments.

The electromagnetic form factors (FFs) of the nucleon have been explored extensively during the last 50 years with ever increasing accuracy. The tool to extract the electromagnetic FFs is provided by the one-photon (1*γ*) exchange approximation to elastic electron-nucleon scattering. Precision measurements of the proton electric to magnetic FF ratio at larger momentum transfers using po-larization experiments [\[1,](#page-4-0)2,3,4] have revealed significant discrepancies in recent years with unpolarized experiments using the Rosenbluth technique [\[5,](#page-4-4)6,7], when analyzing both within the 1*γ*-exchange framework. As both techniques were scrutinized and their findings confirmed by different experimental groups and using different set-ups, it became clear that some other explanation was needed to explain the difference. It was proposed that two-photon (2γ) exchange processes are the most likely explanation of this difference [\[8,](#page-4-7) [9,](#page-4-8) [10\]](#page-4-9). Their study has received a lot of attention lately, see [\[11\]](#page-4-10) for a recent review (and references therein), and [\[12\]](#page-4-11) for a global analysis of elastic *ep* scattering including a model for the 2*γ* corrections.

In recent years dedicated experiments were performed to test the Rosenbluth method [\[7\]](#page-4-6) and to measure the 2*γ*corrections to the polarization observables [\[13\]](#page-4-12). Using the theoretical framework to describe elastic *ep* scattering beyond the 1*γ*-approximation, as laid out in Ref. [\[8\]](#page-4-7), both experiments allow for the first time to provide an empirical determination of the 2*γ*-amplitudes at a common value of the momentum transfer, $Q^2 = 2.64 \text{ GeV}^2$. We extract the resulting 2*γ*-amplitudes in this work and provide predictions for forthcoming experiments.

To describe the process, $l(k) + N(p) \rightarrow l(k') + N(p')$, we adopt the definitions : $P = (p + p')/2$, $K = (k + k')/2$,

 $q = k - k'$, and choose $Q^2 = -q^2$ and $\nu = K \cdot P$ as the independent kinematical invariants. Neglecting the electron mass, the elastic *ep* scattering amplitude can be expressed through 3 independent structures [\[8\]](#page-4-7) :

with *e* the proton charge, *M* its mass, $h = \pm 1/2$ the electron helicity and λ_N (λ'_N) the incoming (outgoing) pro-ton helicities. In Eq. [\(1\)](#page-0-0), \tilde{G}_M , \tilde{F}_2 , \tilde{F}_3 are complex functions of *ν* and Q^2 . For convenience, we also use $\tilde{G}_E \equiv \tilde{G}_M (1 + \tau)\tilde{F}_2$, with $\tau \equiv Q^2/(2M)^2$. To separately identify the 1*γ*- and 2*γ*-exchange contributions, we use the decom- $\tilde{G}_{M} = G_{M} + \delta \tilde{G}_{M}$, and $\tilde{G}_{E} = G_{E} + \delta \tilde{G}_{E}$, where *G^M* and *G^E* are the usual proton magnetic and electric FFs, which are functions of Q^2 only and are defined from matrix elements of the electromagnetic current. The amplitudes \tilde{F}_3 , $\delta \tilde{G}_M$, and $\delta \tilde{G}_E$, originate from processes involving the exchange of at least two photons, and are of order *e* 2 . When calculating observables beyond the 1*γ*approximation, it is convenient to express the real parts ($\overline{\mathcal{R}}$) of the 2 γ -amplitudes relative to the magnetic FF as :

Y_M \equiv \mathcal{R} (\delta \tilde{G}_M / G_M), Y_E \equiv \mathcal{R} (\delta \tilde{G}_E / G_M),
$$

Y_3 \equiv (\nu / M^2) \mathcal{R} (\tilde{F}_3 / G_M).

The reduced $e^-p \rightarrow e^-p$ cross section including the 2*γ*-corrections becomes [\[8\]](#page-4-7)

$$
\frac{\sigma_R}{G_M^2} = 1 + \frac{\varepsilon}{\tau} \frac{G_E^2}{G_M^2} + 2Y_M + 2\varepsilon \frac{G_E}{\tau G_M} Y_E
$$

$$
+ 2\varepsilon \left(1 + \frac{G_E}{\tau G_M}\right) Y_3 + \mathcal{O}(e^4), \quad (3)
$$

where *ε* is the virtual photon polarization parameter. The corresponding expression for the elastic $e^+p\to e^+p$ cross section is obtained by changing the sign in front of the 2 $γ$ -amplitudes in Eq. [\(3\)](#page-1-0).

In the 1*γ*-exchange (Born) approximation, the double polarization observables are given by :

P_l^{Born} = \sqrt{1 - \varepsilon^2} (2h) \left(1 + \frac{\varepsilon}{\tau} \frac{G_E^2}{G_M^2} \right)^{-1}, \tag{4}
$$

$$
P_t^{Born} = -\sqrt{\frac{2\varepsilon(1-\varepsilon)}{\tau}}(2h)\left(1 + \frac{\varepsilon}{\tau}\frac{G_E^2}{G_M^2}\right)^{-1}\frac{G_E}{G_M}.
$$

Including 2*γ*-corrections, the polarization transfer ratio can be written as [\[8\]](#page-4-7):

$$
-\sqrt{\frac{\tau(1+\varepsilon)}{2\varepsilon}}\frac{P_t}{P_l} = \frac{G_E}{G_M} + Y_E - \frac{G_E}{G_M}Y_M
$$

$$
+ \left(1 - \frac{2\varepsilon}{1+\varepsilon}\frac{G_E}{G_M}\right)Y_3 + \mathcal{O}(e^4). \quad (6)
$$

For P_I separately, its expression relative to the 1 γ -result of Eq. (4) is given by :

$$
\frac{P_l}{P_l^{Born}} = 1 - 2\varepsilon \left(1 + \frac{\varepsilon}{\tau} \frac{G_E^2}{G_M^2} \right)^{-1} \times \left\{ \left[\frac{\varepsilon}{1 + \varepsilon} \left(1 - \frac{G_E^2}{\tau G_M^2} \right) + \frac{G_E}{\tau G_M} \right] Y_3 \right. \\ \left. + \frac{G_E}{\tau G_M} \left[Y_E - \frac{G_E}{G_M} Y_M \right] \right\} + \mathcal{O}(e^4). \tag{7}
$$

We can make an estimate of the 2*γ*-amplitudes from the recent data for the *ε*-dependence of P_t / P_l and P_l / P_l^{Born} at $Q^2 = 2.5 \text{ GeV}^2$, as measured by the JLab/Hall C exper-iment [\[13\]](#page-4-12), and combine them with the precision Rosenbluth measurements of σ_R performed at JLab/Hall A [\[7\]](#page-4-6), where data exist at a similar value $Q^2 = 2.64 \text{ GeV}^2$. The combination of both experiments allows for the first time to have three observables at a same Q^2 value to extract the *ε*-dependence of the three 2γ-amplitudes Y_M , Y_E , and *Y*₃, which are functions of both Q^2 and *ε*.

We start with the data for P_t / P_l as shown on Fig. [1.](#page-1-2) It is clearly seen how the data of the dedicated JLab/Hall C GEp-2*γ* experiment [\[13\]](#page-4-12) improve on the precision of the pioneering GEp-I result [\[1,](#page-4-0) [2\]](#page-4-1). Within their error bars of order 1 %, the JLab/Hall C experiment does not see any systematic 2γ-effect on this observable. We effectively tried (Fit 1), and $a_l = -0.032 \pm 0.008_{\rm stat.} \pm 0.020_{\rm syst.}$ (Fit 2).

a fit of $-\mu_p \sqrt{\tau(1+\varepsilon)/(2\varepsilon)} P_t / P_l$ assuming an ε -independent part *R*, which in the 1 γ -limit equals $\mu_p G_E/G_M$, with $\mu_p =$ 2.793 the proton magnetic moment, supplemented with an *ε*-dependent part :

$$
-\mu_p \sqrt{\frac{\tau(1+\varepsilon)}{2\varepsilon}} P_t/P_l = R + B\varepsilon^c (1-\varepsilon)^d. \tag{8}
$$

Using a range of values for *c* and *d*, we found that the value *B* of is zero within the present error, and the extracted values of *R* are all equal within their error bars. Therefore we conclude that the precision of the present data [\[13\]](#page-4-12) at $Q^2 = 2.5 \text{ GeV}^2$ does not allow to extract an *ε*-dependent part, in addition to the constant value *R*. To extract the *GE*/*G^M* ratio from the constant *R*, we are guided by the Regge limit assumption that the 2*γ*correction to P_t/P_l vanishes for $\varepsilon \to 1$. We therefore fit P_t / P_l by its 1 γ -value and obtain at $Q^2 = 2.5 \text{ GeV}^2$:

$$
R = \mu_p G_E / G_M = 0.693 \pm 0.006_{\text{stat.}} \pm 0.010_{\text{syst.}} \quad (9)
$$

To determine the *ε*-dependence of *P^l* , we conventionally divide by P_l^{Born} , which is calculated according to Eq. [\(4\)](#page-1-1), using the value of Eq. [\(9\)](#page-1-3) for *GE*/*GM*. Furthermore, the 2 $γ$ -contribution to P_l is expected to be zero in both limits $\varepsilon \to 0$ and $\varepsilon \to 1$. A perturbative QCD calculation (pQCD) [\[14,](#page-4-13)?] gives as limits : $P_l / P_l^{Born} - 1 \rightarrow (1 - \varepsilon)^{1/2}$ for $\varepsilon \to 1$, and $P_l/P_l^{Born} - 1 \to \varepsilon^2$ for $\varepsilon \to 0$. Although the data for P_l/P_l^{Born} do show a decrease for $\varepsilon \to 0$, in qualitative agreement with pQCD, the empirical fall-off at Q^2 = 2.5 GeV² is faster than the pQCD prediction. Therefore, we fit the data for P_l/P_l^{Born} using two different functional forms :

Fit 1 :
$$
P_l / P_l^{Born} = 1 + a_l \epsilon^4 (1 - \epsilon)^{1/2}
$$
,
Fit 2 : $P_l / P_l^{Born} = 1 + a_l \epsilon \ln(1 - \epsilon) (1 - \epsilon)^{1/2}$. (10)

The fit to the data yields : $a_l = 0.11 \pm 0.03$ _{stat.} ± 0.06 _{syst.}

We next fit the JLab/Hall A Rosenbluth measurements of σ_R [\[7\]](#page-4-6), shown on Fig. [3](#page-2-0) for $Q^2 = 2.64$ GeV². The σ_R data show a linear behavior in *ε*, suggesting the fit :

$$
\sigma_R / (\mu_p G_D)^2 = a + b \varepsilon, \tag{11}
$$

where we follow the convention to factor out the dipole FF $G_D \equiv 1/(1 + Q^2/0.71 \text{GeV}^2)^2$. The fit to the data in Fig. [3](#page-2-0) yields : $a = 1.106 \pm 0.006$ and $b = 0.160 \pm 0.009$.

To extract the three 2*γ*-amplitudes as well as *GE*/*G^M* and G_M from the above three observables at a same Q^2 value we have to make two assumptions. The first assumption was made in Eq. [\(8\)](#page-1-5), where the *ε*-independent term *R* fixes G_E/G_M , see Eq. [\(9\)](#page-1-3). To fix the value of G_M^2 , we make the assumption, that for $\varepsilon \to 1$ (Regge limit) the 2γ-correction to σ_R vanishes, i.e. $\sigma_R(\varepsilon = 1, Q^2) = G_M^2 +$ G_E^2 / τ . Using the *G_E*/*G_M* value extracted from the fit to *Pt*/*P^l* , and the fitted values of *a* and *b* entering Eq. [\(11\)](#page-2-1), then allows to extract the value of G_M^2 as :

$$
\left(\frac{G_M}{\mu_p G_D}\right)^2 = \frac{a+b}{1+(1/\tau)(G_E/G_M)^2}.
$$
 (12)

For $Q^2 = 2.64$ GeV², our fit yields :

$$
\left(\frac{G_M}{\mu_p G_D}\right)^2 = 1.168 \pm 0.010. \tag{13}
$$

Having specified in Eqs. [\(3,](#page-1-0) [6,](#page-1-6) [7\)](#page-1-7) the fits of the observables P_t / P_l , P_l / P_l^{Born} , and σ_R , we next proceed to extract the 2*γ*-amplitudes *YM*, *YE*, and *Y*3. The data allow us to perform this analysis at a common value of Q^2 = 2.64 GeV², where we neglect the small difference in P_t / P_l and P_l/P_l^{Born} between their values at $Q^2 = 2.64 \text{ GeV}^2$ and their measured values at $Q^2=2.5\,\rm{GeV^2}$. In Fig. [4,](#page-3-0) we

show the result of this analysis for the 2*γ* amplitudes, together with their 1*σ* error bands. One sees from Fig. [4](#page-3-0) that the amplitude which is best constrained by the available data is Y_M . This is because the amplitude Y_M is mainly driven by the 2*γ*-effect in the cross section data, Eq. [\(3\)](#page-1-0), which to good approximation is given by : $\sigma_R^{2\gamma} \sim Y_M +$ *ε Y*3. One notices that the error bands on *Y^M* resulting from the two different fits of Eq. [\(10\)](#page-1-4) for P_l largely overlap. Except in the large *ε* region, the dominance of *Y^M* by the Rosenbluth data results in its approximate linear rise in *ε*. For *ε* → 1, *Y^M* has to become non-linear provided *Y*^{*M*} + *ε Y*³ remains linear in the limit $\varepsilon \rightarrow 1$, which we assumed in our present analysis. How far the linearity of the Rosenbluth plot extends when approaching $\varepsilon \to 1$ is of course an open question, which will be addressed by the results of a dedicated experiment [\[16\]](#page-4-14). In contrast to Y_M , the amplitudes Y_E and Y_3 are mainly driven by the polarization data. One sees from Fig. [4](#page-3-0) that the error bands overlap in the range ($\varepsilon > 0.6$) where data exist for all three observables. In the smaller *ε* range, where there is no constraint from the polarization data, one sees clear deviations between the two different functional forms for the *ε*-dependence. We checked that the same conclusion is reached for other forms. One further notices that in the region constrained by the polarization data, the amplitudes Y_E and Y_3 are at the 2-3 % level and have opposite signs. This can be easily understood from Eq. [\(6\)](#page-1-6) when neglecting the small terms in the 2γ -amplitudes which are multiplied by G_E/G_M . The leading 2 γ -correction to P_t / P_l is to very good approximation proportional to Y_E + *Y*3. The absence of 2*γ*-corrections in the data for *Pt*/*P^l* then implies Y_E and Y_3 being of equal magnitude and of opposite sign. Furthermore, the value of Y_3 is nearly entirely driven by the data for P_l . One indeed obtains from Eq. [\(7\)](#page-1-7), when again neglecting the small *GE*/*G^M* terms,

 $P_l^{2\gamma} \simeq -2\varepsilon^2/(1+\varepsilon)Y_3$, therefore determining *Y*₃. To improve on the extraction of Y_E and Y_3 will require a further improvement in precision of the polarization experiments.

We next discuss the ratio $R_{e^+e^-}$ of e^+p/e^-p elastic scattering cross sections. The $e^{\frac{t}{T}}p$ elastic scattering observables are obtained from the ones for e^-p by merely changing the sign in front of the 2*γ*-amplitudes. A measurement of the ratio $R_{e^+e^-}$ therefore provides a test of the 2*γ*-amplitudes and is planned in the near future by several experiments [\[17,](#page-4-15)18,19]. In particular, the Olympus Collaboration at DESY plans to measure the $e^+/e^$ ratio for a value $Q^2 \simeq 2.5 \text{ GeV}^2$ [\[19\]](#page-4-17). Our extraction of the 2 γ -amplitudes at $Q^2 = 2.64$ GeV² allows to predict the ratio $\overline{R}_{e^+e^-}$, which is shown in Fig. [5,](#page-3-1) using Fit 1 in Eq. [\(10\)](#page-1-4). We notice that for $Q^2 = 2.64 \text{ GeV}^2$, $R_{e^+e^-}$ rises linearly to small *ε*, reaching $R_{e^+e^-} = 1.053 \pm 0.004$ for $\varepsilon = 0.5$. In Fig. [5,](#page-3-1) we also show results for the two other values of *Q*² where the JLab high-precision Rosenbluth experiment [\[7\]](#page-4-6) has taken data. At these higher values of *Q*2 , a systematic measurement of the *ε*-dependence of the polarization observables has not yet been performed. For our analysis of the $Q^2 = 3.2$ GeV² and $Q^2 = 4.1$ GeV²

data, we therefore assumed that P_t / P_l can be fitted by its 1*γ*-value proportional to *GE*/*G^M* as extracted in [\[1,](#page-4-0) [2,](#page-4-1) [3\]](#page-4-2). We see from Fig. [5](#page-3-1) that, for a fixed value of *ε*, the extracted ratio $R_{e^+e^-}$ increases with Q^2 .

Summarizing, in this work we provided a first combined analysis of high precision Rosenbluth data for elastic electron-proton scattering and recent measurements of the 2*γ*-corrections to the polarization observables. As both experiments were performed at a similar Q^2 value, we were able to perform an extraction of the three 2*γ*amplitudes at $Q^2 = 2.64 \text{ GeV}^2$ using empirical results for three observables *and* assuming that for $\varepsilon \to 1$ (Regge limit) the 2*γ*-amplitudes vanish. We found that one amplitude (Y_M) can be reliably extracted from the correction on the unpolarized cross section. The other two amplitudes are at the 2-3 % level and of opposite sign, partially cancelling each other in the polarization transfer ratio. Our extraction allowed us to provide a prediction of the e^+p/e^-p elastic cross section ratio, for which dedicated measurements by the Olympus@DESY experiment are underway. Over the measured range of this experiment, the 2γ-corrections to the *e*⁺ *p*/*e*[−] *p* elastic cross section ratio are predicted to vary in the 1 - 6 % range.
