# Coordinate Beamforming with Relaxed Zero Forcing: The Sequential

# Orthogonal Projection Combining Method and Rate Control

### Abstract

In this paper, coordinated beamforming based on relaxed zero forcing (RZF) for *K* transmitter-receiver pair multiple-input single-output (MISO) and multiple-input multiple-output (MIMO) interference channels is considered. In the RZF coordinated beamforming, conventional zero-forcing interference leakage constraints are relaxed so that some predetermined interference leakage to undesired receivers is allowed in order to increase the beam design space for larger rates than those of the zero-forcing scheme. In the MISO case, it is shown that the optimal beam vector under the RZF framework for a given set of interference leakage levels can be obtained by sequential orthogonal projection combining (SOPC). Based on this, closed-form solutions are provided in two-user and three-user cases and an efficient beam design algorithm for RZF coordinated beamforming is provided in the case of more than three users. Furthermore, the rate control problem under the RZF framework is considered. A centralized approach and a distributed heuristic approach are proposed to control the position of the designed rate-tuple along the Pareto boundary of the achievable rate region. Finally, the RZF framework is extended to MIMO interference channels by deriving a new lower bound on the rate of each user.

# I. INTRODUCTION

The necessity for high data rate and spectral efficiency is rapidly increasing for current and future cellular networks. To support the required high data rate, cellular networks are being densely deployed and the cell size is decreasing. In this trend, cellular networks now become interference-limited, and handling interference in the network is one of the most critical problems in current and future cellular networks. This is especially the case for current cellular networks adopting orthogonal frequency-division multiplexing (OFDM) with a frequency reuse factor of one. Among the many ways of handling interference, MIMO antenna techniques and basestation cooperation are considered as the key technologies to the interference problem in current and future cellular networks. Indeed, the Third Generation Partnership Project (3GPP) Long-Term Evolution-Advanced (LTE-Advanced) considers the basestation cooperation and MIMO techniques to mitigate inter-cell interference under the name of Coordinated Multipoint (CoMP) [2] [3]. Among several candidate techniques for the basestation cooperation for the

downlink [4], in this paper, we consider coordinated beamforming (CB), which is a compromise between full cooperation and no cooperation for trading off complexity and performance [3]. In the CB scheme, neither data nor full channel state information (CSI) is shared among cooperating basestations, and the cooperating basestations require local CSI only to design their beamforming vectors with the consideration of interference to undesired receivers served by other basestations. This local CSI sharing aspect of the scheme is especially desirable when inter-basestation communication is limited.

The considered multi-cell situation is depicted in Fig. 1, in which each basestation transmits data to a desired receiver (i.e., mobile station) with interference leaking into the unwanted receivers served by other basestations. Mathematically, when each mobile station has a single receive antenna, the system is modelled as a MISO interference channel (IC), and extensive research has been conducted on beam design for this MISO IC, especially under the assumption of practical linear beamforming. First, Jorswieck et al. investigated the structure of optimal beam vectors achieving Pareto boundary points of the achievable rate region<sup>1</sup> of the MISO IC with linear beamforming [5-8], and showed that any Paretooptimal beam vector at each transmitter is a convex combination of the zero-forcing (ZF) beam vector and maximal ratio transmission (MRT) (i.e., matched-filtering (MF)) beam vector in the case of two users and a linear combination of the channel vectors from the transmitter to all receivers in the general case of an arbitrary number of users. Although their work provides significant insights into the optimal beam structure and a parameterization of any Pareto-optimal beam vector, it is not easy to use their result to design an optimal beam vector in general cases since the search space is large even in the simple three transmitter-receiver pair case. (In this case, the search space is a 9-dimensional complex space.) Thus, the beam design problem still remains in the general case with more than two users. The simplest beam design method for basestation coordination is ZF, which perfectly eliminates interference leakage to undesired receivers. However, it is well known that the ZF method is not optimal. There have been several ideas to fix the problem of the ZF beam design method for enhancing the rate performance. In the case of multi-user MISO/MIMO broadcast channels, the regularized channel inversion (RCI) [9] and the signal-to-leakage-plus-noise (SLNR) method [10] were proposed for this purpose. In particular, the SLNR method maximizes the ratio of signal power (to the desired receiver) to leakage (to undesired receivers) plus noise power, and its solution is given by solving a generalized eigenvalue problem. The SLNR method can easily be adapted to the multi-cell MISO/MIMO case. Recently, Zakhour and Gesbert rediscovered this method in the context of multi-cell MISO CB under the name of the virtual signal-tointerference-plus-noise (SINR) method, and have further (and more importantly) shown that this method can achieve any point on the Pareto boundary theoretically, but practically can achieve one uncontrolled point on the Pareto boundary of the achievable rate region in the case of two<sup>2</sup> users [11]. On the other

hand, another way of fixing the ZF method was proposed by Zhang and Cui [12] and Lee *et al.* [1] by relaxing ZF leakage constraints and by formulating the beam design problem as a constrained optimization problem. The method was named the *relaxed zero-forcing method* in [1]. In this formulation, each transmitter maximizes its own rate under interference leakage constraints to undesired receivers. This idea is based on a simple observation that the ZF beam design method overreacts to inter-cell interference. Most receivers (i.e., mobile stations) that are affected by inter-cell interference are cell-edge users, and thus, thermal noise remains even if the inter-cell interference is completely removed. Thus, it is unnecessary to completely eliminate the inter-cell interference and it is sufficient to limit the inter-cell interference below a certain level lower than that of the thermal noise. By relaxing ZF interference constraints, we have a larger feasible set yielding a larger rate than that of the ZF scheme. Furthermore, Zhang and Cui have shown that the RZF method can theoretically achieve any point on the Pareto boundary of the achievable rate region of the MISO IC with linear beamforming for any number of transmitter-receiver pairs [12]. In this paper, we explore and develop this RZF idea fully in three aspects (algorithm development, rate control, and MIMO extension), which is the contribution of this paper, to provide a useful design paradigm for CB for current and future cellular networks.

#### A. Contributions

• In the MISO IC case, a new structural representation of any beam vector on the Pareto boundary of the achievable rate region is derived. This new derivation reveals the structure of Pareto-optimal beam vectors in the general case with any number of users.

• In the MISO IC case, based on the new structural representation, an efficient method, the *sequential* orthogonal projection combining (SOPC) method, for the RZF beam design is proposed. In the case of K = 3, an approximate closed-form solution is provided. (The case of K = 3 is particularly important for the hexagonal cell structure when three cells are coordinating their beam vectors.)

• A centralized algorithm and a fully distributed heuristic algorithm are provided to control the location of the designed rate-tuple along the Pareto boundary of the achievable rate region. In the RZF beam design, the allowed interference leakage levels to undesired receivers at each transmitter are design parameters, and the rate-tuple is controlled by controlling these interference leakage levels. First, a centralized algorithm is proposed based on alternating optimization, and, by the proposed algorithm, we can almost always achieve any desired Pareto boundary point in the achievable rate region. Also, a fully distributed heuristic method is provided based on the knowledge of thermal noise level, and this heuristic method MISO IC case, too. See Appendix.

can roughly control the location of the designed rate-tuple near the Pareto boundary. The controllability of rate is a desirable feature in network operation since the required data rate of each transmitter-receiver pair may be different from those of others in practice, as in an example that one user is a voice user and the others are high rate data users.

• Finally, the RZF CB (RZFCB) is extended to the MIMO IC case. In the MIMO case, the RZFCB requires joint design among basestations. To circumvent this difficulty, a lower bound on each user's rate has been derived to decompose the beam design problem into separate problems at different transmitters, and the projected gradient method [13] is adopted to solve the MIMO RZFCB problem.

## B. Notations and Organization

In this paper, we will make use of standard notational conventions. Vectors and matrices are written in boldface with matrices in capitals. All vectors are column vectors. For a matrix  $\mathbf{A}$ ,  $\mathbf{A}^H$ ,  $\|\mathbf{A}\|$ ,  $\|\mathbf{A}\|_F$ , tr( $\mathbf{A}$ ), and  $|\mathbf{A}|$  indicate the Hermitian transpose, 2-norm, Frobenius norm, trace, and determinant of  $\mathbf{A}$ , respectively, and  $C(\mathbf{A})$  and vec( $\mathbf{A}$ ) denote the column space of  $\mathbf{A}$  and the vector composed of the columns of  $\mathbf{A}$ , respectively.  $\mathbf{I}_n$  stands for the identity matrix of size n (the subscript is omitted when unnecessary).  $\Pi_{\mathbf{A}} = \mathbf{A}(\mathbf{A}^H \mathbf{A})^{-1}\mathbf{A}^H$  represents the orthogonal projection onto  $C(\mathbf{A})$  and  $\Pi_{\mathbf{A}}^{\perp} = \mathbf{I} - \Pi_{\mathbf{A}}$ . For matrices  $\mathbf{A}$  and  $\mathbf{B}$ ,  $\mathbf{A} \otimes \mathbf{B}$  represents the Kronecker product between  $\mathbf{A}$  and  $\mathbf{B}$ , and  $\mathbf{A} \geq \mathbf{B}$  means that  $\mathbf{A} - \mathbf{B}$ is positive semi-definite.  $[\mathbf{a}_1, \cdots, \mathbf{a}_L]$  or  $[\mathbf{a}_i]_{i=1}^L$  denotes the matrix composed of vectors  $\mathbf{a}_1, \cdots, \mathbf{a}_L$ .  $\mathbf{x} \sim \mathcal{N}(\boldsymbol{\mu}, \boldsymbol{\Sigma})$  means that  $\mathbf{x}$  is complex Gaussian-distributed with mean vector  $\boldsymbol{\mu}$  and covariance matrix  $\boldsymbol{\Sigma}$ .  $\mathbb{R}$ ,  $\mathbb{R}_+$ , and  $\mathbb{C}$  denote the sets of real numbers, non-negative real numbers, and complex numbers, respectively.

The remainder of this paper is organized as follows. The system model and preliminary are provided in Section II. In Section III, the RZFCB in MISO ICs is formulated, and its solution structure and a fast algorithm for RZFCB are provided. In Section IV, the rate-tuple control problem under the RZFCB framework is considered and two approaches are proposed to control the designed rate-tuple. The RZFCB problem in MIMO ICs is considered in Section V, followed by conclusions in Section VI.

### II. SYSTEM MODEL AND PRELIMINARY

In this paper, we consider a multi-user interference channel with K transmitter-receiver pairs, as shown in Fig. 1. In the first part of the paper, we restrict ourselves to the case that the transmitters are equipped with N antennas and each receiver is equipped with one receive antenna only. In this case, the received signal at receiver i is given by

$$y_i = \mathbf{h}_{ii}^H \mathbf{v}_i s_i + \sum_{j=1, j \neq i}^K \mathbf{h}_{ij}^H \mathbf{v}_j s_j + n_i,$$

where  $\mathbf{h}_{ij}$  denotes the  $N \times 1$  (conjugated) channel vector from transmitter j to receiver i, and  $\mathbf{v}_j$  and  $s_j$  are the  $N \times 1$  beamforming vector and the scalar transmit symbol at transmitter j, respectively. We assume that the transmit symbols are from a Gaussian code book with unit variance and that the additive noise  $n_i$ is from distribution  $\mathcal{N}(0, \sigma_i^2)$ . We also assume that each basestation has a transmit power constraint:

$$\|\mathbf{v}_i\|^2 \le P_i, \qquad i = 1, \cdots, K.$$

The first term on the right-hand side (RHS) of (1) is the desired signal, and the second term represents the sum of interference from K - 1 undesired transmitters. Under linear beamforming, for a given set of beamforming vectors  $\{\mathbf{v}_1, \dots, \mathbf{v}_K\}$  and a channel realization  $\{\mathbf{h}_{ij}\}$ , the rate of receiver *i* is given by

$$R_i(\mathbf{v}_1, \cdots, \mathbf{v}_K) = \log\left(1 + \frac{|\mathbf{h}_{ii}^H \mathbf{v}_i|^2}{\sigma_i^2 + \sum_{j \neq i} |\mathbf{h}_{ij}^H \mathbf{v}_j|^2}\right).$$

Then, for the given channel realization, the achievable rate region of the MISO IC with transmit beamforming under linear processing (i.e., treating interference as noise) is defined as the union of the ratetuples that can be achieved by all possible combinations of beamforming vectors under the power constraints in (2):

$$\mathcal{R} := \bigcup_{\substack{\mathbf{v}_i: \mathbf{v}_i \in \mathbb{C}^N, \\ \|\mathbf{v}_i\|^2 \le P_i, \ 1 \le i \le K}} (R_1(\mathbf{v}_1, \cdots, \mathbf{v}_K), \ \cdots, \ R_K(\mathbf{v}_1, \cdots, \mathbf{v}_K)).$$

The outer boundary of the rate region  $\mathcal{R}$  in the first quadrant is called the *Pareto boundary* of  $\mathcal{R}$  because it consists of rate-tuples for which the rate of any one user cannot be increased without decreasing the rate of at least one other user. The precise definition of a Pareto-optimal point of the achievable rate region  $\mathcal{R}$ is given as follows.

Definition 1: [6] A rate-tuple  $(R_1, \dots, R_K)$  is Pareto-optimal if there exists no other rate-tuple  $(R'_1, \dots, R'_K)$  such that (s.t.)  $(R'_1, \dots, R'_K) \ge (R_1, \dots, R_K)$  and  $(R'_1, \dots, R'_K) \ne (R_1, \dots, R_K)$  (the inequality is component-wise).

At each transmitter, the interference to undesired receivers can be eliminated completely by ZF CB (ZFCB) if the number of transmit antennas satisfies  $N \ge K$ . Due to its simplicity and fully distributed nature, ZFCB has widely been considered as a candidate technique for CB and there has been extensive

research on ZFCB, e.g., [14–18]. The best ZF beamforming vector at transmitter i can be obtained by solving the following optimization problem:

$$\mathbf{v}_{i}^{*} = \underset{\mathbf{v}_{i} \in \mathbb{C}^{N}}{\operatorname{arg\,max}} \log \left( 1 + \frac{|\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2}}{\sigma_{i}^{2}} \right)$$
subject to  $\mathbf{h}_{ji}^{H}\mathbf{v}_{i} = 0, \forall j \neq i \text{ and } \|\mathbf{v}_{i}\|^{2} \leq P_{i}.$

Here,  $\mathbf{h}_{ji}^{H}\mathbf{v}_{i} = 0$  is the ZF leakage constraint at transmitter *i* for receiver *j*. If  $N \ge K$ , the problem (5) is feasible and its solution is given by  $\mathbf{v}_{i}^{ZF} = c\mathbf{\Pi}_{[\mathbf{h}_{1i},\cdots,\mathbf{h}_{i-1,i},\mathbf{h}_{i+1,i},\cdots,\mathbf{h}_{Ki}]}^{\perp}\mathbf{h}_{ii}$  for some scalar *c* satisfying the transmit power constraint.

#### **III. RZF COORDINATED BEAMFORMING IN MISO INTERFERENCE CHANNELS**

### A. Formulation

Although the ZFCB provides an effective way to handling inter-cell interference, the ZFCB is not optimal from the perspective of data rate. As mentioned already, even with such complete interference nulling, there exists thermal noise at each receiver, and thus, a certain level of interference leakage comparable to the power of thermal noise can be allowed for better performance. In the MISO IC case, the RZF leakage constraint at transmitter i for receiver j is formulated as follows:

$$|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 \le \alpha_{ji} \sigma_j^2, \quad \forall i, j \ne i,$$
(6)

where  $\alpha_{ji} \ge 0$  is a constant<sup>3</sup> that controls the allowed level of interference leakage from transmitter i to receiver j relative to the thermal noise level  $\sigma_j^2$  at receiver j. When  $\alpha_{ji} = 0$  for all  $j \ne i$ , the RZF constraints reduce to the conventional ZF constraints. When  $\alpha_{ji} > 0$ , on the other hand, the ZF constraints are relaxed to yield a larger feasible set for  $\mathbf{v}_i$  than that associated with the ZF constraints. Under the RZF constraints, the cooperative beam design problem to maximize the sum rate is formulated as follows:

Problem 1 (RZF cooperative beamforming)

$$\underset{\{\mathbf{v}_{i},i=1,\cdots,K\}}{\text{maximize}} \quad \sum_{i=1}^{K} \log \left( 1 + \frac{|\mathbf{h}_{ii}^{H} \mathbf{v}_{i}|^{2}}{\sigma_{i}^{2} + \sum_{j \neq i} |\mathbf{h}_{ij}^{H} \mathbf{v}_{j}|^{2}} \right)$$

subject to (C.1) 
$$|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 \le \alpha_{ji} \sigma_j^2, \quad \forall i, j \ne i,$$
 (8)

$$(C.2) \quad \|\mathbf{v}_i\|^2 \le P_i, \quad \forall i, \tag{9}$$

where the RZF constraints and the transmit power constraint are shown in (8) and (9), respectively.

Note the difference in the rate formula (7) from that in (5). Due to the RZF constraints at other transmitters, the residual interference from other transmitters is now included in the denominator in the logarithm in (7) for the rate of user i. Also, note that the beam design in Problem 1 is intertwined across the transmitters. Due to this dependent structure, Problem 1 is non-convex, and finding a set of optimal beamforming vectors for Problem 1 requires central processing. However, exploiting the RZF constraints imposed in the whole network, we can convert Problem 1 into a simple distributed problem by considering a lower bound on the rate. Under the RZFCB framework, the power of interference from other transmitters at receiver i is upper bounded as

$$\sum_{j=1, j\neq i}^{K} |\mathbf{h}_{ij}^{H} \mathbf{v}_{j}|^{2} \leq \sum_{j\neq i} \alpha_{ij} \sigma_{i}^{2} =: \epsilon_{i} \sigma_{i}^{2}.$$

Hence, a lower bound on the rate of user i under RZF is given by

$$\log\left(1 + \frac{|\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2}}{\sum_{j\neq i}|\mathbf{h}_{ij}^{H}\mathbf{v}_{j}|^{2} + \sigma_{i}^{2}}\right) \geq \log\left(1 + \frac{|\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2}}{(1 + \epsilon_{i})\sigma_{i}^{2}}\right).$$
(11)

The lower bound on the rate at each receiver does not depend on the beamforming vectors of undesired transmitters. Thus, we propose a distributed CB problem based on RZF:

Problem 2: For each transmitter  $i \in \{1, \dots, K\}$ ,

$$\underset{\mathbf{v}_{i}}{\text{maximize}} \quad \log\left(1 + \frac{|\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2}}{(1 + \epsilon_{i})\sigma_{i}^{2}}\right)$$
(12)

subject to 
$$|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 \le \alpha_{ji} \sigma_j^2, \quad \forall j \ne i,$$
 (13)

$$\|\mathbf{v}_i\|^2 \le P_i. \tag{14}$$

Then, due to the monotonicity of the logarithm, Problem 2 is equivalent to the following problem:

Problem 3 (The MISO RZFCB problem) For each transmitter  $i \in \{1, \dots, K\}$ ,

$$\underset{\mathbf{v}_{i}}{\text{maximize}} \quad |\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2} \tag{15}$$

subject to  $|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 \le \alpha_{ji} \sigma_j^2, \quad \forall j \neq i,$  (16)

$$\|\mathbf{v}_i\|^2 \le P_i. \tag{17}$$

From now on, we will consider Problem 3 (the RZFCB problem) and refer to the solution to Problem 3 as the RZF beamforming vector.

#### B. The Optimality and Solution Structure of RZFCB in MISO Interference Channels

In this subsection, we will investigate the optimality and structure of the solution to Problem 3. We start with the optimality of the RZFCB scheme. Without inter-cell interference, it is optimal for the transmitter to use the MRT (i.e., MF) beam vector with full transmit power. However, such a selfish strategy leads to poor performance due to large mutual interference in multi-cell communications [5]. Thus, to enhance the overall rate performance in the network, the beamforming vector should be designed to be as close as possible to the MRT beam vector without giving too much interference to undesired receivers, and this strategy is the RZFCB in Problem 3 (or Problem 2 equivalently). The optimality of the RZFCB is given in the following theorem of Zhang and Cui [12].

*Theorem 1:* [12] Any rate-tuple  $(R_1, \dots, R_K)$  on the Pareto boundary of the achievable rate region defined in (4) can be achieved by the RZFCB if the levels  $\{\alpha_{ij}\sigma_i^2, \forall i, j \neq i\}$  of interference leakage are properly chosen.

*Proof:* See Proposition 3.2 in [12].

Surprisingly, the rate lower-bound based distributed beam design in Problem 3 can achieve any Paretooptimal point of the achievable rate region. Due to Theorem 1, in the MISO IC case, the remaining problems for the RZFCB are 1) to *construct an efficient algorithm to solve Problem 3 for given*  $\{\alpha_{ij}\sigma_i^2, \forall i, j \neq i\}$  and 2) to *devise a method to design*  $\{\alpha_{ij}\sigma_i^2, \forall i, j \neq i\}$  for controlling the location of the rate-tuple along the Pareto boundary of the achievable rate region. We will consider Problem 3 for given  $\{\alpha_{ij}\sigma_i^2, \forall i, j \neq i\}$  here and will consider the rate control problem later. First, we will derive an efficient algorithm for obtaining a good approximate solution to Problem 3 for given  $\{\alpha_{ij}\sigma_i^2, \forall i, j \neq i\}$ . To do this, we need to investigate the solution structure of the RZFCB problem. Instead of solving Problem 2 as in [12] (this becomes complicated due to the logarithm), we here solve Problem 3, which is equivalent to Problem 2.

*Lemma 1:* For transmitter *i*, suppose that the channel vectors  $\{\mathbf{h}_{ji} : j = 1, \dots, K\}$  connecting transmitter *i* and all the receivers are linearly independent.<sup>4</sup> Let  $\mathbf{v}_i^{opt}$  be the unique solution of the (convex) RZFCB problem (i.e., Problem 3) for transmitter *i*. Then, we have

$$\mathbf{v}_{i}^{opt} = c_{ii}\mathbf{h}_{ii} + \sum_{j\in\Gamma_{i}} c_{ji}\mathbf{h}_{ji}$$
(18)

for some  $\{c_{ji} \in \mathbb{C} : j \in \Gamma_i \cup \{i\}\}$ , where  $\Gamma_i := \{j : |\mathbf{h}_{ji}^H \mathbf{v}_i^{opt}|^2 = \alpha_{ji} \sigma_j^2\}$ , and  $\mathbf{v}_i^{opt}$  uses full transmission power, i.e.,  $\|\mathbf{v}_i^{opt}\|^2 = P_i$ .

<sup>&</sup>lt;sup>4</sup>If  $N \ge K$ , the linear independence of the channel vectors is satisfied almost surely, when channel vectors are realized from a continuous distribution.

*Proof:* Since the RZFCB problem in Problem 3 is a convex one, we can find the exact solution by the Lagrange dual method [19]. The Lagrangian of the RZFCB problem for transmitter *i* is given by

$$\mathcal{L}(\mathbf{v}_i, \boldsymbol{\lambda}, \boldsymbol{\mu}) = -|\mathbf{h}_{ii}^H \mathbf{v}_i|^2 + \sum_{j=1, j \neq i}^{K} \lambda_j (|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 - \alpha_{ji} \sigma_j^2) + \boldsymbol{\mu} (\|\mathbf{v}_i\|^2 - P_i),$$
(19)

where  $\lambda := \{\lambda_j \ge 0 : j = 1, \dots, i - 1, i + 1, \dots, K\}$  and  $\mu \ge 0$  are real dual variables. By the Karush-Kuhn-Tucker (KKT) conditions, the gradient of the Lagrangian should be zero at optimal  $\mathbf{v}_i^{opt}$  with optimal dual variables  $\lambda'$  and  $\mu'$ , i.e.,

$$\nabla_{\mathbf{v}_{i}^{*}} \mathcal{L}(\mathbf{v}_{i}, \boldsymbol{\lambda}', \boldsymbol{\mu}') \big|_{\mathbf{v}_{i} = \mathbf{v}_{i}^{opt}} = -\mathbf{h}_{ii} \mathbf{h}_{ii}^{H} \mathbf{v}_{i}^{opt} + \sum_{j=1, j \neq i}^{K} \lambda'_{j} \mathbf{h}_{ji} \mathbf{h}_{ji}^{H} \mathbf{v}_{i}^{opt} + \boldsymbol{\mu}' \mathbf{v}_{i}^{opt},$$
$$= -\mathbf{h}_{ii} \mathbf{h}_{ii}^{H} \mathbf{v}_{i}^{opt} + \sum_{j \in \Gamma_{i}}^{K} \lambda'_{j} \mathbf{h}_{ji} \mathbf{h}_{ji}^{H} \mathbf{v}_{i}^{opt} + \boldsymbol{\mu}' \mathbf{v}_{i}^{opt} = 0,$$
(20)

where  $\Gamma_i := \{j : \lambda'_j > 0\}$ . (From the complementary slackness condition,  $\lambda'_j > 0$  only when  $|\mathbf{h}_{ji}^H \mathbf{v}_i|^2 = \alpha_{ji}\sigma_i^2$ .) Thus, the gradient of the Lagrangian becomes zero if and only if

$$\mu' \mathbf{v}_i^{opt} = \left( \mathbf{h}_{ii} \mathbf{h}_{ii}^H - \sum_{j \in \Gamma_i} \lambda'_j \mathbf{h}_{ji} \mathbf{h}_{ji}^H \right) \mathbf{v}_i^{opt}.$$
 (21)

The RZF beamforming vector  $\mathbf{v}_i^{opt}$  at transmitter *i* can have two different forms according to the optimal dual variable  $\mu'$ .

*i)*  $\mu' = 0$ : This case corresponds to the case in which full power is not used at the transmitter. In this case, (21) becomes  $\left(\mathbf{h}_{ii}\mathbf{h}_{ii}^{H} - \sum_{j\in\Gamma_{i}}\lambda'_{j}\mathbf{h}_{ji}\mathbf{h}_{ji}^{H}\right)\mathbf{v}_{i}^{opt} = 0$ . By the linear independence of  $\{\mathbf{h}_{ji} : j \in \Gamma'_{i} := \Gamma_{i} \cup \{i\}\}$  and the fact  $\{\lambda'_{j} \neq 0, j \in \Gamma_{i}\}$ , we have  $\mathbf{h}_{ji}^{H}\mathbf{v}_{i}^{opt} = 0, \forall j \in \Gamma'_{i}$ . It means that  $\mathbf{v}_{i}^{opt}$  lies within the orthogonal complement of the subspace spanned by  $\{\mathbf{h}_{ji} : j \in \Gamma'_{i}\}$ . Such  $\mathbf{v}_{i}^{opt}$  yields a trivial rate for receiver *i* since  $\mathbf{h}_{ii}^{H}\mathbf{v}_{i}^{opt} = 0$ .

*ii*)  $\mu' > 0$ : This case corresponds to the case in which the transmitter uses full power, i.e.,  $\|\mathbf{v}_i^{opt}\|^2 = P_i$ . In this case, (21) can be rewritten as

$$\mathbf{v}_{i}^{opt} = \frac{1}{\mu'} \left( \mathbf{h}_{ii} \mathbf{h}_{ii}^{H} - \sum_{j \in \Gamma_{i}} \lambda'_{j} \mathbf{h}_{ji} \mathbf{h}_{ji}^{H} \right) \mathbf{v}_{i}^{opt}.$$
(22)

From (22), it is straightforward to see that  $\mathbf{v}_i^{opt}$  is a linear combination of  $\{\mathbf{h}_{ji}, j \in \Gamma'_i\}$ . (Whatever  $\mathbf{v}_i^{opt}$  is, the RHS of (22) is a linear combination of  $\{\mathbf{h}_{ji}, j \in \Gamma'_i\}$ , but the left-hand side (LHS) is  $\mathbf{v}_i^{opt}$  itself.) In this case,  $\mathbf{v}_i^{opt}$  will yield a non-zero rate for receiver *i*.

Since the latter solution has a higher rate than the former, the latter is the optimal solution of the RZFCB problem. Thus, the RZF beamforming vector is a linear combination of  $\{\mathbf{h}_{ji}, j \in \Gamma'_i\}$  and uses full transmission power.

Therefore, the solution to RZFCB for a given set of interference relaxation levels is a linear combination of the desired channel and a subset of interference channels for which the RZF constraint (16) is satisfied with equality. When the transmitter fully exploits the RZF constraints, the RZFCB solution structure coincides with the Pareto-optimal solution structure derived by Jorswieck *et al.* [6]. Now, based on Lemma 1, we present a new useful representation of  $\mathbf{v}_i^{opt}$  that provides a clear insight into the RZFCB solution and a basis for fast algorithm construction.

*Theorem 2:* For transmitter *i* with a linearly independent channel realization  $\{\mathbf{h}_{ji} : j = 1, \dots, K\}$ , the RZFCB solution can also be expressed as

$$\mathbf{v}_{i}^{opt} = c_{0} \frac{\mathbf{h}_{ii}}{\|\mathbf{h}_{ii}\|} + c_{1} \frac{\mathbf{\Pi}_{\mathbf{A}_{1}}^{\perp} \mathbf{h}_{ii}}{\|\mathbf{\Pi}_{\mathbf{A}_{1}}^{\perp} \mathbf{h}_{ii}\|} + \dots + c_{|\widetilde{\Gamma}_{i}|} \frac{\mathbf{\Pi}_{\mathbf{A}_{|\widetilde{\Gamma}_{i}|}}^{\perp} \mathbf{h}_{ii}}{\|\mathbf{\Pi}_{\mathbf{A}_{|\widetilde{\Gamma}_{i}|}}^{\perp} \mathbf{h}_{ii}\|},$$
(23)

where  $A_j$  is constructed recursively as

$$\mathbf{A}_{j} := [\mathbf{A}_{j-1}, \ \mathbf{h}_{\widetilde{\Gamma}_{i}(j), i}], \quad j = 1, \cdots, |\widetilde{\Gamma}_{i}|,$$
(24)

with  $\mathbf{A}_0 = \emptyset$ , and  $c_j \in \mathbb{C}$ ,  $j = 0, 1, \dots, |\widetilde{\Gamma}_i|$ . Here,  $\widetilde{\Gamma}_i$  is a set made by permuting the elements of  $\Gamma_i$  according to an arbitrary order, and  $\widetilde{\Gamma}_i(j)$  denotes the *j*-th element of  $\widetilde{\Gamma}_i$ .

*Proof:* From Lemma 1, we know that  $\mathbf{v}_i^{opt} \in \mathcal{C}([\mathbf{h}_{ji}]_{j\in\Gamma'_i})$ . Proof of the theorem is given by showing the equivalence of the two subspaces  $\mathcal{C}([\mathbf{h}_{ji}]_{j\in\Gamma'_i})$  and  $\mathcal{C}([\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp}\mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\Gamma_i|}}^{\perp}\mathbf{h}_{ii}])$ . First, note that  $\{\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp}\mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\Gamma_i|}}^{\perp}\mathbf{h}_{ii}\}$  are linearly independent. This is easily shown by replacing  $\mathbf{\Pi}_{\mathbf{A}_j}^{\perp}$  with  $\mathbf{I} - \mathbf{\Pi}_{\mathbf{A}_j}$  and by using the linear independence of  $\{\mathbf{h}_{ji}\}_{j\in\Gamma'_i}$ . Thus, the dimension of  $\mathcal{C}([\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp}\mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\Gamma_i|}}^{\perp}\mathbf{h}_{ii}])$  is  $(|\Gamma_i| + 1)$ , which is the same as that of  $\mathcal{C}([\mathbf{h}_{ji}]_{j\in\Gamma'_i})$ . Now, consider the projection of any vector in  $\mathcal{C}([\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp}\mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\Gamma_i|}}^{\perp}\mathbf{h}_{ii}])$  onto the orthogonal complement of  $\mathcal{C}([\mathbf{h}_{ji}]_{j\in\Gamma'_i})$ :

$$\begin{aligned} \mathbf{\Pi}_{[\mathbf{h}_{ji}]_{j\in\Gamma_{i}^{\prime}}}^{\perp} \left( c_{0}\mathbf{h}_{ii} + c_{1}\mathbf{\Pi}_{\mathbf{A}_{1}}^{\perp}\mathbf{h}_{ii} + \dots + c_{|\widetilde{\Gamma}_{i}|}\mathbf{\Pi}_{\mathbf{A}_{|\widetilde{\Gamma}_{i}|}}^{\perp}\mathbf{h}_{ii} \right) \\ &= \mathbf{\Pi}_{[\mathbf{h}_{ji}]_{j\in\Gamma_{i}^{\prime}}}^{\perp} \left( c_{0}\mathbf{h}_{ii} + c_{1}(\mathbf{I} - \mathbf{\Pi}_{\mathbf{A}_{1}})\mathbf{h}_{ii} + \dots + c_{|\widetilde{\Gamma}_{i}|}(\mathbf{I} - \mathbf{\Pi}_{\mathbf{A}_{|\widetilde{\Gamma}_{i}|}})\mathbf{h}_{ii} \right) \\ &= \mathbf{\Pi}_{[\mathbf{h}_{ji}]_{j\in\Gamma_{i}^{\prime}}}^{\perp} \left( c_{0}\mathbf{h}_{ii} + c_{1}(\mathbf{I} - \mathbf{\Pi}_{\mathbf{h}_{\widetilde{\Gamma}_{i}(1),i}})\mathbf{h}_{ii} + \dots + c_{|\widetilde{\Gamma}_{i}|}(\mathbf{I} - \mathbf{\Pi}_{[\mathbf{h}_{\widetilde{\Gamma}_{i}(j),i}]_{j=1}^{|\widetilde{\Gamma}_{i}|}})\mathbf{h}_{ii} \right) \\ &= \mathbf{\Pi}_{[\mathbf{h}_{ji}]_{j\in\Gamma_{i}^{\prime}}}^{\perp} \left( \sum_{j=0}^{|\widetilde{\Gamma}_{i}|} c_{j}\mathbf{h}_{ii} - c_{1}\mathbf{\Pi}_{\mathbf{h}_{\widetilde{\Gamma}_{i}(1),i}}\mathbf{h}_{ii} - \dots - c_{|\widetilde{\Gamma}_{i}|}\mathbf{\Pi}_{[\mathbf{h}_{\widetilde{\Gamma}_{i}(j),i}]_{j=1}^{|\widetilde{\Gamma}_{i}|}}\mathbf{h}_{ii} \right) \\ &= 0. \end{aligned}$$

$$(25)$$

By (25) the orthogonal complement of  $C([\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp} \mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\tilde{\Gamma}_i|}}^{\perp} \mathbf{h}_{ii}])$  is included in that of  $C([\mathbf{h}_{ji}]_{j \in \Gamma'_i})$ , but  $C([\mathbf{h}_{ii}, \mathbf{\Pi}_{\mathbf{A}_1}^{\perp} \mathbf{h}_{ii}, \cdots, \mathbf{\Pi}_{\mathbf{A}_{|\tilde{\Gamma}_i|}}^{\perp} \mathbf{h}_{ii}])$  and  $C([\mathbf{h}_{ji}]_{j \in \Gamma'_i})$  have the same dimensions. Thus, the two orthogonal complements are the same, and hence, the two subspaces themselves are the same. Consequently, for any  $c_{ii}\mathbf{h}_{ii} + \sum_{j\in\Gamma_i} c_{ji}\mathbf{h}_{ji}$  with arbitrary  $\{c_{ji}\in\mathbb{C}: j\in\Gamma'_i\}$ , there exists some  $\{c_j\in\mathbb{C}: 0\leq j\leq|\widetilde{\Gamma}_i|\}$  s.t.

$$\mathbf{v}_{i}^{opt} = c_{ii}\mathbf{h}_{ii} + \sum_{j\in\Gamma_{i}} c_{ji}\mathbf{h}_{ji} = c_{0}\frac{\mathbf{h}_{ii}}{\|\mathbf{h}_{ii}\|} + \sum_{j=1}^{|\mathbf{i}||i|} c_{j}\frac{\mathbf{\Pi}_{\mathbf{A}_{j}}^{\perp}\mathbf{h}_{ii}}{\|\mathbf{\Pi}_{\mathbf{A}_{j}}^{\perp}\mathbf{h}_{ii}\|}.$$
(26)

Theorem 2 states that the RZF solution is a linear combination of vectors that are obtained by projecting the desired channel vector onto the orthogonal complements of a series of subspaces spanned by the channels from the transmitter to the undesired receivers. Furthermore, the series of subspaces are obtained by sequentially including one additional interference channel vector at a time, as shown in (24). Soon, it will be shown that, to obtain the RZF solution to Problem 3, the order of interference channel inclusion for constructing  $\mathbf{A}_j$ s in Theorem 2 is determined by the set of allowed interference levels and the channel realization. Note from Theorem 2 that the ZF term  $\mathbf{v}_i^{ZF} = c \mathbf{\Pi}_{[\mathbf{h}_{1i},\cdots,\mathbf{h}_{i-1,i},\mathbf{h}_{i+1,i},\cdots,\mathbf{h}_{Ki}]} \mathbf{h}_{ii}$  is only a portion of the RZFCB solution. Thus, the set of RZFCB beamforming vectors is a superset of the ZF beamforming vector set.

#### C. The Sequential Orthogonal Projection Combining Method and Closed-Form Solutions

In this subsection, we propose an efficient beam design method for RZFCB that successively allocates the transmit power to certain vectors obtained by sequential orthogonal projection of the desired channel vector onto monotonically decreasing subspaces. Furthermore, we provide the closed-form solution to the RZFCB problem in the two-user case and an approximate closed-form solution in the three-user case.

To obtain the RZF beamforming vector under given interference leakage constraints for a given channel realization, Problem 3 should be solved. One can use a convex optimization problem solver, as in [12]. However, such a method requires a numerical search for determining the Lagrange dual variables satisfying the RZF constraints and the transmit power constraint. To circumvent such difficulty and to increase the practicality of the RZFCB, we exploit Theorem 2 to construct an efficient method to find the RZFCB solution. Theorem 2 provides us with a very convenient way of obtaining the RZFCB solution for given interference leakage levels for a given channel realization; we only need to find  $\tilde{\Gamma}_i$  and complex coefficients { $c_i$ } in (23) for each transmitter. The idea is based on the fact that the RZF beamforming vector should be designed to be as close as possible to the MRT beam vector under the interference leakage constraints for the maximum rate under RZF, as described in Problem 3. Hereafter, we will explain how the coefficients { $c_i$ } and the matrices { $A_i$ } in Theorem 2 can be obtained to maximize the rate under the RZF interference and power constraints. Consider transmitter *i* without loss of generality. For the

given transmit power constraint  $||\mathbf{v}_i|| = P_i$  (full power use is optimal), it may not be possible to allocate all of the transmit power to the MRT direction  $h_{ii}$  because this allocation may violate the RZF constraints. The rate greedy approach under the RZF constraints for a given channel realization is explained as follows. First, we should start to allocate the transmit power to the direction of  $h_{ii}$  by increasing  $c_0$ until this allocation hits one of the RZF constraints with equality, i.e., the interference level to one of the undesired receivers reaches the allowed maximum exactly. (In the case that the allowed interference levels to all undesired receivers are the same, this receiver is the receiver whose channel vector has the maximum inner product with  $\mathbf{h}_{ii}$ .) The index of this receiver is  $\tilde{\Gamma}(1)$ . At this point, transmitter *i* cannot allocate the transmit power to the direction  $h_{ii}$  anymore since this would violate the RZF constraint for receiver  $\Gamma(1)$ . Since the RZF constraints for other undesired receivers are still met with strict inequality, transmitter i can still cause interference to the remaining receivers. Thus, for the maximum rate under the RZF constraints, transmitter i should now start to allocate the remaining power to the direction of  $\Pi_{\mathbf{A}_1}^{\perp} \mathbf{h}_{ii}$ , where  $\mathbf{A}_1 = [\mathbf{h}_{\tilde{\Gamma}_i(1),i}]$ , until this allocation hits another RZF constraint with equality. The index of this receiver is  $\tilde{\Gamma}_i(2)$ . (Note that  $\Pi_{\mathbf{A}_1}^{\perp} \mathbf{h}_{ii}$  is the direction of maximizing the data rate without causing additional interference to receiver  $\tilde{\Gamma}_i(1)$ .) Now, transmitter *i* cannot cause interference to receiver  $\tilde{\Gamma}_i(2)$ in addition to receiver  $\tilde{\Gamma}_i(1)$  anymore. Therefore, at this point, transmitter *i* should start to allocate its remaining power to the next greedy direction  $\Pi_{\mathbf{A}_2}^{\perp} \mathbf{h}_{ii}$ , where  $\mathbf{A}_2 = [\mathbf{h}_{\tilde{\Gamma}_i(1),i}, \mathbf{h}_{\tilde{\Gamma}_i(2),i}]$ . This greedy power allocation without violating the RZF constraints should be done until all the transmit power is used up. When transmit power still remains even after hitting the last interference leakage constraint with equality, from then on, all the remaining power should be allocated to the ZF direction. This ensures the optimality of RZFCB at a high signal-to-noise ratio (SNR). On the other hand, when all the transmit power is used up before reaching the ZF direction, the remaining interference channel vectors do not appear in the solution. The final RZF solution is the sum of these component vectors and has the form in (23). In this way, the RZFCB solution can be obtained by combining the sequential projections of the desired channel vector  $\mathbf{h}_{ii}$  onto the orthogonal complements of the subspaces  $\mathcal{C}(\mathbf{A}_1) \subset \cdots \subset \mathcal{C}(\mathbf{A}_{|\tilde{\Gamma}_i|})$ . Thus, we refer to this beam design method as the sequential orthogonal projection combining (SOPC) method. By Theorem 1, the SOPC strategy with a well chosen set of interference relaxation levels is Pareto-optimal for MISO K-pair interference channels with linear beamforming! An interesting interpretation of the SOPC strategy is in an analogy with the water-filling strategy. The water-filling strategy distributes power to resource bins according to the effectiveness of each bin, and the power fills into the bin with the lowest noise level (or the most effective bin) first. Similarly, the SOPC strategy allocates power to the most

effective direction first and then the next most effective direction when the first direction cannot accept power anymore. This procedure continues until the procedure uses up the power. When the power is enough, the last direction is the ZF direction, which can accommodate infinite power. So, the SOPC strategy can be viewed graphically as pouring water on top of a multi-tiered fountain, as illustrated in Fig. 2 (a). The relationship of the RZFCB/SOPC design and the result by Jorswieck *et al.* [6] is explained in Fig. 2 (b) in the case of two users. In the two-user case, Jorswieck *et al.* have shown that a Pareto-optimal beam vector is a convex combination of the MRT and ZF beam vectors satisfying the power constraint. Thus, the feasible set of optimal beam vectors is the arc denoted by  $\mathcal{F}$  in Fig. 2 (b). All the points on this arc can be represented by the sum of the two vectors in red, and the size of the component vector in the MRT direction is determined by its projection onto  $C(h_{21})$ , i.e., the allowed interference level to the other receiver in the RZF context. Thus, the two-user result by Jorswieck *et al.* can be viewed as a special case of the SOPC strategy when the number of users is two. In Section IV, we will see that the introduction <u>PSfrag replacements</u> of the interference relaxation parameters is crucial to construct a simple and practical heuristic method to control the rate-tuple location along the Pareto boundary of the achievable rate region.

Now consider the detailed implementation of the SOPC method. The implementation of the SOPC method can be simplified further by the well-known result in the Kalman filtering theory, provided in the following lemma.

*Lemma 2* (Sequential orthogonal projection) Let  $\mathcal{H}$  be a Hilbert space with norm  $\|\cdot\|$  and inner product  $\langle \cdot, \cdot \rangle$ . Consider  $\mathbf{x} \in \mathcal{H}$  and a closed linear subspace  $\mathbf{A}_j$  of  $\mathcal{H}$ . For some  $\mathbf{y} \in \mathcal{H}$  but  $\mathbf{y} \notin \mathbf{A}_j$ , the

following equality holds

$$\mathbf{\Pi}_{\mathbf{A}_{j+1}}\mathbf{x} = \mathbf{\Pi}_{[\mathbf{A}_j,\mathbf{y}]}\mathbf{x} = \mathbf{\Pi}_{\mathbf{A}_j}\mathbf{x} + \frac{\langle \mathbf{x} - \mathbf{\Pi}_{\mathbf{A}_j}\mathbf{x}, \ \mathbf{y} - \mathbf{\Pi}_{\mathbf{A}_j}\mathbf{y} \rangle}{\|\mathbf{x} - \mathbf{\Pi}_{\mathbf{A}_j}\mathbf{x}\|^2} (\mathbf{y} - \mathbf{\Pi}_{\mathbf{A}_j}\mathbf{y}).$$
(27)

Since we need to compute  $\Pi_{\mathbf{A}_{j}}^{\perp}\mathbf{h}_{ii} = \mathbf{I} - \Pi_{\mathbf{A}_{j}}\mathbf{h}_{ii}$  in the SOPC method, Lemma 2 can be applied recursively by exploiting the fact  $\mathbf{A}_{j} = [\mathbf{A}_{j-1}, \mathbf{h}_{\tilde{\Gamma}(j),i}]$ . Thus, we only need to compute  $\Pi_{\mathbf{A}_{j-1}}\mathbf{h}_{\tilde{\Gamma}(j),i}$ for each  $j \in \{1, 2, \dots, K\}$ . Before considering the general case of an arbitrary number K of users, we consider simple two-user and three-user cases. For simplicity, we only provide the solution for transmitter 1. The solutions for other transmitters can be obtained in a similar way.

Proposition 1: The closed-form SOPC solution in the two-pair MISO IC case is given by

$$\mathbf{v}_{1} = \begin{cases} \sqrt{P_{1}} \mathbf{v}_{1}^{MF}, & \text{if } P_{1} \leq \alpha_{21} \sigma_{2}^{2} / |\mathbf{h}_{21}^{H} \mathbf{v}_{1}^{MF}|^{2}, \\ \xi_{0} \mathbf{v}_{1}^{MF} + \xi_{1} \mathbf{v}_{1}^{ZF}, & \text{otherwise}, \end{cases}$$
(28)

where  $\mathbf{v}_1^{MF} = \frac{\mathbf{h}_{11}}{\|\mathbf{h}_{11}\|}, \mathbf{v}_1^{ZF} = \frac{\mathbf{\Pi}_{\mathbf{h}_{21}}^{\perp} \mathbf{h}_{11}}{\|\mathbf{\Pi}_{\mathbf{h}_{21}}^{\perp} \mathbf{h}_{11}\|}, \xi_0 = \sqrt{\frac{\alpha_{21}\sigma_2^2}{|\mathbf{h}_{21}^H \mathbf{v}_1^{MF}|^2}}, \text{ and } \xi_1 = -\rho\xi_0 + \sqrt{P_1 - \xi_0^2(1 - \rho^2)}.$  Here,  $\rho = (\mathbf{v}_1^{MF})^H \mathbf{v}_1^{ZF} = \|\mathbf{\Pi}_{\mathbf{h}_{21}}^{\perp} \mathbf{h}_{11}\| / \|\mathbf{h}_{11}\| \in \mathbb{R}.$ 

*Proof:* The solution of RZFCB depends on the transmit power. When the transmit power  $P_1$  is low so that  $|\sqrt{P_1}\mathbf{h}_{21}^H\mathbf{v}_1^{MF}|^2 \leq \alpha_{21}\sigma_2^2$  holds, the SOPC (or RZFCB) solution is  $\sqrt{P_1}\frac{\mathbf{h}_{11}}{\|\mathbf{h}_{11}\|} =: \sqrt{P_1}\mathbf{v}_1^{MF}$ . This is because all the transmit power can be allocated to the MRT (or MF) direction  $\mathbf{h}_{11}$  without violating the RZF constraint. Now, consider the case that the transmit power is high so that  $|\sqrt{P_1}\mathbf{h}_{21}^H\mathbf{v}_1^{MF}|^2 > \alpha_{21}\sigma_2^2$ . In this case, the interference to receiver 2 will exceed the allowed level if all the transmit power is allocated to  $\mathbf{v}_1^{MF}$ . Thus, the total transmit power should be divided into two vectors  $\frac{\mathbf{h}_{11}}{\|\mathbf{h}_{11}\|}$  and  $\frac{\Pi_{\mathbf{h}_{21}}^\perp\mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{21}}^\perp\mathbf{h}_{11}\|}$ , and the SOPC solution is expressed as  $\mathbf{v}_1 = \xi_0 \mathbf{v}_1^{MF} + \xi_1 \mathbf{v}_1^{ZF}$ . Here,  $\xi_0 = \sqrt{\frac{\alpha_{21}\sigma_2^2}{|\mathbf{h}_{21}^H\mathbf{v}_1^{MF}|}}$  is obtained from the interference constraint for receiver 2:

$$|\mathbf{h}_{21}^{H}\mathbf{v}_{1}|^{2} = |\mathbf{h}_{21}^{H}(\xi_{0}\mathbf{v}_{1}^{MF} + \xi_{1}\mathbf{v}_{2}^{ZF})|^{2} = |\xi_{0}\mathbf{h}_{21}^{H}\mathbf{v}_{1}^{MF}|^{2} = \alpha_{21}\sigma_{2}^{2},$$
(29)

and  $\xi_1$  is determined by the transmit power constraint at transmitter 1:

$$\|\mathbf{v}_1\|^2 = \|\xi_0 \mathbf{v}_1^{MF} + \xi_1 \mathbf{v}_1^{ZF}\|^2 = \xi_0^2 + \xi_1^2 + 2\xi_0 \xi_1 \rho = P_1$$
(30)

where  $\rho := (\mathbf{v}_1^{MF})^H \mathbf{v}_1^{ZF}$ . Thus,  $\xi_1 = -\rho \xi_0 + \sqrt{P_1 - \xi_0^2 (1 - \rho^2)}$ .

Now, we consider the case of K = 3. This case is particularly important when the hexagonal cell structure is used and three cells are coordinating their beam vectors. In the case of K = 3, the solution can have six different forms depending on the transmit power and channel realization. We will provide

the closed-form solution for transmitter 1 in the case that the interference leakage to receiver 3 reaches the allowed level before the interference leakage to receiver 2 reaches the allowed level. (For this, we should first take inner products  $\langle \mathbf{h}_{21}, \mathbf{h}_{11} \rangle$  and  $\langle \mathbf{h}_{31}, \mathbf{h}_{11} \rangle$  and compare the ratio of their magnitudes with some threshold. The solutions of the other case and of other users can be derived in the same manner.)

Proposition 2: For K = 3 and  $\frac{|\mathbf{h}_{31}^H \mathbf{v}_1^{MF}|^2}{|\mathbf{h}_{21}^H \mathbf{v}_1^{MF}|^2} \ge \frac{\alpha_{31}\sigma_3^2}{\alpha_{21}\sigma_2^2}$ , the closed-form SOPC solution at transmitter 1 is given as follows:

$$\mathbf{v}_{1} = \begin{cases} \sqrt{P_{1}}\mathbf{v}_{1}^{MF}, & \text{if } P_{1} \in \Psi_{1} := \{P_{1} \in \mathbb{R}^{+} : \sqrt{P_{1}} \leq \beta_{0}\}, \\ \beta_{0}\mathbf{v}_{1}^{MF} + \beta_{1}\frac{\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|}, & \text{if } P_{1} \in \Psi_{2} := \left\{P_{1} \in \mathbb{R}^{+} : \sqrt{P_{1}} > \beta_{0} \text{ and} \\ \left|\mathbf{h}_{21}^{H}\left(\beta_{0}\mathbf{v}_{1}^{MF} + \beta_{1}\frac{\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|}\right)\right|^{2} \leq \alpha_{21}\sigma_{2}^{2}\right\}, \\ \beta_{0}\mathbf{v}_{1}^{MF} + \beta_{1}'\frac{\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|} + \beta_{2}\mathbf{v}_{1}^{ZF}, & \text{if } P_{1} \in \Psi_{3} := \left\{P_{1} \in \mathbb{R}^{+} : \\ \left|\mathbf{h}_{21}^{H}\left(\beta_{0}\mathbf{v}_{1}^{MF} + \beta_{1}\frac{\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|}\right)\right|^{2} > \alpha_{21}\sigma_{2}^{2}\right\}, \end{cases}$$

$$(31)$$

where  $\beta_0, \beta_1, \beta_1'$  and  $\beta_2$  are the values obtained from

$$\beta_0 = \frac{\sqrt{\alpha_{31}\sigma_3^2}}{|\mathbf{h}_{31}^H \mathbf{v}_1^{MF}|},\tag{32}$$

$$\left\| \beta_0 \mathbf{v}_1^{MF} + \beta_1 \frac{\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp} \mathbf{h}_{11}}{\|\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp} \mathbf{h}_{11}\|} \right\|^2 = P_1,$$

*Proof:* When the total transmit power is low or the allowed interference leakage levels are high, we can allocate all the transmit power to the direction of  $\mathbf{v}_1^{MF} := \frac{\mathbf{h}_{11}}{\|\mathbf{h}_{11}\|}$  without violating the RZF constraints. In this case, the SOPC solution is given by  $\mathbf{v}_1 = \sqrt{P_1}\mathbf{v}_1^{MF}$ . This holds when the transmit power is in  $\Psi_1$ . When the transmit power  $P_1 \in \Psi_2$  (i.e., all the transmit power can be allocated to the two directions  $\mathbf{h}_{11}$  and  $\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}$  without reaching the maximum allowed interference level for receiver 2), the SOPC solution has the form of  $\beta_0\mathbf{v}_1^{MF} + \beta_1\frac{\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|}$  and the residual power  $P_1 - \beta_0^2$  after allocating to  $\mathbf{v}_1^{MF}$  should be allocated to  $\frac{\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}}{\|\mathbf{\Pi}_{\mathbf{h}_{31}}^{\perp}\mathbf{h}_{11}\|}$ . So,  $\beta_1$  can be obtained from (33). Finally, when the transmit power  $P_1$  is even higher so that  $P_1 \in \Psi_3$ , the interference leakage to receiver 2 also reaches the maximum allowed level. Thus, we need the new direction of  $\mathbf{v}_1^{ZF} := \frac{\mathbf{\Pi}_{\mathbf{h}_{31},\mathbf{h}_{21}}^{\perp}\mathbf{h}_{11}}{\|\mathbf{\Pi}_{\mathbf{h}_{31},\mathbf{h}_{21}}^{\perp}\mathbf{h}_{11}\|}$  to allocate the remaining power without causing interference to both undesired receivers. In this case, the SOPC solution

is given by  $\beta_0 \mathbf{v}_1^{MF} + \beta_1' \frac{\Pi_{\mathbf{h}_{31}}^{\perp} \mathbf{h}_{11}}{\|\Pi_{\mathbf{h}_{31}}^{\perp} \mathbf{h}_{11}\|} + \beta_2 \mathbf{v}_1^{ZF}$ , and  $\beta_1'$  and  $\beta_2$  can be obtained from (32), (34), and (35).

Although Theorem 2 seemingly provides a closed-form SOPC solution in the case of K = 3, the complex coefficients  $\beta'_1$  and  $\beta_2$  are not uniquely determined by (32), (34) and (35). This is because (34) is underdetermined. (We have two variables, the real and complex values of  $\beta'_1$ , but have only one equation from (34).) To circumvent this difficulty, we restrict the coefficients to the set of positive real numbers in the case of K = 3 as well as in the case of K > 3. Then, the explicit expressions for the coefficients can be obtained as

$$\begin{aligned} \beta_1 &= -a\beta_0 + \sqrt{P_1 - (1 - a^2)\beta_0^2}, \\ \beta_1' &= \frac{-d\beta_0 + \sqrt{d^2\beta_0^2 - c(b\beta_0^2 - \alpha_{21}\sigma_2^2)}}{c}, \\ \beta_2 &= -(f\beta_0 + e\beta_1') + \sqrt{(f\beta_0 + e\beta_1')^2 - (2a\beta_0\beta_1' + \beta_0^2 + \beta_1'^2 - P_1)}, \end{aligned}$$

where  $a := \operatorname{Re}\{\langle \mathbf{v}_{1}^{MF}, \mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11} / || \mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11} || \rangle\} = || \mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{v}_{1}^{MF} ||, b = |\mathbf{h}_{21}^{H} \mathbf{v}_{1}^{MF}|^{2}, c = \left| \mathbf{h}_{21}^{H} \frac{\mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11}}{|| \mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11} ||} \right|^{2}, d = \operatorname{Re}\left\{ (\mathbf{h}_{21}^{H} \mathbf{v}_{1}^{MF})^{*} \left( \mathbf{h}_{21}^{H} \frac{\mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11}}{|| \mathbf{\Pi}_{h_{31}}^{\perp} \mathbf{h}_{11} ||} \right) \right\}, e = \frac{|\mathbf{h}_{21}^{H} \mathbf{h}_{11}|^{2}}{|| \mathbf{h}_{11} ||^{2}}, \text{ and } f = (\mathbf{v}_{1}^{MF})^{H} \mathbf{v}_{1}^{ZF}.$  Note in the case of K = 3 that the necessary computations for the SOPC solution are a few inner product and square root operations and the complexity of the SOPC method is simply O(N), where N is the number of transmit antennas at the transmitter. The solution procedure can easily be programmed in a real hardware. In the case of K > 3, it is cumbersome to distinguish all possible scenarios and to derive an explicit SOPC solution. Thus, we propose using an algorithm implementing the SOPC strategy with real combining coefficients in Table I. The proposed SOPC solution based on real coefficients is a sub-optimal solution in the case of  $K \ge 3$ . However, the performance gap between the optimal RZFCB (or optimal SOPC) beamforming vector and the proposed SOPC solution based on real coefficients is insignificant for a wide range of meaningful SNR values, as seen in Fig. 3. Thus, practically, the proposed SOPC solution can be used with negligible performance loss.

### IV. RATE-TUPLE CONTROL

In the previous section, we provided a very efficient algorithm to solve the RZFCB problem for a given set  $\{\alpha_{ji}\}\$  of interference relaxation parameters. Now, we consider how to design these parameters. We first provide a centralized approach that can almost always determine  $\{\alpha_{ji}\}\$  to achieve *any* desired point on the Pareto boundary of the achievable rate region and then a fully-distributed heuristic approach that exploits the parameterization in terms of interference relaxation levels in RZFCB and is able to control the rate-tuple location roughly along the Pareto boundary of the achievable rate region.

### The Sequential Orthogonal Projection Combining (SOPC) Algorithm

- 2. If there exists  $j \in \Phi_i$  such that  $\|\mathbf{h}_{ji}^H \mathbf{v}_i\|^2 \ge \alpha_{ji} \sigma_j^2$ , then go to step 3. Otherwise, go to step 4.
- 3. Update  $\mathbf{A} = [\mathbf{A}, \mathbf{h}_{ji}], \Delta \mathbf{v} = \frac{\mathbf{\Pi}_{\mathbf{A}}^{\perp} \mathbf{h}_{ii}}{\|\mathbf{\Pi}_{\mathbf{A}}^{\perp} \mathbf{h}_{ii}\|}, \text{ and } \Phi_i = \Phi_i \setminus \{j\}.$
- 4. If  $\|\mathbf{v}_i\|^2 \ge P_i$ , stop iteration. Otherwise, go to step 1.

### A. A Centralized Approach

By Theorem 1, with a set of well chosen allowed interference leakage levels, the RZFCB can achieve any Pareto-optimal point of the rate region. However, the problem of designing the interference leakage

levels  $\{\alpha_{ii}\}\$  in the network remains. In [12], a necessary condition for the level of interference leakage at each receiver to achieve a Pareto-optimal point was derived. Based on that, the authors proposed an iterative algorithm that updates the interference leakage levels iteratively until the RZFCB reaches a point on the Pareto boundary. One merit of the algorithm in [12] is that it is applicable to general K-user MISO interference channels. However, the proposed algorithm cannot control the location on the Pareto boundary to which the algorithm converges, and this aspect was not fully explored. On the other hand, the authors in [20] proposed a beam design algorithm for 2-user MISO interference channels, based on their result that any Pareto-optimal point is represented as  $\mathbf{v}_i = \frac{\lambda_i \mathbf{v}_i^{MF} + (1-\lambda_i) \mathbf{v}_i^{ZF}}{\|\lambda_i \mathbf{v}_i^{MF} + (1-\lambda_i) \mathbf{v}_i^{ZF}\|}$ , where  $0 \le \lambda_i \le 1$ , in 2user MISO interference channels. Thus, the algorithm proposed in [20] iteratively updates  $\{\lambda_i, i = 1, 2\}$ to achieve any desired rate-tuple. A good point of this algorithm is that any desired Pareto-optimal point can be obtained. However, the proposed algorithm has limitations in that it is applicable only to 2-user MISO interference channels. The difficulty in applying the technique to the case of  $K \ge 3$  lies in the parameterization of the authors for Pareto-optimal beam vectors in the case of  $K \ge 3$ , which is given in (18) (i.e., any Pareto-optimal beam vector is a linear combination of the desired channel vector and the interference channel vectors). With this parameterization, the search space becomes  $\mathbb{C}^9$  even in the case of K = 3, and the problem of finding the desired parameters is difficult. However, in the RZFCB framework, we do not parameterize Pareto-optimal beam vectors directly with  $\{c_{ji}\}$  in (18) or with  $\{c_j\}$ in (23). Instead, we parameterize Pareto-optimal beam vectors in terms of the interference leakage levels  $\{\alpha_{ii}\}$  indirectly. This indirect parameterization provides us with an advantage of a reduced parameter search space. (In the case of K = 3, the parameter space is  $\mathbb{R}^6_+$ .) By exploiting the advantage of this new parameterization and the idea in the algorithm in [20], we here propose a new beam design algorithm that updates  $\{\alpha_{ii}\}\$  and is applicable to the case of reasonably large K.

First, we convert the problem of finding the desired point on the Pareto boundary of the achievable rate region into that of finding the optimal point of the following optimization problem:

$$\begin{array}{ll} \underset{\{\alpha_{ji}\}}{\operatorname{maximize}} & u(R_1, \cdots, R_K), \\ \text{subject to} & \|\mathbf{h}_{ji}^H \mathbf{v}_i\|^2 \le \alpha_{ji} \sigma_j^2, \quad \forall i, \ j \ne i, \\ & \|\mathbf{v}_i\|^2 \le P_i, \qquad \forall i, \end{array}$$

$$(36)$$

where  $u(R_1, \dots, R_K)$  is an utility function of the network determined by the rates of all transmitterreceiver pairs. A few examples of the utility function are given as follows [20]:

• Weighted sum rate:  $u_1(R_1, \dots, R_K) = \sum w_i R_i$ , where  $w_i \ge 0$  and  $\sum w_i = 1$ .

• Nash bargaining point:  $u_2(R_1, \cdots, R_K) = \prod_{i=1}^K (R_i - R_i^{NE})$ , where  $R_i^{NE} = \log_2\left(1 + \frac{|\mathbf{h}_{ii}\mathbf{v}_i^{MF}|^2}{\sigma_i^2 + \sum_{j \neq i} |\mathbf{h}_{ij}\mathbf{v}_j^{MF}|^2}\right)$ .

• Egalitarian point:  $u_3(R_1, \cdots, R_K) = \min(R_1, \cdots, R_K)$ .

Then, the optimization (36) can be solved by alternating optimization. That is, we fix all other  $\alpha_{ji}$ 's except one interference relaxation parameter and update the unfixed parameter so that the utility function is maximized. After this update, the next  $\alpha_{ji}$  is picked for update. This procedure can be continued until it converges. The proposed algorithm is described in detail in Table II. (For computing the rate-tuple in the utility function, optimal beam vectors for given  $\{\alpha_{ji}\}$  can be obtained by the SOPC algorithm in the previous section and the rate-tuple can be computed based on the obtained beam vectors.) Due to the non-convex structure, the convergence of the proposed algorithm is not guaranteed, but simulations showed that the proposed algorithm almost always found the desired Pareto-optimal point. Some simulation results of this centralized rate control algorithm are given in Figures 4 (a) and (b) for two different channel realizations in the case of K = 2. It is noteworthy that, in a simple utility function case such as the weighted sum rate, gradient-descent based approaches can be used directly. However, a gradient-descent based approach requires updating  $N \times K$  complex elements at each iteration. On the other hand, the proposed approach updating the levels of interference leakage only requires updating K(K - 1) real variables.

#### B. A Distributed Heuristic Approach and Practical Considerations

Whereas the proposed centralized algorithm yields the desired rate-tuple in the Pareto boundary of the rate region in most cases, it requires central processing with the knowledge of all { $\mathbf{h}_{ji}, i, j =$  $1, 2, \dots, K$  and  $\{\sigma_j^2, j = 1, 2, \dots, K\}$ . This reduces the practicality of the centralized approach to determining  $\{\alpha_{ij}\}\$  when the inter-bases communication is limited or impossible. Note that the RZFCB framework in Problem 3 itself is distributed. Transmitter i only needs to know  $\{\mathbf{h}_{ji}, j = 1, 2, \cdots, K\}$ and  $\{\sigma_{j}^{2}, j = 1, 2, \cdots, K\}$  and needs to control  $\{\alpha_{1i}, \cdots, \alpha_{i-1,i}, \alpha_{i+1,i}, \alpha_{Ki}\}$ . In the RZF framework, heuristic control of  $\{\alpha_{ii}\}$  is straightforward based on (6), (10), and (11) with the knowledge of  $\{\mathbf{h}_{ji}, j = 1, 2, \cdots, K\}$  and  $\{\sigma_j^2, j = 1, 2, \cdots, K\}$  at transmitter *i*. Note that  $\epsilon_i = \sum_{j \neq i} \alpha_{ij}$  in (10) is the additional interference power relative to thermal noise power  $\sigma_i^2$  at receiver *i*. Thus,  $\epsilon_i = 1$  means that the SINR of receiver i is lower than the SNR of the same receiver by 3dB, and 3dB loss cannot be accepted. Classical heuristic guidelines can now be applied here; setting  $\alpha_{ji}$ 's for  $\epsilon_i$  to be within an interval of [0.1, 0.3] usually yields good performance near the Pareto boundary of the rate region. Furthermore, to obtain corner points of the Pareto boundary of the rate region, another heuristic idea works. One transmitter should use a nearly MRT beam vector (i.e., this transmitter increases the interference relaxation parameter to  $\eta |\mathbf{h}_{ji} \mathbf{v}_i^{MF}|^2$ ,  $\eta = 0.8 \sim 0.9$ ), and the rest of the transmitters should use nearly ZF beam vectors (i.e., the interference relaxation parameters for these transmitters should be near zero, say, 0.01). Figures 4 (a) and (b) contain numerical results regarding the rate performance of RZFCB with this heuristic approach.

There are several advantages in the RZFCB with the distributed control of the interference relaxation parameters, which are summarized below.

- It is fully distributed. Transmitter i only needs to know  $\{\mathbf{h}_{ji}, j = 1, 2, \cdots, K\}$  and  $\{\sigma_i^2, j = 1, 2, \cdots, K\}$ .
- The rate is controllable. When the transmitters form a coordinating cluster, they can negotiate their rates depending on the requests from their receivers. In this phase,  $\{\alpha_{ji}\}$  can be negotiated. (One can mix RZFs with different interference relaxation levels, thus including ZF, freely in the network.)

• Once transmitter *i* knows  $\{\alpha_{1i}, \dots, \alpha_{i-1,i}, \alpha_{i+1,i}, \alpha_{Ki}\}$ , there exists a very fast algorithm, the SOPC algorithm, to design the RZFCB beam vector. Furthermore, in the case of K = 3, there is a closed-form solution.

• Transmitter *i* knows its SINR and achievable rate exactly, and its achievable rate is given by

$$R_i = \log\left(1 + \frac{|\mathbf{h}_{ii}^H \mathbf{v}_i|^2}{(1 + \epsilon_i)\sigma_i^2}\right).$$
(37)

So, transmission based on this rate will be successful with high probability. This is true even when  $\{\alpha_{ji}\}$ 

are designed suboptimally, i.e., away from the Pareto boundary of the rate region. Thus, the RZFCB scheme is robust.

• If we give up the SOPC algorithm and are willing to use a convex optimization solver, there is no restriction in the number of transmit antennas. (A method like the projected gradient method can be used in this case.)

• When a few bits carrying information about the SNR of each interfering receiver are available, the control of  $\{\alpha_{ji}\}$  can be made more accurate. When an interfering receiver is in high SNR, we can allow more interference leakage to the receiver. The amount of this information is negligible when compared with the amount of channel feedback.

#### V. RZFCB FOR MIMO INTERFERENCE CHANNELS

In this section, we consider the case that both transmitters and receivers are equipped with multiple antennas i.e., MIMO interference channels. We first provide a distributed RZFCB formulation for MIMO interference channels and then propose a solution to the MIMO RZFCB based on the projected gradient

## method [13]. The rate control idea in the MISO case can be applied to the MIMO case too.

#### A. Problem Formulation

We assume that each receiver has M receive antennas and each transmitter has N transmit antennas. In this case, the received signal at receiver i is given by

$$\mathbf{y}_{i} = \mathbf{H}_{ii}\mathbf{V}_{i}\mathbf{s}_{i} + \sum_{j\neq i}\mathbf{H}_{ij}\mathbf{V}_{j}\mathbf{s}_{j} + \mathbf{n}_{i},$$
(38)

where  $\mathbf{H}_{ij}$  is the  $M \times N$  channel matrix from transmitter j to receiver i,  $\mathbf{V}_i$  is the  $N \times d_i$  beamforming matrix,  $\mathbf{s}_i$  is the  $d_i \times 1$  transmit symbol vector at transmitter i from a Gaussian codebook with  $\mathbf{s}_i \sim \mathcal{N}(0, \mathbf{I}_{d_i})$ , and  $\mathbf{n}_i \sim \mathcal{N}(0, \sigma_i^2 \mathbf{I})$  is the additive noise. As in the MISO case, we have a transmit power constraint,  $\|\mathbf{V}_j\|_F^2 \leq P_j$ , for transmitter j. The RZF constraint in the MIMO case is given by an inequality with the Frobenius norm as

$$\|\mathbf{H}_{ji}\mathbf{V}_i\|_F^2 \le \alpha_{ji}\sigma_j^2, \quad \forall i, \ j \ne i$$
(39)

for some constant  $\alpha_{ji} \ge 0$ . As in the MISO case, the RZF constraints reduce to ZF constraints when  $\alpha_{ji} = 0$  for all  $i, j \ne i$ . With the MIMO RZF constraints, a cooperative beam design problem that maximizes the sum rate is formulated as follows:

Problem 4 (RZF cooperative beamforming problem)

$$\underset{\{\mathbf{V}_i\}}{\text{maximize}} \quad \sum_{i=1}^{K} \log \left| \mathbf{I}_M + (\sigma_i^2 \mathbf{I} + \mathbf{B}_i)^{-1} \mathbf{H}_{ii} \mathbf{V}_i \mathbf{V}_i^H \mathbf{H}_{ii}^H \right|, \tag{40}$$

subject to (C.1) 
$$\|\mathbf{H}_{ji}\mathbf{V}_i\|_F^2 \le \alpha_{ji}\sigma_j^2, \quad \forall i, j \ne i,$$
 (41)

(C.2) 
$$\|\mathbf{V}_i\|_F^2 \le P_i, \quad \forall i,$$
 (42)

where  $\mathbf{B}_i = \sum_{j \neq i} \mathbf{H}_{ij} \mathbf{V}_j \mathbf{V}_j^H \mathbf{H}_{ij}^H$  is the interference covariance matrix at receiver *i*.

Note that, in Problem 4, the interference from other transmitters is incorporated in the rate formula through the interference covariance matrix  $\mathbf{B}_i$  capturing the residual inter-cell interference under the RZF constraints. As in the MISO case, we will derive a lower bound on the rate by exploiting the RZF constraints to convert the joint design problem into a distributed problem. Note that, under the RZF constraints, the total power of interference from undesired transmitters is upper bounded as

$$\operatorname{tr}(\mathbf{B}_{i}) = \sum_{j \neq i} \|\mathbf{H}_{ij}\mathbf{V}_{j}\|_{F}^{2} \leq \sigma_{i}^{2} \sum_{j \neq i} \alpha_{ij} =: \epsilon_{i}\sigma_{i}^{2},$$
(43)

which implies  $\mathbf{B}_i \leq \epsilon_i \sigma_i^2 \mathbf{I}$ .

Hassibi and Hochwald derived a lower bound on the ergodic rate of a MIMO channel with interference [21]. However, their result is not directly applicable<sup>5</sup> here since the rate here is for an instantaneous channel realization. Thus, we have derived a new lower bound under the RZF interference constraints, and the lower bound on the rate of receiver i is given in the following Lemma.

Lemma 3: A lower bound on the rate of receiver i under the RZF constraints is given by

$$\log \left| \mathbf{I}_{M} + (\sigma_{i}^{2}\mathbf{I} + \mathbf{B}_{i})^{-1}\mathbf{H}_{ii}\mathbf{V}_{i}\mathbf{V}_{i}^{H}\mathbf{H}_{ii}^{H} \right| \geq \log \left| \mathbf{I}_{M} + \frac{1}{\sigma_{i}^{2}(1+\epsilon_{i})}\mathbf{H}_{ii}\mathbf{V}_{i}\mathbf{V}_{i}^{H}\mathbf{H}_{ii}^{H} \right|,$$
(44)

where  $\operatorname{tr}(\mathbf{B}_i) = \sum_{j \neq i} \|\mathbf{H}_{ij}\mathbf{V}_j\|_F^2 \le \epsilon_i \sigma_i^2$  for all *i*.

*Proof:* The rate at receiver i is given by

$$\log |\mathbf{I} + \mathbf{\Phi}_i^{-1} \mathbf{A}_i| = \log \prod_{k=1}^M (1 + \lambda_k(\mathbf{\Phi}_i^{-1} \mathbf{A}_i))$$
(45)

where  $\Phi_i = \sigma_i^2 \mathbf{I} + \mathbf{B}_i$ ,  $\mathbf{A}_i = \mathbf{H}_{ii} \mathbf{V}_i \mathbf{V}_i^H \mathbf{H}_{ii}^H$ , and  $\lambda_k(\mathbf{X})$  denotes the k-th largest eigenvalue of **X**. By the Rayleigh-Ritz theorem [22, p.176], we have

$$\lambda_M(\mathbf{\Phi}_i^{-1}\mathbf{A}_i) \le \frac{\mathbf{x}^H \mathbf{A}_i \mathbf{x}}{\mathbf{x}^H \mathbf{\Phi}_i \mathbf{x}} = \frac{\mathbf{p}^H \mathbf{\Phi}_i^{-\frac{1}{2}} \mathbf{A}_i \mathbf{\Phi}_i^{-\frac{H}{2}} \mathbf{p}}{\mathbf{p}^H \mathbf{p}} \le \lambda_1(\mathbf{\Phi}_i^{-1} \mathbf{A}_i)$$
(46)

for any non-zero vector  $\mathbf{x} \in \mathbb{C}^M$  and  $\mathbf{p} := \mathbf{\Phi}_i^{\frac{H}{2}} \mathbf{x}$ . From the Courant-Fischer theorem [22, p.179], the *k*-th largest generalized eigenvalue  $\lambda_k(\mathbf{\Phi}_i^{-1}\mathbf{A}_i)$  of  $\mathbf{\Phi}_i^{-1}\mathbf{A}_i$ ,  $k = 1, \dots, M$ , is given by

$$\lambda_k(\mathbf{\Phi}_i^{-1}\mathbf{A}_i) = \max_{\substack{\mathbf{p}\neq 0, \ \mathbf{p}\in\mathbb{C}^M, \\ \mathbf{p}\perp\mathbf{p}_1,\cdots,\mathbf{p}_{k-1}}} \frac{\mathbf{p}^H \mathbf{\Phi}_i^{-\frac{1}{2}} \mathbf{A}_i \mathbf{\Phi}_i^{-\frac{H}{2}} \mathbf{p}}{\mathbf{p}^H \mathbf{p}}$$
(47)

where  $\mathbf{p}_i$  is the eigenvector associated with the *i*-th largest eigenvalue of  $\mathbf{\Phi}_i^{-\frac{1}{2}} \mathbf{A}_i \mathbf{\Phi}_i^{-\frac{H}{2}}$ . Let  $\mathbf{A}_i = \mathbf{U}_i \mathbf{\Sigma}_i \mathbf{U}_i^H$  be the eigen-decomposition of  $\mathbf{A}_i$ , where  $\mathbf{\Sigma}_i = \text{diag}(\lambda_1(\mathbf{A}_i), \dots, \lambda_M(\mathbf{A}_i))$ . Then, for all k

$$\lambda_{k}(\boldsymbol{\Phi}_{i}^{-1}\mathbf{A}_{i}) = \max_{\substack{\mathbf{p}\neq0, \mathbf{p}\in\mathbb{C}^{M},\\\mathbf{p}\perp\mathbf{p}_{1},\cdots,\mathbf{p}_{k-1}}} \frac{\mathbf{p}^{H}\boldsymbol{\Phi}_{i}^{-\frac{1}{2}}\mathbf{A}_{i}\boldsymbol{\Phi}_{i}^{-\frac{H}{2}}\mathbf{p}}{\mathbf{p}^{H}\mathbf{p}},$$
$$= \max_{\substack{\mathbf{p}\neq0, \mathbf{p}\in\mathbb{C}^{M},\\\mathbf{p}\perp\mathbf{p}_{1},\cdots,\mathbf{p}_{k-1}}} \frac{\mathbf{p}^{H}\boldsymbol{\Phi}_{i}^{-\frac{1}{2}}\mathbf{U}_{i}\boldsymbol{\Sigma}_{i}\mathbf{U}_{i}^{H}\boldsymbol{\Phi}_{i}^{-\frac{H}{2}}\mathbf{p}}{\mathbf{p}^{H}\mathbf{p}}$$

$$= \max_{\substack{\mathbf{z}\neq0, \mathbf{z}\in\mathbb{C}^{M}, \\ \Phi_{i}^{H/2}\mathbf{U}_{i}\mathbf{z}\perp\mathbf{p}_{1},\cdots,\mathbf{p}_{k-1}}} \frac{\mathbf{z}^{H}\Sigma_{i}\mathbf{z}}{\mathbf{z}^{H}\mathbf{U}_{i}^{H}\Phi_{i}\mathbf{U}_{i}\mathbf{z}}, \qquad (\mathbf{z}:=\mathbf{U}_{i}^{H}\Phi_{i}^{-\frac{H}{2}}\mathbf{p}),$$

$$\stackrel{(a)}{\geq} \max_{\substack{\mathbf{z}\neq0, ||\mathbf{z}||=1, \mathbf{z}\in\mathbb{C}^{M}, \\ z_{k+1}=z_{k+2}=\cdots=z_{M}=0, \\ \Phi_{i}^{H/2}\mathbf{U}_{i}\mathbf{z}\perp\mathbf{p}_{1},\cdots,\mathbf{p}_{k-1}, \\ = \max_{\substack{\mathbf{z}\neq0, ||\mathbf{z}||=1, \mathbf{z}\in\mathbb{C}^{M}, \\ z_{k+1}=z_{k+2}=\cdots=z_{M}=0, \\ \Phi_{i}^{H/2}\mathbf{U}_{i}\mathbf{z}\perp\mathbf{p}_{1},\cdots,\mathbf{p}_{k-1}, \\ } \frac{\sum_{j=1}^{k}\lambda_{j}(\mathbf{A}_{i})|z_{j}|^{2}}{\mathbf{z}^{H}\mathbf{U}_{i}^{H}\Phi_{i}\mathbf{U}_{i}\mathbf{z}}, \qquad (\mathbf{z}=[z_{1},z_{2},\cdots,z_{M}]^{T})$$

$$(\mathbf{b}) \quad \lambda_{k}(\mathbf{A}_{i}), \qquad (48)$$

where (a) is satisfied since the feasible set for  $\mathbf{z}$  is reduced and (b) is satisfied since  $||\mathbf{z}||^2 = |z_1|^2 + \cdots + |z_k|^2 = 1$ ,  $\lambda_1(\mathbf{A}_i) \ge \cdots \ge \lambda_k(\mathbf{A}_i)$ , and  $\mathbf{z}^H \mathbf{U}_i^H \mathbf{\Phi}_i \mathbf{U}_i \mathbf{z} \le \lambda_1(\mathbf{\Phi}_i)$  by the Rayleigh-Ritz theorem. Based on (48), a lower bound on the rate is given by

$$\log |\mathbf{I} + \mathbf{\Phi}_i^{-1} \mathbf{A}_i| = \log \prod_{k=1}^M (1 + \lambda_k(\mathbf{\Phi}_i^{-1} \mathbf{A}_i)) \ge \log \prod_{k=1}^M \left( 1 + \frac{\lambda_k(\mathbf{A}_i)}{\lambda_1(\mathbf{\Phi}_i)} \right).$$
(49)

Since  $\Phi_i = \sigma_i^2 \mathbf{I} + \sum_{j \neq i} \mathbf{H}_{ij} \mathbf{V}_j \mathbf{V}_j^H \mathbf{H}_{ij}^H$ , we have  $\lambda_1(\Phi_i) = \sigma_i^2 + \lambda_1 \left( \sum_{j \neq i} \mathbf{H}_{ij} \mathbf{V}_j \mathbf{V}_j^H \mathbf{H}_{ij}^H \right)$ , where the maximum eigenvalue of the interference covariance matrix is upper bounded by

$$\lambda_1 \Big( \sum_{j \neq i} \mathbf{H}_{ij} \mathbf{V}_j \mathbf{V}_j^H \mathbf{H}_{ij}^H \Big) \le \operatorname{tr} \Big( \sum_{j \neq i} \mathbf{H}_{ij} \mathbf{V}_j \mathbf{V}_j^H \mathbf{H}_{ij}^H \Big) = \sum_{j \neq i} \alpha_{ij} \sigma_i^2 = \epsilon_i \sigma_i^2.$$
(50)

Thus, a lower bound for receiver i is given by

$$\left|\mathbf{I} + \mathbf{\Phi}_{i}^{-1}\mathbf{A}_{i}\right| \geq \prod_{k=1}^{M} \left(1 + \frac{\lambda_{k}(\mathbf{A}_{i})}{\lambda_{1}(\mathbf{\Phi}_{i})}\right) \geq \left|\mathbf{I}_{M} + \frac{1}{\sigma_{i}^{2}(1+\epsilon_{i})}\mathbf{A}_{i}\right|.$$
(51)

Note that in (44) the inter-user dependency is removed and the beam design can be performed at each transmitter in a distributed manner. Based on the lower bound (44), the RZFCB problem is now formulated as a distributed problem:

Problem 5 (The MIMO RZFCB problem)

$$\min_{\mathbf{V}_{i}} \quad \phi_{i}(\mathbf{V}_{i}) := -\log \left| \mathbf{I}_{M} + \frac{1}{\sigma_{i}^{2}(1+\epsilon_{i})} \mathbf{H}_{ii} \mathbf{V}_{i} \mathbf{V}_{i}^{H} \mathbf{H}_{ii}^{H} \right|,$$
(52)

subject to (C.1) 
$$\|\mathbf{H}_{ji}\mathbf{V}_i\|_F^2 \le \alpha_{ji}\sigma_j^2, \quad \forall j \ne i,$$
 (53)

$$(C.2) \quad \|\mathbf{V}_i\|_F^2 \le P_i,\tag{54}$$

for each transmitter  $i = 1, 2, \cdots, K$ .

Note that Problem 5 is a constrained convex problem since the log determinant function is a concave function and since the constraint sets are convex.

### B. Beam Design Based on the Projected Gradient Method

One of many known algorithms for constrained convex optimization can be used to solve Problem 5 for given  $\{\alpha_{ji}\}$ . In particular, we choose to use the projected gradient method (PGM) by Goldstein [13]. The following theorem states the convergence property of PGM in the finite dimensional case.

Theorem 3 (The PGM [13,23]) Let  $C \subset \mathcal{H}$  be a nonempty closed convex subset of a finite-dimensional real Hilbert space  $\mathcal{H}$  and let  $\phi : \mathcal{H} \to \mathbb{R}$  be a differentiable convex function with its derivative  $\phi' :$  $\mathcal{H} \to \mathcal{H} \nu$ -Lipschitzian ( $\nu > 0$ ) over  $\mathcal{H}$ .<sup>6</sup> Assume that the function  $\phi$  has a minimum over C; i.e.,  $\arg\min_{\mathbf{u}\in C} \phi(\mathbf{u}) \neq \emptyset$ . In this case, for any  $\mathbf{u}_0 \in \mathcal{H}$  and any  $\lambda \in (0, \frac{2}{\nu})$ , the sequence  $(\mathbf{u}_k)_{k\in\mathbb{N}}$  generated by

$$\mathbf{u}_{n+1} := P_C \left( \mathbf{u}_n - \mu \phi'(\mathbf{u}_n) \right) \tag{55}$$

converges to a solution  $\mathbf{u}^* \in C$  that minimizes  $\phi$  over C.

The update equation in (55) is composed of two operations: the first is a slight shift in the steepest descent direction (which we refer to as *steepest descent shift*) for finding a better point reducing the cost and the latter is a metric projection for satisfying the constraint. The application of the PGM to Problem 5 is

straightforward. The convex cost function is given by (52) and the convex feasible set C is given by the intersection of the K convex constraint sets (K - 1 from the RZF constraints (C.1) and one from the power constraint (C.2)). Based on the properties of the determinant [24], the gradient of the cost function is given by

$$\phi_i'(\mathbf{V}_i) = -\frac{1}{\sigma_i^2(1+\epsilon_i)} \mathbf{H}_{ii}^H \mathbf{C}_i^{-1} \mathbf{H}_{ii} \mathbf{V}_i,$$
(56)

where  $\mathbf{C}_i = \mathbf{I}_M + \frac{1}{\sigma_i^2(1+\epsilon_i)} \mathbf{H}_{ii} \mathbf{V}_i \mathbf{V}_i^H \mathbf{H}_{ii}^H$ . The constraints (C.1) and (C.2) can be rewritten in vector form respectively as

$$\|\breve{\mathbf{H}}_{ji}\mathbf{v}_i\|^2 \le \alpha_{ji}\sigma_j^2 \quad \text{and} \quad \|\mathbf{v}_i\|^2 \le P_i,$$
(57)

where  $\mathbf{v}_i := \operatorname{vec}(\mathbf{V}_i)$  and  $\check{\mathbf{H}}_{ji} := \mathbf{I}_M \otimes \mathbf{H}_{ji}$ . The corresponding feasible sets are given respectively by  $E_{ji} := \{\mathbf{v} \in \mathbb{C}^{MN} : \mathbf{v}^H \mathbf{Q}_{ji} \mathbf{v} \le \alpha_{ji} \sigma_j^2\}$  and  $B_i := \{\mathbf{v} \in \mathbb{C}^{MN} : \|\mathbf{v}\|^2 \le P_i\}$ , where  $\mathbf{Q}_{ji} = \check{\mathbf{H}}_{ji}^H \check{\mathbf{H}}_{ji}$ . The constraint sets in (C.1) are transformed into ellipsoids  $\{E_{ji}\}$  and the constraint in (C.2) is a ball  $B_i$ . Thus, their intersection  $C_i := (\bigcap_{j \neq i} E_{ji}) \cap B_i$  is closed and convex since the intersection of closed convex sets is closed and convex [19]. The metric projection onto  $C_i$  does not have a closed-form expression, but it can be approximated by successive metric projections onto constraint sets [25]. That is, we first project an initial point sequentially onto the ellipsoids  $\{E_{ji}\}$ , which can be done by a known method [26], and then project the image of the first projection onto the ball  $B_i$ , which can be done simply by  $P_{B_i}(\mathbf{v}) = \mathbf{v}$ , if  $||\mathbf{v}||^2 \leq P_i$ , or  $P_{B_i}(\mathbf{v}) = \frac{\sqrt{P_i}}{\|\mathbf{v}\|} \mathbf{v}$ , otherwise. Thus, an approximate metric projection onto the constraint set  $C_i$  for transmitter i can be done in a successive manner

$$P_{C_i}(\mathbf{v}) \approx T_i(\mathbf{v}) := P_{B_i} \circ P_{E_{K,i}} \circ \ldots \circ P_{E_{i+1,i}} \circ P_{E_{i-1,i}} \circ \ldots \circ P_{E_{1,i}}(\mathbf{v}).$$
(58)

The proposed algorithm for the RZFCB solution in MIMO interference channels is summarized in Table III. Although a rigorous convergence analysis of the proposed approximate projected gradient method is beyond the scope here, we present some discussion below about a characterization of the convergent point of the sequence of vectors generated by the proposed algorithm. The convergent point  $\mathbf{v}_{K}^{*}$ , if exists, should satisfy the following property: for some  $\mathbf{v}_{i}^{*}$ ,  $i = 0, 1, \dots, K - 1$ , the algorithm  $\mathbf{v}_{n+1} := T_{i}(\mathbf{v}_{n} - \mu\phi'(\mathbf{v}_{n})) := P_{B_{i}} \circ P_{E_{K,i}} \circ \ldots \circ P_{E_{i+1,i}} \circ P_{E_{i-1,i}} \circ \ldots \circ P_{E_{1,i}}(\mathbf{v}_{n} - \mu\phi'(\mathbf{v}_{n}))$  should lead to a closed path  $\mathbf{v}_{K}^{*} \rightarrow \mathbf{v}_{0}^{*} := \mathbf{v}_{K}^{*} - \mu\phi'(\mathbf{v}_{K}^{*}) \rightarrow \mathbf{v}_{1}^{*} := P_{E_{1,i}}(\mathbf{v}_{0}^{*}) \rightarrow \mathbf{v}_{2}^{*} := P_{E_{2,i}}(\mathbf{v}_{1}^{*}) \rightarrow \cdots \rightarrow \mathbf{v}_{K-1}^{*} := P_{E_{K,i}}(\mathbf{v}_{K-2}^{*}) \rightarrow \mathbf{v}_{K}^{*} := P_{B_{i}}(\mathbf{v}_{K-2}^{*})$ . Such a point  $\mathbf{v}_{K}^{*}$  is called *a fixed point* of the mapping  $T_{i} \circ (I - \mu\phi')$ , where  $I : \mathcal{H} \rightarrow \mathcal{H}, \mathbf{u} \mapsto \mathbf{u}$  denotes the identity mapping. We mention that the closed-path property is similar to the behavior of the popular method called *projection onto convex sets (POCS)* in the inconsistent case [27, Theorem 2.10-1]. Although details are omitted, the convergence can be proved

by showing (i) the existence of a fixed point and (ii) the Lipschitz continuity of the mapping  $\phi'$  (cf. [23]). (In the special case that  $N = d_i = 1$ , it is not difficult to prove that the two properties are satisfied.)

### PGM based Beam Design Algorithm

For each transmitter  $i \in \{1, \dots, K\}$ ,

- 0. Initialize  $V_i$  as the ZF beamforming matrix;
- 1. Compute  $\phi'(\mathbf{V}_i)$  using (56);
- 2. Perform a steepest descent shift of  $V_i$  using (55);
- 3. Perform successive metric projections of  $V_i$  onto  $\{E_{ji}, j \neq i\}$  and then onto  $B_i$ , (58);
- 4. Go to Step 1 and repeat until the relative difference of  $\phi_i(\mathbf{V}_i)$  is less than a predetermined threshold.

#### C. Numerical Results

In this section, we provide some numerical results for the performance of RZFCB in the MIMO case. We considered two MIMO interference channels with system parameters (K, M, N) = (3, 2, 6) and (K, M, N) = (5, 2, 10). In each case, we set  $\alpha_{ji} = 0.01, 0.1$  and 0.2 for all *i* and *j*. The step size parameter  $\lambda_n$  for the PGM was chosen to be  $\lambda_n = 0.01$  for all *n*. Figures 6 (a) and (b) show the sum rate performance of the ZFCB and RZFCB averaged over 30 independent channel realizations. It is seen that the RZFCB with the PGM outperforms the ZFCB at all SNR and the gain of the RZFCB over the ZFCB at low SNR is large. This large gain at low SNR is especially important because most cell-edge receivers operate in the low SNR regime.

#### VI. CONCLUSION

We have considered coordinated beamforming for MISO and MIMO interference channels under the RZF paradigm. In the MISO case, we have revealed that the SOPC strategy with a set of well chosen interference relaxation levels is Pareto-optimal from the overall rate perspective. We have provided closed-form solutions for the SOPC strategy in the cases of two and three users and the SOPC algorithm for the case of more than three users for a given set of interference relaxation levels. In the MIMO case, we have formulated the RZFCB problem as a distributed optimization problem based on a newly derived rate lower bound and have provided an algorithm based on the PGM to solve the MIMO RZFCB beam design problem. We have also considered the rate control problem under the RZFCB framework and have provided a centralized approach and a fully-distributed heuristic approach to control the rate-tuple location along the Pareto boundary of the achievable rate region. Numerical results validate our new CB

paradigm and show both the achievability of Pareto optimality and the controllability of the rate-tuple by the RZFCB scheme.

## APPENDIX

Consider general K. The virtual SINR (or SLNR) method maximizes the following quantity for transmitter i under the power constraint  $||\mathbf{v}_i||^2 = P_i$ :

$$\frac{|\mathbf{h}_{ii}^{H}\mathbf{v}_{i}|^{2}}{\sigma_{i}^{2} + \sum_{j\neq i}\gamma_{ji}|\mathbf{h}_{ji}^{H}\mathbf{v}_{i}|^{2}} = \frac{\mathbf{v}_{i}^{H}(\mathbf{h}_{ii}\mathbf{h}_{ii}^{H})\mathbf{v}_{i}}{\mathbf{v}_{i}^{H}(\frac{\sigma_{i}^{2}}{P_{i}}\mathbf{I} + \sum_{j\neq i}\gamma_{ji}\mathbf{h}_{ji}\mathbf{h}_{ji}^{H})\mathbf{v}_{i}},$$
(59)

where  $\gamma_{ji} \ge 0$ . This is an SINR maximization problem. Thus, the solution is given by the whitened matched filter:

$$\mathbf{v}_{i}^{VSINR} = c \left( \frac{\sigma_{i}^{2}}{P_{i}} \mathbf{I} + \sum_{j \neq i} \gamma_{ji} \mathbf{h}_{ji} \mathbf{h}_{ji}^{H} \right)^{-1} \mathbf{h}_{ii}, \tag{60}$$

but Zhang and Cui have shown in [12] that the MISO RZFCB solution has the form (60) by solving Problem 2 directly instead of equivalent Problem 3. In their work, they have shown that  $\{\gamma_{ji}\}$  are nonnegative Lagrange dual variables associated with Problem 2. Thus, the solution sets of the virtual SINR (or SLNR) method and the RZFCB method are the same, and by Theorem 1, the virtual SINR method can achieve any point on the Pareto boundary of the achievable rate region with properly chosen nonnegative parameters  $\{\gamma_{ji}\}$  in the case of general K. However, the parameterization in terms of  $\{\gamma_{ji}\}$  in the ratio in (59) does not provide as concrete insights or heuristics for rate control as the parameterization in terms of  $\{\alpha_{ji}\}\$  in the RZFCB framework (Problem 2 or Problem 3). See Section IV for the advantages of the RZF parameterization.
