## ON THE NEW INTERSECTION THEOREM FOR TOTALLY REFLEXIVE MODULES

ABSTRACT. Let  $(R, \mathfrak{m}, k)$  be a local ring. We establish a totally reflexive analogue of the New Intersection Theorem, provided for every totally reflexive  $R$ -module  $M$ , there is a big Cohen-Macaulay R-module  $B_M$  such that the socle of  $B_M \otimes_R M$  is zero. When R is a quasi-specialization of a G-regular local ring or when  $M$  has complete intersection dimension zero, we show the existence of such a big Cohen-Macaulay  $R$ -module. It is conjectured that if  $R$  admits a non-zero Cohen-Macaulay module of finite Gorenstein dimension, then it is Cohen-Macaulay. We prove this conjecture if either R is a quasi-specialization of a G-regular local ring or a quasi-Buchsbaum local ring.

#### 1. INTRODUCTION

Throughout,  $(R, \mathfrak{m}, k)$  is a commutative Noetherian local ring with identity. The celebrated New Intersection Theorem is perceived as a deep result at the interface of homological and local algebra. It provides simple proofs for several outstanding homological conjectures e.g. Auslander's zero-divisor conjecture [\[Ro,](#page-12-0) Theorem 6.2.3] and Bass' conjecture [\[PS,](#page-12-1) Theorem 5.1]. The New Intersection Theorem was proved in prime characteristic by Peskine and Szpiro [\[PS\]](#page-12-1) in 1973. Then Hochster's works [\[H1\]](#page-12-2) and [\[H2\]](#page-12-3) established a reduction to prime characteristic from equicharacteristic zero to give a proof of this theorem in every equicharacteristic ring in 1975. Finally, in 1987, Roberts [\[Ro\]](#page-12-0) proved the New Intersection Theorem for mixed characteristic rings by using local Chern characters.

The New Intersection Theorem asserts that if

$$
0 \longrightarrow F_s \longrightarrow F_{s-1} \longrightarrow \cdots \longrightarrow F_1 \longrightarrow F_0 \longrightarrow 0
$$

is a non-exact complex of finitely generated free R-modules with finite length homology modules, then  $\dim R \leq s$ . Using the New Intersection Theorem, one can easily see that if R admits a non-zero Cohen-Macaulay module with  $\text{pd}_{R} M < \infty$ , then R must be Cohen-Macaulay.

One of the most important notions in Gorenstein homological algebra is that of totally reflexive modules, which was defined by Auslander [\[Au\]](#page-12-4). The local ring  $(R, \mathfrak{m}, k)$  is Gorenstein if and only if k admits a finite resolution by totally reflexive R-modules. On the other hand, over a Gorenstein local ring, the totally reflexive modules are precisely the maximal Cohen-Macaulay modules. From this perspective,

over a Gorenstein local ring, a totally reflexive module is regarded as a common generalization of a finitely generated free module and a maximal Cohen-Macaulay module. Since many results in classical homological algebra have counterparts in Gorenstein homological algebra, the following questions are raised naturally:

<span id="page-1-0"></span>*Question* 1.1. Let  $(R, \mathfrak{m}, k)$  be a local ring. Assume that

$$
0 \longrightarrow G_s \longrightarrow G_{s-1} \longrightarrow \cdots \longrightarrow G_1 \longrightarrow G_0 \longrightarrow 0
$$

is a non-exact complex of totally reflexive R-modules with finite length homology modules. Is dim  $R \leq$ s?

<span id="page-1-1"></span>*Question* 1.2*.* Let  $(R, \mathfrak{m}, k)$  be a local ring. Assume that R admits a non-zero Cohen-Macaulay module of finite Gorenstein dimension. Is R Cohen-Macaulay?

Question 1.2 was asked in [\[C1,](#page-12-5) page 40], [\[CFH,](#page-12-6) Question 1.31] and [\[T2\]](#page-13-0). This question has been studied by many authors; see e.g. [\[T3\]](#page-13-1), [\[T2\]](#page-13-0), [\[GHT\]](#page-12-7) and [\[DMT\]](#page-12-8).

This paper is concerned with the study of these questions. Note that Question 1.1 easily implies Question 1.2. Theorems [2.4,](#page-3-0) [2.7](#page-5-0) and [3.6](#page-10-0) are the main results of this paper. Let

$$
G = 0 \longrightarrow G_s \longrightarrow G_{s-1} \longrightarrow \cdots \longrightarrow G_1 \longrightarrow G_0 \longrightarrow 0
$$

be a non-exact complex of totally reflexive  $R$ -modules with finite length homologies. In Theorem [2.4,](#page-3-0) we show that dim  $R \leq s$ , provided for every totally reflexive R-module M, there is a big Cohen-Macaulay R-module  $B_M$  such that the socle of  $B_M \otimes_R M$  is zero. We show the existence of such a big Cohen-Macaulay R-module when  $R$  is a quasi-specialization of a G-regular local ring or when  $M$  has complete intersection dimension zero; see Theorem [2.7.](#page-5-0) Also in Corollary [2.8,](#page-6-0) we show that if CI–dim<sub>R</sub>  $G < \infty$ , then dim  $R \leq s$ . Note that this generalizes the New Intersection Theorem without imposing any extra assumption on the ring R. The notion of G-regular rings was introduced by Ryo Takahashi in [\[T1\]](#page-13-2). In Remark [2.9,](#page-7-0) we provide many examples of quasi-specializations of G-regular rings which are neither G-regular nor Cohen-Macaulay. We provide an affirmative answer to Question 1.2 in the cases  $R$  is a quasi-specialization of a G-regular local ring or a quasi-Buchsbaum local ring; see Corollary [3.1](#page-8-0) and Theorem [3.6.](#page-10-0)

#### 2. QUESTION 1.1

In this section, we are dealing with Question [1.1.](#page-1-0) Let us begin by recalling some needed definitions.

For an R-complex X, we set inf  $X := \inf\{i \in \mathbb{Z} \mid H_i(X) \neq 0\}$  and  $\sup X := \sup\{i \in \mathbb{Z} \mid H_i(X) \neq 0\}$ . We obey the convention that the infimum and supremum of the empty set are  $+\infty$  and  $-\infty$ ; respectively. In the sequel, we use "  $\simeq$  " for denoting a quasi-isomorphism between two complexes. An R-complex X is said to be *homologically finite* if every homology module of X is finitely generated and  $H_i(X) = 0$ for every  $|i| \gg 0$ . Finally, *dimension* of an R-complex X is defined as:

$$
\dim_R X := \sup \{ \dim_R H_i(X) - i \mid i \in \mathbb{Z} \}.
$$

Definition 2.1. i) A finitely generated R-module M is said to be *totally reflexive* if there exists an exact complex

$$
F = \cdots \to F_2 \stackrel{d_2}{\to} F_1 \stackrel{d_1}{\to} F_0 \stackrel{d_0}{\to} F_{-1} \to \cdots,
$$

of finitely generated free R-modules such that  $\text{Hom}_R(F, R)$  is exact and  $M \cong \text{im } d_0$ . Such an Rcomplex F is called a *complete free resolution* of M. For each integer i, we set  $Syz_i^F(M) := \text{im } d_i$ .

ii) For a homologically finite R-complex  $M$ , the *Gorenstein dimension* of  $M$ ,  $G-\dim_R M$ , is defined as the infimum of all integers  $n$  such that there exists a complex

$$
0 \longrightarrow G_n \longrightarrow G_{n-1} \longrightarrow \cdots \longrightarrow G_{l+1} \longrightarrow G_l \longrightarrow 0
$$

of totally reflexive R-modules with  $G \simeq M$  and  $G_n \neq 0$ .

iii) The class of all totally reflexive R-modules is denoted by  $G(R)$ . The ring R is said to be G-*regular* if every R-module  $M \in G(R)$  is free.

Every finitely generated projective module is totally reflexive. So for a finitely generated R-module M, one has  $G-\dim_R M \leq \mathrm{pd}_R M$ , moreover, equality holds if either R is G-regular or  $\mathrm{pd}_R M < \infty$ ; see [\[T1,](#page-13-2) Proposition 1.8 (2)] and [\[C1,](#page-12-5) Proposition 1.2.10].

Recall that an R-module B is called *big Cohen-Macaulay* if there exists a system of parameters  $\mathbf{x} = x_1, \ldots, x_n$  for R such that **x** is a B-regular sequence. If every system of parameters for R is a B-regular sequence, then B is called *balanced big Cohen-Macaulay*. Recently, André [\[An\]](#page-12-9) shows that any local ring R possesses a big Cohen-Macaulay module which is an R-algebra. Note that, by [\[BH,](#page-12-10) Corollary 8.5.3], if B is a big Cohen-Macaulay R-module, then  $\widehat{B}$ , the m-adic completion of B, is a balanced big Cohen-Macaulay R-module.

**Lemma 2.2.** *Let*  $(R, \mathfrak{m}, k)$  *be a local ring and* B *a big Cohen-Macaulay* R-module. Then  $B \otimes_R M \neq 0$ *for every non-zero finitely generated* R*-module* M*.*

**Proof.** Set  $d := \dim R$  and let  $\mathbf{x} = x_1, \dots, x_d \in \mathfrak{m}$  be a system of parameters for R such that  $\mathbf{x}$  is a B-regular sequence. Thus  $B/(\mathbf{x})B \neq 0$  and then we can easily verify that  $B/\mathfrak{m}B \neq 0$ . Hence

$$
k \otimes_R (B \otimes_R M) \cong B/\mathfrak{m} B \otimes_k M/\mathfrak{m} M \neq 0,
$$

for every non-zero finitely generated  $R$ -module  $M$ .

Recall that for a not necessarily finitely generated R-module M, the *depth* of M is defined by

$$
\operatorname{depth}_R M := \inf\{i \in \mathbb{N}_0 \mid \operatorname{Ext}_R^i(k, M) \neq 0\}.
$$

(Note that by our convention on the infimum of the empty set, we have depth<sub>R</sub>  $0 = +\infty$ .) By [\[St,](#page-12-11) Theorem 6.1.6], this definition coincides with [\[BH,](#page-12-10) Definition 9.1.1].

Next, we recall the Peskine-Szpiro Acyclicity Lemma.

<span id="page-2-0"></span>**Lemma 2.3.** *Let*  $(R, \mathfrak{m}, k)$  *be a local ring. Let* 

$$
Y := 0 \longrightarrow Y_s \longrightarrow Y_{s-1} \longrightarrow \cdots \longrightarrow Y_1 \longrightarrow Y_0
$$

*be a complex of* R-modules such that for each  $i = 1, \ldots, s$ , one has depth  $Y_i \geq i$  and either  $H_i(Y) = 0$ *or* depth<sub>R</sub>(H<sub>i</sub>(Y)) = 0*. Then* H<sub>i</sub>(Y) = 0 *for each*  $i \geq 1$ *.* 

Proof. See e.g. [\[St,](#page-12-11) Proposition 1.1.1].

For an R-module M, its *socle* is defined as  $Soc(M) := (0 :_M \mathfrak{m})$ .

Let X be an R-complex such that the R-module  $H_i(X)$  is finitely generated for every i and  $H_i(X) = 0$ for every  $i \ll 0$ . Set  $t := \inf X$ . By [\[C1,](#page-12-5) Theorem A.3.2 (L)], there is a complex

 $F := \cdots \longrightarrow F_i \longrightarrow F_{i-1} \longrightarrow \cdots \longrightarrow F_{t+1} \longrightarrow F_t \longrightarrow 0$ 

of finitely generated free R-modules such that  $F \simeq X$ . A such complex F is called a free resolution of X.

We are ready to present our first main result in this section.

<span id="page-3-0"></span>Theorem 2.4. *Let* (R, m, k) *be a local ring. Assume that to each totally reflexive* R*-module* G*, a big Cohen-Macaulay* R-module  $B_G$  *is assigned such that*  $Soc(B_G \otimes_R G) = 0$ *. Then existences of a non-exact complex*

$$
\mathcal{G} := 0 \to G_s \to G_{s-1} \to \cdots \to G_0 \to 0,
$$

*of finite length homologies and consisting of totally reflexive* R-modules, yields  $s \geq \dim R$ .

**Proof.** By considering the free resolution of the complex  $\mathcal{G}$  and applying [\[C1,](#page-12-5) Theorem 2.3.7], we may reduce to the special case that

$$
\mathcal{G} := 0 \to G \to F_{s-1} \to F_{s-2} \to \cdots \to F_0 \to 0
$$

for some finite free modules  $F_0, \ldots, F_{s-1}$ , as well as a totally reflexive module G. Let  $Spec(R)^\circ$  denote, the punctured spectrum of R,  $Spec(R) \setminus \{\mathfrak{m}\}\$ and  $(-)^*$  denote the R-dual functor  $Hom_R(-, R)$ .

Since all homology modules of  $G$  have finite length, it turns out that  $G$  is locally split-exact on  $Spec(R)^\circ$ , and so G is locally free on  $Spec(R)^\circ$ . As G is locally split-exact on  $Spec(R)^\circ$ , it follows that  $\mathcal{G}^*$  is also locally split-exact on Spec $(R)^\circ$ , and so all of its homology modules have finite length. If  $\mathcal{G}^*$ is exact, then we would have  $\text{pd}_R(G^*) < \infty$ , so  $G^*$  and thus G would be free implying that  $s \ge \dim R$ , by the miracle of the New Intersection Theorem. Hence, it suffices to consider only the case where  $\mathcal{G}^*$ is non-exact. If necessary, we may replace  $\mathcal{G}^*$  with the complex

$$
0 \to F_0^* \to \cdots \to F_{s-3}^* \to F_{s-2}^* \to \ker(F_{s-1} \to G^*) \to 0,
$$

and so on, to impose the condition  $F_{s-1}^* \to G^*$  has non-zero finite length cokernel. Pick a big-Cohen-Macaulay module  $R$ -module  $B := B_{G^*}$  such that  $Soc(B \otimes_R G^*) = 0$ . Lemma 2.2 implies that

$$
H_0(B \otimes_R \mathcal{G}^*) = B \otimes_R H_0(\mathcal{G}^*) \neq 0,
$$

and so the complex  $B \otimes_R \mathcal{G}^*$  is non-exact. It has the form

$$
\mathcal{C}_{\bullet} = 0 \to C_{s+1} := B^{n_0} \to C_s := B^{n_1} \to \cdots \to C_2 = B^{n_{s-1}} \to C_1 = B \otimes_R G^* \to C_0 = 0.
$$

Since the complex  $\mathcal{C}_{\bullet}$  is locally split-exact on  $Spec(R)^{\circ}$ , all of its homology modules are either zero or of depth zero. In case,  $s \leq \dim R - 1$ , then we have depth<sub>R</sub>  $C_i \geq i$  for every  $i \geq 1$ , so we may apply Lemma [2.3](#page-2-0) to conclude that the complex  $C_{\bullet}$  is exact which is a contradiction.

Now, we provide a sufficient condition for satisfying the assumption of Theorem [2.4.](#page-3-0) Also, it will be used in the proof of Theorem [2.7.](#page-5-0)

$$
\Box
$$

<span id="page-4-0"></span>**Lemma 2.5.** *Let*  $(R, \mathfrak{m}, k)$  *be a local ring,* M *a totally reflexive* R-module and  $\ell$  *an integer with*  $1 \leq \ell \leq$  $\dim R$ *. Let*  $\text{Syz}_{i}^{F}(M)$  *be as in Definition 2.1. Assume that there exists a big Cohen-Macaulay*  $R$ *-module*  $B_M$  such that  $\operatorname{Tor}_1^R(B_M, \operatorname{Syz}_{-i}^F(M)) = 0$  for all  $1 \leq i \leq \ell$ . Then  $\operatorname{depth}_R(B_M \otimes_R M) \geq \ell$ .

**Proof.** Set  $d := \dim R$  and  $B := B_M$ . By [\[BH,](#page-12-10) Exercise 9.1.12 (a),(b)] for every R-module X with  $X \neq \mathfrak{m}X$ , one has depth $\mathfrak{h}_RX \leq d$  and depth $\mathfrak{h}_R 0 = +\infty$ . Also, by [\[BH,](#page-12-10) Proposition 9.1.2 (e)] every short exact sequence

$$
0 \longrightarrow X \longrightarrow Y \longrightarrow Z \longrightarrow 0,
$$

yields an inequality

$$
\operatorname{depth}_R X \ge \min\{\operatorname{depth}_R Y, \operatorname{depth}_R Z + 1\}. \tag{\dagger}
$$

Since  $M$  is totally reflexive, there exists an exact complex

$$
F = \cdots \to F_2 \stackrel{d_2}{\to} F_1 \stackrel{d_1}{\to} F_0 \stackrel{d_0}{\to} F_{-1} \to \cdots,
$$

of finitely generated free modules such that  $\text{Hom}_R(F, R)$  is exact and  $M \cong \text{im } d_0$ . By the assumption, we have the short exact sequences

$$
0 \longrightarrow B \otimes_R \text{Syz}_{1-i}^F(M) \longrightarrow B \otimes_R F_{-i} \longrightarrow B \otimes_R \text{Syz}_{-i}^F(M) \longrightarrow 0
$$

for all  $1 \leq i \leq \ell$ . Note that  $B \otimes_R \mathrm{Syz}_0^F(M) \cong B \otimes_R M$ . We may and do assume that  $M \neq 0$ .

First, assume that

$$
\mathrm{depth}_R(B \otimes_R \mathrm{Syz}_{-i}^F(M)) + 1 < d
$$

for all  $1 \leq i \leq \ell$ . Since  $\operatorname{depth}_R B = \dim R$ , applying (†) to the short exact sequences

$$
0 \longrightarrow B\otimes_R \operatorname{Syz}_{1-i}^F(M) \longrightarrow B\otimes_R F_{-i} \longrightarrow B\otimes_R \operatorname{Syz}_{-i}^F(M) \longrightarrow 0; \ \ i=1,\ldots,\ell,
$$

successively yields that

$$
\begin{aligned} \n\operatorname{depth}_R(B \otimes_R M) &\geq \operatorname{depth}_R(B \otimes_R \operatorname{Syz}_{-1}^F(M)) + 1 \\ \n&\geq \operatorname{depth}_R(B \otimes_R \operatorname{Syz}_{-2}^F(M)) + 1 + 1 \\ \n&\vdots \\ \n&\geq \operatorname{depth}_R(B \otimes_R \operatorname{Syz}_{-\ell}^F(M)) + 1 + \ell - 1 \\ \n&\geq \ell. \n\end{aligned}
$$

Next, assume that there is an integer  $1 \leq i \leq \ell$  such that

$$
d \leq \mathrm{depth}_R(B \otimes_R \mathrm{Syz}_{-j}^F(M)) + 1,
$$

and set

$$
s := \inf\{i \in \{1, 2, \dots, \ell\} \mid d \leq \operatorname{depth}_R(B \otimes_R \operatorname{Syz}_{-i}^F(M)) + 1\}.
$$

By repeating the above inequalities  $s$  times, we get

$$
\mathrm{depth}_R (B \otimes_R M) \ge d + s - 1 \ge \ell + s - 1 \ge \ell.
$$

Next, we recall the definition of complete intersection dimension; see [\[AGP\]](#page-12-12) and [\[Sa\]](#page-12-13).

 $\Box$ 

**Definition 2.6.** Let  $(R, \mathfrak{m}, k)$  be a local ring.

- i) A *deformation* is a surjective homomorphism of local rings  $R \leftarrow A$  with the kernel generated by an A-sequence. In this situation, we say R is a *specialization* of A.
- ii) A *quasi-deformation* is a diagram of local homomorphisms  $R \to R' \leftarrow A$  such that the first map is flat and the second map is a deformation. In this situation, we say R is a *quasi-specialization* of A.
- iii) For a homologically finite R-complex  $M$ , *complete intersection dimension* of  $M$ , CI–dim<sub>R</sub>  $M$ , is defined as

 $\text{CI-dim}_R M := \inf \{ \text{pd}_A(R' \otimes_R M) - \text{pd}_A R' \mid R \to R' \leftarrow A \text{ is a quasi-deformation} \}.$ 

For a homologically finite  $R$ -complex  $M$ , [\[Sa,](#page-12-13) Proposition 3.3] implies that

 $\operatorname{G-dim}_R M \leq \operatorname{CI-dim}_R M \leq \operatorname{pd}_R M$ 

and if one of these dimensions is finite, then it equals those to its left.

The next is our second main result in this section.

<span id="page-5-0"></span>**Theorem 2.7.** *Let*  $(R, \mathfrak{m}, k)$  *be a local ring.* 

- i) *Assume that* M *is a finitely generated* R-module with  $CI$ -dim<sub>R</sub>  $M = 0$ . Then there is a balanced *big Cohen-Macaulay* R-module  $B_M$  *such that* depth $_R(B_M \otimes_R M) \geq \dim R$ .
- ii) *Assume that* A *is a* G-regular local ring and there is a quasi-deformation  $R \to R' \leftarrow A$ *. Then, there is a balanced big Cohen-Macaulay* R-module B such that  $\text{depth}_R(B \otimes_R M) \geq \dim R$  for *every totally reflexive* R*-module* M*.*

**Proof.** i) In view of Lemma [2.5,](#page-4-0) it would be enough to show that there is a balanced big Cohen-Macaulay R-module  $B_M$  such that  $\text{Tor}_1^R(B_M, \text{Syz}_i^F(M)) = 0$  for all  $1 \le i \le \dim R$ . Since CI-dim<sub>R</sub>  $M =$ 0, there exists a quasi-deformation  $R \to R' \leftarrow A$  such that

$$
\mathrm{pd}_A(R'\otimes_R M)=\mathrm{pd}_A(R')<\infty.
$$

As  $M \in G(R)$ , it possesses a complete free resolution

$$
F = \cdots \to F_2 \stackrel{d_2}{\to} F_1 \stackrel{d_1}{\to} F_0 \stackrel{d_0}{\to} F_{-1} \to \cdots.
$$

By [\[CFH,](#page-12-6) Lemma 1.1], we can easily see that the R'-complex  $F' := R' \otimes_R F$  is a complete free resolution of the R'-module  $M' := R' \otimes_R M$ . In particular, M' is a totally reflexive R'-module.

Let  $B_A$  be a balanced big Cohen-Macaulay A-module. There exists an A-regular sequence  $\mathbf{x}$  :=  $x_1, \ldots, x_\ell$ , such that  $R' = A/(\mathbf{x})A$ . Then, it is routine to check that  $B_M := B_A/(\mathbf{x})B_A$  is a balanced big Cohen-Macaulay R'-module. Namely, let  $(T, \mathfrak{n})$  be a local ring and  $\mathbf{z} := z_1, z_2, \ldots, z_r \in \mathfrak{n}$ . By [\[BH,](#page-12-10) Proposition A.4], one knows that z is part of a system of parameters of T if and only if dim  $T/(\mathbf{z}) =$  $\dim T - r$ . Also for a finitely generated R-module N, [\[BH,](#page-12-10) Theorem A.11] implies that

$$
\dim_{R'}(R'\otimes_R N)=\dim_R N+\dim_{R'}R'/\mathfrak{m}R'.
$$

Putting these two facts together, we can see that a system of parameters of R maps to a part of a system of parameters for  $R'$ , and so  $B_M$  is also a balanced big Cohen-Macaulay R-module.

Let  $i \in \mathbb{N}_0$  and set  $N := \text{Syz}_{-i}^{F'}$  $F'_{-i-d}(M')$ , where  $d := \dim A$ . Then  $Syz_{-i}^{F'}$  $\frac{F'}{-i}(M') = \mathrm{Syz}_d^{F'}$  $_d^F(N)$ . Since  $pd_A$   $M' < \infty$  and  $pd_A$   $R' < \infty$ , from the exact sequence

$$
0 \to M' \to R' \otimes_R F_{-1} \to \cdots \to R' \otimes_R F_{-i-d} \to N \to 0,
$$

we deduce that  $pd_A N < \infty$ . By the Auslander-Buchsbaum formula, it turns out that  $pd_A N \leq d$ . Let G be a free resolution of the A-module  $B_A$ . By [\[BH,](#page-12-10) Proposition 1.1.5], we conclude that  $G \otimes_A R'$  is a free resolution of the R'-module  $B_M$ . Let L be a free resolution of the R-module  $Syz_{-i}^F(M)$ . As R' is a faithfully flat R-algebra, it turns out that  $R' \otimes_R L$  is a free resolution of the  $R'$ -module  $R' \otimes_R \mathrm{Syz}_{-i}^F(M)$ . Now, one has

$$
\operatorname{Tor}_{1}^{R}(B_{M}, \operatorname{Syz}_{-i}^{F}(M)) \cong \operatorname{H}_{1}(B_{M} \otimes_{R} L)
$$
  
\n
$$
\cong \operatorname{Tor}_{1}^{R'}(B_{M}, R' \otimes_{R} \operatorname{Syz}_{-i}^{F}(M))
$$
  
\n
$$
\cong \operatorname{Tor}_{1}^{R'}(B_{M}, R' \otimes_{R} \operatorname{Syz}_{-i}^{F}(M'))

ii) There exits an A-regular sequence  $\mathbf{x} := x_1, \ldots, x_\ell$  such that  $R' = A/(\mathbf{x})A$ . Let  $B_A$  be a balanced big Cohen-Macaulay A-module and set  $B := B_A/(\mathbf{x})B_A$ . Then, as we saw above, B is a balanced big Cohen-Macaulay R-module.

Let M be a totally reflexive R-module and set  $M' := R' \otimes_R M$ . As we saw above, by the assumption  $M \in G(R)$ , it turns out that the R'-module M' is totally reflexive. Then, [\[AB,](#page-12-14) Corollary 4.33] implies that G-dim<sub>A</sub>  $M' < \infty$ . This implies that  $\text{pd}_A M' < \infty$ , because A is assumed to be G-regular. Now, by considering  $B$  instead of  $B_M$ , we can mimic the argument given in the part (i) to conclude that  $\text{Tor}_{1}^{R}(B,M) = 0.$  This completes the argument by Lemma [2.5.](#page-4-0)

Now, we record the following corollary. Although it can be proved by applying Theorems [2.4](#page-3-0) and [2.7,](#page-5-0) we present a direct argument for its first two parts. We thank an anonymous reader who suggested us this proof.

<span id="page-6-0"></span>Corollary 2.8. *Let* (R, m, k) *be a local ring and let*

 $G = 0 \longrightarrow G_s \longrightarrow G_{s-1} \longrightarrow \cdots \longrightarrow G_0 \longrightarrow 0$ 

*be a non-exact complex of totally reflexive* R*-modules with finite length homologies. Assume that either of the following conditions is satisfied:*

- i) CI–dim<sub>R</sub>  $G < \infty$ ; or
- ii) R *is a quasi-specialization of a* G*-regular local ring; or*

iii) R *is Cohen-Macaulay.*

*Then* dim  $R \leq s$ *.* 

**Proof.** i) As CI–dim<sub>R</sub>  $G < \infty$ , there is a quasi-deformation  $R \to R' \leftarrow A$  such that CI–dim<sub>R</sub>  $G =$  $\text{pd}_A(R' \otimes_R G) - \text{pd}_A R'$ . By localizing at a minimal prime ideal of  $\mathfrak{m}R'$ , we may and do assume that  $R'/\mathfrak{m}R'$  is Artinian. In particular, dim  $R' = \dim R$ . Since G has homology of finite length over R and  $R'/\mathfrak{m}R'$  is Artinian, [\[BH,](#page-12-10) Theorem A.11] yields that  $R' \otimes_R G$  has homology of finite length over  $R'$  and over A. In particular,  $\dim_A(R' \otimes_R G) \leq 0$ . So, [\[F,](#page-12-15) Lemma 4.2], whose proof is an application of the existence of Big Cohen-Macaulay modules, implies that dim  $A \leq \text{pd}_{A}(R' \otimes_{R} G)$ . Now, we have:

$$
\dim R = \dim R'
$$
  
= 
$$
\dim A - \mathrm{pd}_A R'
$$
  

$$
\leq \mathrm{pd}_A (R' \otimes_R G) - \mathrm{pd}_A R'
$$
  
= 
$$
\mathrm{CI} - \dim_R G
$$
  
= 
$$
\mathrm{G} - \dim_R G
$$
  

$$
\leq s.
$$

ii) Assume that there is a quasi-deformation  $R \to R' \leftarrow A$  in which A is G-regular. As A is G-regular, one has  $G-\dim_A(R'\otimes_R G) = \text{pd}_A(R'\otimes_R G)$ . Thus applying [\[C1,](#page-12-5) Theorem 2.3.12] and [\[C2,](#page-12-16) Corollary 5.11] yield that

$$
pd_{A}(R' \otimes_{R} G) - pd_{A} R' = G - dim_{A}(R' \otimes_{R} G) - pd_{A} R'
$$

$$
= G - dim_{R'}(R' \otimes_{R} G)
$$

$$
= G - dim_{R} G.
$$

Therefore  $\text{CI}-\dim_B G < \infty$ , and so the assertion follows by i).

iii) It is obvious by Theorem 2.4. Note that if  $R$  has positive dimension, then by the Auslander-Bridger formula all totally reflexive R-modules have positive depth.  $\square$ 

The following result indicates that the class of quasi-specializations of G-regular local rings is quite big.

<span id="page-7-0"></span>*Remark* 2.9. Let  $(S, \mathfrak{m}_{S}, k)$  and  $(T, \mathfrak{m}_{T}, k)$  be two commutative Noetherian local rings with a common residue field k. Let  $\pi_S : S \longrightarrow k$  and  $\pi_T : T \longrightarrow k$  denote the natural epimorphisms and

$$
U := \{ (s, t) \in S \times T \mid \pi_S(s) = \pi_T(t) \}.
$$

Then U, by the natural pointwise multiplication, is a commutative Noetherian local ring which is called the fiber product ring of  $S$  and  $T$ .

- i) If U is not Gorenstein, then it is G-regular; see [\[NS,](#page-12-17) Corollary 4.7].
- ii) By [\[NTSV,](#page-12-18) Fact 2.2], the ring  $U$  is Cohen-Macaulay if and only if  $S$  and  $T$  are Cohen-Macaulay and  $\dim S = \dim T \leq 1$ . So, there are plenty of examples of non-Cohen-Macaulay G-regular rings.
- iii) Let  $(R, \mathfrak{m}, k)$  be a G-regular local ring and  $x \in \mathfrak{m}$  an R-regular element. By [\[T1,](#page-13-2) Proposition 4.6], the ring  $R/xR$  is G-regular if and only if  $x \notin \mathfrak{m}^2$ . Thus, there are plenty of examples of quasi-specializations of G-regular rings which are neither G-regular nor Cohen-Macaulay.
- iv) By [\[AM,](#page-12-19) Example 3.5 (2)], every Golod local ring which is not a hypersurface is G-regular.
- v) Let  $(R, \mathfrak{m}, k)$  be a non-Cohen-Macaulay local ring. Assume that  $x_1, x_2, \ldots, x_n \in \mathfrak{m}$  form an R-regular sequence such that  $\mathfrak{m}/(x_1, x_2, \ldots, x_n)$  is decomposable. Then  $R/(x_1, x_2, \ldots, x_n)$  is a non-Cohen-Macaulay G-regular local ring; see [\[Og,](#page-12-20) Lemma 3.1] or [\[NT,](#page-12-21) Fact 3.1].

Next, we present an example of a big Cohen-Macaulay R-module B and a totally reflexive R-module G such that  $\operatorname{Soc}(B \otimes_R G) \neq 0$ .

*Example* 2.10*.* Let  $R := k[[X, Y]]/(XY)$ , where k is a field. Then R is a Gorenstein complete local ring of dimension one. Denote by x and y the residue classes of X and Y in R and set  $B := R/(x)$  and  $G := R/(y)$ . We can easily check that B and G are maximal Cohen-Macaulay R-modules, and so both B and G are totally reflexive. Now, as  $B \otimes_R G \cong k$ , we have  $\text{Soc}(B \otimes_R G) \neq 0$ .

### 3. Question 1.2

This section deals with Question [1.2.](#page-1-1) As, we have already mentioned Question 1.1 easily implies Question 1.2. So, we begin with recording the following consequence of Corollary [2.8](#page-6-0) ii).

<span id="page-8-0"></span>Corollary 3.1. *Let* R *be a quasi-specialization of a* G*-regular local ring. If* R *admits a non-zero Cohen-Macaulay module* M *with finite Gorenstein dimension, then* R *is Cohen-Macaulay.*

**Proof.** Suppose that  $x := x_1, \ldots, x_t \in \mathfrak{m}$  is a maximal M-regular sequence. Then the R-module  $M/(\mathbf{x})M$  has finite length and [\[Av,](#page-12-22) Theorem 8.7.7] implies that

$$
\operatorname{G-dim}_{R} M/(\mathbf{x})M = \operatorname{G-dim}_{R} M + t.
$$

Hence, we may and do assume that M has finite length. Set  $s := \text{depth } R$ . By the Auslander-Bridger formula, one has

$$
\operatorname{G-dim}_R M = \operatorname{depth} R - \operatorname{depth}_R M = s,
$$

and so there is a non-exact complex

$$
G=0\longrightarrow G_s\longrightarrow\cdots\longrightarrow G_0\longrightarrow 0
$$

of totally reflexive R-modules such that  $G \simeq M$ . Now by Corollary [2.8](#page-6-0) ii), it turns out that dim  $R \leq s$ , and so R is Cohen-Macaulay.  $\square$ 

Next, we provide an affirmative answer to Question [1.2](#page-1-1) in the case  $R$  is quasi-Buchsbaum. First, we recall definition of quasi-Buchsbaum rings.

**Definition 3.2.** Let  $(R, \mathfrak{m}, k)$  be a local ring.

i) A sequence  $x_1, x_2, \ldots, x_r \in \mathfrak{m}$  is called a *weak* R-sequence if

 $\langle x_1, x_2, \ldots, x_{i-1} \rangle : R x_i = \langle x_1, x_2, \ldots, x_{i-1} \rangle : R \mathfrak{m}$ 

for every  $i = 1, 2, \ldots, r$ .

ii) The local ring R is said to be *quasi-Buchsbaum* if every system of parameters of R in  $\mathfrak{m}^2$  is a weak R-sequence.

To prove the main result of this section, we need the following three lemmas.

<span id="page-9-1"></span>Lemma 3.3. *Let* (R, m, k) *be a local ring. Then the following are equivalent:*

- i) *There is a system of parameters of* R *contained in* m<sup>2</sup> *which is a weak* R*-sequence.*
- ii) R *is quasi-Buchsbaum.*
- iii)  $\mathfrak{m}H_{\mathfrak{m}}^{i}(R) = 0$  *for all*  $i = 0, ..., \dim R 1$ *.*

**Proof.** See [\[SV,](#page-12-23) Proposition 2.1]. □

<span id="page-9-0"></span>**Lemma 3.4.** *Let*  $(R, \mathfrak{m}, k)$  *be a quasi-Buchsbaum local ring. For every*  $R$ *-regular sequence*  $x_1, x_2, \ldots, x_t \in$  $\mathfrak{m}^2$ , the local ring  $R/\langle x_1, x_2, \ldots, x_t \rangle$  is quasi-Buchsbaum.

**Proof.** Set  $\overline{R} := R/(x_1, x_2, \ldots, x_t)$  and let  $- : R \rightarrow \overline{R}$  denote the natural ring epimorphism. Set  $d := \dim R$  and let  $\overline{x}_{t+1}, \overline{x}_{t+2}, \ldots, \overline{x}_d \in (\mathfrak{m}\overline{R})^2$  form a system of parameters of  $\overline{R}$ . Thus,  $x_1, x_2, \ldots, x_t, x_{t+1}, \ldots, x_d \in \mathfrak{m}^2$  form a system of parameters of R. As R is quasi-Buchsbaum,  $x_1, x_2, \ldots, x_d$  is a weak R-sequence. In particular,

$$
\langle x_1, x_2, \ldots, x_{i-1} \rangle : R x_i = \langle x_1, x_2, \ldots, x_{i-1} \rangle : R \mathfrak{m}
$$

for every  $i = 1, 2, \ldots, d$ . Therefore,

$$
\langle \overline{x}_{t+1}, \overline{x}_{t+2}, \ldots, \overline{x}_{t+i-1} \rangle :_{\overline{R}} \overline{x}_{t+i} = \langle \overline{x}_{t+1}, \overline{x}_{t+2}, \ldots, \overline{x}_{t+i-1} \rangle :_{\overline{R}} \mathfrak{m} \overline{R}
$$

for every  $i = 1, 2, ..., d - t$ , and so  $\overline{R}$  is quasi-Buchsbaum.

The next result is interesting by its own right. It improves [\[As,](#page-12-24) Corollary 4.5] and [\[DHN,](#page-12-25) Lemma 5.2] by relaxing locally free assumption in [\[As,](#page-12-24) Corollary 4.5] and finite length assumption in [\[DHN,](#page-12-25) Lemma 5.2].

<span id="page-9-2"></span>**Lemma 3.5.** Let  $(R, \mathfrak{m}, k)$  be a local ring for which  $\Gamma_{\mathfrak{m}}(R)$  is a non-zero k-vectore space. Let M be a *finitely generated* R-module. Assume that,  $\Omega_{t+1}(M)$ , the  $t+1$ -th syzygy of M has finite length for some *integer*  $t \geq 2$ *. Then M is free.* 

**Proof.** Assume that R is Artinian. Since  $\Gamma_m(R)$  is a k-vector space, it follows that  $m = mR =$  $\mathfrak{m}\Gamma_{\mathfrak{m}}(R) = 0$ . Thus R is a field, and so every R-module is free. Hence, we may and do assume that  $\dim R > 0.$ 

Set  $H := \Gamma_{\mathfrak{m}}(R)$ . Choose an augmented minimal free resolution

$$
F = \cdots \to F_2 \stackrel{d_2}{\to} F_1 \stackrel{d_1}{\to} F_0 \stackrel{d_0}{\to} M \to 0
$$

of M. From the short exact sequence

$$
0 \longrightarrow H \longrightarrow R \longrightarrow R/H \longrightarrow 0, (*)
$$

we obtain the following commutative diagram with exact rows:

$$
\begin{array}{ccccccc}\n0 & \longrightarrow & F_t \otimes_R H & \longrightarrow & F_t \otimes_R R & \longrightarrow & F_t \otimes_R R/H & \longrightarrow & 0 \\
& & d_t \otimes_R H \downarrow & & d_t \otimes_R R \downarrow & & d_t \otimes_R R/H \downarrow & \\
0 & \longrightarrow & F_{t-1} \otimes_R H & \longrightarrow & F_{t-1} \otimes_R R & \longrightarrow & F_{t-1} \otimes_R R/H & \longrightarrow & 0,\n\end{array}
$$

which, in view of the Snake Lemma, yields the exact sequence

 $\Omega_{t+1}(M) \longrightarrow \text{ker}(d_t \otimes_R R/H) \longrightarrow \text{coker}(d_t \otimes_R H).$ 

By the assumption,  $\ell_R(\Omega_{t+1}(M)) < \infty$  and as  $\ell_R(H) < \infty$ , we get  $\ell_R(\text{coker}(d_t \otimes_R H)) < \infty$ . Thus  $\ell_R(\ker(d_t \otimes_R R/H)) < \infty$ . But  $F_t \otimes_R R/H$  has positive depth, and so it can not possess any non-zero Artinian submodule. Hence  $\ker(d_t \otimes_R R/H) = 0$ , and so  $\operatorname{Tor}_t^R(M, R/H) = 0$ .

Next, the long exact Tor-sequence induced by the short exact sequence (∗) implies that

$$
\operatorname{Tor}_{t-1}^R(M, H) \cong \operatorname{Tor}_t^R(M, R/H) = 0.
$$

By the assumption, H is a direct sum of finitely many copies of k. Thus  $\text{Tor}_{t-1}^R(M,k) = 0$ , and so  $pd_R M \leq t-2$ . As  $H \neq 0$ , we get depth  $R = 0$ . Therefore, the Auslander-Buchsbaum formula concludes that  $\operatorname{pd}_R M = 0$ .

Next, we present the main result of this section.

<span id="page-10-0"></span>Theorem 3.6. *Let* (R, m, k) *be a quasi-Buchsbaum local ring. Assume that* R *admits a non-zero Cohen-Macaulay module of finite Gorenstein dimension. Then* R *is Cohen-Macaulay.*

**Proof.** As we saw in the proof of Corollary [3.1,](#page-8-0) we may and do assume that R possesses a non-zero finite length module  $M$  of finite Gorenstein dimension. Since  $M$  has finite length, it is annihilated by some power  $s \geq 2$  of m. Set  $t := \text{depth } R$ . Let  $x_1, x_2, \ldots, x_t \in \mathfrak{m}^s$  be an R-regular sequence and set  $S := R/\langle x_1, x_2, \ldots, x_t \rangle$  and  $\mathfrak{n} := \mathfrak{m}/\langle x_1, x_2, \ldots, x_t \rangle$ . Then depth  $S = 0$  and, by Lemma [3.4,](#page-9-0) the local ring  $S$  is quasi-Buchsbaum.

Once we show dim  $S = 0$ , the proof will be complete. On the contrary, suppose that dim  $S > 0$ . Then Lemma [3.3](#page-9-1) yields that  $\Gamma_n(S)$  is a non-zero k-vector space. Next, [\[AB,](#page-12-14) Corollary 4.33] implies that G-dim<sub>R</sub>  $M = G$ -dim<sub>S</sub>  $M + t$ . As M has finite length, by the Auslander-Bridger formula, we conclude that  $G$ -dim<sub>R</sub>  $M = t$ , and so M is totally reflexive as an S-module.

Let

$$
F = \cdots \to F_2 \stackrel{d_2}{\to} F_1 \stackrel{d_1}{\to} F_0 \stackrel{d_0}{\to} F_{-1} \to \cdots,
$$

be a complete free resolution of the S-modules M and set  $N := \mathrm{Syz}_{-3}^F(M)$ . Hence,  $\mathrm{Syz}_{3}^F(N) = M$  and there is an exact sequence

$$
0 \to M \to F_{-1} \xrightarrow{d_{-1}} F_{-2} \xrightarrow{d_{-2}} F_{-3} \to N \to 0. \tag{\dagger}
$$

Now, Lemma [3.5](#page-9-2) implies that the S-module  $N$  is free. Hence, from  $(\dagger)$ , one deduces that the S-module M is also free. This implies that the ring S is Artinian, which is a contradiction.  $\Box$ 

Next, we propose the following natural three questions.

<span id="page-10-1"></span>*Question* 3.7. Let  $(R, \mathfrak{m}, k)$  be a local ring. Assume that R admits a non-zero totally reflexive module of finite length. Is  $R$  Artinian?

<span id="page-11-0"></span>*Question* 3.8*.* Let  $(R, \mathfrak{m}, k)$  be a local ring and M a non-zero totally reflexive R-module. Does dim<sub>R</sub>  $M =$ dim R?

As far as we know, the above question was first asked by Pham Hung Quy in MathOverflow.

*Question* 3.9. Let  $(R, \mathfrak{m}, k)$  be a local ring and M a totally reflexive R-module. Is there a big Cohen-Macaulay R-module  $B_M$  such that  $Soc(B_M \otimes_R M) = 0$ ?

<span id="page-11-1"></span>*Remark* 3.10*.* Although, we do not know the answers to these three questions and also to the two questions in the introduction, below we indicate the relationship between them.



- i) Suppose that T is a non-zero totally reflexive R-module and  $\bf{x}$  is a system of parameters for T, i.e. the sequence x has length dim T, and  $T/\mathbf{x}T$  is of finite length. Consider the the complex,  $K_{\bullet}(\mathbf{x}; T)$ . At each  $\mathfrak{p} \neq \mathfrak{m}$  we have  $T_{\mathfrak{p}} = (\mathbf{x})T_{\mathfrak{p}}$ , thus either  $(\mathbf{x})R_{\mathfrak{p}} = R_{\mathfrak{p}}$  or  $T_{\mathfrak{p}} = 0$  by Nakayama's Lemma. Hence, since **x** kills the homologies  $H_i(\mathbf{x}; T_p)$ , we get  $H_i(\mathbf{x}; T_p) = 0$  for all i. Thus,  $K_{\bullet}(\mathbf{x};T)$  has finite length homologies. If the Gorenstein version of the New Intersection Theorem holds, then applying it to the complex  $K_{\bullet}(\mathbf{x}; T)$ , we would have dim  $R \le \dim_R T$ . So, the implication (a) holds.
- ii) The implication (b) is obvious.
- iii) Assume that  $(R, \mathfrak{m}, k)$  is a local ring such that  $\text{Ass}_{R} R \setminus \{\mathfrak{m}\}\subseteq \text{Ass}_{R} R$  (e.g. R is generalized Cohen-Macaulay; see [\[SV,](#page-12-23) Chapter 1, Lemma 2.2]). Then Question [3.7](#page-10-1) implies Question [3.8.](#page-11-0) To this end, assume that the answer to Question [3.7](#page-10-1) is affirmative and let  $T$  be a non-zero totally reflexive R-module. Let  $\mathfrak{p} \in \text{Assh}_{R}T$ . Then, we already have  $\mathfrak{p} \in \text{Ass } R$ , because  $T \cong \text{Hom}_{R}(\text{Hom}_{R}(T, R), R)$ . If it is the case that  $\mathfrak{p} = \mathfrak{m}$ , then T would be a totally reflexive module of finite length and thus R would be an Artinian ring. On the other hand, if  $\mathfrak{p} \neq \mathfrak{m}$ , then  $\mathfrak{p} \in \text{Assh } R$ , and so we have dim  $R/\mathfrak{p} = \dim R$ .
- iv) Theorem [2.4](#page-3-0) implies the implication (c).
- v) The equivalence (d) follows by the argument given in the first two paragraphs of the proof of Theorem [3.6.](#page-10-0)
- vi) The implication (e) is immediate by the argument which is given in the proof of Corollary [3.1.](#page-8-0)

**Corollary 3.11.** Let  $(R, \mathfrak{m}, k)$  be a quasi-Buchsbaum ring. Then  $\dim_R M = \dim R$  for every non-zero *totally reflexive* R*-module* M*.*

Proof. Follows by Theorem [3.6](#page-10-0) and Remark [3.10](#page-11-1) v) and iii). Note that any quasi-Buchsbaum ring is generalized Cohen-Macaulay.
