# On monotonicity and order-preservation for multidimensional $G$-diffusion processes

#### Abstract

In this paper, we prove a comparison theorem for multidimensional $G$-SDEs. Moreover we obtain respectively the sufficient conditions and necessary conditions of the monotonicity and order-preservation for two multidimensional $G$-diffusion processes. Finally, we give some applications.

## 1 Introduction

In the classical framework, it is known that Itô diffusions can be used to construct linear semigroups, which are known as Markov semigroups. The relationships among Itô's diffusions, Markov semigroups and infinitesimal generators have been well studied and many interesting results have been deduced. They can be summarized as follows. We suppose $\left(X_{t}\right)_{t \geq 0}$ to be $n$-dimensional Itô diffusion

$$
d X_{t}=b\left(X_{t}\right) d t+\sigma\left(X_{t}\right) d W_{t},
$$

where $\left(W_{t}\right)_{t \geq 0}$ is a $d$-dimensional Brownian motion and $b, \sigma$ are Lipschitz continuous functions on $\mathbb{R}^{n}$. The Markov semigroup $P_{t}$ is defined by $P_{t} f(x)=E\left[f\left(X_{t}^{0, x}\right)\right]$, where $X^{0, x}$ represents the Itô process with initial condition $x$ at initial time $t=0$ and $f$ is a function defined on $\mathbb{R}^{n}$. Here $E[\cdot]$ stands for the expectation related to a probability $P$. The infinitesimal generator $L$ of the Markov semigroup, which satisfies

$$
L f(x)=\lim _{t \rightarrow 0^{+}} \frac{P_{t} f(x)-f(x)}{t}
$$

for $f$ appropriately taken such that the above limit exists, is of the following form:

$$
L f=\frac{1}{2} \operatorname{tr}\left[\sigma^{*} \frac{\partial^{2}}{\partial x^{2}} f \sigma\right]+b^{*} \frac{\partial}{\partial x} f,
$$

where "*" denotes the transposition. For more details, the readers can refer to, for example, Stroock and Varadhan (36]) and Rogers and Williams ([35]).

The monotonicity property of the semigroups associated with the corresponding diffusions was initiated by Holly ([13]) and studied by Cox ([4) and Harris ([10]). Afterwards, Herbst and Pitt

[^0]([11]) investigated the use of diffusion equations as a tool for establishing stochastic monotonicity of semigroups. Chen and Wang ([3]) continued the study on the order-preservation for multidimensional diffusion processes. One of the main results of Chen and Wang ([3]), which covers the monotonicity result in Herbst and Pitt $([11)$, is as follows:
Lemma 1.1 (Chen and Wang ([3], Theorem 1.3)) Let $A=\frac{1}{2} \Sigma_{i, j=1}^{n} a_{i j} \frac{\partial^{2}}{\partial x_{i} \partial x_{j}}+\Sigma_{i=1}^{n} l_{i} \frac{\partial}{\partial x_{i}}$ (resp. $\bar{A}=\frac{1}{2} \sum_{i, j=1}^{n} \bar{a}_{i j} \frac{\partial^{2}}{\partial x_{i} \partial x_{j}}+\sum_{i=1}^{n} \bar{l}_{i} \frac{\partial}{\partial x_{i}}$ ). Assume that ( $a_{i j}$ ) and ( $\bar{a}_{i j}$ ) are nonnegative definite everywhere, $a_{i j}, \bar{a}_{i j}, l_{i}, \bar{l}_{i} \in C\left(\mathbb{R}^{n}\right)$ and the martingale problems for $A$ and $\bar{A}$ are well posed. Let $P_{t}$ (resp. $\bar{P}_{t}$ ) be the Markov semigroup generated by $A$ (resp. $\bar{A}$ ). Then $P_{t} \geq \bar{P}_{t}$ if and only if the following two conditions hold:
(a) for all $i$ and $j, a_{i j} \equiv \bar{a}_{i j}$ and $a_{i j}(x)$ depends only on $x_{i}$ and $x_{j}$;
(b) for all $i, l_{i}(x) \geq \bar{l}_{i}(y)$ whenever $x_{i}=y_{i}$ and $x_{j} \geq y_{j}$ for all $j \in\{1, \ldots, n\}$ and $j \neq i$.

Peng ([27]) introduced the notion of $g$-expectation defined via a backward stochastic differential equation (BSDE). A $g$-expectation preserves most properties of the classical expectations except nonlinearity since it is a nonlinear functional. Its nonlinearity can be characterized by its generator $g$. Zhang and Jia ([37]) constructed a nonlinear semigroup by decoupled FBSDEs. They obtained the equivalent conditions of the monotonicity and order-preservation of semigroups.

Recently, Peng systemically established a time-consistent fully nonlinear expectation theory ( see [28, 29] and (30]). As a typical and important case, Peng introduced the $G$-expectation theory ( see 32 and the references therein) in 2006. In the $G$-expectation framework ( $G$-framework for short), the notion of $G$-Brownian motion and the corresponding stochastic calculus of Itô's type were established. On that basis, Gao [7] and Peng [31] have studied the existence and uniqueness of the solution of $G$-SDEs under a standard Lipschitz condition on its coefficients. Moreover, based on Gao [7], Bai and Lin [2] obtained the existence and uniqueness of the solution of GSDEs under some integral-Lipschitz conditions. For a recent account and development of this theory we refer the reader to $([20,21,[22,, 23,24])$. Recently, Hu et. al. ([14]) proved an existence and uniqueness result on BSDEs driven by $G$-Brownian motions (G-BSDEs), further (in [15]) they gave a comparison theorem for G-BSDEs. He et. al. ([12]) proved the representation theorem for generators of G-BSDEs, and then the converse comparison theorem of G-BSDEs and some equivalent results for nonlinear expectations generated by G-BSDEs.

This paper is organized as follow: In section 2, we recall some notations and results that we will use in this paper. In section 3 , we give our assumptions and recall some notations and results of $G$-SDES and $G$-BSDEs. In section 4, we obtain a comparison theorem for multidimensional $G$-SDEs. In section 5 , we obtain respectively the sufficient conditions and necessary conditions of the monotonicity and order-preservation of two multidimensional $G$-diffusion processes. In section 6 , some applications are given.

## 2 Preliminaries

### 2.1 Sublinear expectation, $G$-Brownian motion and capacity

### 2.1.1 Sublinear expectation

We present some preliminaries in the theory of sublinear expectation, $G$-Brownian motions and the capacity under $G$-framework. More details can be found in Peng 31] and Li and Peng [19].

Definition 2.1 Let $\Omega$ be a given set and let $\mathcal{H}$ be a linear space of real valued functions defined on $\Omega$ with $c \in \mathcal{H}$ for all constants $c$, and $|X| \in \mathcal{H}$, if $X \in \mathcal{H}$. $\mathcal{H}$ is considered as the space of our random variables. A sublinear expectation $\hat{\mathbb{E}}$ on $\mathcal{H}$ is a functional $\hat{\mathbb{E}}: \mathcal{H} \rightarrow \mathbb{R}$ satisfying the following
properties: for all $X, Y \in \mathcal{H}$, we have
(a)Monotonicity: if $X \geq Y$, then $\hat{\mathbb{E}}[X] \geq \hat{\mathbb{E}}[Y]$.
(b)Constant preserving: $\hat{\mathbb{E}}[c]=c, \forall c \in \mathbb{R}$.
(c)Sub-additivity: $\hat{\mathbb{E}}[X+Y] \leq \hat{\mathbb{E}}[X]+\hat{\mathbb{E}}[Y]$.
(d)Positive homogeneity: $\hat{\mathbb{E}}[\lambda X]=\lambda \hat{\mathbb{E}}[X], \forall \lambda \geq 0$.

The triple $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called a sublinear expectation space. $X \in \mathcal{H}$ is called a random variable in $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$. We often call $Y=\left(Y_{1}, \ldots, Y_{d}\right), Y_{i} \in \mathcal{H}$ a d-dimensional random vector in $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$. Let us consider a space of random variables $\mathcal{H}$ satisfying: if $X_{i} \in \mathcal{H}, i=1, \ldots, d$, then $\varphi\left(X_{1}, \cdots, X_{d}\right) \in \mathcal{H}$, for all $\varphi \in C_{b, L i p}\left(\mathbb{R}^{d}\right)$, where $C_{b, L i p}\left(\mathbb{R}^{d}\right)$ is the space of all bounded real-valued Lipschitz continuous functions.

Definition 2.2 In a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ an m-dimensional random vector $X=$ $\left(X_{1}, \ldots, X_{m}\right)$ is said to be independent from another $n$-dimensional random vector $Y=\left(Y_{1}, \ldots, Y_{n}\right)$ under $\hat{\mathbb{E}}$ if for any test function $\varphi \in C_{b, \text { Lip }}\left(\mathbb{R}^{m+n}\right)$ we have

$$
\hat{\mathbb{E}}[\varphi(X, Y)]=\hat{\mathbb{E}}\left[\hat{\mathbb{E}}[\varphi(x, Y)]_{x=X}\right]
$$

Definition 2.3 Let $X_{1}$ and $X_{2}$ be two $n$-dimensional random vector defined on sublinear expectation spaces $\left(\Omega_{1}, \mathcal{H}_{1}, \hat{\mathbb{E}}_{1}\right)$ and $\left(\Omega_{2}, \mathcal{H}_{2}, \hat{\mathbb{E}}_{2}\right)$, respectively. They are called identically distributed, denoted by $X_{1} \stackrel{d}{=} X_{2}$, if

$$
\hat{\mathbb{E}}_{1}\left[\varphi\left(X_{1}\right)\right]=\hat{\mathbb{E}}_{2}\left[\varphi\left(X_{2}\right)\right], \forall \varphi \in C_{b, L i p}\left(\mathbb{R}^{n}\right)
$$

We call $\bar{X}$ an independent copy of $X$ if $\bar{X} \stackrel{d}{=} X$ and $\bar{X}$ is independent from $X$.
Definition 2.4 ( $G$-normal distribution) An m-dimensional random vector $X=\left(X_{1}, \ldots, X_{m}\right)$ on a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called (centralized) $G$-normal distributed if for any $a, b \geq 0$

$$
a X+b \bar{X} \stackrel{d}{=} \sqrt{a^{2}+b^{2}} X
$$

where $\bar{X}$ is an independent copy of $X$. The letter $G$ denotes the function

$$
G(A):=\frac{1}{2} \hat{\mathbb{E}}[(A X, X)]: \mathbb{S}(d) \mapsto \mathbb{R}
$$

### 2.1.2 $G$-Brownian motion

Definition 2.5 ( $G$-Brownian motion) Let $G: \mathbb{S}(d) \mapsto \mathbb{R}$ be a given monotonic and sublinear function. A process $(B(t) \in \mathcal{H})_{t \geq 0}$ on a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called a $G$-Brownian motion if the following properties are satisfied:
(a) $B(0)=0$.
(b) For each $t, s \geq 0$ the increment $B_{t+s}-B_{t} \stackrel{d}{=} \sqrt{s} X$ and independent from $\left(B_{t_{1}}, B_{t_{2}}, \ldots, B_{t_{n}}\right)$ for each $n \in \mathbb{N}, 0 \leq t_{1} \leq t_{2} \leq \ldots \leq t_{n} \leq t$, where $X$ is $G$-normal distributed.

We denote by $\Omega=C_{0}^{d}\left(\mathbb{R}^{+}\right)$the space of all $\mathbb{R}^{d}$-value continuous paths $\left(\omega_{t}\right)_{t \in \mathbb{R}^{+}}$, with $\omega_{0}=0$, equipped with the distance

$$
\rho\left(\omega^{1}, \omega^{2}\right):=\sum_{i=1}^{\infty} 2^{-i}\left[\left(\max _{t \in[0, i]}\left|\omega^{1}(t)-\omega^{2}(t)\right|\right) \wedge 1\right]
$$

We denote by $\mathcal{B}(\Omega)$ the Borel $\sigma$-algebra of $\Omega$.
We also denote, for each $t \in[0, \infty)$ :
$\Omega_{t}:=\{\omega(\cdot \wedge t): \omega \in \Omega\}$,
$\mathcal{F}_{t}:=\mathcal{B}\left(\Omega_{t}\right)$,
$L^{0}(\Omega)$ : the space of all $\mathcal{B}(\Omega)$-measurable real function,
$L^{0}\left(\Omega_{t}\right)$ : the space of all $\mathcal{B}\left(\Omega_{t}\right)$-measurable real function,
$B_{b}\left(\Omega_{t}\right)$ : all bounded elements in $L^{0}(\Omega), B_{b}\left(\Omega_{t}\right):=B_{b}(\Omega) \cap L^{0}\left(\Omega_{t}\right)$,
$C_{b}\left(\Omega_{t}\right)$ : all continuous elements in $B_{b}(\Omega), C_{b}\left(\Omega_{t}\right):=B_{b}(\Omega) \cap L^{0}\left(\Omega_{t}\right)$.
In Peng [31, a $G$-Brownian motion is constructed on a sublinear expectation sapce $\left(\Omega, L_{G}^{p}, \hat{\mathbb{E}},\left(\hat{\mathbb{E}}_{t}\right)_{t \geq 0}\right)$ for $p=1$, where $L_{G}^{p}$ is a Banach space under the natural norm $\|X\|_{p}=\hat{\mathbb{E}}\left[|X|^{p}\right]^{1 / p}$. In this space the corresponding canonical process $B(t, \omega)=\omega(t), t \in[0, \infty)$, for $\omega \in \Omega$, is a $G$-Brownian motion. It is proved in Denis et al. [5] that $L^{0}(\Omega) \supset L_{G}^{p}(\Omega) \supset C_{b}(\Omega)$, and there exists a weakly compact family $\mathcal{P}$ of probability measures defined on $(\Omega, \mathcal{B}(\Omega))$ such that

$$
\hat{\mathbb{E}}[X]=\sup _{P \in \mathcal{P}} E_{P}[X], \quad X \in L_{G}^{1}(\Omega) .
$$

We now introduce the natural choquet capacity

$$
c(A):=\sup _{P \in \mathcal{P}} P(A), \quad A \in \mathcal{B}(\Omega)
$$

Definition 2.6 $A$ set $A \subset \Omega$ is polar if $c(A)=0$. A property holds 'quasi-surely' (q.s.) if it holds outside a polar set.

Definition 2.7 $A$ real function $X$ on $\Omega$ is said to be quasi-continuous if for each $\varepsilon>0$, there exists an open set $O$ with $c(O)<\varepsilon$ such that $\left.X\right|_{O^{c}}$ is continuous.

Then $L_{G}^{p}(\Omega)$ can be characterized as follows:

$$
L_{G}^{p}(\Omega)=\left\{X \in \mathbb{L}^{0}(\Omega) \mid \sup _{P \in \mathcal{P}} E_{P}\left[|X|^{p}\right]<\infty, \text { and } X \text { is } c \text { quasi-surely continuous }\right\}
$$

We denote, for $p>0$,

$$
\begin{aligned}
& \mathcal{L}^{p}:=\left\{X \in L^{0}(\Omega): \hat{\mathbb{E}}\left[|X|^{p}\right]=\sup _{P \in \mathcal{P}} E_{P}\left[|X|^{p}\right]<\infty\right\} \\
& \mathcal{N}^{p}:=\left\{X \in L^{0}(\Omega): \hat{\mathbb{E}}\left[|X|^{p}\right]=0\right\} \\
& \mathcal{N}:=\left\{X \in L^{0}(\Omega): \mathrm{X}=0, c \text {-qusi surely (q.s.) }\right\}
\end{aligned}
$$

It is seen that $\mathcal{L}^{p}$ and $\mathcal{N}^{p}$ are linear spaces and $\mathcal{N}^{p}=\mathcal{N}$, for each $p>0$. We define the space $L^{p}(\Omega)=\mathcal{L}^{p} / \mathcal{N}$ as the equivalence classes of $\mathcal{L}^{p}$ modulo equality in $\|\cdot\|_{p}$. Similarly, we can define $L^{p}\left(\Omega_{t}\right)=L^{p}(\Omega) \cap L^{0}\left(\Omega_{t}\right)$. As usual, we do not make the distinction between classes and their representatives.

Definition 2.8 Let $L_{b}^{p}(\Omega)$ be the completion of $B_{b}(\Omega)$ under the Banach norm $\left(\hat{\mathbb{E}}\left[|X|^{p}\right]\right)^{1 / p}$.
Then we have the following characterisation (see [5]): for each $p \geq 1$,

L_{b}^{p}(\Omega)=\left\{X \in L^{p}(\Omega): \lim _{n \rightarrow \infty} \hat{\mathbb{E}}\left[|X|^{p} \mathbf{I}_{\{|X|>n\}}\right]=0\right\}
$$

Definition 2.9 For $p \geq 1$ and $T \in \mathbb{R}^{+}$be fixed. Consider the following simple type of processes:

For each $p \geq 1$, we denote by $M_{G}^{p}(0, T)$ the completion of $M_{G}^{0, p}(0, T)$ under the norm

\|\eta\|_{M_{G}^{p}(0, T)}=\left|\int_{0}^{T} \hat{\mathbb{E}}\left[|\eta(t)|^{p}\right] d t\right|^{1 / p}
$$

Definition 2.10 For $p \geq 1$ and $T \in \mathbb{R}^{+}$be fixed. Consider the following simple type of processes:

M_{b}^{0}(0, T)= & \left\{\eta:=\eta_{t}(\omega)=\sum_{j=0}^{N-1} \xi_{j}(\omega) \mathbf{I}_{\left[t_{j}, t_{j+1}\right)}(t)\right. \\
& \left.\forall N>0,0=t_{0}<\ldots<t_{N}=T, \xi_{j}(\omega) \in B_{b}\left(\Omega_{t_{j}}\right), j=0,1,2, \ldots, N-1 .\right\}
\end{aligned}

For each $p \geq 1$, we denote by $M_{b}^{p}(0, T)$ the completion of $M_{b}^{0}(0, T)$ under the norm $\|\cdot\|_{M_{G}^{p}(0, T)}$.
Definition 2.11 (Integration with respect to $G$-Brownian motion) For each $\eta \in M_{G}^{0,2}(0, T)$ with the form

$$
\eta_{t}(\omega)=\sum_{k=0}^{N-1} \xi_{k}(\omega) I_{\left[t_{k}, t_{k+1}\right)}(t)
$$

define

$$
I(\eta)=\int_{0}^{T} \eta(s) d B(s):=\sum_{k=0}^{N-1} \xi_{k}\left(B_{t_{k+1}^{N}}-B_{t_{k}^{N}}\right)
$$

The mapping $I: M_{G}^{0,2}(0, T) \mapsto \mathbb{L}_{G}^{2}\left(\Omega_{T}\right)$ can be continuously extended to $I: M_{G}^{2}(0, T) \mapsto \mathbb{L}_{G}^{2}\left(\Omega_{T}\right)$. For each $\eta \in M_{G}^{2}(0, T)$, the stochastic integral is defined by

$$
I(\eta):=\int_{0}^{T} \eta(s) d B_{s}, \quad \eta \in M_{G}^{2}(0, T)
$$

We have the following general case.
Definition 2.12 For each $\eta \in M_{b}^{0}(0, T)$ with the form

$$
\eta_{t}(\omega)=\sum_{k=0}^{N-1} \xi_{k}(\omega) \mathbf{I}_{\left[t_{k}, t_{k+1}\right)}(t)
$$

define

$$
I(\eta)=\int_{0}^{T} \eta(s) d B_{s}:=\sum_{k=0}^{N-1} \xi_{k}\left(B_{t_{k+1}^{N}}-B_{t_{k}^{N}}\right)
$$

The mapping $\mathbf{I}: M_{b}^{0}(0, T) \mapsto L^{2}\left(\Omega_{T}\right)$ can be continuously extended to $\mathbf{I}: M_{b}^{2}(0, T) \mapsto L^{2}\left(\Omega_{T}\right)$. For each $\eta \in M_{b}^{2}(0, T)$, the stochastic integral is defined by

$$
I(\eta):=\int_{0}^{T} \eta(s) d B_{s}, \quad \eta \in M_{b}^{2}(0, T)
$$

For notational simplicity, we denote by $B^{i}:=B^{e_{i}}$ the $i$ th coordinate of the d-dimensional $G$ Brownian motion $B$, under a given orthonormal basis $\left(e_{1}, \ldots, e_{d}\right)$ of $\mathbb{R}^{d}$. We also denote by $B_{t}^{a}:=$ $\left(a, B_{t}\right)$ for fixed $a \in \mathbb{R}^{d}$. Then $\left(B_{t}^{a}\right)_{t \geq 0}$ is a 1-dimensional $G$-Brownian motion with $\sigma_{a a^{T}}^{2}=\hat{\mathbb{E}}\left[\left(a, B_{1}\right)^{2}\right]$ and $\sigma_{-a a^{T}}^{2}=-\hat{\mathbb{E}}\left[-\left(a, B_{1}\right)^{2}\right]$. Let $a$ and $\bar{a}$ be two given vectors in $\mathbb{R}^{d}$. We can define

$$
\left\langle B^{a}\right\rangle_{t}:=\left(B_{t}^{a}\right)^{2}-\int_{0}^{t} B_{s}^{a} d B_{s}^{a}
$$

where $\left\langle B^{a}\right\rangle$ is called the quadratic variation process of $B^{a}$. We can also define mutual variation process by

$$
\left\langle B^{a}, B^{\bar{a}}\right\rangle_{t}:=\frac{1}{4}\left[\left\langle B^{a}+B^{\bar{a}}\right\rangle_{t}-\left\langle B^{a}-B^{\bar{a}}\right\rangle_{t}\right]
$$

Itô's integral with respect to $\left\langle B^{a}\right\rangle$ or $\left\langle B^{i}, B^{j}\right\rangle$ can be similarly defined. By Li and Peng [19, we have
Lemma 2.13 Let $X \in M_{b}^{p}(0, T)$. Then for each $\varepsilon>0$, there exists $\delta>0$ such that for all $\eta \in$ $M_{b}^{0}(0, T)$ satisfying $\hat{\mathbb{E}} \int_{0}^{T}\left|\eta_{t}\right| d t \leq \delta$ and $\left|\eta_{t}(\omega)\right| \leq 1$, we have $\hat{\mathbb{E}} \int_{0}^{T}\left|X_{t}\right|^{p}\left|\eta_{t}\right| d t \leq \varepsilon$.

Definition 2.14 A stopping time $\tau$ relative to the filtration $\left(\mathcal{F}_{t}\right)$ is a map on $\Omega$ with values in $[0, T]$, such that for every $t$,

$$
\{\tau \leq t\} \in \mathcal{F}_{t}
$$

Lemma 2.15 For each stopping time $\tau \in[0, T]$, we have $I_{[0, \tau]}(\cdot) X \in M_{b}^{p}(0, T)$, for each $X \in$ $M_{b}^{p}(0, T)$.

Definition 2.16 A process $\left(M_{t}\right)_{t \geq 0}$ is called a $G$-martingale if for each $t \in[0, T], M_{t} \in \mathbb{L}_{G}^{1}\left(\Omega_{t}\right)$ and for each $s \in[0, t)$, we have

$$
\hat{\mathbb{E}}_{s}\left[M_{t}\right]=M_{s}
$$

Corollary 2.17 For each $\eta \in M_{G}^{2}(0, T)$, the process $\left(\int_{0}^{T} \eta(s) d B_{s}\right)_{t \in[0, T]}$ is a $G$-martingale.

## $3 \quad G$-SDEs and $G$-BSDEs

### 3.1 G-SDEs

We make use of the following assumptions on the generator $b, h$ and $\sigma$ of GSDE:
(H1) $b, h_{i j}$ and $\sigma_{i}$ are given $\mathbb{R}^{n}$-valued bounded Lipschitz continuous functions defined on $[0, T] \times \mathbb{R}^{n}$ which satisfy the Lipchitz condition, i.e., there exists some constant $K$ such that $\mid \varphi(t, x)-$ $\varphi(t, y)|\leq K| x-y \mid$, for each $t \in[0, T], x, y \in \mathbb{R}^{n}, \varphi=b, h_{i j}$ and $\sigma_{i}$ respectively, $i, j=1, \ldots, d$.
(H2) $b, h_{i j}$ and $\sigma_{i}$ are given $\mathbb{R}^{n}$-valued bounded Lipschitz continuous functions defined on $\mathbb{R}^{n}$, i.e., there exists some constant $K$ such that $|\varphi(x)-\varphi(y)| \leq K|x-y|$, for each $x, y \in \mathbb{R}^{n}, \varphi=b, h_{i j}$ and $\sigma_{i}$ respectively, $i, j=1, \ldots, d$.

We consider the following SDE driven by a $d$-dimensional $G$-Brownian motion:

where the initial condition $X_{0} \in \mathbb{R}^{n}$ is a given constant.
Theorem 3.1 Under the assumption (H1), there exists a unique solution $X \in M_{G}^{2}(0, T)$ of the stochastic differential equation (1).

## $3.2 \quad G$-BSDEs

In this subsection, we present some notations and results of $G$-BSDEs. More details can be found in [14] and [15].

Definition 3.2 For fixed $T>0$, let $M_{G}^{0}(0, T)$ be the collection of processes in the following form: for a given partition $\left\{t_{0}, \cdots, t_{N}\right\}=\pi_{T}$ of $[0, T]$,

where $\xi_{j} \in L_{i p}\left(\Omega_{t_{j}}\right), j=0,1,2, \cdots, N-1$. For $p \geq 1$, we denote by $H_{G}^{p}(0, T), M_{G}^{p}(0, T)$ the completion of $M_{G}^{0}(0, T)$ under the norms $\|\eta\|_{H_{G}^{p}}=\left\{\hat{\mathbb{E}}\left[\left(\int_{0}^{T}\left|\eta_{s}\right|^{2} d s\right)^{p / 2}\right]\right\}^{1 / p},\|\eta\|_{M_{G}^{p}}=\left\{\int_{0}^{T} \hat{\mathbb{E}}\left[\left|\eta_{s}\right|^{p}\right] d s\right\}^{1 / p}$ respectively.

For each $\eta \in M_{G}^{1}(0, T)$, we can define the integrals $\int_{0}^{T} \eta_{t} d t$ and $\int_{0}^{T} \eta_{t} d\left\langle B^{\mathbf{a}}, B^{\overline{\mathbf{a}}}\right\rangle_{t}$ for each $\mathbf{a}, \overline{\mathbf{a}} \in \mathbb{R}^{d}$. For each $\eta \in H_{G}^{p}\left(0, T ; \mathbb{R}^{d}\right)$ with $p \geq 1$, we can define Itô's integral $\int_{0}^{T} \eta_{t} d B_{t}$.

Let $S_{G}^{0}(0, T)=\left\{h\left(t, B_{t_{1} \wedge t}, \cdots, B_{t_{n} \wedge t}\right): t_{1}, \ldots, t_{n} \in[0, T], h \in C_{b, L i p}\left(\mathbb{R}^{n+1}\right)\right\}$. For $p \geq 1$ and $\eta \in S_{G}^{0}(0, T)$, set $\|\eta\|_{S_{G}^{p}}=\left\{\hat{\mathbb{E}}\left[\sup _{t \in[0, T]}\left|\eta_{t}\right|^{p}\right]\right\}^{\frac{1}{p}}$. Denote by $S_{G}^{p}(0, T)$ the completion of $S_{G}^{0}(0, T)$ under the norm $\|\cdot\| \|_{G}^{p}$.

We only consider non-degenerate $G$-normal distribution, i.e.,
(H3) There exists some $\underline{\sigma}^{2}>0$ such that $G(A)-G(B) \geq \underline{\sigma}^{2} \operatorname{tr}[A-B]$ for any $A \geq B$.
We consider the following type of $G$-BSDEs (in this paper we always use Einstein convention):

(H4) There exists some $\beta>1$ such that for any $y, z, f(\cdot, \cdot, y, z), g_{i j}(\cdot, \cdot, y, z) \in M_{G}^{\beta}(0, T)$.
(H5) There exists some $L>0$ such that

For simplicity, we denote by $\mathfrak{S}_{G}^{\alpha}(0, T)$ the collection of processes $(Y, Z, K)$ such that $Y \in S_{G}^{\alpha}(0, T)$, $Z \in H_{G}^{\alpha}\left(0, T ; \mathbb{R}^{d}\right), K$ is a decreasing $G$-martingale with $K_{0}=0$ and $K_{T} \in L_{G}^{\alpha}\left(\Omega_{T}\right)$.

Definition 3.3 Let $\xi \in L_{G}^{\beta}\left(\Omega_{T}\right)$ and $f$ satisfy (H4) and (H5) for some $\beta>1$. A triplet of processes $(Y, Z, K)$ is called a solution of equation (2) if for some $1<\alpha \leq \beta$ the following properties hold:
(a) $(Y, Z, K) \in \mathfrak{S}_{G}^{\alpha}(0, T) ;$
(b) $Y_{t}=\xi+\int_{t}^{T} f\left(s, Y_{s}, Z_{s}\right) d s+\int_{t}^{T} g_{i j}\left(s, Y_{s}, Z_{s}\right) d\left\langle B^{i}, B^{j}\right\rangle_{s}-\int_{t}^{T} Z_{s} d B_{s}-\left(K_{T}-K_{t}\right)$.

Theorem 3.4 (14]) Assume that $\xi \in L_{G}^{\beta}\left(\Omega_{T}\right)$ and $f, g_{i j}$ satisfy (H4) and (H5) for some $\beta>1$. Then equation (2) has a unique solution $(Y, Z, K)$. Moreover, for any $1<\alpha<\beta$ we have $Y \in S_{G}^{\alpha}(0, T)$, $Z \in H_{G}^{\alpha}\left(0, T ; \mathbb{R}^{d}\right)$ and $K_{T} \in L_{G}^{\alpha}\left(\Omega_{T}\right)$.

We consider the following $G$-BSDEs:

where $g_{i j}^{l}=g_{j i}^{l}$.
He and Hu [12] generalized the comparison theorem in [15].
Proposition 3.5 Let $f^{l}$ and $g_{i j}^{l}$ satisfy (H4) and (H5) for some $\beta>1, l=1,2$. If $f^{2}-f^{1}+2 G\left(\left(g_{i j}^{2}-\right.\right.$ $\left.\left.g_{i j}^{1}\right)_{i, j=1}^{d}\right) \leq 0$, then for each $\xi \in L_{G}^{\beta}\left(\Omega_{T}\right)$, we have $Y_{t}^{1, \xi} \geq Y_{t}^{2, \xi}$ for $t \in[0, T]$.

### 3.3 Nonlinear Feynman-Kac Formula

In this subsection, we give the nonlinear Feynman-Kac Formula which was studied in Peng [32] for special type of $G$-BSDEs. We consider the following type of $G$-FBSDEs:

& -\int_{s}^{T} Z_{r}^{t, \xi} d B_{r}-\left(K_{T}^{t, \xi}-K_{s}^{t, \xi}\right) \tag{4}

where $b, h_{i j}, \sigma_{j}:[0, T] \times \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}, \Phi: \mathbb{R}^{n} \rightarrow \mathbb{R}, f, g_{i j}:[0, T] \times \mathbb{R}^{n} \times \mathbb{R} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ are deterministic functions and satisfy the following conditions:
(A1) $h_{i j}=h_{j i}$ and $g_{i j}=g_{j i}$ for $1 \leq i, j \leq d$;
(A2) $b, h_{i j}, \sigma_{j}, f, g_{i j}$ are continuous in $t$;
(A3) There exist a positive integer $m$ and a constant $L>0$ such that

Remark 3.6 It is important to note that $u(t, x)$ is a deterministic function of $(t, x)$, because $b, h_{i j}$, $\sigma_{j}, \Phi, f, g_{i j}$ are deterministic functions and $\tilde{B}_{s}:=B_{t+s}-B_{t}$ is a $G$-Brownian motion.

We now give the Feynman-Kac formula.
Theorem 3.7 Let $u(t, x):=Y_{t}^{t, x}$ for $(t, x) \in[0, T] \times \mathbb{R}^{n}$. Then $u(t, x)$ is the unique viscosity solution of the following PDE:

H_{i j}\left(D_{x}^{2} u, D_{x} u, u, x, t\right)= & \left\langle D_{x}^{2} u \sigma_{i}(t, x), \sigma_{j}(t, x)\right\rangle+2\left\langle D_{x} u, h_{i j}(t, x)\right\rangle \\
& +2 g_{i j}\left(t, x, u,\left\langle\sigma_{1}(t, x), D_{x} u\right\rangle, \ldots,\left\langle\sigma_{d}(t, x), D_{x} u\right\rangle\right) .

## 4 Comparison Theorem for Multidimensional GSDEs

In the classical framework, comparison theorem for stochastic differential equations are well studied (see [1], [6, 8], [9, [18] and etc.). In particular, Geiß and Manthey (8]) obtained a comparison theorem for multidimensional SDEs. We also refer to Lin ([21) and Luo and Wang ([24]) for the comparison theorem of 1-dimensional G-SDEs. In this paper, we follow the idea of their proof to get our results. We consider the following SDEs driven by a $d$-dimensional $G$-Brownian motion:

Y(t)=Y(0)+\int_{0}^{t} \bar{b}(s, Y(s)) d s+\int_{0}^{t} \bar{h}_{i j}(s, Y(s)) d\left\langle B^{i}, B^{j}\right\rangle_{s}+\int_{0}^{t} \sigma_{i}(s, Y(s)) d B_{s}^{i}, t \in[0, T]
$$

where the initial conditions $X(0), Y(0) \in \mathbb{R}^{n}$ are given constants together with

We now give a comparison theorem for multidimensional $G$-SDEs.
Theorem 4.1 Suppose that the following two conditions hold.
(B1) For any $t \in[0, T]$, and $i=1, \ldots, n$, the inequality

(B2) $b, h_{i j}, \sigma_{i}$ and $\bar{b}, \bar{h}_{i j}, \sigma_{i}$ satisfy (H1) and $\left(\sigma_{i}\right)_{k}$ depends only on $x_{k}$, for each $k=1, \ldots, n$, $i, j=1, \ldots, d$, i.e.,

Proof. We first proof the theorem under the following condition (B1') instead of (B1).
(B1') For any $t \in[0, T]$ and $i=1, \ldots, n$ the inequality

Because of condition (B1'), the continuity of $b, h_{i j}, \bar{b}, \bar{h}_{i j}, i, j=1,2, \ldots, d$, and the continuity of $X$ and $Y$ there exists a stopping time $T \geq \kappa>\tau$ q.s. defined on $\{\tau<T\}$ such that

then we take $\kappa=\frac{\tau+\kappa_{1}}{2}$. It is easy to check that $\kappa$ satisfies the above condition.
Now we define $\rho(x)=K x$ for $x \geq 0$. Then $\int_{0^{+}} \rho^{-2}(u) d u=\infty$. Hence there exists a strictly increasing sequence $\left\{a_{n}\right\}_{n=0}^{\infty}$ such that $a_{0}=1, \lim _{n \rightarrow \infty} a_{n}=0$ (actually, $a_{n}=\frac{2}{n(n+1) K^{2}+2}$ ) and

In fact, let $b_{1}=h_{1}=\bar{b}_{1}=\bar{h}_{1}=h_{2}=\bar{b}_{2}=0, b_{2}=\frac{\bar{\sigma}^{2}+\underline{\sigma}^{2}}{2}, \bar{h}_{2}=1$ and $x=\bar{x}=0$, we consider 1-dimensional $G$-Brownian motion. One can show that $b, h, \bar{b}, \bar{h}$ satisfy condition ( $B$ "). However we can not deduce that $\frac{\bar{\sigma}^{2}+\underline{\underline{\sigma}}^{2}}{2} t \leq\langle B\rangle_{t}$, q.s. whenever $\underline{\sigma}^{2}<\bar{\sigma}^{2}$.

## 5 Stochastic monotonicity and order-preservation

Lin (20]) defined the infinitesimal generator of $G$-SDEs and obtained the representation theorem under the Lipschitz condition. Similarly, we can obtain the relationships among $G$-Itô's diffusions, Markov semigroups and infinitesimal generators. They can be summarized as follows. We suppose $\left(X_{t}\right)_{t \geq 0}$ to be $n$-dimensional $G$-Itô diffusion

where $\left(B_{t}\right)_{t \geq 0}$ is a $d$-dimensional $G$-Brownian motion and $b, h, \sigma$ are Lipschitz continuous functions on $\mathbb{R}^{n}$. The Markov semigroup $\mathcal{E}_{t}$ is defined by $\mathcal{E}_{t} f(x)=\hat{\mathbb{E}}\left[f\left(X_{t}^{0, x}\right)\right]$, where $X^{0, x}$ represents the $G$-Itô process with initial condition $x$ at initial time $t=0$ and $f$ is a function defined on $\mathbb{R}^{n}$. The infinitesimal generator $L$ of the Markov semigroup, which satisfies

Now we introduce the following definitions, which are similar to that in Herbst and Pitt ([11]) and Chen and Wang ([3). Let " $\leq$ " denote the usual semi-order in $\mathbb{R}^{n}$.
(1) A measurable function $f$ is called monotone if

and let $\left\{\mathcal{E}_{t}\right\}_{0 \leq t \leq T},\left\{\overline{\mathcal{E}}_{t}\right\}_{0 \leq t \leq T}$ and $\left\{\overline{\mathcal{E}}_{t}^{\prime}\right\}_{0 \leq t \leq T}$ be the semigroup generated by $L, \bar{L}$ and $\bar{L}^{\prime}$ respectively. And we always assume that $b, h_{i j}, \sigma_{i}$ and $\bar{b}, \bar{h}_{i j}, \bar{\sigma}_{i}$ satisfy (H2) for each $i, j=1, \ldots, d$.

We have the following results.

## Theorem 5.1 Suppose the following conditions hold:

then $\mathcal{E}_{t}$ is monotone
Proof. Suppose (C1)and(C2) hold. By setting $\bar{b}=b$ and $\bar{h}=h$ in Theorem (4.1), we have $\forall x \leq \bar{x}$, $X_{t}^{0, x} \leq X_{t}^{0, \bar{x}}$ q.s.. Then by the monotonicity of $f$, the results follows.

So $\left[\sigma_{l i}(v) \sigma_{k i}(v)\right]_{l, k=1}^{d} \geq\left[\sigma_{l i}(u) \sigma_{k i}(u)\right]_{l, k=1}^{d}$ as $m \rightarrow \infty$. Replacing $f_{m}$ with $\left(x_{i}-x_{i}^{(1)}-1\right)^{2 m+1}$ in a neighborhood of $\left\{x^{(1)}, x^{(2)}\right\}$, we obtain the inverse inequality. Therefore, $\left[\sigma_{l i}(v) \sigma_{k i}(v)\right]_{l, k=1}^{d}=$ $\left[\sigma_{l i}(u) \sigma_{k i}(u)\right]_{l, k=1}^{d}$.

is a non-increasing $G$-martingale. By the uniqueness of solutions of $G$-BSDES, $\bar{Z}_{r}^{0, x, t, f}=\sigma^{*}\left(X_{t}^{0, x}\right) \partial_{x} \hat{u}\left(t, X_{t}^{0, x}\right)$ for all $0 \leq r \leq t \leq T-\kappa$. By the assumption that $\overline{\mathcal{E}}_{t}$ is monotone, we have $\bar{u}$ (then $\hat{u}$ ) is nondecreasing in $x$. Thus $\left.\partial_{x} \hat{( } u\right) \geq 0$. By condition (D5) and the comparison of $G$-BSDEs, we have $Y_{r}^{0, x, t, f} \geq \bar{Y}_{r}^{0, x, t, f}$ for all $0 \leq r \leq t \leq T-\kappa$. Particularly, we have $\mathcal{E}_{t} f(x) \geq \overline{\mathcal{E}}_{t} f(x)$. By the monotonicity of $\overline{\mathcal{E}}_{t}$, for all $x \geq \bar{x}, \mathcal{E}_{t} f(x) \geq \overline{\mathcal{E}}_{t} f(x) \geq \overline{\mathcal{E}}_{t} f(\bar{x})$. Thus $\mathcal{E}_{t} \geq \overline{\mathcal{E}}_{t}$ for all $t \in[0, T)$. By continuity, we have $\mathcal{E}_{t} \geq \overline{\mathcal{E}}_{t}$ for all $t \in[0, T]$.

## 6 Applications to PDEs

In this section, we will give some applications of the above results to a special type of PDEs. We assume that $b, h_{i j}, \sigma_{i}$ and $\bar{b}, \bar{h}_{i j}, \bar{\sigma}_{i}$ satisfy (H2) for each $i, j=1, \ldots, d$. We have the following results. We will omit the proofs since the results hold in view of Theorem5.1, Theorem5.2, Corollary 5.9. Theorem 5.10 and the nonlinear Feynman-Kac formula in section 3.3.

Theorem 6.1 Let $u$ be the unique viscosity solution of PDE (9), if (C1) and (C2) hold, then $u$ is nondecreasing in $x$ for all $f \in \mathcal{M}$.

Theorem 6.2 Let $u$ be the unique viscosity solution of PDE (9), if $u$ is nondecreasing in $x$ for all $f \in \mathcal{M}$, then (C1) and (C2') hold.

Theorem 6.3 Let us consider PDE (9) and PDE (10), if $u(t, x) \geq \bar{u}(t, \bar{x})$ for all $t \in[0, T], f \in \mathcal{M}$ and $x \geq \bar{x}$, then (D1), (D2), and (D2') hold.

Theorem 6.4 Assume (H3) and assume that $\sigma \sigma^{*}$ (or resp. $\bar{\sigma} \bar{\sigma}^{*}$ ) is uniformly positive definite. Suppose that (C1) and (C2) hold for $b, h, \sigma$ or $\bar{b}, \bar{h}, \bar{\sigma}$. Let us consider PDE (G) and PDE (10), if (D1) and (D5) hold, then $u(t, x) \geq \bar{u}(t, \bar{x})$ for all $t \in[0, T], f \in \mathcal{M}$ and $x \geq \bar{x}$.
