# Cosmological perturbations in the ( $1+3+6$ )-dimensional space-times

#### Abstract

Cosmological perturbations in the $(1+3+6)$-dimensional space-times including photon gas without viscous processes are studied on the basis of Abbott et al.'s formalism. Space-times consist of the outer space (the 3-dimensional expanding section) and the inner space (the 6 -dimensional section). The inner space expands initially and contracts later. Abbott et al. derived only power-type solutions in the small wave-number limit which appear at the final stage of the space-times. In this paper, we derive not only small wave-number solutions, but also large wave-number solutions. It is found that the latter solutions depend on the two wave-numbers $k_{r}$ and $k_{R}$ (which are defined in the outer and inner spaces, respectively), and that the $k_{r}$-dependent and $k_{R}$-dependent parts dominate the total perturbations when $\left(k_{r} / r(t)\right) /\left(k_{R} / R(t)\right) \gg 1$ or $\ll 1$, respectively, where $r(t)$ and $R(t)$ are the scale-factors in the outer and inner spaces. By comparing the behaviors of these perturbations, moreover, changes in the spectrum of perturbations in the outer space with time are discussed.


## 1. Introduction

From the viewpoint of analyzing cosmological perturbations and discussing the evolution of their spectrum, we study the cosmological evolution of the $(1+3+6)$-dimensional spacetimes, in which it is assumed that our universe appears as an isotropic and homogeneous 10 -dimensional space-time and evolves to the state consisting of the 3 -dimensional inflating outer space and the 6 -dimensional collapsing outer space. This scenario is supported by the present super-string theory (Kim et al. [1, 2] in a matrix model).
In a previous paper[3], we discussed the entropy production at the stage when the above inflation and collapse coexist, and showed how viscous processes help the increase of cosmological entropy; we also discussed the possibility that we satisfy, at the same time, the condition that the entropy in the Guth level[4] is obtained and the condition that the inner space decouples from the outer space.
In this paper we study the evolution of cosmological perturbations in these space-times (in the case with no viscous processes), on the basis of Abbott et al.'s formalism[5]. They extended Bardeen's gauge-invariant formalism[6] in the 4-dimensional cosmological models to that in the multi-dimensional models. Abbott et al. derived only power-type solutions in the small wave-number limit which appear at the final stage of the space-times. In this paper, we derive not only small wave-number solutions, but also large wave-number solutions. It is found that the latter solutions depend on the two wave-numbers $k_{r}$ and $k_{R}$ which are defined in the outer and inner spaces, respectively, and that $k_{r}$-dependent and $k_{R}$-dependent parts dominate the total perturbations when $\left(k_{r} / r(t)\right) /\left(k_{R} / R(t)\right) \gg 1$ or $\ll 1$, respectively, where
$r(t)$ and $R(t)$ are the scale-factors in the outer and inner spaces. Using these solutions, we discuss the evolution of the $k_{r}$-dependence (spectrum) of perturbations in the outer space.
In Sect. 2, we review our formalism based on that of Abbott et al., in which the perturbed quantities and Einstein equations are shown and they are classified into three modes, i.e., scalar, vector, and tensor modes. A new equation to be solved in the scalar mode is introduced. In Sect. 3, we derive solutions for the perturbed equations in the scalar mode, and approximate solutions in the cases of $\left(k_{r} / r(t)\right) /\left(k_{R} / R(t)\right) \gg 1$ or $\ll 1$ are shown. In Sects. 4 and 5 , we derive solutions in the vector and tensor modes, respectively. Similarly approximate solutions in the cases of $\left(k_{r} / r(t)\right) /\left(k_{R} / R(t)\right) \gg 1$ or $\ll 1$ are shown. In Sect. 6 , changes in the spectrum of perturbations with time are discussed. In Sect. 7, concluding remarks are given. In Appendix A, we show the formulas of harmonics and gauge transformations in outer and inner spaces. In Appendices B and C, we show the derivations of approximate solutions in the scalar mode in the cases of $x\left(\equiv k_{r} \tau^{4 / 3}\right) \ll 1$ and $y\left(\equiv k_{R} \tau^{2 / 3}\right) \ll 1$, respectively, corresponding to the above cases, where $\tau \equiv t_{0}-t$ and $t_{0}$ denotes the final time corresponding to $r \rightarrow \infty$ and $R=0$.

## 2. Formalism of the perturbation theory

The background space-time is expressed in the form of a product of two homogeneous spaces $\mathrm{M}_{\mathrm{d}}$ and $\mathrm{M}_{\mathrm{D}}$ as

where ${ }^{d} g_{i j}$ and ${ }^{D} g_{a b}$ are the metrics of the outer space $\mathrm{M}_{\mathrm{d}}$ and the inner space $\mathrm{M}_{\mathrm{D}}$ with constant curvatures $K_{r}$ and $K_{R}$, respectively. Here the dimensions of $\mathrm{M}_{\mathrm{d}}$ and $\mathrm{M}_{\mathrm{D}}$ are $d=3$ and $D=6$. The inner space $\mathrm{M}_{\mathrm{D}}$ expands initially and collapses after the maximum expansion with $K_{R}=1$, while the outer space $\mathrm{M}_{\mathrm{d}}$ continues to expand with $K_{r}=0$ or -1 . As the collapse and expansion in these spaces proceed, however, the curvature terms of both spaces are negligible and the curvatures can be regarded approximately as $K_{r}=K_{R}=0$. Then the background metric is

where $i, j=1, \ldots, d, a, b=d+1, \ldots, d+D$, and an overdot denotes $d / d t$. The background energy-momentum tensor is

where $u^{\mu}$ is the fluid velocity, $\rho$ the energy density, and $p$ the pressure. Here $\rho$ and $p$ are the common photon density and pressure in both spaces. The fluid is extremely hot and satisfies
the equation of state $p=\rho / n$ of photon gas, where $n=d+D=9$. Einstein equations are expressed as

where $\bar{G}$ is the $(1+d+D)$-dimensional gravitational constant. In the following, we set $8 \pi \bar{G}=1$. The background equation of motion for the matter is

At the early stage, the expansion of the total universe is nearly isotropic (i.e. $r \propto R$ ). At the later stage, the inner space collapses after the maximum expansion, and at the final stage we have an approximate solution

For the solutions (7), Eqs. (4) and (5) lead to $R_{0}^{0}=0$ and $T_{0}^{0}-\frac{1}{2} T_{\mu}^{\mu} \propto \rho$, so that we have

at the final stage.

### 2.1. Classification of perturbations

The simplest treatment of perturbations of geometrical and fluidal quantities is to expand them using harmonics, and to find the gauge-invariant quantities, as in Bardeen's theory for perturbations in the four-dimensional universe[6]. In the multi-dimensional universe consisting of the outer and inner homogeneous spaces $M_{d}$ and $M_{D}$ with different geometrical structures, we can have no harmonics in the $(d+D)$-dimensional space. Abbott et al.[5] considered separate expansions in $\mathrm{M}_{\mathrm{d}}$ and $\mathrm{M}_{\mathrm{D}}$ using the harmonics defined in the individual spaces, classified the perturbations in $M_{d}$ and $M_{D}$ individually as scalar ( S ), vector ( V ), and tensor (T), and classified the 6 types of perturbations in $M_{d}+M_{D}$ as $S S, S V, V S, V V$, ST, and TS. The left and right sides of signatures correspond to the perturbations in $M_{d}$ and $M_{D}$, respectively. The Helmholtz equations defining the harmonics are shown in Appendix A.

In the classification adopted by Abbott et al., the six types of perturbations are divided into three groups:

1. scalar mode (SS),
2. vector mode (SV, VS, VV) ,
3. tensor mode (ST, TS).

In this paper we call these three groups as "modes", corresponding to Abbott et al's "problems".

### 2.2. Perturbed quantities

2.2.1. The scalar mode. The metric perturbations are expressed as

where $q^{(0)}, q_{i}^{(0)}, q_{i j}^{(0)}$ and $Q^{(0)}, Q_{a}^{(0)}, Q_{a b}^{(0)}$ are scalar harmonics in $\mathrm{M}_{\mathrm{d}}$ and $\mathrm{M}_{\mathrm{D}}$, respectively, and $A, b^{(0)}, B^{(0)}, h_{L}, H_{L}, h_{T}^{(0)}, H_{T}^{(0)}$, and $G^{(0)}$ are functions of $t$.
The perturbations of fluid velocities and the energy-momentum tensor are expressed as

where we consider a perfect fluid, so that the anisotropic pressure terms vanish and we have

The metric perturbations in Eq. (11) transform as shown in Appendix A for changes in the coordinates, and the following gauge-invariant quantities are defined:

The gauge-invariant quantities $\Phi_{h}$ and $\Phi_{A}^{(r)}$ in the outer space correspond to the gaugeinvariant perturbations defined by Bardeen[6] in the $(1+3)$-dimensional usual universes,
and $\Phi_{H}$ and $\Phi_{A}^{(R)}$ in the inner space are similar to the above quantities. $\Phi_{h}$ and $\Phi_{H}$ represent the curvature perturbations in both spaces.
The gauge-invariant quantities for fluid velocity and energy density perturbations are given by

2.2.3. The tensor mode. We have only metric perturbations given by

and have no fluidal perturbations, where have we neglected anisotropic stresses. In this mode, $h_{T}^{(2)}$ and $H_{T}^{(2)}$ correspond to the TS and ST parts of curvature perturbations and they themselves are gauge-invariant.

### 2.3. Perturbed Einstein equations

The perturbed Einstein equations are

In Ref.[5], Eq. (43) was not adopted as the equation to be solved, but it is a fundamental equation to be solved to derive $\Phi_{h}$ and $\Phi_{H}$ in general situations. They paid attention only to
the case when $\rho \rightarrow 0$ at the final stage $r \rightarrow \infty$ and $R \rightarrow 0$. In this case, Eq.(39) with $\rho \epsilon=0$ may be one of the conditions for constraining the behaviors of $\Phi_{h}$ and $\Phi_{H}$, and they could derive the behavior of $\Phi_{h}$ and $\Phi_{H}$ using it in the limit of small wave-numbers. In present paper, however, we use Eqs. (43) and (44) to derive their behaviors in more general cases including the case of large wave-numbers. Then, equations to be solved are Eqs. (32), (37), (42), and (44) for the four quantities $\tilde{\Phi}_{G}, \Phi_{6}, \Phi_{h}$, and $\Phi_{H}$.

The four equations Eqs.(57), (58), (62), and (63) are basic equations to be solved for deriving $\tilde{\Phi}_{G}, \Phi_{6}, \Phi_{h}$ and $\Phi_{H}$. In this system of equations, two wave-numbers $k_{r}^{(0)}$ and $k_{R}^{(0)}$ appear, and so the solutions are functions of these two wave-numbers.

The above four equations can be solved from the epoch $x_{i}$ numerically in the direction of increasing $x$ (or decreasing $t$ ), when we use Eq. (73) as the condition at the epoch. They

were solved using the Runge-Kutta method. An example of the numerical solutions is shown in Fig. 1, which gives $\Phi_{h}$ and $\Phi_{H}$ in the case of $x_{i}=0.1$ and $\mu=0$. It is found that, during the stage of $x \ll 1, \Phi_{h}$ and $\Phi_{H}$ behave simply as $\propto x^{-2}$ and $\propto x^{-1}$, respectively, but, as $x$ ( or $\tau$ ) increases, the behaviors change, and they oscillate when $x \gg 1$.
Now let us consider the case when $x \gg 1$ and $\mu / x \ll 1$. In this case, the outer wavenumber $\left(k_{r}^{(0)} / r\right)$ is $\gg 1$ and much larger than the inner wave-number $\left(k_{R}^{(0)} / R\right)$, as can be found from Eq. (72). Here we neglect the terms $\mu / x$ in four equations (65) - (68), and assume that all quantities have an oscillatory factor $\exp i \omega x$, where $\omega$ is a constant frequency. Then $\Phi_{G x}, \Phi_{6 x}, \Phi_{h}$, and $\Phi_{H}$ are expressed as

Now let us consider the case when $y \gg 1$ and $\nu y^{2}(=\mu / x) \ll 1$. In this case, the inner wave-number $\left(k_{R}^{(0)} / R\right)$ is $\gg 1$ and much larger than the outer wave-number $\left(k_{r}^{(0)} / r\right)$, as can be found from Eq. (97). Here we neglect the terms $\nu y^{2}$ in the four equations, and assume that

(b) $\omega=(2 / 3)^{1 / 2}$ and $\Phi_{H 0}=0$

As shown in Appendix C, $\Phi_{h 0}$ for $\omega=(2 / 3)^{1 / 2}$ has the $y$-dependence as

### 3.4. Summary of approximate solutions in the scalar mode

In the case of small $\tau$ and $x \ll 1$ (or $y \ll 1$ ), we have $\Phi_{h} \propto x^{-2}$ and $\Phi_{H} \propto x^{-1}$ (or $\Phi_{h} \propto y^{-4}$ and $\Phi_{H} \propto y^{-2}$ ), respectively, where $x \equiv \frac{3}{4 r_{0}} k_{r}^{(0)} \tau^{4 / 3}$ and $y \equiv \frac{3}{2 R_{0}} k_{R}^{(0)} \tau^{2 / 3}$.
In the case of $x \gg 1$ and $\mu / x \ll 1$ (or $y \gg 1$ and $\left.\nu y^{2}(=x / \mu) \ll 1\right)$, $k_{r}$ dependent perturbations (or $k_{R}$ dependent perturbations) dominate $k_{R}$ dependent ones (or $k_{r}$ dependent ones), respectively. Among the solutions in these cases, only the solutions in the cases of $\omega=1, \alpha \simeq 0.81 \quad\left(\right.$ of $x \gg 1, \mu / x \ll 1$ ) and $\omega=(2 / 3)^{1 / 2}, \beta \simeq 2.13 \quad\left(\right.$ of $y \gg 1, \nu y^{2} \ll 1$ ) grow in the direction of increasing $\tau$, and all the other perturbations grow in the direction of decreasing $\tau$ (or increasing $t$ ).
In Figs. 1 and 2, we can see the behaviors of the solutions with $\omega=1, \alpha \simeq 0.81$ in the region of $x \gg 1$ and $\omega=(2 / 3)^{1 / 2}, \beta \simeq 2.13$ in the region of $y \gg 1$. It is noted that only these perturbations appear as growing ones, when we solve in the direction of increasing $x$ or $y$.

## 4. Solutions in the vector mode

We consider here the VS, SV and VV cases at the final stage with $r=r_{0} \tau^{-1 / 3}$ and $R=$ $R_{0} \tau^{1 / 3}$, and $\rho=p=0$.

### 4.1. The VS case

From Eqs. (48) and (49), we obtain

## 5. Solutions in the tensor mode

Here we consider the TS and ST cases at the final stage.

### 5.1. The TS case

## 6. Evolution of models, perturbations and their spectrum

We consider the evolution of the inner and outer spaces and the perturbations in their spaces at the final stage. Characteristic epochs in the evolution are as follows. Since the total universe starts from the isotropic state, we assume first for simplicity that, at the initial epoch $t_{1}$ of this final stage, both scale-factors are equal, i.e., $R\left(\tau_{1}\right)=r\left(\tau_{1}\right)$, where $\tau_{1}=t_{0}-t_{1}$. As $R\left(\tau_{1}\right)=R_{0} \cdot\left(\tau_{1}\right)^{1 / 3}$ and $r\left(\tau_{1}\right)=r_{0} \cdot\left(\tau_{1}\right)^{-1 / 3}$, we have

Then we have the relation $\left(\bar{k}_{R} / R\right) /\left(\bar{k}_{r} / r\right)=1$ at epoch $\tau_{1}$.
Secondly, let us consider a characteristic epoch $\tau_{2}$, when the mean wavelength of $k_{r}$ dependent perturbations in the outer space is equal to the sound wavelength, that is, $\bar{k}_{r} / r\left(\tau_{2}\right)=1 /\left(c_{s} \tau_{2}\right)$ in all modes, where $c_{s}$ is the sound velocity of photon fluids $(\approx 1)$. The mean value of $x\left(\equiv \frac{3}{4 r_{0}} k_{r} \tau^{4 / 3}\right)$ is $\approx 1$ and $\gg 1$ at $\tau=\tau_{2}$ and $\tau \gg \tau_{2}$, respectively.
Thirdly, we consider another characteristic epoch $\tau_{3}$, when the mean wavelength of $k_{R}$ dependent perturbations in the outer space is equal to the sound wavelength, i.e., $\bar{k}_{R} / R=$ $1 /\left(c_{s} \tau_{3}\right)$ in all modes. The mean values of $y\left(\equiv \frac{3}{2 R_{0}} k_{R} \tau^{2 / 3}\right)$ are $\approx 1$ and $\gg 1$ at $\tau=\tau_{3}$ and $\tau \gg \tau_{3}$, respectively. Then

\tau_{2}=\left(r_{0} / c_{s} \bar{k}_{r}\right)^{3 / 4} \text { and } \tau_{3}=\left(R_{0} / c_{s} \bar{k}_{R}\right)^{3 / 2} \tag{147}
\end{equation*}

so that, using Eq. (146), we obtain the relation

between the three epochs $\tau_{1}, \tau_{2}$ and $\tau_{3}$.

Finally, we consider as the limiting epoch the epoch $\tau_{\dagger}$ when the cosmological entropy reaches the Guth level and the inner space decouples from the outer space. According to my previous work[3], we have $R\left(\tau_{\dagger}\right) / R\left(\tau_{M}\right) \simeq 3.0 \times 10^{-13}$, where $\tau_{M}$ represents an epoch at the stage when the inner space has the maximum expansion. So, if we assume $\tau_{M} \approx \tau_{1}$ roughly,

because of $R \propto \tau^{1 / 3}$.
Now we define the spectrum of perturbations in the outer space as the square of absolute values of curvature perturbations in the scalar mode (i.e., $\left|\Phi_{h}\right|^{2}$ ) which is expressed as their functions of $k_{r}$. The form of the primeval spectrum appearing before the final stage is assumed to be a simple one with a peak in the mean value $\left(\bar{k}_{r}\right)$ of $k_{r}$. At the final stage, the spectrum in the case of $x \gg 1$ and $\mu / x \ll 1$ changes with time due to the evolution of the $k_{r}$ dependent perturbations, but the spectrum in the case of $y \gg 1$ and $\nu y^{2}(=x / \mu) \ll 1$ does not change with time, because $k_{R}$ dependent perturbations are dominant and do not depend on $k_{r}$.
As we have seen, perturbations are functions of two wave-numbers $k_{r}$ and $k_{R}$. Here let us consider the behaviors of perturbations with various values of $k_{r}$. To simplify the treatment about them, we fix in the following the value of $k_{R}$ to the mean value $\bar{k}_{R}$, when we compare the $k_{r}$ dependence with the $k_{R}$ dependence.
(a) First we consider the perturbations with the mean wavelengths, i.e., $k_{r}=\bar{k}_{r}$ at epoch $\tau_{1}$. Then, at epochs $\tau_{1} \gg \tau \gg \tau_{3}$, we have $y \gg 1$ and

\left(\bar{k}_{r} / r\right) /\left(\bar{k}_{R} / R\right) \ll 1 \quad \text { or } \quad \nu y^{2}(=x / \mu) \ll 1, \tag{150}
\end{equation*}
$$

because $r$ increases and $R$ decreases with time. In this case, from the results in Sect. 3, it is found that, in the outer space, the $k_{R}$ dependent perturbations dominate and the change in $k_{r}$ dependent perturbations is relatively small, because the $k_{R}$ dependent perturbations have no role to changing the $k_{r}$ dependence of the spectrum. At epochs $\tau_{\dagger}<\tau<\tau_{3}$, we have $y<1$ and the wave-like behaviors disappear in both of $k_{r}$ and $k_{R}$ dependent perturbations, and so the change in perturbations is expressed in the form of power functions of $\tau$. Accordingly the evolution of perturbations gives only small change in the $k_{r}$ dependence of the spectrum around $k_{r}=\bar{k}_{r}$.
(b) Next we consider the perturbations with $k_{r}\left\langle\bar{k}_{r}\right.$. At epochs $\tau_{1} \gg \tau \gg \tau_{3}$, we have $y \gg 1$ and

\end{equation*}

similarly for the mean perturbations in the inner space $\left(k_{R}=\bar{k}_{R}\right)$. So, the $k_{R}$ dependent perturbations dominate and the change in $k_{r}$ dependent perturbations are relatively small. That is, we have small changes in the spectrum for $k_{r}<\bar{k}_{r}$.
(c) Thirdly we consider the perturbations with $k_{r}>\bar{k}_{r}$. Then we have

during the time interval of

or

\tau_{k}=\left(\bar{k}_{r} / k_{r}\right)^{3 / 2} \tau_{1} \tag{155}
\end{equation*}

In the last equation, we used the relation $\bar{k}_{R}=\bar{k}_{r}$. If $\tau_{1}>\tau_{k}>\tau_{2}$, we have $x>1$ and the $k_{r}$ dependent wavy behavior in these perturbations dominates the $k_{R}$ dependent perturbations in the outer space for $\tau_{1}>\tau>\tau_{k}$. If $\tau_{2}>\tau_{k}>\tau_{3}$, the $k_{r}$ dependent wavy behavior dominates the $k_{R}$ dependent perturbations for $\tau_{1}>\tau>\tau_{2}$ and the $k_{r}$ dependent power-like behavior dominates them for $\tau_{2}>\tau>\tau_{k}$. If $\tau_{3}>\tau_{k}>\tau_{\dagger}$, the $k_{r}$ dependent perturbations dominate the $k_{R}$ dependent perturbations for $\tau_{1}>\tau>\tau_{3}$, and both of $k_{r}$ and $k_{R}$ dependent perturbations are expressed for $\tau_{3}>\tau>\tau_{k}$ as power functions of $\tau$ being independent of $k_{r}$, so that there is no change in the spectrum.

From the above analyses, it is found to be for

$$
\begin{equation*}
k_{r}>\bar{k}_{r} \quad \text { and } \quad \tau_{k}<\tau_{3} \tag{156}
\end{equation*}
$$

that, in the most effective way, the $k_{r}$ dependent perturbations dominate the $k_{R}$ dependent perturbations and can modify the spectrum of perturbations in the outer space. From Eqs. (155) and (156), we obtain the condition

where $k_{r m}$ is the critical values of $k_{r}$ with maximum spectral changes and

1<\left(\tau_{1} / \tau_{3}\right)^{2 / 3}<\left(\tau_{1} / \tau_{\dagger}\right)^{2 / 3} \approx 10^{25} \tag{158}
\end{equation*}
$$

This condition (157) means that, for larger values of $\tau_{1} / \tau_{3}(\gg 1)$, we have spectral changes for larger $k\left(>k_{r m}\right)$.

## 7. Concluding remarks

In this paper we studied the evolution of various perturbations (including the curvature perturbations) in three modes and found that both of $k_{r}$ and $k_{R}$ dependences appear in the perturbations. Sometimes the perturbations depend mainly on $k_{r}$, and sometimes they depend mainly on $k_{R}$. The $k_{R}$ dependent perturbations do not depend on $k_{r}$, and so have no influence on the spectrum of $k_{r}$ dependent perturbations. It was found that, in the large interval of $k_{r}$ including the mean value $\bar{k}_{r}$, the $k_{R}$ dependent perturbations dominate the $k_{r}$ dependent perturbations in the outer space, and so the spectrum of perturbations as functions of $k_{r}$ does not change with time, and that it is $k_{r}>k_{r m}\left[\equiv \bar{k}_{r}\left(\tau_{1} / \tau_{3}\right)^{2 / 3}\right]$ that $k_{r}$ dependent perturbations modify the spectrum by dominating the $k_{R}$ dependent perturbations, where $\tau_{1}$ and $\tau_{3}$ are the initial epoch at the final stage and the epoch when the mean wavelength of $k_{R}$ dependent perturbations is equal to the sound wavelength, respectively, and $\tau_{1} / \tau_{3} \gg 1$.

Thus, in our classical treatments of perturbations, the spectrum of perturbations in the outer space starts from the primeval one at the nearly isotropic stage $\left(\tau>\tau_{1}\right)$, changes mainly for $k_{r}>k_{r m}$ due to the evolution of perturbations at the final stage $\left(\tau_{1}>\tau>\tau_{\dagger}\right)$, and transfers to the observed spectrum of perturbations in the Friedmann stage (after epoch $\left.\tau_{\dagger}\right)$. During the long period from the primeval stage to the final anisotropic stage of the multi-dimensional universe, the perturbations may be created by the quantum fluctuations of scalar, vector and tensor fields. Their treatments may be very interesting, but are beyond the scope of the present work.

We have paid attention only to the spectrum in the scalar mode in Sect. 6. Similar discussions on the spectrum in the vector and tensor modes may be possible.
In this paper we have treated the case with no viscous processes. In the cases with viscous processes, the dynamical evolution of perturbations may be much more complicated, but the fundamental structure, that, in the outer space, perturbations depend on both $k_{r}$ and $k_{R}$ and the change in the spectrum depends on how the $k_{r}$ dependence dominates the $k_{R}$ dependence, may be invariant.

The vector and tensor quantities are constructed from $q^{(0)}$ and $Q^{(0)}$, and indices are raised and lowered by ${ }^{d} g_{i j}$ and ${ }^{D} g_{a b}$ in Eq. (1), i.e.,

\alpha_{h}=\alpha_{H}=1 / 8, \quad \alpha_{6}=13 / 8, \quad \text { and } \quad \alpha_{G}=9 / 8 . \tag{C49}
