CALLIAS-TYPE OPERATORS IN VON NEUMANN ALGEBRAS

Abstract. We study differential operators on complete Riemannian manifolds which act on sections of a bundle of finite type modules over a von Neumann algebra with a trace. We prove a relative index and a Callias-type index theorems for von Neumann indexes of such operators. We apply these results to obtain a version of Atiyah's L^2 -index theorem, which states that the index of a Callias-type operator on a non-compact manifold M is equal to the Γ-index of its lift to a Galois cover of M . We also prove the cobordism invariance of the index of Callias-type operators. In particular, we give a new proof of the cobordism invariance of the von Neumann index of operators on compact manifolds.

1. INTRODUCTION

Index theory of operators acting on bundles of modules over a von Neumann algebra was initiated by Atiyah's [\[3\]](#page-33-0). Atiyah studied the special case of a Galois cover of a compact manifold M with a covering group Γ. More specifically, let D be an elliptic operator acting on a finite dimensional vector bundle over a compact manifold M and let M be a Galois cover of M with covering group Γ. We denote by $\mathcal{N}\Gamma$ the von Neumann algebra of Γ. The lift D of D to M can be viewed as an operator on M with values in a bundle of $N\Gamma$ -modules. Atiyah studied the Γ-index of this operator and showed that it is equal to the index of D. The index theorem for an operator acting on a general bundle of von Neumann modules over a compact manifold was obtained by Schick [\[36\]](#page-34-0).

In this paper we investigate the von Neumann index of Callias-type operators on non-compact manifolds. A Callias-type operator on a complete Riemannian manifold is an operator of the form $B = D + \Phi$, where D is a first order elliptic operator and Φ is a potential satisfying certain conditions. If B acts on sections of a finite dimensional vector bundle, then the conditions on Φ guarantee that the operator B is Fredholm. The study of such operators was initiated by Callias, [\[19\]](#page-34-1), and further developed by many authors, cf., for example, [\[7\]](#page-33-1), [\[17\]](#page-34-2), [\[2\]](#page-33-2), [\[18\]](#page-34-3). Several generalizations and new applications of the Callias-type index theorem were obtained recently, cf. [\[30\]](#page-34-4), [\[21\]](#page-34-5), [\[37\]](#page-34-6), [\[31\]](#page-34-7), [\[14\]](#page-33-3).

The extension of the definition of Callias-type index to operators acting on sections of a bundle of modules over a von Neumann algebra was obtained in [\[13\]](#page-33-4). In this paper we obtain several properties of this index.

1.1. The relative index theorem. The relative index theorem of Gromov and Lawson [\[25\]](#page-34-8) allows to use a "cut and paste" procedure to compute the index. This theorem was reformulated

for Callias-type operators by Anghel [\[1\]](#page-33-5) and Bunke [\[18\]](#page-34-3). Moreover, Bunke considered the case of C^* -algebra valued differential operators invertible at infinity.

Our first result in this paper is a version of the relative index theorem for operators acting on bundles of modules over a von Neumann algebra with finite trace. Notice, that our result does not follow directly from [\[18\]](#page-34-3), since it is not clear whether the von Neumann index descends from the K-theoretical index used by Bunke. In particular, it is not clear whether our operators satisfy the conditions required in [\[18\]](#page-34-3).

1.2. The Callias-type index theorem. The Callias-type index theorem, [\[2\]](#page-33-2), [\[18\]](#page-34-3), states that the index of a Callias-type operator B is equal to the index of a certain operator induced by the restriction of B to a compact hypersurface. We show that this result continues to hold for the von Neumann index of operators acting on sections of a bundle of modules over a von Neumann algebra.

Our proof uses the relative index theorem and is similar to the proof in the case of a finite dimensional vector bundles in [\[2\]](#page-33-2) and [\[18\]](#page-34-3). However, more care is needed due to the fact that the spectrum of B is not discrete around 0, see Section [4.6](#page-15-0) for details.

1.3. The cobordism invariance of the von Neumann index. The cobordism invariance of the index was used in the original proof of the index theorem [\[4\]](#page-33-6) (see also [\[35\]](#page-34-9)). The cobordism invariance of the index of Callias-type operators acting on finite dimensional vector bundles was recently obtained in [\[14\]](#page-33-3).

In this paper we show that the cobordism invariance of the index can be obtained as an easy corollary of the Callias-type index theorem. By this method we prove the cobordism invariance of the von Neumann index both for Dirac-type operators on compact manifolds and for Calliastype operators on non-compact manifolds.

1.4. Atiyah's type L^2 -index theorem. Let M be a complete Riemannian manifold and let B be a Callias-type operator on M , acting on sections of a *finite dimensional* vector bundle $E \to M$. Let M be a Galois cover of M with covering group Γ. We denote by B the lift of B to M. Then B is a Γ-equivariant operator and its Γ-index ind_Γ B is well defined. We show that

$$
\operatorname{ind}_{\Gamma}\widetilde{B} \;=\; \operatorname{ind} B.
$$

For the case when the manifold M is compact, this result was proven by Ativah [\[3\]](#page-33-0).

1.5. The paper is organized as follows: in Section [2](#page-1-0) we formulate the main results of the paper. In Section [3](#page-10-0) we prove the relative index theorem. Sections [4](#page-14-0)[–6](#page-25-0) are devoted to the proof of the Callias-type index theorem. In Section [7](#page-28-0) we prove the cobordism invariance of the index. Finally in Section [8](#page-29-0) we prove the Atiyah-type L^2 -index theorem for Callias-type operators.

2. The main results

In this section we formulate the main results of the paper.

2.1. Callias-type operators. Let A be a von Neumann algebra with a finite, faithful, normal trace $\tau : A \to \mathbb{C}$ and let M be a complete Riemannian manifold. Assume $E = E^+ \oplus E^-$ is a \mathbb{Z}_{2} graded A-Hilbert bundle of finite type over M (for this notion we refer to [\[36,](#page-34-0) Sections 8.1-8.3] and [\[13,](#page-33-4) Section 3.5]). Let

$$
\mathcal{D}:=\left(\begin{array}{cc}0 & D^- \\ D^+ & 0\end{array}\right)
$$

be an elliptic differential operator acting on smooth sections of E , where

$$
D^{\pm}: C^{\infty}(M, E^{\pm}) \to C^{\infty}(M, E^{\mp})
$$

are formally adjoint to each other. We make the following

Assumption 2.2. The principal symbol of D is uniformly bounded from above, i.e. there exists a constant $b > 0$ such that

$$
\|\sigma(\mathcal{D})(x,\xi)\| \le b\|\xi\|, \qquad \text{for all } x \in M, \ \xi \in T_x^*M. \tag{2.1}
$$

Here $|\xi|$ denotes the length of ξ defined by the Riemannian metric on M, $\sigma(D)(x,\xi): E_x^+ \to E_x^$ is the leading symbol of $\mathcal D$, and $\|\sigma(\mathcal D)(x,\xi)\|$ is its operator norm.

By [\[13\]](#page-33-4), the above assumption guarantees that the operator D is essentially self-adjoint.

Let $F^+ : E^+ \to E^-$ be a morphism of A-Hilbert bundles and consider the odd self-adjoint endomorphism of E

$$
\mathcal{F}:=\left(\begin{array}{cc}0 & F^-\\F^+ & 0\end{array}\right),
$$

where $F^- : E^- \to E^+$ is the formal adjoint of F^+ .

Definition 2.3. The endomorphism F is called admissible if

(i) the anticommutator

$$
\{\mathcal{D},\mathcal{F}\}:=\mathcal{D}\circ\mathcal{F}+\mathcal{F}\circ\mathcal{D}=\left(\begin{array}{cc}D^-F^++F^-D^+&0\\0&D^+F^-+F^+D^-\end{array}\right)
$$

is an operator of order 0;

(ii) there exist a constant $c > 0$ and a compact set $K \subset M$ such that

$$
\mathcal{F}^2 + \{\mathcal{D}, \mathcal{F}\} \ge c,\qquad \text{on } M \setminus K. \tag{2.2}
$$

In this case, we say that the compact set K is an essential support of \mathcal{F} .

Definition 2.4. A Callias-type operator is an operator of the form

$$
B := \mathcal{D} + \mathcal{F} = \begin{pmatrix} 0 & D^{-} + F^{-} \\ D^{+} + F^{+} & 0 \end{pmatrix}, \tag{2.3}
$$

where F is an admissible endomorphism. We set $B^{\pm} := D^{\pm} + F^{\pm}$.

2.5. The τ -index of a Callias-type operator. We use the Riemannian metric on M and the inner product on the fibers of E to define the A-Hilbert space $L^2(M, E)$ of square-integrable sections of E and we regard B as an A-linear unbounded operator on $L^2(M, E)$. By [\[13,](#page-33-4) Theorem 2.3, B is essentially self-adjoint with initial domain $C_c^{\infty}(M, E)$. We denote its closure by the same symbol B.

The trace $\tau : A \to \mathbb{C}$ on A induces a dimension function

$$
\dim_{\tau} : \operatorname{Gr}(L^2(M,E)) \longrightarrow [0,\infty],
$$

where $\text{Gr}(L^2(M, E))$ denotes the set of closed A-invariant subspaces of $L^2(M, E)$: for the construction of the function dim_τ out of the trace τ see [\[33,](#page-34-14) Sections 1.1.3 and 9.1.4]. By [\[13,](#page-33-4) Theorem 2.19], the operator B is τ -Fredholm (for the notion of closed τ -Fredholm operator we refer to [\[15\]](#page-33-11) and [\[16\]](#page-33-12)). In particular, this means that the A-Hilbert spaces Ker B^{\pm} have finite τ -dimension and we define the τ -index of B by

$$
\operatorname{ind}_{\tau} B := \dim_{\tau} \ker B^{+} - \dim_{\tau} \ker B^{-}.
$$
\n(2.4)

2.6. A relative index theorem. Suppose E_j , with $j = 0, 1$, are \mathbb{Z}_2 -graded A-Hilbert bundles over complete Riemannian manifolds M_j and $B_j = \mathcal{D}_j + \mathcal{F}_j$ are Callias-type operators. Suppose $M_j = W_j \cup_{N_j} V_j$ are partitions of M_j , where N_j are *compact* hypersurfaces. We make the following

Assumption 2.7. There exist tubular neighborhoods $U(N_0)$, $U(N_1)$ respectively of N_0 , N_1 and a diffeomorphism $\psi : U(N_0) \to U(N_1)$ such that:

- (i) ψ restricts to a diffeomorphism between N_0 and N_1 ;
- (ii) there exists an isomorphism of \mathbb{Z}_2 -graded A-Hilbert bundles $\Psi : E_0|_{U(N_0)} \to E_1|_{U(N_1)}$ covering ψ ;
- (iii) the restrictions $\mathcal{D}_0|_{U(N_0)}$ and $\mathcal{D}_1|_{U(N_1)}$ are conjugated through the isomorphism Ψ .

We cut M_i along N_i and use the map ψ to glue the pieces together interchanging V_0 and V_1 . In this way we obtain the manifolds

$$
M_2 := W_0 \cup_N V_1, \qquad M_3 := W_1 \cup_N V_0,
$$

where $N \cong N_0 \cong N_1$. We refer to M_2 and M_3 as manifolds obtained from M_0 and M_1 by cutting and pasting.

We use the map Ψ to cut the bundles E_0 , E_1 at N_0 , N_1 and glue the pieces together interchanging $E_0|_{V_0}$ and $E_1|_{V_1}$. With this procedure we obtain \mathbb{Z}_2 -graded A-Hilbert bundles $E_2 \to M_2$ and $E_3 \rightarrow M_3$. Use Condition (iii) of Assumption [2.7](#page-3-0) to construct an odd formally self-adjoint first order elliptic operator \mathcal{D}_2 acting on smooth sections of E_2 satisfying Assumption [2.2](#page-2-0) and such that $\mathcal{D}_2|_{W_0} = \mathcal{D}_0|_{W_0}$ and $\mathcal{D}_2|_{V_1} = \mathcal{D}_1|_{V_1}$. In the same fashion, define an elliptic operator \mathcal{D}_3 acting on smooth sections of the bundle E_3 .

Assume \mathcal{F}_0 and \mathcal{F}_1 are admissible endomorphisms respectively of the bundles E_0 and E_1 . For $j = 0, 1$ we choose positive functions $\alpha_j, \beta_j \in C^{\infty}(M_j)$ such that:

(C.1) supp $\alpha_j \subset W_j \cup U(N_j)$ and supp $\beta_j \subset V_j \cup U(N_j)$;

(C.2) $\alpha_j = 1$ on $W_j \setminus U(N_j)$ and $\beta_j = 1$ on $V_j \setminus U(N_j)$; (C.3) $\alpha_j^2 + \beta_j^2 = 1$.

By construction, $E_2|_{W_0\cup U(N_0)} \cong E_0|_{W_0\cup U(N_0)}$ and $E_2|_{V_1\cup U(N_1)} \cong E_1|_{V_1\cup U(N_1)}$. We use this identification and Condition [\(C.1\)](#page-3-1) to define the endomorphism $\mathcal{F}_2 := \mathcal{F}_0 \alpha_0 + \mathcal{F}_1 \beta_1$ of E_2 . In the same way we define the endomorphism $\mathcal{F}_3 := \mathcal{F}_1 \alpha_1 + \mathcal{F}_0 \beta_0$ of E_3 . Observe that \mathcal{F}_2 and \mathcal{F}_3 are admissible so that the operators $B_2 := \mathcal{D}_2 + \mathcal{F}_2$ and $B_3 := \mathcal{D}_3 + \mathcal{F}_3$ are of Callias-type. We often refer to B_2 and B_3 as operators obtained from B_0 and B_1 by cutting and pasting.

The first result of the paper is the following

Theorem 2.8 (Relative index theorem in von Neumann setting).

$$
\operatorname{ind}_{\tau} B_0 + \operatorname{ind}_{\tau} B_1 = \operatorname{ind}_{\tau} B_2 + \operatorname{ind}_{\tau} B_3.
$$

Remark 2.9. In the case $A = \mathbb{C}$, this theorem was proved by Gromov and Lawson in [\[25\]](#page-34-8). A K-theoretical version has been proved by Bunke in [\[18\]](#page-34-3). Our formulation of the relative index theorem is close to this last one. The reason why we cannot apply directly [\[18,](#page-34-3) Theorem 1.2] is that it is not clear whether the numerical index that we use in the present paper descends from a K-theoretical one. In particular, it is not clear whether the operator B is invertible at infinity in the sense of Bunke, cf. the discussion on page 258 of [\[18\]](#page-34-3).

2.10. Ungraded bundles and Callias-type operators. We now describe a class of Calliastype operators constructed out of an *ungraded* bundle. Let M be a complete odd-dimensional Riemannian manifold and let $\Sigma \to M$ be an ungraded A-Hilbert bundle over M. Suppose $D\colon C_c^{\infty}(M,\Sigma) \to C_c^{\infty}(M,\Sigma)$ is a formally self-adjoint first order elliptic operator satisfying Assumption [2.2.](#page-2-0) Let Φ be a self-adjoint endomorphism of Σ .

Definition 2.11. The endomorphism Φ is said to be admissible for the pair (Σ, D) if

- (i) the commutator $[D, \Phi] := D\Phi \Phi D$ is an endomorphism of Σ ;
- (ii) there exist a constant $d > 0$ and a compact set $K \subset M$ such that

$$
\Phi^2(x) \ge d + ||[D, \Phi](x)||, \qquad x \in M \setminus K,\tag{2.5}
$$

where $\|[D, \Phi](x)\|$ denotes the operator norm of the bounded operator $[D, \Phi](x) : \Sigma_x \to$ Σ_x .

In this case we say that K is an essential support of Φ with respect to the pair (Σ, D) and that (Σ, D, Φ) is an admissible ungraded triple over M.

Suppose the endomorphism Φ is admissible and regard $\Sigma \oplus \Sigma$ as a \mathbb{Z}_2 -graded A-Hilbert bundle over M. Then the first order elliptic operator

$$
\mathcal{D} := \left(\begin{array}{cc} 0 & D \\ D & 0 \end{array} \right) \tag{2.6}
$$

is odd with respect to this grading, formally self-adjoint and satisfies Assumption [2.2.](#page-2-0) We use the endomorphism Φ to define the odd self-adjoint endomorphism of $\Sigma \oplus \Sigma$

$$
\mathcal{F}_{\Phi} := i \left(\begin{array}{cc} 0 & -\Phi \\ \Phi & 0 \end{array} \right). \tag{2.7}
$$

Conditions (i) and (ii) of Definition [2.11](#page-4-0) imply that \mathcal{F}_{Φ} is admissible according to Definition [2.3](#page-2-1) and any essential support of Φ is also an essential support of \mathcal{F}_{Φ} .

Definition 2.12. The operator

$$
B_{\Phi} := \mathcal{D} + \mathcal{F}_{\Phi} = \begin{pmatrix} 0 & D - i\Phi \\ D + i\Phi & 0 \end{pmatrix}
$$
 (2.8)

is called the Callias-type operator associated with the triple (Σ, D, Φ) .

The equation [\(2.4\)](#page-3-2) for the Callias index takes in this case the form

$$
\mathrm{ind}_{\tau} B_{\Phi} = \mathrm{dim}_{\tau} \ker(D + i\Phi) - \mathrm{dim}_{\tau} \ker(D - i\Phi). \tag{2.9}
$$

In particular, we obtain

$$
\operatorname{ind}_{\tau} B_{-\Phi} = -\operatorname{ind}_{\tau} B_{\Phi}.
$$
\n(2.10)

Since the index of the Callias-type operator on a *compact* manifold is independent of Φ we obtain the following

Proposition 2.13. The index of a Callias-type operator associated with an ungraded triple (Σ, D, Φ) over a compact manifold is equal to zero.

Remark 2.14. The operator [\(2.8\)](#page-5-0) is a Callias-type operator in the sense of Definition [2.4.](#page-2-2) Notice, however, that not every Callias-type operator is associated with some triple (Σ, D, Φ) . In fact, an operator [\(2.3\)](#page-2-3) is associated with such a triple if and only if there exists an isomorphism $E^+ \to E^-$ which commutes with the leading symbol of D and anticommutes with the admissible endomorphism F.

In the case $A = \mathbb{C}$, Callias-type operators associated with a triple (Σ, D, Φ) were extensively studied, cf. for example, [\[19\]](#page-34-1), [\[17\]](#page-34-2) and [\[2\]](#page-33-2).

2.15. Callias-type Theorem. Let M be a complete oriented n-dimensional Riemannian manifold. Let $\Sigma \to M$ be an ungraded Dirac A-Hilbert bundle over M. This means that Σ is an A-Hilbert bundle of finite type endowed with a Clifford action $c: T^*M \to \text{End}_A(\Sigma)$ of the cotangent bundle and a metric connection ∇^{Σ} compatible with the inner product of the fibers and satisfying the Leibniz rule (for the theory of connections on A-Hilbert bundles we refer to [\[36,](#page-34-0) Sections 8.1-8.3]). When $A = \mathbb{C}$, our definition coincides with the classical notion of a Dirac bundle (see [\[32,](#page-34-15) Definition II.5.2]).

An operator $D: C_0^{\infty}(M, \Sigma) \to C^{\infty}(M, \Sigma)$ is called a *(generalized) Dirac operator* if

$$
[D, f] = c(df)
$$
 for all $f \in C^{\infty}(M)$.

Let (e_1, \ldots, e_n) be an orthonormal basis of the tangent bundle, and (e^1, \ldots, e^n) be the dual basis of T^*M . By [\[5,](#page-33-13) §3.3], there exists $V \in \text{End}_A(\Sigma)$ such that

$$
D = \sum_{i=1}^{n} c(e^i) \nabla_{e_i}^{\Sigma} + V.
$$
 (2.11)

In this situation we refer to D as the Dirac operator associated with the connection ∇^{Σ} and the potential V.

It follows from [\(2.11\)](#page-5-1) that D satisfies Assumption [2.2.](#page-2-0) Suppose $\Phi \in \text{End}_{A}(\Sigma)$ is admissible. Note that Condition (i) of Definition [2.3](#page-2-1) is equivalent in this case to the condition that

$$
[c(\xi), \Phi] = 0, \qquad \text{for all} \quad \xi \in T^*M. \tag{2.12}
$$

We denote by B_{Φ} the Callias-type operator associated with the triple (Σ, D, Φ) .

Suppose that there is a partition $M = M_-\cup_N M_+$, where $N = M_-\cap M_+$ is a smooth compact hypersurface and M[−] is a compact submanifold, whose interior contains an essential support of Φ . Let Σ_N be the restriction of Σ to $N \subset M$. By Condition (ii) of Definition [2.11,](#page-4-0) zero is not in the spectrum of $\Phi(x)$ for all $x \in N$. Therefore

$$
\Sigma_N = \Sigma_{N+} \oplus \Sigma_{N-},\tag{2.13}
$$

where the fiber of Σ_{N+} (resp. Σ_{N-}) over $x \in N$ is the image of the spectral projection of $\Phi_N(x)$ corresponding to the interval $(0, \infty)$ (resp. $(-\infty, 0)$). By (2.12) the endomorphism Φ commutes with the Clifford multiplication. Hence $c(\xi) : \Sigma_{N\pm} \to \Sigma_{N\pm}$ for all $\xi \in T^*M$. It follows that both bundles, Σ_{N+} and Σ_{N-} , inherit the Clifford action of T^*M .

In particular, the Clifford multiplication by the unit normal vector field pointing at the direction of M_+ defines an endomorphism $\gamma : \Sigma_{N\pm} \to \Sigma_{N\pm}$. Since $\gamma^2 = -1$, the endomorphism $\alpha := -i\gamma$ induces a grading

$$
\Sigma_{N\pm} = \Sigma_{N\pm}^+ \oplus \Sigma_{N\pm}^-,\tag{2.14}
$$

where $\Sigma_{N\pm}$ is the span of the eigenvectors of α with eigenvalues ± 1 .

We use the Riemannian metric on M to identify T^*N with a subspace of T^*M . Then the Clifford action of T^*N on $\Sigma_{N\pm}$ is graded with respect to this grading, i.e. $c(\xi): \Sigma_{\pm} \to \Sigma_{\mp}$ for all $\xi \in T^*N$.

Let ∇^{Σ_N} be the connection on Σ_N obtained by restricting the connection on Σ . It does not, in general, preserve decomposition [\(2.13\)](#page-6-1). We define a connection $\nabla^{\Sigma_{N\pm}}$ on the bundle $\Sigma_{N\pm}$ by

$$
\nabla^{\Sigma_{N\pm}} s^{\pm} = \text{pr}_{\Sigma_{N\pm}} \left(\nabla^{\Sigma_{N}} s^{\pm} \right), \qquad s^{\pm} \in C^{\infty}(N, \Sigma_{N\pm}), \tag{2.15}
$$

where $\mathrm{pr}_{\Sigma_{N\pm}}$ is the projection onto the bundle $T^*N\otimes \Sigma_{N\pm}$. Since γ commutes with both, the connection ∇^{Σ_N} and the projection $\mathrm{pr}_{\Sigma_{N\pm}}$, it also commutes with the connection $\nabla^{\Sigma_{N\pm}}$. In other words, $\nabla^{\Sigma_{N\pm}}$ is a graded connection with respect to the grading [\(2.14\)](#page-6-2). By [\[1,](#page-33-5) Lemma 2.7] (see also Section [5.1\)](#page-17-0), it is also compatible with the inner product of the fibers of Σ_{N+} and satisfies the Liebniz rule. Therefore, $\Sigma_{N\pm}$ carries a \mathbb{Z}_2 -graded Dirac A-Hilbert bundle structure.

We denote by $D_N := D_{N+} \oplus D_{N-}$ the Dirac operator on N associated with the connection $\nabla^{\Sigma_{N+}} \oplus \nabla^{\Sigma_{N-}}$ and the zero potential. Then

$$
D_{N\pm} := \sum_{i=1}^{n-1} c(e^i) \nabla_{e_i}^{\Sigma_{N\pm}}, \tag{2.16}
$$

where (e_1, \ldots, e_{n-1}) is an orthonormal frame of TN and (e^1, \ldots, e^{n-1}) is the dual frame of T^*N . The operators $D_{N\pm}$ are odd with respect to the grading [\(2.14\)](#page-6-2), i.e. they have the form

$$
D_{N\pm} = \begin{pmatrix} 0 & D^-_{N\pm} \\ D^+_{N\pm} & 0 \end{pmatrix},
$$

where $D_{N\pm}^+$ (respectively $D_N^ \overline{N}_{N\pm}$) is the restriction of $D_{N\pm}$ to $\Sigma_{N\pm}^+$ (respectively $\Sigma_{N\pm}^-$). It is a classical fact that $D_{N\pm}$ are τ -Fredholm (see for instance [\[36,](#page-34-0) Section 7]) so that they have a well-defined τ -index

$$
\operatorname{ind}_{\tau} D_{N\pm} = \operatorname{dim}_{\tau} \ker D_{N\pm}^+ - \operatorname{dim}_{\tau} \ker D_{N\pm}^-.
$$
 (2.17)

The next theorem is the first main result of this paper. It generalizes [\[2,](#page-33-2) Theorem 1.5] and [\[18,](#page-34-3) Theorem 2.9] to the von Neumann setting.

Theorem 2.16 (Callias-type theorem in von Neumann setting).

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} D_{N+}.
$$

From this theorem and [\(2.10\)](#page-5-2) we immediately obtain

Corollary 2.17. ind_τ $B_{\Phi} = -\text{ind}_{\tau} D_{N-}$. Hence,

$$
\operatorname{ind}_{\tau} D_{N+} = -\operatorname{ind}_{\tau} D_{N-} \tag{2.18}
$$

Remark 2.18. Equality [\(2.18\)](#page-7-0) might look a bit surprising, since at the first glance the bundles Σ_+ and Σ_- might look completely unrelated. However, the fact that both operators, D_{N+} and D_{N-} , are induced by the same operator D puts a strong relation between them. In fact, the direct sum $D_{N+} \oplus D_{N-}$ is *cobordant to 0* in the sense of [\[10\]](#page-33-7), and the cobordism is given by the operator D. Thus the equality (2.18) can be viewed as a version of the cobordism invariance of the index. In fact, it is, in a sense, equivalent to the cobordism invariance, as explained in the next subsection.

If Φ is an admissible function for Σ then so is $\lambda \Phi$ for all $\lambda > 1$. As an immediate corollary of Theorem [2.16](#page-7-1) we obtain the following

Corollary 2.19. The index ind_τ $B_{\lambda\Phi}$ is independent of $\lambda \geq 1$.

Remark 2.20. If the endomorphism Φ is bounded then the domain of the operator $B_{\lambda\Phi}$ is independent of λ and the corollary follows directly from the stability of the τ -index, cf. [\[13,](#page-33-4) Lemma 7.3. However, if Φ is not bounded the domain of $B_{\lambda\Phi}$ depends on λ and the corollary is not a priori obvious.

2.21. The cobordism invariance. We now introduce a class of non-compact cobordisms similar to those considered in $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$ $[24],[26],[8],[12],[14]$. Then we show that the index is invariant under this type of cobordisms. To make the exposition simpler we will only discuss the *null-cobordism* (i.e. the cobordism between a manifold and the empty set). We show that the index of a nullcobordant operator vanishes. A standard argument, cf. for example [\[14,](#page-33-3) Remark 2.10], shows that this is equivalent to the cobordism invariance of the index.

Definition 2.22. Let $\Sigma \to M$ be a Dirac bundles over a complete oriented Riemannian manifold M. Let D be a (generalized) Dirac operator on Σ .

A triple $(W, \overline{\Sigma}, \overline{D})$, where W is a complete manifold with boundary $\partial W \simeq M$, $\overline{\Sigma}$ is a Dirac Abundle over W, and \overline{D} is a Dirac operator on $\overline{\Sigma}$, is called a null-cobordism of D if the following conditions are satisfied:

(i) There is an open neighborhood U of ∂W and a metric-preserving diffeomorphism

$$
\phi: M \times (-\epsilon, 0] \to U. \tag{2.19}
$$

- (ii) Let $\hat{\Sigma} \simeq \Sigma \times \mathbb{R}$ denote the lift of Σ to $M \times \mathbb{R}$. Then the bundle $\hat{\Sigma} \oplus \hat{\Sigma}$ has a natural structure of a Dirac bundle over $M \times \mathbb{R}$, cf. Section [5.1.](#page-17-0) We assume that the restriction of $\overline{\Sigma}$ to $M \times (-\epsilon, 0] \subset U$ is isomorphic to $\widehat{\Sigma} \oplus \widehat{\Sigma}$.
- (iii) Let t denote the coordinate on \mathbb{R} . Consider the operator

$$
\widehat{D} := \begin{pmatrix} i\frac{\partial}{\partial t} & D \\ D & -i\frac{\partial}{\partial t} \end{pmatrix} : C_0^{\infty}(M \times \mathbb{R}, \widehat{\Sigma} \oplus \widehat{\Sigma}) \rightarrow C_0^{\infty}(M_i \times \mathbb{R}, \widehat{\Sigma} \oplus \widehat{\Sigma}).
$$

Then the restriction of \overline{D} to $M \times (-\epsilon, 0]$ is equal to the restriction of \widehat{D} to the same set.

Notice, that the notion of non-compact cobordism is not very useful by itself. For example for any triple (M, Σ, D) the pair $(M \times [0, \infty), \Sigma \times [0, \infty), D)$ is a null-cobordism of (M, Σ, D) . However, if one considers cobordisms carrying some extra structure, like in the next definition, the notion of non-compact cobordism becomes useful and non-trivial.

Definition 2.23. Let $\Sigma \to M$ be a Dirac bundle over a complete oriented Riemannian manifolds M and let D be a (generalized) Dirac operator on Σ . Suppose $\Phi \in \text{End}_A(\Sigma)$ is an admissible endomorphism for (Σ, D) . Let B_{Φ} be the corresponding Callias-type operator. A null-cobordism of B_{Φ} consists of the following data:

- (i) A null-cobordism $(W, \overline{\Sigma}, \overline{D})$ of D;
- (ii) A bundle map $\overline{\Phi} \in \text{End}_A(\overline{\Sigma})$, such that the restriction of $\overline{\Phi}$ to $M \subset \partial W$ is equal to

$$
\begin{pmatrix} \Phi & 0 \\ 0 & \Phi \end{pmatrix} \ \in \ \operatorname{End}_A\big(\widehat{\Sigma} \oplus \widehat{\Sigma}\big)
$$

and there exist a constant $d > 0$ and a compact set $K \subset W$ such that Inequality [\(2.5\)](#page-4-1) holds for all $x \in W \setminus K$.

The operator B_{Φ} is called null-cobordant if there exists a null-cobordism of B_{Φ} .

Theorem 2.24. The τ -index of a null-cobordant Callias-type operator is equal to 0.

In the case when the manifold M is compact the theorem implies the cobordism invariance of the τ -index of Dirac operators on compact manifolds. In fact, as a part of the proof of Theorem [2.24,](#page-8-0) in Section [7](#page-28-0) we give a new proof of the cobordism invariance of the τ -index on compact manifolds.

Remark 2.25. In this paper we first prove the relative index and the Callias-type index theorems and then use them to prove the cobordism invariance of the index. The opposite order of arguments is also possible. In fact, for the case $A = \mathbb{C}$, i.e. for operators acting on finite dimensional vector bundles, the direct proof of the cobordism invariance of the Callias index was given in [\[14\]](#page-33-3). The proof in [14] can be adapted to our current situation using a method similar to the one used in Section [4.](#page-14-0) Then, as it is explained in [\[14\]](#page-33-3), the cobordism invariance of the index implies the relative index theorem.

2.26. The Γ -index Theorem. Let M be a complete oriented Riemannian manifold and let $S \to M$ be an ungraded finite dimensional Dirac bundle.^{[1](#page-9-0)} Let D be a Dirac operator on S, cf. [\(2.11\)](#page-5-1). Let Φ be an admissible endomorphism of Σ . We also suppose that M is a Galois cover of M with deck transformation group Γ. The bundle S lifts to a bundle $\widetilde{S} \to \widetilde{M}$ and the Callias-type operator $B_{\Phi} := \mathcal{D} + \mathcal{F}_{\Phi}$ defined by [\(2.8\)](#page-5-0) lifts to a Γ-equivariant first order elliptic operator $\widetilde{B}_{\Phi} := \widetilde{\mathcal{D}} + \widetilde{\mathcal{F}}_{\Phi}$ acting on smooth sections of $\widetilde{S} \oplus \widetilde{S}$.

The Γ-action on $C_c^{\infty}(\tilde{M},\tilde{S})$ induces an action of Γ on the Hilbert space $L^2(\tilde{M},\tilde{S})$. Fix a closed Γ-invariant subspace L of $L^2(\tilde{M}, \tilde{S})$. Denote by P_L the orthogonal projection onto L and by $K_L(\cdot, \cdot)$ the Schwartz kernel of P_L . For $x \in M$, $K_L(x, x)$ is an endomorphism of the finite dimensional complex vector space \tilde{S}_x and has a well-defined trace tr $K_L(x, x) \in [0, \infty]$. The Γ-dimension of L is defined by the formula

$$
\dim_{\Gamma}(L) := \int_{\Omega} \text{tr}\, K_L(x, x) \, d\tilde{\mu}(x),\tag{2.20}
$$

where $\Omega \subset \widetilde{M}$ is a fundamental domain for the action of Γ and $d\widetilde{\mu}$ is the positive Γ -invariant measure induced by the Riemannian metric on M lifted to \overline{M} . Equation [\(2.20\)](#page-9-1) defines a dimension function on the set of closed Γ-invariant subspaces of $L^2(\tilde{M}, \tilde{S})$. We say that L has a finite von Neuman dimension if $\dim_{\Gamma}(L) < \infty$.

In Section [8.4,](#page-31-0) we show that B_{Φ} can be regarded as a Callias-type operator constructed out of a suitable ungraded Dirac $\mathcal{N}\Gamma$ -bundle W, where $\mathcal{N}\Gamma$ is the group von Neumann algebra of Γ (see Section [8.4\)](#page-31-0). As a consequence of [\[13,](#page-33-4) Theorem 2.3] we deduce the following

Lemma 2.27. The closed Γ -invariant subspaces ker $(D \pm i\tilde{\Phi}) \subset L^2(M, \tilde{V}^{\pm})$ have finite von Neumann dimension.

Define the Γ-index of $\widetilde{B_{\Phi}}$ by

$$
\operatorname{ind}_{\Gamma} \widetilde{B_{\Phi}} := \operatorname{dim}_{\Gamma} \ker(\widetilde{D} + i \widetilde{\Phi}) - \operatorname{dim}_{\Gamma} \ker(\widetilde{D} - i \widetilde{\Phi}).
$$

The second main result of this paper is the following generalization of Atiyah's Γ-index theorem (cf. [\[3,](#page-33-0) Formula (1.1)]) to operators of Callias-type.

¹In other words in this section we assume that $A = \mathbb{C}$. We use the notation S (rather than Σ) for the Dirac bundle, to stress the difference from the other sections where Σ was a Hilbert A-bundle.

Theorem 2.28 (Γ-index theorem for Callias-type operators). Let S be an ungraded Dirac bundle over a complete oriented Riemannian manifold M and let Φ be an admissible self-adjoint endomorphism of S. If \overline{M} is a Galois cover of M , then

$$
\text{ind}_{\Gamma} B_{\Phi} = \text{ind} B_{\Phi},\tag{2.21}
$$

where Γ is the group of the deck transformations of $\widetilde{M} \to M$.

2.29. **Idea of the proof.** We prove Theorem [2.28](#page-10-1) by reduction to the compact case. We choose a compact hypersurface N lying outside of an essential support of Φ and use Theorem [2.16](#page-7-1) to construct a \mathbb{Z}_2 -graded Dirac bundle $E \to N$ and a flat Dirac $\mathcal{N}\Gamma$ -bundle $W \to N$ such that

$$
\operatorname{ind} B_{\Phi} = \operatorname{ind} D, \qquad \operatorname{ind}_{\Gamma} \widetilde{B_{\Phi}} = \operatorname{ind}_{\tau} D_W, \tag{2.22}
$$

where D (resp. D_W) is the graded Dirac operator associated with E (resp. $E \otimes W$). The Atiah's L^2 -index theorem [\[3\]](#page-33-0) (see also [\[36\]](#page-34-0)) implies that

$$
\text{ind } D = \text{ind}_{\tau} D_W. \tag{2.23}
$$

Finally, formula (2.21) follows from (2.22) and (2.23) .

3. The relative index theorem

In this section we prove Theorem [2.8.](#page-4-2) We adapt to the von Neumann setting the K-theoretical argument used by Bunke in [\[18\]](#page-34-3).

3.1. Idea of the Proof. Let M_j , E_j , $B_j := \mathcal{D}_j + \mathcal{F}_j$ denote the same objects as in Section [2.6](#page-3-3) and set $M := M_1 \sqcup M_2 \sqcup M_3 \sqcup M_4$. We use E_1, E_2, E_3 and E_4 to construct the bundle

$$
E := E_1 \oplus E_2 \oplus E_3^{\text{op}} \oplus E_4^{\text{op}} \tag{3.1}
$$

over M , where the superscript "op" means that we consider the opposite grading on the fibers of E_3 and E_4 (see also Section [3.2](#page-11-0) for this notation). Consider the Callias-type operator

$$
B := B_1 \oplus B_2 \oplus B_3 \oplus B_4 \tag{3.2}
$$

acting on smooth sections of E. Then

$$
\operatorname{ind}_{\tau} B = \operatorname{ind}_{\tau} B_1 + \operatorname{ind}_{\tau} B_2 - \operatorname{ind}_{\tau} B_3 - \operatorname{ind}_{\tau} B_4. \tag{3.3}
$$

Theorem [2.8](#page-4-2) is then equivalent to the equality $\text{ind}_{\tau} B = 0$.

For $j = 1, 2$, let α_j , $\beta_j \in C^{\infty}(M_j)$ be the functions defined in Section [2.6.](#page-3-3) We use these functions to construct an *odd* self-adjoint A-equivariant bundle map $U \in C^{\infty}(M, \text{End}_{A}(E))$ with the following properties:

(U.1) $U^2 = id_E;$

(U.2) the anticommutator $\{B, U\} := BU + UB$ is an even compactly supported endomorphism of the bundle E.

By Condition [\(U.1\)](#page-10-5), $U^{-1} = U$. Since the degree of U with respect to the grading on E is odd, i.e. $U: E^{\pm} \to E^{\mp}$, we have

$$
ind_{\tau} UBU = -ind_{\tau} B. \tag{3.4}
$$

From Condition [\(U.2\)](#page-10-6) we deduce that $B + UBU$ is a compactly supported odd self-adjoint A-linear endomorphism of E . Hence, by [\[13,](#page-33-4) Theorem 2.21] we get

$$
ind_{\tau} UBU = ind_{\tau} B. \tag{3.5}
$$

By Equations [\(3.4\)](#page-11-1) and [\(3.5\)](#page-11-2) we finally deduce that $\text{ind}_{\tau} B = -\text{ind}_{\tau} B$, from which the thesis follows.

3.2. Construction of the operator B. Let us first introduce some notation. Given a \mathbb{Z}_2 graded A-module $Z = Z^+ \oplus Z^-$, we denote by $Z^{\rm op}$ the A-module Z endowed with the opposite grading, i.e. $(Z^{op})^{\pm} = Z^{\mp}$. The bundles $E_1 \to M_1$, $E_2 \to M_2$, $E_3^{op} \to M_3$ and $E_4^{op} \to M_4$ define a Z₂-graded A-Hilbert bundle $E \to M$ through Formula [\(3.1\)](#page-10-7). Observe that

$$
C^{\infty}(M, E^{\pm}) = C^{\infty}(M_1, E_1^{\pm}) \oplus C^{\infty}(M_2, E_2^{\pm}) \oplus C^{\infty}(M_3, E_3^{\mp}) \oplus C^{\infty}(M_4, E_4^{\mp}).
$$

With respect to this decomposition, define the odd formally self-adjoint elliptic differential operator

$$
\mathcal{D} = \left(\begin{array}{cc} 0 & D^- \\ D^+ & 0 \end{array} \right),
$$

where

$$
D^{\pm} = \begin{pmatrix} D_1^{\pm} & 0 & 0 & 0 \\ 0 & D_2^{\pm} & 0 & 0 \\ 0 & 0 & D_3^{\mp} & 0 \\ 0 & 0 & 0 & D_4^{\mp} \end{pmatrix} : C^{\infty}(M, E^{\pm}) \longrightarrow C^{\infty}(M, E^{\mp}).
$$

Here, $D_j^{\pm} = \mathcal{D}_j|_{C^{\infty}(M,E^{\pm})}$. Notice that the operator $\mathcal D$ satisfies Assumption [2.2.](#page-2-0) Define the self-adjoint endomorphism of E

$$
\mathcal{F} := \left(\begin{array}{cc} 0 & F^- \\ F^+ & 0 \end{array} \right), \tag{3.6}
$$

where

$$
F^{\pm} = \begin{pmatrix} F_1^{\pm} & 0 & 0 & 0 \\ 0 & F_2^{\pm} & 0 & 0 \\ 0 & 0 & F_3^{\mp} & 0 \\ 0 & 0 & 0 & F_4^{\mp} \end{pmatrix} : E^{\pm} \longrightarrow E^{\mp}.
$$

Observe that $\mathcal F$ is admissible so that the operator

$$
B:=\mathcal{D}+\mathcal{F}
$$

is of Callias-type. Denote by H_j the \mathbb{Z}_2 -graded A-Hilbert spaces $L^2(M_j, E_j)$ and set

$$
H := H_1 \oplus H_2 \oplus H_3^{\text{op}} \oplus H_4^{\text{op}}.
$$
\n
$$
(3.7)
$$

Notice that H coincides with the space of L^2 -sections of the A-Hilbert bundle E. As in Section [2.1](#page-2-4) we use [\[13\]](#page-33-4) to conclude that the Callias-type operator B as a closed odd self-adjoint τ -Fredholm operator on H. Similarly, the Callias-type operators B_j $(j = 1, ..., 4)$ is a closed odd self-adjoint

 τ -Fredholm operator on H_i . From Decomposition [\(3.7\)](#page-11-3) it follows that the operator B has the form (3.2) so that it satisfies (3.3) . The construction of B is complete.

3.3. Construction of the bundle map U. Recall that the functions α_j , $\beta_j \in C^{\infty}(M_j)$ were defined in Section [2.6.](#page-3-3) The function α_1 is smooth and supported in $W_1 \cup U(N_1)$. Since $E_1|_{W_1\cup U(N_1)} \cong E_3|_{W_1\cup U(N_1)}$, multiplication by α_1 defines a bundle map $a: E_1 \to E_3$. In the same fashion, we construct bundle maps $b: E_1 \to E_4$, $c: E_2 \to E_3$ and $d: E_2 \to E_4$ by using respectively the functions β_1 , β_2 and α_2 . Observe that we can also regard α_1 as a smooth function on M_3 with support in $W_1 \cup U(N_1)$. By using again the isomorphism $E_3|_{W_1 \cup U(N_1)} \cong E_1|_{W_1 \cup U(N_1)}$, multiplication by α_1 gives a bundle map $E_3 \to E_1$, that coincides with the map a^* adjoint to a. In the same way we see that the maps b^* , c^* and d^* are multiplication respectively by the functions β_1 , β_2 and α_2 . Condition [\(C.3\)](#page-4-3) of Section [2.6](#page-3-3) implies

$$
aa^* + bb^* = 1, \qquad cc^* + dd^* = 1. \tag{3.8}
$$

We now assume that the functions α_j and β_j are chosen in such a way that

$$
\alpha_1|_{U(N_1)} = \alpha_2|_{U(N_2)}, \qquad \beta_1|_{U(N_1)} = \beta_2|_{U(N_2)}, \tag{3.9}
$$

where the neighborhoods $U(N_1)$ and $U(N_2)$ are identified through the isomorphism ψ of Assumption [2.7.](#page-3-0) Define the odd A-linear self-adjoint operator

$$
V \; := \; \begin{pmatrix} 0 & 0 & -a^* & -b^* \\ 0 & 0 & -c^* & d^* \\ a & c & 0 & 0 \\ b & -d & 0 & 0 \end{pmatrix} : \; C^{\infty}(M, E^{\pm}) \; \longrightarrow \; C^{\infty}(M, E^{\mp}).
$$

We remark that the operator V is odd because we use the opposite grading on E_3 and E_4 . Let ϵ be the grading operator on E, i.e. $\epsilon|_{E^{\pm}} = \pm 1$. Finally set

$$
U := \epsilon V.
$$

In the next two lemmas we show that the map U has the required properties.

First, notice that since V is odd with respect to the grading of E , we have

$$
\{\epsilon, U\} = \epsilon V + V\epsilon = 0,\tag{3.10}
$$

i.e., U is also an odd operator.

Lemma 3.4. *U satisfies Condition [\(U.1\)](#page-10-5).*

Proof. Equations (3.8) and (3.9) together with Condition $(C.1)$ of Section [2.6](#page-3-3) imply

$$
V \circ V = \begin{pmatrix} -\alpha_1^2 - \beta_1^2 & -\alpha_1 \beta_2 + \beta_1 \alpha_2 & 0 & 0 \\ -\beta_2 \alpha_1 + \alpha_2 \beta_1 & -\beta_2^2 - \alpha_2^2 & 0 & 0 \\ 0 & 0 & -\alpha_1^2 - \beta_2^2 & -\alpha_1 \beta_1 + \beta_2 \alpha_2 \\ 0 & 0 & -\beta_1 \alpha_1 + \alpha_2 \beta_2 & -\beta_1^2 - \alpha_2^2 \end{pmatrix} = -id_E.
$$

nce, $U^2 = \epsilon V \epsilon V = -V^2 = id_E.$

Hence, $U^2 = \epsilon V \epsilon V = -V$

Lemma 3.5. *U satisfies condition [\(U.2\)](#page-10-6).*

Proof. Since both B and U are odd differential operators, the commutator $\{B, U\}$ is a differential operator of even degree. It remains to show that $\{B, U\}$ is of order zero and compactly supported. For $s^+ \in C^\infty(M_1, E_1^+)$, we have

$$
(UB + BU)(s^{+}) = aB_{1}^{+}s^{+} - B_{3}^{+}(as^{+})
$$

= $\alpha_{1}(D_{1}^{+} + F_{1}^{+}) (s^{+}) - (D_{1}^{+} + F_{1}^{+}) (\alpha_{1}s^{+})$
= $\alpha_{1}D_{1}^{+}s^{+} - D_{1}^{+} (\alpha_{1}s^{+})$
= $[\alpha_{1}, D_{1}^{+}] (s^{+}).$

Conditions [\(C.1\)](#page-3-1) and [\(C.2\)](#page-4-4) of Section [2.6](#page-3-3) imply that $\left[\alpha_1, D_1^+\right]$ is a bundle map supported in $U(N_1)$. Since the closure of $U(N_1)$ is a compact set, the previous calculation shows that $\{U,B\}|_{C^\infty(M_1,E_1^+)}$ is a compactly supported homomorphism $E_1^+ \to (E_3^\text{op})$ $\binom{10}{3}^+$. A similar argument shows that the homomorphism ${U, B\vert_{C^{\infty}(M_j, E_j^{\pm})}}$ is compactly supported for all j.

3.6. **Proof of Theorem [2.8.](#page-4-2)** We need to show that Conditions $(U.1)$ and $(U.2)$ imply Equations (3.4) and (3.5) .

We start with proving that Equation (3.4) follows from Condition $(U.1)$. Since the functions α_i , β_i are uniformly bounded, U defines an A-equivariant bounded operator on the A-Hilbert space $L^2(M, E)$, that we denote by the same symbol U. By Condition [\(U.1\)](#page-10-5), U is unitary. Since B is τ -Fredholm and U is an A-equivariant isomorphism of A-Hilbert spaces, UBU is τ -Fredholm and the τ -index of UBU is well-defined. As a bundle map, U is odd with respect to the grading of E , i.e. it is of the form

$$
U=\left(\begin{array}{cc} 0 & U^- \\ U^+ & 0 \end{array}\right),
$$

where U^{\pm} : $C^{\infty}(M, E^{\pm}) \longrightarrow C^{\infty}(M, E^{\mp})$. It follows that $(UBU)^{\pm} = U^{\pm}B^{\mp}U^{\pm}$. Since U is an A-equivariant isomorphism, we deduce

$$
Ker (UBU)^{\pm} \cong Ker B^{\mp}, \tag{3.11}
$$

where the isomorphism is taken in the category of A -Hilbert spaces. Since U is unitary, we use Borel functional calculus and from Equation [\(3.11\)](#page-13-0) we deduce

$$
\dim_{\tau} (UBU)^{\pm} = \dim_{\tau} B^{\mp},\tag{3.12}
$$

from which Equation [\(3.4\)](#page-11-1) follows.

It remains to show that Equation [\(3.5\)](#page-11-2) holds. By Conditions [\(U.1\)](#page-10-5) and [\(U.2\)](#page-10-6), the operator

$$
B + UBU = BU^2 + UBU = \{B, U\}U
$$

is a compactly supported odd self-adjoint A-linear endomorphism of the bundle E. It follows from [\[13,](#page-33-4) Theorem 2.21] that

$$
\mathrm{ind}_{\tau} B = \mathrm{ind}_{\tau} (B - (B + UBU)) = \mathrm{ind}_{\tau} (-UBU).
$$

Finally, Equation [\(3.5\)](#page-11-2) follows by noticing that $\text{ind}_{\tau} UBU = \text{ind}_{\tau} (-UBU)$.

4. Analysis on the cylinder

The next three sections are devoted to the proof of Theorem [2.16.](#page-7-1) In this section we define a particular Callias-type operator acting on a cylinder $N \times \mathbb{R}$ with compact base N. We call this operator the model operator and show that Theorem [2.16](#page-7-1) holds in this case. In Section [5](#page-17-1) we consider the case of a manifold with cylindrical ends. We use the relative index theorem to reduce this case to the case of a cylinder $N \times \mathbb{R}$. Finally, in Section [6](#page-25-0) we again use the relative index theorem to reduce the general case to the case of a manifold with cylindrical ends.

4.1. The model operator. Let $E_N = E_N^+ \oplus E_N^ N \over N$ be a \mathbb{Z}_2 -graded Dirac A-Hilbert bundle over a compact oriented manifold N. Let $\nabla^E = \nabla^{E_N^+} \oplus \nabla^{E_N^-}$ be the connection on E_N and let D_N

$$
D_N = \left(\begin{array}{cc} 0 & D_N^- \\ D_N^+ & 0 \end{array} \right),
$$

be a Dirac operator associated with ∇^{E_N} and the zero potential, cf. Section [2.15.](#page-5-3)

It is a classical fact (see for instance [\[23\]](#page-34-18)) that the operator D_N is τ -Fredholm and its τ -index is defined through the formula:

$$
\operatorname{ind}_\tau D_N \,\,=\,\, \dim_\tau \ker D^+_N \,\,-\,\, \dim_\tau \ker D^-_N.
$$

Let $p: N \times \mathbb{R} \to N$ be the projection onto the first factor and denote by \widehat{E}_N the pull-back bundle p^*E_N . Then

$$
\widehat{E}_N = \widehat{E}_N^+ \oplus \widehat{E}_N^-, \qquad \text{where} \quad \widehat{E}_N^{\pm} := p^* E_N^{\pm}.
$$
 (4.1)

The bundle \widehat{E}_N has a natural Clifford action given by:

$$
\widehat{c}(\xi, t) = c(\xi) + \gamma t, \qquad (\xi, t) \in T^*_{(x, r)}(N \oplus \mathbb{R}) = T^*_x N \oplus \mathbb{R}, \qquad (x, r) \in N \times \mathbb{R}, \qquad (4.2)
$$

where c is the Clifford action of T^*N on E_N and $\gamma|_{\widehat{E}_N^{\pm}} = \pm i$. Notice, however, that this action does not preserve the grading [\(4.1\)](#page-14-1).

Endowed with the pull-back connection $\nabla^{\widehat{E}_N}$ induced by the connection on E_N , the bundle \widehat{E}_N becomes an ungraded Dirac A-Hilbert bundle. Let \widehat{D}_N denote the Dirac operator associated with the connection $\nabla^{\widehat{E}_N}$ and the zero potential. With respect to the decomposition

$$
L^{2}(N \times \mathbb{R}, \widehat{E}) = L^{2}(E) \otimes L^{2}(\mathbb{R}).
$$
\n(4.3)

 \widehat{D}_N has the form

$$
\widehat{D}_N := D_N \otimes 1 + \gamma \otimes \partial_r, \tag{4.4}
$$

where ∂_r denotes the operator of derivation in the axial direction of the cylinder $N \times \mathbb{R}$.

Let $h : \mathbb{R} \to \mathbb{R}$ be a smooth function such that

$$
h(r) = \begin{cases} -1, & r < R_1 \\ 1, & r > R_2 \end{cases}
$$
\n
$$
(4.5)
$$

for some constants $R_1 < R_2$. By a slight abuse of notation we will denote by h also the induced function $h: N \times \mathbb{R} \to [-1, 1]$. Notice that the multiplication by h is an admissible endomorphism of the ungraded Dirac A-Hilbert bundle E_N (see Definition [2.11\)](#page-4-0).

Definition 4.2. The model operator M associated with the pair (N, E_N) is the Callias-type operator associated with the ungraded triple $(\widehat{E}_N, \widehat{D}_N, h)$.

Thus

$$
\mathbf{M} := \begin{pmatrix} 0 & \mathbf{M}_{-} \\ \mathbf{M}_{+} & 0 \end{pmatrix}, \tag{4.6}
$$

where $\mathbf{M}_{+} := \widehat{D}_{N} \pm i h$.

4.3. The index of the model operator. As already seen in Section [2.1,](#page-2-4) M is τ -Fredholm and its τ -index is given by

$$
\operatorname{ind}_\tau \mathbf{M} \ = \ \operatorname{dim}_\tau \ker \mathbf{M}^+ - \operatorname{dim}_\tau \ker \mathbf{M}^-.
$$

Our proof of Theorem [2.16](#page-7-1) is based on the following

Proposition 4.4. $\text{ind}_{\tau} D_N = \text{ind}_{\tau} M$.

Remark 4.5. The definition of the operator M depends on the choice of a function h satisfying [\(4.5\)](#page-14-2). Proposition [4.4](#page-15-1) shows that the τ -index of M is independent of this choice. This fact justifies the notation used in Definition [4.2.](#page-15-2)

The rest of this section is occupied with the proof of Proposition [4.4.](#page-15-1)

4.6. Differences from the case $A = \mathbb{C}$. When $A = \mathbb{C}$, Proposition [4.4](#page-15-1) was proven by Anghel in [\[2\]](#page-33-2) by using a separation of variables argument. Anghel proved that for every $\lambda > 0$ there exists $\mu > 0$ such that

$$
\operatorname{im} E_{(-\mu,\mu)}(\mathbf{M}) \subseteq \operatorname{im} E_{(-\lambda,\lambda)}(D_N) \otimes L^2(\mathbb{R}), \tag{4.7}
$$

where $E_{(-\mu,\mu)}(\mathbf{M})$ is the spectral projection of M relative to the interval $(-\mu,\mu)$ and $E_{(-\lambda,\lambda)}(D_N)$ is the spectral projection of D_N relative to the interval $(-\lambda, \lambda)$. Since the operator D_N is Fredholm, 0 is not in the essential spectrum of D_N and we can choose λ_0 such that

$$
\operatorname{im} E_{(-\lambda_0,\lambda_0)}(D_N) = \operatorname{Ker} D_N.
$$

It then follows from [\(4.7\)](#page-15-3) that

$$
Ker \mathbf{M} \subseteq Ker D_N \otimes L^2(\mathbb{R}). \tag{4.8}
$$

In the case when A is an arbitrary von Neumann algebra with a finite trace τ , [\(4.3\)](#page-14-3) and [\(4.7\)](#page-15-3) still hold. However, in general the τ -Fredholmness of D_N doesn't imply that 0 is not in the essential spectrum of this operator and we might not be able to deduce [\(4.8\)](#page-15-4) from [\(4.7\)](#page-15-3). Instead we study the square of the model operator and use the method of $[10, \S3]$ $[10, \S3]$ (see also $[8, \S11.2]$) to compute ker $M = \ker M^2$.

4.7. The square of the model operator. Our proof of Proposition [4.4](#page-15-1) is based on the study of the operator

$$
\mathbf{M}^2 ~=~ \begin{pmatrix} \mathbf{M}_-\mathbf{M}_+ & 0 \\ 0 & \mathbf{M}_+\mathbf{M}_-\end{pmatrix}.
$$

First we compute $M_{-}M_{+}$. Since $\gamma \otimes \partial_r$ anticommutes with D_N , multiplication by ih commutes with D_N , $\gamma^2 = -1$, and $\partial_r h - h \partial_r = h'$, we obtain

$$
\mathbf{M}_{-}\mathbf{M}_{+} = D_{N}^{2} \otimes 1 - 1 \otimes \partial_{r}^{2} + i\gamma \otimes h' + 1 \otimes h^{2}.
$$
 (4.9)

Even though the model operator M is neither even, nor odd with respect to the grading (4.1) , it follows from the equality [\(4.9\)](#page-16-0) that M_M_M does preserve this grading. Moreover,

$$
\mathbf{M}_{-}\mathbf{M}_{+}\big|_{C^{\infty}(N\times\mathbb{R},\widehat{E}_{N}^{\pm})} = D_{N}^{2}\otimes 1 + 1\otimes Q^{\pm}, \tag{4.10}
$$

where

$$
Q^{\pm} = -\partial_r^2 \mp h' + h^2 = (i\partial_r \mp ih)(i\partial_r \pm ih) \geq 0. \tag{4.11}
$$

Similarly,

$$
\mathbf{M}_{+}\mathbf{M}_{-}\big|_{C^{\infty}(N\times\mathbb{R},\widehat{E}_{N}^{\pm})} = D_{N}^{2} \otimes 1 + 1 \otimes Q^{\mp}.
$$
\n(4.12)

4.8. The kernel of M_{\pm} . Since the operators M_{+} and M_{-} are adjoint of each other, we conclude that

$$
\ker \mathbf{M}_{+} = \ker \mathbf{M}_{-} \mathbf{M}_{+}, \qquad \ker \mathbf{M}_{-} = \ker \mathbf{M}_{+} \mathbf{M}_{-}.
$$
 (4.13)

In particular, it follows from the discussion in Section [4.7](#page-16-1) that

$$
\ker \mathbf{M}_{\pm} = \left. \ker \mathbf{M}_{\pm} \right|_{C^{\infty}(N \times \mathbb{R}, \widehat{E}_N^+)} \oplus \ker \mathbf{M}_{\pm} \right|_{C^{\infty}(N \times \mathbb{R}, \widehat{E}_N^-)}.
$$

Since the operators D_N^2 and Q^{\pm} are non-negative, we have

$$
\ker \mathbf{M}_{-} \mathbf{M}_{+} \Big|_{C^{\infty}(N \times \mathbb{R}, \widehat{E}_{N}^{\pm})} = \ker D_{N}^{2} \Big|_{C^{\infty}(N \times \mathbb{R}, E_{N}^{\pm})} \otimes \ker Q^{\pm} = \ker D_{N}^{\pm} \otimes \ker Q^{\pm};
$$

\n
$$
\ker \mathbf{M}_{+} \mathbf{M}_{-} \Big|_{C^{\infty}(N \times \mathbb{R}, \widehat{E}_{N}^{\pm})} = \ker D_{N}^{2} \Big|_{C^{\infty}(N \times \mathbb{R}, E_{N}^{\pm})} \otimes \ker Q^{\mp} = \ker D_{N}^{\pm} \otimes \ker Q^{\mp}.
$$
\n(4.14)

Thus to compute ker M_{\pm} it remains to compute ker Q^{\pm} .

Lemma 4.9. dim ker $Q^+ = 1$ and dim ker $Q^- = 0$.

Proof. By [\(4.11\)](#page-16-2), $y(r) \in \text{ker } Q^{\pm} \subset L^2(\mathbb{R})$ if and only if

$$
y'(r) \ \pm \ h(r)y(r) \ = \ 0.
$$

The lemma follows now from the fact that the solutions of the ODE $y' + hy = 0$ are squareintegrable, whereas the solutions of the ODE $y' - hy = 0$ are not.

Using [\(4.13\)](#page-16-3) and [\(4.14\)](#page-16-4) we obtain the following corollary of Lemma [4.9](#page-16-5)

Corollary 4.10. The A-Hilbert spaces ker M_+ and ker D_N^+ $_N^+$ are isomorphic. Similarly, the A-Hilbert spaces ker **M**_− and ker $D_N^ N_N$ are isomorphic. In particular,

$$
\dim_{\tau} \ker \mathbf{M}_{\pm} = \dim_{\tau} D_{N}^{\pm}.
$$

4.11. Proof of Proposition [4.4.](#page-15-1) By Corollary [4.10,](#page-16-6) we have

$$
\mathrm{ind}_{\tau} \, \mathbf{M} = \dim_{\tau} \ker \mathbf{M}_{+} - \dim_{\tau} \ker \mathbf{M}_{-} = \dim_{\tau} \mathrm{Ker} \, D_{N}^{+} - \dim_{\tau} \mathrm{Ker} \, D_{N}^{-} = \mathrm{ind}_{\tau} \, D_{N}.
$$

 \Box

5. A manifold with cylindrical ends

In this section we prove Theorem [2.16](#page-7-1) for the special case of a manifold with cylindrical ends.

5.1. A manifold with cylindrical ends. We use the notation of Section [2.15.](#page-5-3) In addition we assume that $M_+ = N \times [1,\infty)$ for some compact manifold N. In other words, we assume that

$$
M = M_{-} \cup_{N} (N \times [1, \infty)), \qquad (5.1)
$$

where M[−] is a compact manifold with boundary, whose interior contains an essential support of the potential $\Phi \in \text{End}_{A}(\Sigma)$.

5.2. A Dirac operator on the hypersurface N. We identify N with $N \times \{1\} \subset M$. Let Σ_N and Φ_N denote the restrictions of Σ and Φ to $N \simeq N \times \{1\}$. Since an essential support of Φ is contained in the interior of $M_$, the bundle map Φ_N is non-degenerate. As in Section [2.15](#page-5-3) we decompose

$$
\Sigma_N = \Sigma_{N+} \oplus \Sigma_{N-}, \tag{5.2}
$$

where, for every $x \in N$, $\Sigma_{N+}(x)$ (respectively $\Sigma_{N-}(x)$) is the closed A-invariant subspace of $\Sigma_N(x)$ obtained as the image of the spectral projection of $\Phi_N(x)$ corresponding to the interval $(0,\infty)$ (resp. $(-\infty,0)$). We denote by $\Phi_{N\pm}$ the restrictions of Φ_N to $\Sigma_{N\pm}$. It follows from [\(2.12\)](#page-6-0) that the grading [\(5.2\)](#page-17-2) is preserved by Clifford multiplication, i.e.

$$
c(\xi): \Sigma_{N\pm} \to \Sigma_{N\pm}, \qquad \text{for all} \quad \xi \in T^*N. \tag{5.3}
$$

The bundle Σ_{N+} plays in what follows the same role as the bundle E_N in Section [4.](#page-14-0) However, in general, the connection ∇^{Σ_N} , induced on Σ_N by ∇^{Σ} , does not preserve the grading [\(5.2\)](#page-17-2). That is why we need to define new connections

$$
\nabla^{\Sigma_{N\pm}}\ :=\ \operatorname{pr}_{\Sigma_{N\pm}}\circ\nabla^{\Sigma_{N}}
$$

on $\Sigma_{N\pm}$, cf. [\(2.15\)](#page-6-3). This makes the situation of this section slightly different from the one considered in Section [4.](#page-14-0) To apply the results of Section [4](#page-14-0) we need to deform the connection ∇^{Σ_N} so that it does preserve the grading. Lemma [5.8](#page-18-0) guarantees that such a deformation exists and preserves the index.

Let $D_N = D_{N+} \oplus D_{N-}$ be the Dirac operator on Σ_N associated to the connection $\nabla^{\Sigma_{N+}} \oplus$ $\nabla^{\Sigma_{N-}}$ and the zero potential, cf. [\(2.16\)](#page-6-4).

5.3. A Dirac operator on the cylinder $N \times \mathbb{R}$. Let $p : N \times \mathbb{R} \to N$ be the projection and denote by

$$
\widehat{\Sigma}_N = \widehat{\Sigma}_{N+} \oplus \widehat{\Sigma}_{N-}, \qquad \widehat{\Sigma}_{N\pm} := p^* \Sigma_{N\pm}, \tag{5.4}
$$

the pull-back bundle over $N \times \mathbb{R}$. Let $\nabla^{\widehat{\Sigma}_N}$ denote the connection on $\widehat{\Sigma}_N$ obtained by pulling back the connection ∇^{Σ_N} . Notice that in general this connection does not preserve the grading $(5.4).$ $(5.4).$

Endowed with the connection $\nabla^{\hat{\Sigma}_N}$ and the Clifford action [\(4.2\)](#page-14-4) the bundle $\hat{\Sigma}_N$ becomes a Dirac bundle. Let

$$
\widehat{D}_N : C^{\infty}(N \times \mathbb{R}, \widehat{\Sigma}_{N+}) \rightarrow C^{\infty}(N \times \mathbb{R}, \widehat{\Sigma}_{N+})
$$

denote the Dirac operator on $\hat{\Sigma}_N$ associated to the connection $\nabla^{\hat{\Sigma}_N}$ and the zero potential.

Remark 5.4. We warn the reader that the operator \widehat{D}_N introduced above is not related to D_N by formula [\(4.4\)](#page-14-5). This is because D_N was defined using the connection

$$
\nabla^{\Sigma_{N+}} \oplus \nabla^{\Sigma_{N-}} \neq \nabla^{\Sigma_{N}}.
$$

This is one of the difficulties which arise in trying to use the results of Section [4](#page-14-0) in the proof of Theorem [2.16.](#page-7-1) We address this problem by deforming the connection ∇^{Σ_N} in such a way that the index of the operator \hat{D}_N does not change, cf. Lemma [5.8.](#page-18-0)

Finally, we denote by $\widehat{\Phi}_N \in \text{End}_A(\widehat{\Sigma}_N)$ and $\widehat{\Phi}_{N\pm} \in \text{End}_A(\widehat{\Sigma}_{N\pm})$ the lifts of Φ_N and $\Phi_{N\pm}$ to the cylinder $N \times \mathbb{R}$. Notice that $\widehat{\Phi}_{N+}$ is a strictly positive operator, while $\widehat{\Phi}_{N-}$ is a strictly negative operator.

5.5. A Callias-type theorem for a manifold with cylindrical ends. The main result of this section is the following special case of Theorem [2.16.](#page-7-1)

Proposition 5.6. In the situation of Theorem [2.16,](#page-7-1) suppose that $M = M_{-} \cup_{N} (N \times [1, \infty))$, where M_ is a compact submanifold with boundary $\partial M \simeq N$. Assume that there exist $\epsilon > 0$ and an open neighborhood of N in M_ isometric to $N \times (1 - \epsilon, 1]$ such that $M \setminus (N \times (1 - \epsilon, \infty))$ is an essential support of Φ . Suppose that the restriction $\Sigma|_{N\times(1-\epsilon,\infty)}$ coincides with $\widehat{\Sigma}_{N+} \oplus \widehat{\Sigma}_{N-}$, the restriction $D|_{N\times(1-\epsilon,\infty)}$ coincides with \widehat{D}_N and $\Phi|_{N\times(1-\epsilon,\infty)} = \widehat{\Phi}_{N+} \oplus \widehat{\Phi}_{N-}$. Then

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} D_{N+}.
$$
\n(5.5)

The rest of this section is occupied with the proof of Proposition [5.6.](#page-18-2)

5.7. Deformation of the data on the cylindrical end. In the next two lemmas we construct a deformation of the restriction of the connection ∇^{Σ} and the potential Φ to the cylindrical end $N \times (1 - \epsilon, \infty)$, and show that the τ -index of B_{Φ} is preserved by these deformations.

In particular, in Lemma [5.8](#page-18-0) we construct a new connection $\nabla^{\prime\Sigma}$ on Σ . We denote by D' the Dirac operator associated with the connection $\nabla^{\prime\Sigma}$ and the zero potential, cf. Section [2.5.](#page-3-4) We also denote by $\nabla^{\widehat{\Sigma}_{N\pm}}$ the connection on $\widehat{\Sigma}_{N\pm}$ obtained by pulling back the connection $\nabla^{\Sigma_{N\pm}}$.

Lemma 5.8. Under the hypotheses of Proposition [5.6,](#page-18-2) there exists a connections $\nabla^{\prime \Sigma}$ on Σ and a number $\lambda \geq 1$, such that

- (i) $\nabla^{\prime \Sigma} \big|_{N \times (1-\epsilon,\infty)} = \nabla^{\widehat{\Sigma}_{N+}} \oplus \nabla^{\widehat{\Sigma}_{N-}};$
- (ii) $\lambda \Phi$ is an admissible endomorphism for the pair (Σ, D') ;
- (iii) $\text{ind}_{\tau} B'_{\lambda \Phi} = \text{ind}_{\tau} B_{\Phi}$ for all $t \in [0,1]$, where $B'_{\lambda \Phi}$ denotes the Callias-type operator associated with the triple $(\Sigma, D', \lambda \Phi)$.

Lemma 5.9. Under the hypotheses of Proposition [5.6](#page-18-2) assume that

$$
\nabla^{\Sigma}\big|_{N\times(1-\epsilon,\infty)} = \nabla^{\widehat{\Sigma}_{N+}} \oplus \nabla^{\widehat{\Sigma}_{N-}}.
$$
\n(5.6)

Then there exists an admissible endomorphism Φ' for (Σ, D) such that

- (i) The restriction of Φ' to $N \times (1 \epsilon, \infty)$ is the grading operator on $\Sigma|_{N \times (1 \epsilon, \infty)} = \widehat{\Sigma}_{N+} \oplus$ $\widehat{\Sigma}_{N-}, i.e. \Phi' |_{\widehat{\Sigma}_{N\pm}} = \pm 1;$
- (ii) $\text{ind}_{\tau} B_{\Phi'} = \text{ind}_{\tau}^{-1} B_{\Phi}$, where $B_{\Phi'}$ denotes the Callias-type operator associated with the triple (Σ, D, Φ') .

The proofs of these lemmas are presented at the end of this section, after we explained how the lemmas are used to prove Proposition [5.6.](#page-18-2)

5.10. Scketch of the proof of Proposition [5.6.](#page-18-2) If follows from Lemmas [5.8](#page-18-0) and [5.9](#page-19-0) that it is enough to prove the proposition for the case when the connection ∇^{Σ} satisfies $\nabla^{\Sigma_{N}}$ = $\nabla^{\Sigma_{N+}} \oplus \nabla^{\Sigma_{N-}}$ and Φ_N is the grading operator on Σ_N .

Let $M_1 = -M$ denote a copy of M with the opposite orientation. Then M_1 is naturally isomorphic to $(N \times (-\infty, 1]) \cup_N (-M_-)$. The bundle Σ induces a Dirac bundle $\Sigma_1 := -\Sigma$ on M_1 , cf. Section [5.11.](#page-20-0) Let D_1 be the corresponding Dirac operator.

In Section [5.12](#page-20-1) we construct a potential Φ_1 on Σ_1 such that

- (i) the restriction of the Callias-type operator B_{Φ_1} associated with the triple (Σ_1, D_1, Φ_1) to the cylinder $N \times (-\infty, 1]$ is equal to $M \oplus T$, where M is the model operator of Definition [4.2,](#page-15-2) and $T^2 > 0$;
- (ii) $\text{ind}_{\tau} B_{\Phi_1} = 0.$

The restriction of all the data to neighborhoods of $N \times \{1\}$ in M and M_1 coincide. Hence, we can apply the relative index theorem to compute

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} B_{\Phi} + \operatorname{ind}_{\tau} B_{\Phi_1}.
$$
 (5.7)

The cut and paste procedure of Section [2.6](#page-3-3) applied to manifolds M and M_1 yields manifolds

$$
M_2 = N \times \mathbb{R} \quad \text{and} \quad M_3 = M_- \cup_N (-M_-).
$$

Let B_2 and B_3 be the Callias-type operators on M_2 and M_3 obtained from B_{Φ} and B_{Φ_1} by cutting and pasting. One readily sees that B_2 is equal to $\mathbf{M} \oplus T$, where M is the model operator of Definition [4.2,](#page-15-2) and $T^2 > 0$. Hence, $\text{ind}_{\tau} B_2 = \text{ind}_{\tau} M$. Also B_3 is a Callias-type operator on a compact manifold M_3 . Thus ind_{τ} B₃ = 0 by Proposition [2.13.](#page-5-4) The relative index theorem and [\(5.7\)](#page-19-1) imply that

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} B_2 + \operatorname{ind}_{\tau} B_3 = \operatorname{ind}_{\tau} M. \tag{5.8}
$$

Proposition [5.6](#page-18-2) follows now from Proposition [4.4.](#page-15-1)

5.11. The manifold with the reversed orientation. Before presenting the details of the proof of Proposition [5.6,](#page-18-2) we introduce some additional notation.

For an oriented manifold W we denote by $-W$ a copy of this manifold with the opposite orientation. If E is a Dirac bundle over W, we denote by $-E$ the same bundle viewed as a vector bundle over $-W$, endowed with the *opposite* Clifford action. This means that a vector $\xi \in T^*W \simeq T^*(-W)$ acts on $-E$ by $c(-\xi)$. The change of the Clifford action is needed because we reversed the orientation of $M_-\$ (for more details about this construction we refer to [\[18,](#page-34-3) Section 2.3.2 and $[6, Chapter 9]$.

From now on we assume that $W = W_-\cup_N (N \times [1,\infty))$. Then there is a natural orientation preserving isometry

$$
\psi: -W \stackrel{\sim}{\longrightarrow} (N \times (-\infty, 1]) \cup_N (-W_-),
$$

such that

$$
\psi(x) = x, \qquad \text{if} \quad x \in -W_- \simeq W_-
$$

$$
\psi(y, t) = (y, 2 - t), \qquad \text{if} \quad (y, t) \in N \times [1, \infty).
$$

To simplify the notation we will skip ψ from the notation and simply write

$$
-W = (N \times (-\infty, 1]) \cup_N (-W_-). \tag{5.9}
$$

Let E_N be a bundle over N and let \widehat{E}_N denote the pull-back of E_N by the projection map $p: N \times \mathbb{R} \to N$. Suppose that E is a bundle over $W = W_-\cup_N (N \times [1,\infty))$ whose restriction to $N \times [1,\infty)$ coincides with the restriction of E_N to the same cylinder. Recall that $-E$ is a bundle over the manifold [\(5.9\)](#page-20-2). One readily sees that

$$
-E\Big|_{N\times(-\infty,1]} \simeq \widehat{E}_N\Big|_{N\times(-\infty,1]}.\tag{5.10}
$$

5.12. Construction of a potential on $-M$. Consider the manifold $M_1 := -M$. Then by (5.9) we have

 $M_1 = (N \times (-\infty, 1]) \cup_N (-M_-).$

Consider the bundle $\Sigma_1 = -\Sigma$ over M_1 . By [\(5.10\)](#page-20-3) the restriction of Σ_1 to the cylinder part coincides with $\widehat{\Sigma}_N$. In particular, this restriction has a natural grading [\(5.4\)](#page-18-1)

$$
\widehat{\Sigma}_N = \widehat{\Sigma}_{N+} \oplus \widehat{\Sigma}_{N-}.
$$

We denote by D_1 the Dirac operator associated with the connection on Σ_1 .

Let $h : \mathbb{R} \to [-1,1]$ be a smooth function such that

$$
h(r) = \begin{cases} -1, & r < -1 \\ 1 & r > 0 \end{cases}, \qquad r \in \mathbb{R}.
$$
 (5.11)

By a slight abuse of notation we also denote by h the induced function $h : N \times \mathbb{R} \to [-1, 1]$. Let Φ_1 be the admissible endomorphism of Σ_1 , which coincides with Φ on $(N \times (1 - \epsilon, 1]) \cup_N (-M_-)$ and such that

$$
\Phi_1|_{N\times(-\infty,1+\epsilon)} = \begin{pmatrix} h & 0 \\ 0 & -1 \end{pmatrix}.
$$

Notice, that we can view the product $N \times (1 - \epsilon, 1 + \epsilon)$ as a subset of both manifolds M and M_1 . Then the restrictions of Φ and Φ_1 to this subset coincide.

Lemma 5.13. Let B_{Φ_1} denote the Callias-type operator associated with the pair (Σ_1, Φ_1) . Then

$$
\operatorname{ind}_{\tau} B_{\Phi_1} = 0. \tag{5.12}
$$

Proof. Consider a new potential $\Phi'_1 \equiv -Id$ on Σ_1 and denote by $B_{\Phi'_1}$ the corresponding Calliastype operator. Notice, that the bundle maps Φ_1 and Φ'_1 coincide outside of the compact set

$$
(N \times [-1,1]) \cup_N (-M_-).
$$

It follows now from Theorem 2.21 of [\[13\]](#page-33-4) that

$$
\text{ind}_{\tau} B_{\Phi_1} = \text{ind}_{\tau} B_{\Phi'_1}.
$$
\n(5.13)

Since

$$
B_{\Phi_1'}^2 = \begin{pmatrix} D_1^2 + 1 & 0 \\ 0 & D_1^2 + 1 \end{pmatrix} > 0,
$$

we conclude that $\text{ind}_{\tau} B_{\Phi'_1} = 0$. The lemma follows now from [\(5.13\)](#page-21-0).

5.14. Proof of Proposition [5.6.](#page-18-2) By Lemmas [5.8](#page-18-0) and [5.9](#page-19-0) it is enough to prove the proposition for the case when $\nabla^{\Sigma_N} = \nabla^{\Sigma_{N+}} \oplus \nabla^{\Sigma_{N-}}$ and Φ_N is the grading operator on Σ_N .

Let M_1 , Σ_1 , and Φ_1 be as in the previous section. As we already noted, the restrictions of Φ and Φ_1 to $N \times (1 - \epsilon, 1 + \epsilon)$ coincide. Thus we can apply the relative index theorem [2.8](#page-4-2) to the pair of manifolds M and M_1 . As a result of the cutting and pasting procedure used in this theorem we obtain two new manifolds

$$
M_2 := N \times \mathbb{R}, \qquad M_3 := M_- \cup_N (-M_-). \tag{5.14}
$$

Let B_2 and B_3 be the operators on M_2 and M_3 obtained from B_{Φ} and B_{Φ} by cutting and pasting. It follows immediately from our assumptions that Φ is the grading operator and from the construction of Φ_1 that the restriction of B_2 to $\widehat{\Sigma}_{N+} \oplus \widehat{\Sigma}_{N+}$ is equal to the model operator M, while the restriction of B_2 to $\Sigma_{N-} \oplus \Sigma_{N-}$ is equal the Callias-type operator associated with the ungraded triple $(\Sigma_{N-}, \overline{D}_{N-}, -1)$. In other words,

$$
B_2|_{\widehat{\Sigma}_{N-}\oplus \widehat{\Sigma}_{N-}} = \begin{pmatrix} 0 & \widehat{D}_{N-} + i \\ \widehat{D}_{N-} - i & 0 \end{pmatrix}.
$$

Hence,

$$
B_2^2|_{\widehat{\Sigma}_{N-}\oplus \widehat{\Sigma}_{N-}}\ =\ \begin{pmatrix} \widehat{D}_{N-}^2+1 & 0 \\ 0 & \widehat{D}_{N-}^2+1 \end{pmatrix}\ >\ 0.
$$

We conclude that $\text{ind}_{\tau} B_2|_{\widehat{\Sigma}_{N-}} \oplus \widehat{\Sigma}_{N-}} = 0$ and

$$
\mathrm{ind}_{\tau} B_2 = \mathrm{ind}_{\tau} M.
$$

Furthermore, B_3 is a Callias-type operator on *compact manifold* M_3 . Hence, $\text{ind}_{\tau} B_3 = 0$ by Proposition [2.13.](#page-5-4) Applying the relative index theorem and using Lemma [5.13,](#page-21-1) we now obtain

 $\text{ind}_{\tau} B_{\Phi} = \text{ind}_{\tau} B_{\Phi} + \text{ind}_{\tau} B_{\Phi_1} = \text{ind}_{\tau} B_2 + \text{ind}_{\tau} B_3 = \text{ind}_{\tau} M.$

Proposition [5.6](#page-18-2) follows now from Proposition [4.4.](#page-15-1)

We now pass to the proofs of Lemmas [5.8](#page-18-0) and [5.9.](#page-19-0)

5.15. A rescaling of the potential. Fix $\lambda \geq 1$. If the endomorphism Φ is admissible, then also $\lambda \Phi$ is admissible with the same essential support. Denote by $B_{\lambda \Phi}$ the Callias-type operator associated with $(\Sigma, D, \lambda \Phi)$. The hypotheses of Proposition [5.6](#page-18-2) imply that Φ is constant in the axial direction over the cylindrical end. Therefore, Φ is uniformly bounded and defines a bounded operator on $L^2(M,\Sigma)$. It follows that ${B_{t\Phi}}_{1\leq t\leq\lambda}$ is a continuous homotopy of τ -Fredholm operators with fixed domain. By [\[13,](#page-33-4) Lemma 7.3], we deduce

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} B_{\lambda \Phi}.
$$
\n(5.15)

5.16. Proof of Lemma [5.8.](#page-18-0) By the hypotheses of Proposition [5.6,](#page-18-2)

$$
\Sigma\big|_{N\times(1-\epsilon,\infty)}\ =\ \widehat{\Sigma}_{N+}\oplus\widehat{\Sigma}_{N-}.
$$

With respect to this decomposition, we have

$$
D\big|_{N\times(1-\epsilon,\infty)} = \begin{pmatrix} \widehat{D}_{N+} & \widehat{\pi}_{-} \circ \widehat{D}_{N} \circ \widehat{\pi}_{+} \\ \widehat{\pi}_{+} \circ \widehat{D}_{N} \circ \widehat{\pi}_{-} & \widehat{D}_{N-} \end{pmatrix},\tag{5.16}
$$

where $\hat{\pi}_{\pm}$ are the projections onto $\Sigma_{N\pm}$.

Let $\widehat{\alpha} \in \text{End}_{A}(\widehat{\Sigma}_{N})$ be the grading operator, i.e. $\widehat{\alpha}|_{\widehat{\Sigma}_{N\pm}} = \pm 1$. Then $\widehat{\pi}_{\pm} = \frac{1}{2}(I \pm \widehat{\alpha})$ and

$$
\widehat{\pi}_{\pm} \circ \widehat{D}_N \circ \widehat{\pi}_{\mp} = \pm \frac{1}{2} [\widehat{D}_N, \widehat{\alpha}] \circ \widehat{\pi}_{\mp},
$$

where $\hat{\alpha} = \pm 1$ on $\hat{\Sigma}_{N\pm}$. It follows from [\(5.3\)](#page-17-3) that $\hat{\alpha}$ commutes with the Clifford multiplication. Hence, the commutator $[\hat{D}_N, \hat{\alpha}]$ is a zero-order differential operator, i.e. a bundle map. We conclude that $\hat{\pi}_{+} \circ \hat{D}_N \circ \hat{\pi}_{\pm}$ are also bundle maps.

Pick a constant ϵ_1 such that $0 < \epsilon_1 < \epsilon$ and let Ψ be a self-adjoint endomorphism of Σ such that $\Psi = 0$ off $N \times (1 - \epsilon, \infty)$ and

$$
\Psi|_{N\times(1-\epsilon_1,\infty)}\;:=\; \begin{pmatrix}0&\widehat{\pi}_-\circ\widehat{D}_N\circ\widehat{\pi}_+\\ \widehat{\pi}_+\circ\widehat{D}_N\circ\widehat{\pi}_-&0\end{pmatrix}.
$$

Since both Ψ and Φ are uniformly bounded, the commutator $[\Psi, \Phi]$ is in $L^{\infty}(M, \text{End}_{A}(\Sigma)).$ Since the restriction of D to $N \times (1 - \epsilon, \infty)$ is the lift of D_N , the commutator $[D, \Phi]$ is also in $L^{\infty}(M, \text{End}_{A}(\Sigma))$. Hence, we can choose constants $d > 0$ and $\lambda \geq 1$ such that

$$
\lambda^2 \Phi^2(x) \ge d + \lambda \left(\| [D, \Phi] \|_{\infty} + \| \Psi, \Phi \|_{\infty} \right), \qquad x \in N \times (1 - \epsilon, \infty). \tag{5.17}
$$

Consider the family $D_t := D - t\Psi$ of Dirac operators on Σ . We claim that if λ satisfies [\(5.17\)](#page-22-0) and $t \in [0, 1]$, then $\lambda \Phi$ is an admissible endomorphism for (Σ, D_t) . Indeed, since

$$
[D - t\Psi, \lambda \Phi] = \lambda ([D, \Phi] - t [\Psi, \Phi]),
$$

by using [\(5.17\)](#page-22-0) we obtain

$$
\lambda^{2} \Phi^{2}(x) \geq d + \lambda \left(\| [D, \Phi] \|_{\infty} + \| \Psi, \Phi \|_{\infty} \right)
$$

\n
$$
\geq d + \lambda \left(\| [D, \Phi] \|_{\infty} + t \| [\Psi, \Phi] \|_{\infty} \right)
$$

\n
$$
\geq d + \lambda \| [D, \Phi] - t [\Psi, \Phi] \|_{\infty}
$$

\n
$$
\geq d + \| [D - \lambda \Psi, \lambda \Phi](x) \|,
$$
\n(5.18)

for every $x \in N \times (1 - \epsilon, \infty)$.

Let $B^t_{\lambda \Phi}$ denote the Callias-type operator associated with the triple $(\Sigma, D - t\Psi, \lambda \Phi)$. Since Ψ is uniformly bounded, the family of operators

$$
\left\{\,B^t_{\lambda\Phi} : \ t\in [0,1] \,\right\}
$$

is a continuous homotopy of τ -Fredholm operators with fixed domain. By [\[13,](#page-33-4) Lemma 7.3], the τ -index of $B_{\lambda\Phi}^t$ is independent of t. Using [\(5.15\)](#page-22-1) we now deduce

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} B_{\lambda \Phi} = \operatorname{ind}_{\tau} B_{\lambda \Phi}^{0} = \operatorname{ind}_{\tau} B_{\lambda \Phi}^{1}.
$$
 (5.19)

Let $\nabla^{\prime\Sigma}$ be a connection on Σ satisfying condition (i) of the lemma. In other words we assume that the restriction of $\nabla^{\prime\Sigma}$ to $N \times (1 - \epsilon, \infty)$ is equal to $\nabla^{\widehat{\Sigma}_{N+}} \oplus \nabla^{\widehat{\Sigma}_{N-}}$. Let D' be the Dirac operator associated with the connection ∇^2 and the zero potential. Let $B'_{\lambda \Phi}$ denote the Calliastype operator associated with the triple $(\Sigma, D', \lambda \Phi)$. Then the restrictions of the operators $B'_{\lambda \Phi}$ and $B^1_{\lambda\Phi}$ to the cylindrical part $N \times (1 - \epsilon, \infty)$ coincide. Hence, $\text{ind}_{\tau} B'_{\lambda\Phi} = \text{ind}_{\tau} B^1_{\lambda\Phi}$ by Theorem 2.21 of [\[13\]](#page-33-4). The lemma follows now from [\(5.19\)](#page-23-0).

5.17. Proof of Lemma [5.9.](#page-19-0) By [\(5.6\)](#page-19-2)

$$
D\big|_{N\times(1-\epsilon,\infty)}\ =\ \widehat{D}_{N+}\oplus\widehat{D}_{N-},
$$

where $\widehat{D}_{N\pm}$ is the Dirac operator on $\widehat{\Sigma}_{N\pm}$ associated with the connection $\nabla^{\widehat{\Sigma}_{N\pm}}$ and the zero potential.

Pick constants ϵ_1 , ϵ_2 such that $0 < \epsilon_1 < \epsilon_2 < \epsilon$. Let $f : (1 - \epsilon, \infty) \to [0, 1]$ be a smooth function such that $f = 0$ on $(1 - \epsilon, 1 - \epsilon_2)$ and $f = 1$ on $(1 - \epsilon_1, \infty)$. Let Φ' be a self-adjoint endomorphism of Σ such that $\Phi' = 0$ off $N \times (1 - \epsilon, \infty)$ and

$$
\Phi'(y,r) = \begin{pmatrix} f(r) & 0 \\ 0 & -f(r) \end{pmatrix}, \quad \text{for} \quad (y,r) \in N \times (1 - \epsilon, \infty).
$$

Observe that $[D, \Phi'] = 0$ outside of $N \times (1 - \epsilon, \infty)$ and

$$
[D,\Phi']\big|_{N\times(1-\epsilon,\infty)} = \left[\begin{pmatrix} \widehat{D}_{N+} & 0 \\ 0 & \widehat{D}_{N-} \end{pmatrix}, \begin{pmatrix} f & 0 \\ 0 & -f \end{pmatrix} \right] = \begin{pmatrix} [\widehat{D}_{N+},f] & 0 \\ 0 & [f,\widehat{D}_{N-}] \end{pmatrix}.
$$

Hence, $[D, \Phi']$ is a zero-order differential operator. Thus Φ' satisfies Condition (i) of Definition [2.11.](#page-4-0)

Furthermore,

$$
\Phi'|_{N \times (1-\epsilon_1,\infty)} = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, \qquad [D,\Phi']|_{N \times (1-\epsilon_1,\infty)} = 0. \tag{5.20}
$$

Thus Condition (ii) of Definition [2.11](#page-4-0) is also satisfied. We conclude that Φ' is an admissible endomorphism for (Σ, D) with essential support $M \setminus (N \times (1 - \epsilon, \infty)).$

To prove the lemma it remains to show that

$$
\operatorname{ind}_{\tau} B_{\Phi'} = \operatorname{ind}_{\tau} B_{\Phi}, \tag{5.21}
$$

where $B_{\Phi'}$ is the Callias-type operator associated with (Σ, D, Φ') . We prove this equality by considering the homotopy

$$
\Phi_t := t \Phi + (1 - t) \Phi', \qquad 0 \le t \le 1.
$$
\n(5.22)

A subtlety here is that in general the endomorphism Φ_t is not admissible. However, we show below that there exists $\lambda \geq 1$ such that the endomorphism $\lambda \Phi_t$ is admissible for all $t \in [0,1]$.

First, recall that in Proposition [5.6](#page-18-2) we assumed that

$$
\Phi\big|_{N\times(1-\epsilon,\infty)}\ =\ \widehat{\Phi}_{N+}\oplus\widehat{\Phi}_{N-},
$$

where $\widehat{\Phi}_{N+} = \widehat{\Phi}|_{\widehat{\Sigma}_{N+}}$ is a strictly positive operator and $\widehat{\Phi}_{N-} = \widehat{\Phi}|_{\widehat{\Sigma}_{N-}}$ is a strictly negative operator. Since $\Phi_{N\pm}(x)$ are constant along the axial direction on the cylinder, there exists a constant $d_1 > 0$ such that $\widehat{\Phi}_{N+} \ge d_1$ and $\widehat{\Phi}_{N-} \le -d_1$. It follows that

$$
\Phi^2|_{N \times (1-\epsilon,\infty)} = \begin{pmatrix} \widehat{\Phi}_{N+}^2 & 0\\ 0 & \widehat{\Phi}_{N-}^2 \end{pmatrix} \geq d_1^2.
$$
 (5.23)

Using [\(5.20\)](#page-24-0) we also obtain

$$
\left\{\Phi,\Phi'\right\}\big|_{N\times(1-\epsilon_1,\infty)} := \left(\Phi\circ\Phi' + \Phi'\circ\Phi\right)\big|_{N\times(1-\epsilon_1,\infty)} = 2\left(\begin{array}{cc} \widehat{\Phi}_{N+} & 0\\ 0 & -\widehat{\Phi}_{N-} \end{array}\right) \geq 2d_1. (5.24)
$$

Since Φ' is constant in the axial direction over the cylindrical end, the commutator $[D, \Phi']$ is in $L^{\infty}(M, \text{End}_A(\Sigma))$. Set

$$
d_2 \ := \ \min(\{d_1, d_1^2, 1\})
$$

and pick constants $d > 0$, $\lambda \geq 1$ such that

$$
\lambda^2 d_2 \ge d + \lambda ||[D, \Phi']||_{\infty}.
$$
\n(5.25)

We claim that $\lambda \Phi_t$ is an admissible endomorphism for all $t \in [0, 1]$. Indeed, using [\(5.20\)](#page-24-0), [\(5.24\)](#page-24-1), [\(5.23\)](#page-24-2), and the equality

$$
[D,\lambda\Phi_t]\ =\ \lambda\,\big(\,t[D,\Phi]+(1-t)[D,\Phi']\,\big),
$$

we obtain

$$
(\lambda \Phi_t)^2 (x) = t^2 \lambda^2 \Phi^2(x) + (1 - t)^2 \lambda^2 \Phi'^2(x) + 2t(1 - t)\lambda^2 {\Phi, \Phi'}(x)
$$

\n
$$
\geq t^2 \lambda^2 d_1^2 + (1 - t)^2 \lambda^2 + 2t(1 - t)\lambda^2 d_1
$$

\n
$$
\geq (t^2 + (1 - t)^2 + 2t(1 - t)) \lambda^2 d_2
$$

\n
$$
\geq d + \lambda ||[D, \Phi']||_{\infty} \geq d + \lambda ||[D, \lambda \Phi_t](x)||,
$$

for every $x \in N \times (1 - \epsilon_1, \infty)$.

Let $B_{\lambda \Phi_t}$ denote the Callias-type operator associated with $(\Sigma, D, \lambda \Phi_t)$. Since both endomorphisms, Φ and Φ' , are constant in the axial direction, the family of endomorphisms Φ_t is uniformly bounded and depends continuously on t. By [\[13,](#page-33-4) Lemma 7.3], the index $\text{ind}_{\tau} B_{\lambda \Phi_t}$ is independent of $t \in [0, 1]$. Using [\(5.15\)](#page-22-1) we now obtain

$$
\mathrm{ind}_{\tau} B_{\Phi'} = \mathrm{ind}_{\tau} B_{\lambda \Phi'} = \mathrm{ind}_{\tau} B_{\lambda \Phi} = \mathrm{ind}_{\tau} B_{\Phi}.
$$

6. Proof of the Callias-type theorem in general case

In this section we conclude the proof of Theorem [2.16.](#page-7-1) We use the relative index theorem to reduce the computation of the index in general case to a computation on a manifold with cylindrical ends.

6.1. Notation. Throughout the section we use the notation of Section [2.15.](#page-5-3) In particular, $M = M_{-} \cup_{N} M_{+}$, Σ is a Dirac bundle over M, and D is a Dirac operator on Σ associated to a connection ∇^{Σ} and a potential V.

Let Σ_N and Φ_N be the restrictions of Σ and Φ to N. We denote by $\widehat{\Sigma}_N$ and $\widehat{\Phi}_N$ the lifts of Σ_N and Φ_N to $N \times \mathbb{R}$, cf. Section [5.3.](#page-18-3)

6.2. Sketch of the proof of Theorem [2.16.](#page-7-1) We first deform all the structures in a small neighborhood $U(N) \subset M$ of N so that the following conditions hold:

- (N.1) $U(N)$ is isometrically diffeomorphic to $N \times (-3\epsilon, 3\epsilon)$;
- (N.2) the restrictions of Σ and $\widehat{\Sigma}_N$ to $N \times (-\epsilon, \epsilon)$ are isomorphic as A-Hilbert bundles with connections;
- $(N.3) \Phi\big|_{N\times (-\epsilon,\epsilon)} = \widehat{\Phi}_N\big|_{N\times (-\epsilon,\epsilon)};$
- (N.4) the potential V vanishes on $N \times (-\epsilon, \epsilon)$;
- (N.5) the essential support of the Callias-type operator associated to the new structures is still contained in the interior of $M_-.$

By [\[13,](#page-33-4) Lemma 7.3], the τ -index of a Callias-type operator does not change under such deformation of the data. Hence, it suffices to prove Theorem [2.16](#page-7-1) in the case when the conditions $(N.1)$ – $(N.5)$ are satisfied, which we shall henceforth assume.

The rest of the proof is very similar to the proof of Proposition [5.6.](#page-18-2) In Section [5](#page-17-1) we used the relative index theorem to reduce the computation of the index on a manifold with cylindrical ends to the computation of an index on a cylinder. Here in exactly the same way we use the

relative index theorem to reduce the computation of the index on M to a computation of an index on a manifold with cylindrical ends.

The rest of this section is occupied with the details of the proof of Theorem [2.16.](#page-7-1)

6.3. Deformation of the metric. Before presenting the construction of the deformation of the data near N , discussed in the beginning of Section [6.2,](#page-25-1) let us recall how a Dirac-type operator changes under a conformal change of the Riemannian metric.

Let g^M denote the Riemannian metric on M. Let $c: T^*M \to \text{End}_A(\Sigma)$, ∇^{Σ} , and $\langle \cdot, \cdot \rangle$ denote respectively the Clifford action of the cotangent bundle, the metric connection, and the inner product on fibers of $Σ$.

Let $h : M \to \mathbb{R}$ be a smooth compactly supported function and define a new Riemannian metric $g_h^M := e^{-2h} g^M$. For a cotangent vector ξ we denote by $|\xi|$ and $|\xi|_h$ its norms with respect to the metrics g^M and g_h^M respectively. Then $|\cdot|_h = e^h|\cdot|$.

In order to make Σ a Dirac bundle over the Riemannian manifold (M, g_h^M) we also need to change the other structures. The new Clifford action $c_h: T^*M \to \text{End}_A(\Sigma)$ is given by

$$
c_h(\xi) := e^h c(\xi), \qquad \xi \in T^*M. \tag{6.1}
$$

The formula for the new connection ∇_h^{Σ} is more involved, cf. formula (17) of [\[34\]](#page-34-19). This formula is forced by the assumption that the connection satisfies the Leibniz rule with respect to the Clifford action. We denote by Σ_h the Dirac bundle over (M, g_h^M) endowed with the Clifford action c_h and the Clifford connection ∇_h^{Σ} (the Hermitian metric on Σ_h is the same as on Σ).

Let D' denote the Dirac operator on Σ associated with the connection ∇^{Σ} and the zero potential. We recall from Section [2.5](#page-3-4) that $D - D' = V \in \text{End}_A(\Sigma)$. Let D'_h denote the Dirac operator on Σ_h associated with the connection ∇_h^{Σ} and the zero potential. Then

$$
D'_h = e^{h/2} \left(D' - \frac{n}{2} c(dh) \right) e^{h/2} = e^h \left(D' - \frac{n-1}{2} c(dh) \right).
$$

This formula was obtained by Hitchin [\[29,](#page-34-20) §1.4] (see also [\[32,](#page-34-15) [§II.5]) for the case when Σ is the bundle of spinors. The general case was treated in [\[34,](#page-34-19) §4].

We now set

$$
D_h := e^h \left(D - \frac{n-1}{2} c(dh) \right). \tag{6.2}
$$

Then D_h is the Dirac operator associated with connection ∇_h^{Σ} and potential e^hV .

More generally, let $\chi : M \to [0, 1]$ be a smooth function, such that $\chi(x) \equiv 1$ for all $x \in M \setminus K$, where K is an essential support of Φ . We consider the Dirac operator $D_{h,\chi}$ associated with the connection ∇_h^{Σ} and the potential $\chi e^h V$. Then

$$
D_{h,\chi} = D_h - (1 - \chi)e^h V.
$$
 (6.3)

Notice, that since h and $1 - \chi$ have compact support, any endomorphism $\Phi : \Sigma \to \Sigma$ which is admissible for D is also admissible for $D_{h,\chi}$. We denote by $B_{\Phi,h,\chi}$ the Callias-type operator associated with the triple $(\Sigma_h, D_{h,\chi}, \Phi)$. Since B_{Φ} and $B_{\Phi,h,\chi}$ coincide outside of a compact set,

$$
\text{ind}_{\tau} B_{\Phi,h,\chi} = \text{ind}_{\tau} B_{\Phi} \tag{6.4}
$$

by Theorem 2.21 of [\[13\]](#page-33-4).

Lemma 6.4. Let B_{Φ} be a Callias-type operator associated with a triple (Σ, D, Φ) . Assume that K is an essential support of Φ with respect to the pair (Σ, D) and that there exists a constant $d_1 > 0$ and a compact set $K_1 \subset K$ such that $\Phi^2(x) > d_1$ for all $x \notin K_1$. Then there exists a function $h \in C_0^{\infty}(M)$ such that K_1 is an essential support for Φ with respect to the pair $(\Sigma_h, D_{h,\chi}).$

Together with [\(6.4\)](#page-26-0) the lemma suggests that for all index related questions we could define the essential support as the set K_1 such that $\Phi^2(x) > d_1$ for all $x \notin K_1$.

Proof. Let $h : M \to (-\infty, 0]$ be a smooth compactly supported non-positive function such that

$$
e^{h(x)} \left\| [D, \Phi](x) - \left(1 - \chi(x) \right) [V, \Phi](x) \right\| < \frac{d_1}{2}, \quad \text{for all} \quad x \in K.
$$

By (2.12) Φ commutes with the Clifford multiplication. Hence, using (6.2) and (6.3) we obtain

$$
[D_{h,\chi}, \Phi](x) = e^{h(x)} [D, \Phi](x) - (1 - \chi(x)) e^{h(x)} [V, \Phi](x), \qquad x \in M,
$$
 (6.5)

and

$$
\| [D_{h,\chi}, \Phi](x) \| = e^{h(x)} \| [D, \Phi](x) - (1 - \chi(x)) [V, \Phi](x) \| < \frac{d_1}{2}.
$$

Therefore,

$$
\Phi(x)^2 > d_1 > \frac{d_1}{2} + ||[D_{h,\chi}, \Phi](x)||, \quad \text{for all} \quad x \in K \setminus K_1. \tag{6.6}
$$

Since $e^{h} \leq 1$ and $1 - \chi(x) = 0$ for $x \notin K$, we conclude from [\(6.5\)](#page-27-0) that

$$
\|[D_{h,\chi},\Phi](x)\| \leq \| [D,\Phi](x)\|, \quad \text{for all} \quad x \notin K.
$$

Hence, by part (ii) of Definition [2.11,](#page-4-0) there exists $d > 0$ such that

$$
\Phi(x)^2 > d + ||[D_{h,\chi}, \Phi](x)||, \quad \text{for all} \quad x \notin K. \tag{6.7}
$$

Set $d_2 := \min\{\frac{d_1}{2}$ $\left\{ \frac{a_1}{2}, d \right\}$. Then combining [\(6.6\)](#page-27-1) and [\(6.7\)](#page-27-2) we conclude that

$$
\Phi(x)^2 > d_2 + ||[D_{h,\chi}, \Phi](x)||
$$
, for all $x \notin K_1$.

 \Box

6.5. Deformation of the data in a neighborhood of N. By [\[6,](#page-33-15) Chapter 9], we can deform the Riemannian metric on M, the Clifford action of T^*M on Σ and the connection on Σ in a small neighborhood $U(N) \subset M$ of N such that Conditions (N.1)–(N.3) of Section [6.2](#page-25-1) are satisfied and $\Phi(x)^2 > 0$ for all $x \in (N \times (-\epsilon, 0]) \cup_N M_+$.

Let $\chi : M \to [0,1]$ be a smooth function such that $\chi(x) = 0$ for all $x \in N \times (-\epsilon, \epsilon) \subset U(N)$ and $\chi(x) = 1$ for all $x \notin N \times (-2\epsilon, 2\epsilon)$. We replace the potential V with χV . Then Condition (N.4) of Section [6.2](#page-25-1) is also satisfied.

It follows now from Lemma [6.4](#page-27-3) that we can deform the structures in a small neighborhood of N so that with respect to the new structures the essential support of Φ is contained in the interior of $M_-\setminus (N \times (-\epsilon, 0])$. Then Condition (N.5) of Section [6.2](#page-25-1) is satisfied.

Since all our changes occurred only in a relatively compact neighborhood of N , it follows from Theorem 2.21 of [\[13\]](#page-33-4) that they don't change the index of the associated Callias-type operator. Hence, it is enough to prove Theorem [2.16](#page-7-1) for the case when Conditions $(N.1)$ (N.5) of Section [6.2](#page-25-1) are satisfied, which we will henceforth assume.

6.6. Proof of Theorem [2.16.](#page-7-1) Let $M_1 := N \times \mathbb{R}$ be the cylinder, and let $B_1 = B_{\widehat{\Phi}_N}$ be the Callias-type operator on M_1 associated with the triple $(\widehat{\Sigma}_N, \widehat{D}_N, \widehat{\Phi}_N)$. Since the essential support of $\widehat{\Phi}_N$ is empty, $B_1^2 > 0$. Hence, $\text{ind}_{\tau} B_1 = 0$.

As in Section [5.6](#page-18-2) we are going to cut and paste manifolds M and M_1 along N and use the relative index theorem. Notice, that we can do it, because in Section [6.5](#page-27-4) we deformed all the data on the collar neighborhood of N in M so that now it matches the data on the cylinder M_1 .

Applying the cut and paste procedure of Section [2.6](#page-3-3) to manifolds M and M_1 and potentials Φ and $\widehat{\Phi}_N$ we obtain manifolds

$$
M_2 = M_-\cup_N (N\times [0,\infty)) \quad \text{and} \quad M_3 := N\times (-\infty,0] \cup_N M_+,
$$

with potentials Φ_2 and Φ_3 respectively. Let B_{Φ_2} and B_{Φ_3} be the corresponding Callias-type operators.

The restriction of Φ_2 to the cylindrical part $N \times [0,\infty)$ is equal to $\widehat{\Phi}_N$. Similarly, the restriction of Φ_3 to $N \times (-\infty, 0]$ is equal to Φ_N . Moreover, the essential support of Φ_3 is empty. Hence, ind_τ $B_3 = 0$. From Proposition [5.6](#page-18-2) we obtain ind_τ $B_2 = \text{ind}_{\tau} D_{N+}$. From the relative index theorem [2.8](#page-4-2) we now obtain

$$
\operatorname{ind}_{\tau} B_{\Phi} = \operatorname{ind}_{\tau} B_{\Phi} + \operatorname{ind}_{\tau} B_1 = \operatorname{ind}_{\tau} B_2 + \operatorname{ind}_{\tau} B_3 = \operatorname{ind}_{\tau} D_{N+}.
$$

7. COBORDISM INVARIANCE OF THE τ -INDEX

In this section we prove Theorem [2.24](#page-8-0) about the cobordism invariance of the τ -index of a Callias-type operator. As a first step we give a new proof of the cobordism invariance of the index of Dirac operators on compact manifolds.

In this section we freely use the notation introduced in Sections [2.21](#page-7-2) and [5.1](#page-17-0)[–5.3.](#page-18-3)

7.1. Compact cobordisms. Let Σ be a Dirac A-bundle over a *compact* manifold M, and let D be a Dirac operator on Σ . We say that D is *compactly null-cobordant* if there exists a null-cobordism (W, Σ, D) of D with W a compact manifold with boundary.

Proposition 7.2. If D is compactly null-cobordant Dirac operator, then $ind_{\tau} D = 0$.

Proof. Consider the manifold $W' := W \cup_M (M \times [0, \infty))$. Let Σ' denote the Dirac bundle over W', whose restriction to W is equal to $\overline{\Sigma}$ and whose restriction to the cylinder $M \times [0, \infty)$ is equal to the bundle $\widehat{\Sigma}$. Let D' be the Dirac operator whose restriction to W is equal to \overline{D} and whose restriction to $M \times [0,\infty)$ is equal to \hat{D} .

For $\Phi' \in \text{End}_A(\Sigma')$ we denote by $B'_{\Phi'}$ be the Callias-type operator on W' associated with the triple (Σ', D', Φ') . Applying the Callias-type index theorem [2.16](#page-7-1) to the operators $B'_{\rm Id}$ and $B'_{\rm -Id}$ we obtain

$$
\mathrm{ind}_{\tau} B'_{\mathrm{Id}} = \mathrm{ind}_{\tau} D, \quad \mathrm{ind}_{\tau} B'_{-\mathrm{Id}} = 0.
$$

The proposition follows now from Corollary [2.17.](#page-7-3) \Box

7.3. Proof of Theorem [2.24.](#page-8-0) We now deduce the cobordism invariance of a Callias-type operator from Theorem [2.16](#page-7-1) and Proposition [7.2.](#page-28-1)

Let B_{Φ} be the Callias-type operator associated with a triple (Σ, D, Φ) and let $(W, \overline{\Sigma}, \overline{D}, \overline{\Phi})$ be a null-cobordism of B_{Φ} . Choose an open subset $\Omega \subset W$ with compact closure such that

- (1) Ω contains the essential support of $\overline{\Phi}$;
- (2) the boundary $\overline{N} := \partial\Omega$ of Ω is a smooth manifold which intersects $M = \partial W$ transversely.

Then $\Omega \cap \partial W$ is an open subset of $M = \partial W$ which contains an essential support of Φ . Furthermore

$$
N := \overline{N} \cap \partial W = \partial(\Omega \cap M)
$$

is a smooth compact hypersurface in M.

Let $\Sigma_{\overline{N}}$ denote the restriction of Σ to N. Then $\Sigma_{\overline{N}}$ has a natural grading

$$
\overline{\Sigma}_{\overline{N}} = \overline{\Sigma}_{\overline{N}+} \oplus \overline{\Sigma}_{\overline{N}-},\tag{7.1}
$$

where the fiber of $\Sigma_{\overline{N}_+}$ (respectively $\Sigma_{\overline{N}_-}$) over $x \in N$ is the image of the spectral projection of $\overline{\Phi}|_{\overline{N}}$ corresponding to the interval $(0,\infty)$ (respectively $(-\infty,0)$). We denote by $\overline{D}_{\overline{N}}$ the restriction of \overline{D} to \overline{N} . It is a Dirac operator on $\overline{\Sigma}_{\overline{N}}$ which preserves the grading [\(7.1\)](#page-29-1). We denote by $\overline{D}_{\overline{N}\pm}$ the restriction of $\overline{D}_{\overline{N}}$ to $C_0^{\infty}(\overline{N}, \overline{\Sigma}_{\overline{N}\pm})$.

Let D_{N+} be the operator induced on N by B_{Φ} , cf. Section [2.15.](#page-5-3) Then $(N, \Sigma_{\overline{N}+}, D_{\overline{N}+})$ is a null-cobordism of D_{N+} . Hence, it follows from Proposition [7.2,](#page-28-1) that $\text{ind}_{\tau} D_{N+} = 0$. We now use the Callias-type theorem [2.16](#page-7-1) to obtain $\text{ind}_{\tau} B_{\phi} = \text{ind}_{\tau} D_{N+} = 0.$

8. The Γ-index Theorem

This section is devoted to the proof of the Γ-index theorem for Callias-type operators. In Section [8.1](#page-29-2) we analyze Callias-type operators twisted by an A-Hilbert bundle of finite type. In section [8.4](#page-31-0) we show that the Callias-type operators lifted to Galois covers can be interpreted using the twisted construction and deduce from this Lemma [2.27](#page-9-2) and Theorem [2.28.](#page-10-1)

8.1. Twisted Callias-type operators. Let M, S, D and Φ be as in Section [2.26.](#page-9-3) We denote by ∇^S the connection on S. Recall from [\(2.11\)](#page-5-1) that D is the Dirac operator on S given by

$$
D = \sum_{i} c(e^i) \nabla_{e_i}^S + V,
$$
\n(8.1)

where $V \in \text{End}_A(S)$ is a bundle map.

Suppose that H is an A-Hilbert bundle of finite type endowed with a connection ∇^H . Then the bundle $S \otimes H$ carries a Dirac A-Hilbert bundle structure with connection

$$
\nabla^{S\otimes H} \ := \ \nabla^S\otimes 1 \ + \ 1\otimes \nabla^H.
$$

We define a *twisted Dirac operator* on $S \otimes H$ by

$$
D_H = \sum_i c(e^i) \nabla_{e_i}^{S \otimes H} + V \otimes 1. \tag{8.2}
$$

Lemma 8.2. The endomorphism

$$
\Phi_H \ := \ \Phi \otimes 1 \ \in \ \text{End}_A \left(S \otimes H \right),
$$

is admissible for the pair $(S \otimes H, D_H)$.

Proof. Fix a trivializing neighborhood U of $S \otimes H$ and local sections $s \in C^{\infty}(U, S|_U)$, $h \in$ $C^{\infty}(U, H|_U)$. By [\(8.1\)](#page-29-3) and [\(8.2\)](#page-30-0) we have

$$
D_H(s\otimes h) = (Ds)\otimes h + \sum_i (c(X^i)s) \otimes (\nabla^H_{X_i}h) ,
$$

where $\{X_i\}$ is a local orthonormal frame of TM and X^i is the dual frame of T^*M . It follows that

$$
[D_H, \Phi_H] (s \otimes h) = ([D, \Phi] s) \otimes h + \sum_i \left([c(X_i), \Phi] s \right) \otimes \left(\nabla_{X_i}^H h \right). \tag{8.3}
$$

By (2.12) , the endomorphism Φ commutes with Clifford multiplication. Hence the second term on the right-hand side of [\(8.3\)](#page-30-1) vanishes. Therefore,

$$
[D_H, \Phi_H] = [D, \Phi] \otimes 1.
$$

It follows that Φ_H is admissible whenever Φ is admissible.

Let B_{Φ}^H denote the Callias-type operator associated with the triple $(S \otimes H, D_H, \Phi_H)$. When the connection ∇^H is flat, Theorem [2.16](#page-7-1) allows to connect the $\text{ind}_{\tau} B_{\Phi}^H$ and $\text{ind } B_{\Phi}$ in a particularly nice way.

Theorem 8.3. Let S be an ungraded Dirac bundle over a complete odd-dimensional oriented Riemannian manifold M and let Φ be an admissible self-adjoint endomorphism of S. Suppose $H \to M$ is a flat A-Hilbert bundle of finite type. Then

$$
\operatorname{ind}_{\tau} B_{\Phi}^H = d \cdot \operatorname{ind} B_{\Phi},
$$

where d is the τ -dimension of the typical fiber of H.

Proof. Choose a compact hypersurface $N \subset M$ such that $M = M_{-} \cup_{N} M_{+}$, where M_{-} is compact and contains an essential support of both endomorphisms Φ and Φ_H .

We apply the construction of Section [2.15](#page-5-3) to construct the Dirac bundles S_{N+} and $(S \otimes H)_{N+}$ over N. Let D_{N+} and D_{N+}^H the Dirac operators on N defined as in [\(2.16\)](#page-6-4). By Theorem [2.16,](#page-7-1) we have

$$
\operatorname{ind}_{\tau} B_{\Phi}^H = \operatorname{ind}_{\tau} D_{N+}^H, \qquad \operatorname{ind} B_{\Phi} = \operatorname{ind} D_{N+}.
$$
 (8.4)

Let $H_N \to N$ denote the restriction of the flat bundle H to N and let $D_{N+}^{H_N}$ denote the Dirac operator D_{N+} twisted with the bundle H_N . Observe that $(S \otimes H)_{N+} = S_{N+} \otimes H_N$ so that we can identify D_{N+}^H with the operator $D_{N+}^{H_N}$. Therefore,

$$
\operatorname{ind}_{\tau} D_N^H = \operatorname{ind}_{\tau} D_{N+}^{H_N}.\tag{8.5}
$$

Finally, since H_{N+} is a flat A-Hilbert bundle, from [\[36,](#page-34-0) Theorem 7.30 and Corollary 5.13] we get

$$
\operatorname{ind}_{\tau} D_{N+}^{H_N} = d \cdot \operatorname{ind}(D_{N+}),\tag{8.6}
$$

where d is the τ -dimension of the typical fiber of H_N , that by definition of this bundle coincides with the typical fiber of H. The theorem follows now from equations [\(8.4\)](#page-30-2), [\(8.5\)](#page-31-1) and [\(8.6\)](#page-31-2). \Box

8.4. Galois covers. Suppose Γ is a discrete group and denote by $l^2(\Gamma)$ the Hilbert space of complex valued square summable functions on Γ. We let Γ act on the Hilbert space $l^2(\Gamma)$ by the right regular representation

$$
(R_g f)(h) := f(h \cdot g), \qquad g, h \in \Gamma, \quad f \in l^2(\Gamma). \tag{8.7}
$$

Observe that this action induces an action of the group algebra $\mathbb{C}\Gamma$ on $l^2(\Gamma)$, that coincides with the right convolution multiplication. Observe also that the operator R_q defined by formula [\(8.7\)](#page-31-3) is bounded and that $R_g^* = R_{g^{-1}}$. In this way we identify the group algebra CΓ with a $*$ -subalgebra of $\mathcal{B}(l^2(Γ))$. The weak closure of $\mathbb{C}Γ$ in $\mathcal{B}(l^2(Γ))$ is called the group von Neumann algebra of Γ and is denoted by $\mathcal{N}\Gamma$. On this algebra we have the canonical faithful positive trace τ defined by

$$
\tau(f) = \langle f(\delta_e), \delta_e \rangle_{l^2(\Gamma)}, \qquad f \in \mathcal{N}\Gamma,\tag{8.8}
$$

where $\delta_e \in l^2(\Gamma)$ is by definition the characteristic function of the unit element.

Notice that the right Γ -action on $l^2(\Gamma)$ extends to a right $\mathcal{N}\Gamma$ -action. In this way we endow the space $l^2(\Gamma)$ with a Hilbert N_T-space structure. We also let Γ act on the Hilbert space $l^2(\Gamma)$ by the left regular representation

$$
(L_g f)(h) := f(g^{-1} \cdot h), \qquad g, h \in \Gamma, \quad f \in l^2(\Gamma). \tag{8.9}
$$

The right action of $\mathcal{N}\Gamma$ on $l^2(\Gamma)$ commutes with the left Γ -action. Therefore,

$$
H_{\Gamma} := \widetilde{M} \times_{\Gamma} l^2(\Gamma)
$$

is an $\mathcal{N}\Gamma$ -Hilbert bundle of finite type on M.

It follows from [\(8.8\)](#page-31-4) that the τ -dimension of $l^2(\Gamma)$ is one. Hence, the τ -dimension of the typical fiber of H_{Γ} is also 1, i.e.

$$
\dim_{\tau} H_{\Gamma,x} = 1, \qquad x \in M. \tag{8.10}
$$

8.5. Lift of a Callias-type operator to a Galois cover. Notice that, since Γ is discrete, H_{Γ} is endowed with a canonical flat connection $\nabla^{H_{\Gamma}}$. Let $D_{H_{\Gamma}}$ and $\Phi_{H_{\Gamma}}$ be the twisted Dirac operator and the endomorphism induced in $S \otimes H_{\Gamma}$ by D and Φ as in Section [8.1.](#page-29-2)

Let M, S, Φ , B_{Φ} , M, Γ , S, Φ , B_{Φ} be as in Section [2.26.](#page-9-3) Notice that

$$
\widetilde{B_{\Phi}}\ =\ \begin{pmatrix} 0 & \widetilde{D}-i\widetilde{\Phi} \\ \widetilde{D}+i\widetilde{\Phi} & 0 \end{pmatrix},
$$

where \widetilde{D} and $\widetilde{\Phi}$ are the lifts of D and Φ to the Galois cover. We want to compare the operator B_{Φ} with an operator B_{Φ}^H given by the twisted construction of Section [8.1.](#page-29-2)

Observe that the action of Γ on $L^2(M, \tilde{S})$ induces an $\mathcal{N}\Gamma$ -Hilbert space structure on this space. Observe also that a closed subspace $L \subset L^2(\tilde{M}, \tilde{S})$ is Γ-invariant if and only if it is $\mathcal{N}\Gamma$ -invariant and in this case the τ -dimension and the Γ -dimension of L coincide. Moreover, there is a $N\Gamma$ -Hilbert space isomorphism

$$
\mathcal{I}: L^2(\widetilde{M}, \widetilde{S}) \longrightarrow L^2(M, S \otimes H_{\Gamma})
$$
\n(8.11)

with the following properties:

(a) For every $s \in C_c^{\infty}(\widetilde{M}, \widetilde{S})$

$$
(\mathcal{I}s)(x) = \sum_{\gamma \in \Gamma} s(\gamma \cdot \widetilde{x}) \otimes (\widetilde{x}, \gamma), \qquad x \in M,
$$
\n(8.12)

where \tilde{x} is any lift of x to M. Notice that in Equation [\(8.12\)](#page-32-0) the fibers $S_{\gamma \tilde{x}}$ and S_x are identified.

- (b) The operators D and $D_{H_{\Gamma}}$ are conjugated through \mathcal{I} . Here, D is the lifting of D to M and $D_{H_{\Gamma}}$ is the Dirac operator associated with the twisted bundle $S \otimes H_{\Gamma}$: cf. Formula [\(8.2\)](#page-30-0).
- (c) If L is a closed $\mathcal{N}\Gamma$ -invariant subspace of $L^2(\tilde{M}, \tilde{S})$, then $\dim_{\Gamma} L = \dim_{\tau} \mathcal{I}(L)$.
- (d) Suppose that

$$
\mathcal{D}_1 = \begin{pmatrix} 0 & D_1^- \\ D_1^+ & 0 \end{pmatrix} \quad \text{and} \quad \mathcal{D}_2 = \begin{pmatrix} 0 & D_2^- \\ D_2^+ & 0 \end{pmatrix}
$$

are odd formally self-adjoint $\mathcal{N}\Gamma$ -equivariant differential operators acting respectively on $C_c^{\infty}(\widetilde{M}, \widetilde{S} \oplus \widetilde{S})$ and $C_c^{\infty}(M, (S \oplus S) \otimes H)$. Suppose also that $\mathcal{I} \circ D_1^{\pm} = D_2^{\pm}$ $\frac{1}{2} \circ \mathcal{I}$ on $C_c^{\infty}(\widetilde{M}, \widetilde{S})$. Then \mathcal{D}_1 is essentially self-adjoint if and only if \mathcal{D}_2 is and \mathcal{D}_1 is τ -Fredholm if and only if \mathcal{D}_2 is. In this case, it follows from (c) that $\text{ind}_{\tau} \mathcal{D}_1$ and $\text{ind}_{\tau} \mathcal{D}_2$ coincide.

For more details about the construction of the map $\mathcal I$ and its properties, we refer to [\[36,](#page-34-0) Section 7.5, where the case when M is compact is treated. The case when M is noncompact follows with minor modifications.

Lemma 8.6. The operator \widetilde{B}_{Φ} is τ -Fredholm and we have

$$
\text{ind}_{\Gamma} \widetilde{B_{\Phi}} = \text{ind}_{\tau} B_{\Phi}^{H_{\Gamma}}.
$$
\n(8.13)

Proof. By [\[13\]](#page-33-4) (see also Section [2.1](#page-2-4) of the present paper), the operator $B_{\Phi}^{H_{\Gamma}}$ $_{\Phi}^{H_{\Gamma}}$ is essentially selfadjoint and its closure is τ -Fredholm. By points (b) and (d), to prove the lemma it suffices to show that $\Phi_H \circ \mathcal{I} = \mathcal{I} \circ \widetilde{\Phi}$ on $C_c^{\infty}(\widetilde{M}, \widetilde{S})$. Fix $s \in C_c^{\infty}(\widetilde{M}, \widetilde{S})$. By point (a) we have

$$
\begin{array}{rcl}\n\left(\mathcal{I}\circ\widetilde{\Phi}\right)(s)(x) & = & \sum_{\gamma\in\Gamma}\widetilde{\Phi}(s(\gamma\cdot\widetilde{x}))\otimes(\widetilde{x},\gamma) = \sum_{\gamma\in\Gamma}\widetilde{\Phi}(s(\gamma\cdot\widetilde{x}))\otimes(\widetilde{x},\gamma) \\
& = & \widetilde{\Phi}_H\left(\sum_{\gamma\in\Gamma}s(\gamma\cdot\widetilde{x})\otimes(\widetilde{x},\gamma)\right) = (\Phi_H\circ\mathcal{I})(s)(x),\n\end{array}
$$

where \tilde{x} is any lift of x to \widetilde{M} . The proof is complete.

8.7. Proof of Lemma [2.27.](#page-9-2) It follows from Lemma [8.6](#page-32-1) and the fact that the τ -dimension and the Γ-dimension coincide on closed $\mathcal{N}\Gamma$ -invariant subspaces of $L^2(\widetilde{M}, \widetilde{S})$.

8.8. Proof of Theorem [2.28.](#page-10-1) Since H_{Γ} is a flat N_T-bundle, the thesis follows from [\(8.10\)](#page-31-5), Lemma [8.6,](#page-32-1) and Theorem [8.3.](#page-30-3)
