# On functionals involving the torsional rigidity related to some classes of nonlinear operators

ABSTRACT: In this paper we study optimal estimates for two functionals involving the anisotropic p-torsional rigidity  $T_p(\Omega)$ ,  $1 . More precisely, we study <math>\Phi(\Omega) = \frac{T_p(\Omega)}{|\Omega| M(\Omega)}$  and  $\Psi(\Omega) = \frac{T_p(\Omega)}{|\Omega| [R_F(\Omega)]^{\frac{p}{p-1}}}$ , where  $M(\Omega)$  is the maximum of the torsion function  $u_{\Omega}$  and  $R_F(\Omega)$  is the anisotropic inradius of  $\Omega$ .

KEYWORDS: torsional rigidity, anisotropic operators, optimal estimates

#### 1 INTRODUCTION

Let  $F : \mathbb{R}^N \to [0, +\infty[, N \ge 2)$ , be a convex, even, 1-homogeneous and  $C^{3,\beta}(\mathbb{R}^N \setminus \{0\})$  function such that  $[F^p]_{\xi\xi}$  is positive definite in  $\mathbb{R}^N \setminus \{0\}$ , 1 . The anisotropic p–laplacian is the operator defined by

$$\mathfrak{Q}_{p}\mathfrak{u} := \sum_{i=1}^{N} \frac{\partial}{\partial x_{i}} (F(\nabla \mathfrak{u})^{p-1}F_{\xi_{i}}(\nabla \mathfrak{u})).$$

For p = 2,  $\Omega_2$  is the so-called Finsler Laplacian, while when  $F(\xi) = |\xi|$  is the Euclidean norm,  $\Omega_p$  reduces to the well known p-Laplace operator.

Given a bounded domain  $\Omega$  in  $\mathbb{R}^N$ , let us consider the torsion problem for  $\Omega_p$ :

$$\begin{cases} -\Omega_{\rm p} u = 1 & \text{in } \Omega \\ u = 0 & \text{on } \partial \Omega. \end{cases}$$
(1)

The anisotropic p-torsional rigidity of  $\Omega$  is the number  $T_p(\Omega) > 0$  defined by

$$\mathsf{T}_{\mathsf{p}}(\Omega) = \int_{\Omega} \mathsf{F}(\nabla \mathfrak{u}_{\Omega})^{\mathsf{p}} d\mathfrak{x} = \int_{\Omega} \mathfrak{u}_{\Omega} d\mathfrak{x}$$

where  $u_{\Omega} \in W_{0}^{1,p}(\Omega)$  is the torsion function, that is the unique solution of (1).

The main aim of the paper is the study of optimal estimates for the following two functionals involving  $T_p(\Omega)$ :

$$\Phi(\Omega) = \frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|\mathsf{M}(\Omega)}, \qquad \Psi(\Omega) = \frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|[\mathsf{R}_{\mathsf{F}}(\Omega)]^{\mathsf{q}}}$$

Here and after we will denote by q the Hölder conjugate of p,  $q = \frac{p}{p-1}$ , by  $M(\Omega)$  the maximum of the torsion function  $u_{\Omega}$  and by  $R_F(\Omega)$  the anisotropic inradius of  $\Omega$  (see Section 2 for the precise definitions). Observe that the functionals  $\Phi$  and  $\Psi$  are scaling invariant with respect to the domain. Indeed:

 $T_p(t\Omega)=t^{N+q}T_p(\Omega), \quad |t\Omega|=t^N|\Omega|, \quad M(t\Omega)=t^qM(\Omega), \quad R_F(t\Omega)=tR_F(\Omega).$ 

Our main result is the following.

**Theorem 1.1.** Let  $\Omega$  be a convex bounded domain in  $\mathbb{R}^N$ . It holds that

*i*) 
$$\frac{q}{N^{q-1}(N+q)} \leq \Phi(\Omega) \leq \frac{q}{q+1}$$
.

The right-hand side inequality is optimal for a suitable sequence of thinning rectangles.

*ii*) 
$$\frac{1}{N^{q-1}} \frac{1}{N+q} \leq \Psi(\Omega) \leq \frac{1}{q+1}$$
.

The left-hand side inequality holds as an equality if and only if  $\Omega$  is a Wulff shape, that is a ball in the dual norm  $F^{\circ}$ ; the right-hand side inequality is optimal for a suitable sequence of thinning rectangles.

When  $F = \mathcal{E}$  is the Euclidean norm, there is a wide literature on sharp estimates for  $T_p(\Omega)$  related to several geometrical quantities depending on  $\Omega$ . For example, in the classical case of the torsional rigidity for the Laplace operator (p = 2), with N = 2, it is known that

$$\frac{1}{8} \leqslant \Psi(\Omega) = \frac{\mathsf{T}_2(\Omega)}{\mathsf{R}_{\mathcal{E}}^2|\Omega|} \leqslant \frac{1}{3},$$

where  $R_{\mathcal{E}}(\Omega)$  is the standard Euclidean inradius of  $\Omega$ . The left-hand side inequality is due to Pólya and Szegő (see [PZ]), while the right-hand side inequality was proved by Makai in [M]. As regards the case  $p \neq 2$ , in [FGL], among other results, estimates for  $\Psi(\Omega)$  are given in the planar case, obtaining an upper bound and a sharp lower bound. In the anisotropic case, in [BGM] the estimates in *ii*) are proved for p = 2.

As regards the functional  $\Phi(\Omega)$ , up to our knowledge, it seems that the only known result is in the Euclidean case for p = 2. Indeed, in [HLP] the authors prove the following estimates:

$$\frac{1}{(N+1)^2} \leqslant \Phi(\Omega) = \frac{T_2(\Omega)}{|\Omega| M(\Omega)} \leqslant \frac{2}{3}$$

Moreover, they show the optimality of the upper bound, while they conjecture that the lower bound is not optimal, and that the sharp constant in the plane is  $\frac{1}{3}$ , achieved on a sequence of thinning isosceles triangles. In our result, we improve the constant  $(N + 1)^{-2}$ , replacing it with  $[N(N + 2)]^{-1}$ . Anyway, we believe that  $[N(N + 2)]^{-1}$  is not optimal, and for N = 2 we show that there is a sequence of thinning isosceles triangles  $\tau_n$  such that  $\Phi(\tau_n) \rightarrow \frac{1}{3}$ .

In order to prove our main result, among the main tools involved, the following estimate for the maximum  $M(\Omega)$  of the torsion function  $u_{\Omega}$  plays a key role.

(6)

**Theorem 1.2.** Let  $\Omega$  be a bounded convex domain in  $\mathbb{R}^N$ ,  $N \ge 2$ , and let  $R_F(\Omega)$  the anisotropic inradius of  $\Omega$ . Let  $u_{\Omega}$  be the solution of (1). For 1 it holds that

$$\frac{\mathsf{R}_{\mathsf{F}}^{\mathsf{q}}(\Omega)}{\mathsf{q}\mathsf{N}^{\mathsf{q}-1}} \leqslant \mathsf{M}(\Omega) \leqslant \frac{\mathsf{R}_{\mathsf{F}}^{\mathsf{q}}(\Omega)}{\mathsf{q}}.$$
(2)

The right-hand side inequality is optimal for a suitable sequence of thinning N-rectangular domains. The other inequality, holds as an equality if and only if  $\Omega$  is the Wulff shape  $W_R(x_0)$ .

The upper bound in (2) has been proved in [P] in the Euclidean case for p = 2, N = 2 (see also [S]), by using a  $\mathcal{P}$ -function computation and a maximum principle. Anyway, many other estimates for the torsion function are known; the interested reader can refer, for example, to [vB, BFr, HLP] and the reference therein contained. We prove inequality (2) generalizing the  $\mathcal{P}$ -function technique to the case 1 , and in the anisotropic case.

Finally, we recall that in the Euclidean case, several other estimates for the p-torsional rigidity, involving different geometrical quantities, are known (for the Euclidean case, see for instance [vBBV, vBFNT, S] (p = 2), [FGL] (1 ), and [DG1] for the anisotropic case (<math>1 )).

The paper is organized as follows. In Section 2 we fix some notation and recall prelimiary results about Finsler metrics and the anisotropic p-torsional rigidity. In Section 3 we prove Theorem 1.2 by using the  $\mathcal{P}$ -function method. Finally, in Section 4 we give the proof of the main Theorem 1.1. We will split it in several partial results.

## 2 NOTATION AND PRELIMINARIES

Throughout the paper we will consider a convex even 1-homogeneous function

$$\xi \in \mathbb{R}^{\mathbb{N}} \mapsto F(\xi) \in [0, +\infty[,$$

that is a convex function such that

$$F(t\xi) = |t|F(\xi), \quad t \in \mathbb{R}, \, \xi \in \mathbb{R}^{N},$$
(3)

and such that

$$a|\xi| \leqslant F(\xi), \quad \xi \in \mathbb{R}^N,$$
 (4)

for some constant a > 0. The hypotheses on F imply there exists  $b \ge a$  such that

$$F(\xi) \leq b|\xi|, \quad \xi \in \mathbb{R}^{N}. \tag{5}$$

Moreover, throughout the paper we will assume that  $F\in C^{3,\beta}(\mathbb{R}^N\setminus\{0\}),$  and

 $[F^p]_{\xi\xi}(\xi)$  is positive definite in  $\mathbb{R}^N \setminus \{0\}$ ,

with 1 .

The hypothesis (6) on F ensures that the operator

$$\mathfrak{Q}_{p}\mathfrak{u} := \operatorname{div}\left(\frac{1}{p}\nabla_{\xi}[F^{p}](\nabla\mathfrak{u})\right)$$

is elliptic, hence there exists a positive constant  $\gamma$  such that

$$\frac{1}{p}\sum_{i,j=1}^{n}\nabla_{\xi_{i}\xi_{j}}^{2}[F^{p}](\eta)\xi_{i}\xi_{j} \geqslant \gamma|\eta|^{p-2}|\xi|^{2},$$

for some positive constant  $\gamma$ , for any  $\eta \in \mathbb{R}^n \setminus \{0\}$  and for any  $\xi \in \mathbb{R}^n$ .

## **Remark 2.1.** We stress that for $p \ge 2$ the condition

 $\nabla^2_{\xi}[F^2](\xi)$  is positive definite in  $\mathbb{R}^N \setminus \{0\}$ ,

implies (6).

The polar function  $F^o\colon \mathbb{R}^N \to [0,+\infty[$  of F is defined as

$$F^{o}(v) = \sup_{\xi \neq 0} \frac{\langle \xi, v \rangle}{F(\xi)}.$$

It is easy to verify that also  $F^{o}$  is a convex function which satisfies properties (3) and (4). Furthermore,

$$\mathsf{F}(\mathsf{v}) = \sup_{\xi \neq 0} \frac{\langle \xi, \mathsf{v} \rangle}{\mathsf{F}^{\mathsf{o}}(\xi)}.$$

From the above property it holds that

 $|\langle \xi, \eta \rangle| \leqslant F(\xi) F^{o}(\eta), \qquad \forall \xi, \eta \in \mathbb{R}^{N}.$ (7)

The set

$$\mathcal{W} = \{\xi \in \mathbb{R}^{\mathsf{N}} : \mathsf{F}^{\mathsf{o}}(\xi) < 1\}$$

is the so-called Wulff shape centered at the origin. We put  $\kappa_n = |\mathcal{W}|$ , where  $|\mathcal{W}|$  denotes the Lebesgue measure of  $\mathcal{W}$ . More generally, we denote with  $\mathcal{W}_r(x_0)$  the set  $r\mathcal{W} + x_0$ , that is the Wulff shape centered at  $x_0$  with measure  $\kappa_n r^n$ , and  $\mathcal{W}_r(0) = \mathcal{W}_r$ .

We observe that F is the support function of  $\overline{W}$ . In general for a nonempty closed convex set  $K \subset \mathbb{R}^N$ , the support function  $h_K$  is defined by

$$h_{\mathsf{K}}(\mathbf{x}) := \sup\{\langle \mathbf{x}, \xi \rangle, \xi \in \mathsf{K}\}, \quad \text{for } \mathbf{x} \in \mathbb{R}^{\mathsf{N}}.$$
(8)

The following properties of F and F<sup>o</sup> hold true:

$$\langle \mathsf{F}_{\xi}(\xi), \xi \rangle = \mathsf{F}(\xi), \quad \langle \mathsf{F}^{\mathsf{o}}_{\xi}(\xi), \xi \rangle = \mathsf{F}^{\mathsf{o}}(\xi), \qquad \forall \xi \in \mathbb{R}^{\mathsf{N}} \setminus \{0\}$$
(9)

$$F(F^{o}_{\xi}(\xi)) = F^{o}(F_{\xi}(\xi)) = 1, \quad \forall \xi \in \mathbb{R}^{N} \setminus \{0\},$$
(10)

$$\mathsf{F}^{\mathsf{o}}(\xi)\mathsf{F}_{\xi}(\mathsf{F}^{\mathsf{o}}_{\xi}(\xi)) = \mathsf{F}(\xi)\mathsf{F}^{\mathsf{o}}_{\xi}(\mathsf{F}_{\xi}(\xi)) = \xi \qquad \forall \xi \in \mathbb{R}^{\mathsf{N}} \setminus \{0\}.$$
(11)

## 2.1 Anisotropic mean curvature

Let  $\Omega$  be a  $C^2$  bounded domain, and  $\nu(x)$  be the unit outer normal at  $x \in \partial\Omega$ , and let  $u \in C^2(\overline{\Omega})$  such that  $\Omega_t = \{u > t\}$ ,  $\partial\Omega_t = \{u = t\}$  and  $\nabla u \neq 0$  on  $\partial\Omega_t$ . The anisotropic outer normal  $n_F$  to  $\partial\Omega_t$  is given by

$$\mathfrak{n}_{\mathsf{F}}(\mathbf{x}) = \mathsf{F}_{\xi}(\mathbf{v}(\mathbf{x})) = \mathsf{F}_{\xi}(-\nabla \mathfrak{u}), \quad \mathbf{x} \in \partial \Omega.$$

It holds

$$F^{o}(n_{F}) = 1.$$

The anisotropic mean curvature of  $\partial \Omega_t$  is defined as

$$\mathcal{H}_{\mathsf{F}}(\mathbf{x}) = \operatorname{div}\left(\mathsf{n}_{\mathsf{F}}(\mathbf{x})\right) = \operatorname{div}\left[\nabla_{\xi}\mathsf{F}\left(-\nabla \mathsf{u}(\mathbf{x})\right)\right], \quad \mathbf{x} \in \partial\Omega_{\mathsf{t}}.$$
(12)

It holds that

$$\frac{\partial u}{\partial n_{\rm F}} = \nabla u \cdot F_{\xi}(-\nabla u) = -F(\nabla u). \tag{13}$$

In [X] it has been proved that for a smooth function u, on its level sets  $\{u = t\}$  it holds

$$Q_2 u = \frac{\partial u}{\partial n_F} \mathcal{H}_F + \frac{\partial^2 u}{\partial n_F^2}, \tag{14}$$

where  $\frac{\partial u}{\partial n_F} = \nabla u \cdot n_F$ . In the next result we generalize (14) for  $\Omega_p u$ .

**Proposition 2.2.** Let u be a  $C^2(\overline{\Omega})$  function with a regular level set  $\partial \Omega_t$ . Then we have

$$\mathfrak{Q}_{p}\mathfrak{u} = F^{p-2}(\nabla\mathfrak{u})\left(\frac{\partial\mathfrak{u}}{\partial\mathfrak{n}_{F}}\mathfrak{H}_{F} + (p-1)\frac{\partial^{2}\mathfrak{u}}{\partial\mathfrak{n}_{F}^{2}}\right),\tag{15}$$

where  $\mathcal{H}_{F}$  is the anisotropic mean curvature of  $\partial \Omega_{t}$  as defined in (12).

*Proof.* By definition of  $Q_p$ , (14) and (13), we have

$$\begin{split} \mathfrak{Q}_p \mathfrak{u} &= div \left( F^{p-2}(\nabla \mathfrak{u}) F(\nabla \mathfrak{u}) F_{\xi}(\nabla \mathfrak{u}) \right) \\ &= F^{p-2}(\nabla \mathfrak{u}) \left( Q_2 \mathfrak{u} + (p-2) F_{\xi_i}(\nabla \mathfrak{u}) F_{\xi_j}(\nabla \mathfrak{u}) \mathfrak{u}_{x_i x_j} \right) \\ &= F^{p-2}(\nabla \mathfrak{u}) \left( \frac{\partial \mathfrak{u}}{\partial \mathfrak{n}_F} \mathfrak{H}_F + \frac{\partial^2 \mathfrak{u}}{\partial \mathfrak{n}_F^2} + (p-2) F_{\xi_i}(\nabla \mathfrak{u}) F_{\xi_j}(\nabla \mathfrak{u}) \mathfrak{u}_{x_i x_j} \right) \\ &= F^{p-2}(\nabla \mathfrak{u}) \left( \frac{\partial \mathfrak{u}}{\partial \mathfrak{n}_F} \mathfrak{H}_F + (p-1) \frac{\partial^2 \mathfrak{u}}{\partial \mathfrak{n}_F^2} \right), \end{split}$$

that is the thesis.

Finally we recall the definition of the anisotropic distance from the boundary and the anisotropic inradius.

Let us consider a domain  $\Omega$ , that is a connected open set of  $\mathbb{R}^N$ , with non-empty boundary. The anisotropic distance of  $x \in \overline{\Omega}$  to the boundary of  $\partial \Omega$  is the function

$$d_F(x) = \inf_{y \in \partial \Omega} F^o(x - y), \quad x \in \overline{\Omega}.$$

We stress that when  $F = |\cdot|$  then  $d_F = d_{\mathcal{E}}$ , the Euclidean distance function from the boundary.

It is not difficult to prove that  $d_F$  is a uniform Lipschitz function in  $\overline{\Omega}$  and, using the property of F we have

$$F(\nabla d_F(x)) = 1$$
 a.e. in  $\Omega$ .

Obviously, assuming  $\sup_{\Omega} d_F < +\infty$ ,  $d_F \in W_0^{1,\infty}(\Omega)$  and the quantity

$$R_{\rm F}(\Omega) = \sup\{d_{\rm F}(x), \ x \in \Omega\},\tag{16}$$

is called anisotropic inradius of  $\Omega$ .

For further properties of the anisotropic distance function we refer the reader to [CM].

# 2.2 Anisotropic p-torsional rigidity

In this subsection we summarize some properties of the anisotropic p-torsional rigidity. We refer the reader to [DG1] for further details.

Let  $\Omega$  be a bounded domain in  $\mathbb{R}^N$ , and 1 . Throughout the paper we will denote by q the Hölder conjugate of p,

$$q:=\frac{p}{p-1}.$$

Let us consider the torsion problem for the anisotropic p-Laplacian

$$\begin{cases} -\Omega_{p} \mathfrak{u} := -\operatorname{div} \left( F^{p-1}(\nabla \mathfrak{u}) F_{\xi}(\nabla \mathfrak{u}) \right) = 1 & \text{in } \Omega \\ \mathfrak{u} = 0 & \text{on } \partial \Omega. \end{cases}$$
(17)

By classical result there exists a unique solution of (17), that we will always denote by  $u_{\Omega}$ , which is positive in  $\Omega$ . Moreover, by (6) and being  $F \in C^3(\mathbb{R}^n \setminus \{0\})$ , then  $u_{\Omega} \in C^{1,\alpha}(\Omega) \cap C^3(\{\nabla u_{\Omega} \neq 0\})$  (see [LU, To]).

In view of the above considerations, we define the p-torsional anisotropic rigidity of  $\Omega$  the number  $T_p(\Omega) > 0$  such that

$$T_{p}(\Omega) = \int_{\Omega} F(\nabla u_{\Omega})^{p} dx = \int_{\Omega} u_{\Omega} dx.$$
(18)

A characterization of  $T_p$  is provided by the equality  $T_p(\Omega) = \sigma(\Omega)^{\frac{1}{p-1}}$ , where  $\sigma(\Omega)$  is the best constant in the Sobolev inequality

$$\|\phi\|_{L^{1}(\Omega)}^{p} \leqslant \sigma(\Omega) \|F(\nabla\phi)\|_{L^{p}(\Omega)}^{p},$$

that is

$$T_{p}(\Omega)^{p-1} = \sigma(\Omega) = \max_{\Psi \in W_{0}^{1,p}(\Omega) \setminus \{0\}} \frac{\left(\int_{\Omega} |\Psi| \, dx\right)^{p}}{\int_{\Omega} F(\nabla \Psi)^{p} \, dx},$$
(19)

and the solution  $u_{\Omega}$  of (17) realizes the maximum in (19).

It is immediate to see that if  $\Omega \subset \tilde{\Omega}$ , then

$$\mathsf{T}_{\mathsf{p}}(\Omega) \leqslant \mathsf{T}_{\mathsf{p}}(\tilde{\Omega}). \tag{20}$$

Moreover, by the maximum principle it holds that

$$\mathsf{M}(\Omega) \leqslant \mathsf{M}(\Omega),$$
 (21)

where  $M(\Omega)$  is the maximum of the torsion function in  $\Omega$ .

A consequence of the anisotropic Pólya-Szegő inequality (see [AFLT]) is the following upper bound for  $T_p(\Omega)$  in terms of the measure of  $\Omega$ .

**Theorem 2.3.** Let  $\Omega$  be a bounded open set of  $\mathbb{R}^{N}$ . Then,

$$\mathsf{T}_{\mathsf{p}}(\Omega) \leqslant \mathsf{T}_{\mathsf{p}}(\mathcal{W}_{\mathsf{R}}),\tag{22}$$

where  $W_R$  is the Wulff shape centered at the origin with the same Lebesgue measure as  $\Omega$ .

**Remark 2.4.** If  $\Omega = W_R$ , by the simmetry of the problem,  $T_p(W_R)$  and the solution u of (17) can be explicitly calculated. We have:

$$u_{\mathcal{W}}(x) = \frac{R^{q} - F^{o}(x)^{q}}{qN^{q-1}} \quad \text{and} \quad T_{p}(\mathcal{W}_{R}) = \frac{1}{N^{q-1}} \frac{|\mathcal{W}_{R}|}{N+q} R^{q}.$$
(23)

**Remark 2.5.** We point out that the lower bound in statement *ii*) of Theorem 1.1 gives a stability type inequality for (22). Indeed we have

$$0 \leqslant T_{p}(\mathcal{W}_{R}) - T_{p}(\Omega) \leqslant \frac{1}{8} \left( R^{2} - R_{F}^{2}(\Omega) \right),$$

where  $|\mathcal{W}_{\mathsf{R}}| = |\Omega|$ .

# 3 AN ESTIMATE OF THE MAXIMUM OF THE TORSION FUNCTION

In order to give a sharp upper bound for the maximum  $M(\Omega)$  of the torsion function  $u_{\Omega}$ , we will take into account the following  $\mathcal{P}$ -function:

$$\mathfrak{P}(\mathbf{x}) = \frac{\mathbf{p} - \mathbf{1}}{\mathbf{p}} \mathsf{F}^{\mathbf{p}}(\nabla \mathfrak{u}_{\Omega}) + \mathfrak{u}_{\Omega} - \mathsf{M}(\Omega),$$

where  $M(\Omega) = \max_{\Omega} u_{\Omega}$ . The following result is proved in [CFV].

**Proposition 3.1.** Let  $\Omega$  be a domain in  $\mathbb{R}^N$ ,  $N \ge 2$ , and  $\mathfrak{u}_{\Omega} \in W_0^{1,p}(\Omega)$  be a solution of (17). Set

$$d_{ij} := \frac{1}{F(\nabla u_{\Omega})} \vartheta_{\xi_i \xi_j} \left[ \frac{F^p}{p} \right] (\nabla u_{\Omega}),$$

Then it holds that

$$(\mathbf{d}_{ij}\mathcal{P}_{i})_{j} - \mathbf{b}_{k}\mathcal{P}_{k} \ge 0 \quad in \{\nabla \mathbf{u}_{\Omega} \neq 0\}$$

where

$$\mathfrak{b}_{k} = \frac{\mathfrak{p}-2}{F^{3}(\nabla\mathfrak{u}_{\Omega})} F_{\xi_{\ell}}(\nabla\mathfrak{u}_{\Omega}) \mathcal{P}_{\mathfrak{x}_{\ell}} F_{\xi_{k}}(\nabla\mathfrak{u}_{\Omega}) + \frac{2\mathfrak{p}-3}{F^{2}(\nabla\mathfrak{u}_{\Omega})} \left(\frac{F_{\xi_{k}\xi_{\ell}}(\nabla\mathfrak{u}_{\Omega})\mathcal{P}_{\mathfrak{x}_{\ell}}}{\mathfrak{p}-1} - F_{\xi_{k}}(\nabla\mathfrak{u}_{\Omega})\right)$$

As a consequence of the previous result we get the following maximum principle for  $\mathcal{P}$ .

**Theorem 3.2.** Let  $\Omega$  be a bounded  $C^2$  domain in  $\mathbb{R}^N$ ,  $N \ge 2$ , with nonnegative anisotropic mean curvature  $\mathcal{H}_F \ge 0$  on  $\partial\Omega$ , and  $u_{\Omega}$  the torsion function. Then

$$\frac{p-1}{p}\mathsf{F}^{\mathsf{p}}(\nabla \mathfrak{u}_{\Omega}) + \mathfrak{u}_{\Omega} \leqslant \mathsf{M}(\Omega) \quad \text{ in } \overline{\Omega},$$

that is the function  $\mathfrak{P}$  achieves its maximum at the points  $x_M \in \Omega$  such that  $u_{\Omega}(x_M) = M(\Omega)$ .

*Proof.* Let us denote by  $E_{u_{\Omega}}$  the set of the critical points of  $u_{\Omega}$ , that is  $E_{u_{\Omega}} = \{x \in \overline{\Omega} : \nabla u_{\Omega}(x) = 0\}$ . Being  $\partial \Omega C^2$ , by the Hopf Lemma (see for example [CT]),  $E_{u_{\Omega}} \cap \partial \Omega = \emptyset$ .

Applying Proposition 3.1, the function  $\mathcal{P}$  verifies a maximum principle in the open set  $\Omega \setminus E_{u_{\Omega}}$ . Then we have

$$\max_{\Omega \setminus \mathsf{E}_{\mathfrak{u}_{\Omega}}} \mathcal{P} = \max_{\mathfrak{d} \left( \Omega \setminus \mathsf{E}_{\mathfrak{u}_{\Omega}} \right)} \mathcal{P}$$

Hence one of the following three cases occur

- 1. the maximum point of  $\mathcal{P}$  is on  $\partial \Omega$ ;
- 2. the maximum point of  $\mathcal{P}$  is on  $E_u$ ;
- 3. the function  $\mathcal{P}$  is constant in  $\overline{\Omega}$ .

In order to prove the theorem we have to show that statement 1 cannot happen. Let us compute the derivative of  $\mathcal{P}$  in the direction of the anisotropic normal  $n_F$ , in the sense of (13). Hence we get

$$\frac{\partial \mathcal{P}}{\partial n_{F}} = \frac{p-1}{p} \frac{\partial}{\partial n_{F}} \left( -\frac{\partial u_{\Omega}}{\partial n_{F}} \right)^{p} + \frac{\partial u_{\Omega}}{\partial n_{F}} = -(p-1) \left( -\frac{\partial u}{\partial n_{F}} \right)^{p-1} \frac{\partial^{2} u_{\Omega}}{\partial n_{F}^{2}} + \frac{\partial u_{\Omega}}{\partial n_{F}} = -F(\nabla u_{\Omega}) \mathcal{Q}_{p}[u] - F^{p-1}(\nabla u_{\Omega}) \mathcal{H}_{F} - F(\nabla u_{\Omega}) = -F^{p-1}(\nabla u_{\Omega}) \mathcal{H}_{F}, \quad (24)$$

where last identity follows by (15). On the other hand, if a maximum point  $\bar{x}$  of  $\mathcal{P}$  is on  $\partial\Omega$ , by Hopf Lemma either  $\mathcal{P}$  is constant in  $\overline{\Omega}$ , or  $\frac{\partial \mathcal{P}}{\partial n_F}(\bar{x}) > 0$ . Hence being  $\mathcal{H}_F \ge 0$  we have a contradiction.

As a consequence of the previous result we get the following optimal estimate for the maximum of  $u_{\Omega}$ .

**Theorem 3.3.** Let  $\Omega$  be a bounded convex domain in  $\mathbb{R}^N$ ,  $N \ge 2$ , and 1 . It holds that

$$\frac{\mathsf{R}_{\mathsf{F}}^{\mathsf{q}}(\Omega)}{\mathsf{q}\mathsf{N}^{\mathsf{q}-1}} \leqslant \mathsf{M}(\Omega) \leqslant \frac{\mathsf{R}_{\mathsf{F}}^{\mathsf{q}}(\Omega)}{\mathsf{q}}.$$
(25)

**Remark 3.4.** In the next section we will show that the right-hand side inequality in (25) is optimal on a suitable sequence of thinning rectangles (see Proposition 4.4 and (36). We stress that, in general, the quotient  $\frac{R_F^q(\Omega)}{qM(\Omega)}$  approaches the value 1 also for different sequences of sets (see the example 4.7).

*Proof.* The left-hand side inequality of (25) follows by (21) and (23). Hence, let us prove the other inequality.

First of all, suppose that  $\Omega$  is a C<sup>2</sup>, strictly convex domain. Let  $\nu$  be a direction in  $\mathbb{R}^N$ . By Theorem 3.2 and property (7) we have

$$\frac{\mathrm{d}\mathfrak{u}_{\Omega}}{\mathrm{d}\nu} = \langle \nabla\mathfrak{u}, \nu \rangle \leqslant F(\nabla\mathfrak{u}_{\Omega})F^{o}(\nu) \leqslant \left[\frac{p}{p-1}\left(\mathsf{M}(\Omega) - \mathfrak{u}_{\Omega}\right)\right]^{\frac{1}{p}}F^{o}(\nu), \tag{26}$$

where  $M(\Omega)$  is the maximum of  $u_{\Omega}$  in  $\overline{\Omega}$ . Let us denote by  $x_{M}$  the point of  $\Omega$  such that  $M(\Omega) = u_{\Omega}(x_{M})$ , by  $\bar{x} \in \partial \Omega$  such that  $F^{o}(x_{M} - \bar{x}) = d_{F}(x_{M})$  and by  $\nu$  the direction of the straight line joining the points  $x_{m}$  and  $\bar{x}$ . Then by (26) we get

$$\int_{u(\bar{x})}^{M(\Omega)} \frac{1}{(M(\Omega) - u_{\Omega})^{\frac{1}{p}}} du \leqslant \left(\frac{p}{p-1}\right)^{\frac{1}{p}} F^{o}(\nu) |\bar{x} - x_{M}| = \left(\frac{p}{p-1}\right)^{\frac{1}{p}} F^{o}(\bar{x} - x_{M}).$$

Being  $F^{o}(\bar{x} - x_{\mathcal{M}}) \leq R_{F}(\Omega)$ , we get

$$\left(\frac{p}{p-1}\right)M(\Omega)^{\frac{p-1}{p}} \leqslant \left(\frac{p}{p-1}\right)^{\frac{1}{p}} R_{F}(\Omega),$$

which gives the estimate (25) for smooth convex domains. To prove the estimate in the case of a general convex body  $\Omega$ , we proceed by approximation. It is well-known (see for example [BF]) that a convex body  $\Omega$  can be approximated in the Hausdorff distance by an increasing sequence of smooth strictly convex bodies  $\Omega_n \subseteq \Omega$ . Clearly,  $R_F(\Omega_n) \nearrow R_F(\Omega)$ .

Let  $u_n \ge 0$  be the torsion function in  $\Omega_n$ . In order to conclude the proof we have to show that  $M(\Omega_n) \to M(\Omega)$  as  $n \to \infty$ . We first observe that by (25),

$$M(\Omega_n) \leqslant \frac{\mathsf{R}^{\mathsf{q}}_{\mathsf{F}}(\Omega_n)}{\mathsf{q}} \leqslant \frac{\mathsf{R}^{\mathsf{q}}_{\mathsf{F}}(\Omega)}{\mathsf{q}},\tag{27}$$

hence  $u_n$  are bounded in  $L^{\infty}(\Omega_n)$ . Furthermore, applying Theorem 3.2 in  $\Omega_n$  we have

$$\frac{p-1}{p}F^{p}(\nabla u_{n})+u_{n}\leqslant M(\Omega_{n})\quad\text{ in }\overline{\Omega}_{n}.$$

Then by property (5)

$$|\nabla u_n| \leqslant C \quad \text{in } \overline{\Omega}_n. \tag{28}$$

Hence by (27) and (28), using Ascoli-Arzelà theorem we get that  $u_n \to u_\Omega$  uniformly in  $\Omega$  and this allows to pass to the limit in (27) and the proof is completed.

**Remark 3.5.** We point out that if we take  $\Omega$  smooth, the thesis of Theorem 3.3 holds if we assume only that the anisotropic mean curvature of  $\Omega$  is nonnegative.

# 4 PROOF OF THEOREM 1.1

We split the proof in various theorems. We first prove the lower bound for  $\Psi(\Omega)$  in *ii*).

**Theorem 4.1.** If  $\Omega \in \mathbb{R}^N$  is a convex bounded domain,  $N \ge 2$ , and 1 , then

$$\frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|} \ge \frac{1}{\mathsf{N}^{\mathsf{q}-1}} \frac{1}{\mathsf{N}+\mathsf{q}} \mathsf{R}_{\mathsf{F}}(\Omega)^{\mathsf{q}},\tag{29}$$

where  $R_F(\Omega)$  is the anisotropic inradius of  $\Omega$  defined in (16). Moreover the equality holds when  $\Omega$  is a Wulff shape.

*Proof.* Let us assume first that  $\Omega$  is a strictly convex domain and then we remove this assumption with a proof that follows by approximation as in Theorem 3.3. Let us consider as test function into (19) the following

$$\phi(x) = \frac{1 - \mathcal{K}^o(x)^q}{qN^{q-1}}$$

where  $\mathcal{K}^{o}$  is the support function of the polar set of  $\Omega$ , defined in (8). Then  $\Omega = \{\mathcal{K}^{o} < 1\}$ . By (23), we observe that when  $\Omega = W$  then  $\varphi$  is exactly the torsion function of the Wulff shape.

We start computing

$$\begin{split} \int_{\Omega} \mathcal{K}^{\mathbf{o}}(\mathbf{x})^{q} \, d\mathbf{x} &= \int_{0}^{1} \int_{\mathcal{K}^{\mathbf{o}}=\mathbf{t}} \frac{\mathbf{t}^{q}}{|\nabla \mathcal{K}^{\mathbf{o}}(\mathbf{x})|} \, d\mathcal{H}^{\mathbf{N}-1} \, d\mathbf{t} = \int_{0}^{1} \mathbf{t}^{q} \int_{\mathcal{K}^{\mathbf{o}}=\mathbf{t}} \frac{\mathcal{K}(\nabla \mathcal{K}^{\mathbf{o}}(\mathbf{x}))}{|\nabla \mathcal{K}^{\mathbf{o}}|} \, d\mathcal{H}^{\mathbf{N}-1} \, d\mathbf{t}, \\ &= \int_{0}^{1} \mathbf{t}^{q+\mathbf{N}-1} \int_{\partial\Omega} \mathcal{K}(\mathbf{v}_{\Omega}(\mathbf{x})) \, d\mathcal{H}^{\mathbf{N}-1} \, d\mathbf{t} = \frac{1}{\mathbf{N}+q} \int_{\partial\Omega} \mathbf{x} \cdot \mathbf{v}_{\Omega}(\mathbf{x}) \, d\mathcal{H}^{\mathbf{N}-1} \\ &= \frac{1}{\mathbf{N}+q} \int_{\Omega} \operatorname{div} \mathbf{x} \, d\mathbf{x} = \frac{\mathbf{N}|\Omega|}{\mathbf{N}+q}, \end{split}$$

where  $\mathcal{K} = (\mathcal{K}^{o})^{o}$ . Then we have

$$\left(\int_{\Omega} \varphi \, dx\right)^p = \frac{|\Omega|^p}{\mathsf{N}^q(\mathsf{N}+\mathsf{q})^p} = \left(\frac{|\Omega|}{\mathsf{N}^{q-1}(\mathsf{N}+\mathsf{q})}\right)^p. \tag{30}$$

Let us now compute

$$\begin{split} \int_{\Omega} F^{p}(\nabla \phi) \, dx &= \frac{1}{q^{p} N^{q}} \int_{\Omega} F^{p}\left(\nabla(\mathcal{K}^{o}(x)^{q})\right) \, dx = \frac{1}{N^{q}} \int_{0}^{1} t^{p(q-1)} \int_{\mathcal{K}^{o}=t} \frac{F^{p}(\nabla \mathcal{K}^{o})}{|\nabla \mathcal{K}^{o}|} \, d\mathcal{H}^{N-1} \, dt \\ &= \frac{1}{N^{q}} \int_{0}^{1} t^{q+N-1} \int_{\partial \Omega} |\nabla \mathcal{K}^{o}|^{p-1} F^{p}(\nu_{\Omega}) \, d\mathcal{H}^{N-1} \, dt \\ &= \frac{1}{N^{q}} \int_{0}^{1} t^{q+N-1} \int_{\partial \Omega} \frac{F^{p}(\nu_{\Omega})}{\mathcal{K}^{p-1}(\nu_{\Omega})} \, d\mathcal{H}^{N-1} \, dt, \end{split}$$

where last equality follows by the identity  $\mathcal{K}(\nabla \mathcal{K}^{o}(x)) = 1$ . Being  $\mathcal{W}_{\mathsf{R}_{\mathsf{F}}(\Omega)} \subseteq \Omega$ , it follows that  $\mathcal{K}(x) \ge \mathsf{R}_{\mathsf{F}}(\Omega)\mathsf{F}(x)$ , so we have

$$\int_{\Omega} F^{p}(\nabla \varphi) \, dx \leqslant \frac{1}{(N+q)N^{q}} \cdot \frac{1}{R_{F}(\Omega)^{p}} \int_{\partial \Omega} \mathcal{K}(\nu_{\Omega}(x)) \, d\mathcal{H}^{N-1} = \frac{1}{(N+q)N^{q-1}} \cdot \frac{|\Omega|}{R_{F}(\Omega)^{p}}.$$
 (31)

Joining together (30) and (31), we have the thesis.

Now we prove the validity of (29) without the assumption on the strict convexity of the domain  $\Omega$ . As in the proof of Theorem 3.3, let  $\Omega_n$  be a sequence of smooth strictly convex bodies such that  $\Omega_n \to \Omega$ . Such a convergence ensures that, as  $n \to \infty$ ,

$$|\Omega_n| \to |\Omega|$$
 and  $R_F(\Omega_n) \to R_F(\Omega)$ . (32)

By (20), it follows that

 $\mathsf{T}_{\mathsf{p}}(\Omega) \geqslant \mathsf{T}_{\mathsf{p}}(\Omega_{\mathfrak{n}}),$ 

and by applying (29) to each  $\Omega_n$ , we find

$$T_p(\Omega) \ge \frac{|\Omega_n|}{N^{q-1}(N+q)} R_F(\Omega_n)^q,$$

which, combined with (32), gives the desired result. Finally we stress that if  $\Omega$  is a Wulff shape, the equality case follows from Remark 2.4. On the other hand, if the equality holds in (29), then equality must hold in (31), and then  $\mathcal{K}(x) = R_F(\Omega)F(x)$ , which implies  $\Omega = \mathcal{W}_{R_F}$ .  $\Box$ 

Let us consider the functional

$$\Phi(\Omega) = \frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|\mathsf{M}(\Omega)}.$$
(33)

As consequence of theorems 4.1 and 3.3, we can prove the following estimates for (33) which is statement i) of Theorem 1.1.

**Theorem 4.2.** For any bounded convex domain  $\Omega \subset \mathbb{R}^N$ ,  $N \ge 2$ , 1 it holds that

$$\frac{q}{N^{q-1}(N+q)} \leqslant \Phi(\Omega) \leqslant \frac{q}{q+1}$$
(34)

*Proof.* We first prove the lower bound for the functional  $\Phi$ . By (29) and (25) we have

$$\Phi(\Omega) = \frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|\mathsf{M}(\Omega)} \ge \frac{\mathsf{q}}{\mathsf{N}^{\mathsf{q}-1}(\mathsf{N}+\mathsf{q})},$$

which gives the lower bound in (34).

In order to prove the inequality in the right-hand side in (34), by Theorem 3.2 we have

$$\frac{p-1}{p}F^p(\nabla \mathfrak{u}_{\Omega}) + \mathfrak{u}_{\Omega} \leqslant M(\Omega) \quad \text{in } \overline{\Omega}.$$

Integrating in both sides and recalling (18), we get

$$\left(\frac{p-1}{p}+1\right)T_p(\Omega)\leqslant M(\Omega)|\Omega|,$$

which implies the upper bound in (34).

In the following last result we prove the upper bound in statement *ii*) of Theorem 1.1, which follows immediately by the preceding results. We stress that in the anisotropic setting, the case p = 2 was previously considered in [BGM] with a completely different proof.

**Theorem 4.3.** Let  $\Omega \in \mathbb{R}^N$  be a bounded convex domain,  $N \ge 2$ , 1 . It holds that

$$\frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|} \leqslant \frac{\mathsf{R}_{\mathsf{F}}(\Omega)^{\mathsf{q}}}{\mathsf{q}+1}.$$
(35)

*Proof.* By the right-hand side inequality in (34), and (25), we have

$$\frac{\mathsf{T}_{\mathsf{p}}(\Omega)}{|\Omega|} \leqslant \frac{\mathsf{q}}{\mathsf{q}+1}\mathsf{M}(\Omega) \leqslant \frac{\mathsf{R}_{\mathsf{F}}^{\mathsf{q}}(\Omega)}{\mathsf{q}+1}.$$
(36)

The final part of the section is devoted to prove the optimality of (35). As a consequence, by (36) this will give the optimality of the right-hand side inequality of (34), and of (25).

**Proposition 4.4.** Let  $\Omega_{\varepsilon}$  be the N-rectangle  $] - \varepsilon$ ,  $\varepsilon[\times] - a_2$ ,  $a_2[\times \ldots \times] - a_N$ ,  $a_N[$ , and suppose that  $R_F(\Omega) = \varepsilon F^o(e_1)$ . Then

$$\lim_{\varepsilon \to 0^+} \frac{\mathsf{T}_{\mathsf{p}}(\Omega_{\varepsilon})}{(\mathsf{R}_{\mathsf{F}}(\Omega_{\varepsilon}))^{\mathfrak{q}} |\Omega_{\varepsilon}|} = \frac{1}{\mathfrak{q}+1} \,.$$

The hypothesis  $R_F(\Omega) = \varepsilon F^o(e_1)$  is not restrictive, in the sense that if it is not true we can choose a rotated N-rectangle where  $R_F(\Omega) = \varepsilon F^o(\nu)$  for some direction  $\nu$ , and use the remark below.

**Remark 4.5.** If  $A \in SO(N)$  is a rotation matrix, then, denoting by  $F_A(\xi) = F(A\xi)$ , it holds that

$$(F_A)^{o}(\xi) = (F^{o})_A(\xi)$$
, and then  $R_{F_{aT}}(A\Omega) = R_F(\Omega)$ 

(see [DGP] for the details). Hence, emphasizing the dependence on F by denoting  $T_p(\Omega) = T_{p,F}(\Omega)$ , we have

$$\begin{split} T_{p,F}(\Omega) &= \max_{\phi \in W_0^{1,p}(\Omega)} \frac{\left( \int_{\Omega} |\phi(x)| dx \right)^p}{\int_{\Omega} F^p(\nabla \phi(x)) dx} = \max_{\phi \in W_0^{1,p}(\Omega)} \frac{\left( \int_{A\Omega} |\phi(A^{\mathsf{T}}x)| dx \right)^p}{\int_{A\Omega} F_{A^{\mathsf{T}}}^p(\nabla \phi(A^{\mathsf{T}}x)) dx} \\ &= T_{p,F_{A^{\mathsf{T}}}}(A\Omega) \geqslant \frac{|\Omega|}{q+1} R_{F_{A^{\mathsf{T}}}}(A\Omega)^q = \frac{|\Omega|}{q+1} R_F(\Omega)^q. \end{split}$$

Proof of Proposition 4.4. First of all, we observe that

$$\mathsf{F}^{\mathsf{o}}(\mathsf{e}_1) = \frac{1}{\mathsf{F}(\mathsf{e}_1)}.$$

Indeed, being  $R_F(\Omega) = \varepsilon F^o(e_1)$ , it holds that

$$\nu_{\Omega}(\varepsilon e_1) = e_1 = \frac{\mathsf{F}^{\mathsf{o}}_{\xi}(e_1)}{|\mathsf{F}^{\mathsf{o}}_{\xi}(e_1)|},$$

where  $\nu_{\Omega}(\epsilon e_1)$  is the Euclidean outer normal vector to  $\partial\Omega$ . Hence by (10) and (9), we have

$$F(e_1) = \frac{1}{|F_{\xi}^{o}(e_1)|} = \frac{1}{F^{o}(e_1)},$$

where last equality follows by  $F^{o}(e_1) = F^{o}_{\xi}(e_1) \cdot e_1 = |F^{o}_{\xi}(e_1)|$ .

Let  $\Omega_{\varepsilon} = C_{\varepsilon} \cup D_{\varepsilon}$ , where  $C_{\varepsilon} = ] - \varepsilon$ ,  $\varepsilon[\times]a_2 + \varepsilon$ ,  $a_2 - \varepsilon[\times ... \times] - a_N + \varepsilon$ ,  $a_N - \varepsilon[$ , and  $D_{\varepsilon} = \Omega_{\varepsilon} \setminus C_{\varepsilon}$ . Setting  $x = (x_1, z)$  with  $z \in \mathbb{R}^{N-1}$  and  $a = (a_2, ..., a_N)$ , we consider the function  $\varphi_{\varepsilon}$  defined by

$$\begin{cases} \varphi_{\varepsilon}(x_{1},z) = \frac{\varepsilon^{q} - x_{1}^{q}}{q} & \text{in } C_{\varepsilon} \\ \varphi_{\varepsilon}(x_{1},z) = \min\left\{|a - z|, |-a - z|\right\} \frac{\varepsilon^{q} - x_{1}^{q}}{q\varepsilon} & \text{in } D_{\varepsilon}. \end{cases}$$

We can estimate the anisotropic p-torsional rigidity by using  $\varphi_{\varepsilon}$  as test function. We have:

$$T_{p}(\Omega_{\varepsilon})^{p-1} \geq \frac{\left(\int_{\Omega_{\varepsilon}} \varphi_{\varepsilon}\right)^{p}}{\int_{\Omega_{\varepsilon}} F^{p}(\nabla \varphi_{\varepsilon}) dx} = \frac{\left(\int_{C_{\varepsilon}} \varphi_{\varepsilon} + \int_{D_{\varepsilon}} \varphi_{\varepsilon} dx\right)^{p}}{\int_{C_{\varepsilon}} F^{p}(\nabla \varphi_{\varepsilon}) dx + \int_{D_{\varepsilon}} F^{p}(\nabla \varphi_{\varepsilon}) dx}$$

We now compute

$$\int_{C_{\varepsilon}} \varphi_{\varepsilon} \, dx = \int_{C_{\varepsilon}} \frac{\varepsilon^{q} - x_{1}^{q}}{q} \, dx = \frac{|C_{\varepsilon}|\varepsilon^{q}}{q+1}$$

and

$$\int_{C_{\varepsilon}} F^{p}(\nabla \phi_{\varepsilon}) \, dx = F^{p}(e_{1}) \int_{C_{\varepsilon}} x_{1}^{q} \, dx = F^{p}(e_{1}) \frac{|C_{\varepsilon}| \varepsilon^{q}}{q+1} \, .$$

We notice that both  $\int_{D_{\varepsilon}} \varphi_{\varepsilon} dx$  and  $\int_{D_{\varepsilon}} F^{p}(\nabla \varphi_{\varepsilon}) dx$  are negligible, since they go to zero as  $\varepsilon^{N+q-1}$ . By recalling that

$$(\mathbf{R}_{\mathbf{F}}(\Omega))^{\mathbf{q}} = \varepsilon^{\mathbf{q}} \mathbf{F}^{\mathbf{o}}(e_1)^{\mathbf{q}} = \frac{\varepsilon^{\mathbf{q}}}{\mathbf{F}(e_1)^{\mathbf{q}}}$$
,

we have

$$\frac{1}{q+1} \geqslant \lim_{\epsilon \to 0} \frac{T_p(\Omega_\epsilon)}{\left(R_F(\Omega_\epsilon)\right)^q |\Omega_\epsilon|} \geqslant \frac{1}{q+1}$$

which concludes the proof.

**Remark 4.6.** We believe that the lower bound of  $\Phi(\Omega)$  in (34) is not optimal. Actually, in the Euclidean setting, with p = 2 our bound improves the analogous result of [HLP]:

$$\Phi(\Omega) \geqslant \frac{2}{N(N+2)} > \frac{1}{(N+1)^2}$$

Moreover in [HLP] the authors conjecture that for  $F = \mathcal{E}$ , p = 2 and N = 2 it holds

$$\Phi(\Omega) \geqslant \frac{1}{3}$$

and

$$\Phi(\Omega_n) \to \frac{1}{3}, \quad \text{as } n \to \infty,$$
(37)

where  $\Omega_n$  is a sequence of isosceles triangles degenerating to a segment.

In the following example, for  $F = \mathcal{E}$ , N = 2 and p = 2, we find a sequence of degenerating triangles  $\Omega_n$  such that (37) holds.

Example 4.7. Let

N = 2, 
$$F(\xi) = \sqrt{\xi_1^2 + \xi_2^2}, p = 2.$$

We want to show that there exists a sequence of thinning isosceles triangles  $\tau_a$  of the plane such that

$$\Phi(\tau_{a}) = \frac{\mathsf{T}_{2}(\tau_{a})}{|\tau_{a}|\mathsf{M}(\tau_{a})} \to \frac{1}{3} \quad \text{as} \quad a \to 0,$$
(38)

where  $T_2(\tau_a)$  is the torsional rigidity of  $\tau_a$ ,  $M(\tau_a)$  is the maximum of the torsion function in  $\tau_a$  and  $|\tau_a|$  is the area of the triangle.

First of all, we recall that by a result contained in [FGL], for any sequence of isosceles triangles  $\tau_n$  such that the ratio  $\frac{R(\tau_n)}{w(\tau_n)} \rightarrow 0$ , where  $w(\tau_n)$  is the width of  $\tau_n$ , then

$$\lim_{n \to \infty} \frac{T_2(\tau_n)}{|\tau_n|} \frac{P^2(\tau_n)}{|\tau_n|^2} = \frac{2}{3}$$

Hence, recalling that in a triangle it holds that  $R(\tau_n) = \frac{2|\tau_n|}{P(\tau_n)}$  then

$$\Phi(\tau_n) = \frac{\mathsf{T}_2(\tau_n)}{|\tau_n|} \frac{\mathsf{P}^2(\tau_n)}{|\tau_n|^2} \frac{\mathsf{R}^2(\tau_n)}{4\mathsf{M}(\tau_n)}$$

the result is proved if we find a sequence of triangles with vanishing ratio  $R(\tau_n)/w(\tau_n)$  and such that  $\frac{R^2(\tau_n)}{2M(\tau_n)}$  tends to 1.

To this aim, let

$$\mathcal{E}_{\mathfrak{a}} = \left\{ (x, y) \in \mathbb{R}^2 \colon \frac{x^2}{1 - a^2} + \frac{(y - a)^2}{a^2} = 1 \right\},$$

and consider a point  $(a, y_a)$ , with  $y_a = a + a\sqrt{\frac{1-2a^2}{1-a^2}}$ . Let  $\tau_a$  be the isosceles triangle constructed with one side on the x-axis and with each side tangent to the ellipse at the points (0, 0),  $(a, y_a)$ ,  $(-a, y_a)$ , as in Figure 1.

The vertices of the triangle are:

$$V_{1} = \left(0, y_{a} + \frac{a^{4}}{(1 - a^{2})(y_{a} - a)}\right), \quad V_{2} = \left(a + \frac{y_{a}(y_{a} - a)}{a^{3}}(1 - a^{2}), 0\right), \quad V_{3} = -V_{2}.$$

Let us observe that  $V_1 \rightarrow (0, 0)$  as  $a \rightarrow 0$ , while the first coordinate of  $V_2$  diverges.

Then, denoting by  $A(\tau_{\alpha})$  and  $P(\tau_{\alpha})$  respectively the area and the perimeter of  $\tau_{\alpha}$ , and by

$$h = y_{a} + \frac{a^{4}}{(1-a^{2})(y_{a}-a)}, \quad \frac{b}{2} = a + \frac{y_{a}(y_{a}-a)}{a^{3}}(1-a^{2}),$$

we have:

$$R(\tau_{\alpha}) = \frac{2|\tau_{\alpha}|}{P(\tau_{\alpha})} = \frac{bh}{b + \sqrt{2h^2 + b^2}}.$$

Now, being  $\mathcal{E}_{\mathfrak{a}}\subset\tau_{\mathfrak{a}},$  by the comparison principle and (25) it holds that

$$M(\mathcal{E}_{\mathfrak{a}}) \leqslant M(\tau_{\mathfrak{a}}) \leqslant \frac{R^{2}(\tau_{\mathfrak{a}})}{2}, \qquad M(\mathcal{E}_{\mathfrak{a}}) = \frac{\mathfrak{a}^{2}(1-\mathfrak{a}^{2})}{2},$$

where the maximum of the torsion function on  $\mathcal{E}_a$  follows by a direct computation. Then, being  $h = 2a + o(a^2)$  and  $b \to +\infty$  as  $a \to 0$ , we have

$$1 \leqslant \frac{R(\tau_{\mathfrak{a}})^{2}}{2M(\mathcal{E}_{\mathfrak{a}})} = \left(\frac{b}{b + \sqrt{2h^{2} + b^{2}}}\right)^{2} \frac{h^{2}}{\mathfrak{a}^{2}(1 - \mathfrak{a}^{2})} = \left(\frac{1}{1 + \sqrt{2\frac{h^{2}}{b^{2}} + 1}}\right)^{2} \cdot \frac{h^{2}}{\mathfrak{a}^{2}(1 - \mathfrak{a}^{2})} \longrightarrow 1$$
as  $\mathfrak{a} \to \mathfrak{0}$ 

and (38) is proved.

We explicitly observe that, from the above computations, it holds

$$\frac{R^2(\mathcal{E}_{\mathfrak{a}})}{2M(\mathcal{E}_{\mathfrak{a}})} \to 1 \qquad \text{as } \mathfrak{a} \to 0.$$
