ABSTRACT.

In the first part of this article, which contains three of them, we have identified the notion of level N strong modular unit. It enabled us to structure the modular forms family $(M_{2k}(\Gamma_0(N)))_{k\in\mathbb{N}^*}$ and to propose the explicit bases for these spaces. It is in this perspective that we wrote this second part where the structure and explicit bases are proposed when $1 \leq N \leq 10$.

Introduction

We propose in this article to describe the complete modular space structure $(M_{2k}(\Gamma_0(N)))_{k\in\mathbb{N}^*}$ for $N \in [1, 10]$. This set of integers contains the first prime numbers, the square and the cube of prime numbers, as well as the product of two distinct prime numbers. Enough to adapt to other situations if necessary.

It is a question of applying concretely the results developed in the first part of this article [\[4\]](#page-28-0). For a given level N, we established the existence of a function Δ_N which enables one to structure the family $(M_{2k}(\Gamma_0(N)))_{k\in\mathbb{N}^*}$ and to describe bases of each of its spaces when we know a basis of each space $M_{2k}(\Gamma_0(N))$, for weights between 2 and ρ_N+2 , where ρ_N is the weight of Δ_N .

The modular forms constituting the bases for $2 \leq 2k \leq \rho_N + 2$, will be described in the form of $η$ -products, as far as $Δ_N$ is concerned, but especially of classic or renormalized Weierstrass elliptic functions described in [\[3\]](#page-28-1). These will enable one representations on various forms of modular forms.

1 – Weierstrass functions on the reduced lattice $\Lambda_{\tau} = \mathbb{Z} + \tau \mathbb{Z}$

The following results are reminders from [\[3\]](#page-28-1).

For τ in Poincaré half plane H, let $\Lambda_{\tau} = \mathbb{Z} + \tau \mathbb{Z}$ be the lattice of periods 1 and τ .

We remind results for the functions $\wp(z, \tau)$ and $\tilde{\wp}(z, \tau)$, renormalized by a multiplicative factor that avoids cluttering the modular forms with unnecessary factors

 and $\widetilde{\gamma} = \frac{1}{\pi^2} \widetilde{\wp}.$

These two functions enable one to obtain modular forms according to groups $\Gamma_0(N)$. As we will see, the γ function is more flexible to use, whereas γ is particularly adapted to $N = 2^n$ case and enables one to naturally obtain modular units.

 \bullet The function γ

- Definition on series form

For $(z, \tau) \in (\mathbb{C} - \Lambda_{\tau}) \times \mathcal{H}$:

where it was noted $\sum_{n=1}^{\infty}$ n,m $=$ \sum $(m,n) \in \mathbb{Z}^2$ $(m,n)\neq(0,0)$

- Poles and zeros

The zeros of $z \mapsto \gamma(z, \tau)$ are not simply locatable, this is essentially due to the dissymmetric processing of the $z = 0$ pole.

The second order poles of γ are exactly on the lattice Λ_{τ} .

- Fourier's representations

For $z = \alpha + \beta \tau$, $(\alpha, \beta) \in \mathbb{R}^2$,

The terms c_{τ} and d_{τ} depend only on τ and check $c_{\tau} - d_{\tau} = -\frac{2}{\pi^2 \tau}$. Both representations enable one to reconstitute $\forall (z, \tau)$ for $(z, \tau) \in (\mathbb{C} - \Lambda_{\tau}) \times \mathcal{H}$ by periodicity.

Moreover, Euler's equality

- Factorization

Ignorance of the location of the zeros of γ does not provide a pleasant factorized representation of this function.

 \bullet The $\widetilde{\mathsf{Y}}$ function

- Poles and zeros

The second order zeros of $\widetilde{\gamma}$ are located on the lattice Λ_{τ} .

The poles of $\widetilde{\gamma}$, also of order two, are on the translated lattice $\frac{1+\tau}{2} + \Lambda_{\tau}$.

- Fourier's representations

Both representations enable one to reconstitute $\widetilde{\gamma}(z,\tau)$ for $(z,\tau) \in (\mathbb{C} - (\frac{1+\tau}{2} + \Lambda_{\tau})) \times \mathcal{H}$ by periodicity.

In addition, Euler's equality [\(4\)](#page-1-1) coupled with [\(6\)](#page-1-2) gives

\bullet RELATIONSHIP BETWEEN FUNCTIONS $\widetilde{\mathsf{Y}}$ and Y

We will see later, the two functions $\tilde{\gamma}$ and γ lead to modular functions, this aspect is visible on the relations [\(7\)](#page-2-0) and [\(8\)](#page-2-1), for example.

For $tau \in \mathcal{H}$ fixed, knowledge on the poles of γ and $\tilde{\gamma}$ show that $z \mapsto \tilde{\gamma}(z, \tau) - \gamma(z + \frac{1+\tau}{2}, \tau)$ is constant. Liouville's Theorem combined with $\gamma(0, \tau) = 0$ gives the following result.

Lemma I- 1.1.

\widetilde{\gamma}(z,\tau) = \gamma(z + \frac{1+\tau}{2},\tau) - \gamma(\frac{1+\tau}{2},\tau). \tag{11}
$$

To complete this lemma, we try to write γ according to $\tilde{\gamma}$. Specifically, we are going to establish the following equality (which is not found in [\[3\]](#page-28-1))

Lemma I- 1.2. For $\tau \in \mathcal{H}$, we have

\gamma(\frac{1}{2}+\tau,2\tau) = -\frac{1}{3}\left(\widetilde{\gamma}(\frac{1}{2},2\tau) + \widetilde{\gamma}(\tau,2\tau)\right) \in M_2(\Gamma_0(4))\tag{12}
$$

and consequently

\gamma(z,\tau) = \widetilde{\gamma}\left(z + \frac{1+\tau}{2},\tau\right) - \frac{1}{3}\left(\widetilde{\gamma}(\frac{1}{2},\tau) + \widetilde{\gamma}(\frac{\tau}{2},\tau)\right). \tag{13}

Note that this last relationship leads to a partial factorization of $\gamma(z, \tau)$. It also enables one to specify the constants c_{τ} and d_{τ} in the [\(2\)](#page-1-3) and [\(3\)](#page-1-4) equalities.

Proof. The relation (13) is clearly deduced from the equalities (11) and (12) , then the modular character of [\(12\)](#page-2-4) will be established in the following paragraph.

It remains to prove the equality [\(12\)](#page-2-4), we rely for that on the representations [\(5\)](#page-1-5) and [\(9\)](#page-2-5). We find

$$

On the other hand,

2 – The symmetries of $\widetilde{\gamma}$ and γ ; Examples of modular forms

The equalities [\(1\)](#page-1-0), [\(7\)](#page-2-0) and [\(8\)](#page-2-1) for $\widetilde{\gamma}$ and (1) for γ lead to the following elementary symmetries:

\widetilde{\gamma}(z+1,\tau) = \widetilde{\gamma}(z+\tau,\tau) = \widetilde{\gamma}(z,\tau) \qquad \gamma(z+1,\tau) = \gamma(z+\tau,\tau) = \gamma(z,\tau) \n\widetilde{\gamma}(z,\tau+2) = \widetilde{\gamma}(z,\tau) \qquad \gamma(z,\tau+1) = \gamma(z,\tau) \n\widetilde{\gamma}(-z,\tau) = \widetilde{\gamma}(z,\tau) \qquad \gamma(-z,\tau) = \gamma(z,\tau) \n\widetilde{\gamma}(z,-\tau) = \widetilde{\gamma}(z,\tau) \qquad \gamma(z,-\tau) = \gamma(z,\tau)

Let us note two points. For $z \in \mathbb{C}$ fixed, the period of $\gamma(z,.)$ is worth 1, whereas it is worth 2 for $\widetilde{\gamma}(z,.)$. Besides, the last symmetry is correct, but from the point of view of modular forms, we only consider $\tau \in \mathcal{H}$ case. To this is added the inversion symmetry which leads to the modular character:

$$

Now let us show the modularity of some modular forms built with \curlyvee and $\widetilde{\curlyvee}.$

For a given N, we know systems that generate $(\Gamma_0(N), \times)$. A standard result indicates that it is sufficient to verify the (i) condition of definition I-1.3 on such a system to deduct the (i) property in its generality. Similarly, we know how to build a representative system for each of the classes of $\Gamma_0(1)/\Gamma_0(N)$. To show (ii), just check this condition on the equivalency class representatives.

We will give, in this paragraph, examples of modular forms to build explicit bases. In order not to overextend this article, it will not be possible to produce a demonstration of modularity for each of these functions. Nevertheless, we will now show on some examples, how the symmetries of γ and γ lead to demonstrations of modularity. An effective way to verify future and unproven modularity claims is to compare with the $q = e^{2i\pi\tau}$ asymptotic expansion of modular feature bases found, particularly in SAGE software.

• $\gamma(\tau, 2\tau) \in M_2(\Gamma_0(2))$

This result is well known, see [\[2\]](#page-27-0) p. 130 for example

From the relationships [\(6\)](#page-1-2), [\(7\)](#page-2-0) and [\(8\)](#page-2-1), the conditions of definition I-1.3 are easy to verify except the condition (i) for the non-trivial generator of $\Gamma_0(2)$, $\begin{pmatrix} 1 & 0 \\ 2 & 1 \end{pmatrix}$.

The cusps behavior of a function Φ is processed using a system of class representatives of $\Gamma_0(1)/\Gamma_0(2)$ given by SAGE:

\begin{pmatrix} 1 & 0 \ 0 & 1 \end{pmatrix}, \begin{pmatrix} 0 & -1 \ 1 & 0 \end{pmatrix} \text{ et } \begin{pmatrix} 1 & 0 \ 1 & 1 \end{pmatrix}.

For such a matrix it is necessary to show that $\tau \mapsto (c\tau+d)^{-2}\Phi\left(\frac{a\tau+b}{c\tau+d}\right)$) admits a limit when τ tends towards i ∞ and this is clear on the representation of Weierstrass given in [\(1\)](#page-1-0).

Let us pose $\Phi(\tau) = \gamma(\tau, 2\tau)$ and check the modularity relationship for γ by applying the inversion twice:

Relationships [\(6\)](#page-1-2) and [\(7\)](#page-2-0) give immediately for $\in \mathcal{H}$:

\Phi(\tau) = \widetilde{\gamma}(\frac{1}{2}, 2\tau) = \frac{1}{\pi^2} \sum_{\substack{(n,m) \in \mathbb{Z}^2}} \frac{1}{(n + (2m+1)\tau)^2} - \frac{1}{((n+\frac{1}{2}) + (2m+1)\tau)^2}

= -8i \sum_{n=1}^{+\infty} \frac{2n+1}{\sin(2(2n+1)\pi\tau)}.

Similarly, the conditions in definition I-1.3 are easy to establish except the (i) condition for the nontrivial generator $\gamma =$ $\begin{pmatrix} 1 & 0 \\ 4 & 1 \end{pmatrix}$, and possibly the cusps behavior.

Let us check the modularity relationship for γ by applying the inversion twice:

\Phi\left(\frac{\tau}{4\tau+1}\right) = \widetilde{\gamma}\left(\frac{1}{2}, \frac{2\tau}{4\tau+1}\right)
$$

= \left(\frac{4\tau+1}{2\tau}\right)^2 \widetilde{\gamma}\left(\frac{1}{2}\frac{4\tau+1}{2\tau}, -\frac{4\tau+1}{2\tau}\right)

For the study at cusps of a function Φ , we use the system of class representatives of $\Gamma_0(1)/\Gamma_0(4)$ given by SAGE:

\begin{pmatrix} 1 & 0 \ 0 & 1 \end{pmatrix}, \begin{pmatrix} 0 & -1 \ 1 & 0 \end{pmatrix}, \begin{pmatrix} 1 & 0 \ 1 & 1 \end{pmatrix}, \begin{pmatrix} 0 & -1 \ 1 & 2 \end{pmatrix}, \begin{pmatrix} 0 & -1 \ 1 & 3 \end{pmatrix}, \begin{pmatrix} 1 & 0 \ 2 & 1 \end{pmatrix}.
$$

For these matrices, the existence of a limit for $\tau \mapsto (c\tau+d)^{-2}\Phi\left(\frac{a\tau+b}{c\tau+d}\right)$) when τ tends towards $i\infty$ is clear on the Weierstrass representation given in [\(17\)](#page-4-0).

• $\widetilde{\gamma}(\tau, 2\tau) \in M_2(\Gamma_0(4))$

Using (6) but also (8) we get:

\Phi(\tau) = \tilde{\gamma}(\tau, 2\tau) = \frac{1}{\pi^2} \sum_{\substack{(n,m) \in \mathbb{Z}^2}} \frac{1}{((n + \frac{1}{2}) + 2m\tau)^2} - \frac{1}{((n + \frac{1}{2}) + (2m + 1)\tau)^2}
$$
\n

= \frac{2i}{\tau^2} \sum_{n=1}^{+\infty} \frac{n}{\sin(n\pi/\tau)}.
$$

Again, the conditions of definition I-1.3 are easy to establish except the (i) condition for the non-trivial generator of $\Gamma_0(4)$, $A =$ $\begin{pmatrix} 1 & 0 \\ 4 & 1 \end{pmatrix}$. Cusps behavior is treated as above thanks to the Weierstrass form of [\(19\)](#page-5-0) relationships.

• $\widetilde{\gamma}(\tau, 2\tau)^2 \in M_4(\Gamma_0(2))$

Let us pose $\Phi(\tau) = (\tau, 2\tau)$. Based on the previous case, $\Psi = \Phi^2 \in M_4(\Gamma_0(4))$ and we want to show better: $\Psi \in M_4(\Gamma_0(2)).$

Again, the conditions of definition I-1.3 are easy to establish except the (i) condition for the non-trivial generator of $\Gamma_0(2)$, $A = \begin{pmatrix} 1 & 0 & 2 & 1 \end{pmatrix}$. Cusps behavior is treated as above thanks to the Ψ Weierstrass representation.

In order to check the modularity Ψ under the action of A, let us notice the equality $\widetilde{\gamma}(\frac{1}{2}, \tau - 1) =$ $-\check{\gamma}(\frac{1}{2},\tau)$) which is an immediate consequence of [\(7\)](#page-2-0).

The result can be deduced from this.

This is the [\(12\)](#page-2-4) relationship already established and which is also a modular equality, here is why. First, we check that $M_2(\Gamma_0(4))$ belongs to the space by checking the only non-trivial condition: $\Phi\left(\frac{\tau}{4\tau+1}\right) = (4\tau+1)^2 \Phi(\tau).$

Besides, $\tilde{\gamma}(\tau, 2\tau)$ and $\tilde{\gamma}(\frac{1}{2}, 2\tau)$ are two elements of the two dimensional space $M_2(\Gamma_0(4))$. The [\(17\)](#page-4-0) and [\(16\)](#page-4-1) relationships enable one to write:

As a result $\gamma(\frac{1}{2})$ $\frac{1}{2} + \tau, 2\tau$) = $-\frac{1}{3}$ $\frac{1}{3}(1-24q+24q^2+O(q^3))$ is an element of $M_4(\Gamma_0(2))$ and the relationship [\(12\)](#page-2-4) is the expression of $\sqrt{\frac{1}{2}}$ $\frac{1}{2} + \tau$, 2τ) in the previous basis.

This function is particularly interesting since it will be, with a multiplicative constant, Δ_2 . The relationships [\(6\)](#page-1-2) and [\(7\)](#page-2-0) give:

The Φ function is clearly 1-periodic, it remains to check the modular relationship Φ $\left(\frac{\tau}{4\tau+1}\right) = (4\tau +$ $1)^2\Phi(\tau)$:

This check suggests that the root of Δ_2 could be a modular form, but in fact not: the function γ $\sqrt{1}$ $\left(\frac{1}{2},\tau\right)$ is 2-periodic but not 1-periodic as we can easily see on its representations.

3 – Determination of an element $E_{2,N}^{(0)}$ $_{2,N}$

Part I Theorem I-5.2 noted the existence of a 0 valuation element in $M_2(\Gamma_0(p))$ and its importance in the algorithmic description of spaces $(M_{2k}(\Gamma_0(p)))_{k\in\mathbb{N}^*}$ for $N\geq 2$. The proposed demonstration was based on Eisenstein's E_2 series. We will give a different demonstration here and provide an explicit form for an $E_{2,N}^{(0)}$ element.

Theorem I-3.1. Either $N \in \mathbb{N}^*$, then the function defined by

is an element of $M_2(\Gamma_0(N))$ unitary with valuation 0.

Proof. According to the [\(5\)](#page-1-5) relationship, Φ_N is 1-periodic and

The existence of a limit in any cusp results from [\(1\)](#page-1-0), it remains to study the action of $\Gamma_0(N)$ on Φ_N .

We also know that $ad - c'Nb = 1$, and therefore $r_k \neq 0$ and even $\{r_k, 1 \leq k \leq N - 1\} = \{1, \ldots, N - 1\}$ because \overline{a} is invertible in Z/NZ . You can also write: for $r \in [1, N-1]$ there is a single $(v_r, k_r) \in \mathbb{Z} \times [1, N-1]$ such that $r = v_r N + a k_r$. By reordering,

Theorem I- 3.2. Either $N \geq 1$, we have the representation of Fourier

Note that we can provide a more numerically efficient version of Φ_N by remembering that $z \mapsto \gamma(z, N\tau)$ is an elliptic function of periods 1 and N τ . Therefore, for $k \in [1, N-1], \forall (k\tau, N\tau) = \forall ((N-k)\tau, N\tau)$. Thus, according to the parity of N:

Using the ratings from Part I for generic bases $\mathcal{B}_{2k}(\Gamma_0(N)) = (E_{2k,N}^{(s)})_{0 \leq s \leq d_{2k}(N)-1}$, we can choose: Corollary I- 3.1.

To finish this paragraph, and without any demonstration, we note that [\(25\)](#page-7-0) is an access point to a much more general toolbox.

If $P \in \mathbb{C}[X_1,\ldots,X_{N-1}]$ is a homogeneous symmetric polynomial of k degree, then the application

is an element of $M_{2k}(\Gamma_0(N))$. This process will be used in the $N = 7$ case.

Just check that for everything $k \in \mathbb{N}^*, \tau \mapsto$ \sum^{N-1} $n=1$ $\bigl\langle (n\tau,N\tau)^k \bigr\rangle$ belongs to $M_{2k}(\Gamma_0(N)),$ thanks to Newton's formulae on symmetric polynomials.

$4 \quad - \text{Structure and bases of } (M_{2k}(\Gamma_0(N)))_{k \in \mathbb{N}^*}, \ 1 \leqslant N \leqslant 10$

In this paragraph, we are trying to determine explicit unitary upper triangular bases for all spaces $(M_{2k}(\Gamma_0(N)))_{k\in\mathbb{N}^*}$, $1 \leqslant N \leqslant 10$. By explicit, we mean representable using η -products or elliptic functions γ and γ , which naturally provides other representations allowing serial Fourier development at any order.

Using the notations from part I, $d_{2k}(N)$ is the dimension of $M_{2k}(\Gamma_0(N))$, and by $\mathcal{B}_{2k}(\Gamma_0(N)) =$ $(E_{2k,N}^{(s)})_{0\leqslant s\leqslant d_{2k}(N)-1}$ a $M_{2k}(\Gamma_0(N))$ unitary upper triangular basis. Such a basis exists but is not unique, unlike the strictly increasing sequence of valuations $(\nu(E_{2k,N}^{(s)}))_{0 \leqslant s \leqslant d_{2k}(N)-1}$.

Theorem I-7.3 in the first part indicates that bases for spaces $(M_{2k}(\Gamma_0(N)))_{k\geq \frac{1}{2}\rho_N+1}$ are calculable as soon as we know bases $(\mathcal{B}_{2k}(\Gamma_0(N)))_{k \leq \frac{1}{2}\rho_N}$ as well as $(E_{\rho_N+2,N}^{(s)})_{0 \leq s \leq \nu(\Delta(N))-1}$, the beginning of a $\mathcal{B}_{\rho_N+2}(\Gamma_0(N))$ basis.

When $d_{\rho_N}(N) = \nu(\Delta_N) + 1$, and it will be the case for $1 \le N \le 10$, it is enough to know $(\mathcal{B}_{2k}(\Gamma_0(N)))_{k\leqslant \frac{1}{2}\rho_N}$. We can indeed choose $E_{\rho_N+2,N}^{(s)} = E_{\rho_N,N}^{(s)} E_{2,N}^{(0)}$ for $0 \leqslant s \leqslant \nu(\Delta_N) - 1$.

Theorem I-7.3 then takes the following form:

Theorem I- 4.1. Let N be a positive integer such as $d_{\rho_N}(N) = \nu(\Delta_N) + 1$, then

\forall k \geq \frac{\rho_N}{2}, \quad M_{2k}(\Gamma_0(N)) = \Delta_N.M_{2k-\rho_N}(\Gamma_0(N)) \oplus Vect \Big(E_{\rho_N,N}^{(s)}[E_{2,N}^{(0)}]^{k-\frac{\rho_N}{2}} \ / \ 0 \leq s < \nu(\Delta_N) \Big). \tag{39}

Therefore, if $k \in \mathbb{N}^*$ and $k = q \frac{\rho_N}{2} + r$ with $1 \leqslant r \leqslant \frac{\rho_N}{2}$,

The characteristic value $N = 11$ is the first for which $d_{\rho_N}(N) < \nu(\rho_N) + 1$, and in this case we must of course apply Theorem I-7.3. Note that, quickly, the hypothesis $d_{\rho_N}(N) = \nu(\rho_N)+1$ becomes systematically false.

4.1 – Structure and bases of $(M_{2k}(\Gamma_0(1)))_{k\in\mathbb{N}^*}$

The $N = 1$ case is well known [\[14,](#page-28-3) [15,](#page-28-4) [11\]](#page-28-5), it differs from the generic $N \ge 2$ case because $M_2(\Gamma_0(1)) =$ {0}. The strong modular unit is the modular discriminant $\Delta_1(\tau) = \Delta(\tau) = \eta(\tau)^{24}$, the first space dimensions table is the following:

2k 2 4 6 8 10 12 14 16 d2k(1) 0 1 1 1 1 2 1 2

We have classically

$$
\forall k \geq 7, \quad M_{2k}(\Gamma_0(1)) = Vect(E_{2k,1}^{(0)}) \oplus \Delta . M_{2k-12}(\Gamma_0(1)).
$$

As for the bases, the reference result built on the Eisenstein series (see [\[15\]](#page-28-4), for example) is: the space $M_{2k}(\Gamma_0(1))$ is based on the family of $E_4^a E_6^b$, with $(a, b) \in \mathbb{N}^2$ such that $2a + 3b = k$. However, this basis is not upper triangular, all these elements are of zero valuation.

The results of Theorem II[-4.1](#page-10-0) enable one recursively constructing unitary upper triangular bases, even in the absence of an $E_{2,1}^{(0)}$ element. With the usual notations, you can choose:

because Eisenstein's series are well known and admit various representations. A more economical choice, and in the spirit of Theorem II[-4.1,](#page-10-0) is to ask

Anyway, for $k = 6q + r \geq 2$, $1 \leq r \leq 6$, a $M_{2k}(\Gamma_0(1))$ basis is given by

This is a unitary and upper triangular basis without jump.

In order to be consistent with the announced objectives, equality can be noted

obtained, for example, with the [\(10\)](#page-2-6) factorization of $\widetilde{\gamma}$. We will find representations of E_4 and E_6 depending on $\widetilde{\gamma}$ in paragraph 4.4.

Remember that the $\widetilde{\gamma}$ function systematically leads to modular units (no cancellation on \mathcal{H}), and that this is also the case for products of such functions. Thus, any modular form according to $\Gamma_0(1) = SL_2(\mathbb{Z})$ is a linear combination of modular units.

4.2 – Structure and bases of $(M_{2k}(\Gamma_0(2)))_{k\in\mathbb{N}^*}$

The strong modular unit that structures this set of spaces is:

\Delta_2(\tau) = \eta(2\tau)^{16}\eta(\tau)^{-8} = q \prod_{k=1}^{+\infty} \frac{\left(1 - q^{2k}\right)^{16}}{\left(1 - q^k\right)^8} \in M_4(\Gamma_0(2)).\tag{42}
$$

From the $\widetilde{\gamma}$ factorization, we deduct:

Before we continue, let us note one important point. The zeros of $z \mapsto \widetilde{\gamma}(z, \tau)$ are on the lattice Λ_{τ} and $\frac{1}{2}$ is never on this lattice. This remark spreads easily, and explains why γ is a good tool to obtain modular units (not necessarily strong because one does not control the behavior at the cusps).

Let us remind the first values of $d_{2k}(2)$:

We established the [\(16\)](#page-4-1) relationship earlier, $\gamma(\tau, 2\tau) \in M_2(\Gamma_0(2))$, and we set:

We can apply Theorem II- [4.1](#page-10-0) with $\nu(\Delta_2) = 1$:

We choose $E_{2k,2}^{(0)} = [E_{2,2}^{(0)}]^k$, and we deduct a $M_{2k}(\Gamma_0(2))$ unitary upper triangular basis:

Finally, we see that the products of the two modular forms $\tilde{\gamma}(\tau, 2\tau) - 2\tilde{\gamma}(\frac{1}{2}, 2\tau)$ and $\tilde{\gamma}(\frac{1}{2}, \tau)^2$ generate, by linear combinations of homogeneous weights, all modular forms according to $\Gamma_0(2)$... And therefore also according to $\Gamma_0(1) = SL_2(\mathbb{Z})$.

We could check, for example, the equalities for the Eisenstein series E_4 :

The strong modular unit Δ_3 that structures this set of spaces is defined as follows:

We can choose $E_{4,3}^{(0)} = [E_{2,3}^{(0)}]^2 \in M_4(\Gamma_0(3)).$

 \star The element $E_{4,3}^{(0)}$: $E^{(0)}_{4,3}(\tau) = 9\gamma(\tau,3\tau)^2$ $= 1 + 24q + 216q^2 + 888q^3 + 1752q^4 + O(q^5)$

In addition, the Eisenstein series $E_4(3\tau)$ is also a unitary element of $M_4(\Gamma_0(3))$, with null valuation and not colinear at $E_{4,3}^{(0)}$. By subtraction,

4.4 – Structure and bases of $(M_{2k}(\Gamma_0(4)))_{k\in\mathbb{N}^*}$

The modular form that structures this set of spaces is Δ_4 defined as follows:

\Delta_4(\tau) = \eta(4\tau)^8 \eta(2\tau)^{-4} = -\frac{1}{16} \widetilde{\gamma}(\frac{1}{2}, 2\tau) = q \prod_{k=1}^{+\infty} \frac{(1 - q^{4n})^8}{(1 - q^{2n})^4} \in M_2(\Gamma_0(4)).
$$

This time Δ_4 belongs to $M_2(\Gamma_0(4))$, which gives a very simple structure for the level 4 spaces of which here is the first dimensions table.

• $M_2(\Gamma_0(4))$

There is a lot of choices for $E_{2,4}^{(0)}$: $E_{2,2}^{(0)}$, $\widetilde{\gamma}(\tau,2\tau)$, $\gamma(\tau,4\tau)$, the Eisentein E_4 series and others... This time we choose $\widetilde{\gamma}(\tau, 2\tau)$ for consistency with Δ_4 . Of course, we must have $E_{2,4}^{(1)} = \Delta_4$.

Consequently, Eisenstein series are written in this form, as well as all modular forms according to $\Gamma_0(1)$. Also, since these two modular forms are *η*-products, we find that the level 1 modular forms are linear combinations of η -products.

When we compare the early terms of the asymptotic expansions, we find representations other than [\(45\)](#page-12-0):

This time Δ_5 belongs to $M_4(\Gamma_0(5))$, so it is necessary to explain $M_2(\Gamma_0(5))$ and $M_4(\Gamma_0(5))$ bases. The table of the dimensions of the first spaces:

There is a begining for a unitary upper triangular basic: $([E_{2,7}^{(0)}]^3, E_{2,7}^{(0)}E_{4,7}^{(1)}, E_{2,7}^{(0)}E_{4,7}^{(2)}).$ The function Δ_7 is valuation 4, there is a 3 valuation item missing. To get it we can notice that E_6 is in $M_6(\Gamma_0(7))$ (just like $E_2(3\tau)$ by the way) and work by linear combinations.

We will rather introduce here a generic process outlined in $N = 4$ case: the homogeneous symmetrical polynomials of degree 3 in $(\gamma(k\tau, 7\tau))_{1 \leq k \leq 6}$, and by symmetry those of $(\gamma(k\tau, 7\tau))_{1 \leq k \leq 3}$, are elements of $M_6(\Gamma_0(7))$.

The structure here is very simple since $\Delta_8(\tau) = \Delta_4(2\tau) \in M_2(\Gamma_0(8)).$

As in $N = 4$ case, it is possible to find a $M_2(\Gamma_0(8))$ basis consisting of modular units (strong for Δ_8).

\star \text{ The element } E_{2k,9}^{(1)}: \\
E_{2k,9}^{(1)} = E_{2,9}^{(1)} [E_{2,9}^{(0)}]^{k-1}
$$

Then we get a $M_{2k}(\Gamma_0(9))$ basis:

$$
\mathcal{B}_{2k}(\Gamma_0(9)) = \left([E_{2,9}^{(0)}]^a \cdot \Delta_9^b, (a, b) \in \mathbb{N}^2 / a+b=k \right) \cup \left([E_{2,9}^{(1)} \cdot [E_{2,9}^{(0)}]^a \cdot \Delta_8^b, (a, b) \in \mathbb{N}^2 / a+b=k-1 \right)
$$

4.10 – Structure and bases of $(M_{2k}(\Gamma_0(10)))_{k \in \mathbb{N}^*}$

The modular form that structures this set of spaces is Δ_{10} defined by:

$$
\Delta_{10}(\tau) = \eta(\tau)^2 \eta(2\tau)^{-4} \eta(5\tau)^{-10} \eta(10\tau)^{20} = q^6 \prod_{k=0}^{+\infty} \frac{(1-q^n)^2 (1-q^{10n})^{20}}{(1-q^{2n})^4 (1-q^{5n})^{10}} \in M_4(\Gamma_0(10)).
$$

Let us remind the first values of $d_{2k}(10)$:

2k 2 4 6 8 10 12 14 16 d²k(10) 3 7 9 13 15 19 21 25

• $M_2(\Gamma_0(10))$

From $M_2(\Gamma_0(2))$ and $M_2(\Gamma_0(5))$ bases, we find the following elements:

(i) $\gamma(\tau, 2\tau) = -\frac{1}{2}$ $\frac{1}{3}(1+24q+24q^2+96q^3+24q^4+144q^5+O(q^6))$

(ii)
$$
\gamma(5\tau, 10\tau) = -\frac{1}{3}(1 + 24q^5 + 24q^{10} + O(q^{15}))
$$

(iii)
$$
\gamma(\tau, 5\tau) - \gamma(2\tau, 5\tau) = -\frac{2}{3}(1 + 6q + 18q^2 + 24q^3 + 42q^4 + 6q^5 + O(q^6))
$$

(iv)
$$
\sum_{k=1}^{4} \gamma(k\tau, 10\tau) = -\frac{4}{3}(1 + 3q + 9q^2 + 12q^3 + 21q^4 + 15q^5 + O(q^6))
$$

These functions are linked by the relationship $2(ii) + (iii) - (iv) = 0$. The following unitary upper triangular basis is derived.

$$
\star \text{ The element } E_{2,10}^{(0)}:E_{2,10}^{(0)}(\tau) = -3\gamma(5\tau, 10\tau)= 1 + 24q^5 + 24q^{10} + O(q^{15})
$$

 \star The element $E_{2,10}^{(1)}$: $E_{2,10}^{(1)}(\tau) = -\frac{1}{8}$ $\frac{1}{8}(\gamma(\tau, 2\tau) - \gamma(5\tau, 10\tau))$ $= q + q^2 + 4q^3 + q^4 + 5q^5 + 4q^6 + 8q^7 + O(q^8)$ \star The element $E_{2,10}^{(2)}$:

$$
E_{2,10}^{(2)}(\tau) = \frac{1}{16}(\gamma(\tau, 2\tau) - 2\gamma(\tau, 5\tau) - 2\gamma(2\tau, 5\tau) + 3\gamma(5\tau, 10\tau))
$$

= $q^2 + 3q^4 - 4q^5 + 4q^6 + O(q^8)$

• $M_4(\Gamma_0(10))$

The form Δ_{10} and the products of two elements of $M_2(\Gamma_0(10))$ provide elements for a $M_4(\Gamma_0(10))$ unitary upper triangular basis. Just missing a 5 valuation element to complete the basis.

We know that the Eisenstein series $E_4(5\tau)$ is in $M_4(\Gamma_0(10))$, but it is a linear combination of the elements $(E_{4,10}^{(k)})_{0 \leq k \leq 4}$ and therefore does not bring the element $E_{4,10}^{(5)}$ sought.

We can also think of $\Delta_5(2\tau) \in M_4(\Gamma_0(10))$. It is a 4 valuation term but it is also a linear combination of $(E_{4,10}^{(k)})_{0 \leq k \leq 4}$.

Finally, the last "natural" candidate who completes $\Delta_2(5\tau)$ basis, necessarily in $M_4(\Gamma_0(10))$ with valuation 5.

- \star The element $E_{4,10}^{(0)}$: $E^{(0)}_{4,10}(\tau) \quad = \quad [E^{(0)}_{2,10}(\tau)]^2$ $= 1 + 48 q^{5} + 624 q^{10} + O(q^{15})$ \star The element $E_{4,10}^{(1)}$: $E^{(1)}_{4,10}(\tau) \quad = \quad E^{(0)}_{2,10}(\tau) E^{(1)}_{2,10}(\tau)$ $= q + q^2 + 4q^3 + q^4 + 5q^5 + 28q^6 + 32q^7 + O(q^8)$ \star The element $E_{4,10}^{(2)}$: $E^{(2)}_{4,10}(\tau) = E^{(0)}_{2,10}(\tau) E^{(2)}_{2,10}(\tau)$ $= q² + 3 q⁴ - 4 q⁵ + 4 q⁶ + 24 q⁷ + O(q⁸)$ \star The element $E_{4,10}^{(3)}$: $E^{(3)}_{4,10}(\tau) \quad = \quad E^{(1)}_{2,10}(\tau) E^{(2)}_{2,10}(\tau)$ $= q^{3} + q^{4} + 7 q^{5} + 17 q^{7} + O(q^{8})$ \star The element $E_{4,10}^{(4)}$: $E^{(4)}_{4,10}(\tau) = [E^{(2)}_{2,10}(\tau)]^2$ $= q^4 + 6 q^6 - 8 q^7 + O(q^8)$ \star The element $E_{4,10}^{(5)}$: $E^{(5)}_{4,10}(\tau) = \Delta_2(5\tau)$ $=$ $\frac{1}{25}$ $\frac{1}{256}\widetilde{\gamma}(\frac{1}{2}%)^{2}+2\widetilde{\gamma}(\frac{1}{2})^{2}$ $(\frac{1}{2}, 5\tau)^2$ $= \overline{q^5 + 8q^{10} + 28q^{15} + O(q^{20})}$
- \star The element $E_{4,10}^{(6)}$:

$$
E_{4,10}^{(6)}(\tau) = \Delta_{10}(\tau)
$$

= $\eta(\tau)^2 \eta(2\tau)^{-4} \eta(5\tau)^{-10} \eta(10\tau)^{20}$
= $q^6 - 2q^7 + 3q^8 - 6q^9 + O(q^{10})$

• The general $M_{2k}(\Gamma_0(10))$ case

We have the equality from Theorem II[-4.1:](#page-10-0)

$$
\forall k \geqslant 3, \quad M_{2k}(\Gamma_0(10)) = Vect((E_{2k,10}^{(r)})_{0 \leqslant r \leqslant 5}) \oplus \Delta_{10} . M_{2k-4}(\Gamma_0(10)).
$$

For $k \geq 3$, you can choose the first six elements of a $M_{2k}(\Gamma_0(10))$ unitary upper triangular basis as follows:

- \star The element $E_{2k,10}^{(0)}$: $E_{2k,10}^{(0)} = E_{4,10}^{(0)}$] $[E_{2,10}^{(0)}]^{k-2} = [E_{2,10}^{(0)}]^{k}$
- \star The element $E_{2k,10}^{(1)}$: $E_{2k,10}^{(1)} = [E_{4,10}^{(1)}][E_{2,10}^{(0)}]^{k-2}$
- \star The element $E_{2k,10}^{(2)}$: $E_{2k,10}^{(1)}=[E_{4,10}^{(2)}][E_{2,10}^{(0)}]^{k-2}$
- \star The element $E_{2k,10}^{(3)}$: $E_{2k,10}^{(1)} = [E_{4,10}^{(3)}][E_{2,10}^{(0)}]^{k-2}$
- \star The element $E_{2k,10}^{(4)}$: $E_{2k,10}^{(1)} = [E_{4,10}^{(4)}][E_{2,10}^{(0)}]^{k-2}$
- \star The element $E_{2k,10}^{(5)}$: $E_{2k,10}^{(5)} = [E_{4,10}^{(5)}][E_{2,10}^{(0)}]^{k-2}$

We then obtain a $M_{2k}(\Gamma_0(10))$ basis as follows.

We put $\mathcal{B}_2(\Gamma_0(10)) = (E_{2,10}(r))_{0 \le r \le 2}$ and $\mathcal{B}_4(\Gamma_0(10)) = (E_{4,10}^{(r)})_{0 \le r \le 6}$.

For $k \in \mathbb{N}^*$, by posing $k = 2q + r$, $r \in \{1, 2\}$:

$$
\mathcal{B}_{2k}(\Gamma_0(10)) = \Delta_{10}^q \mathcal{B}_{2r}(\Gamma_0(10)) \cup \bigcup_{i=0}^5 \left(E_{4,10}^{(i)} \cdot [E_{2,10}^{(0)}]^a \cdot \Delta_{10}^b, (a,b) \in \mathbb{N}^2 / a + 2b = k - 2 \right).
$$

5 – Conclusion

Essentially thanks to the introduction of the notion of strong modular unit, we were able to identify, in part I of this article [\[4\]](#page-28-0), the theoretical tools allowing one to structure the family of modular spaces $(M_{2k}(\Gamma_0(N)))_{k\in\mathbb{N}^*}$ and to obtain unitary upper triangular bases of them. These results were applied to every values $1 \le N \le 10$.

Although not all modularity proofs of the proposed functions are provided, this would produce a document as indigestible as it is voluminous, these have been done carefully for strong modular units in the first part of this article [\[4\]](#page-28-0). The modularity of other frequently appearing modular functions has also been verified, in particular thanks to the properties of the Weierstrass functions γ and $\tilde{\gamma}$ studied in [\[3\]](#page-28-1).

These two elliptic functions were chosen γ and $\widetilde{\gamma}$ for several reasons.

- (i) The γ function is the elliptic Weierstrass function, while $\widetilde{\gamma}$ is derived by renormalization. Both functions have an inversion symmetry that is almost immediately modular in character.
- (ii) Thanks to the lemmas [11](#page-2-3) and [13,](#page-2-2) one of the two functions γ or $\tilde{\gamma}$ would have been enough to represent the bases of modular forms, but the formulations would have been heavier.
- (iii) For the modularity according to the congruence group $\Gamma_0(N)$, $1 \le N \le 10$, and apart from the strong modular units represented in $[4]$ in the form of η -products, these functions are sufficient to represent all the modular functions involved in this article.

This last point is important. The γ and $\tilde{\gamma}$ functions naturally produce modular functions of weight 2, then even weight per extension. If the congruence group enabled one access to odd degree modular spaces, for example $\Gamma_1(N)$, we would have chosen to represent the modular forms using Jacobi's elliptic functions, in particular SD, or even [\[3\]](#page-28-1). The functions γ and γ being themselves linked to Jacobi's functions, in particular $-\frac{1}{16}\tilde{\gamma}(z,\tau) = SD(z,\tau)^2$.

Other choices are possible to represent modular forms. In particular, for $k \in \mathbb{N}^*$, $\frac{\partial^{2k} \gamma}{\partial x^k}$ $\frac{\partial}{\partial^{2k}z}(z,\tau) =$ $\partial^{2k} \gamma$ $\frac{\partial^2 f}{\partial x^2}$ (z, τ) naturally produces modular forms of weight $2k + 2$.

We will have noted that the exceptional Eisenstein series $E_{2,2}^{(0)}M_2(\Gamma_0(2))$ appears here naturally since $E_{2,2}^{(0)}(\tau) = -3\gamma(\tau,2\tau)$, and it is well known that, the Eisenstein series E_{2k+2} is exactly $\frac{\partial^{(2k)}\gamma}{\partial^{(2k)}\gamma}$ $\frac{1}{\partial (2k)z}(\tau,2\tau).$ The use of the derivation would have given greater clarity to the elements of the proposed bases, but the essential tools should have been expanded. Now the modular functions form a dense maquis in which it is better to have a good compass!

To close this second part of the article, I would like to acknowledge the exceptional work of the team in charge of the development of the SAGE module concerning modular functions. Many ideas have come from an interaction between theory and this powerful tool. And this, either to confirm an intuition or to guide towards the solution when the initial idea proved erroneous. Finally, this tool was a constant help to verify that a function was indeed in the expected modular space: a simple confrontation of the development in Fourier series with a unitary upper triangular basis of the modular space giving the answer in an almost certain way. In return, this work provides high performance algorithms for the calculation of high weight modular forms.

For example, a modular form according to $\Gamma_0(10)$ with weight and valuation 2018 is given by:

$$
E_{2018,10}^{(2018)} = E_{4,10}^{(i)} [E_{2,10}^{(0)}]^a [\Delta_{10}]^b
$$
 avec $a + 2b = 1007$ et $i + 6b = 2018$, $0 \le i \le 5$.

It comes $a = 335$, $b = 336$ and $i = 2$ for an almost immediate result on a personal computer:

$$
E_{2018,10}^{(2018)} = q^{2018} - 672 q^{2019} + 226131 q^{2020} - 50806116 q^{2021} + 8574211132 q^{2022} - 1159385836896 q^{2023} + 130843082948319 q^{2024} - 12676560614152160 q^{2025} + 1076314597159060977 q^{2026} - 81359425707034726432 q^{2027} + O(q^{2028})
$$
