STABILITY OF ASAI LOCAL FACTORS FOR $GL(2)$

ABSTRACT. For a quadratic extension E/F of non-archimedean local fields of characteristic not equal to 2, we prove the stability of Asai local factors attached to irreducible admissible representations of *GL*(2*, E*) via the Rankin-Selberg method. Our strategy is to compute the associated zeta integrals using certain special Whittaker functions called Howe Whittaker functions which are also partial Bessel functions.

1. **Introduction and statement of the main result**

Let $G = GL_2$ and let *F* be a non-archimedean local field whose char(*F*) \neq 2. Let *q* denote the cardinality of the residue field. Let E be a quadratic extension of F and let θ denote the non-trivial Galois automorphism of E over F . We consider the local Asai γ -factor attached to an irreducible admissible generic representation π of $G(E)$ by the Rankin-Selberg method [\[11,](#page-11-2) [12,](#page-11-3) [16\]](#page-11-4). Let $\gamma_{AS}(s, \pi, \chi, \psi)$ denote this γ -factor, where χ is a character (smooth) of F^{\times} and ψ is a fixed non-trivial character of *F*. If χ_E denotes a character of E^{\times} whose restriction to F^{\times} is χ , then this is in fact the Asai γ -factor attached to the representation $\pi \otimes \chi_E$ of $\mathbf{G}(E)$. By definition, it is independent of the choice of χ_E . In this paper, we prove

Theorem 1.1. Suppose π_1 and π_2 are irreducible admissible generic representations of $GL_2(E)$ having *the same central character. Then there exists an integer N* so that

$$
\gamma_{\rm As}(s,\pi_1,\chi,\psi)=\gamma_{\rm As}(s,\pi_2,\chi,\psi)
$$

for all characters χ *whose conductor* $n(\chi) > N$ *. In other words, the local* γ -factor $\gamma_{AS}(s, \pi, \chi, \psi)$ *is stable for χ sufficiently highly ramified.*

When char(F) = 0, the above theorem follows from [\[6,](#page-11-5) Theorem A] since the stability property for Artin *y*-factors is known [\[10\]](#page-11-6). Their proof is global-to-local where as our proof using the theory of Howe vectors [\[13\]](#page-11-7) is completely local. To the best of our knowledge, this theorem is new in the positive characteristic case. More importantly, our methods can potentially be applied to other situations. (See remark [\(3\)](#page-2-0) below.)

The Rankin-Selberg theory of Asai local factor for GL_n , $n \geq 2$, is a twisted version of the local theory of Rankin-Selberg convolutions [\[23\]](#page-12-0). The stability property of the latter local gamma factor was proved by Jacquet and Shalika in [\[15\]](#page-11-8). Stability, under highly ramified twists, is also known for gamma factors arising from other methods. See [\[8\]](#page-11-9), [\[9\]](#page-11-10) and [\[22\]](#page-12-1) for the Langlands-Shahidi method, [\[20\]](#page-12-2) for the doubling method, and [\[3,](#page-11-11) [7,](#page-11-12) [25\]](#page-12-3) for the Rankin-Selberg method. It plays a central role in (i) proving the existence of Langlands functorial transfers using converse theorems and (ii) comparing local γ -factors arising from disparate methods.

To put things in perspective, let us for now assume π is a, irreducible admissible generic representation of $GL_n(E)$. Besides the Rankin-Selberg Asai γ -factor $\gamma_{As}(s, \pi, \chi, \psi)$ mentioned above, there are two other ways to define the Asai γ -factor for the data (π, χ, ψ) . One is $\gamma_{As}^{(1)}(s, \pi, \chi, \psi)$ defined through the Langlands-Shahidi method $[19, 21]$ $[19, 21]$. If ρ is the *n*-dimensional semi-simple representation of the Deligne-Weil group W'_E attached to π through the local Langlands correspondence, the other is the Artin γ -factor $\gamma_{\text{As}}^{(2)}(s, \pi, \chi, \psi)$ defined via the *tensor induction* of ρ to W'_F (cf. [\[17,](#page-11-13) Section 8]). For convenience, we denote these gamma factors as $\gamma_{\rm As}$, $\gamma_{\rm As}^{(1)}$ and $\gamma_{\rm As}^{(2)}$, respectively, suppressing the underlying parameters. These are conjectured to be the same up to a normalization, in particular, implying stability by virtue of [\[10\]](#page-11-6). However, in practice, to prove a given local gamma factor equals the corresponding Artin gamma factor, the argument is global-to-local and one has to establish the stability property beforehand. (See [\[9\]](#page-11-10), for example.) In contrast, we note that in [\[6\]](#page-11-5), the authors prove that $\gamma_{\rm As} \approx \gamma_{\rm As}^{(2)}$ (equality up to a constant) for GL_2 , independent of any stability property.

Now, we mention some recent developments in the study of Asai gamma factors. The equality $\gamma_{\rm As}^{(1)}$ = $\gamma_{\text{As}}^{(2)}$ has been proved by Shankman [\[22\]](#page-12-1) when *F* is of characteristic 0, and when *F* is of characteristic \bar{p} , this equality is shown in [\[14\]](#page-11-14). On the other hand, if the residual characteristic of *F* is odd and π is supercuspidal, then $\gamma_{\text{As}} \approx \gamma_{\text{As}}^{(1)}$ according to [\[1,](#page-11-15) Theorem 9.29]. In addition, when char(*F*) = 0, this latter theorem has been generalized (using a global method) to any π by Beuzart-Plessis [\[4\]](#page-11-16). Then this combined with $[22]$ implies that, for (π, χ, ψ) as above,

$$
\gamma_{\rm As} \approx \gamma_{\rm As}^{(1)} = \gamma_{\rm As}^{(2)}
$$

in the characteristic zero case.

We now outline the proof of Theorem [1.1.](#page-0-1) It is inspired by the proofs of Baruch [\[3\]](#page-11-11) and Zhang [\[25\]](#page-12-3). Recall the local zeta integral

$$
Z(s, W, \Phi, \chi) = \int_{\mathsf{U}(F)\backslash \mathsf{G}(F)} W(g) \Phi(e_2 g) \chi(\det(g)) |\det(g)|_F^s dg.
$$

Here, *W* lies in the Whittaker model of π , and Φ is a Schwartz-Bruhat function on F^2 . Also, we have \widetilde{W} , the Whittaker function dual to W , which belongs to the Whittaker model of the contragredient representation $\tilde{\pi}$. If $\hat{\Phi}$ denotes the Fourier transform of Φ relative to a fixed additive character ψ of F, then there is the associated dual zeta integral $Z(1-s, \widetilde{W}, \widehat{\Phi}, \chi^{-1})$. The Asai gamma factor $\gamma_{AS}(s, \pi, \chi, \psi)$ is a rational function of q^{-s} satisfying the relation

$$
Z(1-s,\widetilde{W},\widehat{\Phi},\chi^{-1})=\gamma_{\rm As}(s,\pi,\chi,\psi)Z(s,W,\Phi,\chi)
$$

for all pairs (W, Φ) .

For $m \gg 0$ suitably large and an appropriate Φ , we show that $Z(s, W_m, \Phi, \chi)$ is a non-zero constant on *s* and that it only depends on π through its central character. This is done in Proposition [3.2.](#page-7-1) Here, W_m is the Howe Whittaker function as in [\(2.3\)](#page-5-1). However, following [\[26\]](#page-12-6), we use the notation $B_m(g, W)$ to denote $W_m(g)$, since it is also a partial Bessel function in the sense of [\[9\]](#page-11-10). On the other hand, for π_1 and π_2 as in Theorem [1.1,](#page-0-1) let ω denote the restriction of the common central character to F^{\times} . Taking the corresponding Whittaker functions $(W_1)_{m} = W_{1,m}$ and $(W_2)_{m} = W_{2,m}$ in the Whittaker model of π_1 and π_2 , respectively, we show that the the difference $Z(1-s, \widetilde{W}_{1,m}, \widehat{\Phi}, \chi^{-1}) - Z(1-s, \widetilde{W}_{2,m}, \widehat{\Phi}, \chi^{-1})$ (see [3.8\)](#page-10-0)) is

$$
\approx \int\limits_{F^{\times}} [B_m(t(1,a)w,W_1) - B_m(t(1,a)w,W_2)] \chi(a)|a|_F^s d^{\times}a,
$$

where the implied constant depends only on ω , χ , ψ and m . We exploit properties of Howe Whittaker functions to arrive at this equality, particularly Proposition [2.6,](#page-5-2) which controls the support of the function $B_m(\cdot, W_1) - B_m(\cdot, W_2)$ away from the identity.

At this point, it should be noted that our choice of m in the above expression depends on $n(\chi)$. But it turns out that for sufficiently large *m* the function $a \mapsto B_m(t(1, a)w, W_1) - B_m(t(1, a)w, W_2)$ is uniformly smooth, meaning, independent of *m*. This once again follows from properties of the functions W_m . This means that the above integral is zero for sufficiently highly ramified χ concluding the proof of our theorem. This is all explained in Section [3.](#page-7-0) We also summarize the required properties of W_m in Subsection [2.1.](#page-3-1)

We conclude this introduction with the following remarks.

(1) The Asai gamma factor $\gamma_{As}(s, \pi, \chi, \psi)$ may also be defined when π is non-generic using Langlands classification. In particular, any non-generic representation π of $GL_2(E)$ is of the form $\pi = \eta_E$ odet for some character η_E of E^\times and may be realized as the Langlands quotient of the (normalized) induced representation $I = I(\eta_E | \cdot |E^{1/2})$ $_{E}^{1/2}, \eta_{E}|\cdot|_{E}^{-1/2}$ $\bar{E}^{1/2}$). Then it follows from the proof of [\[6,](#page-11-5) Theorem 2.1] that

$$
\gamma_{\rm As}(s,\pi,\chi,\psi)=\gamma(s+1,\eta\chi,\psi)\gamma(s-1,\eta\chi,\psi)\gamma(s,\eta_E\chi_E\eta_E^\theta\chi_E^\theta,\psi_E),
$$

where the factors on the right are Tate γ -factors and the character ψ_E of *E* is as defined in Section [2.2.](#page-5-0) But the stability of Tate γ -factors is well-known (cf. [\[5,](#page-11-17) Section 23.8]) and it follows from this that $\gamma_{\text{As}}(s, \pi, \chi, \psi)$ is stable for highly ramified χ . Thus we may allow nongeneric representations in the statement of Theorem [1.1.](#page-0-1)

(2) Suppose $L_{\text{As}}(s, \pi, \chi)$ and $\epsilon_{\text{As}}(s, \pi, \chi, \psi)$ are the corresponding Asai *L* and ϵ -factors satisfying the relation

$$
\epsilon_{\text{As}}(s,\pi,\chi,\psi) = \gamma_{\text{As}}(s,\pi,\chi,\psi) \frac{L_{\text{As}}(s,\pi,\chi)}{L_{\text{As}}(1-s,\widetilde{\pi},\chi^{-1})}.
$$

One can show that $L_{\text{As}}(s, \pi, \chi) \equiv 1$ for sufficiently highly ramified χ as in [\[15,](#page-11-8) Proposition 5.1]. Hence it follows, for π_1 , π_2 as in Theorem [1.1,](#page-0-1) that

$$
\epsilon_{\rm As}(s, \pi_1, \chi, \psi) = \epsilon_{\rm As}(s, \pi_2, \chi, \psi)
$$

for all sufficiently highly ramified χ .

(3) We hope to generalize our method to prove the stability of the Rankin-Selberg Asai, Sym² and \wedge^2 gamma factors for GL_n. This appears to be a non-trivial problem – the main obstacle being the analogue of Proposition [2.6](#page-5-2) for GL_n (see [\[2,](#page-11-18) Lemma 6.2.2]) which introduces other relevant

Weyl elements, besides the identity and the long element, in the analysis of the partial Bessel function $B_m(\cdot, W_1 - W_2)$. We speculate the techniques of [\[9\]](#page-11-10) to be useful in this regard.

2. **Preliminaries**

2.1. **Howe vectors and partial Bessel functions.** For any local field L , we write \mathfrak{o}_L to denote its ring of integers and \mathfrak{p}_L for the maximal ideal in \mathfrak{o}_L . Let val_{$L : L^\times \to \mathbb{Z}$ be the associated discrete valuation} map. We fix a uniformizer ϖ_L , so that $\varphi_L = (\varpi_L)$ and val $_L(\varpi_L) = 1$. The corresponding absolute value $|x|_L = q_L^{-\text{val}_L(x)}$ $\bar{L}^{\text{val}_L(x)}$ is the normalized absolute of *L* with $|\varpi_L|_L = q_L^{-1}$, where $q_L = |\mathfrak{d}_L/\mathfrak{p}_L|$ is the cardinality of the residue field. For the algebraic group $G = GL_2$, let $B = TU$ denote the Borel subgroup of upper triangular matrices, where

$$
T = \left\{ t(a, b) := \begin{pmatrix} a & b \end{pmatrix} \middle| a, b \in \mathbb{G}_m \right\}
$$

is the maximal torus consisting of diagonal matrices and

$$
U = \left\{ u(x) := \begin{pmatrix} 1 & x \\ & 1 \end{pmatrix} \middle| x \in \mathbb{G}_a \right\}
$$

is the unipotent radical of B. Let Z denote the center of GL_2 , and let A denote the subtorus

$$
A = \{t(a, 1) | a \in \mathbb{G}_m\}.
$$

Let

$$
\overline{\mathbf{U}} = \left\{ \overline{u}(x) := \begin{pmatrix} 1 \\ x & 1 \end{pmatrix} \middle| x \in \mathbb{G}_a \right\}
$$

end to U. We write

be the unipotent subgroup opposed to U. We write

$$
w = \begin{pmatrix} 1 \\ 1 \end{pmatrix}
$$

to denote the long Weyl element in GL_2 . Recall the Bruhat decomposition

$$
\mathbf{G}(L) = \mathbf{B}(L) \cup \mathbf{B}(L)w\mathbf{U}(L),
$$

with uniqueness of expression, i.e., every $g \notin B(L)$ has a unique expression of the form $g = bw, b \in A$ $B(L)$, $\mu \in U(L)$. Put $\tilde{K} = K_L = GL_2(\mathfrak{o}_L)$, the standard maximal compact subgroup of $G(L)$.

Before proceeding further, we fix our choice of Haar measures. If H is any of the unimodular groups $G(L)$, $A(L)$, $Z(L)$, $U(L)$, $\overline{U}(L)$ or K, we normalize the Haar measure on H so that vol(H∩K) = 1. Since $U(L), \overline{U}(L) \simeq L$ and $A(L) \simeq L^{\times}$, we may identify the measure on $U(L)$ and $\overline{U}(L)$ with the additive measure dx on L , and the measure on $A(L)$ with the multiplicative measure $d^{\times}a$ on L^{\times} . (Likewise, for $Z(L) \simeq L^{\times}$.) Our normalization is such that $d^{\times}a$ and dx assigns \mathfrak{o}^{\times}_I χ_L^{\times} and \mathfrak{o}_L , respectively, unit measure. If we use the coordinates $g = u(x)zt(a, 1)k$, the Haar measure dg on $G(L)$ can then be decomposed as

$$
dg = \delta_{\mathcal{B}}^{-1}(a)dx d^{\times}zd^{\times}adk,
$$

where δ_B is the modulus character. If $C_c^{\infty}(\mathbf{G}(L))$ denotes the space of smooth functions of compact support on $\mathbf{G}(L)$, then for $f \in C_c^{\infty}(\mathbf{G}(L))$, there is a constant $c = c(B)$ that only depends on B, so that we have the following integration formula [\[24\]](#page-12-7) (also see [\[18,](#page-12-8) Proposition 8.45])

(2.1)
$$
\int_{G(L)} f(g) dg = c \int_{U(L)\times T(L)\times \overline{U}(L)} f(ut\overline{u}) \delta_B(t)^{-1} d\overline{u} dt du.
$$

We will use this formula in our calculations. (Of course, one can also normalize the Haar measures so that $c = 1$ in the above formula.)

Now, we review the theory of Howe vectors $[13]$ for GL_2 over a local field L which was subsequently studied by Baruch $[2]$ in a more general context. Let ψ be an additive character of *L* of conductor 0, i.e., ψ is trivial on \mathfrak{o}_L whiel $\psi|_{\mathfrak{p}_L^{-1}} \neq 1$. Suppose (π, V) is an irreducible admissible *generic* representation of $GL_2(L)$ with the associated Whittaker model $W = W(\pi, \psi)$ relative to ψ . Let $\omega = \omega_{\pi}$ denote its central character. After fixing a non-zero Whittaker functional λ on V (unique up to a scalar multiple), we may identify *V* with *W* via $v \mapsto W_v$, where $W_v(g) = \lambda(\pi(g)v)$. Let π^i denote the representation of $GL_2(L)$ with $\pi^i(g) = \pi({}^t g^{-1})$ on the same underlying space *V*. It is well-known that π^i is isomorphic to its contragredient representation $\tilde{\pi}$. If $\widetilde{W}(g) := W(w^t g^{-1})$, then \widetilde{W} lies in $\mathcal{W}(\widetilde{\pi}, \psi^{-1})$.

For $m \geq 1$, let K_m be the *m*-th congruence subgroup, i.e., $K_m = I + M_2(\mathfrak{p}_{L}^m)$ $_{L}^{m}$). On K_{m} , define the function τ_m by the formula

$$
\tau_m(k) = \psi(\varpi_L^{-2m}k_{1,2}),
$$

where $(k_{i,j})$ is the matrix of k. One checks that τ_m is a linear (unitary) character of K_m , trivial on K_{2m} . Put

$$
d_m = \begin{pmatrix} \varpi_L^{-2m} \\ 1 \end{pmatrix},
$$

and let $J_m = d_m K_m d_m^{-1}$. Then J_m is given by

$$
\mathbf{J}_m = \begin{pmatrix} 1 + \mathfrak{p}_L^m & \mathfrak{p}_L^{-m} \\ \mathfrak{p}_L^{3m} & 1 + \mathfrak{p}_L^m \end{pmatrix}.
$$

Define a character φ_m of J_m by $\varphi_m(j) = \tau_m(d_m^{-1}jd_m)$, $j \in J_m$.

It is well-known that K*^𝑚* is *decomposed* with respect to B, i.e., the product map

$$
\mathbf{K}_m \cap \mathbf{U}(L) \times \mathbf{K}_m \cap \mathbf{T}(L) \times \mathbf{K}_m \cap \overline{\mathbf{U}}(L) \longrightarrow \mathbf{K}_m
$$

is a bijection, in fact, a homeomorphism of topological spaces. Since d_m is diagonal, it follows that the group J_m is also decomposed with respect to B. Further,

$$
d_m(\mathbf{K}_m \cap \mathbf{U}(L))d_m^{-1} \supset \mathbf{K}_m \cap \mathbf{U}(L), d_m(\mathbf{K}_m \cap \overline{\mathbf{U}}(L))d_m^{-1} \subset \mathbf{K}_m \cap \overline{\mathbf{U}}(L),
$$

i.e., conjugation by d_m enlarges the *upper* part $K_m \cap U(L)$ of K_m while shrinking its *lower* part $K_m \cap \overline{U}(L)$. Let us put $J_m^{\prime\prime}$ $\frac{u}{m} = J_m \cap U(L)$ and J_m^{ℓ} $\frac{\partial}{\partial m} = J_m \cap \overline{U}(L)$. One checks that φ_m and ψ both agree on J_m^u u
m[•]

For $m \geq 1$, consider the function f_m in the Hecke algebra of $\mathbf{G}(L)$ given by

$$
f_m = \begin{cases} \frac{1}{\text{vol}(\mathbf{J}_m)} \varphi_m^{-1} & \text{on } \mathbf{J}_m \\ 0 & \text{outside of } \mathbf{J}_m \end{cases}
$$

.

For *v* in *V*, put $v_m = \pi(f_m)v$. Explicitly, $v_m = \frac{1}{\text{vol}(f_m)}$ $\frac{1}{\text{vol}(\mathbf{J}_m)} \int$ J_m $\varphi_m^{-1}(j)(\pi(j)v)di.$

Definition 2.2. *Fix a v satisfying* $\lambda(v) = 1$ *and let l be an integer so that* K_l *fixes v*. *Then the vector* v_m *is called a Howe vector of* π *if* $m \geq l$.

An important property of Howe vector v_m is that it is also given by the formula

$$
v_m = \frac{1}{\text{vol}(J_m^u)} \int_{J_m^u} (\pi(u)v)\psi^{-1}(u)du.
$$

To see this, one has to utilize the decomposition $J_m = J_m^u \cdot (J_m \cap \overline{B}(L))$ and observe that $J_m \cap \overline{B}(L) \subset K_m$ fixes *v* for $m \geq l$. For $W \in \mathcal{W}$, we define $W_m \in \mathcal{W}$ by

(2.3)
$$
W_m(g) = \frac{1}{\text{vol}(J_m^u)} \int_{J_m^u} W(gu)\psi^{-1}(u)du.
$$

Note, if $W = W_v$ and v_m is a Howe vector, then $W_m = W_{v_m}$ is the corresponding Howe Whittaker function.

We collect the important properties of the functions W_m in the following lemma. (cf. [\[3,](#page-11-11) Lemma 5.2]).

Lemma 2.4. *Choose* $W \in \mathcal{W}$ *so that* $W(e) = 1$ *. Let l* be such that $\rho(K_i)W = W$ *, where* ρ denotes *right translation. Then we have*

- (1) $W_m(e) = 1$;
- (2) If $m \geq l$, then $W_m(gj) = \varphi_m(j)W_m(g)$ for all $j \in J_m$; (3) If $m \geq k$, then

$$
W_m(g) = \frac{1}{\text{vol}(\mathbf{J}_m^u)} \int_{\mathbf{J}_m^u} W_k(gu) \psi^{-1}(u) du.
$$

We also have the following lemma (cf. $[2]$) concerning the support of W_m on the diagonal torus.

Lemma 2.5. *Let* $m \geq l$ *and* W_m *be as in Lemma [2.4.](#page-5-3) Then*

$$
W_m(t(a,1)) \neq 0 \iff a \in 1 + \mathfrak{p}_L^m.
$$

By virtue of Lemma [2.4,](#page-5-3) W_m is what one calls a *partial Bessel function*, in the sense that,

$$
W_m(u_1gu_2)=\psi(u_1)\psi(u_2)W_m(g), u_1\in {\rm U}(L), u_2\in {\rm J}_m^u, g\in {\rm GL}_2(L).
$$

As mentioned in Section [1,](#page-0-0) we use the notation $B_m(g, W) = W_m(g), g \in G(L)$. The main result that we need regarding these partial Bessel functions is $[25,$ Proposition 5.3] (slightly paraphrased here):

 ${\bf Proposition \ 2.6.}$ Let π_1 and π_2 be irreducible ψ -generic representation of ${\rm GL}_2(L)$ with the same central *character. Let l be an integer so that* $W_1 \in \mathcal{W}(\pi_1, \psi)$ *and* $W_2 \in \mathcal{W}(\pi_2, \psi)$ *are Whittaker functions fixed by* K_l *. Assume* $W_i(e) = 1$ *, i* = 1*,* 2*. Then, for* $m \geq 3l$ *, the function given by the difference*

$$
B_m(g, W_1) - B_m(g, W_2)
$$

is supported on $g \in B(L) \cup J^{\omega}_{m}$ *𝑚 .*

2.2. **Asai local factors.** For the rest of the paper, we fix E/F as in Section [1](#page-0-0) with associated trace map Tr_{*E*/*F*}. Choose an element $\xi \in E$ so that $Tr_{E/F}\xi = 0$ and $E = F(\xi)$. Let $C_c^{\infty}(F^2)$ be the space of locally constant, compactly supported functions $\Phi : F^2 \to \mathbb{C}$. We write $e_1 = (1,0)$ and $e_2 = (0,1)$ to denote the standard basis for F^2 . Fix a non-trivial additive character ψ of F of conductor 0. The Fourier transform of $\Phi \in C_c^{\infty}(F^2)$ with respect to ψ is given by

$$
\widehat{\Phi}(y) = \widehat{\Phi}_{\psi}(y) = \int_{F^2} \Phi(x)\psi(x^t y) \ dx,
$$

where *dx* is the self-dual measure for which the Fourier inversion formula takes the form $\hat{\Phi}(x) = \Phi(-x)$. Define $\psi_E : E \to \mathbb{C}$ by

(2.7)
$$
\psi_E(x) = \psi_E(x; \xi) = \psi(\text{Tr}_{E/F}(\xi x)).
$$

Then ψ_F defines defines a non-trivial additive character of *E* that is trivial on *F*. We choose ξ so that ψ_E also has conductor 0. As usual, ψ defines a non-degenerate character of U(*F*) via $u(x) \mapsto \psi(x)$. Similarly, ψ_F defines one for U(*E*).

Let (π, V) be an irreducible admissible representation of $GL_2(E)$ that is *generic* with respect to ψ_E . Let $W(\pi, \psi_E)$ denote the corresponding Whittaker model with the associated bijection $v \mapsto W_v$ as before. Let χ_E be a smooth character of E^\times whose restriction to F^\times is denoted as χ . For $W \in \mathcal{W}(\pi, \psi_E)$, $\Phi \in C_c^{\infty}(\overline{F^2})$, and $s \in \mathbb{C}$, consider the zeta integral [\[11,](#page-11-2) [16\]](#page-11-4)

$$
Z(s, W, \Phi, \chi) = \int_{\mathrm{U}(F)\backslash \mathrm{G}(F)} W(g) \Phi(e_2 g) \chi(\det(g)) |\det(g)|_F^s dg.
$$

It is the *Flicker* integral [\[11\]](#page-11-2) associated to the representation $\pi \otimes \chi_F$ and clearly only depends on the restriction χ of χ_E .

For each (s, W, Φ) as above, the integral $Z(s, W, \Phi, \chi)$ converges absolutely when $\Re(s)$ is sufficiently large and defines a rational function of q^{-s} . The collection of all such integrals span a $\mathbb{C}[q^s, q^{-s}]$ fractional ideal of $\mathbb{C}(q^{-s})$. Further, there is a function $\gamma_{As}(s, \pi, \chi, \psi, \xi) \in \mathbb{C}(q^{-s})$ satisfying the local functional equation

(2.8)
$$
Z(1-s,\widetilde{W},\widehat{\Phi},\chi^{-1})=\gamma_{\text{As}}(s,\pi,\chi,\psi,\xi)Z(s,W,\Phi,\chi).
$$

We refer the reader to [\[23,](#page-12-0) Theorem 2.7] for proofs of these properties, and as noted in [\[16,](#page-11-4) Theorem 2], the proofs there are applicable to this situation. The function $\gamma_{As}(s, \pi, \chi, \psi, \xi)$ is the so-called *Asai* γ -factor attached to the representation $\pi \otimes \chi_E$ of $\mathbf{G}(E)$ [\[16,](#page-11-4) Theorem 3]. From loc.cit., we also have the corresponding Asai *L*-factor $L_{\text{As}}(s, \pi, \chi)$ and the Asai ϵ -factor $\epsilon_{\text{As}}(s, \pi, \chi, \psi, \xi)$ satisfying

(2.9)
$$
\epsilon_{As}(s,\pi,\chi,\psi,\xi)=\gamma_{As}(s,\pi,\chi,\psi,\xi)\frac{L_{As}(s,\pi,\chi)}{L_{As}(1-s,\widetilde{\pi},\chi^{-1})}.
$$

2.3. **Dependence on the pair** (ψ, ξ) . A different choice of (ψ', ξ') results in elements $a, b \in F^{\times}$, satisfying $\psi'(x) = \psi(ax), x \in F$, and $\xi' = b\xi$. We have the following well-known fact whose proof we include here for the sake of completeness.

Lemma 2.10. *For* $a, b \in F^\times$ *as above, we have*

$$
\gamma_{\rm As}(s, \pi, \chi, \psi', \xi) = \omega_{\pi}^2(a) \chi^4(a) |a|^{4s-2} \gamma_{\rm As}(s, \pi, \chi, \psi, \xi)
$$

and

$$
\gamma_{\rm As}(s,\pi,\chi,\psi,\xi')=\omega_{\pi}(b)\chi^2(b)|b|^{2s-1}\gamma_{\rm As}(s,\pi,\chi,\psi,\xi).
$$

Proof. Let $W'(g) = W(t(a, 1)g)$, then one checks that $W' \in \mathcal{W}(\pi, \psi'_E)$ and the map $W \mapsto W'$ is a bijection from $W(\pi, \psi_E)$ to $W(\pi, \psi_E')$. Then it is easy to see that

$$
Z(s, W', \Phi, \chi) = \int_{\mathcal{U}(F) \backslash \mathcal{G}(F)} W'(g) \Phi(e_2 g) \chi(\det(g)) |\det(g)|_F^s \, dg
$$

= $\chi^{-1}(a) |a|_F^{1-s} Z(s, W, \Phi, \chi).$

For $\Phi \in C_c^{\infty}(F^2)$, if $\hat{\Phi}_{\psi'}$ denotes the Fourier transform with respect to ψ' , then

$$
\widehat{\Phi}_{\psi'}(x, y) = |a|_F \widehat{\Phi}_{\psi}(ax, ay).
$$

Thus (with $\widehat{\Phi} = \widehat{\Phi}_{\psi}$)

$$
Z(1-s, \widetilde{W}', \widehat{\Phi}_{\psi'})
$$

\n
$$
= \omega_{\pi}(a)|a|_{F} \int_{\mathcal{U}(F)\backslash\mathcal{G}(F)} \widetilde{W}(t(a, 1)g) \widehat{\Phi}(e_{2}t(a, a)g) \chi^{-1}(\det(g)) |\det(g)|_{F}^{1-s} dg
$$

\n
$$
= \omega_{\pi}^{2}(a)\chi^{2}(a)|a|_{F}^{2s-1} \int_{\mathcal{U}(F)\backslash\mathcal{G}(F)} \widetilde{W}(t(a, 1)g) \widehat{\Phi}(e_{2}g) \chi^{-1}(\det(g)) |\det(g)|_{F}^{1-s} dg
$$

\n
$$
= \omega_{\pi}^{2}(a)\chi^{3}(a)|a|_{F}^{3s-1} Z(1-s, \widetilde{W}, \widehat{\Phi}).
$$

The first assertion now follows from the local functional equation [\(2.8\)](#page-6-1). A similar calculation works for the second assertion. One only needs to observe that, changing $\xi \mapsto \xi'$ but keeping ψ fixed, alters the additive character with respect to which the Whittaker model is considered but has no effect on the Fourier transform.

Henceforth, we fix a choice of ξ and take ψ to be unramified as in the previous subsection, and write $\gamma_{\rm As}(s, \pi, \chi, \psi)$ and $\epsilon_{\rm As}(s, \pi, \chi, \psi)$ to denote the corresponding Asai γ -factor and ϵ -factor, respectively.

3. **Proof of stability of Asai local gamma factor for** GL_2

A (smooth) character η of F^{\times} is said to be unramified if it is trivial on \mathfrak{o}_F^{\times} . If η is unramified, we α ¹/_{*Istrobury* character η or T is said to be dimantmed if it is divided by \mathcal{L}_F . If η is dimantmed, we set its conductor to be 0; otherwise, the conductor of η is the smallest positive integer *d* f} trivial upon restriction to $1 + \mathfrak{p}_{\mu}^{d}$ d_F . We write $n(\eta)$ to denote the conductor of η . For $a \in F$, recall the Gauss sum

$$
\tau(\eta, \psi, a) = \int_{\mathfrak{o}_F^{\times}} \eta^{-1}(u) \psi^{-1}(au) d^{\times} u
$$

of η relative to ψ . We have the following basic result (cf. [\[5,](#page-11-17) 23.6 Remark], for example):

Lemma 3.1. *For η ramified*,

$$
\int_{\mathfrak{d}_F^\times} \eta^{-1}(u)\psi^{-1}(\varpi_F^k u) d^\times u \begin{cases} = 0 & \text{if } k \neq -n(\eta) \\ \neq 0 & \text{if } k = -n(\eta). \end{cases}
$$

For a set $A \subset F$, we denote by $\mathbb{1}_A$ the characteristic function of *A*. For integers $i \geq 0$, $j > 0$, put

$$
\Phi_{i,j}(x,y) = \mathbb{1}_{\mathfrak{p}_F^i}(x)\mathbb{1}_{1+\mathfrak{p}_F^j}(y).
$$

Keeping the notation of Subsection [2.2,](#page-5-0) recall π is an irreducible admissible generic representation of $GL_2(E)$. Let $\omega = \omega_{\pi}|_{F^{\times}}$ be the restriction of its central character to F^{\times} . Choose a Whittaker function W catiofying $W(x) = U(x)$ *W* satisfying $W(e) = 1$ and let *l* be a positive integer such that $\rho(K_i)W = W$.

Proposition 3.2. *Let* $n = n(\omega \chi^2)$ *and choose* $m \ge \max\{l, 2n(\chi)\}\$ *. Then for* $i \ge 3m$ *,*

$$
Z(s, W_m, \Phi_{i,n}, \chi) = cq^{-i-n} \text{vol}((1 + \mathfrak{p}_E^m) \cap F^{\times}).
$$

Proof. Put $\Phi = \Phi_{i,n}$. According to [\(2.1\)](#page-3-2), we have

(3.3)
\n
$$
= c \int_{F^{\times}} \int_{F} W_m(t(a,1)\overline{u}(x)) \chi(a) |a|_F^{s-1} \left(\int_{F^{\times}} \Phi(e_2 t(a,1)\overline{u}(x)z) \omega_{\pi}(z) \chi^2(z) |z|_F^{2s} d^{\times}z \right) dxd^{\times}a
$$
\n
$$
= c \int_{F^{\times}} \int_{F} W_m(t(a,1)\overline{u}(x)) \chi(a) |a|_F^{s-1} \left(\int_{F^{\times}} \Phi(e_2 \overline{u}(x)z) \omega_{\pi}(z) \chi^2(z) |z|_F^{2s} d^{\times}z \right) dxd^{\times}a.
$$

The innermost integral reduces to

$$
\int_{F^\times} \Phi(e_2 \overline{u}(x)z) \omega_\pi(z) \chi^2(z) |z|_F^{2s} d^\times z = \int_{F^\times} \Phi(xz, z) \omega_\pi(z) \chi^2(z) |z|_F^{2s} d^\times z
$$
\n
$$
= \int_{F^\times} \mathbb{1}_{\mathfrak{p}_F^i}(xz) \mathbb{1}_{1 + \mathfrak{p}_F^n}(z) d^\times z = \begin{cases} q^{-n} & \text{if } x \in \mathfrak{p}_F^i, \\ 0 & \text{otherwise.} \end{cases}
$$

Thus

$$
Z(s, W_m, \Phi_{i,n}, \chi) = cq^{-n} \int\limits_{F^\times} \int\limits_{\mathfrak{p}_F^i} W_m(t(a, 1)\overline{u}(x))\chi(a)|a|_F^{s-1} dx d^\times a.
$$

Since $i \geq 3m$, $x \in \mathfrak{p}_i^i$ $\overline{\mu}_F^i \subset \mathfrak{p}_F^{3m} \implies \overline{\mu}(x) \in J_m$. But, according to Lemma [2.4,](#page-5-3) the function $W_m(\cdot)$ is right invariant under $\overline{u}(x)$ for $x \in \mathfrak{p}_i^i$ i_F . Therefore

$$
Z(s, W_m, \Phi, \chi) = cq^{-i-n} \int_{F^{\times}} W_m(t(a, 1)) \chi(a) |a|_F^{s-1} d^{\times} a
$$

= $cq^{-i-n} \int_{(1+\mathfrak{p}_E^m) \cap F^{\times}} \chi(a) |a|_F^{s-1} d^{\times} a$.

Here, the second equality follows from Lemma [2.5.](#page-5-4) Now, since $m \ge 2n(\chi)$ and $((1 + \mathfrak{p}_{\kappa}^m)^T \mathfrak{p}_{\kappa})$ *𝐸*) ∩ *𝐹* ×) *⊂* $(1 + p)$ $\frac{m}{2}$ $\frac{1}{2}$ $\binom{1}{F}^{\frac{1}{2}}$, we obtain

$$
Z(s, W_m, \Phi_{i,n}, \chi) = cq^{-i-n} \text{vol}((1 + \mathfrak{p}_E^m) \cap F^{\times}).
$$

Next, we consider the dual side. By our choice of the measure on F , for the characteristic function $\mathbb{1}_{\mathfrak{p}_F^i}$, we have

and

$$
\widehat{\mathbb{1}}_{\mathfrak{p}_F^i}(y) = q^{-i} \mathbb{1}_{\mathfrak{p}_F^{-i}}(y),
$$

$$
\begin{aligned} \widehat{\mathbb{1}}_{1+\mathfrak{p}_F^j}(y) &= \int\limits_F \mathbb{1}_{1+\mathfrak{p}_F^j}(x)\psi(xy) \, dx = \int\limits_F \mathbb{1}_{\mathfrak{p}_F^j}(x)\psi((x-1)y) \, dx \\ &= \psi(-y) \int\limits_F \mathbb{1}_{\mathfrak{p}_F^j}(x)\psi(xy) \, dx = q^{-j}\psi(-y)\mathbb{1}_{\mathfrak{p}_F^{-j}}(y). \end{aligned}
$$

 \Box

Hence

(3.4)
$$
\widehat{\Phi}_{i,j}(x, y) = q^{-i-j} \psi(-y) \mathbb{1}_{\mathfrak{p}_F^{-j}}(y) \mathbb{1}_{\mathfrak{p}_F^{-i}}(x).
$$

Lemma 3.5. With notations as in Proposition [3.2,](#page-7-1) for $i \geq 3m$ and $n = n(\omega \chi^2) > 0$, we have

$$
Z(1-s,\widetilde{W_m},\widehat{\Phi}_{i,n},\chi^{-1})=c\int\limits_{F^\times}\int\limits_{F}B_m(t(1,a)wu(-x),W)\chi(a)|a|_F^sG_{i,n}(x)dx\,d^\times a,
$$

where the function

$$
G_{i,n}(x) = \begin{cases} q^{-i-n+2n(1-s)}(\omega \chi^2)(\varpi_F^n) \tau(\omega \chi^2, \psi, \varpi_F^{-n}) & \text{if} \quad |x|_F \le q^{i-n}, \\ q^{-i-n} \int_{|z|_F \le \frac{q^i}{|x|_F}} \psi(-z) \omega^{-1}(z) \chi^{-2}(z) |z|_F^{2(1-s)} d^\times z & \text{if} \quad |x|_F > q^{i-n}. \end{cases}
$$

Note that $G_{i,n}(x)$ *depends on* π *only through its central character and is constant on* x *in the range* $|x|_F \leq q^{i-n}$.

Proof. Using [\(2.1\)](#page-3-2) again, we see that $Z(1 - s, \widetilde{W_m}, \widehat{\Phi}_{i,n}, \chi^{-1})$ equals

$$
(3.6) \quad c \int\limits_{F^\times} \int\limits_F \widetilde{W_m}(t(a,1)\overline{u}(x)) \chi^{-1}(a) |a|_F^{-s} \left(\int\limits_{F^\times} \widehat{\Phi}_{i,n}(e_2t(a,1)\overline{u}(x)z) \omega_{\pi}^{-1}(z) \chi^{-2}(z) |z|_F^{2-2s} d^\times z \right) dx d^\times a.
$$

Substituting for the Fourier transform [\(3.4\)](#page-9-0), the inner integral

 ϵ

$$
= \begin{cases} q^{-i-n} \int_{|z|_F \le q^n} \psi(-z) \omega^{-1}(z) \chi^{-2}(z) |z|_F^{2(1-s)} d^{\times} z & \text{if } |x|_F \le q^{i-n}, \\ q^{-i-n} \int_{|z|_F \le \frac{q^i}{|x|_F}} \psi(-z) \omega^{-1}(z) \chi^{-2}(z) |z|_F^{2(1-s)} d^{\times} z & \text{if } |x|_F > q^{i-n}. \end{cases}
$$

However, we may re-write the first integral as a sum over *shells* to obtain

$$
q^{-i-n} \int_{|z|_F \le q^n} \psi(-z) \omega^{-1}(z) \chi^{-2}(z) |z|_F^{2(1-s)} d^{\times} z
$$

= $q^{-i-n} \sum_{k=-n}^{\infty} \int_{\mathfrak{p}_F^k - \mathfrak{p}_F^{k+1}} \psi(-z) (\omega \chi^2) (z^{-1}) (q^{-k})^{2(1-s)} d^{\times} z$
= $q^{-i-n} \sum_{k=-n}^{\infty} q^{-2k(1-s)} (\omega \chi^2) (\varpi_F^{-k}) \tau (\omega \chi^2, \psi, \varpi_F^k).$

Since $\omega \chi^2$ is ramified character of F^\times with conductor *n*, by Lemma [3.1,](#page-7-2) the above expression reduces to

$$
q^{-i-n+2n(1-s)}(\omega\chi^2)(\varpi_F^n)\tau(\omega\chi^2,\psi,\varpi_F^{-n}).
$$

Collecting all of these, using $\widetilde{W_m}(t(a,1)\overline{u}(x)) = W_m(t(1,a^{-1})wu(-x))$ in [\(3.6\)](#page-9-1) and change $a \mapsto a^{-1}$ in the resulting integral, we get the desired conclusion.

Now, suppose π_1 and π_2 are irreducible admissible generic representations of $GL_2(E)$ having the same central character. Fix Whittaker functions $W_j \in \mathcal{W}(\pi_j, \psi_E)$ satisfying $W_j(e) = 1$, $j = 1, 2$, and let *l* be a positive integer so that K_l fixes both W_1 and W_2 . Choose $m \ge \max\{\frac{3l}{n}, \frac{2n(\chi)}{l}\}\.$ We write $\widetilde{W}_{j,m}$ to denote the dual of $W_{j,m} = (W_j)_m$ (cf. [2.3\)](#page-5-1). It follows from Proposition [2.6](#page-5-2) that

$$
B_m(t(1, a)wu(-x), W_1) - B_m(t(1, a)wu(-x), W_2) = 0
$$

for $x \notin \mathfrak{p}_F^{-m}$ $\bar{E}^m \cap F$. Hence, by Lemma [3.5,](#page-9-2) the difference

$$
Z(1-s,\widetilde{W}_{1,m},\widehat{\Phi}_{i,n},\chi^{-1}) - Z(1-s,\widetilde{W}_{2,m},\widehat{\Phi}_{i,n},\chi^{-1})
$$

$$
= c \int_{F^{\times}} \int_{\mathfrak{p}_E^{-m} \cap F} [B_m(t(1,a)wu(-x),W_1) - B_m(t(1,a)wu(-x),W_2)] \chi(a)|a|_F^s G_{i,n}(x) dx d^{\times} a.
$$

Choose $m \geq n$ so that $x \in \mathfrak{p}_F^{-m}$ $\overline{E}^m \cap F \implies x \in \mathfrak{p}_F^{-(i-n)}$ $_{F}^{-(i-n)}$ for $i \geq 3m$. Hence

(3.8)
\n
$$
Z(1-s, \widetilde{W}_{1,m}, \widehat{\Phi}_{i,n}, \chi^{-1}) - Z(1-s, \widetilde{W}_{2,m}, \widehat{\Phi}_{i,n}, \chi^{-1})
$$
\n
$$
= cq^{-i-n+2n(1-s)}(\omega \chi^2)(\varpi_F^m) \tau(\omega \chi^2, \psi, \varpi_F^{-n}) \text{vol}(\mathfrak{p}_E^{-m} \cap F, dx)
$$
\n
$$
\int_{F^\times} [B_m(t(1,a)w, W_1) - B_m(t(1,a)w, W_2)] \chi(a) |a|_F^s d^\times a.
$$

To remove the dependence of the integrand on *m*, we use part (3) of Lemma [2.4](#page-5-3) with $m \geq 3l$, to obtain

(3.9)
\n
$$
B_m(t(1, a)w, W_1) - B_m(t(1, a)w, W_2)
$$
\n
$$
= \frac{1}{\text{vol}(J_m^u)} \int_{J_m^u} [B_{3l}(t(1, a)wu, W_1) - B_{3l}(t(1, a)wu, W_2)] \psi_E^{-1}(u) du
$$
\n
$$
= \frac{1}{\text{vol}(J_m^u)} \int_{J_m^u} [B_{3l}(t(1, a)wu, W_1) - B_{3l}(t(1, a)wu, W_2)] \psi_E^{-1}(u) du
$$
\n
$$
= \frac{\text{vol}(J_m^u)}{\text{vol}(J_m^u)} [B_{3l}(t(1, a)w, W_1) - B_{3l}(t(1, a)w, W_2)].
$$

Here, we have used Proposition [2.6](#page-5-2) in deducing the second equality. Therefore the function

$$
a \mapsto B_m(t(1, a)w, W_1) - B_m(t(1, a)w, W_2)
$$

is right invariant under $1 + p_F^{3l}$ $^{3l}_{F}$ and is consequently uniformly smooth relative to *m*.

Plugging [\(3.9\)](#page-10-1) into [\(3.8\)](#page-10-0), we arrive at the following proposition:

Proposition 3.10. Let π_1 , π_2 and ω as above. and χ as above. For a character χ of F^\times , set $n = n(\omega \chi^2)$. Also, choose W_1, W_2 and l be as indicated above. Then there exists a suitably large integer $m \gg 0$ such *that, for* $i \geq 3m$ *, we have*

$$
Z(1-s, \widetilde{W}_{1,m}, \widehat{\Phi}_{i,n}, \chi^{-1}) - Z(1-s, \widetilde{W}_{2,m}, \widehat{\Phi}_{i,n}, \chi^{-1})
$$

= $cq^{-i-n+2n(1-s)}(\omega \chi^2)(\varpi_F^n)\tau(\omega \chi^2, \psi, \varpi_F^{-n})\text{vol}(\mathfrak{p}_E^{-m} \cap F, dx) \frac{\text{vol}(J_i^{\omega})}{\text{vol}(J_m^{\omega})}$

$$
\int_{F^{\times}} [B_{3l}(t(1,a)w, W_1) - B_{3l}(t(1,a)w, W_2)]\chi(a)|a|_F^s d^{\times}a.
$$

3.1. **Conclusion of the proof of Theorem [1.1.](#page-0-1)** By Proposition [3.2,](#page-7-1) Proposition [3.10](#page-10-2) and [\(2.8\)](#page-6-1), we obtain

(3.11)
$$
\gamma_{As}(s, \pi_1, \chi, \psi) - \gamma_{As}(s, \pi_2, \chi, \psi) = \nu_m c_{\omega, \chi, \psi} \int_{F^\times} [B_{3l}(t(1, a)w, W_1) - B_{3l}(t(1, a)w, W_2)] \chi(a) |a|_F^s d^\times a,
$$

where v_m is the volume factor $v_m = \frac{\text{vol}(\mathbf{p}_E^{-m} \cap F) \text{vol}(J_i^{\mu})}{\text{vol}(1 + \mathbf{p}_m^m \cap F^{\times}) \text{vol}(J_i^{\mu})}$ $\frac{\sqrt{6}(\psi_E + i \pi \cos(\sigma_f))}{\sqrt{6}(\psi_E + i \pi \cos(\sigma_f))}$ and

$$
c_{\omega,\chi,\psi} = q^{2n(1-s)}(\omega \chi^2)(\varpi_F^n) \tau(\omega \chi^2, \psi, \varpi_F^{-n})
$$

is a non-zero constant. But the integral on the right hand side is 0 for a suitable highly ramified χ . For instance, if χ is such that $n(\chi) > 3l$, then the integral vanishes concluding the proof of Theorem [1.1.](#page-0-1)
