### TRANSFER OF CHARACTERS IN THE THETA CORRESPONDENCE WITH ONE COMPACT MEMBER

ABSTRACT. For an irreducible dual pair  $(G, G') \in Sp(W)$  with one member compact and two representations  $\Pi \leftrightarrow \Pi'$  appearing in the Howe duality, we give an expression of the character  $\Theta_{\Pi'}$  of  $\Pi'$  via the character of  $\Pi$ . We make computations for the dual pair ( $G = U(n, \mathbb{C}), G' = U(p, q, \mathbb{C})$ ), which are explicit in low dimensions. For ( $G = U(1, \mathbb{C}), G' = U(1, 1, \mathbb{C})$ ), we verify directly a result of H. Hecht saying that the character has the same value on both Cartan subgroups of G'.

#### 1. INTRODUCTION

For a finite dimensional representation  $(\Pi, V)$  of a group G, the character of  $\Pi$ , denote by  $\Theta_{\Pi}$ , is defined by:

$$\Theta_{\Pi}$$
: G  $\ni$  g  $\rightarrow$  tr( $\Pi(g)$ )  $\in$  C.

In general, to determine precisely the character of such representations it's a hard problem, but in few cases, in particular for a compact connected group, the formula is explicit. Indeed, let G be a compact connected Lie group, T a Cartan subgroup of G, g and t the Lie algebras of G and T respectively,  $g_{\mathbb{C}}$  and  $t_{\mathbb{C}}$  the complexifications of g and t,  $\Phi(g_{\mathbb{C}}, t_{\mathbb{C}})$  (resp.  $\Phi^+(g_{\mathbb{C}}, t_{\mathbb{C}})$ ) be the set of roots (resp. positive roots) of  $g_{\mathbb{C}}$  with respect to  $t_{\mathbb{C}}$  and  $\mathcal{W} = \mathcal{W}(g_{\mathbb{C}}, t_{\mathbb{C}})$  be the corresponding Weyl group. According to H. Weyl, all the irreducible representations ( $\Pi, V$ ) of G are finite dimensional and parametrised by a

linear form  $\lambda$  on  $t_{\mathbb{C}}$ : this linear form is called the highest weight of  $\Pi$ . Moreover, the character of  $\Pi$  is given by the following formula:

(1) 
$$\Theta_{\Pi}(\exp(x)) = \sum_{\omega \in \mathscr{W}} \operatorname{sgn}(\omega) \frac{e^{\omega(\lambda + \rho)(x)}}{\prod_{\alpha \in \Phi^+(\mathfrak{g}_{\mathbb{C}}, \mathfrak{t}_{\mathbb{C}})} (e^{\frac{\alpha(x)}{2}} - e^{-\frac{\alpha(x)}{2}})} \qquad (x \in \mathfrak{t}^{\operatorname{reg}})$$

where  $\rho$  is a linear form on  $t_{\mathbb{C}}$  given by  $\rho = \frac{1}{2} \sum_{\alpha \in \Phi^+(g_{\mathbb{C}}, t_{\mathbb{C}})} \alpha$ .

In the 50's, for a real reductive Lie group G, Harish-Chandra extended the concept of characters for a certain class of representation of G called quasi-simple (see [12, Section 10]). More precisely, for such a representation ( $\Pi$ ,  $\mathscr{H}$ ) of G, he proved that the map:

$$\Theta_{\Pi}: \mathscr{C}^{\infty}_{c}(\mathbf{G}) \ni \Psi \to \operatorname{tr}(\Pi(\Psi)) = \operatorname{tr} \int_{\mathbf{G}} \Psi(g) \Pi(g) dg \in \mathbb{C}$$

is well-defined and continuous. The map  $\Theta_{\Pi}$  is called the global character of  $\Pi$ . Moreover, he proved that this distribution is given by an analytic function, still denoted by  $\Theta_{\Pi}$ , on the set of regular points of G, i.e.

$$\Theta_{\Pi}(\Psi) = \int_{\mathcal{G}} \Theta_{\Pi}(g) \Psi(g) dg \qquad (\Psi \in \mathscr{C}^{\infty}_{c}(\mathcal{G})).$$

Again, an explicit formula for the function  $\Theta_{\Pi}$  on  $G^{reg}$  is hard to get. We recall briefly some well known facts on those characters. Let G be reductive group, K be a maximal compact subgroup of G such that rk(K) = rk(G) and T be a Cartan subgroup of K (which is also a Cartan subgroup for G by our assumptions on ranks). As before, we denote by g, t and t their Lie algebras and by  $g_{\mathbb{C}}$ ,  $t_{\mathbb{C}}$  and  $t_{\mathbb{C}}$  their complexifications.

(1) If  $(\Pi, \mathscr{H})$  is a discrete series representation of G of Harish-Chandra parameter  $\lambda \in \mathfrak{t}_{\mathbb{C}}^*$ , the character  $\Theta_{\Pi}$  of  $\Pi$  is given by (see [13]):

$$\Theta_{\Pi}(\exp(x)) = (-1)^{\frac{\dim(G/K)}{2}} \sum_{\omega \in \mathscr{W}(\mathfrak{t}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} \varepsilon(\omega) \frac{e^{\omega(\lambda(x))}}{\prod_{\alpha \in \Phi^{+}(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} (e^{\frac{\alpha(x)}{2}} - e^{-\frac{\alpha(x)}{2}})} \qquad (x \in \mathfrak{t}^{\mathrm{reg}}),$$

where  $\mathscr{W}(\mathfrak{t}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})$  is the compact Weyl group of K.

(2) If  $(\Pi, \mathcal{H}_{\Pi})$  is an irreducible unitary representation of G of highest weight  $\lambda - \rho$ , the character  $\Theta_{\Pi}$  of  $\Pi$  is given by (see [14, Corollary 2.3]):

$$\prod_{\alpha \in \Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}}) \setminus \Phi^+(\mathfrak{t}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} (e^{\frac{\alpha(x)}{2}} - e^{-\frac{\alpha(x)}{2}}) \Theta_{\Pi}(\exp(x)) = \sum_{\omega \in \mathcal{W}_{\lambda}^{\mathfrak{t}}} (-1)^{l_{\lambda}(\omega)} \Theta(\mathbf{K}, \Lambda(\omega, \lambda))(\exp(x)) \qquad (x \in \mathfrak{t}^{\operatorname{reg}}),$$

where  $\mathscr{W}_{\lambda}^{\dagger}$  is defined in [14, Definition 2.1], and  $\Theta(\mathbf{K}, \Lambda(\omega, \lambda))(\exp(x))$  is the character of a K-representation of highest weight  $\Lambda(\omega, \lambda)$ , where  $\Lambda(\omega, \lambda)$  is defined in [14, Corollary 2.3].

We can also mention a conjecture of A. Kirillov (see [23]), which should hold for a really general Lie group, and a paper of H. Hecht ([26])

Let  $(W, \langle \cdot, \cdot \rangle)$  be a real symplectic space, Sp(W) its corresponding group of isometries,  $\widetilde{Sp(W)}$  the metaplectic group and  $(\omega, \mathscr{H})$  the corresponding metaplectic representation (see Section 2). For a subgroup  $H \in Sp(W)$ , we denote by  $\widetilde{H}$  its preimage in  $\widetilde{Sp(W)}$  and by  $\mathscr{R}(\widetilde{H}, \omega)$  the set of equivalence

classes of irreducible admissible representations of  $\widetilde{H}$  which are infinitesimally equivalent to a quotient of  $\omega^{\infty}$ . For an irreducible reductive dual pair (G, G') in Sp(W), R. Howe proved that there exists a bijection between  $\mathscr{R}(\widetilde{G}, \omega)$  and  $\mathscr{R}(\widetilde{G'}, \omega)$ .

In this paper, we assume that G is compact. In that case, it turns out that the situation is easier: the representations  $\Pi$  and  $\Pi'$  are just subrepresentations of  $\omega^{\infty}$ . Our goal here is to determine the character  $\Theta_{\Pi'}$  using the character  $\Theta_{\Pi}$  of  $\Pi$ . By projecting on the  $\Pi$ -isotypic component in  $\mathscr{H}^{\infty}$ , we get, for all  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{G})$ , that:

$$\Theta_{\Pi}(\Psi) = \operatorname{tr} \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Psi(\widetilde{g'}) \omega^{\infty}(\widetilde{g}\widetilde{g'}) d\widetilde{g}d\widetilde{g'}.$$

So, formally, we have:

$$\Theta_{\Pi'}(\widetilde{g}') = \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{g}\widetilde{g}') d\widetilde{g} \qquad (\widetilde{g}' \in \widetilde{G}'^{\operatorname{reg}}),$$

where the last equality is in terms of distributions on  $\mathscr{C}_c^{\infty}(\widetilde{G})$  and where  $\Theta$  is the character of  $\omega$  (see Section 2). To avoid the problem of non-continuity of  $\Theta$ , we use the Oscillator semigroup introduced by Howe (see [2] or Section 3) and denoted by  $\operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++}$ . The extension of  $\Theta$  on  $\operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++}$  is holomorphic and  $\operatorname{Sp}(W).\operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++} \subseteq \operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++}$ . In particular, we get for  $\widetilde{g'} \in \widetilde{G'}^{\operatorname{reg}}$  that:

$$\Theta_{\Pi'}(\widetilde{g'}) = \lim_{\substack{\widetilde{p} \to 1\\ \widetilde{p} \in G^{\widetilde{\tau+1}}}} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{g}\widetilde{g'}\widetilde{p}) d\widetilde{g},$$

where  $G'^{++} = G'_{\mathbb{C}} \cap \operatorname{Sp}(W_{\mathbb{C}})^{++}$ . The character of the representation  $\Pi$  can be obtained using Weyl's character formula (see Equation (1)) together with a paper of M. Kashiwara and M. Vergne [17], where they give explicitly the weights of the representations appearing in the correspondence. Moreover, using [24] or [5], we get an explicit formula for the restriction of the character  $\Theta$  on  $T \cdot T'^{++}$ , where T (resp. T') is a compact torus of G (resp. G') and  $T'^{++} = T'_{\mathbb{C}} \cap \operatorname{Sp}(W_{\mathbb{C}})^{++}$ . We focus our attention on the case (G = U(n,  $\mathbb{C}$ ), G' = U(p, q,  $\mathbb{C}$ )). More precisely, for n = 1, we get the following result (see Proposition 6.4):

$$\Theta_{\Pi'_{k}}(\tilde{t}') = \begin{cases} \prod_{i=1}^{p+q} t_{i}^{\frac{1}{2}} \sum_{h=1}^{p} \frac{t_{h}^{p-(k+1)}}{\prod_{h\neq j} (t_{h} - t_{j})} & \text{if } k \leq p-1 \\ -\prod_{i=1}^{p+q} t_{i}^{\frac{1}{2}} \sum_{h=p+1}^{p+q} \frac{t_{h}^{p-(k+1)}}{\prod_{h\neq j} (t_{h} - t_{j})} & \text{otherwise} \end{cases}$$

In Section 7, we work with the pair ( $G = U(1, \mathbb{C}), G' = U(1, 1, \mathbb{C})$ ) and determine the value of the character  $\Theta_{\Pi'}$  on the non-compact torus of  $U(1, 1, \mathbb{C})$  (unique up to conjugation, see Section 7). In particular, we verify a result of H. Hecht [26], saying that the value of the character does not depend of the Cartan subgroup

In Section 8, we recall a conjecture of T. Przebinda (see [7]) concerning the transfer of characters for a general dual pair (G, G') and present in few words an ongoing project linked with recents works of T. Przebinda [6].

### 2. METAPLECTIC REPRESENTATION AND HOWE'S DUALITY THEOREM

As far as I know, the first construction of this metaplectic representation used the so-called Stone-Von Neumann theorem. Brieffly, let  $(W, \langle \cdot, \cdot \rangle)$  be a real symplectic space and H(W) the space  $W \oplus \mathbb{R}$  with group multiplication:

$$(w_1, \lambda_1).(w_2, \lambda_2) = (w_1 + w_2, \lambda_1 + \lambda_2 + \frac{1}{2} \langle w_1, w_2 \rangle), \qquad (w_1, w_2 \in W, \lambda_1, \lambda_2 \in \mathbb{R}).$$

Clearly,  $\mathscr{Z}(H(W)) = \{(0, \lambda), \lambda \in \mathbb{R}\} \approx \mathbb{R}$ . According to the Stone- Von Neumann theorem, for every character non trivial character  $\Psi$  of  $\mathscr{Z}(H(W))$ , there exists, up to equivalence, a unique irreducible unitary representation of H(W) with central character  $\Psi$ . The group of isometries of  $(W, \langle \cdot, \cdot \rangle)$ , denoted by Sp(W), acts naturally on H(W) by

$$g.(w, \lambda) = (g(w), \lambda)$$
  $(g \in \operatorname{Sp}(W), (w, \lambda) \in \operatorname{H}(W)).$ 

By fixing an irreducible unitary representation  $(\Pi_{\lambda}, \mathscr{H}_{\lambda})$  of H(W) with infinitesimal character  $\Psi_{\lambda}, \lambda \in \mathbb{R}$ , we get that the map:

$$\Pi_{\lambda,g}(h) = \Pi_{\lambda}(g^{-1}(h)) \qquad (g \in \operatorname{Sp}(W), h \in \operatorname{H}(W)),$$

is an irreducible unitary representation of H(W) with infinitesimal character  $\Psi_{\lambda}$ , and then, by application of the Stone- Von Neumann theorem, there exists an operator  $\omega_{\lambda}(g)$  such that:

$$\omega_{\lambda}(g)\Pi_{\lambda}(h)\omega_{\lambda}(g)^{-1}=\Pi_{\lambda}(g^{-1}(h)).$$

In particular, we get a projective representation of Sp(W). One can prove that we get a representation  $(\omega, \mathcal{H})$  of a non-trivial double cover of Sp(W), that we will denote by  $\widetilde{Sp(W)}$  (see [11]).

In this section, we give an explicit realisation of the metaplectic representation (using a paper of A-M. Aubert and T. Przebinda [5]). In particular, we get a formula for the character of this representation (one can also check the paper of T. Thomas [24]).

Let  $\chi$  be the character of  $\mathbb{R}$  given by  $\chi(r) = e^{2i\pi r}$ . We denote by  $\mathfrak{sp}(W)$  the Lie algebra of Sp(W), i.e.

$$\mathfrak{sp}(W) = \{ X \in \operatorname{End}(W), \langle X(w), w' \rangle + \langle w, X(w') \rangle = 0, \ (\forall w, w' \in W) \} .$$

Let *J* be an element of  $\mathfrak{sp}(W)$  satisfying  $J^2 = -$  Id and such that the symmetric bilinear form (w, w') defined by  $(w, w') = \langle J(w), w' \rangle$  is positive definite. For all  $g \in Sp(W)$ , we denote by  $J_g$  the automorphism of *W* given by  $J_g = J^{-1}(g - 1)$ . One can check easily that the adjoint  $J_g^*$  of  $J_g$  with respect to the form  $(\cdot, \cdot)$  is given by  $J_g^* = Jg^{-1}(1 - g)$  and that the restriction of  $J_g$  to  $J_g(W)$  is well defined and invertible. The metaplectic group is defined as:

(2) 
$$\widetilde{\operatorname{Sp}(W)} = \left\{ \widetilde{g} = (g,\xi) \in \operatorname{Sp}(W) \times \mathbb{C}^*, \xi^2 = i^{\dim_{\mathbb{R}}(g-1)W} \det(J_g)_{J_g(W)}^{-1} \right\}.$$

The covering map  $\pi : \widetilde{Sp(W)} \ni (g, \xi) \rightarrow g \in Sp(W)$  is the first projection and the multiplication law is defined by:

$$(g_1,\xi_1).(g_2,\xi_2) = (g_1g_2,\xi_1\xi_2C(g_1,g_2)),$$

where the cocycle  $C : Sp(W) \times Sp(W) \to \mathbb{C}$  is defined in [5, Proposition 4.13]. Using [6, Equation (3)], we get that the absolute value of *C* satisfies, for every  $g_1, g_2 \in Sp(W)$ , the following equations:

$$|C(g_1, g_2)| = \sqrt{\left|\frac{\det(J_{g_1})_{J_{g_1}(W)} \det(J_{g_2})_{J_{g_2}(W)}}{\det(J_{g_1g_2})_{J_{g_1g_2}(W)}}\right|}, \qquad \frac{C(g_1, g_2)}{|C(g_1, g_2)|} = \chi\left(\frac{1}{8}\operatorname{sgn}(q_{g_1, g_2})\right),$$

where sgn( $q_{g_1,g_2}$ ) is the signature of the form  $q_{g_1,g_2}$  defined by:

$$q_{g_1,g_2}(u,v) = \frac{1}{2} \left( \langle c(g_1)u,v \rangle + \langle c(g_2)u,v \rangle \right) \qquad (u,v \in (g_1-1)W \cap (g_2-1)W).$$

To simplify the notations, for all  $g \in \text{Sp}(W)$ , we denote by  $\chi_{c(g)}$  the form on (g - 1)W given by  $\chi_{c(g)}(u) = \chi(\frac{1}{8}\langle c(g)u, u \rangle).$ 

We now construct the metaplectic representation. We denote by S(W) the Schwarz space corresponding to *W* and by  $t : Sp(W) \to S^*(W)$ ,  $\Theta : \widetilde{Sp(W)} \to \mathbb{C}^*$  and  $T : \widetilde{Sp(W)} \to S^*(W)$  defined by

$$t(g) = \chi_{c(g)} \mu_{(g-1)W} \qquad \Theta(\widetilde{g}) = \xi, \qquad T(\widetilde{g}) = \Theta(\widetilde{g})t(g), \qquad (\widetilde{g} = (g,\xi)),$$

where  $\mu_{(g-1)W} \in S^*(W)$  is the Lebesgue measure on the space (g-1)W such that the volume with respect to  $(\cdot, \cdot)$  of the corresponding unit cube is 1.

We now fix a complete polarisation  $W = X \oplus Y$ , i.e. a direct sum of two maximal isotropic subspaces of *W*. The Weyl transform  $\mathcal{K} : S(W) \to S(X \times X)$  given by:

$$\mathscr{K}(\eta)(x,x') = \int_{Y} \eta(x-x'+y)\chi\left(\frac{1}{2}\langle y,x+x'\rangle\right) dy$$

is an isomorphism and the extension of  $\mathscr{K}$  to the corresponding space of tempered distributions  $\mathscr{K}$ :  $S^*(W) \to S^*(X \times X)$  is still an isomorphism. Similarly, the map  $Op : S(X \times X) \to Hom(S(X), S^*(X))$ given by:

$$Op(K)v(x) = \int_X K(x, x')v(x')dx'$$

extends to isomorphism Op :  $S^*(X \times X) \to Hom(S(X), S^*(X))$ . According to [5, Section 4.8], for every  $\Psi \in L^2(W)$ , Op  $\circ \mathscr{K}(\Psi)$  is an Hilbert-Schmidt operator on  $L^2(X)$  and the map:

 $\operatorname{Op} \circ \mathscr{K} : \operatorname{L}^2(W) \to \operatorname{HS}(\operatorname{L}^2(X))$ 

is an isometry. We denote by  $\omega : \widetilde{\operatorname{Sp}(W)} \to U(L^2(X))$  defined by:

$$\omega = \operatorname{Op} \circ \mathscr{K} \circ T$$

is a unitary representation of  $\widetilde{Sp(W)}$ , called metaplectic representation. Moreover, the function  $\Theta$  defined previously is the character of  $(\omega, L^2(X))$  and the space of smooth vectors is S(X), the Schwartz space of *X*.

*Remark* 2.1. We denote by  $\text{Sp}(W)^c$  the subspace of Sp(W) defined by  $\text{Sp}(W)^c = \{g \in \text{Sp}(W), \det(g - 1) \neq 0\}$ : it's the domain of the Cayley transform of Sp(W). We denote by  $\widetilde{\text{Sp}(W)^c}$  the preimage of  $\text{Sp}(W)^c$  in  $\widetilde{\text{Sp}(W)}$ . For every  $\widetilde{g} = (g, \xi) \in \widetilde{\text{Sp}(W)^c}$ , we get:

$$\Theta(\tilde{g}) = \left(i^{\dim_{\mathbb{R}} W} \det(J(g-1))^{-1}\right)^{\frac{1}{2}} = \det(i(g-1))^{-\frac{1}{2}}.$$

A dual pair in Sp(*W*) is a pair of subgroups (G, G') of Sp(*W*) which are mutually centralizer in Sp(*W*), i.e.  $C_{\text{Sp}(W)}(G) = G'$  and  $C_{\text{Sp}(W)}(G') = G$ . The dual pair is said to be reductive if the action of G and G' on *W* is reductive. If we have a decomposition of *W* as an orthogonal sum  $W = W_1 \oplus W_2$  where  $W_1$ and  $W_2$  are G. G'-invariants, then  $(G_{|W_i}, G'_{|W_i})$  is a dual pair in Sp $(W_{|W_i})$ , i = 1, 2. If we cannot find such a decomposition, the dual pair is said irreducible.

The irreducible reductive dual pairs in the symplectic group had been classified by R. Howe [4]. In this paper, we assume that the group G is compact. In this case, (G, G') is one of the following dual pairs

- (1)  $(U(n,\mathbb{C}), U(p,q,\mathbb{C})) \subseteq \operatorname{Sp}(2n(p+q),\mathbb{R}),$
- (2)  $(O(n, \mathbb{R}), Sp(2m, \mathbb{R})) \subseteq Sp(2nm, \mathbb{R}),$
- (3)  $(U(n, \mathbb{H}), O^*(m, \mathbb{H})) \subseteq Sp(4nm, \mathbb{R}).$

For the computations in the Section 6, we will focus our attention on the first one.

- *Remark* 2.2. (1) For a dual pair (G, G') in Sp(W), we denote by  $\widetilde{G} = \pi^{-1}(G)$  and  $\widetilde{G}'$  the preimages of G and G' in  $\widetilde{Sp(W)}$ . In [4], R. Howe proved that  $(\widetilde{G}, \widetilde{G}')$  is a dual pair in  $\widetilde{Sp(W)}$ . With the precise definition we gave for  $\widetilde{Sp(W)}$  in Equation (2), we can see that easily. Indeed, we need to prove that for all  $g \in G$  and  $g' \in G'$ , we have C(g, g') = C(g', g). Obviously, |C(g, g')| = |C(g', g)|, and because  $q_{g,g'} = q_{g',g}$ , the result follows.
  - (2) If the group G is compact, then  $\overline{G}$  is also compact.

From now on, we assume that (G, G') is an irreducible reductive dual pair in Sp(W) with G compact. The Howe duality theorem can be stated in a easier way when we assume that one member is compact. As before, we consider a complete polarisation of W of the form  $X \oplus Y$  and we realise the metaplectic representation  $\omega$  on the space  $L^2(X)$ . The space of smooth vector is the Schwartz space S(X) and under the action of  $\widetilde{G}$ , we get the following decomposition:

$$\mathbf{S}(X) = \bigoplus_{(\Pi, V_{\Pi}) \in \widetilde{\widetilde{G}}_{\omega}} V(\Pi),$$

where  $\widehat{\widetilde{G}}_{\omega}$  is the set of irreducible unitary representations of  $\widetilde{G}$  such that  $\operatorname{Hom}_{\widetilde{G}}(\Pi, \omega^{\infty}) \neq \{0\}$  and  $V(\Pi)$  is the  $\Pi$ -isotypic component in S(X), i.e. the closure with respect to the topology on S(X) of the sspace  $\{T(V_{\Pi}), T \in \operatorname{Hom}_{\widetilde{G}}(\Pi, \omega^{\infty})\}$ .

Because  $\widetilde{G}'$  commute with  $\widetilde{G}$ , the group  $\widetilde{G}'$  acts on  $V(\Pi)$  for every  $\Pi \in \widehat{\widetilde{G}}_{\omega}$ , and as a  $\widetilde{G} \times \widetilde{G}'$ -module, we get the following decomposition:

$$\mathbf{S}(X) = \bigoplus_{(\Pi, V_{\Pi}) \in \widetilde{\widetilde{\mathbf{G}}}_{\omega}} \Pi \otimes \Pi',$$

where  $\Pi'$  is an irreducible unitary representation of  $\widetilde{G}'$ . The map

$$\theta:\widehat{\widetilde{\mathsf{G}}}_{\omega} \ni \Pi \to \Pi' = \theta(\Pi) \to \widehat{\widetilde{\mathsf{G}}'}_{\omega}$$

is one-to-one and usually called Howe's correspondence.

Let  $(\Pi, V_{\Pi}) \in \widetilde{\widetilde{G}}_{\omega}$  and  $\Pi' = \theta(\Pi)$  the corresponding representation of  $\widetilde{G}'$ . We denote by  $\mathscr{P}_{\Pi} : S(X) \to V(\Pi)$  the projection onto the  $\Pi$ -isotypic component. According to [15, Section 1.4], the map  $\mathscr{P}_{\Pi}$  is given by the formula:

$$\mathscr{P}_{\Pi} = d_{\Pi} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \omega^{\infty}(\widetilde{g}) d\widetilde{g} = \omega^{\infty}(d_{\Pi}\overline{\Theta_{\Pi}}),$$

where  $d_{\Pi} = \dim_{\mathbb{C}}(V_{\Pi})$  is the dimension of the representation  $\Pi$ . We get the following result for the global character of  $\Pi'$ .

**Proposition 2.3.** For every compactly supported function  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{G}')$ , we get:

$$\Theta_{\Pi'}(\Psi) = \operatorname{tr} \int_{\widetilde{G}'} \left( \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \omega^{\infty}(\widetilde{g}\widetilde{g}') d\widetilde{g} \right) \Psi(\widetilde{g}') d\widetilde{g}'.$$

*Proof.* For such a function  $\Psi$ , we have:

$$\operatorname{tr}(\mathscr{P}_{\Pi}\omega(\Psi)) = \operatorname{tr}(\operatorname{Id}_{V_{\Pi}}\otimes\Pi'(\Psi)) = d_{\Pi}\Theta_{\Pi'}(\Psi)$$

and then,

$$\Theta_{\Pi'}(\Psi) = \frac{1}{d_{\Pi}} \operatorname{tr}(\mathscr{P}_{\Pi}\omega^{\infty}(\Psi)) = \operatorname{tr}\int_{\widetilde{\mathsf{G}}'} \Psi(\widetilde{g}') \mathscr{P}_{\Pi}\omega^{\infty}(\widetilde{g}')d\widetilde{g}' = \operatorname{tr}\int_{\widetilde{\mathsf{G}}'} \left(\int_{\widetilde{\mathsf{G}}} \overline{\Theta_{\Pi}(\widetilde{g})}\omega^{\infty}(\widetilde{g}\widetilde{g}')d\widetilde{g}\right) \Psi(\widetilde{g}')d\widetilde{g}'.$$

Using that  $\Theta$  is the character of  $\omega$ , we get formally:

$$\Theta_{\Pi'}(\widetilde{g}) = \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{g}\widetilde{g'}) d\widetilde{g} \qquad (\widetilde{g'} \in \widetilde{G}').$$

Because the character  $\Theta$  is not continuous, the second member of the previous equation could not make sense. To avoid this problem, we use the Oscillator semigroup introduced by R. Howe (see [2]).

# 3. Howe's Oscillator semigroup

Let  $(W, \langle \cdot, \cdot \rangle)$  be a (finite dimensional) real symplectic vector space and  $(W_{\mathbb{C}}, \langle \cdot, \cdot \rangle)$  its complexification. For every  $w \in W_{\mathbb{C}}$ , we consider the decomposition  $w = a + ib, a, b \in W$  and we denote by  $\overline{w} = a - ib$  the conjugate with respect to the decomposition  $W_{\mathbb{C}} = W \oplus iW$ . By extension, we get a symplectic form  $\langle \cdot, \cdot \rangle$  on  $W_{\mathbb{C}}$ .

**Lemma 3.1.** The form  $H: W_{\mathbb{C}} \times W_{\mathbb{C}} \to \mathbb{C}$  defined by

(3) 
$$H(w, w') = i \langle w, \overline{w'} \rangle$$

is hermitian.

Proof. Straightforward verification.

We define now the subset  $\operatorname{Sp}(W_{\mathbb{C}})^{++}$  of  $\operatorname{Sp}(W_{\mathbb{C}})$  by:

(4) 
$$\operatorname{Sp}(W_{\mathbb{C}})^{++} = \{g \in \operatorname{Sp}(W_{\mathbb{C}}); \operatorname{H}(w, w) > \operatorname{H}(g(w), g(w)), (\forall w \in W_{\mathbb{C}} \setminus \{0\})\}$$

Similarly, we denote by  $\mathfrak{sp}(W_{\mathbb{C}})^{++}$  the subset of  $\operatorname{End}(W_{\mathbb{C}})$  given by:

$$\mathfrak{sp}(W_{\mathbb{C}})^{++} = \{ z = x + iy ; x, y \in \mathfrak{sp}(W), \det(z-1) \neq 0, \langle yw, w \rangle > 0, w \in W \setminus \{0\} \}$$

**Lemma 3.2.** Fix an element z = x + iy with  $x, y \in \mathfrak{sp}(W)$  such that  $det(z - 1) \neq 0$ . Then,

$$H(w, w) > H(c(z)w, c(z)w) \qquad (\forall w \in W_{\mathbb{C}} \setminus \{0\})$$

if and only if

$$\langle yw, w \rangle > 0 \qquad (\forall w \in W \setminus \{0\}).$$

*Finally, we obtain*  $c(\mathfrak{sp}(W_{\mathbb{C}})^{++}) = \operatorname{Sp}(W_{\mathbb{C}})^{++}$ .

*Proof.* Fix z = x + iy, with  $x, y \in \mathfrak{sp}(W)$ . We have  $H(c(z)w, c(z)w) = H(\overline{c(z)}^{-1}c(z)w, w)$  and then  $H(w, w) > H(c(z)w, c(z)w) \Leftrightarrow H((1 - \overline{c(z)}^{-1}c(z))w, w) > 0$ . Or,

$$1 - \overline{c(z)}^{-1}c(z)) = 1 - \left((\overline{z}+1)(\overline{z}-1)^{-1}\right)^{-1}(z+1)(z-1)^{-1} = 1 - (\overline{z}-1)(\overline{z}+1)^{-1}(z+1)(z-1)^{-1}$$
  
=  $1 - (\overline{z}+1)^{-1}(\overline{z}-1)(z+1)(z-1)^{-1}$   
=  $(\overline{z}+1)^{-1}(\overline{z}+1)(z-1)(z-1)^{-1} - (\overline{z}+1)^{-1}(\overline{z}-1)(z+1)(z-1)^{-1}$   
=  $(\overline{z}+1)^{-1}((\overline{z}+1)(z-1) - (\overline{z}-1)(z+1))(z-1)^{-1}$ 

By definition of z, we get  $(\bar{z}+1)(z-1) - (\bar{z}-1)(z+1) = 4iy$ . So,  $1 - \overline{c(z)}^{-1}c(z) = 4i(\bar{z}+1)^{-1}y(z-1)^{-1}$ . Then, for all  $w \in W_{\mathbb{C}} \setminus \{0\}$ , we get:

$$\begin{split} \mathrm{H}(w,w) > \mathrm{H}(c(z)w,c(z)w) & \Leftrightarrow \quad \mathrm{H}((1-\overline{c(z)}^{-1}c(z))w,w) > 0 \Leftrightarrow 4i\,\mathrm{H}((\bar{z}+1)^{-1}y(z-1)^{-1}w,w) > 0 \\ & \Leftrightarrow \quad -4\langle(\bar{z}+1)^{-1}y(z-1)^{-1}w,\overline{w}\rangle > 0 \Leftrightarrow -4\langle y(z-1)^{-1}w,(-\bar{z}+1)^{-1}\overline{w}\rangle > 0 \\ & \Leftrightarrow \quad 4\langle yw',\overline{w'}\rangle > 0 \end{split}$$

with  $w' = (z-1)^{-1}w$ . Because  $\langle yw', \overline{w'} \rangle \in \mathbb{R}^*_+$ , by writing w' as  $w' = w'_1 + iw'_2$ , we get:

$$\langle yw', \overline{w}' \rangle = \langle y(w_1'), w_1' \rangle + \langle y(w_2'), w_2' \rangle.$$

**Proposition 3.3.** The set  $\text{Sp}(W_{\mathbb{C}})^{++}$  is a subsemigroup of  $\text{Sp}(W_{\mathbb{C}})$ , which does not contain the identity but stable under  $g \to \overline{g}^{-1}$ . Moreover, we have

(5) 
$$\operatorname{Sp}(W_{\mathbb{C}})^{++}.\operatorname{Sp}(W) = \operatorname{Sp}(W).\operatorname{Sp}(W_{\mathbb{C}})^{++} \subseteq \operatorname{Sp}(W_{\mathbb{C}})^{++}$$

and the set  $\operatorname{Sp}(W_{\mathbb{C}})^{++} \cup \operatorname{Sp}(W)$  is a subsemigroup of  $\operatorname{Sp}(W_{\mathbb{C}})$ . To conclude, the symplectic group  $\operatorname{Sp}(W)$  is contained in the closure of  $\operatorname{Sp}(W_{\mathbb{C}})^{++}$ .

*Proof.* Fix g and g' in  $\text{Sp}(W_{\mathbb{C}})^{++}$ . Obviously,  $gg' \in \text{Sp}(W_{\mathbb{C}})$ . For every  $w \in W_{\mathbb{C}}$ , we have:

$$\mathrm{H}(gg'w, gg'w) < \mathrm{H}(g'w, g'w) < H(w, w),$$

which imply that  $gg' \in \operatorname{Sp}(W_{\mathbb{C}})^{++}$ . The subspace  $\operatorname{sp}(W_{\mathbb{C}})^{++}$  is stable under the map  $z \to -\overline{z}$  and  $\overline{c(z)}^{-1} = c(-\overline{z})$ . Then, if  $g \in \operatorname{Sp}(W_{\mathbb{C}})^{++}$ , we get  $\overline{g}^{-1} \in \operatorname{Sp}(W_{\mathbb{C}})^{++}$ .

Now, fix  $g \in \text{Sp}(W_{\mathbb{C}})^{++}$  and  $h \in \text{Sp}(W)$ . For all  $w \in W_{\mathbb{C}}$ , we have  $\overline{h(w)} = h(\overline{w})$  and then:

$$H(gh(w), \overline{gh(w)}) < H(h(w), \overline{h(w)}) = i\langle h(w), \overline{h(w)} \rangle = i\langle h(w), h(\overline{w}) \rangle = H(w, w).$$

In particular,  $gh \in \text{Sp}(W_{\mathbb{C}})^{++}$ . Finally, for every element  $g \in \text{Sp}(W)$ ,

$$g = -c(0)g = \lim_{\substack{y \to 0 \\ \langle y, \cdot \rangle > 0}} -c(iy)g$$

which prove that every elements of Sp(W) is a limit of elements in the semigroup  $Sp(W_{\mathbb{C}})^{++}$ .

*Remark* 3.4. Let z = X + iY with  $z \in \mathfrak{sp}(W_{\mathbb{C}})^{++}$ . Then, for all  $w \in W$ ,  $\chi_{z}(w) = e^{\frac{i\pi}{2}w^{t}J(X+iY)w} = e^{\frac{i\pi}{2}w^{t}JXw}e^{-\frac{\pi}{2}w^{t}JYw}.$ 

The matrix  $Y \in \mathfrak{sp}(W)$ , the form  $\langle Y, \cdot \rangle$  is positive and *JY* is symmetric and positive definite. Then, there exists a diagonal matrix  $D = \operatorname{diag}(d_1, \ldots, d_{2n})$  and a matrix  $O \in O(2n, \mathbb{R})$  such that  $JY = O^t DO$ . So,

$$\int_{W} \chi_{iY}(w) dw = \int_{W} e^{-\frac{\pi}{2} w^{t} JY_{W}} dw = \int_{W} e^{-\frac{\pi}{2} w^{t} O^{t} DOw} dw = \int_{W} e^{-\frac{\pi}{2} Y^{t} DY} |\det(O)| dY$$
$$= \int_{W} e^{-\frac{\pi}{2} \sum_{k=1}^{2n} d_{k} Y_{k}^{2}} |\det(O)| dY = \prod_{k=1}^{2n} \int_{\mathbb{R}} e^{-\frac{\pi}{2} d_{k} Y_{k}^{2}} dY_{k} = \prod_{k=1}^{2n} \frac{1}{\sqrt{d_{k}}} = \det^{-\frac{1}{2}}(D)$$

Using that  $|\chi_{X+iY}(w)| = e^{-\frac{\pi}{2}w^t JYw}$ , we get that the integral

$$\int_W \chi_{X+iY}(w) dw$$

is absolutely convergent. More precisely, we get:

$$\int_W \chi_{X+iY}(w) dw = \det^{-\frac{1}{2}} \left( \frac{1}{2} (X+iY) \right).$$

From now on, we denote by  $\Lambda(X + iY)$  the previous determinant, i.e.

(6) 
$$\Lambda(X+iY) = \det^{-\frac{1}{2}}\left(\frac{1}{2}(X+iY)\right)$$

Even if the complex symplectic group  $\operatorname{Sp}(W_{\mathbb{C}})$  is simply connected, the complex manifold  $\operatorname{Sp}(W_{\mathbb{C}})^{++}$  is not simply connected. We define on  $\operatorname{Sp}(W_{\mathbb{C}})^{++}$  a non-trivial cover, denoted by  $\operatorname{Sp}(W_{\mathbb{C}})^{++}$ , by

$$\widetilde{\operatorname{Sp}(W_{\mathbb{C}})}^{++} = \{(g,\xi); g \in \operatorname{Sp}(W_{\mathbb{C}})^{++}, \xi^2 = \det(i(g-1))^{-1}\},\$$

and let  $C : \operatorname{Sp}(W_{\mathbb{C}})^{++} \times \operatorname{Sp}(W_{\mathbb{C}})^{++} \to \mathbb{C}$  defined by:

 $\sim \sim \sim \sim$ 

$$C(g_1, g_2) = \det^{-\frac{1}{2}} \left( \frac{1}{2i} (c(g_1) + c(g_2)) \right).$$

**Theorem 3.5.** The function  $\Theta$  :  $\widetilde{Sp(W_{\mathbb{C}})}^{++} \ni (g,\xi) \to \xi \in \mathbb{C}$  is holomorphic, and we have the following equality:

(7) 
$$\frac{\Theta(g_1g_2)}{\Theta(\widetilde{g_1})\Theta(\widetilde{g_2})} = C(g_1, g_2) \qquad \left(\widetilde{g_1}, \widetilde{g_2} \in \widetilde{\mathrm{Sp}(W_{\mathbb{C}})}^{++} \cup \widetilde{\mathrm{Sp}(W)}\right).$$

Moreover, for every functions  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{\operatorname{Sp}(W)})$ , we get:

(8) 
$$\int_{\widetilde{Sp(W)}} \Theta(\widetilde{g}) \Psi(\widetilde{g}) d\mu_{\widetilde{Sp(W)}}(\widetilde{g}) = \lim_{\substack{\widetilde{p} \to 1\\ \widetilde{p} \in Sp(W_{\mathbb{C}})^{++}}} \int_{\widetilde{Sp(W)}} \Theta(\widetilde{pg}) \Psi(\widetilde{g}) d\mu_{\widetilde{Sp(W)}}(\widetilde{g}).$$

*Proof.* We assume that the support of  $\Psi$  is contained in the image of  $\tilde{c}(0)\tilde{c}$ . Then,

$$\int_{\widetilde{Sp(W)}} \Theta(\widetilde{pg}) \Psi(\widetilde{g}) d\widetilde{g} = \int_{\widetilde{Sp(W)}} \Theta(\widetilde{pc}(0)\widetilde{g}) \Psi(\widetilde{c}(0)\widetilde{g}) d\widetilde{g} = \int_{\operatorname{supp}} \Psi \Theta(\widetilde{pc}(0)\widetilde{g}) \Psi(\widetilde{c}(0)\widetilde{g}) d\widetilde{g}$$
$$= \int_{\mathfrak{sp}(W)} \Theta(\widetilde{pc}(0)\widetilde{c}(x)) \Psi(\widetilde{c}(0)\widetilde{c}(x)) j(x) dx = \int_{\mathfrak{sp}(W)} \Theta(\widetilde{c}(iy)\widetilde{c}(x)) \Psi(\widetilde{c}(0)\widetilde{c}(x)) j(x) dx$$

where  $\widetilde{pc}(0) = \widetilde{c}(iy)$  with  $y \in \mathfrak{sp}(W)$  and  $\langle y, \cdot \rangle > 0$ . In particular,  $y \to 0$  when  $\widetilde{p} \to 1$ . But, according to equation (6)

$$\Theta(\widetilde{c}(iy)\widetilde{c}(x)) = \Theta(\widetilde{c}(iy))\Theta(\widetilde{c}(x))\Lambda(x+iy).$$

We denote by  $\psi$  the function of  $\mathfrak{sp}(W)$  given by  $\psi(x) = \Theta(\widetilde{c}(x))\Psi(\widetilde{c}(x))j(x)$  (we notice easily that  $\psi \in \mathscr{C}^{\infty}_{c}(\mathfrak{sp}(W))$ ). We get:

$$\int_{\mathfrak{sp}(W)} \Lambda(x+iy)\psi(x)dx = \int_{\mathfrak{sp}(W)} \int_{W} \chi_{x+iy}(w)\psi(x)dwdx = \int_{W} \int_{\mathfrak{sp}(W)} \chi_{x}(w)\chi_{iy}(w)\psi(x)dxdw$$
$$= \int_{W} \chi_{iy}(w) \int_{\mathfrak{sp}(W)} \chi_{x}(w)\psi(x)dxdw$$

and then

$$\int_{\mathfrak{sp}(W)} \chi_x(w) \psi(x) dx = \int_{\mathfrak{sp}(W)} \psi(x) e^{2i\pi\tau(w)(x)} dx = \widehat{\psi}\left(\frac{1}{4}\tau(w)\right),$$

where  $\tau: W \to \mathfrak{sp}(W)^*$  is the moment map and  $\widehat{\psi}$  is the Fourier transform of  $\psi$  on  $\mathfrak{sp}(W)$ . Then,

$$\int_{\mathfrak{sp}(W)} \Lambda(x+iy)\psi(x)dx = \int_{W} \chi_{iy}(w)\widehat{\psi}\left(\frac{1}{4}\tau(w)\right)dw.$$

For all  $w \in W \setminus \{0\}$ , we have

$$\chi_{iy}(w) = e^{\frac{2i\pi}{4}\langle iy(w),w\rangle} = e^{-\frac{\pi}{2}\langle yw,w\rangle} < 1,$$

because  $\langle yw, w \rangle > 0$  for every non zero  $w \in W$ . Finally, we get:

$$\lim_{y \to 0} \int_{\mathfrak{sp}(W)} \Lambda(x + iy) \psi(x) dx = \int_{W} \widehat{\psi}\left(\frac{1}{4}\tau(w)\right) dw$$

Using that  $\lim_{y\to 0} \Theta(\widetilde{c}(iy)) = \Theta(\widetilde{c}(0))$ , we get:

$$\lim_{y\to 0}\int_{\mathfrak{sp}(W)}\Theta(\widetilde{c}(iy))\Lambda(x+iy)\psi(x)dx=\int_W\widehat{\psi}\left(\frac{1}{4}\tau(w)\right)dw.$$

Finally, we proved that the limit we considered in Equation (8) exists. Now, we determine this limit. For every  $x \in \mathfrak{sp}(W)$ , we denote by *B* the matrix of the bilinear form  $\langle x \cdot, \cdot \rangle$ . We remark that the matrix of the form  $\langle J \cdot, \cdot \rangle$  is the identity matrix. For all t > 0, we have:

$$\Lambda(x+itJ) = \int_{W} \chi_{x+itJ}(w) dw = \int_{W} e^{\frac{i\pi}{2} \langle (x+itJ)w,w \rangle} dw = \int_{W} e^{\frac{i\pi}{2} \langle (x+itJ)w,w \rangle} dw$$

$$= \int_{W} e^{\frac{i\pi}{2}w^{t}(B+itI)w} dw = \int_{W} e^{-\frac{\pi}{2}w^{t}(-iB+tI)w} dw = \det^{-\frac{1}{2}}\left(\frac{1}{2}(-iB+tI)\right)$$

We know that the eigenvalues of x are real numbers. So, for all t > 0,

$$|\det(-iB + tI)| > |\det(iB)|$$

i.e.

$$|\det(-iB + tI)|^{-\frac{1}{2}} < |\det(iB)|^{-\frac{1}{2}}$$

Then,

 $|\Lambda(x + itJ)| \le |\Lambda(x)|.$ 

Using that the function  $\Lambda$  is locally integrable, we get:

$$\lim_{t \to 0^+} \int_{\mathfrak{sp}(W)} \Lambda(x + itJ)\psi(x)dx = \int_{\mathfrak{sp}(W)} \Lambda(x)\psi(x)dx.$$

*Remark* 3.6. We first extend the map *T* on the semigroup. For every element  $g \in \text{Sp}(W_{\mathbb{C}})^{++}$ , we have  $\det(g-1)$ . We define the map  $T : \text{Sp}(\widetilde{W_{\mathbb{C}}})^{++} \to S^*(W)$  by

$$T(\widetilde{g} = (g,\xi)) = \Theta(\widetilde{g})\chi_{c(g)}\mu_W.$$

We denote by  $Cont(L^2(X))$  the semigroup of contractions on the Hilbert space  $L^2(X)$ . One can prove that:

$$\omega = \operatorname{Op} \circ \mathscr{K} \circ T : \operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++} \to \operatorname{Cont}(\operatorname{L}^{2}(X))$$

is a semigroup homomorphism. Moreover, for all  $\widetilde{p} \in \operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++}$ , the operator  $\omega(\widetilde{p})$  is of trace class and

$$\operatorname{tr} \omega(\widetilde{p}) = \Theta(\widetilde{p}).$$

### 4. A general formula for $\Theta_{\Pi'}$

Let us start this section with comments concerning some particular integrals. As shown in [5, Section 4.8], for all  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{\operatorname{Sp}(W)})$ ,

(9) 
$$\int_{\widetilde{Sp(W)}} \Psi(\widetilde{g}) T(\widetilde{g}) d\widetilde{g}$$

is in S(*W*). Brieffly, for  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{\operatorname{Sp}(W)})$  such that  $\operatorname{supp}(\Psi) \subseteq \operatorname{Im}(\widetilde{c})$  and  $\phi \in \operatorname{S}(W)$ , we have:

$$\left( \int_{\widetilde{\operatorname{Sp}(W)}} \Psi(\widetilde{g}) T(\widetilde{g}) d\widetilde{g} \right)(\phi) = \int_{W} \int_{\operatorname{sp}(W)} \Psi(\widetilde{c}(X)) \Theta(\widetilde{c}(X)) \phi(w) j_{\operatorname{sp}}(X) \chi\left(\frac{1}{4} \langle Xw, w \rangle\right) dX dw$$

$$= \int_{W} \left( \int_{\operatorname{sp}(W)} \varphi(X) \chi\left(\frac{1}{4} \langle Xw, w \rangle\right) dX \right) \phi(w) dw = \int_{W} \widehat{\varphi} \circ \tau_{\operatorname{sp}}(w) \phi(w) dw$$

where  $\varphi(X) = \Psi(\widetilde{c}(X))\Theta(\widetilde{c}(X))j_{\mathfrak{sp}}(X) \in \mathscr{C}^{\infty}_{c}(\mathfrak{sp}(W))$ . Then,  $\widehat{\phi} \in \mathcal{S}(\mathfrak{sp}(W))$  and  $\lambda(w) = \widehat{\phi} \circ \tau_{\mathfrak{sp}}(w) \in \mathcal{S}(W)$ .

Similarly, for all  $\widetilde{p} \in \operatorname{Sp}(\widetilde{W_{\mathbb{C}}})^{++}$  and  $\Psi \in \mathscr{C}_{c}^{\infty}(\widetilde{\operatorname{Sp}(W)})$ , one can prove that there exists  $\lambda_{\widetilde{p}} \in \operatorname{S}(W)$  such that for every  $\phi \in \operatorname{S}(W)$ , we have:

(10) 
$$\left(\int_{\widetilde{\operatorname{Sp}(W)}} \Psi(\widetilde{g}) T(\widetilde{pg}) d\widetilde{g}\right)(\phi) = \int_{W} \lambda_{\widetilde{p}}(w) \phi(w) dw$$

The link between the functions  $\lambda_{\tilde{p}}$  and  $\lambda$  is given by the following equality:

(11) 
$$\lambda_{\widetilde{p}}(w) = T(\widetilde{p}) \natural \lambda(w) \qquad (w \in W).$$

**Lemma 4.1.** For all  $\widetilde{g} \in \widetilde{\operatorname{Sp}(W)}^c$  and  $\widetilde{h} \in \operatorname{Sp}(W_{\mathbb{C}})^{++}$ , we get:

$$C(g,h)\chi_{c(gh)}(w) = \int_{W} \chi_{c(g)}(u)\chi_{c(h)}(w-u)\chi\left(\frac{1}{2}\langle u,w\rangle\right)du \qquad (\forall w \in W).$$

*Proof.* We have  $T(\widetilde{gh}) = T(\widetilde{g}) \natural T(\widetilde{h})$ , i.e.  $T(\widetilde{gh}) \natural \phi = T(\widetilde{g}) \natural T(\widetilde{h}) \natural \phi$  for all  $\phi \in S(W)$ . For all  $w \in W$ , we have:

$$T(\widetilde{g}\widetilde{h}) \natural \phi(w) = \int_{W} \Theta(\widetilde{g}\widetilde{h}) \chi_{c(gh)}(u) \phi(w-u) \chi\left(\frac{1}{2}\langle u, w \rangle\right) du$$
  
$$= \Theta(\widetilde{g}) \Theta(\widetilde{h}) C(g,h) \int_{W} \chi_{c(gh)}(u) \phi(w-u) \chi\left(\frac{1}{2}\langle u, w \rangle\right) du$$
  
$$= -\Theta(\widetilde{g}) \Theta(\widetilde{h}) C(g,h) \int_{W} \chi_{c(gh)}(w-v) \chi\left(-\frac{1}{2}\langle v, w \rangle\right) dv$$

and

$$(T(\tilde{g})\natural T(\tilde{h}))\natural \phi(w) = T(\tilde{g})\natural (T(\tilde{h})\natural \phi)(w) = \int_{W} \Theta(\tilde{g})\chi_{c(g)}(u)T(\tilde{h})\natural \phi(w-u)\chi\left(\frac{1}{2}\langle u,w\rangle\right) du$$

$$= \int_{W} \Theta(\tilde{g})\chi_{c(g)}(u)\left(\int_{W} \Theta(\tilde{h})\chi_{c(h)}(v)\phi(w-u-v)\chi\left(\frac{1}{2}\langle v,w-u\rangle\right) dv\right)\chi\left(\frac{1}{2}\langle u,w\rangle\right) du$$

$$= \int_{W} \Theta(\tilde{g})\chi_{c(g)}(u)\left(\int_{W} \Theta(\tilde{h})\chi_{c(h)}(w-u-z)\phi(z)\chi\left(-\frac{1}{2}\langle z,w-u\rangle\right) dz\right)\chi\left(\frac{1}{2}\langle u,w\rangle\right) du$$

$$= \Theta(\tilde{g})\Theta(\tilde{h})\int_{W} \phi(z)\left(\int_{W}\chi_{c(g)}(u)\chi_{c(h)}(w-u-z)\chi\left(-\frac{1}{2}\langle z,w-u\rangle\right)\chi\left(\frac{1}{2}\langle u,w\rangle\right) du\right) dz$$

$$= C(g,h)\chi_{c(gh)}(w-v)\chi\left(-\frac{1}{2}\langle v,w\rangle\right)$$

Then, for all  $v, w \in W$ , we get:

$$C(g,h)\chi_{c(gh)}(w-v)\chi\left(-\frac{1}{2}\langle v,w\rangle\right) = \int_{W}\chi_{c(g)}(u)\chi_{c(h)}(w-u-v)\chi\left(-\frac{1}{2}\langle v,w-u\rangle\right)\chi\left(\frac{1}{2}\langle u,w\rangle\right)du.$$

We get the result by taking v = 0.

**Proposition 4.2.** For every  $\widetilde{p} \in \widetilde{Sp(W_{\mathbb{C}})}^{++}$  and  $\Psi, \Phi \in \mathscr{C}^{\infty}_{c}(\widetilde{Sp(W)})$ , we get that:

$$\int_{\widetilde{\operatorname{Sp}(W)}} \Psi(\widetilde{g}) \int_{\widetilde{\operatorname{Sp}(W)}} \Phi(\widetilde{h}) T(\widetilde{g}\widetilde{h}\widetilde{p}) d\widetilde{h} d\widetilde{g}$$

is a Schwartz function  $\phi_{\overline{p}}$  given by:

$$\phi_{\widetilde{p}}(w) = \int_{\widetilde{\operatorname{Sp}(W)}} \Psi(\widetilde{g}) \int_{\widetilde{\operatorname{Sp}(W)}} \Phi(\widetilde{h}) \Theta(\widetilde{g}\widetilde{h}\widetilde{p}) \chi_{c(ghp)}(w) d\widetilde{h} d\widetilde{g}.$$

*Proof.* For all  $\phi \in S(W)$ , we have:

$$\begin{split} & \left(\int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \int_{S\widetilde{p}(W)} \Phi(\widetilde{h}) T(\widetilde{g}\widetilde{h}\widetilde{p}) d\widetilde{h} d\widetilde{g}\right)(\phi) = \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \int_{S\widetilde{p}(W)} \Phi(\widetilde{h}) T(\widetilde{g}\widetilde{h}\widetilde{p}) \natural \phi(0) d\widetilde{h} d\widetilde{g} \\ &= \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) T(\widetilde{g}) \natural \left(\int_{S\widetilde{p}(W)} \Phi(\widetilde{h}) T(\widetilde{h}\widetilde{p}) \natural \phi d\widetilde{h}\right)(0) d\widetilde{g} \\ &= \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \int_{W} \Theta(\widetilde{g}) \chi_{c(g)}(w) \left(\int_{S\widetilde{p}(W)} \Phi(\widetilde{h}) T(\widetilde{h}\widetilde{p}) \natural \phi d\widetilde{h}\right)(-w) dw d\widetilde{g} \\ &= \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \int_{W} \Theta(\widetilde{g}) \chi_{c(g)}(w) \int_{S\widetilde{p}(W)} \Phi(\widetilde{h}) \left(\int_{W} \Theta(\widetilde{h}\widetilde{p}) \chi_{c(hp)}(u) \phi(-w-u) \chi\left(-\frac{1}{2}\langle u,w\rangle\right) du\right) d\widetilde{h} dw d\widetilde{g} \\ &= \int_{W} \phi(v) \left(\int_{S\widetilde{p}(W)} \int_{S\widetilde{p}(W)} \int_{W} \Psi(\widetilde{g}) \Phi(\widetilde{h}) \Theta(\widetilde{g}) \Theta(\widetilde{h}\widetilde{p}) \chi_{c(g)}(u-v) \chi_{c(hp)}(u) \chi\left(\frac{1}{2}\langle u,w\rangle\right) du d\widetilde{h} d\widetilde{g}\right) dv \\ &= \int_{W} \phi(v) \left(\int_{S\widetilde{p}(W)} \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \Phi(\widetilde{h}) \Theta(\widetilde{g}) \Theta(\widetilde{h}\widetilde{p}) C(g,hp) \chi_{chp}(v) d\widetilde{h} d\widetilde{g}\right) dv \\ &= \int_{W} \phi(v) \left(\int_{S\widetilde{p}(W)} \int_{S\widetilde{p}(W)} \Psi(\widetilde{g}) \Phi(\widetilde{h}) \Theta(\widetilde{g}\widetilde{h}\widetilde{p}) \chi_{c(ghp)}(v) d\widetilde{g} d\widetilde{h}\right) dv \end{split}$$

(where the last equality is obtained using Lemma (4.1)).

Now, we are able to prove state and prove the following theorem.

**Theorem 4.3.** For every function  $\Psi \in \mathscr{C}^{\infty}_{c}(\widetilde{G}')$ , we get:

$$\Theta_{\Pi'}(\Psi) = \lim_{\substack{\widetilde{p} \to 1\\ \widetilde{p} \in \mathrm{Sp}(W_{\mathbb{C}})^{++}}} \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{g}\widetilde{g}'\widetilde{p}) \Psi(\widetilde{g}') d\widetilde{g} d\widetilde{g}'.$$

Then, as a distributions on  $\widetilde{G}^{\prime},$  we have:

(12) 
$$\Theta_{\Pi'}(\widetilde{g}') = \lim_{\substack{\widetilde{p} \to 1\\ \widetilde{p} \in S\widetilde{p}(W_{\mathbb{C}})^{++}}} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{gg}'\widetilde{p}) d\widetilde{g}.$$

*Proof.* According to Proposition 4.2, there exists a function  $\lambda_{\tilde{p}} \in S(W)$  such that

$$\left(\int_{\widetilde{G}'}\int_{\widetilde{G}}\overline{\Theta_{\Pi}(\widetilde{g})}T(\widetilde{g}\widetilde{g'}\widetilde{p})\Psi(\widetilde{g'})d\widetilde{g}d\widetilde{g'}\right)(\phi) = \int_{W}\lambda_{\widetilde{p}}(w)\phi(w)dw \qquad (\phi \in \mathcal{S}(W)).$$

Similarly, there exists  $\lambda \in S(W)$  such that

$$\left(\int_{\widetilde{G}'}\int_{\widetilde{G}}\overline{\Theta_{\Pi}(\widetilde{g})}T(\widetilde{gg'})\Psi(\widetilde{g'})d\widetilde{g}d\widetilde{g'}\right)(\phi) = \int_{W}\lambda(w)\phi(w)dw \qquad (\phi \in \mathcal{S}(W)).$$

Using Equation (11), for all  $w \in W$ , we have  $\lambda_{\tilde{p}}(w) = T(\tilde{p}) \natural \lambda(w)$ .

We have that  $\delta_0 = T(\widetilde{1}) = \lim_{\substack{\widetilde{p} \to 1 \\ \widetilde{p} \in Sp(\widetilde{W}_{\mathbb{C}})^{++}}} T(\widetilde{p})$ , and then, using [5, Section 4.5],  $\lim_{\substack{\widetilde{p} \to 1 \\ \widetilde{p} \in Sp(\widetilde{W}_{\mathbb{C}})^{++}}} \lambda_{\widetilde{p}}(0) = \lim_{\substack{\widetilde{p} \to 1 \\ \widetilde{p} \in Sp(\widetilde{W}_{\mathbb{C}})^{++}}} T(\widetilde{p}) \natural \lambda(0) = \delta_0 \natural \lambda(0) = \lambda(0).$ 

Then, using [3, Theorem 3.5.4], we get:

$$\begin{split} \Theta_{\Pi'}(\Psi) &= \operatorname{tr} \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Psi(\widetilde{g}') \omega(\widetilde{gg'}) d\widetilde{g} d\widetilde{g}' \\ &= \operatorname{tr} \operatorname{Op} \circ \mathscr{K} \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Psi(\widetilde{g}') T(\widetilde{gg'}) d\widetilde{g} d\widetilde{g}' \\ &= \left( \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Psi(\widetilde{g}') T(\widetilde{gg'}) d\widetilde{g} d\widetilde{g}' \right) (0) = \lambda(0) \\ &= \lim_{\widetilde{p} \to 1 \atop \widetilde{p} \in \operatorname{Sp}(W_{\mathbb{C}})^{++}} \lambda_{\widetilde{p}}(0) = \lim_{\widetilde{p} \to 1 \atop \widetilde{p} \in \operatorname{Sp}(W_{\mathbb{C}})^{++}} \int_{\widetilde{G}'} \int_{\widetilde{G}} \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{gg'}\widetilde{p}) \Psi(\widetilde{g}') d\widetilde{g} d\widetilde{g}'. \end{split}$$

From now on, we assume that G is connected. For every  $\widetilde{p} \in \widetilde{Sp(W_{\mathbb{C}})}^{++}$  and  $\widetilde{g}' \in \widetilde{G}'$ , we define the function  $F_{\widetilde{p},\widetilde{g}'}: \widetilde{G} \to \mathbb{C}$  by:

$$F_{\widetilde{p},\widetilde{g}'}(\widetilde{g}) = \overline{\Theta_{\Pi}(\widetilde{g})} \Theta(\widetilde{g}\widetilde{g}'\widetilde{p}).$$

We easily prove that for every element  $g \in G$ , we have:

$$F_{\widetilde{p},\widetilde{g}'}((g,\xi)) = F_{\widetilde{p},\widetilde{g}'}((g,-\xi))$$

and by a standard result of differential geometry (see [16, Lemma A.4.2.11]), we get

$$\int_{\widetilde{G}} F_{\widetilde{p},\widetilde{g}'}(\widetilde{g}) d\widetilde{g} = 2 \int_{G} H_{\widetilde{p},\widetilde{g}'}(g) dg,$$

where dg is the normalized Haar measure on G and  $H_{\widetilde{p},\widetilde{g}'}: G \to \mathbb{C}$  is the function defined by:

$$H_{\widetilde{p},\widetilde{g}'}(\mathrm{pr}(\widetilde{g})) = F_{\widetilde{p},\widetilde{g}'}(\widetilde{g}) \qquad (\widetilde{g} \in \widetilde{\mathrm{G}}).$$

From now on, we assume that G is connected. By Weyl's integration formula (see [22, Theorem 8.60]), we get:

$$\int_{\mathcal{G}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(g) dg = \int_{\mathcal{T}} \left( \int_{\mathcal{G}/\mathcal{T}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(gtg^{-1}) dg \, \mathcal{T} \right) |D(t)|^2 dt$$

where *D* is the Weyl denominator. We define  $G'^{++} = G'_{\mathbb{C}} \cap \operatorname{Sp}(W_{\mathbb{C}})^{++}$  and denote by  $\widetilde{G'}^{++}$  the preimage in  $\operatorname{Sp}(\widetilde{W}_{\mathbb{C}})^{++}$ . For every element  $\widetilde{p} \in \widetilde{G'}^{++}$ , we prove easily that the function  $\operatorname{H}_{\widetilde{p},\widetilde{g'}}$  in invariant by conjugation. In particular, we get:

$$\int_{\mathcal{T}} \left( \int_{\mathcal{G}/\mathcal{T}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(gtg^{-1})dg \mathcal{T} \right) |D(t)|^2 dt = \int_{\mathcal{T}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(t) |D(t)|^2 dt$$

Using Theorem 4.3, we get:

**Lemma 4.4.** For every regular element  $\tilde{g}' \in \tilde{G}'$ , the character  $\Theta_{\Pi'}$  of  $\Pi'$  is given by the following formula:

(13) 
$$\Theta_{\Pi'}(\widetilde{g}') = \lim_{\substack{\widetilde{p} \to 1 \\ \widetilde{p} \in \widetilde{G}'^{t+1}}} \int_{\mathcal{T}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(t) |\Delta(t)|^2 dt.$$

Using an article of M. Kashiwara and M. Vergne [17], we obtain the weights of the representations  $\Pi \in \widehat{\widetilde{G}}_{\omega}$ . Then, using the Weyl character formula (Equation (1)), we get a formula for the character  $\Theta_{\Pi}$ . What we need now, is an explicit realisation of the character  $\Theta$  of the metaplectic representation.

#### 5. A restriction of $\Theta$ to a maximal compact subgroup

We recall here the main ideas of [8, Section 2]. Here we want an explicit formula for the character  $\Theta$  of the metaplectic representation on a maximal compact subgroup of Sp(*W*). We know that for any positive complex structure *J* on *W*, the subgroup Sp(*W*)<sup>*J*</sup> of symplectic matrices which commute with *J* is a maximal compact subgroup of Sp(*W*). More precisely, for every compact dual pair (G, G') (with G compact), there exists a complex structure *J* of Sp(*W*) such that G . T'  $\subseteq$  Sp(*W*)<sup>*J*</sup>, where T' is the maximal compact Cartan subgroup of G' (we will construct this element *J* explicitly for the dual pair (U(*n*,  $\mathbb{C}$ ), U(*p*, *q*,  $\mathbb{C}$ )) in Section 6).

We fix a positive complex structure *J* on *W*, and we denote by  $W_{\mathbb{C}}$  the complexification of *W*. With respect to the endomorphism *J*, we get a decomposition of  $W_{\mathbb{C}}$  of the form

$$W_{\mathbb{C}} = W_{\mathbb{C}}^+ \oplus W_{\mathbb{C}}^-$$

where  $W_{\mathbb{C}}^+$  (resp.  $W_{\mathbb{C}}^-$ ) is the *i*-eigenspace (resp. -i-eigenspace) for *J*. One can prove easily that the restriction of the form H defined in Equation (3) to the space  $W_{\mathbb{C}}^+$  is positive definite. We denote by  $U = U(W_{\mathbb{C}}^+, H_{|w_{\mathbb{C}}})$  the subgroup of  $GL(W_{\mathbb{C}}^+)$  which preserve the form  $H_{|w_{\mathbb{C}}}$ . We define a two fold cover of U, denoted by  $\widetilde{U}$ , as

(14) 
$$\widetilde{\mathbf{U}} = \left\{ (u,\xi), \xi^2 = \det(u), u \in \mathbf{U} \right\} \subseteq \mathrm{GL}(W^+_{\mathbb{C}}) \times \mathbb{C}^*$$

Then,  $\widetilde{U}$  is a group (endowed with the pointwise multiplication). More precisely, it's a connected two-fold covering of U.

#### **Proposition 5.1.** *The map:*

$$\operatorname{Sp}(W)^J \ni g \to g|_{W^+_{\alpha}} \in \mathrm{U}$$

is a group isomorphism and lifts to an isomorphism

$$\widetilde{\operatorname{Sp}(W)}^{\prime} \ni (g,\xi) \to (u,\xi \operatorname{det}(g-1)_{|_{(g-1)W_{\alpha}^+}}) \in \widetilde{U}.$$

Then, the restriction of the metaplectic cover to  $Sp(W)^J$  is isomorphic to the covering

$$\widetilde{\mathbf{U}} \ni (u, \xi) \to u \in \mathbf{U}$$

*Proof.* The proof of this result can be found in [8, Proposition 1].

According to Equation (12), we need a formula for  $\Theta$  not only on  $\text{Sp}(W)^J$ , but on an analogue subset in the oscillator semigroup. Briefly, the map

$$(\operatorname{Sp}(W_{\mathbb{C}})^{++})^J \ni g \to g|_{W_{\mathbb{C}}^+} \in \operatorname{GL}(W_{\mathbb{C}}^+)$$

is well define and bijective. We now define a subgroup  $\operatorname{GL}(W^+_{\mathbb{C}})^{++}$  of  $\operatorname{GL}(W^+_{\mathbb{C}})$  as

$$\mathrm{GL}(W^+_{\mathbb{C}})^{++} = \left\{ h \in \mathrm{GL}(W^+_{\mathbb{C}}), \mathrm{H}_{|_{W_{\mathbb{C}}}}(w, w) > \mathrm{H}_{|_{W_{\mathbb{C}}}}(hw, hw), 0 \neq w \in W^+_{\mathbb{C}} \right\}$$

As in Equation (14), we define a non-trivial double cover of  $GL(W_{\mathbb{C}}^{+})^{++}$  by

$$\widetilde{\mathrm{GL}(W_{\mathbb{C}}^{+})}^{++} = \left\{ (h,\xi) \in \mathrm{GL}(W_{\mathbb{C}}^{+})^{++} \times \mathbb{C}^{*}, \xi^{2} = \det(h) \right\}.$$

The group structure on  $\widetilde{GL(W_{\mathbb{C}}^+)}^{++}$  is given by the coordinate-wise multiplication. More particularly, we get the following proposition.

**Proposition 5.2.** The set  $\widetilde{GL(W^+_{\mathbb{C}})}^{++} \cup \widetilde{U}$  is a semigroup. Moreover, the map

$$(\operatorname{Sp}(W_{\mathbb{C}})^{++})^{J} \cup \widetilde{\operatorname{Sp}(W)}^{J} \ni g \to g_{|_{W_{\mathbb{C}}^{+}}} \in \widetilde{\operatorname{GL}(W_{\mathbb{C}}^{+})}^{++} \cup \widetilde{\operatorname{U}}$$

is a semigroup isomorphism.

The following corollary gives us the character  $\Theta$  on the subsemigroup  $(\operatorname{Sp}(W_{\mathbb{C}})^{++})^{J} \cup \widetilde{\operatorname{Sp}(W)}^{J}$ .

**Corollary 5.3.** The restriction of the character  $\Theta$  on the subsemigroup  $(\widetilde{Sp(W_{\mathbb{C}}^+)}^{++})^J \cup \widetilde{Sp(W)}^J$  is given by

(15) 
$$\Theta(\widetilde{k}) = \lim_{\widetilde{h} \to \widetilde{k} \atop \widetilde{h} \in G\widetilde{L}(W_{\mathbb{C}}^{+})^{++}} \Theta(\widetilde{h}) = \lim_{\widetilde{h} \to \widetilde{k} \atop \widetilde{h} \in G\widetilde{L}(W_{\mathbb{C}}^{+})^{++}} \frac{\xi}{\det(1-h)} \qquad (\widetilde{h} = (h,\xi)).$$

6. The dual pair  $(G = U(n, \mathbb{C}), G' = U(p, q, \mathbb{C}))$ 

Let (V, b) be a *n*-dimensional vector space over  $\mathbb{C}$  endowed with a positive definite hermitian form *b* and  $\mathscr{B}$  be a basis of *V* such that  $Mat(b, \mathscr{B}) = Id_n$ . We denote by U(V, b) the group of isometries of *b*, i.e.

(16) 
$$U(V, b) = \{g \in GL(V), b(gu, gv) = b(u, v), (\forall u, v \in V)\}.$$

By writing the endomorphisms in the basis  $\mathscr{B}$ , we get that the right hand side of Equation (16) can be written as:

(17) 
$$\{g \in \operatorname{GL}(n, \mathbb{C}), g^*g = \operatorname{Id}_n\},\$$

where  $g^* = g^{-1^t}$ . We denote by  $G = U(n, \mathbb{C})$  the group defined in Equation (17), by  $g = u(n, \mathbb{C})$  the Lie algebra of  $U(n, \mathbb{C})$ . The maximal torus T of  $U(n, \mathbb{C})$  is given by  $T = \{ \text{diag}(t_1, \ldots, t_n), t_i \in S^1 \}$  and its Lie algebra t is defined as:

$$\mathsf{t} = \bigoplus_{k=1}^n i\mathbb{R} \operatorname{E}_{k,k}.$$

One can check (see [22, Chapter II]) that the roots of  $\mathfrak{g}_\mathbb{C}$  with respect to  $t_\mathbb{C}$  are given by:

$$\Phi(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}}) = \left\{ \pm (e_i - e_j), 1 \le i < j \le n \right\},\$$

where  $e_k(\operatorname{diag}(h_1,\ldots,h_n)) = h_k$ .

Similarly, let (V', b') be a p + q-dimensional vector space over  $\mathbb{C}$  endowed with a non-degenerate hermitian form b' of signature (p, q) and let  $\mathscr{B}'$  be a basis of V' such that  $Mat(b', \mathscr{B}') = Id_{p,q}$ . We denote by U(V', b') the group of isometries of b', i.e.

(18) 
$$U(V', b') = \{g \in GL(V'), b'(gu, gv) = b'(u, v), (\forall u, v \in V')\},\$$

and by  $U(p, q, \mathbb{C})$  the following group

(19) 
$$\left\{g \in \mathrm{GL}(p,q,\mathbb{C}), g^* \operatorname{Id}_{p,q} g = \operatorname{Id}_{p,q}\right\}.$$

Let  $K' = U(p, \mathbb{C}) \times U(q, \mathbb{C})$  be the maximal compact subgroup of G'.

Using the paper of M. Kashiwara and M. Vergne [17] (we can also use the Appendix of [9]), the weights of the representations of  $\Pi \in U(n, \mathbb{C})_{\omega}$  which appears in the correspondence are given by the following formula:

(20) 
$$\lambda = \sum_{a=1}^{n} \frac{q-p}{2} e_a - \sum_{a=1}^{r} v_a e_{n+1-a} + \sum_{a=1}^{s} \mu_a e_a,$$

where  $0 \le r \le p$ ,  $0 \le s \le q$ ,  $r + s \le m$ , and integers  $v_1, \ldots, v_r, \mu_1, \ldots, \mu_s$  which satisfy  $v_1 \ge \ldots \ge v_r > 0$  and  $\mu_1 \ge \ldots \ge \mu_s > 0$ . The weights  $\lambda$  can also be written as

(21) 
$$\lambda = \sum_{a=1}^{m} \left( \frac{q-p}{2} + \lambda_a \right) e_a$$

where  $\lambda_i \in \mathbb{Z}, \lambda_1 \ge ... \ge \lambda_m$  with at most *q* of the integers  $\lambda_i$  are positives and *p* negatives. We easily proved that, for  $G = U(n, \mathbb{C})$ , we have:

$$\rho = \frac{1}{2} \sum_{\alpha \in \Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} \alpha = \sum_{a=1}^n \frac{n-2a+1}{2} e_a$$

Using Corollary 5.3, we give a formula for the character  $\Theta$  on  $T \cdot T'^{++}$ , where T and T' are diagonal Cartan subgroups of G and G' respectively and  $T'^{++} = T'_{\mathbb{C}} \cap \operatorname{Sp}(W_{\mathbb{C}})^{++}$ .

**Proposition 6.1.** (1) The set  $T'^{++}$  is given by

(22)  $\mathbf{T}^{\prime ++} = \left\{ \operatorname{diag}(t_1, \dots, t_{p+q}); \ |t_i| < 1 \text{ for } 1 \le i \le p, |t_i| > 1 \text{ for } p < i \le p+q \right\}.$ 

(2) For all  $\tilde{t} \in \tilde{T}$  and  $\tilde{t'} \in T'^{++}$ , the character  $\Theta$  is given by:

(23) 
$$\Theta(\tilde{t}\tilde{t'}) = \frac{(-1)^{mq} \prod_{b=1}^{m} t_b^p \left(\prod_{a=1}^{p+q} t_a'\right)^{\frac{m}{2}} \left(\prod_{b=1}^{m} t_b^{\frac{q-p}{2}}\right)}{\prod_{a=1}^{p} \prod_{b=1}^{m} (t_b - t_a') \prod_{a=p+1}^{p+q} \prod_{b=1}^{m} \left(t_b - \frac{1}{t_a'}\right)}$$

*Proof.* (1) See Appendix A.

(2) We consider  $W = M((p+q) \times m, \mathbb{C})$  as a real vector space endowed with the following form

$$\langle w, w' \rangle = \operatorname{Im}(\bar{w'}^{t}I_{p,q}w)$$

This form is symmetric and non-degenerate. Moreover, the map  $J(w) = iI_{p,q}w$  is a posiitive definite complex structure on *W*. The maps

$$G \times W \ni (g, X) \to gX \in W$$
  $G' \times W \ni (g', X) = Xg'^{-1}$ 

give embeddings of G and G' into Sp(W). For every matrix  $E_{a,b} \in W$ , we have:

$$(tt') \operatorname{E}_{a,b} = t'_a t_b^{-1} \operatorname{E}_{a,b}$$

By definition of *J*, we get:

$$J(\mathbf{E}_{a,b}) = \begin{cases} i \, \mathbf{E}_{a,b} & \text{if } 1 \le a \le p \\ -i \, \mathbf{E}_{a,b} & \text{if } a > p \end{cases}$$

Then, the eigenvalues of tt' are of the form

$$\left\{t'_{a}t^{-1}_{b}; \ 1 \le a \le p, 1 \le b \le n\right\} \cup \left\{\overline{t'_{a}t^{-1}_{b}}; \ p+1 \le a \le p+q, 1 \le b \le n\right\}.$$

Finally, using Equation (15), we get:

$$\Theta(\widetilde{t}\widetilde{t}') = \frac{\left(\prod_{a=1}^{p}\prod_{b=1}^{n}t'_{a}t_{b}^{-1}\prod_{a=p+1}^{p+q}\prod_{b=1}^{n}\overline{t'_{a}t_{b}^{-1}}\right)^{\frac{1}{2}}}{\prod_{a=1}^{p}\prod_{b=1}^{n}(1-t'_{a}t_{b}^{-1})\prod_{a=p+1}^{p+q}\prod_{b=1}^{n}(1-\overline{t'_{a}t_{b}^{-1}})} = \frac{\left(\prod_{a=1}^{p}(t'_{a})^{n}\prod_{a=p+1}^{p+q}(\overline{t'_{a}})^{n}\prod_{b=1}^{n}t_{b}^{q-p}\right)^{\frac{1}{2}}}{\prod_{a=1}^{p}\prod_{b=1}^{n}(1-t'_{a}t_{b}^{-1})\prod_{a=p+1}^{p+q}\prod_{b=1}^{n}(1-\overline{t'_{a}t_{b}^{-1}})}$$

In particular, for every element  $\tilde{t}'$  of  $\tilde{T}'$ , we get:

$$\Theta(\widetilde{t}') = \frac{\left(\prod_{a=1}^{p} (t'_{a})^{m} \prod_{a=p+1}^{p+q} (\overline{t'_{a}})^{m}\right)^{\frac{1}{2}}}{\prod_{a=1}^{p} \prod_{b=1}^{m} (1 - t'_{a}) \prod_{a=p+1}^{p+q} \prod_{b=1}^{m} (1 - \overline{t'_{a}})}$$

According to Equation (7), we get that:

$$\Theta(\tilde{t}\tilde{t'}) = \Theta(\tilde{t})\Theta(\tilde{t'})\Lambda(c(t) + c(t')).$$

The rest of the proof is a straightforward computation.

**Proposition 6.2.** For every regular element  $\tilde{t}'$  in  $\tilde{T}'$ , we get:

$$\Theta_{\Pi'}(\tilde{t}') = \frac{(-1)^{nq+\frac{(n-1)n}{2}} \left(\prod_{a=1}^{p+q} t'_{a}\right)^{\frac{n}{2}}}{(2i\pi)^{n} n!} \lim_{\substack{r \to 1 \\ 0 < r < 1}} \sum_{w \in \mathscr{W}} \operatorname{sgn}(w) \int_{S^{1}} \dots \int_{S^{1}} \frac{\prod_{b=1}^{n} t_{b}^{p-n-1} \prod_{a=1}^{n} t_{w(a)}^{a-\lambda_{a}} \prod_{1 \le i < j \le n} (t_{i} - t_{j})}{\prod_{a=1}^{p} \prod_{b=1}^{n} (t_{b} - rt'_{a}) \prod_{a=p+1}^{p+q} \prod_{b=1}^{n} \left(t_{b} - \frac{1}{rt'_{a}}\right)} \prod_{k=1}^{n} dt_{k}$$

$$= K(t') \lim_{\substack{r \to 1 \\ 0 < r < 1}} \sum_{w \in \mathcal{W}} \sum_{\beta \in \mathcal{S}_n} \operatorname{sgn}(w) \operatorname{sgn}(\beta) \prod_{b=1}^n \int_{S^1} \frac{t_b^{p-n-2+w^{-1}(b)-\lambda_{w^{-1}(b)}+\beta^{-1}(b)}}{\prod_{a=1}^p (t_b - rt'_a) \prod_{a=p+1}^{p+q} \left(t_b - \frac{1}{rt'_a}\right)} dt_b$$
  
where  $K(t') = \frac{(-1)^{nq + \frac{(n-1)n}{2}} \left(\prod_{a=1}^{p+q} t'_a\right)^{\frac{n}{2}}}{(2i\pi)^n n!}.$ 

*Proof.* Using Equation (13), we get that

$$\Theta_{\Pi'}(\widetilde{g}') = \lim_{\substack{\widetilde{p} \to 1 \\ \widetilde{p} \in \widetilde{G}_{\mathbb{C}}^{t++}}} \int_{\mathcal{T}} \mathcal{H}_{\widetilde{p},\widetilde{g}'}(t) |\Delta(t)|^2 d\mu_{\mathcal{T}}(t).$$

The torus T of  $U(n, \mathbb{C})$  is isomorphic to  $S^{1^{\otimes n}}$ . Under this identification, we get:

$$d\mu_{\rm T} = \bigotimes_{i=1}^n d\mu_{\rm S^1},$$

and  $d\mu_{S^1}(z) = \frac{dz}{2i\pi z}$ . Moreover,

(24) 
$$D(\widetilde{t} = \widetilde{\exp(x)}) = \prod_{\alpha > 0} (e^{\frac{\alpha}{2}(x)} - e^{-\frac{\alpha}{2}(x)}) = \prod_{1 \le i < j \le m} (t_i^{\frac{1}{2}} t_j^{-\frac{1}{2}} - t_i^{-\frac{1}{2}} t_j^{\frac{1}{2}}) = \prod_{i=1}^m t_i^{-\frac{m-1}{2}} \prod_{1 \le i < j \le m} (t_i - t_j).$$

and by using the Vandermonde's determinant formula, we get:

(25) 
$$\prod_{1 \le i < j \le n} (t_j - t_i) = \sum_{\beta \in \mathscr{S}_n} \operatorname{sgn}(\beta) \prod_{i=1}^n t_{\beta_i}^{i-1}.$$

The rest of the proof is a straightforward computation using Equation (1), Proposition 6.1 and Equation (21).

We now give a technical lemma concerning the integrals which appears in the previous proposition (the proof is obvious using residue theorem).

**Lemma 6.3.** Let  $a_1, \ldots, a_p$  be p-complex numbers such that  $|a_i| < 1$  for all  $i \in [|1, p|]$ . Similarly, we consider  $a_{p+1}, \ldots, a_{p+q} \in \mathbb{C}$  such that  $|a_i| > 1$  for all  $i \in [|p + 1, p + q|]$ . Moreover, we assume that  $a_i \neq a_j, i \neq j$ . Then, we get:

$$\frac{1}{2i\pi} \int_{S^1} \frac{t^k}{\prod\limits_{i=1}^{p+q} (t-a_i)} dt = \begin{cases} \sum\limits_{h=1}^p \frac{a_h^k}{\prod\limits_{j\neq h} (a_h-a_j)} & \text{if } k \ge 0\\ -\sum\limits_{h=p+1}^{p+q} \frac{a_h^k}{\prod\limits_{j\neq h} (a_h-a_j)} & \text{otherwise} \end{cases}$$

Let's now fix n = 1. In this case, the weights  $\lambda$  of the representations  $\Pi$  are of the form  $\lambda = ke_1$  if k is positive and  $\lambda = ke_2$  otherwise. The reason why we voluntarily change the notations here is because

the set of irreducible genuine representations of  $U(1, \mathbb{C})$  is isomorphic to the unitary dual of  $U(1, \mathbb{C})$ , which is isomorphic to  $\mathbb{Z}$  via the isomorphism:

$$\mathbb{Z} \ni k \to (x \to e^{2i\pi kx}) \in \widetilde{\mathrm{U}(1,\mathbb{C})}.$$

Using Proposition 6.2 and Lemma 6.3, we get the following proposition.

**Proposition 6.4.** The character  $\Theta_{\Pi'_k}$  of the representation  $\Pi'_k$  of  $U(p, q, \mathbb{C})$  is given, for every  $\tilde{t'} \in \widetilde{T'}$ , *by*:

(26) 
$$\Theta_{\Pi'_{k}}(\tilde{t}') = \begin{cases} \prod_{i=1}^{p+q} t_{i}^{\frac{1}{2}} \sum_{h=1}^{p} \frac{t_{h}^{p-(k+1)}}{\prod_{i\neq j} (t_{h} - t_{j})} & \text{if } k \leq 0 \\ -\prod_{i=1}^{p+q} t_{i}^{\frac{1}{2}} \sum_{h=p+1}^{p+q} \frac{t_{h}^{p-(k+1)}}{\prod_{i\neq j} (t_{h} - t_{j})} & \text{otherwise} \end{cases}$$

**Notation 6.5.** The Weyl group  $\mathscr{W}$  (resp.  $\mathscr{W}(\mathfrak{k})$ ) of G' (resp. K') is isomorphic to  $\mathscr{S}_{p+q}$  (resp.  $\mathscr{S}_p \times \mathscr{S}_p$ ). For every element  $h \in \{1, ..., p+q\}$ , we denote by  $\mathscr{W}^h$  the stabilizer of h, i.e.

$$\mathscr{W}^h = \{ \sigma \in \mathscr{W}, \sigma(h) = h \}.$$

We define similarly  $\mathscr{W}(\mathfrak{k})^h$ .

Proposition 6.6. We get, up to a constant, the following result:

$$D(X)\Theta_{\Pi'}(\exp(X)) = \begin{cases} \sum_{\mu \in A^{p+1}} \operatorname{sgn}(\mu) \sum_{\omega \in \mathscr{S}_p \times \mathscr{S}_q} \operatorname{sgn}(\omega) e^{i\omega(\mu\lambda_1 + \xi)(x)} & \text{if } k > p-1 \\ \sum_{\mu \in A^1} \operatorname{sgn}(\mu) \sum_{\omega \in \mathscr{S}_p \times \mathscr{S}_q} \operatorname{sgn}(w) e^{i\omega(\mu\lambda_2 + \xi)(x)} & \text{otherwise} \end{cases}$$

where

• 
$$\lambda_1 = \sum_{i=1}^{p} (i-1)e_i + (p-(k+1))e_{p+1} + \sum_{i=p+2}^{p+q} (i-2)e_i,$$
  
•  $\lambda_2 = (p-(k+1))e_1 + \sum_{a=2}^{p+q} (a-2)e_a,$   
•  $A^1$  (resp.  $A^{p+1}$ ) is a system of representatives of  $\mathcal{W}^1/\mathcal{W}(\mathfrak{k})^1$  (resp.  $\mathcal{W}^{p+1}/\mathcal{W}(\mathfrak{k})^{p+1})$   
•  $\xi = \sum_{k=1}^{p+q} \frac{p+q-2}{2}e_k.$ 

*Proof.* We assume first that k > p - 1. According to Equation (24), we have:

$$\prod_{\alpha\in\Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} (e^{\frac{\alpha(x)}{2}} - e^{-\frac{\alpha(x)}{2}}) = \prod_{i=1}^m t_i^{-\frac{p+q-1}{2}} \prod_{1\leq i< j\leq p+q} (t_i - t_j).$$

For all  $h \in \{1, \ldots, p + q\}$ , we get:

$$\frac{\prod\limits_{1 \le i < j \le p+q} (t_i - t_j)}{\prod\limits_{k \ne h} (t_h - t_k)} = (-1)^{h-1} \prod_{\substack{1 \le i < j \le p+q \\ i, j \ne h}} (t_i - t_j)$$

and then

$$\prod_{\alpha \in \Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} (e^{\frac{\alpha(x)}{2}} - e^{-\frac{\alpha(x)}{2}}) \Theta_{\Pi'_k}(\widetilde{\exp(x)}) = \prod_{i=1}^{p+q} t_i^{-\frac{p+q-2}{2}} \sum_{h=p+1}^{p+q} (-1)^{h+1} t_h^{p-(k+1)} \prod_{\substack{1 \le i < j \le p+q \\ i \neq h, j \neq h}} (t_i - t_j).$$

For all  $h \in \{1, ..., p + q\}$ , we denote by  $\tilde{t}_k, 1 \le k \le p + q - 1$  the following elements

$$\tilde{t}_k = \begin{cases} t_k & \text{if } k < h \\ t_{k+1} & \text{otherwise} \end{cases}.$$

Then, up to a  $\pm 1$ , we get:

$$\prod_{\substack{1 \leq i < j \leq p+q \\ i \neq h, j \neq h}} (t_i - t_j) = \prod_{\substack{1 \leq i < j \leq p+q-1}} (\tilde{t}_i - \tilde{t}_j) = \sum_{\sigma \in \mathscr{S}_{p+q-1}} \operatorname{sgn}(\sigma) \prod_{a=1}^{p+q-1} \tilde{t}_{\sigma(a)}^{a-1}$$
$$= \sum_{\sigma \in \mathscr{S}_{p+q}^h} \operatorname{sgn}(\sigma) \prod_{a=1}^{h-1} t_{\sigma(a)}^{a-1} \prod_{a=h+1}^{p+q} t_{\sigma(a)}^{a-2}.$$

Finally, we prove that:

$$\sum_{h=p+1}^{p+q} \sum_{\sigma \in \mathscr{S}_{p+q}^{h}} \operatorname{sgn}(\sigma)(-1)^{h+1} t_{h}^{p-(k+1)} \prod_{a=1}^{h-1} t_{\sigma(a)}^{a-1} \prod_{a=h+1}^{p+q} t_{\sigma(a)}^{a-2} = (-1)^{p} \sum_{\mu \in A^{p+1}} \operatorname{sgn}(\mu) \sum_{\omega \in \mathscr{S}_{p} \times \mathscr{S}_{q}} \operatorname{sgn}(\omega) e^{i\omega(\mu\lambda)(x)}$$
  
where  $\lambda_{1} = \sum_{i=1}^{p} (i-1)e_{i} + (p-(k+1))e_{p+1} + \sum_{i=p+2}^{p+q} (i-2)e_{i}$ . The proof is similar if  $k \le p-1$ .

*Recall* 6.7. We recall briefly some well-known facts from [10] (see also [25]) concerning the Fourier transform of co-adjoint orbits. To simplify the notations, we assume that G is a semi-simple connected Lie group such that rk(K) = rk(G), where K is a maximal compact subgroup of G. We denote by Ad<sup>\*</sup> the natural co-ajoint action of G on g<sup>\*</sup>. For every  $\lambda \in g^*$ , we denote by  $G_{\lambda}$  the G-orbit associated to  $\lambda$ . On the space  $G_{\lambda}$ , we have a natural measure  $d\beta_{\lambda}$ , usually called the Liouville measure on  $G_{\lambda}$  (see [25, Section 7.5]).

The Fourier transform of  $G_{\lambda}$ , denoted by  $F_{G_{\lambda}}$ , is the generalized function on g defined by:

$$F_{G_{\lambda}}(X) = \int_{G_{\lambda}} e^{if(X)} d\beta_{\lambda}(f) \qquad (X \in \mathfrak{g}).$$

As proved in [10, Page 217], if  $\lambda \in t^{*reg}$ , we have, up to a constant, the following quality:

$$\left(\prod_{\alpha\in\Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})}\alpha(X)\right)\mathsf{F}_{\mathsf{G}_{\lambda}}(X)=\sum_{\omega\in\mathscr{W}(\mathfrak{f})}\varepsilon(\omega)e^{i\lambda(\omega(X))}\qquad(X\in\mathfrak{t}^{\mathrm{reg}}).$$

If the weight  $\lambda$  is not regular, see [17, Theorem 7.24]. To simplify the notations, we denote by  $\pi(X)$  the quantity  $\prod_{\alpha \in \Phi^+(\mathfrak{g}_{\mathbb{C}},\mathfrak{t}_{\mathbb{C}})} \alpha(X)$ .

Corollary 6.8. Using the notations of Proposition 6.6, we get, up to a constant:

$$\pi(X)^{-1}D(X)\Theta_{\Pi'}(\exp(X)) = \begin{cases} \sum_{\mu \in A^{p+1}} \operatorname{sgn}(\mu) \operatorname{F}_{G_{\mu(\lambda_1+\xi)}}(X) & \text{if } p < k+1 \\ \sum_{\mu \in A^1} \operatorname{sgn}(\mu) \operatorname{F}_{G_{\mu(\lambda_2+\xi)}}(X) & \text{if } k < -q+1 \end{cases}$$

*Remark* 6.9. (1) For the dual pair ( $G = U(1, \mathbb{C}), G' = U(1, \mathbb{C})$ ), using the Equation (26), we get:

$$\Theta_{\Pi'_k}(\widetilde{t'}) = t'^{-k-\frac{1}{2}} = \Theta_{\Pi_k}(t'^{-1}).$$

In particular, to be precise, with our method, we don't get  $\Theta_{\Pi'}(\tilde{t}')$  but  $\Theta_{\Pi'}(\tilde{t}'^{-1})$  (or  $\Theta_{\Pi'}(\tilde{t}')$  because the representation  $\Pi'$  is unitary): in the embedding of (G, G') in Sp(W),  $g' \in G'$  acts on  $w \in W$  as  $g'.w = wg'^{-1}$ .

(2) The function  $t \to X \to \pi(X)^{-1}D(X) \in \mathbb{C}$  is well-known in the literature, usually denoted by p(x) (see [23] or [10]). More particularly, p(X) can be defined as:

$$p(X) = \det^{\frac{1}{2}}\left(\frac{\sinh(\operatorname{ad}(X/2))}{\operatorname{ad}(X/2)}\right)$$

7. The case 
$$G' = U(1, 1, \mathbb{C})$$

As recalled in Equation (19), the unitary group  $U(p, q, \mathbb{C})$  is defined by

$$U(p,q,\mathbb{C}) = \left\{ A \in GL(p+q,\mathbb{C}), A^* \operatorname{Id}_{p,q} A = \operatorname{Id}_{p,q} \right\}.$$

We fix the convention that  $p \le q$ . In this case, there is, up to conjugaison, q + 1 Cartan subgroups in  $U(p, q, \mathbb{C})$  (see [21]). More precisely, the Cartan subgroups  $H_k, 0 \le k \le q$  are of the form  $H_k = H_k^- H_k^+$ , where  $H_k^-$  and  $H_k^+$  are the subgroups of  $U(p, q, \mathbb{C})$  are defined by

$$\mathbf{H}_{k}^{+} = \{\mathbf{H}_{k}^{+}(t_{1}, \dots, t_{k}), t_{i} \in \mathbb{R}, 1 \le i \le k\}$$

where  $H_k^+(t_1, \ldots, t_k)$  is given by

 $\mathbf{H}_{k}^{+}(t_{1},\ldots,t_{k}) = \begin{pmatrix} \mathrm{Id}_{p-k} & & & & & 0 \\ & \mathrm{ch}(t_{k}) & & & & & \mathrm{sh}(t_{k}) & \\ & & \mathrm{ch}(t_{k-1}) & & & & \mathrm{sh}(t_{k-1}) & \\ & & & \ddots & & \ddots & & \\ & & & & \mathrm{ch}(t_{1}) & \mathrm{sh}(t_{1}) & & & \\ & & & & & \mathrm{sh}(t_{1}) & \mathrm{ch}(t_{1}) & & \\ & & & & & \ddots & & & \\ & & & & & \mathrm{sh}(t_{k-1}) & & & & \mathrm{ch}(t_{k-1}) & \\ & & & & & & \mathrm{sh}(t_{k}) & & & & \mathrm{ch}(t_{k}) \\ & & & & & & & \mathrm{sh}(t_{k}) & & & & \mathrm{sh}(t_{k}) \end{pmatrix}$ 

and

$$\mathbf{H}_{k}^{-} = \{ \operatorname{diag}(e^{i\phi_{1}}, \dots, e^{i\phi_{p-k}}, e^{i\theta_{k}}, \dots, e^{i\theta_{1}}, e^{i\theta_{1}}, \dots, e^{i\theta_{k}}, e^{i\tau_{q-k}}, \dots, e^{i\tau_{1}}), \phi_{i}, \theta_{i}, \tau_{i} \in \mathbb{R} \}$$

We now work with the pair  $(G(V, b_V), G(V', b_{V'})) = (U(1, \mathbb{C}), U(1, 1, \mathbb{C})) \subseteq Sp(W)$ , where  $W = (\mathbb{C} \otimes \mathbb{C}^2)_{\mathbb{R}}$  and  $\langle \cdot, \cdot \rangle = Im(b_V \otimes b_{V'})$ . We denote by  $H_1$  and  $H_2$  the two Cartan subgroups of G' (up to conjugation), with  $H_1$  compact.

Let  $\mathscr{B}' = \{v_1, v_2\}$  be a basis of V' such that:

$$\mathbf{F} = \operatorname{Mat}(\mathscr{B}', \mathbf{b}_{V'}) = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}.$$

Then,

$$U(1, 1, \mathbb{C}) = \{g \in GL(2, \mathbb{C}), g^* F g = F\},\$$

and

$$\mathfrak{u}(1,1,\mathbb{C}) = \{A \in \mathcal{M}(2,\mathbb{C}), A \in \mathcal{F} + \mathcal{F}A^* = 0\} = \mathbb{R} \begin{pmatrix} i & 0 \\ 0 & i \end{pmatrix} \oplus \mathbb{R} \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} \oplus \mathbb{R} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix} \oplus \mathbb{R} \begin{pmatrix} 0 & i \\ -i & 0 \end{pmatrix}.$$

In particular, we have  $\mathfrak{u}(1,1,\mathbb{C})_{\mathbb{C}} = \mathbb{C} \operatorname{Id}_2 \oplus \mathfrak{sl}(2,\mathbb{C})$ . We fix the  $\mathfrak{sl}(2,\mathbb{C})$ -triple (h,e,f) defined by  $h = E_{1,1} - E_{2,2}, e = E_{1,2}, f = E_{2,1}$  and let

$$C = \exp\left(i\frac{\pi}{4}(e+f)\right).$$

More particularly, we have:

$$C = \exp\begin{pmatrix} 0 & \frac{i\pi}{4} \\ \frac{i\pi}{4} & 0 \end{pmatrix} = \begin{pmatrix} \operatorname{ch}(\frac{i\pi}{4}) & \operatorname{sh}(\frac{i\pi}{4}) \\ \operatorname{sh}(\frac{i\pi}{4}) & \operatorname{ch}(\frac{i\pi}{4}) \end{pmatrix} = \begin{pmatrix} \cos(\frac{\pi}{4}) & i\sin(\frac{\pi}{4}) \\ i\sin(\frac{\pi}{4}) & \cos(\frac{\pi}{4}) \end{pmatrix} = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & i \\ i & 1 \end{pmatrix}$$

so  $C \notin \mathfrak{u}(1, 1, \mathbb{C})$ .

Lemma 7.1. Let

$$\mathfrak{h}_1 = \mathbb{R} \begin{pmatrix} i & 0 \\ 0 & i \end{pmatrix} \oplus \mathbb{R} \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} \qquad \mathfrak{h}_2 = \mathbb{R} \begin{pmatrix} i & 0 \\ 0 & i \end{pmatrix} \oplus \mathbb{R} \begin{pmatrix} 0 & i \\ -i & 0 \end{pmatrix}$$

Then,  $H_1 = \exp(\mathfrak{h}_1)$  and  $H_2 = \exp(\mathfrak{h}_2)$  are the two non-conjugate Cartan subgroups of  $U(1, 1, \mathbb{C})$  and  $H_1$  is compact. Moreover, we have

$$\begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix} = C \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} C^{-1}$$

*Remark* 7.2. More particularly, the subgroups  $H_1$  and  $H_2$  are given by

$$\mathbf{H}_{1} = \left\{ \begin{pmatrix} e^{i\theta_{1}} & 0\\ 0 & e^{i\theta_{2}} \end{pmatrix}, \theta_{1}, \theta_{2} \in \mathbb{R} \right\}$$

and

$$H_{2} = \left\{ \begin{pmatrix} e^{i\theta_{1}} \operatorname{ch}(X) & i\operatorname{sh}(X) \\ -i\operatorname{sh}(X) & e^{i\theta_{1}} \operatorname{ch}(X) \end{pmatrix}, \theta_{1}, X \in \mathbb{R} \right\} = \left\{ \begin{pmatrix} e^{i\theta_{1}} & 0 \\ 0 & e^{i\theta_{1}} \end{pmatrix}, \theta_{1} \in \mathbb{R} \right\} \cdot \left\{ \begin{pmatrix} \operatorname{ch}(X) & i\operatorname{sh}(X) \\ -i\operatorname{sh}(X) & \operatorname{ch}(X) \end{pmatrix}, X \in \mathbb{R} \right\} = \operatorname{T}_{2} \operatorname{A}_{2} \operatorname{A}_{$$

The set  $A_2$  is the split part of  $H_2$  (see [15, Section 2.3.6]).

**Proposition 7.3.** For all element  $\tilde{g} \in \tilde{G}^{\prime++}$ , we get:

$$\Theta(\widetilde{g}) = \det(g)^{\frac{1}{2}} \det(g-1)^{-1}.$$

Proof. Let 
$$g \in U(1, 1, \mathbb{C}) \left( \leftrightarrow \begin{pmatrix} g & 0 \\ 0 & g^* \end{pmatrix} \in \operatorname{Sp}(4, \mathbb{R}) \right)$$
. We get:  

$$\det_{W_{\mathbb{C}}}(i(g-1)) = \det_{W_{\mathbb{C}}}(g-1) = \det_{\mathbb{C}^2}(g-1) \det_{\mathbb{C}^2}(g^*-1)$$

$$= \det(g-1) \det(g^{-1}-1) = \det(g-1) \det(g^{-1}) \det(g^{-1}) \det(1-g)$$

$$= \det(g)^{-1} \det(g-1)^2.$$

We can now determine  $\Theta_{\Pi'_k}$  on H<sub>2</sub> (more particularly on A<sub>2</sub>). According to Equation (13), we get for X > 0:

$$\begin{split} \Theta_{\Pi'_{k}} \begin{pmatrix} \operatorname{ch}(X) & i \operatorname{sh}(X) \\ -i \operatorname{sh}(X) & \operatorname{ch}(X) \end{pmatrix} &= \Theta_{\Pi'_{k}} \begin{pmatrix} \exp\left(\begin{array}{c} 0 & iX \\ -iX & 0 \end{pmatrix} \right) = \int_{S^{1}} z^{-k} \Theta \left( z \exp\left(\begin{array}{c} 0 & iX \\ -iX & 0 \end{pmatrix} \right) dz \\ &= \int_{S^{1}} z^{-k} \Theta \left( z \exp\left(\begin{array}{c} -X & 0 \\ 0 & X \end{pmatrix} C^{-1} \right) dz = \int_{S^{1}} z^{-k} \Theta \left( \begin{pmatrix} ze^{-X} & 0 \\ 0 & ze^{X} \end{pmatrix} \right) dz \\ &= \int_{S^{1}} z^{-k+1} \det \left( \begin{array}{c} 2e^{-X} - 1 & 0 \\ 0 & ze^{X} - 1 \end{array} \right)^{-1} dz = \int_{S^{1}} \frac{z^{-k+1}}{(ze^{X} - 1)(ze^{-X} - 1)} dz \\ &= \int_{S^{1}} \frac{z^{-k+1}}{(z-e^{-X})(z-e^{X})} dz = \begin{cases} \frac{e^{X(k-1)}}{e^{-X} - e^{X}} & \text{if } k \ge 1 \\ \frac{e^{-X(k-1)}}{e^{-X} - e^{X}} & \text{otherwise} \end{cases} \end{split}$$

More generally, for all  $\theta \in \mathbb{R}$  and  $X \in \mathbb{R}^+$ , we get:

$$\begin{split} \Theta_{\Pi'_{k}} & \left( \begin{pmatrix} e^{i\theta} \operatorname{ch}(X) & ie^{i\theta} \operatorname{sh}(X) \\ -ie^{i\theta} \operatorname{sh}(X) & e^{i\theta} \operatorname{ch}(X) \end{pmatrix} \right) = \Theta_{\Pi'_{k}} \left( \exp\left( \begin{pmatrix} i\theta & 0 \\ 0 & i\theta \end{pmatrix} + \begin{pmatrix} 0 & iX \\ -iX & 0 \end{pmatrix} \right) \right) \\ &= \int_{S^{1}} z^{-k} \Theta\left( z \exp\left( \begin{pmatrix} i\theta & 0 \\ 0 & i\theta \end{pmatrix} + \begin{pmatrix} 0 & iX \\ -iX & 0 \end{pmatrix} \right) \right) dz = \int_{S^{1}} z^{-k} \Theta\left( z \exp\left( C\left( \begin{pmatrix} i\theta & 0 \\ 0 & i\theta \end{pmatrix} + \begin{pmatrix} -X & 0 \\ 0 & X \end{pmatrix} \right) C^{-1} \right) \right) dz \\ &= \int_{S^{1}} z^{-k} \Theta\left( \begin{pmatrix} ze^{-X}e^{i\theta} & 0 \\ 0 & ze^{i\theta}e^{X} \end{pmatrix} \right) dz = \int_{S^{1}} z^{-k+1}e^{i\theta} \det\left( ze^{i\theta}e^{-X} - 1 & 0 \\ 0 & ze^{i\theta}e^{X} - 1 \right)^{-1} dz \\ &= \int_{S^{1}} \frac{z^{-k+1}e^{i\theta}}{(ze^{i\theta}e^{X} - 1)(ze^{i\theta}e^{-X} - 1)} dz = \int_{S^{1}} \frac{e^{-i\theta}z^{-k+1}}{(z - e^{-i\theta}e^{-X})(z - e^{-i\theta}e^{X})} dz = \begin{cases} \frac{e^{i\theta(k-1)}e^{X(k-1)}}{e^{X}(k-1)} \\ \frac{e^{i\theta(k-1)}e^{-X(k-1)}}{e^{X(k-1)}} \\ \frac{e^{i\theta(k-1)}e^{-X(k-1)}}{e^{X(k-1)}} \end{cases} \text{ otherwise} \end{split}$$

We got similar results for X < 0.

# 8. A CONJECTURE OF T. PRZEBINDA

In [7], T. Przebinda investigated the correspondence of characters for a general dual pair. We recall here the Howe's duality theorem in this context. Let  $(W, \langle \cdot, \cdot \rangle)$  be a symplectic vector space over  $\mathbb{R}$ ,  $\widetilde{Sp(W)}$  the corresponding metaplectic group,  $(\omega, \mathscr{H})$  the metaplectic representation of  $\widetilde{Sp(W)}$ , (G, G') be a dual pair in Sp(W) and  $(\widetilde{G}, \widetilde{G}')$  the corresponding dual pair in  $\widetilde{Sp(W)}$ .

We denote by  $\mathscr{R}(\widetilde{G}, \omega)$  the set of equivalence classes of irreducible admissible representations of  $\widetilde{G}$  which are infinitisemally equivalent to a quotient of  $\omega^{\infty}$ . In [1], R. Howe proved that there exists a bijection between  $\mathscr{R}(\widetilde{G}, \omega)$  and  $\mathscr{R}(\widetilde{G}', \omega)$  whose graph is  $\mathscr{R}(\widetilde{G}, \widetilde{G}', \omega)$ . We denote by  $\theta$  the following one-to-one map:

$$\theta: \mathscr{R}(\widetilde{\mathbf{G}}, \omega) \ni \Pi \to \Pi' = \theta(\Pi) \in \mathscr{R}(\widetilde{\mathbf{G}}', \omega).$$

Let's (G, G') be an irreducible reductive dual pair in Sp(*W*). Without loss of generality, we assume that  $rk(G) \le rk(G')$ . We denote by  $\{H_1, \ldots, H_n\}$  the set of conjugacy classes of Cartan subgroups of G. As explained in [15, Section 2.3.6], for every  $1 \le i \le n$ , there exists a decomposition of  $H_i$  of the form

$$\mathbf{H}_i = \mathbf{T}_i \, \mathbf{A}_i,$$

where  $T_i$  is compact and  $A_i$  is the split part of  $H_i$  (by convention,  $H_1$  is the compact Cartan subgroup, i.e.  $A_1 = \{Id\}$ ).

For every  $1 \le i \le n$ , we denote by  $A'_i = C_{Sp(W)}(A_i)$  and  $A''_i = C_{Sp(W)}(A'_i)$  (in particular,  $A'_1 = Sp(W)$  and  $A''_1 = Z(Sp(W)) = \{\pm 1\}$ ). Then,  $(A'_i, A''_i)$  is a reductive dual pair in Sp(W) (not irreducible in general).

We define a measure  $\overline{dw_i}$  on the quotient  $A_i'' \setminus W$  given by:

$$\int_{W} \phi(w) dw = \int_{A'' \setminus W} \int_{A'_i} \phi(a'w) d\mu_{A'_i}(a') \overline{dw}.$$

In [7, Section 2], T. Przebinda define the following distribution on  $A'_i$ :

$$\operatorname{Chc}(\Psi) = \int_{A_i'' \setminus W} \left( \int_{A_i'} \Psi(\overline{g}) T(\overline{g}) d\overline{g} \right)(w) \overline{dw} \qquad (\Psi \in \mathscr{C}_c^{\infty}(A_i')).$$

As mentioned in Section 4, the integral

$$\int_{A_i'} \Psi(\widetilde{g}) T(\widetilde{g}) d\widetilde{g} \in \mathcal{S}(W),$$

in particular,  $Chc(\Psi)$  is well defined. Moreover, for all  $\tilde{h} \in H_i^{reg}$ , the intersection of the wave front set WF(Chc) of the distribution Chc with the conormal bundle of the embedding

$$\widetilde{\mathbf{G}'} \ni \widetilde{\mathbf{g}}' \to \widetilde{h} \widetilde{\mathbf{g}}' \in \widetilde{A}'_i$$

is empty. In particular, there is a unique restriction of the distribution Chc to  $\widetilde{G}'$ . We denote by  $Chc_{\tilde{h}}$  this restriction. In [7, Conjecture 2.18], T. Przebinda conjectured the following result:

**Conjecture 8.1** (T. Przebinda). We denote by  $G'_1$  the connected component at identity of G'. We assume that  $(\Theta_{\Pi'})_{\widetilde{G'}\setminus\widetilde{G'_1}} = 0$ . For every  $\Psi \in \mathscr{C}^{\infty}_c(\widetilde{G'_1})$ , the character  $\Theta_{\Pi'}$  of  $\Pi'$  is given by:

(27) 
$$\Theta_{\Pi'}(\Psi) = K_{\Pi} \sum_{i=1}^{n} \frac{1}{|\mathscr{W}(H_{i})|} \int_{\widetilde{H}_{i}^{reg}} \overline{\Theta_{\Pi}(\widetilde{h})} |D(\widetilde{h})|^{2} \operatorname{Chc}_{\widetilde{h}}(\Psi) d\widetilde{h}.$$

where  $K_{\Pi}$  is a complex number depending of  $\Pi$  (one can check [7, Definition 2.17]).

We now explain how can we get characters by double lifting starting with a compact dual pair. To simplify the notations, we will present that for the dual pair of unitary groups. Let  $(G = U(1, \mathbb{C}), G' = U(1, 1, \mathbb{C}))$  in  $Sp(W_{\mathbb{R}})$ , where  $W_{\mathbb{R}} = (\mathbb{C}^1 \otimes_{\mathbb{C}} \mathbb{C}^{1,1})_{\mathbb{R}}$  and  $(G_1, G'_1) = (U(1, 1, \mathbb{C}), U(m, m + 1))$  in  $Sp(W_{\mathbb{R}}^m)$ , where  $W_{\mathbb{R}}^1 = (\mathbb{C}^{1,1} \otimes_{\mathbb{C}} \mathbb{C}^{m,1+m})_{\mathbb{R}}$ . We denote by  $(\omega, \mathscr{H})$  the metaplectic representation of  $Sp(W_{\mathbb{R}})$ , by  $(\omega_m, \mathscr{H}_m)$  the metaplectic representation of  $Sp(W_{\mathbb{R}}^m)$  and by  $\theta$  and  $\theta_m$  the two bijections

$$\theta: \mathscr{R}(\widetilde{\mathbf{G}}, \omega) \to \mathscr{R}(\widetilde{\mathbf{G}}', \omega) \qquad \theta_m: \mathscr{R}(\widetilde{\mathbf{G}_1}, \omega_m) \to \mathscr{R}(\widetilde{\mathbf{G}_1}, \omega_m)$$

**Notation 8.2.** For two positive integers *r*, *s*, we denote by det  $\frac{r-s}{2}$  – cov the double cover of U(*r*, *s*,  $\mathbb{C}$ ) given by:

$$\{(g,\xi)\in \mathrm{U}(r,s,\mathbb{C})\times\mathbb{C}^*,\xi^2=\mathrm{det}(g)^{r-s}\}$$

According to [18, Section 1.2], we have:

$$\widetilde{G} \approx \det^{\frac{1}{2}} - \operatorname{cov}, \qquad \widetilde{G'} \approx \det^0 - \operatorname{cov}, \qquad \widetilde{G_1} \approx \det^0 - \operatorname{cov} \qquad \widetilde{G'_1} \approx \det^{\frac{1}{2}} - \operatorname{cov}.$$

where  $det^0 - cov$  is the trivial cover.

Let  $\Pi \in \mathscr{R}(\widetilde{G}, \omega)$  such that  $\theta(\Pi) \neq \{0\}$ . According to a result of J-S Li [20],  $\theta(\Pi) \in \mathscr{R}(\widetilde{G}_1, \omega_m)$  and using the conservation of Kudla [19],  $\theta_m(\theta(\Pi)) \neq \{0\}$ .

We now assume that the dual pair  $(G_1, G'_1)$  is in the stable range (with  $rk(G_1) \le rk(G'_1)$ ).

As explained previously, the weights of the representations  $\Pi$  such that  $\theta(\Pi) \neq \{0\}$  are well-known (see [17]). The distribution character  $\Theta_{\theta_m(\theta(\Pi))}$  is given, for all  $\Psi \in \mathscr{C}^{\infty}_c(\widetilde{G'_1})$ , by the following formula:

$$\Theta_{\theta_m(\theta(\Pi))}(\Psi) = K_{\Pi} \sum_{i=1}^{2} \frac{1}{|\mathscr{W}(\mathbf{H}_i)|} \int_{\widetilde{\mathbf{H}}_i^{\text{reg}}} \overline{\Theta_{\theta(\Pi)}(\widetilde{h_i})} |D(\widetilde{h_i})|^2 \operatorname{Chc}_{\widetilde{h_i}}(\Psi) d\widetilde{h_i}.$$

where {H<sub>1</sub>, H<sub>2</sub>} the set of Cartan subgroups of G' (up to equivalence). The value of the character  $\Theta_{\theta(\Pi)}$  on H<sub>1</sub> can be obtained using the formula given in Proposition 6.4 (it can also be obtained using Enright's formula (see [14, Corollary 2.3]). The representation  $\theta(\Pi)$  is an irreducible unitary highest weight module. According to H. Hecht's thesis [26], the formula on the other Cartan subgroups is given by the same formula on the other Cartan subgroups. H<sub>2</sub> can be obtained similarly. Clearly, the same method can be applied in "higher dimensions".

## Appendix A. The oscillator semigroup for $U(1, 1, \mathbb{C})$

In this appendix, we would like to prove the equality given in Equation 22 of the Proposition 6.1. We recall here some well-known facts concerning complexifications. Let's V be a complex dimension n endowed with an antilinear involution c (i.e.  $c^2 = 1$  and  $c(\lambda v) = \overline{\lambda}c(v), \lambda \in \mathbb{C}, v \in V$ ). Then, we have the decomposition:

(28) 
$$V = \{v \in V, c(v) = v\} \oplus \{v \in V, c(v) = -v\} = \operatorname{Re}(V, c) \oplus \operatorname{Im}(V, c).$$

Both  $\operatorname{Re}(V, c)$  and  $\operatorname{Im}(V, c)$  are vector spaces over  $\mathbb{R}$  of dimension *n*. Moreover,

$$\operatorname{Re}(V, c) \ni v \to iv \in \operatorname{Im}(V, c)$$

is well-defined and an isomorphism of  $\mathbb{R}$  vector spaces. We denote by  $V_{\mathbb{R}}$  the vector space given in Equation (28).

**Example A.1.** Let  $V = \mathbb{C}^n$  and  $c : V \to V$  given by  $c(v) = \overline{v}$  the natural conjugation on  $\mathbb{C}^n$ . Then,

$$\operatorname{Re}(V) = \{x \in \mathbb{C}^n, x = \bar{x}\} = \mathbb{R}^n \qquad \operatorname{Im}(V) = \{x \in \mathbb{C}^n, x = -\bar{x}\} = i\mathbb{R}^n.$$

On the vector space  $V \oplus V$ , we define the map  $\tilde{c}$  given by

 $\tilde{c}: V \oplus V \ni (u, v) \to (c(v), c(u)) \in V \oplus V$ 

is an antilinear involution. As in Equation (28), we define the spaces  $\text{Re}(V \oplus V, \tilde{c})$  and  $\text{Im}(V \oplus V, \tilde{c})$ . In particular, we have:

$$\operatorname{Re}(V \oplus V, \tilde{c}) = \{(v, c(v)), v \in V\}.$$

Moreover, tha map:

(29) 
$$V_{\mathbb{R}} \ni v \to (v, c(v)) \in \operatorname{Re}(V \oplus V, \tilde{c}) \subseteq V \oplus V$$

is an isomorphism of real vector spaces. In particular, the complexification of  $V_{\mathbb{R}}$ , denoted by  $(V_{\mathbb{R}})_{\mathbb{C}}$ , is  $V \oplus V$ .

For all  $(x, y) \in V \oplus V$ , it's "conjugate"  $\tilde{c}(x, y)$  is equal to (c(y), c(x)). Moreover, there exists  $a, b \in V$  such that

$$(x, y) = (a, c(a)) + (b, -c(b)) \in \operatorname{Re}(V \oplus V, \tilde{c}) \oplus \operatorname{Im}(V \oplus V, \tilde{c})$$

More particularly, we have  $a = \frac{u+c(v)}{2}$  and  $b = \frac{u-c(v)}{2}$ .

Let's now assume that the space V is endowed with an hermitian form  $b_V$  of signature (p, q) (i.e. there exists a basis  $\mathscr{B}_V$  of V such that  $F = Mat(b_V, \mathscr{B}_V) = Id_{p,q}$ ). On the space  $W = V_{\mathbb{R}}$ , we have a natural symplectic form b given by  $b = Im(b_V)$ . We denote by  $W_{\mathbb{C}}$  the complexification of W and by  $b_{\mathbb{C}}$  th corresponding symplectic form on  $W_{\mathbb{C}}$ . Then, using the identification given in Equation (29), we get for all  $w = (w_1, w_2) \in W_{\mathbb{C}} = V \oplus V$ , we get:

$$H(w,w) = \operatorname{Im}\left(b_{V}\left(\frac{w_{1}+c(w_{2})}{2},-\frac{i(w_{1}-c(w_{2}))}{2}\right)\right)$$
  

$$= \frac{1}{4}\left(\operatorname{Re}(b_{V}(w_{1},w_{1}))-\operatorname{Re}(b_{V}(w_{1},c(w_{2})))+\operatorname{Re}(b_{V}(c(w_{2}),w_{1}))-\operatorname{Re}(b_{V}(c(w_{2}),c(w_{2})))\right)$$
  

$$= \frac{1}{4}\left(\operatorname{Re}(b_{V}(w_{1},w_{1}))-\operatorname{Re}(\overline{b_{V}(w_{1},c(w_{2}))})+\operatorname{Re}(b_{V}(c(w_{2}),w_{1}))-\operatorname{Re}(b_{V}(c(w_{2}),c(w_{2})))\right)$$
  

$$= \frac{1}{4}\left(\operatorname{Re}(b_{V}(w_{1},w_{1}))-\operatorname{Re}(b_{V}(c(w_{2}),c(w_{2})))\right)$$
  

$$= \frac{1}{4}\left(\operatorname{Re}(b_{V}(w_{1},w_{1}))-\operatorname{Re}(b_{V}(w_{2},w_{2}))\right)$$

For all  $g \in \text{Sp}(W_{\mathbb{C}})^{++}$ , we get, according to Equation (4), that:

$$g \in \mathbf{G}^{++} \iff H\left(g\begin{pmatrix}w_1\\w_2\end{pmatrix}, g\begin{pmatrix}w_1\\w_2\end{pmatrix}\right) < H\left(\begin{pmatrix}w_1\\w_2\end{pmatrix}, \begin{pmatrix}w_1\\w_2\end{pmatrix}\right) \qquad (\forall (w_1, w_2) \in V \oplus V)$$
  
$$\Leftrightarrow \operatorname{Re}(\mathbf{b}_V(w_1, w_1)) - \operatorname{Re}(\mathbf{b}_V(w_2, w_2)) > \operatorname{Re}(\mathbf{b}_V(gw_1, gw_1)) - \operatorname{Re}(\mathbf{b}_V(g^*w_2, g^*w_2))$$
  
$$\Leftrightarrow \begin{cases}\operatorname{Re}(\mathbf{b}_V(w_1, w_1)) - \operatorname{Re}(\mathbf{b}_V(gw_1, gw_1)) > 0\\\operatorname{Re}(\mathbf{b}_V(w_2, w_2)) - \operatorname{Re}(\mathbf{b}_V(g^*w_2, g^*w_2)) < 0\end{cases}$$

$$\Leftrightarrow \begin{cases} b_V(w,w) - b_V(gw,gw) > 0\\ b_V(w,w) - b_V(g^*w,g^*w) < 0 \end{cases} \quad (\forall w \in \operatorname{Re}(V,c) \setminus \{0\}) \\ \Leftrightarrow \quad F - g^* F g > 0 \end{cases}$$

**Example A.2.** We assume that  $V = \mathbb{C}^2$  and that the signature of  $b_V$  is (1, 1). The compact torus T is given by:

$$\mathbf{T} = \left\{ t = \begin{pmatrix} t_1 & 0\\ 0 & t_2 \end{pmatrix}, t_1, t_2 \in \mathbf{U}(1, \mathbb{C}) \right\}.$$

and then, using the notations of Section 7,

$$\mathbf{F} - \vec{t}' \, \mathbf{F} \, t < 0 \Leftrightarrow \mathrm{Id}_{1,1} - \begin{pmatrix} \vec{t}_1 & 0\\ 0 & \vec{t}_2 \end{pmatrix} \mathrm{Id}_{1,1} \begin{pmatrix} t_1 & 0\\ 0 & t_2 \end{pmatrix} > 0 \Leftrightarrow \begin{pmatrix} 1 - |t_1|^2 & 0\\ 0 & |t_2|^2 - 1 \end{pmatrix} > 0,$$

i.e.  $t \in \mathbf{T}^{++} \Leftrightarrow |t_1| < 1$  and  $|t_2| > 1$ .
