# Converged ab initio calculations of heavy nuclei

#### Abstract

We propose a novel storage scheme for three-nucleon (3N) interaction matrix elements relevant for the normal-ordered two-body approximation used extensively in ab initio calculations of atomic nuclei. This scheme reduces the required memory by approximately two orders of magnitude, which allows the generation of 3 N interaction matrix elements with the standard truncation of $E_{3 \text { max }}=28$, well beyond the previous limit of 18 . We demonstrate that this is sufficient to obtain the ground-state energy of ${ }^{132} \mathrm{Sn}$ converged to within a few MeV with respect to the $E_{3 \text { max }}$ truncation. In addition, we study the asymptotic convergence behavior and perform extrapolations to the un-truncated limit. Finally, we investigate the impact of truncations made when evolving free-space 3 N interactions with the similarity renormalization group. We find that the contribution of blocks with angular momentum $J_{\text {rel }}>9 / 2$ to the ground-state energy is dominated by a basis-truncation artifact which vanishes in the large-space limit, so these computationally expensive components can be neglected. For the two sets of nuclear interactions employed in this work, the resulting binding energy of ${ }^{132} \mathrm{Sn}$ agrees with the experimental value within theoretical uncertainties. This work enables converged ab initio calculations of heavy nuclei.


## I. INTRODUCTION

With recent progress in constructing two- (NN) and three-nucleon (3N) interactions [1, 2], solving the nuclear many-body problem [3-9], and rapid increases in computational power, the range of applicability of ab initio calculations of atomic nuclei has exploded over the past decade [10]. On the side of nuclear interactions, it has become clear that a consistent treatment of NN scattering and finite nuclei requires the inclusion of 3 N forces [1115], where chiral effective field theory $[1,2,16]$ provides a path to a consistent and systematic treatment.

On the many-body side, polynomially scaling methods, such as coupled-cluster theory [6], self-consistent Green's functions [7], and in-medium similarity renormalization group (IMSRG) [8] have been used to treat systems of up to $A \sim 100$ particles [17-19]. In all of these calculations, the wave function is expanded on a set of basis functions - typically the eigenstates of the harmonic oscillator-and the NN and 3 N matrix elements in that basis are needed as an input. The number of single-particle basis states in a calculation is given by the truncation $e=2 n+\ell \leq e_{\max }$, with the radial quantum number $n$ and angular momentum $l$. Achieving convergence in both the infrared (IR) and ultraviolet (UV) for medium-mass nuclei typically requires $e_{\max } \gtrsim 12$. At even $e_{\max }=12$, however, storing the full set of 3 N matrix

[^0]elements would require approximately 10 TB of memory with single-precision floating point numbers, which considerably exceeds the available RAM per node on a typical supercomputer. It is therefore necessary to impose some additional truncation on the 3 N matrix elements, typically taken as $e_{1}+e_{2}+e_{3} \leq E_{3 \max }$. Ideally, the value of $E_{3 \text { max }}$ is increased until convergence is achieved for a given observable.

The current limit of $E_{3 \max } \lesssim 18$ is the primary bottleneck preventing ab initio calculations from reaching much beyond $A \sim 100$ [18, 20-22]. Overcoming this limit would significantly increase the reach of ab initio theory, e.g. to searches for physics beyond the standard model using heavy isotopes of xenon, tellurium, cesium, or mercury [23-29]. Furthermore, potential controlled calculations of ${ }^{208} \mathrm{~Pb}$ would provide the best experimentally accessible link between finite nuclei and nuclear matter, particularly in light of recently reported parity-violating electron scattering experiments [30-32]. Ab initio predictions would even be possible for the astrophysically relevant, but experimentally challenging, $N=126$ region below ${ }^{208} \mathrm{~Pb}$ [33-35].

One way to overcome this limitation is to apply an importance truncation and/or tensor factorization [36, 37] to the 3 N matrix elements, which would dramatically reduce the required RAM while retaining sufficient accuracy. Before resorting to these techniques, however, we observe that the most of today's practical calculations are based on the normal-ordered two-body (NO2B) approximation [38]. This means we do not need the full set of 3 N matrix elements in actual applications, particularly in the heavy-mass region. In this work, we demonstrate the efficiency of generating and storing only those combinations of 3 N matrix elements involved in the NO2B ap-

proximation and discuss the $E_{3 \text { max }}$ convergence of heavy nuclei around ${ }^{132} \mathrm{Sn}$.

The structure of this paper is as follows. In Sec. II, we introduce a novel procedure to store the 3 N matrix elements relevant to the NO2B approximation. In Sec. III, the asymptotic behavior with respect to $E_{3 \text { max }}$ is discussed. In Sec. IV, we demonstrate large $E_{3 \text { max }}$ calculations around ${ }^{132} \mathrm{Sn}$, using the well-established $\mathrm{NN}+3 \mathrm{~N}$ 1.8/2.0 (EM) interaction [39]. We also discuss the uncertainty from free-space 3 N similarity renormalization group (SRG) evolution and present results for ${ }^{132} \mathrm{Sn}$ with the chiral NN $+3 \mathrm{~N}(\operatorname{lnl})$ interaction [40]. Finally, we conclude in Sec. V.

## II. CALCULATION OF 3N MATRIX ELEMENTS

In Figure 1 we show the estimated file size of the 3 N matrix elements as a function of $E_{3 \max }$ for a fixed $e_{\max }=16$. The curve "full" illustrates that the typical basis-size limit is approximately $E_{3 \text { max }}=16-18$ for a memory limit of about 100 GB . This limit, however, is typically not sufficient to obtain converged results for nuclei beyond $A=100$ as discussed in Refs. [18, 20-22, 41], and which we also demonstrate below. Towards heavier systems, the contributions of the residual 3 N interactions is expected to be comparable to the truncation error of the many-body method [42]. Since the memory requirement for storing the full set of 3 N matrix elements is prohibitive, we instead aim to exploit the simplifications offered by the NO approximation. In order to identify the minimal subset of 3 N matrix elements for the NO2B Hamiltonian, we begin by reviewing the normal-ordering procedure.

## A. NO2B 3N matrix elements

Our starting Hamiltonian in second-quantized form is

where $t_{p^{\prime} p}, V_{p^{\prime} q^{\prime} p q}^{\mathrm{NN}}$, and $V_{p^{\prime} q^{\prime} r^{\prime} p q r}^{3 \mathrm{~N}}$ are the one-, two, and three-body matrix elements, respectively. The index $p$ labels the single-particle orbit with quantum numbers $\left\{n_{p}, \ell_{p}, j_{p}, m_{p}, t_{z_{p}}\right\}$ corresponding to the radial quantum number, orbital angular momentum, total angular momentum, total angular momentum projection, and isospin projection, respectively. Performing normal ordering with respect to a reference state characterized by a one-body density matrix $\rho_{p^{\prime} p}=\left\langle a_{p^{\prime}}^{\dagger} a_{p}\right\rangle$ and discarding the residual 3 N part, we obtain the NO2B Hamiltonian:

where the braces $\{\ldots\}$ indicate that the enclosed string of creation and annihilation operators are normal-ordered with respect to the used reference state. The Hamiltonian is now expressed in terms of a zero-body part

The accuracy of the NO2B approximation has been investigated for ground state energies [38, 42, 43], where it was found that by ${ }^{16} \mathrm{O}$ the error is at the level of $1 \%$ of the binding energy. With increasing mass number, this error should decrease as a fraction of the total binding energy ${ }^{1}$.

[^1]If the one-body density matrix $\rho_{p p^{\prime}}$ is rotationally invariant and conserves parity and isospin projection, it must satisfy $\left(\ell_{p^{\prime}}, j_{p^{\prime}}, m_{p^{\prime}}, t_{z_{p^{\prime}}}\right)=\left(\ell_{p}, j_{p}, m_{p}, t_{z_{p}}\right)$, and the number of required 3 N matrix elements is drastically smaller than that of the original full set. This condition is satisfied for single-reference calculations (e.g. coupled cluster, self-consistent Green's function, IMSRG, HF-MBPT) with a closed-shell reference, as well as for particle-attached and particle-removed methods [6], and the ensemble normal ordering reference used in the valence-space IMSRG [44]. On the other hand, for broken-symmetry [45, 46] or multi-configurational [47, 48] references necessary to describe e.g. well-deformed nuclei, this would constitute an additional approximation.

Furthermore, in the practically used $J T$-coupled representation, we can sum up the 3 N total angular momentum dependence. This can be seen in the $J$-coupled expression for the normal-ordered matrix element, the full expressions for which are provided in Appendix A. Here we show only the contributions from the three-nucleon interactions $V^{3 \mathrm{~N}}$ (with the notation $[x] \equiv 2 x+1$, and using un-normalized matrix elements):

We can see that in Eq. (6) all terms depend on $V^{3 \mathrm{~N}}$ through the quantity

where the symbol $\tilde{\delta}_{r^{\prime} r}$ is shorthand for all the quantum numbers which are conserved by the one-body density matrix $\rho_{r^{\prime} r}$. If, instead of the full $V^{3 \mathrm{~N}}$, we only store the quantity (7), we obtain the curve "NO2B" in Fig. 1, allowing us to access $E_{3 \max }=26$ (28) using single- (half-) precision floating point numbers.

Note that for a Hartree-Fock (HF) calculation, we only need the combination

The number of matrix elements (8) is sufficiently low that we can store the full $\overline{\mathcal{V}}_{p^{\prime} q^{\prime} r^{\prime} p q r}$ without any $E_{3 \max }$ truncation. However, we find that the HF part of the calculation converges at lower $E_{3 \max }$ than the beyond-mean-field corrections, which is why we store the quantity $\mathcal{V}_{p^{\prime} q^{\prime} r^{\prime} p q r}^{J_{p q}}$.

A similar idea was employed in Ref. [20]. However, in that work an iterative procedure was adopted in
which a HF calculation was performed at a manageable $E_{3 \max }=14$, and then the lab-frame matrix elements necessary for the NO2B approximation for larger $E_{3 \max }$ were computed from the relative-basis matrix elements, and the procedure was iterated until self consistency was attained. In our approach, the transformation to the lab frame is performed once, and the resulting matrix elements $\mathcal{V}$ are written to disk and can be used for future calculations of any desired nucleus, without the need for iteration.

## B. Transformation to single-particle coordinate

Although we can compress the file size by calculating only the NO2B relevant matrix elements via Eq. (7), we still need an efficient way to perform the transformation from the three-body Jacobi basis to single-particle basis. Originally, this transformation was derived for the threenucleon single-particle $m$-scheme basis [12, 49]. Memory requirements for the $m$-scheme storage limited calculations to $E_{3 \text { max }}=9$. Later, a $j$-coupled storage scheme was introduced [50, 51] that allowed calculations with $E_{3 \text { max }} \lesssim 18$ as discussed in the introduction with file size requirements illustrated in Fig. 1. Here, we specify the angular momentum coupling in detail. The antisymmetrized three-body states in the lab frame are defined as

defined in terms of the permutation operator $P_{i j}$. In Eq.(9), the symbol $\mathcal{C}$ indicate a Clebsch-Gordan coefficient. A state in the antisymmetrized Jacobi basis is denoted $\left|N i J_{\text {rel }}\right\rangle$, with total oscillator quanta $N$, total angular momentum $J_{\text {rel }}$, and an additional quantum number $i$ to distinguish the states. The transformation from the Jacobi basis to the lab frame may be expressed as

The quantity $\left\langle N_{\mathrm{cm}} L_{\mathrm{cm}} N i J_{\text {rel }}: J T \mid p q r: J_{p q} T_{p q} J T\right\rangle$ denotes the transformation coefficient. The quantum numbers $N_{\mathrm{cm}}$ and $L_{\mathrm{cm}}$ are the radial nodes and orbital angular momentum of the center-of-mass (c.m.) motion. The
summations over $N, i, N^{\prime}, i^{\prime}$ can be performed efficiently by matrix-matrix multiplication, and the remaining summations over $N_{\mathrm{cm}}, L_{\mathrm{cm}}$ and $J_{\text {rel }}$ can be computed manually.

The transformation coefficient can be calculated through the non-antisymmetrized Jacobi state:

The index $\alpha$ labels the set of Jacobi quantum numbers $\alpha=\left\{n_{12}, l_{12}, s_{12}, j_{12}, t_{12}, n_{3}, l_{3}, j_{3}\right\}$. The quantum num-
bers $\left\{n_{12}, l_{12}, s_{12}, j_{12}, t_{12}\right\}$ are used for the relative motion of nucleons 1 and 2, i.e., the nodal, orbital angular momentum, spin, total angular momentum, and total isospin quantum numbers, respectively. Similarly, the quantum numbers $\left\{n_{3}, l_{3}, j_{3}\right\}$ correspond to the motion of nucleon 3 with respect to the c.m. of nucleons 1 and 2 . Since the antisymmetrized state $\left|N i J_{\text {rel }}\right\rangle$ is an eigenstate of the antisymmetrizer $\mathcal{A}$, the coefficient $\left\langle N i J_{\text {rel }} \mid N \alpha J_{\text {rel }}\right\rangle$ is also known as the coefficient of fractional parentage $[52,53]$. The coefficient $\left\langle N_{\mathrm{cm}} L_{\mathrm{cm}} N \alpha J_{\mathrm{rel}}: J T\right| p q r$ : $\left.J_{p q} T_{p q} J T\right\rangle$ is known as the $T$-coefficient [49, 51], and is the bottleneck of the calculation. It turns out one can sum up three of the angular momentum sums in Eq. (B11) in Ref. [49] $\left(S_{3}, L_{3}, \mathcal{L}\right)$ and obtain a significantly more efficient expression for the $T$-coefficient:

Here, as above, we use the notation $[x] \equiv 2 x+1$ and the usual $6-j$ and $9-j$ symbols are used. In addition, we use a $12-j$ symbol of the first kind [54], and $\langle\ldots \mid \ldots\rangle_{d}$ is TalmiMoshinsky bracket with mass ratio $d$ [55]. For efficiency, $12-j$ symbols are calculated on the fly from cached $6-j$ symbols [54]. We have also used $s_{p}=s_{q}=s_{r}=1 / 2$. While (13) is a complicated expression, it involves four nested summations (including the expansion of the $12-j$ symbol; the sum over $N_{12}$ is trivial by energy conservation), rather than the six needed for the expression in Refs. [49, 51].

Our implementation of the above expressions allows us to generate all the lab-frame three-body matrix elements (with half-precision floating point numbers) needed for a calculation employing the NO2B approximation with a spherical reference state up to $E_{3 \text { max }}=28$ using $\sim 10^{5}$ CPU hours with 187 GB RAM per node. Importantly, this step only needs to be done once for a given interaction. Subsequent many-body calculations for different nuclei, or using different methods can be performed using the same file.

## III. CONVERGENCE BEHAVIOR

Before presenting results for heavy nuclei, we consider the expected convergence behavior of ground-state energies with increasing $E_{3 \text { max }}$. Knowing the asymptotic behavior enables a controlled extrapolation to $E_{3 \max } \rightarrow$
$3 e_{\max }$. Convergence in $E_{3 \text { max }}$ is distinct from the convergence in $e_{\max }$ (or $N_{\text {max }}$ in the no-core shell model) discussed in Refs. [56, 57], in that the latter deals with a truncation of the Hilbert space, while the former is a truncation on the Hamiltonian. This means we do not even have an approximate variational principle to rely on. To simplify the analysis, we assume that for the soft interactions we consider here, the main contribution to the correlation energy comes from second-order perturbation theory. Also we assume that $E_{3 \max }$ is sufficiently large that the HF wave function is converged. The secondorder energy correction is

where $\Gamma_{a b i j}$ contains both two-body and three-body contributions, c.f. (5). Here $i, j$ and $a, b$ run over hole and particle states, respectively. We can simplify the evaluation by approximating the single-particle energies by the harmonic oscillator energy with the proper energy scale: $\epsilon_{p}=e_{p} \hbar \omega$ with $e_{p}=2 n_{p}+l_{p}$ and $\hbar \omega$ the optimal oscillator frequency. The subscript $p$ indicates either hole or particle state. We have confirmed that this replacement does not affect the asymptotic behavior. By increasing the value of $E_{3 \max }$ by one unit the second-order energy
changes by
$\Delta E^{[2]} \approx \frac{1}{2} \sum_{a b i j k} \frac{V_{a b i j}^{\mathrm{NN}} V_{i j k a b k}^{3 \mathrm{~N}}}{\left(e_{i}+e_{j}+e_{k}-E_{3 \max }\right) \hbar \omega} \delta_{E_{3 \max }, e_{a}+e_{b}+e_{k}}$,
where we have assumed $\left\|V^{\mathrm{NN}}\right\| \gg\left\|V^{3 \mathrm{~N}}\right\|$ and retained only the term linear in $V^{3 \mathrm{~N}}$. The interactions we are interested in are regularized by cutoff functions of the form $\exp \left(-Q^{2 n} / \Lambda^{2 n}\right)$, where $Q$ is a momentum scale, $\Lambda$ the cutoff scale and $n$ some positive power $n$. Depending on the nature of the 3 N interaction, $Q$ can be the momentum transfer or the sum of the Jacobi momenta of the form $Q^{2}=k_{1}^{2}+3 k_{2}^{2} / 4+k_{1}^{\prime 2}+3 k_{2}^{\prime 2} / 4$, where $k_{i} / k_{i}^{\prime}$ are the Jacobi momenta of the initial/final state (see [15] for details). Then, it is reasonable to assume that the off-diagonal matrix elements are suppressed as:

with the cutoff for $\mathrm{NN}(3 \mathrm{~N})$ interaction $\Lambda_{\mathrm{NN}}\left(\Lambda_{3 \mathrm{~N}}\right)$ and the scale of the NN $(3 \mathrm{~N})$ interaction $\bar{V}^{\mathrm{NN}}\left(\bar{V}^{3 \mathrm{~N}}\right)^{2}$. For the sake of simplicity, we also assume $n_{\mathrm{NN}}=n_{3 \mathrm{~N}} \equiv n$ in the following. The above suppression is also found in SRG-evolved potentials [58]. To further simplify, we take the most relevant excitations, i.e., excitations from the Fermi level (with energy $e_{F}$ ) to the unoccupied orbits. In this case the numerator in both (16) and (17) become, when combined with the $\delta$ in (15), equal to $E_{3 \max }-3 e_{F}$. Introducing the new scale factor $1 / \sigma^{n}=m^{n} \epsilon_{0}^{n}\left(1 / \Lambda_{\mathrm{NN}}^{2 n}+\right.$ $1 / \Lambda_{3 \mathrm{~N}}^{2 n}$ ) and taking the summation explicitly, we obtain the form

with $X=\left(E_{3 \max }-\mu\right), \mu \approx 3 e_{\mathrm{F}}$. We expect the correction $E^{[2]}$ to be a smooth function of $E_{3 \text { max }}$ in the asymptotic limit, and so we treat the difference $\Delta E^{[2]}$ as a derivative and integrate to obtain the form of $E^{[2]}$ :

[^2]with $x=\left[\left(E_{3 \max }-\mu\right) / \sigma\right]^{n}$. Here, $\gamma_{s}(x)$ is the incomplete gamma function:

It turns out that the functions $\gamma_{\frac{1}{n}}(x), \gamma_{\frac{2}{n}}(x), \gamma_{\frac{3}{n}}(x)$ show the same asymptotic behavior, and are therefore redundant for our purposes, so we may simply retain one of the $\gamma$ functions in (19), and we choose $\gamma_{\frac{2}{n}}(x)$. Assuming that the HF energy is well converged with respect to $E_{3 \text { max }}$, the formula for the $E_{3 \text { max }}$ extrapolation is

It remains to select a reasonable value of the power $n$ entering in (21). An SRG-evolved interaction will go as $\exp \left[-s\left(k^{2}-k^{2}\right)^{2}\right]$ [58] with relative momenta $k$ and $k^{\prime}$, which suggests a value $n=2$. For the interaction under consideration, $1.8 / 2.0(\mathrm{EM})$, the 3 N force is not SRG evolved, but instead comes with a regulator $\sim \exp \left[-\left(Q^{2} / \Lambda^{2}\right)^{4}\right]$ [39], suggesting $n=4$. We deal with this ambiguity by checking $n=2,4,6$ to explore the sensitivity to the choice.

Furthermore, from the perturbative expansion of onebody density matrix, we can expect the same $E_{3 \max }$ asymptotic behavior for the expectation value of the mean-squared radius operator $\left\langle r^{2}\right\rangle$, or any other predominantly one-body operator.

We emphasize that all the discussions are based on the softness of the employed nuclear interaction enabling us to derive the expression through the MBPT. For a harder interaction, where the MBPT breaks down, we may observe a different convergence pattern with respect to $E_{3 \text { max }}$.

## IV. NUMERICAL RESULTS

The many-body calculation methods used in the following are HF basis many-body perturbation theory (HF-MBPT) and IMSRG. For open-shell systems, we use the valence-space IMSRG (VS-IMSRG). For all the many-body methods, we store the usual NN and NO2B 3 N matrix elements in RAM, perform the HF calculation to optimize the single-particle basis, and obtain the normal ordered matrix elements (A12),(A13) and (A14). For open-shell systems, we use an ensemble reference for the normal ordering to capture the 3 N interaction effect of valence nucleons as much as possible within the spherical basis framework [44, 59]. In addition to the HF calculation, we evaluate the correlation energy with MBPT. Based on a soft nuclear interaction, it was shown that the computationally cheap second- or third-order MBPT can provide results comparable with those from the coupledcluster method [9, 60, 61]. We could confirm these results in our calculations, and so we use HF-MBPT for the calculations with a large $e_{\max }$ space, where the IMSRG is

considerably more expensive. Our IMSRG calculations are performed with the Magnus formulation [62], using the arctangent generator. Details of the method may be found in recent reviews [8, 59]. The IMSRG and VSIMSRG calculations are done with the imsrg++ [63] code, and the subsequent shell-model diagonalizations are done with the NuShellX@MSU [64] and KSHELL [65] codes.

## A. $E_{3 \text { max }}$ convergence around ${ }^{132} \mathbf{S n}$

Here, we investigate large- $E_{3 \text { max }}$ calculations around ${ }^{132} \mathrm{Sn}$ using the well-established $\mathrm{NN}+3 \mathrm{~N}$ interaction 1.8/2.0 (EM) [39], which accurately reproduces binding energies to $A \sim 100[17,66,67]$. We employ an oscillator basis with frequency $\hbar \omega=16 \mathrm{MeV}$, which is near the optimal value giving the most rapid $e_{\text {max }}$ convergence for the ground-state energies and radii of the medium-mass nuclei (converged results are independent of $\hbar \omega$ ) [66].

One important feature of the 1.8/2.0 (EM) interaction for our purposes is that, while the NN force is softened by a free-space similarity renormalization group (SRG) evolution to a scale $\lambda_{\mathrm{SRG}}=1.8 \mathrm{fm}^{-1}$, the corresponding 3 N interactions are not SRG evolved. Instead, the cutoff is chosen to be $\Lambda_{3 \mathrm{~N}}=2.0 \mathrm{fm}^{-1}$ and the short-range lowenergy constants $c_{D}$ and $c_{E}$ are refit to the triton binding energy and ${ }^{4} \mathrm{He}$ radius. This means that we can avoid SRG evolution of the 3 N interaction, which introduces additional challenges due to basis truncations (we address these in section IV B).

In Fig. 2 we show the ground-state energy of ${ }^{132} \mathrm{Sn}$ calculated with HF-MBPT and IMSRG as a function of $E_{3 \text { max }}$. The non-variational nature mentioned above is evident, and is present even at the mean-field level. We see that truncations at $E_{3 \max }=22$ or 24 are sufficient to obtain convergence within a few MeV . For all points

in Fig. 2, the 3N matrix elements are stored and read in using half-precision floating point numbers to reduce the memory footprint. Up to $E_{3 \max }=24$, we can use singleprecision numbers to check the impact of this choice. At $e_{\text {max }}=14, E_{3 \text { max }}=24$, the half-precision calculation yields HF energies shifted by -2.14 MeV , while the second- and third-order MBPT corrections are changed by 0.68 MeV and 0.11 MeV , respectively, yielding a total difference up to third order of -1.35 MeV . This is completely negligible compared with uncertainties aris-

ing from many-body truncations (which we expect to be on the order of 20 MeV here $^{3}$ ) and the interaction itself. We also show in Fig. 2 the convergence with respect to $e_{\max }$. At $E_{3 \max }=28$, the third-order energies for $e_{\max }=14,16,18$, are $-1115.85 \mathrm{MeV},-1117.61 \mathrm{MeV}$, and -1118.16 MeV , respectively, demonstrating convergence at the 1 MeV level.

Since the second-order correction of $\sim-300 \mathrm{MeV}$ is much larger than third-order correction of $\sim-20 \mathrm{MeV}$, the correlation energy is dominated by second-order correction. This supports the claim that the extrapolation formula Eq. (21) based on the second-order energy correction is applicable in the case of the $\operatorname{HF-MBPT}(3)$ and IMSRG, which includes correlations beyond second order. In panel (a) of Fig. 3, we show $n=2,4,6$ curves of Eq. (21) fitted with the HF-MBPT(2) and IMSRG energy results at $e_{\max }=14$, indicated by the solid symbols in the panel. We see that Eq. (21) works for IMSRG energies as well. Panels (b) and (c) show the extrapolated energies to $E_{3 \max }=28$, which is the largest value we can calculate. Since the extrapolated point is finite, the uncertainty of all the fitting parameters can propagate to uncertainty of the extrapolated energies. The uncertainty of the energy is estimated as the standard deviation of the 10000 samples generated with the covariance matrix from the fit. Comparing the extrapolated and calculated energies, we see that $n=2$ (Gaussian) reproduces the energies for both HF-MBPT(2) and IMSRG cases, and $n=2$ is the most likely to reproduce the convergence behavior in this case. With $n=2$ formula, we

observed that the extrapolated energy to $E_{3 \text { max }}=42$ is $-1110.57(2)[-1097.13(2)] \mathrm{MeV}$ using the IMSRG [HF$\operatorname{MBPT}(2)]$ data $18 \leq E_{3 \text { max }} \leq 23$.

As already mentioned in Sec. I, we have observed a lack of convergence with respect to $E_{3 \max }$ in some calculations of heavier systems. One particular example is ${ }^{127} \mathrm{Cd}$ as discussed in Ref. [21]. We revisit the calculations in that work, obtained with the VS-IMSRG, and extend them to larger $E_{3 \max }$. Here, our singleparticle basis truncation is $e_{\max }=14$, and we take the valence space as $\left\{1 p_{3 / 2}, 1 p_{1 / 2}, 0 f_{5 / 2}, 0 g_{9 / 2}\right\}$ for protons and $\left\{1 d_{5 / 2}, 2 s_{1 / 2}, 1 d_{3 / 2}, 0 g_{7 / 2}, 0 h_{11 / 2}\right\}$ for neutrons above ${ }^{78} \mathrm{Ni}$ core. As seen in Fig 4, by $E_{3 \max }=28$ we obtain convergence in excitation energies at the level of 5 keV . With the previous limit of $E_{3 \max }=18$ there is no sign of convergence. This behavior can be understood by noting that the $h_{11 / 2}$ orbit with $e \geq 5$, is impacted by the $E_{3 \text { max }}$ cut differently than the other neutron valence orbits which have $e \geq 4$, and that the parity of a state is driven by the occupation of the $h_{11 / 2}$. An analogous argument applies to the proton orbits.

In contrast, when two states have the same number of oscillator quanta in their naive configurations, we expect that their convergence with respect to $E_{3 \text { max }}$ will be similar and so the energy difference will be less sensitive to the $E_{3 \text { max }}$ truncation. To illustrate this, we present in the top panel of Fig 5 the first $2^{+}$excitation energies of even-mass tin isotopes, obtained with the VS-IMSRG. The valence space is $\left\{1 p_{3 / 2}, 1 p_{1 / 2}, 0 f_{5 / 2}, 0 g_{9 / 2}\right\}$ for protons and $\left\{2 s_{1 / 2}, 1 d_{3 / 2}, 0 h_{11 / 2}, 1 f_{7 / 2}\right\}$ for neutrons above a ${ }^{92} \mathrm{Ni}$ core, indicated by the open symbols in the figure. During the IMSRG evolution, the center-of-mass (c.m.) motions are separated with the Glöckner-Lawson prescription [69] with the coefficient $\beta=3$, and we observe the stability with respect to $\beta$ (see [70] for a detailed discussion). The ground-state energies are converged within approximately 2 MeV . It is clear from the figure that the
$2^{+}$energies show convergence as $E_{3 \text { max }}$ is increased and $E_{3 \text { max }}=18$ is sufficient to see the systematics of the $2^{+}$energies. We note that the $2^{+}$energy of ${ }^{132} \mathrm{Sn}$ at $E_{3 \text { max }}=18$ and 24 differ by 200 keV . We successfully reproduce the $A$-independent excitation energies of the open-shell nuclei, consistent with the seniority picture. In fact, the analysis of the calculated wave function of ${ }^{126-130}$ Sn reveals that our valence-space wave functions of ground and first $2^{+}$states are dominated more than $70 \%$ by the seniority $v=0$ and $v=2$ states, respectively ${ }^{4}$. The relatively fast convergence of the excitation energies with respect to $E_{3 \text { max }}$ reflects the fact that both the ground and excited states are dominated by configurations with the same occupancies in the oscillator basis. On the other hand, the excitation at $N=82$ is dominated by a single neutron excitation $0 h_{11 / 2} \rightarrow 1 f_{7 / 2}$. As these orbits have the same naive number of oscillator quanta, dependence on the $E_{3 \max }$ is still mild. The predicted excitation energy is about 1.5 MeV above the experimental value, which is attributed to the $\operatorname{IMSRG}(2)$ approximation, as seen in earlier works [66, 71]. Efforts to go beyond the $\operatorname{IMSRG}(2)$ approximation are underway [72].

Finally, we consider the convergence behavior of pointproton and point-neutron radii through the HartreeFock, second-order HF-MBPT, and IMSRG(2). The diagrams taken into account in the second-order HF-MBPT are listed in Appendix B. The charge radii of several isotopes including ${ }^{132} \mathrm{Sn}$ were recently computed with the self-consistent Green's function method using chiral forces up to $e_{\max }=13$ and $E_{3 \max }=16$ [18]. We compute point-proton and point-neutron root-mean-squared radii and the neutron skin of ${ }^{132} \mathrm{Sn}$ as a function of $E_{3 \max }$, and plot the result in Fig. 6. We see that convergence is achieved by $E_{3 \max } \sim 22$. The corresponding converged charge radii are $r_{c h}=4.43 \mathrm{fm}$ and 4.42 fm with IMSRG and second-order HF-MBPT, respectively, demonstrating that the effect of the many-body truncation is controllable for radii. Eq. (21) with $n=2$ reasonably captures the asymptotic convergence behavior of radii. Also we note that the often-used $\mathrm{N}^{2} \mathrm{LO}_{\text {sat }}$ interaction is harder than the interaction employed here, and thus we would expect the calculations with $\mathrm{N}^{2} \mathrm{LO}_{\text {sat }}$ will show slower convergence with respect to $E_{3 \max }$. Our converged neutron skin with $\operatorname{IMSRG}(2)$ is $0.2202(4)$-where the quoted uncertainty only accounts for the $E_{3 \max }$ truncationconsistent with the (model-dependent) extraction [73] of $0.24(4)$.

## B. SRG evolved $\mathrm{NN}+3 \mathrm{~N}$ interaction

The NN and 3N contributions to the 1.8/2.0 (EM) interaction, used for the calculations discussed in the previous section, are defined at different cutoff and resolution scales. For a more systematic convergence study of the calculations it would be desirable explore the resolutionscale and cutoff dependence of observables. Using interactions with a higher cutoff, observables in heavy nuclei will be impossible to converge in the largest feasible model spaces, even with the advances discussed in this work. Therefore, these interactions first need to be softened via a free-space SRG evolution [74] (or some other procedure [75-77]). For the following calculations we

evolve NN and 3N sectors consistently in the harmonicoscillator basis space. For the NN sector, the evolution is done within the space spanned by the principle quantum number of the relative motion up to 200. Assuming our typical basis frequency of a few tens MeV , the UV scale of this space is a few $\mathrm{GeV} / c$-sufficiently larger than the typical momentum scale of $\sim 500 \mathrm{MeV} / c$ of the bare NN interaction from the chiral EFT, and we can safely evolve the NN Hamiltonian.

For the 3 N sector, we evolve the 3 N Hamiltonian within the space defined by the three-body principle quantum number $N_{3 \text { max }}$, the sum of the principle quantum numbers of the motions for corresponding Jacobi variables. Since the 3 N evolution is computationally demanding compared to the NN evolution, we cannot handle a value of $N_{3 \text { max }}$ well beyond the typical nuclear interaction scale. We therefore need to investigate the $N_{3 \text { max }}$ dependence as we move to heavier systems, as done in Ref. [20]. In the following, we use the chiral $\mathrm{N}^{3} \mathrm{LO}$ NN interaction from Entem and Machleidt [78] and the $\mathrm{N}^{2} \mathrm{LO}$ 3 N interaction with both local and non-local regulators developed in Ref. [40] denoted as $\mathrm{NN}+3 \mathrm{~N}(\operatorname{lnl})$.

In Fig. 7 we show the ground-state energy of ${ }^{132} \mathrm{Sn}$ as a function of $N_{3 \max }$. Because the Hamiltonian is block diagonal in the relative angular momentum $J_{\text {rel }}$, we can apply a different $N_{3 \text { max }}$ cut to each $J_{\text {rel }}$ block. We include all channels up to $J_{\text {rel }} \leq E_{3 \max }+3 / 2=47 / 2$, which is the highest value that can contribute. To simplify the analysis, we divide the $J_{\text {rel }}$ blocks into low- $J\left(J_{\text {rel }} \leq 13 / 2\right)$, middle- $J\left(15 / 2 \leq J_{\text {rel }} \leq 21 / 2\right)$, and high- $J\left(J_{\text {rel }} \geq 23 / 2\right)$
partitions, and vary $N_{3 \max }$ for each partition. The SRG evolution is run to a scale of $\lambda_{\mathrm{SRG}}=2.0 \mathrm{fm}^{-1}$, working with a basis frequency $\hbar \omega=30 \mathrm{MeV}$. After the evolution, the frequency is converted to $\hbar \omega=15 \mathrm{MeV}$ for the manybody calculations (see Ref. [51] for details). The manybody calculations are done with third-order HF-MBPT with lab-frame truncations $e_{\max }=16$ and $E_{3 \max }=22$. In Fig. 7 we see that the low- $J$ and high- $J$ partitions are converged within the level of a few MeV by $N_{3 \text { max }}=48$ and $N_{3 \text { max }}=42$, respectively, while the middle- $J$ region converges more slowly. To our knowledge, these are the largest $N_{3 \text { max }}$ spaces explored in the literature. It appears that SRG evolution of the $J_{\text {rel }} \gtrsim 15 / 2$ blocks such that heavy nuclei are converged with respect to $N_{3 \max }$ will not be possible in the near term without further technical developments.

An alternative truncation scheme we can explore is the maximum value of $J_{\mathrm{rel}}$. Since the nuclear interaction is short range, we naively expect that the high $J_{\text {rel }}$ components are suppressed by the angular momentum barrier. In the top panel of Fig. 8, the ground-state energy of ${ }^{132} \mathrm{Sn}$ is shown as a function of the maximum $J_{\text {rel }}$ included in the transformation Eq. (11). The points labeled "Full" use a uniform $N_{3 \max }$ for all blocks up to $J_{\text {rel }}=47 / 2$. Again, energies are computed with HF$\operatorname{MBPT}(3)$ at $\hbar \omega=15 \mathrm{MeV}, e_{\max }=16$, and $E_{3 \max }=22$. We observe that as we increase $N_{3 \text { max }}$, the contribution of channels with $J_{\text {rel }}>9 / 2$ becomes essentially negligible.

In order to extrapolate to $N_{3 \max } \rightarrow \infty$, we fit the calculated energies with an exponential function $E=$ $a \exp \left(-b N_{3 \max }\right)+E_{\infty}$ as shown in the middle panel. In the fitting procedure, we used the energies at $N_{3 \max }=$ $36,38,40,42,44$, and used the $N_{3 \text { max }}=48$ points to validate the assumed functional form. ${ }^{5}$ The $N_{3 \max }$ extrapolated energies are shown in the bottom panel. The agreement of calculated and extrapolated energies at $N_{3 \max }=48$ validates the fitting formula employed here. The final energy obtained by extrapolating the "full" results to $N_{3 \text { max }} \rightarrow \infty$ is $-1105.6(15) \mathrm{MeV}$, which agrees within the error bars with the extrapolated energies from $\max \left(J_{\text {rel }}\right)=9 / 2,11 / 2,13 / 2$ results. This reinforces the observation that the contributions from channels with $J_{\text {rel }}>9 / 2$ are negligible in the $N_{3 \max } \rightarrow \infty$ limit.

This result is somewhat surprising as it suggests that we can obtain a more accurate result by neglecting the high- $J_{\text {rel }}$ sector altogether than we can by evolving it in the largest space we can manage. Evidently, the main impact of the high- $J_{\text {rel }}$ matrix elements is to introduce an artifact due to the $N_{3 \max }$ truncation, which is removed in the limit $N_{3 \max } \rightarrow \infty$. To investigate the origin of this artifact, in Fig. 9 we hold fixed $N_{3 \max }=48$ for the $J_{\text {rel }} \leq 13 / 2$ partition, and plot the expectation values $\left\langle T+V^{\mathrm{NN}}\right\rangle,\left\langle V_{\text {ind }}^{3 \mathrm{~N}}\right\rangle,\left\langle V_{\text {gen }}^{3 \mathrm{~N}}\right\rangle$, and $\langle H\rangle$ as a function of the

$N_{3 \text { max }}$ cut applied to the $J_{\text {rel }} \geq 15 / 2$ partition. Here $T$ is the relative kinetic energy, $V^{\mathrm{NN}}$ is the evolved NN potential, $V_{\text {ind }}^{3 \mathrm{~N}}$ is the induced 3 N potential, $V_{\text {gen }}^{3 \mathrm{~N}}$ is the evolved "genuine" 3 N potential, and $H$ is the transformed Hamiltonian obtained by summing all of the kinetic and potential terms. The expectation values are taken in a naive harmonic oscillator ground state of ${ }^{132} \mathrm{Sn}$.

At $N_{3 \text { max }}=0$, corresponding to the $J=13 / 2$ point in Fig. 8, we obtain a bound energy. With increasing $N_{3 \max }$ the energy shoots up to 15 GeV , driven by the $\left\langle V_{\text {ind }}^{3 \mathrm{~N}}\right\rangle$ component, before converging back towards the

$N_{3 \max }=0$ value. It appears that the impact the high$J_{\text {rel }}$ matrix elements are negligible. Similar behavior is found in ${ }^{78} \mathrm{Ni}$, where the fully-converged and $N_{3 \max }=0$ HF energies differ by 0.3 MeV .

To further investigate the enormous contributions from induced 3 N interactions, we decompose $\left\langle V_{\text {ind }}^{3 \mathrm{~N}}\right\rangle$ into terms induced by transforming the one-pion exchange, two-pion exchange, and contact parts of $V_{\mathrm{NN}}$, as well as the kinetic energy. We find that at $N_{3 \max }=16$, all four of these induced terms contribute several GeV to the energy in Fig. 9, indicating that this behavior is generic and not tied to the detailed structure of the NN interaction. Further understanding of the mechanism of this large induced component should be pursued, as it may point the way to a more efficient treatment.

Through this analysis, we conclude that one can perform a more accurate 3N SRG evolution with a truncation in $J_{\text {rel }}$, rather than using all possible $J_{\text {rel }}$ channels without fully achieving the convergence with respect to $N_{3 \text { max }}$. We leave for future work the question of whether this holds for other operators.

Finally, we demonstrate that the asymptotic convergence in $E_{3 \text { max }}$ discussed in section III is also observed for a consistently SRG-evolved NN+3N interaction. In Fig. 10, we show the 3rd order HF-MBPT ground-state energy of ${ }^{132} \mathrm{Sn}$ as a function of $E_{3 \max }$, at multiple values of $N_{3 \text { max }}$ for the case $J_{\text {rel }} \leq 13 / 2$ (similar behavior is observed for $J_{\text {rel }} \leq 9 / 2$ ). In contrast to the unevolved case, we observe an increase in the energy for large $E_{3 \text { max }}$. This bump diminishes with increasing $N_{3 \max }$, indicating that the truncation artifact shows up most significantly in the large $E_{3 \text { max }}$ matrix elements, as would be expected. For each $E_{3 \text { max }}$, we extrapolate to $N_{3 \max } \rightarrow \infty$ using an exponential form, and we obtain the gray squares in Fig. 10 (the extrapolation uncertainties are smaller than the markers).

The extrapolated points still display a minimum as a

function of $E_{3 \text { max }}$ before converging to the final answer from below. The decreasing trend below $E_{3 \text { max }}=20$ is driven by the convergence of the HF energy, while the increase above $E_{3 \max }=20$ is driven by the second order MBPT correction. The fact that the energy converges from below in this case supports the assumption in section III that the asymptotic convergence in $E_{3 \text { max }}$ is driven by the $V_{N N}-V_{3 N}$ cross-term, which can be either positive or negative. The asymptotic behavior is fit well with a Gaussian with similar parameters (aside from the overal sign) to those in the unevolved case.

The extrapolated ground-state energy for ${ }^{132} \mathrm{Sn}$ is then $-1099.502(3) \mathrm{MeV}$, where this tiny uncertainty only accounts for the fit uncertainty in the $E_{3 \max }$ and $N_{3 \max }$ extrapolations. This uncertainty is clearly negligible compared with the many-body uncertainty (we only use third-order MBPT), the $e_{\max }$ truncation uncertainty, effects of induced 4 N forces, contributions from higher orders in the EFT expansion, and the fact that we use a half-precision floating point representation for storing the 3 N matrix elements. We note that the effect of the SRG induced many-body interactions can be accessed by checking the $\lambda_{\text {SRG }}$ dependence. Our almost-converged ${ }^{132} \mathrm{Sn}$ calculations at $e_{\max }=16$ and $E_{3 \max }=22$ show that the ground-state energy changes about 20 MeV within $\lambda_{\mathrm{SRG}}=1.8-2.2 \mathrm{fm}^{-1}$ range, which is at the $2 \%$ level of the total ground-state energy. As the other sources of uncertainty likely contribute at the level of a few tens of MeV , the $\mathrm{NN}+3 \mathrm{~N}(\operatorname{lnl})$ interaction is in excellent agreement with the experimental value of -1102.8 MeV [79], especially considering that it was fit to the properties of $A \leq 4$ nuclei.

## V. CONCLUSION

In this work we introduce a framework in which only 3 N matrix elements relevant for the NO2B approximation are stored in memory, which reduces the memory requirement by approximately two orders of magnitude. This enables us to generate lab-frame 3N matrix elements up to $E_{3 \max }=28$, significantly larger than the previous limit of $E_{3 \max }=18$. We further discussed the asymptotic behavior of the ground-state energy with respect to the $E_{3 \text { max }}$ truncation, which allows controlled extrapolations to $E_{3 \max }=3 e_{\max }$. To explore the applicability of the ab initio calculation, we empolyed the HF$\operatorname{MBPT}(2)$, $\mathrm{HF}-\mathrm{MBPT}(3)$, and $\operatorname{IMSRG}(2)$ to solve the many-body Schrödinger equation. Using the established 1.8/2.0 (EM) interaction, we obtained the ground-state energies converged at the level of 1 MeV (with respect to the $e_{\max }$ and $E_{3 \max }$ truncations) around ${ }^{132} \mathrm{Sn}$. As illustrated in the ${ }^{127} \mathrm{Cd}$ case, convergence in $E_{3 \text { max }}$ is essential not just for ground states but for spectroscopy as well. Even with this substantially larger lab-frame $E_{3 \text { max }}$ cut, as we move to the heavy-mass region, convergence with respect to truncations made in the freespace 3 N SRG evolution pose an additional challenge. Using the $\mathrm{N}^{3} \mathrm{LO} \mathrm{NN}+\mathrm{N}^{2} \mathrm{LO} 3 \mathrm{~N}(\operatorname{lnl})$ [40] interaction, we have demonstrated that a truncation $J_{\text {rel }} \lesssim 13 / 2$ is more accurate (not to mention less costly) for calculations of ground state energies than including larger $J_{\text {rel }}$, if full convergence in those channels cannot be achieved. A corresponding convergence analysis for excited states and other observables with respect to $J_{\text {rel }}$ remains future work.

This work lifts the primary limitation that has thus far kept ab initio calculations constrained to the $A \lesssim 100$ region. Among the studies that will be enabled are the neutron skin of ${ }^{208} \mathrm{~Pb}$ [80], neutrinoless double-beta decays and dark matter searches in germanium and selenium [81], as well as xenon [28] and tellurium [82], and investigations of nuclear matter parameters based on the response functions of heavy nuclei [83].

Here, $X_{p q r s}^{J}$ is the normalized antisymmetrized two-body matrix element of either Hamiltonian or scalar operator. In the following, we show the $J$-coupled expressions for the diagrams. As in the main text, we use the convention that $a, b, c, d$ label particle states and $i, j, k, l$ label hole states.

    Even with these forms, one can obtain Eq. (21) by introducing $X=E_{3 \max }+\mu, \mu \approx 2 e_{\mathrm{F}}$ and assuming the condition $E_{3 \text { max }} \gg$ $e_{\mathrm{F}}$.

[^3]:    3 This estimate is based on the difference between the $\operatorname{MBPT}(2)$, $\operatorname{MBPT}(3)$ and IMSRG(2) energies, and is consistent with Ref. [60] where the error at MBPT(3) for similarly soft interactions was found to be $0.1-0.2 \mathrm{MeV}$ per particle. We have further corroborated this estimate with $\operatorname{MBPT}(4)$ calculations in a smaller $e_{\text {max }}$ space.
