GLOBAL RENORMALISED SOLUTIONS AND EQUILIBRATION OF REACTION–DIFFUSION SYSTEMS WITH NON-LINEAR DIFFUSION

ABSTRACT. The global existence of renormalised solutions and convergence to equilibrium for reaction–diffusion systems with non-linear diffusion are investigated. The system is assumed to have quasi-positive non-linearities and to satisfy an entropy inequality. The difficulties in establishing global renormalised solutions caused by possibly degenerate diffusion are overcome by introducing a new class of weighted truncation functions.

By means of the obtained global renormalised solutions, we study the large-time behaviour of complex balanced systems arising from chemical reaction network theory with non-linear diffusion. When the reaction network does not admit boundary equilibria, the complex balanced equilibrium is shown, by using the entropy method, to exponentially attract all renormalised solutions in the same compatibility class. This convergence extends even to a range of non-linear diffusion, where global existence is an open problem, yet we are able to show that solutions to approximate systems converge exponentially to equilibrium uniformly in the regularisation parameter.

1. INTRODUCTION AND MAIN RESULTS

In this paper, we consider the evolution of concentrations $u = (u_1, \ldots, u_I), I \in \mathbb{N}$, in a bounded domain $\Omega \subset \mathbb{R}^d$ with Lipschitz boundary $\partial \Omega$ subject to non-linear diffusion and reactions as modelled

by the parabolic system

$$\begin{cases} \partial_t u_i - d_i \Delta u_i^{m_i} = f_i(u) & \text{in } Q_T, \\ \nabla u_i^{m_i} \cdot \nu = 0 & \text{on } \Gamma_T, \\ u_i(\cdot, 0) = u_{i,0} & \text{in } \Omega. \end{cases}$$
(1.1)

Here and below, we set $Q_T := \Omega \times (0,T)$ and $\Gamma_T := \partial \Omega \times (0,T)$ for any T > 0, and we employ ν to denote the unit outward normal vector to $\partial \Omega$. The diffusion constants d_i and the non-linear diffusion exponents m_i are assumed to satisfy $d_i > 0$ and $0 < m_i < 2$. For proving exponential convergence to equilibrium, we further demand $m_i > (d-2)_+/d$ with $(d-2)_+ := \max\{0, d-2\}$. We will comment on the bounds on m_i later on. Moreover, we generically assume $u_{i,0} \in L^1(\Omega)$, $u_{i,0} \ge 0$, and impose the following assumptions on the reaction terms $f_i(u), i = 1, \ldots, I$:

- (F1) (Local Lipschitz continuity) $f_i : \mathbb{R}^I_+ \to \mathbb{R}$ is locally Lipschitz continuous.
- (F2) (Quasi-positivity) $f_i(u) \ge 0$ for all $u = (u_1, \ldots, u_I) \in \mathbb{R}^I_+$ with $u_i = 0$.
- (F3) (Entropy inequality) There exist constants $(\mu_i)_{i=1,\dots,I} \in \mathbb{R}^I$ satisfying

$$\sum_{i=1}^{I} f_i(u)(\log u_i + \mu_i) \le C \sum_{i=1}^{I} (1 + u_i \log u_i)$$
(1.2)

for all $u \in \mathbb{R}^{I}_{+}$, where C > 0 is independent of u.

The second assumption (F2) guarantees non-negativity of solutions provided that the initial data are non-negative, which is a natural assumption since we consider here u_i as concentrations or densities. Assumption (F3), on the other hand, implies existence and control of an *entropy* of the system and it is only slightly stronger than assuming control of the mass, i.e.

$$\sum_{i=1}^{I} f_i(u) \le 0.$$
 (1.3)

In general, the assumptions (F1), (F2), and either (F3) or (1.3) of the non-linearities f_i are not enough to obtain suitable a priori estimates which allow to extend local strong solutions globally, see e.g. [25]. On the one hand, for the case of linear diffusion (i.e. $m_i = 1$ for all i = 1, ..., I), the global existence for (1.1) under extra assumptions on non-linearities has been extensively investigated. For instance, global bounded solutions were shown under (F3) for the case d = 1 with cubic non-linearities and d = 2 with quadratic non-linearities, see [17, 28]. Recent works [27, 1, 12] showed under either (F3) or (1.3) that bounded solutions can be obtained for (slightly super-)quadratic non-linearities in all dimensions. We refer the reader to the extensive review [24] for related results concerning global existence of bounded or weak solutions. It is remarked that in all such results, additional assumptions on non-linearities must be imposed. A breakthrough has been made in [15] where global *renormalised solutions* were obtained without any extra assumptions on the non-linearities. The notion of renormalised solution was initially introduced for Boltzmann's equation in [7] and it has been applied subsequently to many other problems; see e.g. [4, 5, 2]. The case of non-linear, possibly degenerate diffusion is, on the other hand, much less understood. Up to our knowledge, there are only two works (20] and (11) which showed global existence of weak or bounded solutions for porous medium type of diffusion, i.e. $m_i > 1$, under (1.3) and some restricted growth conditions on the non-linearities. A recent preprint, however, provides renormalised solutions to a system as in (1.1) but imposing more regularity on the initial data and the underlying domain [21]. Instead of an entropy condition as in (1.2), the authors of [21] assume an additional bound on cross-absorptive reaction terms. Furthermore, [11] proved the convergence to equilibrium for (1.1) modelling a single reversible chemical reaction.

The present study shows the existence of global renormalised solutions to (1.1) featuring non-linear diffusion of porous medium type or fast diffusion without any extra conditions on the non-linearities (up to assuming (F1)–(F3)). In addition, we show that these solutions, in case (1.1) models general complex balanced chemical reaction networks, converge exponentially to equilibrium with explicitly computable rates. Our paper seems to be the first extensive contribution to the non-linear diffusion type system (1.1) establishing—for specific parameter regimes—the existence of global renormalised (or even weak and bounded) solutions as well as exponential convergence to equilibrium in various L^p spaces. A brief summary of our results is given in Table 1 at the end of this section.

The first part of this paper is concerned with the global existence of renormalised solutions to (1.1). We consider the following definition of renormalised solutions.

Definition 1.1 (Renormalised solutions). Let $m_i < 2$ for all $1 \le i \le I$ and $u_0 = (u_{i,0})_i \in L^1(\Omega)^I$ be (componentwise) non-negative. A non-negative function $u = (u_1, \ldots, u_I) : \Omega \times (0, \infty) \to \mathbb{R}^I_+$ is called a renormalised solution to (1.1) with initial data u_0 if $u_i \in L^{\infty}_{loc}(0, \infty; L^1(\Omega))$ and $\nabla u_i^{\frac{m_i}{2}} \in L^2_{loc}(0, \infty; L^2(\Omega)^I)$, and if for any smooth function $\xi : \mathbb{R}^I_+ \to \mathbb{R}$ with compactly supported derivative $D\xi$ and any function $\psi \in C^{\infty}(\overline{\Omega} \times (0, \infty))$, we have

$$\begin{split} \int_{\Omega} \xi(u(\cdot,T))\psi(\cdot,T) \, dx &- \int_{\Omega} \xi(u_0)\psi(\cdot,0) \, dx - \int_{Q_T} \xi(u)\partial_t \psi \, dx \, dt \\ &= -\sum_{i,j=1}^{I} d_i m_i \int_{Q_T} \psi \partial_i \partial_j \xi(u) u_i^{m_i-1} \nabla u_i \cdot \nabla u_j \, dx \, dt \\ &- \sum_{i=1}^{I} d_i m_i \int_{Q_T} \partial_i \xi(u) u_i^{m_i-1} \nabla u_i \cdot \nabla \psi \, dx \, dt \\ &+ \sum_{i=1}^{I} \int_{Q_T} \partial_i \xi(u) f_i(u) \psi \, dx \, dt \end{split}$$
(1.4)

for a.e. T > 0.

We notice that all integrals in (1.4) are well-defined due to the compact support of $D\xi$ and as the integrals relating to gradients of solutions can be rewritten as

$$\int_{Q_T} \psi \partial_i \partial_j \xi(u) u_i^{m_i - 1} \nabla u_i \cdot \nabla u_j \, dx \, dt = \frac{4}{m_i m_j} \int_{Q_T} \psi \partial_i \partial_j \xi(u) u_i^{\frac{m_i}{2}} u_j^{1 - \frac{m_j}{2}} \nabla u_i^{\frac{m_i}{2}} \cdot \nabla u_j^{\frac{m_j}{2}} \, dx \, dt$$

and

$$\int_{Q_T} \partial_i \xi(u) u_i^{m_i - 1} \nabla u_i \nabla \psi \, dx \, dt = \frac{2}{m_i} \int_{Q_T} \partial_i \xi(u) u_i^{\frac{m_i}{2}} \nabla u_i^{\frac{m_i}{2}} \nabla \psi \, dx \, dt$$

which are both finite thanks to the boundedness of $\nabla u_i^{\overline{2}}$ in $L^2(Q_T)$ and the restriction $m_i < 2$ for all $1 \leq i \leq I$.

The first main result of this article is the following theorem.

Theorem 1.2 (Global existence of renormalised solutions). Let $\Omega \subset \mathbb{R}^d$ be a bounded domain with Lipschitz boundary $\partial\Omega$. Assume $m_i < 2$ for all i = 1, ..., I, and that the conditions (F1)–(F3) hold. Then, for any non-negative initial data $u_0 = (u_{i,0})_i \in L^1(\Omega)^I$ subject to

$$\sum_{i=1}^{I} \int_{\Omega} u_{i,0} \log u_{i,0} \, dx < \infty,$$

there exists a global renormalised solution to (1.1).

Moreover, any renormalised solution satisfies the following weak entropy-entropy dissipation relation for a.e. $0 \leq s < T$:

$$\sum_{i=1}^{I} \int_{\Omega} u_i (\log u_i + \mu_i - 1) \, dx \Big|_s^T \leqslant -\sum_{i=1}^{I} \frac{4d_i}{m_i^2} \int_s^T \int_{\Omega} |\nabla(u_i)^{\frac{m_i}{2}}|^2 \, dx \, dt \\ +\sum_{i=1}^{I} \int_s^T \int_{\Omega} f_i(u) (\log u_i + \mu_i) \, dx \, dt \leqslant 0.$$
(1.5)

In addition, if there exist some numbers $q_i \in \mathbb{R}$ such that $\sum_{i=1}^{I} q_i f_i(u) = 0$, then all renormalised solutions satisfy

$$\sum_{i=1}^{I} \int_{\Omega} q_i u_i(x,t) \, dx = \sum_{i=1}^{I} \int_{\Omega} q_i u_{i,0}(x) \, dx \tag{1.6}$$

for a.e. t > 0.

Remark 1.3.

- The relation (1.6) usually corresponds to mass conservation laws in chemical reactions, see e.g. [14].
- The uniqueness of renormalised solutions is widely open. For a weaker notion called weakstrong uniqueness, i.e. the renormalised solution is unique as long as a strong solution exists, we refer the interested reader to [16].
- The fact that (1.5) and (1.6) are satisfied by any renormalised solution plays an important role in the next part of this paper where we show that all renormalised solutions, instead of only some of them, converge to equilibrium.

The strategy for constructing a global renormalised solution follows the ideas in [15]. Given a sequence of approximate solutions u^{ε} , one proves compactness of the family u^{ε} by deriving bounds on truncations $\varphi_i^E(u^{\varepsilon})$, $E \in \mathbb{N}$, $i = 1, \ldots, I$, and subsequently employing an Aubin–Lions lemma. The smooth functions φ_i^E defined in (2.6) essentially truncate the mappings $u \mapsto u_i$ if u becomes too large (measured in terms of E) while leaving $u \mapsto u_i$ unchanged for sufficiently small u. The main difficulty in our current situation is caused by the different diffusion exponents m_i for each species u_i , which makes the truncations φ_i^E provided in [15] not applicable. We overcome this issue by modifying the functions φ_i^E in such a way that the truncation is not decided by $\sum_j u_j$ but by a weighted sum $\sum_j E^{-\alpha_j^i} u_j$ with suitable constants $\alpha_j^i \ge 1$ chosen depending on the diffusion exponents m_i . We then pass to the limit $\varepsilon \to 0$ in the equation for $\varphi_i^E(u^{\varepsilon})$ at the cost of an additional defect measure which, nevertheless, vanishes in the subsequent limit $E \to \infty$. Finally, an equation for $\xi(\varphi_i^E(u))$ is derived, where ξ is subject to the same assumptions as in Definition 1.1, and the limit $E \to \infty$ is performed resulting in the desired equation (1.4) for $\xi(u)$.

The restriction $m_i < 2$ for i = 1, ..., I appears already in the definition of renormalised solutions in Definition 1.1. It is also crucial in showing the vanishing of the defect measure when establishing the renormalised solution. We do not know whether this restriction is purely technical or due to a deeper reason. It is remarked that the same condition was crucially imposed in [20], where global weak solutions to (1.1) were investigated.

In the second part of this paper, we study the large-time behaviour of reaction-diffusion systems of type (1.1) modelling chemical reaction networks subject to the complex balance condition. The main vocabulary is introduced below but we refer to [6] for a more detailed discussion of the involved

concepts. We assume that there are I chemicals S_1, \ldots, S_I reacting via the following R reactions

$$y_{r,1}S_1 + \dots + y_{r,I}S_I \xrightarrow{k_r} y'_{r,1}S_1 + \dots + y'_{r,I}S_I \quad \text{for all} \quad r = 1, \dots, R$$
(1.7)

where $y_{r,i}, y'_{r,i} \in \{0\} \cup [1, \infty)$ are stoichiometric coefficients, and $k_r > 0$ are reaction rate constants. Utilizing the notation $y_r = (y_{r,i})_{i=1,...,I}$ and $y'_r = (y'_{r,i})_{i=1,...,I}$, we can rewrite the reactions in (1.7) as

$$y_r \xrightarrow{\kappa_r} y'_r$$
 for all $r = 1, \dots, R.$ (1.8)

Denote by $u_i(x,t)$ the concentration of S_i at position $x \in \Omega$ and time $t \ge 0$. The reaction network (1.7) results in the following reaction-diffusion system with non-linear diffusion for $u = (u_1, \ldots, u_I)$:

$$\begin{cases} \partial_t u_i - d_i \Delta u_i^{m_i} = f_i(u) & \text{in } Q_T, \\ \nabla u_i^{m_i} \cdot \nu = 0 & \text{on } \Gamma_T, \\ u_i(x,0) = u_{i,0}(x) & \text{in } \Omega, \end{cases}$$
(1.9)

in which the reaction term $f_i(u)$ is determined using the mass action law,

$$f_i(u) = \sum_{r=1}^R k_r u^{y_r} (y'_{r,i} - y_{r,i}) \quad \text{where} \quad u^{y_r} = \prod_{i=1}^I u_i^{y_{r,i}}.$$
 (1.10)

It is obvious that $f_i(u)$ is locally Lipschitz continuous, hence (F1) is satisfied. For (F2), it is easy to check that $f_i(u) \ge 0$ holds true for all $u \in \mathbb{R}^I_+$ satisfying $u_i = 0$ since we assume $k_r > 0$ and $y \in (\{0\} \cup [1, \infty))^I$ for all $y \in \{y_r, y'_r\}_{r=1,...,R}$. Before verifying (F3), we recall the definition of a complex balanced equilibrium. A constant state $u_{\infty} = (u_{i,\infty})_i \in [0, \infty)^I$ is called a complex balanced equilibrium for (1.9)-(1.10) if

$$\sum_{\{r:y_r=y\}} k_r u_{\infty}^{y_r} = \sum_{\{s:y_s'=y\}} k_s u_{\infty}^{y_s} \quad \text{for all} \quad y \in \{y_r, y_r'\}_{r=1,\dots,R}.$$
(1.11)

Intuitively, this condition means that for any complex the total outflow from the complex and the total inflow into the complex are balanced at such an equilibrium. Using complex balanced equilibria, one can show that the non-linearities in (1.10) satisfy (F3) by choosing $\mu_i = -\log u_{i,\infty}$ with a strictly positive complex balanced equilibrium u_{∞} (see [6, Proposition 2.1]). Therefore, one can apply Theorem 1.2 to obtain global renormalised solutions to (1.9)–(1.10).

In general, there might exist infinitely many solutions to (1.11). To uniquely identify a *positive* equilibrium, we need a set of conservation laws. More precisely, we consider the Wegscheider matrix (or stoichiometric coefficient matrix)

$$W = \left[(y'_r - y_r)_{r=1,\dots,R} \right]^T \in \mathbb{R}^{R \times I},$$

and define $m = \dim(\ker(W))$. If m > 0, then we can choose a matrix $\mathbb{Q} \in \mathbb{R}^{m \times I}$, where the rows form a basis of $\ker(W)$. Note that this implies $\mathbb{Q}(y'_r - y_r) = 0$ for all $r = 1, \ldots, R$. Therefore, by recalling $f(u) = (f_i(u))_{i=1,\ldots,I} = \sum_{r=1}^R k_r u^{y_r} (y'_r - y_r)$ we obtain

$$\mathbb{Q} f(u) = \sum_{r=1}^{R} k_r u^{y_r} \mathbb{Q}(y'_r - y_r) = 0 \quad \text{for any} \quad u \in \mathbb{R}^I.$$

By using the homogeneous Neumann boundary condition, we can then (formally) compute that

$$\frac{d}{dt}\int_{\Omega}\mathbb{Q}\,u(t)\,dx = \int_{\Omega}\mathbb{Q}\,f(u)\,dx = 0$$

and, consequently, for a.e. t > 0,

$$\mathbb{Q}\int_{\Omega} u(t) \, dx = \mathbb{Q}\int_{\Omega} u_0 \, dx.$$

In other words, system (1.9)-(1.10) possesses m linearly independent mass conservation laws. By the vocabulary used in the literature on chemical reaction network theory, for any fixed nonnegative mass vector $M \in \mathbb{R}^m$, the set $\{u \in \mathbb{R}^I_+ : \mathbb{Q}u = M\}$ is called the *compatibility class* corresponding to M. In case that for each strictly positive vector $M \in \mathbb{R}^m$, there exists a strictly positive complex balanced equilibrium, one says that the chemical reaction network is complex balanced. This terminology is well-defined since it was proved in [18] that if one equilibrium is complex balanced, then all equilibria are complex balanced. It was further shown that for each non-negative initial mass $M \in \mathbb{R}^m$ with $M \neq 0$, there exists a unique strictly positive complex balanced equilibrium $u_{\infty} = (u_{i,\infty})_i \in \mathbb{R}^I_+$ in the compatibility class corresponding to M (cf. [19, 10]). We stress that additionally there might exist many so-called *boundary equilibria*, which are complex balanced equilibria lying on $\partial \mathbb{R}^{I}_{+}$. It is remarked that there exists a large class of complex balanced chemical reaction networks, called concordant networks, which do not have boundary equilibria. see [26]. For the sake of brevity, from now on we call the unique strictly positive complex balanced equilibrium simply the *complex balanced equilibrium*. Note that all the previous considerations although established for ODE models for chemical reaction networks—also apply to our PDE setting thanks to the homogeneous Neumann boundary conditions, which allow for spatially homogeneous equilibria.

Theorem 1.4 (Exponential equilibration of renormalised solutions). Let $\Omega \subset \mathbb{R}^d$ be a bounded domain with Lipschitz boundary $\partial\Omega$. Assume that the reaction network (1.8) is complex balanced, suppose that (F1)–(F3) hold, and let any non-negative initial data $u_0 = (u_{i,0})_i \in L^1(\Omega)^I$ with $\sum_{i=1}^I \int_{\Omega} u_{i,0} \log u_{i,0} dx < \infty$ be given.

- If $m_i < 2$ for all $1 \le i \le I$, there exists a global renormalised solution to (1.9)–(1.10).
- If $\frac{(d-2)_+}{d} < m_i$ for all $1 \le i \le I$ and assuming that there exist no boundary equilibria, any renormalised solution to (1.9)-(1.10) converges exponentially to the positive equilibrium $u_{\infty} \in \mathbb{R}^{I}_{+}$ in the same compatibility class as u_0 with a rate which can be explicitly computed up to a finite dimensional inequality, i.e.

$$\sum_{i=1}^{I} \|u_i(t) - u_{i,\infty}\|_{L^1(\Omega)} \leqslant C e^{-\lambda t} \quad \text{for all} \quad t \ge 0,$$

for some positive constants $C, \lambda > 0$.

We emphasise that the convergence to equilibrium in Theorem 1.4 is proved for all renormalised solutions, not only the ones obtained via an approximation procedure. This is possible because the proof of the convergence uses only the weak entropy–entropy dissipation law (1.5) and the conservation laws (1.6) which are satisfied by all renormalised solutions. It is noted that, when a system possesses boundary equilibria, the convergence to the positive equilibrium (more precisely, the instability of boundary equilibria) is very subtle and strongly connected to the famous Global Attractor Conjecture, see for instance [6, 14, 3].

Theorem 1.4, up to our knowledge, is the first result of trend to equilibrium for general complex balanced reaction networks with non-linear diffusion. A special case of a single reversible reaction was considered recently in [11] in which the authors utilised a so-called *indirect diffusion effect* (see e.g. [9]), which seems difficult to be generalised to general systems. The proof of Theorem 1.4 uses

the relative entropy

$$\mathcal{E}[u|u_{\infty}] = \sum_{i=1}^{I} \int_{\Omega} \left(u_i \log \frac{u_i}{u_{i,\infty}} - u_i + u_{i,\infty} \right) dx \tag{1.12}$$

and its corresponding entropy dissipation

$$\mathcal{D}[u] = \sum_{i=1}^{I} d_i m_i \int_{\Omega} u_i^{m_i - 2} |\nabla u_i|^2 \, dx + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \Psi\left(\frac{u^{y_r}}{u_{\infty}^{y_r}}; \frac{u^{y'_r}}{u_{\infty}^{y'_r}}\right) \, dx \tag{1.13}$$

where $\Psi(x; y) = x \log(x/y) - x + y$. It holds, at least formally, that

$$-\frac{d}{dt}\mathcal{E}[u|u_{\infty}] = \mathcal{D}[u]$$

along any trajectory of (1.9)-(1.10). The degeneracy of the non-linear diffusion makes the classical logarithmic Sobolev inequality not applicable. Our main idea here is to utilise some generalised logarithmic Sobolev inequalities (see Lemmas 3.3 and 3.4), which are suited for non-linear diffusion, and the established results in [14] for the case of linear diffusion, to firstly derive an entropy–entropy dissipation inequality of the form

$$\mathcal{D}[u] \ge C(\mathcal{E}[u|u_{\infty}])^{\alpha} \tag{1.14}$$

where $\alpha = \max_{i=1,...,I}\{1, m_i\}$. Note that this functional inequality is proved for all non-negative functions $u: \Omega \to \mathbb{R}^I_+$ satisfying the conservation laws $\mathbb{Q} \int_{\Omega} u \, dx = |\Omega| \mathbb{Q} u_{\infty}$, and therefore is suitable for renormalised solutions, which have very low regularity. If $\alpha = 1$ in (1.14), one immediately gets exponential convergence of the relative entropy to zero and, consequently, exponential convergence of the solutions to equilibrium in L^1 thanks to a Csiszár–Kullback–Pinsker type inequality. If $\alpha > 1$, we first obtain an algebraic decay of the relative entropy to zero. Thanks to this, we can explicitly compute a finite time $T_0 > 0$ from which onwards (in time) the averages of concentrations are strictly bounded below by a positive constant. This helps to compensate the degeneracy of the diffusion and, therefore, to show that solutions with such lower bounds satisfy the linear entropy– entropy dissipation inequality, i.e.

$$\mathcal{D}[u(t)] \ge C\mathcal{E}[u(t)|u_{\infty}] \quad \text{for all} \quad t \ge T_0,$$

which recovers exponential convergence to equilibrium.

The use of renormalised solutions allows to deal with a large class of non-linearities, but on the other hand it restricts Theorem 1.4 to the case $\frac{(d-2)_+}{d} < m_i < 2$. When the non-linearities are of polynomial type, it was shown in [20, 11], under the assumption of the mass dissipation (1.3) instead of the entropy inequality (1.2), that one can get global weak or even bounded solutions if the porous medium exponents m_i are large enough. In the following theorem, we show an analog result under the entropy inequality condition (1.2). Moreover, the solution is shown to converge exponentially to the positive complex balanced equilibrium.

Theorem 1.5 (Existence and convergence of weak and bounded solutions). Let $\Omega \subset \mathbb{R}^d$ be a bounded domain with Lipschitz boundary $\partial\Omega$. Assume that the assumptions (F1)–(F3) hold, and the non-linearities are bounded by polynomials, i.e. there exist C > 0 and $\mu \ge 1$ such that

$$|f_i(u)| \leq C \left(1+|u|^{\mu}\right)$$
 for all $u \in \mathbb{R}^I, i = 1, \dots, I.$

• *If*

 $m_i \ge \max\{\mu - 1, 1\}$ for all $i = 1, \dots, I$, (1.15)

then the system (1.1) has a global non-negative weak solution for each non-negative initial data $u_0 = (u_{i,0})_{i=1,...,I}$ such that $u_{i,0} \log u_{i,0} \in L^2(\Omega)$ for all i = 1, ..., I.

• Under an even stronger condition on the porous medium exponents, namely

$$\min_{i=1,...,I} m_i > \max\{\mu - 1, 1\} \quad for \quad d \le 2,
\min_{i=1,...,I} m_i > \mu - \frac{4}{d+2} \quad for \quad d \ge 3,$$
(1.16)

the weak solution to (1.1) subject to bounded non-negative initial data $u_0 \in L^{\infty}(\Omega)^I$ is locally bounded in time, i.e.

$$||u_i||_{L^{\infty}(\Omega \times (0,T))} \leq C_T \quad for \ all \quad i = 1, \dots, I,$$

where C_T is a constant growing at most polynomially in T > 0.

Assume now that the reaction network (1.8) is complex balanced and define

$$\mu = \max_{r=1,\dots,R} \{ |y_r|, |y_r'| \}$$
(1.17)

where $|y_r| = \sum_{i=1}^{I} y_{r,i}$. Assume moreover that (1.8) has no boundary equilibria.

• If (1.15) holds and $0 \leq u_0$ such that $u_{i,0} \log u_{i,0} \in L^2(\Omega)$ for all $i = 1, \ldots, I$, all weak solutions to (1.9)–(1.10) converge exponentially to the complex balanced equilibrium in $L^1(\Omega)$, *i.e.*

$$\sum_{i=1}^{I} \|u_i(t) - u_{i,\infty}\|_{L^1(\Omega)} \leq C e^{-\lambda t} \quad \text{for all} \quad t \ge 0,$$

for some $C, \lambda > 0$.

• If (1.16) holds and $0 \leq u_0 \in L^{\infty}(\Omega)^I$, weak solutions to (1.9)–(1.10) are bounded locally in time and converge exponentially to equilibrium in any L^p norm with $p \in [1, \infty)$, i.e.

$$\sum_{i=1}^{I} \|u_i(t) - u_{i,\infty}\|_{L^p(\Omega)} \leqslant C_p e^{-\lambda_p t} \quad \text{for all} \quad t \ge 0,$$

$$(1.18)$$

with positive constants $C_p, \lambda_p > 0$.

As one can see from Theorems 1.4 and 1.5, the global existence and trend to equilibrium for (1.9)–(1.10) are well-established for either $m_i < 2$ for all i = 1, ..., I, or m_i large enough in the sense of (1.15) or (1.16) for all i = 1, ..., I. There exists, therefore, a gap in which the global existence of any kind of solution remains open. Remarkably, the proof of the convergence to equilibrium in this paper does not rely on the restriction $m_i < 2$, and it therefore is applicable to any global solution to (1.9)–(1.10) as long as it satisfies the entropy law (1.5) and the mass conservation laws (1.6). We, thus, arrive at the following result on the convergence to equilibrium for approximating systems of (1.9)–(1.10) uniformly in the approximation parameter.

Theorem 1.6 (Uniform convergence of approximate solutions). Let $\Omega \subset \mathbb{R}^d$ be a bounded domain with Lipschitz boundary $\partial\Omega$. Assume that (1.9)–(1.10) subject to (F1)–(F3), non-negative initial data $u_0 = (u_{i,0})_i \in L^1(\Omega)^I$ with $\sum_{i=1}^I \int_{\Omega} u_{i,0} \log u_{i,0} dx < \infty$, and $m_i > \frac{(d-2)_+}{d}$ for all $i = 1, \ldots, I$ admits a complex balanced equilibrium but no boundary equilibria. For any $\varepsilon > 0$, let $u^{\varepsilon} = (u_i^{\varepsilon})_{i=1,\ldots,I}$ be the solution to the approximate system

$$\begin{cases} \partial_t u_i^{\varepsilon} - d_i \Delta (u_i^{\varepsilon})^{m_i} = \frac{f_i(u^{\varepsilon})}{1 + \varepsilon |f(u^{\varepsilon})|} & in \ Q_T, \\ \nabla (u_i^{\varepsilon})^{m_i} \cdot \nu = 0 & on \ \Gamma_T, \\ u_i^{\varepsilon}(x, 0) = u_{i,0}^{\varepsilon}(x) & in \ \Omega, \end{cases}$$
(1.19)

where $u_{i,0}^{\varepsilon} \in L^{\infty}(\Omega)$ satisfies

$$\max_{i} \lim_{\varepsilon \to 0} \|u_{i,0}^{\varepsilon} - u_{i,0}\|_{L^{1}(\Omega)} = 0 \quad and \quad \max_{i} \sup_{\varepsilon > 0} \int_{\Omega} u_{i,0}^{\varepsilon} \log u_{i,0}^{\varepsilon} \, dx < \infty.$$
(1.20)

Moreover, the approximated initial data u_0^{ε} are chosen such that, for all $\varepsilon > 0$,

$$\mathbb{Q}\int_{\Omega} u_0^{\varepsilon} dx = \mathbb{Q}\int_{\Omega} u_0 dx.$$
(1.21)

(This implies that the system (1.19) admits a unique positive complex balanced equilibrium $u_{\infty} \in \mathbb{R}^{I}_{+}$, which is independent of $\varepsilon > 0$.)

Then, u^{ε} converges exponentially to u_{∞} with a rate which is uniform in ε , i.e.

$$\sum_{i=1}^{I} \|u_i^{\varepsilon}(t) - u_{i,\infty}\|_{L^1(\Omega)} \leq C e^{-\lambda t} \quad \text{for all} \quad t \ge 0,$$

where $C, \lambda > 0$ are constants independent of $\varepsilon > 0$.

To prove Theorem 1.6, we make use of the same relative entropy as in (1.12),

$$\mathcal{E}[u^{\varepsilon}|u_{\infty}] = \sum_{i=1}^{I} \int_{\Omega} \left(u_{i}^{\varepsilon} \log \frac{u_{i}^{\varepsilon}}{u_{i,\infty}} - u_{i}^{\varepsilon} + u_{i,\infty} \right) dx,$$

where u^{ε} is the solution to (1.19). The corresponding non-negative entropy dissipation can be calculated as

$$\mathcal{D}[u^{\varepsilon}] = \sum_{i=1}^{I} d_i \int_{\Omega} m_i (u_i^{\varepsilon})^{m_i - 2} |\nabla u_i|^2 \, dx + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \frac{1}{1 + \varepsilon |f(u^{\varepsilon})|} \Psi\left(\frac{(u^{\varepsilon})^{y_r}}{u_{\infty}^{y_r}}; \frac{(u^{\varepsilon})^{y_r'}}{u_{\infty}^{y_r'}}\right) dx.$$

Since there is no uniform-in- εL^{∞} bound for u^{ε} available, the factor $\frac{1}{1+\varepsilon|f(u^{\varepsilon})|}$ is not bounded below uniformly in $\varepsilon > 0$. Therefore, it seems to be impossible to use the entropy dissipation (for limit solutions) in (1.13) as a lower bound for $\mathcal{D}[u^{\varepsilon}]$. We overcome this issue by using the ideas in [14]. Roughly speaking, we deal with the second sum in $\mathcal{D}[u^{\varepsilon}]$ by estimating it below by a term involving only spatial averages of u^{ε} (rather than u^{ε} pointwise as above), and then exploiting the fact that these averages are bounded uniformly in $\varepsilon > 0$.

We summarise the global existence and convergence to equilibrium for the mass action system (1.9)-(1.10) in Table 1 (assuming the existence of a unique strictly positive complex balanced equilibrium and the absence of boundary equilibria). Note that the global existence of any kind of solution remains open for diffusion exponents satisfying $2 \leq m_i < \mu - 1$, where μ is defined in (1.17).

The rest of this paper is organised as follows. In Section 2, we show the global existence of renormalised solutions for the general system (1.1). The proofs of Theorems 1.4, 1.5, and 1.6 on the convergence to equilibrium of chemical reaction networks are presented in Section 3. Some technical proofs of auxiliary results are postponed to the Appendix.

2. GLOBAL EXISTENCE OF RENORMALISED SOLUTIONS

2.1. Existence of approximate solutions. Let $\varepsilon > 0$ and consider the following approximating system for $u^{\varepsilon} = (u_1^{\varepsilon}, \ldots, u_I^{\varepsilon})$,

$$\partial_t u_i^{\varepsilon} - d_i \Delta(u_i^{\varepsilon})^{m_i} = f_i^{\varepsilon}(u^{\varepsilon}) := \frac{f_i(u^{\varepsilon})}{1 + \varepsilon |f(u^{\varepsilon})|}, \quad \nabla(u_i^{\varepsilon})^{m_i} \cdot \nu = 0, \quad u_i^{\varepsilon}(\cdot, 0) = u_{i,0}^{\varepsilon}, \tag{2.1}$$

where $u_{i,0}^{\varepsilon} \in L^{\infty}(\Omega)$ is non-negative and $u_{i,0}^{\varepsilon} \xrightarrow{\varepsilon \to 0} u_{i,0}$ in $L^{1}(\Omega)$. Moreover, we demand

$$\sup_{\varepsilon > 0} \int_{\Omega} u_{i,0}^{\varepsilon} \log u_{i,0}^{\varepsilon} \, dx < +\infty.$$
(2.2)

With this approximation, it is easy to check that the approximated non-linearities f_i^{ε} still satisfy the assumptions (F1)–(F3).

Lemma 2.1. For any $\varepsilon > 0$, there exists a global weak solution $u^{\varepsilon} = (u_i^{\varepsilon})_i \in L^{\infty}_{loc}(0, \infty; L^{\infty}(\Omega))^I$ to the approximate system (2.1) with $\nabla(u_i^{\varepsilon})^{\frac{m_i}{2}} \in L^2_{loc}(0, \infty; L^2(\Omega))$ and $\partial_t u_i^{\varepsilon} \in L^2_{loc}(0, \infty; (H^1(\Omega))')$. In detail,

$$\int_{t_0}^{t_1} \left\langle \frac{d}{dt} u_i^{\varepsilon}, \psi \right\rangle_{(H^1(\Omega))', H^1(\Omega)} dt = -d_i m_i \int_{t_0}^{t_1} \int_{\Omega} (u_i^{\varepsilon})^{m_i - 1} \nabla u_i^{\varepsilon} \cdot \nabla \psi \, dx \, dt + \int_{t_0}^{t_1} \int_{\Omega} \frac{f_i(u^{\varepsilon})}{1 + \varepsilon |f(u^{\varepsilon})|} \psi \, dx \, dt$$

$$(2.3)$$

for all $\psi \in L^2_{loc}(0,\infty; H^1(\Omega))$, $i \in \{1,\ldots,I\}$, and a.e. $0 \leq t_0 < t_1$. Moreover, each u_i^{ε} is a.e. non-negative and

$$\sum_{i=1}^{I} \int_{\Omega} u_i^{\varepsilon}(t_1) \left[\log u_i^{\varepsilon}(t_1) + \mu_i - 1 \right] dx + C \int_{t_0}^{t_1} \int_{\Omega} \sum_{i=1}^{I} \left| \nabla(u_i^{\varepsilon})^{\frac{m_i}{2}} \right|^2 dx dt$$

$$\leq e^{C(t_1 - t_0)} \left(\int_{\Omega} \sum_{i=1}^{I} u_i^{\varepsilon}(t_0) \left[\log u_i^{\varepsilon}(t_0) + \mu_i - 1 \right] dx + C(t_1 - t_0) \right)$$
(2.4)

for a.e. $0 \le t_0 < t_1$.

Proof. For each $\varepsilon > 0$, we see by recalling $|f(u^{\varepsilon})| = \sum_{i=1}^{I} |f_i(u^{\varepsilon})|$ that

$$\frac{f_i(u^{\varepsilon}(x,t))}{1+\varepsilon|f(u^{\varepsilon}(x,t))|} \leq \frac{1}{\varepsilon} \quad \text{for all} \quad (x,t) \in Q_T.$$

The existence of bounded weak solutions to (2.1) is therefore standard. However, since we are not able to find a precise reference, a proof is given in Appendix A. By multiplying (2.1) by $\log(u_i^{\varepsilon}) + \mu_i$

(or more rigorously by $\log(u_i^{\varepsilon} + \delta) + \mu_i$ for some $\delta > 0$, then let $\delta \to 0$), summing the resultants over $i = 1, \ldots, I$, and then integrating over Ω , we obtain

$$\frac{d}{dt} \int_{\Omega} \sum_{i=1}^{I} u_i^{\varepsilon} (\log u_i^{\varepsilon} + \mu_i - 1) \, dx + \sum_{i=1}^{I} \frac{4d_i}{m_i} \int_{\Omega} \left| \nabla(u_i^{\varepsilon})^{\frac{m_i}{2}} \right|^2 dx$$

$$= \frac{1}{1 + \varepsilon |f(u^{\varepsilon})|} \int_{\Omega} \sum_{i=1}^{I} f_i(u^{\varepsilon}) (\log u_i^{\varepsilon} + \mu_i) \, dx$$

$$\leq C \sum_{i=1}^{I} \int_{\Omega} u_i^{\varepsilon} (\log u_i^{\varepsilon} + \mu_i - 1) \, dx + C$$
(2.5)

where we used (F3) and $x \leq \delta x \log x + C_{\delta}$ for all $x \geq 0$ and any $\delta > 0$ at the last step. Hence, by integrating (2.5) over (t,T) and using Gronwall's inequality, we obtain the desired estimate (2.4). The uniform bound on $u_i^{\varepsilon} \log u_i^{\varepsilon}$ in $L^{\infty}(0,T;L^1(\Omega))$ and $|\nabla(u_i^{\varepsilon})^{\frac{m_i}{2}}|$ in $L^2(0,T;L^2(\Omega))$ follow immediately from (2.4).

2.2. Existence of renormalised solutions. As it can be seen from Lemma 2.1, the *a priori* estimates of u_i^{ε} are not enough to extract a convergent subsequence. Following the idea from [15], we consider another approximation of u_i^{ε} by defining

$$\varphi_i^E(v) = (v_i - 3E) \xi \left(\sum_{j=1}^I \frac{v_j}{E^{\alpha_j^i}} - 1 \right) + 3E$$
(2.6)

for $E \in \mathbb{N}$, and a smooth function $\xi : \mathbb{R} \to [0, 1]$ satisfying $\xi \equiv 1$ on $(-\infty, 0)$ and $\xi \equiv 0$ on $(1, \infty)$. The constants α_i^i are given by

$$\alpha_i^i := 1, \quad \alpha_j^i := \frac{2}{\min(m_j, 2 - m_j)} \text{ for } j \neq i.$$
 (2.7)

Remark 2.2. The α_j^i are chosen in (2.7) for the sake of simplicity. In fact, we can choose any α_j^i such that

See the proof of (E2) in Lemma 2.3.

Lemma 2.3. The smooth truncations φ_i^E defined in (2.6) have the following properties:

(E1) $\varphi_i^E \in C^2(\mathbb{R}^I_+).$

(E2) For any $i \in \{1, \ldots, I\}$, there exists a constant $K_i > 0$ such that the inequality

- (E3) For every E the set supp $D\varphi_i^E$ is bounded.
- (E4) For all $j \in \{1, \ldots, I\}$ and all $v \in \mathbb{R}^{I}_{+}$ there holds $\lim_{E \to \infty} \partial_{j} \varphi_{i}^{E}(v) = \delta_{ij}$.
- (E5) There exists a constant K > 0 such that

$$\max_{1 \leq j \leq I} \sup_{E \geq 1} \sup_{v \in \mathbb{R}^I_+} |\partial_j \varphi_i^E(v)| \leq K.$$

- (E6) $\varphi_i^E(v) = v_i \text{ for any } v \in \mathbb{R}^I_+ \text{ with } \sum_{j=1}^I v_j E^{-\alpha_j^i} \leq 1.$
- (E7) For every K > 0 and every j, k there holds

$$\lim_{E \to \infty} \sup_{|v| \le K} |\partial_j \partial_k \varphi_i^E(v)| = 0$$

(E8)
$$\varphi_i^E(v) = v_i \text{ for any } v \in \mathbb{R}^I_+ \text{ with } \sum_{j=1}^I \varphi_j^E(v) E^{-\alpha_j^i} \leq 1.$$

Proof. Properties (E1), (E3), (E4), and (E6) are immediate. To prove (E2), we first compute

$$\partial_i \varphi_i^E(v) = (v_i - 3E)\xi'(\cdots)E^{-\alpha_i^i} + \xi(\cdots),$$

$$\partial_j \varphi_i^E(v) = (v_i - 3E)\xi'(\cdots)E^{-\alpha_j^i}$$

for $j \neq i$, where for brevity we write (\cdots) instead of $\left(\sum_{j=1}^{I} E^{-\alpha_{j}^{i}} v_{j} - 1\right)$. From that, one further gets the second derivatives

$$\partial_i^2 \varphi_i^E(v) = (v_i - 3E)\xi''(\cdots)E^{-2\alpha_i^i} + 2\xi'(\cdots)E^{-\alpha_i^i},$$

$$\partial_i \partial_j \varphi_i^E(v) = (v_i - 3E)\xi''(\cdots)E^{-\alpha_i^i - \alpha_j^i} + \xi'(\cdots)E^{-\alpha_j^i},$$

$$\partial_j \partial_k \varphi_i^E(v) = (v_i - 3E)\xi''(\cdots)E^{-\alpha_j^i - \alpha_k^i}$$

for $j \neq i$ and $k \neq i$.

To show (2.8), we will consider the following cases:

• When i = j = k, we have

$$v_{i}^{\frac{m_{i}}{2}}v_{i}^{1-\frac{m_{i}}{2}}|\partial_{i}^{2}\varphi_{i}^{E}(v)| = v_{i}|\partial_{i}^{2}\varphi_{i}^{E}(v)| \\ \leqslant |v_{i}||v_{i}-3E|E^{-2\alpha_{i}^{i}}|\xi''(\cdots)| + 2v_{i}E^{-\alpha_{i}^{i}}|\xi'(\cdots)|.$$

Employing the identities $\xi'(\cdots) = \xi''(\cdots) = 0$ for $v_i \ge 2E^{\alpha_i^i}$ as well as the bound $|\xi'(\cdots)| + |\xi''(\cdots)| \le C$, we can further estimate

$$v_i^{\frac{m_i}{2}} v_i^{1 - \frac{m_i}{2}} |\partial_i^2 \varphi_i^E(v)| \le C E^{-\alpha_i^i} |E^{\alpha_i^i} + E| + C.$$

Therefore, by choosing $\alpha_i^i = 1$, we have the desired estimate (2.8) for i = j = k.

• When k = i and $j \neq i$, we estimate using $\alpha_i^i = 1, \, \xi'(\cdots) = \xi''(\cdots) = 0$ when $v_j \ge 2E^{\alpha_j^i}$ or $v_i \ge 2E$, and $|\xi'(\cdots)| + |\xi''(\cdots)| \le C$,

$$\begin{split} &v_{j}^{\frac{m_{j}}{2}}v_{i}^{1-\frac{m_{i}}{2}}|\partial_{j}\partial_{i}\varphi_{i}^{E}(v)| \\ &\leqslant v_{j}^{\frac{m_{j}}{2}}v_{i}^{1-\frac{m_{i}}{2}}|\xi'(\cdots)|E^{-\alpha_{j}^{i}}+v_{j}^{\frac{m_{j}}{2}}v_{i}^{1-\frac{m_{i}}{2}}|\xi''(\cdots)||v_{i}-3E|E^{-\alpha_{j}^{i}-1} \\ &\leqslant CE^{\frac{m_{j}}{2}\alpha_{j}^{i}}E^{1-\frac{m_{i}}{2}}|\xi'(\cdots)|E^{-\alpha_{j}^{i}}+CE^{\frac{m_{j}}{2}\alpha_{j}^{i}}E^{1-\frac{m_{i}}{2}}|\xi''(\cdots)||E+3E|E^{-\alpha_{j}^{i}-1} \\ &\leqslant CE^{\alpha_{j}^{i}(\frac{m_{j}}{2}-1)+(1-\frac{m_{i}}{2})}. \end{split}$$

Thus, (2.8) is proved in the case $k = i \neq j$ if we choose α_j^i such that

$$\alpha_j^i(\frac{m_j}{2}-1) + (1-\frac{m_i}{2}) \leqslant 0 \quad \text{or equivalently} \quad \alpha_j^i \geqslant \frac{2-m_i}{2-m_j}.$$
(2.9)

• When j = i and $k \neq i$, we estimate similarly to the previous cases

$$v_i^{\frac{m_i}{2}} v_k^{1-\frac{m_k}{2}} \left| \partial_i \partial_k \varphi_i^E(v) \right| \leqslant C E^{\frac{m_i}{2} - \alpha_k^i \frac{m_k}{2}}$$

If we choose

then obviously (2.8) holds true for $j = i \neq k$.

• Finally, when $j \neq i$ and $k \neq i$, we estimate

$$v_{j}^{\frac{m_{j}}{2}}v_{k}^{1-\frac{m_{k}}{2}}|\partial_{j}\partial_{k}\varphi_{i}^{E}(v)| \leq CE^{\alpha_{j}^{i}\frac{m_{j}}{2}}E^{\alpha_{k}^{i}(1-\frac{m_{k}}{2})}|\xi''(\cdots)|E^{-\alpha_{j}^{i}-\alpha_{k}^{i}}E \leq CE^{\alpha_{j}^{i}(\frac{m_{j}}{2}-1)-\alpha_{k}^{i}\frac{m_{k}}{2}+1}.$$

It is easy to see that from (2.9) and (2.10) it follows

$$\alpha_j^i \left(\frac{m_j}{2} - 1\right) - \alpha_k^i \frac{m_k}{2} + 1 \leqslant 0,$$

and hence (2.8) is proved in this case.

From (2.9) and (2.10), we see that $\alpha_j^i > 1$ for all $j \neq i$, hence, (E5) and (E7) follow. For (E8), it is enough to show that $\sum_{j=1}^{I} \varphi_j^E(v) E^{-\alpha_j^i} \leq 1$ yields $\sum_{j=1}^{I} v_j E^{-\alpha_j^i} \leq 1$. Set

$$y := \sum_{j=1}^{I} \frac{v_j}{E^{\alpha_j^i}} - 1$$
 and $z := \sum_{j=1}^{I} \frac{1}{E^{\alpha_j^i}}$

From $\varphi_j^E(v) = (v_j - 3E)\xi(y) + 3E$ and $\sum_{j=1}^{I} \varphi_j^E(v) E^{-\alpha_j^i} \leq 1$ we deduce $\xi(y)(y+1) + 3E(1-\xi(y))z \leq 1.$

Due to $\xi \leq 1$ and $Ez \geq 1$, we are now led to

$$y\xi(y) \leqslant (1 - 3Ez)(1 - \xi(y)) \leqslant 0.$$

This entails $y \leq 0$ and, thus, completes the proof of the lemma.

Lemma 2.4. Consider non-negative functions $u_0 = (u_{i,0})_i \in L^1(\Omega)^I$ which satisfy

$$\sum_{i=1}^{I} \int_{\Omega} u_{i,0} \log u_{i,0} \, dx < \infty.$$

Let $u^{\varepsilon} = (u_1^{\varepsilon}, \dots, u_I^{\varepsilon})$ for $\varepsilon \to 0$ be the sequence of solutions to the regularised problems as stated in Lemma 2.1.

Then, there exists a subsequence u^{ε} converging a.e. on $\Omega \times [0, \infty)$ to a limit $u \in L^{\infty}_{loc}(0, \infty; L^{1}(\Omega))^{I}$ with $u_{i} \log u_{i} \in L^{\infty}_{loc}(0, \infty; L^{1}(\Omega))$ for all $i \in \{1, \ldots, I\}$. Furthermore, $(u_{i}^{\varepsilon})^{\frac{m_{i}}{2}} \rightarrow (u_{i})^{\frac{m_{i}}{2}}$ weakly in $L^{2}(0, T; H^{1}(\Omega))$ for all $i \in \{1, \ldots, I\}$ and T > 0.

Proof. Due to the lack of uniform-in- ε estimates of the non-linearities, it is difficult to show directly, for instance by means of an Aubin–Lions lemma, that u_i^{ε} has a convergent subsequence. Following the ideas from [15], we first prove that $\varphi_i^E(u^{\varepsilon})$ converges (up to a subsequence) to z_i^E as $\varepsilon \to 0$, and then that z_i^E converges to u_i (up to a subsequence) as $E \to \infty$. In combination with the convergence of $\varphi_i^E(u^{\varepsilon})$ to u_i^{ε} for $E \to \infty$, this leads to the desired result.

Due to the bound $\varphi_i^E \leq 3E$, it follows at once that $\{\varphi_i^E(u^{\varepsilon})\}$ is bounded in $L^2(0,T;L^2(\Omega))$ uniformly in $\varepsilon > 0$ for each $E \in \mathbb{N}$. Next, by the chain rule we have

$$\nabla \varphi_i^E(u^{\varepsilon}) = \sum_{j=1}^I \partial_j \varphi_i^E(u^{\varepsilon}) \nabla u_j^{\varepsilon} = \sum_{j=1}^I \frac{2}{m_j} \partial_j \varphi_i^E(u^{\varepsilon}) \left(u_j^{\varepsilon}\right)^{1-\frac{m_j}{2}} \nabla (u_j^{\varepsilon})^{\frac{m_j}{2}}.$$

Thus,

$$\begin{split} \int_{Q_T} |\nabla \varphi_i^E(u^{\varepsilon})|^2 \, dx \, dt &\leq I \sum_{j=1}^I \frac{4}{m_j^2} \int_{Q_T} |\partial_j \varphi_i^E(u^{\varepsilon})|^2 |u_j^{\varepsilon}|^{2-m_j} \left| \nabla (u_j^{\varepsilon})^{\frac{m_j}{2}} \right|^2 \, dx \, dt \\ &\leq C(E) \sum_{j=1}^I \int_{Q_T} \left| \nabla (u_j^{\varepsilon})^{\frac{m_j}{2}} \right|^2 \, dx \, dt \end{split}$$

thanks to the compact support of $D\varphi_i^E$, $m_j < 2$, and the $L^2(0,T;L^2(\Omega))$ bound on $\nabla(u_j^{\varepsilon})^{\frac{m_j}{2}}$ from Lemma 2.1. As a consequence, we know that $\{\varphi_i^E(u^{\varepsilon})\}$ is bounded (uniformly in ε) in $L^2(0,T;H^1(\Omega))$.

To apply the Aubin–Lions Lemma, we need an estimate concerning the time derivative of $\varphi_i^E(u^{\varepsilon})$. Using $\partial_j \varphi_i^E(u^{\varepsilon})\psi$ as a test function in (2.3) and summing over $j \in \{1, \ldots, I\}$, we obtain for almost all $t_2 > t_1 \ge 0$,

$$\begin{split} &\int_{\Omega} \varphi_i^E(u^{\varepsilon}(\cdot,t_2))\psi(\cdot,t_2)\,dx - \int_{\Omega} \varphi_i^E(u^{\varepsilon}(\cdot,t_1))\psi(\cdot,t_1)\,dx - \int_{t_1}^{t_2} \int_{\Omega} \varphi_i^E(u^{\varepsilon})\partial_t\psi\,dx\,dt \\ &= -\sum_{j,k=1}^{I} \frac{4d_j}{m_k} \int_{t_1}^{t_2} \int_{\Omega} \psi \left[\partial_j \partial_k \varphi_i^E(u^{\varepsilon})(u_j^{\varepsilon})^{\frac{m_j}{2}}(u_k^{\varepsilon})^{1-\frac{m_k}{2}} \right] \nabla(u_j^{\varepsilon})^{\frac{m_j}{2}} \cdot \nabla(u_k^{\varepsilon})^{\frac{m_k}{2}}\,dx\,dt \\ &- \sum_{j=1}^{I} 2d_j \int_{t_1}^{t_2} \int_{\Omega} \partial_j \varphi_i^E(u^{\varepsilon})(u_j^{\varepsilon})^{\frac{m_j}{2}} \nabla(u_j^{\varepsilon})^{\frac{m_j}{2}} \cdot \nabla\psi\,dx\,dt \\ &+ \sum_{j=1}^{I} \int_{t_1}^{t_2} \int_{\Omega} \partial_j \varphi_i^E(u^{\varepsilon}) \frac{f_j(u^{\varepsilon})}{1+\varepsilon|f(u^{\varepsilon})|}\psi\,dx\,dt. \end{split}$$
(2.11)

The third term on the right hand side is clearly bounded uniformly in ε for each fixed $E \in \mathbb{N}$ since $D\varphi_i^E$ has a compact support. The first and second terms are bounded uniformly in ε thanks to the boundedness of $\nabla(u_k^{\varepsilon})^{\frac{m_k}{2}}$ in $L^2(0,T;L^2(\Omega))$ for all $k = 1, \ldots, I$, and properties (E2), (E3) in Lemma 2.3. It follows then that $\partial_t \varphi_i^E(u^{\varepsilon})$ is bounded uniformly (w.r.t. $\varepsilon > 0$) in $L^1(0,T;(W^{1,\infty}(\Omega))')$ for each fixed $E \in \mathbb{N}$.

Therefore, by applying an Aubin–Lions lemma to the sequence $\{\varphi_i^E(u^{\varepsilon})\}_{\varepsilon>0}$, for fixed $E \in \mathbb{N}$, there exists a subsequence (not relabeled) of $\varphi_i^E(u^{\varepsilon})$ converging strongly in $L^2(0,T;L^2(\Omega))$ and, thus, almost everywhere as $\varepsilon \to 0$. Using a diagonal sequence argument, one can extract a further subsequence such that $\varphi_i^E(u^{\varepsilon})$ converges a.e. in Ω to a measurable function z_i^E for all $E \in \mathbb{N}$ and $i = 1, \ldots, I$.

We next prove that z_i^E converges a.e. to some measurable function u_i as $E \to \infty$. First, since $\sum_{j=1}^{I} u_j^{\varepsilon} \log u_j^{\varepsilon}$ is uniformly bounded w.r.t. to $\varepsilon > 0$ in $L^{\infty}(0,T;L^1(\Omega))$, it follows that $\varphi_i^E(u^{\varepsilon}) \log \varphi_i^E(u^{\varepsilon})$ is uniformly bounded w.r.t. to $\varepsilon > 0$ and $E \in \mathbb{N}$ in $L^{\infty}(0,T;L^1(\Omega))$. This is trivial in case $E \leq 1$, $\varphi_i^E(u^{\varepsilon}) \leq 1$, or $\sum_{j=1}^{I} u_j^{\varepsilon} E^{-\alpha_j^i} \leq 1$. Otherwise, there exists some j such that $u_j^{\varepsilon} E^{-\alpha_j^i} > 1/I$ holds true. And as $\alpha_j^i > 1$, we derive

$$\varphi_i^E(u^{\varepsilon}) \leqslant 3E \leqslant 3EIu_j^{\varepsilon}E^{-\alpha_j^i} \leqslant 3Iu_j^{\varepsilon}.$$

The bound $\varphi_i^E(u^{\varepsilon}) > 1$ ensures $\varphi_i^E(u^{\varepsilon}) \log \varphi_i^E(u^{\varepsilon}) \leq 3Iu_j^{\varepsilon} \log(3Iu_j^{\varepsilon})$ and the claim follows. Thus, $z_i^E \log z_i^E$ is uniformly bounded in $L^{\infty}(0,T;L^1(\Omega))$ w.r.t. $E \in \mathbb{N}$ by Fatou's Lemma. Secondly,

$$\begin{split} z_j^E(x,t) &= z_j^{\widetilde{E}}(x,t) \text{ for all } \widetilde{E} > E, \text{ if } \sum_{j=1}^I z_j^E(x,t) E^{-\alpha_j^i} < 1. \text{ Indeed}, \\ \sum_{j=1}^I z_j^E(x,t) E^{-\alpha_j^i} &= \lim_{\varepsilon \to 0} \sum_{j=1}^I \varphi_j^E(u^\varepsilon(x,t)) E^{-\alpha_j^i} \end{split}$$

guarantees that $\sum_{j=1}^{I} \varphi_j^E(u^{\varepsilon}(x,t)) E^{-\alpha_j^i} < 1$ holds true for sufficiently small $\varepsilon > 0$. Thanks to the property (E8) in Lemma 2.3, it follows that $\varphi_i^E(u^{\varepsilon}(x,t)) = u_i^{\varepsilon}(x,t) = \varphi_i^{\widetilde{E}}(u^{\varepsilon}(x,t))$ for small enough ε and all $\widetilde{E} > E$. Therefore, due to $z_i^E(x,t) = \lim_{\varepsilon \to 0} \varphi_i^E(u^{\varepsilon}(x,t))$, we obtain $z_i^E(x,t) = z_i^{\widetilde{E}}(x,t)$ for all $\widetilde{E} > E$ as desired. As a result, if $\sum_{j=1}^{I} z_j^E(x,t) E^{-\alpha_j^i} < 1$ for some (x,t), then $\lim_{E\to\infty} z_i^E(x,t)$ exists and is finite for all $i = 1, \ldots, I$. Using the fact that $\sum_{j=i}^{I} z_j^E \log z_j^E$ is bounded uniformly w.r.t. $E \in \mathbb{N}$ in $L^{\infty}(0,T; L^1(\Omega))$, we have

$$\lim_{E \to \infty} \mathcal{L}^{n+1}\left(\left\{(x,t) \in Q_T : \sum_{j=1}^{I} z_j^E(x,t) E^{-\alpha_j^i} \ge 1\right\}\right) = 0$$

where \mathcal{L}^{n+1} is the Lebesgue measure in \mathbb{R}^{n+1} . Hence, the limit $u_i(x,t) = \lim_{E \to \infty} z_i^E(x,t)$ exists for a.e. $(x,t) \in Q_T$. Moreover, $u_i \log u_i \in L^{\infty}(0,T;L^1(\Omega))$ due to Fatou's Lemma and $z_i^E \log z_i^E \in L^{\infty}(0,T;L^1(\Omega))$. Since $\sum_{j=1}^{I} u_j^{\varepsilon}$ is uniformly bounded in $L^1(Q_T)$, we find

$$0 = \lim_{E \to \infty} \mathcal{L}^{n+1} \left(\left\{ (x,t) \in Q_T : \sum_{j=1}^{I} u_j^{\varepsilon}(x,t) E^{-\alpha_j^i} \ge 1 \right\} \right)$$
$$\geq \lim_{E \to \infty} \mathcal{L}^{n+1} \left(\left\{ (x,t) \in Q_T : u_i^{\varepsilon}(x,t) \neq \varphi_i^E(u^{\varepsilon})(x,t) \right\} \right)$$

and this limit is uniform in $\varepsilon > 0$. Now, we estimate for $\delta > 0$

$$\mathcal{L}^{d+1}\left(\left\{(x,t)\in Q_T: |u_i^{\varepsilon}(x,t)-u_i(x,t)|>\delta\right\}\right)$$

$$\leq \mathcal{L}^{d+1}\left(\left\{(x,t)\in Q_T: u_i^{\varepsilon}(x,t)\neq \varphi_i^E(u^{\varepsilon})(x,t)\right\}\right)$$

$$+\mathcal{L}^{d+1}\left(\left\{(x,t)\in Q_T: |\varphi_i^E(u^{\varepsilon})(x,t)-z_i^E(x,t)|>\frac{\delta}{2}\right\}\right)$$

$$+\mathcal{L}^{d+1}\left(\left\{(x,t)\in Q_T: |z_i^E(x,t)-u_i(x,t)|>\frac{\delta}{2}\right\}\right).$$

As we have proved that $\varphi_i^E(u^{\varepsilon}) \to z_i^E$ a.e. in Q_T for $\varepsilon \to 0$ and fixed $E \in \mathbb{N}$, and that $z_i^E \to u_i$ a.e. in Q_T as $E \to \infty$, we infer the convergence in measure of u_i^{ε} to u_i for $\varepsilon \to 0$, and convergence a.e. of another subsequence.

The uniform bound on $u_i^{\varepsilon} \log u_i^{\varepsilon}$ in $L^{\infty}(0,T; L^1(\Omega))$ and the convergence $u_i^{\varepsilon} \to u_i$ a.e. ensure that $u_i^{\varepsilon} \to u_i$ strongly in $L^p(0,T; L^1(\Omega))$ for all $p \ge 1$. One can easily prove this by truncating u_i^{ε} at a sufficiently large threshold. By the strong convergence of u_i^{ε} to u_i in $L^1(0,T; L^1(\Omega))$, we are able to prove the distributional convergence of $(u_i^{\varepsilon})^{\frac{m_i}{2}}$ to $(u_i)^{\frac{m_i}{2}}$ by noting that $m_i < 2$. The uniform $L^2(0,T; H^1(\Omega))$ bound on $(u_i^{\varepsilon})^{\frac{m_i}{2}}$ then leads to a subsequence $(u_i^{\varepsilon})^{\frac{m_i}{2}}$ which converges to $(u_i)^{\frac{m_i}{2}}$ weakly in $L^2(0,T; H^1(\Omega))$. Thanks to the weak lower semicontinuity of the $L^2(0,T; L^2(\Omega))$ norm, we also deduce

$$\int_0^T \int_\Omega |\nabla(u_i)^{\frac{m_i}{2}}|^2 \, dx \, dt \le \liminf_{\varepsilon \to 0} \int_0^T \int_\Omega |\nabla(u_i^\varepsilon)^{\frac{m_i}{2}}|^2 \, dx \, dt$$

for all $i \in \{1, ..., I\}$, where the right hand side is bounded via the uniform $L^2(0, T; H^1(\Omega))$ bound on $(u_i^{\varepsilon})^{\frac{m_i}{2}}$. This completes the proof of the lemma. At this point, we expect the function $u = (u_1, \ldots, u_I)$ in Lemma 2.4 to be a renormalised solution to (1.1). We will first derive an equation admitting $\varphi_i^E(u)$ as a solution. This equation is already "almost" matching the formulation for a renormalised solution (1.4) except for a "defect measure".

Lemma 2.5. Let $u = (u_1, \ldots, u_I)$ be the functions constructed in Lemma 2.4. Then, for any $\psi \in C^{\infty}([0,T]; C_0^{\infty}(\overline{\Omega})), \varphi_i^E(u)$ satisfies

$$\int_{\Omega} \varphi_i^E(u(\cdot,T))\psi(\cdot,T) \, dx - \int_{\Omega} \varphi_i^E(u(\cdot,0))\psi(\cdot,0) \, dx - \int_{Q_T} \varphi_i^E(u)\partial_t \psi \, dx \, dt$$
$$= -\int_{Q_T} \psi \, d\mu_i^E(x,t) - \sum_{j=1}^I d_j m_j \int_{Q_T} \partial_j \varphi_i^E(u) u_j^{m_j-1} \nabla u_j \cdot \nabla \psi \, dx \, dt$$
$$+ \sum_{j=1}^I \int_{Q_T} \partial_j \varphi_i^E(u) f_j(u) \psi \, dx \, dt$$
(2.12)

where μ_i^E is a signed Radon measure satisfying

$$\lim_{E \to \infty} |\mu_i^E| (\overline{\Omega} \times [0, T)) = 0$$
(2.13)

for all T > 0 and $i \in \{1, ..., I\}$.

Proof. Choosing $t_1 = 0$, $t_2 = T$, and using the convergence $u^{\varepsilon} \to u$ a.e. in Q_T , the weak convergence $\nabla(u_i^{\varepsilon})^{\frac{m_i}{2}} \to \nabla(u_i)^{\frac{m_i}{2}}$ in $L^2(0,T;L^2(\Omega))$, and the fact that $D\varphi_i^E(u^{\varepsilon})$ vanishes when u^{ε} is too large, we straightforwardly obtain the convergence of the left hand side and the last two terms on the right hand side of (2.11). It remains to establish

$$-4\sum_{j,k=1}^{l} \frac{d_j}{m_k} \int_{Q_T} \psi \left[\partial_j \partial_k \varphi_i^E(u^\varepsilon) (u_j^\varepsilon)^{\frac{m_j}{2}} (u_k^\varepsilon)^{1-\frac{m_k}{2}} \right] \nabla (u_j^\varepsilon)^{\frac{m_j}{2}} \cdot \nabla (u_k^\varepsilon)^{\frac{m_k}{2}} dx \, dt \\ \longrightarrow -\int_{Q_T} \psi \, d\mu_i^E(x,t)$$

with a signed Radon measure μ_i^E satisfying (2.13). By denoting

$$\mu_{i,\varepsilon}^E := 4 \sum_{j,k=1}^{I} \frac{d_j}{m_k} \left[\partial_j \partial_k \varphi_i^E(u^\varepsilon) (u_j^\varepsilon)^{\frac{m_j}{2}} (u_k^\varepsilon)^{1-\frac{m_k}{2}} \right] \nabla (u_j^\varepsilon)^{\frac{m_j}{2}} \cdot \nabla (u_k^\varepsilon)^{\frac{m_k}{2}} \, dx \, dt$$

we can use property (E2) of the truncation function φ_i^E and the ε -uniform bound of $\nabla(u_i^{\varepsilon})^{\frac{m_i}{2}}$ in $L^2(0,T;L^2(\Omega))$, to obtain

$$|\mu_{i,\varepsilon}^E|(\overline{Q}_T) \leqslant C$$

for all $\varepsilon > 0$. Therefore, by passing to a subsequence, we know that $\mu_{i,\varepsilon}^E$ weak-* converges on \overline{Q}_T to a signed Radon measure μ_i^E as $\varepsilon \to 0$. It remains to prove (2.13). Due to Young's inequality, we have

$$\begin{split} &|\mu_{i,\varepsilon}^{E}|(\overline{Q}_{T}) \\ &\leqslant C\sum_{j,k=1}^{I}\sum_{K=1}^{\infty}\int_{Q_{T}}|\partial_{j}\partial_{k}\varphi_{i}^{E}(u^{\varepsilon})|(u_{j}^{\varepsilon})^{\frac{m_{j}}{2}}(u_{k}^{\varepsilon})^{1-\frac{m_{k}}{2}}\chi_{\{K-1\leqslant|u^{\varepsilon}|< K\}}\left|\nabla(u_{j}^{\varepsilon})^{\frac{m_{j}}{2}}\right|^{2}\,dx\,dt \\ &\leqslant C\sum_{l=1}^{I}\sum_{K=1}^{\infty}\nu_{l,K}^{\varepsilon}(\overline{Q}_{T})\sup_{\substack{1\leqslant j,k\leqslant I\\K-1\leqslant|v|< K}}|\partial_{j}\partial_{k}\varphi_{i}^{E}(v)|v_{j}^{\frac{m_{j}}{2}}v_{k}^{1-\frac{m_{k}}{2}} \end{split}$$

where

$$\nu_{l,K}^{\varepsilon} := \chi_{\{K-1 \le |u^{\varepsilon}| < K\}} \left| \nabla (u_l^{\varepsilon})^{\frac{m_l}{2}} \right|^2 \, dx \, dt.$$

We stress that $\nu_{l,K}^{\varepsilon}$ is uniformly bounded w.r.t. l, K, and ε . Consequently, we may pass to a subsequence $\nu_{l,K}^{\varepsilon}$ which converges weak-* on \overline{Q}_T to a Radon measure $\nu_{l,K}$ as $\varepsilon \to 0$. Together with the weak-* convergence of $\mu_{i,\varepsilon}^E$ to μ_i^E on \overline{Q}_T , we derive

$$\begin{aligned} |\mu_i^E|(\overline{Q}_T) &\leq \liminf_{\varepsilon \to 0} |\mu_{i,\varepsilon}^E|(\overline{Q}_T) \\ &\leq C \sum_{l=1}^I \sum_{K=1}^\infty \nu_{l,K}(\overline{Q}_T) \sup_{\substack{1 \leq j,k \leq I\\ K-1 \leq |v| < K}} |\partial_j \partial_k \varphi_i^E(v)| v_j^{\frac{m_j}{2}} v_k^{1-\frac{m_k}{2}}. \end{aligned}$$

Moreover,

$$\sum_{K=1}^{\infty} \nu_{l,K}^{\varepsilon}(\overline{Q}_T) = \int_{Q_T} \left| \nabla(u_j^{\varepsilon})^{\frac{m_j}{2}} \right|^2 \, dx \, dt,$$

which is bounded uniformly in ε . Fatou's Lemma applied to the counting measure on N now entails

$$\sum_{K=1}^{\infty}\nu_{l,K}(\overline{Q}_T)\leqslant \liminf_{\varepsilon\to 0}\sum_{K=1}^{\infty}\nu_{l,K}^{\varepsilon}(\overline{Q}_T)<+\infty.$$

Therefore, employing the dominated convergence theorem, we can finally estimate

$$\begin{split} \lim_{E \to \infty} |\mu_i^E|(\overline{Q}_T) &\leqslant C \sum_{l=1}^I \sum_{K=1}^\infty \nu_{l,K}(\overline{Q}_T) \lim_{E \to \infty} \sup_{\substack{1 \leqslant j, k \leqslant I \\ K-1 \leqslant |v| < K}} |\partial_j \partial_k \varphi_i^E(v)| v_j^{\frac{m_j}{2}} v_k^{1-\frac{m_k}{2}} \\ &= C \sum_{l=1}^I \sum_{K=1}^\infty \nu_{l,K}(\overline{Q}_T) \cdot 0 = 0 \end{split}$$

thanks to the properties (E2) and (E7) of the truncation function φ_i^E .

To prove Theorem 1.2, we use the following technical lemma whose proof can be found in [15].

Lemma 2.6 (A weak chain rule for the time derivative). [15, Lemma 4] Let Ω be a bounded domain with Lipschitz boundary. Assume that T > 0, $v \in L^2(0, T; H^1(\Omega)^I)$, and $v_0 \in L^1(\Omega)^I$. Let ν_i be a Radon measure on \overline{Q}_T , $w_i \in L^1(Q_T)$, and $z_i \in L^2(0, T; L^2(\Omega)^I)$ for $1 \leq i \leq I$. Assume moreover that for any $\psi \in C^{\infty}(\overline{Q}_T)$ with compact support we have

$$\begin{split} \int_{\Omega} v_i(T)\psi(T) \, dx &- \int_{Q_T} v_i \frac{d}{dt} \psi \, dx \, dt - \int_{\Omega} v_0 \psi(0) \, dx \\ &= \int_{\overline{Q}_T} \psi \, d\nu_i + \int_{Q_T} w_i \psi \, dx \, dt + \int_{Q_T} z_i \cdot \nabla \psi \, dx \, dt. \end{split}$$

Let $\xi : \mathbb{R}^I \to \mathbb{R}$ be a smooth function with compactly supported first derivatives. Then, we have for all $\psi \in C^{\infty}(\overline{Q}_T)$ with compact support

$$\begin{split} \left| \int_{\Omega} \xi(v(T))\psi(T) \, dx - \int_{Q_T} \xi(v) \frac{d}{dt} \psi \, dx \, dt - \int_{\Omega} \xi(v_0)\psi(0) \, dx - \sum_{i=1}^{I} \int_{Q_T} \psi \partial_i \xi(v) w_i \, dx \, dt \right| \\ &- \sum_{i=1}^{I} \int_{Q_T} \partial_i \xi(v) z_i \cdot \nabla \psi \, dx \, dt - \sum_{i,k=1}^{I} \int_{Q_T} \psi \partial_i \partial_k \xi(v) z_i \cdot \nabla v_k \, dx \, dt \bigg| \\ &\leqslant C(\Omega) \|\psi\|_{\infty} (\sup_u |D\xi(u)|) \sum_{i=1}^{I} |\nu_i| (\overline{Q}_T). \end{split}$$

We are now ready to prove the existence of global renormalised solutions.

Proof of Theorem 1.2. By applying Lemma 2.6 to (2.12), we obtain an approximate relation for the weak time derivative of $\xi(\varphi^E(u))$, which leads to the desired equation for $\xi(u)$ when passing to the limit $E \to \infty$. In detail, we set $v_i := \varphi_i^E(u), (v_0)_i := \varphi_i^E(u_0), v_i := -\mu_i^E$,

$$z_i := -\sum_{j=1}^I d_j m_j \partial_j \varphi_i^E(u) u_j^{m_j - 1} \nabla u_j, \quad w_i := \sum_{j=1}^I \partial_j \varphi_i^E(u) f_j(u),$$

and obtain for any smooth function ξ with compactly supported first derivatives

$$\begin{split} & \left| \int_{\Omega} \xi(\varphi^{E}(u))\psi(T) \, dx - \int_{Q_{T}} \xi(\varphi^{E}(u)) \frac{d}{dt} \psi \, dx \, dt - \int_{\Omega} \xi(\varphi^{E}(u_{0}))\psi(0) \, dx \right. \\ & \left. - \sum_{i=1}^{I} \sum_{j=1}^{I} \int_{Q_{T}} \psi \partial_{i} \xi(\varphi^{E}(u)) \partial_{j} \varphi^{E}_{i}(u) f_{j}(u) \, dx \, dt \right. \\ & \left. + \sum_{i=1}^{I} \sum_{j=1}^{I} \int_{Q_{T}} d_{j} m_{j} \partial_{i} \xi(\varphi^{E}(u)) \partial_{j} \varphi^{E}_{i}(u) u^{m_{j}-1}_{j} \nabla u_{j} \cdot \nabla \psi \, dx \, dt \right. \\ & \left. + \sum_{i,k=1}^{I} \sum_{j,\ell=1}^{I} \int_{Q_{T}} d_{j} m_{j} \psi \partial_{i} \partial_{k} \xi(\varphi^{E}(u)) \partial_{j} \varphi^{E}_{i}(u) \partial_{\ell} \varphi^{E}_{k}(u) u^{m_{j}-1}_{j} \nabla u_{j} \cdot \nabla u_{\ell} \, dx \, dt \right| \\ & \leq C(\Omega) \|\psi\|_{\infty} (\sup_{u} |D\xi(u)|) \sum_{i=1}^{I} |\mu^{E}_{i}| (\overline{Q}_{T}). \end{split}$$

We now want to pass to the limit $E \to \infty$ in (2.14) to obtain (1.4). Note first that due to (2.13), we obtain in the limit an equality instead of just an estimate. Since ξ has compactly supported first derivatives, $\partial_j \varphi_i^E(u)$ is bounded (see (E5)), and $\varphi_i^E(u) \to u_i$ a.e. as $E \to \infty$, we directly obtain the following limits for the first line in (2.14):

$$\begin{split} &\int_{\Omega} \xi(\varphi^{E}(u(T)))\psi(T) \, dx \longrightarrow \int_{\Omega} \xi(u(T))\psi(T) \, dx, \\ &\int_{Q_{T}} \xi(\varphi^{E}(u)) \frac{d}{dt}\psi \, dx \, dt \longrightarrow \int_{Q_{T}} \xi(u) \frac{d}{dt}\psi \, dx \, dt, \\ &\int_{\Omega} \xi(\varphi^{E}(u_{0}))\psi(0) \, dx \longrightarrow \int_{\Omega} \xi(u_{0})\psi(0) \, dx. \end{split}$$

By employing $m_j u_j^{m_j-1} \nabla u_j = 2(u_j)^{\frac{m_j}{2}} \nabla (u_j)^{\frac{m_j}{2}}$ and $(u_j)^{\frac{m_j}{2}} \in L^2(0,T;H^1(\Omega))$, we also derive

$$\begin{split} \sum_{i=1}^{I} \sum_{j=1}^{I} \int_{Q_{T}} d_{j} m_{j} \partial_{i} \xi(\varphi^{E}(u)) \partial_{j} \varphi^{E}_{i}(u) u_{j}^{m_{j}-1} \nabla u_{j} \cdot \nabla \psi \, dx \, dt \\ \longrightarrow \sum_{i=1}^{I} \int_{Q_{T}} d_{i} m_{i} \partial_{i} \xi(u) u_{i}^{m_{i}-1} \nabla u_{i} \cdot \nabla \psi \, dx \, dt. \end{split}$$

It remains to ensure the convergence of the third and fourth line of (2.14). To this end, we recall $(u_j)^{\frac{m_j}{2}} \in L^2(0,T; H^1(\Omega))$, and we utilise the following observation: there exists a constant $E_0 > 0$ such that for all $E > E_0$ the inequality $\sum_{i=1}^{I} u_i \ge E_0$ implies $\partial_i \xi(\varphi^E(u)) = \partial_i \xi(u) = 0$ and $\partial_i \partial_k \xi(\varphi^E(u)) = \partial_i \partial_k \xi(u) = 0$ for all $i, k \in \{1, \ldots, I\}$. The convergence of the third and fourth line above is now a consequence of this auxiliary result, as the derivatives of ξ are zero provided $\max_i u_i$ is larger than E_0 :

$$\begin{split} \sum_{i=1}^{I} \sum_{j=1}^{I} \int_{Q_{T}} \psi \partial_{i} \xi(\varphi^{E}(u)) \partial_{j} \varphi_{i}^{E}(u) f_{j}(u) \, dx \, dt \longrightarrow \sum_{i=1}^{I} \int_{Q_{T}} \psi \partial_{i} \xi(u) f_{i}(u) \, dx \, dt \\ \sum_{i,j,k,\ell=1}^{I} \int_{Q_{T}} d_{j} m_{j} \psi \partial_{i} \partial_{k} \xi(\varphi^{E}(u)) \partial_{j} \varphi_{i}^{E}(u) \partial_{\ell} \varphi_{k}^{E}(u) u_{j}^{m_{j}-1} \nabla u_{j} \cdot \nabla u_{\ell} \, dx \, dt \\ \longrightarrow \sum_{i,k=1}^{I} \int_{Q_{T}} d_{i} m_{i} \psi \partial_{i} \partial_{k} \xi(u) u_{i}^{m_{i}-1} \nabla u_{i} \cdot \nabla u_{k} \, dx \, dt. \end{split}$$

The previous observation readily follows by choosing $E_0 > 0$ such that $\operatorname{supp}(D\xi) \subset B_{E_0/\sqrt{I}}(0)$. Given $E > E_0$ and $\sum_{i=1}^{I} u_i \ge E_0$, one gets $\sum_{i=1}^{I} \varphi_i^E(u) \ge E_0$ from the definition of φ_i^E in (2.6). In particular, $u, \varphi^E(u) \notin B_{E_0/\sqrt{I}}(0)$, which proves the claim.

2.3. Entropy–entropy dissipation law and conservation laws. We prove in this subsection that any global renormalised solution to (1.1) satisfies the entropy law (1.5) and (1.6). These relations become helpful in the next section to investigate the convergence to equilibrium of renormalised solutions.

Proof of the entropy law (1.5). We will use ideas from [16, Proposition 5]. Let $M \ge 2$ and $\theta_M : \mathbb{R} \to \mathbb{R}$ be a smooth function such that for some C > 0 sufficiently large,

$$\begin{aligned} \theta_M(s) &= s \quad \forall s \leqslant M, \qquad 0 \leqslant \theta'_M(s) \leqslant 1 \quad \forall s \in \mathbb{R}, \qquad \theta'_M(s) = 0 \quad \forall s \geqslant M^C, \\ \text{and} \quad |\theta''_M(s)| \leqslant \frac{C}{1 + s \log(s + 1)} \quad \forall s \geqslant 0. \end{aligned}$$

Such a function θ_M exists for C > 0 large enough as in this situation

$$\int_{M}^{M^{C}} \frac{1}{1+s\log(s+1)} \, ds \ge 2.$$

In the following, we first choose the renormalising function ξ from Definition 1.1 to be

$$\xi(u) := \theta_M \left(\sum_{i=1}^{I} (u_i + \varepsilon) (\log(u_i + \varepsilon) + \mu_i - 1) \right)$$

then let $\varepsilon \to 0$ and $M \to \infty$ consecutively. Using this ξ in (1.4) with $\psi \equiv 1$, we derive

$$\int_{\Omega} \theta_M \left(\sum_{i=1}^{I} (u_i(\tau) + \varepsilon) (\log(u_i(\tau) + \varepsilon) + \mu_i - 1) \right) dx \Big|_{\tau=s}^{\tau=T}$$

$$= -\sum_{i=1}^{I} d_{i}m_{i} \int_{s}^{T} \int_{\Omega} \theta'_{M}(\cdots) \frac{1}{u_{i}+\varepsilon} u_{i}^{m_{i}-1} |\nabla u_{i}|^{2} dx dt$$

$$- \sum_{i,j=1}^{I} d_{j}m_{i} \int_{s}^{T} \int_{\Omega} \theta'_{M}(\cdots) (\log(u_{i}+\varepsilon) + \mu_{i}) (\log(u_{j}+\varepsilon) + \mu_{j}) u_{i}^{m_{i}-1} \nabla u_{i} \nabla u_{j} dx dt$$

$$+ \sum_{i=1}^{I} \int_{s}^{T} \int_{\Omega} \theta'_{M}(\cdots) (\log(u_{i}+\varepsilon) + \mu_{i}) f_{i}(u) dx dt.$$
(2.15)

Here we write $(\cdots) := \sum_{i=1}^{I} (u_i + \varepsilon) (\log(u_i + \varepsilon) + \mu_i - 1)$ for simplicity. In the limit $\varepsilon \to 0$, the convergence of the left hand side of (2.15) is immediate by the Lebesgue dominated convergence theorem. By rewriting

$$\frac{u_i^{m_i-1}}{u_i+\varepsilon}|\nabla u_i|^2 = \frac{4}{m_i^2}\frac{u_i}{u_i+\varepsilon}\left|\nabla u_i^{\frac{m_i}{2}}\right|^2,$$

and

$$u_i^{m_i-1} \nabla u_i \nabla u_j = \frac{4}{m_i m_j} u_i^{\frac{m_i}{2}} u_j^{1-\frac{m_j}{2}} \nabla u_i^{\frac{m_i}{2}} \nabla u_j^{\frac{m_j}{2}},$$

we can use the fact that $\nabla u_i^{\frac{m_i}{2}}$ is bounded in $L^2(Q_T)$ and $\theta'_M(s) = \theta''_M(s) = 0$ for $s \ge M^C$ to pass to the limit $\varepsilon \to 0$ for the first and second terms on the right hand side of (2.15). Concerning the last term, we observe that

$$\theta'_M(\cdots)f_i(u)\log(u_i+\varepsilon) \leq C(M)u_i|\log(u_i+\varepsilon)|$$

thanks to the Lipschitz continuity of f_i and the fact that $\theta'_M(s) = 0$ for $s \ge M^C$. Note that $\{u_i | \log(u_i + \varepsilon)|\}_{\varepsilon>0}$ is bounded uniformly (in ε) in $L^1(Q_T)$ due to Lemma 2.4. We now use the assumption (1.2) and Fatou's Lemma to get

$$\limsup_{\varepsilon \to 0} \sum_{i=1}^{I} \int_{s}^{T} \int_{\Omega} \theta'_{M}(\cdots) (\log(u_{i}+\varepsilon) + \mu_{i}) f_{i}(u) \, dx \, dt$$
$$\leqslant \sum_{i=1}^{I} \int_{s}^{T} \int_{\Omega} \theta'_{M}(\cdots) (\log u_{i} + \mu_{i}) f_{i}(u) \, dx \, dt.$$

Therefore, by letting $\varepsilon \to 0$ in (2.15), we obtain

$$\int_{\Omega} \theta_M \left(\sum_{i=1}^{I} u_i(\tau) (\log u_i(\tau) + \mu_i - 1) \right) dx \Big|_{\tau=s}^{\tau=T}$$

$$\leq -\sum_{i=1}^{I} d_i m_i \int_s^T \int_{\Omega} \theta'_M(\cdots) u_i^{m_i-2} |\nabla u_i|^2 dx dt$$

$$-\sum_{i,j=1}^{I} d_j m_i \int_s^T \int_{\Omega} \theta'_M(\cdots) (\log u_i + \mu_i) (\log u_j + \mu_j) u_i^{m_i-1} \nabla u_i \nabla u_j dx dt$$

$$+ \sum_{i=1}^{I} \int_s^T \int_{\Omega} \theta'_M(\cdots) (\log u_i + \mu_i) f_i(u) dx dt.$$
(2.16)

Note that here (\cdots) stands for $\sum_{i=1}^{I} u_i (\log u_i + \mu_i - 1)$. We now pass to the limit $M \to \infty$. The convergence of the left hand side of (2.16) follows from Fatou's Lemma and the dominated convergence theorem thanks to the fact that $u_i \log u_i \in L^{\infty}(0,T; L^1(\Omega))$. Using $\nabla(u_i)^{\frac{m_i}{2}} \in L^2(Q_T)$ and $u_i^{m_i-2} |\nabla u_i|^2 = \frac{4}{m_i^2} |\nabla(u_i)^{\frac{m_i}{2}}|^2$, the convergence of the first term on the right hand side of (2.16) follows via dominated convergence. The reaction term can also be dealt by Fatou's Lemma, the entropy dissipation assumption (1.2) and the fact that $\theta'_M \ge 0$. We are left to consider the second term on the right hand side of (2.16). It is straightforward that the integrand converges pointwise to zero as $M \to \infty$, since θ_M is an approximation of the identity. By the fact that $\nabla(u_i)^{\frac{m_i}{2}} \in L^2(Q_T)$ and rewriting

$$\theta_M''(\cdots)(\log u_i + \mu_i)(\log u_j + \mu_j)u_i^{m_i - 1} \nabla u_i \nabla u_j = \frac{4}{m_i m_j} \theta_M''(\cdots)(\log u_i + \mu_i)(\log u_j + \mu_j)u_i^{\frac{m_i}{2}} u_j^{1 - \frac{m_j}{2}} \nabla u_i^{\frac{m_i}{2}} \nabla u_j^{\frac{m_j}{2}},$$

it is sufficient to show that $\theta''_M(\dots)(\log u_i + \mu_i)(\log u_j + \mu_j)u_i^{\frac{m_i}{2}}u_j^{1-\frac{m_j}{2}}$ is bounded uniformly in M. Indeed, using the assumption on θ_M as well as $0 < \frac{m_i}{2}$ and $1 - \frac{m_j}{2} < 1$, we deduce

$$\begin{aligned} \left| \theta_M''(\cdots)(\log u_i + \mu_i)(\log u_j + \mu_j)u_i^{\frac{m_i}{2}}u_j^{1-\frac{m_j}{2}} \right| \\ &\leqslant C \left(1 + \sum_{i=1}^I u_i(\log(u_i + 1))^2 \right)^{-1} \left| (\log u_i + \mu_i)(\log u_j + \mu_j)u_i^{\frac{m_i}{2}}u_j^{1-\frac{m_j}{2}} \right| \leqslant C, \end{aligned}$$

In conclusion, by letting $M \to \infty$ in (2.16), we obtain the desired inequality (1.5).

Proof of the conservation law (1.6). Let $\rho \in \mathbb{R}$ be arbitrary. Using the renormalisation

$$\xi(u) := \theta_M \left(\varrho \sum_{i=1}^I q_i u_i + \sum_{i=1}^I (u_i + \varepsilon) (\log(u_i + \varepsilon) + \mu_i - 1) \right)$$

and $\psi \equiv 1$ in (1.4), we can proceed similarly to the previous proof of the entropy law (1.5), now with the additional information that $\sum_{i=1}^{I} \rho \theta'_{M}(\cdots) q_{i} f_{i}(u) = 0$, to obtain

$$\begin{split} \sum_{i=1}^{I} \int_{\Omega} \varrho q_{i} u_{i}(\tau) + u_{i}(\tau) (\log u_{i}(\tau) + \mu_{i} - 1) dx \Big|_{\tau=0}^{\tau=T} \\ \leqslant -\frac{4}{m_{i}^{2}} \sum_{i=1}^{I} \int_{0}^{T} \int_{\Omega} d_{i} |\nabla(u_{i})^{m_{i}/2}|^{2} dx dt + \sum_{i=1}^{I} \int_{0}^{T} \int_{\Omega} f_{i}(u) (\log u_{i} + \mu_{i}) dx dt. \end{split}$$

For $\rho > 0$, we divide both sides by ρ and let $\rho \to +\infty$ to get

$$\sum_{i=1}^{I} \int_{\Omega} q_i u_i(\tau) \, dx \bigg|_{\tau=0}^{\tau=T} \le 0.$$

Repeating the argument for $\rho < 0$, we obtain the reverse inequality and, therefore, the desired conservation law (1.6).

3. EXPONENTIAL CONVERGENCE TO EQUILIBRIUM

3.1. Entropy–entropy dissipation inequality. Without loss of generality, we assume that the domain Ω has unit volume, i.e. $|\Omega| = 1$. We employ the following notation:

$$\overline{u_i} := \int_{\Omega} u_i \, dx \quad \text{and} \quad \overline{u} := (\overline{u_i})_{i=1,\dots,I}$$

To show the convergence to equilibrium for (1.9), we exploit the so-called entropy method. Assuming the complex balanced condition, system (1.9) possesses the relative entropy functional

$$\mathcal{E}[u|u_{\infty}] = \sum_{i=1}^{I} \int_{\Omega} \left(u_i \log \frac{u_i}{u_{i,\infty}} - u_i + u_{i,\infty} \right) dx$$
(3.1)

and the corresponding entropy dissipation function

$$\mathcal{D}[u] = \sum_{i=1}^{I} d_i m_i \int_{\Omega} u_i^{m_i - 2} |\nabla u_i|^2 \, dx + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \Psi\left(\frac{u^{y_r}}{u_{\infty}^{y_r}}; \frac{u^{y'_r}}{u_{\infty}^{y'_r}}\right) \, dx \tag{3.2}$$

with $\Psi(x;y) = x \log(x/y) - x + y$ (see [6, Proposition 2.1] for a derivation of $\mathcal{D}[u]$). Formally we have

$$\mathcal{D}[u] = -\frac{d}{dt}\mathcal{E}[u|u_{\infty}]$$

along the trajectory of (1.9). The following lemma shows that the L^1 norm can be bounded by the relative entropy.

Lemma 3.1. Assume that $\mathcal{E}[u|u_{\infty}] < +\infty$. Then

$$||u_i||_{L^1(\Omega)} = \overline{u_i} \leqslant \widetilde{K} := 2\left(\mathcal{E}(u|u_\infty) + \sum_{i=1}^I u_{i,\infty}\right)$$

for i = 1, ..., I.

Proof. The elementary inequalities $x \log(x/y) - x + y \ge (\sqrt{x} - \sqrt{y})^2 \ge \frac{1}{2}x - y$ ensure that

$$\mathcal{E}[u|u_{\infty}] = \sum_{i=1}^{I} \int_{\Omega} \left(u_i \log \frac{u_i}{u_{i,\infty}} - u_i + u_{i,\infty} \right) dx \ge \frac{1}{2} \sum_{i=1}^{I} \int_{\Omega} u_i dx - \sum_{i=1}^{I} u_{i,\infty} dx$$

Taking the non-negativity of the solution u into account allows to conclude.

Lemma 3.2 (Csiszár–Kullback–Pinsker type inequality). [13, Lemma 2.3] Fix a non-negative mass $M \in \mathbb{R}^m_+$. For all measurable functions $u : \Omega \to \mathbb{R}^I_+$ satisfying the mass conservation $\mathbb{Q}\overline{u} = M$, the following inequality holds,

$$\mathcal{E}[u|u_{\infty}] \ge C_{CKP} \sum_{i=1}^{I} \|u_i - u_{i,\infty}\|_{L^1(\Omega)}^2$$

in which $C_{CKP} > 0$ is a constant depending only on Ω and u_{∞} .

The following two lemmas provide generalisations of the classical logarithmic Sobolev inequality, which are suited for non-linear diffusion.

Lemma 3.3 (L^m -logarithmic Sobolev inequality). [8] For any $m \ge 1$, there exists a constant $C(\Omega, m) > 0$ such that we have

$$\int_{\Omega} \left| \nabla \left(u^{\frac{m}{2}} \right) \right|^2 dx \ge C(\Omega, m) \left(\int_{\Omega} u \log \frac{u}{\overline{u}} \, dx \right)^m.$$

Lemma 3.4 (Generalised logarithmic Sobolev inequality). [22] For any $m > (d-2)_+/d$, there exists a constant $C(\Omega, m) > 0$ such that

$$\int_{\Omega} u^{m-2} |\nabla u|^2 \, dx \ge C(\Omega, m) \overline{u}^{m-1} \int_{\Omega} u \log \frac{u}{\overline{u}} \, dx$$

The cornerstone of the entropy method is the entropy–entropy dissipation inequality which is proved in the following lemma. **Lemma 3.5.** Let K > 0 and $m_i > (d-2)_+/d$ for all $1 \le i \le I$. There exist constants C > 0 and $\alpha \ge 1$ depending on K such that for any measurable function $u : \Omega \to \mathbb{R}^I_+$ subject to $\mathbb{Q}\overline{u} = \mathbb{Q}u_\infty$ and $\mathcal{E}[u|u_\infty] \le K$, we have

$$\mathcal{D}[u] \ge C(\mathcal{E}[u|u_{\infty}])^{\alpha}.$$

Proof. First, similarly to Lemma 3.1, we have the following L^1 bounds:

$$\overline{u}_i = \|u_i\|_{L^1(\Omega)} \leq M_1 := 2\left(K + \sum_{i=1}^I u_{i,\infty}\right).$$

For all i with $(d-2)_+/d < m_i < 1$, we apply Lemma 3.4 to have

$$\int_{\Omega} u_i^{m_i - 2} |\nabla u_i|^2 \, dx \ge C(\Omega, m_i) \overline{u}_i^{m_i - 1} \int_{\Omega} u_i \log \frac{u_i}{\overline{u}_i} \, dx$$

$$\ge C(\Omega, m_i) M_1^{m_i - 1} \int_{\Omega} u_i \log \frac{u_i}{\overline{u}_i} \, dx$$
(3.3)

since $m_i < 1$ and $\overline{u}_i \leq M_1$. Therefore, by applying Lemma 3.3, we can estimate the entropy dissipation from below as follows:

$$\mathcal{D}[u] \ge K_1 \left[\sum_{i=1}^{I} \left(\int_{\Omega} u_i \log \frac{u_i}{\overline{u_i}} \, dx \right)^{\max\{1, m_i\}} + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \Psi \left(\frac{u^{y_r}}{u_{\infty}^{y_r}}; \frac{u^{y_r'}}{u_{\infty}^{y_r'}} \right) \, dx \right].$$

For simplicity, we denote $\alpha = \max_{i=1,\dots,I} \{1, m_i\},\$

$$D_i = \int_{\Omega} u_i \log \frac{u_i}{\overline{u}_i} \, dx \quad \text{for } i = 1, \dots, I, \quad \text{and} \quad F = \sum_{r=1}^R k_r u_{\infty}^{y_r} \int_{\Omega} \Psi\left(\frac{u^{y_r}}{u_{\infty}^{y_r}}; \frac{u^{y'_r}}{u_{\infty}^{y'_r}}\right) \, dx.$$

If $D_i \ge 1$ for some $i \in \{1, \ldots, I\}$ or $F \ge 1$, then we have

$$\mathcal{D}[u] \ge K_1 \ge \frac{K_1}{K^{\alpha}} \left(\mathcal{E}[u|u_{\infty}] \right)^{\alpha} \tag{3.4}$$

using $\mathcal{E}[u|u_{\infty}] \leq K$. It remains to consider the case $D_i \leq 1$ for all $i = 1, \ldots, I$ and $F \leq 1$. Here, we find

$$\mathcal{D}[u] \ge K_1 \left[\sum_{i=1}^{I} D_i^{\max\{1,m_i\}} + F \right] \ge K_1 \left[\sum_{i=1}^{I} D_i^{\alpha} + F^{\alpha} \right] \ge K_2 \left[\sum_{i=1}^{I} D_i + F \right]^{\alpha}.$$
(3.5)

By applying now the entropy–entropy production estimate for the case of linear diffusion (cf. [14, Theorem 1.1]), we have

$$\sum_{i=1}^{I} D_i + F \ge K_3 \mathcal{E}[u|u_\infty]$$
(3.6)

and, thus,

$$\mathcal{D}[u] \ge K_4(\mathcal{E}[u|u_\infty])^{\alpha}.$$

From (3.4) and (3.6), we obtain the desired estimate.

3.2. Convergence of renormalised solutions.

Proof of Theorem 1.4. The global existence of renormalised solutions for (1.9) follows from Theorem 1.2. Indeed, the assumptions (F1) and (F2) can be easily checked using (1.10), and (F3) follows from the identity (cf. [6, Proposition 2.1])

$$\sum_{i=1}^{I} f_i(u)(-\log u_{i,\infty} + \log u_i) = -\sum_{r=1}^{R} k_r u_{\infty}^{y_r} \Psi\left(\frac{u^{y_r}}{u_{\infty}^{y_r}}; \frac{u^{y_r'}}{u_{\infty}^{y_r'}}\right) \le 0$$

recalling $\Psi(x; y) = x \log(x/y) - x + y$.

Thanks to (1.6) and (1.5), we have the conservation laws

$$\mathbb{Q}\overline{u(t)} = \mathbb{Q}\overline{u_0} \quad \text{for all} \quad t \ge 0,$$

and

$$\mathcal{E}[u(t)|u_{\infty}] + \int_{s}^{t} \mathcal{D}[u(\tau)]d\tau \leq \mathcal{E}[u(s)|u_{\infty}] \quad \text{for all} \quad 0 \leq s \leq t.$$

We now apply Lemma 3.5 to get

$$\mathcal{E}[u(t)|u_{\infty}] + C \int_{s}^{t} \left(\mathcal{E}[u(\tau)|u_{\infty}] \right)^{\alpha} d\tau \leq \mathcal{E}[u(s)|u_{\infty}] \quad \text{for all} \quad 0 \leq s \leq t.$$
(3.7)

If $\alpha = 1$, we immediately get the exponential convergence

$$\mathcal{E}[u(t)|u_{\infty}] \leq e^{-\lambda t} \mathcal{E}[u_0|u_{\infty}] \quad \text{for all} \quad t \ge 0$$

for some constant $\lambda > 0$. For $\alpha > 1$, we first obtain the algebraic decay

$$\mathcal{E}[u(t)|u_{\infty}] \leq \frac{1}{\left(\mathcal{E}[u_0|u_{\infty}]^{1-\alpha} + C(\alpha-1)t\right)^{1/(\alpha-1)}}.$$
(3.8)

Indeed, we define

$$\psi(t) = \mathcal{E}[u(t)|u_{\infty}]$$
 and $\varphi(s) = \int_{s}^{t} \left(\mathcal{E}[u(\tau)|u_{\infty}]\right)^{\alpha} d\tau$

It follows from (3.7) that

$$\psi(t) + C\varphi(s) \leqslant \psi(s).$$

Differentiating $\varphi(s)$ with respect to s gives

$$\frac{d}{ds}\varphi(s) = -(\psi(s))^{\alpha} \leqslant -(\psi(t) + C\varphi(s))^{\alpha}$$

and consequently

$$\frac{d}{ds} \left[\psi(t) + C\varphi(s) \right] + C \left[\psi(t) + C\varphi(s) \right]^{\alpha} \le 0.$$

Applying a non-linear Gronwall inequality yields

$$\psi(t) + C\varphi(s) \leq \frac{1}{\left[(\psi(t) + C\varphi(0))^{1-\alpha} + C(\alpha - 1)s \right]^{1/(\alpha - 1)}} \leq \frac{1}{\left[\psi(0)^{1-\alpha} + C(\alpha - 1)s \right]^{1/(\alpha - 1)}}$$

thanks to $\psi(t) + C\varphi(0) \leq \psi(0)$ and $\alpha > 1$. Setting s = t and using $\varphi(t) = 0$ leads us to the desired estimate (3.8). Owing to the Csiszár–Kullback–Pinsker inequality, it follows

$$\sum_{i=1}^{I} \|u_i(t) - u_{i,\infty}\|_{L^1(\Omega)}^2 \leq \frac{C_{CKP}^{-1}}{(\mathcal{E}[u_0|u_{\infty}]^{1-\alpha} + C(\alpha-1)t)^{1/(\alpha-1)}}$$

Therefore, there exists an explicit $T_0 > 0$ such that

$$||u_i(t) - u_{i,\infty}||_{L^1(\Omega)} \leq \frac{1}{2}u_{i,\infty}$$
 for all $t \ge T_0$

and, thus,

$$\overline{u}_i(t) = \|u_i(t)\|_{L^1(\Omega)} \ge \frac{1}{2}u_{i,\infty} \quad \text{for all} \quad t \ge T_0.$$

Using this property, we estimate $\mathcal{D}[u(t)]$ for $t \ge T_0$ as follows. If $m_i < 1$, then it is similar to (3.3) that

$$\int_{\Omega} \overline{u}_{i}(t)^{m_{i}-2} |\nabla u_{i}(t)|^{2} dx \geq C(\Omega, m_{i}) \overline{u}_{i}(t)^{m_{i}-1} \int_{\Omega} u_{i}(t) \log \frac{u_{i}(t)}{\overline{u}_{i}(t)} dx$$

$$\geq C(\Omega, m_{i}) \tilde{K}^{m_{i}-1} \int_{\Omega} u_{i}(t) \log \frac{u_{i}(t)}{\overline{u}_{i}(t)} dx,$$
(3.9)

and for $m_i \ge 1$,

$$\int_{\Omega} \overline{u}_{i}(t)^{m_{i}-2} |\nabla u_{i}(t)|^{2} dx \geq C(\Omega, m_{i}) \overline{u}_{i}(t)^{m_{i}-1} \int_{\Omega} u_{i}(t) \log \frac{u_{i}(t)}{\overline{u}_{i}(t)} dx$$

$$\geq C(\Omega, m_{i}) \left(\frac{u_{i,\infty}}{2}\right)^{m_{i}-1} \int_{\Omega} u_{i}(t) \log \frac{u_{i}(t)}{\overline{u}_{i}(t)} dx$$
(3.10)

since $\overline{u}_i(t) \ge \frac{1}{2}u_{i,\infty}$ for all $t \ge T_0$. Therefore, for all $t \ge T_0$, we can estimate $\mathcal{D}[u(t)]$ as

$$\mathcal{D}[u(t)] \ge K_5 \left[\sum_{i=1}^{I} \int_{\Omega} u_i(t) \log \frac{u_i(t)}{\overline{u}_i(t)} dx + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \Psi \left(\frac{u(t)^{y_r}}{u_{\infty}^{y_r}}; \frac{u(t)^{y_r'}}{u_{\infty}^{y_r'}} \right) dx \right].$$

Using again the entropy–entropy production estimate in the case of linear diffusion (cf. [14, Theorem 1.1]), we have

$$\mathcal{D}[u(t)] \ge K_6 \mathcal{E}[u(t)|u_\infty] \quad \text{for all} \quad t \ge T_0,$$

which leads to the exponential convergence

$$\mathcal{E}[u(t)|u_{\infty}] \leq e^{-K_6(t-T_0)} \mathcal{E}[u(T_0)|u_{\infty}] \quad \text{for all} \quad t \geq T_0.$$

Since T_0 can be explicitly computed, we in fact get the exponential convergence for all $t \ge 0$, i.e.

$$\mathcal{E}[u(t)|u_{\infty}] \leq C e^{-\lambda t} \mathcal{E}[u_0|u_{\infty}] \quad \text{for all} \quad t \ge 0,$$

for some constants C > 0 and $\lambda > 0$. Thanks to the Csiszár–Kullback–Pinsker inequality, we finally obtain the desired exponential convergence to equilibrium.

3.3. Convergence of weak and bounded solutions. We consider the approximate u^{ε} to the regularised system (2.1). From Lemma 2.4, we know that, up to a subsequence,

$$u_i^{\varepsilon} \xrightarrow{\varepsilon \to 0} u_i$$
 a.e. in Q_T . (3.11)

The next lemma establishes uniform-in- ε a priori bounds.

Lemma 3.6. Under the assumptions (F1)–(F3) and $0 \leq u_0$ with $u_{i,0} \log u_{i,0} \in L^2(\Omega)$ for all i = 1, ..., I, there exists a constant $C_T > 0$ which depends on T > 0 but not on $\varepsilon > 0$, such that

$$\int_{Q_T} (\log u_i^{\varepsilon})^2 (u_i^{\varepsilon})^{m_i+1} \, dx \, dt \leqslant C_T \quad \text{for all} \quad i = 1, \dots, I.$$
(3.12)

Proof. The proof is similar to [20, Proof of Theorem 2.7]. For the sake of completeness, we present it in Appendix B.

Proof of Theorem 1.5. By testing (2.1) with smooth test functions $\psi \in C^{\infty}([0,T]; C_0^{\infty}(\Omega))$ satisfying $\psi(\cdot,T) = 0$, we have

$$-\int_{Q_T} u_i^{\varepsilon} \partial_t \psi \, dx \, dt - \int_{Q_T} d_i (u_i^{\varepsilon})^{m_i} \Delta \psi \, dx \, dt = -\int_{\Omega} u_{i,0}^{\varepsilon} \psi(\cdot, 0) \, dx + \int_{Q_T} f_i^{\varepsilon} (u^{\varepsilon}) \psi \, dx \, dt \qquad (3.13)$$

It follows from (3.11) that $(u_i^{\varepsilon})^{m_i} \to u_i^{m_i}$ a.e. in Q_T . Due to the bound (3.12), it holds that the set $\{(u_i^{\varepsilon})^{m_i}\}_{\varepsilon>0}$ is uniformly integrable in Q_T . Thus, thanks to Vitali's lemma, we deduce that $(u_i^{\varepsilon})^{m_i}$ converges strongly to $u_i^{m_i}$ in $L^1(Q_T)$, which implies

$$\int_{Q_T} d_i (u_i^{\varepsilon})^{m_i} \Delta \psi \, dx \, dt \to \int_{Q_T} d_i u_i^{m_i} \Delta \psi \, dx \, dt.$$

From the definition of f_i^{ε} in (2.1) as well as (3.11), we have

$$f_i^{\varepsilon}(u^{\varepsilon}) \to f_i(u)$$
 a.e. in Q_T . (3.14)

It remains to show that the set $\{f_i^{\varepsilon}(u^{\varepsilon})\}_{\varepsilon>0}$ is uniformly integrable. Indeed, let $K \subset Q_T$ be a measurable and compact set with its measure being denoted by |K|. From (1.17) and (1.15), we have

$$\int_{K} |f_{i}^{\varepsilon}(u^{\varepsilon})| \, dx \, dt \leq \int_{K} |f_{i}(u^{\varepsilon})| \, dx \, dt \leq C \int_{K} \left(1 + \sum_{i=1}^{I} |u_{i}^{\varepsilon}|^{\mu}\right) \, dx \, dt$$

$$\leq C \left[|K| + \int_{K} \sum_{i=1}^{I} |u_{i}^{\varepsilon}|^{m_{i}+1} \, dx \, dt \right].$$
(3.15)

It is easy to see that for any $\delta > 0$, there exists some $C_{\delta} > 0$ such that for all $x \ge 0$,

$$x^{m_i+1} \leqslant \delta(\log x)^2 x^{m_i+1} + C_\delta$$

It follows from (3.15) and Lemma 3.6 that

$$\int_{K} |f_{i}^{\varepsilon}(u^{\varepsilon})| \, dx \, dt \leq C \left[|K| + \delta \int_{K} \sum_{i=1}^{I} (\log u_{i}^{\varepsilon})^{2} (u_{i}^{\varepsilon})^{m_{i}+1} + IC_{\delta}|K| \right]$$
$$\leq C_{\delta}|K| + C\delta.$$

Therefore, for any $\tau > 0$, we first choose $\delta > 0$ fixed such that $C\delta < \tau/2$ and then $K \subset Q_T$ arbitrarily according to $C_{\delta}|K| < \tau/2$ to ultimately obtain

$$\int_{K} |f_{i}^{\varepsilon}(u^{\varepsilon})| \, dx \, dt \leqslant \tau,$$

which is exactly the uniform integrability of $\{f_i^{\varepsilon}(u^{\varepsilon})\}_{\varepsilon>0}$. From this and (3.14), we can apply Vitali's lemma again to get $f_i^{\varepsilon}(u^{\varepsilon}) \to f_i(u)$ strongly in $L^1(Q_T)$ and, therefore,

$$\int_{Q_T} f_i^{\varepsilon}(u^{\varepsilon}) \psi \, dx \, dt \to \int_{Q_T} f_i(u) \psi \, dx \, dt.$$

This gives us the existence of a global weak solution. The exponential convergence to equilibrium in $L^1(\Omega)$ follows from Theorem 1.4.

Concerning bounded solutions, we first obtain from Lemma 3.6 that

$$\|u_i\|_{L^{m_i+1}(Q_T)} \leq C_T \quad \text{for all} \quad i = 1, \dots, I$$

Under the assumptions (1.16) on the porous medium exponent, we can apply [11, Lemma 2.2] to get

$$||u_i||_{L^{\infty}(Q_T)} \leq C_T \quad \text{for all} \quad i = 1, \dots, I.$$

Note that the constant C_T grows at most polynomially in T. This implies the exponential convergence to equilibrium in $L^p(\Omega)$ for any $1 \leq p < \infty$ in (1.18). Indeed, from the exponential convergence in $L^1(\Omega)$, we can use the interpolation inequality to have

$$\begin{aligned} \|u_i(T) - u_{i,\infty}\|_{L^p(\Omega)} &\leq \|u_i(T) - u_{i,\infty}\|_{L^{\infty}(\Omega)}^{1-1/p} \|u_i(T) - u_{i,\infty}\|_{L^1(\Omega)}^{1/p} \\ &\leq C_T^{1-1/p} \left(Ce^{-\lambda T}\right)^{1/p} \leq C_p e^{-\lambda_p T} \end{aligned}$$

for some $0 < \lambda_p < \lambda$, since C_T grows at most polynomially in T.

3.4. Uniform convergence of approximate solutions. We remark that all the involved constants in the following results do not depend on ε .

Lemma 3.7. There exists a constant $L_0 > 0$ such that

$$\sup_{t \ge 0} \max_{i=1,\dots,I} \|u_i^{\varepsilon}(t)\|_{L^1(\Omega)} \le L_0.$$
(3.16)

Proof. It follows from

$$\frac{d}{dt}\mathcal{E}[u^{\varepsilon}|u_{\infty}] = -\mathcal{D}[u^{\varepsilon}] \leqslant 0$$

that

$$\mathcal{E}[u^{\varepsilon}(t)|u_{\infty}] \leq \mathcal{E}[u_{0}^{\varepsilon}|u_{\infty}].$$
(3.17)

Thanks to (1.20), $\sup_{\varepsilon>0} \max_{i=1,\dots,I} \mathcal{E}[u_0^{\varepsilon}|u_{\infty}] < +\infty$. The L^1 bound (3.16) follows with the same arguments as in Lemma 3.1.

Lemma 3.8. There exists a constant $L_2 > 0$ such that

$$\begin{split} \sum_{i=1}^{I} \|\sqrt{u_{i}^{\varepsilon}} - \overline{\sqrt{u_{i}^{\varepsilon}}}\|_{L^{2}(\Omega)}^{2} + \sum_{r=1}^{R} \int_{\Omega} \frac{1}{1 + \varepsilon |f(u^{\varepsilon})|} \left[\sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_{r}} - \sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_{r}'} \right]^{2} dx \\ \geqslant L_{2} \sum_{r=1}^{R} \left[\frac{\overline{\sqrt{u^{\varepsilon}}}^{y_{r}}}{\sqrt{u_{\infty}}}^{y_{r}} - \frac{\overline{\sqrt{u^{\varepsilon}}}^{y_{r}'}}{\sqrt{u_{\infty}}} \right]^{2}. \end{split}$$

Proof. We introduce the short hand notation

$$\begin{aligned} v_i^{\varepsilon} &= \sqrt{u_i^{\varepsilon}}, \quad v^{\varepsilon} = (v_i^{\varepsilon})_{i=1,\dots,I}, \quad v_{i,\infty} = \sqrt{u_{i,\infty}}, \quad v_{\infty} = (v_{i,\infty})_{i=1,\dots,I}, \\ \text{and } g(v^{\varepsilon}) &= f((v^{\varepsilon})^2) = f(u^{\varepsilon}). \text{ Moreover, for each } i \in \{1,\dots,I\}, \text{ we set} \\ v_i^{\varepsilon}(x) &= \overline{v_i^{\varepsilon}} + \delta_i(x), \quad x \in \Omega. \end{aligned}$$

The desired inequality in Lemma 3.8 becomes

$$\sum_{i=1}^{I} \|\delta_i\|_{L^2(\Omega)}^2 + \sum_{r=1}^{R} \int_{\Omega} \frac{1}{1+\varepsilon |g(v^{\varepsilon})|} \left[\frac{(v^{\varepsilon})^{y_r}}{v_{\infty}^{y_r}} - \frac{(v^{\varepsilon})^{y_r'}}{v_{\infty}^{y_r'}} \right]^2 dx \ge L_2 \sum_{r=1}^{R} \left[\frac{\overline{v^{\varepsilon}}^{y_r}}{v_{\infty}^{y_r}} - \frac{\overline{v^{\varepsilon}}^{y_r'}}{v_{\infty}^{y_r'}} \right]^2.$$
(3.18)

Using Lemma 3.7, we observe by Hölder's inequality, noting that $|\Omega| = 1$, that

$$\overline{v_i^\varepsilon} = \overline{\sqrt{u_i^\varepsilon}} \leqslant \sqrt{\overline{u_i^\varepsilon}} \leqslant \sqrt{L_0}$$

and

$$\|\delta_i\|_{L^2(\Omega)} = \sqrt{\overline{(v_i^\varepsilon)^2} - \overline{v_i^\varepsilon}^2} \leqslant \sqrt{\overline{u_i^\varepsilon}} \leqslant \sqrt{L_0}.$$

Therefore, there exists a constant $K_7 > 0$ such that

$$\sum_{r=1}^{R} \left[\frac{\overline{\sqrt{u^{\varepsilon}}}^{y_r}}{\sqrt{u_{\infty}}^{y_r}} - \frac{\overline{\sqrt{u^{\varepsilon}}}^{y'_r}}{\sqrt{u_{\infty}}^{y'_r}} \right]^2 \leqslant K_7.$$
(3.19)

We decompose Ω into $\Omega = \Omega_1 \cup \Omega_2$ where

$$\Omega_1 = \{ x \in \Omega : |\delta_i(x)| \leq 1 \quad \forall i = 1, \dots, I \} \text{ and } \Omega_2 = \Omega \backslash \Omega_1.$$

Note that on Ω_1 we have

$$0 \leq v_i^{\varepsilon}(x) = \overline{v_i^{\varepsilon}} + \delta_i \leq \sqrt{L_0} + 1$$
 for all $i = 1, \dots, I$.

Therefore, there exists a constant $K_8 > 0$ such that

$$\frac{1}{1+\varepsilon|g(v^{\varepsilon}(x))|} \ge K_8 \quad \text{for all} \quad x \in \Omega_1.$$
(3.20)

By using Taylor's expansion, we have for all $x \in \Omega_1$,

$$\left[\frac{(v^{\varepsilon}(x))^{y_r}}{v^{y_r}_{\infty}} - \frac{(v^{\varepsilon}(x))^{y_r}}{v^{y_r}_{\infty}}\right]^2 = \left[\frac{1}{v^{y_r}_{\infty}}\prod_{i=1}^{I}\left[\overline{v^{\varepsilon}_i} + \delta_i(x)\right]^{y_{r,i}} - \frac{1}{v^{y'_r}_{\infty}}\prod_{i=1}^{I}\left[\overline{v^{\varepsilon}_i} + \delta_i(x)\right]^{y'_{r,i}}\right]^2$$
$$= \left[\frac{1}{v^{y_r}_{\infty}}\prod_{i=1}^{I}\left(\overline{v^{\varepsilon}_i}^{y_{r,i}} + R_1\delta_i(x)\right) - \frac{1}{v^{y'_r}_{\infty}}\prod_{i=1}^{I}\left(\overline{v^{\varepsilon}_i}^{y'_{r,i}} + R_2\delta_i(x)\right)\right]^2$$
$$\geq \frac{1}{2}\left[\frac{\overline{v^{\varepsilon}}^{y_r}}{v^{y_r}_{\infty}} - \frac{\overline{v^{\varepsilon}}^{y'_r}}{v^{y'_r}_{\infty}}\right]^2 - K_9\sum_{i=1}^{I}|\delta_i(x)|^2 \tag{3.21}$$

for some $K_9 > 0$. From (3.20) and (3.21), we can estimate the second sum on the left hand side of (3.18) as

$$\begin{split} \sum_{r=1}^{R} \int_{\Omega} \frac{1}{1+\varepsilon |g(v^{\varepsilon})|} \left[\frac{(v^{\varepsilon})^{y_{r}}}{v_{\infty}^{y_{r}}} - \frac{(v^{\varepsilon})^{y_{r}'}}{v_{\infty}^{y_{r}'}} \right]^{2} dx \\ \geqslant \sum_{r=1}^{R} \int_{\Omega_{1}} \frac{1}{1+\varepsilon |g(v^{\varepsilon})|} \left[\frac{(v^{\varepsilon})^{y_{r}}}{v_{\infty}^{y_{r}}} - \frac{(v^{\varepsilon})^{y_{r}'}}{v_{\infty}^{y_{r}'}} \right]^{2} dx \\ \geqslant K_{8} \sum_{r=1}^{R} \int_{\Omega_{1}} \left(\frac{1}{2} \left[\frac{\overline{v^{\varepsilon}}^{y_{r}}}{v_{\infty}^{y_{r}'}} - \frac{\overline{v^{\varepsilon}}^{y_{r}'}}{v_{\infty}^{y_{r}'}} \right]^{2} - K_{9} \sum_{i=1}^{I} |\delta_{i}(x)|^{2} \right) dx \\ \geqslant \frac{K_{8}}{2} |\Omega_{1}| \sum_{r=1}^{R} \left[\frac{\overline{v^{\varepsilon}}^{y_{r}}}{v_{\infty}^{y_{r}'}} - \frac{\overline{v^{\varepsilon}}^{y_{r}'}}{v_{\infty}^{y_{r}'}} \right]^{2} - K_{8} K_{9} R \sum_{i=1}^{I} \|\delta_{i}\|_{L^{2}(\Omega)}^{2}. \end{split}$$

$$(3.22)$$

On the other hand, the first sum on the left hand side of (3.18) is estimated as

$$\sum_{i=1}^{I} \|\delta_{i}\|_{L^{2}(\Omega)}^{2} \geq \frac{1}{2} \sum_{i=1}^{I} \|\delta_{i}\|_{L^{2}(\Omega)}^{2} + \frac{1}{2} \int_{\Omega_{2}} \sum_{i=1}^{I} |\delta_{i}(x)|^{2} dx$$

$$\geq \frac{1}{2} \sum_{i=1}^{I} \|\delta_{i}\|_{L^{2}(\Omega)}^{2} + \frac{1}{2} |\Omega_{2}|$$

$$\geq \frac{1}{2} \sum_{i=1}^{I} \|\delta_{i}\|_{L^{2}(\Omega)}^{2} + \frac{1}{2K_{7}} |\Omega_{2}| \sum_{r=1}^{R} \left[\frac{\overline{v^{\varepsilon}}^{y_{r}}}{v_{\infty}^{y_{r}}} - \frac{\overline{v^{\varepsilon}}^{y_{r}}}{v_{\infty}^{y_{r}'}} \right]^{2}.$$
(3.23)

By combining (3.22) and (3.23), we have for any $\theta \in (0, 1]$,

LHS of (3.18)
$$\geq \left(\theta \frac{K_8}{2} |\Omega_1| + \frac{1}{2K_7} |\Omega_2|\right) \sum_{r=1}^R \left[\frac{\overline{v}^{\varepsilon y_r}}{v_{\infty}^{y_r}} - \frac{\overline{v}^{\varepsilon y_r'}}{v_{\infty}^{y_r'}}\right]^2 + \left(\frac{1}{2} - \theta K_8 K_9 R\right) \sum_{i=1}^I \|\delta_i\|_{L^2(\Omega)}^2.$$

$$(3.24)$$

Thus, by choosing $\theta = \min\left\{1; \frac{1}{2K_8K_9R}\right\}$, we finally obtain the desired inequality (3.18) with $L_2 = \min\left\{\frac{\theta K_8}{2}; \frac{1}{2K_7}\right\}$.

Lemma 3.9. There exists a constant $L_3 > 0$ such that

$$\sum_{i=1}^{I} \|\sqrt{u_i^{\varepsilon}} - \overline{\sqrt{u_i^{\varepsilon}}}\|_{L^2(\Omega)}^2 + \sum_{r=1}^{R} \left[\frac{\overline{\sqrt{u^{\varepsilon}}}^{y_r}}{\sqrt{u_{\infty}}^{y_r}} - \frac{\overline{\sqrt{u^{\varepsilon}}}^{y_r}}{\sqrt{u_{\infty}}^{y_r'}} \right]^2 \ge L_3 \sum_{r=1}^{R} \left[\sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_r} - \sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_r'} \right]^2$$

Proof. The proof of this lemma follows by the same arguments as in [14, Lemma 2.7], so we omit it here. \blacksquare

We are now ready to prove Theorem 1.6.

Proof of Theorem 1.6. We proceed similarly to the proof of Lemma 3.5. If $(d-2)_+/d < m_i < 1$, we have, thanks to Lemma 3.4 and the bound (3.16),

with a constant $C = C(\Omega, m_i) > 0$. If $m_i \ge 1$, we apply Lemma 3.3 to get

$$\int_{\Omega} (u_i^{\varepsilon})^{m_i - 2} |\nabla u_i^{\varepsilon}|^2 \, dx \ge C(\Omega, m_i) \left(\int_{\Omega} u_i^{\varepsilon} \log \frac{u_i^{\varepsilon}}{u_i^{\varepsilon}} \, dx \right)^{m_i}$$

Therefore, by using $\Psi(x,y) = x \log(x/y) - x + y \ge (\sqrt{x} - \sqrt{y})^2$ and noting that

there exists a constant $K_{10} > 0$ such that

$$\mathcal{D}[u^{\varepsilon}] \ge K_{10} \bigg[\sum_{i=1}^{I} \bigg(\|\sqrt{u_i^{\varepsilon}} - \overline{\sqrt{u_i^{\varepsilon}}}\|_{L^2(\Omega)}^2 \bigg)^{\max\{1,m_i\}} + \sum_{r=1}^{R} k_r u_{\infty}^{y_r} \int_{\Omega} \frac{1}{1 + \varepsilon |f(u^{\varepsilon})|} \bigg(\sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_r} - \sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_r'} \bigg)^2 dx \bigg].$$

$$(3.25)$$

We define

$$\hat{D}_i := \|\sqrt{u_i^{\varepsilon}} - \overline{\sqrt{u_i^{\varepsilon}}}\|_{L^2(\Omega)}^2, \quad \hat{F} := \sum_{r=1}^R k_r u_{\infty}^{y_r} \int_{\Omega} \frac{1}{1 + \varepsilon |f(u^{\varepsilon})|} \left[\sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_r} - \sqrt{\frac{u^{\varepsilon}}{u_{\infty}}}^{y_r'}\right]^2 dx,$$

and we consider the following two cases.

Case 1. If $\hat{F} \ge 1$ or if there exists some $i \in \{1, \ldots, I\}$ such that $\hat{D}_i \ge 1$, we estimate from (3.25) that

$$\mathcal{D}[u^{\varepsilon}] \ge K_{10} \ge K_{10} \frac{1}{\mathcal{E}[u_0|u_{\infty}]} \mathcal{E}[u^{\varepsilon}|u_{\infty}].$$

Case 2. If $\hat{F} \leq 1$ and $\hat{D}_i \leq 1$ for all i = 1, ..., I, then with $\alpha = \max_{i=1,...,I}\{1, m_i\}$, we have from (3.25) that

(3.27)

for some $K_{11} = K_{11}(K_{10}, \alpha)$. Thanks to Lemmas 3.8 and 3.9, we have

$$\sum_{i=1}^{I} \widehat{D}_{i} + \widehat{F} \ge \min_{r=1,\dots,R} \{1, k_{r} u_{\infty}^{y_{r}}\} \left[\frac{1}{2} \sum_{i=1}^{I} \|\sqrt{u_{i}^{\varepsilon}} - \overline{\sqrt{u_{i}^{\varepsilon}}}\|_{L^{2}(\Omega)}^{2} + \frac{L_{2}}{2} \sum_{r=1}^{R} \left(\frac{\overline{\sqrt{u^{\varepsilon}}}^{y_{r}}}{\sqrt{u_{\infty}}^{y_{r}}} - \frac{\overline{\sqrt{u^{\varepsilon}}}^{y_{r}'}}{\sqrt{u_{\infty}}^{y_{r}'}} \right)^{2} \right]$$

$$\ge K_{12} \sum_{r=1}^{R} \left[\sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_{r}} - \sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_{r}'} \right]^{2}$$

$$(3.28)$$

where

$$K_{12} = \frac{1}{2} \min_{r=1,\dots,R} \{L_2, 1, k_r u_{\infty}^{y_r}\} L_3$$

From here, we can use [14, Lemma 2.5] to estimate

$$\mathcal{E}[u^{\varepsilon}|u_{\infty}] \leqslant K_{13} \sum_{i=1}^{I} \left(\sqrt{\frac{\overline{u_{i}^{\varepsilon}}}{u_{i,\infty}}} - 1 \right)^{2}$$

and [14, Eq. (11)] to get

$$\sum_{r=1}^{R} \left[\sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_r} - \sqrt{\frac{\overline{u^{\varepsilon}}}{u_{\infty}}}^{y_r'} \right]^2 \ge K_{14} \sum_{i=1}^{I} \left(\sqrt{\frac{\overline{u^{\varepsilon}}}{u_{i,\infty}}} - 1 \right)^2 \ge \frac{K_{14}}{K_{13}} \mathcal{E}[u^{\varepsilon} | u_{\infty}].$$
(3.29)

It follows from (3.27), (3.28), and (3.29) that

Owing to (3.26) and (3.30), there exists some $L_4 > 0$ such that

The rest of this proof follows exactly from that of Theorem 1.4, which helps us to eventually obtain the exponential convergence to equilibrium

where $C, \lambda > 0$ are independent of ε .

Appendix A. Proof of the global existence of approximate solutions

In this appendix, we provide a proof for the existence of a global solution to the approximate system (2.1). While a similar proof, with Dirichlet instead of Neumann boundary conditions, can be found in [20, Proof of Lemma 2.3], we mainly follow a standard Galerkin approach as presented in many textbooks.

For $0 < \delta \leq 1$ and $1 \leq i \leq I$, we consider the regularised system

$$\partial_t u_i^{\varepsilon,\delta} - d_i \nabla \cdot \left[\left(\frac{m_i |u_i^{\varepsilon,\delta}|^{m_i - 1}}{1 + \delta m_i |u_i^{\varepsilon,\delta}|^{m_i - 1}} + \delta \right) \nabla u_i^{\varepsilon,\delta} \right] = f_i^{\varepsilon} (u^{\varepsilon,\delta}), \quad \nu \cdot \nabla u_i^{\varepsilon,\delta} = 0, \tag{A.1}$$

with initial data $u_i^{\varepsilon,\delta}(x,0) = u_{i,0}^{\varepsilon}(x) + \delta$, where we extend f_i^{ε} to a locally Lipschitz continuous function on \mathbb{R}^I by setting $f_i^{\varepsilon}(v) := f_i^{\varepsilon}(\max\{v_1,0\},\ldots,\max\{v_I,0\})$. For the sake of readability, we subsequently write $w_i := u_i^{\varepsilon,\delta}$ and $H^{\delta}(w_i) := \frac{m_i|w_i|^{m_i-1}}{1+\delta m_i|w_i|^{m_i-1}} + \delta$. We employ the ansatz $w_i^k(x,t) = \sum_{j=1}^k \xi_i^{j,k}(t)e_j(x)$ with $k \in \mathbb{N}$, scalar coefficient functions $\xi_i^{j,k}(t)$, and the Schauder basis $e_j \in H^1(\Omega)$ of $L^2(\Omega)$ given by the orthonormal eigenfunctions of the Laplace operator satisfying $\nu \cdot \nabla e_j = 0$ on $\partial\Omega$. Along with the initial condition $\xi_i^{j,k}(0) = \int_{\Omega} (w_0)_i e_j dx$, the functions $\xi_i^{j,k}$, $1 \leq j \leq k$, are solutions to the set of equations

$$\int_{\Omega} \partial_t w_i^k e_j \, dx = -d_i \int_{\Omega} H^{\delta}(w_i^k) \nabla w_i^k \cdot \nabla e_j \, dx + \int_{\Omega} f_i^{\varepsilon}(w_i^k) e_j \, dx \tag{A.2}$$

for $1 \leq j \leq k$, which can be recast into an ODE system for the time-dependent coefficient vector $\hat{\xi}_i^k(t) := (\xi_i^{1,k}(t), \dots, \xi_i^{k,k}(t))$. As the right hand side continuously depends on $\hat{\xi}_i^k(t)$ via the bounded and continuous functions H^{δ} and f_i^{ε} , we know that a solution $\hat{\xi}_i^k(t) \in C^1([0, \tau], \mathbb{R}^I)$ exists for some $\tau > 0$. The energy estimate below, which is essentially obtained by multiplying (A.2) with $\xi_i^{j,k}(t)$ and summing over j, will indeed show that the solution exists for all times $t \geq 0$. Integrating (A.2) over $[0, t] \subset [0, \tau)$, we have

$$\|w_i^k(t)\|_{L^2(\Omega)}^2 + \delta d_i \int_0^t \|\nabla w_i^k(s)\|_{L^2(\Omega)}^2 \, ds \le C \bigg(\|w_i^k(0)\|_{L^2(\Omega)}^2 + \int_0^t \int_\Omega \varepsilon^{-1} |w_i^k| \, dx \, ds \bigg),$$

where C > 0 is independent of k by the uniform bounds $H^{\delta}(w_i^k) \ge \delta$ and $f_i^{\varepsilon}(w_i^k) \le \varepsilon^{-1}$. In order to control the $H^1(\Omega)$ norm of w_i^k , we first observe that e_1 is constant in space. Hence, (A.2) leads for all $t \in (0, \tau)$ to

$$\left|\int_{\Omega} w_i^k(x,t) \, dx\right| = \left|\int_{\Omega} w_i^k(x,0) \, dx + \int_0^t \int_{\Omega} f_i^{\varepsilon}(w_i^k) \, dx \, ds\right| \le \|w_i^k(0)\|_{L^1(\Omega)} + \frac{|\Omega|t}{\varepsilon}$$

Poincaré's inequality now yields

$$\|w_i^k(t)\|_{H^1(\Omega)}^2 \leqslant C\bigg(\|\nabla w_i^k(t)\|_{L^2(\Omega)}^2 + \|w_i^k(0)\|_{L^2(\Omega)}^2 + \frac{|\Omega|^2 \tau^2}{\varepsilon^2}\bigg).$$

As a result, we arrive at

$$\|w_i^k(t)\|_{L^2(\Omega)}^2 + \int_0^t \|w_i^k(s)\|_{H^1(\Omega)}^2 \, ds \le C \bigg(1 + \|w_i(0)\|_{L^2(\Omega)}^2\bigg),\tag{A.3}$$

where C > 0 is independent of k, and which shows that the solution is bounded on $[0, \tau)$ and, thus, existing for all $t \ge 0$. Note that we applied the elementary estimate $||w_i^k(0)||_{L^2(\Omega)} \le ||w_i(0)||_{L^2(\Omega)}$ in the last step.

Let $P_k : L^2(\Omega) \to L^2(\Omega)$ be the orthogonal projection in $L^2(\Omega)$ onto $\operatorname{span}\{e_1, \ldots, e_k\}$, and let $\phi \in L^2(0,T; H^1(\Omega))$ for some arbitrary but fixed T > 0. We recall the uniform bounds $H^{\delta}(w_i^k) \leq \delta^{-1} + \delta$ and $f_i^{\varepsilon}(w_i^k) \leq \varepsilon^{-1}$ leading to

$$\begin{split} \int_{0}^{T} \int_{\Omega} \partial_{t} w_{i}^{k} \phi \, dx \, dt &= \int_{0}^{T} \int_{\Omega} \partial_{t} w_{i}^{k} P_{k} \phi \, dx \, dt \\ &= -d_{i} \int_{0}^{T} \int_{\Omega} H^{\delta}(w_{i}^{k}) \nabla w_{i}^{k} \cdot \nabla(P_{k} \phi) \, dx \, dt + \int_{0}^{T} \int_{\Omega} f_{i}^{\varepsilon}(w_{i}^{k}) P_{k} \phi \, dx \, dt \\ &\leq C \int_{0}^{T} \| \nabla w_{i}^{k}(t) \|_{L^{2}(\Omega)} \| \nabla(P_{k} \phi)(t) \|_{L^{2}(\Omega)} \, dt + C \int_{0}^{T} \| (P_{k} \phi)(t) \|_{L^{2}(\Omega)} \, dt \\ &\leq C (1 + \| w_{i}^{k} \|_{L^{2}(0,T;H^{1}(\Omega))}) \| \phi \|_{L^{2}(0,T;H^{1}(\Omega))} \end{split}$$

with a constant C > 0 independent of k. We stress that the last estimate also employs the bound $||(P_k\phi)(t)||_{H^1(\Omega)} \leq ||\phi(t)||_{H^1(\Omega)}$ for a.e. $t \in [0,T]$, which provides a uniform-in-k bound for $\partial_t w_i^k \in L^2(0,T; (H^1(\Omega))')$ together with (A.3).

We may choose a (not relabelled) subsequence w_i^k being weakly converging for $k \to \infty$ to some w_i in $L^2(0,T; H^1(\Omega))$ and in $H^1(0,T; (H^1(\Omega))')$. Strong convergence $w_i^k \to w_i$ in $L^2(0,T; L^2(\Omega)) \cong L^2(Q_T)$ now follows by means of the Aubin–Lions Lemma. Choosing another subsequence, we obtain for all $i = 1, \ldots I$, $w_i^k \to w_i$ and, hence, $H^{\delta}(w_i^k) \to H^{\delta}(w_i)$ and $f_i^{\varepsilon}(w_i^k) \to f_i^{\varepsilon}(w_i)$ a.e. in Ω due to the continuity of H^{δ} and f_i^{ε} . The boundedness of H^{δ} and f_i^{ε} further guarantees $H^{\delta}(w_i^k) \to H^{\delta}(w_i)$ and $f_i^{\varepsilon}(w_i^k) \to f_i^{\varepsilon}(w_i)$ strongly in $L^2(Q_T)$. This allows us to pass to the limit $k \to \infty$ in an integrated version of (A.2) resulting in

$$\int_{\Omega} w_i \phi \, dx \Big|_0^T - \int_{Q_T} w_i \partial_t \phi \, dx \, dt + d_i \int_{Q_T} H^{\delta}(w_i) \nabla w_i \cdot \nabla \phi \, dx \, dt = \int_{Q_T} f_i^{\varepsilon}(w_i) \phi \, dx \, dt$$

for all $\phi \in C^{\infty}(\overline{\Omega} \times [0,T])$. By a density argument, (A.1) holds as an identity in $L^2(0,T;(H^1(\Omega))')$.

Thanks to the quasi-positivity assumption (F2), the solution w_i is also non-negative. For p > 1, we have

$$\partial_{t} \|w_{i}\|_{L^{p}(\Omega)}^{p} + d_{i}p(p-1)\int_{\Omega} H^{\delta}(w_{i})w_{i}^{p-2}|\nabla w_{i}|^{2}dx$$

$$= p\int_{\Omega} w_{i}^{p-1}f_{i}^{\varepsilon}(w)dx \leq p\|f_{i}^{\varepsilon}(w)\|_{L^{p}(\Omega)} \left(\|w_{i}(t)\|_{L^{p}(\Omega)}^{p}\right)^{1-\frac{1}{p}}.$$
 (A.4)

Applying the Gronwall lemma $y' \leq \alpha(t)y^{1-1/p} \Rightarrow y(t) \leq \left(y(0)^{1/p} + \frac{1}{p}\int_0^t \alpha(s)ds\right)^p$ for $y(t) = \|w_i(t)\|_{L^p(\Omega)}^p$ entails

$$\begin{split} \|w_{i}(t)\|_{L^{p}(\Omega)}^{p} &\leqslant \left(\|w_{i}(0)\|_{L^{p}(\Omega)} + \int_{0}^{t} \|f_{i}^{\varepsilon}(w(s))\|_{L^{p}(\Omega)} ds\right)^{p} \\ &\leqslant \left(\|w_{i}(0)\|_{L^{p}(\Omega)} + \|f_{i}^{\varepsilon}(w)\|_{L^{p}(Q_{T})} T^{\frac{p-1}{p}}\right)^{p}. \end{split}$$

Taking the root of order p on both sides and letting $p \to \infty$, this leads to

$$\sup_{t \in (0,T)} \|w_i(t)\|_{L^{\infty}(\Omega)} \leq \|w_i(0)\|_{L^{\infty}(\Omega)} + T\|f_i^{\varepsilon}(w)\|_{L^{\infty}(Q_T)},$$

which means

$$\|w_i\|_{L^{\infty}(Q_T)} \leq C_{\varepsilon,T} \quad \text{for all} \quad i = 1, \dots, I,$$
(A.5)

where $C_{\varepsilon,T}$ is *independent* of $\delta > 0$. Therefore,

$$H^{\delta}(w_i) = \frac{m_i w_i^{m_i - 1}}{1 + \delta m_i w_i^{m_i - 1}} + \delta \ge \frac{m_i w_i^{m_i - 1}}{1 + m_i C_{\varepsilon, T}^{m_i - 1}} + \delta.$$

By integrating (A.4) on (0, T), and using (A.5), we get

$$m_{i} \int_{0}^{T} \int_{\Omega} w_{i}^{m_{i}-1} w_{i}^{p-2} |\nabla w_{i}|^{2} dx dt + \delta \int_{0}^{T} \int_{\Omega} w_{i}^{p-2} |\nabla w_{i}|^{2} dx dt$$

$$\leq \frac{1}{d_{i}(p-1)} \left(\|w_{i}(0)\|_{L^{p}(\Omega)}^{p} + \int_{0}^{T} \int_{\Omega} f_{i}^{\varepsilon}(w) w_{i}^{p-1} dx dt \right)$$

$$\leq \frac{1}{d_{i}(p-1)} \left(\|w_{i}(0)\|_{L^{p}(\Omega)}^{p} + |\Omega|T\| f_{i}^{\varepsilon}(w)\|_{L^{\infty}(Q_{T})} C_{\varepsilon,T}^{p-1} \right),$$
(A.6)

which implies, in particular,

$$\left\|\nabla\left(w_i^{\frac{m_i+p-1}{2}}\right)\right\|_{L^2(Q_T)} \leqslant C_{\varepsilon,T} \tag{A.7}$$

for all p > 1. By testing the equation (A.1) with $\phi \in L^2(0,T; H^1(\Omega))$ and keeping (A.5) in mind, we see that $\{\partial_t w_i\}$ is bounded in $L^2(0,T; (H^1(\Omega))')$ uniformly in $\delta > 0$. Hence, from this, (A.5), and (A.7), we can apply a non-linear Aubin–Lions lemma, see e.g. [23, Theorem 1], to ensure the existence of a subsequence (not relabelled) such that $w_i = u_i^{\varepsilon,\delta} \to u_i^{\varepsilon}$ strongly in $L^2(Q_T)$ as $\delta \to 0$. From here onwards, we will write $u_i^{\varepsilon,\delta}$ instead of w_i . Thanks to the L^{∞} bound (A.5), this convergence in fact holds in $L^p(Q_T)$ for any $1 \leq p < \infty$. It remains to pass to the limit $\delta \to 0$ in the weak formulation of (A.1) with $\psi \in L^2(0,T; H^1(\Omega))$,

$$\int_{t_0}^{t_1} \langle \partial_t u_i^{\varepsilon,\delta}, \psi \rangle_{(H^1(\Omega))', H^1(\Omega)} dt + d_i \int_{t_0}^{t_1} \int_{\Omega} \frac{m_i (u_i^{\varepsilon,\delta})^{m_i - 1}}{1 + \delta m_i (u_i^{\varepsilon,\delta})^{m_i - 1}} \nabla u_i^{\varepsilon,\delta} \cdot \nabla \psi \, dx \, dt \\
+ d_i \delta \int_{t_0}^{t_1} \int_{\Omega} \nabla u_i^{\varepsilon,\delta} \cdot \nabla \psi \, dx \, dt = \int_{t_0}^{t_1} \int_{\Omega} f_i^{\varepsilon} (u^{\varepsilon,\delta}) \psi \, dx \, dt. \quad (A.8)$$

The convergence of the first term on the left hand side and the last term on the right hand side of (A.8) is immediate. From

$$\nabla u_i^{\varepsilon,\delta} = \frac{2}{m_i + p - 1} \left(u_i^{\varepsilon,\delta} \right)^{\frac{3 - m_i - p}{2}} \nabla (u_i^{\varepsilon,\delta})^{\frac{m_i + p - 1}{2}}$$

we can choose $1 (since <math>m_i < 2$) to get

$$\|\nabla u_i^{\varepsilon,\delta}\|_{L^2(Q_T)} \leqslant C_{\varepsilon,T} \tag{A.9}$$

thanks to the uniform bounds (A.5) and (A.7). For the third term on the left hand side of (A.8), we estimate

$$\left|\delta\int_{t_0}^{t_1}\int_{\Omega}\nabla u_i^{\varepsilon,\delta}\nabla\psi\,dx\,dt\right|\leqslant\delta\|\nabla u_i^{\varepsilon,\delta}\|_{L^2(Q_T)}\|\nabla\psi\|_{L^2(Q_T)}\leqslant C_{\varepsilon,T}\delta\|\nabla\psi\|_{L^2(Q_T)},$$

and, therefore, it converges to zero as $\delta \to 0$. Finally, the convergence

$$\int_{t_0}^{t_1} \int_{\Omega} \frac{m_i(u_i^{\varepsilon,\delta})^{m_i-1}}{1+\delta m_i(u_i^{\varepsilon,\delta})^{m_i-1}} \nabla u_i^{\varepsilon,\delta} \cdot \nabla \psi \, dx \, dt \xrightarrow{\delta \to 0} \int_{t_0}^{t_1} \int_{\Omega} m_i(u_i^{\varepsilon})^{m_i-1} \nabla u_i^{\varepsilon} \cdot \nabla \psi \, dx \, dt$$
from $\frac{m_i(u_i^{\varepsilon,\delta})^{m_i-1}}{\delta \to 0} \xrightarrow{\delta \to 0} m_i(u_i^{\varepsilon})^{m_i-1}$ a.e. in Q_T (A.5) and (A.9)

follows from $\frac{m_i(u_i^{\varepsilon,o})^{m_i-1}}{1+\delta m_i(u_i^{\varepsilon,\delta})^{m_i-1}} \xrightarrow{\delta \to 0} m_i(u_i^{\varepsilon})^{m_i-1}$ a.e. in Q_T , (A.5), and (A.9).

APPENDIX B. PROOF OF A UNIFORM BOUND ON APPROXIMATE SOLUTIONS

We provide a proof of Lemma 3.6. Define the new variables

$$w_i^{\varepsilon} = u_i^{\varepsilon} \log u_i^{\varepsilon} + (\mu_i - 1)u_i^{\varepsilon} + e^{-\mu_i} \ge 0$$

and

$$z_i^{\varepsilon} = (\log u_i^{\varepsilon} + \mu_i)(u_i^{\varepsilon})^{m_i} - \frac{(u_i^{\varepsilon})^{m_i} - e^{-\mu_i m_i}}{m_i} \ge 0,$$

where the non-negativity follows from elementary calculus. Direct computations give

$$\partial_t w_i^{\varepsilon} - d_i \Delta z_i^{\varepsilon} = (\log u_i^{\varepsilon} + \mu_i) f_i^{\varepsilon} (u^{\varepsilon}) - d_i m_i (u_i^{\varepsilon})^{m_i - 2} |\nabla u_i^{\varepsilon}|^2.$$

Therefore, thanks to (1.2),

$$\partial_t \left(\sum_{i=1}^I w_i^{\varepsilon} \right) - \Delta \left(\sum_{i=1}^I d_i z_i^{\varepsilon} \right) \leqslant C \sum_{i=1}^I \left(1 + u_i^{\varepsilon} \log u_i^{\varepsilon} \right) \leqslant A + \beta \sum_{i=1}^I w_i^{\varepsilon}$$

with fixed positive constants $A, \beta > 0$ and a generic constant C > 0. Introducing $v(x,t) := e^{-\beta t} \sum_{i=1}^{I} w_i^{\varepsilon}$, this leads to

$$\partial_t v - \Delta \left(e^{-\beta t} \sum_{i=1}^I d_i z_i^{\varepsilon} \right) \leqslant A e^{-\beta t}.$$
 (B.1)

We integrate (B.1) in time on (0, t), then multiply the resultant by $e^{-\beta t} \sum_{i=1}^{I} d_i z_i^{\varepsilon}$ and integrate in Q_T , to get

$$\int_{Q_T} v \, e^{-\beta t} \sum_{i=1}^{I} d_i z_i^{\varepsilon} \, dx \, dt - \int_{Q_T} \left(\Delta \int_0^t e^{-\beta s} \sum_{i=1}^{I} d_i z_i^{\varepsilon} \, ds \right) \left(e^{-\beta t} \sum_{i=1}^{I} d_i z_i^{\varepsilon} \right) dx \, dt$$

$$\leqslant \int_{Q_T} \left(\frac{A}{\beta} + v(x,0) \right) e^{-\beta t} \sum_{i=1}^{I} d_i z_i^{\varepsilon} \, dx \, dt. \quad (B.2)$$

For the second term on the left hand side of (B.2), we have

$$-\int_{Q_T} \left(\Delta \int_0^t e^{-\beta s} \sum_{i=1}^I d_i z_i^\varepsilon \, ds \right) \left(e^{-\beta t} \sum_{i=1}^I d_i z_i^\varepsilon \right) \, dx \, dt$$
$$= \int_{Q_T} \nabla \left(\underbrace{\int_0^t e^{-\beta s} \sum_{i=1}^I d_i z_i^\varepsilon(x,s) \, ds}_{=:\varphi(x,t)} \right) \cdot \nabla \left(\underbrace{e^{-\beta t} \sum_{i=1}^I d_i z_i^\varepsilon(x,t)}_{=\partial_t \varphi(x,t)} \right) \, dx \, dt$$
$$= \frac{1}{2} \int_0^T \frac{d}{dt} \int_{\Omega} |\nabla \varphi(x,t)|^2 \, dx \, dt = \frac{1}{2} \int_{\Omega} |\nabla \varphi(x,T)|^2 \, dx \ge 0$$

where we used $\varphi(x,0) = 0$ at the last step. On the other hand, (B.1) ensures that

$$-\Delta \int_0^T e^{-\beta t} \sum_{i=1}^I d_i z_i^{\varepsilon} dt \leqslant \frac{A}{\beta} + v(x,0).$$
(B.3)

By putting $y = \int_0^T e^{-\beta t} \sum_{i=1}^I d_i z_i^{\varepsilon} dt$, we have $-\Delta y + y \leq y + \frac{A}{\beta} + v(x, 0)$. Multiplying both sides by y and integrating over Ω results in

$$\|y\|_{H^1(\Omega)}^2 \leq 2\|y\|_{L^2(\Omega)}^2 + \left\|\frac{A}{\beta} + v(0,x)\right\|_{L^2(\Omega)}^2.$$

By an interpolation estimate and Young's inequality, there exist $\theta \in (0,1)$ and $c, \gamma, \Gamma > 0$ with γ arbitrarily small satisfying $\|y\|_{L^2(\Omega)}^2 \leq c \|y\|_{H^1(\Omega)}^{2\theta} \|y\|_{L^1(\Omega)}^{2(1-\theta)} \leq \gamma \|y\|_{H^1(\Omega)}^2 + \Gamma \|y\|_{L^1(\Omega)}^2$. Hence, we obtain

$$||y||_{L^2(\Omega)} \leq C \left(1 + ||y||_{L^1(\Omega)}\right).$$

Using (B.2) and the above bound on y, it follows that

$$\int_{Q_T} \left(\sum_{i=1}^I w_i^{\varepsilon} \right) \left(\sum_{i=1}^I d_i z_i^{\varepsilon} \right) dx \, dt \leqslant C_T \int_{\Omega} \left(\frac{A}{\beta} + v(x,0) \right) y \, dx \\
\leqslant C_T \left(1 + \|y\|_{L^1(\Omega)} \right) \leqslant C_T \left(1 + \int_{Q_T} \sum_{i=1}^I d_i z_i^{\varepsilon} \, dx \, dt \right). \quad (B.4)$$

From the definition of w_i^{ε} and z_i^{ε} , it is easy to see that for any $\delta > 0$, there exists some $C_{\delta} > 0$ such that

$$\sum_{i=1}^{I} d_i z_i^{\varepsilon} \leq \delta \left(\sum_{i=1}^{I} w_i^{\varepsilon} \right) \left(\sum_{i=1}^{I} d_i z_i^{\varepsilon} \right) + C_{\delta}.$$

We then derive from (B.4) that

$$\int_{Q_T} \left(\sum_{i=1}^I w_i^{\varepsilon} \right) \left(\sum_{i=1}^I d_i z_i^{\varepsilon} \right) dx \, dt \leqslant C.$$

The desired estimate (3.12) is now an immediate consequence.
