A general family of Plotkin-optimal two-weight codes over **Z**⁴

Abstract

We obtained all possible parameters of Plotkin-optimal two-Lee weight projective codes over \mathbb{Z}_4 , together with their weight distributions. We show the existence of codes with these parameters as well as their weight distributions by constructing an infinite family of two-weight codes. Previously known codes constructed by Shi et al. (*Des Codes Cryptogr.* **88**(12): 2493-2505, 2020) can be derived as a special case of our results. We also prove that the Gray image of any Plotkin-optimal two-Lee weight projective codes over **Z**⁴ has the same parameters and weight distribution as some two-weight binary projective codes of type SU1 in the sense of Calderbank and Kantor (*Bull. Lond. Math. Soc.* **18**:97-122, 1986).

Keywords: Plotkin-optimal codes, projective codes, two-weight codes.

1 Introduction

A code *C* ⊆ **F** *ⁿ* over an alphabet **F** is called a constant weight code (or one-weight code) if every nonzero codeword has the same weight. Well-known examples of such codes over \mathbb{F}_q are simplex codes, which are the duals of Hamming codes (see, e.g., [\[6\]](#page-15-0)). Constant weight codes over **F***^q* have been extensively studied (see [\[9\]](#page-15-1) for a detailed account). One

important result regarding constant weight linear codes over \mathbb{F}_2 is that for every positive integer *k*, there exists a unique (up to equivalence) one-weight code of dimension *k* such that any two columns in its generator matrix are linearly independent. A similar phenomenon was proved by Carlet [\[3\]](#page-15-2) for constant weight linear codes over **Z**4.

A two-weight code $C \subseteq \mathbb{F}^n$ over an alphabet \mathbb{F} is a code with exactly two nonzero different weights. Two-weight codes over **F***^q* have been investigated since a long time because of their connection to other combinatorial objects such as strongly regular graphs, difference sets and also finite geometries [\[1,](#page-15-3) [2,](#page-15-4) [4\]](#page-15-5). Recently, there were also some progress in the study of two-weight codes over finite rings, such as \mathbb{Z}_4 [\[13–](#page-16-0)[15\]](#page-16-1), \mathbb{Z}_{2^m} [\[8,](#page-15-6) [11,](#page-16-2) [12\]](#page-16-3), \mathbb{Z}_{p^m} [\[11\]](#page-16-2), and $\mathbb{F}_p + u\mathbb{F}_p$ [\[10\]](#page-16-4), with $u^2 = u$, where p is an odd prime. Interestingly, twoweight codes over \mathbb{Z}_{p^m} for some prime p also have some connections to strongly regular graphs [\[12\]](#page-16-3) and finite geometries [\[11\]](#page-16-2).

Constructing (optimal) codes is one of the main problems in coding theory. The construction of one-weight codes over \mathbb{Z}_4 has been provided in [\[13\]](#page-16-0), while several constructions of two-weight codes over **Z**⁴ have been found by several authors [\[12–](#page-16-3)[14\]](#page-16-5), and recently by [\[15\]](#page-16-1). All two-weight codes over **Z**⁴ constructed in [\[12](#page-16-3)[–15\]](#page-16-1) are Plotkin-optimal and projective (see Section 2 for the definition). The purpose of this paper is to find a complete list of possible parameters and weight distributions of Plotkin-optimal two-weight projective codes over **Z**4.

The organization of the paper is as follows. In Section 2, we provide some definitions related to linear codes over \mathbb{Z}_4 . Several useful identities related to linear codes over \mathbb{Z}_4 are derived in Section 3. In Section 4, we study possible parameters and weight distributions of Plotkin-optimal two-weight projective codes over **Z**⁴ and their Gray images. In Section 5, we first consider a family of free two-weight codes over **Z**4. After that, we use these free codes to construct an infinite family of two-weight codes. The paper is ended by concluding remarks. We refer the readers to [\[6,](#page-15-0) [9\]](#page-15-1) for undefined terms in coding theory.

2 Preliminaries

A *code* C of length *n* over the ring \mathbb{Z}_4 is a nonempty subset of \mathbb{Z}_4^n . If the code is also a submodule of **Z***ⁿ* 4 , then we say that the code is *linear.* The linear code is called *free* if it is a free submodule of \mathbb{Z}_4^n .

A matrix $G \in \mathbb{Z}_4^{k \times n}$ $_{4}^{k\times n}$ is called a *generator matrix* of a linear code C of length *n* over \mathbb{Z}_4 if the rows of *G* generate *C* and no proper subset of the rows of *G* generates *C*.

Two codes are said to be *equivalent* if one can be obtained from the other by permuting the coordinates and (if necessary) changing the signs of certain coordinates. Codes differing by only a permutation of coordinates are called *permutation-equivalent.* It is wellknown (see [\[5\]](#page-15-7)) that any linear code over \mathbb{Z}_4 is permutation-equivalent to the linear code *C* with generator matrix *G* of the form

$$
G = \begin{pmatrix} I_{k_1} & A & B_1 + 2B_2 \\ 0 & 2I_{k_2} & 2D \end{pmatrix},
$$
 (1)

where A , B_1 , B_2 , and D are $(0, 1)$ -matrices. Moreover, the code C is a free linear code if and only if $k_2 = 0$. The generator matrix of a linear code *C* over \mathbb{Z}_4 is called in a *standard form* if it has the form as given in the Equation [\(1\)](#page-2-0).

The Lee weight of $x \in \mathbb{Z}_4$, denoted by $w_L(x)$, is defined by $w_L(0) = 0$, $w_L(1) = 1$, $w_L(2) = 2$, and $w_L(3) = 1$. The Lee weight of a vector $\mathbf{x} = (x_1, x_2, \dots, x_n) \in \mathbb{Z}_4^n$ is defined as $w_L(\mathbf{x}) = \sum_{i=1}^n w_L(x_i)$. For a given positive integer β , a linear code *C* over \mathbb{Z}_4 is called a *β-weight code* if

$$
|\{w_L(\mathbf{c})\,:\,\mathbf{0}\neq\mathbf{c}\in\mathbb{C}\}|=\beta,
$$

where **0** denotes the all-zero vector.

For $x, y \in \mathbb{Z}_4^n$, the *Lee distance* between x and y , denoted by $d_L(x, y)$, is defined by $d_L(\mathbf{x}, \mathbf{y}) = w_L(\mathbf{x} - \mathbf{y})$. The *minimum Lee distance* of a linear code $C \subseteq \mathbb{Z}_4^n$ is defined by

$$
d_L = d_L(C) := \min\{d_L(\mathbf{x}, \mathbf{y}) : \mathbf{x}, \mathbf{y} \in C, \mathbf{x} \neq \mathbf{y}\}.
$$

Throughout the paper, what we mean by weight and distance are Lee weight and Lee distance, respectively. It is clear that the minimum Lee distance of a linear code *C* is exactly the same as the minimum Lee weight, namely $d_L(C) = \min\{w_L(\mathbf{x}) : \mathbf{0} \neq \mathbf{x} \in C\}$. We write the parameters of a linear code C over \mathbb{Z}_4 as $[n, 4^{k_1}2^{k_2}, d_L]$, where n is a length of *C*, $|C| = 4^{k_1}2^{k_2}$, and $d_L = d_L(C)$. Following Hammons et al. [\[5\]](#page-15-7) (cf. [\[17\]](#page-16-6)), we say that *C* is of type $4^{k_1}2^{k_2}$. In [\[5\]](#page-15-7), the *Gray map* $\phi : \mathbb{Z}_4 \to \mathbb{F}_2^2$ $\frac{2}{2}$ is defined as $\phi(0) = (0,0), \phi(1) = 0$ $(0, 1), \phi(2) = (1, 1),$ and $\phi(3) = (1, 0)$. The Gray map ϕ can be extended naturally to $\Phi: \mathbb{Z}_4^n \to \mathbb{F}_2^{2n}$ 2^n . Φ is a distance-preserving map (isometry) from (\mathbb{Z}_4^n, d_L) to (\mathbb{F}_2^{2n}) $_{2}^{2n},d_{H}$), where d_H denotes the Hamming distance.

In 1968, Wyner and Graham [\[18\]](#page-16-7) proved an upper bound for the minimum Lee distance of codes over \mathbb{Z}_4 , as follows (see also [\[16,](#page-16-8) Theorem 3.4] for a simpler proof).

Theorem 2.1 (Plotkin-type Lee distance bound)**.** *If C is a linear code of length n over* **Z**⁴ *with parameters* [*n*, 4*k*¹ 2 *k*2 , *dL*]*, then*

$$
d_L \le \frac{|C|}{|C| - 1} n. \tag{2}
$$

A linear code *C* whose minimum Lee distance *dL*(*C*) is an integer nearest to the upper bound of the Plotkin-type Lee distance bound [\(2\)](#page-2-1) as given in Theorem [2.1](#page-2-2) is called *Plotkinoptimal.* In other words, a linear code *C* is Plotkin-optimal if $d_L(C) = \left| \frac{|C|}{|C|} \right|$ $\frac{|C|}{|C| - 1}n$ $\overline{1}$.

For $\mathbf{x} = (x_1, x_2, \dots, x_n)$, $\mathbf{y} = (y_1, y_2, \dots, y_n) \in \mathbb{Z}_4^n$, we define the *Euclidean inner product* of **x** and **y** as $\mathbf{x} \cdot \mathbf{y} = \sum_{i=1}^{n} x_i y_i \in \mathbb{Z}_4$. The *Dual* of *C*, denoted by C^{\perp} , is defined as

$$
C^{\perp} = \{ \mathbf{x} \in \mathbb{Z}_4^n : \ \mathbf{x} \cdot \mathbf{y} = 0, \text{ for all } \mathbf{y} \in C \}.
$$

A *projective code C* of length *n* over **Z**⁴ is a linear code such that the minimum Lee distance of its dual*, d*_L(C^{\perp}), is at least three.

3 Some useful identities

In this section, we derive several identities related to linear codes over \mathbb{Z}_4 . We will use these identities to obtain parameters and weight distributions of Plotkin-optimal twoweight projective codes over **Z**4.

Let $G \in \mathbb{Z}_4^{(k_1+k_2) \times n}$ $\frac{(k_1+k_2)\times n}{4}$ be a generator matrix of a linear code *C* over \mathbb{Z}_4 . Following Kløve [\[7\]](#page-15-8), for any $\mathbf{c} \in \mathbb{Z}_4^{k_1+k_2}$ $\frac{\mu_1+\mu_2}{4}$, we define the *multiplicity* of **c**, denoted by $\mu(\mathbf{c})$, as the number of occurrences of **c** as a column vector in *G*. Observe that for any $\mathbf{x} \in \mathbb{Z}_4^k$ with $k := k_1 + k_2$, we have

$$
w_L(\mathbf{x}G)=\sum_{\mathbf{c}\in\mathbb{Z}_4^k}\mu(\mathbf{c})w_L(\mathbf{x}\cdot\mathbf{c}).
$$

It is also clear that

$$
\sum_{\mathbf{c}\in\mathbb{Z}_4^k}\mu(\mathbf{c})=n.
$$

It is known that for any nonzero codeword $\mathbf{c} \in \mathbb{Z}_4^k$, the sum $\sum_{\mathbf{x} \in \mathbb{Z}_4^k} w_L(\mathbf{x} \cdot \mathbf{c})$ is constant, and depends only on *k*.

Lemma 3.1 ([\[16,](#page-16-8) Lemma 3.1]). Let k be a positive integer. If $\mathbf{c} = (c_1, c_2, \dots, c_k) \in \mathbb{Z}_4^k$ is a *nonzero vector, then*

$$
\sum_{\mathbf{x}\in\mathbb{Z}_4^k}w_L(\mathbf{x}\cdot\mathbf{c})=4^k.
$$

Moreover, we have a constant sum of Lee weights of codewords in the linear code as follows.

Lemma 3.2 ([\[16,](#page-16-8) Lemma 3.2], [\[16,](#page-16-8) Lemma 3.3])**.** *Let C be a linear code over* **Z**⁴ *with parame*ters $[n,4^{k_1}2^{k_2},d_L].$ If G is a generator matrix of C and $\mu(\mathbf{0})=0$, then

$$
\sum_{\mathbf{x}\in\mathbb{Z}_4^{k_1+k_2}} w_L(\mathbf{x}G)=4^{k_1+k_2}n \quad \text{and} \quad \sum_{\mathbf{c}\in C} w_L(\mathbf{c})=|C|n.
$$

Now, consider the quotient group $\mathbb{Z}_4^k/(2\mathbb{Z}_4)^k$ for a positive integer *k*. For any $\mathbf{S} \in$ $\mathbb{Z}_4^k/(2\mathbb{Z}_4)^k$, it is clear that $|\mathbf{S}| = |(2\mathbb{Z}_4)^k| = 2^k$. Moreover, for any $\mathbf{x}, \mathbf{y} \in \mathbf{S}$, we have $2x = 2y$. We can prove the identity stronger than the one in Lemma [3.1](#page-3-0) and Lemma [3.2](#page-3-1) by proving that $\sum_{\mathbf{x}\in\mathbf{S}} w_L(\mathbf{x}\cdot\mathbf{c})$ and $\sum_{\mathbf{x}\in\mathbf{S}} w_L(\mathbf{x}G)$ are constant for any $\mathbf{S}\in\mathbb{Z}_4^k/(2\mathbb{Z}_4)^k$ in certain conditions. We first consider the case when $S = (2\mathbb{Z}_4)^k$. For this purpose, we recall the property of one-weight codes below.

Theorem 3.3 ([\[13,](#page-16-0) Theorem 4.5], [\[16,](#page-16-8) Theorem 4.2]). For any nonnegative integer k_1 , k_2 with $2k_1 + k_2 \geq 1$, let $G^{(k_1,k_2)}$ denote the generator matrix of a linear code $C^{(k_1,k_2)}$ whose columns consist of all possible nonzero vectors in $\mathbb{Z}_4^{k_1}\times (2\mathbb{Z}_4)^{k_2}.$ Then $C^{(k_1,k_2)}$ is a one-weight linear code *over* \mathbb{Z}_4 with parameters $[n, 4^{k_1}2^{k_2}, d_L]$, where $n = 4^{k_1}2^{k_2} - 1$, and $d_L = 4^{k_1}2^{k_2}$.

By using the above theorem, we obtain the following lemma.

Lemma 3.4. *Let k be a positive integer. If* $\mathbf{c} = (c_1, c_2, \dots, c_k) \in \mathbb{Z}_4^k$, then

$$
\sum_{\mathbf{x}\in(2\mathbb{Z}_4)^k}w_L(\mathbf{x}\cdot\mathbf{c})=\begin{cases}0&\text{if }\mathbf{c}\in(2\mathbb{Z}_4)^k,\\2^k&\text{if }\mathbf{c}\in\mathbb{Z}_4^k-(2\mathbb{Z}_4)^k.\end{cases}
$$

Proof. Since it is clear for $c \in (2\mathbb{Z}_{4})^{k}$, we prove the case $c \in \mathbb{Z}_{4}^{k} - (2\mathbb{Z}_{4})^{k}$. By Theorem [3.3,](#page-4-0) we know that the code $C^{(0,k)}$ has parameters $[2^k-1,4^02^k,2^k]$ and also a one-weight code having weight 2^k. Because $\mathbf{c} G^{(0,k)}$ is a nonzero codeword in $C^{(0,k)}$, we have

$$
2^k = w_L(\mathbf{c}G^{(0,k)}) = \sum_{\mathbf{x} \in \mathbb{Z}_4^k} \mu(\mathbf{x}) w_L(\mathbf{x} \cdot \mathbf{c}) = \sum_{\mathbf{x} \in (2\mathbb{Z}_4)^k} w_L(\mathbf{x} \cdot \mathbf{c}). \square
$$

A constant summation of the Lee weight along any nonzero element in $\mathbb{Z}_4^k/(2\mathbb{Z}_4)^k$ is given in the following. Throughout the rest of this paper, the notation $[a, b]_Z$ denotes the set $\{x \in \mathbb{Z} : x \ge a \text{ and } x \le b\}$, where *a*, *b* are integers.

Lemma 3.5. Let k be a positive integer and let **S** be a nonzero element of $\mathbb{Z}_4^k/(2\mathbb{Z}_4)^k$. If $\mathbf{c} =$ $(c_1, c_2, \ldots, c_k) \in \mathbb{Z}_4^k - (2\mathbb{Z}_4)^k$, then

$$
\sum_{\mathbf{x}\in\mathbf{S}} w_L(\mathbf{x}\cdot\mathbf{c}) = 2^k.
$$

Proof. Let $x \in S$. We consider two cases.

Case 1: If $w_L(\mathbf{x} \cdot \mathbf{c}) = 1$, then for any $\mathbf{y} \in \mathbf{S}$ we have $2\mathbf{y} \cdot \mathbf{c} = 2\mathbf{x} \cdot \mathbf{c} = 2$, which implies $w_L(\mathbf{y} \cdot \mathbf{c}) = 1$. Hence, $\sum_{\mathbf{x} \in \mathbf{S}} w_L(\mathbf{x} \cdot \mathbf{c}) = |\mathbf{S}| = 2^k$.

Case 2: If $w_L(\mathbf{x} \cdot \mathbf{c}) \in \{0,2\}$, take $j \in [1,k]$ g such that $c_j \in \{1,3\}$. Without loss of generality, assume $w_L(\mathbf{x} \cdot \mathbf{c}) = 0$. For $i \in [1, k]_{\mathbb{Z}}$, define a vector $\mathbf{e}_i = (e_{i1}, e_{i2}, \dots e_{ik}) \in \mathbb{Z}_4^k$ as

$$
e_{ij} := \begin{cases} 1, & \text{if } j = i, \\ 0, & \text{if } j \neq i. \end{cases}
$$

Now, define a map $f : \mathbb{Z}_4^k \longrightarrow \mathbb{Z}_4^k$ by $f(\mathbf{x}) = \mathbf{x} + 2\mathbf{e}_i$. It is easy to check that f is a bijection from $A := \{x \in S : w_L(x \cdot c) = 0\}$ to $B := \{x \in S : w_L(x \cdot c) = 2\}$. For any $y \in S$, we have $2y \cdot c = 2x \cdot c = 0$, so $w_L(y \cdot c) \in \{0, 2\}$. Hence, $A \cup B = S$ and $|A| = |B| = \frac{|S|}{2} = 2^{k-1}$. We conclude that

$$
\sum_{\mathbf{x}\in\mathbf{S}} w_L(\mathbf{x}\cdot\mathbf{c}) = \sum_{\mathbf{x}\in A} w_L(\mathbf{x}\cdot\mathbf{c}) + \sum_{\mathbf{x}\in B} w_L(\mathbf{x}\cdot\mathbf{c}) = 2^k.
$$

From the constant summation properties as given in Lemma [3.4](#page-4-1) and Lemma [3.5,](#page-4-2) we obtain two new identities similar to Lemma [3.2.](#page-3-1)

Corollary 3.6. *Let C be a linear code over* **Z**⁴ *with parameters* [*n*, 4*k*¹ 2 *k*2 , *dL*] *and a generator matrix G. If* μ (**c**) = 0, *for all* **c** $\in (2\mathbb{Z}_{4})^{k_{1}+k_{2}}$, then

$$
\sum_{\mathbf{x} \in (2\mathbb{Z}_4)^{k_1+k_2} - \{\mathbf{0}\}} w_L(\mathbf{x}G) = 2^{k_1+k_2}n. \tag{3}
$$

Proof. Let $k := k_1 + k_2$. By Lemma [3.4,](#page-4-1) we have

$$
\sum_{\mathbf{x}\in(2\mathbb{Z}_4)^k} w_L(\mathbf{x}G) = \sum_{\mathbf{x}\in(2\mathbb{Z}_4)^k} \sum_{\mathbf{c}\in\mathbb{Z}_4^k} \mu(\mathbf{c}) w_L(\mathbf{x}\cdot\mathbf{c}) = \sum_{\mathbf{c}\in\mathbb{Z}_4^k} \mu(\mathbf{c}) \left(\sum_{\mathbf{x}\in(2\mathbb{Z}_4)^k} w_L(\mathbf{x}\cdot\mathbf{c})\right) = 2^k n.
$$

The result follows as $w_L(\mathbf{0}G) = 0$.

Similarly, we can prove the following using Lemma [3.5.](#page-4-2)

Corollary 3.7. *Let C be a linear code over* **Z**⁴ *with parameters* [*n*, 4*k*¹ 2 *k*2 , *dL*] *and a generator* m atrix G. If $\mu(\mathbf{c})=0$, for all $\mathbf{c}\in (2\mathbb{Z}_4)^{k_1+k_2}$, and $\mathbf S$ is a nonzero element in $\mathbb Z_4^{k_1+k_2}$ $_{4}^{k_{1}+k_{2}}/(2\mathbb{Z}_{4})^{k_{1}+k_{2}}$ *then*

$$
\sum_{\mathbf{x}\in\mathbf{S}} w_L(\mathbf{x}G) = 2^{k_1+k_2}n.
$$
 (4)

Equations [\(3\)](#page-5-0) and [\(4\)](#page-5-1) will be very useful to prove several results in next section.

4 Two-weight projective codes over Z⁴

In [\[12](#page-16-3)[–15\]](#page-16-1), Shi and his coauthors considered two-weight projective codes. In this section, we provide all possible parameters and weight distributions of Plotkin-optimal twoweight projective codes over **Z**4. As consequences, we show that the results obtained before in [\[12](#page-16-3)[–15\]](#page-16-1) are just special cases of our results.

First, let us recall the necessary and sufficient existence conditions for projective codes.

 \Box

Lemma 4.1 ([\[15,](#page-16-1) Lemma 4.8])**.** *Let C be a linear code over* **Z**⁴ *with type* 4 *^k*¹ 2 *^k*² *of length n and a generator matrix G. Then C is projective if and only if the following two conditions hold:*

- *(1) every column of G contains 1 or 3 (i.e.* $\mu(\mathbf{c}) = 0$ *, for all* $\mathbf{c} \in (2\mathbb{Z}_{4})^{k_{1}+k_{2}}$ *);*
- *(2) any two columns of G are not multiple of each other by* ± 1 *(i.e.* μ (**c**) + μ (3**c**) \leq 1, *for all* $\mathbf{c} \in \mathbb{Z}_4^{k_1} \times (2\mathbb{Z}_4)^{k_2}$, given G in a standard form).

By using Lemma [4.1,](#page-6-0) we can easily obtain an upper bound for the length of projective codes.

Proposition 4.2. If C is a projective code of length n over \mathbb{Z}_4 with type $4^{k_1}2^{k_2}$, then $n \leq$ $2^{2k_1+k_2-1}-2^{k_1+k_2-1}.$

Proof. Let $k := k_1 + k_2$. From Lemma [4.1,](#page-6-0) it is clear that

$$
2n = 2 \sum_{\mathbf{c} \in \mathbb{Z}_4^k} \mu(\mathbf{c}) = \sum_{\mathbf{c} \in \mathbb{Z}_4^k} \mu(\mathbf{c}) + \mu(3\mathbf{c}) \le \left| \left(\mathbb{Z}_4^{k_1} \times (2\mathbb{Z}_4)^{k_2} \right) - (2\mathbb{Z}_4)^k \right| = 2^{2k_1 + k_2} - 2^{k_1 + k_2}.
$$

Here, we consider the multiplicity using the generator matrix in a standard form. \Box

We knew that Plotkin-optimal projective codes always satisfy $d_L = n$. From the above proposition, it is clear that *n* < |*C*| − 1. Thus, a projective code *C* of length *n* is Plotkinoptimal if and only if

$$
d_L(C) = \left\lfloor \frac{|C|}{|C|-1} n \right\rfloor = \left\lfloor n + \frac{n}{|C|-1} \right\rfloor = n.
$$

As a consequence, Plotkin-optimal projective codes always contain a codeword of Lee weight *n*. Hence, for two-weight codes, we can obtain the other weight by using the result in [\[13\]](#page-16-0) below.

Proposition 4.3 ([\[13,](#page-16-0) Proposition 5.1 (12)])**.** *Let C be any linear code of length n over* **Z**4*. If C is a two-Lee weight projective code with nonzero weights w*¹ *and w*2*, then*

$$
n(2n+1) - (w_1 + w_2)2n + 2w_1w_2\left(1 - \frac{1}{|C|}\right) = 0.
$$
 (5)

From Proposition [4.3,](#page-6-1) we conclude that the other weight of Plotkin-optimal projective codes must be |*C*|/2. The relation between two-weight projective codes and Plotkinoptimal codes is summarized in the following corollary.

Corollary 4.4. *Let C be any linear code of length n over* **Z**4*. If C is a two-Lee weight projective code with nonzero weights* $w_1 < w_2$, then the following statements are equivalent:

- *(1) C is Plotkin-optimal;*
- *(2)* $w_1 = n$;

$$
(3) \ w_2 = \frac{|C|}{2}.
$$

Notice that $w_1 = n$ and $w_2 = \frac{|C|}{2}$ $\frac{C}{2}$ satisfy Equation [\(5\)](#page-6-2) for all positive integers $n <$ |*C*| $\frac{C_1}{2}$. In this case, we could not determine the nonexistence of Plotkin-optimal two-weight projective codes of certain length from that equation. Fortunately, by using additional equations, namely Equations [\(3\)](#page-5-0) and [\(4\)](#page-5-1), we obtain the nonexistence results for many values of *n* as follows (note that Corollary [3.6](#page-5-2) and [3.7](#page-5-3) hold for any projective codes by Lemma [4.1\)](#page-6-0).

Corollary 4.5. *Let C be a two-Lee weight projective code of length n over* **Z**⁴ *with a generator matrix G. If C is Plotkin-optimal, then* $w_L(\mathbf{x}G) = n$ *, for all* $\mathbf{x} \in \mathbb{Z}_4^{k_1+k_2} - (2\mathbb{Z}_4)^{k_1+k_2}$ *.*

Proof. Let **S** be any nonzero element of $\mathbb{Z}_4^{k_1+k_2}$ $\frac{k_1+k_2}{4}/(2\mathbb{Z}_4)^{k_1+k_2}$. From Lemma [3.7,](#page-5-3) we have

$$
2^{k_1+k_2}n = \sum_{c \in S} w_L(cG) \ge |S|d_L = 2^{k_1+k_2}n.
$$

The equality occurs when $w_L(cG) = n$, for all $c \in S$. Since S is arbitrary, $w_L(xG) = n$, for all $\mathbf{x} \in \mathbb{Z}_4^{k_1+k_2} - (2\mathbb{Z}_4)^{k_1+k_2}$. □

Let *A^w* denote the number of codewords in *C* having the Lee weight equal to *w*. The theorem below shows possible parameters of Plotkin-optimal two-Lee weight projective codes over **Z**4.

Theorem 4.6. *Let C be a Plotkin-optimal two-weight projective code with type* 4 *^k*¹ 2 *^k*² *of length n* over \mathbb{Z}_4 . Then $n = d_L = 2^{2k_1+k_2-1} - 2^{2k_1+k_2-t-1}$, for some integer $1 \le t \le k_1$. Moreover, *the nonzero weights of C are* $w_1 = 2^{2k_1+k_2-1} - 2^{2k_1+k_2-t-1}$ *and* $w_2 = 2^{2k_1+k_2-1}$ *, with* $A_{w_1} =$ $2^{2k_1+k_2}-2^t$ and $A_{w_2}=2^t-1$.

Proof. Let *G* be a generator matrix of *C*. Let $w_1 < w_2$ be the two nonzero weights of *C*. By Corollary [4.4,](#page-6-3) we have $w_1 = n$ and $w_2 = \frac{|C|}{2}$ $\frac{c_1}{2}$.

Let *s* be the number of vectors $\mathbf{x} \in (2\mathbb{Z}_4)^k$ such that $w_L(\mathbf{x} G) = \frac{|C|}{2}$. Since *C* is projective, *C* satisfies Corollary [3.6:](#page-5-2)

$$
2^{k_1+k_2}n=\sum_{\mathbf{c}\in(2\mathbb{Z}_4)^{k_1+k_2}-\{\mathbf{0}\}}w_L(\mathbf{c}G)=s\frac{|C|}{2}+(2^{k_1+k_2}-1-s)n.
$$

From the above equation, we have $n = \frac{s}{2(s+1)}|C|$. It implies that $s|C|$ is divisible by $s+1$, and hence $s + 1$ divides $|C| = 2^{2k_1+k_2}$. It forces $s + 1 = 2^t$ for some $t \in \mathbb{Z}^+$. By Proposition [4.2,](#page-6-4) we obtain

$$
2^{2k_1+k_2-1}-2^{k_1+k_2-1}\geq n=\frac{2^t-1}{2^{t+1}}2^{2k_1+k_2}=2^{2k_1+k_2-1}-2^{2k_1+k_2-t-1},
$$

which implies $1 \le t \le k_1$. We conclude that

$$
n = 2^{2k_1+k_2-1} - 2^{2k_1+k_2-t-1} = w_1 \text{ and } w_2 = \frac{|C|}{2} = 2^{2k_1+k_2-1}
$$

for some integer *t* with $1 \le t \le k_1$. Now, to find the values of A_{w_1} and A_{w_2} , we know from Corollary [4.5,](#page-7-0) that $w_L(\mathbf{x}G) = n$, for all $\mathbf{x} \in \mathbb{Z}_4^{k_1+k_2} - (2\mathbb{Z}_4)^{k_1+k_2}$. Therefore, $A_{w_1} =$ $|C| - 1 - s = 2^{2k_1 + k_2} - 2^t$ and $A_{w_2} = s = 2^t - 1$. \Box

In the remark below, we compare our result above (Theorem [4.6\)](#page-7-1) with the previous results available in [\[12–](#page-16-3)[15\]](#page-16-1).

- **Remark 1.** 1. Any code in the family of two-weight projective codes in [\[13,](#page-16-0) Theorem 5.6] (same as [\[14,](#page-16-5) Theorem 3.4]) is Plotkin-optimal and also a special case of Theorem [4.6](#page-7-1) with $t = 1$. Moreover, [\[12,](#page-16-3) Theorem 4.2] shows that any two-weight projective code with $d_L(\mathcal{C}^\perp) \geq 4$ must be Plotkin-optimal and also a special case of Theorem [4.6](#page-7-1) with $t = 1$.
	- 2. Any code in two families of two-weight projective codes in [\[15,](#page-16-1) Theorem 4.2] and [\[15,](#page-16-1) Corollary 4.5] is Plotkin-optimal and also a special case of Theorem [4.6](#page-7-1) with $t = k_1 - 1$ and $t = k_1$.

Now, let us consider the Gray image of any Plotkin-optimal two-weight projective code over **Z**4. First, recall the parameters of SU1-type two-weight [*n*, *k*] linear codes over **F***^q* (see Figure 1a and Figure 2a in [\[2\]](#page-15-4)):

$$
n=\frac{q^{l}-q^{m}}{q-1}, k=l, w_1=q^{l-1}-q^{m-1}, w_2=q^{l-1}, A_{w_1}=q^{l}-q^{l-m}, A_{w_2}=q^{l-m}-1,
$$

for some integers $l > 1$ and $1 \le m \le l - 1$. From Theorem [4.6,](#page-7-1) the Gray image of any Plotkin-optimal two-weight projective code C over \mathbb{Z}_4 is a binary code with parameters

$$
n = 2n(C) = 2^{2k_1 + k_2} - 2^{2k_1 + k_2 - t}, k = 2k_1 + k_2, w_1 = 2^{2k_1 + k_2 - 1} - 2^{2k_1 + k_2 - t - 1}, w_2 = 2^{2k_1 + k_2 - 1}
$$

and weight distribution $A_{w_1} = 2^{2k_1+k_2} - 2^t$, $A_{w_2} = 2^t - 1$. Notice that $\Phi(C)$ is not necessarily linear, but it always has the same parameters and weight distribution as some binary two-weight linear codes of type SU1. In this case, $q = 2, l = 2k_1 + k_2$, and $m = 2k_1 + k_2 - t$.

Moreover, we can also conclude that the syndrome graph (see [\[12\]](#page-16-3) for definition) of the dual of any Plotkin-optimal two-weight projective code over \mathbb{Z}_4 is a strongly regular graph on 22*k*1+*k*² vertices, degree 22*k*1+*k*² − 2 2*k*1+*k*2−*t* , and restricted eigenvalues 0 and −2 2*k*1+*k*2−*t* . This graph is also a complete multipartite graph of type *Ka*×*m*, where *a* = 2 *t* and $m = 2^{2k_1+k_2-t}$. The details are very similar to [\[15,](#page-16-1) Section 6].

5 A general family

In this section, we first recall a family of free Plotkin-optimal two-weight projective codes over **Z**⁴ constructed in [\[15\]](#page-16-1). Using this family of codes, we prove the existence of Plotkinoptimal two-weight projective codes over **Z**⁴ with the same parameters and weight dis-tribution as in Theorem [4.6,](#page-7-1) for any $1 \le t \le k_1$.

5.1 A family of two weight codes with $k_2 = 0$

Let *k* be a positive integer. Following Shi et al. [\[15\]](#page-16-1), we define a matrix Y_k as follows: for $k=1$, we define $Y_k := \bigl\lceil 1 \bigr\rceil$; and for $k \geq 2$, we define

$$
Y_k := \left[\begin{array}{c|c|c|c} Y_{k-1} & Y_{k-1} & Y_{k-1} & Y_{k-1} & B_{k-1} \\ \hline 0 & 0 & 0 & 1 & 1 & 1 & 2 & 2 & 3 & 3 & 3 & 3 & 1 & 1 & 1 & 1 \end{array} \right],
$$

where B_{k-1} is a $(k-1)\times 2^{k-1}$ matrix whose columns are all possible vectors in $(2\mathbb{Z}_4)^{k-1}.$ From the definition, it is easy to check that the linear code generated by *Y^k* is projective for any positive integer k (Lemma [4.1\)](#page-6-0). In other words, $\mu(\mathbf{c}) = 0$, for all $\mathbf{c} \in (2\mathbb{Z}_4)^k$ and $\mu(c) + \mu(3c) \leq 1$, for all $c \in \mathbb{Z}_4^k$. Now, we reprove [\[15,](#page-16-1) Proposition 3.1] and [15, Corollary 3.2] with a slightly different (and shorter) proof.

Proposition 5.1 ([\[15,](#page-16-1) Proposition 3.1], [\[15,](#page-16-1) Corollary 3.2])**.** *If C is the code generated by Y^k ,* then C is a free two-weight code of length $n\,=\,2^{k-1}(2^k-1)$, with nonzero Lee weights $w_1\,=$ $2^{k-1}(2^k-1)$ and $w_2 = 2^{2k-1}$, also $A_{w_1} = 4^k - 2^k$ and $A_{w_2} = 2^k - 1$. Moreover,

$$
w_L(\mathbf{x}Y_k) = \begin{cases} 2^{2k-1}, & \text{if } \mathbf{x} \in (2\mathbb{Z}_4)^k - \{\mathbf{0}\}, \\ 2^{k-1}(2^k-1), & \text{if } \mathbf{x} \in \mathbb{Z}_4^k - (2\mathbb{Z}_4)^k. \end{cases}
$$

Proof. It is easy to check that $n = 2^{k-1}(2^k - 1)$, $k_1 = k$, and $k_2 = 0$. From the proof of Proposition [4.2,](#page-6-4) we conclude that $\mu(c) + \mu(3c) = 1$ for all $c \in \mathbb{Z}_4^k$. Now, for any $\mathbf{x} \in \mathbb{Z}_4^k - \{\mathbf{0}\}$ we have

$$
w_L(\mathbf{x}Y_k) = \frac{1}{2} \left(2 \sum_{\mathbf{c} \in \mathbb{Z}_4^k} \mu(\mathbf{c}) w_L(\mathbf{x} \cdot \mathbf{c}) \right)
$$

\n
$$
= \frac{1}{2} \left(\sum_{\mathbf{c} \in \mathbb{Z}_4^k} \mu(\mathbf{c}) w_L(\mathbf{x} \cdot \mathbf{c}) + \sum_{\mathbf{c} \in \mathbb{Z}_4^k} \mu(3\mathbf{c}) w_L(\mathbf{x} \cdot 3\mathbf{c}) \right)
$$

\n
$$
= \frac{1}{2} \left(\sum_{\mathbf{c} \in \mathbb{Z}_4^k} (\mu(\mathbf{c}) + \mu(3\mathbf{c})) w_L(\mathbf{x} \cdot \mathbf{c}) \right)
$$

\n
$$
= \frac{1}{2} \left(\sum_{\mathbf{c} \in \mathbb{Z}_4^k} w_L(\mathbf{x} \cdot \mathbf{c}) - \sum_{\mathbf{c} \in (2\mathbb{Z}_4)^k} w_L(\mathbf{x} \cdot \mathbf{c}) \right)
$$

\n
$$
= \begin{cases} 2^{2k-1}, & \text{if } \mathbf{x} \in (2\mathbb{Z}_4)^k - \{0\}, \\ 2^{k-1}(2^k - 1), & \text{if } \mathbf{x} \in \mathbb{Z}_4^k - (2\mathbb{Z}_4)^k. \end{cases}
$$

The last equality is obtained from Lemma [3.1](#page-3-0) and Lemma [3.4.](#page-4-1) It is clear that A_{w_1} = $|\mathbb{Z}_4^k - (2\mathbb{Z}_4)^k| = 4^k - 2^k$ and $A_{w_2} = |(2\mathbb{Z}_4)^k - \{0\}| = 2^k - 1$. □

Remark 2. Note that " $\mathbf{x} \in (2\mathbb{Z}_4)^k - \{\mathbf{0}\}$ " and " $\mathbf{x} \in \mathbb{Z}_4^k - (2\mathbb{Z}_4)^{k}$ " are equivalent to "the order of $\mathbf{c} = \mathbf{x} Y_k$ is 2" and "the order of $\mathbf{c} = \mathbf{x} Y_k$ is 4" in [\[15,](#page-16-1) Corollary 3.2], respectively. Here, the order of a nonzero codeword **c** is the smallest positive integer *k* such that $k\mathbf{c} = \mathbf{0}$.

Notice that the code generated by *Y^k* is Plotkin-optimal, because

$$
\left\lfloor \frac{|C|}{|C|-1}n \right\rfloor = \left\lfloor \frac{4^k}{4^k-1} \left(2^{k-1}(2^k-1) \right) \right\rfloor = 2^{k-1}(2^k-1) = d_L(C).
$$

Moreover, we can prove the uniqueness (up to equivalence) of free Plotkin-optimal twoweight projective codes over \mathbb{Z}_4 of length $n=2^{k-1}(2^k-1).$ From the proof of Proposition [4.2,](#page-6-4) notice that *n* attains the upper bound only if $\mu(c) + \mu(3c) = 1$, for all $c \in \mathbb{Z}_4^k$. It is easy to see that any two codes with $\mu(c) + \mu(3c) = 1$, for all $c \in \mathbb{Z}_4^k$, are equivalent. Note that we can replace *C* in Proposition [5.1](#page-9-0) with other equivalent codes.

5.2 An infinite family of two-weight codes

We begin with the following construction.

Theorem 5.2. *Let C be a two-weight linear code of parameters* [*n*, 4*k*¹ 2 *k*2 , *dL*] *with a generator matrix G and nonzero weights* $w_1 < w_2$. Let C_1 *and* C_2 *be two linear codes generated by the* *matrices*

$$
G_1 := \left[\begin{array}{c|c} G & G & G & G \\ \hline 0 & 0 & 0 & 1 & 1 & 1 & 2 & 2 & 3 & 3 & 3 \\ \end{array} \right]
$$
 (6)

and

$$
G_2 := \left[\frac{G}{0 \ 0 \dots 0} \frac{G}{2 \ 2 \dots 2} \right],
$$
 (7)

respectively. Then the following five statements hold:

- *(1) C* is projective if and only if C_1 and C_2 are projective;
- *(2)* $A_{4n}(C_1) = 3|C| + \delta_{n,w_1}A_n(C)$; and $A_{4w}(C_1) = A_w(C)$, for any integer $w \in \{w_1, w_2\}$ − {*n*};
- (3) $A_{2n}(C_2) = |C| + \delta_{n,w_1}A_n(C)$; and $A_{2w}(C_2) = A_w(C)$, for any integer $w \in \{w_1, w_2\}$ − {*n*};
- *(4) C*¹ *and C*² *are two-weight projective codes if and only if C is Plotkin-optimal and projective;*
- *(5) If C is Plotkin-optimal, then* C_1 *and* C_2 *is also Plotkin-optimal.*
- *Proof.* (1) Straightforward from Lemma [4.1.](#page-6-0)
	- (2) For any **c**^{*} ∈ C₁, there exists **x** = $(x_1, x_2, ..., x_{k+1})$ ∈ $\mathbb{Z}_4^{k+1}(k := k_1 + k_2)$ such that $c^* = xG_1$. For any $y = (y_1, y_2, \ldots, y_{k+1}) \in \mathbb{Z}_4^{k+1}$ $_{4}^{k+1}$, let **y**' denote the vector $(y_1, y_2, \ldots, y_k) \in \mathbb{Z}_4^k$. Notice that

$$
w_L(\mathbf{c}^*) = w_L(\mathbf{x}G_1) = \sum_{\mathbf{c} \in \mathbb{Z}_4^{k+1}} \mu(\mathbf{c})w_L(\mathbf{x} \cdot \mathbf{c}) = \sum_{\mathbf{c'} \in \mathbb{Z}_4^k} \mu(\mathbf{c'}) \sum_{c_{k+1}=0}^3 w_L(\mathbf{x'} \cdot \mathbf{c'} + x_{k+1}c_{k+1}).
$$

Note that $\mu(c)$ denotes the multiplicity of c in G_1 for $c \in \mathbb{Z}_4^{k+1}$ and $\mu(c')$ denotes the multiplicity of c' in *G* for $c' \in \mathbb{Z}_4^k$. We obtain the following:

- If $x_{k+1} = 0$, then $w_L(c^*) = 4w_L(x'G)$ where $x'G \in C$.
- If $x_{k+1} \in \{1, 2, 3\}$, then $w_L(c^*) = 4n$.

In this case, $A_{4n}(C_1) = 3|C| + \delta_{n,w_1}A_n(C)$ and $A_{4w}(C_1) = A_w(C)$ for any integer $w \in \{w_1, w_2\} - \{n\}.$

(3) Similar to (2).

(4) If C_1 and C_2 are two-weight projective codes, then C is projective from (1). Suppose that *C* is not Plotkin-optimal. Then $d_L(C) = w_1 < n$. If $w_2 \le n$, then from Lemma [3.2](#page-3-1) we have

$$
|C|n = \sum_{\mathbf{c} \in C} w_L(\mathbf{c}) < (|C| - 1)n,
$$

which is impossible. Thus, $w_2 > n$. From (2) and (3), we have $A_{4w} > 0$ and $A_{2w} > 0$ for $w \in \{w_1, n, w_2\}$. Hence, C_1 and C_2 are not two-weight codes, a contradiction. Therefore, *C* must be Plotkin-optimal.

If *C* is Plotkin-optimal and projective, then from (1) , C_1 and C_2 are projective. More-over, by Corollary [4.4,](#page-6-3) we have $w_1 = n$ and $w_2 = \frac{|C|}{2}$ $\frac{C_1}{2}$. From (2) and (3), we conclude that the nonzero weights of C_1 must be $4n$, $2|C|$ and the nonzero weights of C_2 must be $2n$, $|C|$. Therefore, C_1 and C_2 are two-weight codes.

(5) Straightforward from (2), (3), (4), and Corollary [4.4.](#page-6-3)

We can apply the construction method as mentioned in Theorem [5.2](#page-10-0) finitely many times to obtain families of two-weight codes.

Theorem 5.3. *Let C be a Plotkin-optimal two-weight projective code over* **Z**⁴ *with parameters* [*n*, 4*k*¹ 2 *k*2 , *n*] *and nonzero Lee weights m*, *n*. *Let a*, *b be nonnegative integers, not both are zero. Then there exists a Plotkin-optimal two-weight projective code C*′ *over* **Z**⁴ *with parame*ters $[4^a 2^b n, 4^{k_1+a} 2^{k_2+b}, 4^a 2^b n]$. Moreover, $w_1 = 4^a 2^b m$, $w_2 = 4^a 2^b n$ and $A_{w_1}(C') = A_m(C)$, $A_{w_2}(C') = 4^{k_1 + a}2^{k_2 + b} - 1 - A_m(C).$

Proof. Let *G* be the generator matrix of *C* (in a standard form). Consider a linear code *C* ′ over **Z**⁴ with a generator matrix *G* ′ whose columns consist of all distinct nonzero vectors

$$
(c_1, \ldots, c_{k_1+k_2}, c_{k_1+k_2+1}, \ldots, c_{k_1+k_2+a}, c_{k_1+k_2+a+1}, \ldots, c_{k_1+k_2+a+b})^T
$$
,

where $(c_1, \ldots, c_{k_1+k_2})^T$ is a column of *G*, $c_i \in \mathbb{Z}_4$, for $i \in [k_1+k_2+1, k_1+k_2+a]_{\mathbb{Z}}$, and $c_i \in 2\mathbb{Z}_4$, for $i \in [k_1 + k_2 + a + 1, k_1 + k_2 + a + b]$.

The result follows by applying Theorem [5.2](#page-10-0) $a + b$ times.

As an illustration of Theorem [5.3,](#page-12-0) let us consider the example below.

Example 5.4. Following the notation in Theorem [5.3,](#page-12-0) let $a = 1$ and $b = 2$. If C is a Plotkinoptimal two-weight projective code with parameters $[n, 4^{k_1}2^{k_2}, n]$ generated by a matrix *G*, then by Theorem [5.2\(](#page-10-0)4), the linear code C_1 with generator matrix

$$
G_1 = \left[\begin{array}{c|c} G & G & G & G \\ \hline 0 & 0 & 0 & 1 & 1 & 1 & 2 & 2 & 3 & 3 & 3 \\ \end{array} \right]
$$

 \Box

 \Box

is a Plotkin-optimal two-weight projective code with parameters $[4n, 4^{k_1+1}2^{k_2}, 4n]$ and nonzero Lee weights $4m$, $4n$. Moreover, by Theorem [5.2\(](#page-10-0)2), $A_{4m}(C_1) = A_m(C)$ and $A_{4n}(C_1) =$ $3|C| + \delta_{n,n}A_n(C) = 3|C| + A_n(C) = 4|C| - 1 - A_m(C) = 4^{k_1+1}2^{k_2} - 1 - A_m(C).$

Next, notice that the linear code C' over \mathbb{Z}_4 with a generator matrix G' whose columns consist of all distinct nonzero vectors

$$
(c_1, \ldots, c_{k_1+k_2}, c_{k_1+k_2+1}, c_{k_1+k_2+2}, c_{k_1+k_2+3})^T
$$

 $\text{where } (c_1, \ldots, c_{k_1+k_2})^T \text{ is a column of } G, c_{k_1+k_2+1} \in \mathbb{Z}_4, \text{ and } c_{k_1+k_2+2}, c_{k_1+k_2+3} \in 2\mathbb{Z}_4 \text{ is }$ permutation-equivalent to the linear code C_2 with generator matrix

From Theorem [5.2\(](#page-10-0)4), we conclude that C' is a Plotkin-optimal two-weight projective code with parameters $[16n, 4^{k_1+1}2^{k_2+2}, 16n]$ and nonzero Lee weights $16m$, 16*n*. Moreover, by applying Theorem [5.2\(](#page-10-0)3) twice, we have $A_{16m}(C') = A_{16m}(C_2) = A_{4m}(C_1) = A_m(C)$ and $A_{16n}(C') = A_{16n}(C_2) = |C_2| - 1 - A_{16m}(C_2) = 2^2|C_1| - 1 - A_m(C) = 4^{k_1+1}2^{k_2+2} - 1 A_m(C)$, as desired.

Remark 3. The family of two-weight codes in [\[15,](#page-16-1) Theorem 4.2] is a special case of The-orem [5.3](#page-12-0) when *C* is the linear code generated by Y_{k_1} , $a = 0$, and $b = k_2$. The family of two-weight codes in [\[15,](#page-16-1) Corollary 4.5] is a special case of Theorem [5.3](#page-12-0) when *C* is the linear code generated by Y_{k_1-1} , $a=1$, and $b=k_2$.

Finally, we provide a general family of two-weight codes, which includes all twoweight codes in two families constructed by Shi et al. [\[15\]](#page-16-1).

Theorem 5.5. Let k_1, k_2 be nonnegative integers such that $2k_1 + k_2 \geq 2$. Then for any integer *t with* $1 \leq t \leq k_1$, there exists a two-weight projective code with parameters $[n, 4^{k_1}2^{k_2}$, $d_L]$ ω here $n=d_L=2^{2k_1+k_2-1}-2^{2k_1+k_2-t-1}.$ Moreover, the nonzero weights of the code are $w_1=0$ $2^{2k_1+k_2-1}-2^{2k_1+k_2-t-1}$ and $w_2=2^{2k_1+k_2-1}$, with $A_{w_1}=2^{2k_1+k_2}-2^t$ and $A_{w_2}=2^t-1$.

Proof. By applying Theorem [5.3](#page-12-0) with $a = k_1 - t$, $b = k_2$ on the linear code C generated by Y_t (the parameters of this code are given in Proposition [5.1\)](#page-9-0), we get the desired result. \Box

The Theorem [5.5](#page-13-0) above proves the existence of Plotkin-optimal two-weight projective codes over \mathbb{Z}_4 with the same parameters and weight distribution as the codes in Theorem [4.6](#page-7-1) for any $1 \le t \le k_1$.

Remark 4. If C is a linear code over \mathbb{Z}_4 with a generator matrix G whose columns consist of all distinct nonzero vectors

$$
(c_1, \ldots, c_t, c_{t+1}, \ldots, c_{k_1}, c_{k_1+1}, \ldots, c_{k_1+k_2})^T
$$
,

where $(c_1, \ldots, c_t)^T$ is a column of Y_t , $c_i \in \mathbb{Z}_4$, for $i \in [t+1, k_1]_{\mathbb{Z}}$, and $c_i \in 2\mathbb{Z}_4$, for $i \in [k_1 + 1, k_1 + k_2]$ _Z, then we can completely determine the linearity of $\Phi(C)$. It is easy to check that $\Phi(C)$ is not linear for $1 \leq t < k_1 - 1$ from [\[5,](#page-15-7) Theorem 5]. The linearity of $\Phi(C)$ for $t = k_1 - 1$ and $t = k_1$ have been completely determined in [\[15,](#page-16-1) Theorem 5.8] and [\[15,](#page-16-1) Theorem 5.6], respectively.

6 Concluding remarks

We constructed a general family of two-weight projective codes over \mathbb{Z}_4 . Our result generalized the previous results, mainly from [\[15\]](#page-16-1). We also obtained all possible parameters and weight distributions of Plotkin-optimal two-Lee weight projective codes over **Z**4. However, the number of non-equivalent codes for some fixed parameters and weight distribution is still unknown, which is interesting to investigate further.

Although the two-weight projective codes obtained here are all Plotkin-optimal, it is not the case that all two-weight projective codes over **Z**⁴ are Plotkin-optimal. As an example, consider the linear code *C* with generator matrix *G* as follows:

$$
G = \begin{bmatrix} 1 & 0 & 0 & 3 & 3 & 3 & 2 & 0 & 0 & 3 & 1 & 2 & 3 & 3 \\ 0 & 1 & 0 & 2 & 1 & 3 & 0 & 1 & 3 & 2 & 0 & 1 & 1 & 1 \\ 0 & 0 & 1 & 2 & 2 & 2 & 3 & 1 & 1 & 1 & 1 & 2 & 1 & 3 \end{bmatrix}.
$$

C is a linear code with parameters $[14, 4^32^0, 12]$. The code *C* is a two-weight code with nonzero weights $w_1 = 12$, $w_2 = 16$ and weight distribution $A_{w_1} = 28$, $A_{w_2} = 35$. It can be checked that $d_L(C^{\perp}) = 3$, and hence *C* is a projective code. However, $d_L(C) = 12 <$ $\frac{4^3}{2}$ $\left\lfloor \frac{4^3}{4^3-1} 14 \right\rfloor = 14$, and hence C is not Plotkin-optimal. Moreover, the Gray image of this code has the same parameters and distribution as some two-weight binary linear codes of type SU2 (see Figure 1a and Figure 2a in [\[2\]](#page-15-4)). So far, we have found a family of non-Plotkin-optimal two-weight projective codes over **Z**⁴ of this type. It is interesting to find all possible parameters and weight distributions of two-weight linear projective codes over **Z**⁴ of this type and we are now working on that direction.
