

Incidence matrices for the class \mathcal{O}_6 of lines external to the twisted cubic in $\text{PG}(3, q)$ *

Abstract. We consider the structures of the plane-line and point-line incidence matrices of the projective space $\text{PG}(3, q)$ connected with orbits of planes, points, and lines under the stabilizer group of the twisted cubic. In the literature, lines are partitioned into classes, each of which is a union of line orbits. In this paper, for all q , even and odd, we determine the incidence matrices connected with a family of orbits of the class named \mathcal{O}_6 . This class contains lines external to the twisted cubic. The considered family include an essential part of all \mathcal{O}_6 orbits, whose complete classification is an open problem.

1 Introduction

Let \mathbb{F}_q be the Galois field with q elements, $\mathbb{F}_q^* = \mathbb{F}_q \setminus \{0\}$, $\mathbb{F}_q^+ = \mathbb{F}_q \cup \{\infty\}$.

In the N -dimensional projective space $\text{PG}(N, q)$ over \mathbb{F}_q , an n -arc is a set of n points such that no $N + 1$ points belong to the same hyperplane.

In $\text{PG}(N, q)$ a normal rational curve is any $(q + 1)$ -arc projectively equivalent to the point set $\{(t^N, t^{N-1}, \dots, t^2, t, 1) | t \in \mathbb{F}_q^+\}$, named *twisted cubic* for $N = 3$; see [26].

The twisted cubic has many interesting properties and is connected with distinct combinatorial and applied problems, which led this curve to be widely studied, see for instance [4, 6, 7, 9–11, 23, 26, 29, 32] and the references therein.

Of particular interest is to consider the action of the stabilizer group $G_q \cong \text{PGL}(2, q)$ of the twisted cubic on points, lines, planes of $\text{PG}(3, q)$ and the determination of their related incidence matrices. The investigations, based on the known classification of the point and plane orbits of G_q given in [26], were started by D. Bartoli and the present authors in 2020 [2]: the point-plane incidence matrix is determined and applied in coding theory obtaining optimal multiple covering codes. The results in [2] are also useful to classify the cosets of the $[q + 1, q - 3, 5]_q$ 3 generalized doubly-extended Reed-Solomon code of codimension 4 through their weight distributions [17].

For the study of plane-line and point-line incidence matrices a description of line orbits under G_q is useful. In [26], a partition of the lines in $\text{PG}(3, q)$ into classes is given, each of which is a union of line orbits under G_q . In [15, 16, 20] we have determined both the number and the structure of the orbits forming those unions, apart from one class denoted by \mathcal{O}_6 , containing lines external to the twisted cubic that are not its chords or axes and do not lie in its osculating planes. Basing on the results of [15, 16, 20], in [14, 18, 19] the plane-line and point-line incidence matrices connected with orbits of all line classes apart from \mathcal{O}_6 were obtained. For \mathcal{O}_6 some average and cumulative values are calculated.

The above results have attracted attention, and motivated some investigation using different techniques in [3, 24] and in the recent paper [8]. In particular, in [3] (for all $q \geq 23$) and in [24] (for finite fields of characteristic > 3) line orbits (without those from \mathcal{O}_6) are obtained by other methods than in [15, 16, 20]. Also, in [24] incidence matrices connected with the described line orbits are given. In [8], for even $q = 2^n$, $n \geq 3$ the $(q + 1)$ -arc $\mathcal{A} = \{(1, t, t^{2^h}, t^{2^{h+1}}) | t \in \mathbb{F}_q^+\} \subset \text{PG}(3, q)$ with $\text{gcd}(n, h) = 1$ (it is the twisted cubic for $h = 1$), has been considered; it is shown that the orbits of points and of planes under the projective stabilizer G_h of \mathcal{A} are similar to those under G_1 described in [26]; moreover, the point-plane incidence matrix with respect to G_h -orbits mirrors the case $h=1$ described in [2]. In [8], it is also proved that for even q , $q \equiv \xi \pmod{3}$, $\xi \in \{1, -1\}$, G_h has $2q + 7 + \xi$ orbits on lines, providing a proof of a conjecture of ours [15, 20, Conjecture 8.2] in the case even q . Also, in [8], the point-line incidence matrix for even q is given.

The class \mathcal{O}_6 is the most complicated since the number of orbits it contains depends on q , whereas the remaining seven classes contain at most three orbits.

Recently, for all even and odd q , we have determined a family \mathcal{F} of orbits of this class \mathcal{O}_6 ; see [21]. The orbits of the family depend on a parameter running over \mathbb{F}_q^* . Also, there is once more special orbit with another description. The family \mathcal{F} includes an essential part of all \mathcal{O}_6 orbits, whose complete classification remains an open problem.

In this paper, using the properties of the family \mathcal{F} from [21], we determine all the incidence matrices connected with \mathcal{F} and the special orbit. For plane-line incidence matrices we obtain the numbers of distinct planes through distinct lines and, conversely,

the numbers of distinct lines lying in distinct planes. (By “distinct planes” we mean “planes from distinct orbits”, and similarly for points and lines.) For point-line incidence matrices we obtain the numbers of distinct lines through distinct points and, vice versa, the numbers of distinct points lying on distinct lines. To obtain the needed numbers we prove relations connecting them based on the general properties of \mathcal{O}_6 , see Section 3. Then, using the properties of \mathcal{F} , we consider intersections of lines generating orbits of \mathcal{F} with distinct lines and planes. This gives rise to some cubic and quartic equations, the numbers of solutions of which is equal to parameters of the incidence matrices, see Sections 4, 5. Formulas for the numbers of solutions are described.

The incidence submatrices considered in this paper are configurations in the sense of [25], see Definition 2.4 in Section 2.2. They do not contain 2×2 submatrices whose entries are 1. The interest for such matrices is, for example, in the classical Zarankiewicz problem, see [22, 30, 31], or in the construction of low-density parity-check (LDPC) codes, whose corresponding bipartite graph codes are free from the so-called 4-cycles [1, 13, 28].

The paper is organized as follows. Section 2 contains preliminaries, including the description of \mathcal{F} , see Section 2.3. Some useful relations are given in Section 3. The incidence matrices and needed cubic equations for the special orbit are obtained in Section 4. In Section 5, we consider intersections of lines generating orbits of \mathcal{F} given parametrically with distinct lines and planes and form the needed cubic and quartic equations. In Sections 6, 7, and 8, the incidence matrices, respectively, for even q , odd $q \not\equiv 0 \pmod{3}$, and $q \equiv 0 \pmod{3}$, are obtained.

2 Preliminaries

2.1 Twisted cubic

We summarize the results on the twisted cubic of [26] useful in this paper.

Let $\mathbf{P}(x_0, x_1, x_2, x_3)$ be a point of $\text{PG}(3, q)$ with homogeneous coordinates $x_i \in \mathbb{F}_q$. For $t \in \mathbb{F}_q^+$, let $P(t)$ be a point such that

$$P(t) = \mathbf{P}(t^3, t^2, t, 1) \text{ if } t \in \mathbb{F}_q; \quad P(\infty) = \mathbf{P}(1, 0, 0, 0). \quad (2.1)$$

Let $\mathcal{C} \subset \text{PG}(3, q)$ be the *twisted cubic* consisting of $q + 1$ points P_1, \dots, P_{q+1} no four of which are coplanar. We consider \mathcal{C} in the canonical form

$$\mathcal{C} = \{P_1, P_2, \dots, P_{q+1}\} = \{P(t) \mid t \in \mathbb{F}_q^+\}. \quad (2.2)$$

A *chord* of \mathcal{C} is a line through a pair of real points of \mathcal{C} or a pair of complex conjugate points. In the last case it is an *imaginary chord*. If the real points are distinct, it is a *real chord*; if they coincide with each other, it is a *tangent*. Let \mathcal{T}_t be the tangent to \mathcal{C} at

$P(t)$; \mathcal{T}_t has a coordinate vector

$$L_t^{\text{tang}} = (t^4, 2t^3, 3t^2, t^2, -2t, 1), \quad t \in \mathbb{F}_q; \quad L_\infty^{\text{tang}} = (1, 0, 0, 0, 0, 0). \quad (2.3)$$

Let $\pi(c_0, c_1, c_2, c_3) \subset \text{PG}(3, q)$, be the plane with equation

$$c_0x_0 + c_1x_1 + c_2x_2 + c_3x_3 = 0, \quad c_i \in \mathbb{F}_q. \quad (2.4)$$

The *osculating plane* in the point $P(t) \in \mathcal{C}$ is as follows:

$$\pi_{\text{osc}}(t) = \pi(1, -3t, 3t^2, -t^3) \text{ if } t \in \mathbb{F}_q; \quad \pi_{\text{osc}}(\infty) = \pi(0, 0, 0, 1). \quad (2.5)$$

The $q + 1$ osculating planes form the osculating developable Γ to \mathcal{C} , that is a *pencil of planes* for $q \equiv 0 \pmod{3}$ or a *cubic developable* for $q \not\equiv 0 \pmod{3}$.

An *axis* of Γ is a line of $\text{PG}(3, q)$ which is the intersection of a pair of real planes or complex conjugate planes of Γ . In the last case it is an *imaginary axis*. If the real planes are distinct it is a *real axis*; if they coincide with each other, it is a tangent to \mathcal{C} .

For $q \not\equiv 0 \pmod{3}$, the null polarity \mathfrak{A} [27, Sections 2.1.5, 5.3], [26, Theorem 21.1.2] is given by

$$\mathbf{P}(x_0, x_1, x_2, x_3)\mathfrak{A} = \pi(x_3, -3x_2, 3x_1, -x_0). \quad (2.6)$$

Notation 2.1. Throughout the paper, we consider $q \equiv \xi \pmod{3}$ with $\xi \in \{-1, 0, 1\}$. Many values depend on ξ or have sense only for specific ξ . If it is not clear by the context, we note this by remarks. The following notation is used.

G_q	the group of projectivities in $\text{PG}(3, q)$ fixing \mathcal{C} ;

Orbits under G_q :

Remark 2.2. The words “nor an axis” are included to the definition of En Γ -line by the context of [26, Lemma 21.1.4].

The following theorem summarizes the results from [26] useful in this paper.

Theorem 2.3. [26, Chapter 21] *The following properties of the twisted cubic \mathcal{C} of (2.2) hold:*

(i) *The group G_q acts triply transitively on \mathcal{C} ; $G_q \cong PGL(2, q)$ for $q \geq 5$.*

The matrix \mathbf{M} corresponding to a projectivity of G_q has the general form

$$\mathbf{M} = \begin{bmatrix} a^3 & a^2c & ac^2 & c^3 \\ 3a^2b & a^2d + 2abc & bc^2 + 2acd & 3c^2d \\ 3ab^2 & b^2c + 2abd & ad^2 + 2bcd & 3cd^2 \\ b^3 & b^2d & bd^2 & d^3 \end{bmatrix}, \quad a, b, c, d \in \mathbb{F}_q, \quad ad - bc \neq 0. \quad (2.7)$$

(ii) *Under G_q , $q \geq 5$, there are the following five orbits \mathcal{N}_π of planes:*

$$\begin{aligned} \mathcal{N}_1 = \mathcal{N}_\Gamma &= \{\Gamma\text{-planes}\}, \quad \#\mathcal{N}_\Gamma = q + 1; \quad \mathcal{N}_2 = \mathcal{N}_{2_\mathcal{C}} = \{2_\mathcal{C}\text{-planes}\}, \quad \#\mathcal{N}_{2_\mathcal{C}} = q^2 + q; \\ \mathcal{N}_3 = \mathcal{N}_{3_\mathcal{C}} &= \{3_\mathcal{C}\text{-planes}\}, \quad \#\mathcal{N}_{3_\mathcal{C}} = (q^3 - q)/6; \quad \mathcal{N}_4 = \mathcal{N}_{\overline{1_\mathcal{C}}} = \{\overline{1_\mathcal{C}}\text{-planes}\}, \end{aligned}$$

$$\#\mathcal{N}_{\overline{1_\mathcal{E}}} = (q^3 - q)/2; \quad \mathcal{N}_5 = \mathcal{N}_{0_\mathcal{E}} = \{0_\mathcal{E}\text{-planes}\}, \quad \#\mathcal{N}_{0_\mathcal{E}} = (q^3 - q)/3.$$

(iii) For $q \not\equiv 0 \pmod{3}$, there are the following five orbits \mathcal{M}_j of points:

$$\begin{aligned} \mathcal{M}_1 &= \mathcal{M}_\mathcal{E} = \{\mathcal{C}\text{-points}\}, \quad \mathcal{M}_2 = \mathcal{M}_\Gamma = \{\text{T-points}\}, \quad \mathcal{M}_3 = \mathcal{M}_{3_\Gamma} = \{3_\Gamma\text{-points}\}, \\ \mathcal{M}_4 &= \mathcal{M}_{1_\Gamma} = \{1_\Gamma\text{-points}\}, \quad \mathcal{M}_5 = \mathcal{M}_{0_\Gamma} = \{0_\Gamma\text{-points}\}. \\ \text{For } q &\equiv 1 \pmod{3}, \quad \mathcal{M}_{3_\Gamma} \cup \mathcal{M}_{0_\Gamma} = \{\text{RC-points}\}, \quad \mathcal{M}_{1_\Gamma} = \{\text{IC-points}\}; \\ \text{for } q &\equiv -1 \pmod{3}, \quad \mathcal{M}_{3_\Gamma} \cup \mathcal{M}_{0_\Gamma} = \{\text{IC-points}\}, \quad \mathcal{M}_{1_\Gamma} = \{\text{RC-points}\}. \\ \mathcal{M}_j\mathfrak{A} &= \mathcal{N}_j, \quad \#\mathcal{M}_j = \#\mathcal{N}_j, \quad j = 1, \dots, 5; \\ \mathcal{M}_\mathcal{E}\mathfrak{A} &= \mathcal{N}_\Gamma, \quad \mathcal{M}_\Gamma\mathfrak{A} = \mathcal{N}_{2_\mathcal{E}}, \quad \mathcal{M}_{3_\Gamma}\mathfrak{A} = \mathcal{N}_{3_\mathcal{E}}, \quad \mathcal{M}_{1_\Gamma}\mathfrak{A} = \mathcal{N}_{\overline{1_\mathcal{E}}}, \quad \mathcal{M}_{0_\Gamma}\mathfrak{A} = \mathcal{N}_{0_\mathcal{E}}. \end{aligned} \quad (2.8)$$

(iv) For $q \equiv 0 \pmod{3}$, there are the following five orbits \mathcal{M}_j of points:

$$\begin{aligned} \mathcal{M}_1 &= \mathcal{M}_\mathcal{E} = \{\mathcal{C}\text{-points}\}, \quad \mathcal{M}_2 = \mathcal{M}_{(q+1)_\Gamma} = \{(q+1)_\Gamma\text{-points}\}, \\ \#\mathcal{M}_\mathcal{E} &= \#\mathcal{M}_{(q+1)_\Gamma} = q + 1; \quad \mathcal{M}_3 = \mathcal{M}_{\text{TO}} = \{\text{TO-points}\}, \quad \#\mathcal{M}_{\text{TO}} = q^2 - 1; \\ \mathcal{M}_4 &= \mathcal{M}_{\text{RC}} = \{\text{RC-points}\}, \quad \mathcal{M}_5 = \mathcal{M}_{\text{IC}} = \{\text{IC-points}\}, \\ \#\mathcal{M}_{\text{RC}} &= \#\mathcal{M}_{\text{IC}} = (q^3 - q)/2. \end{aligned}$$

(v) The lines of $\text{PG}(3, q)$ can be partitioned into classes called \mathcal{O}_i and $\mathcal{O}'_i = \mathcal{O}_i\mathfrak{A}$, each of which is a union of orbits under G_q . The full list of the classes can be found in [26, Lemma 21.1.4]. In particular, for all q , there is the class $\mathcal{O}_6 = \mathcal{O}_{\text{En}\Gamma} = \{\text{En}\Gamma\text{-lines}\}$, $\#\mathcal{O}_6 = \#\mathcal{O}_{\text{En}\Gamma} = (q^2 - q)(q^2 - 1)$. If $q \not\equiv 0 \pmod{3}$, we have $\mathcal{O}_6 = \mathcal{O}'_6 = \mathcal{O}_6\mathfrak{A}$.

2.2 \mathbf{J}_2 -free matrices and configurations

We denote by $\mathbf{J}_2 = \begin{bmatrix} 1 & 1 \\ 1 & 1 \end{bmatrix}$ the 2×2 matrix consisting of all ones. A 01-matrix not containing the submatrices \mathbf{J}_2 is called a \mathbf{J}_2 -free matrix. Designs $2\text{-(}v, k, 1)$ and configurations are important examples of \mathbf{J}_2 -free matrices.

Definition 2.4. [25] A *configuration* (v_r, b_k) is an incidence structure of v points and b lines such that each line contains k points, each point lies on r lines, and two different points are connected by at most one line. If $v = b$ and, hence, $r = k$, the configuration is symmetric, denoted by v_k .

For an introduction to configurations see [12, 25] and the references therein.

\mathbf{J}_2 -free matrices are known to be of interest, for instance, in the classical Zarankiewicz problem, see [22, 30, 31], but also in a recent application to the low-density parity-check (LDPC) codes, i.e. error correcting codes with a strongly sparse parity check matrix. The absence of the submatrices \mathbf{J}_2 allows to avoid the 4-cycles in the bipartite graphs corresponding to the codes, see e.g. [1, 13, 28] and the references therein.

2.3 The known orbits of $\text{En}\Gamma$ -lines from class $\mathcal{O}_6 = \mathcal{O}_{\text{En}\Gamma}$

In this subsection we give results from [21] useful in this paper.

2.3.1 An orbit $\mathcal{O}_{\mathcal{L}}$

Let Q_β and Q_∞ be the points: $Q_\beta = \mathbf{P}(1, 0, \beta, 1)$, $\beta \in \mathbb{F}_q$; $Q_\infty = \mathbf{P}(0, 0, 1, 0)$. We consider the line $\ell_{\mathcal{L}} = \overline{Q_0 Q_\infty}$ through the points Q_β and Q_∞ . We have

$$\ell_{\mathcal{L}} = \overline{\mathbf{P}(1, 0, 0, 1)\mathbf{P}(0, 0, 1, 0)} = \{\mathbf{P}(0, 0, 1, 0), \mathbf{P}(1, 0, \beta, 1) \mid \beta \in \mathbb{F}_q\}. \quad (2.9)$$

Let $\mathcal{O}_{\mathcal{L}}$ be the orbit of $\ell_{\mathcal{L}}$ under G_q .

Theorem 2.5. [21, Theorem 3.5]

- (i) For $q \not\equiv 0 \pmod{3}$, we have $\mathcal{O}_{\mathcal{L}} \subset \mathcal{O}_6 = \mathcal{O}_{\text{En}\Gamma}$, i.e. the lines of $\mathcal{O}_{\mathcal{L}}$ are $\text{En}\Gamma$ -lines.
- (ii) Let $q \equiv \xi \pmod{3}$. The orbit $\mathcal{O}_{\mathcal{L}}$ has size

$$\#\mathcal{O}_{\mathcal{L}} = \begin{cases} (q^3 - q)/3 & \text{if } \xi = 1, \quad q \text{ is even or } 2 \text{ is a non-cube in } \mathbb{F}_q; \\ (q^3 - q)/12 & \text{if } \xi = 1, \quad q \text{ is odd and } 2 \text{ is a cube in } \mathbb{F}_q; \\ q^3 - q & \text{if } \xi = -1, \quad q \text{ is even}; \\ (q^3 - q)/2 & \text{if } \xi = -1, \quad q \text{ is odd.} \end{cases} \quad (2.10)$$

2.3.2 Orbits \mathcal{O}_μ , $\mu \in \mathbb{F}_q^* \setminus \{1, 1/9\}$

Let $R_{\mu, \gamma}$ be the point:

$$R_{\mu, \gamma} = \mathbf{P}(\gamma, \mu, \gamma, 1), \quad \gamma \in \mathbb{F}_q^+; \quad R_{\mu, 0} = \mathbf{P}(0, \mu, 0, 1), \quad R_{\mu, \infty} = \mathbf{P}(1, 0, 1, 0),$$

$$\mu \in \begin{cases} \mathbb{F}_q^* \setminus \{1\} & \text{if } q \text{ is even or } q \equiv 0 \pmod{3} \\ \mathbb{F}_q^* \setminus \{1, 1/9\} & \text{if } q \text{ is odd and } q \not\equiv 0 \pmod{3} \end{cases}. \quad (2.11)$$

We consider the line $\ell_\mu = \overline{R_{\mu, 0} R_{\mu, \infty}}$ through $R_{\mu, 0}$ and $R_{\mu, \infty}$.

$$\ell_\mu = \overline{\mathbf{P}(0, \mu, 0, 1)\mathbf{P}(1, 0, 1, 0)} = \{\mathbf{P}(\gamma, \mu, \gamma, 1) \mid \gamma \in \mathbb{F}_q^+, \mu \text{ is fixed}\}. \quad (2.12)$$

Let \mathcal{O}_μ be the orbit of ℓ_μ under G_q .

Theorem 2.6. [21, Lemma 4.2, Theorems 3.5, 5.2, 6.3]

- (i) We have $R_{\mu, \gamma} \notin \pi_{\text{osc}}(\infty)$, $\gamma \in \mathbb{F}_q$.
- (ii) For all $q \geq 5$, we have $\mathcal{O}_\mu \subset \mathcal{O}_6 = \mathcal{O}_{\text{En}\Gamma}$, i.e. the lines of \mathcal{O}_μ are $\text{En}\Gamma$ -lines.

(iii) Let $q \equiv \xi \pmod{3}$. Let the condition $\Upsilon_{q,\mu}$ be of the form

$$\Upsilon_{q,\mu} : \mu = -1/3, q \equiv 1 \pmod{12}, 1/3 \text{ is a fourth power.} \quad (2.13)$$

The orbit \mathcal{O}_μ has size

$$\#\mathcal{O}_\mu = \begin{cases} (q^3 - q)/2 & \text{if } q \text{ is even or } \mu \text{ is a non-square in } \mathbb{F}_q; \\ (q^3 - q)/4 & \text{if } \mu \text{ is a square in } \mathbb{F}_q \text{ and } \xi = 0; \\ (q^3 - q)/4 & \text{if } q \text{ is odd, } \mu \text{ is a square in } \mathbb{F}_q, \xi \neq 0, \\ & \Upsilon_{q,\mu} \text{ does not hold;} \\ (q^3 - q)/12 & \text{if } q \text{ is odd, } \xi \neq 0, \Upsilon_{q,\mu} \text{ holds.} \end{cases} \quad (2.14)$$

3 Useful relations

Notation 3.1. In addition to Notation 2.1, for $\pi \in \mathfrak{P}$, $\mathfrak{p} \in \mathfrak{M}$, and an orbit \mathcal{O} of $\text{En}\Gamma$ -lines, the following notation is used:

Π_π	the number of π -planes through a line from the orbit \mathcal{O} ;
Λ_π	the number of lines from the orbit \mathcal{O} in a π -plane;
$\mathbb{P}_\mathfrak{p}$	the number of \mathfrak{p} -points on a line from the orbit \mathcal{O} ;
$\mathbb{L}_\mathfrak{p}$	the number of lines from the orbit \mathcal{O} through a \mathfrak{p} -point.

From now on, when we use the notations and the results of this section, as the line-orbit \mathcal{O} we consider the orbit $\mathcal{O}_\mathcal{L}$ or \mathcal{O}_μ , see Section 2.3.2. The situation will be clear by the context.

Also, from now on, we consider $q \geq 5$.

The following lemma is obvious, see also [18, Lemma 4.1, Corollary 4.2], [19, Lemma 4.1].

Lemma 3.2. (i) *The number of lines from an orbit \mathcal{O} in a plane of an orbit \mathcal{N}_π is the same for all planes of \mathcal{N}_π ; conversely, the number of planes from the orbit \mathcal{N}_π through a line of the orbit \mathcal{O} is the same for all lines of \mathcal{O} .*

(ii) *The number of lines from an orbit \mathcal{O} through a point of an orbit $\mathcal{M}_\mathfrak{p}$ is the same for all points of $\mathcal{M}_\mathfrak{p}$. And, vice versa, the number of points from the orbit $\mathcal{M}_\mathfrak{p}$ on a line of the orbit \mathcal{O} is the same for all lines of \mathcal{O} .*

(iii)

$$\Pi_\pi = \frac{\Lambda_\pi \cdot \#\mathcal{N}_\pi}{\#\mathcal{O}}, \quad \mathbb{P}_\mathfrak{p} = \frac{\mathbb{L}_\mathfrak{p} \cdot \#\mathcal{M}_\mathfrak{p}}{\#\mathcal{O}}; \quad (3.1)$$

$$\Lambda_\pi = \frac{\Pi_\pi \cdot \#\mathcal{O}}{\#\mathcal{N}_\pi}, \quad \mathbb{L}_\mathfrak{p} = \frac{\mathbb{P}_\mathfrak{p} \cdot \#\mathcal{O}}{\#\mathcal{M}_\mathfrak{p}}. \quad (3.2)$$

Let ℓ be a line. Let $\Pi_\pi(\ell)$ be the number of π -planes through ℓ , $\pi \in \mathfrak{P}$. Let $\mathbb{P}_\mathfrak{p}(\ell)$ is the number of \mathfrak{p} -points on ℓ , $\mathfrak{p} \in \mathfrak{M}$.

Lemma 3.3. (i) *For all $q \geq 5$, the union of $q + 1$ Γ -planes and $q^2 + q$ $2_\mathcal{C}$ -planes can be partitioned into $q + 1$ pencils of planes such that each pencil consists of one Γ -plane and q $2_\mathcal{C}$ -planes and the axis of the pencil is a tangent to \mathcal{C} .*

(ii) *For all $q \geq 5$, among $\text{En}\Gamma$ -lines, only lines lying in $2_\mathcal{C}$ -planes can intersect tangents. If $q \not\equiv 0 \pmod{3}$, $\text{En}\Gamma$ -lines lying in $2_\mathcal{C}$ -planes intersect tangents in Γ -points. If $q \equiv 0 \pmod{3}$, $\text{En}\Gamma$ -lines lying in $2_\mathcal{C}$ -planes intersect tangents in TO -points.*

(iii) *Let ℓ be an $\text{En}\Gamma$ -line. Then $\mathbb{P}_\Gamma(\ell) = \Pi_{2_\mathcal{C}}(\ell)$ if $q \not\equiv 0 \pmod{3}$ and $\mathbb{P}_{\text{TO}}(\ell) = \Pi_{2_\mathcal{C}}(\ell)$ if $q \equiv 0 \pmod{3}$.*

Proof. (i) By [19, Table 1], there is one tangent in every $2_\mathcal{C}$ -plane and, conversely, there are q $2_\mathcal{C}$ -planes through each tangent; in addition, there is one tangent in every Γ -plane and, vice versa, there is one Γ -plane through each tangent.

(ii) By definition, an $\text{En}\Gamma$ -line does not belong to a Γ -plane and does not contain a \mathcal{C} -point. Also, we take into account the case (i) and the fact that, for $q \equiv 0 \pmod{3}$, Γ -planes form a pencil whose axis can intersect only lines lying in a Γ -plane.

(iii) We take into account the cases (i) and (ii) and their proofs. Also, by [19, Proposition 5.6], for a real chord \mathcal{RC} and the two Γ -planes in its common points with \mathcal{C} , the following holds: every $2_\mathcal{C}$ -plane through \mathcal{RC} intersects one of these Γ -planes in its tangent and the other in a non-tangent unisecant. The above means that the $2_\mathcal{C}$ -planes through an ℓ_μ -line and the tangents intersecting it complete the set of $2_\mathcal{C}$ -planes containing this line. \square

Proposition 3.4. *For any orbit \mathcal{O} of $\text{En}\Gamma$ -lines the following holds.*

$$\Pi_\Gamma = \Lambda_\Gamma = \mathbb{P}_\mathcal{C} = \mathbb{L}_\mathcal{C} = 0, \text{ for all } q. \quad (3.3)$$

$$\mathbb{P}_\Gamma = \Pi_{2_\mathcal{C}} \text{ if } q \not\equiv 0 \pmod{3}; \mathbb{P}_{\text{TO}} = \Pi_{2_\mathcal{C}} \text{ if } q \equiv 0 \pmod{3}. \quad (3.4)$$

Proof. The assertions follows from the definition of $\text{En}\Gamma$ -lines and Lemmas 3.2, 3.3. \square

For $q \not\equiv 0 \pmod{3}$, we denote $\tilde{\ell} = \ell\mathfrak{A}$ the image of a line $\ell = \overline{P_1P_2}$ such that $\ell\mathfrak{A} = P_1\mathfrak{A} \cap P_2\mathfrak{A}$ where P_1, P_2 are two distinct points of ℓ and $P_1\mathfrak{A}, P_2\mathfrak{A}$ are planes. Obviously, $\ell = \tilde{\ell}\mathfrak{A}$. By Theorem 2.3(iii), including (2.8), we have the following lemma.

Lemma 3.5. *Let $q \not\equiv 0 \pmod{3}$. The following holds:*

$$\Pi_{2_\mathcal{C}}(\tilde{\ell}) = \mathbb{P}_\Gamma(\ell), \Pi_{3_\mathcal{C}}(\tilde{\ell}) = \mathbb{P}_{3_\Gamma}(\ell), \Pi_{\overline{1_\mathcal{C}}}(\tilde{\ell}) = \mathbb{P}_{1_\Gamma}(\ell), \Pi_{0_\mathcal{C}}(\tilde{\ell}) = \mathbb{P}_{0_\Gamma}(\ell).$$

Lemma 3.6. *Let ℓ be an $\text{En}\Gamma$ -line. Let $\tilde{\ell} = \ell\mathfrak{A}$. Then $\ell = \tilde{\ell}\mathfrak{A}$ and*

$$\Pi_{\overline{1_\mathcal{C}}}(\ell) + 2\Pi_{2_\mathcal{C}}(\ell) + 3\Pi_{3_\mathcal{C}}(\ell) = q + 1, \text{ for all } q; \quad (3.5)$$

$$\Pi_{\overline{1_{\mathcal{C}}}}(\tilde{\ell}) + 2\Pi_{2_{\mathcal{C}}}(\tilde{\ell}) + 3\Pi_{3_{\mathcal{C}}}(\tilde{\ell}) = q + 1, \quad q \not\equiv 0 \pmod{3}; \quad (3.6)$$

$$\mathbb{P}_{1_{\Gamma}}(\ell) + 2\mathbb{P}_{\Gamma}(\ell) + 3\mathbb{P}_{3_{\Gamma}}(\ell) = q + 1, \quad q \not\equiv 0 \pmod{3}; \quad (3.7)$$

$$\mathbb{P}_{1_{\Gamma}}(\tilde{\ell}) + 2\mathbb{P}_{\Gamma}(\tilde{\ell}) + 3\mathbb{P}_{3_{\Gamma}}(\tilde{\ell}) = q + 1, \quad q \not\equiv 0 \pmod{3}. \quad (3.8)$$

Proof. As ℓ is external with respect to \mathcal{C} we may use [19, Theorem 4.3]. Then we apply (3.3) and obtain (3.5). As $\tilde{\ell}$ also is an $\text{En}\Gamma$ -line, (3.6) can be obtained similarly.

Then on (3.6) we act by the null-polarity \mathfrak{A} , taking into account that $\ell\mathfrak{A}\mathfrak{A} = \ell$ and applying Lemma 3.5, that implies (3.7). Finally, we act by \mathfrak{A} on (3.5) and obtain (3.8). \square

Proposition 3.7. *For an orbit \mathcal{O} the following holds.*

$$\Pi_{\overline{1_{\mathcal{C}}}} + 2\Pi_{2_{\mathcal{C}}} + 3\Pi_{3_{\mathcal{C}}} = q + 1, \text{ for all } q \quad (3.9)$$

$$\Pi_{0_{\mathcal{C}}} = \Pi_{2_{\mathcal{C}}} + 2\Pi_{3_{\mathcal{C}}}, \text{ for all } q; \quad (3.10)$$

$$\mathbb{P}_{1_{\Gamma}} + 2\mathbb{P}_{\Gamma} + 3\mathbb{P}_{3_{\Gamma}} = q + 1, \quad q \not\equiv 0 \pmod{3}, \quad (3.11)$$

$$\mathbb{P}_{0_{\Gamma}} = \mathbb{P}_{\Gamma} + 2\mathbb{P}_{3_{\Gamma}}, \quad q \not\equiv 0 \pmod{3}. \quad (3.12)$$

Proof. We use (3.3) and Lemma 3.2(i)(ii), that gives (3.9) and (3.11). Then we again apply (3.3) and the facts that there are $q + 1$ planes through a line and $q + 1$ points on a line. This gives (3.10) and (3.12). \square

4 The point-line and plane-line incidence submatrices for the orbit $\mathcal{O}_{\mathcal{L}}$, $q \not\equiv 0 \pmod{3}$

In this section $q \not\equiv 0 \pmod{3}$. We consider the line $\ell_{\mathcal{L}}$ and its orbit $\mathcal{O}_{\mathcal{L}}$, see Section 2.3.1. When we use the notations and the results of Section 3, we take $\mathcal{O}_{\mathcal{L}}$ as the line orbit \mathcal{O} .

Lemma 4.1. *For $q \not\equiv 0 \pmod{3}$, every T-point lies in exactly two osculating planes.*

Proof. The assertion follows from [2, Table 1]. \square

Lemma 4.2. *Let the point $Q_{\beta} = \mathbf{P}(1, 0, \beta, 1)$ lie in an osculating plane $\pi_{\text{osc}}(t)$, $t \in \mathbb{F}_q$. Then the values of β and t satisfy the following cubic equation*

$$F_{\beta}(t) = t^3 - 3\beta t^2 - 1 = 0, \quad \beta, t \in \mathbb{F}_q. \quad (4.1)$$

Proof. By (2.5), $\pi_{\text{osc}}(t) = \boldsymbol{\pi}(1, -3t, 3t^2, -t^3)$, $t \in \mathbb{F}_q$. \square

We denote by \mathbb{V}_m the number of $\beta \in \mathbb{F}_q$ such that the cubic equation $F_{\beta}(t)$ (4.1) has exactly m distinct solutions t in \mathbb{F}_q , $m = 0, 1, 2, 3$.

Lemma 4.3. *For the orbit $\mathcal{O}_{\mathcal{L}}$, the following holds.*

$$\mathbb{P}_T = \mathbb{V}_2 + 1, \mathbb{P}_{1T} = \mathbb{V}_1. \quad (4.2)$$

Proof. By Lemma 4.2, if, for a fixed β , the equation $F_\beta(t)$ (4.1) has exactly m distinct solutions t in \mathbb{F}_q then the point Q_β belongs to exactly m distinct osculating planes. So, the line $\ell_{\mathcal{L}} \setminus \{Q_\infty\}$ contains \mathbb{V}_m points belonging to exactly m distinct osculating planes. In particular, if $m = 2$, they are T-points, see Lemma 4.1.

Also, Q_∞ lies on the tangent to \mathcal{C} at the point $\mathbf{P}(0, 0, 0, 1)$ with equations $x_0 = x_1 = 0$, see [20, Lemma 5.2]. So, Q_∞ is a T-point. \square

Remind that over \mathbb{F}_q , the equation $x^3 = c$ has a unique solution if $q \equiv -1 \pmod{3}$ or three distinct solutions if $q \equiv 1 \pmod{3}$ [27, Section 1.5].

For $a \in \mathbb{F}_q$, the *quadratic character* $\eta(a)$ is equal to 1 (resp. -1) if a is a square (resp. non-square) in \mathbb{F}_q^* . Also, $\eta(0) = 0$. We denote

$$\mathfrak{N}_q \triangleq \#\{\beta \mid \eta(1 + 4\beta^3) = -1, \beta \in \mathbb{F}_q\}.$$

Lemma 4.4. *Let q be odd. Let $q \equiv \xi \pmod{3}$. For the orbit $\mathcal{O}_{\mathcal{L}}$, we have*

- (i) $\mathbb{V}_2 = 1, \mathbb{V}_1 = (q - 1)/2$, if $\xi = -1$;
- (ii) $\mathbb{V}_2 = 0, \mathbb{V}_1 = \mathfrak{N}_q$, if $\xi = 1$, 2 is a non-cube in \mathbb{F}_q ;
- (iii) $\mathbb{V}_2 = 3, \mathbb{V}_1 = \mathfrak{N}_q$, if $\xi = 1$, 2 is a cube in \mathbb{F}_q .

Proof. Let the discriminant Δ and the Hessian $H(T)$ of the equation $F_\beta(t)$ (4.1) be as in [27, Section 1.8, Lemma 1.18, Theorem 1.28]. We have $\Delta = -27(1 + 4\beta^3)$, $H(T) = \beta^2 T^2 + T - \beta = 0$, $\beta \in \mathbb{F}_q$. The roots of $H(T)$ are $T = (-1 \pm \sqrt{1 + 4\beta^3})/2\beta^2$.

For the calculation of \mathbb{V}_m we use [27, Theorem 1.34, Table 1.3].

(i) Let $\Delta = 0$. Then $\beta = \sqrt[3]{-1/4}$ and $F_\beta(t)$ has exactly two distinct roots: $-\beta$ and -2β . This implies $\mathbb{V}_2 = 1$.

Let $\Delta \neq 0$. Then $\beta \neq \sqrt[3]{-1/4}$. If β runs over $\mathbb{F}_q^* \setminus \sqrt[3]{-1/4}$ the value $1 + 4\beta^3$ runs over $\mathbb{F}_q^* \setminus \{1\}$ where there are exactly $(q - 3)/2$ squares for which $H(T)$ has two solutions in \mathbb{F}_q and $F_\beta(t)$ has one solution in \mathbb{F}_q . This gives $\mathbb{V}_1 = (q - 3)/2 + 1$ where “+1” takes into account $\beta = 0$ when $F_\beta(t)$ has the unique root $t = 1$.

(ii) As $-1/4$ is a non-cube in \mathbb{F}_q , always $\Delta \neq 0$ that implies $\mathbb{V}_2 = 0$. If β runs over \mathbb{F}_q^* the value $1 + 4\beta^3$ takes \mathfrak{N}_q non-squares for which $H(T)$ has no solutions in \mathbb{F}_q and $F_\beta(t)$ has exactly one solution in \mathbb{F}_q . Thus, $\mathbb{V}_1 = \mathfrak{N}_q$ as $F_\beta(t)$ has 3 distinct roots if $\beta = 0$.

(iii) Let $\Delta = 0$. Then $\beta = \sqrt[3]{-1/4} = \{\beta_1, \beta_2, \beta_3\}$. For every i , $F_{\beta_i}(t)$ has two distinct roots that gives $\mathbb{V}_2 = 3$. Let $\Delta \neq 0$. Similarly to the case (ii) we obtain $\mathbb{V}_1 = \mathfrak{N}_q$. \square

For even q , let $\text{Tr}_2(a)$ be the absolute trace of $a \in \mathbb{F}_q$. We denote

$$\mathfrak{T}_q \triangleq \#\{\beta \mid \text{Tr}_2(\beta^3) = 1, \beta \in \mathbb{F}_q, q = 2^{2m}\}.$$

By the context of [8, Section 4],

$$\mathfrak{T}_q = 2^{2m-1} + (-2)^m = \frac{1}{2}q + (-1)^m \sqrt{q}, \quad q = 2^{2m}. \quad (4.3)$$

Lemma 4.5. *Let q be even. Let $q \equiv \xi \pmod{3}$. For the orbit $\mathcal{O}_{\mathcal{L}}$, we have*

- (i) $\mathbb{V}_2 = 0, \mathbb{V}_1 = q/2$, if $q = 2^{2m+1}, \xi = -1$;
- (ii) $\mathbb{V}_2 = 0, \mathbb{V}_1 = \mathfrak{T}_q$, if $q = 2^{2m}, \xi = 1$.

Proof. For even q , $F_\beta(t) = t^3 + \beta t^2 + 1 = 0$, $H(T) = \beta^2 T^2 + T + \beta = 0$, $\Delta \neq 0$. The replacement T by T/β^2 implies $\overline{H}(T) \triangleq T^2 + T + \beta^3 = 0$. By [27, Sections 1.2(iv), 1.4], $\overline{H}(T)$ has 2 (resp. 0) roots in \mathbb{F}_q if $\text{Tr}_2(\beta^3) = 0$ (resp. $\text{Tr}_2(\beta^3) = 1$).

For the calculation of \mathbb{V}_m we use [27, Theorem 1.34]. As $\Delta \neq 0$, we have $\mathbb{V}_2 = 0$.

(i) If β runs over \mathbb{F}_q^* then $\text{Tr}_2(\beta^3)$ is equal to 0 $(q-2)/2$ times, $\overline{H}(T)$ (and hence $H(T)$) has two roots in \mathbb{F}_q , and $F_\beta(t)$ has one root in \mathbb{F}_q . So, $\mathbb{V}_1 = (q-2)/2 + 1$ where “+1” takes into account that $F_0(t)$ has one root in \mathbb{F}_q .

(ii) If β runs over \mathbb{F}_q^* then $\text{Tr}_2(\beta^3)$ is equal to 1 \mathfrak{T}_q times, $H(T)$ has no roots in \mathbb{F}_q , and $F_\beta(t)$ has one root in \mathbb{F}_q . So, $\mathbb{V}_1 = \mathfrak{T}_q$ as $F_0(t)$ has 3 distinct roots in \mathbb{F}_q . \square

Lemma 4.6. *Let $q \not\equiv 0 \pmod{3}$. We have $\mathcal{L} = \mathcal{L}\mathfrak{A}$.*

Proof. We have $\mathcal{L}\mathfrak{A} = Q_0\mathfrak{A} \cap Q_\infty\mathfrak{A} = \pi(1, 0, 0, 1) \cap \pi(0, -3, 0, 0)$. One sees that $Q_0, Q_\infty \in \pi(1, 0, 0, 1)$ and $Q_0, Q_\infty \in \pi(0, -3, 0, 0)$; this implies $Q_0, Q_\infty \in \mathcal{L}\mathfrak{A}$. \square

For the point type $\mathfrak{p} \in \{\text{T}, 3_\Gamma, 1_\Gamma, 0_\Gamma\}$, let $\pi(\mathfrak{p})$ be the plane type such that $\mathcal{M}_\mathfrak{p}\mathfrak{A} = \mathcal{N}_{\pi(\mathfrak{p})}$ in accordance to (2.8). We have

$$\pi(\text{T}) = 2_{\mathcal{E}}, \quad \pi(3_\Gamma) = 3_{\mathcal{E}}, \quad \pi(1_\Gamma) = \overline{1}_{\mathcal{E}}, \quad \pi(0_\Gamma) = 0_{\mathcal{E}}. \quad (4.4)$$

Theorem 4.7. *For the submatrices of the point-line and plane-line incidence matrices with respect to the orbit $\mathcal{O}_{\mathcal{L}}$, the values $\mathbb{P}_\mathfrak{p}$, Π_π , $\mathbb{L}_\mathfrak{p}$, and Λ_π (see Notation 3.1), are as in Table 1 and (3.3). In that, $\mathbb{P}_\mathfrak{p} = \Pi_{\pi(\mathfrak{p})}$ and $\mathbb{L}_\mathfrak{p} = \Lambda_{\pi(\mathfrak{p})}$ with $\pi(\mathfrak{p})$ in accordance to (4.4). The sizes of orbits $\#\mathcal{M}_\mathfrak{p} = \#\mathcal{N}_{\pi(\mathfrak{p})}$ are noted in the top of columns.*

Proof. We obtain the values of \mathbb{P}_T and \mathbb{P}_{1_Γ} using (4.3) and Lemmas 4.3–4.5. Then we calculate \mathbb{P}_{3_Γ} by (3.11), \mathbb{P}_{0_Γ} by (3.12), and all $\mathbb{L}_\mathfrak{p}$ by (3.2). To prove $\mathbb{P}_\mathfrak{p} = \Pi_{\pi(\mathfrak{p})}$ and $\mathbb{L}_\mathfrak{p} = \Lambda_{\pi(\mathfrak{p})}$, we use Theorem 2.3(iii) and Lemmas 3.5, 4.6. \square

Example 4.8. Let $q \equiv 1 \pmod{3}$. Let q be odd. By computer search, using the system MAGMA [5], we obtained Table 2 where one can do the following observations. We denote $\delta_q = 2\mathfrak{N}_q - q$. In Table 2, δ_q is odd, $\delta_q \equiv -1 \pmod{3}$. Let $q' \equiv q'' \pmod{9}$; for both q' and q'' 2 is a cube or a non-cube. Then $\delta'_q \equiv \delta''_q \pmod{9}$.

In the bottom part of Table 2 (where 2 is a cube in \mathbb{F}_q) all the values of \mathfrak{N}_q are even providing integer values in Table 1.

5 Connections of lines ℓ_{μ} with Γ -, $2_{\mathcal{C}}$ -, and $\overline{1}_{\mathcal{C}}$ -planes and tangents to cubic \mathcal{C}

Let the line ℓ_{μ} be as in Section 2.3.2, in particular, $\mu \in \mathbb{F}_q^* \setminus \{1, 1/9\}$ that for even q and $q \equiv 0 \pmod{3}$ naturally reduces to $\mu \in \mathbb{F}_q^* \setminus \{1\}$.

5.1 Intersections of lines ℓ_{μ} with osculating planes, $q \not\equiv 0 \pmod{3}$

Lemma 5.1. *Let q be odd, $q \not\equiv 0 \pmod{3}$. Then the point $R_{\mu, \infty} = \mathbf{P}(1, 0, 1, 0)$ is a 1_{Γ} -point if $q \equiv -1 \pmod{3}$ and a 3_{Γ} -point if $q \equiv 1 \pmod{3}$.*

Proof. We have $R_{\mu, \infty} \in \pi_{\text{osc}}(\infty)$ for all q , see (2.5). If $q \equiv -1 \pmod{3}$ then $R_{\mu, \infty} \notin \pi_{\text{osc}}(t)$ with $t \in \mathbb{F}_q$. If $q \equiv 1 \pmod{3}$ then $R_{\mu, \infty} \in \pi_{\text{osc}}(\pm\sqrt{-1/3})$. \square

Lemma 5.2. *Let $q \not\equiv 0 \pmod{3}$. Let $\gamma, t \in \mathbb{F}_q$. Let the point $R_{\mu, \gamma} = \mathbf{P}(\gamma, \mu, \gamma, 1)$ belong to the osculating plane $\pi_{\text{osc}}(t)$. Then the values of μ, γ , and t satisfy the cubic equation*

$$\Phi_{\mu, \gamma}(t) = t^3 - 3\gamma t^2 + 3\mu t - \gamma = 0, \quad \gamma \in \mathbb{F}_q, \quad \mu \in \mathbb{F}_q^* \setminus \left\{1, \frac{1}{9}\right\}, \quad q \not\equiv 0 \pmod{3}. \quad (5.1)$$

Proof. We have $\pi_{\text{osc}}(t) = \pi(1, -3t, 3t^2, -t^3)$, $t \in \mathbb{F}_q$, that implies the assertions. \square

We denote $N_1(\mu)$ the number of $\gamma \in \mathbb{F}_q$, such that the equation $\Phi_{\mu, \gamma}(t)$ (5.1) has exactly one solution t in \mathbb{F}_q .

5.2 Intersections of lines ℓ_μ with tangents to cubic \mathcal{C} ; lines ℓ_μ and $2_{\mathcal{C}}$ -planes

The coordinate vector L_μ of ℓ_μ is $L_\mu = (\mu, 0, 1, -\mu, 0, 1)$. By [26, Section 15.2], (2.3), the mutual invariant of ℓ_μ and a tangent \mathcal{T}_t is:

$$\varpi(\ell_\mu, \mathcal{T}_t) = t^4 - (3\mu - 1)t^2 + \mu, \quad t \in \mathbb{F}_q; \quad \varpi(\ell_\mu, \mathcal{T}_\infty) = 1 \neq 0. \quad (5.2)$$

Two lines intersect if and only if their mutual invariant is equal to zero. Thus, ℓ_μ does not intersect \mathcal{T}_∞ for any μ ; we may consider only intersections with \mathcal{T}_t for $t \in \mathbb{F}_q$.

Let $\mathbf{n}_q(\mu)$ be the number of solutions in \mathbb{F}_q of the equation

$$\varpi(\ell_\mu, \mathcal{T}_t) = t^4 - (3\mu - 1)t^2 + \mu = 0, \quad t \in \mathbb{F}_q. \quad (5.3)$$

Useful results on $\mathbf{n}_q(\mu)$ can be found in [27, Section 1.11]. By above, in particular by Lemma 3.3, Propostion 3.4, and (3.4), the following lemma holds.

Lemma 5.3. *Both the number of T-points on an ℓ_μ -line and the number of $2_{\mathcal{C}}$ -planes containing the line are equal to $\mathbf{n}_q(\mu)$.*

5.3 Line ℓ_μ and $\overline{1_{\mathcal{C}}}$ -planes

We consider the cubic equation regarding t .

$$\tilde{\Phi}_{\mu,c}(t) \triangleq t^3 + ct^2 - t - \mu c = 0, \quad t \in \mathbb{F}_q, \quad c \in \mathbb{F}_q^*, \quad \mu \text{ is as in (2.11)}. \quad (5.4)$$

We denote $\tilde{N}_1(\mu)$ the number of $c \in \mathbb{F}_q^*$ such that the equation $\tilde{\Phi}_{\mu,c}(t)$ (5.4) has exactly one solution t in \mathbb{F}_q .

Lemma 5.4. *The number of $\overline{1_{\mathcal{C}}}$ -planes containing a line ℓ_μ is equal to $\tilde{N}_1(\mu)$ if μ is a square in \mathbb{F}_q and $\tilde{N}_1(\mu) + 1$ otherwise.*

Proof. Let $\tilde{\pi} = \boldsymbol{\pi}(c_0, c_1, c_2, c_3)$ be a plane containing ℓ_μ . As $R_{\mu,0}, R_{\mu,\infty} \in \tilde{\pi}$, we have $\tilde{\pi} = \boldsymbol{\pi}(c_0, c_1, -c_0, -\mu c_1)$.

Let $c_0 = 0$. Then $c_1 \neq 0$, $\tilde{\pi} = \boldsymbol{\pi}(0, 1, 0, -\mu)$, $P(\infty) \in \tilde{\pi}$. For $t \in \mathbb{F}_q$, $P(t) \in \tilde{\pi}$ if $t^2 = \mu$. So, $\tilde{\pi}$ is a $\overline{1_{\mathcal{C}}}$ (resp. $3_{\mathcal{C}}$)-plane if μ is a non-square (resp. square) in \mathbb{F}_q .

Let $c_1 = 0$. Then $c_0 \neq 0$, $\tilde{\pi} = \boldsymbol{\pi}(1, 0, -1, 0)$, $P(\infty) \notin \tilde{\pi}$. For $t \in \mathbb{F}_q$, $P(t) \in \tilde{\pi}$ if $t^3 = t$. So, $\tilde{\pi}$ is a $3_{\mathcal{C}}$ -plane.

Let $c_0, c_1 \neq 0$. Then $\tilde{\pi} = \boldsymbol{\pi}(1, c, -1, -\mu c)$, $c = c_1/c_0 \in \mathbb{F}_q^*$, $P(\infty) \notin \tilde{\pi}$. The point $P(t)$ of \mathcal{C} , $t \in \mathbb{F}_q$, lies in $\tilde{\pi}$ if and only if t satisfies $\tilde{\Phi}_{\mu,c}(t)$ (5.4). If $\tilde{\Phi}_{\mu,c}(t)$ has exactly one solution t in \mathbb{F}_q then $\tilde{\pi}$ contains exactly one point $P(t)$, i.e. $\tilde{\pi}$ is a $\overline{1_{\mathcal{C}}}$ -plane. \square

6 Point-line and plane-line incidence submatrices for orbits \mathcal{O}_μ , even q

In this section we assume that q is even. This implies the natural simplification of some elements of Sections 2.3.2 and 5. For even q we have $\mu \in \mathbb{F}_q^* \setminus \{1\}$ and

$$\varpi(\ell_\mu, \mathcal{T}_t) = t^4 + (\mu + 1)t^2 + \mu; \quad (6.1)$$

$$\Phi_{\mu,\gamma}(t) = t^3 + \gamma t^2 + \mu t + \gamma = 0, \quad \tilde{\Phi}_{\mu,c}(t) = t^3 + ct^2 + t + \mu c = 0. \quad (6.2)$$

6.1 Incidence submatrices

Lemma 6.1. *Let $q \geq 8$ be even. The points $R_{\mu,\infty}$ and $R_{\mu,0}$ lie on the tangents \mathcal{T}_1 and $\mathcal{T}_{\sqrt{\mu}}$, respectively. No other point of ℓ_μ is a T-point, i.e. for all orbits generated by the lines ℓ_μ we have $\mathbb{P}_T = 2$.*

Proof. We use the equations of the corresponding tangents given in [15, Lemma 6.2], [20, Lemma 5.2]. Also, by (6.1), the equation $\varpi(\ell_\mu, \mathcal{T}_t) = 0$ has exactly two solutions $t = 1$ and $t = \sqrt{\mu}$. By (5.2), ℓ_μ does not intersect \mathcal{T}_∞ . Finally, we use Lemma 3.2(ii). \square

Lemma 6.2. *Let q be even. For the orbits \mathcal{O}_μ the following holds.*

$$\mathbb{P}_T = \Pi_{2_\ell} = 2, \quad \mathbb{P}_{1_\Gamma} = \mathbb{N}_1(\mu); \quad \Pi_{1_\ell} = \tilde{\mathbb{N}}_1(\mu). \quad (6.3)$$

Proof. By Lemma 5.2, for a fixed γ , if the equation $\Phi_{\mu,\gamma}(t)$ (5.1) (see also (6.2)) has exactly m distinct solutions in \mathbb{F}_q then the point $R_{\mu,\gamma}$ belongs to exactly m distinct osculating planes. Also we use (3.4), Lemmas 5.4, 6.1. \square

Theorem 6.3. *Let q be even. For the submatrices of the point-line and plane-line incidence matrices with respect to the orbit \mathcal{O}_μ , the values \mathbb{P}_p , \mathbb{L}_p and Π_π , Λ_π (see Notation 3.1), are as in Tables 3 and 4, respectively; see also Proposition 3.4. The sizes of orbits $\#\mathcal{M}_p$ and $\#\mathcal{N}_\pi$ are noted in the top of columns.*

Proof. For \mathcal{O}_μ , we obtain the values of \mathbb{P}_T and \mathbb{P}_{1_Γ} using (6.3). Then we calculate \mathbb{P}_{3_Γ} by (3.11) and \mathbb{P}_{0_Γ} by (3.12). Finally, we obtain all \mathbb{L}_p by (3.2). This gives Table 3.

We obtain Π_{2_ℓ} and Π_{1_ℓ} by (6.3), calculate Π_{3_ℓ} by (3.9), Π_{0_ℓ} by (3.10), and all Λ_π by (3.2). This gives Table 4. \square

6.2 Obtaining of $\mathbb{N}_1(\mu)$ and $\tilde{\mathbb{N}}_1(\mu)$ for equations $\Phi_{\mu,\gamma}(t)$ and $\tilde{\Phi}_{\mu,c}(t)$ of (6.2)

By [27, Section 1.8] the invariants δ and $\tilde{\delta}$ of $\Phi_{\mu,\gamma}(t)$ and $\tilde{\Phi}_{\mu,c}(t)$ of (6.2) are, respectively,

$$\delta_{\mu,\gamma} = \frac{\mu^3 + \gamma^4}{\gamma^2(\mu + 1)^2} + \frac{1}{\mu + 1}, \quad \tilde{\delta}_{\mu,c} = \frac{1 + \mu c^4}{c^2(\mu + 1)^2} + \frac{\mu}{\mu + 1}, \quad \gamma, c \in \mathbb{F}_q^*. \quad (6.4)$$

Lemma 6.4. *Let q be even. Let $\text{Tr}_2(a)$ be the absolute trace of an element a of \mathbb{F}_q . Then*

$$\mathbb{N}_1(\mu) = \#\{\gamma \mid \text{Tr}_2(\delta_{\mu,\gamma}) = 1, \gamma \in \mathbb{F}_q^*\}; \quad \tilde{\mathbb{N}}_1(\mu) = \#\{c \mid \text{Tr}_2(\tilde{\delta}_{\mu,c}) = 1, c \in \mathbb{F}_q^*\}. \quad (6.5)$$

Proof. We use [27, Corollary 1.15(ii)]. □

Example 6.5. In Table 5, for even q , we give the values of $\mathbb{N}_1(\mu)$ and $\tilde{\mathbb{N}}_1(\mu)$, obtained by the system MAGMA. By \mathcal{N} we denote the number of μ providing the given values. Table 5 allows us to do the following interesting observations:

- Let $q = 2^{2m}$, i.e. $q \equiv 1 \pmod{3}$. Then $\mathbb{N}_1(\mu) = \tilde{\mathbb{N}}_1(\mu)$. The values of $\mathbb{N}_1(\mu)$ form an arithmetic progression with difference 3 and the first term $q/2 - \Delta$, $\Delta \equiv 1 \pmod{3}$.
- Let $q = 2^{2m+1}$, i.e. $q \equiv -1 \pmod{3}$. Then the set $\{(\mathbb{N}_1(\mu), \tilde{\mathbb{N}}_1(\mu)) \mid \mu \in \mathbb{F}_q^* \setminus \{1\}\}$ is partitioned into pairs of the form $(\mathbb{N}_1(\mu), \tilde{\mathbb{N}}_1(\mu)) = (a, b)$ and $(\mathbb{N}_1(\mu), \tilde{\mathbb{N}}_1(\mu)) = (b, a)$ where (a, b) forms the series $(q/2 + 1, q/2 - 2)$, $(q/2 + 4, q/2 - 5)$, $(q/2 + 7, q/2 - 8)$... $(q/2 + A, q/2 - A - 1)$, $A = 3 \cdot 2^{m-1} - 2$. The number \mathcal{N} of μ providing each pair is divided by $2m + 1$.

7 Point-line and plane-line incidence submatrices for orbits \mathcal{O}_λ for odd $q \not\equiv 0 \pmod{3}$

In this section q is odd and $q \not\equiv 0 \pmod{3}$. By (5.3), it can be shown

$$\mathbf{n}_q(\mu) = \# \left\{ t \mid t = \pm \sqrt{\frac{1}{2} \left(3\mu - 1 \pm \sqrt{(\mu-1)(9\mu-1)} \right)}, t \in \mathbb{F}_q \right\} \in \{0, 2, 4\}. \quad (7.1)$$

7.1 Incidence submatrices

Lemma 7.1. *Let q be odd, $q \not\equiv 0 \pmod{3}$. For the orbit \mathcal{O}_μ we have*

$$\begin{aligned} \mathbb{P}_T &= \Pi_{2\mathcal{C}} = \mathbf{n}_q(\mu) \text{ for all } q, \mu; \\ \mathbb{P}_{1_T} &= \mathbb{N}_1(\mu) + 1 \text{ if } q \equiv -1 \pmod{3}, \mathbb{P}_{1_T} = \mathbb{N}_1(\mu) \text{ if } q \equiv 1 \pmod{3}; \\ \Pi_{\overline{1\mathcal{C}}} &= \tilde{\mathbb{N}}_1(\mu) \text{ if } \mu \text{ is a square in } \mathbb{F}_q, \Pi_{\overline{1\mathcal{C}}} = \tilde{\mathbb{N}}_1(\mu) + 1 \text{ otherwise.} \end{aligned} \quad (7.2)$$

Proof. By Lemma 5.2, for a fixed $\gamma \in \mathbb{F}_q$, if $\Phi_{\mu,\gamma}(t)$ (5.1) has exactly one solution t in \mathbb{F}_q then the point $R_{\mu,\gamma}$ belongs to exactly one osculating plane. So, the set $\ell_\mu \setminus \{R_{\mu,\infty}\}$ contains $\mathbb{N}_1(\mu)$ points belonging to exactly one osculating plane. Then, using Lemmas 5.1 and 5.3 we obtain \mathbb{P}_{1_T} and $\mathbb{P}_T = \Pi_{2\mathcal{C}}$. Finally, by Lemmas 3.2 and 5.4, we obtain $\Pi_{\overline{1\mathcal{C}}}$. \square

Theorem 7.2. *Let q be odd, $q \not\equiv 0 \pmod{3}$. For the submatrices of the point-line and plane-line incidence matrices with respect to the orbit \mathcal{O}_μ , the values $\mathbb{P}_\mathfrak{p}$, $\mathbb{L}_\mathfrak{p}$ and Π_π , Λ_π (see Notation 3.1), are as in Tables 6 and 7, respectively; see also Proposition 3.4. The sizes of orbits $\#\mathcal{M}_\mathfrak{p}$ and $\#\mathcal{N}_\pi$ are noted in the top of columns.*

Proof. For \mathcal{O}_μ , we obtain the values of $\mathbb{P}_\mathbb{T}$ and $\mathbb{P}_{1\Gamma}$ using (7.2). Then we calculate $\mathbb{P}_{3\Gamma}$ by (3.11) and $\mathbb{P}_{0\Gamma}$ by (3.12). Finally, we obtain all $\mathbb{L}_\mathfrak{p}$ by (3.2). This gives Table 6.

Then we obtain $\Pi_{2\mathcal{E}}$, $\Pi_{1\mathcal{E}}$ by (7.2), calculate $\Pi_{3\mathcal{E}}$ by (3.9), $\Pi_{0\mathcal{E}}$ by (3.10), and all Λ_π by (3.2). This gives Table 7. \square

7.2 Obtaining of $\mathbb{N}_1(\mu)$ and $\tilde{\mathbb{N}}_1(\mu)$ for equations $\Phi_{\mu,\gamma}(t)$ (5.1) and $\tilde{\Phi}_{\mu,c}(t)$ (5.4)

For $\Phi_{\mu,\gamma}(t)$ (5.1), the discriminant $\Delta_{\mu,\gamma}$ and the coefficients A_i of the Hessian $H(T) = A_0T^2 + A_1T + A_2$, considered in [27, Section 1.8, equation (1.14), Lemma 1.18, Theorem

1.28, Proof of Lemma 1.32], are as follows:

$$\begin{aligned} \Delta_{\mu,\gamma} &= 27(3\gamma^2\mu^2 - 4\mu^3 - 4\gamma^4 - \gamma^2 + 6\mu\gamma^2); \\ A_0 &= 9(\mu - \gamma^2), \quad A_1 = 9\gamma(\mu - 1), \quad A_1^2 - 4A_0A_2 = -3\Delta_{\mu,\gamma}. \end{aligned} \quad (7.3)$$

For $\tilde{\Phi}_{\mu,c}(t)$ (5.4), the corresponding objects $\tilde{\Delta}_{\mu,c}$ and \tilde{A}_i have the form

$$\begin{aligned} \tilde{\Delta}_{\mu,c} &= c^2 + 4 + 4\mu c^4 - 27\mu^2 c^2 + 18\mu c^2; \\ \tilde{A}_0 &= -(3 + c^2), \quad \tilde{A}_1 = c(1 - 9\mu); \quad \tilde{A}_1^2 - 4\tilde{A}_0\tilde{A}_2 = -3\tilde{\Delta}_{\mu,c}. \end{aligned} \quad (7.4)$$

Lemma 7.3. *Let q be odd. Let $q \equiv \xi \pmod{3}$, $\xi \neq 0$. Let the quadratic character η be as in Section 4. Then the number of $\gamma \in \mathbb{F}_q$ and $c \in \mathbb{F}_q^*$ such that the equations $\Phi_{\mu,\gamma}(t)$ (5.1) and $\tilde{\Phi}_{\mu,c}(t)$ (5.4) have exactly one solution in \mathbb{F}_q is:*

$$\mathbb{N}_1(\mu) = \#\{\gamma \mid \gamma \in \mathbb{F}_q, \eta(-3\Delta_{\mu,\gamma}) = -\xi\}, \quad (7.5)$$

$$\tilde{\mathbb{N}}_1(\mu) = \#\{c \mid c \in \mathbb{F}_q^*, \eta(-3\tilde{\Delta}_{\mu,c}) = -\xi\}. \quad (7.6)$$

Proof. We take $\Delta_{\mu,\gamma}$ and A_i from (7.3). By [27, Corollary 1.30], for $\Delta_{\mu,\gamma} = 0$, $\Phi_{\mu,\gamma}(t)$ has one root in \mathbb{F}_q if all $A_i = 0$. But $A_0 \neq 0$ if $\gamma = 0$ and $A_1 \neq 0$ if $\gamma \neq 0$. By [27, Theorem 1.34, Table 1.3], for $\Delta_{\mu,\gamma} \neq 0$, $\Phi_{\mu,\gamma}(t)$ has exactly one root in \mathbb{F}_q , if $H(T)$ has 2 or 0 roots in \mathbb{F}_q according to $q \equiv -1 \pmod{3}$ or $q \equiv 1 \pmod{3}$, respectively. By (7.3), $H(T)$ has 2 roots in \mathbb{F}_q (resp. 0 roots) if and only if $-3\Delta_{\mu,\gamma}$ is a non-zero square (resp. non-square). This proves (7.5).

The assertion (7.6) for $\tilde{\mathbb{N}}_1(\mu)$ can be proved similarly. \square

Example 7.4. In Table 8, for odd $q \not\equiv 0 \pmod{3}$, we give the values of $\mathbf{n}_q(\mu)$, $\mathbb{N}_1(\mu)$, and $\tilde{\mathbb{N}}_1(\mu)$, obtained by the system MAGMA. By \mathcal{N} we denote the number of μ providing the given values. Table 8 allows us to do the following interesting observations:

- $\mathbf{n}_q(\mu) \in \{0, 2\}$ if $\eta(\mu) = -1$; $\mathbf{n}_q(\mu) \in \{0, 4\}$ if $\eta(\mu) = 1$.
- $\mathbb{N}_1(\mu) - \tilde{\mathbb{N}}_1(\mu) = 1$ if $q \equiv 1 \pmod{3}$ and $\eta(\mu) = -1$.
- $\mathbb{N}_1(\mu) = \tilde{\mathbb{N}}_1(\mu)$ if $q \equiv 1 \pmod{3}$ and $\eta(\mu) = 1$.
- Let $q \equiv -1 \pmod{3}$, $\eta(\mu) = -1$. Then there are cases $\mathbb{N}_1(\mu) = \tilde{\mathbb{N}}_1(\mu)$ and also pairs of the form $(\mathbb{N}_1(\mu), \tilde{\mathbb{N}}_1(\mu)) = (a, b)$ and $(\mathbb{N}_1(\mu), \tilde{\mathbb{N}}_1(\mu)) = (b, a)$.
- For $q' \equiv q'' \pmod{12}$, relations between $\mathbb{N}_1(\mu)$ and $\tilde{\mathbb{N}}_1(\mu)$ are similar.

8 Point-line and plane-line incidence submatrices for orbits \mathcal{O}_λ , $q \equiv 0 \pmod{3}$

In this section $q \equiv 0 \pmod{3}$. This implies the natural simplification of some elements of Sections 2.3.2 and 5. For $q \equiv 0 \pmod{3}$ we have $\mu \in \mathbb{F}_q^* \setminus \{1\}$ and

$$\begin{aligned} \varpi(\ell_\mu, \mathcal{T}_t) &= t^4 + t^2 + \mu, t \in \mathbb{F}_q; \quad \varpi(\ell_\mu, \mathcal{T}_t) = 0 \text{ if } t = \pm\sqrt{1 \pm \sqrt{1 - \mu}}; & (8.1) \\ \mathbf{n}_q(\mu) &= \# \left\{ t \mid t = \pm\sqrt{1 \pm \sqrt{1 - \mu}}, t \in \mathbb{F}_q \right\} \in \{0, 2, 4\}. \end{aligned}$$

8.1 Incidence submatrices

Lemma 8.1. *Let $q \equiv 0 \pmod{3}$. For an orbit \mathcal{O}_μ , (3.9) and (3.10) hold. Also, we have*

$$(i) \quad \mathbb{P}_{(q+1)\Gamma} = 0, \quad \mathbb{P}_{\text{TO}} = \mathbf{n}_q(\mu); \quad (8.2)$$

$$(ii) \quad \Pi_{\overline{1\mathcal{E}}} = \mathbb{P}_{\text{IC}}; \quad (8.3)$$

$$(iii) \quad \Pi_{\overline{1\mathcal{E}}} = \tilde{\mathbb{N}}_1(\mu) \text{ if } \mu \text{ is a square in } \mathbb{F}_q, \quad \Pi_{\overline{1\mathcal{E}}} = \tilde{\mathbb{N}}_1(\mu) + 1 \text{ otherwise.} \quad (8.4)$$

Proof. (i) An $\text{En}\Gamma$ -line does not lie in any osculating plane, therefore it does not intersect the axis of the pencil of the osculating planes. See also Proposition 3.4 and Lemmas 3.3, 5.3.

(ii) The assertion follows from [19, Table 1, Theorem 3.3(vi)] and [18, Remark 3, (4.13)].

(iii) The assertion follows from Lemmas 3.2, 5.4. □

Theorem 8.2. *Let $q \equiv 0 \pmod{3}$. For the submatrices of the point-line and plane-line incidence matrices with respect to the orbit \mathcal{O}_μ , the values $\mathbb{P}_\mathfrak{p}$, $\mathbb{L}_\mathfrak{p}$ and Π_π , Λ_π (see Notation 3.1), are as in Tables 9 and 10, respectively; see also Proposition 3.4 and Lemma 8.1. The sizes of orbits $\#\mathcal{M}_\mathfrak{p}$ and $\#\mathcal{N}_{\pi(\mathfrak{p})}$ are noted in the top of columns.*

Proof. For \mathcal{O}_μ , we obtain the values of \mathbb{P}_{TO} , Π_{2_ℓ} , $\Pi_{\overline{1_\ell}}$, and \mathbb{P}_{IC} , using Proposition 3.4 and Lemma 8.1. Then we calculate $\mathbb{P}_{\text{RC}} = q + 1 - \mathbb{P}_{\text{TO}} - \mathbb{P}_{\text{IC}}$, Π_{3_ℓ} by (3.9), and Π_{0_ℓ} by (3.10). Finally, we obtain all $\mathbb{L}_\mathfrak{p}$ and Λ_π by (3.2). \square

8.2 Obtaining of $\tilde{\mathbb{N}}_1(\mu)$ for equation $\tilde{\Phi}_{\mu,c}(t)$ (5.4)

Lemma 8.3. *Let the quadratic character η be as in Section 4. For $\tilde{\mathbb{N}}_1(\mu)$ we have*

$$\tilde{\mathbb{N}}_1(\mu) = \# \left\{ c \mid \eta \left(\frac{c^4}{\mu c^4 + c^2 + 1} \right) = -1, c \in \mathbb{F}_q^*, \mu c^4 + c^2 + 1 \neq 0 \right\}. \quad (8.5)$$

Proof. We use the results of [27, Corollary 1.23, Section 1.10, p. 25]. We put $\alpha = -c^{-1}$, make the variable substitution $t = x + \alpha$ in $\tilde{\Phi}_{\mu,c}(t)$ and obtain $f(x) = x^3 + cx^2 + d = 0$ where $d = \tilde{\Phi}_{\mu,c}(\alpha) = -(\mu c^4 + c^2 + 1)/c^3$. If $d = 0$ then α is a double root of $\tilde{\Phi}_{\mu,c}(t)$. If $d \neq 0$ then, by [27, p. 25], $f(x)$ has exactly one root in \mathbb{F}_q if $-c/d$ is a non-square in \mathbb{F}_q . \square

Example 8.4. In Table 11, for $q \equiv 0 \pmod{3}$, we give the values of $\mathbf{n}_q(\mu)$ and $\tilde{\mathbb{N}}_1(\mu)$ obtained by the system MAGMA. By \mathcal{N} we denote the number of μ providing the given values. Similarly to Example 6.5, we observe here that $\mathbf{n}_q(\mu) \in \{0, 2\}$ if $\eta(\mu) = -1$; $\mathbf{n}_q(\mu) \in \{0, 4\}$ if $\eta(\mu) = 1$.
