Learning a Neuron by a Shallow ReLU Network: Dynamics and Implicit Bias for Correlated Inputs

Abstract

We prove that, for the fundamental regression task of learning a single neuron, training a onehidden layer ReLU network of any width by gradient flow from a small initialisation converges to zero loss and is implicitly biased to minimise the rank of network parameters. By assuming that the training points are correlated with the teacher neuron, we complement previous work that considered orthogonal datasets. Our results are based on a detailed non-asymptotic analysis of the dynamics of each hidden neuron throughout the training. We also show and characterise a surprising distinction in this setting between interpolator networks of minimal rank and those of minimal Euclidean norm. Finally we perform a range of numerical experiments, which corroborate our theoretical findings.

1 Introduction

One of the grand challenges for machine learning research is to understand how overparameterised neural networks are able to fit perfectly the training examples and simultaneously to generalise well to unseen data [\[Zhang, Bengio, Hardt, Recht, and Vinyals,](#page-13-0) [2021\]](#page-13-0). The double-descent phenomenon [\[Belkin,](#page-11-0) [Hsu, Ma, and Mandal,](#page-11-0) [2019\]](#page-11-0), where increasing the neural network capacity beyond the interpolation threshold can eventually reduce the test loss much further than could be achieved around the underparameterised "sweet spot", is a mystery from the standpoint of classical machine learning theory. This has been observed to happen even for training without explicit regularisers.

Implicit bias of gradient-based algorithms. A key hypothesis towards explaining the double-descent phenomenon is that the gradient-based algorithms that are used for training are *implicitly biased* (or *implicitly regularised*) [\[Neyshabur, Bhojanapalli, McAllester, and Srebro,](#page-12-0) [2017\]](#page-12-0) to converge to solutions that in addition to fitting the training examples have certain properties which cause them to generalise well. It has attracted much attention in recent years from the research community, which has made substantial progress in uncovering implicit biases of training algorithms in many important settings [\[Vardi,](#page-13-1) [2023\]](#page-13-1). For example, for classification tasks, and for homogeneous networks (which is a wide class that includes ReLU networks provided they contain neither biases at levels deeper than the first nor residual connections), [Lyu and Li](#page-12-1) [\[2020\]](#page-12-1) and [Ji and Telgarsky](#page-12-2) [\[2020\]](#page-12-2) established that gradient flow is biased towards maximising the classification margin in parameter space, in the sense that once the training loss

gets sufficiently small, the direction of the parameters subsequently converges to a Karush-Kuhn-Tucker point of the margin maximisation problem.

Insights gained in this foundational research direction have not only shed light on overparameterised generalisation, but have been applied to tackle other central problems, such as the susceptibility of networks trained by gradient-based algorithms to adversarial examples [\[Vardi, Yehudai, and Shamir,](#page-13-2) [2022\]](#page-13-2) and the possibility of extracting training data from network parameters [\[Haim, Vardi, Yehudai,](#page-12-3) [Shamir, and Irani,](#page-12-3) [2022\]](#page-12-3).

Regression tasks and initialisation scale. Showing the implicit bias for regression tasks, where the loss function is commonly mean square, has turned out to be more challenging than for classification tasks, where loss functions typically have exponential tails. A major difference is that, whereas most of the results for classification do not depend on how the network parameters are initialised, the scale of the initialisation has been observed to affect decisively the implicit bias of gradient-based algorithms for regression [\[Woodworth, Gunasekar, Lee, Moroshko, Savarese, Golan, Soudry, and Srebro,](#page-13-3) [2020\]](#page-13-3). When it is large so that the training follows the *lazy regime*, we tend to have fast convergence to a global minimum of the loss, however without an implicit bias towards sparsity and with limited generalisation [Jacot, Ged, Şimşek, Hongler, and Gabriel, [2021\]](#page-12-4). The focus, albeit at the price of uncertain convergence and lengthier training, has therefore been on the *rich regime* where the initialisation scale is small.

Considerable advances have been achieved for linear networks. For example, [Azulay, Moroshko,](#page-11-1) [Nacson, Woodworth, Srebro, Globerson, and Soudry](#page-11-1) [\[2021\]](#page-11-1) and [Yun, Krishnan, and Mobahi](#page-13-4) [\[2021\]](#page-13-4) proved that gradient flow is biased to minimise the Euclidean norm of the predictor for one-hidden layer linear networks with infinitesimally small initialisation, and that the same holds also for deeper linear networks under an additional assumption on their initialisation. A related extensive line of work is on implicit bias of gradient-based algorithms for matrix factorisation and reconstruction, which has been a fruitful test-bed for regression using multi-layer networks. For example, [Gunasekar, Woodworth,](#page-12-5) [Bhojanapalli, Neyshabur, and Srebro](#page-12-5) [\[2017\]](#page-12-5) proved that, under a commutativity restriction and starting from a small initialisation, gradient flow is biased to minimise the nuclear norm of the solution matrix; they also conjectured that the restriction can be dropped, which after a number of subsequent works was refuted by [Li, Luo, and Lyu](#page-12-6) [\[2021\]](#page-12-6), leading to a detailed analysis of both underparameterised and overparameterised regimes by [Jin, Li, Lyu, Du, and Lee](#page-12-7) [\[2023\]](#page-12-7).

For non-linear networks, such as those with the popular ReLU activation, progress has been difficult. Indeed, [Vardi and Shamir](#page-13-5) [\[2021\]](#page-13-5) showed that precisely characterising the implicit bias via a non-trivial regularisation function is impossible already for single-neuron one-hidden layer ReLU networks, and [Timor, Vardi, and Shamir](#page-13-6) [\[2023\]](#page-13-6) showed that gradient flow is not biased towards low-rank parameter matrices for multiple-output ReLU networks already with one hidden layer and small training datasets.

ReLU networks and training dynamics. We suggest that, in order to further substantially our knowledge of convergence, implicit bias, and generalisation for regression tasks using non-linear networks, we need to understand more thoroughly the dynamics throughout the gradient-based training. This is because of the observed strong influence that initialisation has on solutions, but is challenging due to the highly non-convex optimisation landscape. To this end, evidence and intuition were provided by [Maennel, Bousquet, and Gelly](#page-12-8) [\[2018\]](#page-12-8), [Li et al.](#page-12-6) [\[2021\]](#page-12-6), and [Jacot et al.](#page-12-4) [\[2021\]](#page-12-4), who conjectured that, from sufficiently small initialisations, after an initial phase where the neurons get aligned to a number of directions that depend only on the dataset, training causes the parameters to pass close to a sequence of saddle points, during which their rank increases gradually but stays low.

The first comprehensive analysis in this vein was accomplished by [Boursier, Pillaud-Vivien, and](#page-11-2) [Flammarion](#page-11-2) [\[2022\]](#page-11-2), who focused on orthogonal datasets (which are therefore of cardinality less than or equal to the input dimension), and established that, for one-hidden layer ReLU networks, gradient flow from an infinitesimal initialisation converges to zero loss and is implicitly biased to minimise the Euclidean norm of the network parameters. They also showed that, per sign class of the training labels (positive or negative), minimising the Euclidean norm of the interpolator networks coincides with minimising their rank.

Our contributions. We tackle the main challenge posed by [Boursier et al.](#page-11-2) [\[2022\]](#page-11-2), namely handling datasets that are not orthogonal. A major obstacle to doing so is that, whereas the analysis of the training dynamics in the orthogonal case made extensive use of an almost complete separation between a turning phase and a growth phase for all hidden neurons, non-orthogonal datasets cause considerably more complex dynamics in which hidden neurons follow training trajectories that simultaneously evolve their directions and norms [\[Boursier et al.,](#page-11-2) [2022,](#page-11-2) Appendix A].

To analyse this involved dynamics in a reasonably clean setting, we consider the training of one-hidden layer ReLU networks by gradient flow from a small balanced initialisation on datasets that are labelled by a teacher ReLU neuron with which all the training points are correlated. More precisely, we assume that the angles between the training points and the teacher neuron are less than $\pi/4$, which implies that all angles between training points are less than $\pi/2$. The latter restriction has featured per label class in many works in the literature (such as by [Phuong and Lampert](#page-13-7) [\[2021\]](#page-13-7) and [Wang and Pilanci](#page-13-8) [\[2022\]](#page-13-8)), and the former is satisfied for example if the training points can be obtained by summing the teacher neuron v^* with arbitrary vectors of length less than $||v^*||/\sqrt{2}$. All our other assumptions are very mild, either satisfied with probability exponentially close to 1 by any standard random initialisation, or excluding corner cases of Lebesgue measure zero.

Our contributions can be summarised as follows.

- We provide a detailed **non-asymptotic analysis** of the dynamics of each hidden neuron throughout the training, and show that it applies whenever the initialisation scale λ is below a **precise bound** which is polynomial in the network width m and exponential in the training dataset cardinality n . Moreover, our analysis applies for any input dimension $d > 1$, for any $n \geq d$ (otherwise exact learning of the teacher neuron may not be possible), for any m , and without assuming any specific random distribution for the initialisation. In particular, we demonstrate that the role of the overparameterisation in this setting is to ensure that initially at least one hidden neuron with a positive last-layer weight has in its active half-space at least one training point.
- We show that, during a first phase of the training, all active hidden neurons with a positive last-layer weight **get aligned** to a single direction which is positively correlated with all training points, whereas all active hidden neurons with a negative last-layer weight get turned away from all training points so that they deactivate. In contrast to the orthogonal dataset case where the sets of training points that are in the active half-spaces of the neurons are essentially constant during the training, in our correlated setting this first phase in general consists, for each neuron, of a different **sequence of stages** during which the cardinality of the set of training points in its active half-space gradually increases or decreases, respectively.
- We show that, during the rest of the training, the bundle of aligned hidden neurons with their last-layer weights, formed by the end of the first phase, grows and turns as it travels from near the origin to near the teacher neuron, and **does not separate**. To establish the latter property, which is the most involved part of this work, we identify a set in predictor space that depends only on λ and the training dataset, and prove: first, that the trajectory of the bundle **stays inside the set**; and second, that this implies that the directional gradients of the individual neurons are such that the angles between them are non-increasing.
- We prove that, after the training departs from the initial saddle, which takes time logarithmic in λ and linear in d , the gradient satisfies a Polyak-Łojasiewicz inequality and consequently the loss **converges to zero exponentially fast**.
- We prove that, although for any fixed λ the angles in the bundle of active hidden neurons do not

in general converge to zero as the training time tends to infinity, if we let λ tend to zero then the networks to which the training converges have a limit: a network of rank 1, in which all non-zero hidden neurons are positive scalings of the teacher neuron and have positive last-layer weights. This establishes that gradient flow from an infinitesimal initialisation is **implicitly biased** to select interpolator networks of **minimal rank**. Note also that the limit network is identical in predictor space to the teacher neuron.

- We show that, surprisingly, among all networks with zero loss, there may exist some whose Euclidean norm is smaller than that of any network of rank 1. Moreover, we prove that this is the case if and only if a certain condition on angles determined by the training dataset is satisfied. This result might be seen as **refuting the conjecture** of [Boursier et al.](#page-11-2) [\[2022,](#page-11-2) section 3.2] that the implicit bias to minimise Euclidean parameter norm holds beyond the orthogonal setting, and adding some weight to the hypothesis of [Razin and Cohen](#page-13-9) [\[2020\]](#page-13-9). The counterexample networks in our proof have rank 2 and make essential use of the ReLU non-linearity.
- We perform numerical experiments that indicate that the training dynamics and the implicit bias we theoretically established occur in practical settings in which some of our assumptions are relaxed. In particular, gradient flow is replaced by gradient descent with a realistic learning rate, the initialisation scales are small but not nearly as small as in the theory, and the angles between the teacher neuron and the training points are distributed around $\pi/4$.

We further discuss related work, prove all theoretical results, and provide additional material on our experiments, in the appendix.

2 Preliminaries

Notation. We write: $[n]$ for the set $\{1, \ldots, n\}$, $||v||$ for the Euclidean length of a vector $v, \overline{v} := v/||v||$ for the normalised vector, $\angle(v, v') \coloneqq \arccos(\overline{v}^\top \overline{v}')$ for the angle between v and v', and $\cos\{v_1, \ldots, v_n\} \coloneqq$ $\{\sum_{i=1}^n \beta_i \mathbf{v}_i \mid \beta_1, \dots, \beta_n \geq 0\}$ for the cone generated by vectors $\mathbf{v}_1, \dots, \mathbf{v}_n$.

One-hidden layer ReLU network. For an input $x \in \mathbb{R}^d$, the output of the network is

$$
h_{\theta}(\boldsymbol{x}) \coloneqq \sum_{j=1}^{m} a_j \,\sigma(\boldsymbol{w}_j^{\top}\boldsymbol{x})\;,
$$

where m is the width, the parameters $\bm{\theta} = (\bm{a}, \bm{W}) \in \mathbb{R}^m \times \mathbb{R}^{m \times d}$ consist of last-layer weights $\bm{a} =$ $[a_1, \ldots, a_m]$ and hidden-layer weights $\boldsymbol{W}^\top = [\boldsymbol{w}_1, \ldots, \boldsymbol{w}_m]$, and $\sigma(u) \coloneqq \max\{u, 0\}$ is the ReLU function.

Balanced initialisation. For all $j \in [m]$ let

$$
\boldsymbol{w}_j^0\coloneqq \lambda\,\boldsymbol{z}_j \qquad \qquad a_j^0\coloneqq s_j\|\boldsymbol{w}_j^0\|
$$

where $\lambda > 0$ is the initialisation scale, $\boldsymbol{z}_j \in \mathbb{R}^d \setminus \{\boldsymbol{0}\}$, and $s_j \in \{\pm 1\}$.

A precise upper bound on λ will be stated in [Assumption 2.](#page-6-0)

We regard the initial unscaled hidden-layer weights z_j and last-layer signs s_j as given, without assuming any specific random distributions for them. For example, we might have that each z_j consists of *d* independent centred Gaussians with variance $\frac{1}{d m}$ and each s_j is uniform over $\{\pm 1\}$.

We consider only initialisations for which the layers are balanced, i.e. $|a_j^0| = \|w_j^0\|$ for all $j \in [m]$. Since more generally each difference $(a_j^t)^2 - ||\boldsymbol{w}_j^t||^2$ is constant throughout training [\[Du, Hu, and Lee,](#page-11-3) [2018,](#page-11-3) Theorem 2.1] and we focus on small initialisation scales that tend to zero, this restriction (which is also present in [Boursier et al.](#page-11-2) [\[2022\]](#page-11-2)) is minor but simplifies our analysis.

Neuron-labelled correlated inputs. The teacher neuron $v^* \in \mathbb{R}^d$ and the training dataset $\{(x_i, y_i)\}_{i=1}^n \subseteq$ $(\mathbb{R}^d \setminus \{\mathbf{0}\}) \times \mathbb{R}$ are such that for all *i* we have

$$
y_i = \sigma({\bm{v}^*}^\top {\bm{x}}_i) \qquad \qquad \measuredangle({\bm{v}^*},{\bm{x}}_i) < \pi/4 \; .
$$

In particular, since the angles between \bm{v}^* and the training points \bm{x}_i are acute, each label y_i is positive.

To apply our results to a network with biases in the hidden layer and to a teacher neuron with a bias, one can work in dimension $d + 1$ and extend the training points to $\begin{bmatrix} x_i \\ 1 \end{bmatrix}$.

Mean square loss gradient flow. For the regression task of learning the teacher neuron by the onehidden layer ReLU network, we use the standard mean square empirical loss

$$
L(\boldsymbol{\theta}) \coloneqq \frac{1}{2n} \sum_{i=1}^n (y_i - h_{\boldsymbol{\theta}}(\boldsymbol{x}_i))^2.
$$

Our theoretical analysis concentrates on training by gradient flow, which from an initialisation as above evolves the network parameters by descending along the gradient of the loss by infinitesimal steps in continuous time [\[Li, Tai, and E,](#page-12-9) [2019\]](#page-12-9). Formally, we consider any parameter trajectory $\boldsymbol{\theta}^t$: $[0,\infty) \to$ $\mathbb{R}^m\times\mathbb{R}^{m\times d}$ that is absolutely continuous on every compact subinterval, and that satisfies the differential inclusion

$$
\mathrm{d}\boldsymbol{\theta}^{t}/\mathrm{d}t\in-\partial L(\boldsymbol{\theta}^{t})\quad\text{for almost all }t\in[0,\infty)\;,
$$

where ∂L denotes the [Clarke](#page-11-4) [\[1975\]](#page-11-4) subdifferential of the loss function (which is locally Lipschitz).

We work with the Clarke subdifferential, which is a generalisation of the gradient, because the ReLU activation is not differentiable at 0, which causes non-differentiability of the loss function [\[Bolte,](#page-11-5) [Daniilidis, Ley, and Mazet,](#page-11-5) [2010\]](#page-11-5). Although it follows from our results that, in our setting, the derivative of the ReLU can be fixed as $\sigma'(0) \coloneqq 0$ like in the orthogonal case [\[Boursier et al.,](#page-11-2) [2022,](#page-11-2) Appendix D], and the gradient flow trajectories are uniquely defined, that is not a priori clear; hence we work with the unrestricted Clarke subdifferential of the ReLU. We also remark that, in other settings, $\sigma'(0)$ cannot be fixed in this way due to gradient flow subtrajectories that correspond to gradient descent zig-zagging along a ReLU boundary (cf. e.g. [Maennel et al.](#page-12-8) [\[2018,](#page-12-8) section 9.4]).

Basic observations. We establish the formulas for the derivatives of the last-layer weights and the hidden neurons; and that throughout the training, the signs of the last-layer weights do not change, and their absolute values track the norms of the corresponding hidden neurons. The latter property holds for all times t by continuity and enables us to focus the analysis on the hidden neurons.

Proposition 1. *For all* $j \in [m]$ *and almost all* $t \in [0, \infty)$ *we have:*

(i) ${\rm d} a_j^t/{\rm d} t = {\boldsymbol w}_j^t{}^\top \boldsymbol g_j^t$ and ${\rm d} {\boldsymbol w}_j^t/{\rm d} t = a_j^t\, \boldsymbol g_j^t$, where $\boldsymbol g_j^t \in \frac{1}{n} {\sum_{i=1}^n} (y_i - h_{\boldsymbol \theta^t}(\boldsymbol x_i))\, \partial \sigma ({\boldsymbol w}_j^t{}^\top \boldsymbol x_i)\, {\boldsymbol x}_i$; (*ii*) $a_j^t = s_j ||\boldsymbol{w}_j^t|| \neq 0.$

The definition in part [\(i\)](#page-4-0) of the vectors g_j^t that govern the dynamics is a membership because the subdifferential of the ReLU at 0 is the set of all values between 0 and 1, i.e. $\partial \sigma(0) = [0, 1]$.

3 Assumptions

To state our assumptions precisely, we introduce some additional notation. Let

$$
I_{+}(\boldsymbol{v}) := \{i \in [n] \, | \, \boldsymbol{v}^{\top} \boldsymbol{x}_{i} > 0\} \qquad I_{0}(\boldsymbol{v}) := \{i \in [n] \, | \, \boldsymbol{v}^{\top} \boldsymbol{x}_{i} = 0\} \qquad I_{-}(\boldsymbol{v}) := \{i \in [n] \, | \, \boldsymbol{v}^{\top} \boldsymbol{x}_{i} < 0\}
$$

denote the sets of indices of training points that are, respectively, either inside or on the boundary or outside of the non-negative half-space of a vector v . Then let

$$
J_+ := \{ j \in [m] \mid I_+(z_j) \neq \emptyset \land s_j = +1 \} \qquad J_- := \{ j \in [m] \mid I_+(z_j) \neq \emptyset \land s_j = -1 \}
$$

be the sets of indices of hidden neurons that are initially active on at least one training point and whose last-layer signs are, respectively, positive or negative. Also let

$$
\boldsymbol{X} \coloneqq [\boldsymbol{x}_1, \dots, \boldsymbol{x}_n] \hspace{2cm} \boldsymbol{\gamma}_I \coloneqq \tfrac{1}{n} {\textstyle \sum}_{i \in I} y_i \boldsymbol{x}_i
$$

denote the matrix whose columns are all the training points, and the sum of all training points whose indices are in a set I , weighted by the corresponding labels and divided by n .

Moreover we define, for each $j\in J_+\cup J_-$, a continuous trajectory $\boldsymbol{\alpha}_j^t$ in \mathbb{R}^d by

$$
\alpha_j^0 \coloneqq z_j \qquad \qquad \mathrm{d}\alpha_j^t/\mathrm{d}t \coloneqq s_j \|\alpha_j^t\| \, \gamma_{I_+(\alpha_j^t)} \quad \text{for all } t \in (0,\infty) \; .
$$

Thus, starting from the unscaled initialisation z_j of the corresponding hidden neuron, α_j^t follows a dynamics obtained from that of w_j^t in [Proposition 1](#page-4-1) [\(i\)](#page-4-0) and [\(ii\)](#page-4-2) by replacing the vector g_j^t by $\gamma_{I+(\alpha_j^t)}$ which amounts to removing from \boldsymbol{g}_j^t the network output terms and the activation boundary summands. These trajectories will be useful as *yardsticks* in our analysis of the first phase of the training.

Assumption 1. *(i)* $d > 1$, $\text{span}\{x_1, ..., x_n\} = \mathbb{R}^d$, and $||v^*|| = 1$.

- (*ii*) $J_+ \neq \emptyset$, $I_0(z_j) = \emptyset$ *for all* $j \in [m]$, and $\measuredangle(z_j, \gamma_{[n]}) > 0$ *for all* $j \in J_-$ *.*
- (iii) $\overline{x}_1,\ldots,\overline{x}_n$ are distinct, the eigenvalues of $\frac{1}{n}XX^\top$ are distinct, and v^* does not belong to a span of fewer than d eigenvectors of $\frac{1}{n}\boldsymbol{X}\boldsymbol{X}^\top$.
- (iv) $|I_0(\boldsymbol{\alpha}^t_j)| \leq 1$ *for all* $j \in J_+ \cup J_-$ *and all* $t \in [0, \infty)$ *.*
- (v) For all $j \in [m]$ and all $0 \leq T < T'$, if for all $t \in (T, T')$ we have $I_+(\boldsymbol{w}_j^t) = I_0(\boldsymbol{w}_j^{T'}) \neq \emptyset$ and $I_0(\bm{w}_j^t)=I_{+}(\bm{w}_j^{T'})=\emptyset$, then for all $t\geq T'$ we have $\bm{w}_j^t=\bm{w}_j^{T'}.$

This assumption is very mild. Part [\(i\)](#page-5-0) excludes the trivial univariate case without biases (for univariate inputs with biases one needs $d = 2$, ensures that exact learning is possible, and fixes the length of the teacher neuron to streamline the presentation. Part [\(ii\)](#page-5-1) assumes that, initially: at least one hidden neuron with a positive last-layer weight has in its active half-space at least one training point, no training point is at a ReLU boundary, and no hidden neuron with a negative last-layer weight is perfectly aligned with the $\gamma_{[n]}$ vector; this holds with probability at least $1-(3/4)^m$ for any continuous symmetric distribution of the unscaled hidden-neuron initialisations, e.g. $z_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{N}(0, \frac{1}{d_m} I_d)$, and the uniform distribution of the last-layer signs s_j i.i.d. $U{\{\pm 1\}}$. Parts [\(iii\)](#page-5-2) and [\(iv\)](#page-5-3) exclude corner cases of Lebesgue measure zero;
checked bet V^T is positive definite and that (iv) welse out a variatiely trainatory encountains two observe that $\frac{1}{n}XX^\top$ is positive-definite, and that [\(iv\)](#page-5-3) rules out a yardstick trajectory encountering two or more training points in its half-space boundary at exactly the same time. Part (v) excludes some unrealistic gradient flows that might otherwise be possible due to the use of the subdifferential: it specifies that, whenever a neuron deactivates (i.e. all training points exit its positive half-space), then it stays deactivated for the remainder of the training.

Before our next assumption, we define several further quantities. Let $\eta_1 > \cdots > \eta_d > 0$ denote the eigenvalues of $\frac{1}{n}XX^\top$, and let u_1,\dots,u_d denote the corresponding unit-length eigenvectors such that $\bm{v}^* = \sum_{k=1}^d \nu_k^* \bm{u}_k$ for some $\nu_1^*, \ldots, \nu_d^* > 0$. Also, for each $j \in J_+ \cup J_-$, let $n_j \coloneqq |I_{-s_j}(\bm{z}_j)|$ be the number of training points that should enter into or exit from the non-negative half-space along the trajectory α_j^t depending on whether the sign s_j is positive or negative (respectively), and let

$$
\varphi_j^t \coloneqq \measuredangle(\boldsymbol{\alpha}_j^t,\boldsymbol{\gamma}_{I+(\boldsymbol{\alpha}_j^t)}) \quad \text{for all } t \in [0,\infty) \text{ such that } I_{+}(\boldsymbol{\alpha}_j^t) \neq \emptyset
$$

be the evolving angle between α_j^t and the vector governing its dynamics (if any). Then the existence of the times at which the entries or the exits occur is confirmed in the following.

Proposition 2. For all $j \in J_+ \cup J_-$ there exist a unique enumeration $i_j^1, \ldots, i_j^{n_j}$ of $I_{-s_j}(\boldsymbol{z}_j)$ and unique $0 = \tau_j^0 < \tau_j^1 < \cdots < \tau_j^{n_j}$ such that for all $\ell \in [n_j]$:

(i)
$$
I_{s_j}(\alpha_j^t) = I_{s_j}(z_j) \cup \{i_j^1, \ldots, i_j^{\ell-1}\}
$$
 for all $t \in (\tau_j^{\ell-1}, \tau_j^{\ell})$;
\n(ii) $I_0(\alpha_j^t) = \emptyset$ for all $t \in (\tau_j^{\ell-1}, \tau_j^{\ell})$, and $I_0(\alpha_j^{\tau_j^{\ell}}) = \{i_j^{\ell}\}$.

Finally we define two measurements of the unscaled initialisation and the training dataset, which are positive thanks to [Assumption 1,](#page-5-0) and which will simplify the presentation of our results.

$$

 $\Delta := \max\{\max_{i \in [n]} ||x_i||, \, \max_{j \in [m]} ||z_j||, 1\}$.

Assumption 2.
$$
0 < \varepsilon \leq \frac{1}{4}
$$
 and $\lambda \leq \left(m \, n^{9n \Delta^2 / \delta^3} \right)^{-3/\varepsilon}$

The quantity ε introduced here has no effect on the network training, but is a parameter of our analysis, so that varying it within the assumed range tightens some of the resulting bounds while loosening others. The assumed bound on the initialisation scale λ is polynomial in the network width m and exponential in the dataset cardinality n . The latter is also the case in [Boursier et al.](#page-11-2) [\[2022\]](#page-11-2), where the bound was stated informally and without its dependence on parameters other than m and n .

.

4 First phase: alignment or deactivation

We show that, for each initially active hidden neuron, if its last-layer sign is positive then it turns to include in its active half-space all training points that were initially outside, whereas if its last-layer sign is negative then it turns to remove from its active half-space all training points that were initially inside. Moreover, those training points cross the activation boundary in the same order as they cross the half-space boundary of the corresponding yardstick trajectory α_j^t , and at approximately the same times (cf. [Proposition 2\)](#page-6-1).

Lemma 3. For all $j \in J_+ \cup J_-$ there exist unique $0 = t_j^0 < t_j^1 < \ldots < t_j^{n_j}$ such that for all $\ell \in [n_j]$:

(i)
$$
I_{s_j}(\boldsymbol{w}_j^t) = I_{s_j}(z_j) \cup \{i_j^1, \ldots, i_j^{\ell-1}\}
$$
 for all $t \in (t_j^{\ell-1}, t_j^{\ell})$;

(ii)
$$
I_0(\boldsymbol{w}_j^t) = \emptyset
$$
 for all $t \in (t_j^{\ell-1}, t_j^{\ell}),$ and $I_0(\boldsymbol{w}_j^{t_j^{\ell}}) = \{i_j^{\ell}\};$

$$
(iii) \ \ |\tau_j^{\ell}-t_j^{\ell}| \leq \lambda^{1-\left(1+\frac{3\ell-1}{3n_j}\right)\varepsilon}.
$$

The preceding lemma is proved by establishing, for this first phase of the training, non-asymptotic upper bounds on the Euclidean norms of the hidden neurons and hence on the absolute values of the network outputs, and inductively over the stage index ℓ , on the distances between the unit-sphere normalisations of $\bm{\alpha}_j^t$ and \bm{w}_j^t . Based on that analysis, we then obtain that each negative-sign hidden neuron does not grow from its initial length and deactivates by time $T_0 \coloneqq \max_{j \in J_+ \cup J_-} \tau_j^{n_j} + 1$.

Lemma 4. *For all* $j \in J$ _– *we have:*

\|\boldsymbol{w}_j^{T_0}\| \leq \lambda \|\boldsymbol{z}_j\| \qquad \qquad \boldsymbol{w}_j^t = \boldsymbol{w}_j^{T_0} \quad \textit{for all } t \geq T_0 .
$$

We also obtain that, up to a later time $T_1 \coloneqq \varepsilon \ln(1/\lambda)/\|\boldsymbol{\gamma}_{[n]}\|$, each positive-sign hidden neuron: grows but keeps its length below $2\|z_j\|^{\lambda^{1-\varepsilon}},$ continues to align to the vector $\gamma_{[n]}$ up to a cosine of at least $1 - \lambda^ε$, and maintains bounded by $\lambda^{1-3ε}$ the difference between the logarithm of its length divided by the initialisation scale and the logarithm of the corresponding yardstick vector length.

Lemma 5. *For all* $j \in J_+$ *we have:*

\|\boldsymbol{w}_j^{T_1}\| < 2\|\boldsymbol{z}_j\| \lambda^{1-\varepsilon} \hspace{1cm} \overline{\boldsymbol{w}}_j^{T_1^\top} \, \overline{\boldsymbol{\gamma}}_{[n]} \geq 1-\lambda^{\varepsilon} \hspace{1cm} |\ln\|\boldsymbol{\alpha}_j^{T_1}\| - \ln\|\boldsymbol{w}_j^{T_1}/\lambda\|| \leq \lambda^{1-3\varepsilon} \, .
$$

5 Second phase: growth and convergence

We next analyse the gradient flow subsequent to the deactivation of the negative-sign hidden neurons by time T_0 and the alignment of the positive-sign ones up to time T_1 , and establish that the loss converges to zero at a rate which is exponential and does not depend on the initialisation scale λ .

Theorem 6. *Under Assumptions* [1](#page-5-0) *and* [2,](#page-6-0) there exists a time $T_2 < \ln(1/\lambda)(4+\epsilon)d\Delta^2/\delta^6$ such that for all $t \ge 0$ we have $L(\boldsymbol{\theta}^{T_2+t}) < 0.5\,\Delta^{\!2}\,\mathrm{e}^{-t+0.4\,\delta^4/\Delta^{\!2}}.$

In particular, for $\varepsilon = 1/4$ and $\lambda = \left((m\,n^n)^{9\Delta^2/\delta^3}\right)^{-3/\varepsilon}$ (cf. [Assumption 2\)](#page-6-0), the first bound in [Theorem 6](#page-7-0) becomes $T_2 < (\ln m + n \ln n) d \cdot 17 \cdot 27 \Delta^4 / \delta^9$.

The proof of [Theorem 6](#page-7-0) is in large part geometric, with a key role played by a set $S := S_1 \cup \cdots \cup S_d$ in predictor space, whose constituent subsets are defined as

\mathcal{S}_\ell \coloneqq \left\{ \bm{v} = \sum_{k=1}^d \nu_k \bm{u}_k \ \left| \ \bigwedge_{1 \leq k < \ell} \Omega_k \ \wedge \ \Phi_\ell \ \wedge \ \bigwedge_{\ell \leq k < k' \leq d} (\Psi_{k,k'}^\downarrow \wedge \Psi_{k,k'}^\uparrow) \ \wedge \ \Xi \right\} \ ,
$$

where the individual constraints are as follows (here $\eta_0 \coloneqq \infty$ so that e.g. $\frac{\eta_1}{2\eta_0} = 0$):

$$
\begin{aligned} \Omega_k\colon\;&\,1<\frac{\nu_k}{\nu_k^*}\qquad\quad\Phi_\ell\colon\;\frac{\eta_\ell}{2\eta_{\ell-1}}<\frac{\nu_\ell}{\nu_\ell^*}\leq 1\qquad\qquad\,\Psi_{k,k'}^\downarrow\colon\;\frac{\eta_{k'}}{2\eta_k}\frac{\nu_k}{\nu_k^*}<\frac{\nu_{k'}}{\nu_{k'}^*}\\ \Xi\colon\;\overline{\pmb v}^\top\overline{\pmb X\pmb X^\top(\pmb v^*-\pmb v)}&>\lambda^{\varepsilon/3}\qquad\qquad\qquad\qquad\,\,\Psi_{k,k'}^\uparrow\colon\;\frac{\nu_{k'}}{\nu_{k'}^*}<1-\left(1-\frac{\nu_k}{\nu_k^*}\right)^{\frac{1}{2}+\frac{\eta_{k'}}{2\eta_k}}\,. \end{aligned}
$$

Thus $\mathcal S$ is connected, open, and constrained by Ξ to be within the ellipsoid $\bm v^\top \bm X \bm X^\top (\bm v^* - \bm v) = 0$ which is centred at $\frac{v^*}{2}$ $\frac{y^2}{2}$, with the remaining constraints slicing off further regions by straight or curved boundary surfaces.

In the most complex component of this work, we show that, for all $t \geq T_1$, the trajectory of the sum $v^t := \sum_{j \in J_+} a_j^t w_j^t$ of the active hidden neurons weighted by the last layer stays inside S, and the cosines of the angles between the neurons remain above $1 - 4\lambda^{\epsilon}$. This involves proving that each face of the boundary of S is repelling for the training dynamics when approached from the inside; we remark that, although that is in general false for the entire boundary of the constraint Ξ, it is in particular true for its remainder after the slicing off by the other constraints. We also show that all points in S are positively correlated with all training points, which together with the preceding facts implies that, during this second phase of the training, the network behaves approximately like a linear one-hidden layer one-neuron network. Then, as the cornerstone of the rest of the proof, we show that, for all $t \geq T_2$,

the gradient of the loss satisfies a [Polyak-](#page-13-10)Łojasiewicz inequality $\|\nabla L(\bm{\theta}^t)\|^2 > \frac{2\eta_d \|\bm{\gamma}_{[n]}\|}{5\eta_1}L(\bm{\theta}^t)$. Here $T_2 := \inf\{t \geq T_1 \mid \nu_1^t/\nu_1^* \geq 1/2\}$ is a time by which the network has departed from the initial saddle, more precisely when the first coordinate ν_1^t of the bundle vector \bm{v}^t with respect to the basis consisting of the eigenvectors of the matrix $\frac{1}{n}XX^\top$ crosses the half-way threshold to the first coordinate ν_1^* of the teacher neuron.

The interior of the ellipsoid in the constraint Ξ actually consists of all vectors that have an acute angle with the derivative of the training dynamics in predictor space, and the "padding" of $\lambda^{\varepsilon/3}$ is present because the derivative of the bundle vector v^t is "noisy" due to the latter being made up of the approximately aligned neurons. The remaining constraints delimit the subsets S_1, \ldots, S_d of the set S, through which the bundle vector v_t passes in that order, with each unique "handover" from S_ℓ to $S_{\ell+1}$ happening exactly when the corresponding coordinate ν_{ℓ}^t exceeds its target ν_{ℓ}^* . The non-linearity of the constraints $\Psi^{\top}_{k,k'}$ is needed to ensure the repelling for the training dynamics.

6 Implicit bias of gradient flow

Let us denote the set of all balanced networks by

$$
\Theta \coloneqq \{(\mathbf{a}, \mathbf{W}) \in \mathbb{R}^m \times \mathbb{R}^{m \times d} \mid \forall j \in [m] \colon |a_j| = \|\mathbf{w}_j\|\}
$$

and the subset in which all non-zero hidden neurons are positive scalings of v^* , have positive last-layer weights, and have lengths whose squares sum up to $\|\bm{v}^*\|=1$, by

$$
\Theta_{\mathbf{v}^*} \coloneqq \{(\mathbf{a}, \mathbf{W}) \in \Theta \mid \sum_{j=1}^m \|\mathbf{w}_j\|^2 = 1 \; \wedge \; \forall j \in [m] \colon \mathbf{w}_j \neq \mathbf{0} \; \Rightarrow \; (\overline{\mathbf{w}}_j = \mathbf{v}^* \; \wedge \; a_j > 0)\} \; .
$$

Our main result establishes that, as the initialisation scale λ tends to zero, the networks with zero loss to which the gradient flow converges tend to a network in Θ_{v^*} . The explicit subscripts indicate the dependence on λ of the parameter vectors. The proof builds on the preceding results and involves a careful control of accumulations of approximation errors over lengthy time intervals.

Theorem 7. *Under Assumptions [1](#page-5-0) and [2,](#page-6-0)* L lim $t\rightarrow\infty$ $\left(\boldsymbol{\theta}_{\lambda}^{t}\right)=0$ and $\lim_{\lambda\to 0}$ $\lambda \rightarrow 0^+$ lim $t\rightarrow\infty$ $\boldsymbol{\theta}^t_{\lambda} \in \Theta_{\boldsymbol{v}^*}.$

7 Interpolators with minimum norm

To compare the set Θ_{v^*} of balanced rank-1 interpolator networks with the set of all minimum-norm interpolator networks, in this section we focus on training datasets of cardinality d , we assume the network width is greater than 1 (otherwise the rank is necessarily 1), and we exclude the threshold case of Lebesgue measure zero where $M = 0$. The latter measurement of the training dataset is defined below in terms of angles between the teacher neuron and vectors in any two cones generated by different generators of the dual of the cone of all training points.

Let $[\boldsymbol{\chi}_1,\ldots,\boldsymbol{\chi}_d]^\top \coloneqq \boldsymbol{X}^{-1}$ and

$$
\mathcal{M} \coloneqq \max \left\{ \cos \measuredangle(\boldsymbol{p}, \boldsymbol{q}) - \sin \measuredangle(\boldsymbol{p}, \boldsymbol{v}^*) \middle| \begin{array}{c} \emptyset \subsetneq K \subsetneq [d] \\ \wedge \boldsymbol{0} \neq \boldsymbol{p} \in \mathrm{cone}\{\chi_k \mid k \in K\} \\ \wedge \boldsymbol{0} \neq \boldsymbol{q} \in \mathrm{cone}\{\chi_k \mid k \notin K\} \end{array} \right\}.
$$

Assumption 3. $n = d, m > 1$, and $\mathcal{M} \neq 0$.

We obtain that, surprisingly, Θ_{v^*} equals the set of all interpolators with minimum Euclidean norm if $M < 0$, but otherwise they are disjoint.

Theorem 8. *Under Assumptions [1](#page-5-0) and [3:](#page-8-0)*

- *(i) if* $M < 0$ *then* Θ_{v^*} *is the set of all global minimisers of* $\|\theta\|^2$ *subject to* $L(\theta) = 0$ *;*
- (*ii*) *if* $M > 0$ then no point in Θ_{v^*} is a global minimiser of $\|\theta\|^2$ subject to $L(\theta) = 0$.

For each of the two cases, we provide a family of example datasets in [Appendix G.](#page-50-0) We remark that a sufficient condition for $M < 0$ to hold is that the inner product of any two distinct rows χ_k of the inverse of the dataset matrix X is non-positive, i.e. that the inverse of the Gram matrix of the dataset (in our setting this Gram matrix is positive) is a Z-matrix (cf. e.g. [Fiedler and Pták](#page-12-10) [\[1962\]](#page-12-10)). Also, if the training points were orthogonal then all the $\cos \angle (p, q)$ terms in the definition of M would be zero and consequently we would have $M < 0$; this is consistent with the result that, per sign class of the training labels in the orthogonal setting, minimising the Euclidean norm of interpolators coincides with minimising their rank [\[Boursier et al.,](#page-11-2) [2022,](#page-11-2) Appendix C].

8 Experiments

We consider two schemes for generating the training dataset, where \mathbb{S}^{d-1} is the unit sphere in \mathbb{R}^d .

Centred: We sample μ from $\mathcal{U}(\mathbb{S}^{d-1})$, then sample x_1, \ldots, x_d from $\mathcal{N}(\mu, \frac{\partial}{\partial}I_d)$ where $\rho = 1$, and finally set $v^* = \mu$. This distribution has the property that, in high dimensions, the angles between the teacher neuron v^* and the training points x_i concentrate around $\pi/4.$ We exclude rare cases where some of these angles exceed $\pi/2$.

Uncentred: This is the same, except that we use $\rho = \sqrt{2} - 1$, sample one extra point x_0 , and finally set $\bm{v}^*=\overline{\bm{x}}_0.$ Here the angles between \bm{v}^* and \bm{x}_i also concentrate around $\pi/4$ in high dimensions, but the expected distance between v^* and μ is $\sqrt{\rho}$.

For each of the two dataset schemes, we train a one-hidden layer ReLU network of width $m = 200$ by gradient descent with learning rate 0.01, from a balanced initialisation such that $z_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{N}(\mathbf{0}, \frac{1}{d m} \mathbf{I}_d)$ and $s_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{U}\{\pm 1\}$, and for a range of initialisation scales λ and input dimensions d.

We present in [Figure 1](#page-10-0) some results from considering initialisation scales $\lambda = 4^2, 4^1, \ldots, 4^{-12}, 4^{-13}$ and input dimensions $d = 4, 16, 64, 256, 1024$, where we train until the number of iterations reaches $2 \cdot 10^7$ or the loss drops below 10^{-9} . The plots are in line with [Theorem 7,](#page-8-1) showing how the maximum angle between active hidden neurons at the end of the training decreases with λ .

[Figure 2](#page-10-1) on the left illustrates the exponential convergence of the training loss (cf. [Theorem 6\)](#page-7-0), and on the right how the implicit bias can result in good generalisation. The test loss is computed over an input distribution which is different from that of the training points, namely we sample 64 test inputs from the standard multivariate $\mathcal{N}(\mathbf{0}, \mathbf{I}_d)$. These plots are for initialisation scales $\lambda = 4^{-2}, 4^{-3}, \dots, 4^{-7}, 4^{-8}$.

9 Conclusion

We provided a detailed analysis of the dynamics of training a shallow ReLU network by gradient flow from a small initialisation for learning a single neuron which is correlated with the training points, establishing convergence to zero loss and implicit bias to rank minimisation in parameter space. We believe that in particular the geometric insights we obtained in order to deal with the complexities of the multi-stage alignment of hidden neurons followed by the simultaneous evolution of their norms and directions, will be useful to the community in the ongoing quest to understand implicit bias of gradient-based algorithms for regression tasks using non-linear networks.

A major direction for future work is to bridge the gap between, on one hand, our assumption that the angles between the teacher neuron and the training points are less than $\pi/4$, and the other, the

assumption of [Boursier et al.](#page-11-2) [\[2022\]](#page-11-2) that the training points are orthogonal, while keeping a fine granularity of description. We expect this to be difficult because it seems to require handling bundles of approximately aligned neurons which may have changing sets of training points in their active half-spaces and which may separate during the training. However, it should be straightforward to extend our results to orthogonally separable datasets and two teacher ReLU neurons, where each of the latter has an arbitrary sign, labels one of the two classes of training points, and has angles less than $\pi/4$ with them; the gradient flow would then pass close to a second saddle point, where the labels of one of the classes have been nearly fitted but the hidden neurons that will fit the labels of the other class are still small. We report on related numerical experiments in [Appendix I.](#page-68-0)

We also obtained a condition on the dataset that determines whether rank minimisation and Euclidean norm minimisation for interpolator networks coincide or are distinct. Although this dichotomy remains true if the $\pi/4$ correlation bound is relaxed to $\pi/2$, the implicit bias of gradient flow in that extended setting is an open question.

Other directions for future work include considering multi-neuron teacher networks, student networks with more than one hidden layer, further non-linear activation functions, and gradient descent instead of gradient flow; also refining the bounds on the initialisation scale and the convergence time.

A Related work

Here we further discuss a selection of related work.

Early training phase. Our analysis of the first phase of the training builds on those of [Maennel et al.](#page-12-8) [\[2018\]](#page-12-8), who considered unrestricted datasets but focused on asymptotic results; and of [Boursier et al.](#page-11-2) [\[2022\]](#page-11-2), who restricted the datasets to orthogonal but provided detailed non-asymptotic bounds. In particular, our normalised yardstick trajectories $\overline{\alpha}_j^t$ are analogous to $\vec{U}_i(t)$ in [Maennel et al.](#page-12-8) [\[2018,](#page-12-8) section 9.6] and \widetilde{w}_j^t in [Boursier et al.](#page-11-2) [\[2022,](#page-11-2) Appendix B.6]. Our contribution in this part, in relation to
these two works, is to extend the fine grained description for the exthesional sese to the more involved these two works, is to extend the fine-grained description for the orthogonal case to the more involved correlated case, which exhibits a sequence of intermediate stages, obtaining detailed non-asymptotic bounds including for the initialisation scale λ ; the latter are essential for our analysis of the subsequent second phase of the training and our proof of the implicit bias when λ tends to zero.

Non-asymptotic bounds for early training of one-hidden layer networks were shown by [Lyu, Li, Wang,](#page-12-11) [and Arora](#page-12-11) [\[2021\]](#page-12-11) with the Leaky-ReLU non-linearity, logistic loss, and linearly separable data which are either symmetric or have a principal direction and uniformly labelled support vectors; and by [Min,](#page-12-12) [Vidal, and Mallada](#page-12-12) [\[2023\]](#page-12-12) with the ReLU non-linearity, exponential loss, and orthogonally separable data. [Wang and Ma](#page-13-11) [\[2022\]](#page-13-11) studied early training by gradient descent of one-hidden layer ReLU networks, focusing on a non-balanced random initialisation and on obtaining a lower bound for the Euclidean norm of the gradient. Another related work is by [Xu and Du](#page-13-12) [\[2023\]](#page-13-12), where the hidden layer is trained, every last-layer weight is fixed to 1, and the loss is over a Gaussian data population; consequently some aspects of the training dynamics are simpler, and already the first phase aligns the neurons to the teacher.

Learning a single neuron. A number of previous works studied learning a single neuron by gradientbased algorithms, in settings including realisable without bias [\[Yehudai and Shamir,](#page-13-13) [2020\]](#page-13-13), agnostic and noisy [\[Frei, Cao, and Gu,](#page-12-13) [2020\]](#page-12-13), realisable with bias [\[Vardi, Yehudai, and Shamir,](#page-13-14) [2021\]](#page-13-14), multi

layer [\[Lee, Sim, and Ye,](#page-12-14) [2022\]](#page-12-14), and overparameterised [\[Xu and Du,](#page-13-12) [2023\]](#page-13-12). In particular, [Vardi et al.](#page-13-14) [\[2021\]](#page-13-14) proved exponentially fast convergence of gradient descent to the global minimum by geometric and algebraic arguments, for two complementary sets of assumptions on the data distribution and the student initialisation; [Xu and Du](#page-13-12) [\[2023\]](#page-13-12) determined that, when the student network has width at least 2 and only its hidden layer is trained, the speed of convergence drops to cubic; and [Lee et al.](#page-12-14) [\[2022\]](#page-12-14) studied how neuron depth and initialisation scale affect the speed of convergence. In contrast to the settings in those works, our student network has arbitrary width and both its layers are trained.

Convergence for one-hidden layer ReLU networks and mean square loss. Further related convergence results were obtained by [Jentzen and Riekert](#page-12-15) [\[2023\]](#page-12-15), who proved that, for one-hidden layer ReLU networks trained by gradient flow with respect to a mean square population loss, if the data is one-dimensional, the target function is affine, the initial loss is sufficiently small, and the training trajectory is bounded, then it converges to zero loss; and that if moreover the network is width-one then the boundedness assumption is not needed.

Also with univariate data, [Stewart, Bach, Berthet, and Vert](#page-13-15) [\[2023\]](#page-13-15) compared the features learnt by onehidden layer ReLU networks for the square loss and the cross-entropy loss, postulating that sparseness in the regression case may cause optimisation difficulties, and reporting synthetic experiments that support the claim.

Properties transferred from parameter space to function space. The implicit bias in parameter space that we established, namely to interpolator networks of rank 1, has a clear implication in function space, namely the resulting function is identical to that defined by the teacher neuron. However, we also compared that set of interpolator networks with the one obtained by minimising the Euclidean norm. The question of what functions the latter networks define is in general non-trivial; for one-hidden layer ReLU networks, it was studied in the univariate case by [Savarese, Evron, Soudry, and Srebro](#page-13-16) [\[2019\]](#page-13-16) and [Ergen and Pilanci](#page-11-9) [\[2021\]](#page-11-9), and in the multivariate case by [Ongie, Willett, Soudry, and Srebro](#page-13-17) [\[2020\]](#page-13-17). More recently, [Boursier and Flammarion](#page-11-10) [\[2023\]](#page-11-10) investigated further the univariate case, elucidating the consequences of whether the norm takes into account the bias terms.

Regression using diagonal linear networks. [Even, Pesme, Gunasekar, and Flammarion](#page-12-16) [\[2023\]](#page-12-16) and [Pesme and Flammarion](#page-13-18) [\[2023\]](#page-13-18) considered implicit bias for regression tasks, focusing on diagonal networks with linear activation. The former proved convergence and compared implicit biases of gradient descent and stochastic gradient descent with large learning rates. The latter studied gradient flow from a vanishing initialisation and provided a full description of training trajectories, showing that they jump from saddle to saddle until reaching the minimum ℓ_1 -norm solution.

Classification using Leaky-ReLU networks. Building on the implicit bias to margin maximisation in parameter space for homogenous networks [\[Lyu and Li,](#page-12-1) [2020,](#page-12-1) [Ji and Telgarsky,](#page-12-2) [2020\]](#page-12-2), convergence to a linear classifier was shown by [Lyu et al.](#page-12-11) [\[2021\]](#page-12-11), [Sarussi, Brutzkus, and Globerson](#page-13-19) [\[2021\]](#page-13-19), and [Frei, Vardi,](#page-12-17) [Bartlett, Srebro, and Hu](#page-12-17) [\[2023c\]](#page-12-17) for one-hidden layer networks with the Leaky-ReLU activation and several sets of assumptions that include linear separability of the data. [Frei, Vardi, Bartlett, and Srebro](#page-12-18) [\[2023a\]](#page-12-18) subsequently established that in two kinds of distributional settings benign overfitting occurs, namely the predictors interpolate noisy training data and simultaneously generalise well to unseen test data.

Implicit bias and adversarial examples. In addition to [Vardi et al.](#page-13-14) [\[2021\]](#page-13-14), likewise in the context of one-hidden layer ReLU networks and exponentially-tailed loss functions, consequences for adversarial examples of the implicit bias to margin maximisation in parameter space were investigated by [En-](#page-11-11)glert and Lazić [\[2022\]](#page-11-11), who showed that for orthogonally separable training datasets it may prevent adversarial reprogrammability; and by [Frei, Vardi, Bartlett, and Srebro](#page-12-19) [\[2023b\]](#page-12-19), who showed that for

clustered data it leads to non-robust solutions even though robust networks that fit the data exist. In contrast to those works, which focus on gradient flow, [Melamed, Yehudai, and Vardi](#page-12-20) [\[2023\]](#page-12-20) considered possibly stochastic gradient descent and established that, when data belongs to a low-dimensional linear subspace, the training produces non-robust solutions, but decreasing the initialisation scale or adding a Euclidean norm regulariser increases robustness to orthogonal adversarial perturbations.

B Proof for the preliminaries

First we note that the gradient flow ensures that the loss monotonically decreases, at the rate equal to the square of the Euclidean norm of the gradient.

Proposition 9 (by [Davis, Drusvyatskiy, Kakade, and Lee](#page-11-12) [\[2020,](#page-11-12) Lemma 5.2]). For almost all $t \in [0, \infty)$ we *have* $dL(\boldsymbol{\theta}^t)/dt = -\|\mathrm{d}\boldsymbol{\theta}^t/\mathrm{d}t\|^2$.

(ii) $a_j^t = s_j ||\boldsymbol{w}_j^t|| \neq 0$.

Proof. Part [\(i\)](#page-4-0) follows by straightforward calculations. For part [\(ii\),](#page-4-2) by [\(i\),](#page-4-0) for all $j \in [m]$ and almost all $t \in [0, \infty)$ we have

$$
\mathrm{d}(a_j^t)^2/\mathrm{d}t = 2a_j^t \boldsymbol{w}_j^t{}^\top \boldsymbol{g}_j^t = \mathrm{d} \|\boldsymbol{w}_j^t\|^2/\mathrm{d}t ,
$$

and so $(a_j^t)^2 - ||w_j^t||^2$ is constant and therefore zero for all t by the initialisation and continuity. It remains to show that $a_j^t \neq 0$ for all t. Observe that, by [Proposition 9,](#page-16-3) for almost all t, provided $a_j^t \neq 0$ we have

$$
\mathrm{d}\ln(a_j^t)^2/\mathrm{d}t \geq -2\|\bm{g}_j^t\| \geq -2\sqrt{2L(\bm{\theta}^t)}\min_{i=1}^n\|\bm{x}_i\| \geq -2\sqrt{2L(\bm{\theta}^0)}\min_{i=1}^n\|\bm{x}_i\|.
$$

Hence, by continuity, for all t we have

$$
(a_j^t)^2 \ge (a_j^0)^2 \exp\left(-2t\sqrt{2L(\boldsymbol{\theta}^0)}\max_{i=1}^n \|\boldsymbol{x}_i\|\right).
$$

Also from [Proposition 1](#page-4-1) we obtain the formulas for the derivatives of the spherical coordinates of the hidden neurons, i.e. of their logarithmic Euclidean norms and their unit normalisations.

Corollary 10. For all $j \in [m]$ and almost all $t \in [0, \infty)$ we have

$$
\mathrm{d} \ln \| \bm{w}_j^t \| / \mathrm{d} t = s_j \overline{\bm{w}}_j^t{}^\top \bm{g}_j^t \hspace{2cm} \mathrm{d} \overline{\bm{w}}_j^t / \mathrm{d} t = s_j (\bm{g}_j^t - \overline{\bm{w}}_j^t \, \overline{\bm{w}}_j^t{}^\top \bm{g}_j^t) \ .
$$

C Proofs for the assumptions

In this section we prove [Proposition 2](#page-6-1) from [section 3,](#page-4-4) which is subsumed by [Proposition 14](#page-20-0) below, and then show as [Corollary 15](#page-25-0) that the cases excluded by [Assumption 1](#page-5-0) [\(iv\)](#page-5-3) have Lebesgue measure zero, as claimed in [section 3.](#page-4-4)

We first establish several elementary properties of the yardstick trajectories α_j^t .

Proposition 11. *For all* $j \in J_+ \cup J_-$ *, the following statements hold.*

(*i*) $\gamma_{I_{+}(\boldsymbol{\alpha}^t_j)} = \boldsymbol{0}$ *if and only if* $I_{+}(\boldsymbol{\alpha}^t_j) = \emptyset$ *.*

- $\tilde{f}(\vec{u}) \;\; (\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)} \geq 0.$ Moreover, $(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)} = 0$ if and only if $(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{x}_i \leq 0$ for all $i \in [n].$
- (*iii*) If $(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_+(\boldsymbol{\alpha}_j^t)} = \|\boldsymbol{\alpha}_j^t\| \|\boldsymbol{\gamma}_{I_+(\boldsymbol{\alpha}_j^t)}\|$ for some t , then $I_+(\boldsymbol{\alpha}_j^t) = \emptyset$ or $I_+(\boldsymbol{\alpha}_j^t) = [n].$
- (*iv*) $\alpha_j^t \neq \mathbf{0}$ for all $t \in [0, \infty)$.

Proof. For part [\(i\),](#page-16-4) only the left-to-right implication requires a proof. Let $\gamma_{I+({\bm\alpha}_j^t)}=\frac{1}{n}\sum_i y_i\bm{x}_i$, where the summation is over $i \in I_+(\bm{\alpha}_j^t)$; then $\|\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}\|^2 = \frac{1}{n^2} \sum_{i,k} y_i y_k \bm{x}_i^\top \bm{x}_k$. Since all training points are positively correlated, and all coefficients y_i that are present in the sum are positive, $\|\bm{\gamma}_{I_+(\bm{\alpha}^t_j)}\|^2>0$ unless the sum contains no terms; that is, unless $I_+(\boldsymbol{\alpha}^t_j)=\emptyset$.

For part [\(ii\),](#page-17-0) observe that $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}$ is a positive linear combination of \bm{x}_k for $k\in I_+(\bm{\alpha}_j^t)$, and every such \bm{x}_k forms an acute angle with α_j^t ; thus, $(\alpha_j^t)^\top \gamma_{I_{+}(\alpha_j^t)}>0$ unless $\gamma_{I_{+}(\alpha_j^t)}=0.$

For part [\(iii\),](#page-17-1) we again use the definition of $\gamma_{I+(\bm\alpha_j^t)}$ and the fact that $x_i^+x_k>0$ for all $i,k\in[n].$ If $I_{+}(\boldsymbol{\alpha}^{t}_j) \neq \emptyset$, then $\boldsymbol{\alpha}^{t}_j \neq \boldsymbol{0}$ and $\boldsymbol{x}_i^\top \boldsymbol{\alpha}_j^t = \boldsymbol{x}_i^\top \boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}^{t}_j)} \cdot \|\boldsymbol{\alpha}_j^t\|/\|\boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}^{t}_j)}\| > 0$ for all i , and thus $I_{+}(\boldsymbol{\alpha}^{t}_j) = [n].$

For part [\(iv\),](#page-17-2) note that

$$
\frac{\mathrm{d} \|\boldsymbol{\alpha}_j^t\|^2}{\mathrm{d} t} = 2(\boldsymbol{\alpha}_j^t)^\top \cdot s_j \|\boldsymbol{\alpha}_j^t\| \boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)} = \|\boldsymbol{\alpha}_j^t\|^2 \|\boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)}\| \cdot 2s_j \cos \measuredangle (\boldsymbol{\alpha}_j^t, \boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)}) ,
$$

where the final product is 0 if $\bm{\alpha}_j^t = \bm{0}.$ It follows that $\mathrm{d}\|\bm{\alpha}_j^t\|^2/\mathrm{d}t \geq -2\|\bm{\alpha}_j^t\|^2\|\bm{\gamma}_{[n]}\|$ for all $t\in[0,\infty).$ By Grönwall's inequality, $\|\bm{\alpha}_j^t\|^2\geq\|\bm{\alpha}_j^0\|^2\,\mathrm{e}^{-2\|\bm{\gamma}_{[n]}\|t}>0$ for all t , and it remains to recall that $\bm{\alpha}_j^0=\bm{z}_j$ was initially chosen to be non-zero.

The next proposition establishes continuity and monotonicity properties, assuming that the trajectory $\bm{\alpha}_j^t$ crosses between regions of continuity of the right-hand side of the ODE finitely many times.

Proposition 12. Let $j \in J_+ \cup J_-$. Let $T > 0$ be such that $I_0(\boldsymbol{\alpha}^t_j)$ is only non-empty for finitely many $t \in [0, T]$. *Then the following statements hold.*

- *(i) The map* $t \mapsto (\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_+(\boldsymbol{\alpha}_j^t)}$ *from* $[0, T]$ *to* $\mathbb R$ *is continuous.*
- (*ii*) If $\gamma_{I_+(\boldsymbol{\alpha}^t_j)} = \boldsymbol{0}$ for some $t \in [0,T]$, then $t = T$.

$$
\text{(iii)}\ \ \gamma_{I_{+}(\alpha_j^t)} = \begin{cases} \lim_{\xi \to t^{-}} \gamma_{I_{+}(\alpha_j^{\xi})} & \text{if } s_j = +1 \text{ and } t \in (0, T],\\ \lim_{\xi \to t^{+}} \gamma_{I_{+}(\alpha_j^{\xi})} & \text{if } s_j = -1 \text{ and } t \in [0, T). \end{cases}
$$

- (iv) For each $i \in [n]$, $s_j(\bm{\alpha}^t_j)^\top \bm{x}_i$ is a strictly increasing function of t on $[0,T]$. Furthermore, for all $i \in [n]$, *whenever* $0 \le t_1 < t_2 \le T$:
	- *if* $s_j = +1$ and $i \in I_0(\boldsymbol{\alpha}_j^{t_1}) \cup I_+(\boldsymbol{\alpha}_j^{t_1})$, then $i \in I_+(\boldsymbol{\alpha}_j^{t_2})$;
	- *if* $s_j = -1$ and $i \notin I_+(\boldsymbol{\alpha}_j^{t_1})$, then $i \notin I_0(\boldsymbol{\alpha}_j^{t_2}) \cup I_+(\boldsymbol{\alpha}_j^{t_2})$.
- (v) Let $t_0\in[0,T)$ be either 0 or a point of discontinuity of $\boldsymbol{\gamma}_{I+(\boldsymbol{\alpha}_j^t)}.$ If $s_j=-1$, then $\lim_{t\to t_0^+}\cos\varphi_j^t\neq 1.$

We remark that the assumption of [Proposition 12](#page-17-3) that the set $\{t\geq 0\mid I_0({\bf{\alpha}}_j^t)\neq\emptyset\}$ has a finite intersection with $[0, T]$ will be justified in [Proposition 14,](#page-20-0) in the following sense: we will show that the assumption holds for every segment $[0,T]$ such that $\bm{\gamma}_{I_{+}(\bm{\alpha}_j^t)}\neq\bm{0}$ for all $t\in[0,T).$

Proof. For part [\(i\),](#page-17-4) since the map $t \mapsto \alpha_j^t$ from $[0,\infty)$ to \mathbb{R}^d is continuous by definition, it suffices to consider points of discontinuity of $\gamma_{I+(\bm{\alpha}_j^t)}.$ The set $I_0(\bm{\alpha}_j^{t_0})$ is necessarily non-empty at every such point $t_0\in[0,T].$ Let us fix such a t_0 ; then one-sided limits of $\gamma_{I_+(\bm{\alpha}_j^t)}$ as $t\to t_0^+$ and $t\to t_0^-$ exist (excepting $t \to 0^-$ and $t \to T^+$, which we do not consider). Here we used the assumption from the statement of the proposition: in a small enough neighbourhood of t_0 there are no other points t for which $I_0(\bm{\alpha}^t_j)$ is non-empty; this assumption could have been avoided if necessary. The value of $(\bm{\alpha}_j^{t_0})^{\top}\bm{\gamma}_{I_+(\bm{\alpha}_j^{t_0})}$ may only differ from (either of) the one-sided limits of $(\alpha_j^t)^\top \gamma_{I+(\alpha_j^t)}$ as $t\to t_0^\pm$ by the summands $(\alpha_j^{t_0})^\top \cdot \frac{1}{n} y_i \bm{x}_i$ with $i \in I_0(\boldsymbol{\alpha}_j^{t_0})$. But every such summand is equal to 0 anyway by the definition of I_0 .

Before establishing part [\(ii\),](#page-17-5) we first prove a weaker version of part [\(iv\),](#page-17-6) namely non-strict monotonicity: for each $i \in [n]$, $s_j(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{x}_i$ is a non-decreasing function of t on $[0, T]$. To this end, we consider the derivatives

$$
\frac{\mathrm{d}(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{x}_i}{\mathrm{d}t} = s_j \|\boldsymbol{\alpha}_j^t\| \cdot (\boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)})^\top \boldsymbol{x}_i
$$

inside each interval (t_1,t_2) on which $\bm{\gamma}_{I+(\bm{\alpha}_j^t)}$ is continuous. Observe that $(\bm{\gamma}_{I+(\bm{\alpha}_j^t)})^\top\bm{x}_i\geq 0$ for each $i\in [n]$, since training points are pairwise positively correlated. Therefore, $s_j(\alpha_j^t)^\top x_i$ is non-decreasing on (t_1,t_2) . Since α_j^t is continuous, and there are only finitely many points at which $\gamma_{I+(\alpha_j^t)}$ is discontinuous, $s_j ({\bm \alpha}^t_j)^\top {\bm x}_i$ is also non-decreasing on $[0,T].$

We now establish part [\(ii\).](#page-17-5) If $\bm{\gamma}_{I_+(\bm{\alpha}^t_j)}=\bm{0}$ for some $t\in[0,T]$, then

$$
t_0 := \inf\{t \in [0,T] \mid I_+(\boldsymbol{\alpha}^t_j) = \emptyset\}
$$

is well-defined by [Proposition 11,](#page-16-5) part [\(i\).](#page-16-4) Observe that if $I_+(\bm{\alpha}_j^{t_0})$ is non-empty, then $I_+(\bm{\alpha}_j^{t})$ is nonempty for all t in a small neighbourhood of t_0 by the continuity of α_j^t . Therefore, $I_+(\alpha_j^{t_0}) = \emptyset$ by our choice of t_0 . At the same time, notice that $0 < t_0$ because we assume $j \in J_+ \cup J_-$. Furthermore, for all $t' < t_0$ there is some $i \in [n]$ with $(\alpha_j^{t'})^{\top} x_i > 0$. By compactness and by the (non-strict) monotonicity property proved above, there exists a single $i\in[n]$ such that $(\bm\alpha_j^{t'})^\top\bm x_i>0$ for all $t'< t_0.$ Once again by continuity, we have $(\bm{\alpha}_j^{t_0})^\top \bm{x}_i \geq 0$. Since $I_{+}(\bm{\alpha}_j^{t_0}) = \emptyset$, we conclude that $i \in I_0(\bm{\alpha}_j^{t_0})$.

We have shown that, assuming $\bm{\gamma}_{I+({\bm{\alpha}}_j^t)}=\bm{0}$ for some $t\in[0,T]$, the existence of $t_0\in(0,t]$ such that $I_{+}({\bf{\alpha}}_j^{t_0})=\emptyset$ and $I_{0}({\bf{\alpha}}_j^{t_0})\neq\emptyset$. It follows that ${\bf{\alpha}}_j^{t}={\bf{\alpha}}_j^{t_0}$ and $I_{0}({\bf{\alpha}}_j^{t})=I_{0}({\bf{\alpha}}_j^{t_0})$ for all $t\geq t_0$. Under the assumptions of the proposition, this means $t_0 = t = T$. This completes the proof of part [\(ii\).](#page-17-5)

We now proceed to part [\(iv\),](#page-17-6) proving *strict* monotonicity of each $s_j({\bm\alpha}^t_j)^\top{\bm x}_i$. By part [\(ii\),](#page-17-5) for every interval (t_1,t_2) on which $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}$ is continuous, we have in fact $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}\neq\bm{0}.$ Therefore, $(\bm{\gamma}_{I_+(\bm{\alpha}_j^t)})^\top\bm{x}_i>0$, because training points are pairwise positively correlated, and each $s_j(\bm{\alpha}_j^t)^\top \bm{x}_i$ strictly increases on (t_1,t_2) . Since α_j^t is continuous, and there are only finitely many points at which $\gamma_{I+(\alpha_j^t)}$ is discontinuous, $s_j(\bm{\alpha}_j^t)^\top \bm{x}_i$ is also strictly increasing on $[0,T].$ The two remaining implications in the statement of part [\(iv\)](#page-17-6) follow.

Part [\(iii\)](#page-17-7) is a consequence of part [\(iv\).](#page-17-6)

To establish part [\(v\),](#page-17-8) firstly observe that, by part [\(iii\)](#page-17-7) and by the continuity of α_j^t , the function $\cos\varphi_j^t$ is in fact right-continuous at t_0 : the one-sided limit in question exists and is equal to $\cos \varphi_j^{t_0}$. By [Proposition 11,](#page-16-5) part [\(iii\),](#page-17-1) if $\cos\varphi_j^{t_0}=1$, then $I_+(\bm{\alpha}_j^{t_0})=[n].$ We now consider two cases. If $t_0=0$, then $\alpha_j^{t_0} = z_j$, but this is ruled out by [Assumption 1,](#page-5-0) part [\(ii\).](#page-5-1) Otherwise t_0 is a point of discontinuity of $\gamma_{I+(\bm{\alpha}_j^t)}$. Since $\bm{\alpha}_j^t$ is a continuous function of t , the set $I_0(\bm{\alpha}_j^{t_0})$ is necessarily non-empty, but this is also a contradiction because this set must be disjoint from $I_{\!+}(\boldsymbol{\alpha}_j^{t_0}).$ \Box

The following proposition strengthens the previously proved statement [\(Proposition 11,](#page-16-5) part [\(iv\)\)](#page-17-2) that $\bm{\alpha}_j^t\neq\bm{0}$, bounding $\|\bm{\alpha}_j^t\|$ from below. In the sequel, we will require analytic expressions for two related

quantities:

$$
\begin{aligned}\n\frac{\mathrm{d}\|\boldsymbol{\alpha}_j^t\|}{\mathrm{d}t} &= \frac{\mathrm{d}\sqrt{\|\boldsymbol{\alpha}_j^t\|^2}}{\mathrm{d}t} = \frac{1}{2\|\boldsymbol{\alpha}_j^t\|} \cdot \frac{\mathrm{d}\|\boldsymbol{\alpha}_j^t\|^2}{\mathrm{d}t} = \frac{2(\boldsymbol{\alpha}_j^t)^\top \cdot s_j \|\boldsymbol{\alpha}_j^t\| \boldsymbol{\gamma}_{I_{\!+}(\boldsymbol{\alpha}_j^t)}}{2\|\boldsymbol{\alpha}_j^t\|} = s_j(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_{\!+}(\boldsymbol{\alpha}_j^t)}\,,\\
\frac{\mathrm{d}}{\mathrm{d}t}\left(\frac{\boldsymbol{\alpha}_j^t}{\|\boldsymbol{\alpha}_j^t\|}\right) &= \frac{\frac{\mathrm{d}\boldsymbol{\alpha}_j^t}{\mathrm{d}t} \cdot \|\boldsymbol{\alpha}_j^t\| - \frac{\mathrm{d}\|\boldsymbol{\alpha}_j^t\|}{\mathrm{d}t} \cdot \boldsymbol{\alpha}_j^t}{\|\boldsymbol{\alpha}_j^t\|^2} = \frac{s_j \|\boldsymbol{\alpha}_j^t\|^2 \boldsymbol{\gamma}_{I_{\!+}(\boldsymbol{\alpha}_j^t)} - s_j \cdot (\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}_{I_{\!+}(\boldsymbol{\alpha}_j^t)} \cdot \boldsymbol{\alpha}_j^t}{\|\boldsymbol{\alpha}_j^t\|^2}\,.\n\end{aligned}
$$

Proposition 13. Let $0 \le t_1 < t_2$ be such that $I_0(\boldsymbol{\alpha}_j^t) = \emptyset$ for all $t \in (t_1, t_2)$ and $I_0(\boldsymbol{\alpha}_j^t) \ne \emptyset$ for at most finitely *many* $t \in [0, t_1]$ *.*

- (i) If t_1 is either 0 or a point of discontinuity of $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}$, then there is a constant $\mu>0$, only dependent on t_1 but not on t or t_2 , such that $\|\boldsymbol{\alpha}_j^t\|\geq \mu$ for all $t\in (t_1,t_2).$
- (*ii*) Suppose $\boldsymbol{\gamma}_{I+(\boldsymbol{\alpha}_j^t)}=\boldsymbol{\gamma}$ for all $t\in(t_1,t_2)$, and denote $\varphi_j^{t_1^+} \coloneqq \measuredangle(\boldsymbol{\alpha}_j^{t_1},\boldsymbol{\gamma})=\arccos\big((\overline{\boldsymbol{\alpha}}_j^{t_1})^{\top}\overline{\boldsymbol{\gamma}}\big)$. Then for all $t \in (t_1, t_2)$ *we have*

$$
\|\boldsymbol{\alpha}_{j}^{t}\| = \frac{1}{2} \cdot (1 + s_{j} \cos \varphi_{j}^{t_{1}^{+}}) \cdot \|\boldsymbol{\alpha}_{j}^{t_{1}}\| \cdot e^{\|\boldsymbol{\gamma}\| (t - t_{1})} + \frac{1}{2} \cdot (1 - s_{j} \cos \varphi_{j}^{t_{1}^{+}}) \cdot \|\boldsymbol{\alpha}_{j}^{t_{1}}\| \cdot e^{-\|\boldsymbol{\gamma}\| (t - t_{1})}.
$$

Proof. We establish part [\(ii\)](#page-19-0) first. The functions $\|\alpha_j^t\|$ and $(\alpha_j^t)^\top \gamma$ satisfy, for all $t \in (t_1, t_2)$, the following system of ordinary differential equations:

$$
\frac{\mathrm{d}\|\boldsymbol{\alpha}_j^t\|}{\mathrm{d}t} = s_j \cdot (\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma} ,\qquad \qquad \frac{\mathrm{d}\big((\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma}\big)}{\mathrm{d}t} = s_j \|\boldsymbol{\gamma}\|^2 \|\boldsymbol{\alpha}_j^t\| .
$$

By the standard theory of linear ODEs, the solution can be sought in the form

$$
\|\boldsymbol{\alpha}_j^t\| = c_1 e^{\|\boldsymbol{\gamma}\|_t} + c_2 e^{-\|\boldsymbol{\gamma}\|_t},
$$

$$
(\boldsymbol{\alpha}_j^t)^\top \boldsymbol{\gamma} = (c_1 e^{\|\boldsymbol{\gamma}\|_t} - c_2 e^{-\|\boldsymbol{\gamma}\|_t}) \cdot s_j \|\boldsymbol{\gamma}\|.
$$

The constants c_1 and c_2 are chosen based on the initial conditions as $t \to t_1^+$, i.e., they should satisfy the following system of linear equations:

$$
\begin{bmatrix} \mathbf{e}^{\|\boldsymbol{\gamma}\|t_1} & \mathbf{e}^{-\|\boldsymbol{\gamma}\|t_1} \\ \mathbf{e}^{\|\boldsymbol{\gamma}\|t_1} & -\mathbf{e}^{-\|\boldsymbol{\gamma}\|t_1} \end{bmatrix} \begin{bmatrix} c_1 \\ c_2 \end{bmatrix} = \begin{bmatrix} \|\boldsymbol{\alpha}_j^{t_1}\| \\ s_j(\boldsymbol{\alpha}_j^{t_1})^{\top} \overline{\boldsymbol{\gamma}} \end{bmatrix}
$$

.

Here we rely on the continuity of $t \mapsto \boldsymbol{\alpha}_j^t.$ We obtain

$$
\begin{aligned} \|\boldsymbol{\alpha}_j^t\| = \tfrac{1}{2} \cdot \left(\|\boldsymbol{\alpha}_j^{t_1}\| + s_j (\boldsymbol{\alpha}_j^{t_1})^{\!\top} \overline{\boldsymbol{\gamma}} \right) \cdot \mathrm{e}^{\|\boldsymbol{\gamma}\|(t-t_1)} + \\ \tfrac{1}{2} \cdot \left(\|\boldsymbol{\alpha}_j^{t_1}\| - s_j (\boldsymbol{\alpha}_j^{t_1})^{\!\top} \overline{\boldsymbol{\gamma}} \right) \cdot \mathrm{e}^{-\|\boldsymbol{\gamma}\|(t-t_1)} \ , \end{aligned}
$$

which can then be rewritten in the required form.

We now establish part [\(i\).](#page-19-1) By the continuity of dot products $(\alpha_j^t)^\top x_i$, there exists a vector $\gamma\in\mathbb{R}^d$ such that $\gamma_{I_+(\alpha_j^t)}=\gamma$ for all $t\in(t_1,t_2).$ In the degenerate case, $\gamma=0$, we have $\alpha_j^t=\alpha_j^{t_1}$ for all $t \in (t_1, t_2)$. Hence, we can choose $\mu := \|\boldsymbol{\alpha}_j^{t_1}\|$, which is positive by [Proposition 11,](#page-16-5) part [\(iv\).](#page-17-2) We will therefore assume $\gamma\neq 0$. The idea is to rely on [Proposition 13,](#page-19-2) part [\(ii\),](#page-19-0) noting that $\cos\varphi_j^{t_1^+}=$ $\lim_{t\to t_1^+}(\overline{\alpha}_j^t)^{\top}\overline{\gamma}=(\overline{\alpha}_j^{t_1})^{\top}\overline{\gamma}\geq 0$, by [Proposition 11,](#page-16-5) part [\(ii\),](#page-17-0) and by continuity of α_j^t . So, if $s_j=+1$, then clearly $\|\bm\alpha_j^t\|\geq\frac{1}{2}\|\bm\alpha_j^{t_1}\|=:\mu.$ If $s_j=-1$, then, again dropping the second term in the closed-form expression for $\|\boldsymbol{\alpha}_j^t\|$, we obtain $\|\boldsymbol{\alpha}_j^t\| \geq \frac{1}{2}\|\boldsymbol{\alpha}_j^{t_1}\| \cdot (1-\lim_{t\to t_1^+}\cos\varphi_j^t)\cdot 1$. By [Proposition 12,](#page-17-3) part [\(v\),](#page-17-8) $\lim_{t \to t_1^+} \cos \varphi_j^t < 1$, which completes the proof. \Box

Proposition 14. For all $j \in J_+ \cup J_-$ there exist a unique enumeration $i_j^1, \ldots, i_j^{n_j}$ of $I_{-s_j}(\boldsymbol{z}_j)$ and unique $\tau_j^1,\ldots,\tau_j^{n_j}\in[0,\infty)$ such that for all $\ell\in[n_j]$ the following hold, where $\tau_j^0:=0$, $\varphi_j^{(\ell-1)^+}:=\lim_{t\to(\tau_j^{\ell-1})^+}\varphi_j^t$, $\varphi_j^{\ell^-} \coloneqq \lim_{t \to (\tau_j^\ell)^-} \varphi_j^t$, and

\n(ii) $\sin \left(\varphi_{j}^{(\ell-1)^{+}} - \varphi_{j}^{\ell-}\right) / \sin \varphi_{j}^{\ell-} = -\left(\overline{\alpha}_{j}^{\ell_{j}^{\ell-1}}\right)^{\top} \overline{x}_{i_{j}^{\ell}} / \overline{\gamma}_{I_{j}^{\top}} \overline{x}_{i_{j}^{\ell}};$

Proof. Throughout, we let $j \in J_+ \cup J_-$ stay fixed but arbitrary.

Parts [\(i\),](#page-20-1) [\(iii\),](#page-20-2) [\(iv\),](#page-20-3) and [\(v\).](#page-20-4) We establish these parts by a common inductive argument. The induction is on ℓ , ranging from 1 to n_j . We do not separate the base case. We first notice that $d((\bm{\alpha}_j^t)^\top \overline{\bm{x}}_i)/dt=$ $s_j\|\bm{\alpha}_j^t\|\cdot (\bm{\gamma}_{I_+(\bm{\alpha}_j^t)})^{\!\top\!} \bm{\overline{x}}_i.$ In particular, for any fixed $i\in [n]$ we can write

$$
s_j(\boldsymbol{\alpha}_j^{\xi})^{\top} \overline{\boldsymbol{x}}_i = s_j \left(\boldsymbol{\alpha}_j^{\tau_{j-1}^{\ell-1}} \right)^{\top} \overline{\boldsymbol{x}}_i + \int_{\tau_j^{\ell-1}}^{\xi} \|\boldsymbol{\alpha}_j^t\| \cdot (\boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^t)})^{\top} \overline{\boldsymbol{x}}_i \, \mathrm{d}t \,. \tag{1}
$$

This equality holds for any $\xi > \tau_j^{\ell-1}$ as long as the integral on the right-hand side is well-defined; we first need to justify the existence of an appropriate $\xi > \tau_j^{\ell-1}$. This is not automatic because the function $\gamma_{I+({\bm \alpha}^t_j)}$ is not assumed continuous. We consider two cases.

If $\ell = 1$, then $I_0 \left(\boldsymbol{\alpha}_j^{\tau_j^{\ell-1}} \right)$ $\hat{\phi} = \emptyset$ by [Assumption 1,](#page-5-0) part [\(ii\),](#page-5-1) and thus $\left(\alpha_j^{\tau_j^{\ell-1}}\right)$ $\bigg \rangle \overset{\shortmid }{\overline{x}}_{i}$ are all non-zero; by continuity of α_j^t , this holds in a sufficiently small right-neighbourhood of $\tau_j^{\ell-1}$. Thus, if the set $\{t > \tau_j^{\ell-1} \mid I_0(\alpha_j^t) \neq \emptyset\}$ is non-empty, its infimum is strictly greater than $\tau_j^{\ell-1}$, and we can pick this infimum as ξ. In fact, we will show below that the set cannot be empty, but for now let us say that it is safe to pick any $\xi > \tau_j^{\ell-1}$ in this hypothetical situation.

Now suppose $\ell > 1$, then by the inductive hypothesis $I_0\!\left(\boldsymbol{\alpha}_j^{\tau_j^{\ell-1}}\right)$ $\bigg)=\{i_j^{\ell-1}\}.$ For all $i\neq i_j^{\ell-1}$, we have $\left(\boldsymbol{\alpha}_j^{\tau_j^{\ell-1}}\right)$ $\int \overline{x}_i\neq 0$ and thus each $(\bm\alpha_j^t)^\top \overline{\bm x}_i$ maintains the sign in some right-neighbourhood of $\tau_j^{\ell-1}.$ For $i = i_j^{\ell-1}$, rewrite [Equation 1](#page-20-5) as

$$
s_j(\boldsymbol{\alpha}_j^{\xi})^{\top} \overline{\boldsymbol{x}}_{i_j^{\ell-1}} = \int_{\tau_j^{\ell-1}}^{\xi} \|\boldsymbol{\alpha}_j^{\xi}\| \cdot (\boldsymbol{\gamma}_{I_{+}(\boldsymbol{\alpha}_j^{\xi})})^{\top} \overline{\boldsymbol{x}}_{i_j^{\ell-1}} dt ,
$$
\n(2)

where the integrand is non-negative. Therefore, the function $s_j(\alpha_j^\xi)^\top\overline{x}_{i_j^{\ell-1}}$ is non-negative for all $\xi>\tau_j^{\ell-1}$ and moreover is non-decreasing. Consider the set I_j^ℓ defined in the statement of the proposition; we have $\emptyset\neq I_j^\ell=I_+(\bm\alpha_j^t)$ and $(\bm\gamma_{I_+(\bm\alpha_j^t)})^\top\overline{\bm x}_{i_j^{\ell-1}}>0$ for all t greater than $\tau_j^{\ell-1}$ in a small neighbourhood of $\tau_j^{\ell-1}.$ (Note that $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}\neq\bm{0}$ by [Proposition 11,](#page-16-5) part [\(i\).](#page-16-4)) So we can replace $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)}$ with $\bm{\gamma}_{I_j^\ell}$ in [Equation 2](#page-21-0) if ξ is close enough to $\tau_j^{\ell-1}$; we have now shown the existence of a $\xi>\tau_j^{\ell-1}$ such that $I_+(\bm{\alpha}_j^t)=\bm{\gamma}_{I_j^\ell}$ for all $t\in (\tau_j^{\ell-1},\xi)$. (In fact, we can again choose $\xi\coloneqq\inf\{t>\tau_j^{\ell-1}\mid I_0(\bm{\alpha}_j^t)\neq \emptyset\}.$)

Having found an appropriate ξ , let us observe that, by the inductive hypothesis (part [\(v\)\)](#page-20-4) and by the choice of ξ , the set $I_0(\alpha_j^t)$ is only non-empty for finitely many time points $t \in [0,\xi]$. Let us consider

$$
I' \coloneqq \left\{ i \in [n] \mid s_j\left(\boldsymbol{\alpha}_j^{\tau_j^{\ell-1}}\right)^\top \overline{\boldsymbol{x}}_i < 0 \right\} = I_{-s_j}(\boldsymbol{z}_j) \setminus \{i_j^1, \ldots, i_j^{\ell-1}\} \ .
$$

Recalling that all training points are positively correlated, we see that $(\gamma_{I_j^\ell})^+\overline{x}_i>0.$ By [Proposition 13,](#page-19-2) part [\(i\),](#page-19-1) the integrand in [Equation 1](#page-20-5) is lower-bounded by $\mu\cdot(\bm{\gamma}_{I^{\ell}_j})^|\,\overline{\bm{x}}_i$ for all $t.$ Therefore, for each $i\in I'$ the expression on the right-hand side of [Equation 1](#page-20-5) tends to $+\infty$ if we let, formally, $\xi \to +\infty$. Since for $\xi = \tau_j^{\ell-1}$ each of the right-hand sides is negative if $i \in I'$, there exists some $\xi > \tau_j^{\ell-1}$ and an $i \in I'$ for which the left-hand side, $(\bm{\alpha}_j^{\xi})^{\top}\overline{\bm{x}}_i$, becomes 0. Rewriting [Equation 1](#page-20-5) as $\int_{\tau_j^{\ell}-1}^{\xi} \|\bm{\alpha}_j^t\| \, \mathrm{d}t = r_i$, where $r_i\coloneqq -s_j\biggl(\!\alpha_j^{\tau_j^{\ell-1}}\!\!\!$ $\int_{0}^{1} \overline{\bm{x}}_i / (\bm{\gamma}_{I^{\ell}_j})^\top \overline{\bm{x}}_i > 0$, we observe that the integral on the left-hand side does not depend on *i*. Thus, the smallest $\xi > \tau_j^{\ell-1}$ for which the integral is equal to r_i for some $i \in I'$ is the earliest time point after $\tau_j^{\ell-1}$ at which the set $I_0(\bm{\alpha}_j^\xi)$ becomes non-empty. This value of ξ is then, by definition, $\tau_j^\ell.$ Since for $\xi=\tau_j^{\ell-1}$ the integral is zero and since $r_i>0$ for all $i\in I'$, we also have $I_0(\bm{\alpha}_j^{\xi})=\{i_j^\ell\}$ where

To complete the proof of the inductive step for part [\(i\),](#page-20-1) it remains to note that rescaling each r_i by a factor of $\left\Vert \gamma_{I_{j}^{\ell}}\right\Vert$ $\Big\}$ $\bm{\alpha}_j^{\tau_j^{\ell-1}}$ $\begin{array}{c} \hline \end{array}$ does not change the arg min.

 $i = i_j^{\ell}$ is the index of the smallest r_i among $i \in I'$; this i is unique by [Assumption 1,](#page-5-0) part [\(iv\).](#page-5-3)

Notice that, for the current value of ℓ we have also justified the inequality $\tau_j^{\ell-1} < \tau_j^\ell$ of part [\(iii\),](#page-20-2) as well as equalities $I_{+}(\bm{\alpha}_j^t)=I_j^\ell$ and $I_0(\bm{\alpha}_j^t)=\emptyset$ for all $t\in(\tau_j^{\ell-1},\tau_j^\ell)$, and $I_0\!\left(\bm{\alpha}_j^{\tau_j^\ell}\right)$ $\bigg) = \{i_j^{\ell}\}\text{, which together}$ comprise parts [\(iv\)](#page-20-3) and [\(v\).](#page-20-4) This completes the inductive argument, proving parts [\(i\),](#page-20-1) [\(iii\),](#page-20-2) [\(iv\),](#page-20-3) and [\(v\).](#page-20-4) Intermediate summary. We have already established uniqueness of the enumeration $i_j^1, \ldots, i_j^{n_j}$ and time points $\tau_j^1, \ldots, \tau_j^{n_j}$: part [\(iii\)](#page-20-2) requires that the latter be sorted in the ascending order, and our argument for the choice of τ_j^ℓ makes it clear that there is always only one possibility, if we want to require (as parts [\(iv\)](#page-20-3) and [\(v\)](#page-20-4) do) that $I_+(\bm{\alpha}^t_j)$ remain constant in between $\tau_j^{\ell-1}$ and τ_j^ℓ , and $I_0\!\left(\bm{\alpha}^{\tau_j^\ell}_j\right)$ be non-empty. In addition, we now know that the assumption of [Proposition 12](#page-17-3) holds for every time segment $[0,T]$ such that $\gamma_{I+(\alpha_j^t)}\neq 0$ for all $t\in [0,T)$; and in particular up to $T=\tau_j^{n_j}.$

Parts [\(vii\),](#page-20-6) [\(viii\),](#page-20-7) and [\(ix\).](#page-20-8) For part (vii), suppose $\ell < n_j$. By [Proposition 12,](#page-17-3) part [\(iii\),](#page-17-7) both one-sided limits of $\cos \varphi^t_j$ as $t \to (\tau^\ell_j)^\pm$ exist. By part [\(iv\)](#page-20-3) of the current proposition,

$$
\lim_{t\rightarrow(\tau^\ell_j)^-}\cos\varphi_j^t=\frac{\left(\!\alpha_j^{\tau^\ell_j}\!\right)^\!\!\gamma_{I^\ell_j}}{\left\|\alpha_j^{\tau^\ell_j}\right\|\left\|\gamma_{I^\ell_j}\right\|}\qquad\text{and}\qquad\lim_{t\rightarrow(\tau^\ell_j)^+}\cos\varphi_j^t=\frac{\left(\!\alpha_j^{\tau^\ell_j}\!\right)^\!\!\gamma_{I^{\ell+1}_j}}{\left\|\alpha_j^{\tau^\ell_j}\right\|\left\|\gamma_{I^{\ell+1}_j}\right\|}\,,
$$

and we notice that the numerators are equal by [Proposition 12,](#page-17-3) part [\(i\).](#page-17-4) Multiplying each limit by the norm of the corresponding γ , we obtain the desired equation.

Part [\(viii\)](#page-20-7) follows from the same calculations in the case $\ell = n_j$, where instead of $I_j^{\ell+1}$ we use $I_j^{n_j} \cup$ $\{i_j^{n_j}\} = [n].$

For part [\(ix\)](#page-20-8) we observe that $I_j^{n_j}=\{i_j^{n_j}\}$, so we have $I_+\!\left(\!\boldsymbol{\alpha}_j^{\tau_j^{n_j}}\!\right)$ $\bigg) = \emptyset$ and $I_0 \left(\alpha_j^{\tau_j^{n_j}} \right)$ $\bigg) = \{ i_j^{n_j} \},$ so indeed $\cos \varphi_j^t \to 0$ as $t \to (\tau_j^{n_j})^-$.

Part [\(vi\).](#page-20-9) We rely on the facts that $I_0(\bm{\alpha}_j^t) = \emptyset$ and that $\bm{\gamma}_{I_+(\bm{\alpha}_j^t)} \equiv \bm{\gamma}_{I_j^{\ell}}$ for all $t \in (\tau_j^{\ell-1}, \tau_j^{\ell})$, proved in parts [\(iv\)](#page-20-3) and [\(v\).](#page-20-4) Notice that

$$
\frac{\mathrm{d}\big((\boldsymbol{\alpha}^t_j)^\top \boldsymbol{\gamma}_{I^{\ell}_j}\big)}{\mathrm{d}t} = s_j\|\boldsymbol{\alpha}^t_j\|\big\|\boldsymbol{\gamma}_{I^{\ell}_j}\big\|^2
$$

and, using a previously obtained formula for $\mathrm{d} \| \alpha_j^t \| / \mathrm{d} t$ (just before [Proposition 13\)](#page-19-2),

\frac{\mathrm{d}\cos\varphi_{j}^{t}}{\mathrm{d}t} = \frac{\mathrm{d}}{\mathrm{d}t} \left(\frac{(\boldsymbol{\alpha}_{j}^{t})^{\top}\boldsymbol{\gamma}_{I_{j}^{\ell}}}{\|\boldsymbol{\alpha}_{j}^{t}\| \cdot \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|} \right)
$$
\n
$$
= \frac{\frac{\mathrm{d}}{\mathrm{d}t}((\boldsymbol{\alpha}_{j}^{t})^{\top}\boldsymbol{\gamma}_{I_{j}^{\ell}})}{\|\boldsymbol{\alpha}_{j}^{t}\|^{2}\|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|^{2}} - \frac{\|\boldsymbol{\gamma}_{I_{j}^{\ell}}\| \cdot \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\| - \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\| \cdot \frac{\mathrm{d}\|\boldsymbol{\alpha}_{j}^{t}\|}{\mathrm{d}t} \cdot (\boldsymbol{\alpha}_{j}^{t})^{\top}\boldsymbol{\gamma}_{I_{j}^{\ell}}}{\|\boldsymbol{\alpha}_{j}^{t}\|^{2}\|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|^{2}}
$$
\n
$$
= \frac{s_{j} \|\boldsymbol{\alpha}_{j}^{t}\| \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|^{2} \|\boldsymbol{\alpha}_{j}^{t}\| \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\| - \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|(\boldsymbol{\alpha}_{j}^{t})^{\top}\boldsymbol{\gamma}_{I_{j}^{\ell}} \cdot s_{j} (\boldsymbol{\alpha}_{j}^{t})^{\top}\boldsymbol{\gamma}_{I_{j}^{\ell}}}{\|\boldsymbol{\alpha}_{j}^{t}\|^{2}\|\boldsymbol{\gamma}_{I_{j}^{\ell}}\|^{2}}
$$

= s_{j} \|\boldsymbol{\gamma}_{I_{j}^{\ell}}\| (1 - \cos^{2}\varphi_{j}^{t}).

Separating variables, we obtain

$$
\frac{\mathrm{d}\cos\varphi_j^t}{1-\cos^2\varphi_j^t}=s_j\big\|\boldsymbol{\gamma}_{I_j^\ell}\big\|\mathrm{d} t\;,
$$

and so $\arctanh\cos\varphi_j^t=s_j\|\bm{\gamma}_{I_j^\ell}\|$ $t+C$ for $t\in(\tau_j^{\ell-1},\tau_j^\ell)$, where the constant C is determined from the initial condition $\lim_{t\to(\tau_j^{\ell-1})^+}$ artanh $\cos\varphi_j^t=s_j\big\|\boldsymbol{\gamma}_{I_j^\ell}\big\| \, \tau_j^{\ell-1}+C.$ The left-hand side is well-defined, since $\cos \varphi_j^{(\ell-1)^+} \notin \{-1,1\}$. Indeed, $\cos \varphi_j^t \geq 0$ for all t by [Proposition 11,](#page-16-5) part [\(ii\),](#page-17-0) so the limit cannot be negative; it thus suffices to rule out the value 1. The case $s_j = -1$ is already handled in [Proposition 12,](#page-17-3) part [\(v\).](#page-17-8) For $s_j = +1$, we observe that, if $\ell > 1$, then $\cos \varphi_j^{(\ell-1)^-} > \cos \varphi_j^{(\ell-1)^+}$ by part [\(vii\)](#page-20-6) of the current proposition, since $\|\boldsymbol{\gamma}_{I^{\ell-1}_j}\|$ $\|^2\,<\, \big\|\boldsymbol{\gamma}_{I^{\ell-1}_j\cup\{i^{\ell-1}_j\}}\big\|$ $\alpha^2 \;=\; \bigl\| \boldsymbol{\gamma}_{I^{\ell}_j} \bigr\|$ 2 ² thanks to the positive correlation between training points; hence $\cos\varphi_j^{(\ell-1)^+} < 1$. Finally, $\ell = 1$ implies $\cos\varphi_j^{(\ell-1)^+} = \lim_{t\to 0^+} \cos\varphi_j^t = 1$ $\cos\measuredangle(\bm z_j,\gamma_{I+(\bm\alpha_j^0)})=1$, and in this case $I_+(\bm\alpha_j^0)=[n]$ by [Proposition 11,](#page-16-5) part [\(iii\).](#page-17-1) Hence, $I_{-s_j}(\bm z_j)=\emptyset$ and $n_j=0$, a contradiction. In conclusion, we have thus argued that $\cos\varphi^{(\ell-1)^+}_j\not\in\{-1,1\}$ in all cases, so artanh $\cos\varphi_j^t=s_j\|\bm{\gamma}_{I_j^{\ell}}\|(t-\tau_j^{\ell-1})+$ artanh $\cos\varphi_j^{(\ell-1)^+}$ and it remains to take the hyperbolic tangent on both sides of this equation to prove part [\(vi\)](#page-20-9) for $t \in (\tau_j^{\ell-1}, \tau_j^{\ell}).$

Part (*x*). We rely on the result of part [\(vi\).](#page-20-9) Recall the analytic expression for the derivative $d\bar{\alpha}_j^t/dt$, obtained just before [Proposition 13.](#page-19-2) Notice that, for all $t \in (\tau_j^{\ell-1}, \tau_j^\ell)$, the derivative $d\overline{\alpha}_j^t/dt$ belongs to the linear subspace spanned by vectors $\overline\alpha^t_j$ and $\overline\gamma_{I^{\ell}_j}.$ It follows that $\overline\alpha^t_j$ can be expressed as a linear combination of two fixed vectors, $\overline{\alpha}_j^{\tau_j^{\ell-1}}$ and $\overline{\gamma}_{I_j^\ell}.$ It is thus sufficient to check that the vector

\pmb f \coloneqq \left(\sin(\varphi_j^t) \, \overline{\pmb \alpha}_j^{\tau_j^{\ell-1}} + \sin\Bigl(\varphi_j^{(\ell-1)^+} - \varphi_j^t\Bigr) \, \overline{\gamma}_{I_j^{\ell}}\right) \Big/ \sin \varphi_j^{(\ell-1)^+}
$$

has norm 1 and forms an angle of φ^t_j with $\bm{\gamma}_{I_j^\ell}.$ We have

\begin{split} \|\pmb{f}\|^2 = \left(\frac{\sin\varphi_j^t}{\sin\varphi_j^{(\ell-1)^+}}\right)^{\!\!2} &+ \left(\frac{\sin\!\left(\varphi_j^{(\ell-1)^+}-\varphi_j^t\right)}{\sin\varphi_j^{(\ell-1)^+}}\right)^{\!\!2} \\ &+ 2\cdot\frac{\sin\varphi_j^t\,\sin\!\left(\varphi_j^{(\ell-1)^+}-\varphi_j^t\right)}{\sin^2\varphi_j^{(\ell-1)^+}}\cdot\cos\varphi_j^{(\ell-1)^+} \end{split}
$$

.

Denote $a=\varphi^t_j$ and $b=\varphi^{(\ell-1)^+}_j-\varphi^t_j$, then

||f||^2 = \frac{\sin^2 a + \sin^2 b + 2 \sin a \sin b \cos(a + b)}{\sin^2(a + b)}
$$

=

\frac{\sin^2 a + \sin^2 b + 2 \sin a \sin b (\cos a \cos b - \sin a \sin b)}{(\sin a \cos b + \cos a \sin b)^2}

=

\frac{\sin^2 a + \sin^2 b + 2 \sin a \sin b (\cos a \cos b - \sin a \sin b)}{\sin^2 a \cos^2 b + 2 \sin a \cos b \cos a \sin b + \cos^2 a \sin^2 b}

\frac{\sin^2 a + \sin^2 b + 2 \sin a \sin b \cos a \cos b - 2 \sin^2 a \sin^2 b}{\sin^2 a (1 - \sin^2 b) + 2 \sin a \cos b \cos a \sin b + (1 - \sin^2 a) \sin^2 b}
$$

= 1.

To verify the second claim, observe that

$$
\begin{aligned} \boldsymbol{f}^\top \overline{\boldsymbol{\gamma}}_{I_j^\ell} &= \frac{\sin \varphi_j^t}{\sin \varphi_j^{(\ell-1)+}} \cdot \left(\overline{\boldsymbol{\alpha}}_j^{\tau_\ell^{ \ell-1}} \right)^\top \!\! \overline{\boldsymbol{\gamma}}_{I_j^\ell} + \frac{\sin \left(\varphi_j^{(\ell-1)^+} - \varphi_j^t \right)}{\sin \varphi_j^{(\ell-1)+}} \cdot \left\| \overline{\boldsymbol{\gamma}}_{I_j^\ell} \right\|^2 \\ &= \frac{\sin \varphi_j^t \cos \varphi_j^{(\ell-1)^+} + \sin \varphi_j^{(\ell-1)^+} \cos \varphi_j^t - \cos \varphi_j^{(\ell-1)^+} \sin \varphi_j^t}{\sin \varphi_j^{(\ell-1)^+}} \end{aligned}
$$

$$
= \cos \varphi_j^t .
$$

We must still check still that the vector f is on the correct side of $\overline{\gamma}_{I^{\ell}_j}$: indeed, there are two arcs on the unit circle that connect the endpoint of vector $\overline{\gamma}_{I_j^\ell}$ with a point at arc length φ_j^t away from it. However, this check is easy: for $t=\tau_j^{\ell-1}$, only one of these arcs connects $\overline{\gamma}_{I_j^\ell}$ to $\overline{\alpha}_j^{\tau_j^{\ell-1}}$, and we can see that $\boldsymbol{f}\rightarrow \overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell-1}}$ as $\varphi_j^t \rightarrow \varphi_j^{(\ell-1)^+}.$

Part (ii). Let $t \to (\tau_j^{\ell})^-$ in the equation of part [\(x\),](#page-20-10) and take the dot product of each side with $\overline{x}_{i_j^{\ell}}$. Observe that $\left(\overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell}}\right)$ $\int \overline{\bm{x}}_{i_j^\ell} = 0$, because $I_0 \!\left(\bm{\alpha}_j^{\tau_j^\ell}\right)$ $\bigg) = \{i_j^{\ell}\}\$ by part [\(v\).](#page-20-4) We obtain $0 =$ $\sin \varphi_j^{\ell^-}$. $\left(\overline{\bm{\alpha}}^{\tau_j^{\ell-1}}_j\right)$ $\int \mathbf{\bar{x}}_{i^\ell_j} + \sin\Bigl(\varphi^{(\ell-1)^+}_j - \varphi^{\ell^-}_j\Bigr) \cdot \bigl(\overline\gamma_{I^\ell_j}\bigr)^\top \overline{\bm{x}}_{i^\ell_j}$ $\sin \varphi_j^{(\ell-1)+}$

and the required equation follows. It remains to note that $\sin \varphi_j^{\ell^-} \neq 0$ because otherwise either $\varphi_j^{(\ell-1)^+}-\varphi_j^{\ell^-}\in\{-\pi,0,\pi\}$ or $\big(\overline\gamma_{I_j^\ell}\big)^\top\overline{\bm{x}}_{i_j^\ell}=0.$ The former is impossible because we know already from part [\(vi\)](#page-20-9) that $\cos\varphi_j^t \in (0,1)$ when $t \in (\tau_j^{\ell-1},\tau_j^\ell)$, and $\varphi_j^t \geq 0$ by definition, so $\varphi_j^{(\ell-1)^+} = \varphi_j^{\ell^-}$ but this would still contradict part [\(vi\).](#page-20-9) The latter is impossible because $I_j^{\ell} \neq \emptyset$ and, by [Proposition 11,](#page-16-5) part [\(i\),](#page-16-4) the dot product must be positive due to positive correlation between training points.

Part (xi). Consider any interval (t_1, t_2) such that $I_0(\alpha_j^t) = \emptyset$ for all $t \in (t_1, t_2)$, and let $\gamma := \gamma_{I_+(\alpha_j^t)}$; the choice of t in the interval is immaterial by the continuity of the map $t \mapsto \alpha_j^t$ and of the dot product function with a fixed vector $x_i.$ We have $\gamma=\gamma_{I^{\ell}_j}$ when $t\in(\tau_j^{\ell-1},\tau_j^\ell)$ by part [\(iv\).](#page-20-3) Recall our calculations for the derivative of $\|\alpha_j^t\|$ and of $\overline{\alpha}_j^t$ (before [Proposition 13\)](#page-19-2). We have $d\overline{\alpha}_j^t/dt = s_j p$, where $p\coloneqq \gamma-\overline{\alpha}_j^t\cdot (\overline{\alpha}_j^t)^\top\gamma$ is the vector obtained by subtracting from γ its orthogonal projection onto the line with direction α^t_j . Then

s_j \frac{\mathrm{d} (\overline{\bm{\alpha}}^t_j)^\top \overline{\bm{x}}_i}{\mathrm{d} t} = \bm{\gamma}^\top \overline{\bm{x}}_i - (\overline{\bm{\alpha}}^t_j)^\top \overline{\bm{x}}_i \cdot (\overline{\bm{\alpha}}^t_j)^\top \bm{\gamma} .
$$

For $t \in (t_1, t_2)$, we have $(\overline{\alpha}_j^t)^\top \overline{x}_i \leq 0$ because $i \notin I_+(\alpha_j^t)$. Recall that $(\overline{\alpha}_j^t)^\top \gamma \geq 0$ by [Proposition 11,](#page-16-5) part [\(ii\).](#page-17-0) We have shown that $-(\overline{\alpha}_j^t)^\top \overline{x}_i \cdot (\overline{\alpha}_j^t)^\top \gamma \geq 0$, completing the proof of part [\(xi\).](#page-20-12)

Part (*xii*). We continue the calculation from part (*xi*) assuming that $s_j = -1$ and $i = i_j^{\ell}$. For the function $g(t)\coloneqq (\overline{\boldsymbol{\alpha}}_j^t)^\top \overline{\boldsymbol{x}}_{i_j^\ell}$, we have

\frac{dg}{dt} = -\gamma^{\top} \overline{x}_{i_j^{\ell}} + (\overline{\alpha}_j^t)^{\top} \overline{x}_{i_j^{\ell}} \cdot (\overline{\alpha}_j^t)^{\top} \gamma ,

\frac{1}{\|\gamma\|} \frac{d^2 g}{dt^2} = \frac{d}{dt} ((\overline{\alpha}_j^t)^{\top} \overline{\gamma}) \cdot (\overline{\alpha}_j^t)^{\top} \overline{x}_{i_j^{\ell}} + (\overline{\alpha}_j^t)^{\top} \overline{\gamma} \cdot \frac{d}{dt} ((\overline{\alpha}_j^t)^{\top} \overline{x}_{i_j^{\ell}})
$$
\n
$$
= \frac{d \cos \varphi_j^t}{dt} \cdot g + \cos \varphi_j^t \cdot \frac{dg}{dt} .
$$

We will show the following two properties:

- dg/dt < 0 as $t \to (\tau_j^{\ell-1})^+$;
- if $\frac{dg}{dt} = 0$ for some t, then $\frac{d^2g}{dt^2} < 0$ for the same t.

Together, these properties imply that $dg/dt < 0$ throughout the interval $(\tau_j^{\ell-1}, \tau_j^\ell)$. Indeed, assume otherwise for the sake of contradiction, then $dg/dt = 0$ at some point $t_0 \in (\tau_j^{\ell-1}, \tau_j^{\ell})$. By the second property, g must have a local maximum at t_0 , and in particular $\frac{dg}{dt} > 0$ for all $t < t_0$ close enough to t_0 . By the first property, the minimum of $\frac{dg}{dt}$ on $(\tau_j^{\ell-1}, t_0)$ exists and is attained at an interior point of the interval. But this contradicts the second property.

Let us now justify the properties. For the first property, notice that

$$
\begin{split} \left. \frac{\mathrm{d}g}{\mathrm{d}t} \right|_{t \to (\tau_j^{\ell-1})^+} &= -\Vert \boldsymbol{\gamma} \Vert \cdot \left(\overline{\boldsymbol{\gamma}}^\top \overline{\boldsymbol{x}}_{i_j^\ell} - \left(\overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell-1}} \right)^\top \overline{\boldsymbol{x}}_{i_j^\ell} \cdot \left(\overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell-1}} \right)^\top \overline{\boldsymbol{\gamma}} \right) \\ &= -\Vert \boldsymbol{\gamma} \Vert \cdot (\overline{\boldsymbol{\gamma}}^\top \overline{\boldsymbol{x}}_{i_j^\ell}) \cdot \left(1 - \frac{\left(\overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell-1}} \right)^\top \overline{\boldsymbol{x}}_{i_j^\ell}}{\overline{\boldsymbol{\gamma}}^\top \overline{\boldsymbol{x}}_{i_j^\ell}} \cdot \left(\overline{\boldsymbol{\alpha}}_j^{\tau_j^{\ell-1}} \right)^\top \overline{\boldsymbol{\gamma}} \right) . \end{split}
$$

Here, $\overline{\gamma}^\top \overline{x}_{i_j^\ell} > 0$ since $i_j^\ell \in I_j^\ell.$ The value of the ratio $\left(\overline{\alpha}_j^{\tau_j^{\ell-1}}\right)$ $\int \overline{\bm{x}}_{i^\ell_j} \big/ \overline{\bm{\gamma}}^\top \overline{\bm{x}}_{i^\ell_j}$ appears in the statement of part [\(i\),](#page-20-1) and in particular replacing the index i_j^{ℓ} with any other $i \in I_j^{\ell}$ would result in a higher (positive) value. Therefore, if we assume for the sake of contradiction that the right-hand side in the last equation is non-negative, then it will remain non-negative if i_j^ℓ is replaced with every other $i \in I_j^\ell.$ In other words, if $g(t)=(\overline{\bm{\alpha}}_j^t)^\top\overline{\bm{x}}_{i_j^\ell}$ is non-decreasing in a right-neighbourhood of $\tau_j^{\ell-1}$, so is every dot product $(\overline{\alpha}_j^t)^\top \overline{x}_i$ with $i \in I_j^\ell$. But then their linear combination with positive coefficients $y_i ||x_i||/n$ is also non-decreasing. This, however, is not possible because this linear combination is $(\overline\alpha_j^t)^\top\gamma_{I+(\alpha_j^t)}$, and we already saw in the proof of part [\(xi\)](#page-20-12) that $d\overline{\alpha}_j^t/dt = s_j p$, where p is an orthogonal projection of $\gamma_{I+(\alpha_j^t)}$ onto a proper subspace. By standard properties of projections we must have $p^+\gamma_{I+(\alpha_j^t)}>0$ and, since $s_j=-1$, ${\rm d}\big((\overline\alpha_j^t)^{\top}\gamma_{I_+(\bm\alpha_j^t)}\big)/{\rm d}t< 0$, which is a contradiction. (The case $\bm p^{\top}\gamma_{I_+(\bm\alpha_j^t)}=0$ is impossible by [Proposition 12,](#page-17-3) part [\(v\),](#page-17-8) as we would then have $\cos\varphi_j^{(\ell-1)^+}=1.$) This concludes the proof of the first property.

The second property follows directly from the equation for ${\rm d}^2g/{\rm d}t^2$, because $\cos\varphi_j^t$ decreases by part [\(vi\)](#page-20-9) and because $g > 0$.

For the sign of second derivative in general, it remains to consider the second term. The first factor is positive by [Proposition 11,](#page-16-5) part [\(ii\);](#page-17-0) and we just proved above that $dg/dt < 0$. (Note that $\gamma \neq 0$ by Proposition 11, part (i) because $i^{\ell} \in I_1(\alpha^{\ell})$) This completes the proof of part (xii) [Proposition 11,](#page-16-5) part [\(i\),](#page-16-4) because $i_j^{\ell} \in I_+(\alpha_j^t)$.) This completes the proof of part [\(xii\).](#page-20-13)

Corollary 15. For all $j \in J_+ \cup J_-$, the set of all $z_j \in \mathbb{R}^d$ such that $|I_0(\alpha_j^t)| > 1$ for some $t \in [0, \infty)$ has *Lebesgue measure zero.*

Proof. A single yardstick trajectory at any time t follows a direction γ_S for some $S \subseteq [n]$. The set S changes at most *n* times, namely at the crossing of $\bigcup_{i\in[n]} H_i$, where H_i is the set of vectors orthogonal to the training point x_i . (The proof of this fact does not rely on [Assumption 1,](#page-5-0) part [\(iv\).](#page-5-3) It is a consequence of [Proposition 12,](#page-17-3) part [\(iv\).](#page-17-6) We note that the assumption of [Proposition 12](#page-17-3) is shown to be valid in the proof of [Proposition 14,](#page-20-0) under "Intermediate summary" on [page 23.](#page-21-0))

The union U of all $H_i \cap H_k$, $i < k$, is a union of finitely many subspaces of dimension $d-2$ (because no two training points are collinear by [Assumption 1,](#page-5-0) part [\(iii\)\)](#page-5-2). Consider all the vectors u such that the yardstick trajectory starting at u passes through U . We claim that this is a set of zero measure. Indeed:

• Every convex polyhedron P of dimension $d-2$, for example $H_i \cap H_k$, can be reached by a straight-line trajectory (without change of direction) from a convex polyhedron P' of dimension at most d − 1, i.e., of co-dimension at least 1.

- The previous change of direction occurs at the intersection of the polyhedron P' and the union of all H_i . This intersection is a finite union of convex polyhedra of co-dimension at least 2 , because, for all nonempty subsets $S \subseteq [n]$, the vector γ_S cannot belong to any H_i , thanks to the 45-degree condition. To each of these polyhedra, the previous bullet point applies.
- No more than n changes of direction may take place along a single trajectory.

Thus, all vectors from which a point in U can be reached along a yardstick trajectory belong to a finite union of affine subspaces of co-dimension 1. Thus, they form a measure zero set. \Box

D Proofs for the first phase

Here we prove [Lemma 3,](#page-6-4) [Lemma 4,](#page-6-5) and [Lemma 5,](#page-7-2) as well as a number of related results. The former are subsumed by [Lemma 19,](#page-29-0) [Lemma 21,](#page-30-0) and [Lemma 23](#page-34-0) below.

Recall the definitions of δ and Δ in [section 3:](#page-4-4)

$$

 $\Delta := \max\{\max_{i \in [n]} ||x_i||, \, \max_{j \in [m]} ||z_j||, 1\}.$

Thus δ is the minimum of: the length of any training point, the cosine of the angle between any two training points, the difference between the square roots of any consecutive eigenvalues adjusted by the dimension, the square root of the smallest eigenvalue, the smallest eigenvector coordinate of the teacher neuron adjusted by the square root of the dimension, the length of any unscaled hidden-neuron initialisation, the cosine or sine of the angle between it (if active) and the corresponding vector γ_I depending on whether the last-layer sign is positive or negative (respectively), the absolute cosine of any angle between a trajectory point α^t_j and a training point which is neither the previous nor the next to cross the half-space boundary, the cosine of the angle between any initial negative-sign active hidden neuron and the first data point to cross the boundary, and the time between any two consecutive crossings; and $\Delta \geq 1$ is the maximum length of any traning point or unscaled hiddenneuron initialisation.

First we observe that, immediately from the definitions in [section 3](#page-4-4) of the vectors γ_I , the matrix X , the eigenvalues η_k , the eigenvectors \bm{u}_k , and the coordinates ν_k^* of the teacher neuron with respect to the basis consisting of the eigenvectors, we have the following two alternative expressions for the vector $\gamma_{[n]}.$

Proposition 16. $\boldsymbol{\gamma}_{[n]} = \frac{1}{n}\boldsymbol{X}\boldsymbol{X}^\top \boldsymbol{v}^* = \sum_{k=1}^d \eta_k \nu_k^* \boldsymbol{u}_k.$

Then we establish upper bounds on: the largest eigenvalue of the matrix $\frac{1}{n}XX^\top$, the ratio of any two consecutive eigenvalues in their decreasing ordering, the Euclidean lengths of the vectors γ_I , the cosines of the angles φ^t_j that measure alignment of the yardstick trajectories $\bm{\alpha}^t_j$ (both defined in [section 3\)](#page-4-4) mapped backwards through the hyperbolic tangent sigmoid, and the finish time of the last intermediate alignment stage of a yardstick trajectory; and lower bounds on: the Euclidean lengths of the vectors γ_I , and the cosines of the angles between a yardstick trajectory and the training point that is the next to enter or exit its active half-space.

As for the remaining hidden neurons, i.e. those whose indices are not in the sets J_+ and J_- , they are by definition inactive at initialisation, and by [Assumption 1](#page-5-0) [\(ii\)](#page-5-1) have no training points in their activation boundaries, so they do not change throughout the training.

The next lemma provides a detailed description of the intermediate alignment stages for each hidden neuron. It states that the training points enter or exit the active half-space of each positive-sign or negative-sign (respectively) hidden neuron in the same order as they do for the positive half-space of the corresponding yardstick trajectory, and it provides non-asymptotic bounds for each difference: between a dynamics-governing vector g_j^t (defined in [Proposition 1](#page-4-1) [\(i\)\)](#page-4-0) and the corresponding intermediate

yardstick target $\gamma_{I_j^\ell}$ (the sets I_j^ℓ of indices of training points that are in the active half-space of hidden neuron j during stage ℓ are defined in [Proposition 14\)](#page-20-0), between the unit-sphere normalisations of a hidden neuron and the corresponding yardstick vector, and between the corresponding boundary crossing times for a hidden neuron and its yardstick vector. In particular, it shows that each negativesign initially active hidden neuron j deactivates at time $t_j^{n_j}$, and hence before time T_0 . The proof of the lemma is inductive over the stage index ℓ , and involves carefully controlling the differences between the trajectories on the unit sphere of the hidden neurons and their yardstick vectors; this is non-trivial because, in contrast to the latter which have separate individual dynamics, the dynamics of the former are joint since each governing vector g_j^t depends on the outputs of the whole network.

For each positive-sign hidden neuron, after the completion of all of the intermediate alignment stages (if any), its yardstick vector proceeds to align to the vector $\gamma_{[n]}$. For the cosine of the angle between them, whose starting point is the angle $\varphi_j^{n_j^+}$ defined below, from the proof of [Proposition 14](#page-20-0) [\(vi\)](#page-20-9) we obtain the following expression, which will be useful in the proof of the next lemma. We also remark that the angle $\varphi_j^{n_j^+}$ already featured in [Proposition 14](#page-20-0) [\(viii\).](#page-20-7)

The final lemma in this section establishes non-asymptotic bounds for the final alignment stage in the first phase of the training, which we consider to end at time T_1 . During it, each positive-sign hidden neuron: continues to grow but keeps its length below $2\|z_j\| \lambda^{1-\varepsilon}$, aligns to the vector $\gamma_{[n]}$ up to a cosine of at least $1 - \lambda^{\varepsilon}$, and maintains bounded by $\lambda^{1-3\varepsilon}$ the difference between the logarithm of its length divided by the initialisation scale and the logarithm of the corresponding yardstick vector length. Establishing the latter bound, which is stated in part [\(iv\)](#page-35-0) and will be instrumental in the proof of the implicit bias (cf. [Lemma 34\)](#page-48-1), involves putting together the bounds in [Lemma 21](#page-30-0) [\(iii\),](#page-30-1) [\(iv\),](#page-30-5) and [\(v\),](#page-30-4) and [Lemma 23](#page-34-0) [\(i\)](#page-34-1) and [\(ii\)](#page-35-1) on the dynamics-governing vectors, the unit-sphere normalisations, and the boundary crossing times, over the lengthy time period up to T_1 which depends on the initialisation scale λ .

E Proofs for the second phase

Here we prove a number of results which culminate in [Lemma 32](#page-46-0) below, whose parts [\(ii\)](#page-47-0) and [\(v\)](#page-47-1) establish [Theorem 6.](#page-7-0)

We begin by observing that the eigenvector of the largest eigenvalue of the matrix $\frac{1}{n}XX^\top$ is in the interior of the cone spanned by the training points.

Since $\bm{v}_{\ell} = \sum_{k=1}^d \eta^\ell_k \nu_k \bm{u}_k$ and η_1 is strictly the largest eigenvalue, we have that $\measuredangle(\bm{u}_1,\bm{v}_{\ell}) \to 0$ as $\ell \to \infty$. Therefore $u_1\in \text{cone}\{x_1,\ldots,x_n\}\setminus\{\mathbf{0}\}$, but since $\frac{1}{n}\boldsymbol X\boldsymbol X^\top\boldsymbol u_1=\eta_1\boldsymbol u_1$, in fact $\boldsymbol u_1\in \text{int}(\text{cone}\{\boldsymbol x_1,\ldots,\boldsymbol x_n\}).$

Our next observation is that the key set S defined in section 5 is strictly contained in the ball with centre $\bm{v}^*/2$ and radius $\|\bm{v}^*\|/2=1/2$, i.e. that passes through the origin and the teacher neuron, and is centred half-way between them.

Our final preparatory result is a positive lower bound, however depending on λ , on the cosine of every angle between a vector v in S and a training point. The proof relies on the correlation property of our datasets, i.e. that the angles between the training points and the teacher neuron are less than $\pi/4$.

The next lemma is at the heart of our analysis of the training dynamics. It establishes several key facts that hold at all times t from the start T_1 of the second phase, and which form the statement of the lemma as follows.

Parts [\(i\)](#page-39-0) and [\(ii\).](#page-39-1) The cosines of all angles between hidden neurons that form the aligned bundle remain above $1-4\lambda^{\epsilon}$, and the bundle vector v^t which was defined as the sum of the constituent hidden neurons multiplied by their last-layer weights stays in the set S . These two properties support each other, e.g. we show that the containment in S implies that the gradients of the individual hidden neurons are such that the bundle keeps together rather than breaks apart.

Parts [\(iii\)](#page-39-2) and [\(iv\).](#page-39-3) The network acts linearly on the training points, namely its outputs for the training points equal their inner products with the bundle vector. Moreover, the vectors \boldsymbol{g}_j^t (defined in [Propo](#page-4-1)[sition 1](#page-4-1) [\(i\)\)](#page-4-0) that govern the dynamics are all equal to the vector g^t which is obtained by applying the operator $\frac{1}{n} \boldsymbol X \boldsymbol X^\top$ to the vector $\boldsymbol v^* - \boldsymbol v^t.$

Parts (*v*) *and* (*vi*). The derivative of the bundle vector v^t with respect to the time t exists, i.e. the issue of the non-differentiability of the ReLU activation at 0 does not arise in this respect. However, the two-layer dynamics is such that this derivative is in general only approximated by the vector f^t defined above, and we bound that error by a ball centred at f^t whose radius depends on the initialisation scale λ .

Parts (*vii)*, (*viii)* and (*ix*). We show that the squared norm of v^t grows exponentially fast as it moves away from the saddle at the origin, obtaining a lower bound on the speed of its increase that does not depend on λ as long as v^t is in the subset \mathcal{S}_1 , and a lower bound that depends on λ subsequently. Also we show an upper bound on the speed of decrease of the squared norm of $v^* - v$, i.e. the square of the distance between the bundle vector and the teacher neuron.

Perhaps the most involved segment of the proof proceeds by showing that each face of the boundary of the set S is repelling towards the interior of S with respect to the dynamics of the bundle vector v^t , whose derivative is approximately f^t . A major complication is that this is in general not true for the entire boundary of the "padded ellipsoid" constraint Ξ, but holds for its remainder after the slicing off by the other constraints that define S .

Example 31*.* To illustrate some aspects of the training dynamics, let us consider a single run of gradient descent with learning rate 0.01, for a network of width $m = 25$ initialised using $z_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{N}(\mathbf{0}, \frac{1}{d m} \mathbf{I}_d)$ and s_j ^{i.i.d.} $U{\{\pm 1\}}$ with scale $\lambda = 4^{-7}$, and on a synthetic uncentred training dataset in dimension $d = 16$ as described in section 8 described in [section 8.](#page-9-1)

[Figure 3](#page-46-1) shows the coordinates of the vector $v^* - v^t$ in the eigenvectors basis crossing zero one by one exactly in the order of their indices, i.e. in the decreasing order of the corresponding eigenvalues of the matrix $\frac{1}{n}XX^\top$. Thus the bundle vector v^t travels through the subsets $\mathcal{S}_1,\mathcal{S}_2,\ldots$ of the set $\mathcal S$ exactly in their order, and in line with what we established in the proof of [Lemma 28,](#page-39-10) passing through each S_k at most once. most once.

Let us write $\boldsymbol{v}^t = \sum_{k=1}^d \nu_k^t \boldsymbol{u}_k$.

Recall from [section 5](#page-7-1) that $T_2 = \inf\{t \ge T_1 \mid \nu_1^t/\nu_1^* \ge 1/2\}.$

Building on the preceding results, the final lemma in this section establishes that the loss converges to zero at an exponential rate. To show it, we partition the second phase of the training into two, namely before and after the time T_2 which is when the coordinate of the bundle vector \bm{v}^t with respect to the largest-eigenvalue eigenvector of the matrix $\frac{1}{n}XX^\top$ crosses the half-way threshold to the corresponding coordinate of the teacher neuron \bm{v}^* . The period before T_2 (and after the start T_1 of the second phase) consists of an exponentially fast departure of v^t from near the saddle at the origin, whereas the period after T_2 obeys a Polyak-Łojasiewicz inequality which implies exponentially fast convergence.

since $\lambda^{\varepsilon/2} \le n^{-\frac{9\cdot3}{2}n\Delta^2/\delta^3} < \frac{\delta^2}{120\Delta^2} \le \frac{\|\gamma_{[n]}\|}{120\eta_1}$.

Hence for all $t \geq T_2$ we have

Example 33*.* Using the single run from [Example 31](#page-46-2) again, we illustrate in [Figure 4](#page-48-2) the progression of several significant measures of the sum v^t of the hidden neurons multiplied by their last-layer weights during the training. In particular, we can see that the alignment with the vector $\pmb{\gamma}_{[n]}$ reaches its maximum around iteration 500, after which the distance and the angle to the teacher neuron v^* starts to decrease. \Box

F Proofs for the implicit bias

In this section, we include an explicit subscript λ for quantities that depend on the initialisation scale.

A key part of showing that the networks to which the training converges as time tends to infinity themselves have a limit in parameter space as the initialisation scale tends to zero is to establish the existence of that double limit for every ratio between the Euclidean norms of two hidden neurons. The following lemma does that, and provides two alternative expressions for each such double-limit ratio: the limit of the same ratio at time T_1 as λ tends to zero, and the corresponding limit for the yardstick trajectories as t tends to infinity.

Lemma 34. *For all* $j, j' \in J_+$ *we have*

By [Lemma 28](#page-39-10) [\(i\),](#page-39-0) [\(iv\),](#page-39-3) and [\(v\),](#page-39-4) for all $t \geq T_{\lambda,1}$ we have

\left|\mathrm{d} \ln \frac{\|\bm{w}_{\lambda,j}^t\|}{\|\bm{w}_{\lambda,j'}^t\|}/\mathrm{d} t\right| = |{(\overline{\bm{w}}_{\lambda,j}^t - \overline{\bm{w}}_{\lambda,j'}^t)}^\top \bm{g}_{\lambda}^t| < \sqrt{8}\lambda^{\varepsilon/2}\|\bm{g}_{\lambda}^t\|.
$$

By [Lemma 28](#page-39-10) [\(ix\)](#page-39-8) and [Lemma 32](#page-46-0) [\(iii\),](#page-47-2) for all $t \geq T_{\lambda,2}$ we have

We are now in a position to prove the main theorem, restated from [section 6.](#page-8-3) It establishes that, as the initialisation scale λ tends to zero, the networks with zero loss to which the gradient flow converges tend to a network in the set Θ_{v^*} (defined in [section 6\)](#page-8-3) of balanced interpolators of rank 1.

Theorem 7. *Under Assumptions [1](#page-5-0) and [2,](#page-6-0)* L lim $t\rightarrow\infty$ $\left(\boldsymbol{\theta}_{\lambda}^{t}\right)=0$ and $\lim_{\lambda\to 0}$ $\lambda \rightarrow 0^+$ lim $t\rightarrow\infty$ $\boldsymbol{\theta}^t_{\lambda} \in \Theta_{\boldsymbol{v}^*}.$ \Box

Proof. By [Lemma 32](#page-46-0) [\(v\),](#page-47-1) we have lim $t\rightarrow\infty$ $L(\boldsymbol{\theta}_{\lambda}^{t})=0.$

By [Proposition 9,](#page-16-3) for all $t \in [0, \infty)$ we have

\int_t^\infty \left\| \frac{\mathrm{d}}{\mathrm{d}t'} \boldsymbol{\theta}_{\lambda}^{t'} \right\|^2 \mathrm{d}t' = -\int_t^\infty \frac{\mathrm{d}}{\mathrm{d}t'} L(\boldsymbol{\theta}_{\lambda}^{t'}) \mathrm{d}t' = L(\boldsymbol{\theta}_{\lambda}^t) .

Hence $\boldsymbol{\theta}_{\lambda}^{\infty} \coloneqq \lim_{t \to \infty}$ $t\rightarrow\infty$ $\bm{\theta}^t_\lambda$ exists, and since the loss function is continuous, we have $L(\bm{\theta}^\infty_\lambda)=0$. Let us write $\bm{\theta}_{\lambda}^{\infty} = \big([a_{\lambda,1}^{\infty}, \ldots, a_{\lambda,m}^{\infty}], [\bm{w}_{\lambda,1}^{\infty}, \ldots, \bm{w}_{\lambda,m}^{\infty}]^{\top} \big)$, and let $\bm{v}_{\lambda}^{\infty} \coloneqq \sum_{j \in J_{+}} a_{\lambda,j}^{\infty} \bm{w}_{\lambda,j}^{\infty}.$ Since Θ is closed, for all $j\in[m]$ we have $a_{\lambda,j}^{\infty}=\|\boldsymbol{w}_{\lambda,j}^{\infty}\|.$ Recalling $\text{span}\{\boldsymbol{x}_1,\ldots,\boldsymbol{x}_n\} = \mathbb{R}^d$ and [Lemma 28](#page-39-10) [\(iii\),](#page-39-2) we have $\boldsymbol{v}_\lambda^\infty = \boldsymbol{v}^*.$ By [Lemma 28](#page-39-10) [\(i\),](#page-39-0) for all $j \in J_+$ we have $\overline{w}^{\infty, \dagger}_{\lambda, j} v^* > 1 - 4 \lambda^{\varepsilon}$, so

By [Lemma 34,](#page-48-1) for all $j, j' \in J_+, \lim_{\lambda \to 0^+}$ $\|\boldsymbol{w}_{\lambda,j}^{\infty}\|$ $\frac{\| \boldsymbol{w}_{\lambda,j} \|}{\| \boldsymbol{w}^{\infty}_{\lambda,j'} \|}$ exists.

Hence, for all $j \in J_+$, we have that $a_j^{\infty} := \lim_{\lambda \to 0} a_j$ $\lim_{\lambda\to 0^+} ||\boldsymbol{w}_{\lambda,j}^{\infty}||$ and $\lim_{\lambda\to 0^+}$ $\overline{w}^{\infty}_{\lambda,j}$ exist, and so also $w_j^{\infty} \coloneqq \lim_{\lambda \to 0}$ $\lambda \rightarrow 0^+$ $\bm{w}_{\lambda, j}^\infty$ exists. Moreover, we have $a_j^{\infty} = \|w_j^{\infty}\|$ and $\overline{w}_j^{\infty} = v^*$ for all $j \in J_+$, and we have $\sum_{j \in J_+} \|w_j^{\infty}\|^2 = 1$.

By [Proposition 18,](#page-28-0) [Lemma 19](#page-29-0) [\(ii\),](#page-29-1) [Lemma 21,](#page-30-0) and [Assumption 1](#page-5-0) [\(v\),](#page-5-4) for all $j \notin J_+$, we have $\|{\bm{w}}_{\lambda,j}^t\| \leq 1$ $\lambda \|z_j\|$ for all $t \in [0, \infty)$, so $a_j^{\infty} := \lim_{\lambda \to 0}$ $\lambda \rightarrow 0^+$ $a_{\lambda,j}^{\infty}=0$ and $w_j^{\infty} \coloneqq \lim_{\lambda \to 0}$ $\lambda \rightarrow 0^+$ $\bm{w}_{\lambda,j}^{\infty}=\bm{0}.$

Therefore

\boldsymbol{\theta}^{\infty} \coloneqq ([a_1^{\infty}, \dots, a_m^{\infty}], [\boldsymbol{w}_1^{\infty}, \dots, \boldsymbol{w}_m^{\infty}]^{\top}) \in \Theta_{\boldsymbol{v}^*}.
$$

Example 35*.* Continuing with the single run from [Example 31,](#page-46-2) we illustrate in [Figure 5](#page-51-0) how, although the loss converges to zero exponentially fast, for a fixed positive initialisation scale the angles between the hidden neurons in the aligned bundle do not in general decrease to zero.

[Figure 6](#page-51-1) shows the course of the training from the point of view of the two measures of network complexity, namely the nuclear and square Euclidean norms: during the alignment phase they are both close to zero, they grow rapidly as the network departs from the saddle at the origin, and they converge towards 1 and 2 respectively as the loss converges to zero. \Box

G Proofs and examples for the interpolators

First we prove the following theorem, restated from [section 7.](#page-8-4) For case $\mathcal{M} < 0$, the main part of our argument shows that, if a global minimiser of $||\theta||^2$ was not a member of Θ_{v^*} , then we could obtain from each hidden neuron \bm{w}_j a vector \bm{p}_j such that the inner products of the inputs \bm{x}_i with the vector $\sum_{j\in [m]}a_j\,\bm{p}_j$ coincide with the network outputs, the projection of each vector \bm{p}_j onto the teacher neuron has length at most $||w_j||$, and at least one of those inequalities is strict, leading to a contradiction. For case $M > 0$, we provide counterexample interpolator networks, the Euclidean norm of whose parameters is smaller than the Euclidean norm of the networks in Θ_{v^*} .

Theorem 8. *Under Assumptions [1](#page-5-0) and [3:](#page-8-0)*

- *(i) if* $M < 0$ *then* $\Theta_{\mathbf{v}^*}$ *is the set of all global minimisers of* $\|\theta\|^2$ *subject to* $L(\theta) = 0$ *;*
- (*ii*) *if* $M > 0$ then no point in Θ_{v^*} is a global minimiser of $\|\theta\|^2$ subject to $L(\theta) = 0$.

Proof. For all $\boldsymbol{\theta} = (\boldsymbol{a}, \boldsymbol{W}) \in \Theta_{\boldsymbol{v}^*}$ we have $L(\boldsymbol{\theta}) = 0$ and $\|\boldsymbol{\theta}\|^2 = \sum_{j \in [m]} (a_j^2 + \|\boldsymbol{w}_j\|^2) = 2$.

To establish the case when $\mathcal{M}< 0$, supposing $\bm{\theta}=(\bm{a},\bm{W})\in \mathbb{R}^m\times \mathbb{R}^{m\times d}$ is a global minimiser of $\|\bm{\theta}\|^2$ subject to $L(\theta) = 0$, it suffices to show $\theta \in \Theta_{v^*}$.

By the minimality of $||\theta||^2$ subject to $L(\theta) = 0$, for all $j \in [m]$, if $a_j = 0$ then $w_j = 0$, and also if $\forall i \in [d] \colon \sigma(\boldsymbol{w}_j^{\top}\boldsymbol{x}_i) = 0$ then $a_j = 0$.

For all $j \in [m]$, if $a_j = 0$ and $w_j = 0$, then removing a_j and w_j from θ preserves the values of $\|\theta\|^2$ and $L(\theta)$, and the truth or falsity of $\theta \in \Theta_{v^*}$. Hence we may assume for all $j \in [m]$ that $a_j \neq 0$ and $\exists i \in [d] \colon \sigma(\boldsymbol{w}_j^{\top}\boldsymbol{x}_i) \neq 0.$

For all $j \in [m]$, replacing a_j by $\sqrt{\|w_j\|/|a_j|} a_j$ and w_j by $\sqrt{|a_j|/||w_j||} w_j$ preserves $L(\theta)$, and decreases $\|\boldsymbol{\theta}\|^2$ unless $|a_j| = \|\boldsymbol{w}_j\|.$ Hence $\boldsymbol{\theta} \in \Theta$.

For all $j\in[m]$, let $K_j\coloneqq\{k\in[d] \mid \bm{w}_j^\top\bm{x}_k\geq 0\}$ and

$$
\boldsymbol{p}_j \coloneqq \sum_{k \in K_j} (\boldsymbol{w}_j^\top \boldsymbol{x}_k) \boldsymbol{\chi}_k \hspace{2cm} \boldsymbol{q}_j \coloneqq \sum_{k \notin K_j} -(\boldsymbol{w}_j^\top \boldsymbol{x}_k) \boldsymbol{\chi}_k \ ,

so that $w_j = \bm p_j - \bm q_j.$ Observe also that since $\exists i \in [d] \colon \sigma(\bm w_j^\top \bm x_i) \neq 0$, we have $\bm p_j \neq \bm 0.$

Claim 36. For all $j \in [m]$ we have $|\bm{p}_j^{\perp} \bm{v}^*| \leq ||\bm{w}_j||$, and if $\bm{q}_j \neq \bm{0}$ then the inequality is strict.

Proof of claim. Suppose $j \in [m]$. If $\boldsymbol{q}_j = \boldsymbol{0}$ then $\boldsymbol{w}_j = \boldsymbol{p}_j$. If $\boldsymbol{q}_j \neq \boldsymbol{0}$ then

\begin{aligned}\n\|\boldsymbol{w}_{j}\|^{2} &= \|\boldsymbol{p}_{j}\|^{2} + \|\boldsymbol{q}_{j}\|^{2} - 2\|\boldsymbol{p}_{j}\|\|\boldsymbol{q}_{j}\|\cos\measuredangle(\boldsymbol{p}_{j}, \boldsymbol{q}_{j}) \\
&> \|\boldsymbol{p}_{j}\|^{2} + \|\boldsymbol{q}_{j}\|^{2} - 2\|\boldsymbol{p}_{j}\|\|\boldsymbol{q}_{j}\|\sin\measuredangle(\boldsymbol{p}_{j}, \boldsymbol{v}^{*}) \\
&= \|\boldsymbol{p}_{j}\|^{2}\cos^{2}\measuredangle(\boldsymbol{p}_{j}, \boldsymbol{v}^{*}) + (\|\boldsymbol{p}_{j}\|\sin\measuredangle(\boldsymbol{p}_{j}, \boldsymbol{v}^{*}) - \|\boldsymbol{q}_{j}\|)^{2} \\
&\geq \|\boldsymbol{p}_{j}\|^{2}\cos^{2}\measuredangle(\boldsymbol{p}_{j}, \boldsymbol{v}^{*}) \\
&= (\boldsymbol{p}_{j}^{\top}\boldsymbol{v}^{*})^{2}.\n\end{aligned}
$$

.

 \Box

Now for all $i \in [d]$ we have

$$
\left(\sum_{j\in[m]}a_j\,\boldsymbol{p}_j\right)^{\mathbf{\cdot}}\boldsymbol{x}_i=\sum_{j\in[m]}a_j\,\boldsymbol{p}_j^{\top}\boldsymbol{x}_i=\sum_{j\in[m]}a_j\,\sigma(\boldsymbol{w}_j^{\top}\boldsymbol{x}_i)=\boldsymbol{v}^{*\top}\boldsymbol{x}_i
$$

Since $\text{span}\{\bm{x}_1,\dots,\bm{x}_d\}=\mathbb{R}^d$, we infer $\sum_{j\in [m]}a_j\,\bm{p}_j=\bm{v}^*$, so by [Claim 36](#page-52-0) we have

$$
1 = \sum_{j \in [m]} a_j p_j^{\top} \mathbf{v}^* \leq \sum_{j \in [m]} |a_j p_j^{\top} \mathbf{v}^*| \leq \sum_{j \in [m]} ||a_j w_j|| = \frac{1}{2} \sum_{j \in [m]} (a_j^2 + ||w_j||^2) = \frac{1}{2} ||\boldsymbol{\theta}||^2 \leq 1,
$$

and if $q_j \neq 0$ for some $j \in [m]$ then the second of the three inequalities is strict. However, all three inequalities must be equalities, so also for all $j \in [m]$ we have $q_j = 0$. Hence $a_j w_j^{\dagger} v^* = a_j p_j^{\dagger} v^* = 0$ $||a_j w_j||$, and thus $\overline{a_j w_j} = v^*$. Since $a_j < 0$ would imply $\overline{w}_j = -v^*$, which would contradict $q_j = 0$, we have $a_j > 0$ and $\overline{\boldsymbol{w}}_j = \boldsymbol{v}^*$. Therefore $\boldsymbol{\theta} \in \Theta_{\boldsymbol{v}^*}.$

To establish the case when $M > 0$, it suffices to exhibit $\theta = (\boldsymbol{a}, \boldsymbol{W}) \in \mathbb{R}^m \times \mathbb{R}^{m \times d}$ such that $L(\theta) = 0$ and $\|\boldsymbol{\theta}\|^2 < 2$.

Let $\emptyset \subsetneq K \subsetneq [d], 0 \neq p \in \text{cone}\{\chi_k \mid k \in K\}$, and $0 \neq q \in \text{cone}\{\chi_k \mid k \notin K\}$ be such that $\cos \angle(p, q) >$ $\sin \angle(p, v^*)$. We have $\overline{p} = \sum_{k \in K} b_k \chi_k$ for some $b_k \ge 0$, and $\overline{q} = \sum_{k \notin K} c_k \chi_k$ for some $c_k \ge 0$. Since $\text{span}\{\boldsymbol{\chi}_1,\ldots,\boldsymbol{\chi}_d\}=\mathbb{R}^d$, we have $\cos\measuredangle(\boldsymbol{p},\boldsymbol{q})< 1.$

Case $\measuredangle(\mathbf{p}, \mathbf{v}^*) \le \pi/2$. Then $\cos \measuredangle(\mathbf{p}, \mathbf{v}^*) > \sin \measuredangle(\mathbf{p}, \mathbf{q})$. Let $\xi \coloneqq \min\{\min\{y_k/b_k \mid k \in K \land b_k \neq 0\}, \cos \measuredangle(\bm p, \bm v^*) - \sin \measuredangle(\bm p, \bm q)\},$ $\bm r \coloneqq \overline{\bm p} - \overline{\bm q} \, \overline{\bm q}^\top \overline{\bm p}$,

it follows that $h_{\theta}(x_i) = y_i$ for all $i \in [d]$, i.e. $L(\theta) = 0$. We have

it follows that $h_{\theta}(\boldsymbol{x}_i) = y_i$ for all $i \in [d]$, i.e. $L(\theta) = 0$. We have

Example 37*.* Now we present two families of examples of a teacher neuron and training points that respectively satisfy: $M < 0$ for any $d > 1$, and $M > 0$ for any $d > 2$.

Let $\{e_i\}_{i=1}^d$ denote the standard basis of \mathbb{R}^d .

 $M < 0$. Let $\xi \in (0, 1)$ and consider, for all $i \in [d]$, vectors

x_i := \left(1 - \frac{d-1}{d}(1-\xi)\right) e_i + \frac{1-\xi}{d} \sum_{k \neq i} e_k.
$$

Take $\boldsymbol{s} \coloneqq (1,\ldots,1) \in \mathbb{R}^d$ and $\boldsymbol{v}^* \coloneqq \boldsymbol{\overline{s}}$.

It can be checked that, for vectors $\pmb{\chi}_1,\ldots,\pmb{\chi}_d$ defined by

Notice that whenever $k\neq i$ we have $\boldsymbol{\chi}_{k}^{\top}\boldsymbol{\chi}_{i}=\frac{1}{\xi^{2}}\biggl(-2\frac{1-\xi}{d}+\biggl(\frac{1-\xi}{d}\biggr)^{\!2}d\biggr)=\frac{1-\xi}{\xi^{2}d}(-2+1-\xi)<0.$ Hence for all $\emptyset \subsetneq K \subsetneq [d]$, all $\mathbf{0} \neq \mathbf{p} \in \mathrm{cone}\{\boldsymbol{\chi}_k \mid k \in K\}$, and all $\mathbf{0} \neq \mathbf{q} \in \mathrm{cone}\{\boldsymbol{\chi}_i \mid i \notin K\}$ we have $\mathrm{cos} \measuredangle(\mathbf{p},\mathbf{q}) < 0.$ Thus $\mathcal{M} < 0$.

It remains to verify that $\measuredangle(\bm{v}^*,\bm{x}_i)<\pi/4$ for all $i.$ Indeed

$$

= \frac{1}{d} + \frac{(d-1)^{2} + (d-1)}{d^{2}}\xi^{2}

so in particular $\|s\|^2 \|x_i\|^2 = 1 + (d-1)\xi^2$. Therefore

 $M > 0$. For $d > 2$, let $b \ge 11$, and consider the data points

and the teacher neuron $v^* \coloneqq \frac{4}{5}e_1 + \frac{3}{5}e_3$.

For all i we have

Remark 38. (i) For any θ such that $L(\theta) = 0$, we have $\|\theta\|^2 \geq 2 h_{\theta}(x_1) / \|x_1\| = 2 \cos \measuredangle(\mathbf{v}^*, x_1) > \sqrt{2}$.

- (ii) For $d = 2$, since $\measuredangle(\mathbf{x}_1, \mathbf{x}_2) < \pi/2$, we have $\measuredangle(\mathbf{x}_1, \mathbf{x}_2) > \pi/2$, so necessarily $\mathcal{M} < 0$.
- (iii) As its proof above shows, Theorem [8](#page-8-5) remains true if we relax the correlation between the teacher neuron and the training points to $\measuredangle(\bm{v}^*,\bm{x}_i)<\pi/2$ for all $i.$

H Additional information about the experiments

For both the centred and the uncentred schemes of generating the training dataset (defined in [section 8\)](#page-9-1), we train a one-hidden layer ReLU network by gradient descent with learning rate 0.01, from a balanced initialisation such that $z_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{N}(0, \frac{1}{d_m} I_d)$ and $s_j \stackrel{\text{i.i.d.}}{\sim} \mathcal{U}\{\pm 1\}$, for a range of initialisation scales λ, and for several combinations of input dimensions *d* and network widths *m*.

The plots in [Figure 7,](#page-56-0) which extends [Figure 1](#page-10-0) in the main, are obtained by varying the input dimension as $d = 4, 16, 64, 256, 1024$ while keeping the network width at $m = 200$. The plots in [Figure 8](#page-57-0) are obtained with input dimension $d = 1024$ by varying the network width as $m = 25, 50, 200$. For all twelve plots, we vary the initialisation scale as $\lambda = 4^2, 4^1, \ldots, 4^{-12}, 4^{-13}$, and we train the network until the number of iterations reaches $2 \cdot 10^7$ or the loss drops below 10^{-9} . The plots are in line with [Theorem 7,](#page-8-1) showing how the three different proxies of rank decrease as λ decreases.

[Figure 9](#page-58-0) complements [Figure 2](#page-10-1) in the main, illustrating exponential convergence of the training loss (cf. [Theorem 6\)](#page-7-0) and reduction of the outside distribution test loss as λ decreases, for the uncentred scheme of generating the training dataset.

The medians plotted in [Figure 7](#page-56-0) and [Figure 8,](#page-57-0) as well as the corresponding standard deviations, can be found in Tables [1](#page-59-0)[–6](#page-64-0) and Tables [7](#page-65-0)[–12](#page-67-0) respectively.

The experiments were run using Python 3.10.4 and Pytorch 1.12.1 with CUDA 11.7 on a cluster utilising Intel Xeon Platinum 8268 processors. Some experiments for dimension 1024 also used NVIDIA RTX 6000 GPUs. The time taken per iteration greatly depends on the dimension and the width. For dimension 1024 and width 200, about 300 iterations per second could be performed on the CPU. The GPU was about 20% faster in this setting. The total number of iterations performed for dimension 1024 was about 1.6 billion. Experiments for lower dimensions or smaller widths are less demanding.

Overall, these numerical results correspond to our theoretical predictions, and suggest that the training dynamics and the implicit bias we established theoretically occur in practical settings in which some of our assumptions are relaxed.

I Further experiments

Here we report on experiments in which we explore the effects of adding a second teacher neuron whose direction is opposite to that of the first, and of increasing the scale ρ of the noise used to generate the synthetic datasets (cf. [section 8\)](#page-9-1) so that quickly most of the data points exceed the $\pi/4$ angle with their corresponding teacher neuron.

In [Figure 10,](#page-68-1) the growing maximum angles between neurons at the end of the training indicate that we no longer have a single (or one per teacher neuron) aligned bundle of neurons forming and sticking together for the rest of the training.

In the bottom two plots of [Figure 10](#page-68-1) and in [Figure 11,](#page-69-0) for small scales ρ (where the smallest values are such that the angles between the data points and the corresponding teacher neuron concentrate around $\pi/4$), the phenomena we identified theoretically still seem to hold, where the training passes near a second saddle point as we outlined in [section 9.](#page-9-2)
