# SOME UNIVERSAL INEQUALITIES OF EIGENVALUES AND UPPER BOUNDS FOR THE  $L_{\infty}$  NORM OF EIGENFUNCTIONS OF THE LAPLACIAN

ABSTRACT. In this short survey, we derive some weyl-type universal inequalities of eigenvalues of the Laplacian on a closed Riemannian manifold of nonnegative Ricci curvature. We also give upper bounds for the  $L_{\infty}$  norm of eigenfunctions of the Laplacian in the same setting. A detailed proof of these results did not seem to appear in the literature but the results follow from a simple combination of Milman's work and Cheng-Li's work.

#### 1. INTRODUCTION

For a closed Riemannian manifold M let  $\lambda_k(M)$  be the k-th nonzero eigenvalue of the Laplacian.

One of the goal of this survey is to give a precise proof of the following theorem: For  $a, b \in \mathbb{R}$ ,  $a \leq b$  stands for  $a \leq Cb$  for some universal (and numerical) constant  $C > 0$ .

<span id="page-0-1"></span>Theorem 1.1. Let M be an n-dimensional closed Riemannian manifold of nonnegative Ricci curvature. Then for any  $k \geq 1$  we have

<span id="page-0-0"></span>
$$
(1.1) \qquad \lambda_k(M) \gtrsim k^{\frac{2}{n}} \lambda_1(M).
$$

Note that the order of k in  $(1.1)$  is sharp by the Weyl asymptotic law. Concerning the above inequality [\(1.1\)](#page-0-0) let us focus on the following two estimates for eigenvalues of the Laplacian on a closed Riemannian manifold of nonnegative Ricci curvature:

- (1)  $\lambda_k(M) \geq \frac{c_n k^{\frac{2}{n}}}{\text{(Diam }M)}$  $\frac{c_n k^n}{(\text{Diam } M)^2}$ , where  $c_n > 0$  is a constant depending only on n (Gromov  $[9, 10]$  $[9, 10]$ . Refer also to [\[18,](#page-7-2) Theorem 4.2] and [\[11,](#page-7-3) Theorems 1.1 and 1.2]).
- $(2)$   $\lambda_k(M) \lesssim \frac{n^2k^2}{(\text{Diam }M)}$  $\frac{n^2k^2}{(\text{Diam }M)^2}$  (Cheng [\[3,](#page-7-4) Corollary 2.2]).

Combining the above two estimates we can obtain

<span id="page-1-0"></span>
$$
(1.2) \qquad \lambda_k(M) \gtrsim c_n k^{\frac{2}{n}} \lambda_1(M)
$$

in the same setting. Since we do not need the dimensional term  $c_n$  in  $(1.1)$ , the inequality  $(1.1)$  is better than the inequality  $(1.2)$ .

The opposite of [\(1.1\)](#page-0-0) was obtained by Liu in [\[14,](#page-7-5) Theorem 1.1]. Under the same assumption of Theorem [1.1](#page-0-1) Liu showed

<span id="page-1-3"></span>
$$
(1.3) \qquad \lambda_k(M) \lesssim k^2 \lambda_1(M),
$$

which is sharp with respect to the order of k.

Throughout this survey  $\mu$  denotes the uniform probability measure on M, i.e.,  $\mu(\cdot) := \text{vol}(\cdot)/\text{vol}(M)$ . For a measurable function  $f : M \to$  $\mathbb R$  and  $p > 0$  we put

$$
||f||_p := \left(\int_M |f(x)|^p d\mu(x)\right)^{\frac{1}{p}}
$$

and

$$
||f||_{\infty} := \operatorname*{ess\,sup}_{x \in M} |f(x)|.
$$

<span id="page-1-5"></span>We also give the proof of the following theorem.

**Theorem 1.2.** Let  $n > 3$  and M be an n-dimensional closed Riemannian manifold of nonnegative Ricci curvature. Then for any  $k \geq 1$  and any eigenfunction  $\varphi_k$  of the Laplacian corresponding to  $\lambda_k(M)$  we have

<span id="page-1-2"></span>(1.4) 
$$
\|\varphi_k\|_{\infty} \lesssim \left(\frac{c\lambda_k(M)}{\lambda_1(M)}\right)^{\frac{n}{4}} \|\varphi_k\|_2.
$$

for some universal constant  $c > 0$ . In particular we have

<span id="page-1-1"></span>kϕkk<sup>∞</sup> . (ck) n (1.5) <sup>2</sup> kϕkk2.

The inequality  $(1.5)$  follows from  $(1.4)$  together with  $(1.3)$ .

A classical result by Hölmander  $[12]$  (see also  $[1]$ ,  $[5]$ ,  $[17]$ ,  $[19]$ , and [\[20,](#page-8-1) Corollary 8.6]) states that

<span id="page-1-4"></span>(1.6) 
$$
\|\varphi_k\|_{\infty} \leq C\lambda_k(M)^{\frac{n-1}{4}}\|\varphi_k\|_2
$$

for any closed Riemannian manifold, where the constant  $C = C(M, q)$ depends on  $(M, g)$ . This inequality is sharp and better than  $(1.4)$  when  $\lambda_k(M)$  is large. In the case where  $\lambda_k(M) \ll \lambda_1(M)^n$  the inequality [\(1.4\)](#page-1-2) is better than the inequaity [\(1.6\)](#page-1-4).

The proof of Theorems [1.1](#page-0-1) and [1.2](#page-1-5) follows from a simple combination of Milman's result [\[16\]](#page-7-10) and Cheng-Li's result [\[4\]](#page-7-11). In fact under the nonnegativity of Ricci curvature, Milman proved the Sobolev inequality in terms of the first nonzero eigenvalue and Cheng-Li proved lower

$$

bounds of eigenvalues of the Laplacian in terms of the Sobolev constant. As a byproduct of the proof of Theorem [1.1](#page-0-1) we prove Theorem [1.2.](#page-1-5)

Remark 1.1. Theorems [1.1](#page-0-1) and [1.2](#page-1-5) hold for a convex domain in a complete Riemannian manifold of nonnegative Ricci curvature. In that case we impose the Neumann boundary condition.

## 2. Proof

Let M be a closed Riemannian manifold and  $\mu$  be the uniform probability measure. For the isoperimetric profile  $I = I_{(M,\mu)} : [0,1] \rightarrow \mathbb{R}$ (Refer to [\[16\]](#page-7-10) for the definition) we put  $I(t) := \min\{I(t), I(1-t)\},$  $t \in [0, 1/2].$ 

<span id="page-2-0"></span>Theorem 2.1 (E. Milman, [\[16,](#page-7-10) Remark 2.11]). Let M be an n-dimensional closed Riemannian manifold of nonnegative Ricci curvature. Then we have the isoperimetric inequality

$$
\tilde{I}(t) \gtrsim \sqrt{\lambda_1(M)} t^{\frac{n-1}{n}} \quad \forall t \in [0, 1/2].
$$

In [\[16,](#page-7-10) Remark 2.11] Milman stated that

$$
\tilde{I}(t) \gtrsim D_{1,\infty} t^{\frac{n-1}{n}} \quad \forall t \in [0, 1/2],
$$

where  $D_{1,\infty}$  is the best constant that satisfies the  $(1,\infty)$ -Poincaré inequality. Since  $D_{1,\infty}$  is equivalent to  $\sqrt{\lambda_1(M)}$  by Milman's result ([\[16,](#page-7-10) Theorem 2.4]), we have Theorem [2.1.](#page-2-0)

For a measurable function  $f : M \to \mathbb{R}$  we define a median of f as a number a such that

$$
\mu(f(x) \ge a) \ge \frac{1}{2}
$$
 and  $\mu(f(x) \le a) \ge \frac{1}{2}$ .

Note that a might not be unique. Let  $M_{\mu}f$  denote one of medians of f. We put

$$
E_{\mu}f := \int_M f(x)d\mu
$$

whenever the right-hand side makes sense.

One can transfer the isoperimetric inequality appeared in Theorem [2.1](#page-2-0) to a  $(1, \frac{n}{n-1})$ -Poincaré inequality via the following theorem. Let  $\mathcal F$ be the space of Lipschitz functions on M.

<span id="page-2-1"></span>Theorem 2.2 (Bobkov–Houdré [\[2\]](#page-7-12), Federer–Fleming [\[6\]](#page-7-13), Maz'ya [\[15\]](#page-7-14)). Let  $0 < r \leq 1$ . Without any assumption on M the  $(1/r, 1)$ -Poincaré inequality

$$
D\|f - M_{\mu}f\|_{\frac{1}{r}} \le \||\nabla f|\|_1 \ \ \forall f \in \mathcal{F}
$$

is equivalent to the isoperimetric inequality

$$
\tilde{I}(t) \ge Dt^r \quad \forall t \in [0, 1/2].
$$

See [\[2,](#page-7-12) Theorem 1.1] for the proof of the above theorem.

<span id="page-3-3"></span>Theorem [2.1](#page-2-0) together with Theorem [2.2](#page-2-1) yields the following.

Corollary 2.3. Let M be an n-dimensional closed Riemannian manifold of nonnegative Ricci curvature. Then we have the  $(\frac{n}{n-1}, 1)$ -Poincaré inequality

$$
\sqrt{\lambda_1(M)}\|f - M_{\mu}f\|_{\frac{n}{n-1}} \lesssim |||\nabla f||_1 \quad \forall f \in \mathcal{F}.
$$

<span id="page-3-2"></span>From now on we shall study Poincaré inequalities.

**Lemma 2.4** ([\[17,](#page-7-9) Section 1.1.3]). Suppose that the  $\left(\frac{n}{n-1}, 1\right)$ -Poincaré inequality

<span id="page-3-0"></span>(2.1) 
$$
D\|f - M_{\mu}f\|_{\frac{n}{n-1}} \leq |||\nabla f|||_1 \ \forall f \in \mathcal{F}
$$

holds for M. Then for any  $p \geq 1$  we have the  $\left(\frac{np}{n-p}\right)$  $\frac{np}{n-p}, p)$ -Poincaré inequality

<span id="page-3-1"></span>(2.2) 
$$
D\|f - M_{\mu}f\|_{\frac{np}{n-p}} \leq \frac{(n-1)p}{n-p} \|\nabla f\|_{p} \ \forall f \in \mathcal{F}.
$$

In [\[17,](#page-7-9) Section 1.1.3] the above lemma is stated for  $\mathbb{R}^n$ . In there the Poincaré inequalities corresponding to  $(2.1)$  and  $(2.2)$  are stated for compactly supported smooth functions and the left-hand sides of [\(2.1\)](#page-3-0) and [\(2.2\)](#page-3-1) in there are the norms of f, not the norms of  $f - M_{\mu}f$ .

*Proof of Lemma [2.4.](#page-3-2)* Assume [\(2.1\)](#page-3-0) and take  $f \in \mathcal{F}$ . We may assume that  $M_{\mu}f = 0$ . Setting  $\alpha := \frac{(n-1)p}{n-m}$  $\frac{n-1}{n-p}$  we find  $\alpha > 1$ . For any  $x \in M$ define

$$
g(x) := \begin{cases} |f(x)|^{\alpha} & \text{if } f(x) \ge 0\\ -|f(x)|^{\alpha} & \text{if } f(x) < 0. \end{cases}
$$

Observe that  $g \in \mathcal{F}$  and  $M_{\mu}g = 0$ . Thus [\(2.1\)](#page-3-0) yields that

$$
D||f||_{\frac{\alpha n}{n-1}}^{\alpha} = D||g||_{\frac{n}{n-1}} \leq \alpha \int |f(x)|^{\alpha-1} |\nabla f(x)| d\mu(x).
$$

Let p' be the conjugate of p, i.e.,  $p^{-1} + p'^{-1} = 1$ . Using the Hölder inequality we obtain

$$
D||f||_{\frac{np}{n-p}}^{\frac{(n-1)p}{n-p}} = D||f||_{\frac{\alpha_n}{n-1}}^{\alpha} \le \alpha |||f|^{\alpha-1}||_{p'}|| |\nabla f|||_{p} = \alpha ||f||_{\frac{np}{n-p}}^{\frac{n(p-1)}{n-p}}|||\nabla f|||_{p},
$$

which gives  $(2.2)$ . This completes the proof.  $\Box$ 

To connect the  $L_p$  norm of  $f-E_\mu f$  with  $f-M_\mu f$  we use the following.

<span id="page-4-0"></span>**Lemma 2.5** ([\[16,](#page-7-10) Lemma 2.1]). For any  $p \ge 1$  and  $f \in \mathcal{F}$  we have

$$
\frac{1}{2}||f - E_{\mu}f||_{p} \le ||f - M_{\mu}f||_{p} \le 3||f - E_{\mu}f||_{p}.
$$

<span id="page-4-1"></span>Lemma [2.4](#page-3-2) together with Lemma [2.5](#page-4-0) gives the following.

**Lemma 2.6** ([\[17,](#page-7-9) Section 1.1.3]). Suppose that the  $\left(\frac{n}{n-1}, 1\right)$ -Poincaré inequality

$$
D\|f - E_{\mu}f\|_{\frac{n}{n-1}} \le \||\nabla f|\|_1 \ \ \forall f \in \mathcal{F}
$$

holds for M. Then for any  $p \geq 1$  we have the  $\left(\frac{np}{n-p}\right)$  $\frac{np}{n-p}, p)$ -Poincaré inequality

$$
D||f - E_{\mu}f||_{\frac{np}{n-p}} \lesssim \frac{(n-1)p}{n-p} |||\nabla f|||_p \quad \forall f \in \mathcal{F}.
$$

Combining Corollary [2.3](#page-3-3) with Lemmas [2.5](#page-4-0) and [2.6](#page-4-1) we obtain the following.

<span id="page-4-2"></span>Corollary 2.7. Let M be an n-dimensional closed Riemannian manifold of nonnegative Ricci curvature. Then for any  $p \geq 1$  we have the  $\left(\frac{np}{n-r}\right)$  $\frac{np}{n-p}, p)$ -Poincaré inequality

$$
\sqrt{\lambda_1(M)}\|f - E_{\mu}f\|_{\frac{np}{n-p}} \lesssim \frac{(n-1)p}{n-p}\|\nabla f\|_{p} \quad \forall f \in \mathcal{F}.
$$

<span id="page-4-3"></span>The Hölder inequality implies the following lemma.

**Lemma 2.8.** Suppose that we have the  $(\frac{2n}{n-2}, 2)$ -Poincaré inequality

$$
D||f - E_{\mu}f||_{\frac{2n}{n-2}} \le |||\nabla f|||_2 \quad \forall f \in \mathcal{F}.
$$

Then we have

$$
D\|f - E_{\mu}f\|_{2}^{\frac{2+n}{n}}\|f - E_{\mu}f\|_{1}^{-\frac{2}{n}} \leq |||\nabla f|||_{2} \ \ \forall f \in \mathcal{F}.
$$

<span id="page-4-4"></span>**Theorem 2.9** (Cheng-Li, [\[4,](#page-7-11) Theorem 1]). Let M be a closed Riemannian manifold. Assume that

<span id="page-4-5"></span>
$$
(2.3) \tD\|f - E_{\mu}f\|_{2}^{\frac{2+n}{n}}\|f - E_{\mu}f\|_{1}^{-\frac{2}{n}} \leq |||\nabla f|||_{2} \quad \forall f \in \mathcal{F}
$$

holds. Then we have

$$
\lambda_k(M) \gtrsim k^{\frac{2}{n}} D^2
$$

for any k.

*Proof of Theorem [1.1.](#page-0-1)* The case where  $n = 2$  follows from  $(1.2)$  and hence we assume  $n \geq 3$ .

Since  $n \geq 3$  we have

$$
\sqrt{\lambda_1(M)}\|f - E_{\mu}f\|_{\frac{2n}{n-2}} \lesssim |||\nabla f||_2 \ \ \forall f \in \mathcal{F}.
$$

by Corollary [2.7.](#page-4-2) From Lemma [2.8](#page-4-3) we have

$$
\sqrt{\lambda_1(M)}\|f - E_{\mu}f\|_2^{\frac{2+n}{n}}\|f - E_{\mu}f\|_1^{-\frac{2}{n}} \lesssim |||\nabla f||_2 \ \ \forall f \in \mathcal{F}.
$$

Theorem [2.9](#page-4-4) thereby implies the theorem. This completes the proof.  $\Box$ 

For the completeness of this paper we give the proof of Theorem [2.9](#page-4-4) following [\[4\]](#page-7-11).

*Proof of Theorem [2.9.](#page-4-4)* Let  $H(x, y, t)$  denotes the fundamental solution of the heat equation, i.e.,

$$
\frac{\partial H}{\partial t}(x, y, t) = \Delta_x H(x, y, t)
$$

and

$$
\int_M H(x, y, t) f(y) d\mu(y) \to f(x) \text{ as } t \to 0
$$

for any  $f \in C^{\infty}(M)$  ([\[9,](#page-7-0) [10\]](#page-7-1)). We define  $G : M \times M \times [0, \infty) \to \mathbb{R}$  as  $G(x, y, t) := H(x, y, t) - 1$ . Denote by  $\{\phi_i\}_{i=0}^{\infty}$  be an orthnormal basis of eigenfunctions of the Laplacian with respect to  $\mu$ , where  $\phi_i$  corresponds to the eigenvalue  $\lambda_k(M)$ . Since  $\phi_0 = 1$  we have an expansion

$$
G(x, y, t) = \sum_{i=1}^{\infty} e^{-\lambda_i(M)t} \phi_i(x) \phi_i(y).
$$

Note also that the semi-group property

$$
G(x, y, t+s) = \int_M G(x, z, s)G(z, y, t)d\mu(z) \quad \forall x, y \in M \quad \forall s, t \ge 0
$$

holds. We thereby have

$$
G'(x, x, t) = \int_M G'(x, y, t/2) G(x, y, t/2) d\mu(y)
$$
  
= 
$$
\int_M \Delta_y G(x, y, t/2) G(x, y, t/2) d\mu(y).
$$

Since

$$
\int_M |G(x, y, t)| d\mu(y) \le \int_M |H(x, y, t)| d\mu(y) + 1 = 2,
$$

the assumption [\(2.3\)](#page-4-5) and the semi-group property give

$$
-G'(x, x, t) = \int_M |\nabla_y G(x, y, t/2)|^2 d\mu(y)
$$
  
\n
$$
\geq 2^{-\frac{4}{n}} D^2 \Big( \int_M G(x, y, t/2)^2 d\mu(y) \Big)^{\frac{2+n}{n}}
$$
  
\n
$$
= 2^{-\frac{4}{n}} D^2 G(x, x, t)^{\frac{2+n}{n}}.
$$

Since  $G(x, x, t) = H(x, x, t) - 1 \rightarrow \infty$  as  $t \rightarrow 0$ , we obtain

$$
\frac{n}{2}G(x, x, t)^{-\frac{2}{n}} \ge 2^{-\frac{4}{n}}D^2t
$$

It gives

<span id="page-6-0"></span>(2.4) 
$$
G(x, x, t) \le 4\left(\frac{2D^2}{n}\right)^{-\frac{n}{2}}t^{-\frac{n}{2}}.
$$

Integrating both-sides yields

$$
\sum_{i=1}^{\infty} e^{-\lambda_i(M)t} \le 4\left(\frac{2D^2}{n}\right)^{-\frac{n}{2}} t^{-\frac{n}{2}}.
$$

Putting  $t := n/(2\lambda_k(M))$  we therefore obtain

$$
ke^{-\frac{n}{2}}\leq \sum_{i=1}^k e^{-\frac{\lambda_i(M)}{2\lambda_k(M)}n}\leq \sum_{i=1}^\infty e^{-\frac{\lambda_i(M)}{2\lambda_k(M)}n}\leq 4\Big(\frac{2\lambda_k(M)}{D^2}\Big)^{\frac{n}{2}},
$$

which implies the conclusion of the theorem. This completes the proof.  $\Box$ 

In [\[4\]](#page-7-11) instead of putting  $t = n/(2\lambda_k(M))$  in the above proof, Cheng-Li put  $t = 1/(2\lambda_k(M))$  and the conclusion in there becomes  $\lambda_k(M) \gtrsim$  $c_n k^{\frac{2}{n}} D^2$ , where  $c_n > 0$  is a constant depending only on n. In [\[18,](#page-7-2) Chapter III §5] it is putted  $t = n/(4\lambda_k(M))$  but the assumption there is different. The assumption there seems the  $(\frac{2n}{n-2}, 2)$ -Poincaré inequality

$$
D||f||_{\frac{2n}{n-2}} \le |||\nabla f|||_2 \ \ \forall f \in \mathcal{F}
$$

to derive the lower bound of  $\lambda_k(M)$ .

We also give the proof of Theorem [1.2](#page-1-5) following [\[4,](#page-7-11) Corollary 1].

Proof of Theorem [1.2.](#page-1-5) Corollary [2.7,](#page-4-2) Lemma [2.8](#page-4-3) and [\(2.4\)](#page-6-0) yield

$$
e^{-\lambda_k(M)t}\phi_k(x)^2 \le 4\Big(\frac{c\lambda_1(M)}{n}\Big)^{-\frac{n}{2}}t^{-\frac{n}{2}},
$$

where  $c > 0$  is a universal constant. Thus substituting  $t := n/(2\lambda_k(M))$ we obtain  $(1.4)$ . This completes the proof.  $\Box$
