Walsh's Brownian Motion and Donsker Scaling Limits of Perturbed Random Walks

Abstract

In this paper we study Markov chains with the state space given by the coordinate axes of \mathbb{R}^m , $m \geq 2$, whose step sizes on each positive half-axis are distributed according to a centered probability distribution with variance $v_i^2 \in (0, \infty)$, $i = 1, \ldots, m$. Under very mild assumptions on the jumps sizes on the negative half-axes, we show that the Donsker scaling limit of such Markov chains is a Walsh Brownian motion whose weights are determined explicitly in terms of stationary distributions of certain embedded Markov chains. This convergence result is applied to integer-valued random walks perturbed on a finite subset of \mathbb{Z} called a *membrane*. We show that their Donsker scaling limit is an oscillating skew Brownian motion.

1 Introduction

Let $S_{\xi}(n) := \xi_1 + \cdots + \xi_n$, $n \ge 0$, be a random walk where (ξ_k) are independent copies of an integer-valued random variable ξ . The well known Donsker invariance principle (see, e.g., Theorem 14.1 in Billingsley [2])

states that a properly scaled random walk converges in law to the standard Brownian motion if $E\xi = 0$ and $v^2 := \operatorname{Var} \xi \in (0, \infty)$. Namely,

$$\frac{S_{\xi}([n \cdot])}{v\sqrt{n}} \Rightarrow W(\cdot), \ n \to \infty, \tag{1.1}$$

in the Skorokhod space $D = D([0, \infty), \mathbb{R})$.

Consider an integer-valued Markov chain X whose transition probabilities coincide with transition probabilities of S_{ξ} everywhere except for a finite set $A \subset \mathbb{Z}$. We call the set A a *membrane* and say that X is a random walk perturbed on A. It appears that the Donsker scaling limit of X is not a Brownian motion any longer but a diffusion with a singular drift.

The first result on this topic belongs to Harrison and Shepp [8], who considered a symmetric Bernoulli random walk perturbed on a one-point membrane $A = \{0\}$. They proved that if

$$P(X(1) = x \pm 1 | X(0) = x) = \frac{1}{2}, \quad x \in \mathbb{Z} \setminus \{0\},$$

$$P(X(1) = 1 | X(0) = 0) = p \in [0, 1],$$

$$P(X(1) = -1 | X(0) = 0) = 1 - p,$$

(1.2)

then the processes $\{\frac{X([n\cdot])}{\sqrt{n}}\}_{n\geq 1}$ converge in distribution to a *skew Brownian motion* (SBM) W_{γ}^{skew} with permeability parameter $\gamma = 2p - 1$. Recall that the SBM W_{γ}^{skew} with permeability parameter $\gamma \in [-1, 1]$ is a continuous homogeneous Markov process with transition probability density function

$$p_t(x,y) = \varphi_t(x-y) + \gamma \operatorname{sgn}(y)\varphi_t(|x|+|y|), \quad x,y \in \mathbb{R}, \quad t > 0,$$
(1.3)

where $\varphi_t(x) = (2\pi t)^{-1/2} e^{-\frac{x^2}{2t}}$, $x \in \mathbb{R}$, t > 0. Another construction of the SBM was suggested by Itô and McKean, see [13, Problem 1, Section 4.2] and Walsh [33]. There, the SBM is obtained from a standard reflecting Brownian motion by flipping its excursions independently with probability 1 - p, and leaving it positive with probability p. An extensive survey on properties of a SBM can be found in Lejay [17].

The approach by Harrison and Shepp [8] is classical. To show convergence, they verified tightness and convergence of finite-dimensional distributions of the family $\{\frac{X([n\cdot])}{\sqrt{n}}\}_{n\geq 1}$, which can be done directly utilizing the simple structure of transition probabilities and André's reflection principle.

The case of a general finite membrane $A = \{-d, \ldots, d\}, d \ge 0$, and arbitrary non-unit jumps outside of A is much harder to deal with. Some partial results on functional limit theorems that generalize the result by Harrison and Shepp [8] were obtained by Minlos and Zhizhina [19], Pilipenko et al. [22, 10, 25, 24], Ngo and Peigné [20]. In these works, the convergence to a SBM was established under various restrictive assumptions, such as boundedness of jumps outside of the membrane, one-point membrane structure, etc.

In this paper we obtain a very general convergence results (Theorems 3.3 and 3.5) that use a minimal set of technical assumptions and generalize all the previous work. Our argument relies on consideration of a SBM as a particular case of a two-ray Walsh Brownian motion (WBM).

Recall that an *m*-ray WBM with non-negative weights $\mathbf{p} = (p_1, \ldots, p_m)$, $p_1 + \cdots + p_m = 1$, can be constructed similarly to the approach by Itô and McKean. Consider *m* rays with a common endpoint 0. A WBM is a time-homogeneous continuous strong Markov process that spends zero time at 0 and behaves like a standard Brownian motion on each ray up to hitting 0. Its excursions "select" the *k*-th ray with probability p_k , see Walsh [33] and Section 2 below. It is clear, that a 2-ray WBM can be naturally identified with a SBM with $\gamma = p_1 - p_2$.

Starting with a perturbed Markov chain X on Z with a membrane $A = \{-d, \ldots, d\}$, we will construct an auxiliary Markov chain \mathcal{X} on the enlarged state space $\mathbb{Z} \times \{-, +\}$, such that the "layers" $\mathbb{Z} \times \{-\}$ and $\mathbb{Z} \times \{+\}$ will be in some sense identified with the negative and positive rays $\{\ldots, -d-2, -d-1\}$ and $\{d+1, d+2, \ldots\}$ located to the left and to the right of the membrane of the Markov chain X. The transition probabilities of \mathcal{X} on the positive layers $\mathbb{N} \times \{-\}$ and $\mathbb{N} \times \{+\}$ will coincide with those of X to the left and to the right of the membrane as well as jumps over the membrane will be mimicked by (short) visits of \mathcal{X} to the negative layers $\{\ldots, -2, -1, 0\} \times \{-\}$ and $\{\ldots, -2, -1, 0\} \times \{+\}$. Employing the martingale characterization technique, we establish convergence of the Donsker scalings of the Markov chain \mathcal{X} to a WBM, and thus, convergence of a properly rescaled Markov chain X to a SBM.

This method of unfolding of a perturbed one-dimensional Markov chain into a multidimensional Markov chain was initially suggested by Iksanov and Pilipenko in [10]. In Bogdanskii et al. [3], this method was used to study convergence of m-dimensional random walks perturbed on a two-sided periodic hyperplane membrane. In particular, in our proofs we will utilize a martingale characterization of the WBM obtained in [3], see Section 2. We emphasize that our approach allows to treat random walks with different variances on different sides of the membrane. This case has not been treated in previous works with the only exception of the paper [20]. The general result on convergence of "unfolded" Markov chains to a m-ray WBM is our Theorem 3.3.

For reader's convenience, we formulate here an easy-to-use version of the assumptions a convergence result for scaling limits of perturbed random walks on \mathbb{Z} .

Let $(X(k))_{k\geq 0}$ be an integer-valued time-homogeneous Markov chain with a membrane $\{-d, \ldots, d\}$, $d\geq 0$, such that

$$P(X(1) = x + y | X(0) = x) = P(\xi_{+} = y), \quad x > d,$$

$$P(X(1) = x + y | X(0) = x) = P(\xi_{-} = y), \quad x < -d,$$
(1.4)

where the integer valued random variables ξ_{-}, ξ_{+} satisfy

$$E\xi_{\pm} = 0, \quad v_{\pm}^2 = Var\,\xi_{\pm} \in (0, +\infty),$$
(1.5)

and each of random variables ξ_+ and ξ_- generates a 1-arithmetic random walk.

Assume also that the states $\mathbb{Z}\setminus\{-d,\ldots,d\}$ of the Markov chain X communicate, X exits from the membrane with probability one, and jumps from the membrane are integrable, i.e.,

$$\max_{|x| < d} \mathbb{E}[|X(1)| \, | \, X(0) = x] < \infty.$$
(1.6)

Let $\varphi \colon \mathbb{R} \to \mathbb{R}$ be the following piece-wise linear function:

$$\varphi(x) := x \cdot v_{\operatorname{sgn}(x)}^{-1} := x \big(v_+^{-1} \mathbb{I}_{x \ge 0} + v_-^{-1} \mathbb{I}_{x < 0} \big).$$
(1.7)

Then for any initial distribution of X(0), the Donsker scaling $\left\{\varphi\left(\frac{X([n:])}{\sqrt{n}}\right)\right\}_{n\geq 1}$ weakly converges in $D([0,\infty),\mathbb{R})$ to a SBM $W_{\gamma}^{\text{skew}}(\cdot)$ starting at 0 with some permeability parameter $\gamma \in (-1,1)$. The rigorous statement of the result as well as the explicit value of the permeability parameter γ will follow from Theorem 3.5 and Remark 3.7. Its formulation requires a consideration of additional construction: entrance and exit embedded Markov chains, existence of their stationary distributions, etc. However, formula (3.41) for the permeability parameter γ is short and natural.

This result allows us to show that the limit of the Donsker scaling $\left\{\frac{X([n\cdot])}{\sqrt{n}}\right\}_{n\geq 1}$ is a oscillating SBM (see Corollary 3.8), which is a natural generalization of the oscillating Brownian motion originally introduced by Keilson and Wellner in [16]. The oscillating SBM is a diffusion that behaves like a Brownian motion with variance v_{+}^2 on the positive half-line and like a Brownian motion with variance v_{-}^2 on the negative half-line, and exhibits an infinitesimal push at 0 in the negative or positive direction. We mention here the work [7] by Hairer and Manson who obtained the process Y as a limit in the periodic homogenization problem with an interface.

We will also prove a result on convergence of Donsker scalings of a perturbed random walk on a graph $\mathbb{N}^m \cup \{0\}$. Under natural assumptions on integrability of jumps the limit process will be a WBM, too, see Theorem 3.9. The result of Theorem 3.9 extends the result of Enriques and Kifer [5]. There the authors studied the Donsker scaling of symmetric random walks with the step size $\varepsilon > 0$ on a spider graph consisting of *m* rays with the common origin 0. They obtained convergence to a WBM with equal weights 1/m for each ray. If the Markov chain lives on a ε -lattice containing the origin, the results of [5] are covered by our Theorem 3.9. For other initial values, an intermediate approximation argument has to be applied, see Examples 4.3 and 4.4 for more detail. Note that our Theorem 3.9 is more general since its allows non-uniform weights of the limit WBM and general step sizes of the Markov chain with different variances on each ray.

Eventually we mention that the case when jumps from the membrane are not integrable and belong to a domain of attraction of an α -stable law with $\alpha \in (0, 1)$ are much harder to deal with even if jumps from the membrane are positive. Some partial results in this direction were obtained by Pilipenko with co-authors in [26, 12, 23], where a reflected Brownian motion with jump-type exit from 0 appeared as a limit process. The

case when jumps outside of the membrane are not in Donsker's setup but belong to a domain of attraction of a stable law with parameter in (1, 2) leads to a skew stable Lévy process as it was recently shown in [11, 4].

The structure of the paper is as follows. In Section 2 we recall the definition of the WBM together with its martingale characterization and its relation to the skew Brownian motion. We formulate main general results on limit behavior of perturbed random walks in Section 3. The most important result is Theorem 3.3, where we consider perturbed random walks on $\mathbb{Z} \times \{1, \ldots, m\}$, whose Donsker scaling limit is a WBM. The result for scaling limits of a perturbed random walk with values in \mathbb{Z} (Theorem 3.5) and the result for scaling limits of a random walk on a graph (Theorem 3.9) follow from Theorem 3.3 and the ideas of its proof. We determine the weights of the WBM and the permeability parameter of the skew Brownian motion explicitly in terms of stationary distributions of some embedded entrance and exit Markov chains. We also write down a stochastic differential equation for a skew oscillating Brownian motion, which is a limit of scalings of perturbed random walk (Corollary 3.8). Section 4 contains six illustrative examples. In particular, we show that formulas obtained in Theorems 3.3 and 3.5 include and extend several known results as special cases. The proof of Theorem 3.3 is presented in Section 5. Theorem 3.5 is proven in Section 6. The last Section 7 contains the proofs of Corollary 3.8 and Theorem 3.9.

2 Walsh's and Skew Brownian motions

The main result of this paper will be expressed in terms of Walsh's Brownian motion $W_{\mathbf{p}}$. In this section we recall its definition, properties and martingale characterizations.

Originally, Walsh's Brownian motion was introduced in the work [33] as a diffusion on m rays on a two-dimensional plane with a common origin. Away from the origin, on each ray, WBM is a standard one-dimensional Brownian motion that can change the ray upon hitting the origin. In other words, the rays are characterized by m non-negative weights $\mathbf{p} = (p_1, \ldots, p_m), p_1 + \cdots + p_m = 1$. The number p_i is the probability to leave the origin into the ray number i.

In our work [3], we proposed a realization of the WBM as an m-dimensional process (as was also indicated in Walsh [33]) living on positive semi-axes. In comparison to the 2-dimensional construction with the help of polar coordinates, in this realization one does not have to treat the origin as a particular point at which the ray number is not well defined.

Let $m \geq 1$,

$$E^{m} = \{ x \in \mathbb{R}^{m} : x_{i} \ge 0 \text{ and } x_{i}x_{j} = 0, \ i \ne j, \ i, j = 1, \dots, m \},$$
(2.1)

and $\mathbf{p} = (p_1, \ldots, p_m)$ be a vector of weights. Let us work on the canonical probability space of continuous \mathbb{R}^m -valued functions equipped with the filtration \mathbb{F} generated by the coordinate mappings. We say that WBM is a time-homogeneous continuous Feller process $W_{\mathbf{p}} = X = (X_1, \ldots, X_m)$ on E^m whose marginal distributions are given by

$$E_{0}e^{\lambda_{1}X_{1}(t)+\dots+\lambda_{m}X_{m}(t)} = \sum_{k=1}^{m} p_{k}E_{0}e^{\lambda_{k}|W(t)|},$$

$$E_{x}e^{\lambda_{1}X_{1}(t)+\dots+\lambda_{m}X_{m}(t)} = E_{x_{j}}\left[\mathbb{I}_{t<\tau_{0}}e^{\lambda_{j}W(t)}\right] + \sum_{k=1}^{m} p_{k}E_{x_{j}}\left[\mathbb{I}_{t\geq\tau_{0}}e^{\lambda_{k}|W(t)|}\right]$$

$$= E_{x_{j}}\left[\sum_{k=1}^{m} p_{k}e^{\lambda_{k}|W(t)|}\right] + E_{x_{j}}\left[\mathbb{I}_{t<\tau_{0}}\left(e^{\lambda_{j}W(t)} - \sum_{k=1}^{m} p_{k}e^{\lambda_{k}W(t)}\right)\right],$$

$$x = (0,\dots,x_{j},\dots,0), \ x_{j} > 0, \ \lambda \in \mathbb{C}^{m},$$
(2.2)

where W is a one-dimensional standard Brownian motion and $\tau_0 = \inf\{t \ge 0 : W_t = 0\}$. Note that the last expectation is the expectation of a standard Brownian motion killed upon hitting zero.

In Barlow et al. [1], the authors provided the martingale characterization of the WBM realized as a process on the plane. In terms of the m-dimensional realization X of the WBM, their characterization takes the following form.

Theorem 2.1 (Propositon 3.1 and Theorem 3.2 in Barlow et al. [1]). Let $X = (X_1(t), \ldots, X_m(t))_{t\geq 0}$ be a continuous process. Then X is a WBM with parameters $p_1, \ldots, p_m > 0$ if and only if it satisfies the following conditions:

- 1. $X_i(t) \ge 0$ and $X_i(t)X_j(t) = 0$ for all $i \ne j$ and $t \ge 0$;
- 2. for each $i = 1, \ldots, m$ the process

$$N_i(t) := (1 - p_i)X_i(t) - p_i \sum_{j \neq i} X_j(t), \quad t \ge 0,$$
(2.3)

is a continuous martingale;

3. for each $i = 1, \ldots, m$ the process

$$(N_i(t))^2 - \int_0^t \left((1 - p_i) \mathbb{I}_{X_i(s) > 0} - p_i \mathbb{I}_{X_i(s) = 0} \right)^2 \mathrm{d}s, \quad t \ge 0,$$
(2.4)

is a continuous martingale.

Note that since the product of the indicator functions in (2.4) is identically zero, we have

$$\langle N_i \rangle_t = \int_0^t \left((1 - p_i) \mathbb{I}_{X_i(s) > 0} - p_i \mathbb{I}_{X_i(s) = 0} \right)^2 \mathrm{d}s = \int_0^t \left((1 - p_i)^2 \mathbb{I}_{X_i(s) > 0} + p_i^2 \mathbb{I}_{X_i(s) = 0} \right) \mathrm{d}s.$$
(2.5)

Furthermore, it is clear, see Lemma 2.2 in Barlow et al. [1], that the radial process

$$R(t) := \sum_{i=1}^{m} X_i(t) = \max_{1 \le i \le m} X_i(t)$$
(2.6)

is a reflecting Brownian motion, and hence it has a symmetric local time at 0 defined by:

$$L_0^X(t) := L_0^R(t) := \lim_{\varepsilon \to 0+} \frac{1}{2\varepsilon} \int_0^t \mathbb{I}_{\max_{1 \le i \le m} X_i(s) \le \varepsilon} \, \mathrm{d}s.$$

$$(2.7)$$

In our paper [3] we gave an equivalent martingale characterization of the WBM that is more convenient for the proof of the convergence theorem of this paper.

Theorem 2.2 (Theorem 3.2 in [3]). Let $X = (X_1(t), \ldots, X_m(t))_{t\geq 0}$ and $\nu = (\nu(t))_{t\geq 0}$ be continuous processes. Then X is a WBM with parameters $p_1, \ldots, p_m > 0$, and ν is the local time of X at 0 if and only if they satisfy the following conditions:

- 1. $X_i(t) \ge 0$ and $X_i(t)X_j(t) = 0$ for all $i \ne j, t \ge 0$;
- 2. $\nu(0) = 0, \nu$ is non-decreasing a.s., $\int_0^\infty \mathbb{I}_{X(s)\neq 0} \, \mathrm{d}\nu(s) = 0$ a.s.;
- 3. the processes M_1, \ldots, M_m defined by

$$M_i(t) := X_i(t) - p_i \nu(t), \quad t \ge 0,$$
(2.8)

are continuous square integrable martingales with the predictable quadratic variations

$$\langle M_i \rangle_t = \int_0^t \mathbb{I}_{X_i(s)>0} \,\mathrm{d}s.$$
(2.9)

4. $\int_0^\infty \mathbb{I}_{X(s)=0} \, \mathrm{d}s = 0 \, a.s.$

In his paper [33], Walsh addressed the properties of the skew Brownian motion originally constructed by Itô and McKean in [13], Problem 1, Section 4.2. A SBM with parameter $\gamma \in [-1, 1]$ is a diffusion that behaves like a standard Brownian motion on the half-lines $(-\infty, 0)$ and $(0, \infty)$ and upon hitting zero continues to the positive half-line with probability $p_+ = (\gamma+1)/2$ and to the negative half line with probability $p_- = (\gamma+1)/2$. In [3], it was shown that a SBM can be obtained from a WBM by summing together the motions on different rays.

Corollary 2.3 ([3], Corollary 3.4). Let $X = (X_1(t), \ldots, X_m(t))_{t \ge 0}$ be a WBM with parameters $p_1, \ldots, p_m > 0$ and let $I \subseteq \{1, \ldots, m\}$. Set

$$\gamma := \sum_{i \in I} p_i - \sum_{j \in I^c} p_j = 2 \sum_{i \in I} p_i - 1.$$
(2.10)

Then $\gamma \in [-1, 1]$ and the process

$$W_{\gamma}^{\text{skew}}(t) := \sum_{i \in I} X_i(t) - \sum_{j \in I^c} X_j(t), \quad t \ge 0,$$
 (2.11)

is a skew Brownian motion with the parameter γ .

Recall that due to [8], the skew Brownian motion is the unique strong solution of the stochastic differential equation

$$dW_{\gamma}^{\text{skew}}(t) = dW(t) + \gamma dL_{0}^{W_{\gamma}^{\text{skew}}}(t), \qquad (2.12)$$

where $L_0^{W_{\gamma}^{\text{skew}}}(\cdot)$ is the symmetric semimartingale local time at 0. Since $\langle W_{\gamma}^{\text{skew}} \rangle_t = t$, the symmetric semimartingale local time coincides with the symmetric local time.

In the sequel, we will use notation $W_{\mathbf{p}}(\cdot, x)$ and $W_{\gamma}^{\text{skew}}(\cdot, x)$ to denote WBM and SBM starting at a point x.

3 Convergence to WBM and SMB

One of the main results of this paper is related to a Markov chain $\mathcal{X} = ((R(k), l(k)))_{k \ge 0}$, on the state space $\mathcal{Z}^m := \mathbb{Z} \times \{1, \ldots, m\}, m \ge 1$, that is defined by the following set of assumptions.

A₁. For all $(x, i) \in \mathcal{N}^m := \mathbb{N} \times \{1, \dots, m\}$

$$P(\mathcal{X}(1) = (x+y,i) | \mathcal{X}(0) = (x,i)) = P(\xi^{(i)} = y),$$
(3.1)

where integer-valued random variables $\xi^{(1)}, \ldots, \xi^{(m)}$ satisfy

$$\mathbf{E}\xi^{(i)} = 0, \quad v_i^2 := \operatorname{Var}\xi^{(i)} \in (0, \infty), \quad 1 \le i \le m,$$
(3.2)

and each $\xi^{(i)}$, i = 1, ..., m, generates a 1-arithmetic random walk, i.e., \mathbb{Z} is the minimal lattice containing $\sup (\xi^{(i)})$.

A₂. For all $x \leq 0$ and $1 \leq i \leq m$

$$P(R(1) \in \mathbb{N} \mid \mathcal{X}(0) = (x, i)) = 1.$$
(3.3)

A₃. There is C > 0 such that for all $x \leq 0$ and $1 \leq i \leq m$

$$\mathbf{E}\Big[R(1)\Big|\mathcal{X}(0) = (x,i)\Big] \le C(1+|x|). \tag{3.4}$$

 \mathbf{A}_4 . The states \mathcal{N}^m of the Markov chain \mathcal{X} communicate.

We will call $R(\cdot)$ the radius and $l(\cdot)$ the label of \mathcal{X} . Note that the radius R may attain non-positive values. The qualitative behaviour of \mathcal{X} is as follows.

Assumption \mathbf{A}_1 says that for the "positive" initial point $\mathcal{X}(0) = (R(0), l(0)) = (x, i), x > 0$, the radius R behaves like a zero mean square integrable random walk with the increments having distribution $\xi^{(i)}$ until it hits $\{\ldots, -2, -1, 0\}$. Therefore the first exit time

$$\sigma = \inf\{k \ge 0 \colon R(k) \le 0\} \tag{3.5}$$

is finite a.s. Note that the label l does not change up to the stopping time σ ,

$$l(0) = l(1) = \dots = l(\sigma) = i.$$
 (3.6)

Upon reaching a non-positive value at time σ , the Markov chain \mathcal{X} for sure jumps to a "positive" value at one step. The label l can change, too:

$$R(\sigma+1) > 0, \quad l(\sigma+1) \in \{1, \dots, m\}.$$
 (3.7)

The technical Assumption A_3 controls the size of the jump of the radius at time $\sigma + 1$.

Let $\{\sigma_{\iota}\}_{\iota>1}$ denote the sequence of exit times of R from N, that is

$$\sigma = \sigma_1 = \inf\{k \ge 0 \colon R(k) \le 0\},$$

$$\sigma_{\iota+1} = \inf\{k > \sigma_{\iota} \colon R(k) \le 0\}.$$
(3.8)

Let also

$$\tau_{\iota} := \sigma_{\iota} + 1, \quad \iota \ge 1, \tag{3.9}$$

be the entrance times to \mathbb{N} .

With the sequences $\{\sigma_{\iota}\}_{\iota\geq 1}$ and $\{\tau_{\iota}\}_{\iota\geq 1}$ we associate embedded *exit* and *entrance* Markov chains taking values in $\{\ldots, -2, -1, 0\} \times \{1, \ldots, m\}$ and \mathcal{N}^m respectively and defined as

$$\begin{aligned}
\mathcal{X}_{\text{exit}}(\iota) &:= \mathcal{X}(\sigma_{\iota}), \\
\mathcal{X}_{\text{entrance}}(\iota) &:= \mathcal{X}(\tau_{\iota}), \quad \iota \ge 1,
\end{aligned}$$
(3.10)

Assumption A_4 yields the following statement.

Lemma 3.1. The Markov chains \mathcal{X}_{exit} and $\mathcal{X}_{entrance}$ have unique stationary distributions π_{exit} and $\pi_{entrance}$ respectively.

Proof. 1. First we prove the statement for the Markov chain \mathcal{X}_{exit} . It is well known that a Markov chain with countably many states has a unique stationary distribution if and only if the set of states contains precisely one positive recurrent class of essential communicating states, see Theorem 2 in Section 6 of Chapter 8 in Shiryaev [29].

It follows from Assumption \mathbf{A}_4 that all essential states of $\mathcal{X}_{\text{exit}}$ communicate. All of them are either null recurrent or positive recurrent. To exclude the case of null recurrence, it is sufficient to show that there is c > 0 such that for all $(x, i) \in \{\dots, -2, -1, 0\} \times \{1, \dots, m\}$

$$\mathbf{P}\Big(\mathcal{X}_{\text{exit}}(\iota+1) \in \{0\} \times \{1,\ldots,m\} \ \Big| \ \mathcal{X}_{\text{exit}}(\iota) = (x,i)\Big) \ge c.$$
(3.11)

To demonstrate this, it is sufficient to verify that there is c > 0 such that for all $(x, i) \in \mathcal{N}^m$

$$P\left(\mathcal{X}(\sigma) = (0,i) \middle| \mathcal{X}(0) = (x,i)\right) \ge c.$$
(3.12)

We borrow the reasoning from Section 2 in Vysotsky [32] and use facts from the renewal theory of random walks.

Let i be fixed. Consider a random walk

$$S_{-\xi^{(i)}}(0) = 0,$$

and let for $z \in \mathbb{Z}$

Then for all $x \in \mathbb{N}$ and $y \in \mathbb{N} \cup \{0\}$

$$P\left(\mathcal{X}(\sigma) = (-y,i) \middle| \mathcal{X}(0) = (x,i)\right) = P\left(S_{-\xi^{(i)}}(\chi_{x-1}) - (x-1) = y+1\right).$$
(3.15)

The value $S_{-\xi^{(i)}}(\chi_{x-1}) - (x-1)$ is the overshoot of the random walk $S_{-\xi^{(i)}}$ above the level x-1.

Let $H^{(i)}$ be the strictly ascending ladder height of the random walk $S_{-\xi^{(i)}}$.

Observe that the overshoot of the random walk $S_{-\xi^{(i)}}$ above the level x - 1 equals in distribution to the the overshoot of the random walk $S_{H^{(i)}}$ above the level x - 1. From Assumption \mathbf{A}_1 we have $\mathbf{E}H^{(i)} < \infty$, see T1 in Section 18 in Spitzer [31].

Therefore by formula (6.7) from Theorem 6.2, §2.6, in Gut [6] and equality (3.15) above we get that for any $y \in \mathbb{N} \cup \{0\}$

$$\lim_{x \to +\infty} \Pr\Big(\mathcal{X}(\sigma) = (-y, i) \Big| \mathcal{X}(0) = (x, i)\Big) = \frac{\Pr(H^{(i)} \ge y + 1)}{\mathbb{E}H^{(i)}},\tag{3.16}$$

and in particular for y = 0

$$\lim_{x \to +\infty} \Pr\Big(\mathcal{X}(\sigma) = (0, i) \Big| \mathcal{X}(0) = (x, i)\Big) = \frac{1}{\mathrm{E}H^{(i)}} > 0.$$
(3.17)

Since the probabilities $P(\mathcal{X}(\sigma) = (0, i) | \mathcal{X}(0) = (x, i))$ are obviously positive for any $x \in \mathbb{N}$, equation (3.17) implies that

$$\min_{i=1,\dots,m} \inf_{x \in \mathbb{N}} \mathbb{P}\Big(\mathcal{X}(\sigma) = (0,i) \Big| \mathcal{X}(0) = (x,i)\Big) > 0,$$

so that (3.12) holds true.

2. Existence of the stationary distribution for the Markov chain $\mathcal{X}_{entrance}$ follows from the observation that

and the existence of the stationary distribution for \mathcal{X}_{exit} .

Note that the stationary distributions π_{exit} and π_{entrance} are related as follows:

(3.20)

see a detailed investigation of exit and entrance chains constructed for the general Markov chain in Mijatović and Vysotsky [18].

Lemma 3.2.

$$E_{\pi_{\text{exit}}}|R(0)| = \sum_{x \ge 0} x \,\pi_{\text{exit}}(-x) < \infty, \tag{3.21}$$

$$E_{\pi_{\text{entrance}}} R(0) = \sum_{x \ge 1} x \, \pi_{\text{entrance}}(x) < \infty.$$
(3.22)

Proof. It follows from A_3 and (3.20) that it suffices to prove (3.21) only.

With the help of formula (18) in Vysotsky [32] we obtain an estimate for the expectation of an overshoot of a level: for each $\alpha > 0$ there is $K(\alpha) > 0$ such that for all $(x, i) \in \mathcal{N}^m$

$$\mathbf{E}_{x,i}|R(\sigma_1)| \le K(\alpha) + \alpha x. \tag{3.23}$$

Assume that R(0) = 0. Denote

(3.24)

where R_{exit} and R_{entrance} are the radii of the embedded Markov chains $\mathcal{X}_{\text{exit}}$ and $\mathcal{X}_{\text{entrance}}$ respectively. Then (3.23) and \mathbf{A}_3 yield inequalities

$$y_{n+1} \le C(1+x_n), \quad x_{n+1} \le K(\alpha) + \alpha y_{n+1}.$$
 (3.25)

Take some $\alpha \in (0, C^{-1})$. It can be shown by induction that

$$\sup_{n} x_n \le \frac{\alpha C + K(\alpha)}{1 - \alpha C}.$$
(3.26)

By the ergodic theorem, for any initial distribution we have convergence

$$\lim_{n \to \infty} \frac{\sum_{k=1}^{n} |R_{\text{exit}}(k)|}{n} = \mathbf{E}_{\pi_{\text{exit}}} |R(0)| \quad \text{a.s.}$$
(3.27)

Hence, the Fatou lemma yields that

$$\mathbf{E}_{\pi_{\text{exit}}}|R(0)| \le \frac{\alpha C + K(\alpha)}{1 - \alpha C} < \infty, \tag{3.28}$$

and the Lemma is proved.

Now we are ready to formulate our results for scaling limits of \mathcal{X} .

Consider a collection of sequences $\{\mathcal{X}^n(k)\}_{k\geq 0} = (R^n(k), l^n(k))_{k\geq 0}$ that have the same transition probabilities as $\{\mathcal{X}(k)\}_{k\geq 0}$, but maybe different initial conditions $\mathcal{X}^n(0) \in \mathcal{Z}^m$. The stopping times $\sigma^n(k)$ and $\tau^n(k)$ are defined respectively.

Let

$$X^{n}(t) := \left(\frac{R^{n}([nt])}{v_{1}\sqrt{n}} \mathbb{I}_{l^{n}([nt])=1}, \dots, \frac{R^{n}([nt])}{v_{m}\sqrt{n}} \mathbb{I}_{l^{n}([nt])=m}\right), \quad t \ge 0,$$
(3.29)

be a \mathbb{R}^m -valued stochastic process that lives on the coordinate axes. Note that its coordinates may take negative values.

Let $W_{\mathbf{p}}(\cdot, x)$ be a Walsh Brownian motion started from $x \in E^m$, see (2.1), with weights $\mathbf{p} = (p_1, \ldots, p_m)$ and the symmetric local time $L(\cdot, x)$ at 0, see the definition of the local time in (2.7).

Theorem 3.3. Assume that conditions A_1 - A_4 are satisfied and

$$X^n(0) \Rightarrow x \in E^m. \tag{3.30}$$

Then we have convergence:

$$(X^n, L^n) \Rightarrow (W_{\mathbf{p}}(\cdot, x), L(\cdot, x)), \ n \to \infty,$$

$$(3.31)$$

where

$$L^{n}(t) = \frac{1}{\sqrt{n}} \sum_{\substack{\tau_{k}^{n} \le [nt]}} \frac{R^{n}(\tau_{k}^{n}) - R^{n}(\sigma_{k+1}^{n})}{v_{l^{n}(\tau_{k}^{n})}}, \quad t \ge 0,$$
(3.32)

and

$$p_{k} = \frac{E_{\pi_{\text{entrance}}} R(0) v_{k}^{-1} \mathbb{I}_{l(0)=k} - E_{\pi_{\text{exit}}} R(0) v_{k}^{-1} \mathbb{I}_{l(0)=k}}{E_{\pi_{\text{entrance}}} R(0) v_{l(0)}^{-1} - E_{\pi_{\text{exit}}} R(0) v_{l(0)}^{-1}}$$

$$= \frac{E_{\pi_{\text{entrance}}} (R(0) - R(\sigma)) v_{k}^{-1} \mathbb{I}_{l(0)=k}}{E_{\pi_{\text{entrance}}} (R(0) - R(\sigma)) v_{l(0)}^{-1}}$$

$$= \frac{E_{\pi_{\text{exit}}} (R(1) v_{l(1)}^{-1} \mathbb{I}_{l(1)=k} - R(0) v_{l(0)}^{-1} \mathbb{I}_{l(0)=k})}{E_{\pi_{\text{exit}}} (R(1) v_{l(1)}^{-1} - R(0) v_{l(0)}^{-1})}.$$
(3.33)

This Theorem will be proven in Section 5.

Remark 3.4. Equality of expectations in (3.33) follows from (3.20) and the definition of the embedded exit and entrance Markov chains.

Let X be a perturbed random walk with a membrane $\{-d, \ldots, d\}, d \ge 0$, that is a Markov chain on \mathbb{Z} such that the following assumption holds true: **B**₁.

where the integer valued random variables ξ_{-}, ξ_{+} satisfy

 (3.35)

and generate 1-arithmetic random walks.

In order to specify the scaling limit of X analogously to Theorem 3.3 we have to introduce the embedded entrance and exit Markov chains and entrance and exit stopping times for the Markov chain X.

We define

$$\widetilde{\sigma}_{0} := 0,
\widetilde{\tau}_{\iota} := \inf\{k \ge \widetilde{\sigma}_{\iota} : |X(k)| > d\}, \quad \iota \ge 0,
\widetilde{\sigma}_{\iota+1} = \inf\{k > \widetilde{\tau}_{\iota} : X(k-1) > d, \quad X(k) \le d \quad \text{or} \quad X(k-1) < -d, \quad X(k) \ge -d\}, \quad \iota \ge 0.$$
(3.36)

The difference between definition (3.36) and definition (3.8), (3.9) is twofold. First, when $X(\tilde{\sigma}_{\iota}) \in \{-d, \ldots, d\}$, the Markov chain may stay on the membrane $\{-d, \ldots, d\}$ more than one step, and hence in general in this case we have $\tilde{\tau}_{\iota} \geq \tilde{\sigma}_{\iota} + 1$. Second, when X "jumps over" the membrane, i.e., when $X(\tilde{\sigma}_{\iota} - 1) > d$ and $X(\tilde{\sigma}_{\iota}) < -d$ or vice versa, we get $\tilde{\tau}_{\iota} = \tilde{\sigma}_{\iota}$.

We adapt the set of Assumptions **A** of Theorem 3.3. **B**₂. For all $x \in \{-d, \ldots, d\}$

B₃. For all $x \in \{-d, \ldots, d\}$

$$\mathbf{E}\Big[|X(\tilde{\tau}_0)|\Big|X(0) = x\Big] < \infty.$$

B₄. The states $\mathbb{Z} \setminus \{-d, \ldots, d\}$ of the Markov chain X communicate.

As above, we introduce the embedded Markov chains $X_{\text{exit}}(\iota) = X(\tilde{\sigma}_{\iota}), \iota \geq 1$, and $X_{\text{entrance}}(\iota) = X(\tilde{\tau}_{\iota}), \iota \geq 0$. Similarly to Lemmas 3.1 and 3.21 it can be shown that X_{exit} and X_{entrance} have unique stationary distributions π_{exit} and π_{entrance} , respectively, which are integrable.

Consider a collection of Markov chains $\{X^n(\cdot)\}_{n\geq 1}$ that have the same transition probabilities as $X(\cdot)$ but maybe have different initial values $X^n(0)$.

Theorem 3.5. Suppose that Assumptions \mathbf{B}_1 - \mathbf{B}_4 are satisfied and

$$\varphi\left(\frac{X^n(0)}{\sqrt{n}}\right) \Rightarrow x \in \mathbb{R},$$
(3.39)

where φ is defined in (1.7). Then we have convergence to a skew Brownian motion $W_{\gamma}^{\text{skew}}(\cdot, x)$ started at x:

where

$$\gamma = \frac{E_{\pi_{\text{entrance}}}\varphi(X(0) - X(\tilde{\sigma}_{1}))}{E_{\pi_{\text{entrance}}}|\varphi(X(0) - X(\tilde{\sigma}_{1}))|} = \frac{E_{\pi_{\text{entrance}}}(X(0) - X(\tilde{\sigma}_{1}))v_{\text{sgn}(X(0) - X(\tilde{\sigma}_{1}))}^{-1}}{E_{\pi_{\text{entrance}}}|X(0) - X(\tilde{\sigma}_{1})|v_{\text{sgn}(X(0) - X(\tilde{\sigma}_{1}))}^{-1}} = \frac{E_{\pi_{\text{entrance}}}(X(0) - X(\tilde{\sigma}_{1}))v_{\text{sgn}(X(0) - X(\tilde{\sigma}_{1}))}^{-1}}{E_{\pi_{\text{entrance}}}|X(0) - X(\tilde{\sigma}_{1})|v_{\text{sgn}(X(0) - X(\tilde{\sigma}_{1}))}^{-1}}.$$
(3.41)

This Theorem will be proven in Section 6.

Remark 3.6. The case when the membrane A is an arbitrary finite set $\{x_1, \ldots, x_m\} \subset \mathbb{Z}$ is also covered by Theorem 3.5. Indeed, X can be considered as a random walk perturbed on bigger membrane $\{-d, \ldots, d\}$, where $d = \max_{1 \le i \le m} |x_i|$.

Remark 3.7. Condition \mathbf{B}_3 can be replaced with a simpler one: \mathbf{B}'_3 .

In the last line we use condition \mathbf{B}_2 and the convention that $\frac{0}{0} = 0$.

Corollary 3.8. The weak limit of the sequence $\left\{\frac{X([n \cdot])}{\sqrt{n}}\right\}_{n \ge 1}$ is a process $(Y(t))_{t \ge 0} := \left(\varphi^{-1}(W_{\gamma}^{\text{skew}}(t))\right)_{t \ge 0}$, which is a skew oscillating Brownian motion that satisfies the SDE

$$Y(t) = \int_0^t \left(v_- \mathbb{I}_{Y(s) < 0} + v_+ \mathbb{I}_{Y(s) \ge 0} \right) \mathrm{d}W(s) + \frac{\gamma(v_+ + v_-) + v_+ - v_-}{\gamma(v_+ - v_-) + v_+ + v_-} L_0^Y(t), \quad t \ge 0, \tag{3.44}$$

where

$$L_0^Y(t) = \lim_{\varepsilon \to 0+} \frac{1}{2\varepsilon} \int_0^t \mathbb{I}_{|Y(s)| < \varepsilon} \, \mathrm{d}\langle Y \rangle_s = \lim_{\varepsilon \to 0+} \frac{1}{2\varepsilon} \int_0^t \left(v_-^2 \mathbb{I}_{-\varepsilon < Y(s) < 0} + v_+^2 \mathbb{I}_{0 \le Y(s) < \varepsilon} \right) \mathrm{d}s \tag{3.45}$$

is the symmetric semimartingale local time of Y at 0.

A result similar to Theorem 3.5 is also true for a perturbed random walk on a graph, where the limit process will be a Walsh Brownian motion. Let us describe the construction. For some $m \in \mathbb{N}$, consider a Markov chain \mathcal{X} on the state space

Let us formulate a set of assumptions concerning the dynamics of \mathcal{X} .

We assume that for each $k \ge 0$, $\mathcal{X}(k)$ is independent of the 'future' $(\xi_{k+j}^{(1)})_{j\ge 1}, \ldots, (\xi_{k+j}^{(m)})_{j\ge 1}$. On each ray $\mathbb{N} \times \{i\}$, \mathcal{X} behaves as a random walk with increments $\xi^{(i)}$, that is if $\mathcal{X}(k) = (x, i) \in \mathcal{N}^m$ and $x + \xi_{k+1}^{(i)} > 0$, then

depends only on *i* and $x + \xi_{k+1}^{(i)}$. **C**₂. The conditional distribution Law($\mathcal{X}(1) | \mathcal{X}(0) = 0$) satisfies

 \mathbf{C}_3 . There is a constant C > 0 such that for all $(x, i) \in \mathcal{N}^m$

$$\mathbf{E}\left[R(k+1) \left| \mathcal{X}(k) = (x,i), \, x + \xi_{k+1}^{(i)} < 0\right] \le C(1 + |x + \xi_{k+1}^{(i)}|). \tag{3.53}$$

 \mathbf{C}_4 . All the states \mathcal{N}^m of \mathcal{X} communicate.

We define the following stopping times:

$$\widehat{\sigma}_{0} := 0,
\widehat{\tau}_{\iota} := \inf\{k \ge \widehat{\sigma}_{\iota} : X(k) > 0\}, \quad \iota \ge 0,
\widehat{\sigma}_{\iota+1} := \inf\{k \ge \widehat{\tau}_{\iota} : R(k) + \xi_{k+1}^{(i)} \le 0\}, \quad \iota \ge 1.$$
(3.54)

The random variable $\hat{\sigma}_{\iota}$ is the ι -th moment when X jumps to 0 or "wants to overjump 0". Introduce the entrance Markov chain $X_{\text{entrance}}(\iota) := X(\hat{\tau}_{\iota}), \iota \geq 1$, with the (unique) invariant distribution π_{entrance} .

Theorem 3.9. Assume that Assumptions C_1 - C_4 hold true. Then the Donsker scaling of R converges in distribution to a Walsh Brownian motion $W_{\mathbf{p}}(\cdot)$ starting at 0:

$$\left(\frac{R([n\cdot])}{v_1\sqrt{n}}\mathbb{I}_{l(n)=1},\ldots,\frac{R([n\cdot])}{v_m\sqrt{n}}\mathbb{I}_{l(n)=m}\right) \Rightarrow W_{\mathbf{p}}(\cdot), \quad n \to \infty.$$
(3.55)

The weights $\mathbf{p} = (p_1, \ldots, p_m)$ of the Walsh Brownian motion are defined as follows:

$$p_{k} = \frac{\mathrm{E}_{\pi_{\mathrm{entrance}}}\left[\left(R(0) - R(\widehat{\sigma}_{1}) - \xi_{\widehat{\sigma}_{1}+1}^{(k)}\right)v_{k}^{-1}\mathbb{I}_{l(0)=k}\right]}{\mathrm{E}_{\pi_{\mathrm{entrance}}}\left[\left(R(0) - R(\widehat{\sigma}_{1}) - \xi_{\widehat{\sigma}_{1}+1}^{(l(0))}\right)v_{l(0)}^{-1}\right]}.$$
(3.56)

4 Examples

Example 4.1. We work in the setting of Theorem 3.5. Consider perturbations of a simple symmetric random walk, i.e., assume that $\xi_+ \stackrel{d}{=} \xi_- \stackrel{d}{=} \xi$, where $P(\xi = \pm 1) = \frac{1}{2}$. Then $v_{\pm}^2 = 1$ and $\varphi(x) = x$.

1. Assume that d = 0. Then the membrane consists of the single point $\{0\}$. Notice that $X(\tilde{\sigma}_1) = 0$, so that the stationary distribution π_{exit} is trivial, $\pi_{\text{exit}}(0) = 1$. Let the law of the jump from 0 coincide with the law of a random variable η ,

$$P(X(1) = j | X(0) = 0) = P(\eta = j), \ j \in \mathbb{Z}.$$
(4.1)

Recall that $P(\eta = 0) < 1$ by assumption B_2 . Hence the entrance stationary distribution is equal to the distribution of the random walk at the moment of exit from 0

$$\pi_{\text{entrance}}(j) = P(X(\tau_0) = j \mid X(0) = 0) = \frac{P(\eta = j)}{P(\eta \neq 0)}, \quad j \neq 0.$$
(4.2)

The permeability parameter γ of the limit skew Brownian motion is

$$\gamma = \frac{\mathrm{E}\eta}{\mathrm{E}|\eta|}.\tag{4.3}$$

In particular, if P(X(1) = 1 | X(0) = 0) = p and P(X(1) = -1 | X(0) = 0) = 1 - p or some $p \in (0, 1)$ then

$$\gamma = 2p - 1. \tag{4.4}$$

Formulas (4.4), (4.3) appeared for the first time in the paper by Harrison and Shepp [8] (formula (4.3) was only announced there).

2. Assume that $d \in \mathbb{N}$, but the random walk can exit from $\{-d, \ldots, d\}$ only to the neighboring points d+1 or -d-1. Then the distribution π_{entrance} is supported on the two point set $\{-d-1, d+1\}$. Denote

$$\alpha := P(X(\tilde{\tau}_0) = d + 1 | X(0) = -d), \quad \beta := P(X(\tilde{\tau}_0) = -d - 1 | X(0) = d).$$
(4.5)

The stationary distribution π_{entrance} is calculated explicitly:

$$\pi_{\text{entrance}}(d+1) = \frac{\alpha}{\alpha+\beta}, \quad \pi_{\text{entrance}}(-d-1) = \frac{\beta}{\alpha+\beta}.$$
 (4.6)

Notice that $X(\tilde{\sigma}_1) = d$ if X(0) = d+1 and $X(\tilde{\sigma}_1) = -d$ if X(0) = -d-1. Hence the permeability parameter γ has the form

$$\gamma = \pi_{\text{entrance}}(d+1) - \pi_{\text{entrance}}(-d-1) = \frac{\alpha - \beta}{\alpha + \beta}.$$
(4.7)

This result was already obtained in Pilipenko and Pryhod'ko [22].

Example 4.2. We work in the setting of Theorem 3.5. Assume that a perturbed random walk on \mathbb{Z} is such that $P(\xi_+ \ge -1) = P(\xi_- \le 1) = 1$ and assume that $d \in \mathbb{N}$. Then π_{exit} is concentrated in two points $\{-d\}$ and $\{d\}$. Denote

$$\widetilde{\tau}_0 := \inf\{k \ge 0 \colon |X(k)| > d\}.$$
(4.8)

and

$$\alpha := P(X(\tilde{\tau}_0) > 0 \,|\, X(0) = -d), \quad \beta := P(X(\tilde{\tau}_0) < 0 \,|\, X(0) = d).$$
(4.9)

Then the stationary exit distribution π_{exit} is

$$\pi_{+} := \pi_{\text{exit}}(d) = \frac{\alpha}{\alpha + \beta}, \quad \pi_{-} := \pi_{\text{exit}}(-d) = \frac{\beta}{\alpha + \beta}, \tag{4.10}$$

and the stationary entrance distribution π_{entrance} is

$$\pi_{\text{entrance}}(x) = \pi_{-} \mathcal{P}(X(\tilde{\tau}_{0}) = x \,|\, X(0) = -d) + \pi_{+} \mathcal{P}(X(\tilde{\tau}_{0}) = x \,|\, X(0) = d), \,\,|x| > d.$$
(4.11)

Notice that $X(\tilde{\sigma}_1) = d \operatorname{sgn} X(0)$ and $X(0) - X(\tilde{\sigma}_1) = X(0) - d \operatorname{sgn} X(0)$ if |X(0)| > d. Hence the parameter γ from Theorem 3.5 equals

$$\gamma = \frac{\mathrm{E}_{\pi_{\mathrm{entrance}}}(X(0) - d \operatorname{sgn} X(0)) v_{\mathrm{sgn} X(0)}^{-1}}{\mathrm{E}_{\pi_{\mathrm{entrance}}} |X(0) - d \operatorname{sgn} X(0)| v_{\mathrm{sgn} X(0)}^{-1}}.$$
(4.12)

In particular, if $v_+ = v_-$, then

$$\gamma = \frac{E_{\pi_{\text{entrance}}}(X(0) - d \operatorname{sgn} X(0))}{E_{\pi_{\text{entrance}}}|X(0) - d \operatorname{sgn} X(0)|}.$$
(4.13)

If additionally (4.5) holds true, then

$$\gamma = \frac{\alpha - \beta}{\alpha + \beta}.\tag{4.14}$$

according to formula (4.7).

Example 4.3. We work in the setting of Theorem 3.3. Assume that the random walk \mathcal{X} on \mathcal{Z}^m , $m \ge 1$, is such that $P(\xi^{(i)} = \pm 1) = 1/2$ and

$$P(\mathcal{X}(1) = (1, j) | \mathcal{X}(0) = (0, i)) = q_{ij},$$
(4.15)

where $Q = ||q_{ij}||$ is an irreducible stochastic matrix. We denote its stationary distribution (column vector) by $\pi = (\pi_i)_{1 \le i \le m}$ and recall that is the unique solution of the equation $Q^T \pi = \pi$.

Notice that the variances of the step sizes are equal to 1, $v_i^2 = 1$, and the stationary distribution π_{entrance} is supported on the set $\{(1,i)\}_{1\leq i\leq m}$. Moreover, $R(\sigma) = 0$, so $\mathcal{X}_{\text{entrance}}$, takes values in $\{1\} \times \{1,\ldots,m\}$ and has transition probabilities

$$P(\mathcal{X}_{entrance}(1) = (1, j) | \mathcal{X}_{entrance}(0) = (1, i)) = P(\mathcal{X}(1) = (1, j) | \mathcal{X}(0) = (0, i)) = q_{ij}.$$
(4.16)

Therefore we have

$$\pi_{\text{entrance}}(1,i) = \pi_i, \quad 1 \le i \le m. \tag{4.17}$$

Hence by (3.33) the weights $\mathbf{p} = (p_1, \ldots, p_m)$ of the limit WBM $W_{\mathbf{p}}$ coincide with the stationary distribution $\pi = (\pi_1, \ldots, \pi_m).$

Let p_1, \ldots, p_m be arbitrary positive probabilities, $p_1 + \cdots + p_m = 1$. Assume that $q_{ij} = p_j$ for all $i, j = 1, \ldots, m$, i.e., the choice of the next label is independent of the previous label. Then $\pi_i = p_i$, $i = 1, \ldots, m$. To the best of our knowledge, this convergence of a perturbed Markov chain to a WBM with *arbitrary* weights is a new result.

Example 4.4. The model from Example 4.3 is related to that studied in Section 3 in Enriquez and Kifer [5]. Let us describe it in detail and show how it can be recovered from Theorem 3.3 and the methods used in the proof. Instead of considering a planar spider graph consisting of m rays, we will work on the space E^m defined in (2.1). Let $\{e_1,\ldots,e_m\}$ be unit coordinate vectors and assume that E^m is equipped with a natural graph distance. For $\varepsilon > 0$ consider a Markov chain $X_{\varepsilon} = (X_{\varepsilon}(k))_{k \ge 0}$ on E^m whose jumps length are equal to ε and the transition probabilities are defined by the following rules:

- 1. if $X_{\varepsilon}(k) = re_i$ and $r \geq \varepsilon$, then $X_{\varepsilon}(k+1) = (r \pm \varepsilon)e_i$ with probability 1/2;
- 2. if $X_{\varepsilon}(k) = 0$, then $X_{\varepsilon}(k+1) = \varepsilon e_j$, $1 \le j \le m$, with probabilities 1/m;

3. if $X_{\varepsilon}(k) = re_i$ and $r \in (0, \varepsilon)$, then

$$X_{\varepsilon}(k+1) = \begin{cases} (\varepsilon - r)e_j, \ j \neq i, \\ (\varepsilon + r)e_i, \ j = i, \end{cases}$$
(4.18)

with probability $q_{(j-i) \mod m}$, $1 \le i, j \le m$, where q_0, \ldots, q_{m-1} are positive probabilities, $q_0 + \cdots + q_{m-1}$ $q_{m-1} = 1.$

Note that $X_{\varepsilon}(k)$ can visit 0 if and only if the initial value $X_{\varepsilon}(0)$ belongs to the lattice $(\varepsilon \mathbb{N}^m) \cup \{0\}$.

Let a sequence of positive numbers $\{\varepsilon_n\}$ be such that $\lim_{n\to\infty} \varepsilon_n = 0$ and let $X_{\varepsilon_n}(0) \Rightarrow x \in E^m$.

If $\varepsilon_n^{-1}X_{\varepsilon_n}(0) \in \mathbb{N}^m \cup \{0\}$ for every n, then Case 3 above never occurs, and by Theorem 3.3 we have convergence

$$X_{\varepsilon_n}(\varepsilon_n^{-2}\cdot) \Rightarrow W_{\mathbf{p}}(\cdot, x), \ n \to \infty, \tag{4.19}$$

where $\mathbf{p} = (\frac{1}{m}, \dots, \frac{1}{m})$. Assume now that the initial value $\varepsilon_n^{-1} X_{\varepsilon_n}(0)$ does not belong to the lattice $\mathbb{N}^m \cup \{0\}$ for every *n*. Then our results are not applicable directly since the values $\varepsilon_n^{-1} X_{\varepsilon_n}(\cdot)$ are not integer. However, they are applicable after some modifications.

We define a Markov chain $\mathcal{X}^n = (\mathbb{R}^n(k), \mathbb{I}^n(k))_{k \ge 0}$ on $\mathcal{Z}^m = \mathbb{Z} \times \{1, \dots, m\}$ as follows:

if
$$X_{\varepsilon_n}(k) = re_i$$
 with $r \in (x\varepsilon_n, (x+1)\varepsilon_n)$ for some $x \in \mathbb{N} \cup \{0\}$ and $i = 1, \dots, m$,
then $\mathcal{X}^n(k) = (x, i)$. (4.20)

It can be seen that all $\{\mathcal{X}^n\}$ are Markov chains with possibly different initial conditions but with the same transition probabilities

$$P(\mathcal{X}^{n}(k+1) = (x \pm 1, i) | \mathcal{X}^{n}(k) = (x, i)) = \frac{1}{2}, \text{ if } x \in \mathbb{N},$$

$$P(\mathcal{X}^{n}(k+1) = (0, j) | \mathcal{X}^{n}(k) = (0, i)) = q_{(i-j) \mod m}, \text{ if } i \neq j,$$
(4.21)

and

$$P(\mathcal{X}^n(k+1) = (1,i) | \mathcal{X}^n(k) = (0,i)) = q_0.$$
(4.22)

Notice that the distance between $X^n(k) := \varepsilon_n(R^n(k)\mathbb{I}_{l^n(k)=1}, \ldots, R^n(k)\mathbb{I}_{l^n(k)=m})$ and $X_{\varepsilon_n}(k)$ does not exceed ε_n . Hence, the limits of $\{X_{\varepsilon_n}(\varepsilon_n^{-2}\cdot)\}$ and $\{X^n(\varepsilon_n^{-2}\cdot)\}$ are equal if at least one of them exists.

Introduce the stopping times

$$\sigma_{1}^{n} = \inf\{k \ge 0 \colon R^{n}(k) = 0\}, \tau_{\iota}^{n} = \inf\{k > \sigma_{\iota}^{n} \colon R^{n}(k) = 1\}, \sigma_{\iota+1}^{n} = \inf\{k > \tau_{\iota}^{n} \colon R^{n}(k) = 0\}, \ \iota \in \mathbb{N},$$
(4.23)

and entrance and exit Markov chains

$$\begin{aligned}
\mathcal{X}_{\text{exit}}^{n}(\iota) &:= \mathcal{X}^{n}(\sigma_{\iota}^{n}), \\
\mathcal{X}_{\text{entrance}}^{n}(\iota) &:= \mathcal{X}^{n}(\tau_{\iota}^{n}), \quad \iota \ge 1.
\end{aligned}$$
(4.24)

Note that Markov chains $\{\mathcal{X}^n\}$ do not visit the set $\{\ldots, -2, -1\} \times \{1, \ldots, m\}$ at all. It is clear that the entrance and exit Markov chains have unique stationary distributions π_{entrance} and π_{exit} concentrated on the sets $\{1\} \times \{1, \ldots, m\}$ and $\{0\} \times \{1, \ldots, m\}$ respectively. It follows from symmetry reasons that these distributions are uniform. Therefore the probabilities p_k defined in (3.33) satisfy

$$p_{k} = \frac{\mathrm{E}_{\pi_{\mathrm{entrance}}}(R(0) - R(\sigma))\mathbb{I}_{l(0)=k}}{\mathrm{E}_{\pi_{\mathrm{entrance}}}(R(0) - R(\sigma))} = \frac{\mathrm{E}_{\pi_{\mathrm{entrance}}}(1-0)\mathbb{I}_{l(0)=k}}{\mathrm{E}_{\pi_{\mathrm{entrance}}}(1-0)} = \pi_{\mathrm{entrance}}(1,k) = \frac{1}{m}.$$
 (4.25)

The Markov chains $\{\mathcal{X}^n\}$ make transitions from the set $\{0\} \times \{1, \ldots, m\}$ to the same set $\{0\} \times \{1, \ldots, m\}$ which is not allowed by the assumptions of Theorem 3.3. However if we skip such transitions, then the new Markov chains will satisfy assumptions of Theorem 3.3. Let us formally explain this construction.

We introduce a sequence $\{\lambda_n(k)\}_{k>0}$ as follows

$$\lambda_n(0) := 0,$$

$$\lambda_n(k) := k - \sum_{j=1}^k \mathbb{I}(\mathcal{X}^n(j-1) \in \{0\} \times \{1, \dots, m\}, \mathcal{X}^n(j) \in \{0\} \times \{1, \dots, m\}), \quad k \ge 1.$$
(4.26)

The sequence λ^n is a time homogeneous additive functional of a Markov chain \mathcal{X}^n that counts all the steps of \mathcal{X}^n except those that start and end within the set $\{0\} \times \{1, \ldots, m\}$. The inverse mapping

$$\lambda_n^{-1}(k) := \inf\{j \ge 0 \colon \lambda_n(j) \ge k\}, \quad k \ge 0,$$
(4.27)

is a sequence of stopping times, so that the process $k \to \mathcal{X}^n(\lambda_n^{-1}(k)) =: \widehat{\mathcal{X}}^n(k) =: (\widehat{R}^n(k), \widehat{l}^n(k))$ is a time homogeneous Markov chain with transition probabilities

$$P(\hat{\mathcal{X}}^{n}(1) = (x \pm 1, i) \,|\, \hat{\mathcal{X}}^{n}(0) = (x, i)) = \frac{1}{2}, \quad \text{if } x \in \mathbb{N},$$
(4.28)

and

$$P(\widehat{\mathcal{X}}^{n}(1) = (1, j) | \widehat{\mathcal{X}}^{n}(0) = (0, i)) = P(\mathcal{X}^{n}(\tau_{1}^{n}) = (1, j) | \mathcal{X}^{n}(0) = (0, i)).$$
(4.29)

In particular this implies that \widehat{R}^n is a Markov chain on \mathbb{N}_0 with transition probabilities

$$P(\widehat{R}^{n}(1) = x \pm 1 | \widehat{R}^{n}(0) = x) = \frac{1}{2}, \quad \text{if } x \in \mathbb{N},$$
(4.30)

and

$$P(\widehat{R}^{n}(1) = 1 | \widehat{R}^{n}(0) = 0) = 1.$$
(4.31)

Theorem 3.3 gives us convergence

$$\left(\varepsilon_n \widehat{R}^n(\varepsilon_n^{-2} \cdot) \mathbb{I}_{\widehat{l}^n(\varepsilon_n^{-2})=1}, \dots, \varepsilon_n \widehat{R}^n(\varepsilon_n^{-2} \cdot) \mathbb{I}_{\widehat{l}^n(\varepsilon_n^{-2})=m}\right) \Rightarrow W_{\mathbf{p}}(\cdot, x), \quad n \to \infty,$$

$$(4.32)$$

with the weights $\mathbf{p} = (\frac{1}{m}, \dots, \frac{1}{m}).$

Convergence (4.19) in this case will follow from (4.32) and for theorem Corollary 6.2 if show that the number of skipped steps is negligible, i.e., for each $t \ge 0$

$$\left|\varepsilon_n^2 \lambda_n([\varepsilon_n^{-2} t]) - t\right| \xrightarrow{\mathbf{P}} 0, \quad n \to \infty.$$
(4.33)

Let

$$\widehat{N}^{n}(k) = \sum_{j=0}^{k} \mathbb{I}_{\widehat{R}^{n}(j)=0}$$
(4.34)

be the number of visits of $\widehat{\mathcal{X}}^n$ to the set $\{0\} \times \{1, \ldots, m\}$. Since \widehat{R}^n is a simple symmetric random walk on \mathbb{N} with reflection at 0, see (4.30) and (4.31), it is well known (see, e.g., Example 2 in Section 9 of Chapter 7 in Shiryaev [29]) that

$$\varepsilon_n^2 \widehat{N}^n([\varepsilon_n^{-2}t]) \xrightarrow{\mathrm{P}} 0, \quad n \to \infty.$$
 (4.35)

Denote the time spent by \mathcal{X}^n in the set $\{0\} \times \{1, \ldots, m\}$ by

$$\zeta_{\iota}^{n} := \tau_{\iota}^{n} - \sigma_{\iota}^{n}, \tag{4.36}$$

see (4.23). The random variables $\{\zeta_{\iota}^n\}_{\iota\geq 0}$ are iid with the geometrical distribution with parameter q_0 . We recall (4.26) and estimate the number of transitions of \mathcal{X}^n inside of the set $\{0\} \times \{1, \ldots, m\}$ as follows

$$k - \lambda_n(k) \le \sum_{\iota=0}^{\widehat{N}^n(k)} \zeta_{\iota}^n, \tag{4.37}$$

so that

$$\left|\varepsilon_n^2 \lambda_n([\varepsilon_n^{-2}t]) - t\right| \le \varepsilon_n^2 + \varepsilon_n^2 \sum_{j=0}^{\widehat{N}^n([\varepsilon_n^{-2}t])} \zeta_j^n \tag{4.38}$$

and (4.33) is proved.

Summarizing all our findings, we get the convergence

$$X_{\varepsilon}(\varepsilon^{-2}\cdot) \Rightarrow W_{\mathbf{p}}(\cdot, x), \quad \varepsilon \to 0,$$

$$(4.39)$$

for any initial conditions such that $X_{\varepsilon}(0) \Rightarrow x \in E^m$, and $\mathbf{p} = (\frac{1}{m}, \dots, \frac{1}{m})$.

Example 4.5. In the work [20], Ngo and Paigné considered a time homogeneous Markov chain $\{Y(k)\}_{k\geq 0}$ defined by

$$Y(k+1) = \begin{cases} Y(k) + \xi_{k+1}^+, & \text{if } Y(k) > 0 \text{ and } Y(k) + \xi_{k+1}^+ > 0, \\ Y(k) + \xi_{k+1}^-, & \text{if } Y(k) < 0 \text{ and } Y(k) + \xi_{k+1}^- < 0, \\ \eta_{k+1}, & \text{if } Y(k) = 0, \\ 0, & \text{otherwise}, \end{cases}$$
(4.40)

where $\xi_k^+ \stackrel{d}{=} \xi_+$, $\xi_k^- \stackrel{d}{=} \xi_-$, η_k , $k \ge 1$, are mutually independent random variables that are independent of Y(0). It is assumed that ξ_- and ξ_+ are zero-mean integer-valued random variables with variances $v_{\pm}^2 = \operatorname{Var} \xi_{\pm} \in (0, \infty)$, and $\operatorname{E} |\eta| < \infty$.

Since Y is forced to hit 0 at any attempt to jump over the origin, it does not satisfy the setting of Theorem 3.5. However it can be fit into our theory with the help of a Markov chain $\mathcal{X}(k) = (R(k), l(k)), k \ge 0$, on the state space $\mathbb{Z} \times \{-, +\}$ defined as follows.

We set

$$R(k+1) = \begin{cases} R(k) + \xi_{k+1}^{+} & \text{if } l(k) = + \text{ and } R(k) > 0, \\ R(k) - \xi_{k+1}^{-} & \text{if } l(k) = - \text{ and } R(k) > 0, \\ |\eta_{k}| & \text{if } R(k) \le 0, \end{cases}$$

$$l(k+1) = \begin{cases} l(k) & \text{if } R(k) > 0, \\ + & \text{if } R(k) \le 0 \text{ and } \eta_{k} \ge 0, \\ - & \text{if } R(k) \le 0 \text{ and } \eta_{k} < 0, \end{cases}$$

$$R(0) = |Y(0)|,$$

$$l(0) = \begin{cases} +, & \text{if } Y(0) \ge 0, \\ -, & \text{if } Y(0) < 0. \end{cases}$$

$$(4.41)$$

We have that Y(k) = l(k)R(k) in each of the following three cases:

$$\left\{Y(k) > 0 \text{ and } Y(k) + \xi_{k+1}^+ > 0\right\} \text{ or } \left\{Y(k) < 0 \text{ and } Y(k) + \xi_{k+1}^- < 0\right\} \text{ or } \left\{Y(k) = 0\right\}.$$
(4.42)

Otherwise,

$$|Y(k) - l(k)R(k)| \le |\xi_{k+1}^{-}| \lor |\xi_{k+1}^{+}|.$$
(4.43)

Since ξ_k^{\pm} are square integrable we have

$$\frac{1}{\sqrt{n}} \max_{k \le [nt]} \left(|\xi_{k+1}^-| \lor |\xi_{k+1}^+| \right) \xrightarrow{\mathbf{P}} 0, \quad n \to \infty,$$

$$(4.44)$$

for any $t \geq 0$.

We apply Theorem 3.3 to study the limit behaviour of \mathcal{X} . The stationary distribution π_{entrance} of the Markov chain $\mathcal{X}_{\text{entrance}}$ can be determined explicitly as

$$\pi_{\text{entrance}}(x,+) = \mathcal{P}(\eta = x \mid \eta \neq 0),$$

$$\pi_{\text{entrance}}(x,-) = \mathcal{P}(\eta = -x \mid \eta \neq 0), \quad x \in \mathbb{N}.$$
(4.45)

Let $\sigma = \inf\{k \ge 0 \colon R(k) \le 0\}$ be the time instant, when the radius becomes non-positive for the first time. Denote by

the expected value of the overshoot over 0. Hence by the formula (3.33)

$$p_{-} = 1 - p_{+}.$$

Eventually, the Donsker scaling limit of $\varphi(Y([n \cdot])/\sqrt{n})$, where φ is defined in (1.7), is the skew Brownian motion with $\gamma = p_+ - p_-$, see Corollary 2.3.

Our formula (4.47) coincides with the result obtained in Ngo and Paigné [20] where the formula for γ was characterized in terms of descending ladder epochs and descending renewal functions of the random walks with steps $\{\xi_k^+\}$ and $\{\xi_k^-\}$, respectively.

Example 4.6. We work in the setting of Theorem 3.5 and assume that all the jumps starting from the membrane have mean value zero:

According to Corollary 3.8 the weak limit of $\left(\frac{X([nt])}{\sqrt{n}}\right)_{t\geq 0}$ is a skew oscillating Brownian motion satisfying (3.44). On the other hand, it is easy to see that the Markov chain $X = (X(k))_{k\geq 0}$ is a martingale, and

that the limit skew oscillating Brownian motion is a martingale, too. Therefore the local time term in (3.44) vanishes. This means that the limit of $\left(\frac{X([nt])}{\sqrt{n}}\right)_{t\geq 0}$ is the oscillating Brownian motion that solves the SDE

This convergence was established by Helland in the case of a one-point membrane, d = 0, see Corollary 8.4. in [9].

5 Proof of Theorem 3.3

The proof of Theorem 3.3 is divided into seven steps.

Step 1. First we introduce several objects related to the random walk $\mathcal{X}(k) = (R(k), l(k)), k \ge 0$.

We say that the radial part R is in the 'normal' mode at time k if R(k) > 0 and is in the 'critical' mode otherwise. Hence, for $k \ge 0$, we denote by

is a moment of k-th exit of R from \mathbb{N} , and

$$U(\iota) - U(\iota - 1) := \frac{R(T_{\text{critical}}^{-1}(\iota))}{v_{l(T_{\text{critical}}^{-1}(\iota))}} - \frac{R(T_{\text{critical}}^{-1}(\iota) - 1)}{v_{l(T_{\text{critical}}^{-1}(\iota) - 1)}} = \frac{R(\tau_{\iota})}{v_{l(\tau_{\iota})}} - \frac{R(\sigma_{\iota})}{v_{l(\sigma_{\iota})}}, \ \iota \ge 1.$$

In (5.8) we used that the label l does not change as long as R is in the normal mode.

$$= \frac{R(0)}{v_{l(0)}} + V(T_{\text{normal}}(k)) + U(T_{\text{critical}}(k)).$$
(5.12)

Since $T_{\text{normal}}^{-1}(\iota)$ and $T_{\text{critical}}^{-1}(\iota)$, $\iota \ge 1$, are stopping times w.r.t. the filtration generated by \mathcal{X} , the sequence $(V(k))_{k\ge 0}$ is a martingale. The sequences

$$\left(R(T_{\text{critical}}^{-1}(\iota)), v_{l(T_{\text{normal}}^{-1}(\iota))}\right)_{\iota \ge 0} \quad \text{and} \quad \left(R(T_{\text{critical}}^{-1}(\iota)-1), v_{l(T_{\text{critical}}^{-1}(\iota)-1)}\right)_{\iota \ge 1} \tag{5.13}$$

are the embedded entrance and exit Markov chains introduced in (3.10).

For $t \in [0,\infty)$ we define

Proof of Lemma 5.2. Since the second coordinate in of the limit in (5.18) is non-random, it is sufficient to prove the coordinate-wise convergence, see the generalization of Slutsky's theorem in Ressel [27].

Convergence $\frac{V^n(nt)}{\sqrt{n}} \Rightarrow W(t), n \to \infty$ follows from the functional central limit theorem for martingale differences, see Theorem 18.2 in Billingsley [2]. Indeed, due to Assumption \mathbf{A}_1 since $\operatorname{Var} \xi^{(j)} = v_j^2 \in (0, \infty)$, for every $t \ge 0$ and $\varepsilon > 0$ the Lindeberg condition holds true, namely

Now we prove the convergence of the second coordinate.

1. First assume that the initial condition $\mathcal{X}(0)$ does not depend on n. Let the initial condition $\mathcal{X}(0) = (R(0), l(0))$ be fixed. Recall the entrance and exit embedded Markov chains $\mathcal{X}_{\text{entrance}}$ and $\mathcal{X}_{\text{exit}}$ defined in (3.10). 2. In the situation when the distribution of the initial value $\mathcal{X}^n(0)$ depends on n, we deal with weak convergence in the scheme of series. Hence, certain modifications of the above argument have to be made.

- 4. g_0 , h_0 are continuous functions and h_0 is strictly increasing;
- 5. $g_0(0) \ge 0, h_n(0) = 0.$

Then (f_n) converges in $D([0,\infty),\mathbb{R})$ to the solution of the Skorokhod reflection problem at zero for the function g_0 , i.e.,

We emphasize that in [30], it was demanded that $E|M_n(s)|^2 \to s, n \to \infty$, for all $s \in [t_0, t]$. However the inspection of Skorokhod's argument shows that only boundedness was used in the proof.

To demonstrate iii), we recall that $X^{\infty} = \sum_{l=1}^{m} X_{l}^{\infty}$ is a reflected Brownian motion. Hence with probability 1, $X^{\infty}(s) > 0$ for any fixed s > 0. Therefore, for a.a. ω there exists $k = k(s, \omega)$ such that $X_{k}^{\infty}(s, \omega) > 0$. Let $\kappa = \kappa(s, \omega) > 0$ be such that

$$\inf_{r\in[s-\kappa,s+\kappa]} X_k^{\infty}(r) > 0.$$
(5.88)

Correspondingly, for $i \neq k$, we have

Recall that $X_j^n(\cdot) \to X_j^\infty(\cdot)$ locally uniformly for all j a.s. and in particular on the interval $[s - \kappa, s + \kappa]$. Therefore, for n large enough

Eventually we establish iv). First we note that by (5.88) and (5.89) the mapping $s \mapsto \mathbb{I}_{X^{\infty}(s)>0}$ is continuous in probability on $[t_0, t]$, and thus is uniformly continuous in probability on $[t_0, t]$, i.e., for each $\varepsilon > 0$

$$\lim_{h \to 0} \sup_{|t_2 - t_1| < h} \mathbb{P}\Big(\mathbb{I}_{X^{\infty}(t_2) > 0} \neq \mathbb{I}_{X^{\infty}(t_1) > 0}\Big) = 0.$$
(5.93)

From (5.88), (5.89), (5.90) and (5.91) we get that for any $\delta > 0$ and $s \in [t_0, t]$ there is $\kappa = \kappa(s)$ and $n_0 = n_0(s)$ such that for all $j = 1, \ldots, m$

$$\sup_{|z-s|<\kappa(s)} \mathbb{P}\Big(\mathbb{I}_{X_j^n(z-)>0} \neq \mathbb{I}_{X_j^\infty(z)>0}\Big) < \delta, \quad n \ge n_0(s).$$
(5.94)

Since $[t_0, t]$ is a compact, from its infinite covering by the sets $(s - \frac{1}{2}\kappa(s), s + \frac{1}{2}\kappa(s)), s \in [t_0, t]$, we may choose a finite subcovering $(s_p - \frac{1}{2}\kappa(s_p), s_p + \frac{1}{2}\kappa(s_p)), p = 1, \ldots, N$. Hence, for $|t_2 - t_1| < h$ with

there is $p = p(t_1, t_2)$ such that

(5.97)

Therefore,

$$\limsup_{h \to 0} \lim_{n \to \infty} \sup_{|t_2 - t_1| < h} \mathbb{P}\Big(|\mathbb{I}_{X_j^n(t_2 -) > 0} - \mathbb{I}_{X_j^n(t_1 -) > 0}| > \varepsilon \Big) \le 2\delta,$$
(5.98)

what finishes the proof of (5.87) and (5.82). The Lemma is proven.

6 Proof of Theorem 3.5

Before we start proofs let us formulate two results on convergence of compositions of functions and processes.

Lemma 6.1. Let $(f_n, \lambda_n)_{n \geq 0}$ be a sequence of càdlàg functions such that

- 1. $f_n \to f_0, n \to \infty$ in $D([0, +\infty), \mathbb{R}^m)$;
- 2. $(\lambda_n)_{n\geq 1}$ are non-negative and non-decreasing functions;
- 3. $\lambda_n \to \lambda_0, n \to \infty$, in $D([0, +\infty), \mathbb{R})$;
- 4. λ_0 is strictly increasing and continuous function.

Then

$$f_n \circ \lambda_n \to f_0 \circ \lambda_0, \ n \to \infty,$$
 (6.1)

in $D([0,+\infty),\mathbb{R}^m)$.

Proof. See Theorem 13.2.2, p. 430, in Whitt [34].

Corollary 6.2. Let $(\xi_n)_{n\geq 0}$ and $(\eta_n)_{n\geq 1}$ be sequences of stochastic càdlàg processes with values in \mathbb{R}^m and \mathbb{R} respectively. Assume that

- 1. $(\xi_n(t))_{t>0} \Rightarrow (\xi_0(t))_{t>0}, n \to \infty \text{ in } D([0, +\infty), \mathbb{R}^m);$
- 2. $(\eta_n)_{n\geq 1}$ are non-negative and non-decreasing processes;
- 3. $(\eta_n(t))_{t>0} \Rightarrow (ct)_{t>0}, n \to \infty \text{ in } D([0, +\infty), \mathbb{R}) \text{ where } c > 0 \text{ is a constant.}$

Then

$$(\xi_n(\eta_n(t))_{t\geq 0} \Rightarrow (\xi_0(ct))_{t\geq 0}, n \to \infty \text{ in } D([0, +\infty), \mathbb{R}^m).$$

$$(6.2)$$

Proof. Since the process $(ct)_{t\geq 0}$ is non-random, assumptions of the corollary are equivalent to the convergence of pairs

$$(\xi_n(t), \eta_n(t))_{t \ge 0} \Rightarrow (\xi(t), ct)_{t \ge 0}, \tag{6.3}$$

see Ressel [27].

The statement follows from Lemma 6.1 and the Skorokhod representation theorem, see for example Kallenberg [15, Theorem 3.30, p. 56]. $\hfill \Box$

Remark 6.3. Since all η_n are non-decreasing and the limit is non-random, condition 3 of Corollary 6.2 is equivalent to weak convergence (or convergence in probability) $\eta_n(t) \to ct, n \to \infty$ for any fixed $t \ge 0$.

The next lemma gives a reverse result: convergence of compositions yields convergence of functions. We formulate the result for functions and then a corollary for processes.

Lemma 6.4. [12, Lemma 3.5] Let $(f_n)_{n\geq 0} \subset D([0,\infty), \mathbb{R}^m)$ and $(\mu_n)_{n\geq 0} \subset D([0,\infty), \mathbb{R})$, μ_n be non negative and non decreasing. Assume that, for all T > 0,

$$\lim_{n \to \infty} \sup_{t \in [0, T]} |\mu_n(t) - t| = 0$$
(6.4)

and

$$\lim_{n \to \infty} f_n \circ \mu_n = f_0 \tag{6.5}$$

in the J₁-topology in $D([0,\infty), \mathbb{R}^m)$. For $n \in \mathbb{N}$, denote by $(t_k^{(n)})_k$ the points of discontinuity of μ_n and put $u_k^{(n)} := \mu_n(t_k^{(n)})$ and $v_k^{(n)} := \mu_n(t_k^{(n)})$. If, in addition to (6.4) and (6.5), for all T > 0,

$$\lim_{n \to \infty} \sup_{k} \sup_{s \in [u_k^{(n)}, v_k^{(n)}) \cap [0, T]} |f_n(s) - f_n(u_k^{(n)} -)| = 0,$$
(6.6)

then

$$\lim_{n \to \infty} f_n = f_0$$

in the J₁-topology in $D([0,\infty), \mathbb{R}^m)$.

Remark 6.5. If μ_n are continuous, $\mu_n(0) = 0$, and $\mu_n(\infty) = \infty$, then the result of the lemma follows from Lemma 6.1. Indeed, let $\lambda_n(t) = \mu_n^{-1}(t) := \inf\{s \ge 0 : \mu_n(s) \ge t\}$. Then $\mu_n \circ \lambda_n = \operatorname{id.}$ So $f_n = (f_n \circ \mu_n) \circ \lambda_n$. It can be easily seen that λ_n locally uniformly converges to t, so all conditions of Lemma 6.1 are satisfied. New features appear if μ_n may be discontinuous, so the compositions $f_n \circ \mu_n$ do not use parts of f_n paths corresponding to jumps of μ_n .

The proof of the next corollary is obtained with the help of Skorokhod's representation theorem similarly to the proof of Corollary 6.2.

Corollary 6.6. Let $(\xi_n)_{n\geq 0}$ and $(\eta_n)_{n\geq 1}$ be sequences of stochastic càdlàg processes with values in \mathbb{R}^m and \mathbb{R} respectively such that η_n , $n \geq 1$, are non negative and non decreasing. Assume that for all T > 0, we have locally uniform convergence in probability

$$\sup_{t \in [0,T]} |\eta_n(t) - t| \xrightarrow{\mathbf{P}} 0, n \to \infty, \tag{6.7}$$

and convergence in distribution

$$\xi_n \circ \eta_n \Rightarrow \xi_0, \ n \to \infty, \ in \ D([0,\infty), \mathbb{R}^m).$$
 (6.8)

For $n \in \mathbb{N}$, denote by $(t_k^{(n)})_k$ the points of discontinuity of η_n and put $u_k^{(n)} := \eta_n(t_k^{(n)})_k$ and $v_k^{(n)} := \eta_n(t_k^{(n)})_k$. If, in addition to (6.7) and (6.8), for all T > 0, we have the uniform convergence in probability

$$\sup_{k} \sup_{s \in [u_{k}^{(n)}, v_{k}^{(n)}) \cap [0, T]} |\xi_{n}(s) - \xi_{n}(u_{k}^{(n)})| \xrightarrow{P} 0, \ n \to \infty,$$
(6.9)

then

$$\xi_n \Rightarrow \xi_0, \ n \to \infty, \tag{6.10}$$

in $D([0,\infty),\mathbb{R}^m)$.

Proof of Theorem 3.5. We will prove Theorem 3.5 in "reverse" order. In Step 1, we construct a Markov chain \mathcal{X}^n on the enlarged state space $\mathbb{Z} \times \{-,+\}$ that mimics the dynamics of X^n and converges to a WBM due to Theorem 3.3. In Step 2, we transform the state space $\mathbb{Z} \times \{-,+\}$ into a $\mathbb{Z} \setminus \{-d,\ldots,d\}$ and construct an auxiliary Markov chain \hat{X}^n whose Donsker scalings converge to a SBM. In Step 3 we define a random time change that removes times that the original Markov chain X^n spends on the membrane $\{-d,\ldots,d\}$, thus obtaining the Markov chain \hat{X}^n . In the final Step 4 we show that this random time change does not affect the convergence.

Step 1. We will employ Theorem 3.3 for the convergence to the WBM and construct Markov chains $\mathcal{X}^n = (\mathbb{R}^n, l^n), n \ge 1$, on $\mathbb{Z} \times \{-, +\}$. The original Markov chain X^n on \mathbb{Z} will be obtained from \mathcal{X}^n by two transformations.

The transition probabilities of \mathcal{X}^n do not depend on n and are defined as follows. If $\mathbb{R}^n(0) = x \in \mathbb{N}$, i.e., if $\mathbb{R}^n(0)$ is on the positive side, then we set

$$P((R^{n}(1), l^{n}(1)) = (y, +) | (R^{n}(0), l^{n}(0)) = (x, +)) := P(\xi_{+} = y - x),$$

$$P((R^{n}(1), l^{n}(1)) = (y, -) | (R^{n}(0), l^{n}(0)) = (x, -)) := P(-\xi_{-} = y - x),$$
(6.11)

that is the distribution of a jump is equal to the distribution of ξ_+ if the label is + and $(-\xi_-)$ if the label is -.

Assume that $R^n(0) = x \in \mathbb{Z} \setminus \mathbb{N}$, i.e., the Markov chain \mathcal{X}^n starts on the membrane.

If $R^n(0) \leq -2d - 1$, then we set

$$R^{n}(1) := -R^{n}(0) - 2d, \quad l^{n}(1) := -l^{n}(0), \tag{6.12}$$

In other words, the random walk changes its label and and the radius gets reflected symmetrically with respect to the point -d. Notice that the new radius lies in \mathbb{N} .

Recall $\tilde{\tau}_0$ defined in (3.36). If $R^n(0) = x \in \{-2d, \ldots, 0\}$ so that $x + d \in \{-d, \ldots, d\}$, and $y \in \mathbb{N}$, then we set

$$P((R^{n}(1), l^{n}(1)) := (y, +) | (R^{n}(0), l^{n}(0)) = (x, +)) := P(X(\tilde{\tau}_{0}) = y + d | X(0) = x + d),$$

$$P((R^{n}(1), l^{n}(1)) := (y, -) | (R^{n}(0), l^{n}(0)) = (x, +)) := P(X(\tilde{\tau}_{0}) = -y - d | X(0) = x + d),$$

$$P((R^{n}(1), l^{n}(1)) := (y, -) | (R^{n}(0), l^{n}(0)) = (x, -)) := P(X(\tilde{\tau}_{0}) = -y - d | X(0) = -x - d),$$

$$P((R^{n}(1), l^{n}(1)) := (y, +) | (R^{n}(0), l^{n}(0)) = (x, -)) := P(X(\tilde{\tau}_{0}) = y + d | X(0) = -x - d).$$
(6.13)

We define the initial condition $\mathcal{X}^n(0) = (R^n(0), l^n(0))$ as follows:

$$(R^{n}(0), l^{n}(0)) = \begin{cases} (X^{n}(0) - d, +), & \text{if } X^{n}(0) \ge -d, \\ (-X^{n}(0) - d, -), & \text{if } X^{n}(0) < -d, \end{cases}$$
(6.14)

where $(X^n(k))_{k\geq 0}$ is the original perturbed random walk.

Then

$$\left(\frac{R^{n}(0)}{v_{-}\sqrt{n}}\mathbb{I}_{l^{n}(0)=-}, \frac{R^{n}(0)}{v_{+}\sqrt{n}}\mathbb{I}_{l^{n}(0)=+}\right) \Rightarrow (x_{-}, x_{+}), \ n \to \infty,$$
(6.15)

where $x_{+} = x \lor 0$, $x_{-} = (-x) \lor 0$, and x is from (3.39).

Theorem 3.3 and Corollary 2.3 imply that

$$\varphi\left(\frac{l^n(n\cdot)R^n([n\cdot])}{\sqrt{n}}\right) \Rightarrow W_{\gamma}^{\text{skew}}(\cdot, x), \quad n \to \infty,$$
(6.16)

where φ is defined in (1.7). The permeability parameter γ equals

$$\gamma = \frac{\mathrm{E}_{\pi_{\mathrm{entrance}}}(R(0) - R(\sigma))(v_{+}^{-1}\mathbb{I}_{l(0)=+} - v_{-}^{-1}\mathbb{I}_{l(0)=-})}{\mathrm{E}_{\pi_{\mathrm{entrance}}}(R(0) - R(\sigma))v_{l(0)}^{-1}}$$
(6.17)

see Theorem 3.3 and Corollary 2.3. The stopping time σ was defined in (3.8) and the stationary measure π_{entrance} was defined in Lemma 3.1.

Therefore, we also have the convergence

$$\varphi\Big(\frac{l^n([n\cdot])(R^n([n\cdot])+d)}{\sqrt{n}}\Big) \Rightarrow W_{\gamma}^{\text{skew}}(\cdot, x), \quad n \to \infty.$$
(6.18)

Step 2. Let us construct a one-dimensional Markov chain \widehat{X}^n that converges to a SBM.

Note that the mapping $(R, l) \mapsto l \cdot (R + d)$ is a bijection of the sets $\mathbb{N} \times \{+\}$ and $\{d + 1, d + 2, ...\}$ and also of the sets $\mathbb{N} \times \{-\}$ and $\{\ldots, -d-2, -d-1\}$. The following behavior of the sequence $(l^n(\cdot)(R^n(\cdot) + d))$ is decisive for out argument. Assume that for some k the sequence R^n overjumps the set $\{-2d, \ldots, 0\}$ from above:

Then by definition of transition probabilities (6.12) we have

i.e., in this case the sequence $(l^n(\cdot)(R^n(\cdot)+d))$ spends two time steps at the same point. Let us construct a new sequence $(\widehat{X}^n(k))_{k\geq 0}$ from the sequence $(l^n(k)(R^n(k)+d))_{k\geq 0}$ that skips one of these steps.

We define a random time change as follows. Set

$$\begin{aligned} \widehat{\lambda}_{n}(0) &:= 0, \\ \widehat{\lambda}_{n}(k) &:= \sum_{j=1}^{k} \left(1 - \mathbb{I}(R^{n}(k+1) > 0, \ R^{n}(k) < -2d) \right), \\ \widehat{\lambda}_{n}^{-1}(k) &:= \inf\{j \ge 0 \colon \widehat{\lambda}_{n}(j) = k\}, \\ \widehat{X}^{n}(k) &:= l^{n}(\widehat{\lambda}_{n}^{-1}(k))(R^{n}(\widehat{\lambda}_{n}^{-1}(k)) + d). \end{aligned}$$
(6.21)

Notice that \widehat{X}^n is a Markov chain with transition probabilities

$$P(\widehat{X}^{n}(1) = j \mid \widehat{X}^{n}(0) = i) = \begin{cases} P(X(1) = j \mid X(0) = i), & |i| > d, \\ P(X(\widehat{\tau}_{0}) = j \mid X(0) = i), & |i| \le d, \end{cases}$$
(6.22)

where $(X(k))_{k\geq 0}$ is the original perturbed random walk and $\hat{\tau}_0 := \inf\{k \geq 0 : |X(k)| > d\}$, see also (3.36). Let us show that the number of skipped steps is negligible as $n \to \infty$ and convergence

 $\varphi\left(\frac{\widehat{X}^n([n\cdot])}{\sqrt{n}}\right) \Rightarrow W_{\gamma}^{\text{skew}}(\cdot, x), \quad n \to \infty.$ (6.23)

holds true.

Indeed, we have the inequality

$$[nt] - \hat{\lambda}_n([nt]) \le \sqrt{nL^n(t)} \max(v_-, v_+), \quad t > 0,$$
(6.24)

where L^n is defined in (3.32). It follows from the weak convergence of $(L^n(\cdot))$ established Theorem 3.3, that for all t > 0

Therefore convergence (6.23) follows by Corollary 6.2.

Step 3. Now we consider the original Markov chain $(X^n(k))_{k\geq 0}$ and define a random time change that removes times that X^n spends in the set $\{-d, \ldots, d\}$ after entering this set. Let us introduce a sequence $\{\lambda_n(k)\}_{k\geq 0}$ as follows

The sequence λ_n is a time homogeneous additive functional of a Markov chain X^n that counts all the steps of X^n except those that start and end within the membrane. The inverse mapping

$$\lambda_n^{-1}(k) := \inf\{j \ge 0 \colon \lambda_n(j) \ge k\}, \quad k \ge 0,$$
(6.29)

is a sequence of stopping times, so that the process $k \mapsto X^n(\lambda_n^{-1}(k))$ is a time homogeneous Markov chain. Assume that $X^n(0) = i \in \mathbb{Z}$. Then

From now on, without loss of generality we assume that

$$\left(\frac{\widehat{X}^n([nt])}{\sqrt{n}}\right)_{t\geq 0} = \left(\frac{X^n(\lambda_n^{-1}([nt]))}{\sqrt{n}}\right)_{t\geq 0}.$$
(6.32)

Step 4. In order prove the weak convergence we will apply Corollary 6.6 and use the following representation:

be the number of visits of \widehat{X}^n to the membrane, i.e., to the set $\{-d, \ldots, d\}$. We define

\widehat{\tau}_{k}^{n} := \inf\{j \ge \widehat{\sigma}_{k}^{n} : |X^{n}(j)| > d\},
\widehat{\sigma}_{k+1}^{n} = \inf\{j > \widehat{\tau}_{k}^{n} : |X^{n}(j)| \le d\}, \quad k \ge 0.$$
(6.35)

Denote the time spent in the membrane by

$$\zeta_k^n := \hat{\tau}_k^n - \hat{\sigma}_k^n. \tag{6.36}$$

Due to Assumption \mathbf{B}_2 , the random variables ζ_k^n have finite moments of all orders. We note that

$$\frac{N^n([nt])}{\sqrt{n}} \le L^n(t) \max(v_-, v_+), \tag{6.39}$$

where L^n is defined in (3.32) (compare with (6.24)). Similarly to (6.25), for any $t \ge 0$ we have

$$\frac{\widehat{N}^n([nt])}{n} \xrightarrow{\mathbf{P}} 0, \quad n \to \infty.$$
(6.40)

For $|x| \leq d$, denote

$$f(x) := \mathbf{E}[\zeta_0^n | X^n(0) = x]$$
(6.41)

and note that $f(\cdot)$ does not depend on n and is bounded. We write:

$$\sum_{j=0}^{\hat{N}^{n}([nt])} \zeta_{j}^{n} = \sum_{j=0}^{\hat{N}^{n}([nt])} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) + \sum_{j=0}^{\hat{N}^{n}([nt])} f(X^{n}(\hat{\sigma}_{j}^{n})).$$
(6.42)

Therefore we get

$$\frac{1}{n} \sum_{j=0}^{\hat{N}^n([nt])} f(X^n(\hat{\sigma}_j^n)) \xrightarrow{\mathbf{P}} 0, \quad n \to \infty.$$
(6.43)

The random sequence

$$k \mapsto \sum_{j=0}^{k} \left(\zeta_j^n - f(X^n(\widehat{\sigma}_j^n)) \right)$$
(6.44)

is a martingale, so that by Doob's inequality for any $N\geq 1$

$$\mathbb{E} \max_{0 \le k \le N} \left| \sum_{j=0}^{k} \left(\zeta_{j}^{n} - f(X^{n}(\widehat{\sigma}_{j}^{n})) \right) \right|^{2} \le 4 \mathbb{E} \sum_{j=0}^{N} \left(\zeta_{j}^{n} - f(X^{n}(\widehat{\sigma}_{j}^{n})) \right)^{2} \\ \le 4(N+1) \max_{|x| \le d} \mathbb{E} \left[\left(\zeta_{0}^{n} - f(X^{n}(\widehat{\sigma}_{0}^{n})) \right)^{2} \middle| X^{n}(0) = x \right] \\ \le C(N+1),$$
(6.45)

for some C > 0. Hence for any $\delta > 0$

$$\frac{1}{n} \Big| \sum_{j=0}^{\hat{N}^{n}([nt])} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) \Big| \leq \frac{1}{n} \mathbb{I}(\hat{N}^{n}([nt]) \leq n\delta) \Big| \sum_{j=0}^{\hat{N}^{n}([nt])} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) \Big| \\
+ \frac{1}{n} \mathbb{I}(\hat{N}^{n}([nt]) > n\delta) \Big| \sum_{j=0}^{\hat{N}^{n}([nt])} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) \Big| \\
\leq \frac{1}{n} \max_{0 \leq k \leq n\delta} \Big| \sum_{j=0}^{k} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) \Big| \\
+ \frac{1}{n} \mathbb{I}\left(\frac{\hat{N}^{n}([nt])}{n} > \delta \right) \Big| \sum_{j=0}^{\hat{N}^{n}([nt])} \left(\zeta_{j}^{n} - f(X^{n}(\hat{\sigma}_{j}^{n})) \right) \Big|$$
(6.46)

The first term in the latter formula converges to zero in mean square sense due to (6.45) whereas the second term converges to zero in probability due to (6.40). Combining all the above estimates yields

$$\left|\frac{\lambda_n([nt])}{n} - t\right| \xrightarrow{\mathbf{P}} 0, \quad n \to \infty.$$
(6.47)

Due to monotonicity, for any T > 0 we have convergence:

$$\sup_{t\in[0,T]} \left| \frac{\lambda_n([nt])}{n} - t \right| \xrightarrow{\mathbf{P}} 0, \ n \to \infty,$$

$$\sup_{t\in[0,T]} \left| \frac{\lambda_n^{-1}([nt])}{n} - t \right| \xrightarrow{\mathbf{P}} 0, \ n \to \infty.$$
(6.48)

Hence, the application of Corollary 6.6 implies the desired convergence

$$\frac{X^n([n\cdot])}{\sqrt{n}} \Rightarrow W_{\gamma}^{\text{skew}}(\cdot, x), \quad n \to \infty.$$
(6.49)

Inspecting the construction steps of the Markov chains \mathcal{X}^n , \widehat{X}^n and X^n we conclude that the parameter γ defined in (6.17) coincides with γ in (3.41).

7 Proofs of Corollary 3.8 and Theorem 3.9

Proof of Corollary 3.8. Denote for brevity the inverse function

$$\psi(x) := \varphi^{-1}(x) = x(v_{+} \mathbb{I}_{x \ge 0} + v_{-} \mathbb{I}_{x < 0})$$
(7.1)

Recall the SDE (2.12) and apply the Itô-Tanaka formula with symmetric semimartingale local time to $\psi(W_{\gamma}^{\text{skew}})$, see [28, Exercise 1.25, Chapter VI]:

$$Y(t) = \psi(W_{\gamma}^{\text{skew}}(t)) := x + \int_{0}^{t} \left(v_{+} \mathbb{I}_{W_{\gamma}^{\text{skew}}(s)>0} + v_{-} \mathbb{I}_{W_{\gamma}^{\text{skew}}(s)<0} \right) dW(s) + \frac{1}{2} \gamma(v_{+} + v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t) + \frac{1}{2} (v_{+} - v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t) = x + \int_{0}^{t} \left(v_{+} \mathbb{I}_{Y(s)>0} + v_{-} \mathbb{I}_{Y(s)<0} \right) dW(s) + \frac{1}{2} \gamma(v_{+} + v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t) + \frac{1}{2} (v_{+} - v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t)$$
(7.2)

and

$$\begin{aligned} |Y(t)| &= |\psi(W_{\gamma}^{\text{skew}}(t))| := |x| + \int_{0}^{t} \left(v_{+} \mathbb{I}_{W_{\gamma}^{\text{skew}}(s) > 0} - v_{-} \mathbb{I}_{W_{\gamma}^{\text{skew}}(s) < 0} \right) dW(s) \\ &+ \frac{1}{2} \gamma(v_{+} - v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t) + \frac{1}{2} (v_{+} + v_{-}) L_{0}^{W_{\gamma}^{\text{skew}}}(t). \end{aligned}$$
(7.3)

On the other hand, the process Y is a continuous semimartingale itself. Hence, the Itô-Tanaka formula applied to the process Y yields

$$|Y(t)| = |x| + \int_0^t \left(\mathbb{I}_{Y(s)>0} - \mathbb{I}_{Y(s)<0} \right) dY(s) + L_0^Y(t) = \int_0^t \left(v_+ \mathbb{I}_{W_{\gamma}^{\text{skew}}(s)>0} - v_- \mathbb{I}_{W_{\gamma}^{\text{skew}}(s)<0} \right) dW(s) + L_0^Y(t),$$
(7.4)

where $L_0^Y(t)$ is the symmetric semimartingale local time defined by

$$L_0^Y(t) = \lim_{\varepsilon \to 0+} \frac{1}{2\varepsilon} \int_0^t \mathbb{I}_{|Y(s)| < \varepsilon} \mathrm{d}\langle Y, Y \rangle_s = \lim_{\varepsilon \to 0+} \frac{1}{2\varepsilon} \int_0^t \left(v_+^2 \mathbb{I}_{Y(s) > 0} + v_-^2 \mathbb{I}_{Y(s) < 0} \right) \mathrm{d}s.$$
(7.5)

Comparing the representations (7.3) and (7.4) we conclude that

$$L_0^Y(t) = \frac{1}{2} \Big[\gamma(v_+ - v_-) + (v_+ + v_-) \Big] L_0^{W_\gamma^{\text{skew}}}(t).$$
(7.6)

Substituting this formula into (7.2) and recalling that Y spends zero time at zero we get (3.44). \Box

Proof of Theorem 3.9. Let \mathcal{X} be a Markov chain on $\mathcal{N}^m \cup \{0\}$ from Theorem 3.9. Since the processes from Theorems 3.9 and 3.3 live on different state spaces, first we construct a Markov chain $\hat{\mathcal{X}}$ on \mathcal{Z}^m related to \mathcal{X} that satisfy assumptions of Theorem 3.3.

In assumption \mathbf{A}_1 , let the distribution of $\xi^{(i)}$ coincide with the distribution of $\xi^{(i)}_k$, i = 1, ..., m. In particular, $\hat{\mathcal{X}}$ may visit the set $\{\ldots, -1, 0\} \times \{1, \ldots, m\}$.

The jumps from the state (0, i) are defined as follows:

$$P(\hat{\mathcal{X}}(1) = (\hat{y}, j) \,|\, \hat{\mathcal{X}}(0) = (0, i)) := P(\mathcal{X}(1) = (\hat{y}, j) \,|\, \mathcal{X}(0) = 0), \quad i, j = 1, \dots, m.$$
(7.7)

For $\hat{x} < 0$ and $\hat{y} \in \mathbb{N}$ we set

$$P(\widehat{\mathcal{X}}(1) = (\widehat{y}, j) | \widehat{\mathcal{X}}(0) = (\widehat{x}, i)) := P(\mathcal{X}(1) = (\widehat{y}, j) | R(0) + \xi_1^{(i)} = \widehat{x}, l(0) = i),$$
(7.8)

where $\mathcal{X}(0) = (R(0), l(0)).$

Let the initial distributions of $\widehat{\mathcal{X}}(0)$ and $\mathcal{X}(0)$ coincide in the following sense:

$$P(\hat{\mathcal{X}}(0) = (\hat{y}, j)) := P(\mathcal{X}(0) = (\hat{y}, j)), \quad \hat{y} \in \mathbb{N}, \ j = 1, ..., m, P(\hat{\mathcal{X}}(0) = (0, 1)) := P(\mathcal{X}(0) = 0),$$
(7.9)

and $P(\hat{\mathcal{X}}(0) = (\hat{y}, j)) = 0$ in all other cases.

According to Theorem 3.3, the scaling limit of $\hat{\mathcal{X}}$ is a WBM starting at 0.

Let

$$\widehat{\lambda}(k) = \sum_{i=1}^{k} \mathbb{I}(\widehat{R}(i) \ge 0).$$
(7.10)

The random time change $\widehat{\lambda}^{-1}(\cdot)$ removes time instants when $\widehat{\mathcal{X}}$ visits the set $\{\ldots, -1, 0\} \times \{1, \ldots, m\}$. It follows from the construction of $\widehat{\mathcal{X}}$ and $\widehat{\lambda}$ that

$$\left(\widehat{R}(\widehat{\lambda}^{-1}(k))\mathbb{I}_{l(\widehat{\lambda}^{-1}(k))=i}, \ i=1,\dots,m\right)_{k\geq 0} \stackrel{\mathrm{d}}{=} \left(R(k)\mathbb{I}_{l(k)=i}, \ i=1,\dots,m\right)_{k\geq 0}.$$
(7.11)

Following the argument of Step 2 in the proof of Theorem 3.5 we see that scaling limit of the original Markov chain \mathcal{X} is the same WBM as for the scaling limit of $\hat{\mathcal{X}}$.
