# More on *r*-cross *t*-intersecting families for vector spaces

#### Abstract

Let V be a finite dimensional vector space over a finite field. Suppose that  $\mathscr{F}_1$ ,  $\mathscr{F}_2, \ldots, \mathscr{F}_r$  are r-cross t-intersecting families of k-subspaces of V. In this paper, we determine the extremal structure when  $\prod_{i=1}^r |\mathscr{F}_i|$  is maximum under the condition that  $\dim(\bigcap_{F \in \mathscr{F}_i} F) < t$  for each *i*.

Key words  $r$ -cross  $t$ -intersecting families; vector spaces; Hilton-Milner theorem.

# 1 Introduction

Intersection problems originate from the famous Erdős-Ko-Rado theorem [\[9\]](#page-12-0). For decades, these problems have attracted widespread attention. We refer readers to [\[1,](#page-12-1) [2,](#page-12-2) [4,](#page-12-3) [8,](#page-12-4) [11,](#page-12-5) [12,](#page-12-6) [13,](#page-13-0) [16,](#page-13-1) [19,](#page-13-2) [20,](#page-13-3) [21\]](#page-13-4) for rich results of sets. Intersection problems are also studied on some other mathematical objects, for example, vector spaces.

Let V be an *n*-dimensional vector space over the finite field  $\mathbb{F}_q$ . Denote the family of all k-subspaces of V by  $\begin{bmatrix} V \\ k \end{bmatrix}$  $\binom{V}{k}$ . A family  $\mathscr{F} \subseteq \binom{V}{k}$  $\binom{V}{k}$  is called *t*-intersecting if dim( $F_1$  ∩  $F_2$ ) ≥ t for any  $F_1, F_2 \in \mathscr{F}$ . The Erdős-Ko-Rado Theorem for vector spaces [\[10,](#page-12-7) [14,](#page-13-5) [15\]](#page-13-6) shows that each member of a maximum-sized *t*-intersecting subfamily of  $\begin{bmatrix} V_k \\ V_l \end{bmatrix}$  $\binom{V}{k}$  contains a fixed *t*-subspace of V when  $n > 2k$ . In [\[3,](#page-12-8) [6,](#page-12-9) [17,](#page-13-7) [18\]](#page-13-8), the Hilton-Milner theorem for vector spaces was proved, providing the structure of the second largest maximal *t*-intersecting subfamilies of  $\begin{bmatrix} V_k \\ k \end{bmatrix}$  $\left[k\right]$ .

Let  $r \geqslant 2$ . Suppose that  $\mathscr{F}_1, \mathscr{F}_2, \ldots, \mathscr{F}_r$  are subfamilies of  $\begin{bmatrix} V_k \\ k \end{bmatrix}$  ${k \choose k}$  with  $\dim(\bigcap_{i=1}^r F_i) \geq t$ for any  $F_i \in \mathscr{F}_i$ ,  $1 \leq i \leq r$ . We say they are *r*-cross *t*-intersecting families. Observe that r-cross t-intersecting families generalize t-intersecting families. Indeed, if  $r = 2$  and  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{F}$ , then  $\mathscr{F}$  is t-intersecting. A natural problem is maximizing  $\sum_{i=1}^r |\mathscr{F}_i|$ . Wang and Zhang [\[19\]](#page-13-2) completely determined the extremal structure when  $r = 2$ . Another natural

problem focuses on  $\prod_{i=1}^{r} |\mathscr{F}_i|$ . An Erdős-Ko-Rado type theorem [\[7\]](#page-12-10) states that, for large n,  $\prod_{i=1}^r |\mathscr{F}_i|$  is maximum implies that  $\dim(\bigcap_{i=1}^r \bigcap_{F \in \mathscr{F}_i} F) = t$ . In [\[7\]](#page-12-10), assuming  $r = 2$  and  $\dim(\bigcap_{i=1}^2 \bigcap_{F \in \mathscr{F}_i} F) < t$ , the authors also described  $\mathscr{F}_1$  and  $\mathscr{F}_2$  when  $|\mathscr{F}_1| |\mathscr{F}_2|$  takes the maximum value.

For  $T \in \begin{bmatrix} V_t \\ V_t \end{bmatrix}$  $\mathcal{U}_t^V$ ,  $L, M \in \begin{bmatrix} V \\ k+1 \end{bmatrix}$  and  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$  with  $T \subseteq L \cap M$  and  $\dim(L \cap M) \geq t+2$ , write

$$
\mathcal{H}_1(T, L, M) = \left\{ F \in \begin{bmatrix} V \\ k \end{bmatrix} : T \subseteq F, \dim(F \cap L) \geq t + 1 \right\} \cup \left\{ F \in \begin{bmatrix} M \\ k \end{bmatrix} : T \nsubseteq F \right\},\
$$

$$
\mathcal{H}_2(Z) = \left\{ F \in \begin{bmatrix} V \\ k \end{bmatrix} : \dim(F \cap Z) \geq t + 1 \right\}.
$$

Observe that if  $\mathscr{F}_1 = \mathscr{H}_1(T, L, M)$  and  $\mathscr{F}_2 = \mathscr{H}_1(T, M, L)$ , or  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{H}_2(Z)$ , then  $\mathscr{F}_1$ and  $\mathscr{F}_2$  are 2-cross t-initersecting families with  $\dim(\bigcap_{F \in \mathscr{F}_i} F) < t$ ,  $i = 1, 2$ .

<span id="page-1-1"></span>In this paper, we characterize the structure of  $\mathscr{F}_1$ ,  $\mathscr{F}_2$ , ...,  $\mathscr{F}_r$  when  $\prod_{i=1}^r |\mathscr{F}_i|$  is maximum under the condition that  $\dim(\bigcap_{F \in \mathscr{F}_i} F) < t$  for each *i*.

**Theorem 1.1.** Let n, k and t be positive integers with  $k \geq t+1$  and  $n \geq 2k+2t+5$ . Assume that  $\mathscr{F}_1, \mathscr{F}_2 \subseteq {V \brack k}$  $\mathcal{E}_{k}^{V}$  are 2-cross t-intersecting families with  $\dim(\bigcap_{F\in\mathscr{F}_i}F)< t$  for each i. If  $|\mathscr{F}_1||\mathscr{F}_2|$  takes the maximum value, then one of the following holds.

- (i)  $\mathscr{F}_1 = \mathscr{H}_1(T, L, M)$  and  $\mathscr{F}_2 = \mathscr{H}_1(T, M, L)$  for some  $T \in \begin{bmatrix} V_t \\ t \end{bmatrix}$  $\begin{bmatrix} V_t \\ t \end{bmatrix}$  and  $L, M \in \begin{bmatrix} V \\ k+1 \end{bmatrix}$  with  $T \subseteq L \cap M$  and  $\dim(L \cap M) \geq t+2$ .
- (ii)  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{H}_2(Z)$  for some  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$ .

<span id="page-1-2"></span>Morover, if  $k > 2t + 1$ , then (i) holds; if  $k \leq 2t + 1$ , then (ii) holds, or  $(k, t) = (3, 1)$  and (i) holds.

**Theorem 1.2.** Let n, r, k and t be positive integers with  $k - t + 1 \ge r \ge 3$  and  $n \ge$  $2k + 2t + 2r + 1$ . Assume that  $\mathscr{F}_1, \mathscr{F}_2, \ldots, \mathscr{F}_r \subseteq \begin{bmatrix} V_k \\ k \end{bmatrix}$  $\begin{bmatrix} V_k \end{bmatrix}$  are r-cross t-intersecting families with  $\dim(\bigcap_{F \in \mathscr{F}_i} F) < t$  for each i, and  $\prod_{i=1}^r |\mathscr{F}_i|$  takes the maximum value.

- (i) If  $k > 2t + 2r 3$ , then  $\mathscr{F}_i = \mathscr{H}_1(T, M, M)$   $(i = 1, 2, \ldots, r)$  for some  $T \in \begin{bmatrix} V \\ t+r \end{bmatrix}$  $\begin{bmatrix} V \\ t+r-2 \end{bmatrix}$  and  $M \in \begin{bmatrix} V \\ k+1 \end{bmatrix}$  with  $T \subseteq M$ .
- (ii) If  $k \leq 2t + 2r 3$ , then  $\mathscr{F}_i = \mathscr{H}_2(Z)$   $(i = 1, 2, \ldots, r)$  for some  $Z \in \begin{bmatrix} V \\ t+1 \end{bmatrix}$  $\begin{bmatrix} V \\ t+r \end{bmatrix}$ .

The first theorem can be seen as a product version of the Hilton-Milner theorem for vector spaces. The second implies the structure of maximum-sized non-trivial r-wise t-intersecting families in [\[7\]](#page-12-10).

#### 2 Inequalities concerning 2-cross t-intersecting families

In this section, we show some inequalities concerning 2-cross t-intersecting families in preparation for the proof of our main results. The Gaussian binomial coefficient is defined by

$$

<span id="page-1-0"></span>We begin with a lemma about it, which can be easily checked.

**Lemma 2.1.** Let m and i be positive integers with  $i < m$ . Then

$$
q^{m-i}<\frac{q^m-1}{q^i-1}
$$

Let T be a subspace of V and  $\mathscr{F} \subseteq \begin{bmatrix} V_k \\ V_k \end{bmatrix}$  $\mathscr{F}_k$ . From now on, write  $\mathscr{F}_T = \{ F \in \mathscr{F} : T \subseteq F \},$ and "cross t-intersecting" instead of "2-cross t-intersecting". If  $k \geq t$  and  $\dim(T \cap F) \geq t$ for each  $F \in \mathscr{F}$ , then T is called a t-cover of  $\mathscr{F}$ . Define the t-covering number  $\tau_t(\mathscr{F})$  of  $\mathscr{F}$ as the minimum dimension of a *t*-cover of  $\mathscr{F}$ . Observe that  $\dim(\bigcap_{F \in \mathscr{F}} F) < t$  if and only if  $t+1 \leqslant \tau_t(\mathscr{F}) \leqslant n.$ 

<span id="page-2-2"></span>**Lemma 2.2.** Let n, k and t be positive integers with  $k \geq t+1$  and  $n \geq 2k+2t+5$ . Suppose that  $\mathscr{F}_1, \mathscr{F}_2 \subseteq {V \brack k}$  $\mathcal{E}_k^V$  are cross t-intersecting families with  $\tau_t(\mathscr{F}_1) = \tau_t(\mathscr{F}_2) = t + 1$ , and B is the set of all members of  $\mathscr{F}_2$  not containing any  $(t+1)$ -dimensional t-cover of  $\mathscr{F}_1$ . Then

$$
|\mathcal{B}| \leqslant q^{k-3t-1} \binom{n-t-1}{k-t-1}.
$$

*Proof.* We may assume that  $\mathscr{B} \neq \emptyset$ , and  $S \in \begin{bmatrix} V \\ t+1 \end{bmatrix}$  is a *t*-cover of  $\mathscr{F}_2$ . Observe that

$$
\mathcal{B} \subseteq \bigcup_{U \in \begin{bmatrix} S \\ t \end{bmatrix}} \mathcal{B}_U. \tag{2.1}
$$

Let  $U \in \begin{bmatrix} S \\ t \end{bmatrix}$  $t_1^S$  with  $\mathscr{B}_U \neq \emptyset$ . Since  $\tau_t(\mathscr{F}_1) = t+1$ , there exists  $F_1 \in \mathscr{F}_1$  with  $\dim(U \cap F_1) \leq t-1$ . Write  $\alpha = \dim(U \cap F_1)$  and  $H = U + F_1$ . For each  $G \in \mathcal{B}_U$ , by  $\dim(G \cap F_1) \geq t$ , we have  $dim(H \cap G) \geq 2t - \alpha \geq t + 1$ . Hence

$$
\mathcal{B}_U \subseteq \bigcup_{R \in \begin{bmatrix} H \\ t+1 \end{bmatrix}, \ U \subseteq R} \mathcal{B}_R. \tag{2.2}
$$

Let  $R \in \begin{bmatrix} H \\ t+1 \end{bmatrix}$  with  $U \subseteq R$  and  $\mathscr{B}_R \neq \emptyset$ . By the definition of  $\mathscr{B}, R$  is not a t-cover of  $\mathscr{F}_1$ . Then there exists  $F_2 \in \mathscr{F}_1$  with  $\dim(R \cap F_2) \leq t-1$ . Note that  $F_2$  is a t-cover of  $\mathscr{B}_R$ . By [\[7,](#page-12-10) Lemma 2.4], there exists a  $(2t + 1 - \dim(R \cap F_2))$ -subspace R' of V such that

$$
|\mathscr{B}_R| \leqslant \begin{bmatrix} k - \dim(R \cap F_2) \\ t - \dim(R \cap F_2) \end{bmatrix} |\mathscr{F}_{R'}| \leqslant \begin{bmatrix} k - t + 1 \\ 1 \end{bmatrix}^{t - \dim(R \cap F_2)} \begin{bmatrix} n - 2t - 1 + \dim(R \cap F_2) \\ k - 2t - 1 + \dim(R \cap F_2) \end{bmatrix}.
$$

For integer  $a \leq k - 1$ , since  $n \geq 2k - t + 1$ , we have

$$
\frac{\genfrac{[}{]}{0pt}{}{n-a}{k-a}}{\genfrac{[}{]}{0pt}{}{n-a-1}{k-a-1}}=\frac{q^{n-a}-1}{q^{k-a}-1}\geqslant q^{n-k}\geqslant q^{k-t+1}\geqslant \genfrac{[}{]}{0pt}{}{k-t+1}{1}.
$$

Note that  $t - \dim(R \cap F_2) \geq 1$ . We derive

$$
|\mathscr{B}_R| \leqslant \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} \begin{bmatrix} n-t-2 \\ k-t-2 \end{bmatrix}.
$$

Then by  $(2.1)$  and  $(2.2)$ , we obtain

$$
|\mathcal{B}| \leqslant \begin{bmatrix} t+1 \\ 1 \end{bmatrix} \begin{bmatrix} k-\alpha \\ 1 \end{bmatrix} \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} \begin{bmatrix} n-t-2 \\ k-t-2 \end{bmatrix}.
$$
 (2.3)

Let S' be a t-cover of  $\mathscr{F}_1$  with dimension  $t + 1$ . We have  $\dim(S \cap S') \geq t$  by [\[7,](#page-12-10) Lemma 2.7]. Then  $\dim(U \cap S') \geq t - 1$ . Hence

$$
t \leq \dim(S' \cap F_1) \leq \dim((S' \cap U) \cap F_1) + \dim S' - \dim(S' \cap U) \leq \alpha + 2,
$$

which implies that  $\alpha \geq t - 2$ . Then by  $n \geq 2k + 2t + 5$ , [\(2.3\)](#page-3-0) and Lemma [2.1,](#page-1-0) we have

$$
\frac{|\mathscr{B}|}{\binom{n-t-1}{k-t-1}}\leqslant \frac{q^{k-t-1}-1}{q^{n-t-1}-1}\binom{t+1}{1}\binom{k-t+1}{1}\binom{k-t+2}{1}\leqslant q^{k-3t-1},
$$

as desired.  $\Box$ 

For  $T \in \begin{bmatrix} V \\ V \end{bmatrix}$  $\mathcal{U}_t^V$ ,  $L, M \in \begin{bmatrix} V \\ k+1 \end{bmatrix}$  and  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$  with  $T \subseteq M \cap L$  and  $\dim(M \cap L) \geqslant t+2$ , note that  $|\mathcal{H}_1(T, L, M)|$  and  $|\mathcal{H}_2(Z)|$  are independent of the choice of M, L, T and Z. Write

$$
h_1(n,k,t) = |\mathcal{H}_1(T,L,M)|, \quad h_2(n,k,t) = |\mathcal{H}_2(Z)|.
$$

<span id="page-3-2"></span>**Lemma 2.3.** Let n, k and t be positive integers with  $k \geq t+2$  and  $n \geq 2k+2t+5$ . Then

$$
h_1(n,k,t) > \frac{383}{384} {k-t+1 \brack 1} {n-t-1 \brack k-t-1}, \quad h_2(n,k,t) > \frac{1023}{1024} {t+2 \brack 1} {n-t-1 \brack k-t-1}.
$$

*Proof.* By [\[17,](#page-13-7) Lemma 2.4] and  $h_2(n, k, t) = \binom{t+2}{1}$  $\begin{bmatrix} 1 \\ 1 \end{bmatrix} \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}$  $_{k-t-1}^{n-t-1}$ ] –  $q_{1}^{t+1}$  $\binom{+1}{1}\binom{n-t-2}{k-t-2}$  $_{k-t-2}^{n-t-2}$ , we have

$$
\frac{h_1(n,k,t)}{\binom{k-t+1}{1}\binom{n-t-1}{k-t-1}} > 1 - \frac{1}{q^{n-2k+t-1}(q^2-1)} \geq 1 - \frac{1}{q^{3t+4}(q^2-1)} \geq \frac{383}{384},
$$
  

$$
\frac{h_2(n,k,t)}{\binom{t+2}{1}\binom{n-t-1}{k-t-1}} > 1 - \frac{q^{k-t-1}-1}{q^{n-t-1}-1} \geq 1 - \frac{1}{q^{n-k}} \geq 1 - \frac{1}{q^{3t+7}} \geq \frac{1023}{1024},
$$

as desired.  $\Box$ 

<span id="page-3-3"></span>**Lemma 2.4.** Let n, k and t be positive integers with  $k \geq t+2$  and  $n \geq 2k+2t+5$ . Suppose  $\mathscr{F}_1, \mathscr{F}_2 \subseteq \begin{bmatrix} V_k \\ k \end{bmatrix}$  $\mathcal{E}_k^V$  are cross t-intersecting families with  $\tau_t(\mathscr{F}_1) \geqslant \tau_t(\mathscr{F}_2) \geqslant t+1$  and  $(\tau_t(\mathscr{F}_1), \tau_t(\mathscr{F}_2)) \neq (t + 1, t + 1)$ . Then  $|\mathscr{F}_1| |\mathscr{F}_2| < (h_1(n, k, t))^2$ .

Proof. We first show

$$
|\mathcal{F}_1||\mathcal{F}_2| \leq \begin{bmatrix} t+1 \\ 1 \end{bmatrix} \begin{bmatrix} t+2 \\ 2 \end{bmatrix} \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix}^3 \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix} \begin{bmatrix} n-t-2 \\ k-t-2 \end{bmatrix}.
$$
 (2.4)

If  $\tau_t(\mathscr{F}_2) = t + 1$ , then  $\tau_t(\mathscr{F}_1) \geq t + 2$ . By [\[7,](#page-12-10) Lemma 2.5], we have

$$
\frac{|\mathscr{F}_1| |\mathscr{F}_2|}{\binom{t+1}{1}\binom{k-t+1}{1}\binom{n-t-1}{k-t-1}} \leqslant \binom{\tau_t(\mathscr{F}_1)}{t} \binom{k}{1}^{\tau_t(\mathscr{F}_1)-t-2} \binom{k-t+1}{1}^2 \binom{n-\tau_t(\mathscr{F}_1)}{k-\tau_t(\mathscr{F}_1)}.
$$



This together with [\[7,](#page-12-10) Lemma 2.3 (ii)] produces [\(2.4\)](#page-3-1). If  $\tau_t(\mathscr{F}_2) \geq t+2$ , then  $\tau_t(\mathscr{F}_1) \geq t+2$ . We get

$$
|\mathcal{F}_1| |\mathcal{F}_2| \leq \prod_{i=1}^2 \begin{bmatrix} \tau_t(\mathcal{F}_i) \\ t \end{bmatrix} {k \brack 1}^{\tau_t(\mathcal{F}_i) - t - 2} {k - t + 1 \brack 1}^2 {n - \tau_t(\mathcal{F}_i) \brack k - \tau_t(\mathcal{F}_i)}
$$

from [\[7,](#page-12-10) Lemma 2.5]. This together with [7, Lemma 2.3 (ii)] also produces  $(2.4)$ .

By  $n \ge 2k + 2t + 5$ ,  $(2.4)$  and Lemma [2.1,](#page-1-0) we have

$$
\frac{|\mathscr{F}_1||\mathscr{F}_2|}{\binom{k-t+1}{1}^2\binom{n-t-1}{k-t-1}^2} \leqslant \frac{q^{k-t-1}-1}{q^{n-t-1}-1}\binom{t+1}{1}\binom{t+2}{2}\binom{k-t+1}{1}\leqslant q^{2k+2t+4-n} < \frac{383^2}{384^2}.
$$

This together with Lemma [2.3](#page-3-2) yields the desired result.  $\Box$ 

### 3 Proof of main results

In this section, we first show Theorem [1.1,](#page-1-1) and then based on this result prove Theorem [1.2.](#page-1-2)

#### 3.1 Proof of Theorem [1.1](#page-1-1)

We may suppose that  $\mathscr{F}_1, \mathscr{F}_2$  are non-empty cross t-intersecting families of k-subspaces of V with  $\tau_t(\mathscr{F}_i) \geq t+1$  for each i, and  $|\mathscr{F}_1||\mathscr{F}_2|$  takes the maximum value. Observe that

$$
|\mathcal{F}_1||\mathcal{F}_2| \ge \max_{i \in \{1,2\}} (h_i(n,k,t))^2. \tag{3.1}
$$

We claim that  $\tau_t(\mathscr{F}_1) = \tau_t(\mathscr{F}_2) = t + 1$ . Indeed, if  $(\tau_t(\mathscr{F}_1), \tau_t(\mathscr{F}_2)) \neq (t + 1, t + 1)$ , then  $k \geq t + 2$ . By Lemma [2.4,](#page-3-3) we have  $|\mathscr{F}_1| |\mathscr{F}_2| < (h_1(n,k,t))^2$ . This contradicts [\(3.1\)](#page-4-0).

Denote the set of all *t*-covers of  $\mathscr{F}_i$  with dimension  $t + 1$  by  $\mathscr{T}_i$  for each *i*. Write

$$
\mathcal{A}_1 = \{ F \in \mathcal{F}_1 : \exists S \in \mathcal{F}_2, S \subseteq F \}, \quad \mathcal{B}_1 = \{ F \in \mathcal{F}_1 : \forall S \in \mathcal{F}_2, S \nsubseteq F \}.
$$
  

$$
\mathcal{A}_2 = \{ F \in \mathcal{F}_2 : \exists S \in \mathcal{F}_1, S \subseteq F \}, \quad \mathcal{B}_2 = \{ F \in \mathcal{F}_2 : \forall S \in \mathcal{F}_1, S \nsubseteq F \}.
$$
  
(3.2)

Observe that  $\mathscr{F}_1 = \mathscr{A}_1 \cup \mathscr{B}_1$  and  $\mathscr{F}_2 = \mathscr{A}_2 \cup \mathscr{B}_2$ . On the other hand, by [\[7,](#page-12-10) Lemma 2.7],  $\mathscr{T}_1$ and  $\mathcal{T}_2$  are cross t-intersecting, implying that  $t \leq \tau_t(\mathcal{T}_i) \leq t+1$  for each i. In the following, we investigate  $\mathscr{F}_1$  and  $\mathscr{F}_2$  in two cases.

Case 1.  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) \neq (t + 1, t + 1).$ 

If  $k = t + 1$ , then by the maximality of  $\mathscr{F}_1$  and  $\mathscr{F}_2$ , we have  $\mathscr{T}_2 \subseteq \mathscr{F}_1 \subseteq \mathscr{T}_2$  and  $\mathscr{T}_1 \subseteq \mathscr{F}_2 \subseteq \mathscr{T}_1$ , implying that  $\mathscr{F}_1 = \mathscr{T}_2$  and  $\mathscr{F}_2 = \mathscr{T}_1$ . So  $\tau_t(\mathscr{T}_1) = \tau_t(\mathscr{T}_2) = t + 1$ . This contradicts the assumption that  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) \neq (t + 1, t + 1)$ . Consequently  $k \geq t + 2$ .

For  $i \in \{1,2\}$  and  $A \in \begin{bmatrix} V_t \\ V_t \end{bmatrix}$  $\mathcal{H}_t^V$  with  $(\mathscr{T}_i)_A \neq \emptyset$ , let E be the space spanned by the union of all memebers of  $(\mathcal{T}_i)_A$ . For  $S_0 \in (\mathcal{T}_i)_A$  and  $F_0 \in \mathcal{F}_i \setminus (\mathcal{F}_i)_A$ , we have  $\dim(S_0 \cap F_0) = t$  and  $\dim(A \cap F_0) = t - 1$ . Then  $k + 1 = \dim(A + F_0) \leq \dim(S_0 + F_0) = k + 1$ . We further get

$$
A + F_0 = S_0 + F_0 = E + F_0, \quad \dim(A + F_0) = k + 1. \tag{3.3}
$$

Therefore

$$
t+1 \leqslant \dim E \leqslant k+1, \quad |(\mathcal{T}_i)_A| \leqslant \begin{bmatrix} \dim E - t \\ 1 \end{bmatrix} \leqslant \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix}.
$$
 (3.4)

Case 1.1.  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) = (t, t).$ 

Let M and L be the spaces spanned by the union of all members of  $\mathcal{T}_1$  and  $\mathcal{T}_2$ , respectively, and  $m = \dim M$ ,  $\ell = \dim L$ . By [\(3.4\)](#page-5-0), we have  $m, \ell \in \{t + 1, t + 2, ..., k + 1\}$ .

Suppose  $(m, \ell) \neq (k + 1, k + 1)$ . We may assume  $m \leq k + 1$  and  $\ell \leq k$ . Since  $\tau_t(\mathscr{T}_2) = t$ , by [\(3.4\)](#page-5-0), we obtain  $|\mathscr{T}_2| \leqslant {\lceil} \frac{\ell - t}{1}$  $\begin{bmatrix} -t \\ 1 \end{bmatrix}$   $\leqslant \begin{bmatrix} k-t \\ 1 \end{bmatrix}$  $\begin{bmatrix} -t \\ 1 \end{bmatrix}$ . Then

$$
|\mathscr{A}_1| \leqslant \begin{bmatrix} k-t \\ 1 \end{bmatrix} \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}.
$$

This together with [\(3.2\)](#page-4-1) and Lemma [2.2](#page-2-2) produces

$$
|\mathscr{F}_1| \leqslant \left( \begin{bmatrix} k-t \\ 1 \end{bmatrix} + q^{k-3t-1} \right) {n-t-1 \brack k-t-1}.
$$

Similarly, we derive

$$
|\mathscr{F}_2| \leqslant \left( \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} + q^{k-3t-1} \right) {n-t-1 \brack k-t-1}.
$$

Then by Lemma [2.1,](#page-1-0) we have

$$
\frac{|\mathscr{F}_1| |\mathscr{F}_2|}{\binom{k-t+1}{1}^2 \binom{n-t-1}{k-t-1}^2} \leqslant \frac{q^{k-t}-1+q^{k-3t-1}(q-1)}{q^{k-t+1}-1} \cdot \left(1+\frac{q^{k-3t-1}(q-1)}{q^{k-t+1}-1}\right) \leqslant \left(\frac{1}{q}+\frac{1}{q^{2t+1}}\right)\left(1+\frac{1}{q^{2t+1}}\right) \leqslant \frac{5}{8} \cdot \frac{9}{8} < \frac{383^2}{384^2}.
$$

This together with Lemma [2.3](#page-3-2) produces  $|\mathscr{F}_1||\mathscr{F}_2| < (h_1(n,k,t))^2$ , which contradicts [\(3.1\)](#page-4-0). Therefore  $m = \ell = k + 1$ .

Suppose that t-subspaces  $T_1$  and  $T_2$  are t-covers of  $\mathcal{T}_1$  and  $\mathcal{T}_2$ , respectively. Assume  $T_1 \neq T_2$ . Observe that  $|\mathscr{T}_1| \geq 2$ . Then  $T_2 \not\subseteq S_1$  for some  $S_1 \in \mathscr{T}_1$ . Note that  $\mathscr{T}_1$  and  $\mathscr{T}_2$ are cross t-intersecting. It is routine to check that  $\dim(T_2 \cap S_1) = t - 1$ . For  $S_2 \in \mathcal{F}_2$ , since  $\dim(S_2 \cap S_1) \geq t$ , we have  $S_2 \subseteq T_2 + S_1$ . Then  $k + 1 = \ell \leq \dim(T_2 + S_1) = t + 2$ , which contradicts the fact that  $k \geqslant t+2$ . Thus  $T_1 = T_2 \in \begin{bmatrix} L \cap M \\ t \end{bmatrix}$  $_{t}^{\scriptscriptstyle \left[ M\right] }$ .

Let  $F_1 \in \mathscr{F}_1 \setminus (\mathscr{F}_1)_{T_1}$  and  $F_2 \in \mathscr{F}_2 \setminus (\mathscr{F}_2)_{T_1}$ . We have  $\dim(F_1 \cap M) = \dim(F_2 \cap L) = k$ by  $(3.3)$ . Therefore

$$
\mathscr{F}_1 \setminus (\mathscr{F}_1)_{T_1} \subseteq \left\{ F \in \begin{bmatrix} M \\ k \end{bmatrix} : T_1 \not\subseteq F \right\}, \quad \mathscr{F}_2 \setminus (\mathscr{F}_2)_{T_1} \subseteq \left\{ F \in \begin{bmatrix} L \\ k \end{bmatrix} : T_1 \not\subseteq F \right\}.
$$

For  $F_3 \in (\mathscr{F}_1)_{T_1}$ , by  $\dim(F_2 \cap F_3) \geq t$  and  $T_1 \nsubseteq F_2 \subseteq L$ , we have  $\dim(F_3 \cap L) \geq t+1$ . So

$$
(\mathscr{F}_1)_{T_1} \subseteq \left\{ F \in \begin{bmatrix} V \\ k \end{bmatrix} : T_1 \subseteq F, \ \dim(F \cap L) \geq t+1 \right\}.
$$

Similarly, we derive that

$$
(\mathscr{F}_2)_{T_1} \subseteq \left\{ F \in \begin{bmatrix} V \\ k \end{bmatrix} : T_1 \subseteq F, \ \dim(F \cap M) \geq t+1 \right\}.
$$

Suppose that  $\dim(L \cap M) \leq t+1$ . Then  $\{F \in \binom{M}{k}\}$  $\binom{M}{k}$  :  $T_1 \nsubseteq F$  and  $\{F \in \binom{L}{k}$  $\left[\begin{smallmatrix}L\k\end{smallmatrix}\right]$  :  $T_1 \not\subseteq F$ } are not cross t-intersecting. Consequently for some  $i \in \{1, 2\},\$ 

$$
|\mathscr{F}_i \setminus (\mathscr{F}_i)_{T_1}| < \left| \left\{ F \in \binom{M}{k} : T_1 \not\subseteq F \right\} \right|.
$$

Then  $|\mathscr{F}_1||\mathscr{F}_2| < (h_1(n,k,t))^2$ , which contradicts  $(3.1)$ . So  $\dim(L \cap M) \geq t+2$ .

Notice that  $\mathscr{H}_1(T_1, L, M), \mathscr{H}_1(T_1, M, L)$  are cross t-intersecting and  $\mathscr{F}_1 \subseteq \mathscr{H}_1(T_1, L, M),$  $\mathscr{F}_2 \subseteq \mathscr{H}_1(T_1,M,L)$ . By the maximality of  $\mathscr{F}_1$  and  $\mathscr{F}_2$ , we have  $\mathscr{F}_1 = \mathscr{H}_1(T_1,L,M)$  and  $\mathscr{F}_2 = \mathscr{H}_1(T_1, M, L).$ 

**Case 1.2.**  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) \neq (t, t).$ 

W.l.o.g., assume that  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) = (t+1, t)$ . Suppose  $\mathcal{T}_2 = \{S\}$ . Since  $\mathcal{T}_1$  and  $\mathcal{T}_2$  are cross t-intersecting, we have  $\mathscr{T}_1 = \bigcup_{T \in \binom{S}{t}} (\mathscr{T}_1)_T$ . For each  $T \in \binom{S}{t}$  $\binom{S}{t}$ , we have  $|(\mathcal{T}_1)_T| \leqslant \binom{k-t+1}{1}$  $\begin{bmatrix} t+1 \\ 1 \end{bmatrix}$ by [\(3.4\)](#page-5-0). Then  $|\mathscr{T}_1| \leqslant \begin{bmatrix} t+1 \\ 1 \end{bmatrix}$  $\begin{bmatrix} 1 \\ 1 \end{bmatrix} \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix}$  $\begin{bmatrix} t+1 \\ 1 \end{bmatrix}$ . We further get

$$
|\mathscr{A}_2| \leqslant \begin{bmatrix} t+1 \\ 1 \end{bmatrix} \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}.
$$

This together with [\(3.2\)](#page-4-1) and Lemma [2.2](#page-2-2) yields

$$
|\mathscr{F}_2| \leqslant \left( \begin{bmatrix} t+1 \\ 1 \end{bmatrix} \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} + q^{k-3t-1} \right) \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}.
$$

Since  $|\mathscr{T}_2|=1$ , we have  $|\mathscr{A}_1| \leqslant {n-t-1 \choose k-t-1}$  $_{k-t-1}^{n-t-1}$ . This together with [\(3.2\)](#page-4-1) and Lemma [2.2](#page-2-2) produces

$$
|\mathscr{F}_1| \leqslant \left(1 + q^{k-3t-1}\right) \binom{n-t-1}{k-t-1}.
$$

Then by Lemma [2.1,](#page-1-0) we have

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{k-t+1}{1}^2 \binom{n-t-1}{k-t-1}^2} \leq \left(1+q^{k-3t-1}\right) \left(\frac{q^{t+1}-1}{q^{k-t+1}-1}+\frac{q^{k-3t-1}(q-1)^2}{(q^{k-t+1}-1)^2}\right)
$$

$$
< \left(1+q^{k-3t-1}\right) \left(\frac{1}{q^{k-2t}}+\frac{1}{q^{k+t+1}}\right)
$$

$$
= \frac{1}{q^{k-2t}}+\frac{1}{q^{t+1}}+\frac{1}{q^{k+t+1}}+\frac{1}{q^{4t+2}} \leq \frac{51}{64} < \frac{383^2}{384^2}
$$
(3.5)

for  $k \geq 2t + 1$ , and

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{t+2}{1}\binom{n-t-1}{k-t-1}^2} \leq \left(1 + \frac{1}{q^{t+1}}\right) \left(\frac{(q^{t+1}-1)^2}{(q^{t+2}-1)^2} + \frac{(q-1)^2}{q^{t+1}(q^{t+2}-1)^2}\right)
$$
\n
$$
\leq \left(1 + \frac{1}{q^{t+1}}\right) \left(\frac{1}{q^2} + \frac{1}{q^{3t+3}}\right) \leq \frac{85}{256} < \frac{1023^2}{1024^2}
$$
\n(3.6)

for  $k \le 2t$ . By [\(3.5\)](#page-6-0), [\(3.6\)](#page-6-1) and Lemma [2.3,](#page-3-2) we get  $|\mathscr{F}_1||\mathscr{F}_2| < \max_{i \in \{1,2\}} (h_i(n,k,t))^2$ . This contradicts [\(3.1\)](#page-4-0). So  $|\mathscr{T}_2| \geq 2$ .

Notice that  $\tau_t(\mathcal{T}_2) = t$ . Let  $S_1$  and  $S_2$  be members of  $\mathcal{T}_2$  with  $\dim(S_1 \cap S_2) = t$ . Since  $\mathcal{T}_1$ ,  $\mathcal{T}_2$  are cross t-intersecting and  $\tau_t(\mathcal{T}_1) = t + 1$ , there exists  $U \in \mathcal{T}_1$  with  $S_1 \cap S_2 \nsubseteq U$ . By  $\dim(U \cap S_1) \geq t$  and  $\dim(U \cap S_2) \geq t$ , we have  $\dim(U \cap (S_1 \cap S_2)) = t - 1$  and  $U \subseteq S_1 + S_2$ . Thus

$$
\mathscr{T}_1 \setminus (\mathscr{T}_1)_{S_1 \cap S_2} \subseteq \left\{ U \in \begin{bmatrix} S_1 + S_2 \\ t+1 \end{bmatrix} : S_1 \cap S_2 \not\subseteq U \right\}.
$$

Notice that  $\dim(S_1 + S_2) = t + 2$ . We obtain

$$
|\mathcal{T}_1 \setminus (\mathcal{T}_1)_{S_1 \cap S_2}| \leqslant \begin{bmatrix} t+2 \\ 1 \end{bmatrix} - \begin{bmatrix} 2 \\ 1 \end{bmatrix} = q^2 \begin{bmatrix} t \\ 1 \end{bmatrix}.
$$

By [\(3.4\)](#page-5-0), we have  $|(\mathcal{T}_1)_{S_1 \cap S_2}| \leq {k-t+1 \choose 1}$  $\begin{bmatrix} t+1 \\ 1 \end{bmatrix}$ . Therefore

$$
|\mathscr{T}_1| = |(\mathscr{T}_1)_{S_1 \cap S_2}| + |\mathscr{T}_1 \setminus (\mathscr{T}_1)_{S_1 \cap S_2}| \leqslant {k-t+1 \brack 1} + q^2 {t \brack 1}.
$$

This together with [\(3.2\)](#page-4-1) and Lemma [2.2](#page-2-2) produces

$$
|\mathscr{F}_2| \leqslant \left( \begin{bmatrix} k-t+1 \\ 1 \end{bmatrix} + q^2 \begin{bmatrix} t \\ 1 \end{bmatrix} + q^{k-3t-1} \right) \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}.
$$

For each  $S_3 \in \mathcal{S}_2$ , since  $S_1 \cap S_2 \subseteq S_3$ ,  $\dim(S_3 \cap U) \geq t$  and  $S_1 \cap S_2 \not\subseteq U$ , we have  $S_3 \subseteq (S_1 \cap S_2) + U$ . Observe that  $\dim((S_1 \cap S_2) + U) = t + 2$ . We further get  $|\mathscr{T}_2| \leq \binom{2}{1}$  $\begin{bmatrix} 2 \\ 1 \end{bmatrix}$ . This together with [\(3.2\)](#page-4-1) and Lemma [2.2](#page-2-2) yields

$$
|\mathscr{F}_1| \leqslant \left(\begin{bmatrix} 2\\1 \end{bmatrix} + q^{k-3t-1}\right) \begin{bmatrix} n-t-1\\k-t-1 \end{bmatrix}.
$$

Then by Lemma [2.1](#page-1-0) and  $\frac{q^2-1}{a^{t+2}-1}$  $\frac{q^2-1}{q^{t+2}-1} \leqslant \frac{q^2-1}{q^3-1}$  $\frac{q^2-1}{q^3-1} \leqslant \frac{3}{7}$  $\frac{3}{7}$ , we have

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{k-t+1}{1}^2 \binom{n-t-1}{k-t-1}^2} \leq \left(\frac{q^2-1}{q^{k-t+1}-1} + \frac{1}{q^{2t+1}}\right) \left(1 + \frac{q^2(q^t-1)}{q^{k-t+1}-1} + \frac{1}{q^{2t+1}}\right)
$$
  

$$
\leq \left(\frac{q^2-1}{q^{t+3}-1} + \frac{1}{q^{2t+1}}\right) \left(1 + \frac{q^2(q^t-1)}{q^{t+3}-1} + \frac{1}{q^{2t+1}}\right)
$$
(3.7)  

$$
\leq \left(\frac{1}{q^{t+1}} + \frac{1}{q^{2t+1}}\right) \left(1 + \frac{1}{q} + \frac{1}{q^{2t+1}}\right) \leq \frac{39}{64} < \frac{383^2}{384^2}
$$

for  $k \geq 2t + 2$ , and

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{t+2}{1}^2 \binom{n-t-1}{k-t-1}^2} \le \left(\frac{q^2-1}{q^{t+2}-1} + \frac{1}{q^{2t+1}}\right) \left(1 + \frac{q^2(q^t-1)}{q^{t+2}-1} + \frac{1}{q^{2t+1}}\right)
$$
\n
$$
\le \left(\frac{q^2-1}{q^{t+2}-1} + \frac{1}{8}\right) \left(\frac{17}{8} - \frac{q^2-1}{q^{t+2}-1}\right) \le \frac{2945}{3136} < \frac{1023^2}{1024^2}
$$
\n(3.8)

for  $k \leq 2t + 1$ . By [\(3.7\)](#page-7-0), [\(3.8\)](#page-7-1) and Lemma [2.3,](#page-3-2) we obtain  $|\mathscr{F}_1| |\mathscr{F}_2| < \max_{i \in \{1,2\}} (h_i(n, k, t))^2$ . This contradicts [\(3.1\)](#page-4-0).

**Case 2.**  $(\tau_t(\mathcal{T}_1), \tau_t(\mathcal{T}_2)) = (t + 1, t + 1).$ 

**Case 2.1.**  $\mathscr{T}_1$  is *t*-intersecting.

By assumption and [\[5,](#page-12-11) Remark (ii) in Section 9.3], there exists  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$  such that  $\mathscr{T}_1 \subseteq \begin{bmatrix} Z \\ t+1 \end{bmatrix}$ . If there exists  $S \in \mathscr{T}_2$  with  $\dim(S \cap Z) \leq t$ , then

$$
\dim(S' \cap S) = \dim(S' \cap (S \cap Z)) \leq t - 1
$$

for some  $S' \in \mathcal{T}_1$ . This contradicts the fact that  $\mathcal{T}_1$  and  $\mathcal{T}_2$  are cross t-intersecting. Therefore, each member of  $\mathcal{I}_2$  is also a subspace of Z, i.e.,  $\mathcal{I}_2 \subseteq \begin{bmatrix} Z \\ t+1 \end{bmatrix}$ .

If  $\dim(H \cap Z) = t$  for some  $H \in \mathscr{F}_1$ , then each member of  $\mathscr{T}_1$  contains  $H \cap Z$ . This contradicts  $\tau_t(\mathcal{T}_1) = t + 1$ . So  $\dim(F \cap Z) \geq t + 1$  for each  $F \in \mathcal{F}_1$ , i.e.,  $\mathcal{F}_1 \subseteq \mathcal{H}_2(Z)$ . Similarly, we have  $\mathscr{F}_2 \subseteq \mathscr{H}_2(Z)$ . Notice that  $\mathscr{H}_2(Z)$  is t-intersecting. By the maximality of  $\mathscr{F}_1$  and  $\mathscr{F}_2$ , we have  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{H}_2(Z)$ .

**Case 2.2.**  $\mathcal{T}_1$  is not *t*-intersecting.

We first show upper bounds of  $|\mathcal{T}_1|$  and  $|\mathcal{T}_2|$ . Let  $U_1, U_2 \in \mathcal{T}_1$  with  $\dim(U_1 \cap U_2) < t$ , and  $S \in \mathcal{I}_2$ . Note that  $\dim(U_i \cap S) \geq t$  for each i. We have

$$
t+1 = \dim S \geqslant \dim(U_1 \cap S) + \dim(U_2 \cap S) - \dim((U_1 \cap U_2) \cap S) \geqslant 2t - \dim((U_1 \cap U_2) \cap S).
$$

Hence

$$
t-1 \leq \dim((U_1 \cap U_2) \cap S) \leq \dim(U_1 \cap U_2) \leq t-1,
$$

which implies that

$$
\dim(U_1 \cap U_2) = t - 1, \quad U_1 \cap U_2 = (U_1 \cap U_2) \cap S \subseteq S.
$$

We further obtain  $\dim(U_1 \cap S) = \dim(U_2 \cap S) = t$  and  $S = (U_1 \cap S) + (U_2 \cap S)$ . So

$$
\mathscr{T}_2 \subseteq \left\{ W_1 + W_2 : W_i \in \begin{bmatrix} U_i \\ t \end{bmatrix}, U_1 \cap U_2 \subseteq W_i, i = 1, 2 \right\}.
$$

Then

$$
|\mathcal{F}_2| \leqslant \binom{(t+1)-(t-1)}{1}^2 = \binom{2}{1}^2.
$$

If  $\mathcal{T}_2$  is t-intersecting, then by discussion in Case 2.1,  $\mathcal{T}_1$  is also t-intersecting, a contradiction. Thus  $\mathscr{T}_2$  is not *t*-intersecting. Similarly, we derive  $|\mathscr{T}_1| \leq 1$  $\binom{2}{1}^2$ .

Assume that  $t = 1$  and  $|\mathscr{T}_1| \geq 3$ . Note that  $U_1 \cap U_2 = \{0\}$ . Since  $\mathscr{T}_1$  and  $\mathscr{T}_2$  are cross 1intersecting, we have  $\mathscr{T}_2 \subseteq \begin{bmatrix} U_1 + U_2 \\ 2 \end{bmatrix}$ <sup>+U<sub>2</sub></sup>]. Observe that there exist  $Y_1, Y_2 \in \mathcal{T}_2$  with  $Y_1 \cap Y_2 = \{0\}.$ Then  $\mathscr{T}_1 \subseteq \begin{bmatrix} Y_1 + Y_2 \\ 2 \end{bmatrix}$  $\binom{+Y_2}{2} \subseteq \binom{U_1+U_2}{2}$  $\left[\begin{matrix}+U_2\2\end{matrix}\right]$ .

Suppose that there exists  $U_3 \in \mathcal{T}_1$  with  $U_3 \cap U_1 = U_3 \cap U_2 = \{0\}$ , and  $U_i$  is spanned by vectors  $\alpha_i$  and  $\beta_i$   $(i = 1, 2)$ . Note that  $U_3 \in \begin{bmatrix} U_1 + U_2 \\ 2 \end{bmatrix}$  $\binom{+U_2}{2}$ . Then  $U_3$  is spanned by vectors  $a_i\alpha_1 + b_i\beta_1 + c_i\alpha_2 + d_i\beta_2$ , where  $a_i, b_i, c_i, d_i \in \mathbb{F}_q$   $(i = 1, 2)$ . If  $a_1b_2 - a_2b_1 = 0$ , then  $\dim(U_3 \cap U_2) \geq 1$ , a contradiction. Thus  $a_1b_2 - a_2b_1 \neq 0$ . We may assume  $a_1 = b_2 = 1$ and  $a_2 = b_1 = 0$ . Recall that  $S \in \mathcal{I}_2$ . Since  $\dim(S \cap U_1) = \dim(S \cap U_2) = 1$ , S is spanned

by vectors  $r_1\alpha_1 + s_1\beta_1$  and  $r_2\alpha_2 + s_2\beta_2$  for some  $(r_1, s_1), (r_2, s_2) \in \mathbb{F}_q^2 \setminus \{(0, 0)\}.$  Note that  $\dim(S \cap U_3) \geq 1$ . There exists  $u \in \mathbb{F}_q^*$  such that

$$
r_1\alpha_1 + s_1\beta_1 + u(r_2\alpha_2 + s_2\beta_2) = r_1(\alpha_1 + c_1\alpha_2 + d_1\beta_2) + s_1(\beta_1 + c_2\alpha_2 + d_2\beta_2) \in S \cap U_3.
$$

We further get  $r_2 = u^{-1}(r_1c_1 + s_1c_2)$  and  $s_2 = u^{-1}(r_1d_1 + s_1d_2)$ , which imply that S is spanned by  $r_1\alpha_1 + s_1\beta_1$  and  $(r_1c_1 + s_1c_2)\alpha_2 + (r_1d_1 + s_1d_2)\beta_2$ . Hence

$$
|\mathscr{T}_2| \leqslant |\mathbb{F}_q^2 \setminus \{(0,0)\}| = q^2 - 1.
$$

Next, w.l.o.g., suppose  $\dim(U_4 \cap U_1) = 1$  for some  $U_4 \in \mathcal{T}_1$ . Note that  $\dim(U_1 + U_4) = 3$ . This together with  $U_4 \subseteq U_1 + U_2$  and  $U_1 \cap U_2 = \{0\}$  yields  $\dim(U_2 \cap (U_1 + U_4)) = 1$ . If  $U_1 \cap U_4 \nsubseteq S$ , then  $S \subseteq U_1 + U_4$  and  $S = W + (U_2 \cap (U_1 + U_4))$  for some  $W \in \begin{bmatrix} U_1 \\ 1 \end{bmatrix}$  $\left\{ \begin{matrix} U_1 \ 1 \end{matrix} \right\}$  \  $\{U_1 \cap U_4\}.$ Consequently

$$
|\mathscr{T}_2 \setminus (\mathscr{T}_2)_{U_1 \cap U_4}| \leqslant \begin{bmatrix} 2 \\ 1 \end{bmatrix} - 1 = q.
$$

If  $U_1 \cap U_4 \subseteq S$ , then by  $\dim(S \cap U_2) = 1$ , we obtain  $|(\mathscr{T}_2)_{U_1 \cap U_4}| \leq 1$  $_{1}^{2}$ . Therefore

$$
|\mathcal{T}_2| = |(\mathcal{T}_2)_{U_1 \cap U_4}| + |\mathcal{T}_2 \setminus (\mathcal{T}_2)_{U_1 \cap U_4}| \leq q + \begin{bmatrix} 2 \\ 1 \end{bmatrix} = 2q + 1.
$$

Now we have  $|\mathcal{I}_2| \leq \max\{q^2 - 1, 2q + 1\}$ . Similarly, since  $\mathcal{I}_2$  is not t-initersecting, when  $t = 1$  and  $|\mathcal{I}_2| \geq 3$ , we have  $|\mathcal{I}_1| \leq \max\{q^2 - 1, 2q + 1\}.$ 

In a word, for each  $i$ , we have

<span id="page-9-0"></span>
$$
|\mathcal{T}_i| \leqslant \begin{cases} \max\{q^2 - 1, 2q + 1\} \leqslant \binom{2}{1}^2, & \text{if } t = 1 \text{ and } |\mathcal{T}_{3-i}| \geqslant 3, \\ \binom{2}{1}^2, & \text{otherwise.} \end{cases} \tag{3.9}
$$

If  $k = t + 1$ , we have known that  $\mathscr{F}_1 = \mathscr{T}_2$  and  $\mathscr{F}_2 = \mathscr{T}_1$ . Then by [\(3.9\)](#page-9-0),

$$
|\mathcal{F}_1| |\mathcal{F}_2| \leq \begin{cases} \max \left\{ (q^2 - 1)^2, (2q + 1)^2, 2\binom{2}{1}^2 \right\} < (h_2(n, 2, 1))^2, & \text{if } t = 1, \\ \binom{2}{1}^4 < \binom{4}{1}^2 \leq \binom{t+2}{1}^2 = (h_2(n, t+1, t))^2, & \text{if } t \geq 2. \end{cases}
$$

This contradicts [\(3.1\)](#page-4-0). So  $k \geq t+2$ .

By  $(3.2)$  and Lemma [2.2,](#page-2-2) we have

<span id="page-9-1"></span>
$$
|\mathcal{F}_1| \leq (|\mathcal{F}_2| + q^{k-3t-1}) \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}, \quad |\mathcal{F}_2| \leq (|\mathcal{F}_1| + q^{k-3t-1}) \begin{bmatrix} n-t-1 \\ k-t-1 \end{bmatrix}.
$$
 (3.10)

Assume  $k \leq 2t + 1$ . Then

$$
\frac{|\mathscr{F}_1| |\mathscr{F}_2|}{\binom{n-t-1}{k-t-1}^2} \leqslant |\mathscr{T}_1| |\mathscr{T}_2| + q^{-t} (|\mathscr{T}_1| + |\mathscr{T}_2|) + q^{-2t}.
$$

Suppose  $t = 1$  and  $|\mathcal{F}_1|, |\mathcal{F}_2| \geq 3$ . If  $q = 2$ , then by  $(3.9)$  and Lemma [2.3,](#page-3-2) we have

<span id="page-10-0"></span>
$$
\frac{(h_2(n,k,1))^2 - |\mathcal{F}_1||\mathcal{F}_2|}{\binom{n-2}{k-2}^2} \ge \frac{1023^2}{1024^2} \begin{bmatrix} 3\\1 \end{bmatrix}^2 - 5^2 - 5 - \frac{1}{2^2} > 0. \tag{3.11}
$$

If  $q \ge 3$ , then by  $(3.9)$ ,  $n \ge 2k + 2t + 5$ , Lemma [2.1](#page-1-0) and

$$
h_2(n,k,1) = \begin{bmatrix} 3 \\ 1 \end{bmatrix} \begin{bmatrix} n-2 \\ k-2 \end{bmatrix} - q \begin{bmatrix} 2 \\ 1 \end{bmatrix} \begin{bmatrix} n-3 \\ k-3 \end{bmatrix},
$$

we obtain

$$
\frac{(h_2(n,k,1))^2 - |\mathcal{F}_1||\mathcal{F}_2|}{\binom{n-2}{k-2}^2} \ge \left(\binom{3}{1} - \frac{q(q^{k-2}-1)\binom{2}{1}}{q^{n-2}-1}^2 - (q^2-1)^2 - \frac{2(q^2-1)}{q} - \frac{1}{q^2}
$$
\n
$$
\ge \left(\binom{3}{1} - \frac{q(q+1)}{q^{10}}\right)^2 - \left(q^2-1 + \frac{1}{q^2}\right)^2 > 0.
$$
\n
$$
(3.12)
$$

Suppose  $t = 1$  and  $|\mathscr{T}_i| \leq 2$  for some  $i \in \{1, 2\}$ . By  $\frac{q^2-1}{q^3-1}$  $\frac{q^2-1}{q^3-1} \leqslant \frac{3}{7}$  $\frac{3}{7}$ , [\(3.9\)](#page-9-0) and Lemma [2.1,](#page-1-0) we get

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{3}{1}^2 \binom{n-2}{k-2}^2} \le \frac{2\binom{2}{1}^2}{\binom{3}{1}^2} + \frac{2 + \binom{2}{1}^2}{q\binom{3}{1}^2} + \frac{1}{q^2\binom{3}{1}^2} \le \frac{18}{49} + \frac{1}{49} + \frac{9}{98} + \frac{1}{196} < \frac{1023^2}{1024^2}.\tag{3.13}
$$

Suppose  $t \geq 2$ , then by [\(3.9\)](#page-9-0) and Lemma [2.1](#page-1-0), we have

$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\left[t+2\right]^2 \left[n-t-1\right]^2} \leq \left(\frac{\binom{2}{1}^2}{\binom{t+2}{1}}\right)^2 + \frac{2}{q^t} \left(\frac{\binom{2}{1}^2}{\binom{t+2}{1}}\right)^2 + \frac{1}{(q^t \binom{t+2}{1})^2}
$$
\n
$$
\leq \frac{(q^2-1)^4}{(q-1)^2(q^4-1)^2} + \frac{2(q^2-1)^2}{q^t(q^{t+2}-1)^2} + \frac{(q-1)^2}{q^{2t}(q^{t+2}-1)^2}
$$
\n
$$
\leq \frac{(q+1)^2}{(q^2+1)^2} + \frac{1}{q^{3t-1}} + \frac{1}{q^{4t+2}} \leq \frac{10041}{25600} < \frac{1023^2}{1024^2}.
$$
\n
$$
(3.14)
$$

Now assume  $k \geq 2t + 2$ . Note that  $|\mathscr{T}_1| |\mathscr{T}_2| \leq \binom{t+2}{1}$  $\binom{+2}{1}^2$  by [\(3.9\)](#page-9-0). This together with (3.9), [\(3.10\)](#page-9-1) and Lemma [2.1](#page-1-0) yields

<span id="page-10-1"></span>
$$
\frac{|\mathcal{F}_1||\mathcal{F}_2|}{\binom{k-t+1}{1}^2 \binom{n-t-1}{k-t-1}^2} \leq \frac{|\mathcal{F}_1||\mathcal{F}_2| + q^{k-3t-1}(|\mathcal{F}_1| + |\mathcal{F}_2|) + q^{2k-6t-2}}{\binom{k-t+1}{1}^2} \\
\leq \frac{(q^{t+2}-1)^2}{(q^{t+3}-1)^2} + \frac{2q^{k-3t-1}(q^2-1)^2}{(q^{k-t+1}-1)^2} + \frac{q^{2k-6t-2}(q-1)^2}{(q^{k-t+1}-1)^2} \\
\leq \frac{1}{q^2} + \frac{1}{q^{k+t-2}} + \frac{1}{q^{4t+2}} \leq \frac{25}{64} < \frac{383^2}{384^2}.
$$
\n(3.15)

By  $(3.11)-(3.15)$  $(3.11)-(3.15)$  and Lemma [2.3,](#page-3-2) we obtain  $|\mathscr{F}_1||\mathscr{F}_2| < \max_{i \in \{1,2\}} (h_i(n,k,t))^2$ . This contradicts  $(3.1)$ .

In summary, assuming  $k = t + 1$ , we have  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{H}_2(Z)$  for some  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}$ ; assuming  $k \geq t+2$ , we have  $\mathscr{F}_1 = \mathscr{H}_1(T, L, M)$  and  $\mathscr{F}_2 = \mathscr{H}_1(T, M, L)$  for some  $T \in \begin{bmatrix} V_t \\ t \end{bmatrix}$  $_t^V$  and  $L, M \in \begin{bmatrix} V \\ k+1 \end{bmatrix}$  with  $T \subseteq L \cap M$  and  $\dim(L \cap M) \geq t+2$ , or  $\mathscr{F}_1 = \mathscr{F}_2 = \mathscr{H}_2(Z)$  for some  $Z \in \begin{bmatrix} V \\ t+2 \end{bmatrix}.$ 

When  $k \geq t+2$ , by [\[6,](#page-12-9) Lemmas 2.6-2.9], we have  $(h_1(n, k, t))^2 > (h_2(n, k, t))^2$  if  $k > 2t+1$ ;  $(h_1(n, k, t))^2 \leqslant (h_2(n, k, t))^2$  if  $k \leqslant 2t + 1$ , and equality holds if and only if  $(k, t) = (3, 1)$ . This finishes the proof of Theorem [1.1.](#page-1-1)

#### 3.2 Proof of Theorem [1.2](#page-1-2)

We may suppose that  $\mathscr{F}_1, \mathscr{F}_2, \ldots, \mathscr{F}_r$  are non-empty r-cross t-intersecting families of ksubspaces of V with  $\tau_t(\mathscr{F}_i) \geq t+1$  for each i, and  $\prod_{i=1}^r |\mathscr{F}_i|$  takes the maximum value.

Let  $d \in \{1, 2, \ldots, r\}$ . Assume that there exists a subspace  $F_0$  of V with  $\dim(\bigcap_{j=0}^d F_j) \geq t$ for any  $F_i \in \mathscr{F}_i$ ,  $1 \leqslant i \leqslant d$ . For  $m \in \{0, 1, 2, \ldots, d - 1\}$ , suppose that there exist  $F'_1 \in \mathscr{F}_1$ ,  $\ldots, F'_m \in \mathscr{F}_m$  such that  $\dim F_0 \geqslant \dim \left(\bigcap_{j=0}^m F'_j\right) + m \geqslant t + m$ , where  $F'_0 = F_0$ . Since  $\tau_t(\mathscr{F}_{m+1}) \geq t+1$ , there exists  $F'_{m+1} \in \mathscr{F}_{m+1}$  not containing  $\bigcap_{j=0}^m F'_j$ , which implies that

$$
\dim F_0 \geqslant \dim \left( \bigcap_{j=0}^m F'_j \right) + m \geqslant \dim \left( \bigcap_{j=0}^{m+1} F'_j \right) + 1 + m \geqslant t + m + 1.
$$

Note that dim  $F_0 \geq t$ . By induction, we get dim  $F_0 \geq t + d$ .

Set  $d = r-2$  and  $F_0 = A \cap B$ , where  $A \in \mathscr{F}_{r-1}$  and  $B \in \mathscr{F}_r$ . Then  $\dim(A \cap B) \geq t+r-2$ . Hence  $\mathscr{F}_{r-1}$  and  $\mathscr{F}_r$  are cross  $(t + r - 2)$ -intersecting. We further conclude that  $\mathscr{F}_i$  and  $\mathscr{F}_j$ are cross  $(t + r - 2)$ -intersecting for distinct *i*, *j*.

If  $\tau_{t+r-2}(\mathscr{F}_\ell) = t+r-2$  for some  $\ell$ , then there exists a t-subspace contained in each member of  $\mathscr{F}_{\ell}$ , a contradiction to  $\tau_t(\mathscr{F}_{\ell}) \geq t+1$ . Thus  $\tau_{t+r-2}(\mathscr{F}_i) \geq t+r-1$  for each i. For distinct  $i, j \in \{1, 2, \ldots, r\}$ , since  $k \geqslant t + r - 1$  and  $n \geqslant 2k + 2t + 2r + 1$ , by Theorem [1.1,](#page-1-1) we get

<span id="page-11-0"></span>
$$
|\mathscr{F}_i||\mathscr{F}_j| \le \max\{(h_1(n,k,t+r-2))^2, (h_2(n,k,t+r-2))^2\},\tag{3.16}
$$

which implies that

$$
\prod_{i=1}^r |\mathscr{F}_i| \le \max\{(h_1(n,k,t+r-2))^r, (h_2(n,k,t+r-2))^r\}.
$$

We may suppose the equality holds. Then the equality in  $(3.16)$  holds for distinct i, j.

Suppose  $k > 2t + 2r - 3$ . By Theorem [1.1,](#page-1-1) we have  $\mathscr{F}_1 = \mathscr{H}_1(T, L, M)$ , then  $\mathscr{F}_i =$  $\mathscr{H}_1(T,M,L)$   $(i \in \{2,3,\ldots,r\})$  for some  $T \in \begin{bmatrix} V_t \\ t \end{bmatrix}$  $\left\{ \begin{array}{l} V_t \\ t \end{array} \right\}$  and  $M, L \in \left[ \begin{smallmatrix} V \\ k+1 \end{smallmatrix} \right]$  with  $T \subseteq L \cap M$  and  $\dim(L \cap M) \geq t+r$ . Note that  $\mathscr{F}_2$  and  $\mathscr{F}_3$  are cross  $(t+r-2)$ -intersecting. Then  $\mathscr{H}_1(T, M, L)$ is  $(t + r - 2)$ -intersecting. If  $p = \dim(M \cap L) \leq k$ , then since  $n \geq 2k + 2t + 2r + 1$ , there exists  $Y \in \mathcal{H}_1(T, M, L)$  with

$$
T \subseteq Y
$$
,  $\dim(Y \cap M) = (t + r - 2) + (k + 1 - p)$ ,  $Y \cap L = T$ .

For  $Y' \in \begin{bmatrix} L \\ k \end{bmatrix}$  $\mathcal{L}^L_k$  with  $T \nsubseteq Y'$ , we have  $\dim(Y \cap Y') = \dim((Y \cap L) \cap Y') < t + r - 2$ . This contradicts the fact that  $\mathcal{H}_1(T, M, L)$  is  $(t + r - 2)$ -intersecting. So  $M = L$ , implying that  $\mathscr{F}_i = \mathscr{H}_1(T, M, M)$  for each i. On the other hand, if  $k \leq 2t + 2r - 3$ , then by Theorem [1.1,](#page-1-1) we have  $\mathscr{F}_1 = \mathscr{F}_i = \mathscr{H}_2(Z)$   $(i \in \{2, 3, \ldots, r\})$  for some  $Z \in \begin{bmatrix} V \\ t+1 \end{bmatrix}$  $\begin{bmatrix} V \\ t+r \end{bmatrix}$ .

To finish our proof, it is sufficient to show that neither  $\dim(\bigcap_{i=1}^r A_i)$  nor  $\dim(\bigcap_{i=1}^r B_i)$ is less than t for any  $A_i \in \mathcal{H}_1(T, M, M)$  and  $B_i \in \mathcal{H}_2(Z)$ ,  $1 \leq i \leq r$ . By [\[7,](#page-12-10) Lemma 4.7], the desired result follows.

**Remark.** Set  $d = r - 1$  and  $F_0 \in \mathcal{F}_r$ . Then  $k = \dim F_0 \geq t + r - 1$ . So  $r > k - t + 1$  implies that there does not exist non-empty r-cross t-intersecting families of  $k$ -subspaces of  $V$ .
