EXISTENCE AND MULTIPLICITY OF SOLUTIONS FOR FRACTIONAL $\kappa(\xi)$ -KIRCHHOFF-TYPE EQUATION

ABSTRACT. In this paper, we aim to tackle the questions of existence and multiplicity of solutions to a new class of $\kappa(\xi)$ -Kirchhoff-type equation utilizing a variational approach. Further, we research the results from the theory of variable exponent Sobolev spaces and from the theory of space ψ -fractional $\mathcal{H}^{\mu,\nu;\,\psi}_{\kappa(\xi)}(\Lambda)$. In this sense, we present a few special cases and remark on the outcomes explored.

1. Introduction and motivation

In this paper, we concern the following Kirchhoff's fractional $\kappa(\xi)$ -Laplacian equation

 ${}^{\mathrm{H}}\mathfrak{D}^{\mu,\nu;\psi}_{T}(\cdot)$ and ${}^{\mathrm{H}}\mathfrak{D}^{\mu,\nu;\psi}_{0+}(\cdot)$ are ψ -Hilfer fractional partial derivatives of order $\frac{1}{\kappa}<\mu<1$ and type $0\leq\nu\leq1$. Further, $\kappa=\kappa(\xi)\in C(\bar{\Lambda}),\ 1<\kappa^-=\inf_{\Lambda}\kappa(\xi)\leq\kappa^+=\sup_{\Lambda}\kappa(\xi)<2,\ \mathfrak{M}(t)$ is a continuous function and $\mathfrak{g}(\xi,\phi):\Lambda\times\mathbb{R}\to\mathbb{R}$ is the Caratheodory function. Note that Eq.(1.2), is a generalization of $\mathbf{L}^{\mu,\nu;\psi}_{\kappa}(\cdot)$ when $\kappa(\xi)=\kappa$ is a constant.

The Kirchhoff proposed a model given by equation

$$\rho \frac{\partial^2 u}{\partial t^2} - \left(\frac{\rho_0}{h} + \frac{E}{2L} \int_0^L \left| \frac{\partial u}{\partial x} \right|^2 dx \right) \frac{\partial^2 u}{\partial x^2} = 0,$$

where ρ , ρ_0 , L, h, E are constants, which extends the classical D'Alembert's wave equation. The operator

$$\Delta_{p(x)}u := \operatorname{div}\left(|\nabla u|^{p(x)-2}|\nabla u|\right)$$

is said to be the p(x)-Laplacian, and it becomes p-Laplacian when p(x) = p. The study of mathematical problems with variable exponents is very interesting. We can highlight the existence and multiplicity problem of the solution of p(x)-Laplacian equation, p(x)-Kirchhoff and p-Kirchhoff both in the classical and in the practical sense [2–6, 14–16, 18]. See also the problems involving fractional operators and the references therein [19, 20, 23, 24]. We can also highlight fractional differential equation problems with p-Laplacian using variational methods, in particular, Nehari manifold [9, 10, 26–31].

In 2006, Correa and Figueiredo [4] investigated the existence of positive solutions to the class of problems of the p-Kirchhoff type

where Λ is a bounded smooth domain of \mathbb{R}^N , $1 , <math>s \ge p^* = \frac{pN}{N-p}$ and M, f are continuous functions.

In 2010, Fan [15] considered the nonlocal p(x)-Laplacian Dirichlet problems with non-variational

and a is allowed to be singular at zero. To obtain the existence and uniqueness of solutions for the problem (1.3), the authors used variational methods, especially Mountain pass geometry.

Problems involving Kirchhoff-type with variable and non-variable exponents are attracting attention and gaining prominence in several research groups for numerous theoretical and practical questions [7, 21, 32] and the references therein. On the other hand, it is also worth mentioning Kirchhoff's problems with fractional operators, which over the years has been increasing exponentially [1,17,34]. The p(x)-Laplacian possesses more complex nonlinearity which raises some of the essential difficulties, for example, it is inhomogeneous.

Dai and Hao [5] discussed the existence of a solution for a p(x)-Kirchhoff-type equation given

Motivated by the ideas found in [4,5,15], we study the existence and multiplicity of solutions for problem (1.1) by supposing the following conditions:

Our main results are the following:

Teorema3.1 **Theorem 1.1.** If \mathfrak{M} satisfies (C_0) and

where $1 \leq \widehat{\beta} < \kappa^-$ then problem (1.1) has a weak solution.

Theorem 1.2. Assume that \mathfrak{M} satisfies $(C_0) - (C_1)$ and \mathfrak{g} satisfies $(f_0), (f_1), (f_2)$. Teorema3.2 problem (1.1) has a non-trivial solution.

Theorem 1.3. Assume that (C_0) , (C_1) , (f_0) and (f_1) hold and \mathfrak{g} satisfies the condition (f_3) . Then, problem (1.1) has a sequence of solutions $\{\pm \phi_k\}_{k=1}^{+\infty}$ such that $\mathfrak{E}(\pm \phi_k) \to +\infty$ as $k \to +\infty$. Teorema3.3

Theorem 1.4. Assume that (C_0) , (C_1) , (f_0) , (f_1) , (f_2) (f_3) hold and \mathfrak{g} satisfies the condition (f_4) . Then, problem (1.1) has a sequence of solutions $\{\pm v_k\}_{k=1}^{+\infty}$ such that $\mathfrak{E}(\pm v_k) < 0$, Teorema3.4 $\mathfrak{E}(\pm v_k) \to +\infty \text{ as } k \to 0.$

> The plan of the paper is as follows. In section 2, we present some definitions on fractional derivatives and integrals, among others, and results on Sobolev spaces with variable exponents and ψ -fractional space. In section 3, we dedicate ourselves to deal with the main contributions of the article, as highlighted above, i.e., **Theorem 1.1**, **Theorem 1.2**, **Theorem 1.3** and Theorem 1.4.

2. Previous results

In this section, we present a few essential definitions, lemmas and propositions to attack the main results of the article.

Let

where $S(\Lambda)$ is the set of all measurable real function defined on Λ . Note that, for $\kappa(\xi) = \kappa$, we have the space \mathcal{L}^{κ} .

The ψ -fractional space is given by [26, 27]

Denote by $\mathcal{H}^{\mu,\nu;\,\psi}_{\kappa(\xi),0}(\Lambda)$ the closure of $C_0^{\infty}(\Lambda)$ in $\mathcal{H}^{\mu,\nu;\,\psi}_{\kappa(\xi)}(\Lambda)$.

Next, we will present the definitions of Riemann-Liouville partial fractional integrals with respect to another function and of the fractional derivatives ψ -Hilfer for 3-variables. For a study of N-variables, see [25,31].

Let $\theta = (\theta_1, \theta_2, \theta_3)$, $T = (T_1, T_2, T_3)$ and $\mu = (\mu_1, \mu_2, \mu_3)$ where $0 < \mu_1, \mu_2, \mu_3 < 1$ with $\theta_j < T_j$, for all $j \in \{1, 2, 3\}$. Also put $\Lambda = I_1 \times I_2 \times I_3 = [\theta_1, T_1] \times [\theta_2, T_2] \times [\theta_3, T_3]$, where T_1, T_2, T_3 and $\theta_1, \theta_2, \theta_3$ are positive constants. Consider also $\psi(\cdot)$ be an increasing and positive monotone function on $(\theta_1, T_1), (\theta_2, T_2), (\theta_3, T_3)$, having a continuous derivative $\psi'(\cdot)$ on $(\theta_1, T_1], (\theta_2, T_2], (\theta_3, T_3]$. The ψ -Riemann-Liouville fractional partial integrals of $\phi \in \mathcal{L}^1(\Lambda)$ of order μ $(0 < \mu < 1)$ are given by [25, 31]:

• 1-variable: right and left-sided

On the other hand, let $\phi, \psi \in C^n(\Lambda)$ be two functions such that ψ is increasing and $\psi'(\xi_j) \neq 0$ with $\xi_j \in [\theta_j, T_j]$, $j \in \{1, 2, 3\}$. The left and right-sided ψ -Hilfer fractional partial derivative of 3-variables of $\phi \in AC^n(\Lambda)$ of order $\mu = (\mu_1, \mu_2, \mu_3)$ $(0 < \mu_1, \mu_2, \mu_3 \le 1)$ and type $\nu = (\nu_1, \nu_2, \nu_3)$ where $0 \le \nu_1, \nu_2, \nu_3 \le 1$, are defined by [25, 31] (2.1)

where θ and T are the same parameters presented in the definition of fractional integrals $\mathbf{I}_{T}^{\mu;\psi}(\cdot)$ and $\mathbf{I}_{\theta}^{\mu;\psi}(\cdot)$.

Taking $\theta = 0$ in the definition of ${}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{\theta}(\cdot)$, we have ${}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{0}(\cdot)$. During the paper we will use the following notation: ${}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{\theta}\phi(\xi_{1},\xi_{2},\xi_{3}) := {}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{\theta}\phi, {}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{T}\phi(\xi_{1},\xi_{2},\xi_{3}) := {}^{\mathbf{H}}\mathfrak{D}^{\mu,\nu;\psi}_{T}\phi$ and $\mathbf{I}_{\theta}^{\mu;\psi}\phi(\xi_1,\xi_2,\xi_3) := \mathbf{I}_{\theta}^{\mu;\psi}\phi.$ Let $\theta = (\theta_1,\theta_2), T = (T_1,T_2)$ and $\mu = (\mu_1,\mu_2)$. Theorem 2.1. Let $\psi(\cdot)$ be an increasing and positive monotone function on $[\theta_1, T_1] \times [\theta_2, T_2]$, having a continuous derivative $\psi'(\cdot) \neq 0$ on $(\theta_1, T_1) \times (\theta_2, T_2)$. If $0 < \mu = (\mu_1, \mu_2) < 1$ and $0 \le \nu = (\nu_1, \nu_2) \le 1$, then

3. Main results

In this section, we will address the main results of this paper, using variational techniques and results from Sobolev spaces with variable exponents and from the ψ -fractional space $\mathcal{H}_{\kappa(\mathfrak{c})}^{\mu,\nu;\psi}(\Lambda)$, as discussed in the previous section.

Proof. (Proof of Theorem 1.1) Using the inequalities (1.4) and (1.6), yields

$$\begin{split} \mathfrak{E}(\phi) &= \widehat{\mathfrak{M}} \left(\int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{\mathrm{H}} \mathfrak{D}_{0+}^{\mu,\nu;\,\psi} \phi \right|^{\kappa(\xi)} d\xi \right) - \int_{\Lambda} \mathfrak{g}(\xi,\phi) d\xi \\ &\geq \frac{m_0}{\kappa^+} \int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{\mathrm{H}} \mathfrak{D}_{0+}^{\mu,\nu;\,\psi} \phi \right|^{\kappa(\xi)} d\xi - c \int_{\Lambda} |\phi|^{\zeta(\xi)} d\xi - c \int_{\Lambda} |\phi| d\xi \\ &\geq \frac{m_0}{\kappa^+} ||\phi||^{\kappa^-} - c||\phi||^{\zeta(\eta)} - c||\phi|| \\ &\geq ||\phi||^{\kappa^-} - c\beta_k^{\zeta^+} ||\phi||^{\kappa^+} - c||\phi|| - c \\ &= m_0 \left(\frac{1}{\kappa^+} - \frac{1}{\zeta^+} \right) \left(c\zeta^+ \beta_\kappa^{\zeta^+} m_0^{-1} \right)^{\frac{\kappa^+}{\kappa^+ - \zeta^+}} - c \left(c\zeta^+ \beta_\kappa^{\zeta^+} m_0^{-1} \right)^{\frac{1}{\kappa^- - \zeta^+}} - c \to +\infty \end{split}$$

as $\kappa \to +\infty$ and with $\kappa^+ < \zeta^+, \kappa^- > 1$ and $\beta_k \to 0$.

 (A_3) Using (f_1) , we have $G(\xi,t) \geq c|t|^{\theta} - c$. Therefore, for any $w \in Y_k$ with ||w|| = 1 and $1 < t = \rho_k$, yields

$$\mathfrak{E}(tw) = \widehat{\mathfrak{M}} \left(\int_{\Lambda} \frac{1}{\kappa(\xi)} \left| t \, {}^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi} w \right|^{\kappa(\xi)} d\xi \right) - \int_{\Lambda} G(\xi, tw) d\xi$$

$$\leq c \rho_{k}^{\frac{\kappa^{+}}{1-\omega}} \left(\int_{\Lambda} \left| {}^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi} \phi \right|^{\kappa(\xi)} d\xi \right)^{\frac{1}{1-\omega}} - c \rho_{k}^{\theta} \int_{\Lambda} |w|^{\theta} d\xi - c.$$

Note that, since $\theta > \frac{\kappa^+}{1-\omega}$ and dim $Y_k = k$ holds, $\mathfrak{E}(\phi) \to -\infty$ as $||\phi|| \to +\infty$ for $\phi \in Y_k$. In this sense, using the **Lemma 2.12** (Fountain theorem), we concluded the proof of Theorem. \square

Proof. (Proof of Theorem 1.4) First, note that, using condition (f_3) and Lemma 2.13, it follows that \mathfrak{E} satisfies the conditions (A_1) and (B_4) (see Lemma 2.12-Dual Fountain Theorem).

 (B_1) For any $v \in \mathbb{Z}_k$, ||v|| = 1, and 0 < t < 1, yields

$$\mathfrak{E}(tv) = \widehat{\mathfrak{M}} \left(\int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi}(tv) \right|^{\kappa(\xi)} d\xi \right) - \int_{\Lambda} G(\xi, tv) d\xi$$

$$\geq \frac{m_{0}}{\kappa^{+}} t^{\kappa^{+}} \int_{\Lambda} \left| {}^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi} v \right|^{\kappa(\xi)} d\xi - \epsilon t^{\kappa^{+}} \int_{\Lambda} |v|^{\kappa^{+}} d\xi - c t^{\zeta^{-}} \int_{\Lambda} |v|^{\zeta(\xi)} d\xi$$

$$\geq \frac{m_{0}}{2\kappa^{+}} t^{\kappa^{+}} - \begin{cases} c \ \beta_{k}^{\zeta^{-}} \ t^{\zeta^{-}} \ \text{if} \ \|\phi\|_{\zeta(\xi) > 1}. \end{cases}$$

Since $\zeta^- > \kappa^+$, without loss of generality taking $\rho_k = t$ with k (sufficiently large), for $v \in Z_k$ with ||v|| = 1, holds $\mathfrak{E}(tv) \geq 0$. In that sense, we have $\inf_{\phi \in Z_k, ||\phi|| = \rho_k} \mathfrak{E}(\phi) \geq 0$ for k sufficiently large. Thus, the condition (B_1) is satisfied.

(B₂) For $v \in Y_k$, ||v|| = 1 and $0 < t < \rho_k < 1$, yields

$$\begin{split} \mathfrak{E}(tv) &= \widehat{\mathfrak{M}} \left(\int_{\Lambda} \frac{1}{\kappa(\xi)} \left| t \right|^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi} v \right|^{\kappa(\xi)} d\xi \right) - \int_{\Lambda} G(\xi,tv) d\xi \\ &\leq c \left(\int_{\Lambda} \left| t \right|^{H} \mathfrak{D}_{0+}^{\mu,\nu;\psi} v \right|^{\kappa(\xi)} d\xi \right)^{\frac{1}{1-\omega}} - c \int_{\Lambda} |tv|^{\gamma(\xi)} d\xi \\ &\leq c t^{\frac{\kappa^{-}}{1-\omega}} \left(\int_{\Lambda} \left| H \mathfrak{D}_{0+}^{\mu,\nu;\psi} v \right|^{\kappa(\xi)} d\xi \right)^{\frac{1}{1-\omega}} - c t^{\gamma^{+}} \int_{\Lambda} |v|^{\gamma(\xi)} d\xi. \end{split}$$

Using the fact $\gamma^+ < \frac{\kappa^-}{1-\omega}$, there exists a $r_k \in (0, \rho_k)$ such that $\mathfrak{E}(tv) < 0$ when $t = r_k$. So, we obtain

$$b_k := \max_{\substack{\phi \in Y_k, \\ ||\phi|| = r_k}} \mathfrak{E}(\phi) < 0$$

Thus, the condition (B_2) is satisfied.

 (B_3) Using the fact that $Y_k \cap Z_k \neq \emptyset$ and $r_k < \rho_k$, one has

$$d_k := \inf_{\substack{\phi \in Z_k, \\ ||\phi|| \le \rho_k}} \mathfrak{E}(\phi) \le b_k := \max_{\substack{\phi \in Y_k, \\ ||\phi|| = r_k}} \mathfrak{E}(\phi) < 0.$$

Using the inequality (3.7), for $v \in Z_k$, ||v|| = 1, $0 \le t \le \rho_k$ and $\phi = tv$, yields

$$\mathfrak{E}(\phi) = \mathfrak{E}(tv) \ge -\begin{cases} c \ \beta_k^{\zeta^-} \ t^{\zeta^-} \ \text{if} \ \|\phi\|_{\zeta(\xi)} \le 1\\ c \ \beta_k^{\zeta^+} \ t^{\zeta^-} \ \text{if} \ \|\phi\|_{\zeta(\xi)} > 1 \end{cases}$$

hence $d_k \to 0$ i.e. (B_3) is satisfied. Therefore, by means of **Theorem 1.4**, we conclude the proof.

4. A Special problem and comments

The following idea is to discuss some consequences of **Theorem 1.1** - **Theorem 1.4**. Consider the following fractional problem

$$\left(a + b \int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{\mathsf{H}} \mathfrak{D}_{0+}^{\mu,\nu;\psi} \phi \right|^{\kappa(\xi)} d\xi \right) \mathbf{L}_{\kappa(\xi)}^{\mu,\nu;\psi} \phi = \mathfrak{g}(\xi,\phi), \ in \ \Lambda = [0,T] \times [0,T]$$

$$\phi = 0$$

where

(4.1)

eq11

$$\mathbf{L}_{\kappa(\xi)}^{\mu,\nu;\psi}\phi = {}^{\mathrm{H}}\mathfrak{D}_{T}^{\mu,\nu;\psi}\left(\left|{}^{\mathrm{H}}\mathfrak{D}_{0+}^{\mu,\nu;\psi}\phi\right|^{\kappa(\xi)-2} {}^{\mathrm{H}}\mathfrak{D}_{0+}^{\mu,\nu;\psi}\phi\right)$$

and a, b are two positive constants.

Let $\mathfrak{M}(t) = a + bt$ with $t = \int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{\mathrm{H}}\mathfrak{D}_{0+}^{\mu,\nu;\psi} \phi \right|^{\kappa(\xi)} d\xi$. Note that, $\mathfrak{M}(t) \geq a > 0$ and taking $\omega = \frac{4}{5}$, yields

$$\widehat{\mathfrak{M}}(t) = \int_0^t \mathfrak{M}(s) ds = at + \frac{b}{2}t^2 \ge \frac{1}{2} \left(a + bt \right) t \ge \frac{1}{5} \left(a + bt \right) t = (1 - \omega) \mathfrak{M}(t) t.$$

Therefore, the conditions (C_0) and (C_1) are satisfied. In this sense, as a consequence of Theorem 1.1, Theorem 1.2, Theorem 1.3 and Theorem 1.4, we have the following corollaries, namely:

Corollary 4.1. If \mathfrak{M} satisfies (C_0) and $|\mathfrak{g}(\xi,t)| \leq A_1 + A_2 |t|^{\beta-1}$, where $1 \leq \beta < \kappa^-$, then problem (4.1) has a weak solution.

Corollary 4.2. If \mathfrak{M} satisfies (C_0) and (C_1) , and f satisfies (f_0) , (f_1) and (f_2) , where $\zeta^- > \kappa^+$, then problem (4.1) has a nontrivial solution.

Corollary 4.3. Assume that the conditions (C_0) , (C_1) , (f_0) , (f_1) and (f_3) hold. Then, problem (4.1) has a sequence of solutions $\{\pm\phi_k\}_{k=1}^{+\infty}$ such that $\mathfrak{E}(\pm\phi_k) \to +\infty$ as $k \to +\infty$.

Corollary 4.4. Assume that the conditions (C_0) , (C_1) , (f_0) , (f_1) , (f_3) and (f_4) hold. Then, problem (4.1) has a sequence of solutions $\{\pm \phi_k\}_{k=1}^{+\infty}$ such that $\mathfrak{E}(\pm \phi_k) \to +\infty$ as $k \to +\infty$.

Remark 1. Note that, we can take other functions with respect to $\mathfrak{M}(t)$ and t in Eq.(4.1) and get other versions of Kirchhoff-type problems, that is:

- $\mathfrak{M}(t) = a + bt$ with $t = \int_{\Lambda} \frac{1}{\kappa} \left| {}^{\mathrm{H}}\mathfrak{D}_{0+}^{\mu,\nu;\psi} \phi \right|^{\kappa} d\xi$.
- $\mathfrak{M}(t) = bt$ with $t = \int_{\Lambda} \frac{1}{\kappa(\xi)} \left| {}^{\mathrm{H}} \mathfrak{D}_{0+}^{\mu,\nu;\psi} \phi \right|^{\kappa(\xi)} d\xi$. Note that it also holds for $\kappa(\xi) = \kappa$.
- Note that, we only discuss the special cases above, starting from the particular choice of $\mathfrak{M}(t) = bt$, t and $\kappa(\xi)$. However, it is also possible to obtain and discuss other special cases, through the limits of $\beta \to 0$, $\beta \to 1$ and the function $\psi(\cdot)$.

Kirchhoff-type problems are of great interest, in particular, in recent years an approach involving fractional operators has gained prominence. After the results investigated above, some future questions can be addressed, namely:

- Discuss the same objectives of the present article for Kirchhoff-type problems with double phase.
- Another investigation possibility is to modify the problem boundary condition (1.1), to Neumann boundary.
