# ENUMERATION OF SETS OF EQUIANGULAR LINES WITH COMMON ANGLE  $\arccos(1/3)$

ABSTRACT. In 2018, Szöllősi and Östergård enumerated some sets of equiangular lines with common angle  $arccos(1/3)$ with a computer. Furthermore, they verified that the numbers  $\omega(n)$  of sets of n equiangular lines with common angle  $\arccos(1/3)$  in dimension 7 are almost symmetric around  $n = 14$ . In this paper, we construct the other sets of equiangular lines with common angle  $arccos(1/3)$  from root lattices of type A or D with the aid of switching roots. In addition, we prove that the numbers  $\omega(n)$  are almost symmetric without a computer.

### 1. INTRODUCTION

<span id="page-0-0"></span>A set of lines through the origin in a Euclidean space is *equiangular* if any pair from these lines forms the same angle. Let  $N(d)$  be the maximum cardinality of a set of equiangular lines in dimension d. The problem of determining the values of  $N(d)$  has been under consideration since 1948 [\[8\]](#page-10-0). The values or bounds of  $N(d)$  are known for  $d \leq$ 43 [\[1,](#page-10-1) [5,](#page-10-2) [7,](#page-10-3) [6,](#page-10-4) [8,](#page-10-0) [10,](#page-10-5) [14\]](#page-10-6) as in Table [1.](#page-0-0) A general upper bound  $N(d) \leq d(d+1)/2$  was proved by Lemmens and





Seidel [\[10,](#page-10-5) Theorem 3.5]. Also, a general lower bound  $(32d^2 + 328d + 29)$  /1089 was proved by Greaves et al. [\[4,](#page-10-7) Corollary 2.8].

Let  $N_{\alpha}(d)$  be the maximum cardinality of a set of equiangular lines with angle arccos( $\alpha$ ) in dimension d. The problem of determining  $N_{\alpha}(d)$  is important to determine  $N(d)$ . In 1966, van Lint and Seidel proved the so-called relative bound  $N_\alpha(d) \leq d(1-\alpha^2)/(1-d\alpha^2)$  for  $d < 1/\alpha^2$  [\[14,](#page-10-6) p. 342]. Since  $1/\alpha$  is an odd integer if  $N_\alpha(d) >$ 2d [\[10,](#page-10-5) Theorem 3.4], the values of  $N_\alpha(d)$  where  $1/\alpha$  is an odd integer have been studied. In 1973, Lemmens and Seidel determined the values of  $N_{1/3}(d)$  for all d [\[10,](#page-10-5) Theorem 3.6]. In addition, they posed the so-called Lemmens-Seidel conjecture, which claims  $N_{1/5}(d) = \max\{276, \lfloor(3d-3)/2\rfloor\}$  for  $d \geq 23$ . This was shown by the works of Lemmens and Seidel [\[10\]](#page-10-5), Cao et al. [\[2\]](#page-10-8) and Yoshino [\[15\]](#page-10-9). In 2021, Jiang et al. proved for every integer  $k \geq 2$ ,  $N_{1/(2k-1)}(d) = |k(d-1)/(k-1)|$  for all sufficiently large d [\[9,](#page-10-10) Corollary 1.3].

In this paper, we investigate the enumeration and structure of sets of equiangular lines with common angle  $arccos(1/3)$ . In 2018, Szöllősi and Östergård [\[13\]](#page-10-11) with a computer enumerated the sets of  $n$  equiangular lines with common angle  $\arccos(1/3)$  for  $n \le 13$ . As a result, they determined  $s(n)$  and  $s_e(n)$  for  $n \le 13$  as in Table [2.](#page-0-1) Here,  $s(n)$  is the number of sets of n equiangular lines with common angle  $arccos(1/3)$ , and  $s_e(n)$  is the number of those in dimension less than n. Additionally, they enumerated the sets of n equiangular lines with common angle  $arccos(1/3)$  in dimension 7 for

every  $n \leq N_{1/3}(7) = 28$  with a computer, and determined the number  $\omega(n)$  of them as in Table [3.](#page-1-0) Then, they noticed that the numbers  $\omega(n)$  are symmetric around  $n = 14$  except for  $n = 6, 22$ . Note that we treat the empty set as the set of equiangular lines of cardinality 0. In 2020, Lin and Yu [\[11\]](#page-10-12) employed a computational approach to determine the

maximal sets of equiangular lines with common angle  $arccos(1/3)$  exactly in dimension 8. After that, Cao et al. [\[2\]](#page-10-8) introduced the concept of switching roots, and classified the maximal sets of equiangular lines with common angle  $arccos(1/3)$  due to the containment relation among root lattices.

In this study, we use switching roots as in [\[2\]](#page-10-8), and apply more precise results on root lattices. In the first half, we consider the orbits of some sets of roots of a root lattice under the left action of the Weyl group. As a result, we obtain the first main result Theorem [6.1,](#page-7-0) which enumerates the sets of equiangular lines with common angle  $arccos(1/3)$ other than those in dimension 7, and have the following corollary.

<span id="page-1-3"></span>**Corollary 1.1.** *For an integer n*,  $s(n) = s_e(n) + 2$  *if*  $n \ge 8$ *, and* 

$$
s(n) = \begin{cases} \omega(n) & \text{if } 0 \le n \le 7, \\ \omega(n) + n - 6 & \text{if } 8 \le n \le 12, \\ \omega(n) + \lfloor \frac{n}{2} \rfloor + 1 & \text{if } 13 \le n. \end{cases}
$$

In the second half, we prove the second main result Theorem [8.4,](#page-9-0) which shows that the orbits of some sets of roots of  $E_8$  correspond almost one-to-one with the sets of equiangular lines with common angle  $arccos(1/3)$  in dimension 7. Here  $E_8$  is the root lattice of rank 8 and type E. Furthermore, we see that  $\omega(n)$  is almost symmetric around  $n = 14$ as in Corollary [1.2](#page-1-1) without a computer.

<span id="page-1-1"></span>**Corollary 1.2.**  $\omega(n) = \omega(28 - n)$  *for*  $n \in \{0, \ldots, 28\} \setminus \{6, 22\}$ *, and*  $\omega(6) + 1 = \omega(22)$ *.* 

Note that throughout this paper, we will consider Seidel matrices instead of sets of equiangular lines. See Section [2](#page-1-2) for the relation between them and the definition of Seidel matrices.

This paper is organized as follows. In Section [2,](#page-1-2) we introduce some notations for graphs and Seidel matrices. In Section [3,](#page-2-0) we introduce basic definitions for root lattices. In Section [4,](#page-3-0) we introduce some results on switching roots. In Section [5,](#page-3-1) we prepare lemmas to prove the main results. In Section [6,](#page-7-1) we prove the first main result Theorem [6.1,](#page-7-0) and have Corollary [1.1.](#page-1-3) In Section [7,](#page-7-2) we consider the isometries from a root lattice to  $E_8$  in order to prove the second main result. In Section [8,](#page-8-0) we prove the second main result Theorem [8.4,](#page-9-0) and show Corollary [1.2.](#page-1-1)

## 2. NOTATIONS

<span id="page-1-2"></span>Throughout this paper, we will consider undirected graphs without loops and multiedges. Let G be a graph. Denote by  $V(G)$  the set of vertices, and by  $E(G)$  the set of edges. For two vertices x and y of G, we write  $x \sim y$  if  $\{x, y\} \in E(G)$ . Denote by  $A(G)$  the adjacency matrix of G.

Denote by j the all-one vector, and by  $e_i$  the vector of which the *i*-th entry is 1 and the others are 0. Denote by I and J the identity matrix and the all-one matrix, respectively.

**Definition 2.1.** A *Seidel matrix* is a symmetric matrix with zero diagonal and all off-diagonal entries  $\pm 1$ . For two Seidel matrices S and S', write  $S \sim_{sw} S'$  and say S and S' are *switching equivalent* if there exists a signed permutation matrix P such that  $P^{\top}SP = S'$  holds. In addition, write [S] for the set of Seidel matrices switching equivalent to a Seidel matrix S, and call it the *switching class* of S. For a graph G, define  $S(G) := J - I - 2A(G)$ . Two graphs G and H are said to be *switching equivalent* if  $S(G)$  and  $S(H)$  are switching equivalent.

Note that for any Seidel matrix S, there exists a graph G such that  $S = S(G)$ . Also, note that if G and H are switching equivalent, then H is isomorphic to  $G^U$  for some  $U \subset V(G)$ . Here the graph  $G^U$  is defined as  $V =$  $V(G^U) := V(G)$  and

$$
x \sim y \text{ in } G^U: \iff \begin{cases} x \sim y \text{ in } G & \text{ if } \{x, y\} \subset U \text{ or } \{x, y\} \subset V \setminus U, \\ x \not\sim y \text{ in } G & \text{ if } \{x, y\} \not\subset U \text{ and } \{x, y\} \not\subset V \setminus U \end{cases}
$$

for  $x \neq y \in V$ .

We explain the relation between sets of equiangular lines and Seidel matrices. Fix a set  $U$  of  $n$  equiangular lines with common angle  $arccos(\alpha)$  in dimension d. Then we may take unit vectors  $\mathbf{u}_1, \dots, \mathbf{u}_n \in \mathbb{R}^d$  such that  $U =$  $\{\mathbb{R}u_1, \ldots, \mathbb{R}u_n\}$ . There exists a Seidel matrix S such that  $I - \alpha S$  equals the Gram matrix of  $u_1, \ldots, u_n$ . Hence the set U of equiangular lines induces the Seidel matrix S with largest eigenvalue at most  $1/\alpha$  and rank $(I - \alpha S) \le d$  up to switching. In addition, it induces the graph G with  $S = S(G)$  up to switching. Conversely, we can recover U from the Seidel matrix  $S$  or the graph  $G$ .

By this relation, we see that  $s(n)$  is the number of Seidel matrices of order n with largest eigenvalue at most 3 up to switching,  $s_e(n)$  is the number of those with largest eigenvalue equal to 3 up to switching, and  $\omega(n)$  is the number of those with largest eigenvalue at most 3 and rank $(3I - S) \le 7$  up to switching.

### 3. ROOT LATTICES

<span id="page-2-0"></span>In this section, we introduce basic definitions for lattices. For a reference, see [\[3\]](#page-10-13). In this paper, we will mainly treat root lattices.

**Definition 3.1.** A *lattice* is the set L of integral linear combinations of some R-linearly independent vectors  $u_1, \ldots, u_m \in$  $\mathbb{R}^n$  ( $m \leq n$ ), that is,

$$
\mathsf{L}=\mathbb{Z}\mathbf{u}_1\oplus\cdots\oplus\mathbb{Z}\mathbf{u}_m.
$$

This lattice is written as  $\langle u_1, \ldots, u_m \rangle$ . In this case, m is called the *rank* of the lattice L. Also, denote by  $(u, v)$  the inner product of two vectors u and v. A lattice L is said to be *integral* if  $(u, v) \in \mathbb{Z}$  for any  $u, v \in L$ . For each vector u, we call  $(\mathbf{u}, \mathbf{u})$  the *norm* of **u**.

**Definition 3.2.** A  $\mathbb{Z}$ -linear injection  $f : L \to M$  between two lattices L and M is called an *isometry* if

$$
(f(\mathbf{u}), f(\mathbf{v})) = (\mathbf{u}, \mathbf{v})
$$

for any  $u, v \in L$ . Two lattices L and M are said to be *isometric* if there is a bijective isometry between them. An isometry from a lattice L to itself is called an *automorphism* of L. The *automorphism group*, denoted by Aut(L), of a lattice L is defined to be the set of automorphisms of L.

A lattice L is said to be *reducible* if it is the orthogonal direct sum of two nonzero lattices. Otherwise it is said to be *irreducible*.

Definition 3.3. A vector of norm 2 in a lattice is called a *root*, and an integral lattice generated by roots is called a *root lattice*.

It is known that the irreducible root lattices are enumerated up to bijective isometry as follows (cf. [\[3,](#page-10-13) Theorem 1.2]).

$$
A_n := \{ \mathbf{v} \in \mathbb{Z}^{n+1} \mid (\mathbf{v}, \mathbf{j}) = 0 \} \quad (n \in \mathbb{Z}_{\ge 1}),
$$
  
\n
$$
D_n := \{ \mathbf{v} \in \mathbb{Z}^n \mid (\mathbf{v}, \mathbf{j}) \in 2\mathbb{Z} \} \quad (n \in \mathbb{Z}_{\ge 4}),
$$
  
\n
$$
E_8 := D_8 \sqcup (\mathbf{j}/2 + D_8),
$$

E_7 := \{ \mathbf{v} \in E_8 \mid (\mathbf{v}, \mathbf{e}_1 - \mathbf{e}_2) = 0 \},

E_6 := \{ \mathbf{v} \in E_8 \mid (\mathbf{v}, \mathbf{e}_1 - \mathbf{e}_2) = (\mathbf{v}, \mathbf{e}_2 - \mathbf{e}_3) = 0 \}.

Definition 3.4. Let

$$
\mathcal{E} := \{A_n : n = 1, \ldots, 8\} \cup \{D_n : n = 4, \ldots, 8\} \cup \{E_6, E_7, E_8\}
$$

and

$$
\mathcal{L} := \{A_n : n \geq 1\} \cup \{D_n : n \geq 4\} \cup \{E_6, E_7, E_8\}.
$$

The *Weyl group*  $W(L)$  of a root lattice L is the subgroup of  $Aut(L)$  generated by all the reflections  $s_r$  corresponding to roots r, where  $s_{\mathbf{r}}(\mathbf{x}) = \mathbf{x} - 2(\mathbf{x}, \mathbf{r})/(\mathbf{r}, \mathbf{r})\mathbf{r}$ .

<span id="page-2-1"></span>Lemma 3.5 ([\[3,](#page-10-13) Lemma 1.10]). *The Weyl group of an irreducible root lattice acts transitively on the set of its roots.*

### 4. SWITCHING ROOTS

<span id="page-3-0"></span>Cao et al. [\[2\]](#page-10-8) introduced the concept of switching roots and described it. It provided a novel method to construct lattices from Seidel matrices. In this section, we describe fundamental results related to it.

**Definition 4.1.** The *cone*  $\tilde{G}$  over a graph  $G$  is defined to be the graph obtained by adding a new vertex to  $G$  and connecting it to all the vertices of G.

<span id="page-3-7"></span><span id="page-3-3"></span><span id="page-3-2"></span>Theorem 4.2 ([\[2,](#page-10-8) Corollary 2.4]). *For every graph* G*, the following are equivalent.*

- (i) *The Seidel matrix* S(G) *has largest eigenvalue at most* 3*.*
- (ii) *The adjacency matrix*  $A(\tilde{G})$  *of the cone*  $\tilde{G}$  *over* G *has smallest eigenvalue at least* −2*.*

*Furthermore, if* [\(i\)](#page-3-2) *or* [\(ii\)](#page-3-3) *holds, then*  $\text{rank}(3I - S(G)) + 1 = \text{rank}(A(\tilde{G}) + 2I)$ .

In this theorem, if [\(ii\)](#page-3-3) holds, then there exist roots  $u_1, \ldots, u_n$ , r of which the Gram matrix is  $A(\tilde{G}) + 2I$ , where n is the order of G. Here, r corresponds to the new vertex of  $\tilde{G}$  added to G. This root r is called a *switching root*.

**Definition 4.3.** Let L be an irreducible root lattice, and r a root in L. Let  $N_r(L)$  be the set of roots  $u \in L$  with  $(u, r) = 1$ . Define the equivalence relation  $\sim_r$  on the set R of roots in L such that for  $u, v \in R$ ,  $u \sim_r v$  if and only if  $u = v$  or  $u = r - v$ . Define  $[u]_r := \{u, r - u\}.$ 

In this definition, note that the set  $[u]_r$  is the equivalence class of u under  $\sim_r$ . For a set A and a non-negative integer *n*, denote by  $\binom{A}{n}$  the set of *n*-subsets of *A*.

**Remark 4.4.** Let L be an irreducible root lattice, and r a root. We remark that for any roots  $u, v \in N_r(L)$ ,

$$
(\mathbf{u}, \mathbf{v}) = \begin{cases} 2 & \text{if } \mathbf{u} = \mathbf{v}, \\ -1 & \text{if } \mathbf{u} = \mathbf{r} - \mathbf{v}, \\ 0, 1 & \text{otherwise.} \end{cases}
$$

Hence, if

$$
\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\}\in \binom{N_{\mathbf{r}}(L)/\sim_{\mathbf{r}}}{n},
$$

then the Gram matrix of  $\mathbf{u}_1, \ldots, \mathbf{u}_n$  equals  $A(G)+2I$  for some graph G. Furthermore, the Gram matrix of  $\mathbf{u}_1, \ldots, \mathbf{u}_n$ , r equals  $A(\tilde{G}) + 2I$ .

The following is necessary to associate a switching class with a lattice. The Lemma [4.5](#page-3-4) [\(i\)](#page-3-5) has been essentially claimed after [\[2,](#page-10-8) Definition 2.1]. Also, Lemma [4.5](#page-3-4) [\(ii\)](#page-3-6) is clearly true.

<span id="page-3-5"></span><span id="page-3-4"></span>**Lemma 4.5.** Let G be a graph such that there are vectors  $u_1, \ldots, u_n$ , r of which the Gram matrix is  $A(\tilde{G}) + 2I$ . Here *the vector* r *corresponds to the added vertex to* G*.*

(i) *We have the surjection*

$$
\begin{array}{ccc} [\mathbf{u}_1]_\mathbf{r} \times \cdots \times [\mathbf{u}_n]_\mathbf{r} & \to & [G] \\ (\mathbf{v}_1, \ldots, \mathbf{v}_n) & \mapsto & H \end{array}
$$

<span id="page-3-6"></span>*where*  $A(H) + 2I$  *is the Gram matrix of*  $\mathbf{v}_1, \ldots, \mathbf{v}_n$ *.* (ii) *For any*  $(\mathbf{v}_1, \dots, \mathbf{v}_n) \in [\mathbf{u}_1]_{\mathbf{r}} \times \dots \times [\mathbf{u}_n]_{\mathbf{r}}$ *, we have*  $\langle \mathbf{u}_1, \dots, \mathbf{u}_n, \mathbf{r} \rangle = \langle \mathbf{v}_1, \dots, \mathbf{v}_n, \mathbf{r} \rangle$ *.* 

## 5. SEIDEL MATRICES AND ROOT LATTICES

<span id="page-3-1"></span>In order to consider the numbers  $s(n)$ ,  $s_e(n)$  and  $\omega(n)$ , we prepare some sets  $\mathcal{S}^{(n)}$ ,  $\mathcal{S}_e^{(n)}$  and  $\Omega^{(n)}$ . In this section, we discuss various relations between these sets and root lattices.

**Definition 5.1.** Let *n* be a non-negative integer. Let  $\mathcal{S}^{(n)}$  be the set of Seidel matrices of order *n* with largest eigenvalue at most 3. Let  $\mathcal{S}_e^{(n)}$  be the set of Seidel matrices of order n with largest eigenvalue equal to 3. Let  $\Omega^{(n)}$  be the subset of Seidel matrices  $S \in \mathcal{S}^{(n)}$  with  $\text{rank}(3I - S) \le 7$ , and set  $\Omega_e^{(n)} := \Omega_n^{(n)} \cap S_e^{(n)}$ .

We have  $s(n) := |\mathcal{S}^{(n)}| \sim_{\text{sw}} |$ ,  $s_e(n) := |\mathcal{S}^{(n)}_e| / \sim_{\text{sw}} |$  and  $\omega(n) := |\Omega^{(n)}| / \sim_{\text{sw}} |$  as noted in Section [2.](#page-1-2)

5.1. Decomposition of the sets  $S^{(n)}$  into sets  $S^{(n)}(L)$ . We prepare more sets  $S^{(n)}(L)$  coming from root lattices, and decompose the sets  $S^{(n)}$  into sets  $S^{(n)}(L)$ .

**Definition 5.2.** Let L be an irreducible root lattice, and n a non-negative integer. Let  $S^{(n)}(L)$  denote the set of Seidel matrices  $S(G)$  where the graph G satisfies that the Gram matrix of some generator of L is  $A(\tilde{G}) + 2I$ .

**Example 5.3.** For example,  $S(K_3) \in S^{(3)}(A_4)$  holds, where  $K_3$  is the complete graph of order 3. Indeed, the Gram matrix of a generator  $e_1 - e_2$ ,  $e_1 - e_3$ ,  $e_1 - e_4$  and  $e_1 - e_5$  of  $A_4$  is  $A(\tilde{K_3}) + 2I = A(K_4) + 2I$ .

<span id="page-4-0"></span>**Lemma 5.4.** *If a root lattice* L *has a generator of which the Gram matrix is*  $A(\tilde{G}) + 2I$  *for some graph G*, *then* L *is irreducible.*

*Proof.* Fix a generator X of L of which the Gram matrix is  $A(\tilde{G}) + 2I$  for some graph G. Assume that there are two lattices  $L_1$  and  $L_2$  such that  $L = L_1 \perp L_2$ . Then,  $X = (X \cap L_1) \sqcup (X \cap L_2)$ . Since the cone  $\tilde{G}$  is connected, we see that either  $X = X \cap L_1$  or  $X = X \cap L_2$  holds. Hence either  $L = L_1$  or  $L = L_2$  holds. This means that L is irreducible.

<span id="page-4-6"></span>By Theorem [4.2](#page-3-7) and Lemma [5.4,](#page-4-0) we obtain the following.

<span id="page-4-2"></span><span id="page-4-1"></span>Lemma 5.5. *Let* n *and* r *be non-negative integers. Let* S *be a Seidel matrix. The following are equivalent.*

(i)  $S \in \mathcal{S}^{(n)}$  and rank $(3I - S) = r$  *hold.* 

(ii)  $S \in \mathcal{S}^{(n)}(\mathsf{L})$  *holds for some*  $\mathsf{L} \in \mathcal{L}$  *with* rank( $\mathsf{L}$ ) =  $r + 1$ *.* 

*In particular, the following are equivalent.*

(iii)  $S \in \mathcal{S}_e^{(n)}$ . (iv)  $S \in \mathcal{S}^{(n)}(\mathsf{L})$  *holds for some*  $\mathsf{L} \in \mathcal{L}$  *with* rank( $\mathsf{L} \leq n$ .

*Proof.* Let G be a graph with  $S = S(G)$ . First, we show that [\(i\)](#page-4-1) and [\(ii\)](#page-4-2) are equivalent. By Theorem [4.2,](#page-3-7) (i) is equivalent to saying that  $A(G)$  has smallest eigenvalue at least  $-2$  and satisfies rank $(A(G) + 2I) = r + 1$ . It is equivalent to saying that there are roots  $\mathbf{v}_1, \dots, \mathbf{v}_n, \mathbf{v}_0$  of which the Gram matrix is  $A(\tilde{G}) + 2I$  with rank $\langle \mathbf{v}_1, \dots, \mathbf{v}_n \mathbf{v}_0 \rangle = r + 1$ . We see by Lemma [5.4](#page-4-0) that  $L := \langle v_1, \ldots, v_n v_0 \rangle$  is an irreducible root lattice of rank  $r + 1$ . Here, we may assume  $L \in \mathcal{L}$  (cf. [\[3,](#page-10-13) Theorem 1.2]). Hence, we conclude that [\(i\)](#page-4-1) is equivalent to [\(ii\).](#page-4-2) Next, we show that (iii) and (iv) are equivalent. Indeed,

$$
S \in \mathcal{S}_e^{(n)} \iff S \in \mathcal{S}^{(n)} \text{ and } \text{rank}(3I - S) \le n - 1
$$
  

$$
\iff S \in \mathcal{S}^{(n)}(\mathsf{L}) \text{ for some } \mathsf{L} \in \mathcal{L} \text{ with } \text{rank}(\mathsf{L}) \le n.
$$

This is the desired conclusion.  $\Box$ 

<span id="page-4-3"></span>This lemma immediately implies the following.

Lemma 5.6. *Let* n *be a non-negative integer. Then*

$$
\Omega^{(n)} := \bigsqcup_{\mathsf{L} \in \mathcal{E}} \mathcal{S}^{(n)}(\mathsf{L}) \quad \text{ and } \quad \Omega_e^{(n)} := \bigsqcup_{\mathsf{L} \in \mathcal{E} \text{ with } \mathrm{rank}(\mathsf{L}) \leq n} \mathcal{S}^{(n)}(\mathsf{L}).
$$

*Also,*

$$
\mathcal{S}^{(n)} = \bigsqcup_{\mathsf{L}\in\mathcal{L}} \mathcal{S}^{(n)}(\mathsf{L}) = \Omega^{(n)} \sqcup \left(\bigsqcup_{\mathsf{L}\in\mathcal{L}\backslash\mathcal{E}} \mathcal{S}^{(n)}(\mathsf{L})\right)
$$

*and*

$$
\mathcal{S}_e^{(n)} = \bigsqcup_{\mathsf{L}\in\mathcal{L} \text{ with } \mathrm{rank}(\mathsf{L})\leq n} \mathcal{S}^{(n)}(\mathsf{L}) = \Omega_e^{(n)} \sqcup \left(\bigsqcup_{\mathsf{L}\in\mathcal{L}\setminus\mathcal{E} \text{ with } \mathrm{rank}(\mathsf{L})\leq n} \mathcal{S}^{(n)}(\mathsf{L})\right).
$$

<span id="page-4-5"></span>Lemma 5.7. *For a non-negative integer* n*,*

$$
S^{(n)}/\sim_{\rm sw} = \bigsqcup_{\mathsf{L}\in\mathcal{L}} S^{(n)}(\mathsf{L})/\sim_{\rm sw} = \Omega^{(n)}/\sim_{\rm sw} \sqcup \left(\bigsqcup_{\mathsf{L}\in\mathcal{L}\backslash\mathcal{E}} S^{(n)}(\mathsf{L})/\sim_{\rm sw}\right)
$$
(5.1)

*and*

<span id="page-5-3"></span>
$$
S_e^{(n)}/\sim_{\rm sw} = \bigsqcup_{\mathsf{L}\in\mathcal{L}\,\text{with rank}(\mathsf{L})\leq n} \mathcal{S}^{(n)}(\mathsf{L})/\sim_{\rm sw} \mathcal{S}^{(n)}/\sim_{\rm sw} \mathcal{L}\left(\bigsqcup_{\mathsf{L}\in\mathcal{L}\setminus\mathcal{E}\,\text{with rank}(\mathsf{L})\leq n} \mathcal{S}^{(n)}(\mathsf{L})/\sim_{\rm sw}\right). \tag{5.2}
$$

*Proof.* By Lemma [5.6,](#page-4-3) it suffices to show that  $S' \in S^{(n)}(\mathsf{L})$  holds for any  $S \in S^{(n)}(\mathsf{L})$  and  $S' \in [S]$ . There exist two graphs G and H such that  $S = S(G)$  and  $S' = S(H)$ . By definition, there exist vectors  $\mathbf{u}_1, \dots, \mathbf{u}_n$ , r of which the Gram matrix is  $A(\tilde{G}) + 2I$  such that  $L = \langle \mathbf{u}_1, \ldots, \mathbf{u}_n, \mathbf{r} \rangle$ . By Lemma [4.5](#page-3-4) [\(i\),](#page-3-5) there exist  $\mathbf{v}_i \in [\mathbf{u}_i]_{\mathbf{r}}$  $(i = 1, \ldots, n)$  of which the Gram matrix is  $A(H) + 2I$ . By Lemma [4.5](#page-3-4) [\(ii\),](#page-3-6) we have  $\langle v_1, \ldots, v_n, r \rangle$  is equal to L. Hence,  $S' = S(H) \in \mathcal{S}^{(n)}$  $(L)$  holds.

5.2. Construction of the sets  $S^{(n)}(L)$ . Let L be an irreducible root lattice, and r a root of L. The stabilizer subgroup  $W(L)$ <sub>r</sub> of the root r in the Weyl group  $W(L)$  acts on  $N_r(L)/\sim_r$  in such a way that  $w([u]_r) := [w(u)]_r$  for  $w \in W(L)_r$ and  $[\mathbf{u}]_{\mathbf{r}} = {\mathbf{u}, \mathbf{r} - \mathbf{u}} \in N_{\mathbf{r}}(L) / \sim_r$ , where  $\mathbf{u} \in N_{\mathbf{r}}(L)$ . Furthermore, the stabilizer subgroup  $W(L)_{\mathbf{r}}$  naturally acts on  $\binom{N_{\mathbf{r}}(\mathsf{L})/\sim_{\mathbf{r}}}{n}$ .

We show that for each irreducible root lattice L, the mapping  $\phi_{L,r}^{(n)}$  in the following definition can construct all the switching classes in  $S^{(n)}(\mathsf{L})/\sim_{\mathrm{sw}}$ .

**Definition 5.8.** Let n be a non-negative integer. Let L be an irreducible root lattice, and r a root in L. Define

$$
N_{\mathbf{r}}^{(n)}(\mathsf{L}) := \left\{ \{[\mathbf{u}_1]_{\mathbf{r}}, \ldots, [\mathbf{u}_n]_{\mathbf{r}}\} \in \binom{N_{\mathbf{r}}(\mathsf{L})/\sim_{\mathbf{r}}}{n} : \mathsf{L} = \langle \mathbf{u}_1, \ldots, \mathbf{u}_n, \mathbf{r} \rangle \right\}.
$$

The stabilizer subgroup  $W(L)$ <sub>r</sub> of the root r in the Weyl group  $W(L)$  naturally acts on  $N_{\mathbf{r}}^{(n)}(L)$ . Define

$$
\phi_{\mathsf{L},\mathbf{r}}^{(n)}: \quad W(\mathsf{L})_{\mathbf{r}} \setminus N_{\mathbf{r}}^{(n)}(\mathsf{L}) \quad \to \quad \mathcal{S}^{(n)}(\mathsf{L})/\sim_{\text{sw}}\\ W(\mathsf{L})_{\mathbf{r}}\{\left[\mathbf{u}_1\right]_{\mathbf{r}},\ldots,\left[\mathbf{u}_n\right]_{\mathbf{r}}\} \quad \mapsto \quad \quad [S(G)]
$$

where  $A(G) + 2I$  is the Gram matrix of  $\mathbf{u}_1, \dots, \mathbf{u}_n$ .

**Remark 5.9.** We verify that the mapping  $\phi_{L,r}^{(n)}$  is well-defined. First, we see by definition that

$$
[S(G)] \in \mathcal{S}^{(n)}(\mathsf{L})/\sim_{\text{sw}} \text{ for every } W(\mathsf{L})_{\mathbf{r}}\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\} \in W(\mathsf{L})_{\mathbf{r}}\setminus N_{\mathbf{r}}^{(n)}(\mathsf{L})
$$

where  $A(G) + 2I$  is the Gram matrices of  $\mathbf{u}_1, \dots, \mathbf{u}_n$ .

Next, we verify that if

$$
W(\mathsf{L})_{\mathbf{r}}\{[\mathbf{u}_{1}]_{\mathbf{r}},\ldots,[\mathbf{u}_{n}]_{\mathbf{r}}\}=W(\mathsf{L})_{\mathbf{r}}\{[\mathbf{v}_{1}]_{\mathbf{r}},\ldots,[\mathbf{v}_{n}]_{\mathbf{r}}\}\in W(\mathsf{L})_{\mathbf{r}}\backslash N_{\mathbf{r}}^{(n)}(\mathsf{L}),\tag{5.3}
$$

then  $[S(G)] = [S(H)]$ , where  $A(G) + 2I$  and  $A(H) + 2I$  are the Gram matrices of  $u_1, \ldots, u_n$  and  $v_1, \ldots, v_n$ , respec-tively. Indeed, we assume [\(5.3\)](#page-5-0). Then there exists  $w \in W(L)_{\mathbf{r}}$  such that  $\{[\mathbf{v}_1]_{\mathbf{r}}, \ldots, [\mathbf{v}_n]_{\mathbf{r}}\} = w(\{[\mathbf{u}_1]_{\mathbf{r}}, \ldots, [\mathbf{u}_n]_{\mathbf{r}}\})$ . This means

$$
\{[\mathbf{v}_1]_\mathbf{r},\ldots,[\mathbf{v}_n]_\mathbf{r}\}=\{[w(\mathbf{u}_1)]_\mathbf{r},\ldots,[w(\mathbf{u}_n)]_\mathbf{r}\}.
$$

<span id="page-5-1"></span>By Lemma [4.5](#page-3-4) [\(i\),](#page-3-5) the graph H is switching equivalent to G. Hence, we have  $|S(H)| = |S(G)|$  as desired.

**Lemma 5.10.** Let n be a non-negative integer. Let L be an irreducible root lattice, and **r** a root in L. Then  $\phi_{L,r}^{(n)}$  is *surjective.*

*Proof.* Fix  $[S] \in S^{(n)}(\mathsf{L})/\sim_{\text{sw}}$ . By the definition of  $S^{(n)}(\mathsf{L})$ , there exist a graph G with  $S = S(G)$  and a generator  $\mathbf{u}_1,\ldots,\mathbf{u}_n,\mathbf{u}_0$  of L such that the Gram matrix of them is  $A(\tilde{G})+2I$ . Here,  $\mathbf{u}_0$  corresponds to the vertex of  $\tilde{G}$  added to G. By Lemma [3.5,](#page-2-1) without loss of generality we may assume  $\mathbf{u}_0 = \mathbf{r}$ . Then we see that  $\{[\mathbf{u}_1]_{\mathbf{r}}, \ldots, [\mathbf{u}_n]_{\mathbf{r}}\} \in N_{\mathbf{r}}^{(n)}(L)$ . Hence,  $W(\mathsf{L})_{\mathbf{r}}\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\}\in W(\mathsf{L})_{\mathbf{r}}\setminus N_{\mathbf{r}}^{(n)}(\mathsf{L})$ . This means that  $\phi_{\mathsf{L},\mathbf{r}}^{(n)}$  is surjective.

# 5.3. Construction of the sets  $S^{(n)}(\mathsf{A}_m)$ .

<span id="page-5-2"></span>**Lemma 5.11.** Let  $n \ge 0$  and  $m \ge 1$  be integers. Let  $\mathbf{r} := \mathbf{e}_m - \mathbf{e}_{m+1} \in A_m$ . Then the set  $W(A_m)_{\mathbf{r}} \setminus N_{\mathbf{r}}^{(n)}(A_m)$  has *only one element*  $W(A_m)_r$  { $[e_i - e_{m+1}]_r : i = 1, ..., m-1$ } *if*  $m = n+1$ *, and it is the empty set otherwise.* 

*Proof.* Assume we can take an element

$$
W(\mathsf{A}_m)_{\mathbf{r}}\left\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\right\}\in W(\mathsf{A}_m)_{\mathbf{r}}\backslash N_{\mathbf{r}}^{(n)}(\mathsf{A}_m).
$$

Then,  $A_m = \langle \mathbf{u}_1, \dots, \mathbf{u}_n, \mathbf{r} \rangle$  holds, and  $n \geq m - 1$  follows. Also, since

$$
N_{\mathbf{r}}(\mathsf{A}_m)/\!\!\sim_{\mathbf{r}}\,=\{[\mathsf{e}_i-\mathsf{e}_{m+1}]_{\mathbf{r}}:i\in\{1,\ldots,m-1\}\}
$$

is of cardinality  $m - 1$ , we have  $n = m - 1$  and

$$
\{[\mathbf{u}_1]_\mathbf{r},\ldots,[\mathbf{u}_n]_\mathbf{r}\}=N_\mathbf{r}(\mathsf{A}_m)/\!\!\sim_\mathbf{r}=\{[\mathsf{e}_i-\mathsf{e}_{m+1}]_\mathbf{r}:i\in\{1,\ldots,m-1\}\}.
$$

<span id="page-6-5"></span>This is the desired result.  $\Box$ 

**Lemma 5.12.** Let  $n \ge 0$  and  $m \ge 1$  be integers. The set  $S^{(n)}(A_m)/\sim_{sw}$  is  $\{[S(K_n)]\}$  if  $m = n + 1$ , and the emptyset *otherwise.*

*Proof.* This follows from Lemmas [5.10](#page-5-1) and [5.11.](#page-5-2) □

<span id="page-6-1"></span>5.4. Construction of the sets 
$$
S^{(n)}(\mathsf{D}_m)
$$
. By the definition of  $\mathsf{D}_m$ , we can verify the following easy fact.

<span id="page-6-2"></span>**Lemma 5.13.** *Let*  $m \geq 4$  *be an integer. The Weyl group*  $W(D_m)$  *contains the following.* 

- <span id="page-6-3"></span>(i) An automorphism that multiplies two distinct coordinates by  $-1$ .
- (ii) *A permutation of the coordinates.*

<span id="page-6-7"></span>**Lemma 5.14.** Let  $n \ge 0$  and  $m \ge 4$  be integers. Let  $\mathbf{r} := \mathbf{e}_{m-1} + \mathbf{e}_m \in \mathsf{D}_m$ . The set  $W(\mathsf{D}_m)_{\mathbf{r}} \setminus N_{\mathbf{r}}^{(n)}(\mathsf{D}_m)$  has only *one element*

$$
W(\mathsf{D}_{m})_{\mathbf{r}}\left(\{[\mathsf{e}_{m}+\mathsf{e}_{i}]_{\mathbf{r}}: i=1,\ldots,m-2\}\sqcup\{[\mathsf{e}_{m}-\mathsf{e}_{i}]_{\mathbf{r}}: i=1,\ldots,n-m+2\}\right)
$$
(5.4)

*if*  $2(m-2) \ge n \ge m-1$ *, and it is the empty set otherwise.* 

*Proof.* Assume we can take an element

$$
W(\mathsf{D}_m)_\mathbf{r}\{[\mathbf{u}_1]_\mathbf{r},\ldots,[\mathbf{u}_n]_\mathbf{r}\}\in W(\mathsf{D}_m)_\mathbf{r}\setminus N_\mathbf{r}^{(n)}(\mathsf{D}_m).
$$

Then, since  $D_m = \langle \mathbf{u}_1, \dots, \mathbf{u}_n, \mathbf{r} \rangle$  by definition, we have  $n \ge m - 1$  and

$$
[\mathbf{e}_m + \mathbf{e}_i]_{\mathbf{r}} \text{ or } [\mathbf{e}_m - \mathbf{e}_i]_{\mathbf{r}} \in \{[\mathbf{u}_1]_{\mathbf{r}}, \dots, [\mathbf{u}_n]_{\mathbf{r}}\} \qquad (i \in \{1, \dots, m-2\}).
$$
\n
$$
(5.5)
$$

Together with  $n \geq m - 1$ ,

$$
N_{\mathbf{r}}(\mathsf{D}_m)/\sim_{\mathbf{r}}=\{[\mathsf{e}_m+\mathsf{e}_i]_{\mathbf{r}},[\mathsf{e}_m-\mathsf{e}_i]_{\mathbf{r}}:i=1,\ldots,m-2\}
$$

implies that

$$
[\mathsf{e}_m+\mathsf{e}_k]_{\mathbf{r}},[\mathsf{e}_m-\mathsf{e}_k]_{\mathbf{r}}\in\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\}
$$

for some  $k \in \{1, \ldots, m-2\}$ . By multiplying two distinct coordinates i and k by  $-1$ , we can change  $[e_m - e_i]$ <sub>r</sub> to  $[e_m + e_i]_r$ . Hence, by [\(5.5\)](#page-6-0) together with Lemma [5.13](#page-6-1) [\(i\),](#page-6-2) we may assume

 $[\mathbf{u}_1]_{\mathbf{r}} = [\mathbf{e}_m + \mathbf{e}_1]_{\mathbf{r}}, \ldots, [\mathbf{u}_{m-2}]_{\mathbf{r}} = [\mathbf{e}_m + \mathbf{e}_{m-1}]_{\mathbf{r}}.$ 

By Lemma [5.13](#page-6-1) [\(ii\),](#page-6-3) we may in addition assume

$$
[\mathbf{u}_{m-1}]_{\mathbf{r}}=[\mathbf{e}_m-\mathbf{e}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}=[\mathbf{e}_m-\mathbf{e}_{n-m+2}]_{\mathbf{r}}.
$$

Hence the element  $W(D_m)_r \left\{[\mathbf{u}_1]_r, \ldots, [\mathbf{u}_n]_r\right\}$  coincides with the element [\(5.4\)](#page-6-4). In particular,  $n - m + 2 \le m - 2$  $holds.$ 

**Definition 5.15.** For non-negative integers  $s \ge t$ , we write  $D_{s,t}$  for the graph obtained from the complete graph  $K_{s+t}$ of order  $s + t$  by removing a matching of size t.

<span id="page-6-6"></span>**Lemma 5.16.** *Let*  $n \ge 0$  *and*  $m \ge 4$  *be integers. The set*  $S^{(n)}(\mathsf{D}_m)$  *is*  $\{[S(D_{m-2,n-m+2})]\}$  *if*  $2(m-2) \ge n \ge m-1$ *, and the emptyset otherwise.*

*Proof.* This follows from Lemmas [5.10](#page-5-1) and [5.11.](#page-5-2) □

### 6. PROOF OF THE FIRST MAIN RESULT

<span id="page-7-1"></span>We prove Theorem [6.1,](#page-7-0) which is the first main result in this paper. Also, since  $s(n) = |\mathcal{S}^{(n)}| \sim_{\text{sw}} |$ ,  $s_e(n) =$  $|S_e^{(n)}/\sim_{\rm sw}|$  and  $\omega(n)=|\Omega^{(n)}/\sim_{\rm sw}|$ , Theorem [6.1](#page-7-0) implies Corollary [1.1.](#page-1-3)

<span id="page-7-0"></span>**Theorem 6.1.** *If*  $n \le 7$ *, then*  $S^{(n)}/\sim_{\text{sw}} = \Omega^{(n)}/\sim_{\text{sw}}$ *, and otherwise* 

$$
S^{(n)}/\sim_{\text{sw}} = \Omega^{(n)}/\sim_{\text{sw}} \sqcup \{ [S(K_n)] \} \sqcup \{ [S(D_{m-2,n-m+2})] : m \in \{ \max\{9, \lceil n/2 \rceil + 2\}, \dots, n+1 \} \}. \tag{6.1}
$$

If  $n \leq 8$ , then  $S_e^{(n)}/\!\sim_{\rm sw} = \Omega_e^{(n)}/\!\sim_{\rm sw}$ , and otherwise

$$
S_e^{(n)} / \sim_{\text{sw}} = \Omega^{(n)} / \sim_{\text{sw}} \sqcup \{ [S(D_{m-2,n-m+2})] : m \in \{ \max\{9, \lceil n/2 \rceil + 2\}, \dots, n\} \}.
$$
 (6.2)

*Proof.* First we prove  $S^{(n)}/\sim_{\rm sw} = \Omega^{(n)}/\sim_{\rm sw}$  if  $n \le 7$ . It suffices to prove  $S^{(n)} \subset \Omega^{(n)}$ . Indeed, we fix  $S \in \mathcal{S}^{(n)}$ . Then by  $n \le 7$ , we have  $\text{rank}(3I - S) \le 7$ . Hence we have  $S \in \Omega^{(n)}$ .

Next we assume  $n \geq 8$ , and show [\(6.1\)](#page-7-3). By Lemmas [5.12](#page-6-5) and [5.16,](#page-6-6) we have

$$
\underset{\mathsf{L}\in\mathcal{L}\backslash\mathcal{E}}{\bigcup_{\mathsf{L}\in\mathcal{L}\backslash\mathcal{E}}}\mathcal{S}^{(n)}(\mathsf{L})/\sim_{\mathrm{sw}}=\mathcal{S}^{(n)}(\mathsf{A}_{n+1})/\sim_{\mathrm{sw}}\sqcup\left(\underset{m\in\{\max\{9,\lceil n/2\rceil+2\},\ldots,n+1\}}{\underset{m\in\{\max\{9,\lceil n/2\rceil+2\},\ldots,n+1\}}{\cup}}\mathcal{S}^{(n)}(\mathsf{D}_{m})/\sim_{\mathrm{sw}}\right)}{\bigcup_{m\in\{\max\{9,\lceil n/2\rceil+2\},\ldots,n+1\}\}}.
$$

Since  $S^{(n)}/\sim_{\text{sw}}$  is decomposed as [\(5.1\)](#page-4-4) by Lemma [5.7,](#page-4-5) we obtain [\(6.1\)](#page-7-3).

By [\(5.2\)](#page-5-3) in Lemma [5.7,](#page-4-5) we have  $S_e^{(n)}/\sim_{\text{sw}} = \Omega_e^{(n)}/\sim_{\text{sw}}$  if  $n \leq 8$ . Next, we assume  $n \geq 9$  and show [\(6.2\)](#page-7-4). Similarly, we have by Lemmas [5.12](#page-6-5) and [5.16](#page-6-6)

$$
\mathop{\bigsqcup}_{\mathsf{L}\in\mathcal{L}\backslash\mathcal{E}\text{ with } \mathrm{rank}(\mathsf{L})\leq n} \mathcal{S}^{(n)}(\mathsf{L})/\sim_{\mathrm{sw}} = \mathop{\bigsqcup}_{m\in\{\max\{9,\lceil n/2\rceil+2\},\ldots,n\}} \mathcal{S}^{(n)}(\mathsf{D}_m)/\sim_{\mathrm{sw}} \\ = \left\{ \left[ S(D_{m-2,n-m+2}) \right] : m\in\{\max\{9,\lceil n/2\rceil+2\},\ldots,n\} \right\}.
$$

<span id="page-7-2"></span>Since  $\Omega_e^{(n)} = \Omega^{(n)}$  holds and the set  $S_e^{(n)}/\sim_{\text{sw}}$  is decomposed as in [\(5.2\)](#page-5-3) by Lemma [5.7,](#page-4-5) we have [\(6.2\)](#page-7-4).

### 7. ISOMETRIES

**Definition 7.1.** Let L and M be root lattices. Denote by Hom(L, M) the set of isometries from L to M. For  $v \in L$  and  $\mathbf{u} \in M$ , define  $Hom((L, \mathbf{v}), (M, \mathbf{u})) := \{f \in Hom(L, M) \mid f(\mathbf{v}) = \mathbf{u}\}.$ 

Note that the automorphism group Aut(M) naturally acts on Hom(L, M) in such a way that  $q_*(f) := q \circ f$  for  $g \in \text{Aut}(\mathsf{M})$  and  $f \in \text{Hom}(\mathsf{L}, \mathsf{M})$ . By Lemma [3.5,](#page-2-1) we have the following lemma.

<span id="page-7-6"></span>**Lemma 7.2.** *Let* L *and* M *be irreducible root lattices. For two roots*  $\mathbf{v} \in L$  *and*  $\mathbf{u} \in M$ *, the mapping* 

$$
W(\mathsf{M})_{\mathbf{u}} \setminus \text{Hom}((\mathsf{L}, \mathbf{v}), (\mathsf{M}, \mathbf{u})) \rightarrow W(\mathsf{M}) \setminus \text{Hom}(\mathsf{L}, \mathsf{M})
$$
  

$$
W(\mathsf{M})_{\mathbf{u}} f \mapsto W(\mathsf{M}) f
$$

*is bijective.*

<span id="page-7-7"></span>We have the following theorem by [\[12,](#page-10-14) Theorem 3.5].

**Theorem 7.3.** Let L be an irreducible root lattice of rank at most 8. The cardinality of  $W(E_8)$  Hom(L,  $E_8$ ) *equals* 2 *if*  $L \in \{A_7, D_8\}$ *, and* 1 *otherwise.* 

7.1. **Isometries from**  $A_7$  **to**  $E_8$ **.** 

**Definition 7.4.** Let  $A'_7 := \langle \{-e_1 - e_2\} \cup \{e_i - e_{i+1} : i = 2, \ldots, 7\} \rangle.$ 

Since the lattice  $A_7$  has a basis  $\{e_i - e_{i+1} : i = 1, ..., 7\}$ , we see that  $A'_7$  and  $A_7$  are isometric.

<span id="page-7-5"></span>**Lemma 7.5.** We have  $W(\mathsf{E}_8) \mathsf{A}_7 \neq W(\mathsf{E}_8) \mathsf{A}_7'$ .

*Proof.* We see that  $A_7^{\perp} \cap E_8 = \langle j/2 \rangle$  and  $A_7^{\perp} \cap E_8 = \langle j - 2e_1 \rangle$  hold. Since the norms of  $j/2$  and  $j - 2e_1$  are 2 and 8, respectively, we obtain  $W(\mathsf{E}_8) \mathsf{A}_7 \neq W(\mathsf{E}_8) \mathsf{A}_7'$ .

<span id="page-7-8"></span>**Lemma 7.6.** *Let*  $r = e_7 - e_8$ *. Then* 

$$
\{W(\mathsf{E}_8)_\mathbf{r} f(\mathsf{A}_7) \mid f \in \mathrm{Hom}((\mathsf{A}_7, \mathbf{r}), (\mathsf{E}_8, \mathbf{r}))\} = \{W(\mathsf{E}_8)_\mathbf{r} \mathsf{A}_7, W(\mathsf{E}_8)_\mathbf{r} \mathsf{A}_7'\}.
$$

<span id="page-7-4"></span><span id="page-7-3"></span>

*Proof.* In this proof, we write *ι* for the inclusion from A<sub>7</sub> to E<sub>8</sub>. Also, we define  $\rho : A_7 \to E_8$  as

$$
\rho(\mathbf{e}_1 - \mathbf{e}_2) = -\mathbf{e}_1 - \mathbf{e}_2 \quad \text{and} \quad \rho(\mathbf{e}_i - \mathbf{e}_{i+1}) = \mathbf{e}_i - \mathbf{e}_{i+1} \quad (i = 2, \dots, 7).
$$
  
Then  $\iota$  and  $\rho$  are in Hom $((\mathsf{A}_7, \mathbf{r}), (\mathsf{E}_8, \mathbf{r}))$ . We have

$$
\{W(\mathsf{E}_8)_\mathbf{r} f(\mathsf{A}_7) \mid f \in \mathrm{Hom}((\mathsf{A}_7, \mathbf{r}), (\mathsf{E}_8, \mathbf{r}))\} \supset \{W(\mathsf{E}_8)_\mathbf{r} \iota(\mathsf{A}_7), W(\mathsf{E}_8)_\mathbf{r} \rho(\mathsf{A}_7)\}
$$

 $\supset$  {*W*(**E**<sub>8</sub>)<sub>**r**</sub>A<sub>7</sub>, *W*(**E**<sub>8</sub>)<sub>**r**</sub>A<sub>7</sub>}.

Also, by Lemma [7.5,](#page-7-5) we have

$$
|\{W(\mathsf{E}_8)_{\mathbf{r}}\mathsf{A}_7,W(\mathsf{E}_8)_{\mathbf{r}}\mathsf{A}'_7\}|=2.
$$

Hence, by Lemma [7.2](#page-7-6) and Theorem [7.3,](#page-7-7) we have

$$
|\{W(\mathsf{E}_8)_\mathbf{r}f(\mathsf{A}_7)\mid f\in \mathrm{Hom}((\mathsf{A}_7,\mathbf{r}),(\mathsf{E}_8,\mathbf{r}))\}|=2.
$$

Therefore, the desired result follows.  $\Box$ 

7.2. Isometries from  $D_8$  to  $E_8$ .

**Definition 7.7.** Let  $\iota$  be the inclusion from D<sub>8</sub> to E<sub>8</sub>. For each  $k \in \{1, \ldots, 8\}$ , we define  $\rho_k : D_8 \to D_8$  as

$$
\rho_k\left(\sum_{i=1}^8 a_i \mathbf{e}_i\right) := -a_k \mathbf{e}_k + \sum_{i=1, i \neq k}^8 a_i \mathbf{e}_i
$$

<span id="page-8-2"></span>**Lemma 7.8.** *For each*  $k \in \{1, \ldots, 8\}$ ,  $W(E_8) \setminus \text{Hom}(L, E_8) = \{W(E_8)\iota, W(E_8)(\iota \circ \rho_k)\}\$  *holds.* 

*Proof.* Since Theorem [7.3](#page-7-7) asserts  $|W(\mathsf{E}_8) \setminus \mathrm{Hom}(\mathsf{D}_8, \mathsf{E}_8)| = 2$ , it suffices to verify

$$
W(\mathsf{E}_8)\iota \neq W(\mathsf{E}_8)(\iota \circ \rho_k). \tag{7.1}
$$

.

By way of contradiction, we assume that there exists  $w \in W(E_8)$  such that  $w \circ \iota = \iota \circ \rho_k$ . Then, we have

$$
w\left(\sum_{i=1}^8 a_i \mathbf{e}_i\right) = -a_k \mathbf{e}_k + \sum_{i=1, i \neq k}^8 a_i \mathbf{e}_i.
$$

Although  $j/2 \in E_8$  holds, we obtain  $w(j/2) = j/2 - e_k \notin E_8$ . This is a contradiction, and hence [\(7.1\)](#page-8-1) follows.  $\square$ 

<span id="page-8-4"></span>From Lemmas [7.2](#page-7-6) and [7.8,](#page-8-2) we obtain the following lemma.

<span id="page-8-0"></span>**Lemma 7.9.** *Let*  $\mathbf{r} = \mathbf{e}_7 + \mathbf{e}_8$ *. Then.*  $W(\mathsf{E}_8)_{\mathbf{r}} \setminus \text{Hom}((\mathsf{D}_8, \mathbf{r}),(\mathsf{E}_8, \mathbf{r})) = \{W(\mathsf{E}_8)_{\mathbf{r}} \cup W(\mathsf{E}_8)_{\mathbf{r}} \cup \{v \in \mathcal{P}_8\} \}$  for  $k = 1, \ldots, 6$ *.* 

## 8. PROOF OF THE SECOND MAIN RESULT

In this section, we prove the second main result Theorem [8.4](#page-9-0) and Corollary [1.2](#page-1-1) by using the mapping  $\phi_{\bf r}^{(n)}$  in the following definition.

**Definition 8.1.** Let *n* be a non-negative integer, and **r** be a root of  $E_8$ . We define

$$
\phi_{\mathbf{r}}^{(n)}: \quad W(\mathsf{E}_8)_{\mathbf{r}} \setminus {N_{\mathbf{r}}(\mathsf{E}_8) \wedge \mathsf{c}_1 \choose n} \rightarrow \Omega^{(n)}/\sim_{\mathrm{sw}} W(\mathsf{E}_8)_{\mathbf{r}} \{[\mathbf{u}_1]_{\mathbf{r}}, \dots, [\mathbf{u}_n]_{\mathbf{r}}\} \rightarrow \Sigma^{(n)}/\sim_{\mathrm{sw}} [S(G)]
$$

where  $A(G) + 2I$  is the Gram matrix of  $\mathbf{u}_1, \dots, \mathbf{u}_n$ . For short, we set  $\phi^{(n)} := \phi_{\mathbf{r}}^{(n)}$ .

By Theorem [4.2](#page-3-7) and Lemma [4.5,](#page-3-4) we see that the mapping  $\phi^{(n)}$  is well-defined.

<span id="page-8-5"></span>**Lemma 8.2.** Let **r** be a root of  $E_8$ . Let  $v_1, \ldots, v_n, v_0$  be roots of which the Gram matrix is  $A(\tilde{G}) + 2I$  for some graph G. Here the vector  $\mathbf{v}_0$  *corresponds to the vertex of G added to G. Assume that* 

<span id="page-8-3"></span>
$$
\mathsf{L}:=\langle \mathbf{v}_1,\ldots,\mathbf{v}_n,\mathbf{v}_0\rangle_{\mathbb{Z}}
$$

*is isometric to*  $A_7$ *. Then G is switching equivalent to*  $K_6$ *, and* 

$$
|\{W(\mathsf{E}_8)_\mathbf{r} f(\{[\mathbf{v}_1]_{\mathbf{v}_0},\ldots,[\mathbf{v}_n]_{\mathbf{v}_0}\})| f \in \text{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))\}| = 2.
$$
 (8.1)

In this lemma, note that  $f(\{[\mathbf{v}_1]_{\mathbf{v}_0},\ldots,[\mathbf{v}_n]_{\mathbf{v}_0}\})$  is naturally defined by  $\{[f(\mathbf{v}_1)]_{f(\mathbf{v}_0)},\ldots,[f(\mathbf{v}_n)]_{f(\mathbf{v}_0)}\}$ .

<span id="page-8-1"></span>

*Proof.* Without loss of generality we may assume that  $L = A_7 \subset E_8$  and  $v_0 = r = e_7 - e_8$  by Lemma [3.5.](#page-2-1) Set

$$
\mathcal{V}:=\{[\mathbf{v}_1]_{\mathbf{v}_0},\ldots,[\mathbf{v}_n]_{\mathbf{v}_0}\}
$$

for short. Since  $\mathbf{v}_1,\ldots,\mathbf{v}_n$ ,  $\mathbf{r} = \mathbf{v}_0$  generates  $A_7$ , we see that  $\mathcal{V} \in N_\mathbf{r}^{(n)}(A_7)$  holds. By Lemma [5.11,](#page-5-2) we have  $n = 6$ and can take  $g \in W(A_7)_{\mathbf{r}}$  such that

$$
g(\mathcal{V})=\{[\mathsf{e}_1-\mathsf{e}_8]_{\mathbf{r}},\ldots,[\mathsf{e}_6-\mathsf{e}_8]_{\mathbf{r}}\}.
$$

Hence G is switching equivalent to  $K_6$ .

Next we prove [\(8.1\)](#page-8-3). Theorem [7.3](#page-7-7) together with Lemma [7.2](#page-7-6) implies

$$
|\{W(\mathsf{E}_8)_{\mathbf{r}}f(\mathcal{V}) \mid f \in \text{Hom}((\mathsf{L}, \mathbf{v}_0), (\mathsf{E}_8, \mathbf{r}))\}| \le |W(\mathsf{E}_8)_{\mathbf{r}} \setminus \text{Hom}((\mathsf{L}, \mathbf{v}_0), (\mathsf{E}_8, \mathbf{r}))|
$$
  
= |W(\mathsf{E}\_8) \setminus \text{Hom}(\mathsf{L}, \mathsf{E}\_8)| = 2.

Also, by Lemma [7.6,](#page-7-8) we have

$$
|\{W(\mathsf{E}_8)_\mathbf{r} f(\mathcal{V}) \mid f \in \mathrm{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))\}| \ge |\{W(\mathsf{E}_8)_\mathbf{r} f(\mathsf{L}) \mid f \in \mathrm{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))\}| = 2.
$$

<span id="page-9-4"></span>These inequalities imply the desired result [\(8.1\)](#page-8-3).  $\Box$ 

**Lemma 8.3.** Let **r** be a root of  $E_8$ . Let  $\mathbf{v}_1, \ldots, \mathbf{v}_n, \mathbf{v}_0$  be roots of which the Gram matrix is  $A(\tilde{G}) + 2I$  for some graph G. Here the vector  $\mathbf{v}_0$  corresponds to the vertex of  $\tilde{G}$  added to G. Assume that  $L := \langle \mathbf{v}_1, \ldots, \mathbf{v}_n, \mathbf{v}_0 \rangle_{\mathbb{Z}}$  is isometric to D<sub>8</sub>. Then

$$
|\{W(\mathsf{E}_8)_\mathbf{r} f(\{[\mathbf{v}_1]_{\mathbf{v}_0},\ldots,[\mathbf{v}_n]_{\mathbf{v}_0}\}) \mid f \in \mathrm{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))\}| = 1.
$$

*Proof.* Without loss of generality we may assume that  $L = D_8$  and  $r = v_0 := e_7 + e_8$  by Lemma [3.5.](#page-2-1) Setting  $\mathcal{V} := \{[\mathbf{v}_1]_{\mathbf{v}_0}, \ldots, [\mathbf{v}_n]_{\mathbf{v}_0}\}$ , we consider

$$
\{W(\mathsf{E}_8)_{\mathbf{r}}f(\mathcal{V}) \mid f \in \text{Hom}((\mathsf{L}, \mathbf{v}_0), (\mathsf{E}_8, \mathbf{r}))\}.
$$
\n(8.2)

Since  $V \in N_{\mathbf{r}}^{(n)}(\mathsf{D}_8)$ , we have  $7 \le n \le 12$  by Lemma [5.14.](#page-6-7) Set  $\mathcal{V}' := \{[\mathsf{e}_8 + \mathsf{e}_i]_{\mathbf{r}} : i \in \{1, \ldots, 6\}\} \sqcup \{[\mathsf{e}_8 - \mathsf{e}_i]_{\mathbf{r}} : i \in \{1, \ldots, 6\}\}$  $i \in \{1, \ldots, n-6\}$ . Since  $\mathcal{V}' \in N_{\mathbf{r}}^{(n)}(\mathsf{D}_8)$ , we see by Lemma [5.14](#page-6-7) that  $W(\mathsf{D}_8)_{\mathbf{r}} \mathcal{V} = W(\mathsf{D}_8)_{\mathbf{r}} \mathcal{V}'$  holds. Hence [\(8.2\)](#page-9-1) equals

$$
\{W(\mathsf{E}_8)_\mathbf{r} f(\mathcal{V}') \mid f \in \text{Hom}((\mathsf{L}, \mathbf{v}_0), (\mathsf{E}_8, \mathbf{r}))\}.
$$
\n
$$
(8.3)
$$

By Lemma [7.9](#page-8-4) with  $k = 1$ , [\(8.3\)](#page-9-2) equals

<span id="page-9-3"></span><span id="page-9-2"></span><span id="page-9-1"></span>
$$
\{W(\mathsf{E}_8)_\mathbf{r} \mathcal{V}', W(\mathsf{E}_8)_\mathbf{r} \rho_1(\mathcal{V}')\}.
$$
\n(8.4)

Since  $\rho_1([\mathbf{e}_8 + \mathbf{e}_1]_{\mathbf{r}}) = [\mathbf{e}_8 - \mathbf{e}_1]_{\mathbf{r}}$  and  $\rho_1([\mathbf{e}_8 - \mathbf{e}_1]_{\mathbf{r}}) = [\mathbf{e}_8 + \mathbf{e}_1]_{\mathbf{r}}$ , we have  $W(\mathsf{E}_8)_{\mathbf{r}}V' = W(\mathsf{E}_8)_{\mathbf{r}}\rho_1(V')$ . Hence the set  $(8.4)$  has exactly one element. This is the desired conclusion.

<span id="page-9-0"></span>The following is the second main result.

### Theorem 8.4. *The following hold.*

- (i) *For a non-negative integer*  $n \neq 6$ *, the mapping*  $\phi^{(n)}$  *is bijective.*
- (ii) The fibre of  $[S(K_6)]$  under  $\phi^{(6)}$  has exactly two elements, and the other fibres have only one element.

*Proof.* Fix  $[S] \in \Omega^{(n)}/\sim_{\text{sw}}$ . We consider the fibre of  $[S]$  under  $\phi^{(n)}$ . By Lemma [5.5](#page-4-6) together with  $\text{rank}(3I - S) \le 7$ , we have  $S \in \mathcal{S}^{(n)}(\mathsf{L})$  for some  $\mathsf{L} \in \mathcal{L}$  with rank $(\mathsf{L}) \leq 8$ . Hence we can take a graph G with  $S = S(G)$  and a generator  $\mathbf{v}_1, \ldots, \mathbf{v}_n, \mathbf{v}_0$  of L such that the Gram matrix of  $\mathbf{v}_1, \ldots, \mathbf{v}_n, \mathbf{v}_0$  is  $A(\tilde{G}) + 2I$ . Here,  $\mathbf{v}_0$  corresponds to the vertex of  $\tilde{G}$  added to G. The fibre  $(\phi^{(n)})^{-1}([S(G)])$  is

$$
\left\{W(\mathsf{E}_8)_{\mathbf{r}}\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\}\in W(\mathsf{E}_8)_{\mathbf{r}}\setminus\binom{N_{\mathbf{r}}(\mathsf{E}_8)/\sim_{\mathbf{r}}}{n}\middle|\phi^{(n)}(W(\mathsf{E}_8)_{\mathbf{r}}\{[\mathbf{u}_1]_{\mathbf{r}},\ldots,[\mathbf{u}_n]_{\mathbf{r}}\})=[S]\right\}.
$$

This can be written as

$$
\{W(\mathsf{E}_8)_\mathbf{r} f(\{[\mathbf{v}_1]_{\mathbf{v}_0},\ldots,[\mathbf{v}_n]_{\mathbf{v}_0}\}) \mid f \in \mathrm{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))\}.
$$

Hence if  $L \neq A_7$ ,  $D_8$ , then this fibre has only one element since

$$
|W(\mathsf{E}_8)_{\mathbf{r}} \backslash \operatorname{Hom}((\mathsf{L},\mathbf{v}_0),(\mathsf{E}_8,\mathbf{r}))|=1
$$

by Lemma [7.2](#page-7-6) and Theorem [7.3.](#page-7-7) Next if L is isometric to  $D_8$ , then the fibre has only one element by Lemma [8.3.](#page-9-4) If L is isometric to  $A_7$ , then G is switching equivalent to  $K_6$  and the fibre has two elements by Lemma [8.2.](#page-8-5)

*Proof of Corollary [1.2.](#page-1-1)* Recall that  $\omega(n) = |\Omega^{(n)}/\sim_{\text{sw}}|$ . Let r be a root of E<sub>8</sub>. For non-negative integers *n* up to 28, the mapping

$$
c^{(n)}: \begin{array}{ccc} \binom{N_{\mathbf{r}}(\mathbf{E}_8)/\sim_{\mathbf{r}}}{n} & \rightarrow & \binom{N_{\mathbf{r}}(\mathbf{E}_8)/\sim_{\mathbf{r}}}{28-n} \\ X & \mapsto & \left(N_{\mathbf{r}}(\mathbf{E}_8)/\sim_{\mathbf{r}}\right) \setminus X \end{array}
$$

is bijective. The mapping  $c^{(n)}$  induces the bijective mapping

$$
\overline{c}^{(n)}: \ W(\mathsf{E}_8)_{\mathbf{r}} \backslash \binom{N_{\mathbf{r}}(\mathsf{E}_8)/\sim_{\mathbf{r}}}{n} \rightarrow \ W(\mathsf{E}_8)_{\mathbf{r}} \backslash \binom{N_{\mathbf{r}}(\mathsf{E}_8)/\sim_{\mathbf{r}}}{28-n}
$$
\n
$$
W(\mathsf{E}_8)_{\mathbf{r}} X \rightarrow W(\mathsf{E}_8)_{\mathbf{r}} \left( \left( N_{\mathbf{r}}(\mathsf{E}_8) \right) \sim_{\mathbf{r}} \right) \backslash X
$$

Fix  $n \in \{0, \ldots, 14\}$ . Since  $\phi^{(28-n)}$  is bijective by Theorem [8.4,](#page-9-0) we obtain the composite mapping

$$
\Omega^{(28-n)}/\!\!\sim_{\mathrm{sw}}\xrightarrow{(\phi^{(28-n)})^{-1}} W(\mathsf{E}_8)_{\mathbf{r}}\backslash \begin{pmatrix} N_{\mathbf{r}}(\mathsf{E}_8)/\sim_{\mathbf{r}}\\ 28-n \end{pmatrix} \xrightarrow{\bar{c}^{(28-n)}} W(\mathsf{E}_8)_{\mathbf{r}}\backslash \begin{pmatrix} N_{\mathbf{r}}(\mathsf{E}_8)/\sim_{\mathbf{r}}\\ n \end{pmatrix} \xrightarrow{\phi^{(n)}} \Omega^{(n)}/\!\sim_{\mathrm{sw}}.
$$

If  $n \neq 6$ , then this mapping is bijective by Theorem [8.4,](#page-9-0) and hence  $|\Omega^{(28-n)}/\sim_{\text{sw}}| = |\Omega^{(n)}/\sim_{\text{sw}}|$  holds. Also, in the case of  $n = 6$ , we see by Theorem [8.4](#page-9-0) that the fibre of  $[S(K_6)]$  under the mapping  $\phi^{(n)} \circ \bar{c}^{(28-n)} \circ (\phi^{(28-n)})^{-1}$  has exactly two elements, and the other fibres have only one element. Hence  $|\Omega^{(22)}/\sim_\text{sw}|=|\Omega^{(6)}/\sim_\text{sw}|+1$  follows as desired.
