# <span id="page-0-1"></span>Distribution-uniform strong laws of large numbers

#### Abstract

We revisit the question of whether the strong law of large numbers (SLLN) holds uniformly in a rich family of distributions, culminating in a distribution-uniform generalization of the Marcinkiewicz-Zygmund SLLN. These results can be viewed as extensions of Chung's distribution-uniform SLLN to random variables with uniformly integrable  $q^{\text{th}}$  absolute central moments for  $0 < q < 2$ ;  $q \neq 1$ . Furthermore, we show that uniform integrability of the  $q^{\text{th}}$  moment is both sufficient and necessary for the SLLN to hold uniformly at the Marcinkiewicz-Zygmund rate of  $n^{1/q-1}$ . These proofs centrally rely on distribution-uniform analogues of some familiar almost sure convergence results including the Khintchine-Kolmogorov convergence theorem, Kolmogorov's three-series theorem, a stochastic generalization of Kronecker's lemma, and the Borel-Cantelli lemmas. The non-identically distributed case is also considered.



## <span id="page-0-0"></span>1 Introduction

In his 1951 Berkeley Symposium paper titled "The strong law of large numbers" [\[5\]](#page-34-0), Kai Lai Chung writes "For use in certain statistical applications Professor Wald raised the question of the uniformity of the strong flaw of large numbers with respect to a family of  $\alpha$  / distributions  $\alpha$ . Chung's paper proceeds to provide a concrete answer to that question, yielding a generalization of Kolmogorov's strong law of large numbers (SLLN) that holds uniformly in a rich family of distributions having a uniformly integrable first absolute moment. Let us formally recall (a minor refinement of) Chung's distribution-uniform SLLN here.

<span id="page-1-7"></span>**Theorem** (Chung's P-uniform strong law of large numbers  $[5, 14]$  $[5, 14]$ ). Let P be a collection of probability distributions and  $(X_n)_{n=1}^{\infty}$  be independent and identically distributed random variables defined on the probability spaces  $(\Omega, \mathcal{F}, \mathcal{P}) := (\Omega, \mathcal{F}, P)_{P \in \mathcal{P}}$  satisfying the P-uniform integrability (P-UI) condition

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|X - \mathbb{E}_P(X)| \cdot 1(|X - \mathbb{E}_P(X)| > m)) = 0.
$$
\n(1)

Then for every  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k} \sum_{i=1}^k X_i - \mathbb{E}_P(X) \right| \ge \varepsilon \right) = 0. \tag{2}
$$

Notice that Chung's SLLN recovers Kolmogorov's as a special case when the class of distributions  $\mathcal{P} = \{P\}$  is taken to be a singleton such that  $\mathbb{E}_P |X| < \infty$  since for any sequence of random variables  $(Y_n)_{n=1}^{\infty},$

$$
\mathbb{P}_P\left(\lim_{n\to\infty}Y_n=0\right)=1\quad\text{if and only if}\quad\forall\varepsilon>0,\ \lim_{m\to\infty}\mathbb{P}_P\left(\sup_{k\geq m}|Y_k|\geqslant\varepsilon\right)=0.\tag{3}
$$

The equivalence in [\(3\)](#page-1-0) highlights why Chung's original characterization of the SLLN holding "P-uniformly" in [\(2\)](#page-1-1) is a natural one. Despite Chung's advance, there are four open questions that we aim to address in this paper:

(i) Can the convergence rate in [\(2\)](#page-1-1) be improved in the presence of higher moments in the sense of Marcinkiewicz and Zygmund [\[11\]](#page-34-2)? That is, can it be shown that for all  $\varepsilon > 0$ ,

\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k^{1/q}} \sum_{i=1}^k (X_i - \mathbb{E}_P(X)) \right| \ge \varepsilon \right) = 0 \tag{4}
$$

under certain  $P$ -UI conditions on the  $q^{\text{th}}$  moment for  $1 < q < 2$ ?

(ii) Is it possible to restrict the *divergence* rate when X has fewer than 1 but more than 0 finite absolute moments, again in the sense of Marcinkiewicz and Zygmund [\[11](#page-34-2)]? That is, can it be shown that

\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k^{1/q}} \sum_{i=1}^k X_i \right| \ge \varepsilon \right) = 0,
$$
\n(5)

under similar P-UI conditions but for  $0 < q < 1$  even when  $\mathbb{E}_P |X| = \infty$  for some  $P \in \mathcal{P}$ ?

(iii) Are  $\mathcal{P}\text{-}\mathrm{UI}$  conditions *necessary* for  $\mathcal{P}\text{-}\mathrm{uniform}$  SLLNs to hold (in addition to being sufficient)? That is, if the condition in [\(1\)](#page-1-2) does not hold, can it be shown that for some positive constant  $C > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k} \sum_{i=1}^k (X_i - \mathbb{E}_P(X)) \right| \ge C \right) > 0, \tag{6}
$$

with analogous questions in the case of higher or lower  $P$ -UI moments as in (i) and (ii)?

(iv) Does an analogue of Chung's SLLN exist for independent but non-identically distributed random variables, such as in the sense of Petrov [\[12](#page-34-3), §IX, Theorem 12]? That is, can it be shown that

\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{a_k} \sum_{i=1}^k (X_i - \mathbb{E}_P(X_i)) \right| \ge \varepsilon \right) = 0 \tag{7}
$$

for some appropriately chosen sequence  $a_n \nearrow \infty$ , and if so, under what conditions on  $(X_n)_{n=1}^{\infty}$ ? We provide positive answers to (i), (ii), (iii), and (iv) in Theorems  $1(i)$  $1(i)$ ,  $1(iii)$ ,  $1(iii)$ , and [2,](#page-6-0) respectively. <span id="page-2-5"></span>**Remark 1** (On centered versus uncentered uniform integrability). As outlined by Ruf et al. [\[14](#page-34-1), Remark] 4.5], the assumption displayed in [\(1\)](#page-1-2) is a minor refinement of Chung [\[5](#page-34-0)] whose original result made the (stronger) uncentered P-UI assumption,

\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X| \mathbb{1} \{ |X| > m \} \right) = 0 \tag{8}
$$

in place of [\(1\)](#page-1-2) but yielding the same conclusion in [\(2\)](#page-1-1). While the difference between (1) and [\(8\)](#page-2-1) may seem minor — indeed, for a single  $P \in \mathcal{P}$ ,  $\mathbb{E}_P |X| < \infty$  and  $\mathbb{E}_P |X - \mathbb{E}_P(X)| < \infty$  are equivalent — we highlight in Theorem  $1(iii)$  $1(iii)$  how  $(1)$  is both sufficient and necessary for the SLLN to hold, while the same cannot be said for [\(8\)](#page-2-1), drawing an important distinction between the two.

**Remark 2** (On the phrase "uniform integrability"). Note that the phrase "uniform integrability" is commonly used to refer to an analogue of [\(1\)](#page-1-2) holding for a family of random variables  $(X_n)_{n=1}^{\infty}$  on the same probability space  $(\Omega, \mathcal{F}, P)$  (as in Chung [\[6,](#page-34-4) §4.5], Chong [\[3\]](#page-34-5), Chandra and Goswami [\[2](#page-34-6)], Hu and Rosalsky [\[7\]](#page-34-7), and Hu and Zhou [\[8\]](#page-34-8) among others) in the sense that

$$
\lim_{m \to \infty} \sup_{k \in \mathbb{N}} \mathbb{E}_P\left(|X_k - \mathbb{E}_P(X_k)| \cdot \mathbb{1}\{|X_k - \mathbb{E}_P(X_k)| > m\}\right) = 0,\tag{9}
$$

while the presentation in  $(1)$  is a statement about a single random variable on a collection of probability spaces  $(\Omega, \mathcal{F}, \mathcal{P})$  (as also seen in Chow and Teicher [\[4](#page-34-9), pp. 93–94] and Ruf et al. [\[14,](#page-34-1) Section 4.2]). Clearly, these two presentations communicate a similar underlying property, but they are used in conceptually different contexts and for this reason, we deliberately write "P-UI" to emphasize adherence to [\(1\)](#page-1-2) and avoid ambiguity.

### <span id="page-2-0"></span>1.1 Notation and conventions

Let us now make explicit some notation and conventions that will be used throughout the paper. First, the discussion surrounding [\(3\)](#page-1-0) motivates the following definition which summarizes, extends, and makes succinct Chung's notion of sequences that vanish both  $P$ -uniformly and almost surely.

<span id="page-2-3"></span>**Definition 1** (Distribution-uniformly and almost surely vanishing sequences). Let  $\mathcal{P}$  be a collection of distributions and  $(Y_n(P))_{n=1}^{\infty}$  be random variables defined on  $(\Omega, \mathcal{F}, P)$  for each  $P \in \mathcal{P}$ . We say that  $(Y_n)_{n=1}^{\infty} \equiv (Y_n(P))_{n=1}^{\infty}$  *P-uniformly vanishes almost surely if for any*  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} |Y_k(P)| \ge \varepsilon \right) = 0,\tag{10}
$$

and as a shorthand for  $(10)$ , we write

<span id="page-2-4"></span>
$$
Y_n = \overline{o}_{\mathcal{P}}(1). \tag{11}
$$

Moreover, for a nondecreasing sequence  $r_n \nearrow \infty$ , we say that  $Y_n = \overline{\sigma}_P(r_n)$  if  $Y_n/r_n = \overline{\sigma}_P(1)$ .

Clearly, if a sequence satisfies Definition [1,](#page-2-3) then it is both  $\mathcal{P}\text{-uniformly vanishing in probability for }$ the same class P as well as vanishing P-almost surely for every  $P \in \mathcal{P}$ . Furthermore, we make use of the following conventions.

- Individual distributions are denoted by the capital letter  $P$  and collections of distributions are denoted by calligraphic capital letters (typically  $P$ ).
- We write "P-UI" (or simply "UI") for "P-uniformly integrable" when it is clear from context that the phrase is used as an adjective and "P-uniform integrability" when used as a noun.
- Collections of probability spaces are written as  $(\Omega, \mathcal{F}, \mathcal{P})$ .
- If the  $q^{\text{th}}$  absolute central moment of X is  $P$ -UI, i.e.

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X - \mathbb{E}_P(X)|^q \mathbb{1} \left\{ |X - \mathbb{E}_P(X)|^q > m \right\} \right) = 0,\tag{12}
$$

we condense this to "the  $q^{\text{th}}$  moment of X is  $\mathcal{P}\text{-}\text{UI}$ " and omit the qualifiers "absolute" and "central".

- <span id="page-3-3"></span>• The phrase "independent and identically distributed" is abbreviated to "i.i.d.".
- For real numbers  $a, b \in \mathbb{R}$ , we use  $a \wedge b$  to denote  $\min\{a, b\}$  and  $a \vee b$  to denote  $\max\{a, b\}$ .
- We write  $b_n \nearrow \infty$  for a real sequence  $(b_n)_{n=1}^{\infty}$  if it is nondecreasing and diverging to  $\infty$ .
- We omit the subscript P from  $\mathbb{E}_P(X)$  when using the shorthand notation in [\(11\)](#page-2-4). For example, we write  $\frac{1}{n} \sum_{i=1}^{n} X_i - \mathbb{E}(X) = \overline{o}_{\mathcal{P}}(1)$  if in fact

$$
\forall \varepsilon > 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} |X_k - \mathbb{E}_P(X)| \ge \varepsilon \right) = 0. \tag{13}
$$

• If  $\mathbb{E}_P[X_n]$  is finite for every  $P \in \mathcal{P}$  and every  $n \in \mathbb{N}$ , we say that "the SLLN holds at a rate of  $\overline{\sigma}_P(a_n/n)$ " to mean that  $a_n^{-1} \sum_{i=1}^n (X_i - \mathbb{E}(X_i)) = \overline{\sigma}_P(1)$  for the sequence  $a_n \nearrow \infty$ . Similarly, if  $\mathbb{E}_P|X_n| = \infty$  for some  $P \in \mathcal{P}$  and some  $n \in \mathbb{N}$ , then we use the same phrase "the SLLN holds at a rate of  $\bar{\sigma}_P(a_n/n)$ " if  $a_n^{-1} \sum_{i=1}^n X_i = \bar{\sigma}_P(1)$ . For example, Chung [\[5\]](#page-34-0) gives conditions under which the SLLN holds at a rate of  $\bar{o}_{\mathcal{P}}(1)$ .

### <span id="page-3-0"></span>1.2 Outline and summary of contributions

Below we outline how the paper will proceed, summarizing our main contributions.

- Section [2](#page-6-0) contains our main results Theorems [1\(](#page-3-2)i), 1(iii), 1(iii), and  $2$  which provide answers to the questions posed in  $(4)$ ,  $(5)$ ,  $(6)$ , and  $(7)$ , respectively. In short, these theorems show that the SLLN holds at a rate of  $\overline{\sigma}_P(n^{1/q-1})$  in the i.i.d. case if and only if they have a P-UI q<sup>th</sup> moment, and that it holds at a rate of  $\overline{\sigma}_{\mathcal{P}}(a_n/n)$  in the non-i.i.d. case if  $\sum_{k=m}^{\infty} \mathbb{E}|X_k - \mathbb{E}X_k|^q/a_k^q$  vanishes P-uniformly as  $m \to \infty$ .
- Section [3](#page-7-0) contains distribution-uniform analogues of several almost sure convergence results that are commonly used in the proofs of SLLNs. These include analogues of the Khintchine-Kolmogorov convergence theorem (Section [3.1\)](#page-7-1), the Kolmogorov three-series theorem (Section [3.2\)](#page-8-0), Kronecker's lemma (Section [3.3\)](#page-10-0), and the Borel-Cantelli lemmas (Section [3.4\)](#page-13-0). These results rely on the notion of a distribution-uniform Cauchy sequence, whose definition is provided in Definition [2](#page-7-2) and which serves as a  $\mathcal{P}-$ uniform generalization of a sequence that is  $P$ -almost surely convergent.
- Section [4](#page-13-1) contains complete proofs to Theorems [1](#page-3-2) and [2.](#page-6-0) After considering the "right" generalizations of distribution-uniform convergence (in Definitions [1](#page-2-3) and [2\)](#page-7-2), the high-level structure of the proofs to Theorems  $1(i)$  $1(i)$ ,  $1(ii)$ , and [2](#page-6-0) largely mirror those of their P-pointwise counterparts due to Kolmogorov, Marcinkiewicz, and Zygmund in the sense that they use analogous technical theorems and lemmas from Section [3](#page-7-0) in similar succession. One exception to this is the combination of Kolmogorov's three-series theorem and Kronecker's lemma — certain subtleties surrounding uniform boundedness in probability of  $\mathcal{P}\text{-uniform}$  Cauchy sequences requires the introduction of another three-series theorem provided in Theorem [5.](#page-22-0) Furthermore, our proofs noticeably deviate from their P-pointwise counterparts in satisfying the conditions of our  $\mathcal{P}\text{-uniform}$  three series theorems (Theorems [4](#page-8-1) and [5\)](#page-22-0). These require additional care in both cases, relying for example on a delicate application of the de la Vallée Poussin criterion of uniform integrability; details can be found in Lemmas [3–](#page-15-0)[8.](#page-27-0)

## <span id="page-3-1"></span>2 Distribution-uniform strong laws of large numbers

<span id="page-3-2"></span>We begin by presenting our first main result which gives both necessary and sufficient conditions for the SLLN to hold at a rate of  $\overline{\sigma}_P(n^{1/q-1})$  in the i.i.d. setting, providing answers to the questions posed in [\(4\)](#page-1-3), [\(5\)](#page-1-4), and [\(6\)](#page-1-5).

<span id="page-4-2"></span>**Theorem 1** (P-uniform Marcinkiewicz-Zygmund strong law of large numbers). Let  $(X_n)_{n=1}^{\infty}$  be independent and identically distributed random variables and consider the following P-UI condition for some  $0 < q < 2$ :

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|X - \mu(P; q)|^q \mathbb{1}\{|X - \mu(P; q)|^q > m\}) = 0,
$$
\n(14)

where  $\mu(P; q) = \mathbb{E}_P(X)$  if  $1 \le q < 2$  and  $\mu(P; q) = 0$  if  $0 < q < 1$ .

(i) If [\(14\)](#page-4-0) holds with  $q \in [1, 2)$ , then

$$
\frac{1}{n^{1/q}} \sum_{i=1}^{n} (X_i - \mathbb{E}(X)) = \bar{o}_{\mathcal{P}}(1).
$$
 (15)

(ii) If [\(14\)](#page-4-0) holds with  $q \in (0, 1)$ , then

$$
\frac{1}{n^{1/q}} \sum_{i=1}^{n} X_i = \bar{o}_{\mathcal{P}}(1).
$$
 (16)

(iii) If  $(14)$  does not hold, then

$$
\frac{1}{n^{1/q}}\sum_{i=1}^{n}(X_i - \mu(P; q)) \neq \overline{o}_{\mathcal{P}}(1).
$$
 (17)

In other words, the P-uniform SLLN holds for the average  $\frac{1}{n}\sum_{i=1}^{n} X_i$  with a rate of  $o(n^{1/q-1})$  if and only if the  $q^{th}$  moment of X is  $P$ -UI.

In the same way that Chung's P-uniform SLLN for UI first moments generalizes Kolmogorov's Ppointwise SLLN for finite first moments, Theorems [1\(](#page-3-2)i) and [1\(](#page-3-2)ii) generalize the Marcinkiewicz-Zygmund [\[11\]](#page-34-2) P-pointwise SLLN for finite  $q^{\text{th}}$  moments when  $0 < q < 2$ ;  $q \neq 1$ , painting a fuller picture of sufficiency for  $P$ -uniform SLLNs in the i.i.d. case.

Turning to Theorem [1\(](#page-3-2)iii), the necessity of  $P$ -UI appears to be new to the literature even in the case of  $q = 1$ . In fact, Chung's original paper [\[5\]](#page-34-0) studied necessary conditions for the P-uniform SLLN but only considered uncentered UI as in [\(8\)](#page-2-1) which turns out not to be necessary in general. Concretely, he showed that if the SLLN in [\(15\)](#page-4-1) holds for  $q = 1$  and the median of X is uniformly bounded, then the uncentered P-UI condition in [\(8\)](#page-2-1) holds; in other words, if  $\sup_{P \in \mathcal{P}} |\text{med}_P(X)| < \infty$  where  $\text{med}_P(X) :=$  $\sup\{x : \mathbb{P}_P(X \leq x) \leq 1/2\}$ , then

$$
\frac{1}{n}\sum_{i=1}^{n}(X_i - \mathbb{E}(X)) = \bar{o}_{\mathcal{P}}(1) \implies \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|X|\mathbb{1}\{|X| > m\}) = 0.
$$
\n(18)

Chung [\[5](#page-34-0), Remark 2] uses a simple counterexample to point out that without uniform boundedness of the medians, uncentered P-UI is not necessary. Indeed, letting  $P_N := \{P_n : n \in \mathbb{N}\}\$  where  $P_n$  is the distribution of X with a point mass at  $x = n$ , we obviously have that the uniform SLLN holds (since the centered sample average is always 0 with P-probability one for all  $P \in \mathcal{P}_{\mathbb{N}}$ ) and yet X does not satisfy uncentered  $\mathcal{P}_{\mathbb{N}}$ -uniform integrability. Clearly, this counterexample does not apply to the *centered* uniform integrability condition we are considering in [\(14\)](#page-4-0).

Theorem [1\(](#page-3-2)iii) also highlights that uniform *boundedness* of the  $q<sup>th</sup>$  moment is not sufficient for the SLLN to hold  $\mathcal{P}$ -uniformly at a rate of  $o(n^{1/q-1})$ . Going further, by the de la Vallée Poussin criterion for uniform integrability [\[3](#page-34-5)], the SLLN holding uniformly at this rate is equivalent to the uniform boundedness of  $\mathbb{E}_P \varphi(|X|^q)$  for some positive and nondecreasing function  $\varphi$  growing faster than  $x \mapsto x$ , i.e.  $\lim_{x\to\infty} \varphi(x)/x = \infty$ . Let us now give rough outlines of the proofs of Theorems [1\(](#page-3-2)i), 1(ii), and 1(iii) (with a diagrammatic overview of the former displayed in Figure [1\)](#page-5-0), leaving most technical details for Section [4.1.](#page-14-0)

*Proof outline of Theorem [1\(](#page-3-2)i).* Since  $q = 1$  corresponds to the SLLN of Chung [\[5](#page-34-0)], we focus on  $1 < q < 2$ . Similar to classical SLLN proofs, we focus our attention on the weighted random variables  $(Z_n)_{n=1}^{\infty}$  given

Note that when  $\mathcal{P} = \{P\}$  is a singleton, the proof due to Marcinkiewicz and Zygmund [\[11](#page-34-2)] only involves the left branch (Lemma  $3\rightarrow$  $3\rightarrow$ Theorem  $4\rightarrow$  $4\rightarrow$ Lemma [1\)](#page-10-1) since the right one is trivially satisfied in that case (more discussion can be found in Section [4.1.2\)](#page-22-1). The above structure similarly applies to the proof of Theorem [1\(](#page-3-2)ii) but we replace Lemmas [3](#page-15-0) and [7](#page-24-0) with Lemmas [4](#page-19-0) and [8](#page-27-0) for the sake of satisfying the conditions of Theorems [4](#page-8-1) and [5,](#page-22-0) respectively.

by  $Z_n := (X_n - \mathbb{E}_P(X_n)) / n^{1/q}$ . First, in Theorem [4](#page-8-1) we develop a P-uniform analogue of the Kolmogorov three-series theorem which states that if for some  $c > 0$ .

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P Z_n^{\leq c} \right| = 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq c} = 0, \text{ and } \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P(|Z_n| > c) = 0, \tag{19}
$$

where  $Z_n^{\leqslant c} := Z_n \mathbb{1}\{Z_n \leqslant c\}$ , then  $S_n := \sum_{i=1}^n Z_i$  is a P-uniform Cauchy sequence (a notion that we define and discuss more thoroughly in Definition [2\)](#page-7-2), meaning that for any  $\varepsilon > 0$ ,

<span id="page-5-2"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n,k \ge m} |S_n - S_k| \ge \varepsilon \right) = 0. \tag{20}
$$

Indeed, Lemma [3](#page-15-0) focuses on exploiting  $\mathcal{P}\text{-UI}$  of the  $q^{\text{th}}$  moment to show that [\(19\)](#page-5-1) holds with  $c = 1$ .

We then introduce the P-uniform stochastic Kronecker lemma (Lemma [1\)](#page-10-1) which states that if  $S_n$  is P-uniformly Cauchy as in [\(20\)](#page-5-2) and P-uniformly bounded in probability — meaning that for any  $\delta > 0$ , there exist  $N, B > 0$  so that for any  $n \ge N$ , we have  $\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| \ge B) < \delta$  — then for any  $b_n \nearrow \infty$ , we have

$$
\frac{1}{b_n} \sum_{i=1}^n b_i Z_i = \overline{o}_{\mathcal{P}}(1). \tag{21}
$$

To apply Lemma [1](#page-10-1) to our setting, we show that  $S_n$  is  $\mathcal{P}$ -uniformly Cauchy as a consequence of the three-series theorem discussed above combined with Lemma [3,](#page-15-0) and to show that  $S_n$  is P-uniformly bounded in probability, we introduce another three-series-type theorem in Theorem [5](#page-22-0) which states that if

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} |\mathbb{E}_P \left[ \left( Z_n / B \right) \mathbb{1} \{ |Z_n / B| \leq 1 \} \right] | = 0, \tag{22}
$$

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P \left[ (Z_n / B) \mathbb{1} \{ |Z_n / B| \leq 1 \} \right] = 0, \text{ and} \tag{23}
$$

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P(|Z_n/B| > 1) = 0,\tag{24}
$$

<span id="page-6-3"></span>then  $S_n := \sum_{i=1}^n Z_i$  is P-uniformly bounded in probability. Lemma [7](#page-24-0) indeed shows that the above three series conditions are satisfied as long as X has a  $\mathcal{P}\text{-UI } q^{\text{th}}$  moment. Taking the sequence  $(b_n)_{n=1}^{\infty}$  to be given by  $b_n = n^{1/q}$  and invoking the  $\mathcal{P}$ -uniform Kronecker lemma yields the desired result:

$$
\frac{1}{n^{1/q}}\sum_{i=1}^{n}(X_i - \mathbb{E}(X)) = \bar{o}_{\mathcal{P}}(1),\tag{25}
$$

which completes the proof outline of Theorem  $1(i)$  $1(i)$ .

*Proof outline of Theorem [1\(](#page-3-2)ii).* The proof in the case of  $0 < q < 1$  proceeds in the same manner as that of  $1 < q < 2$  but instead of Lemma [3](#page-15-0) showing that the three-series conditions in [\(19\)](#page-5-1) are satisfied for  $(X_n - \mathbb{E}_P(X_n))/n^{1/q}$ , it is Lemma [4](#page-19-0) that shows that these conditions are satisfied for  $X_n/n^{1/q}$ , thereby demonstrating that  $\sum_{k=1}^{n} X_k/k^{1/q}$  is P-uniformly Cauchy. Similarly, rather than using Lemma [7](#page-24-0) to satisfy the  $\mathcal{P}-$ uniform boundedness three series above, we use Lemma [8.](#page-27-0) Again, invoking the  $\mathcal{P}-$ uniform stochastic Kronecker lemma yields the desired result.  $\Box$ 

*Proof outline of Theorem [1\(](#page-3-2)iii).* We will describe the proof outline for the case where  $1 \leq q < 2$  but a similar argument goes through for  $0 < q < 1$  (with all details provided in Section [4.1\)](#page-14-0). The proof relies on a P-uniform generalization of the second Borel-Cantelli lemma (Lemma [2\)](#page-13-2) which states that for independent events  $(E_n)_{n=1}^{\infty}$  in F, if the tails of the sums of  $(\mathbb{P}_P(E_n))_{n=1}^{\infty}$  do not uniformly vanish, then the probability of the tails of the *unions* of  $(E_n)_{n=1}^{\infty}$  do not uniformly vanish; more succinctly:

<span id="page-6-1"></span>
$$
0 < \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( E_k \right) \leq \infty \implies \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \bigcup_{k=m}^{\infty} E_k \right) > 0. \tag{26}
$$

To make use of this lemma, we highlight that for any  $P \in \mathcal{P}$ ,

$$
\mathbb{P}_P\left(\sup_{k\geq m-1} \frac{1}{k^{1/q}} |S_k| \geq 1/2\right) \geq \mathbb{P}_P\left(\sup_{k\geq m} \frac{1}{k^{1/q}} |X - \mathbb{E}_P(X)| \geq 1\right)
$$
(27)

where  $S_k := \sum_{i=1}^k (X_i - \mathbb{E}_P(X_i))$  are the centered partial sums, and hence once paired with [\(26\)](#page-6-1), it suffices to show that

<span id="page-6-2"></span>
$$
0 < \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |X_k - \mathbb{E}_P(X_k)|^q > k \right) \leq \infty. \tag{28}
$$

Indeed by Hu and Zhou  $[8,$  Theorem 2.1],  $(28)$  is *equivalent* to the P-UI condition in  $(14)$  being violated, i.e. [\(28\)](#page-6-2) holds if and only if

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|X - \mathbb{E}_P(X)|^q \mathbb{1}\{|X - \mathbb{E}_P(X)|^q > m\}) > 0,
$$
\n(29)

which completes the proof outline of Theorem [1\(](#page-3-2)iii).

Let us now consider the setting of independent but *non-identically distributed* random variables. The following theorem serves as a distribution-uniform generalization of the well-known strong law of large numbers for independent random variables (see Petrov [\[12,](#page-34-3) §IX, Theorem 12]).

<span id="page-6-0"></span>**Theorem 2** (P-uniform strong law for non-identically distributed random variables). Let  $(X_n)_{n=1}^{\infty}$  be independent random variables and suppose that for some  $q \in [1, 2]$ , they each have a finite absolute  $q^{th}$ central moment. Suppose that for some  $a_n \nearrow \infty$ , we have

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{\mathbb{E}_P |X_k - \mathbb{E}_P X_k|^q}{a_k^q} = 0.
$$
\n(30)

Then the strong law of large numbers holds P-uniformly at a rate of  $o(a_n/n)$ , meaning for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{a_k} \sum_{i=1}^k (X_i - \mathbb{E}_P(X_i)) \right| \ge \varepsilon \right) = 0. \tag{31}
$$

 $\Box$ 

<span id="page-7-5"></span>Before giving the proof outline, we make some brief remarks about Theorem [2.](#page-6-0) After some inspection, the reader will notice that when instantiated in the identically distributed setting, Theorem [2](#page-6-0) does not recover Theorem [1,](#page-3-2) meaning that it cannot attain an SLLN rate as fast as  $o(n^{1/q-1})$  in the presence of only  $q \in (1, 2)$  UI moments. This is not surprising, and directly mirrors the relationship between the P-pointwise non-i.i.d. SLLNs [\[12](#page-34-3), §IX, Theorem 12] and the strong laws of Kolmogorov, Marcinkiewicz, and Zygmund in the i.i.d. case. The latter proofs in the P-pointwise case (and now ours provided in Section [4.1](#page-14-0) for the P-uniform case) all crucially exploit the fact that  $(X_n)_{n=1}^{\infty}$  are identically distributed.

Proof outline of Theorem [2.](#page-6-0) The proof of Theorem [2](#page-6-0) is identical to that of Theorem [1\(](#page-3-2)i) but instead of using Lemma [3](#page-15-0) and Lemma [7](#page-24-0) to satisfy the conditions of the  $P$ -uniform Kolmogorov and boundedness three-series theorems (Theorems [4](#page-8-1) and [5\)](#page-22-0), we use different arguments found in Lemmas [10](#page-31-0) and [11,](#page-32-0) respectively. (In fact, the latter two lemmas are simpler and require much softer arguments.) This completes the proof outline of Theorem [2.](#page-6-0) Е

The full proof can be found in Section [4.](#page-13-1) As alluded to in the proof outlines of Theorems [1](#page-3-2) and [2,](#page-6-0) our results rely on so-called "P-uniform Cauchy sequences" as well as P-uniform analogues of several familiar almost sure convergence results. We present all of these in the next section.

## <span id="page-7-0"></span>3 Other distribution-uniform strong laws

In this section, we provide  $P$ -uniform analogues of various almost sure convergence results including the Khintchine-Kolmogorov convergence theorem, the Kolmogorov three-series theorem, and a stochastic generalization of Kronecker's lemma. These are instrumental to the proofs of Theorems [1](#page-3-2) and [2.](#page-6-0) However, note that the classical (P-pointwise) forms of these results are stated (either in their assumptions or in their conclusions) in terms of a sequence of random variables converging P-almost surely. While Definition [1](#page-2-3) provides a natural distribution-uniform generalization of sequences that almost surely vanish (i.e. converge to 0), it does not immediately yield a sensible definition of a sequence that  $\mathcal{P}\text{-uniformly}$ almost surely converges to a potentially random quantity. The definition of a Cauchy sequence however is agnostic to the limiting value of the sequence, motivating the following definition of a  $\mathcal{P}\text{-uniform Cauchy}$ sequence which generalizes the notion of P-almost sure convergence to a family of distributions  $\mathcal{P}$ .

<span id="page-7-2"></span>**Definition 2** (Distribution-uniform Cauchy sequence). Let P be a collection of distributions and  $(X_n)_{n=1}^{\infty}$ a sequence of random variables defined on  $(\Omega, \mathcal{F}, \mathcal{P})$ . We say that  $(X_n)_{n=1}^{\infty}$  is a P-uniform Cauchy sequence if for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k,n \ge m} |X_k - X_n| \ge \varepsilon \right) = 0. \tag{32}
$$

It is easy to check that a  $P$ -uniform Cauchy sequence is  $P$ -almost surely a Cauchy sequence for every  $P \in \mathcal{P}$  and that if  $(X_n - C)_{n=1}^{\infty} = \overline{\sigma}_{\mathcal{P}}(1)$  for any fixed  $C \in \mathbb{R}$ , then  $(X_n)_{n=1}^{\infty}$  is  $\mathcal{P}$ -uniformly Cauchy. Definition [2](#page-7-2) can be viewed as a  $\mathcal{P}-$ uniform generalization of the notion of a sequence that converges with P-probability one. Indeed, the following section makes use of Definition [2](#page-7-2) to provide a P-uniform generalization of the Khintchine-Kolmogorov convergence theorem.

#### <span id="page-7-1"></span>3.1 A distribution-uniform Khintchine-Kolmogorov convergence theorem

In the classical P-pointwise case, the Khintchine-Kolmogorov convergence theorem states that for a sequence of independent random variables  $(X_n)_{n=1}^{\infty}$ , if the sum of their variances is finite, i.e.

<span id="page-7-3"></span>
$$
\sum_{k=1}^{\infty} \text{Var}_P(X_k) < \infty,\tag{33}
$$

<span id="page-7-4"></span>then  $\sum_{k=1}^{\infty} X_k$  is P-almost surely finite. With Definition [2](#page-7-2) in mind, we are ready to state and prove a P-uniform generalization of the Khintchine-Kolmogorov convergence theorem, establishing that the sum  $\sum_{k=1}^{\infty} X_k$  is P-uniformly Cauchy whenever the series in [\(33\)](#page-7-3) has P-uniformly vanishing tails.

**Theorem 3** (P-uniform Khintchine-Kolmogorov convergence theorem). Let  $(X_n)_{n=1}^{\infty}$  be independent random variables on  $(\Omega, \mathcal{F}, \mathcal{P})$ . If

<span id="page-8-4"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \text{Var}_P X_k = 0 \tag{34}
$$

then  $S_n := \sum_{i=1}^n (X_i - \mathbb{E}_P(X_i))$  is P-uniformly Cauchy (Definition [2\)](#page-7-2), meaning for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k,n \ge m} |S_k - S_n| \ge \varepsilon \right) = 0. \tag{35}
$$

*Proof.* First note that for any  $m \ge 1$ , we have that

$$
\left\{\sup_{k,n\geqslant m}|S_k-S_n|\geqslant \varepsilon\right\} \subseteq \left\{\sup_{k\geqslant m}|S_k-S_m|\geqslant \varepsilon/2\right\} \cup \left\{\sup_{n\geqslant m}|S_n-S_m|\geqslant \varepsilon/2\right\} \tag{36}
$$

and hence for any  $P \in \mathcal{P}$ ,

$$
\mathbb{P}_P\left(\sup_{k,n\geq m}|S_k-S_n|\geq \varepsilon\right)\leq \mathbb{P}_P\left(\sup_{k\geq m}|S_k-S_m|\geq \varepsilon/2\right)+\mathbb{P}_P\left(\sup_{n\geq m}|S_n-S_m|\geq \varepsilon/2\right)\tag{37}
$$

<span id="page-8-3"></span><span id="page-8-2"></span>
$$
=2\lim_{M\to\infty}\mathbb{P}_P\left(\max_{m\leq k\leq M}|S_k-S_m|\geq \varepsilon/2\right) \tag{38}
$$

$$
\leq \frac{8}{\varepsilon^2} \cdot \lim_{M \to \infty} \sum_{k=m+1}^{M} \text{Var}_P(X_k) \tag{39}
$$

$$
= \frac{8}{\varepsilon^2} \cdot \sum_{k=m+1}^{\infty} \text{Var}_P(X_k),\tag{40}
$$

where [\(38\)](#page-8-2) follows from monotonicity and [\(39\)](#page-8-3) from Kolmogorov's inequality. Taking suprema over  $P \in \mathcal{P}$ and limits as  $m \to \infty$  and noting the condition in [\(34\)](#page-8-4) yields the desired result, completing the proof.  $\Box$ 

#### <span id="page-8-0"></span>3.2 A distribution-uniform Kolmogorov three-series theorem

Now that we have a P-uniform Khintchine-Kolmogorov convergence theorem, we will use it to prove a P-uniform analogue of Kolmogorov's three-series theorem. To begin, define the truncated version  $X^{\leq c}$ of a random variable  $X$  at a constant  $c$  as

$$
X^{\leqslant c} := X \cdot \mathbb{1}\{|X| \leqslant c\}.\tag{41}
$$

In the P-pointwise case, recall that Kolmogorov's three-series theorem states that if the following three series are finite for some  $c > 0$ :

<span id="page-8-5"></span>
$$
\sum_{n=1}^{\infty} \mathbb{E}_P X_n^{\leq c} < \infty, \quad \sum_{n=1}^{\infty} \text{Var}_P X_n^{\leq c} < \infty, \text{ and } \sum_{n=1}^{\infty} \mathbb{P}_P(|X_n| > c) < \infty,\tag{42}
$$

then  $\sum_{k=1}^{\infty} X_k$  is P-almost surely finite. Similarly to Theorem [3](#page-7-4) in the previous section, our P-uniform analogue of Kolmogorov's three series theorem will conclude that  $\sum_{k=1}^{\infty} X_k$  is P-uniformly Cauchy as long as the tails of a certain three series are  $P$ -uniformly vanishing.

<span id="page-8-1"></span>**Theorem 4** (P-uniform Kolmogorov three-series theorem). Let  $(X_n)_{n=1}^{\infty}$  be a sequence of independent random variables. Suppose that the following three summation tails decay  $P$ -uniformly for some  $c > 0$ :

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_{P} X_n^{\leq c} \right| = 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_{P} X_n^{\leq c} = 0, \text{ and } \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P(|X_n| > c) = 0.
$$

<span id="page-9-0"></span>Then  $S_n := \sum_{i=1}^n X_i$  is a P-uniform Cauchy sequence, meaning for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n,k \ge m} |S_n - S_k| \ge \varepsilon \right) = 0. \tag{43}
$$

Notice that the first series in [\(42\)](#page-8-5) does not have an exact analogue in Theorem [4](#page-8-1) since the former is not a sum of absolute values of  $(\mathbb{E}_P X_n^{\leq c})_{n=1}^{\infty}$  while that of the latter is. In particular, Theorem [4](#page-8-1) is not a strict generalization of Kolmogorov's three-series theorem in general, but this distinction is inconsequential for the sake of proving (P-uniform or P-pointwise) SLLNs, at least in the i.i.d. and independent but non-i.i.d. settings considered by Kolmogorov, Marcinkiewicz, and Zygmund, as well as Petrov [\[13,](#page-34-10) §IX, Theorem 12]. Indeed, all of their (and our) proofs ultimately upper bound  $\mathbb{E}_P X_n^{\leq c}$  for a mean-zero  $X_n$  by  $\mathbb{E}_P(|X_n| \cdot 1\{|X_n| \leq c\})$  or by  $\mathbb{E}_P(|X_n| \cdot 1\{|X_n| > c\})$ , and hence one can simply analyze  $|\mathbb{E}_P X_n^{\leq c}|$  from the outset. Detailed discussions and proofs can be found in Section [4.1.1.](#page-15-1) Let us now return to and prove Theorem [4.](#page-8-1)

*Proof.* Abusing notation slightly, let  $S_n^{\leqslant c} := \sum_{i=1}^n X_i^{\leqslant c}$ . Note that for any  $m \geqslant 1$ , we have

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n,k \geq m} |S_n - S_k| \geq \varepsilon \right) \tag{44}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \ge k \ge m} |S_n - S_k| \ge \varepsilon \right) \tag{45}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \geq k \geq m} \left| S_n^{\leq c} - S_k^{\leq c} \right| \geq \varepsilon \right) + \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \exists k \geq m : X_k \neq X_k^{\leq c} \right) \tag{46}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \geq k \geq m} \left| S_n^{\leq c} - S_k^{\leq c} \right| \geq \varepsilon \right) + \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |X_k| > c \right). \tag{47}
$$

The second term above vanishes asymptotically by the third series, so it suffices to show that the first term goes to 0 as  $m \to \infty$ . Indeed,

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \ge k \ge m} \left| S_n^{\le c} - S_k^{\le c} \right| \ge \varepsilon \right) \tag{48}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \ge k \ge m} \left| S_n^{\le c} - \mathbb{E}_P S_n^{\le c} + \mathbb{E}_P S_n^{\le c} - \mathbb{E}_P S_k^{\le c} + \mathbb{E}_P S_k^{\le c} - S_k^{\le c} \right| \ge \varepsilon \right) \tag{49}
$$

$$
\leq \underbrace{\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{n \geq k \geq m} \left| S_n^{\leq c} - \mathbb{E}_P S_n^{\leq c} - (S_k^{\leq c} - \mathbb{E}_P (S_k^{\leq c})) \right| \geq \varepsilon/2 \right)}_{\cdot} + \tag{50}
$$

$$
\sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{k \ge n \ge m} |\mathbb{E}_P S_n^{\le c} - \mathbb{E}_P S_k^{\le c}| \ge \varepsilon/2 \right\}.
$$
\n(51)

Now,  $(\star) \rightarrow 0$  by the second series combined with the P-uniform Khintchine-Kolmogorov convergence

theorem (Theorem [3\)](#page-7-4). Turning to  $(\dagger)$ , we have

$$
\sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{k \ge n \ge m} \left| \mathbb{E}_P S_n^{\le c} - \mathbb{E}_P S_k^{\le c} \right| \ge \varepsilon / 2 \right\} \tag{52}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{k \geq m} \sum_{i=m}^{k} \left| \mathbb{E}_{P} X_{i}^{\leq c} \right| \geq \varepsilon/4 \right\} + \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{n \geq m} \sum_{i=m}^{n} \left| \mathbb{E}_{P} X_{i}^{\leq c} \right| \geq \varepsilon/4 \right\}
$$
(53)

$$
= \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{k \ge m} \left| \sum_{i=m}^{k} \mathbb{E}_{P} X_i^{\le c} \right| \ge \varepsilon/4 \right\} + \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sup_{n \ge m} \sum_{i=m}^{n} \left| \mathbb{E}_{P} X_i^{\le c} \right| \ge \varepsilon/4 \right\}
$$
(54)

$$
= \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sum_{i=m}^{\infty} \left| \mathbb{E}_{P} X_{i}^{\leq c} \right| \geq \varepsilon/4 \right\} + \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sum_{i=m}^{\infty} \left| \mathbb{E}_{P} X_{i}^{\leq c} \right| \geq \varepsilon/4 \right\}
$$
(55)

which vanishes as  $m \to \infty$  by the first of the three series, completing the proof.

 $\Box$ 

### <span id="page-10-0"></span>3.3 A distribution-uniform stochastic generalization of Kronecker's lemma

In the classical P-pointwise setting, proofs of strong laws of large numbers rely on a (non-stochastic) convergence result known as Kronecker's lemma which states that if  $(x_n)_{n=1}^{\infty}$  is a sequence of real numbers so that  $\sum_{i=1}^{\infty} x_i = \ell \in \mathbb{R}$ , then for any positive sequence  $b_n \nearrow \infty$ ,

$$
\lim_{n \to \infty} \frac{1}{b_n} \sum_{i=1}^{n} b_i x_i = 0.
$$
\n(56)

This lemma is typically used as follows (consider the Marcinkiewicz-Zygmund SLLN with  $1 < q < 2$  for the sake of example). One first shows via the  $P$ -pointwise Kolmogorov three-series theorem that the sum

$$
\sum_{k=1}^{n} \frac{X_k - \mathbb{E}_P(X)}{k^{1/q}} \tag{57}
$$

is P-almost surely convergent as  $n \to \infty$ , at which point one applies Kronecker's lemma (on the same set of P-probability 1) to justify that

<span id="page-10-2"></span>
$$
\mathbb{P}_P\left(\lim_{n\to\infty}\frac{1}{n^{1/q}}\sum_{i=1}^n(X_i-\mathbb{E}_P(X))=0\right)=1.
$$
 (58)

However, it is not clear how Kronecker's lemma can be used to derive a  $P$ -uniform analogue of  $(58)$ if [\(57\)](#page-10-3) is only shown to be P-uniformly Cauchy and especially if the limiting value  $\ell \equiv \ell(P)$  of (57) is a potentially random quantity whose behavior depends on the distribution  $P \in \mathcal{P}$  itself. Indeed, for the P-uniform case, we introduce an additional uniform stochastic *boundedness* condition given in [\(60\)](#page-10-4). Satisfying [\(60\)](#page-10-4) in pursuit of proving Theorems [1\(](#page-3-2)i), [1\(](#page-3-2)ii), and [2](#page-6-0) requires additional care (the details of which can be found in Section  $4.1.2$ ), while this subtlety is easily sidestepped in the  $P$ -pointwise setting. Nevertheless, the following lemma serves as a stochastic and P-uniform generalization of Kronecker's lemma that lends itself naturally to our goals and reduces to the usual P-almost sure application of Kronecker's lemma when  $P = {P}$  is a singleton.

<span id="page-10-1"></span>**Lemma 1** (A P-uniform stochastic generalization of Kronecker's lemma). Let  $(Z_n)_{n=1}^{\infty}$  be a sequence of random variables so that their partial sums  $S_n := \sum_{i=1}^n Z_i$  form a P-uniform Cauchy sequence, meaning for any  $\varepsilon > 0$ ,

<span id="page-10-5"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k,n \ge m} |S_k - S_n| \ge \varepsilon \right) = 0. \tag{59}
$$

Moreover, assume that  $S_n = O_{\mathcal{P}}(1)$ , meaning for any  $\delta > 0$ , there exists  $N, B > 0$  so that for any  $n \ge N$ ,

<span id="page-10-4"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| > B) < \delta. \tag{60}
$$

Let  $b_n \nearrow \infty$  be a positive, nondecreasing, and diverging sequence. Then,  $b_n^{-1} \sum_{i=1}^n b_i Z_i$  vanishes  $\mathcal{P}$ uniformly: for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^k b_i Z_i \right| \ge \varepsilon \right) = 0. \tag{61}
$$

*Proof.* Fix any  $\varepsilon > 0$  and any  $\delta > 0$ . Our goal is to show that for all m sufficiently large,

**Goal:** 
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^k b_i Z_i \right| \ge \varepsilon \right) < 4\delta,
$$
 (62)

where the factor of 4 is only included for mathematical convenience later on. Using the assumptions of the theorem in [\(59\)](#page-10-5) and [\(60\)](#page-10-4), let  $B > 0$  and choose N sufficiently large so that for any  $m \ge N$ ,

<span id="page-11-5"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k,n \ge m} |S_n - S_k| \ge \varepsilon/6 \right) < \delta,\tag{63}
$$

and so that

<span id="page-11-6"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_m| \geq B) < \delta. \tag{64}
$$

Again using [\(60\)](#page-10-4) and the assumption that  $b_n \nearrow \infty$ , let  $N^* \equiv N^*(\varepsilon, B, N) \geq N$  be sufficiently large so that

<span id="page-11-7"></span><span id="page-11-4"></span><span id="page-11-3"></span><span id="page-11-2"></span><span id="page-11-1"></span><span id="page-11-0"></span>
$$
\frac{\varepsilon b_{N^{\star}}}{6b_N} \ge B,\tag{65}
$$

and so that

<span id="page-11-8"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \sum_{i=1}^{N-1} S_i \right| \ge \frac{\varepsilon b_{N^*}}{6b_N} \right) < \delta,\tag{66}
$$

where we can impose the latter condition since  $\sum_{i=1}^{N-1} S_i = \dot{O}_{\mathcal{P}}(1)$  for any fixed N and we can take  $\varepsilon b_{N^*}/6b_N$  to be arbitrarily large for any fixed N and  $\varepsilon$ . Then for all  $m \geq N^*$ ,

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^k b_i Z_i \right| \ge \varepsilon \right) \tag{67}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| S_k - \frac{1}{b_k} \sum_{i=1}^{k-1} (b_{i+1} - b_i) S_i \right| \ge \varepsilon \right) \tag{68}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| S_k - \frac{1}{b_k} \sum_{i=1}^{N-1} (b_{i+1} - b_i) S_i - \frac{b_k - b_N}{b_k} \cdot S_m - \frac{1}{b_k} \sum_{i=N}^{k-1} (b_{i+1} - b_i) (S_i - S_m) \right| \ge \varepsilon \right) \tag{69}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} \left| S_k - \frac{b_k - b_N}{b_k} S_m \right| \geq \varepsilon/3 \right) + \tag{70}
$$

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^{N-1} (b_{i+1} - b_i) S_i \right| \ge \varepsilon/3 \right) + \tag{71}
$$

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=N}^{k-1} (b_{i+1} - b_i)(S_i - S_m) \right| \ge \varepsilon/3 \right),\tag{72}
$$

where [\(68\)](#page-11-0) follows from summation by parts, [\(69\)](#page-11-1) follows from breaking the sum up into  $i = 1, \ldots, N - 1$ and  $i = N, \ldots, k - 1$  and simplifying the telescoping sum, and [\(70\)](#page-11-2) follows from the triangle inequality. We will now bound the terms in  $(70)$ ,  $(71)$ , and  $(72)$  separately.

**Bounding** [\(70\)](#page-11-2) by 2 $\delta$ . For any  $m \ge N^*$ , we have

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| S_k - \frac{b_k - b_N}{b_k} S_m \right| \ge \varepsilon/3 \right) \tag{73}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} |S_k - S_m| \geq \varepsilon/6 \right) + \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} \left| \frac{b_N}{b_k} S_m \right| \geq \varepsilon/6 \right) \tag{74}
$$

$$
\leq \underbrace{\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} |S_k - S_m| \geq \varepsilon/6 \right)}_{\leq \delta} + \underbrace{\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( |S_m| \geq \frac{\varepsilon b_m}{6b_N} \right)}_{\leq \delta} \tag{75}
$$

$$
\langle \delta \rangle < 2\delta,\tag{76}
$$

where the last inequality follows from the conditions imposed on  $N^* \ge N$  in [\(63\)](#page-11-5) and [\(64\)](#page-11-6) combined with the fact that  $\varepsilon b_m/6b_N \ge B$  for all  $m \ge N^*$  as in [\(65\)](#page-11-7).

**Bounding** [\(71\)](#page-11-3) by  $\delta$ . For any  $m \ge N^*$ , we have

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^{N-1} (b_{i+1} - b_i) S_i \right| \ge \varepsilon/3 \right) \tag{77}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \sum_{i=1}^{N-1} (b_{i+1} - b_i) S_i \right| \geq \varepsilon b_m/3 \right) \tag{78}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \sum_{i=1}^{N-1} S_i \right| \geqslant \frac{\varepsilon b_m}{3b_N} \right) \tag{79}
$$

$$
\langle \delta, \rangle \tag{80}
$$

where the last inequality follows from the condition imposed on  $N^*$  in [\(66\)](#page-11-8).

**Bounding** [\(72\)](#page-11-4) by  $\delta$ . For any  $m \geq N$ , we have

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=N}^{k-1} (b_{i+1} - b_i)(S_i - S_m) \right| \ge \varepsilon/3 \right) \tag{81}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} \frac{1}{b_k} \sum_{i=N}^{k-1} (b_{i+1} - b_i) |S_i - S_m| \geq \varepsilon/3 \right) \tag{82}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq m} \frac{1}{b_k} \sum_{i=N}^{k-1} (b_{i+1} - b_i) \varepsilon / 6 \geq \varepsilon / 3 \right) + \sup_{\underline{P} \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \geq N} |S_k - S_m| \geq \varepsilon / 6 \right) \tag{83}
$$

$$
<\n\sup_{P \in \mathcal{P}} \mathbb{1}\n\left\{\n\sup_{k \geq m} \frac{b_k - b_N}{b_k} \geq 2\n\right\} + \delta\n\tag{84}
$$

$$
= \delta,\tag{85}
$$

which follows from the conditions imposed on N in [\(63\)](#page-11-5) and the fact that  $\sup_{k\geq m}(b_k - b_N)/b_k \leq 1$ . Putting the bounds in [\(70\)](#page-11-2), [\(71\)](#page-11-3), and [\(72\)](#page-11-4) together, we have that for any  $m \ge N^{\star}$ ,

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{b_k} \sum_{i=1}^k b_i Z_i \right| \ge \varepsilon \right) < 4\delta,\tag{86}
$$

which yields the desired result, completing the proof.

#### <span id="page-13-0"></span>3.4 Distribution-uniform Borel-Cantelli lemmas

In order to show that  $\mathcal{P}\text{-}\mathrm{UI}$  of certain finite absolute moments is in fact *necessary* for the  $\mathcal{P}\text{-}\mathrm{uniform}$ SLLN to hold — i.e. the result of Theorem  $1(iii)$  $1(iii)$  — we rely on a P-uniform generalization of the second Borel-Cantelli lemma. Before discussing the second Borel-Cantelli lemma, let us briefly discuss the first. A natural desideratum for a  $\mathcal{P}$ -uniform first Borel-Cantelli lemma would be to say that for events  $(E_n)_{n=1}^{\infty}$ in F, if  $\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P(E_n) = 0$ , then  $\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P(\bigcup_{k=m}^{\infty} E_k) = 0$ . Indeed, this is trivially satisfied since

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}\left(\bigcup_{k=m}^{\infty} E_k\right) \le \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P\left(E_k\right). \tag{87}
$$

For this reason, we do not dwell on the first Borel-Cantelli lemma, but instead shift our attention to the second since its P-uniform generalization (and the proof thereof) is nontrivial in comparison and is central to the proof of Theorem [1\(](#page-3-2)iii).

<span id="page-13-2"></span>**Lemma 2** (The second  $\mathcal{P}$ -uniform Borel-Cantelli lemma). Let  $(E_n)_{n=1}^{\infty}$  be independent events such that

<span id="page-13-7"></span>
$$
0 < \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P(E_k) \leq \infty. \tag{88}
$$

Then the probability of infinitely many of them occurring does not  $P$ -uniformly vanish, i.e.

<span id="page-13-3"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \bigcup_{k=m}^{\infty} E_k \right) > 0. \tag{89}
$$

*Proof.* The proof proceeds by a direct calculation. Writing out the limit in  $(89)$ , we have

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \bigcup_{k=m}^{\infty} E_k \right) = \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \left\{ 1 - \mathbb{P}_P \left( \bigcap_{k=m}^{\infty} E_k^c \right) \right\}
$$
(90)

<span id="page-13-4"></span>
$$
= 1 - \lim_{m \to \infty} \inf_{P \in \mathcal{P}} \lim_{t \to \infty} \mathbb{P}_P \left( \bigcap_{k=m}^t E_k^c \right)
$$
 (91)

<span id="page-13-5"></span>
$$
= 1 - \lim_{m \to \infty} \inf_{P \in \mathcal{P}} \lim_{t \to \infty} \prod_{k=m}^{t} (1 - \mathbb{P}_P(E_k))
$$
\n(92)

$$
\geq 1 - \lim_{m \to \infty} \inf_{P \in \mathcal{P}} \lim_{t \to \infty} \exp \left\{-\sum_{k=m}^{t} \mathbb{P}_P(E_k)\right\} \tag{93}
$$

<span id="page-13-6"></span>
$$
= 1 - \exp\left\{-\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P(E_k)\right\} > 0,
$$
\n(94)

where [\(91\)](#page-13-4) follows from the fact that the intersections  $(\bigcap_k^t E_k)_{t=1}^{\infty}$  are nested, [\(92\)](#page-13-5) exploits independence of  $(E_n)_{n=1}^{\infty}$ , and [\(94\)](#page-13-6) follows from the assumption in [\(88\)](#page-13-7). This completes the proof.

# <span id="page-13-1"></span>4 Proof details for Theorems [1](#page-3-2) and [2](#page-6-0)

Given the distribution-uniform analogues of Kolmogorov's three-series theorem (Theorem [4\)](#page-8-1), Kronecker's lemma (Lemma [1\)](#page-10-1), and the second Borel-Cantelli lemma (Lemma [2\)](#page-13-2), we are ready to provide complete and detailed proofs for our main results in Theorems [1](#page-3-2) and [2.](#page-6-0)

### <span id="page-14-5"></span><span id="page-14-0"></span>4.1 Proof of Theorem [1](#page-3-2)

*Proof of Theorem [1\(](#page-3-2)i).* As mentioned in the proof outline, we focus on the case of  $1 < q < 2$  since  $q = 1$ corresponds to the SLLN of Chung  $[5]$ . By Lemma [3](#page-15-0) (the proof of which we defer to Section [4.1.1\)](#page-15-1), we have that the P-UI condition

<span id="page-14-1"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|X - \mathbb{E}_P(X)|^q \cdot \mathbb{1}\{|X - \mathbb{E}_P(X)|^q > m\}) = 0 \tag{95}
$$

implies that the three series in Theorem [4](#page-8-1) vanish  $P$ -uniformly with  $c = 1$  as follows:

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{E}_P Z_k^{\leq 1} = 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \text{Var}_P Z_k^{\leq 1} = 0, \text{ and } \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P (|Z_k| > 1) = 0, \tag{96}
$$

where  $Z_k^{\leq 1}$  is the scaled and truncated version of  $X_k$  given by

$$
Z_k^{\le 1} := \frac{X_k - \mathbb{E}_P(X)}{k^{1/q}} \cdot 1\{|X_k - \mathbb{E}_P(X)| \le k^{1/q}\}.
$$
 (97)

Therefore, by the P-uniform three series theorem (Theorem [4\)](#page-8-1) we have that  $S_n \equiv S_n(P) := \sum_{k=1}^n (X_k \mathbb{E}_P(X)/k^{1/q}$  forms a P-uniform Cauchy sequence, meaning that for any  $\varepsilon > 0$ ,

<span id="page-14-2"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k,n \ge m} |S_k - S_n| \ge \varepsilon \right) = 0. \tag{98}
$$

Moreover, by Lemma [7](#page-24-0) combined with Theorem [5,](#page-22-0) we have that the  $\mathcal{P}\text{-}\mathrm{UI}$  condition [\(95\)](#page-14-1) implies that  $S_n$  is P-uniformly bounded in probability, meaning for any  $\delta > 0$ , there exists  $N, B \geq 1$  so that for any  $n \geq N$ ,

<span id="page-14-3"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| \ge B) < \delta. \tag{99}
$$

Combining  $(98)$  and  $(99)$ , we invoke the P-uniform Kronecker lemma (Lemma [1\)](#page-10-1) with the sequence  $(b_n)_{n=1}^{\infty}$  given by  $b_n := n^{1/q}$  to yield that for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k^{1/q}} \sum_{i=1}^k (X_k - \mathbb{E}_P(X)) \right| \ge \varepsilon \right) = 0, \tag{100}
$$

which completes the proof of Theorem [1\(](#page-3-2)i).

*Proof of Theorem*  $1(ii)$  $1(ii)$ *.* By Lemma [4,](#page-19-0) the P-UI condition

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X|^q \mathbb{1} \{ |X|^q > m \} \right) = 0 \tag{101}
$$

implies that the three series in Theorem [4](#page-8-1) vanish  $\mathcal{P}\text{-uniformly with } c = 1$  and with the random variables  $(Z_k)_{k=1}^\infty$  given by

$$
Z_k^{\le 1} := \frac{X_k}{k^{1/q}} \cdot \mathbb{1}\left\{|X| \le k^{1/q}\right\},\tag{102}
$$

and thus the partial sums  $S_n := \sum_{k=1}^n X_k / k^{1/q}$  are P-uniformly Cauchy. Similar to the proof of Theo-rem [1\(](#page-3-2)i), we have by Lemma [8](#page-27-0) combined with Theorem [5](#page-22-0) that  $S_n := \sum_{k=1}^n X_k$  is P-uniformly bounded in probability. Instantiating the  $P$ -uniform Kronecker lemma (Lemma [1\)](#page-10-1) with the sequence  $(b_n)_{n=1}^{\infty}$  given by  $n^{1/q}$ , we have the desired result. Е

*Proof of Theorem [1\(](#page-3-2)iii).* Suppose that  $P$  is a class of distributions for which the P-UI condition in [\(14\)](#page-4-0) does not hold. Then we aim to show that

<span id="page-14-4"></span>**Goal:** 
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{k^{1/q}} \sum_{i=1}^k (X_i - \mu(P; q)) \right| \ge \frac{1}{2} \right) > 0,
$$
 (103)

<span id="page-15-3"></span>recalling that  $\mu(P; q) = \mathbb{E}_P(X)$  when  $1 \leq q < 2$  and  $\mu(P; q) = 0$  when  $0 < q < 1$ . Consider the partial sums  $S_n := \sum_{i=1}^n (X_i - \mu(P; q))$  and note that for each  $P \in \mathcal{P}$ ,

$$
\mathbb{P}_P\left(\sup_{k\geq m}\frac{1}{k^{1/q}}\left|X-\mu(P;q)\right|\geqslant 1\right) \tag{104}
$$

$$
\leqslant \mathbb{P}_P\left(\sup_{k\geqslant m}\frac{1}{k^{1/q}}(|S_k|+|S_{k-1}|)\geqslant 1\right) \tag{105}
$$

$$
\leqslant \mathbb{P}_P\left(\sup_{k\geqslant m-1}\frac{1}{k^{1/q}}|S_k|\geqslant 1/2\right)+\mathbb{P}_P\left(\sup_{k\geqslant m-1}\frac{1}{k^{1/q}}|S_k|\geqslant 1/2\right) \tag{106}
$$

$$
=2\mathbb{P}_P\left(\sup_{k\geq m-1}\left|\frac{1}{k^{1/q}}\sum_{i=1}^k(X_i-\mu(P;q))\right|\geq 1/2\right),\tag{107}
$$

and hence by the  $P$ -uniform second Borel-Cantelli lemma (Lemma [2\)](#page-13-2), it suffices to show that

<span id="page-15-2"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |X - \mu(P; q)| > k^{1/q} \right) > 0,
$$
\n(108)

from which we will obtain  $(103)$ . Indeed, by Hu and Zhou [\[8,](#page-34-8) Theorem 2.1] — or as shown directly in Lemma  $9$  — we have that for any random variable Y,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P(|Y| > k) = 0 \quad \text{if and only if} \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P(|Y| \mathbb{1}{\{|Y| > m\}}) = 0,\tag{109}
$$

and hence if the  $q^{\text{th}}$  moment is not P-UI, we must have that [\(108\)](#page-15-2) holds. This completes the proof.

### <span id="page-15-1"></span>4.1.1 Sufficient conditions for the  $P$ -uniform Kolmogorov three-series theorem

In what follows, we verify that the tails of the three series of Theorem [4](#page-8-1) vanish  $\mathcal{P}\text{-uniformly when }X$  has a  $\mathcal{P}\text{-UI } q^{\text{th}}$  moment, thereby enabling the application of the  $\mathcal{P}\text{-uniform }$  Kolmogorov three-series theorem. Lemmas [3](#page-15-0) and [4](#page-19-0) consider the cases of  $1 < q < 2$  and  $0 < q < 1$ , respectively.

<span id="page-15-0"></span>**Lemma 3** (Sufficient conditions in the identically distributed case when  $1 < q < 2$ ). Let  $(X_n)_{n=1}^{\infty}$  be i.i.d. random variables on the probability spaces  $(\Omega, \mathcal{F}, \mathcal{P})$  and let  $Y_n := X_n - \mathbb{E}_P X$  be their centered versions for each  $P \in \mathcal{P}$ . Suppose that the  $q^{th}$  moment is UI for some  $1 < q < 2$ :

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \mathbf{1}\{|Y|^q > m\} \right) = 0. \tag{110}
$$

Then, the three conditions of the P-uniform Kolmogorov three-series theorem are satisfied for

$$
Z_n := \frac{Y_n}{n^{1/q}}\tag{111}
$$

with  $c = 1$ , meaning that

 $\sim$ 

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_{P} Z_n^{\leq 1} \right| = 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_{P} (Z_n^{\leq 1}) = 0, \quad \text{and} \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P \left( |Z_n^{\leq 1}| > 1 \right) = 0,
$$
\n
$$
\text{where } Z_n^{\leq 1} := Z_n \mathbb{1} \{ Y_n \leq n^{1/q} \}.
$$

*Proof.* Consider the truncated random variables  $Y_n^{\le}$  and  $Z_n^{\leq 1}$  given by

$$
Y_n^{\leq} := \begin{cases} Y_n & \text{if } |Y_n| \leq n^{1/q} \\ 0 & \text{if } |Y_n| > n^{1/q}. \end{cases} \quad \text{and} \quad Z_n^{\leq 1} := \begin{cases} Z_n & \text{if } |Z_n| \leq 1 \\ 0 & \text{if } |Z_n| > 1, \end{cases}
$$
 (112)

respectively. Let us now separately show that the tails of the three series vanish P-uniformly.

**The first series.** Writing out the first series  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} |\mathbb{E}_P Z_n^{\leq 1}|$  for any  $m \geq 1$  and performing a direct calculation, we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_{P} Z_{n}^{\leq 1} \right| = \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_{P} \left( \frac{Y1(|Y| \leq n^{1/q})}{n^{1/q}} \right) \right| \tag{113}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P \left( \frac{-Y \mathbb{1}(|Y| > n^{1/q})}{n^{1/q}} \right) \right| \tag{114}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P \left( \frac{|Y| \mathbb{1}(|Y| > n^{1/q})}{n^{1/q}} \right) \tag{115}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \sum_{k=n}^{\infty} \mathbb{E}_P \left( \frac{|Y| \mathbb{1}(k^{1/q} < |Y| \leqslant (k+1)^{1/q})}{n^{1/q}} \right) \tag{116}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=n}^{\infty} \mathbb{1}(k \geqslant n \geqslant m) \cdot \mathbb{E}_P\left(\frac{|Y| \mathbb{1}(k^{1/q} < |Y| \leqslant (k+1)^{1/q})}{n^{1/q}}\right) \tag{117}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \sum_{n=m}^{k} \mathbb{E}_P \left( \frac{|Y| \mathbb{1}(k^{1/q} < |Y| \leq (k+1)^{1/q})}{n^{1/q}} \right) \tag{118}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{E}_P \left( |Y| \mathbb{1}(k^{1/q} < |Y| \leq (k+1)^{1/q}) \right) \cdot \sum_{n=1}^{k} \frac{1}{n^{1/q}}. \tag{119}
$$

Now, there exists some constant  $C_q > 0$  depending only on q so that  $\sum_{n=1}^{k} 1/n^{1/q} \leqslant C_q k/(k+1)^{1/q}$  and thus

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P Z_n^{\leq 1} \right| \leq \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{E}_P \left( |Y| \mathbb{1}(k^{1/q} < |Y| \leq (k+1)^{1/q}) \right) \cdot C_q \frac{k}{(k+1)^{1/q}} \tag{120}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} (k+1)^{1/q} \mathbb{P}_P \left( k^{1/q} < |Y| \leqslant (k+1)^{1/q} \right) \cdot C_q \frac{k}{(k+1)^{1/q}} \tag{121}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} k \mathbb{P}_P \left( k^{1/q} < |Y| \le (k+1)^{1/q} \right). \tag{122}
$$

Through another direct calculation, we have that

$$
C_q \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} k \mathbb{P}_P \left( k^{1/q} < |Y| \le (k+1)^{1/q} \right) \tag{123}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=1}^{k} \mathbb{1}(k \geq m \vee n) \cdot \mathbb{P}_P \left( k^{1/q} < |Y| \leq (k+1)^{1/q} \right) \tag{124}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=m \vee n}^{\infty} \mathbb{P}_P \left( k^{1/q} < |Y| \le (k+1)^{1/q} \right) \tag{125}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P \left( |Y|^q > (m \vee n) \right). \tag{126}
$$

Noticing that  $|Y|^q > (m \vee n)$  if and only if  $|Y|^q 1\{|Y|^q > m \vee n\} > (m \vee n)$ , we have that

$$
C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P\left(|Y|^q > (m \vee n)\right) = C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P\left(|Y|^q \mathbb{1}\{|Y|^q > m \vee n\} > (m \vee n)\right) \tag{127}
$$

$$
\leqslant C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > m \} > n \right) \tag{128}
$$

$$
\leqslant C_q \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > m \} \right),\tag{129}
$$

and hence by the  $\mathcal{P}\text{-UI}$  of the  $q^{\text{th}}$  moment as in [\(14\)](#page-4-0), we have that

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P Z_n^{\leq 1} \right| = 0,
$$
\n(130)

which completes the proof for the first of the three series.

**The second series.** Writing out the second series  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P(Z_n^{\leq 1})$  for any  $m \geq 1$  and performing a direct calculation, we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq 1} = \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left\{ \mathbb{E}_P \left[ (Z_n^{\leq 1})^2 \right] - \left[ \mathbb{E}_P Z_n^{\leq 1} \right]^2 \right\} \tag{131}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P[(Z_n^{\leq 1})^2]
$$
\n(132)

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{1}\{n \geq m\} \cdot \mathbb{E}_P\left[\frac{Y^2}{n^{2/q}} \mathbb{1}\{|Y| \leq n^{1/q}\}\right]
$$
\n(133)

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=1}^{n} \mathbb{1}\{n \geq m\} \cdot \mathbb{E}_P \left[ \frac{Y^2}{n^{2/q}} \mathbb{1}\{(k-1)^{1/q} < |Y| \leq k^{1/q}\} \right] \tag{134}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=k}^{\infty} \mathbb{1}\{n \geq k \vee m\} \cdot \mathbb{E}_P \left[ \frac{Y^2}{n^{2/q}} \mathbb{1}\{(k-1)^{1/q} < |Y| \leq k^{1/q}\} \right] \tag{135}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] \sum_{n=k \vee m}^{\infty} \frac{1}{n^{2/q}}. \tag{136}
$$

Now, notice that there exists a constant  $C_q > 0$  depending only on q so that  $\sum_{n=k \vee m}^{\infty} 1/n^{2/q} \leq k \vee$  $m)/(k \vee m)^{2/q}$ , and hence we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq 1} \leq C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \frac{(k \vee m)}{(k \vee m)^{2/q}} \cdot \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] \tag{137}
$$

$$
\leq C_q \left\{ \sup_{\substack{P \in \mathcal{P} \\ k=1}} \sum_{k=1}^m \frac{m}{m^{2/q}} \cdot \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] + \right. \tag{138}
$$

$$
\underbrace{\sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{2/q}} \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right]}_{\text{(139)}},\tag{139}
$$

and we will now separately show that  $(\star_{\leq}) \to 0$  and  $(\star_{\geq}) \to 0$  as  $m \to \infty$ . By Lemma [5,](#page-21-0) let  $\varphi(x) \equiv$  $xh(x); x \ge 0$  be a function where  $h(x) \ge 1$  is nondecreasing and diverging to  $\infty$  no faster than  $x \mapsto \log x$ so that

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P \varphi(|Y|^q) < \infty. \tag{140}
$$

Then, writing out  $(\star_{\leqslant})$ , we have that

$$
(\star_{\leqslant}) := \sup_{P \in \mathcal{P}} \sum_{k=1}^{m} \frac{m}{m^{2/q}} \cdot \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] \tag{141}
$$

$$
= m \cdot \sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ \frac{Y^2}{m^{2/q}} \mathbb{1} \{ |Y| \le m^{1/q} \} \right] \tag{142}
$$

<span id="page-18-0"></span>
$$
\leq m \cdot \sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ \frac{\varphi(|Y|^q)}{\varphi(m)} \mathbb{1}\{|Y| \leq m^{1/q}\} \right] \tag{143}
$$

$$
\leqslant \mathcal{M} \cdot \sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ \frac{\varphi(|Y|^q)}{\mathcal{M} \cdot h(m)} \right] \tag{144}
$$

$$
= \underbrace{\frac{1}{h(m)}}_{\to 0} \underbrace{\sup_{P \in \mathcal{P}} \mathbb{E}_P \varphi(|Y|^q)}_{\lt \infty},\tag{145}
$$

where [\(143\)](#page-18-0) follows from Lemma [6.](#page-22-2) Therefore,  $\lim_{m\to\infty}(\star_{\leq})=0$ . Now, let us show that  $\lim_{m\to\infty}(\star_{\geq})=0$ . Indeed, writing out  $(\star_{\geqslant}),$ 

$$
(\star_{\geqslant}) := \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{2/q}} \mathbb{E}_P \left[ Y^2 \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] \tag{146}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{2/4}} \mathbb{E}_P \left[ k^{2/4} \mathbb{1} \{ (k-1)^{1/q} < |Y| \leq k^{1/q} \} \right] \tag{147}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} k \mathbb{P}_P \left( (k-1)^{1/q} < |Y| \leqslant k^{1/q} \right),\tag{148}
$$

and the above vanishes as  $m \to \infty$  by the proof for the first series. Putting both the analysis for  $(\star_{\leq})$ and  $(\star_{\geqslant})$  together, we have that

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq 1} = 0,
$$
\n(149)

completing the proof for the second series.

**The third series.** Writing out the third series  $\sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P(|Y/k^{1/q}| > 1)$  for any  $m \ge 1$ , we have that

$$
\sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( \left| \frac{Y}{k^{1/q}} \right| > 1 \right) \tag{150}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{1}(k \ge m) \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > k\} > k), \tag{151}
$$

where the equality follows from the fact that  $|Y|^q > k$  if and only if  $|Y|^q 1\{|Y|^q > k\} > k$ . Continuing from the above, we have

$$
\sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{1}(k \geqslant m) \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > k\} > k)
$$
\n
$$
(152)
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{1}(k \geq m) \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k),\tag{153}
$$

since  $\mathbb{P}(|Y|^q 1\{|Y|^q > k\} > k) \leq \mathbb{P}(|Y|^q 1\{|Y|^q > m\} > k)$  whenever  $k \geq m$ . Finally, we use the expectation-tail sum identity:

$$
\sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{1}(k \ge m) \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k)
$$
\n(154)

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k) \tag{155}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > m \} \right), \tag{156}
$$

and thus using the  $\mathcal{P}\text{-}\mathrm{UI} q^{\text{th}}$  moment of Y, we have that

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |Y| > k^{1/q} \right) = 0,
$$
\n(157)

<span id="page-19-0"></span>completing the proof of the third series, and hence the entire lemma.

**Lemma 4** (Sufficient conditions for the three series with  $0 < q < 1$ ). Given the same setup as Lemma [3,](#page-15-0) suppose that X has a  $P$ -UI (uncentered)  $q^{th}$  moment for some  $0 < q < 1$ :

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X|^q \mathbb{1} \{ |X|^q > m \} \right) = 0. \tag{158}
$$

Then, the three conditions of the P-uniform Kolmogorov three-series theorem are satisfied for

$$
Z_n := \frac{X_n}{n^{1/q}}\tag{159}
$$

with  $c = 1$ , meaning that

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_{P} Z_n^{\leq 1} \right| = 0, \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_{P} (Z_n^{\leq 1}) = 0, \quad \text{and} \quad \lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P \left( |Z_n^{\leq 1}| > 1 \right) = 0,
$$
\n
$$
\text{where } Z_n^{\leq 1} := Z_n \mathbb{1} \{ X_n \leq n^{1/q} \}.
$$

*Proof.* The proofs for the second and third series are identical to those when  $1 < q < 2$  as in Lemma [3](#page-15-0) and thus we focus solely on the first series here. Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P(|X|1(|X| \leq n^{1/q})/n^{1/q}),$ we have that

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P Z_n^{\leq 1} \right| \leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P \left( \frac{|X| \mathbb{1}(|X| \leq n^{1/q})}{n^{1/q}} \right)
$$
(160)

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=1}^{n} \mathbb{1}\{n \geq k \vee m\} \mathbb{E}_P\left(\frac{|X| \mathbb{1}\{(k-1)^{1/q} < |X| \leq k^{1/q}\}}{n^{1/q}}\right) \tag{161}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=k}^{\infty} \mathbb{1}\{n \geq k \vee m\} \mathbb{E}_P\left(\frac{|X| \mathbb{1}\{(k-1)^{1/q} < |X| \leq k^{1/q}\}}{n^{1/q}}\right) \tag{162}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left( |X| \mathbb{1}\{(k-1)^{1/q} < |X| \leq k^{1/q} \} \right) \sum_{n=k \vee m}^{\infty} \frac{1}{n^{1/q}},\tag{163}
$$

and thus there exists  $C_q > 0$  depending only on  $q$  so that

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P Z_n^{\leq 1} \leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left( |X| \mathbb{1}\{(k-1)^{1/q} < |X| \leq k^{1/q}\} \right) \cdot C_q \frac{k \vee m}{(k \vee m)^{1/q}} \tag{164}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^m \frac{m}{m^{1/q}} \cdot \mathbb{E}_P \left( |X| \mathbb{1} \left\{ (k-1)^{1/q} < |X| \leq k^{1/q} \right\} \right) + \tag{165}
$$

$$
C_q \underbrace{\sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{1/q}} \cdot \mathbb{E}_P \left( |X| \mathbb{1} \left\{ (k-1)^{1/q} < |X| \leq k^{1/q} \right\} \right)}_{\text{(*)}},\tag{166}
$$

and thus similarly to the proof for the second series in Lemma [3,](#page-15-0) it suffices to show that  $(\star_{\leq}) \to 0$  and  $(\star_{\geqslant})\to 0$  as  $m\to\infty.$  Turning to  $(\star_{\leqslant})$  first, we have

$$
(\star_{\leqslant}) = \sup_{P \in \mathcal{P}} \sum_{k=1}^{m} \frac{m}{m^{1/q}} \cdot \mathbb{E}_P \left( |X| \mathbb{1} \left\{ (k-1)^{1/q} < |X| \leqslant k^{1/q} \right\} \right) \tag{167}
$$

$$
= \sup_{P \in \mathcal{P}} m \cdot \mathbb{E}_P \left( \frac{|X|}{m^{1/q}} \mathbb{1} \left\{ |X| \leq m^{1/q} \right\} \right). \tag{168}
$$

By Lemma [5,](#page-21-0) there exists a function  $\varphi(x) = xh(x); x \ge 0$  where  $h(x) \ge 1$  is nondecreasing and diverges to  $\infty$  no faster than  $x \mapsto \log x$  so that

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P \varphi(|X|^q) < \infty. \tag{169}
$$

Moreover, instantiating Lemma [6](#page-22-2) with  $u = 1$ , we have that  $|X|/m^{1/q} \leq \varphi(|X|^q)/\varphi(m)$  whenever  $|X| \leq$  $m^{1/q}$  and thus

$$
(\star_{\leqslant}) \leqslant \sup_{P \in \mathcal{P}} m \cdot \mathbb{E}_P \left( \frac{|X|}{m^{1/q}} \mathbb{1} \left\{ |X| \leqslant m^{1/q} \right\} \right) \tag{170}
$$

$$
\leq \sup_{P \in \mathcal{P}} m \cdot \mathbb{E}_P \left( \frac{\varphi(|X|^q)}{\varphi(m)} \right) \tag{171}
$$

$$
= \frac{pt}{pth(m)} \underbrace{\sup_{P \in \mathcal{P}} \mathbb{E}_P \varphi(|X|^q)}_{\lt \infty},\tag{172}
$$

<span id="page-21-1"></span>and since  $\lim_{m\to\infty} h(m) = \infty$ , we have that  $\lim_{m\to\infty} (\star_{\leq}) = 0$ . Moving to  $(\star_{\geq})$ , we have that

$$
(\star_{\geqslant}) = \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{1/q}} \cdot \mathbb{E}_P \left( |X| \mathbb{1} \left\{ (k-1)^{1/q} < |X| \leqslant k^{1/q} \right\} \right) \tag{173}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{k}{k^{1/q}} \cdot \mathbb{E}_P \left( k^{1/q} \mathbb{1} \left\{ (k-1)^{1/q} < |X| \leqslant k^{1/q} \right\} \right) \tag{174}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} k \cdot \mathbb{P}_P \left( (k-1)^{1/q} < |X| \leq k^{1/q} \right) \tag{175}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=1}^{k} \mathbb{1}(k \ge m) \cdot \mathbb{P}_P \left( (k-1)^{1/q} < |X| \le k^{1/q} \right) \tag{176}

$$
=\sup_{P\in\mathcal{P}}\sum_{n=1}^{\infty}\sum_{k=n\times m}^{\infty}\mathbb{P}_P\left((k-1)^{1/q}<|X|\leqslant k^{1/q}\right) \tag{177}

$$
= \sup_{P \in \mathcal{P}} \sum_{n=0}^{\infty} \mathbb{P}_P \left( |X|^q > n \vee m \right) \tag{178}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=0}^{\infty} \mathbb{P}_P \left( |X|^q \mathbb{1} \{ |X|^q > n \vee m \} > n \vee m \right) \tag{179}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \mathbb{P}_P(|X|^q \mathbb{1}\{|X|^q > m\} > m) + \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P(|X|^q \mathbb{1}\{|X|^q > n \vee m\} > n \vee m) \tag{180}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P(|X|^q > m) + \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P(|X|^q \mathbb{1}\{|X|^q > m\} > n) \tag{181}
$$

$$
\leq \underbrace{\sup_{P \in \mathcal{P}} \mathbb{E}_P |X|^q / m}_{\leq \infty} + \underbrace{\sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X|^q \mathbb{1} \left\{ |X|^q > m \right\} \right)}_{\leq \infty},\tag{182}
$$

<span id="page-21-0"></span>and thus by the P-UI condition, we have that  $\lim_{m\to\infty}(\star_{\geq})=0$ , completing the proof of Lemma [4.](#page-19-0)  $\Box$ **Lemma 5.** Let  $0 < q < 2$  and suppose that the (potentially uncentered)  $q^{th}$  moment of Y is UI, meaning that

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \mathbb{1}(|Y|^q > m) \right) = 0. \tag{183}
$$

Then there exists a nondecreasing function  $\varphi$  that can be written as  $\varphi(x) = xh(x)$  for any  $x \geq 0$  where  $h(x) \geq 1$  is nondecreasing and diverges to  $\infty$  no faster than  $\log(x)$  so that

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ \varphi(|Y|^q) \right] < \infty. \tag{184}
$$

*Proof.* By the criterion of uniform integrability due to Charles de la Vallée Poussin (see Chong  $[3]$ , Hu and Rosalsky [\[7\]](#page-34-7), or Chandra [\[1\]](#page-33-1)), we have that there exists a function  $\varphi^* : \mathbb{R}^{\geq 0} \to \mathbb{R}^{\geq 0}$  growing faster than  $x \mapsto x$  — meaning that  $\lim_{x \to \infty} \varphi^*(x)/x = \infty$  — so that

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ \varphi^{\star}(|Y|^q) \right] < \infty. \tag{185}
$$

Define  $h^*(x) := x^{-1}\varphi^*(x)1\!\!1(x>0)$ , noting that  $h^*$  diverges to  $\infty$ . From this, define  $h : \mathbb{R}^{\geq 0} \to \mathbb{R}^{\geq 0}$  as

$$
h(x) := \inf_{y \ge x} \left\{ (h^*(y) \vee 1) \wedge \log(e + y) \right\}.
$$
 (186)

Clearly,  $1 \le h(x) \le \log(e + x)$  for every  $x \ge 0$  and the infimum over  $y \ge x$  of  $h^*(y)$  forces  $h(x)$  to be nondecreasing. Define  $\varphi(x) := xh(x)$  and note that

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P \varphi(|Y|^q) = \sup_{P \in \mathcal{P}} \left\{ \mathbb{E}_P |Y|^q h(|Y|^q) \right\} \tag{187}
$$

$$
\leq \sup_{P \in \mathcal{P}} \left\{ \mathbb{E}_P \left( |Y|^q \left[ 2 + h^{\star}(|Y|^q) \right] \right) \right\} \tag{188}
$$

$$
\leq 2 \sup_{P \in \mathcal{P}} \mathbb{E}_P |Y|^q + \sup_{P \in \mathcal{P}} \mathbb{E}_P (|Y|^q h^\star(|Y|^q)) \tag{189}
$$

$$
\leq 2 \sup_{P \in \mathcal{P}} \mathbb{E}_P |Y|^q + \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( \varphi^\star(|Y|^q) \right) \tag{190}
$$

$$
\langle \infty, \tag{191}
$$

<span id="page-22-2"></span>which completes the proof.

**Lemma 6.** Consider the setup of Lemma [5.](#page-21-0) We have that for any  $a \ge 0$  and  $b > 0$  such that  $a \le b$ ,

<span id="page-22-3"></span>
$$
\frac{a^u}{b^u} \leqslant \frac{\varphi(a^q)}{\varphi(b^q)},\tag{192}
$$

whenever  $0 < q \leq u \leq 2$ .

*Proof.* Clearly the result holds when  $a = 0$  since  $\varphi(0) = 0$  and  $\varphi(x) > 0$  when  $x > 0$ , so let us consider the case where  $0 < a \leq b$ . Then without loss of generality, we can write  $b = ac$  for some  $c \geq 1$ . Showing [\(192\)](#page-22-3) amounts to showing that

$$
\frac{1}{c^u} \leqslant \frac{\varphi(a^q)}{\varphi(a^q c^q)}.\tag{193}
$$

Indeed, we have that

$$
\frac{\varphi(a^q)}{\varphi(a^q c^q)} = \frac{\mathscr{A}^q \cdot h(a^q)}{\mathscr{A}^r c^q \cdot h(a^q c^q)}
$$
\n(194)

$$
\geqslant \frac{1}{c^q} \tag{195}
$$

$$
\geqslant \frac{1}{c^u},\tag{196}
$$

where the first line follows from the fact that  $\varphi(x)$  can be written as  $xh(x)$ , the second follows from the fact that  $h(a^q) \leq h(a^q c^q)$  since h is nondecreasing and  $c \geq 1$ , and the last line follows from the fact that  $c^q \leq c^u$  whenever  $c \geq 1$  and  $0 < q \leq u$ , completing the proof of Lemma [6.](#page-22-2) □

#### <span id="page-22-1"></span>4.1.2 Distribution-uniform boundedness in probability

In order to apply our  $\mathcal{P}-$ uniform stochastic Kronecker lemma (Lemma [1\)](#page-10-1) in the proof of Theorems [1\(](#page-3-2)i) and  $1(i)$  $1(i)$ , we ultimately need to show that

$$
S_n := \sum_{k=1}^n Y_k / k^{1/q} \tag{197}
$$

<span id="page-22-0"></span>is P-uniformly bounded in probability — or more succinctly,  $\sum_{k=1}^{n} Y_k/k^{1/q} = \overline{O}_{\mathcal{P}}(1)$  — where  $Y_k =$  $X_k - \mathbb{E}_P(X)$  when  $1 < q < 2$  and  $Y_k = X_k$  when  $0 < q < 1$ . In order to achieve this, we introduce a particular three series theorem for P-uniform boundedness in probability (Theorem [5\)](#page-22-0) that is similar in spirit but distinct from Theorem [4](#page-8-1) and then show in Lemmas [7](#page-24-0) and [8](#page-27-0) that  $\mathcal{P}\text{-}\mathrm{UI}$  is sufficient to satisfy the conditions of Theorem [5.](#page-22-0) Let us now state and prove Theorem [5.](#page-22-0)

**Theorem 5** (A three-series theorem for  $P$ -uniform boundedness in probability). Let  $(Z_n)_{n=1}^{\infty}$  be independent random variables on the probability spaces  $(\Omega, \mathcal{F}, \mathcal{P})$ . Suppose that the following three series uniformly vanish as  $B \to \infty$ :

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} |\mathbb{E}_P \left[ (Z_n / B) \mathbb{1} \{ |Z_n / B| \leq 1 \} \right]| = 0,
$$
\n(198)

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P \left[ (Z_n / B) \mathbb{1} \{ |Z_n / B| \leq 1 \} \right] = 0, \text{ and}
$$
\n(199)

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P(|Z_n/B| > 1) = 0. \tag{200}
$$

Then,  $S_n := \sum_{k=1}^n Z_k$  is P-uniformly bounded in probability, meaning that for any  $\delta$ , there exists  $N_{\delta}$  and  $B_{\delta}$  so that for all  $n \geq N_{\delta}$ ,

<span id="page-23-2"></span><span id="page-23-1"></span><span id="page-23-0"></span>
$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| \geq B_\delta) < \delta. \tag{201}
$$

Conceptually, the P-uniform Kolmogorov three-series theorem derived in Section [3.2](#page-8-0) can be thought of as imposing  $P$ -uniform structure on whether  $(S_n)_{n=1}^{\infty}$  converges almost surely, while Theorem [5](#page-22-0) imposes P-uniform structure on what  $(S_n)_{n=1}^{\infty}$  converges to with high probability. This subtlety is sidestepped in the P-pointwise case since if  $S_n$  is P-almost surely convergent, then it is bounded in probability (its limit point is a well-defined random variable). As such, it is perhaps unsurprising that when  $\mathcal{P} = \{P\}$  is a singleton, the conditions [\(198\)](#page-23-0)–[\(200\)](#page-23-1) reduce to those of the Kolmogorov three-series theorem displayed in [\(42\)](#page-8-5) but with absolute values surrounding the summands of the first series (which, as discussed in Section [3.2,](#page-8-0) is a distinction that is virtually inconsequential for the purposes of proving SLLNs).

Let us now prove Theorem [5](#page-22-0) below, and later (in Lemmas [7](#page-24-0) and [8\)](#page-27-0) show that the three series conditions are satisfied under P-UI conditions. In what follows, we use  $Z_{n,B}^{\leq 1}$  to denote

$$
Z_{n,B}^{\leq 1} := (Z_n/B) \mathbb{1} \{ |Z_n/B| \leq 1 \}
$$
\n(202)

and  $S_{n,B}^{\leq 1} := \sum_{k=1}^{n} Z_{k,B}^{\leq 1}$  to denote their partial sums.

*Proof of Theorem [5.](#page-22-0)* Let  $\delta > 0$  be arbitrary. Our goal is to show that there exists  $N_{\delta}$  and  $B_{\delta}$  large enough so that for all  $n \ge N_\delta$ , [\(201\)](#page-23-2) holds. Notice that for any  $B > 0$ , we have that

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| > B) \tag{203}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \sum_{k=1}^n Z_k \right| > B \right) \tag{204}
$$

$$
\leq \underbrace{\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \sum_{k=1}^n (Z_k/B) \mathbb{1} \{ |Z_k/B| \leq 1 \} \right| > 1 \right)}_{(*)} + \underbrace{\sup_{P \in \mathcal{P}} \sum_{k=1}^n \mathbb{P}_P \left( |Z_k/B| > 1 \right)}_{(†)}.
$$
\n(205)

Now, notice that we can write  $\left(\star\right)$  as

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P\left(\left|\sum_{k=1}^n (Z_k/B) \cdot \mathbb{1}\{|Z_k/B| \le 1\}\right| > 1\right) \tag{206}
$$

$$
= \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| S_{n,B}^{\leq} - \mathbb{E}_P S_{n,B}^{\leq} + \mathbb{E}_P S_{n,B}^{\leq} \right| > 1 \right) \tag{207}
$$

$$
\leq \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| S_{n,B}^{\leq} - \mathbb{E}_P S_{n,B}^{\leq} \right| > 1/2 \right) + \sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| \mathbb{E}_P S_{n,B}^{\leq} \right| > 1/2 \right) \tag{208}
$$

$$
= \underbrace{\sup_{P \in \mathcal{P}} \mathbb{P}_P \left( \left| S_{n,B}^{\leq} - \mathbb{E}_P S_{n,B}^{\leq} \right| > 1/2 \right)}_{\text{(vi)}} + \underbrace{\sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \left| \mathbb{E}_P S_{n,B}^{\leq} \right| > 1/2 \right\}}_{\text{(vii)}}.
$$
\n(209)

By Kolmogorov's inequality, we have that

$$
(\star i) \leq 4 \sup_{P \in \mathcal{P}} \sum_{k=1}^{n} \text{Var}_P \left( (Z_k / B) \cdot \{ |Z_k / B| \leq 1 \} \right) \tag{210}
$$

$$
\leq 4 \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \text{Var}_P \left( (Z_k / B) \cdot \{ |Z_k / B| \leq 1 \} \right). \tag{211}
$$

Furthermore, by the triangle inequality and upper bounding the finite sum by an infinite one, we have

$$
(\star ii) \leqslant \sup_{P \in \mathcal{P}} \mathbb{1} \left\{ \sum_{n=1}^{\infty} |\mathbb{E}_P \left[ (Z_n / B) \mathbb{1} \{ |Z_n / B| \leqslant 1 \} \right] | > 1/2 \right\}.
$$
 (212)

Once again upper bounding a finite sum by an infinite one, we have

$$
(\dagger) \leqslant \sum_{k=1}^{\infty} \mathbb{P}_P\left(|Z_k/B| > 1\right). \tag{213}
$$

Therefore, using the first, second, and third series conditions, we can find  $B_{\delta} > 0$  so that for all  $n \geq 1$ , we have  $(\star i) \leq \delta/2$ ,  $(\star ii) = 0$ , and  $(\dagger) \leq \delta/2$ , respectively, and thus

$$
\sup_{P \in \mathcal{P}} \mathbb{P}_P(|S_n| > B_\delta) \le \delta,\tag{214}
$$

<span id="page-24-0"></span>completing the proof.

**Lemma 7** (Satisfying the three series for uniform boundedness when  $1 < q < 2$ ). Suppose that  $(X_n)_{n=1}^{\infty}$ are i.i.d. and have a  $\mathcal{P}$ -UI q<sup>th</sup> moment for  $1 < q < 2$ . Then the three series for uniform stochastic boundedness in Theorem [5](#page-22-0) are satisfied for the random variable  $Z_n := (X_n - \mathbb{E}_P(X))/n^{1/q}$ .

*Proof.* We will handle the three series separately below. Throughout, let  $Y_n := X_n - \mathbb{E}_P(X)$  and  $Z_{n,B}^{\leq} :=$  $(Y/B) \mathbb{1}\{(Y/B)| \leqslant n^{1/q}\}/n^{1/q}.$ 

The first uniform boundedness series. Writing out the first series  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} |\mathbb{E}_P(Z_{n,B}^{\leq 1})|$  and performing a direct calculation, we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} |\mathbb{E}_P Z_{n,B}^{\leq 1}| = \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P \left( \frac{(Y/B) \mathbb{1}(|(Y/B)| \leq n^{1/q})}{n^{1/q}} \right) \right| \tag{215}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P \left( \frac{-\left(Y/B\right) \mathbb{1}\left(\left|Y/B\right| > n^{1/q}\right)}{n^{1/q}} \right) \right| \tag{216}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P \left( \frac{|Y/B| \mathbb{1}(|Y/B| > n^{1/q})}{n^{1/q}} \right) \tag{217}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=n}^{\infty} \mathbb{E}_P \left( \frac{|Y/B| \mathbb{1}(k^{1/q} < |Y/B| \leq (k+1)^{1/q})}{n^{1/q}} \right) \tag{218}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=1}^{k} \mathbb{E}_P \left( \frac{|Y/B| \mathbb{1}(k^{1/q} < |Y/B| \leq (k+1)^{1/q})}{n^{1/q}} \right) \tag{219}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left( |Y/B| \mathbb{1}(k^{1/q} < |Y/B| \leq (k+1)^{1/q}) \right) \cdot \sum_{n=1}^{k} \frac{1}{n^{1/q}}. \tag{220}
$$

Now, there exists some constant  $C_q > 0$  depending only on q so that  $\sum_{n=1}^{k} 1/n^{1/q} \leqslant C_q k/(k+1)^{1/q}$  and thus

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P Z_{n,B}^{\leq 1} \leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left( |Y/B| \mathbb{1}(k^{1/q} < |Y/B| \leq (k+1)^{1/q}) \right) \cdot C_q \frac{k}{(k+1)^{1/q}} \tag{221}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} (k+1)^{1/q} \mathbb{P}_P \left( k^{1/q} < |Y/B| \leq (k+1)^{1/q} \right) \cdot C_q \frac{k}{(k+1)^{1/q}} \tag{222}
$$

$$
= C_q \cdot \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} k \mathbb{P}_P \left( k^{1/q} < |Y/B| \le (k+1)^{1/q} \right). \tag{223}
$$

Through another direct calculation, we have that

$$
C_q \cdot \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} k \mathbb{P}_P \left( k^{1/q} < |Y/B| \leq (k+1)^{1/q} \right) \tag{224}
$$

$$
= C_q \cdot \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=1}^{k} \mathbb{P}_P \left( k^{1/q} < |Y/B| \le (k+1)^{1/q} \right) \tag{225}
$$

$$
= C_q \cdot \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=n}^{\infty} \mathbb{P}_P \left( k^{1/q} < |Y/B| \leq (k+1)^{1/q} \right) \tag{226}
$$

$$
= C_q \cdot \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P \left( |Y/B|^q > n \right) \tag{227}
$$

$$
\leq C_q \cdot \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y/B|^q \right) \tag{228}
$$

$$
\leq C_q \cdot B^{-q} \underbrace{\sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \right)}_{\lt \infty},\tag{229}
$$

and thus

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P Z_{n,B}^{\leq 1} = 0,
$$
\n(230)

completing the proof for the first uniform boundedness series.

The second uniform boundedness series. Writing out the second series  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P(Z_{n,B}^{\leq 1})$ for any  $B > 0$  and performing a direct calculation, we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} = \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left\{ \mathbb{E}_P \left[ (Z_{n,B}^{\leq 1})^2 \right] - \left[ \mathbb{E}_P Z_{n,B}^{\leq 1} \right]^2 \right\} \tag{231}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P[(Z_{n,B}^{\leqslant 1})^2]
$$
\n(232)

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P \left[ \frac{(Y/B)^2}{n^{2/q}} \mathbb{1}\{|Y/B| \leqslant n^{1/q}\} \right] \tag{233}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=1}^{n} \mathbb{E}_{P} \left[ \frac{(Y/B)^2}{n^{2/q}} \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right] \tag{234}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=k}^{\infty} \mathbb{E}_P \left[ \frac{(Y/B)^2}{n^{2/q}} \mathbb{1}\{(k-1)^{1/q} < |Y/B| \leq k^{1/q}\} \right] \tag{235}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right] \sum_{n=k}^{\infty} \frac{1}{n^{2/q}}. \tag{236}
$$

Now, notice that there exists a constant  $C_q > 0$  depending only on q so that  $\sum_{n=k}^{\infty} 1/n^{2/q} \leqslant C_q k / k^{2/q}$ , and hence we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} \leq C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \frac{k}{k^{2/q}} \cdot \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right]. \tag{237}
$$

Separating the first term from this sum, notice that we have

$$
C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \frac{k}{k^{2/q}} \cdot \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right] \tag{238}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ |Y/B| \leq 1 \} \right] +
$$
\n(239)

$$
C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \frac{k}{k^{2/q}} \cdot \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ (k-1)^{1/q} \le |Y/B| \le k^{1/q} \} \right].
$$
 (240)

Notice that  $(Y/B)^2 1\{|Y/B| \leq 1\} \leq |Y/B|^q 1\{|Y/B| \leq 1\}$  with P-probability one for every  $P \in \mathcal{P}$  since  $0 < q < 2$ . Therefore,

$$
(\star) = C_q \sup_{P \in \mathcal{P}} \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ |Y/B| \leq 1 \} \right] \leq \frac{C_q}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P |Y|^q. \tag{241}
$$

Turning now to  $(\dagger)$ , we have

$$
(\dagger) = C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \frac{k}{k^{2/q}} \cdot \mathbb{E}_P \left[ (Y/B)^2 \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right] \tag{242}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \frac{k}{k^{2/4}} \mathbb{E}_P \left[ k^{2/4} \mathbb{1} \{ (k-1)^{1/q} < |Y/B| \leq k^{1/q} \} \right] \tag{243}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} k \mathbb{P}_P \left( (k-1)^{1/q} < |Y/B| \leq k^{1/q} \right) \tag{244}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \sum_{n=1}^{k} \mathbb{P}_P \left( (k-1)^{1/q} < |Y/B| \leq k^{1/q} \right) \tag{245}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=n}^{\infty} \mathbb{1}\{k \ge 2\} \mathbb{P}_P\left( (k-1)^{1/q} < |Y/B| \le k^{1/q} \right) \tag{246}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \left[ 2 \sum_{n=2}^{\infty} \sum_{k=n}^{\infty} \mathbb{P}_P \left( (k-1)^{1/q} < |Y/B| \leq k^{1/q} \right) \right] \tag{247}
$$

$$
\leqslant 2C_q \sup_{P \in \mathcal{P}} \sum_{n=2}^{\infty} \mathbb{P}_P \left( |Y/B| > (n-1)^{1/q} \right) \tag{248}
$$

$$
\leqslant \frac{2C_q}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \right). \tag{249}
$$

Putting the bounds on  $(\star)$  and  $(\dagger)$  together, we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} \leq (\star) + (\dagger) \leq \frac{3C_q}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P |Y|^q,
$$
\n(250)

and hence we have that

$$
\lim_{B \to \infty} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} = 0,\tag{251}
$$

which completes the proof for the second series.

The third uniform boundedness series. Writing out the series  $\sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{P}_P(|Y/k^{1/q}| > B)$  for any  $B > 0$  and using the expectation-tail sum identity, we have

$$
\sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{P}_P \left( |Y/k^{1/q}| > B \right) \leq \frac{1}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \right),\tag{252}
$$

and we note that  $\sup_{P \in \mathcal{P}} \mathbb{E}_P(|Y|^q) < \infty$  above since uniform integrability implies uniform boundedness. Consequently, we have that

$$
\lim_{B \to \infty} \sum_{k=1}^{\infty} \mathbb{P}_P \left( |Y/k^{1/q}| > B \right) = 0,
$$
\n(253)

 $\Box$ 

<span id="page-27-0"></span>completing the proof for the third series and hence the entire lemma.

**Lemma 8** (Satisfying the three series for uniform boundedness when  $0 < q < 1$ ). Suppose that X has a P-UI (uncentered)  $q^{th}$  moment for  $0 < q < 1$ . Then the three series for uniform stochastic boundedness in Theorem [5](#page-22-0) are satisfied for the random variable  $Z_n := X_n/n^{1/q}$ .

*Proof.* Similar to satisfying the conditions of the  $P$ -uniform Kolmogorov three-series theorem as in Lemma [4,](#page-19-0) satisfying the conditions of the  $P$ -uniform boundedness three-series theorem proceeds identically for the second and third series, and thus we focus solely on the first series here.

Throughout, let  $Z_{n,B}^{\leq} := (X/B) \mathbb{1}\{(X/B) | \leq n^{1/q}\} / n^{1/q}$ . Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} |\mathbb{E}_P(Z_{n,B}^{\leq 1})|$  for any  $B > 0$ , we have via a direct calculation that

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P Z_{n,B}^{\leq 1} \right| \tag{254}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P \left( \frac{|X/B| \mathbb{1} \{|X/B| \leq n^{1/q} \}}{n^{1/q}} \right) \tag{255}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=1}^{n} \mathbb{E}_{P} \left( \frac{|X/B| \mathbb{1} \{ (k-1)^{1/q} < |X/B| \leq k^{1/q} \}}{n^{1/q}} \right) \tag{256}
$$

$$
= \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_P \left( |X/B| \mathbb{1}\{(k-1)^{1/q} < |X/B| \leq k^{1/q}\} \right) \cdot \sum_{n=k}^{\infty} \frac{1}{n^{1/q}}. \tag{257}
$$

Now, following techniques from earlier proofs, notice that since  $0 < q < 1$ , there exists a constant  $C_q$ depending only on q so that  $\sum_{n=k}^{\infty} 1/n^{1/q} \leq C_q k / k^{1/q}$ . Breaking up the sum similarly to how we did for the second series of uniform boundedness in Lemma [7,](#page-24-0) we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_{P} Z_{n,B}^{\leq 1} \right| \leq \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \mathbb{E}_{P} \left( |X/B| \mathbb{1}\{(k-1)^{1/q} < |X/B| \leq k^{1/q}\} \right) \cdot C_q \frac{k}{k^{1/q}} \tag{258}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |X/B| \mathbb{1} \{ |X/B| \leq 1 \right) +
$$
\n
$$
(259)
$$

$$
C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \mathbb{E}_P \left( |X/B| \mathbb{1}\{(k-1)^{1/q} < |X/B| \le k^{1/q}\} \right) \frac{k}{k^{1/q}}. \tag{260}
$$

<span id="page-28-3"></span>First looking at ( $\star$ ), we notice that  $|X/B| \leq 1 \leq |X/B|^q 1\{|X/B| \leq 1\}$  with P-probability one for every  $P \in \mathcal{P}$  since  $0 < q < 1$ , and thus

$$
(\star) \leqslant \frac{C_q}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P |X|^q. \tag{261}
$$

Turning to  $(\dagger)$ , we have that

$$
(\dagger) = C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \mathbb{E}_P \left( |X/B| \mathbb{1} \{ (k-1)^{1/q} < |X/B| \leq k^{1/q} \} \right) \frac{k}{k^{1/q}} \tag{262}
$$

$$
\leq C_q \sup_{P \in \mathcal{P}} \sum_{k=2}^{\infty} \mathbb{E}_P \left( k^{\frac{1}{q}} \mathbb{1}\{(k-1)^{1/q} < |X/B| \leq k^{1/q} \} \right) \frac{k}{k^{1/q}} \tag{263}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{k=1}^{\infty} \sum_{n=1}^{k} \mathbb{1}\{k \geq 2\} \mathbb{P}_P\left( (k-1)^{1/q} < |X/B| \leq k^{1/q} \right) \tag{264}
$$

$$
= C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \sum_{k=n}^{\infty} \mathbb{1}\{k \geq 2\} \mathbb{P}_P\left( (k-1)^{1/q} < |X/B| \leq k^{1/q} \right) \tag{265}
$$

$$
\leq 2C_q \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P \left( |X/B| > n^{1/q} \right) \tag{266}
$$

$$
\leqslant \frac{2C_q}{B^q} \sup_{P \in \mathcal{P}} |X|^q. \tag{267}
$$

Combining the upper bounds on  $(\star)$  and  $(\dagger)$ , we have that

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P Z_{n,B}^{\leq 1} \right| \leq \frac{3C_q}{B^q} \sup_{P \in \mathcal{P}} \mathbb{E}_P |X|^q,
$$
\n(268)

and thus we have that

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P Z_{n,B}^{\leq 1} \right| = 0,
$$
\n(269)

completing the proof of Lemma [8.](#page-27-0)

#### <span id="page-28-0"></span>4.1.3 An equivalent criterion of uniform integrability

**Lemma 9** (Uniform integrability is equivalent to uniformly vanishing sums of tail probabilities). Let Y be a random variable on the probability spaces  $(\Omega, \mathcal{F}, \mathcal{P})$ . Then Y has a P-UI q<sup>th</sup> moment if and only if the tail sum of its tail probability is P-uniformly vanishing, meaning

<span id="page-28-2"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \mathbb{E}_P \left( |Y|^q \mathbb{1}(|Y|^q > m) \right) = 0 \tag{270}
$$

if and only if

<span id="page-28-1"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |Y|^q > k \right) = 0. \tag{271}
$$

The above lemma gives an equivalent criterion of  $\mathcal{P}\text{-}\mathrm{UI}$  and was shown in Hu and Zhou [\[8,](#page-34-8) Theorem 2.1] where they refer to the property in [\(271\)](#page-28-1) as " $W^{\star}$  uniform integrability" [\[8](#page-34-8), Definition 1.6]. Since Hu and Zhou [\[8,](#page-34-8) Theorem 2.1] is written in the context of uniform integrability for a family of random variables  $(X_n)_{n=1}^{\infty}$  defined on a single probability space (as contrasted with P-UI in Section [1\)](#page-0-0), we provide a self-contained proof for completeness.

*Proof.* The forward implication is obvious since for any  $P \in \mathcal{P}$ ,

$$
\sum_{k=m}^{\infty} \mathbb{P}_P(|Y|^q > k) = \sum_{k=m}^{\infty} \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k)
$$
\n(272)

$$
\leqslant \sum_{k=1}^{\infty} \mathbb{P}_P(|Y|^q \mathbb{1}(|Y|^q > m) > k) \tag{273}
$$

$$
\leqslant \int_0^\infty \mathbb{P}_P(|Y|^q \mathbb{1}(|Y|^q > m) > k)dk \tag{274}
$$

$$
= \mathbb{E}_P(|Y|^q \mathbb{1}(|Y|^q > m)). \tag{275}
$$

The reverse implication is more involved. Suppose that there exists a collection of distributions  $P$  so that [\(271\)](#page-28-1) holds but [\(270\)](#page-28-2) does not. First, note that we can write the supremum over expectations in [\(270\)](#page-28-2) as

$$
\sup_{P \in \mathcal{P}} \mathbb{E}_P(|Y|^q \mathbb{1}\{|Y|^q > m\}) = \int_0^\infty \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k) \, dk \tag{276}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{k=0}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1}(|Y|^q > m) > k \right) \tag{277}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > m \} > k \right) + \tag{278}
$$

$$
\exp\sum_{P\in\mathcal{P}}^{m-1} \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k),\tag{279}
$$

and since  $(\star) \to 0$  as  $m \to \infty$ , we must have that  $(\dagger) \to 0$ , and hence

<span id="page-29-0"></span>
$$
\limsup_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=0}^{m-1} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > m \} > k \right) > \varepsilon
$$
\n(280)

for some  $\varepsilon > 0$ , or in other words, no matter how large we take M to be, we can always find some  $M^{\star} \geq M$  and  $P^{\star} \in \mathcal{P}$  so that  $\sum_{k=0}^{M^{\star}-1} \mathbb{P}_{P^{\star}}(|Y|^q 1\{|Y|^q > M^{\star}\} > k) > \varepsilon$ . Writing out the above sum, we have for any  $m, P$ ,

$$
\sum_{k=0}^{m-1} \mathbb{P}_P(|Y|^q \mathbb{1}\{|Y|^q > m\} > k) = \sum_{k=0}^{m-1} \mathbb{P}_P(|Y|^q > m)
$$
\n(281)

since  $|Y|^q 1\{|Y|^q > m\} > k$  if and only if  $|Y|^q > m$  whenever  $k \leq m$ . Carrying on with the above calculation, we have as a consequence of [\(280\)](#page-29-0) that

<span id="page-29-1"></span>
$$
\limsup_{m \to \infty} \sup_{P \in \mathcal{P}} m \mathbb{P}_P(|Y|^q > m) > \varepsilon. \tag{282}
$$

Simultaneously, by the assumed uniform tail vanishing property in  $(271)$ , we can choose an M sufficiently large so that

<span id="page-29-2"></span>
$$
\sup_{P \in \mathcal{P}} \sum_{k=M}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > M \} > k \right) < \varepsilon/2. \tag{283}
$$

By [\(282\)](#page-29-1), find some  $M^* > 3M$  and  $P^* \in \mathcal{P}$  so that

<span id="page-29-3"></span>
$$
M^{\star} \cdot \mathbb{P}_{P^{\star}}\left(|Y|^q > M^{\star}\right) > \varepsilon. \tag{284}
$$

We will now show that [\(283\)](#page-29-2) and [\(284\)](#page-29-3) are incompatible, leading to a contradiction. Indeed,

$$
\sup_{P \in \mathcal{P}} \sum_{k=M}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > M \} > k \right) \tag{285}
$$

$$
\geq \sum_{k=M}^{\infty} \mathbb{P}_{P^*}(|Y|^q \mathbb{1}\{|Y|^q > M\} > k)
$$
\n(286)

$$
\geqslant \sum_{k=M}^{M^{\star}} \mathbb{P}_{P^{\star}}\left( |Y|^q \mathbb{1}\{|Y|^q > M\} > k\right) \tag{287}
$$

$$
= \sum_{k=M}^{M^{\star}} \mathbb{P}_{P^{\star}}(|Y|^q > k), \qquad (288)
$$

where the first inequality follows by definition of a supremum, the second since we are taking only a smaller sum over finitely many elements, and the last equality follows from the fact that whenever  $k \geq M$ ,  $|Y|^q 1\{|Y|^q > M\} > k$  if and only if  $|Y|^q > k$ . Carrying on with the above calculation, we finally have

$$
\sup_{P \in \mathcal{P}} \sum_{k=M}^{\infty} \mathbb{P}_P \left( |Y|^q \mathbb{1} \{ |Y|^q > M \} > k \right) \tag{289}
$$

$$
\geqslant \sum_{k=M}^{M^{\star}} \mathbb{P}_{P^{\star}}\left(|Y|^q > k\right) \tag{290}
$$

$$
\geqslant \sum_{k=M}^{M^{\star}} \mathbb{P}_{P^{\star}}\left(|Y|^q > M^{\star}\right) \tag{291}
$$

$$
= (M^* - M)\mathbb{P}_{P^*}(|Y|^q > M^*)
$$
\n<sup>(292)</sup>

$$
\geqslant (M^{\star} - M^{\star}/3) \mathbb{P}_{P^{\star}} (|Y|^q > M^{\star}) \tag{293}
$$

$$
> 2\varepsilon/3,\tag{294}
$$

which contradicts the fact that the same sum was assumed to be less than  $\varepsilon/2$  in [\(283\)](#page-29-2), completing the proof.  $\Box$ 

### <span id="page-30-0"></span>4.2 Proof of Theorem [2](#page-6-0)

*Proof of Theorem [2.](#page-6-0)* By Lemma [10,](#page-31-0) we have that the following  $P$ -uniform moment regularity condition

<span id="page-30-1"></span>
$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{k=m}^{\infty} \frac{\mathbb{E}_P |X_k - \mathbb{E}_P X_k|^q}{a_k^q} = 0
$$
\n(295)

implies that the three series in Theorem [4](#page-8-1) vanish  $\mathcal{P}$ -uniformly with  $c = 1$  for the random variables  $Z_k^{\leq 1}$ which are scaled and truncated versions of  $X_k$  given by

$$
Z_k^{\le 1} := \frac{X_k - \mathbb{E}_P(X_k)}{a_k} \cdot 1\{|X_k - \mathbb{E}_P(X)| \le a_k\}.
$$
 (296)

Therefore, by the P-uniform three series theorem (Theorem [4\)](#page-8-1) we have that  $S_n \equiv S_n(P) := \sum_{k=1}^n (X_k \mathbb{E}_P(X)/a_k$  forms a P-uniform Cauchy sequence. Moreover, by Theorem [5](#page-22-0) and Lemma [11,](#page-32-0) we have that the P-uniform moment regularity condition [\(295\)](#page-30-1) implies that  $S_n$  is P-uniformly bounded in probability. Combining the facts that  $(S_n)_{n=1}^{\infty}$  is P-uniformly Cauchy and bounded in probability, we invoke the P-uniform Kronecker lemma (Lemma [1\)](#page-10-1) similar to the proof of Theorem  $1(i)$  $1(i)$  but now with the sequence  $(a_n)_{n=1}^{\infty}$  to yield that for any  $\varepsilon > 0$ ,

$$
\lim_{m \to \infty} \mathbb{P}_P \left( \sup_{k \ge m} \left| \frac{1}{a_k} \sum_{i=1}^k (X_k - \mathbb{E}_P(X_k)) \right| \ge \varepsilon \right) = 0,
$$
\n(297)

<span id="page-31-0"></span>**Lemma 10** (Satisfying the three series for independent random variables). Let  $X_1, \ldots, X_n$  be independent random variables and let  $Y_n := X_n - \mathbb{E}X_n$  be their centered versions. Suppose that for some increasing sequence  $(a_n)_{n=1}^{\infty}$  that diverges to  $\infty$ ,

$$
\lim_{t \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=t}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q} = 0.
$$
\n(298)

Then the three series conditions of Theorem  $\frac{1}{4}$  $\frac{1}{4}$  $\frac{1}{4}$  are satisfied for

$$
Z_k := \frac{Y_k}{a_k} \tag{299}
$$

with  $c = 1$ .

*Proof.* First, define the truncated random variables  $Y_n^{\leq}$  as

$$
Y_n^{\leqslant} := \begin{cases} Y_n & \text{if } |Y_n| \leqslant a_n \\ 0 & \text{if } |Y_n| > a_n. \end{cases} \tag{300}
$$

and  $Z_n^{\leq 1}$  as

$$
Z_n^{\leqslant 1} := \begin{cases} Z_n & \text{if } |Z_n| \leqslant 1 \\ 0 & \text{if } |Z_n| > 1 \end{cases} \tag{301}
$$

for any n. We will satisfy the three series separately.

**The first series.** Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} |\mathbb{E}_P Z_n^{\leq 1}|$ , we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} |\mathbb{E}_P Z_n^{\leq 1}| = \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left| \mathbb{E}_P \left( \frac{Y_n \mathbb{1}(|Y_n| \leq a_n)}{a_n} \right) \right| \tag{302}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P \left( \frac{|Y_n| \mathbb{1}(|Y_n| > a_n)}{a_n} \right) \tag{303}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q} \to 0 \tag{304}
$$

where the last inequality follows from the fact that  $(|Y_n|/a_n) \mathbb{1}{\{|Y_n| > a_n\}} \leq (|Y_n|^q/a_n^q) \mathbb{1}{\{|Y_n| > a_n\}}$  since  $q \geqslant 1$ .

**The second series.** Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq 1}$ , we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \text{Var}_P Z_n^{\leq 1} = \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \left\{ \mathbb{E}_P \left[ (Z_n^{\leq 1})^2 \right] - \left[ \mathbb{E}_P Z_n^{\leq 1} \right]^2 \right\} \tag{305}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P[(Z_n^{\leq 1})^2]
$$
\n(306)

$$
= \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P \left( \frac{Y_n^2 \mathbb{1}(|Y_n| \leq a_n)}{a_n^2} \right) \tag{307}
$$

$$
\leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q} \to 0,
$$
\n(308)

where the last inequality follows from the fact that  $(Y_n^2/a_n^2)1\{|Y_n| \leq a_n\} \leq (|Y_n|^q/a_n^q)1\{|Y_n| \leq a_n\}$  with *P*-probability one for each  $P \in \mathcal{P}$  since  $q \leq 2$ .

**The third series.** Finally, writing out the third series  $\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P(|Y_n/a_n| > 1)$ , we have by Markov's inequality,

$$
\sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{P}_P \left( \left| \frac{Y_n}{a_n} \right| > 1 \right) \leq \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \frac{\mathbb{E}|Y_n|^q}{a_n^q} \to 0,\tag{309}
$$

<span id="page-32-0"></span>which completes the proof.

Lemma 11 (Satisfying the three series of P-uniform boundedness for independent random variables). Let  $X_1, \ldots, X_n$  be independent random variables and let  $Y_n := X_n - \mathbb{E} X_n$  be their centered versions. Suppose that for some increasing sequence  $(a_n)_{n=1}^{\infty}$  that diverges to  $\infty$ ,

$$
\lim_{m \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q} = 0.
$$
\n(310)

Then the three series conditions of Theorem [5](#page-22-0) are satisfied for

$$
Z_k := \frac{Y_k}{a_k}.\tag{311}
$$

*Proof.* First, define the truncated random variables  $Z_{n,B}^{\leq 1}$  as

$$
Z_{n,B}^{\leq 1} := \frac{(Y_n/B) \mathbb{1}\{|Y_n/B| \leq a_n\}}{a_n}.
$$
\n(312)

We will satisfy the three series separately.

The first uniform boundedness series. Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_{P} Z_{n,B}^{\leq 1} \right|$  for any  $B > 0$ , we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P Z_{n,B}^{\leq 1} \right| = \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P \left( \frac{(Y_n/B) \mathbb{1}(|Y_n/B| \leq a_n)}{a_n} \right) \right| \tag{313}
$$

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P \left( \frac{|Y_n/B| \mathbb{1}(|Y_n/B| > a_n)}{a_n} \right) \tag{314}
$$

$$
\leq \frac{1}{B^q} \underbrace{\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q}}_{\leq \infty},\tag{315}
$$

and we note that  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P |Y_n|^q / a_n^q < \infty$  since  $\lim_m \sup_{P \in \mathcal{P}} \sum_{n=m}^{\infty} \mathbb{E}_P |Y_n|^q / a_n^q = 0$ . Therefore, we have

$$
\lim_{B \to \infty} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left| \mathbb{E}_P Z_{n,B}^{\leq 1} \right| = 0,
$$
\n(316)

completing the proof of the first series.

<span id="page-33-2"></span>The second uniform boundedness series. Writing out  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1}$ , we have

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} = \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \left\{ \mathbb{E}_P [(Z_{n,B}^{\leq 1})^2] - [\mathbb{E}_P Z_{n,B}^{\leq 1}]^2 \right\}
$$
(317)

$$
\leqslant \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P[(Z_{n,B}^{\leqslant 1})^2]
$$
\n(318)

$$
= \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{E}_P \left( \frac{(Y_n/B)^2 \mathbb{1}(|Y_n/B| \leq a_n)}{a_n^2} \right)
$$
(319)

$$
\leq \frac{1}{B^q} \underbrace{\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \frac{\mathbb{E}_P |Y_n|^q}{a_n^q}}_{\leq \infty}.
$$
\n(320)

Therefore,  $\lim_B \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \text{Var}_P Z_{n,B}^{\leq 1} = 0$ , completing the proof for the second series.

The third uniform boundedness series. Finally, writing out the third series  $\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P(|Y_n/B| > a_n)$ , we have by Markov's inequality,

$$
\sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \mathbb{P}_P \left( |Y_n / B| > a_n \right) \leq \frac{1}{B^q} \sup_{P \in \mathcal{P}} \sum_{n=1}^{\infty} \frac{\mathbb{E} |Y_n|^q}{a_n^q} \to 0
$$
\n(321)

as  $B \to \infty$  which completes the proof.

### <span id="page-33-0"></span>5 Summary

In this paper, we introduced a set of tools and techniques to derive distribution-uniform strong laws of large numbers, culminating in extensions of Chung's i.i.d. strong law to uniformly integrable  $q^{\text{th}}$  moments for  $0 < q < 2$ ;  $q \neq 1$  in the sense of Marcinkiewicz and Zygmund [\[11\]](#page-34-2) as well as to independent but non-identically distributed random variables. Furthermore, we showed that  $\mathcal{P}\text{-uniform integrability of the}$  $q<sup>th</sup>$  moment is both sufficient *and necessary* for the strong law to hold at the Kolmogorov-Marcinkiewicz-Zygmund rates of  $\bar{q}_{\mathcal{P}}(n^{1/q-1})$ , shedding new light on uniform strong laws even in Chung's case when  $q = 1.$ 

As alluded to in the introduction, Ruf et al. [\[14](#page-34-1)] were able to prove Chung's strong law using an argument not resembling those typically found in almost sure convergence theorems. In short, they derive a novel high-probability line-crossing inequality for sums of i.i.d. random variables whose first moments are finite and show how this inequality can be uniformly controlled in a family with a uniformly integrable first moment. It is not obvious to us whether their proof techniques can be adapted to higher (or lower) finite moments or to non-identically distributed settings, but this would be interesting to see.

Zooming out, we anticipate that the proof techniques found in Sections [3](#page-7-0) and [4](#page-13-1) may open vistas for understanding other distribution-uniform almost sure behavior. In particular, we plan to explore their use in the development of distribution-uniform analogues of strong invariance principles such as the Komlós-Major-Tusnády embeddings  $[9, 10]$  $[9, 10]$  $[9, 10]$  in the presence of  $q<sup>th</sup>$  uniformly integrable moments when  $q > 2$ .
