# A GEOMETRIC CHARACTERIZATION OF $\mathbb{N}$-MANIFOLDS AND THE FROBENIUS THEOREM

#### Abstract

This paper studies graded manifolds with local coordinates concentrated in nonnegative degrees. We provide a canonical description of these objects in terms of classical geometric data and, building on this geometric viewpoint, we prove the Frobenius theorem for distributions in this graded setting.

## 1. Introduction

Graded manifolds are generalizations of usual manifolds in which local coordinates carry an additional grading, most often by $\mathbb{Z}_{2}$ or $\mathbb{Z}$. They arise in several areas of mathematics and physics such as supergeometry [4, 10, 35], BV-BFV formalism and homological reduction (see [11] and references therein), topological field theory (e.g. AKSZ sigma models [1, 28]), double structures [25, 39], derived differential geometry [3], among others.

This paper concerns $\mathbb{N}$-graded manifolds ( $\mathbb{N}$-manifolds for short) of a given degree $n \in \mathbb{N}$, i.e. graded manifolds with local coordinates concentrated in degrees $0, \ldots, n$, and that commute in the graded sense; a precise definition is given in terms of sheaves of graded algebras with a suitable local model, see 2.1 Such graded manifolds have become a key tool in the study of Poisson and related structures, including Lie algebroids and their higher versions [7, 34, 37, as well as Courant algebroids and generalized geometry [9, 31, 33. The goal of this paper is twofold: we give a description of $\mathbb{N}$-manifolds by means of ordinary vector bundles and, building on this geometric viewpoint, we prove the Frobenius theorem for $\mathbb{N}$-manifolds, establishing the equivalence between involutive and integrable distributions.

To describe the first part of the paper, consider an $\mathbb{N}$-manifold $\mathcal{M}$ with body $M$. The local condition on the sheaf of functions $C_{\mathcal{M}}$ implies that the subsheaf of homogeneous functions of

[^0]degree $i$ is realized as the sheaf of sections of a vector bundle, i.e., for each $i=1,2, \ldots$ there is a vector bundle $E_{-i} \rightarrow M$ such that $C_{\mathcal{M}}^{i}=\Gamma_{E_{-i}^{*}}$. Moreover, the algebra structure on $C_{\mathcal{M}}$, $C_{\mathcal{M}}^{i} \times C_{\mathcal{M}}^{j} \rightarrow C_{\mathcal{M}}^{i+j}$, gives rise to vector-bundle maps
\[

E_{-(i+j)} \rightarrow E_{-i} \otimes E_{-j} . \tag{1}
\end{equation*}

A key observation is that, if $\mathcal{M}$ is of degree $n$, then it is fully encoded in the first $n$ vector bundles $E_{-1}, \ldots, E_{-n}$ and the maps (11) for $i+j \leq n$. These data can be encapsulated in a coalgebra structure $\mu$ on the graded vector bundle $\mathbf{E}=\oplus_{i=1}^{n} E_{-i}$, and the coalgebra bundle $(\mathbf{E}, \mu)$ may be seen as the "simplest" object from which the $\mathbb{N}$-manifold $\mathcal{M}$ can be reconstructed. In Section 3 we characterize the coalgebra bundles $(\mathbf{E}, \mu)$ that arise from $\mathbb{N}$-manifolds, referred to as admissible (Def. [2.9); we show, by means of a canonical construction, that there is a functor from the category of admissible $n$-coalgebra bundles to that of $\mathbb{N}$-manifolds of degree $n$,

$$

that is an equivalence of categories, see Theorem 3.8, When $n=1$, this result amounts to the well-known equivalence between degree $1 \mathbb{N}$-manifolds and ordinary vector bundles [31]. For $n=2$, it recovers the vector-bundle description of degree $2 \mathbb{N}$-manifolds used in [9, §2.2]. These and other instances of the equivalence (21) can be found in $\S 3.3$ (see also [15]).

A particular type of admissible $n$-coalgebra bundle arises from the symmetric powers of (negatively-)graded vector bundles, as described in Example 2.15. We call those split. We show that a general admissible $n$-coalgebra bundle is always noncanonically isomorphic to one that is split; the auxiliary choices needed to establish such an isomorphism are given in Prop. 2.16. By verifying that the functor (2) sends split coalgebra bundles to split $\mathbb{N}$-manifolds, one recovers the fact that any $\mathbb{N}$-manifold is noncanonically isomorphic to a split one [7, Thm. 1] (which can be regarded as a version of Batchelor's theorem [2] for $\mathbb{N}$-manifolds).

Remark 1.1. In [19], Heuer and Jotz independently gave a geometric description of $\mathbb{N}$-graded manifolds of degree $n$ as certain $n$-fold vector bundles, called symmetric, extending the equivalence between degree $2 \mathbb{N}$-manifolds and involutive double vector bundles in [23, 16, 21] (see also [8, (38). This latter result is related to the equivalence in (2), for $n=2$, as follows: admissible 2-coalgebra bundles can be readily seen to be equivalent to special types of dvb sequences (i.e., exact sequences of vector bundles that codify double vector bundles [13], see $\S$ (3.3) that correspond to involutive double vector bundles, see [16]. More generally, one would expect an extension of the structural description of double vector bundles in 13 to $n$-fold vector bundles to clarify the direct correspondence between admissible $n$-coalgebra bundles and symmetric $n$-fold vector bundles.

Towards the second goal of the paper, in Section 4 we make use of the equivalence (2) to obtain a geometric description of vector fields of non-positive degrees on $\mathbb{N}$-manifolds, see Theorem 4.9 and $\S 4.4$. In Section 5 we introduce distributions on $\mathbb{N}$-manifolds and prove in Theorem 6.4 the Frobenius theorem in this setting, asserting that a distribution is involutive if and only if it is locally spanned by coordinate vector fields. A parallel result for supermanifolds (i.e., $\mathbb{Z}_{2}$-graded manifolds) can be found e.g. in [10, 35] (see [14] for an extension to $\mathbb{Z}_{2}^{n}$-graded manifolds), though the techniques involved are rather different.

Besides it being a foundational theorem in the theory of $\mathbb{N}$-graded manifolds, our main motivation in establishing the Frobenius theorem in this context came from its role in the study of reduction of Poisson manifolds and Courant algebroids in [9, 12]; further possible applications include, in analogy with the classical case [24], the integration of Lie-algebroid morphisms to Lie-groupoid morphisms (Lie II) in the $\mathbb{N}$-graded setting (cf. [22), that we plan to address in a separate work.

## 2. $\mathbb{N}$-MANIFOLDS AND COALGEBRA BUNDLES

In this section we introduce degree $n$ admissible coalgebra bundles, which are geometric objects defined in terms of classical vector bundles. We will show in the next section that they form a category that is equivalent to that of $\mathbb{N}$-manifolds of degree $n$.
2.1. The category of $\mathbb{N}$-manifolds. Given a non-negative integer $n \in \mathbb{N}$, let $\mathbf{V}=\oplus_{i=1}^{n} V_{i}$ be a graded vector space with $\operatorname{dim} V_{i}=m_{i}$; let $\mathrm{S}^{\bullet} \mathbf{V}$ denote the graded symmetric algebra of $\mathbf{V}$. An $\mathbb{N}$-manifold of degree $n$ (or simply an $n$-manifold) is a ringed space $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$, where $M$ is a smooth manifold and $C_{\mathcal{M}}$ is a sheaf of graded commutative algebras such that any point in $M$ admits a neighborhood $U$ with an isomorphism

$$
\begin{equation*}
\left.C_{\mathcal{M}}\right|_{U} \cong C_{U}^{\infty} \otimes \mathrm{S}^{\bullet} \mathbf{V} \tag{3}
\end{equation*}
$$

of sheaves of graded commutative algebras $\sqrt{1}$. We say that $\mathcal{M}$ has dimension $m_{0}\left|m_{1}\right| \cdots \mid m_{n}$, where $m_{0}=\operatorname{dim} M$. The manifold $M$ is known as the body of $\mathcal{M}$. A global section of $C_{\mathcal{M}}^{i}$ is called a homogeneous function of degree $i$; we write $|f|=i$ for the degree of $f$.

Let $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ be an $n$-manifold of dimension $m_{0}|\cdots| m_{n}$. A chart $U \subseteq M$ for which (3) holds is called a chart of $\mathcal{M}$. We say that

$$
\left\{x^{\alpha}, e_{i}^{\beta_{i}}\right\}, \quad \text { where } \alpha=1, \ldots, m_{0}, i=1, \ldots, n, \beta_{i}=1, \ldots, m_{i},
$$

are local coordinates of $\mathcal{M}_{\mid U}=\left(U,\left.C_{\mathcal{M}}\right|_{U}\right)$ if $\left\{x^{\alpha}\right\}_{\alpha=1}^{m_{0}}$ are local coordinates on $U$ and $\left\{e_{i}^{\beta_{i}}\right\}_{\beta_{i}=1}^{m_{i}}$ form a basis of $V_{i}$ for all $i=1, \ldots, n$. Hence $\left.C_{\mathcal{M}}\right|_{U}$ is freely generated over $C_{U}^{\infty}$ by $\left\{e_{i}^{\beta_{i}}\right\}$ with $\left|e_{i}^{\beta_{i}}\right|=i$. We may occasionally simplify the notation and suppress the sub-indices, denoting local coordinates by $\left\{x^{\alpha}, e^{\beta}\right\}$.

A morphism of $n$-manifolds $\Psi: \mathcal{M} \rightarrow \mathcal{N}$ is a degree preserving morphism of ringed spaces, given by a pair $\Psi=\left(\psi, \psi^{\sharp}\right)$, where $\psi: M \rightarrow N$ is a smooth map and $\psi^{\sharp}: C_{\mathcal{N}} \rightarrow \psi_{*} C_{\mathcal{M}}$ is a degree preserving morphism of sheaves of algebras over $N$.

For each $n \in \mathbb{N}$, $n$-manifolds with their morphisms form a category that we denote by $n$-Man.

An $n$-manifold $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ gives rise to a tower of graded manifolds

$$
\begin{equation*}
M=\mathcal{M}_{0} \leftarrow \mathcal{M}_{1} \cdots \leftarrow \mathcal{M}_{n-1} \leftarrow \mathcal{M}_{n}=\mathcal{M} \tag{4}
\end{equation*}
$$

[^1]where $\mathcal{M}_{r}=\left(M, C_{\mathcal{M}_{r}}\right)$ is an $r$-manifold with $C_{\mathcal{M}_{r}}$ the subsheaf of algebras of $C_{\mathcal{M}}$ locally generated by functions of degree $\leq r$, see 31].

We illustrate $n$-manifolds with some examples.
Example 2.1 (Linear $n$-manifolds). The most basic example of an ordinary smooth manifold of dimension $m$ is $\mathbb{R}^{m}$. For the analogous picture in the graded setting, we consider a collection of nonnegative integers $m_{0}, \cdots, m_{n}$ and define the graded vector space

$$
\mathbf{W}=\oplus_{i=1}^{n} W_{i}
$$

where $W_{i}=\mathbb{R}^{m_{i}}$. The standard linear $n$-manifold of dimension $m_{0}|\cdots| m_{n}$ is defined as

$$
\begin{equation*}
\mathbb{R}^{m_{0}|\cdots| m_{n}}=\left(\mathbb{R}^{m_{0}}, C_{\mathbb{R}^{m_{0}}|\cdots| m_{n}}=C_{\mathbb{R}^{m_{0}}}^{\infty} \otimes S^{\bullet} \mathbf{W}\right) \tag{5}
\end{equation*}
$$

Example 2.2 (1-manifolds). Given a vector bundle $E \rightarrow M$, we can define the 1-manifold

$$
E[1]=\left(M, \Gamma_{\wedge} \cdot E^{*}\right)
$$

On a chart $U$ of $M$ where $E_{\mid U}$ is trivializable, if we pick coordinates $\left\{x^{\alpha}\right\}_{\alpha=1}^{m}$ on $U$ and a frame $\left\{e^{\beta}\right\}_{\beta=1}^{\operatorname{rank}(E)}$ of $E_{\mid U}^{*}$ we have that $\left\{x^{\alpha}, e^{\beta}\right\}$ are local coordinates of $E[1]$, where $\left|x^{\alpha}\right|=0$ and $\left|e^{\beta}\right|=1$. Any 1 -manifold is canonically of this type, as we recall in Section 3, Two important examples of 1-manifolds are

$$
T[1] M=\left(M, \Omega_{M}^{\bullet}\right) \quad \text { and } \quad T^{*}[1] M=\left(M, \mathfrak{X}_{M}^{\bullet}\right)
$$

where $\Omega_{M}^{\bullet}=\Gamma_{\wedge^{\bullet} T^{*} M}$ and $\mathfrak{X}_{M}^{\bullet}=\Gamma_{\wedge^{\bullet} T M}$ are the sheaves of differential forms and multivector fields on $M$, respectively.

Example 2.3 (Split n-manifolds). The previous example can be generalized as follows. Given a non-positively graded vector bundle $\mathbf{D}=\oplus_{i=-n+1}^{0} D_{i} \rightarrow M$, we define the graded manifold $\mathbf{D}[1]=\left(M, \Gamma_{S} \bullet(\mathbf{W})\right)$, where $\mathbf{W}=\oplus_{i=1}^{n} D_{-i+1}^{*}$ is the graded dual of $\mathbf{D}$ with a degree shift by 1 , so it is a graded vector bundle concentrated in degrees 1 to $n$, and $\mathrm{S}^{\bullet}$ denotes, as before, its graded symmetric product. Such $n$-manifolds are known as split, see e.g. [7].

Remark 2.4 (Graded duals). Given a graded vector space $\mathbf{V}=\oplus_{i \in \mathbb{Z}} V_{i}$, its dual is the graded vector space $\mathbf{V}^{*}$ defined by $\left(\mathbf{V}^{*}\right)_{j}=\left(V_{-j}\right)^{*}$.

Example 2.5 (Shifted tangent and cotangent bundles of $n$-manifolds). One can generalize the shifted tangent and cotangent bundles of ordinary manifolds considered in Example 2.2 to arbitrary $n$-manifolds $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$, see e.g. [15, 25]. We will give a description using charts and coordinates (cf. [31]), so that $T[k] \mathcal{M}$ and $T^{*}[k] \mathcal{M}$ are defined by gluing local sheaves.

Let $U$ be a chart of $\mathcal{M}$ with coordinates $\left\{x^{\alpha}, e^{\beta}\right\}$, so that $\left\{x^{\alpha}\right\}$ are coordinates on $U$ and $C_{\mathcal{M}}(U)=C_{M}^{\infty}(U) \otimes S^{\bullet} \mathbf{V}$, with $\left\{e^{\beta}\right\}$ a basis of $\mathbf{V}$. Just as for ordinary smooth manifolds, we can introduce the differentials of the coordinates, $\left\{d x^{\alpha}, d e^{\beta}\right\}$, with the transformation rule

$$
\left\{\begin{array} { l } 
{ \widehat { x } ^ { \alpha } = F ^ { \alpha } ( x ) , } \\
{ \widehat { e } ^ { \beta } = F ^ { \beta } ( x , e ) }
\end{array} \Longrightarrow \left\{\begin{array}{l}
d \widehat{x}^{\alpha}=\frac{\partial F^{\alpha}(x)}{\partial x^{\alpha^{\prime}}} d x^{\alpha^{\prime}} \\
d \widehat{e}^{\beta}=\frac{\partial F^{\beta}(x, e)}{\partial x^{\alpha}} d x^{\alpha}+\frac{\partial F^{\beta}(x, e)}{\partial e^{\beta^{\prime}}} d e^{\beta^{\prime}}
\end{array}\right.\right.
$$

Dualizing we can also define $\left\{\frac{\partial}{\partial x^{\alpha}}, \frac{\partial}{\partial e^{\beta}}\right\}$, with the corresponding transformation rule.

For $k \geq 1$ we define the $(n+k)$-manifold $T[k] \mathcal{M}=\left(M, C_{T[k] \mathcal{M}}\right)$ by

$$
C_{T[k] \mathcal{M}}(U)=C_{M}^{\infty}(U) \otimes S^{\bullet} \mathbf{W} \quad \text { with } \quad \mathbf{W}=\mathbf{V} \oplus\left\langle d x^{\alpha}, d e^{\beta}\right\rangle
$$

with $\left|d x^{\alpha}\right|=k,\left|d e^{\beta}\right|=\left|e^{\beta}\right|+k$. Similarly, for $k \geq n+1$ (to ensure that all coordinates are in positive degrees), we define the $k$-manifold $T^{*}[k] \mathcal{M}=\left(M, C_{T^{*}[k] \mathcal{M}}\right)$ by

$$
C_{T^{*}[k] \mathcal{M}}(U)=C_{M}^{\infty}(U) \otimes S^{\bullet} \mathbf{W} \quad \text { with } \quad \mathbf{W}=\mathbf{V} \oplus\left\langle\frac{\partial}{\partial x^{\alpha}}, \frac{\partial}{\partial e^{\beta}}\right\rangle
$$

with $\left|\frac{\partial}{\partial x^{\alpha}}\right|=k,\left|\frac{\partial}{\partial e^{\beta}}\right|=-\left|e^{\beta}\right|+k$.
Example 2.6 (Cartesian product of $n$-manifolds). Given $n$-manifolds $\mathcal{M}_{i}=\left(M_{i}, C_{\mathcal{M}_{i}}\right), i=1,2$, we define an $n$-manifold $\mathcal{M}_{1} \times \mathcal{M}_{2}=\left(M_{1} \times M_{2}, C_{\mathcal{M}_{1} \times \mathcal{M}_{2}}\right)$, where

$$
C_{\mathcal{M}_{1} \times \mathcal{M}_{2}}=C_{\mathcal{M}_{1}} \widehat{\otimes} C_{\mathcal{M}_{2}}
$$

and the hat denotes the usual completion on the product topology, see e.g. [10]. Concretely, on open rectangles $U_{1} \times U_{2}$, with $U_{i} \subset M_{i}$ satisfying $C_{\mathcal{M}_{i}}\left(U_{i}\right) \cong C_{M_{i}}^{\infty}\left(U_{i}\right) \otimes S^{\bullet} \mathbf{V}_{i}$ we have

$$
\begin{equation*}
C_{\mathcal{M}_{1} \times \mathcal{M}_{2}}\left(U_{1} \times U_{2}\right) \cong C_{M_{1} \times M_{2}}^{\infty}\left(U_{1} \times U_{2}\right) \otimes S^{\bullet}\left(\mathbf{V}_{1} \oplus \mathbf{V}_{2}\right) \tag{6}
\end{equation*}
$$

where $\mathbf{V}_{1} \oplus \mathbf{V}_{2}$ denotes the usual graded direct sum. Since open rectangles form a basis of the product topology, (6) is sufficient to define $C_{\mathcal{M}_{1} \times \mathcal{M}_{2}}$.
2.2. Admissible coalgebra bundles. Any $n$-manifold $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ codifies classical geometric information as follows. The multiplication on $C_{\mathcal{M}}$ satisfies

$$
\begin{equation*}
C_{\mathcal{M}}^{i} \cdot C_{\mathcal{M}}^{j} \subseteq C_{\mathcal{M}}^{i+j} \tag{7}
\end{equation*}
$$

and since $C_{\mathcal{M}}^{0}=C_{M}^{\infty}$ (as a consequence of (3)), each $C_{\mathcal{M}}^{i}$ is a $C_{M}^{\infty}$-module, which is locally free and finitely generated (again by condition (3)). It follows that there exist vector bundles $E_{-i} \rightarrow M$ such that

$$
C_{\mathcal{M}}^{i} \cong \Gamma_{E_{-i}^{*}}^{*}
$$

It turns out that the fact that $\mathcal{M}$ is of degree $n$ implies that $C_{\mathcal{M}}$ is completely determined by information involving just the vector bundles $E_{-1}, \cdots, E_{-n}$. More precisely, since the multiplication in (7) is $C_{M}^{\infty}$-bilinear, it defines vector bundle maps $E_{-(i+j)} \rightarrow E_{-i} \otimes E_{-j}$, and we will see (in Lemma 3.7) that $\mathcal{M}$ can be reconstructed from such maps for $i+j \leq n$.

Given vector bundles $E_{-1}, \ldots, E_{-n}$ and vector bundle maps $E_{-(i+j)} \rightarrow E_{-i} \otimes E_{-j}$ (covering the identity map on $M$ ), one could ask whether this data arises from an $n$-manifold. This will lead us to the notion of admissible coalgebra bundles.

Definition 2.7. Given $n \in \mathbb{N}$, an $n$-coalgebra bundle is a pair $(\mathbf{E} \rightarrow M, \mu)$ where $\mathbf{E}=$ $\oplus_{i=-n}^{-1} E_{i} \rightarrow M$ is a negatively graded finite-dimensional vector bundle and $\mu: \mathbf{E} \rightarrow \mathbf{E} \otimes \mathbf{E}$ is a degree-preserving vector bundle map (covering the identity map on $M$ ) that is coassociative and (graded) cocommutative, i.e.

$$
(\operatorname{Id} \otimes \mu) \circ \mu=(\mu \otimes \mathrm{Id}) \circ \mu, \quad \mu=\tau \cdot \mu
$$

where $\tau \in S_{2}$ acts via the braiding map that exchanges the two components with the appropriate sign, i.e., $\tau\left(e \otimes e^{\prime}\right)=(-1)^{i+j} e^{\prime} \otimes e$, for $e \in E_{i}, e^{\prime} \in E_{j}$.

A morphism of $n$-coalgebra bundles, $(\mathbf{E} \rightarrow M, \mu) \rightarrow(\mathbf{F} \rightarrow N, \nu)$, is a degree-preserving vector-bundle map $\Phi: \mathbf{E} \rightarrow \mathbf{F}$ satisfying $\nu \circ \Phi=(\Phi \otimes \Phi) \circ \mu$.

The coassociative and cocommutative assumptions put constraints on the image of $\mu$, that we describe more explicitly. For $k \geq 0$, let

$$
\mu^{k}: \mathbf{E} \rightarrow \otimes^{k+1} \mathbf{E}
$$

be defined by $\mu^{k}=(\operatorname{Id} \otimes \cdots \otimes \operatorname{Id} \otimes \mu) \circ \cdots \circ(\operatorname{Id} \otimes \mu) \circ \mu \circ \mathrm{Id}$. Then coassociativity and cocommutativity imply that, for all $e \in \operatorname{im}(\mu)$, the identity

$$
\begin{equation*}
\tau \cdot\left(\mu^{k} \otimes \mu^{\ell}\right)(e)=\tau^{\prime} \cdot\left(\mu^{k^{\prime}} \otimes \mu^{\ell^{\prime}}\right)(e) \tag{8}
\end{equation*}
$$

holds for all $k, k^{\prime}, \ell, \ell^{\prime} \in \mathbb{Z}_{\geq 0}$ such that $k+\ell=k^{\prime}+\ell^{\prime}$, and for all permutations $\tau, \tau^{\prime} \in S_{k+\ell+2}$, acting via the (graded) braiding action ${ }^{2}$.

Definition 2.8. We denote by $\mathbf{K}^{\mu} \subseteq \mathbf{E} \otimes \mathbf{E}$ the space of all $e \in \mathbf{E} \otimes \mathbf{E}$ satisfying (8). The subspace of degree $i$ elements of $\mathbf{K}^{\mu}$ is denoted by $K_{i}^{\mu}$.

As noted above, coassociativity and cocommutativity of $\mu$ imply that $\operatorname{im}(\mu) \subseteq \mathbf{K}^{\mu}$.
Definition 2.9. An $n$-coalgebra bundle $(\mathbf{E} \rightarrow M, \mu)$ is admissible if, $\forall i=-n, \ldots,-2$,

$$
\operatorname{im}\left(\mu_{i}\right)=K_{i}^{\mu},
$$

where

$$
\mu_{i}=\left.\mu\right|_{E_{i}} .
$$

(Note that the condition is trivial for $i=-1$.) For each $n \in \mathbb{N}$, we denote by $n$-Cob the category of admissible $n$-coalgebra bundles.

Remark 2.10. Since $\mathbf{E} \rightarrow M$ is concentrated in negative degrees, we see that the definition of $K_{i}^{\mu}$ via (8) only involves $\mu_{l}$ for $l>i$. So the admissibility condition at level $i$ relates $\mu_{i}$ to the components $\mu_{l}$ for $l>i$.

We illustrate the previous definition with some examples.
Example 2.11 (1-coalgebra bundles). Let $\mathbf{E} \rightarrow M$ be a graded vector bundle concentrated in degree $-1, \mathbf{E}=E_{-1}$. Then $\mathbf{E} \otimes \mathbf{E}=E_{-1} \otimes E_{-1}$ is concentrated in degree -2 , so any coalgebrabundle structure must be trivial, and hence admissible. It follows that $1-\mathcal{C o b}$ coincides with the category $\mathcal{V e c t}$ of vector bundles.

Example 2.12 (2-coalgebra bundles). For a 2-coalgebra bundle $\mathbf{E}=E_{-2} \oplus E_{-1}$, the coalgebra structure is determined by $\mu_{-2}: E_{-2} \rightarrow E_{-1} \otimes E_{-1}$. For the admissibility condition we need to determine $K_{-2}^{\mu}$. Note that, in the case at hand, equation (8) is determined by $k=l=k^{\prime}=l^{\prime}=$ $0, \tau=(12)$ and $\tau^{\prime}=i d$, showing that $K_{-2}^{\mu}=E_{-1} \wedge E_{-1}$ (viewed as a subspace of $E_{-1} \otimes E_{-1}$ in the usual way). So the admissibility condition amounts to

$$
\operatorname{im}\left(\mu_{-2}\right)=E_{-1} \wedge E_{-1}
$$

[^2]So any 2-coalgebra bundle is determined by two vector bundles $E_{-1}, E_{-2}$ and a map $\mu$ : $E_{-2} \rightarrow E_{-1} \otimes E_{-1}$ satisfying the previous condition. The category 2 - $\mathcal{C o b}$ is thus equivalent to the category whose objects are triples

$$
\left(E_{-1} \rightarrow M, E_{-2} \rightarrow M, \mu: E_{-2} \rightarrow E_{-1} \wedge E_{-1}\right)
$$

where $\mu$ is a surjective vector-bundle map over the identity on $M$, and morphisms

$$
\left(E_{-1}, E_{-2}, \mu\right) \longrightarrow\left(F_{-1}, F_{-2}, \nu\right)
$$

are triples $\left(\phi, \Phi_{-1}, \Phi_{-2}\right)$, where $\left(\phi, \Phi_{i}\right):\left(E_{i} \rightarrow M\right) \rightarrow\left(F_{i} \rightarrow N\right), i=-1,-2$, are vector-bundle maps satisfying $\nu \circ \Phi_{-2}=\left(\Phi_{-1} \wedge \Phi_{-1}\right) \circ \mu$. This category was introduced in [9, § 2.2], where it is called VB2.

Example 2.13 (3-coalgebra bundles). On a 3-coalgebra bundle (E, $\mu$ ), notice that

$$
\begin{aligned}
K_{-3}^{\mu} & =\left\{e \otimes p \in E_{-1} \otimes E_{-2} \mid e \otimes \mu_{-2}(p)=\operatorname{sgn}(\tau) \tau\left(e \otimes \mu_{-2}(p)\right) \quad \text { for } \tau \in S_{3}\right\} \\
& =\left(\operatorname{Id}_{E_{-1}} \otimes \mu_{-2}\right)^{-1}\left(\wedge^{3} E_{-1}\right)
\end{aligned}
$$

Building on the previous example, an admissible 3-coalgebra bundle is determined by three vector bundles $E_{i} \rightarrow M, i=-1,-2,-3$, and two vector-bundle morphisms

$$
\mu_{-2}: E_{-2} \rightarrow E_{-1} \otimes E_{-1} \quad \text { and } \quad \mu_{-3}: E_{-3} \rightarrow E_{-1} \otimes E_{-2}
$$

satisfying
$\left(\mu_{-2} \otimes \operatorname{Id}\right) \circ \mu_{-3}=\left(\operatorname{Id} \otimes \mu_{-2}\right) \circ \mu_{-3}, \quad \operatorname{im}\left(\mu_{-2}\right)=E_{-1} \wedge E_{-1}, \quad \operatorname{im}\left(\mu_{-3}\right)=\left(\operatorname{Id}_{E_{-1}} \otimes \mu_{-2}\right)^{-1}\left(\wedge^{3} E_{-1}\right)$.
A morphism of 3-coalgebra bundles from $(\mathbf{E} \rightarrow M, \mu)$ to $(\mathbf{F} \rightarrow N, \nu)$ amounts to three vectorbundle morphisms $\Phi_{i}: E_{i} \rightarrow F_{i}$ covering the same base map $\phi: M \rightarrow N$ satisfying

$$
\nu_{-2} \circ \Phi_{-2}=\left(\Phi_{-1} \otimes \Phi_{-1}\right) \circ \mu_{-2} \quad \text { and } \quad \nu_{-3} \circ \Phi_{-3}=\left(\Phi_{-1} \otimes \Phi_{-2}\right) \circ \mu_{-3}
$$

The category 3-Cob has objects $\left(E_{-1}, E_{-2}, E_{-3}, \mu_{-1}, \mu_{-2}\right)$ and morphisms $\left(\Phi_{-1}, \Phi_{-2}, \Phi_{-3}\right)$ as just described.

Example 2.14 (Truncation). Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $n$-coalgebra bundle. For each $k=0, \ldots, n$, the $k$-truncation $\left(\mathbf{E}^{\leq k} \rightarrow M, \mu^{\leq k}\right)$ is the $k$-coalgebra bundle given by

$$
\left(\mathbf{E}^{\leq k}\right)_{i}=\left\{\begin{array}{ll}
E_{i} & \text { if }-k \leq i \leq-1 \\
0 & \text { otherwise }
\end{array} \quad \text { and } \quad \mu^{\leq k}=\mu_{\mid \mathbf{E} \leq k}\right.
$$

Hence $\mu_{i}^{\leq k}=\mu_{i}$, for $-k \leq i \leq-1$. Note also that

$$
\begin{equation*}
K_{i}^{\mu}=K_{i}^{\mu^{\leq k}}, \quad \text { for } i \geq-k-1 \tag{9}
\end{equation*}
$$

as a consequence of Remark 2.10. Since $\mathbf{E}$ is admissible, for $i \geq-k$ we have that

$$
\operatorname{im}\left(\mu_{i}^{\leq k}\right)=\operatorname{im}\left(\mu_{i}\right)=K_{i}^{\mu}=K_{i}^{\mu \leq k}
$$

so the truncation $\mathbf{E} \leq k$ is also admissible.
Example 2.15 (Split coalgebra bundles). Given a graded vector bundle $\mathbf{D}=\oplus_{i=-n}^{-1} D_{i}$ we define an admissible $n$-coalgebra bundle $\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ by

$$
\left(\mathbf{E}_{\mathbf{D}}\right)_{i}=\left(\mathrm{S}^{\bullet} \mathbf{D}\right)_{i} \quad \text { for }-n \leq i \leq-1
$$

where $\left(S^{\bullet} \mathbf{D}\right)_{i}$ denotes the subspace of degree $i$ elements in the graded symmetric product of $\mathbf{D}$, and $\mu^{s}: \mathbf{E}_{\mathbf{D}} \rightarrow \mathbf{E}_{\mathbf{D}} \otimes \mathbf{E}_{\mathbf{D}}$ is given in components by

$$
\left\langle\mu_{i}^{s}(e), \eta \otimes \nu\right\rangle=\langle e, \eta \cdot \nu\rangle
$$

where $e \in\left(\mathbf{E}_{\mathbf{D}}\right)_{i}, \eta \in\left(\mathbf{E}_{\mathbf{D}}\right)_{j}^{*}=\left(\mathbf{S}^{\bullet} \mathbf{D}^{*}\right)_{-j}, \nu \in\left(\mathbf{E}_{\mathbf{D}}\right)_{i-j}^{*}=\left(\mathrm{S}^{\bullet} \mathbf{D}^{*}\right)_{j-i}$ with $-n+1 \leq j \leq-1$ (see Remark (2.4) and "." is the graded symmetric product

$$
\left(\mathbf{S}^{\bullet} \mathbf{D}^{*}\right)_{-j} \otimes\left(\mathbf{S}^{\bullet} \mathbf{D}^{*}\right)_{j-i} \rightarrow\left(\mathbf{S}^{\bullet} \mathbf{D}^{*}\right)_{-i}
$$

The fact that $\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ is admissible follows directly from the identities

$$
\begin{equation*}
\left(\mathbf{E}_{\mathbf{D}}\right)_{i}=D_{i} \oplus\left(\mathbf{S}^{\bullet} \mathbf{D}^{\leq-i-1}\right)_{i} \quad \text { and } \quad K_{i}^{\mu^{s}}=\left(\mathrm{S}^{\bullet} \mathbf{D}^{\leq-i-1}\right)_{i} \quad \text { for }-n \leq i \leq-2, \tag{10}
\end{equation*}
$$

where $\mathbf{D}^{\leq-i-1}=\oplus_{j=i+1}^{-1} D_{j}$. In particular we also have that $D_{i}=\operatorname{ker} \mu_{i}^{s}$ for all $-n \leq i \leq-1$. Such $n$-coalgebra bundles of type $\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ are called split.

It follows from the previous example that if a coalgebra bundle is isomorphic to one that is split, then it is admissible. Conversely, we now show that any admissible $n$-coalgebra bundle is isomorphic to a split one.
Proposition 2.16 (Admissible coalgebra bundles are split). Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $n$-coalgebra bundle. Then, for each $i=-n, \ldots,-1$, we have a short exact sequence of vector bundles

$$
0 \longrightarrow \operatorname{ker}\left(\mu_{i}\right) \longrightarrow E_{i} \longrightarrow K_{i}^{\mu} \longrightarrow 0,
$$

and a choice of splittings of these sequences gives rise to an identification

$$
(\mathbf{E}, \mu) \cong\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right),
$$

where $\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ is the split n-coalgebra bundle associated with the graded vector bundle $\mathbf{D}:=$ $\oplus_{i=-n}^{-1} \operatorname{ker} \mu_{i}$ (as in Example 2.15).
Proof. The proof will be by induction on $n$. For $n=1$ the proposition holds since the coalgebra structures are trivial and $E_{-1}=D_{-1}$ (see Example 2.11). Now assume that the proposition holds for admissible ( $n-1$ )-coalgebra bundles.

Given an admissible $n$-coalgebra bundle $(\mathbf{E}, \mu),\left(\mathbf{E}^{\leq n-1}, \mu^{\leq n-1}\right)$ is an admissible $(n-1)$ coalgebra bundle (see Example 2.14). By the induction hypothesis we have an isomorphism

$$
\Phi^{\leq n-1}:\left(\mathbf{E}^{\leq n-1}, \mu^{\leq n-1}\right) \rightarrow\left(\mathbf{E}_{\mathbf{D} \leq n-1}, \mu^{s}\right)
$$

where $\mathbf{D}^{\leq n-1}=\oplus_{i=-n+1}^{-1} \operatorname{ker}\left(\mu_{i}\right)$. We can now use the isomorphism $\Phi^{\leq n-1}$ to conclude that

$$
\operatorname{im}\left(\mu_{-n}\right)=\left(K_{-n}^{\mu}\right)=\left(K_{-n}^{\mu \leq n-1}\right) \cong\left(K_{-n}^{\mu^{s}}\right)=\left(\mathrm{S}^{\bullet} \mathbf{D}^{\leq n-1}\right)_{-n},
$$

where the first equality is the admissibility condition at level $-n$ for $\mathbf{E}$ and the second follows from (91). Therefore $E_{-n}$ and $\left(\mathbf{E}_{\mathbf{D}}\right)_{-n}$ fit into the following diagram


A splitting of the top exact sequence of vector bundles identifies $E_{-n}$ with $\left(\mathbf{E}_{\mathbf{D}}\right)_{-n}$ and extends $\Phi^{\leq n-1}$ to a coalgebra bundle isomorphism $(\mathbf{E}, \mu) \xrightarrow{\sim}\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$.

## 3. The equivalence

For each $n \in \mathbb{N}$, we define in this section a functor that establishes an equivalence of categories from $n-\mathcal{C} o b$ to $n$ - $\mathcal{M a n}$. This geometrization functor thus provides a description of $n$-manifolds by (admissible) $n$-coalgebra bundles, which are ordinary differential-geometric objects. It extends the known correspondence between 1-manifolds and vector bundles, as well as the characterization of 2-manifolds by the VB2-category (see Example 2.12) in [9, § 2.2]. This functor has also been used in $[15]$ to study graded cotangent bundles $T^{*}[n] A[1]$.
3.1. The functor. Let $(\mathbf{E} \rightarrow M, \mu)$ be an $n$-coalgebra bundle, and let $\mu^{*}: \Gamma_{\mathbf{E}^{*}} \times \Gamma_{\mathbf{E}^{*}} \rightarrow \Gamma_{\mathbf{E}^{*}}$ denote the dual algebra structure. Recall that $\mathbf{E}^{*}=\oplus_{i=1}^{n} E_{-i}^{*}$.

In the sheaf of algebras $\left(\Gamma_{S^{\bullet}} \mathbf{E}^{*}, \cdot\right)$ we define the following sheaf of ideals: for an open subset $U \subseteq M$,

$$
\mathcal{I}_{\mu}(U)=\left\langle\omega \cdot \eta-\mu^{*}(\omega, \eta)\right\rangle
$$

where $\omega, \eta \in \Gamma_{\mathbf{E}^{*}}(U),|\omega|+|\eta| \leq n$, and "." denotes the graded symmetric product.
Remark 3.1. Note that $\mathcal{I}_{\mu}$ is a sheaf of homogeneous ideals with respect to the grading of $\mathbf{E}^{*}$. Therefore $\Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}$ is also a sheaf of graded algebras. Note that, for $1 \leq i \leq n$,

$$
\left(\Gamma_{S} \bullet \mathbf{E}^{*} / \mathcal{I}_{\mu}\right)_{i}=\Gamma_{E_{-i}^{*}}^{*}
$$

An $n$-coalgebra bundle $(\mathbf{E}, \mu)$ gives rise to a ringed space by

$$
\begin{equation*}
\left(M, \Gamma_{\mathrm{S}} \bullet \mathbf{E}^{*} / \mathcal{I}_{\mu}\right) \tag{12}
\end{equation*}
$$

Given a coalgebra morphism $\Phi:(\mathbf{E} \rightarrow M, \mu) \rightarrow(\mathbf{F} \rightarrow N, \nu)$, with $\phi=\Phi_{\left.\right|_{M}}: M \rightarrow N$, we also denote by $\Phi: S^{\bullet} \mathbf{E} \rightarrow S^{\bullet} \mathbf{F}$ its natural extension to the symmetric products. The fact that $\Phi$ is a coalgebra map implies that $\Phi^{*}: \Gamma_{\mathbf{F}^{*}} \rightarrow \phi_{*} \Gamma_{\mathbf{E}^{*}}$ is a map of sheaves of algebras, so $\Phi^{*} \mathcal{I}_{\nu} \subseteq \mathcal{I}_{\mu}$. Thus, $\Phi^{*}$ induces a well-defined map on the quotients by the ideals, denoted by $\phi^{\sharp}$, in such a way that

$$
\begin{equation*}
\left(\phi, \phi^{\sharp}\right):\left(M, \Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}\right) \rightarrow\left(N, \Gamma_{S} \bullet \mathbf{F}^{*} / \mathcal{I}_{\nu}\right) \tag{13}
\end{equation*}
$$

is a morphism of ringed spaces.
We need the following result to show that, when $(\mathbf{E}, \mu)$ is admissible, the ringed space (12) is an $n$-manifold.

Lemma 3.2. Let $\mathbf{D}=\oplus_{i=-n}^{-1} D_{i} \rightarrow M$ be a graded vector bundle. Consider the coalgebra bundle $\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ of Example 2.15. Then

$$
\Gamma_{S} \bullet \mathrm{E}_{\mathbf{D}}^{*} / \mathcal{I}_{\mu^{s}}=\Gamma_{\mathrm{S}} \bullet \mathbf{D}^{*}
$$

Proof. Denote the symmetric product on $\Gamma_{S} \bullet \mathbf{E}_{\mathbf{D}}^{*}$ by "." and the symmetric product on $\Gamma_{S} \bullet \mathbf{D}^{*}$ by " $\vee$ ". Since $\left(\mathbf{E}_{\mathbf{D}}^{*}\right)_{i}=\left(\mathrm{S}^{\bullet} \mathbf{D}^{*}\right)_{i}$ for $i=1, \ldots, n$, we can view $\mathbf{D}^{*} \subseteq \mathbf{E}_{\mathbf{D}}^{*}$, so we have a natural inclusion $\Gamma_{S^{\bullet}} \mathbf{D}^{*} \hookrightarrow \Gamma_{S^{\bullet}} \mathbf{E}_{\mathbf{D}}^{*}$, given by $d_{1} \vee \ldots \vee d_{k} \mapsto d_{1} \cdot \ldots \cdot d_{k}$. Consider the quotient homomorphism $\Gamma_{S^{\bullet}} \mathbf{E}_{\mathrm{D}}^{*} \rightarrow\left(\Gamma_{\mathrm{S}} \mathbf{E}_{\mathbf{D}}^{*} / \mathcal{I}_{\mu^{s}}\right), \xi \mapsto \bar{\xi}$. From the definition of $\mathcal{I}_{\mu^{s}}$, one can readily see that the composite map

$$
\begin{equation*}
\Gamma_{\mathrm{S}} \bullet \mathbf{D}^{*} \rightarrow \Gamma_{\mathrm{S}} \cdot \mathbf{E}_{\mathbf{D}}^{*} / \mathcal{I}_{\mu^{s}}, \quad d_{1} \vee \ldots \vee d_{k} \mapsto \overline{d_{1}} \cdot \ldots \cdot \overline{d_{k}} \tag{14}
\end{equation*}
$$

is still an injection. To see that it is also a surjection, recall that $\mu^{s *}(\xi, \eta)=\xi \vee \eta$ (see Example 2.15), so the image of a local section $\xi=d_{1} \vee \ldots \vee d_{l}$ of $\Gamma_{\left(\mathbf{E}_{\mathrm{D}}^{*}\right)_{i}}=\Gamma_{\left(\mathrm{S}^{\bullet} \mathbf{D}^{*}\right)_{i}}$ under the quotient by $\mathcal{I}_{\mu^{s}}$ is $\bar{\xi}=\overline{d_{1}} \cdot \ldots \cdot \overline{d_{l}}$. It follows that an arbitrary local section in $\Gamma_{\mathrm{S}} \mathrm{E}_{\mathrm{D}}^{*} / \mathcal{I}_{\mu^{s}}$ is a symmetric expression of elements $\overline{d_{j}}$ in $\Gamma_{\mathbf{D}^{*}}$, showing that (14) is surjective.

Proposition 3.3. For each non-negative integer $n$ the functor $\mathcal{F}: n-\mathcal{C o b} \rightarrow n-\mathcal{M}$ an given by

$$
\mathcal{F}(\mathbf{E} \rightarrow M, \mu)=\left(M, \Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}\right) \quad \text { and } \quad \mathcal{F}(\Phi)=\left(\phi, \phi^{\sharp}\right): \mathcal{F}(\mathbf{E}, \mu) \rightarrow \mathcal{F}(\mathbf{F}, \nu)
$$

as in (13) is well defined.
Proof. We start by showing that $\mathcal{F}$ is well defined at the level of objects. Assuming that the coalgebra bundle $(\mathbf{E} \rightarrow M, \mu)$ is admissible we must prove that

$$
\begin{equation*}
\mathcal{M}=\mathcal{F}(\mathbf{E} \rightarrow M, \mu)=\left(M, C_{\mathcal{M}}=\Gamma_{S_{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}\right) \tag{15}
\end{equation*}
$$

satisfies condition (3). By the admissibility condition, Prop. 2.16 and Lemma 3.2 imply that $\Gamma_{\mathrm{S}} \mathbf{E}^{*} / \mathcal{I}_{\mu} \cong \Gamma_{\mathrm{S}} \bullet \mathbf{D}^{*}$, for $\mathbf{D}^{*}=\oplus_{i=1}^{n}\left(\operatorname{ker} \mu_{-i}\right)^{*}$. Since $\mathbf{D}^{*}$ is locally trivial, there exists a graded vector space $\mathbf{W}=\oplus_{i=1}^{n} W_{i}$ such that any point in $M$ admits an open neighborhood $U$ with $\left.\mathbf{D}^{*}\right|_{U}=U \times \mathbf{W}$, so that

$$
\begin{equation*}
\left.\left.C_{\mathcal{M}}\right|_{U}=\left.\left(\Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}\right)\right|_{U} \cong \Gamma_{\left(U \times S^{\bullet}\right.} \mathbf{W}\right)=C_{U}^{\infty} \otimes S^{\bullet} \mathbf{W} \tag{16}
\end{equation*}
$$

Since morphisms of graded manifolds are morphisms of ringed spaces it is clear that $\mathcal{F}$ is well defined at the level of morphisms.

Remark 3.4. (a) The functor $\mathcal{F}$ takes split $n$-coalgebra bundles (Example 2.15) to split $n$-manifolds (Example 2.3).
(b) The correspondence $(\mathbf{E} \rightarrow M, \mu) \mapsto \mathcal{F}(\mathbf{E} \rightarrow M, \mu)=\mathcal{M}$ respects truncations (see (4) and Example [2.14), i.e.

$$
\mathcal{F}\left(\mathbf{E}^{\leq k} \rightarrow M, \mu^{\leq k}\right)=\mathcal{M}_{k} \quad \text { for all } \quad k \in\{0, \cdots, n\} .
$$

Remark 3.5 (Local coordinates). For an $n$-manifold $\mathcal{M}$ as in (15), by locally splitting $E_{-i}^{*}$ as $\left(\operatorname{ker} \mu_{-i}\right)^{*} \oplus\left(K_{-i}^{\mu}\right)^{*}$, we see that degree $i$ coordinates on $\mathcal{M}$ are given by a local frame of $\left(\operatorname{ker} \mu_{-i}\right)^{*}$ while the spaces $\left(K_{-i}^{\mu}\right)^{*}=\left(\operatorname{im} \mu_{-i}\right)^{*}$ codify coordinates in degree $i$ which are products of coordinates of lower degrees. In fact, note that, globally,

$$
\begin{equation*}
C_{\mathcal{M}_{i-1}}^{i}=\Gamma_{\left(K_{-i}\right)^{*}}^{\mu}, \quad i=2, \cdots, n \tag{17}
\end{equation*}
$$

One can check this equality by noticing that it holds in the split case (see (10)) and using Prop. 2.16
3.2. The equivalence of categories. We will now show that the functor in Prop. 3.3 is an equivalence of categories.

Given an $n$-manifold $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ recall from $\S 2.2$ that, for each $i=1,2, \ldots, C_{\mathcal{M}}^{i} \cong \Gamma_{E_{-i}^{*}}$ for some vector bundle $E_{-i} \rightarrow M$ (unique up to isomorphism), and the multiplication on $C_{\mathcal{M}}^{-i}$ is codified by vector bundle maps $E_{-(i+j)} \rightarrow E_{-i} \otimes E_{-j}$. Picking those maps with $i+j \leq n$ gives a coalgebra structure $\mu$ on $\mathbf{E}:=\oplus_{i=-n}^{-1} E_{-i}$. Note that, by its very construction, this coalgebra bundle ( $\mathbf{E}, \mu$ ) associated with $\mathcal{M}$ is uniquely defined, up to isomorphism.

Example 3.6. If $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ is a split $n$-manifold, then a corresponding coalgebra bundle ( $\mathbf{E}, \mu$ ) is isomorphic to a split coalgebra bundle. Indeed (see Example 2.3), since

$$
C_{\mathcal{M}}=\Gamma_{S} \cdot(\mathbf{W})
$$

for a graded vector bundle $\mathbf{W}=\oplus_{i=1}^{n} W_{i} \rightarrow M$, by setting $\mathbf{D}=\mathbf{W}^{*}$ one can directly check that $(\mathbf{E}, \mu) \cong\left(\mathbf{E}_{\mathbf{D}}, \mu^{s}\right)$ (see Example [2.15).
Lemma 3.7. Let $\mathcal{M}$ be an n-manifold, and let $(\mathbf{E}, \mu)$ be a corresponding coalgebra bundle. Then $(\mathbf{E}, \mu)$ is admissible and $C_{\mathcal{M}} \cong \Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}$.
Proof. Since admissibility is a pointwise condition, it is enough to verify that $(\mathbf{E}, \mu)$ is admissible on small open subsets, and this holds since $\mathcal{M}$ is locally isomorphic to a split $n$-manifold (by (3)), so ( $\mathbf{E}, \mu$ ) is locally isomorphic to a split coalgebra bundle (Example 3.6), hence admissible (see Example 2.15).

For the second statement, note that, by the way $(\mathbf{E}, \mu)$ is defined, we have that $C_{\mathcal{M}}^{i}=\Gamma_{E_{-i}^{*}}$, for $i=1, \cdots, n$, and there is a natural morphism of graded algebras $\phi: \Gamma_{\mathbf{S}^{\prime}} \mathbf{E}^{*} \rightarrow C_{\mathcal{M}}$ satisfying $\phi\left(\mathcal{I}_{\mu}\right)=0$. To show that the induced map

$$
\Gamma_{\mathrm{S}^{\bullet}} \mathrm{E}^{*} / \mathcal{I}_{\mu} \rightarrow C_{\mathcal{M}}
$$

is an isomorphism, it is enough to show that it is an isomorphism on small open subsets. This can be verified again using that $(\mathbf{E}, \mu)$ is locally isomorphic to a split coalgebra bundle, so the result follows from Lemma 3.2,

We are ready to show that, for each $n$, the category of $n$-coalgebra bundles and the category of $n$-manifolds are equivalent.
Theorem 3.8. For each non-negative integer $n$ the functor $\mathcal{F}: n-\mathcal{C} o b \rightarrow n-\mathcal{M}$ an from Proposition 3.3 is an equivalence of categories.
Proof. We must verify that $\mathcal{F}$ is fully faithful and essentially surjective. To see that it is fully faithful, let $(\mathbf{E} \rightarrow M, \mu)$ and $(\mathbf{F} \rightarrow N, \nu)$ be admissible $n$-coalgebra bundles, and let $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ and $\mathcal{N}=\left(N, C_{\mathcal{N}}\right)$ be their respective images under $\mathcal{F}$. As noticed in Remark 3.1. we have that $C_{\mathcal{M}}^{i}=\Gamma_{E_{-i}^{*}}$ and $C_{\mathcal{N}}^{i}=\Gamma_{F_{-i}^{*}}$ for $1 \leq i \leq n$. For morphisms $\Phi_{1}, \Phi_{2}:(\mathbf{E}, \mu) \rightarrow$ $(\mathbf{F}, \nu)$, consider $\mathcal{F}\left(\Phi_{1}\right)=\left(\phi_{1}, \phi_{1}^{\sharp}\right), \mathcal{F}\left(\Phi_{2}\right)=\left(\phi_{2}, \phi_{2}^{\sharp}\right): \mathcal{M} \rightarrow \mathcal{N}$, the corresponding morphisms of $n$-manifolds. Then $\mathcal{F}\left(\Phi_{1}\right)=\mathcal{F}\left(\Phi_{2}\right)$ if and only if

$$
\left\{\begin{array}{l}
\phi_{1}=\phi_{2}, \\
\left(\phi_{1}^{\sharp}\right)^{i}=\left(\phi_{2}^{\sharp}\right)^{i}: C_{\mathcal{N}}^{i} \rightarrow \phi_{1 *} C_{\mathcal{M}}^{i} \quad \text { for } i=1, \ldots, n .
\end{array}\right.
$$

$\operatorname{But}\left(\phi_{j}^{\sharp}\right)^{i}=\left(\Phi_{j}^{*}\right)^{i}: \Gamma_{F_{i}^{*}} \rightarrow \phi_{j *} \Gamma_{E_{i}^{*}}$, for $j=1,2$. Therefore $\Phi_{1}=\Phi_{2}$, so $\mathcal{F}$ is faithful.
To see that $\mathcal{F}$ is full, recall that, for a morphism $\Psi=\left(\psi, \psi^{\sharp}\right): \mathcal{M} \rightarrow \mathcal{N}$, the fact that $\psi^{\sharp}: C_{\mathcal{N}} \rightarrow \psi_{*} C_{\mathcal{M}}$ is a morphism of sheaves of graded algebras implies that, for each $i=1, \ldots, n$, $\left(\psi^{\sharp}\right)^{i}: C_{\mathcal{N}}^{i}=\Gamma_{F_{i}^{*}} \rightarrow \psi_{*} C_{\mathcal{M}}^{i}=\psi_{*} \Gamma_{E_{i}^{*}}$ is a morphism of sheaves of $C_{N}^{\infty}$-modules, which is equivalent (by adjointness) to a morphism $\left(\psi^{\sharp}\right)^{i}: \psi^{*} \Gamma_{F_{i}^{*}} \rightarrow \Gamma_{E_{i}^{*}}$ of sheaves of $C_{M}^{\infty}$-modules, which is necessarily defined by a vector-bundle map $\psi^{*} F_{i}^{*} \rightarrow E_{i}^{*}$. It follows that there is a map $\Phi: \mathbf{E} \rightarrow \mathbf{F}$ of graded vector bundles covering $\psi: M \rightarrow N$ such that $\left(\Phi^{*}\right)^{i}=\left(\psi^{\sharp}\right)^{i}$, for $1 \leq i \leq n$. Finally the fact that $\psi^{\sharp}$ is an algebra morphism implies that $\Phi: \mathbf{E} \rightarrow \mathbf{F}$ is a coalgebra morphism.

The fact that $\mathcal{F}$ is essentially surjective is a direct consequence of Lemma 3.7.

As a direct consequence of the equivalence in Theorem [3.8, along with Remark 3.4 (a) and Prop. [2.16, we have the following result, see [7, Thm. 1].

Corollary 3.9. Any n-manifold is isomorphic to one that is split.
Remark 3.10 (Submanifolds). By means of the geometrization functor, one obtains a description of submanifolds of a given $n$-manifold $\mathcal{M}=\mathcal{F}(\mathbf{E} \rightarrow M, \mu)$ as admissible coalgebra subbundles $(\mathbf{F} \rightarrow N, \nu) \hookrightarrow(\mathbf{E} \rightarrow M, \mu)$. Alternatively, by taking annihilators one can describe submanifolds of $\mathcal{M}$ as graded subbundles $(\mathbf{K} \rightarrow N) \subseteq\left(\mathbf{E}^{*} \rightarrow M\right)$ satisfying

$$
\mathbf{K} \cap \mu^{*}\left(\mathbf{E}^{*} \otimes \mathbf{E}^{*}\right)_{\mid N}=\mu^{*}\left(\mathbf{K} \otimes \mathbf{E}_{\mid N}^{*}\right)
$$

At the graded geometric level, such subbundle $\mathbf{K} \rightarrow N$ codifies the subsheaf of regular ideals in $C_{\mathcal{M}}$ defining the submanifold; see [9, § 2.3] for a discussion for the case $n=2$.

### 3.3. Examples.

Example 3.11. As we saw in Example 2.11, 1-Cob is isomorphic to $\mathcal{V}$ ect, the category of vector bundles. Theorem 3.8 boils down to the well-known fact that

$$
\mathcal{F}: \mathcal{V e c t} \rightarrow 1-\mathcal{M a n}, \quad \mathcal{F}(E \rightarrow M)=\left(M, \Gamma_{\wedge} \bullet E^{*}\right)=E[1]
$$

is an equivalence of categories.
$\diamond$
Example 3.12 (1-manifolds as $n$-manifolds). For a vector bundle $E \rightarrow M$ define the admissible $n$-coalgebra bundle $\left(\mathbf{E} \rightarrow M, \mu^{E}\right)$ given by $E_{-i}=\wedge^{i} E$ for $1 \leq i \leq n$ and $\mu^{E}$ the coalgebra structure dual to the algebra structure on $\mathbf{E}^{*}$ defined by the wedge product. Then $\mathcal{F}(\mathbf{E} \rightarrow$ $\left.M, \mu^{E}\right)=E[1]$, where $E[1]$ is viewed as an $n$-manifold.

Example 3.13. We saw in Example 2.12 a characterization of admissible 2-coalgebra bundles as triples $\left(E_{-1} \rightarrow M, E_{-2} \rightarrow M, \mu: E_{-2} \rightarrow E_{-1} \wedge E_{-1}\right)$. The geometrization functor

$$
\mathcal{F}: 2-\mathcal{C} o b \rightarrow 2-\mathcal{M a n}, \quad \mathcal{F}(\mathbf{E} \rightarrow M, \mu)=\left(M, \frac{\Gamma_{\wedge} \bullet E_{1}^{*} \otimes S^{\bullet} E_{2}^{*}}{\left\langle e \wedge e^{\prime} \otimes 1-1 \otimes \mu^{*}\left(e, e^{\prime}\right)\right\rangle}\right)
$$

recovers the vector-bundle description of 2-manifolds used in [9, § 2.2].
The previous examples provided geometric characterizations of $n$-manifolds in low degrees. We now give a class of examples of admissible $n$-coalgebra bundles in arbitrary degrees and describe the corresponding $n$-manifolds via the geometrization functor.

In order to construct $n$-coalgebra bundles, we will take as input exact sequences of the form

$$
\begin{equation*}
0 \rightarrow C \rightarrow \Omega \xrightarrow{\varphi} A \otimes B \rightarrow 0, \tag{18}
\end{equation*}
$$

where $A, B, C$ and $\Omega$ are vector bundles over $M$, and the maps are over the identity map. We will refer to such exact sequences as dbv-sequences, since, as shown in [13, the natural category they form is equivalent to the category of double vector bundles; more concretely, a double vector bundle

with core $C$ gives rise to a dvb-sequence (18) where $\Omega \rightarrow M$ is the dual of the vector bundle whose space of sections are the double linear functions on $D$ (see [18] and [27), and this sequence fully recovers $D$, up to isomorphism (see also [16] for a detailed discussion).

For the double vector bundles given by tangent and cotangent prolongations of a given vector bundle $A \rightarrow M$,

the corresponding dvb-sequences are the dual sequences of
(21) $0 \rightarrow \operatorname{Hom}\left(T M, A^{*}\right) \rightarrow J^{1} A^{*} \rightarrow A^{*} \rightarrow 0 \quad$ and $\quad 0 \rightarrow \operatorname{End}(A) \rightarrow \operatorname{Der}(A) \rightarrow T M \rightarrow 0$,
where $J^{1} A^{*}$ is the first jet prolongation of $A^{*}$ and $\operatorname{Der}(A)$ is the vector bundle whose sections are derivations of $A$ (see § 4.3).

Example 3.14 ( $n$-coalgebra bundles from double vector bundles). For $D$ a double vector bundle (as in (19)) with corresponding dvb-sequence (18), we define, for each $n \geq 2$, an admissible $n$-coalgebra bundle $\left(\mathbf{E}^{D} \rightarrow M, \mu^{D}\right)$ as follows. For $n=2$, we set

$$
E_{-1}^{D}=A \oplus B, \quad E_{-2}^{D}=\wedge^{2} A \oplus \Omega \oplus \wedge^{2} B, \quad \mu_{-2}^{D}(\xi+\omega+\tau)=\mu_{-2}^{A}(\xi)+\varphi(\omega)+\mu_{-2}^{B}(\tau),
$$

where $\xi \in \wedge^{2} A, \omega \in \Omega, \tau \in \wedge^{2} B$ and $\mu^{A}, \mu^{B}$ are as in Example 3.12, For $n>2$, we set

$$
E_{-i}^{D}=\left\{\begin{array}{ll}
\wedge^{i} A, & i=1, \ldots, n-2, \\
\wedge^{n-1} A \oplus B, & i=n-1, \\
\wedge^{n} A \oplus \Omega, & i=n,
\end{array} \quad \text { and } \quad \mu_{-i}^{D}= \begin{cases}\mu_{-i}^{A}, & i=1, \ldots, n-1 \\
\mu_{-n}^{A}+\varphi, & i=n .\end{cases}\right.
$$

Note that one can directly check that $\left(\mathbf{E}^{D} \rightarrow M, \mu^{D}\right)$ is admissible by realizing that an splitting of the exact sequence (18) gives an isomorphism with the split coalgebra bundle ( $\mathbf{E}_{\mathbf{D}} \rightarrow M, \mu^{s}$ ), where $\mathbf{D} \rightarrow M$ is given by $D_{-1}=A, D_{1-n}=B$ and $D_{-n}=C$.

For a geometric description of the $n$-manifolds

$$
\mathcal{M}^{D}:=\mathcal{F}\left(\mathbf{E}^{D} \rightarrow M, \mu^{D}\right),
$$

we consider the 1-manifolds $A[1]$ and $D[1]$ corresponding to the vector bundles $A \rightarrow M$ and $D \rightarrow B$. The additional vector bundle structure of $D$ over $A$ makes $D[1] \rightarrow A[1]$ into a vector bundle in the category of 1 -manifolds. Denoting by $\mathcal{R} \rightarrow A[1]$ the trivial vector bundle with just one fiber coordinate of degree $n-1$, i.e. $\mathcal{R}=\mathbb{R}^{0|\cdots| 0 \mid d_{n-1}} \times A[1]$ with $d_{n-1}=1$, the $n$-manifold $\mathcal{M}^{D}$ can be regarded as the total space of the graded vector bundle $D[1] \otimes \mathcal{R} \rightarrow A[1]$.

When $D$ is the tangent or cotangent prolongation of $A \rightarrow M$ (see (20) and (21)), one can check that

$$
\mathcal{M}^{T A}=T[n-1] A[1] \quad \text { and } \quad \mathcal{M}^{T^{*} A}=T^{*}[n] A[1],
$$

as defined in Example 2.5,
One can also use coalgebra bundles to give more explicit descriptions of morphisms between $\mathbb{N}$-manifolds, see e.g. Remark 4.11,

## 4. Vector fields and tangent vectors

In this section we review the notion of vector fields on $\mathbb{N}$-manifolds and characterize them in terms of admissible coalgebra bundles.
4.1. Vector fields. Let $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ be an $n$-manifold of dimension $m_{0}|\cdots| m_{n}$. For an open subset $U \subseteq M$, a vector field of degree $k$ on $\left.\mathcal{M}\right|_{U}$ is a degree $k$ derivation $X$ of the graded algebra $C_{\mathcal{M}}(U)$, i.e., an $\mathbb{R}$-linear map $X: C_{\mathcal{M}}(U) \rightarrow C_{\mathcal{M}}(U)$ with the property that, for all $f, g \in C_{\mathcal{M}}(U)$ with $f$ homogeneous, $|X(f)|=|f|+k$ and

$$
\begin{equation*}
X(f g)=X(f) g+(-1)^{|f| k} f X(g) \tag{22}
\end{equation*}
$$

Vector fields give rise to a sheaf of $C_{\mathcal{M}}$-modules over $M$. The sheaf of degree $k$ vector fields is denoted by $\mathcal{T}_{\mathcal{M}}^{k}$, and the sheaf of all vector fields by $\mathcal{T}_{\mathcal{M}}^{\dot{ }}=\bigoplus_{k \in \mathbb{Z}} \mathcal{T}_{\mathcal{M}}^{k}$. The graded commutator of vector fields, defined for homogeneous vector fields $X, Y$ by

$$
[X, Y]=X Y-(-1)^{|X||Y|} Y X
$$

makes $\mathcal{T}_{\mathcal{M}}^{\circ}$ into a sheaf of graded Lie algebras.
Let $U \subseteq M$ be a chart of $\mathcal{M}$ with coordinates $\left\{x^{\alpha}, e_{i}^{\beta_{i}}\right\}$. Define the vector fields $\frac{\partial}{\partial x^{\alpha}}, \frac{\partial}{\partial e_{i}^{\beta_{i}}}$ as the derivations acting on coordinates by

$$
\frac{\partial}{\partial x^{\alpha}}\left(x^{\alpha^{\prime}}\right)=\delta_{\alpha \alpha^{\prime}}, \quad \frac{\partial}{\partial x^{\alpha}}\left(e_{i}^{\beta_{i}}\right)=0, \quad \frac{\partial}{\partial e_{i}^{\beta_{i}}}\left(x^{\alpha}\right)=0, \quad \frac{\partial}{\partial e_{i}^{\beta_{i}}}\left(e_{j}^{\beta_{j}^{\prime}}\right)=\delta_{i j} \delta_{\beta_{i} \beta_{j}^{\prime}} .
$$

This definition implies that $\left|\frac{\partial}{\partial x^{\alpha}}\right|=0$ and $\left|\frac{\partial}{\partial e_{i}^{\beta_{i}}}\right|=-\left|e_{i}^{\beta_{i}}\right|=-i$.
Proposition 4.1. Let $U$ be a chart of $\mathcal{M}$ with coordinates $\left\{x^{\alpha}, e_{i}^{\beta_{i}}\right\}$. Then $\mathcal{T}_{\mathcal{M}}(U)$ is freely generated by $\left\{\frac{\partial}{\partial x^{\alpha}}, \frac{\partial}{\partial e_{i}^{\beta_{i}}}\right\}$ as a $C_{\mathcal{M}}(U)$-module.

Proof. Let $X$ be a vector field on $\mathcal{M}_{\mid U}$, and consider the vector field

$$
X^{\prime}=X-\sum_{\alpha=0}^{m_{0}} X\left(x^{\alpha}\right) \frac{\partial}{\partial x^{\alpha}}-\sum_{i=1}^{n} \sum_{\beta_{i}=1}^{m_{i}} X\left(e_{i}^{\beta_{i}}\right) \frac{\partial}{\partial e_{i}^{\beta_{i}}} .
$$

It is clear that $X^{\prime}$ acts by zero on the coordinates, hence on arbitrary functions, and therefore $X$ can be written as a $C_{\mathcal{M}}(U)$-linear combination of $\left\{\frac{\partial}{\partial x^{\alpha}}, \frac{\partial}{\partial e_{i}^{\beta_{i}}}\right\}$.

Remark 4.2. By considering vector bundles in the realm of graded manifolds, one can equivalently view vector fields on $\mathcal{M}$ as sections of tangent bundles [25].

Example 4.3 ( $Q$-manifolds). A degree 1 vector field $Q$ on an $n$-manifold $\mathcal{M}$ such that $[Q, Q]=$ $2 Q^{2}=0$ is called a homological vector field (aka a $Q$-structure), since in this case $\left(C_{\mathcal{M}}, Q\right)$ is a differential complex. The pair $(\mathcal{M}, Q)$ is called a $Q$-manifold. A 1-manifold with a homological vector field is the same as a Lie algebroid [37]; in general, $Q$-manifolds codify $L_{n}$-algebroids, see [7.
4.2. Tangent vectors at a point. Let $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ be an $n$-manifold of dimension $m_{0}|\cdots| m_{n}$. Given $x \in M$, we denote by $\left.C_{\mathcal{M}}\right|_{x}$ the stalk of $C_{\mathcal{M}}$ at $x$, and given $f \in C_{\mathcal{M}}(U)$ with $x \in U$, we denote by $\mathbf{f}$ its class in $\left.C_{\mathcal{M}}\right|_{x}$. A homogeneous tangent vector of degree $k$ at a point $x \in M$ is a linear map $v:\left.C_{\mathcal{M}}\right|_{x} \rightarrow \mathbb{R}$ satisfying

$$
v(\mathbf{f g})=v(\mathbf{f}) g^{0}(x)+(-1)^{k|f|} f^{0}(x) v(\mathbf{g})
$$

where $f^{0}$ and $g^{0}$ denote the degree zero components of $f$ and $g$, respectively. We denote by $T_{x} \mathcal{M}$ the space of tangent vectors at a point $x \in M$, noticing that it is a graded vector space over $\mathbb{R}$ with $\operatorname{dim}\left(T_{x} \mathcal{M}\right)_{-i}=m_{i}$ for $i=0, \ldots, n$, and zero otherwise.

For each open subset $U \subseteq M$, any vector field $X \in \mathcal{T}_{\mathcal{M}}^{\bullet}(U)$ defines a tangent vector $X_{x}$ at each point $x \in U$ by

$$
\begin{equation*}
X_{x}(\mathbf{f})=X(f)^{0}(x) \tag{23}
\end{equation*}
$$

Definition 4.4. We say that two vector fields $X, Y \in \mathcal{T}_{\mathcal{M}}^{\bullet}(U)$ are linearly independent if $X_{x}$ and $Y_{x}$ are linearly independent for all $x \in U$.

For $\mathbb{N}$-manifolds, it is clear that only vector fields of non-positive degrees can generate nonzero tangent vectors. Therefore in this setting, unlike the case of smooth manifolds, vector fields are not determined by their corresponding tangent vectors.

Example 4.5 (Two different vector fields with the same tangent vectors at all points). Consider the 1-manifold $\mathbb{R}^{1 \mid 1}:=\{x, e\}$, where $|x|=0$ and $|e|=1$. Then the vector fields

$$
X=\frac{\partial}{\partial x} \quad \text { and } \quad Y=\frac{\partial}{\partial x}+e \frac{\partial}{\partial e}
$$

have the same tangent vectors at all points.
Proposition 4.6. Let $U \subseteq M$ be an open subset, and consider vector fields $X_{k}^{i_{k}} \in \mathcal{T}_{\mathcal{M}}^{-k}(U)$, for $k=0, \ldots, n, i_{k}=1, \ldots, d_{k}$. If they are linearly independent (in the sense of Definition 4.4), then the set $\left\{X_{k}^{i_{k}}\right\}$ is linearly independent over $C_{\mathcal{M}}(U)$.

The proof is a direct extension of the argument in [9, Prop. 2.17] for $n=2$.
4.3. Geometrization of vector fields. We will now describe vector fields in non-positive degrees on $\mathbb{N}$-manifolds in terms of coalgebra bundles.

Let $\mathbf{E}=\oplus_{i=k}^{l} E_{i} \rightarrow M$ be a graded vector bundle, for $k, l \in \mathbb{Z}$. For an open subset $U \subseteq M$, a derivation of $\left.\mathbf{E}\right|_{U}$ is a pair $(D, X)$ where $X$ is a vector field on $U$, called the symbol of the derivation, and $D: \Gamma_{\mathbf{E}}(U) \rightarrow \Gamma_{\mathbf{E}}(U)$ satisfies

$$
D(f e)=X(f) e+f D(e), \quad \forall f \in C^{\infty}(U), e \in \Gamma_{\mathbf{E}}(U)
$$

Note that if $(D, X)$ is homogeneous of nonzero degree, then $X=0$. The corresponding sheaf of derivations of $\mathbf{E} \rightarrow M$ is a sheaf of (graded) $C_{M}^{\infty}$-modules and also a sheaf of graded Lie algebras with respect to the graded commutator bracket

$$
\left[D, D^{\prime}\right]=D \circ D^{\prime}-(-1)^{\left|D \| D^{\prime}\right|} D^{\prime} \circ D
$$

Since, as a sheaf of $C_{M}^{\infty}$-modules, the sheaf of derivations is locally finitely generated and free, it can be realized as the sheaf of sections of a (graded) vector bundle

$$
\operatorname{Der}(\mathbf{E}) \rightarrow M
$$

fitting into the following short exact sequence,

$$
\begin{equation*}
0 \rightarrow \operatorname{End}(\mathbf{E}) \rightarrow \operatorname{Der}(\mathbf{E}) \xrightarrow{\sigma} T M \rightarrow 0, \tag{24}
\end{equation*}
$$

where $\sigma$ is the symbol map. Note that $\operatorname{Der}(\mathbf{E})=\oplus_{j} \operatorname{Der}(\mathbf{E})_{j}$, where

$$
\operatorname{Der}(\mathbf{E})_{j}= \begin{cases}\operatorname{Der}\left(E_{k}\right) \times_{T M} \cdots \times_{T M} \operatorname{Der}\left(E_{l}\right) & \text { for } j=0,  \tag{25}\\ \bigoplus_{b=a+j} \operatorname{Hom}\left(E_{a}, E_{b}\right) & \text { for } j \neq 0\end{cases}
$$

Remark 4.7. The bundle $\operatorname{Der}(\mathbf{E})$, also called the Atiyah algebroid of $\mathbf{E} \rightarrow M$, was previously considered in [26], where representations up to homotopy of a Lie algebroid ( $A \rightarrow M,[\cdot, \cdot], \rho$ ) on a graded vector bundle $\mathbf{E} \rightarrow M$ are understood as $L_{\infty}$-morphisms from $A$ to $\operatorname{Der}(\mathbf{E})$. $\diamond$

We will use such derivations to describe vector fields of non-positive degrees on $\mathbb{N}$-manifolds. Given an $n$-coalgebra bundle $(\mathbf{E} \rightarrow M, \mu$ ), we define the associated extended $n$-algebra bundle as the pair $\left(\mathbf{E}_{\mathbb{R}}^{*} \rightarrow M, m\right)$, where $\mathbf{E}_{\mathbb{R}}^{*}=\oplus_{i=0}^{n}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{i}$ is the graded vector bundle with

$$
\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{i}= \begin{cases}\mathbb{R}_{M}, & i=0,  \tag{26}\\ E_{-i}^{*}, & 1 \leq i \leq n,\end{cases}
$$

and the multiplication $m: \mathbf{E}_{\mathbb{R}}^{*} \otimes \mathbf{E}_{\mathbb{R}}^{*} \rightarrow \mathbf{E}_{\mathbb{R}}^{*}$ is defined by $\mu^{*}$ and scalar multiplication $\mathbb{R}_{M} \times E_{j}^{*} \rightarrow$ $E_{j}^{*}$; here $\mathbb{R}_{M}=\mathbb{R} \times M \rightarrow M$. For an open subset $U \subseteq M$, a degree $k$ derivation $(D, X)$ of $\left.\mathbf{E}_{\mathbb{R}}^{*}\right|_{U}$ is said to be compatible with $m$ if

$$
\begin{equation*}
D\left(m\left(e, e^{\prime}\right)\right)=m\left(D(e), e^{\prime}\right)+(-1)^{k|e|} m\left(e, D\left(e^{\prime}\right)\right) . \tag{27}
\end{equation*}
$$

One can directly verify that the sheaf of compatible derivations of $\left(\mathbf{E}_{\mathbb{R}}^{*} \rightarrow M, m\right)$ is a subsheaf of graded Lie algebras of the sheaf of derivations of $\mathbf{E}_{\mathbb{R}}^{*}$.
Lemma 4.8. Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $n$-coalgebra bundle and $\mathcal{M}=\mathcal{F}(\mathbf{E} \rightarrow M, \mu)$ be the corresponding n-manifold. For each non-positive integer $k$, there is a natural inclusion

$$
\Upsilon^{k}: \mathcal{T}_{\mathcal{M}}^{k} \hookrightarrow \Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{k}},
$$

given, for each open subset $U \subseteq M$, by

$$
\Upsilon^{k}(X)(e)=X(e), \quad \Upsilon^{k}(X)(f)=X(f)
$$

where $X \in \mathcal{T}_{\mathcal{M}}^{k}(U), e \in \Gamma_{\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{i}}(U)=\Gamma_{E_{-i}^{*}}(U)=C_{\mathcal{M}}^{i}(U)$, for $i=1, \ldots, n$, and $f \in \Gamma_{\mathbb{R}_{M}}(U)=$ $C^{\infty}(U)$, with the following properties:
(a) $\Upsilon^{k}\left(\mathcal{T}_{\mathcal{M}}^{k}(U)\right)=\left\{D \in \Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{k}}(U)\right.$ compatible with $\left.m\right\}$,
(b) $\Upsilon^{k+l}([X, Y])=\left[\Upsilon^{k}(X), \Upsilon^{l}(Y)\right]$.

Proof. The $n$-manifold $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ is such that $C_{\mathcal{M}}^{i}=\Gamma_{\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{i}}$ for $i=0, \ldots, n$, and the multiplication of functions in $C_{\mathcal{M}}^{i}$ and $C_{\mathcal{M}}^{j}$, with $i+j \leq n$, agrees with $m$. Since $C_{\mathcal{M}}$ is generated as a sheaf of algebras by the homogeneous functions of degree $\leq n$, for any open subset $U \subseteq M$, a vector field $X \in \mathcal{T}_{\mathcal{M}}^{k}(U)$ is completely determined by the maps

$$
X^{i}: C_{\mathcal{M}}^{i}(U) \rightarrow C_{\mathcal{M}}^{i+k}(U) \quad \text { for } i=0, \ldots, n
$$

Thus, for $k \leq 0$, we see that $X$ gives rise, and is completely determined by, a map $D: \Gamma_{\mathbf{E}_{\mathbb{R}}^{*}}(U) \rightarrow$ $\Gamma_{\mathbf{E}_{\mathbf{R}}^{*}}(U)$, which is a degree $k$ derivation. Hence $\Upsilon^{k}$ is well defined and injective. The bracket preserving property (b) follows directly from the definitions.

It remains to verify (a). Since $m$ agrees with the multiplication of functions on $C_{\mathcal{M}}$, it is clear that any derivation in the image of $\Upsilon^{k}$ satisfies (27), so we obtain one inclusion in (b). For the other inclusion observe that any degree $k$ derivation $D$ of $\mathbf{E}_{\mathbb{R}}^{*}$ can be extended to $\widehat{D}: \Gamma_{\mathbf{S}} \bullet \mathbf{E}^{*} \rightarrow \Gamma_{\mathbf{S}} \bullet \mathbf{E}^{*}$ as a degree $k$ derivation. If $D$ satisfies (27) then $\widehat{D}\left(\mathcal{I}_{\mu}\right) \subseteq \mathcal{I}_{\mu}$, so it descends to a derivation $X$ of $C_{\mathcal{M}}^{\bullet}=\Gamma_{S^{\bullet}} \mathbf{E}^{*} / \mathcal{I}_{\mu}$, in such a way that $\Upsilon^{k}(X)=D$.

Since $\mathcal{T}_{\mathcal{M}}^{k}$ is locally finitely generated and free as a sheaf of $C_{M}^{\infty}$-modules, a consequence of Theorem 4.8 is that the sheaf of compatible derivations of $\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)$ of degree $k$ is the sheaf of sections of a subbundle

$$
\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k} \subseteq \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)
$$

for $k=-n, \ldots, 0$. This subbundle has a simple description when $k=-n$. From (25), note that $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{-n}=\operatorname{Hom}\left(E_{-n}^{*}, \mathbb{R}\right)=E_{-n}$, while from (27) we see that $\xi \in E_{-n}$ is a compatible derivation if and only if $\left.\xi\right|_{\left(K_{-n}^{\mu}\right)^{*}}=0$ (see (17)), which implies that

$$
\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-n}=\operatorname{ker} \mu_{-n} \subseteq E_{-n} .
$$

Theorem 4.9. For each $k=-n, \ldots, 0$,

$$
\mathcal{T}_{\mathcal{M}}^{k}=\Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k}} .
$$

In particular, $\mathcal{T}_{\mathcal{M}}^{-n}=\Gamma_{\text {ker } \mu_{-n}}$.
By means of the identification in Theorem 4.9, the natural $C_{\mathcal{M}}$-module structure of $\mathcal{T}_{\mathcal{M}}$ translates into vector bundle maps

$$
\begin{equation*}
\Theta_{i, k}: E_{-i}^{*} \otimes \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k} \rightarrow \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k+i} \tag{28}
\end{equation*}
$$

given on sections by $\Theta_{i, k}(e \otimes D)=m(e, D(\cdot))$, for $i=1, \ldots, n, k=-n, \ldots, 0$, and $k+i \leq 0$.
Example 4.10 (Vector fields on 1-manifolds). Let $\mathcal{M}=E[1]$ be a 1-manifold. As recalled in Example 2.11, the associated coalgebra bundle is $\mathbf{E}=E_{-1}=E$, with zero comultiplication. By (25) and Theorem 4.9,

$$
\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}=\operatorname{Der}\left(E^{*}\right) \cong \operatorname{Der}(E), \quad \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right)_{-1}=E,
$$

where the isomorphism on the left-hand side is via dualization of derivations. Therefore

$$
\mathcal{T}_{E[1]}^{0}=\Gamma_{\operatorname{Der}\left(E^{*}\right)} \cong \Gamma_{\operatorname{Der}(E)} \quad \text { and } \quad \mathcal{T}_{E[1]}^{-1}=\Gamma_{E},
$$

see [40]. The only nontrivial map in the collection (28) occurs when $i=1$ and $k=-1$, and it is the natural inclusion

$$
E^{*} \otimes E=\operatorname{End}(E) \hookrightarrow \operatorname{Der}(E),
$$

see (24).
We will discuss vector fields on 2-manifolds in Example 4.15 below.
Remark 4.11 (Positive-degree vector fields on 1-manifolds). One can also describe positivedegree vector fields on $E[1]$. For $k>0$, since a degree $k$ vector field $Q$ is a degree $k$ derivation of $\Gamma_{\wedge} \bullet E^{*}$, it is completely described by maps

$$
\delta_{0}: C_{M}^{\infty} \rightarrow \Gamma_{\wedge^{k} E^{*}} \quad \text { and } \quad \delta_{1}: \Gamma_{E^{*}} \rightarrow \Gamma_{\wedge^{k+1} E^{*}}
$$

satisfying $\delta_{0}(f g)=\delta_{0}(f) g+f \delta_{0}(g)$ and $\delta_{1}(f e)=\delta_{0}(f) \wedge e+f \delta_{1}(f)$. Such pairs $\left(\delta_{0}, \delta_{1}\right)$ are called almost $(k+1)$-differentials in [20], where they are shown to be equivalent to linear $(k+1)$-vector
fields on $E^{*}$. For $k=1$ and $Q^{2}=0$, this recovers the correspondence between $Q$-structures on $E[1]$, Lie-algebroid structures on $E$ (see Example 4.3) and linear Poisson structures on $E^{*}$.

From another viewpoint, following Remark 4.2, a degree $k$ vector field $Q$, with $k>0$, may be seen as a section $Q: E[1] \rightarrow T[k] E[1]$ of the shifted tangent bundle of $E[1]$ (here $Q$ is regarded a morphism of $(k+1)$-manifolds). Using the geometrization functor in Examples 3.12 and 3.14, one can view $Q$ as a morphism $Q:\left(\mathbf{E}, \mu^{E}\right) \rightarrow\left(\mathbf{E}^{T E}, \mu^{T E}\right)$ of $(k+1)$-coalgebra bundles satisfying $\operatorname{Id}_{\mathbf{E}}=\pi \circ Q$, where $\pi:\left(\mathbf{E}^{T E}, \mu^{T E}\right) \rightarrow\left(\mathbf{E}, \mu^{E}\right)$ is the natural projection. We conclude that, for $k \geq 1$, there is a natural identification

$$
\text { degree } k \text { vector field } Q \rightleftharpoons\left\{\begin{array}{l}
\text { Pairs of vector bundle maps } \\
\rho: \wedge^{k} E \rightarrow T M, \text { and } \Theta: \wedge^{k+1} E \rightarrow\left(J^{1} E^{*}\right)^{*} \\
\text { such that } \varphi \circ \Theta=\rho \wedge \operatorname{Id}
\end{array}\right.
$$

By means of the canonical splitting $\Gamma_{J^{1} E^{*}}=\Gamma_{E^{*}} \oplus\left(\Omega_{M}^{1} \otimes \Gamma_{E^{*}}\right)$, the previous description of vector fields in positive degrees can be alternatively expressed in terms of multi-brackets,

$$
\text { degree } k \text { vector field } Q \rightleftharpoons\left\{\begin{array}{l}
\text { A vector bundle map } \rho: \wedge^{k} E \rightarrow T M, \\
\text { and a bracket }[\cdot, \cdots, \cdot]: \Gamma_{\wedge^{k+1} E} \rightarrow \Gamma_{E} \text { such that } \\
{\left[e_{1}, \cdots, f e_{k+1}\right]=f\left[e_{1}, \cdots, e_{k+1}\right]+\rho\left(e_{1} \wedge \cdots \wedge e_{k}\right)(f) e_{k+1} .}
\end{array}\right.
$$

The fact that the objects on the right-hand side are equivalent to almost differentials on $E^{*} \rightarrow$ $M$ is verified in [20, Sec. 3.2].
4.4. An inductive description. Recall (see (4)) that an $n$-manifold $\mathcal{M}$ gives rise to a tower of $\mathbb{N}$-manifolds

$$
M=\mathcal{M}_{0} \leftarrow \mathcal{M}_{1} \cdots \leftarrow \mathcal{M}_{n-1} \leftarrow \mathcal{M}_{n}=\mathcal{M}
$$

where $\mathcal{M}_{r}$ is an $r$-manifold defined by the subsheaf of algebras of $C_{\mathcal{M}}$ locally generated by functions of degree $\leq r$. We will use this tower to obtain a more explicit description of vector fields in non-positive degrees on $\mathcal{M}$ following Theorem 4.8,

For $k \leq 0$, any section of $\mathcal{T}_{\mathcal{M}}^{k}$ preserves the subsheaf $C_{\mathcal{M}_{r}} \subseteq C_{\mathcal{M}}$, and hence restricts to a section of $\mathcal{T}_{\mathcal{M}_{r}}^{k}$, so we have restriction maps

$$
\operatorname{res}_{r}: \mathcal{T}_{\mathcal{M}}^{k} \rightarrow \mathcal{T}_{\mathcal{M}_{r}}^{k}, \quad r=0, \cdots, n
$$

Remark 4.12. Let $\mathcal{M}$ correspond to the admissible $n$-coalgebra bundle $(\mathbf{E}, \mu)$. When $k=0$, $r=0$, the restriction map $\mathcal{T}_{\mathcal{M}}^{0} \rightarrow \mathcal{T}_{M}^{0}=\mathfrak{X}_{M}^{1}$ corresponds to the symbol map

$$
\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0} \subseteq \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}\right) \xrightarrow{\sigma} T M .
$$

Let $X$ be a vector field on $\mathcal{M}$ of degree $k \leq 0$. Since a vector field on $\mathcal{M}$ is completely specified by how it acts on $C_{\mathcal{M}}^{i}$, for $i=1, \ldots, n$, and

$$
C_{\mathcal{M}}^{i}=C_{\mathcal{M}_{n-1}}^{i}, \quad \text { for } i=1, \ldots, n-1,
$$

it follows that $X$ is completely determined by the degree $k$ vector field $\operatorname{res}_{n-1}(X)$ on $\mathcal{M}_{n-1}$ together with the map $\mathrm{p}_{n}(X):=X_{\mid C_{\mathcal{M}}^{n}}: C_{\mathcal{M}}^{n} \rightarrow C_{\mathcal{M}}^{n+k}$. Note that $\operatorname{res}_{n-1}(X)$ and $\mathrm{p}_{n}(X)$ are related by the fact that they coincide on $C_{\mathcal{M}_{n-1}}^{n} \subseteq C_{\mathcal{M}}^{n}$. In fact, we have

Lemma 4.13. A vector field on an $n$-manifold $\mathcal{M}$ of degree $k \leq 0$ is equivalent to a pair $(Y, Z)$, where $Y$ is a degree $k$ vector field on $\mathcal{M}_{n-1}, Z: C_{\mathcal{M}}^{n} \rightarrow C_{\mathcal{M}}^{n+k}$ satisfies $Z(f e)=Z(f) e+f Z(e)$ for $f$ and $e$ sections of $C_{M}^{\infty}$ and $C_{\mathcal{M}}^{n}$, respectively, and such that

$$
Z_{\left.\right|_{\mathcal{M}_{n-1}^{n}} ^{n}}=Y_{\left.\right|_{C_{\mathcal{M}_{n-1}}^{n}}} .
$$

Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $(n+1)$-coalgebra bundle, let $\mathcal{M}=\mathcal{F}(\mathbf{E}, \mu)$ be the corresponding $(n+1)$-manifold, take $k \leq 0$, and recall that

$$
\mathcal{T}_{\mathcal{M}}^{k}=\Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k}},
$$

and that

$$
\mathcal{T}_{\mathcal{M}_{n}}^{k}=\Gamma_{\operatorname{Der}\left((\mathbf{E} \leq n)_{\mathbb{R}}^{*}, m \leq n\right)_{k}} \quad \text { and } \quad C_{\mathcal{M}_{n}}^{n+1}=\Gamma_{\left(K_{-(n+1)}^{\mu}\right)^{*}},
$$

see Remarks 3.4(b) and 3.5. The next result is a reformulation of the previous lemma in terms of coalgebra bundles using the identifications above.

Proposition 4.14. The vector bundle $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}$ is given by the following pullback diagram:


Analogously, for $k<0$, the vector bundles $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k}$ are given by the pullback diagrams


Following the notation above, the maps $\operatorname{res}_{n}$ and $\mathrm{p}_{n+1}$ are given by the natural restrictions. Recalling the exact sequence

$$
0 \rightarrow \operatorname{ker} \mu_{-(n+1)} \rightarrow E_{-(n+1)} \xrightarrow{\mu_{-(n+1)}} \operatorname{im} \mu_{-(n+1)}=K_{-(n+1)}^{\mu} \rightarrow 0
$$

the right vertical maps in the diagrams are given by restrictions with respect to the inclusions $\mu_{-(n+1)}^{*}:\left(K_{-(n+1)}^{\mu}\right)^{*} \hookrightarrow E_{-(n+1)}^{*}$. The bottom maps are defined by means of (27).

As an illustration of the previous proposition, we give a description of non-positive degree vector fields on 2-manifolds using the description of vector fields on 1-manifolds given in Example 4.10

Example 4.15 (Vector fields on 2-manifolds). Let ( $\mathbf{E}=E_{-2} \oplus E_{-1}, \mu: E_{-2} \rightarrow E_{-1} \otimes E_{-1}$ ) be an admissible 2-coalgebra bundle and denote by $\mathcal{M}$ the associated degree 2-manifold. Then putting together Examples 2.12 and 4.10 we get that $K_{-2}^{\mu}=E_{-1} \wedge E_{-1}, \mathcal{M}_{1}=E_{-1}[1]$ and

$$
\mathcal{T}_{\mathcal{M}_{1}}^{-2}=0, \quad \mathcal{T}_{\mathcal{M}_{1}}^{-1}=\Gamma_{E_{-1}} \quad \text { and } \quad \mathcal{T}_{\mathcal{M}_{1}}^{0}=\Gamma_{\operatorname{Der}\left(E_{-1}^{*}\right)}
$$

Thus, for $k=0,-1,-2$, the vector bundles $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{k}$ are defined by the following pullback diagrams:

with the bottom maps given by

$$
\xi\left(e \wedge e^{\prime}\right)=\xi(e) e^{\prime}-\xi\left(e^{\prime}\right) e \quad \text { and } \quad D\left(e \wedge e^{\prime}\right)=D(e) \wedge e^{\prime}+e \wedge D\left(e^{\prime}\right)
$$

for $\xi \in \Gamma\left(E_{-1}\right), D \in \Gamma\left(\operatorname{Der}\left(E_{-1}^{*}\right)\right)$ and $e, e^{\prime} \in \Gamma\left(E_{-1}^{*}\right)$. In other words,

$$
\begin{aligned}
& \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-2}=\operatorname{ker}(\mu) \\
& \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-1}=\left\{(\xi, \varphi) \in E_{-1} \times \operatorname{Hom}\left(E_{-2}^{*}, E_{-1}^{*}\right) \mid \varphi\left(e \wedge e^{\prime}\right)=\xi(e) e^{\prime}-\xi\left(e^{\prime}\right) e\right\},
\end{aligned}
$$

and $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}$ is such that
$\Gamma\left(\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}\right)=\left\{\left(D^{1}, D^{2}\right) \in \Gamma\left(\operatorname{Der}\left(E_{-1}^{*}\right) \times_{T M} \operatorname{Der}\left(E_{-2}^{*}\right)\right) \mid D^{2}\left(e \wedge e^{\prime}\right)=D^{1}(e) \wedge e^{\prime}+e \wedge D^{1}\left(e^{\prime}\right)\right\}$.
This recovers the geometric description of vector fields in degrees $0,-1$ and -2 in [16. .

## 5. Distributions

Let $\mathcal{M}=\left(M, C_{\mathcal{M}}\right)$ be an $n$-manifold of dimension $m_{0}|\cdots| m_{n}$.
Definition 5.1. A distribution on $\mathcal{M}$ of rank $d_{0}|\cdots| d_{n}$ is a graded ${ }^{3}$ subsheaf

$$
\mathcal{D} \subseteq \mathcal{T}_{\mathcal{M}}^{\bullet}
$$

of $C_{\mathcal{M}}$-modules such that any point in $M$ admits an open neighborhood $U$ with the property that $\mathcal{D}(U)$ is generated by vector fields $\left\{X_{k}^{i_{k}}\right\}$, where $k=0, \ldots, n$ and $i_{k}=1, \ldots, d_{k}$, such that $\left|X_{k}^{i_{k}}\right|=-k$ and which are linearly independent (at each point in $U$ ).

We say that a distribution $\mathcal{D}$ is involutive if it is closed under the Lie bracket on $\mathcal{T}_{\mathcal{M}}^{\bullet}$.
For $n=0$ such distributions are just the usual (regular) distributions on manifolds.
Remark 5.2. Distributions on supermanifolds have been considered e.g. in [10, 14, 17] as subsheaves of the tangent sheaf which are locally direct factors. Our formulation of the local triviality property is closer to the one in [5].

[^3]Example 5.3 (The tangent vectors of a distribution do not determine its involutivity). In $\mathbb{R}^{0|1| 1}$, described by coordinates $\{e, p\}$ with $|e|=1$ and $|p|=2$, consider the distributions

$$
\mathcal{D}=\left\langle\frac{\partial}{\partial e}\right\rangle \quad \text { and } \quad \mathcal{D}^{\prime}=\left\langle\frac{\partial}{\partial e}+e \frac{\partial}{\partial p}\right\rangle .
$$

These two distributions have the same tangent vectors at all points, but $\mathcal{D}$ is involutive while $\mathcal{D}^{\prime}$ is not.

Lemma 5.4. For each $l=0, \ldots, n$, the sheaf of $C_{M}^{\infty}$-modules $\mathcal{D} \cap \mathcal{T}_{\mathcal{M}}^{-l}$ is locally free and finitely generated.
Proof. For a small open subset $U \subseteq M$, let $\left\{X_{k}^{i_{k}}\right\}$ be linearly independent vector fields generating $\mathcal{D}(U)$ (as in the definition), and, for each $r=1, \ldots, n$, let $\left\{w_{r}^{q_{r}}\right\}$ be a basis of $C_{\mathcal{M}}^{r}(U)$ as a $C^{\infty}(U)$-module. Then, as a $C^{\infty}(U)$-module,

$$
\begin{equation*}
\mathcal{D} \cap \mathcal{T}_{\mathcal{M}}^{-l}(U)=\operatorname{span}_{C^{\infty}(U)}\left\{X_{l}^{i_{l}}, w_{r}^{q_{r}} X_{l+r}^{i_{l+r}} \mid r=1, \ldots, n-l\right\} . \tag{31}
\end{equation*}
$$

The fact that the generating set above is linearly independent over $C^{\infty}(U)$ is a direct consequence of the linear independence of the vector fields $\left\{X_{k}^{i_{k}}\right\}$ over $C_{\mathcal{M}}(U)$, which follows from Prop. 4.6.

Suppose now that $\mathcal{M}=\mathcal{F}(\mathbf{E}, \mu)$ for an admissible $n$-coalgebra bundle $(\mathbf{E} \rightarrow M, \mu)$. Recall that, by Theorem 4.9.

$$
\mathcal{T}_{\mathcal{M}}^{-k}=\Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-k}} \quad \text { for } \quad k=0, \ldots, n
$$

By the previous lemma, there are vector subbundles $\left(C_{k} \rightarrow M\right) \subseteq\left(\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right) \rightarrow M\right)$ such that

$$
\begin{equation*}
\Gamma_{C_{k}}=\mathcal{D} \cap \mathcal{T}_{\mathcal{M}}^{-k}, \quad k=0, \ldots, n \tag{32}
\end{equation*}
$$

Recall the maps $\Theta_{i, j}$ in (28) and res $_{r}$ (see Prop. 4.14).
Theorem 5.5. Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $n$-coalgebra bundle. A distribution in $\mathcal{M}=$ $\mathcal{F}(\mathbf{E}, \mu)$ is equivalent to a collection of vector subbundles $\left(C_{k} \rightarrow M\right) \subseteq \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-k}$, for $k=0, \cdots, n$, satisfying

$$
\begin{equation*}
\Theta_{1,-(k+1)}\left(E_{-1}^{*} \otimes C_{k+1}\right)+\ldots+\Theta_{n-k,-n}\left(E_{k-n}^{*} \otimes C_{n}\right)=\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k} . \tag{33}
\end{equation*}
$$

Moreover, for such a collection $\left\{C_{k}\right\}$, the intersections $\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k}$ have constant rank, and local generators of the distribution are identified with the union of local frames of $C_{k} /\left(\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap\right.$ $C_{k}$ ), for $k=0, \ldots, n$. (Note that (33) is trivial for $k=n$ since $\mathrm{res}_{n}$ is the identity map.)

Proof. Given a distribution $\mathcal{D}$ in $\mathcal{M}$, condition (33) is a direct consequence of (32) and (31).
On the other hand, consider subbundles $C_{k} \subseteq \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-k}$, for $k=0, \cdots, n$, satisfying (33). Using that $\Gamma_{C_{k}} \subseteq \Gamma_{\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{-k}}=\mathcal{T}_{\mathcal{M}}^{-k}$, we consider the subsheaf of $C_{\mathcal{M}}$-modules of $\mathcal{T}_{\mathcal{M}}$ given by

$$
\mathcal{D}=C_{\mathcal{M}} \cdot \Gamma_{C_{0}}+\ldots+C_{\mathcal{M}} \cdot \Gamma_{C_{n}} .
$$

We must check that it is a distribution, in the sense of Definition 5.1.
Note that, as a sheaf of $C_{M}^{\infty}$-modules, $C_{\mathcal{M}}^{1} \cdot \Gamma_{C_{k+1}}+\ldots+C_{\mathcal{M}}^{n-k} \cdot \Gamma_{C_{n}}$ is locally free. By (33), $\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k}$ is a vector subbundle of $C_{k}$, so that

$$
C_{\mathcal{M}}^{1} \cdot \Gamma_{C_{k+1}}+\ldots+C_{\mathcal{M}}^{n-k} \cdot \Gamma_{C_{n}}=\Gamma_{\operatorname{ker}\left(\mathrm{res}_{k}\right) \cap C_{k}} .
$$

In particular, the fact that $C_{\mathcal{M}}^{1} \cdot \Gamma_{C_{k+1}}+\ldots+C_{\mathcal{M}}^{n-k} \cdot \Gamma_{C_{n}} \subseteq \Gamma_{C_{k}}$ implies that

$$
\mathcal{D} \cap \mathcal{T}_{\mathcal{M}}^{-k}=\Gamma_{C_{k}} .
$$

With the choice of splittings, we may write $C_{k}=\left(\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k}\right) \oplus\left(C_{k} /\left(\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k}\right)\right)$, and consider local frames of $C_{k} /\left(\operatorname{ker}\left(\operatorname{res}_{k}\right) \cap C_{k}\right)$ as given by local vector fields $\left\{X_{k}^{i_{k}}\right\}, i_{k}=1, \ldots, d_{k}$, of degree $-k$. The union of these vector fields for $k=0, \ldots, n$ on any small open subset $U \subseteq M$ generates $\mathcal{D}(U)$, as in Definition 5.1.

Remark 5.6 (Restrictions). For an $n$-manifold $\mathcal{M}$, recall the tower of $\mathbb{N}$-manifolds,

$$
M=\mathcal{M}_{0} \leftarrow \mathcal{M}_{1} \cdots \leftarrow \mathcal{M}_{n-1} \leftarrow \mathcal{M}_{n}=\mathcal{M}
$$

Given a distribution $\mathcal{D}$ on $\mathcal{M}$ of rank $d_{0}|\cdots| d_{n}$, there is a distribution $\mathcal{D}_{r}$ on each $\mathcal{M}_{r}$, of rank $d_{0}|\cdots| d_{r}$, characterized by the condition

$$
\mathcal{D}_{r} \cap \mathcal{T}_{\mathcal{M}_{r}}^{-k}=\operatorname{res}_{r}\left(\mathcal{D} \cap \mathcal{T}_{\mathcal{M}}^{-k}\right),
$$

for $k=0, \ldots, r$. This can be shown directly using local generators, or the viewpoint of Thm. 55.5, Moreover, if $\mathcal{D}$ is involutive so is each $\mathcal{D}_{r}$.

Example 5.7 (Distributions on 1-manifolds). Any 1-manifold is of the form $E[1]$ for a vector bundle $E \rightarrow M$, and, as seen in Example 4.10,

$$
\mathcal{T}_{E[1]}^{0}=\Gamma_{\operatorname{Der}\left(E^{*}\right)} \quad \text { and } \quad \mathcal{T}_{E[1]}^{-1}=\Gamma_{E} .
$$

It follows from Theorem [5.5 that distributions on $E[1]$ are described by vector subbundles $C_{0} \subseteq \operatorname{Der}\left(E^{*}\right)$ and $C_{1} \subseteq E$ satisfying

$$
C_{1} \otimes E^{*}=C_{0} \cap \operatorname{ker}\left(\operatorname{res}_{0}\right)=C_{0} \cap \operatorname{ker} \sigma,
$$

where $\sigma: \operatorname{Der}\left(E^{*}\right) \rightarrow T M$ is the symbol map (see Remark 4.12). Hence, for $n=1$, we recover the geometric characterization of distributions in [40, Lemma 3.1].

A distribution represented by $C_{0}$ and $C_{1}$ is involutive if and only if $C_{0}$ is a Lie subalgebroid of $\operatorname{Der}\left(E^{*}\right) \cong \operatorname{Der}(E)$ and $C_{1} \subseteq E$ is invariant under $C_{0}$. In this case, as shown in [40, Lemma 3.2], $C_{0}$ is equivalent to the data of an involutive distribution $F \subseteq T M$ and a flat $F$-connection $\nabla$ on $E / C_{1}$ : indeed, given $C_{0}$, we set $F=\sigma\left(C_{0}\right)$, and

$$
\nabla_{X}[e]=\left[D^{\dagger}(e)\right] \quad \text { for } X \in \Gamma_{F}, \quad[e] \in \Gamma_{E / C_{1}},
$$

and $D^{\dagger}$ the dual of $D \in \Gamma\left(C_{0}\right)$ with $\sigma(D)=X$; given $F$ and $\nabla$, we define $C_{0}$ such that

$$
\begin{equation*}
\Gamma_{C_{0}}=\left\{D \in \Gamma_{\operatorname{Der}\left(E^{*}\right)} \mid \sigma(D) \in \Gamma_{F}, D^{\dagger}\left(\Gamma_{C_{1}}\right) \subseteq \Gamma_{C_{1}},\left[D^{\dagger}\right]=\nabla_{\sigma(D)}\right\} \tag{34}
\end{equation*}
$$

where $\left[D^{\dagger}\right] \in \Gamma_{\operatorname{Der}\left(E / C_{1}\right)}$ is given by $\left[D^{\dagger}\right][e]=\left[D^{\dagger}(e)\right]$, for $[e]$ denoting the class of $e \in \Gamma_{E}$ in $\Gamma_{E / C_{1}}$.

The next example is a particular instance of the previous one.
Example 5.8 (Lie algebroids). A Lie algebroid structure on $A \rightarrow M$, with anchor $\rho$ and bracket $[\cdot, \cdot]$, is equivalent to a degree -1 Poisson structure $\Pi$ on the manifold $A^{*}[1]$ that can be written in local coordinates $\left\{x^{i}, e_{\alpha}\right\}$ as

$$
\Pi=\rho_{\alpha}^{i}(x) \frac{\partial}{\partial x^{i}} \wedge \frac{\partial}{\partial e_{\alpha}}+c_{\beta \alpha}^{\gamma}(x) e_{\gamma} \frac{\partial}{\partial e_{\beta}} \wedge \frac{\partial}{\partial e_{\alpha}} .
$$

We have the subsheaf of hamiltonian vector fields $\mathcal{A}_{\text {Ham }} \subseteq \mathcal{T}_{A^{*}[1]}$, defined on open subsets $U \subseteq M$ by

$$
\mathcal{A}_{H a m}(U)=\left\{\Pi(d f) \in \mathcal{T}_{A^{*}[1]}(U) \mid f \in C_{A^{*}[1]}(U)\right\},
$$

that is locally generated by the vector fields

$$
X^{\alpha}=\rho_{\alpha}^{i}(x) \frac{\partial}{\partial x^{i}}+c_{\beta \alpha}^{\gamma}(x) e_{\gamma} \frac{\partial}{\partial e_{\beta}}, \quad \text { and } \quad Y^{i}=\rho_{\alpha}^{i}(x) \frac{\partial}{\partial e_{\alpha}} .
$$

Then $\mathcal{A}_{\text {Ham }}$ defines a distribution (in the sense of Definition 5.1) if and only if $\rho: A \rightarrow T M$ has constant rank and $\operatorname{ker}(\rho)$ is a bundle of abelian Lie algebras. The corresponding triple $\left(C_{1}, F, \nabla\right)$ as in Example 5.7 is given by $C_{1}=\operatorname{im}\left(\rho^{t}\right) \subseteq A^{*}, F=\operatorname{im} \rho$, and $\nabla$ the dual of the $F$-connection given by

$$
\nabla^{\dagger}: \Gamma_{\mathrm{im}(\rho)} \times \Gamma_{\mathrm{ker}(\rho)} \rightarrow \Gamma_{\mathrm{ker}(\rho)}, \quad \nabla_{X}^{\dagger} e=[\widehat{e}, e],
$$

where $\hat{e} \in \Gamma_{A}$ is such that $\rho(\widehat{e})=X$, noticing that $\operatorname{ker}(\rho)^{*}=A^{*} / \operatorname{im}\left(\rho^{t}\right)=A^{*} / C_{1}$.
A source of examples of $\mathbb{N}$-manifolds carrying distributions in degree 2 is given by coisotropic submanifolds of symplectic 2-manifolds, as discussed in [9, Sec. 4].

It follows from Example 5.7] that a distribution on a 1-manifold $E[1]$ of rank $d_{0} \mid 0$ is specified by an involutive subbundle $F \subseteq T M$ and a flat $F$-connection on $E$ (or, dually, on $E^{*}$ ). For later use, we will need the extension of this result to $\mathbb{N}$-manifolds of arbitrary degrees.

Proposition 5.9. Let $(\mathbf{E} \rightarrow M, \mu)$ be an admissible $n$-coalgebra bundle and $\mathcal{M}=\mathcal{F}(\mathbf{E}, \mu)$ the associated $n$-manifold. An involutive distribution $\mathcal{D}$ on $\mathcal{M}$ of rank $d_{0}|0| \cdots \mid 0$ is equivalent to the following data: an involutive subundle $F \subseteq T M$ and flat $F$-connections $\nabla^{i}$ on $E_{-i}^{*}$, $i=1, \ldots, n$, satisfying

$$
\begin{equation*}
\nabla_{X}^{i+j}\left(\mu^{*}\left(e, e^{\prime}\right)\right)=\mu^{*}\left(\nabla_{X}^{i} e, e^{\prime}\right)+\mu^{*}\left(e, \nabla_{X}^{j} e^{\prime}\right) \tag{35}
\end{equation*}
$$

for all $e \in \Gamma\left(E_{-i}^{*}\right), e^{\prime} \in \Gamma\left(E_{-j}^{*}\right)$, and $X \in \Gamma(F)$.
Proof. According to Theorem [5.5, a distribution $\mathcal{D}$ with rank $d_{0}|0| \ldots \mid 0$ is equivalent to a vector subbundle $C_{0} \subseteq \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}$ such that $\operatorname{ker}(\sigma) \cap C_{0}=0$. Recall that sections of $\operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}$ are given by derivations $D^{i}$ of $E_{-i}^{*}$, all with the same symbol $X=\sigma\left(D^{i}\right)$, such that

$$
D^{i+j}\left(\mu^{*}\left(e, e^{\prime}\right)\right)=\mu^{*}\left(D^{i} e, e^{\prime}\right)+\mu^{*}\left(e, D^{j} e^{\prime}\right) .
$$

The symbol map $\sigma$ projects $C_{0}$ isomorphically onto its image $F:=\sigma\left(C_{0}\right)$, so $C_{0}$ is the image of $\nabla=\left(\left.\sigma\right|_{C_{0}}\right)^{-1}: F \rightarrow \operatorname{Der}\left(\mathbf{E}_{\mathbb{R}}^{*}, m\right)_{0}$. The distribution $\mathcal{D}$ is involutive if and only if $C_{0}$ is a subalgebroid, which amounts to $F$ being involutive and $\nabla$ being determined by $F$-connections $\nabla^{i}$ on $E_{-i}^{*}$, satisfying (35), which are flat.

## 6. The Frobenius theorem

In this section we will prove the Frobenius theorem for $n$-manifolds, asserting that any involutive distribution is locally generated by coordinate vector fields.

As a warm up, we start by proving the Frobenius theorem for 1-manifolds. Let $E \rightarrow M$ be a vector bundle with $m_{0}=\operatorname{dim}(M)$ and $m_{1}=\operatorname{rank}(E)$.

Proposition 6.1. Let $\mathcal{D}$ be an involutive distribution on $E[1]$ of rank $d_{0} \mid d_{1}$. Then any point in $M$ admits a neighborhood $U$ with coordinates $\left\{x^{\alpha}, e^{\beta}\right\}, \alpha=1, \ldots, m_{0}$ and $\beta=1, \ldots, m_{1}$, on $E[1]_{\mid U}$ such that

$$
\begin{equation*}
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial x^{1}}, \cdots, \frac{\partial}{\partial x^{d_{0}}}, \frac{\partial}{\partial e^{1}}, \cdots, \frac{\partial}{\partial e^{d_{1}}}\right\rangle . \tag{36}
\end{equation*}
$$

Proof. Any point in $M$ admits a neighborhood $U$ such that

$$
\begin{equation*}
\mathcal{D}(U)=\left\langle X^{1}, \cdots, X^{d_{0}}, Y^{1}, \cdots, Y^{d_{1}}\right\rangle \tag{37}
\end{equation*}
$$

where $X^{i} \in \mathcal{T}_{E[1]}^{0}(U), Y^{j} \in \mathcal{T}_{E[1]}^{-1}(U)$ are linearly independent. As recalled in Example [5.7, $\mathcal{D}$ is described by a triple $\left(C_{1}, F, \nabla\right)$, where $C_{1} \subseteq E$ is a subbundle, $F \subseteq T M$ is an involutive subbundle and $\nabla$ is a flat $F$-connection on $E / C_{1}$. With respect to these data, picking local generators of $\mathcal{D}$ as in (37) amounts to choosing a frame $\left\{\xi_{1}, \cdots \xi_{d_{1}}\right\}$ of $C_{\left.1\right|_{U}}$ and local sections $\left\{D_{1}, \ldots, D_{d_{0}}\right\}$ of $C_{\left.0\right|_{U}}$, following the notation in (34), so that the symbols $\sigma\left(D_{j}\right), j=1, \ldots, d_{0}$, form a frame for $F_{\left.\right|_{U}}$.

Showing that one can find local generators of $\mathcal{D}$ as in (36) translates into showing that there exist local coordinates $\left\{x^{\alpha}\right\}_{\alpha=1}^{m_{0}}$ on $U$ and a frame $\left\{e^{\beta}\right\}_{\beta=1}^{m_{1}}$ of $E_{\mid U}^{*}$, as well as a frame $\left\{\xi_{1}, \cdots \xi_{d_{1}}\right\}$ of $C_{\left.1\right|_{U}}$ and sections $\left\{D_{1}, \ldots, D_{d_{0}}\right\}$ of $C_{\left.0\right|_{U}}$ as above satisfying

$$
\begin{equation*}
\sigma\left(D_{a}\right)\left(x^{\alpha}\right)=\delta_{a \alpha}, \quad D_{a}\left(e^{\beta}\right)=0, \quad \xi_{b}\left(e^{\beta}\right)=\delta_{b \beta}, \tag{38}
\end{equation*}
$$

for $a=1, \ldots, d_{0}, \alpha=1, \ldots, m_{0}, b=1, \ldots, d_{1}, \beta=1, \ldots, m_{1}$.
We construct the above data $\left\{x^{\alpha}\right\},\left\{e^{\beta}\right\},\left\{\xi_{b}\right\}$ and $\left\{D_{a}\right\}$ as follows. Shrinking $U$ if necessary, the usual Frobenius theorem implies the existence of local coordinates $\left\{x^{\alpha}\right\}_{\alpha=1}^{m_{0}}$ on $U$ such that $F_{\left.\right|_{U}}=\left\langle\partial_{x^{a}} \mid a=1, \ldots, d_{0}\right\rangle$, we can assume that $E_{\mid U}$ and $C_{1 \mid U}$ are trivial and, writing $E_{\mid U}=\left.C_{1}\right|_{U} \oplus\left(E / C_{1}\right)_{\mid U}$ (with the choice of a splitting), we define a flat $F$-connection on $E_{\mid U}$ by

$$
\widehat{\nabla}=\nabla^{t r i v} \oplus \nabla
$$

where $\nabla^{\text {triv }}$ denotes the trivial $F$-connection on $C_{1 \mid U}$. Let $\hat{\nabla}^{\dagger}$ be the dual flat $F$-connection on $E_{\mid U}^{*}$, and let $\left\{e^{\beta}\right\}_{\beta=1}^{m_{1}}$ be a frame of flat sections of $E_{\mid U}^{*}$ such that $\left\{e^{1}, \cdots e^{d_{1}}\right\}$ is a frame of flat section of $\left.C_{1}^{*}\right|_{U}$. Take $\left\{\xi_{b}\right\}_{b=1}^{d_{1}}$ to be the dual frame on $\left.C_{1}\right|_{U}$ and

$$
D_{a}:=\hat{\nabla}_{\partial_{x^{a}}}^{\dagger}, \quad a=1, \cdots, d_{0}
$$

These data satisfy (38).
We will now generalize the previous proposition to $n$-manifolds of arbitrary degree; for that, we will first consider the special cases of distributions of ranks $d_{0}|0| \ldots \mid 0$ and $0\left|d_{1}\right| \ldots \mid d_{n}$.
Lemma 6.2. Let $\mathcal{M}$ be an n-manifold of dimension $m_{0}|\ldots| m_{n}$ with an involutive distribution $\mathcal{D}$ of rank $d_{0}|0| \cdots \mid 0$. Then any point in $M$ admits a neighborhood $U$ with coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ on $\mathcal{M}_{\mid U}$ such that

$$
\begin{equation*}
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial x^{1}}, \cdots, \frac{\partial}{\partial x^{d_{0}}}\right\rangle . \tag{39}
\end{equation*}
$$

[^4]Proof. Let $(\mathbf{E} \rightarrow M, \mu)$ be an $n$-coalgebra bundle such that $\mathcal{M}=\mathcal{F}(\mathbf{E}, \mu)$. As seen in Proposition 5.9, the distribution $\mathcal{D}$ is equivalent to an involutive subbundle $F \subseteq T M$ and flat $F$-connections $\nabla^{j}$ on $E_{-j}^{*}$, for $j=1, \ldots, n$, satisfying (35); with respect to this geometric description, the statement of the lemma translates into the existence of a neighborhood $U$ of any point in $M$ admitting coordinates $\left\{x^{\alpha}\right\}_{\alpha=1}^{m_{0}}$, together with a frame $\left\{Z_{1}, \ldots, Z_{d_{0}}\right\}$ of $F_{l_{U}}$ and frames $\left\{e_{j}^{\beta_{j}}\right\}_{\beta_{j}=1}^{m_{j}}$ of $\left(\operatorname{ker} \mu_{-j}\right)^{*}$, for $j=1, \ldots, n$, satisfying the following properties:

$$
Z_{a}\left(x^{\alpha}\right)=\delta_{a \alpha}, \quad \nabla_{Z_{a}}^{j}\left(e_{j}^{\beta_{j}}\right)=0
$$

In the equation on the right-hand side, we regard $e_{j}^{\beta_{j}}, \beta_{j}=1, \ldots, m_{j}$, as sections of $E_{-j_{U}}^{*}$ by means of suitable splittings of the exact sequences

$$
0 \rightarrow\left(K_{-j}^{\mu}\right)^{*} \rightarrow E_{-j}^{*} \rightarrow \operatorname{ker}\left(\mu_{-j}\right)^{*} \rightarrow 0,
$$

for $j=1, \ldots, n$, see Remark 3.5.
The desired data $\left\{x^{\alpha}\right\},\left\{Z_{a}\right\},\left\{e_{j}^{\beta_{j}}\right\}$ is constructed as follows. Taking $U$ small enough, the usual Frobenius theorem implies the existence of local coordinates $\left\{x^{\alpha}\right\}_{\alpha=1}^{m_{0}}$ on $U$ such that $\left\{Z_{a}:=\partial_{x_{a}}\right\}_{a=1}^{d_{0}}$ is a frame for $F_{\left.\right|_{U}}$. It follows from condition (35) that $\left(K_{-j}^{\mu}\right)^{*} \subseteq E_{-j}^{*}$ is $\nabla^{j}{ }_{-}$ invariant, and this ensures the existence of linearly independent flat sections $\left\{e_{j}^{\beta_{j}}\right\}_{\beta_{j}=1}^{m_{j}}$ of $E_{-\left.j\right|_{U}}^{*}$ spanning a subbundle complementary to $\left(K_{-j}^{\mu}\right)^{*}$.
Lemma 6.3. Let $\mathcal{M}$ be an n-manifold of dimension $m_{0}|\ldots| m_{n}$ and $\mathcal{D}$ an involutive distribution of rank $0\left|d_{1}\right| \cdots \mid d_{n}$. Then any point in $M$ admits a neighborhood $U$ with coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ on $\mathcal{M}_{\mid U}$ such that

$$
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial e_{1}^{1}}, \cdots, \frac{\partial}{\partial e_{1}^{d_{1}}}, \ldots, \frac{\partial}{\partial e_{n}^{1}}, \cdots, \frac{\partial}{\partial e_{n}^{d_{n}}}\right\rangle .
$$

Proof. We proceed by induction on $n$. For $n=1$ the statement is a particular case of Prop. 6.1, Assuming that the lemma holds for $\mathbb{N}$-manifolds of degree $n-1$, we will prove it for degree $n$. For simplicity, we will use the notation

$$
p^{\gamma}=e_{n}^{\gamma}
$$

for degree $n$ coordinates.
Following Remark 5.6. $\mathcal{D}$ defines a distribution $\mathcal{D}_{n-1}$ on the truncation $\mathcal{M}_{n-1}$. The explicit local picture is as follows: in an open $U$ with coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}, p^{\gamma}\right\}$, for $j=1, \ldots, n-1$, on $\mathcal{M}_{\mid U}$, and such that $\mathcal{D}(U)$ is generated by linearly independent vector fields $Y_{j}^{b_{j}}$ and $Z^{c}$, where $j=1, \ldots, n-1, b_{j}=1, \ldots, d_{j}, c=1, \ldots, d_{n}, Y_{j}^{b_{j}}$ has degree $-j$ and $Z^{c}$ has degree $-n$, the truncation $\mathcal{M}_{n-\left.1\right|_{U}}$ has coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ and $\mathcal{D}_{n-1}(U)$ is generated by the restrictions of $Y_{j}^{b_{j}}$ to $\mathcal{M}_{n-\left.1\right|_{U}}$.

By the induction hypothesis, shrinking $U$ if necessary, we may assume that

$$
\mathcal{D}_{n-1}(U)=\left\langle\frac{\partial}{\partial e_{j}^{1}}, \cdots, \left.\frac{\partial}{\partial e_{j}^{d_{j}}} \right\rvert\, j=1, \ldots, n-1\right\rangle,
$$

and that the vector fields $Y_{j}^{b_{j}}$ and $Z^{c}$ satisfy

$$
\begin{equation*}
\operatorname{res}_{n-1}\left(Y_{j}^{b_{j}}\right)=\frac{\partial}{\partial e_{j}^{b_{j}}} \quad \text { and } \quad \operatorname{res}_{n-1}\left(Z^{c}\right)=0 \tag{40}
\end{equation*}
$$

The vector fields $Z^{c}$ form a local frame for the subbundle $C_{n} \subseteq \operatorname{ker} \mu_{-n} \subseteq E_{-n}$ (see Theorems 4.9 and 5.5). Passing to a smaller neighborhood if necessary, we can extend this frame to a local frame of $\operatorname{ker} \mu_{-n}$, and the dual frame of $\left(\operatorname{ker} \mu_{-n}\right)^{*}$ defines degree $n$ coordinates

$$
\left\{p^{1}, \ldots p^{d_{n}}, \widehat{p}^{d_{n}+1}, \ldots, \widehat{p}^{m_{n}}\right\}
$$

that complete $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ to a set of local coordinates of $\mathcal{M}_{\mid U}$ in such a way that $Z^{c}=\frac{\partial}{\partial p^{c}}$ and, by (40),

$$
Y_{j}^{b_{j}}=\frac{\partial}{\partial e_{j}^{b_{j}}}+\sum_{l=1}^{d_{n}} Y_{j}^{b_{j}}\left(p^{l}\right) \frac{\partial}{\partial p^{l}}+\sum_{l=d_{n}+1}^{m_{n}} Y_{j}^{b_{j}}\left(\hat{p}^{l}\right) \frac{\partial}{\partial \widehat{p}^{l}},
$$

cf. Prop. 4.1. By considering linear combinations, we may redefine

$$
Y_{j}^{b_{j}}:=\frac{\partial}{\partial e_{j}^{b_{j}}}+\sum_{l=d_{n}+1}^{m_{n}} Y_{j}^{b_{j}}\left(\widehat{p}^{l}\right) \frac{\partial}{\partial \widehat{p}^{l}}
$$

and conclude that

$$
\mathcal{D}(U)=\left\langle Y_{j}^{b_{j}}, \frac{\partial}{\partial p^{c}}\right\rangle,
$$

for $j=1, \ldots n-1, b_{j}=1, \ldots, d_{j}$, and $c=1, \ldots, d_{n}$. We will now implement successive changes of coordinates just involving the variables $\hat{p}^{l}$ that will turn each $Y_{j}^{b_{j}}$ into $\frac{\partial}{\partial e_{j}^{b_{j}}}$.

We will simplify the notation and denote the coordinates $e_{j}^{b_{j}}$ by $e^{b}$. Suppose that we have already brought $s-1$ vector fields (note that $s-1$ could be zero) to the desired form, so we are in the situation

$$
\begin{equation*}
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial e^{1}}, \ldots, \frac{\partial}{\partial e^{s-1}}, Y^{s}, \ldots, Y^{k}, \frac{\partial}{\partial p^{1}}, \ldots, \frac{\partial}{\partial p^{d_{n}}}\right\rangle, \tag{41}
\end{equation*}
$$

where $Y^{b}=\frac{\partial}{\partial e^{b}}+\sum_{l=d_{n}+1}^{m_{n}} g^{b l} \frac{\partial}{\partial \widehat{p}^{\prime}}$. Note that, since each coefficient $g^{b l}$ has degree $n-\left|e^{b}\right|<n$, we have that

$$
\begin{equation*}
\frac{\partial}{\partial p^{c}} g^{b l}=0, \quad \frac{\partial}{\partial \widehat{p}^{i}} g^{b l}=0, \tag{42}
\end{equation*}
$$

for $c=1, \ldots, d_{n}$ and $i=d_{n}+1, \ldots, m_{n}$.
We will now define a change of variables turning $Y^{s}$ into $\frac{\partial}{\partial e^{s}}$. The following is a key observation.
Claim. For each $l$ with $g^{s l} \neq 0$, there is a (unique) degree $n$ function $G^{s l}$ on $\mathcal{M}_{\mid U}$ such that $\frac{\partial}{\partial e^{s}} G^{s l}=g^{s l}$.

Let us verify this claim. Since $g^{s l}$ depends polynomially on $e^{s}$, we may write it as

$$
\begin{equation*}
g^{s l}=\sum_{t=0}^{r}\left(e^{s}\right)^{t} a_{t}^{s l} \tag{43}
\end{equation*}
$$

(note that this sum must have finitely many terms), and we simply set

$$
\begin{equation*}
G^{s l}=\sum_{t=0}^{r} \frac{1}{1+t}\left(e^{s}\right)^{t+1} a_{t}^{s l} \tag{44}
\end{equation*}
$$

Such $G^{s j}$ satisfies the condition in the claim provided it is nonzero. This is clearly the case when $\left|e^{s}\right|$ is even. To check that this also holds when $\left|e^{s}\right|$ is odd, we will make use of the involutivity condition of $\mathcal{D}$. Using the second condition in (42), we see that (recall that $\left|Y^{s}\right|=-\left|e^{s}\right|$ is odd)

$$
\left[Y^{s}, Y^{s}\right]=2 \sum_{l=d_{n}+1}^{m_{n}} \frac{\partial g^{s l}}{\partial e^{s}} \frac{\partial}{\partial \widehat{p}^{l}}
$$

and this vector can only be in $\mathcal{D}(U)$ if

$$
\begin{equation*}
\frac{\partial g^{s l}}{\partial e^{s}}=0 \tag{45}
\end{equation*}
$$

Note that $G^{s l}=e^{s} g^{s l}$ when $\left|e^{s}\right|$ is odd, and (45) ensures that this is nonzero. This concludes the proof of the claim.

Consider the change of coordinates that only modifies the coordinates $\widehat{p}^{l}$ according to

$$
\widehat{p}^{l} \mapsto \widehat{p}^{l}-G^{s l}, \quad l=d_{n}+1, \ldots, m_{n}
$$

while keeping all the other coordinates unchanged (here we set $G^{s l}$ to be zero if $g^{s l}$ is zero).
To verify how this transforms the generators of $\mathcal{D}(U)$ in (41), we first observe that

$$
\begin{equation*}
\frac{\partial g^{s l}}{\partial e^{b}}=0, \quad b=1, \ldots, s-1 \tag{46}
\end{equation*}
$$

which is a consequence of

$$
\left[\frac{\partial}{\partial e^{b}}, Y^{s}\right]=\sum_{l=d_{n}+1}^{m_{n}} \frac{\partial g^{s l}}{\partial e^{b}} \frac{\partial}{\partial \widehat{p}^{l}}
$$

and the involutivity of $\mathcal{D}$. Note that conditions (42) and (46) hold for $a_{t}^{s l}$ in (43), and hence (see (44))

$$
\begin{equation*}
\frac{\partial G^{s l}}{\partial p^{c}}=0, \quad \frac{\partial G^{s l}}{\partial \widehat{p}^{i}}=0, \quad \text { and } \quad \frac{\partial G^{s l}}{\partial e^{b}}=0 \tag{47}
\end{equation*}
$$

for $b=1, \ldots, s-1$. It then follows, by the usual transformation rule for vector fields under change of coordinates, that

$$
\frac{\partial}{\partial p^{c}}, \quad \frac{\partial}{\partial \widehat{p}^{i}}, \quad \text { and } \quad \frac{\partial}{\partial e^{b}}
$$

for $b=1, \ldots, s-1$, remain unchanged. For $b \geq s$ we have that $\frac{\partial}{\partial e^{b}}$ transforms to

$$
\frac{\partial}{\partial e^{b}}-\sum_{l=d_{n}+1}^{m_{n}} \frac{\partial G^{s l}}{\partial e^{b}} \frac{\partial}{\partial \widehat{p}^{l}}
$$

in the new coordinates. In particular, the fact that $\frac{\partial}{\partial e^{s}} G^{s l}=g^{s l}$ implies that $Y^{s}$ agrees with $\frac{\partial}{\partial e^{s}}$ after the change of coordinates.

We conclude that, in the new coordinates, we can write

$$
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial e^{1}}, \ldots, \frac{\partial}{\partial e^{s}}, Y^{s+1}, \ldots, Y^{k}, \frac{\partial}{\partial p^{1}}, \ldots, \frac{\partial}{\partial p^{d_{n}}}\right\rangle,
$$

where $Y^{b}=\frac{\partial}{\partial e^{b}}+\sum_{l=d_{n}+1}^{m_{n}} \tilde{g}^{b l} \frac{\partial}{\partial \vec{p}}$. The proof of the lemma follows from a successive repetition of the argument.

We now prove our main theorem.
Theorem 6.4 (Frobenius theorem for $\mathbb{N}$-manifolds). Let $\mathcal{M}$ be an n-manifold of dimension $m_{0}|\ldots| m_{n}$ and $\mathcal{D}$ an involutive distribution on $\mathcal{M}$ of rank $d_{0}|\cdots| d_{n}$. Then any point in $M$ has a neighborhood $U$ with coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ on $\mathcal{M}_{\mid U}$ such that

$$
\mathcal{D}(U)=\left\langle\frac{\partial}{\partial x^{1}}, \ldots, \frac{\partial}{\partial x^{d_{0}}}, \frac{\partial}{\partial e_{1}^{1}}, \ldots, \frac{\partial}{\partial e_{1}^{d_{1}}}, \ldots, \frac{\partial}{\partial e_{n}^{1}}, \ldots, \frac{\partial}{\partial e_{n}^{d_{n}}}\right\rangle .
$$

Proof. Let $U$ be a neighborhood where $\mathcal{D}(U)$ is generated by vector fields $\left\{X_{k}^{i_{k}}\right\}, k=0, \ldots, n$, as in Definition 5.1. By applying Lemma 6.3 to the distribution generated by $\left\{X_{k}^{i_{k}}\right\}$ for $k>0$, we conclude that (by shrinking $U$ if necessary) that there exist coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ on $\mathcal{M}_{\mid U}$ such that

$$
\mathcal{D}(U)=\left\langle\widehat{X}^{1}, \cdots, \widehat{X}^{d_{0}}, \frac{\partial}{\partial e_{1}^{1}}, \cdots, \frac{\partial}{\partial e_{1}^{d_{1}}}, \cdots, \frac{\partial}{\partial e_{n}^{1}}, \cdots, \frac{\partial}{\partial e_{n}^{d_{n}}}\right\rangle,
$$

where $\widehat{X}^{1}, \cdots, \widehat{X}^{d_{0}}$ are linearly independent, degree 0 vector fields. In the above coordinates,

$$
\widehat{X}^{a}=\sum_{\alpha=0}^{m_{0}} g_{\alpha}^{a} \frac{\partial}{\partial x^{\alpha}}+\sum_{j=1}^{n} \sum_{\beta_{j}=1}^{m_{j}} f_{\beta_{j}}^{a j} \frac{\partial}{\partial e_{j}^{\beta_{j}}}
$$

with $g_{\alpha}^{a} \in C^{\infty}(U)=C_{\mathcal{M}}^{0}(U)$ and $f_{\beta_{j}}^{a j} \in C_{\mathcal{M}}^{j}(U)$. Hence, by taking linear combinations, we can write

$$
\mathcal{D}(U)=\left\langle X^{1}, \cdots, X^{d_{0}}, \frac{\partial}{\partial e_{1}^{1}}, \cdots, \frac{\partial}{\partial e_{1}^{d_{1}}}, \cdots, \frac{\partial}{\partial e_{n}^{1}}, \cdots, \frac{\partial}{\partial e_{n}^{d_{n}}}\right\rangle,
$$

where $X^{a}$ is of the form

$$
X^{a}=\sum_{\alpha=0}^{m_{0}} g_{\alpha}^{a} \frac{\partial}{\partial x^{a}}+\sum_{j=1}^{n} \sum_{b_{j}=d_{j}+1}^{m_{j}} f_{b_{j}}^{a j} \frac{\partial}{\partial e_{j}^{b_{j}}} .
$$

Note that, for $i=1, \ldots, n$ and $\beta_{i}=1, \ldots, d_{i}$,

$$
\left[\frac{\partial}{\partial e_{i}^{\beta_{i}}}, X^{a}\right]=\sum_{j=1}^{n} \sum_{b_{j}=d_{j}+1}^{m_{j}} \frac{\partial f_{b_{j}}^{a j}}{\partial e_{i}^{\beta_{i}}} \frac{\partial}{\partial e_{j}^{b_{j}}}
$$

so it follows from the involutivity of $\mathcal{D}$ that

$$
\begin{equation*}
\frac{\partial f_{b_{j}}^{a j}}{\partial e_{i}^{\beta_{i}}}=0 \tag{48}
\end{equation*}
$$

By splitting the local coordinates on $\mathcal{M}_{\mid U}$ as $\left\{x^{\alpha}, e_{j}^{b_{j}}\right\}$ and $\left\{e_{j}^{\beta_{j}}\right\}$, for $j=1, \ldots, n, b_{j}=$ $d_{j}+1, \ldots, m_{j}$, and $\beta_{j}=1, \ldots, d_{j}$ we write

$$
\mathcal{M}_{\mid U}=\mathbb{R}_{\mid U}^{m_{0}\left|m_{1}-d_{1}\right| \cdots \mid m_{n}-d_{n}} \times \mathbb{R}^{0\left|d_{1}\right| \cdots \mid d_{n}}
$$

in such a way that, by (48), $\mathcal{D}$ is identified with the direct product of the involutive distributions

$$
\mathcal{D}_{1}=\left\langle X^{1}, \ldots X^{d_{0}}\right\rangle
$$

on $\mathbb{R}_{\mid U}^{m_{0}\left|m_{1}-d_{1}\right| \cdots \mid m_{n}-d_{n}}$ of rank $d_{0}|0| \cdots \mid 0$ and $\mathcal{D}_{2}=\left\langle\frac{\partial}{\partial e_{j}^{1}}, \cdots, \left.\frac{\partial}{\partial e_{j}^{d_{j}}} \right\rvert\, j=1, \ldots, n\right\rangle$ on $\mathbb{R}^{0\left|d_{1}\right| \cdots \mid d_{n}}$. We conclude the proof by applying Lemma 6.2 to $\mathcal{D}_{1}$.

The following is a simple instance of the Frobenius theorem.
Corollary 6.5. Let $X$ be a vector field of degree $-k$ on an n-manifold $\mathcal{M}$, for $k=1, \ldots, n$ (resp. $k=0$ ), such that $X_{x} \neq 0$ for $x \in M$ and $[X, X]=\lambda X$, where $\lambda$ is a degree $k$ function on $\mathcal{M}$. Then there is a neighborhood of $x$ with coordinates $\left\{x^{\alpha}, e_{j}^{\beta_{j}}\right\}$ such that $X=\frac{\partial}{\partial e_{k}^{I}}$ (resp. $X=\frac{\partial}{\partial x^{1}}$.

This last result follows from the observation that the vector field $X$ generates an involutive distribution in a neighborhood of $x$. Analogous local normal forms for vector fields on supermanifolds can be found in [32] (cf. [35, Lemmas 4.7.5, 4.7.6]), see also [30].

Remark 6.6 (Normal forms of $Q$-structures). Since vector fields of positive degree vanish when evaluated at points in the body, they do not generate distributions and hence do not fit into the framework of the Frobenius theorem. For homological vector fields (see Example 4.3), the study of local normal forms is motivated by several results in geometry; e.g., local splitting theorems for Lie algebroids as well as similar results for Courant and higher Lie algebroids (see [6]) can be viewed as local normal forms for $Q$-structures on $\mathbb{N}$-manifolds (see [36] for results on supermanifolds).

Remark 6.7 (Integrability and foliations). We say that a distribution $\mathcal{D}$ of rank $d_{0}|\ldots| d_{n}$ on an $n$-manifold $\mathcal{M}$ of dimension $m_{0}|\ldots| m_{n}$ is integrable if there exist, around any point in $M$, a neighborhood $U$, neighborhoods $V_{1}$ and $V_{2}$ of the origin in $\mathbb{R}^{d_{0}}$ and $\mathbb{R}^{m_{0}-d_{0}}$, respectively, and an isomorphism

$$
\begin{equation*}
\Psi: \mathcal{M}_{\mid U} \rightarrow \mathbb{R}^{d_{0}|\cdots| d_{n}}{ }_{\mid V_{1}} \times \mathbb{R}^{m_{0}-d_{0}|\cdots| m_{n}-d_{n}}{ }_{\mid V_{2}} \tag{49}
\end{equation*}
$$

identifying $\mathcal{D}$ with the distribution $\mathcal{T}_{\mathbb{R}^{d_{0}}|\cdots| d_{n}} \times 0$. As in the classical case, Theorem 6.4 is equivalent to saying that a distribution $\mathcal{D}$ is integrable if and only if it is involutive.

A foliation atlas on $\mathcal{M}$ is a collection of charts as in (49) such that the transition maps preserve the distribution $\mathcal{T}_{\mathbb{R}^{d_{0}}|\ldots| d_{n}} \times 0$. As in classical geometry (see e.g. [29]), one can define foliations on $\mathbb{N}$-manifolds by means of foliation atlases and establish an equivalence between foliations and involutive distributions.
