# THE LEAST PRIMARY FACTOR OF THE MULTIPLICATIVE GROUP

#### Abstract

Let $S(n)$ denote the least primary factor in the primary decomposition of the multiplicative group $M_{n}=(\mathbb{Z} / n \mathbb{Z})^{\times}$. We give an asymptotic formula, with order of magnitude $x /(\log x)^{1 / 2}$, for the counting function of those integers $n$ for which $S(n) \neq 2$. We also give an asymptotic formula, for any prime power $q$, for the counting function of those integers $n$ for which $S(n)=q$. This group-theoretic problem can be reduced to problems of counting integers with restrictions on their prime factors, allowing it to be addressed by classical techniques of analytic number theory.


## 1. Introduction

The multiplicative group modulo $n$ is the finite abelian group $M_{n}=(\mathbb{Z} / n \mathbb{Z})^{\times}$of units in the ring $\mathbb{Z} / n \mathbb{Z}$, or equivalently the group of reduced residue classes modulo $n$ under multiplication. Several common arithmetic functions are related to the multiplicative group: its size is the Euler phi-function $\phi(n)$, for instance, and its exponent is the Carmichael lambda-function $\lambda(n)$. Both of these functions have been investigated for their distributional properties (as well as pointwise bounds), which reflects the fact that the multiplicative groups $M_{n}$ form a natural family of groups to study, and indeed a richer family of groups than the cyclic (additive) groups $\mathbb{Z}_{n}$ themselves.

The structure of these multiplicative groups is best described in terms of one of the two canonical forms for finite abelian groups $G$. One canonical form is the invariant factor decomposition $G \cong$ $\mathbb{Z}_{d_{1}} \times \cdots \times \mathbb{Z}_{d_{k}}$ where each $d_{j}$ divides $d_{j+1}$; indeed in this form we have $d_{k}=\lambda(n)$ exactly. It turns out that the length $k$ of the invariant factor decomposition is essentially $\omega(n)$, the number of distinct prime factors of $n$, whose distribution also has a robust theory. Chang and the first author [1] used a refinement of the Selberg-Delange method to show that $d_{1}=2$ for almost all integers $n$ and found an asymptotic formula for the number of $n \leq x$ for which $d_{1}=d$ for any fixed integer $d$.

In this paper we focus on the other canonical form for finite abelian groups, namely the primary decomposition $G \cong \mathbb{Z}_{q_{1}} \times \cdots \times \mathbb{Z}_{q_{t}}$ where each $q_{j}$ is a prime power; this decomposition (which is also called the elementary factor decomposition) is uniquely determined by $G$ up to the order of the primary factors $q_{j}$. The result mentioned above implies that the least primary factor of $M_{n}$ equals 2 for almost all integers $n$ (since every primary factor of an invariant factor of $G$ is also a primary factor of $G$ itself). More specifically, we can prove:

Theorem 1.1. The number of $n \leq x$ for which 2 is not the least primary factor of $M_{n}$ is

where

C_{3}=\frac{3}{4 \sqrt{2}} \prod_{p \equiv 3(\bmod 4)}\left(1-\frac{1}{p^{2}}\right)^{1 / 2} \approx 0.490694 \tag{1.1}
\end{equation*}

The main result of this paper is to use the same refinement of the Selberg-Delange method to establish an asymptotic formula for the number of integers $n \leq x$ for which the least primary factor of $M_{n}$ equals any fixed prime power $q$. We introduce the following notation:

Definition 1.2. Let $S(n)$ denote the smallest primary factor of $M_{n}$, that is, the least prime power appearing in the primary decomposition of $M_{n}$. (Note that $M_{1}$ and $M_{2}$ are trivial groups; we are content to leave $S(1)$ and $S(2)$ undefined.) Also let $\mathcal{E}_{q}(x)$ denote the set of positive integers $n \leq x$ such that $S(n)=q$.

Theorem 1.3. For all prime powers $q \leq(\log x)^{1 / 3}$,

\# \mathcal{E}_{q}(x)=\frac{C_{q} x}{(\log x)^{1-\beta_{q}}}+O_{q}\left(\frac{x}{(\log x)^{1-\beta_{q^{+}}}}\right)
$$

where the constants $\beta_{q}, \beta_{q^{+}}$, and $C_{q}$ are defined in Definitions 3.8 and 3.13.
The constant $C_{q}$ has an implicit definition but can be computed in principle for any $q$; we work out the following special cases as examples.

Theorem 1.4. We have

where $C_{3}$ was defined in equation (1.1) above, and $C_{4} \approx 0.4200344$ and $C_{5} \approx 0.2095134$ are given by

Remark 1.5. The notation $\chi_{3}$ appearing in the expressions for $C_{4}$ and $C_{5}$ will be explained more fully in Remark 6.2 below. For now, it suffices to say that $\chi$ in the expression for $C_{4}$ runs over all nonprincipal Dirichlet characters modulo 36, and any such character restricted to the residue class $1(\bmod 4)$ yields a Dirichlet character modulo 9 ; it is this latter character that $\chi_{3}$ refers to. In the expression for $C_{5}$, the same convention holds with 36 replaced by 72 and with $1(\bmod 4)$ replaced by $1(\bmod 8)$.

Throughout this paper, $p$ and $\ell$ will always refer to primes, while $q$ will refer to a prime power (possibly itself prime). All $O$-constants may depend on $q$. In Section 2 we prove Theorem 1.1; the argument also serves as a foundation for the subsequent, more involved proof of Theorem 1.3. In Section 3 we characterize integers $n$ for which $M_{n}$ has no elementary factors less than $q$ in terms of the factorization of $n$, and then deduce Theorem 1.3 from that characterization using the Selberg-Delange method. The rest of the paper is devoted to demonstrating how to calculate the leading constants in Theorem 1.3 explicitly in a form that allows for numerical approximation; the overall plan for doing so is given in Section 4, and the evaluation of $C_{3}$ is carried out in Section 5. After evaluating some subsidiary sums and products involving Dirichlet characters in Section 6, we complete the proof of Theorem 1.4 by evaluating $C_{4}$ in Section 7 and $C_{5}$ in Section 8.

## 2. COUNTING INTEGERS $n$ WITH LEAST PRIMARY FACTOR NOT EQUAL TO 2

In this section we prove Theorem 1.1; the argument also serves as a foundation for the more involved proof of Theorem 1.3 in the next section.

We rely in an essential way on the fact that the primary decomposition of a direct product $G=\prod_{j=1}^{k} G_{k}$ of finite abelian groups is simply the concatenation of the primary decompositions of the individual groups $G_{j}$. In particular, the least primary factor of $G$ is equal to the minimum of the least primary factors of the $G_{j}$. This observation gives a particularly simple criterion for detecting the smallest possible primary factor 2 . Recall that $S(n)$ denotes the smallest primary factor of the multiplicative group $M_{n}$. We also write $p^{r} \| n$ to mean $p^{r} \mid n$ but $p^{r+1} \nmid n$.

Lemma 2.1. We have $S(n) \neq 2$ if and only if both $4 \nmid n$ and all odd primes dividing $n$ are congruent to $1(\bmod 4)$.

Proof. If the prime-power factorization of $n$ is $n=\prod_{p^{r} \| n} p^{r}$, the Chinese remainder theorem tells us that $M_{n} \cong \prod_{p^{r} \| n} M_{p^{r}}$; in particular, $S(n)=2$ if and only if $S\left(p^{r}\right)=2$ for some prime power $p^{r} \| n$.

When $p$ is odd, classical results on primitive roots imply that $M_{p^{r}} \cong \mathbb{Z}_{\phi\left(p^{r}\right)} \cong \mathbb{Z}_{p^{r-1}} \oplus \mathbb{Z}_{p-1}$; the least primary factor of this direct sum is the least primary factor of $\mathbb{Z}_{p-1}$, which is the smallest
prime power dividing $p-1$. In particular, its least primary factor equals 2 precisely when $p \equiv$ $3(\bmod 4)$.

On the other hand, $M_{2}$ is the trivial group, while $M_{2^{r}} \cong \mathbb{Z}_{2} \oplus \mathbb{Z}_{2^{r-2}}$ when $r \geq 2$. In particular, the least primary factor of $M_{2^{r}}$ equals 2 as soon as $r \geq 2$.

As we carry out the proof of Theorem 1.1, we introduce notation that will foreshadow more general notation in the next section.
Definition 2.2. Let $\mathcal{A}_{3}(x)$ be the set of all positive integers $n$ not exceeding $x$ such that $S(n) \geq 3$. Let $\mathcal{A}_{3}^{\prime}(x)$ be the set of all odd integers in $\mathcal{A}_{3}(x)$.

Note that $\left\{n \leq x: n \notin \mathcal{E}_{2}(x)\right\}=\{n \leq x: S(n) \neq 2\}=\{n \leq x: S(n) \geq 3\}=\mathcal{A}_{3}(x)$, and so Theorem 1.1 is a claim about an asymptotic formula for $\# \mathcal{A}_{3}(x)$, which we will deduce from an asymptotic formula for $\# \mathcal{A}_{3}^{\prime}(x)$.
Lemma 2.3. We have $\# \mathcal{A}_{3}(x)=\# \mathcal{A}_{3}^{\prime}(x)+\# \mathcal{A}_{3}^{\prime}\left(\frac{x}{2}\right)$.
Proof. The odd elements of $\mathcal{A}_{3}(x)$ are counted by $\# \mathcal{A}_{3}^{\prime}(x)$ by definition. On the other hand, every even $n \in \mathcal{A}_{3}(x)$ is of the form $n=2 m$ where $m \leq \frac{x}{2}$ is odd, since $4 \nmid n$ by Lemma 2.1; therefore the even elements of $\mathcal{A}_{3}(x)$ are counted by $\# \mathcal{A}_{3}^{\prime}\left(\frac{x}{2}\right)$.

Note that $\mathcal{A}_{3}^{\prime}(x)=\{n \leq x: p \mid n \Longrightarrow p \equiv 1(\bmod 4)\}$ by Lemma 2.1. Counting integers with this sort of restriction on their prime factors is a classical problem in analytic number theory (and indeed this particular case is almost the same as the seminal study by Landau [2] of the counting function of sums of two squares).
Lemma 2.4. We have $\# \mathcal{A}_{3}^{\prime}(x)=\frac{g_{4} x}{(\log x)^{1 / 2}}+O\left(\frac{x}{(\log x)^{3 / 4}}\right)$, where

g_{4}=\frac{1}{2 \sqrt{2}} \prod_{p \equiv 3(\bmod 4)}\left(1-\frac{1}{p^{2}}\right)^{1 / 2} \approx 0.32713 .
$$

Proof. The paper of Chang and first author [1, Proposition 4.1] contains the asymptotic formula

\#\{n \leq x: p \mid n \Longrightarrow p \equiv 1(\bmod q)\}=\frac{g_{q} x}{(\log x)^{1-1 / \phi(q)}}+O\left(\frac{x}{(\log x)^{5 / 4-1 / \phi(q)}}\right)
$$

for any even positive integer $q \geq 3$, where

\begin{equation*}
g_{q}=\frac{1}{\Gamma(1 / \phi(q))}\left(\frac{\phi(q)}{q} \prod_{\substack{\chi(\bmod q) \\ \chi \neq \chi_{0}}} L(1, \chi)\right)^{1 / \phi(q)} \prod_{\substack{p \nmid q \\ p \neq 1(\bmod q)}}\left(1-\frac{1}{p^{\operatorname{ord}_{q}(p)}}\right)^{1 / \operatorname{ord}_{q}(p)} . \tag{2.1}
\end{equation*}
$$

Here $\operatorname{ord}_{q}(a)$ is the order of $a$ in the multiplicative group $M_{q}$, and $\Gamma(s)$ and $L(s, \chi)$ are the Euler Gamma function and Dirichlet $L$-functions, respectively. The simplification of the constant $g_{4}$ was carried out after Theorem 1.2 of that paper:

g_{4} & =\frac{1}{\Gamma(1 / 2)}\left(\frac{2}{4} L\left(1, \chi_{-4}\right)\right)^{1 / 2} \prod_{p \equiv 3(\bmod 4)}\left(1-\frac{1}{p^{2}}\right)^{1 / 2} \\
& =\frac{1}{\sqrt{\pi}}\left(\frac{\pi}{8}\right)^{1 / 2} \prod_{p \equiv 3(\bmod 4)}\left(1-\frac{1}{p^{2}}\right)^{1 / 2} \tag{2.2}
\end{align*}
$$

as claimed.

With these results in hand, the proof of Theorem 1.1 is a simple calculation:
Proof of Theorem 1.1. By Lemmas 2.3 and 2.4,

\# \mathcal{A}_{3}(x) & =\# \mathcal{A}_{3}^{\prime}(x)+\# \mathcal{A}_{3}^{\prime}\left(\frac{x}{2}\right) \\
& =\left(\frac{g_{4} x}{(\log x)^{1 / 2}}+O\left(\frac{x}{(\log x)^{3 / 4}}\right)\right)+\left(\frac{g_{4} x / 2}{(\log x / 2)^{1 / 2}}+O\left(\frac{x / 2}{(\log x / 2)^{3 / 4}}\right)\right) \\
& =g_{4} x\left(\frac{1}{(\log x)^{1 / 2}}+\frac{1}{2(\log (x / 2))^{1 / 2}}\right)+O\left(\frac{x}{(\log x)^{3 / 4}}\right) \\
& =g_{4} x\left(\frac{1}{(\log x)^{1 / 2}}+\frac{1}{2(\log x)^{1 / 2}}\left\{1+O\left(\frac{1}{\log x}\right)\right\}\right)+O\left(\frac{x}{(\log x)^{3 / 4}}\right) \\
& =g_{4} x\left(\frac{3 / 2}{(\log x)^{1 / 2}}\right)+O\left(\frac{x}{(\log x)^{3 / 4}}\right),
\end{aligned}
$$

which is the desired asymptotic formula since $C_{3}=\frac{3}{2} g_{4}$.

## 3. COUNTING INTEGERS $n$ WITH LEAST PRIMARY FACTOR EQUAL TO $q$

Recall that $\mathcal{E}_{q}(x)$ from Definition 1.2 is comprised of integers $m$ such that the smallest primary factor $S(m)$ is exactly equal to $q$, while $\mathcal{A}_{q}(x)$ from Definition 2.2 is comprised of integers $m$ such that $S(m)$ is at least $q$. In this section we prove Theorem 1.3, the asymptotic formula for $\# \mathcal{E}_{q}(x)$, using an elaboration on the method for finding an asymptotic formula for $\# \mathcal{A}_{3}(x)$ in the previous section.

Definition 3.1. Given a prime power $q$, let $q^{+}$denote the smallest prime power that is greater than $q$. Note that

\begin{align*}
\# \mathcal{E}_{q}(x) & =\{m \leq x: S(m)=q\} \\
& =\{m \leq x: S(m) \geq q\}-\left\{m \leq x: S(m) \geq q^{+}\right\}=\# \mathcal{A}_{q}(x)-\# \mathcal{A}_{q^{+}}(x) \tag{3.1}
\end{align*}
$$

Thus to obtain an asymptotic formula for $\# \mathcal{E}_{q}(x)$ for all prime powers $q$, it suffices to obtain an asymptotic formula for $\# \mathcal{A}_{q}(x)$ for all prime powers $q$. This observation is helpful because, as it turns out, the property $S(m) \geq q$ is easier to characterize than the property $S(m)=q$ (see Proposition 3.6 below).

Definition 3.2. Given a prime power $q$ and a prime $p<q$, let $m(p, q)$ denote the largest positive integer such that $p^{m(p, q)}<q$, so that $m(p, q)=\lceil(\log q) / \log p\rceil-1$.
Definition 3.3. For any prime $p$, let $v_{p}(n)$ denote the multiplicity with which $p$ divides $n$. For example, $v_{2}(40)=3$ and $v_{3}(21)=1$ and $v_{3}(5)=0$.
Lemma 3.4. Fix primes $\ell$ and $p$ and a prime power $q \geq 3$. There exists $s \in \mathbb{N}$ such that $\ell^{s}<q$ and $\ell^{s} \|(p-1)$ if and only if $p \equiv 1(\bmod \ell)$ and $p \not \equiv 1\left(\bmod \ell^{m(\ell, q)+1}\right)$.
Proof. Choose $s=v_{\ell}(p-1)$, the only possibility for satisfying $\ell^{s} \|(p-1)$. If $s=0$ then the equivalence holds because both $s \notin \mathbb{N}$ and $p \not \equiv 1(\bmod \ell)$. If $s>m(\ell, q)$ then the equivalence holds as well because both $\ell^{s} \geq q$ and $p \equiv 1\left(\bmod \ell^{m(\ell, q)+1}\right)$. Otherwise $1 \leq s \leq m(\ell, q)$, and the equivalence holds because all statements are true in this case.
Lemma 3.5. Fix an odd prime power $p^{k}$ and a prime power $q \geq 3$. We have $S\left(p^{k}\right) \geq q$ if and only iffor every prime $\ell<q$, either $p \not \equiv 1(\bmod \ell)$ or $p \equiv 1\left(\bmod \ell^{m(\ell, q)+1}\right)$.

Proof. By Lemma 3.4, it suffices to show that $S\left(p^{k}\right)<q$ if and only if there exists a prime $\ell$ and an integer $s \in \mathbb{N}$ such that $\ell^{s}<q$ and $\ell^{s} \|(p-1)$. But this is clear because $S\left(p^{k}\right)$ is the smallest prime power $\ell^{j}$ such that $\ell^{j} \|(p-1)$, since $M_{p^{k}}$ is cyclic of order $p^{k-1}(p-1)$. (We remark that the exponent $k$ plays no role, as the second half of the claimed equivalence indicates.)

Proposition 3.6. Let $q \geq 3$ be a prime power and $m \geq 3$ an integer. We have $S(m) \geq q$ if and only if:
(a) $4 \nmid m$;
(b) if $p \leq q$ is an odd prime, then $p \nmid m$; and
(c) if $\ell<q$ is a prime and $p \mid m$ is an odd prime, then either $p \not \equiv 1(\bmod \ell)$ or $p \equiv$ $1\left(\bmod \ell^{m(\ell, q)+1}\right)$.
(Technically part (b) is a special case of part (c), since there is always some prime divisor $\ell$ of $p-1$ and this $\ell$ will automatically be less than $q$ if $p \leq q$. But it will be helpful to record part (b) explicitly.)

Proof. Since $M_{m} \cong \prod_{p^{k} \| m} M_{p^{k}}$ by the Chinese remainder theorem, we see that $S(m)$ is the minimum value of $S\left(p^{k}\right)$ over all $p^{k} \| m$; in particular, $S(m) \geq q$ if and only if $S\left(p^{k}\right) \geq q$ for all $p^{k} \| m$. We check the implications of this inequality separately for $p=2$, for $3 \leq p \leq q$, and for $p>q$.
(a) If $2^{k} \| m$ with $k \geq 2$, then $M\left(2^{k}\right) \cong \mathbb{Z}_{2} \times \mathbb{Z}_{2^{k-2}}$ and thus $S\left(2^{k}\right)=2<q$. Otherwise $p=2$ does not contribute to $M(m)$.
(b) If $p \mid m$ for some $3 \leq p \leq q$, then $S(p) \leq p-1<q$, which makes $S(m) \geq q$ impossible.
(c) This last item follows directly from Lemma 3.5.

Remark 3.7. Recall that $m(\ell, q)$ was defined in Definition 3.2. Proposition 3.6(c) says that for each prime $\ell<q$, each odd prime $p \mid m$ belongs to one of $(\ell-2) \ell^{m(\ell, q)}+1$ reduced residue classes modulo $\ell^{m(\ell, q)+1}$ : one of those residue classes is $1\left(\bmod \ell^{m(\ell, q)}+1\right)$, and the other $(\ell-2) p^{m(\ell, q)}$ residue classes modulo $\ell^{m(\ell, q)+1}$ are those congruent to neither 0 nor $1(\bmod \ell)$. (We write these residue classes explicitly in Definition 6.1 below.)

Definition 3.8. Given a prime power $q \geq 3$, define

$$
Q_{q}=\prod_{\ell<q} \ell^{m(\ell, q)+1} \quad \text { and } \quad B_{q}=\prod_{\ell<q}\left((\ell-2) \ell^{m(\ell, q)}+1\right),
$$

and define $\mathcal{B}_{q}$ to be the union of $B_{q}$ reduced residue classes modulo $Q_{q}$, namely those corresponding to the $(\ell-2) \ell^{m(\ell, q)}+1$ residue classes modulo $\ell^{m(\ell, q)+1}$ described in Remark 3.7 for each $\ell<q$. Further define

$$
\begin{equation*}
\beta_{q}=\frac{B_{q}}{\phi\left(Q_{q}\right)}=\prod_{\ell<q}\left(\frac{\ell-2}{\ell-1}+\frac{1}{\ell^{m(\ell, q)}(\ell-1)}\right) . \tag{3.2}
\end{equation*}
$$

Recalling from Definition 3.1 that $q^{+}$is the next prime power after $q$, we see thar

$$
\beta_{q^{+}}=\prod_{\ell \leq q}\left(\frac{\ell-2}{\ell-1}+\frac{1}{\ell^{m(\ell, q)}(\ell-1)}\right) .
$$

Remark 3.9. If $q$ is prime then $\beta_{q^{+}}=\frac{q-1}{q} \beta_{q}$; if $q=\ell^{m}$ with $m \geq 2$ then

$$
\beta_{q^{+}}=\frac{\ell-2+\ell^{-m}}{\ell-2+\ell^{1-m}} \beta_{q} .
$$

Either way, we see that $\beta_{q^{+}}<\beta_{q}$.
Definition 3.10. Let $Q \geq 3$ be an integer. Let $\mathcal{B}$ be the union of $B$ distinct reduced residue classes $(\bmod Q)$, and set $\beta=B / \phi(Q)$. Let $\mathcal{N}_{\mathcal{B}}=\{n \in \mathbb{N}: p \mid n \Rightarrow p \in \mathcal{B}\}$ be the set of all positive integers $n$ whose prime factors all lie in $\mathcal{B}$. We define the associated Dirichlet series:

$$
F_{\mathcal{B}}(s)=\sum_{n \in \mathcal{N}_{\mathcal{B}}} \frac{1}{n^{s}}=\prod_{p \in \mathcal{B}} \frac{1}{1-p^{-s}},
$$

which converges absolutely when $\Re(s)>1$. If we define

$$
G_{\mathcal{B}}(s)=F_{\mathcal{B}}(s) \zeta(s)^{-\beta}
$$

it turns out that $G_{\mathcal{B}}(s)$ has a removable singularity at $s=1$, and thus $G_{\mathcal{B}}(1)$ is well defined.
Recall that $\mathcal{A}_{q}^{\prime}(x)$ from Definition 2.2 is comprised of odd integers $m$ such that $S(m)$ is at least $q$.
Proposition 3.11. For any prime power $q \geq 3$,

$$
\# \mathcal{A}_{q}^{\prime}(x)=\frac{x}{(\log x)^{1-\beta_{q}}}\left(\frac{G_{\mathcal{B}_{q}}(1)}{\Gamma\left(\beta_{q}\right)}+O\left((\log x)^{-1 / 4}\right)\right)
$$

Proof. By Proposition 3.6, we have $\mathcal{A}_{q}^{\prime}(x)=\left\{n \leq x: n \in \mathcal{N}_{\mathcal{B}_{q}}\right\}$, where $\mathcal{B}_{q}$ was defined in Definition 3.8. The proposition then follows directly from the asymptotic formula

$$
\#\left\{n \leq x: n \in \mathcal{N}_{\mathcal{B}}\right\}=\frac{x}{(\log x)^{1-\beta}}\left(\frac{G_{\mathcal{B}}(1)}{\Gamma(\beta)}+O\left((\log x)^{-1 / 4}\right)\right)
$$

derived by Chang and the second author [1, Theorem 3.4] (in particular, that derivation verifies the claim that $G_{\mathcal{B}}(s)$ has a removable singularity at $s=1$ ).

Lemma 2.3 is straightforward to generalize:
Lemma 3.12. We have $\# \mathcal{A}_{q}(x)=\# \mathcal{A}_{q}^{\prime}(x)+\# \mathcal{A}_{q}^{\prime}\left(\frac{x}{2}\right)$.
Proof. The odd elements of $\mathcal{A}_{q}(x)$ are counted by $\# \mathcal{A}_{q}^{\prime}(x)$ by definition. On the other hand, every even $n \in \mathcal{A}_{q}(x)$ is of the form $n=2 m$ where $m \leq \frac{x}{2}$ is odd, since $4 \nmid n$ by Proposition 3.6; therefore the even elements of $\mathcal{A}_{q}(x)$ are counted by $\# \mathcal{\mathcal { A }}_{q}^{\prime}\left(\frac{x}{2}\right)$.

Definition 3.13. Using the notation $\mathcal{B}_{q}$ and $\beta_{q}$ from Definition 3.8 and the function $G$ from Definition 3.10, define

$$
C_{q}=\frac{3 G_{\mathcal{B}_{q}}(1)}{2 \Gamma\left(\beta_{q}\right)}=\frac{3}{2 \Gamma\left(\beta_{q}\right)} \lim _{s \rightarrow 1}\left(\zeta(s)^{-\beta_{q}} \prod_{p \in \mathcal{B}_{q}} \frac{1}{1-p^{-s}}\right)
$$

where $\Gamma$ is the Euler Gamma-function.

Proof of Theorem 1.3. By equation (3.1) and Lemma 3.12,

$$
\begin{aligned}
\# \mathcal{E}_{q}(x)= & \# \mathcal{A}_{q}(x)-\# \mathcal{A}_{q^{+}}(x) \\
= & \# \mathcal{A}_{q}^{\prime}(x)+\# \mathcal{A}_{q}^{\prime}\left(\frac{x}{2}\right)+O\left(\# \mathcal{A}_{q^{+}}^{\prime}(x)+\# \mathcal{A}_{q^{+}}\left(\frac{x}{2}\right)\right) \\
= & \frac{x}{(\log x)^{1-\beta_{q}}}\left(\frac{G_{\mathcal{B}_{q}}(1)}{\Gamma\left(\beta_{q}\right)}+O\left((\log x)^{-1 / 4}\right)\right) \\
& \quad+\frac{x / 2}{\log (x / 2)^{1-\beta_{q}}}\left(\frac{G_{\mathcal{B}_{q}}(1)}{\Gamma\left(\beta_{q}\right)}+O\left((\log x / 2)^{-1 / 4}\right)\right)+O\left(\frac{x}{(\log x)^{1-\beta_{q^{+}}}}\right) \\
= & \frac{3}{2} \frac{G_{\mathcal{B}_{q}}(1)}{\Gamma\left(\beta_{q}\right)} \frac{x}{(\log x)^{1-\beta_{q}}}+O\left(\frac{x}{(\log x)^{1-\beta_{q^{+}}}}\right),
\end{aligned}
$$

which completes the proof of Theorem 1.3 by virtue of Definition 3.13.

## 4. Plan for evaluating the leading constants

The remainder of this paper analyzes the constant $C_{q}$ from Definition 3.13 for $q \in\{3,4,5\}$, establishing Theorem 1.4 and illustrating that in principle $C_{q}$ can be given a more concrete form for any prime power $q$. The difficult component of $C_{q}$ is the constant $G_{\mathcal{B}_{q}}(1)$, which we now outline a method for evaluating.

Recall Definition 3.8 for the quantities $Q_{q}$ and $B_{q}$ and the set $\mathcal{B}_{q}$, as well as Definition 3.10 for the functions $F_{\mathcal{B}}$ and $G_{\mathcal{B}}$. Chang and the first author showed [1, equation (3.3)] that

$$
\begin{equation*}
G_{\mathcal{B}_{q}}(s)^{\phi\left(Q_{q}\right)}=A_{\mathcal{B}_{q}}(s) \prod_{p \mid Q_{q}}\left(1-p^{-s}\right)^{B_{q}} \prod_{\substack{\chi\left(\bmod Q_{q}\right) \\ \chi \neq \chi_{0}}} L(s, \chi)^{\sum_{b \in \mathcal{B}_{q}} \bar{\chi}(b)} . \tag{4.1}
\end{equation*}
$$

In the two products we can simply plug in $s=1$ and evaluate, using equations (7.4) and (7.5) below for the $L(1, \chi)$ terms. (It turns out that the exponent of $L(s, \chi)$ is an integer-see Lemma 6.3 below-and in particular real-valued. Therefore the right-hand side is a positive real number at $s=1$, as we can see after pairing the terms $\chi$ and $\bar{\chi}$ in the product; thus taking the $\phi\left(Q_{q}\right)$ th root to solve for $G_{\mathcal{B}_{q}}(1)$ is unproblematic.) As for the $A_{\mathcal{B}_{q}}(s)$ factor, Chang and the first author further showed [1, equation (3.1)] that

$$
\begin{equation*}
A_{\mathcal{B}_{q}}(s)=F_{\mathcal{B}_{q}}(s)^{\phi\left(Q_{q}\right)} \prod_{\chi\left(\bmod Q_{q}\right)} L(s, \chi)^{-\sum_{b \in \mathcal{B}_{q}} \bar{\chi}(b)} \tag{4.2}
\end{equation*}
$$

To evaluate $A_{\mathcal{B}_{q}}(1)$, we will rewrite the right-hand side in terms of convergent Euler products over primes in various residue classes, such as the one arising in equation (5.1) whose value at $s=1$ already appeared in equation (2.2).

## 5. Calculating the leading constant $C_{3}$

Implementing the plan from the previous section when $q=3$ is essentially reproducing the calculation summarized in the proof of Lemma 2.4. Carrying out this computation explicitly will be helpful practice before addressing the more complicated cases $q=4$ and $q=5$ in later sections.

Proof of Theorem 1.4 for $q=3$. We have $Q_{3}=\prod_{\ell<3} \ell^{m(\ell, q)+1}=2^{1+1}=4$ and $\mathcal{B}_{3}=\{1(\bmod 4)\}$. Equation (4.2) becomes

$$
\begin{aligned}
A_{\mathcal{B}_{3}}(s) & =F_{\mathcal{B}_{3}}(s)^{\phi\left(Q_{3}\right)} \prod_{\chi(\bmod 4)} L(s, \chi)^{-\bar{\chi}(1)} \\
& =\prod_{p \equiv 1(\bmod 4)}\left(1-p^{-s}\right)^{-2} \cdot L\left(s, \chi_{0}\right)^{-1} L\left(s, \chi_{-4}\right)^{-1} \\
& =\prod_{p \equiv 1(\bmod 4)}\left(1-p^{-s}\right)^{-2} \cdot \prod_{p \neq 2}\left(1-p^{-s}\right)\left(1-\chi_{-4}(p) p^{-s}\right),
\end{aligned}
$$

where $\chi_{0}$ and $\chi_{-4}$ are the principal and nonprincipal characters modulo 4 , respectively. Splitting the odd primes into their residue classes modulo 4 , this formula becomes

$$
\begin{align*}
A_{\mathcal{B}_{3}}(s) & =\prod_{p \equiv 1(\bmod 4)}\left(1-p^{-s}\right)^{-2}\left(1-p^{-s}\right)\left(1-p^{-s}\right) \cdot \prod_{p \equiv 3(\bmod 4)}\left(1-p^{-s}\right)\left(1+p^{-s}\right) \\
& =\prod_{p \equiv 3(\bmod 4)}\left(1-p^{-2 s}\right) . \tag{5.1}
\end{align*}
$$

Notice that this product converges whenever $\Re s>\frac{1}{2}$; in particular we can evaluate $A_{\mathcal{B}_{3}}(1)$ by simply plugging in $s=1$ to the right-hand side.

Now equation (4.1) becomes

$$
G_{\mathcal{B}_{3}}(s)^{2}=\prod_{p \equiv 3(\bmod 4)}\left(1-p^{-2 s}\right) \cdot\left(1-2^{-s}\right)^{1} \prod_{\substack{\chi(\bmod 4) \\ \chi \neq \chi_{0}}} L(s, \chi)^{\bar{\chi}(1)}
$$

and therefore, using equation (5.1),

$$
G_{\mathcal{B}_{3}}(1)=\left(\frac{1}{2} L\left(1, \chi_{-4}\right) \prod_{p \equiv 3(\bmod 4)}\left(1-p^{-2}\right)\right)^{1 / 2}=\sqrt{\frac{\pi}{8}} \prod_{p \equiv 3(\bmod 4)}\left(1-p^{-2}\right)^{1 / 2}
$$

Finally, since $\beta_{3}=\frac{1}{2}$ and $\beta_{3^{+}}=\beta_{4}=\frac{1}{3}$, Theorem 1.3 becomes

$$
\# \mathcal{E}_{3}(x)=\frac{C_{3} x}{(\log x)^{1 / 2}}+O\left(\frac{x}{(\log x)^{2 / 3}}\right)
$$

where by Definition 3.13,

$$
\begin{equation*}
C_{3}=\frac{3}{2 \Gamma(1 / 2)} G_{\mathcal{B}_{3}}(1)=\frac{3}{2 \sqrt{\pi}} \sqrt{\frac{\pi}{8}} \prod_{p \equiv 3(\bmod 4)}\left(1-p^{-2}\right)^{1 / 2} \tag{5.2}
\end{equation*}
$$

which is consistent with equation (1.1).

## 6. Evaluating $\sum_{b \in \mathcal{B}} \chi(b)$

In order to evaluate the exponents in equation (4.2), we need to determine $\sum_{b \in \mathcal{B}_{q}} \bar{\chi}(b)$ in general. We accomplish this task in Lemma 6.3 below after introducing some necessary notation.
Definition 6.1. Let $q \geq 3$ be a prime power and $\ell<q$ be a prime. With $m(\ell, q)$ as in Definition 3.2:

- Define $\mathcal{M}_{\ell, q}=M_{\ell^{m(\ell, q)+1}}$ to be the full multiplicative group modulo $\ell^{m(\ell, q)+1}$.
- Define $\mathcal{H}_{\ell, q}=\left\{b \in M_{\ell^{m(\ell, q)+1}}: b \equiv 1(\bmod \ell)\right\}$, which is also the subgroup of $(\ell-1)$ st powers in $\mathcal{M}_{\ell, q}$.
- Let $\mathcal{I}_{\ell, q}=\left\{1\left(\bmod \ell^{m(\ell, q)+1}\right)\right\}$ be the singleton set containing only one residue class.
- Set $\mathcal{B}_{\ell, q}=\left(\mathcal{M}_{\ell, q} \backslash \mathcal{H}_{\ell, q}\right) \cup \mathcal{I}_{\ell, q}$, which is the set of residue classes described in Remark 3.7.

Remark 6.2. Considering the large multiplicative group $M_{Q_{q}}$ where $Q_{q}$ is from Definition 3.8, we see that $M_{Q_{q}} \cong \prod_{\ell<q} \mathcal{M}_{\ell, q}$ by the Chinese remainder theorem; under this isomorphism, the collection $\mathcal{B}_{q}$ of residue classes in $M_{Q_{q}}$ from Definition 3.8 can be written exactly as $\mathcal{B}_{q}=\prod_{\ell<q} \mathcal{B}_{\ell, q}$.

Moreover, every Dirichlet character $\chi\left(\bmod Q_{q}\right)$ can be uniquely written as the product of Dirichlet characters modulo $\ell^{m(\ell, q)+1}$ as $\ell$ ranges over the primes less than $q$; more precisely, there exist characters $\left\{\chi_{\ell}: \ell<q\right\}$ such that $\chi(b)=\prod_{\ell<q} \chi_{\ell}\left(b_{\ell}\right)$, where the $b_{\ell}$ are the components of the image of $b \in M_{Q_{q}}$ under the isomorphism from $M_{Q_{q}} \cong \prod_{\ell<q} \mathcal{M}_{\ell, q}$. It follows, for instance, that

$$
\begin{equation*}
\sum_{b \in \mathcal{B}_{q}} \chi(b)=\prod_{\ell<q} \sum_{b_{\ell} \in \mathcal{B}_{\ell, q}} \chi_{\ell}\left(b_{\ell}\right) . \tag{6.1}
\end{equation*}
$$

Lemma 6.3. Let $q \geq 3$ be a prime power and let $\ell<q$ be a prime. For any Dirichlet character $\chi\left(\bmod \ell^{m(\ell, q)+1}\right)$,

$$
\sum_{b \in \mathcal{B}_{\ell, q}} \chi(b)=\left\{\begin{array}{ll}
\ell^{m(\ell, q)}(\ell-1), & \text { if } \chi=\chi_{0}, \\
0, & \text { if } \chi \neq \chi_{0}
\end{array}\right\}-\left\{\begin{array}{ll}
\ell^{m(\ell, q)}, & \text { if } \chi^{\ell-1}=\chi_{0}, \\
0, & \text { if } \chi^{\ell-1} \neq \chi_{0}
\end{array}\right\}+1
$$

In particular, if $\ell=2$ then $\sum_{b \in \mathcal{B}_{\ell, q}} \chi(b)=1$ for any $\chi\left(\bmod \ell^{m(\ell, q)+1}\right)$.
Proof. We concentrate on the first assertion since the second one follows directly from it (or directly from the fact that $\mathcal{B}_{\ell, q}=\left\{1\left(\bmod \ell^{m(\ell, q)+1}\right)\right\}$ when $\left.\ell=2\right)$. By definition,

$$
\begin{aligned}
\sum_{b \in \mathcal{B}_{\ell, q}} \chi(b) & =\sum_{b \in \mathcal{M}_{\ell, q}} \chi(b)-\sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)+\sum_{b \in \mathcal{I}_{\ell, q}} \chi(b) \\
& =\left\{\begin{array}{ll}
\ell^{m(\ell, q)}(\ell-1), & \text { if } \chi=\chi_{0}, \\
0, & \text { if } \chi \neq \chi_{0},
\end{array}\right\}-\sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)+1
\end{aligned}
$$

by orthogonality. Comparing this expression to the desired formula, it suffices to prove that

$$
\sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)= \begin{cases}\ell^{m(\ell, q)}, & \text { if } \chi^{\ell-1}=\chi_{0} \\ 0, & \text { if } \chi^{\ell-1} \neq \chi_{0}\end{cases}
$$

But this is an immediate consequence of the fact that the subgroup $\left\{\chi\left(\bmod \ell^{m(\ell, q)}\right): \chi^{\ell-1}=\chi_{0}\right\}$ is the dual group to the subgroup $\mathcal{H}_{\ell, q}$ which is the set of $(\ell-1)$ st powers modulo $m(\ell, q)$. More concretely, if $\chi^{\ell-1}=\chi_{0}$, then for every $b \in \mathcal{H}_{\ell, q}$ there exists $a \in \mathcal{M}_{\ell, q}$ such that $a^{\ell-1} \equiv$ $b\left(\bmod \ell^{m(\ell, q)+1}\right)$, and therefore $\chi(b)=\chi\left(a^{\ell-1}\right)=\chi^{\ell-1}(a)=\chi_{0}(a)=1$ for each of the $\ell^{m(\ell, q)}$ elements of $\mathcal{H}_{\ell, q}$. On the other hand, if $\chi^{\ell-1} \neq \chi_{0}$, then we can choose $c \in \mathcal{M}_{\ell, q}$ such that $\chi^{\ell-1}(c) \neq 1$; then, since $c^{\ell-1}$ is in the subgroup $\mathcal{H}_{\ell, q}$,

$$
\sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)=\sum_{b \in \mathcal{H}_{\ell, q}} \chi\left(c^{\ell-1} b\right)=\chi^{\ell-1}(c) \sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)
$$

which forces $\sum_{b \in \mathcal{H}_{\ell, q}} \chi(b)=0$.

By Definition 3.10 and Remark 6.2, we can write equation (4.2) as

$$
\begin{align*}
A_{\mathcal{B}_{q}}(s) & =\prod_{p \in \mathcal{B}_{q}}\left(1-p^{-s}\right)^{-\phi\left(Q_{q}\right)} \cdot \prod_{\chi\left(\bmod Q_{q}\right)} \prod_{p}\left(1-\chi(p) p^{-s}\right)^{\Pi_{\ell<q} \sum_{b_{\ell} \in \mathcal{B}_{\ell, q}} \chi_{\ell}\left(b_{\ell}\right)} \\
& =\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-\phi\left(Q_{q}\right)}, & \text { if } p \in \mathcal{B}_{q}, \\
1, & \text { if } p \notin B_{q}
\end{array}\right\} \prod_{\chi\left(\bmod Q_{q}\right)}\left(1-\chi(p) p^{-s}\right)^{\Pi_{\ell<q} \sum_{b_{\ell} \in \mathcal{B}_{\ell, q}} \chi_{\ell}\left(b_{\ell}\right)}\right) . \tag{6.2}
\end{align*}
$$

The factor corresponding to a prime $p$ is some rational function of $p^{-s}$ that depends only upon the residue class of $p\left(\bmod Q_{q}\right)$. When we compute these $\phi\left(Q_{q}\right)$ rational functions, the following lemma implies that each one is actually a rational function of $p^{-k s}$ for some integer $k \geq 2$ (depending on the residue class). Consequently, while the above formulas are valid for $\Re s>1$, the entire expression for $A_{\mathcal{B}_{q}}(s)$ will end up converging for $\Re s>\frac{1}{2}$ at least; in particular, we can evaluate $A_{\mathcal{B}_{q}}(1)$ by simply plugging $s=1$ into the resulting expression.
Lemma 6.4. Given $Q \in \mathbb{N}$, let $H$ be any subgroup of the group of Dirichlet characters modulo $Q$. If $p \nmid Q$ and the cardinality of $\{\chi(p): \chi \in H\}$ equals $k$, then

$$
\prod_{\chi \in H}\left(1-\chi(p) p^{-s}\right)=\left(1-p^{-k s}\right)^{(\# H) / k} .
$$

Proof. Since the image $\{\chi(p): \chi \in H\}$ is a subgroup of $\mathbb{C}^{\times}$, it must equal the cyclic group of $k$ th roots of unity. It follows easily that the image contains all $k$ th roots of unity each with equal multiplicity $(\# H) / k$. Therefore

$$
\prod_{\chi \in H}\left(1-\chi(p) p^{-s}\right)=\prod_{j=0}^{k-1}\left(1-e^{2 \pi i j / k} p^{-s}\right)^{(\# H) / k}=\left(1-p^{-k s}\right)^{(\# H) / k}
$$

by the factorization of $1-z^{k}$ over the complex numbers.

## 7. Calculating the leading constant for $q=4$

We now have all the tools we need to calculate the constant $C_{4}$ from Theorem 1.4.
Lemma 7.1. For $\Re s>1$ we have

$$
\begin{align*}
& A_{\mathcal{B}_{4}}(s)=\prod_{p \equiv 5,29(\bmod 36)}\left(1-p^{-6 s}\right)^{2}\left(1-p^{-2 s}\right)^{-6} \prod_{p \equiv 7,11,23,31(\bmod 36)}\left(1-p^{-6 s}\right)^{2} \\
& \times \prod_{p \equiv 13,25(\bmod 36)}\left(1-p^{-3 s}\right)^{4} \prod_{p \equiv 19,35(\bmod 36)}\left(1-p^{-2 s}\right)^{6} . \tag{7.1}
\end{align*}
$$

Note that the products on the right-hand side converge absolutely for $\Re s>\frac{1}{2}$.
Proof. When $q=4$, we have $Q_{4}=\prod_{\ell<4} \ell^{m(\ell, q)+1}=2^{1+1} 3^{1+1}=36$; we also have $\mathcal{B}_{2,4}=$ $\{1(\bmod 4)\}$ and $\mathcal{B}_{3,4}=\{1,2,5,8(\bmod 9)\}$ and therefore $\mathcal{B}_{4}=\{1,5,17,29(\bmod 36)\}$. Equation (6.2) then simplifies since the sum over $\mathcal{B}_{2,4}$ always equals 1 :

$$
A_{\mathcal{B}_{4}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-12}, & \text { if } p \in \mathcal{B}_{4},  \tag{7.2}\\
1, & \text { if } p \notin B_{4}
\end{array}\right\} \prod_{\chi(\bmod 36)}\left(1-\chi(p) p^{-s}\right)^{\sum_{b_{3} \in \mathcal{B}_{3,4}} \chi_{3}\left(b_{3}\right)}\right)
$$

where $\chi_{3}$ is the character $(\bmod 9)$ that is the restriction of $\chi$ to the residue class $1(\bmod 4)$. By Lemma 6.3, this becomes

$$
\begin{aligned}
& A_{\mathcal{B}_{4}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-12}, & \text { if } p \in \mathcal{B}_{4}, \\
1, & \text { if } p \notin \mathcal{B}_{4}
\end{array}\right\}\right. \\
&\left.\times \prod_{\substack{\chi(\bmod 36) \\
\chi 3=\chi_{0}}}\left(1-\chi(p) p^{-s}\right)^{6} \prod_{\substack{\chi(\bmod 36) \\
\chi_{3}^{2}=\chi_{0}}}\left(1-\chi(p) p^{-s}\right)^{-3} \prod_{\chi(\bmod 36)}\left(1-\chi(p) p^{-s}\right)\right) .
\end{aligned}
$$

The products on the second line are all (powers of) products of the shape treated by Lemma 6.4, over character subgroups of cardinality 2,4 , and 12 , respectively; the expression evaluates to

$$
\begin{align*}
& A_{\mathcal{B}_{4}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-12}, & \text { if } p \in \mathcal{B}_{4}, \\
1, & \text { if } p \notin B_{4}
\end{array}\right\}\right. \\
&\left.\times\left(1-p^{-k_{1} s}\right)^{12 / k_{1}}\left(1-p^{-k_{2} s}\right)^{-12 / k_{2}}\left(1-p^{-k_{3} s}\right)^{12 / k_{3}}\right), \tag{7.3}
\end{align*}
$$

where $k_{1}=\#\left\{\chi(p): \chi(\bmod 36), \chi_{3}=\chi_{0}\right\}$ and $k_{2}=\#\left\{\chi(p): \chi(\bmod 36), \chi_{3}^{2}=\chi_{0}\right\}$ and $k_{3}=\#\{\chi(p): \chi(\bmod 36)\}$, quantities that depend only upon $p(\bmod 36)$. A case-by-case analysis of the 12 residue classes in $M_{36}$ results in the expression asserted in the lemma. To see two example cases:

- The residue class $p \equiv 29(\bmod 36)$, which is $1(\bmod 4)$ and $2(\bmod 9)$, is in $\mathcal{B}_{4}$. In this case equation (8.3) becomes $\left(1-p^{-s}\right)^{-12}\left(1-p^{-s}\right)^{12}\left(1-p^{-2 s}\right)^{-6}\left(1-p^{-6 s}\right)^{2}$ since $k_{1}=1$, $k_{2}=2$, and $k_{3}=6$.
- The residue class $p \equiv 31(\bmod 36)$, which is $3(\bmod 4)$ and $4(\bmod 9)$, is not in $\mathcal{B}_{4}$. In this case equation (8.3) becomes $1\left(1-p^{-2 s}\right)^{6}\left(1-p^{-2 s}\right)^{-6}\left(1-p^{-6 s}\right)^{2}$ since $k_{1}=2, k_{2}=2$, and $k_{3}=6$.

Remark 7.2. The quantity $A_{\mathcal{B}_{4}}(1)$ can be calculated numerically to several decimal places by plugging in $s=1$ to equation (7.1) and approximating the resulting absolutely convergent products numerically using all the primes up to some bound.

Proof of Theorem 1.4 for $q=4$. Equation (4.1) becomes

$$
G_{\mathcal{B}_{4}}(s)^{12}=A_{\mathcal{B}_{4}}(s)\left(1-2^{-s}\right)^{4}\left(1-3^{-s}\right)^{4} \prod_{\substack{\chi(\bmod 36) \\ \chi \neq \chi_{0}}} L(s, \chi)^{\sum_{b \in \mathcal{B}_{4}} \bar{\chi}(b)}
$$

Therefore by Lemma 6.3,

$$
G_{\mathcal{B}_{4}}(1)=\frac{1}{3^{1 / 3}} A_{\mathcal{B}_{4}}(1)^{1 / 12} \prod_{\substack{\chi \neq \chi_{0} \\ \chi 3=\chi_{0}}} L(1, \chi)^{1 / 3} \prod_{\substack{\chi \neq \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 6} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 12},
$$

where the products are over the characters $(\bmod 36)$ with the given properties, remembering that $\chi_{3}$ is the restriction of $\chi$ to the residue class $1(\bmod 4)$. (As a reality check on the notation, the first product runs over all characters $\chi(\bmod 36)$ that are nonprincipal but for which the corresponding character $\chi_{3}(\bmod 9)$ is principal; there turns out to be exactly one such character, namely the
character induced by the nonprincipal character $\chi_{-4}(\bmod 4)$. The second and third products run over 3 and 11 characters ( $\bmod 36$ ), respectively.)

Finally, by Definition 3.13,

$$
C_{4}=\frac{3 G_{\mathcal{B}_{4}}(1)}{2 \Gamma\left(\beta_{4}\right)}=\frac{3^{2 / 3}}{2 \Gamma(1 / 3)} A_{\mathcal{B}_{4}}(1)^{1 / 12} \prod_{\substack{\chi \neq \chi_{0} \\ \chi 3=\chi_{0}}} L(1, \chi)^{1 / 3} \prod_{\substack{\chi \neq \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 6} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 12}
$$

which is identical to equation (1.2) by Lemma 7.1.
We briefly describe how we calculated the numerical approximation $C_{4} \approx 0.4200344$. Standard computational software can calculate $3^{2 / 3} / 2 \Gamma(1 / 3) \approx 0.3882291057$ to any desired accuracy. Furthermore, there are classical results that allow us to write $L(1, \chi)$ as a finite sum of easily calculated quantities. For example, [3, Theorem 9.9] tells us that if $q>1$ and $\chi$ is a primitive character modulo $q$, then

$$
L(1, \chi)= \begin{cases}\frac{i \pi \tau(\chi)}{q^{2}} \sum_{k \in M_{q}} \bar{\chi}(k) k, & \text { if } \chi \text { is odd }  \tag{7.4}\\ -\frac{\tau(\chi)}{q} \sum_{k \in M_{q}} \bar{\chi}(k) \log \sin \frac{k \pi}{q}, & \text { if } \chi \text { is even. }\end{cases}
$$

where $\tau(\chi)=\sum_{a \in M_{q}} \chi(a) e^{2 \pi i a / q}$ is the Gauss sum. Furthermore, if $\chi$ is a Dirichlet character $(\bmod q)$ which is induced by the primitive character $\chi^{*}\left(\bmod q^{*}\right)$, then plugging $s=1$ into [3, equation (9.2)] yields

$$
\begin{equation*}
L(1, \chi)=L\left(1, \chi^{*}\right) \prod_{p \mid q}\left(1-\frac{\chi^{*}(p)}{p}\right) \tag{7.5}
\end{equation*}
$$

Therefore for any nonprincipal character, $L(1, \chi)$ can be calculated with standard software to any desired accuracy. In this way we find that

$$
\prod_{\substack{\chi \neq \chi 0 \\ \chi=\chi_{0}}} L(1, \chi)^{1 / 3} \prod_{\substack{\chi \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 6} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 12} \approx 1.0608329542 .
$$

It remains to calculate

$$
\begin{aligned}
& A_{\mathcal{B}_{4}}(1)^{1 / 12}=\prod_{p \equiv 5,29(\bmod 36)}\left(1-p^{-6}\right)^{1 / 6}\left(1-p^{-2}\right)^{-1 / 2} \prod_{p \equiv 7,11,23,31(\bmod 36)}\left(1-p^{-6}\right)^{1 / 6} \\
& \times \prod_{p \equiv 13,25(\bmod 36)}\left(1-p^{-3}\right)^{1 / 3} \prod_{p \equiv 19,35(\bmod 36)}\left(1-p^{-2}\right)^{1 / 2} .
\end{aligned}
$$

We approximate $A_{\mathcal{B}_{4}}(1)^{1 / 12}$ by its truncation using all of the primes up to $10^{7}$, which evaluates to 1.0198817240. To control the error in this approximation, we note that $\left|\log \left(1-p^{-2}\right)^{-1 / 2}\right| \leq \frac{1}{2} p^{-2}$ by a linear approximation to the convex function $\log (1-t)$; the upper bounds for the absolute logarithms of the other possible Euler factors are all majorized by this one. Thus the absolute logarithm of the truncation error is at most

$$
\left|\log \prod_{p>10^{7}}\left(1-p^{-2}\right)^{-1 / 2}\right| \leq \sum_{p>10^{7}} \frac{1}{2 p^{2}}=\int_{10^{7}}^{\infty} \frac{1}{2 t^{2}} d\left(\pi(t)-\pi\left(10^{7}\right)\right)=\int_{10^{7}}^{\infty} \frac{\pi(t)-\pi\left(10^{7}\right)}{t^{3}} d t
$$

after integrating by parts. Using the Rosser-Schoenfeld bound $\pi(x)<1.25506 x / \log x$ [4, equation (3.6)], we obtain the crude estimate

$$
\int_{10^{7}}^{\infty} \frac{\pi(t)-\pi\left(10^{7}\right)}{t^{3}} d t<\int_{10^{7}}^{\infty} \frac{1.25506 t / \log t}{t^{3}} d t<\frac{1.25506}{\log 10^{7}} \int_{10^{7}}^{\infty} \frac{d t}{t^{2}}=\frac{1.25506}{10^{7} \log 10^{7}}<8 \cdot 10^{-9} .
$$

Therefore the true value of $A_{\mathcal{B}_{4}}(1)^{1 / 12}$ is in the interval $\left(1.019881724 e^{-8 \cdot 10^{-9}}, 1.019881724 e^{8 \cdot 10^{-9}}\right)$.
We conclude that $C_{4} \approx 0.3882291057 \cdot 1.0608329542 \cdot 1.019881724 \approx 0.4200344$ and that this approximation is accurate to the indicated seven decimal places.

## 8. CALCULATING THE LEADING CONSTANT FOR $q=5$

As a final example, we use the same technique to calculate the constant $C_{5}$ from Theorem 1.4.
Lemma 8.1. For $\Re s>1$ we have

$$
\begin{align*}
& A_{\mathcal{B}_{5}}(s)=\prod_{\substack{p \equiv 19,35,37,53, 55,71(\bmod 72)}}\left(1-p^{-2 s}\right)^{12} \prod_{\substack{p \equiv 5,7,11,13,23,29,31,43, 47,59,61,67(\bmod 72)}}\left(1-p^{-6 s}\right)^{4} \\
& \times \prod_{p \equiv 41,65(\bmod 72)}\left(1-p^{-6 s}\right)^{4}\left(1-p^{-2 s}\right)^{12} \prod_{p \equiv 25,49(\bmod 72)}\left(1-p^{-3 s}\right)^{8} . \tag{8.1}
\end{align*}
$$

Proof. When $q=5$, we have $Q_{5}=\prod_{\ell<5} \ell^{m(\ell, q)+1}=2^{2+1} 3^{1+1}=72$; we also have $\mathcal{B}_{2,5}=$ $\{1(\bmod 8)\}$ and $\mathcal{B}_{3,5}=\{1,2,5,8(\bmod 9)\}$ and therefore $\mathcal{B}_{4}=\{1,17,41,65(\bmod 72)\}$. Equation (6.2) then simplifies since the sum over $\mathcal{B}_{2,5}$ always equals 1 :

$$
A_{\mathcal{B}_{5}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-24}, & \text { if } p \in \mathcal{B}_{5},  \tag{8.2}\\
1, & \text { if } p \notin B_{5}
\end{array}\right\} \prod_{\chi(\bmod 72)}\left(1-\chi(p) p^{-s}\right)^{\sum_{b_{3} \in \mathcal{B}_{3,5}} \chi_{3}\left(b_{3}\right)}\right)
$$

where $\chi_{3}$ is the character $(\bmod 9)$ that is the restriction of $\chi$ to the residue class $1(\bmod 4)$. By Lemma 6.3, this becomes

$$
\begin{aligned}
& A_{\mathcal{B}_{5}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-24}, & \text { if } p \in \mathcal{B}_{5}, \\
1, & \text { if } p \notin \mathcal{B}_{5}
\end{array}\right\}\right. \\
&\left.\times \prod_{\substack{\left.\chi(\bmod 72) \\
\chi_{3}=\chi_{0}\right)}}\left(1-\chi(p) p^{-s}\right)^{6} \prod_{\substack{\chi(\bmod 72) \\
\chi_{3}^{2}=\chi_{0}}}\left(1-\chi(p) p^{-s}\right)^{-3} \prod_{\chi(\bmod 72)}\left(1-\chi(p) p^{-s}\right)\right) .
\end{aligned}
$$

The products on the second line are all (powers of) products of the shape treated by Lemma 6.4, over character subgroups of cardinality 4,8 , and 24 , respectively; the expression evaluates to

$$
\begin{align*}
& A_{\mathcal{B}_{5}}(s)=\prod_{p}\left(\left\{\begin{array}{ll}
\left(1-p^{-s}\right)^{-24}, & \text { if } p \in \mathcal{B}_{5}, \\
1, & \text { if } p \notin B_{5}
\end{array}\right\}\right. \\
&\left.\times\left(1-p^{-k_{1} s}\right)^{24 / k_{1}}\left(1-p^{-k_{2} s}\right)^{-24 / k_{2}}\left(1-p^{-k_{3} s}\right)^{24 / k_{3}}\right) \tag{8.3}
\end{align*}
$$

where $k_{1}=\#\left\{\chi(p): \chi(\bmod 72), \chi_{3}=\chi_{0}\right\}$ and $k_{2}=\#\left\{\chi(p): \chi(\bmod 72), \chi_{3}^{2}=\chi_{0}\right\}$ and $k_{3}=\#\{\chi(p): \chi(\bmod 72)\}$, quantities that depend only upon $p(\bmod 72)$. A case-by-case analysis of the 24 residue classes in $M_{72}$ results in the expression asserted in the lemma.

Proof of Theorem 1.4 for $q=5$. Equation (4.1) becomes

$$
G_{\mathcal{B}_{5}}(s)^{24}=A_{\mathcal{B}_{5}}(s)\left(1-2^{-s}\right)^{4}\left(1-3^{-s}\right)^{4} \prod_{\substack{\chi(\bmod 72) \\ \chi \neq \chi_{0}}} L(s, \chi)^{\sum_{b \in \mathcal{B}_{5}} \bar{\chi}(b)} .
$$

Therefore by Lemma 6.3,

$$
G_{\mathcal{B}_{5}}(1)=\frac{1}{3^{1 / 6}} A_{\mathcal{B}_{5}}(1)^{1 / 24} \prod_{\substack{\chi \neq \chi_{0} \\ \chi 3=\chi_{0}}} L(1, \chi)^{1 / 6} \prod_{\substack{\chi \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 12} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 24}
$$

where the products are over the characters $(\bmod 72)$ with the given properties, remembering that $\chi_{3}$ is the restriction of $\chi$ to the residue class $1(\bmod 8)$.

Finally, by Definition 3.13,

$$
C_{5}=\frac{3 G_{\mathcal{B}_{5}}(1)}{2 \Gamma\left(\beta_{5}\right)}=\frac{3^{5 / 6}}{2 \Gamma(1 / 6)} A_{\mathcal{B}_{5}}(1)^{1 / 24} \prod_{\substack{\chi \neq \neq \chi_{0} \\ \chi 3=\chi_{0}}} L(1, \chi)^{1 / 6} \prod_{\substack{\chi \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 12} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 24}
$$

which is identical to equation (1.3) by Lemma 8.1.
As before, standard computational software can calculate $3^{5 / 6} / 2 \Gamma(1 / 6) \approx 0.2095133578$, and the known formulas for $L(1, \chi)$ allow us to calculate

$$
\prod_{\substack{\chi \neq \chi_{0} \\ \chi_{3}=\chi_{0}}} L(1, \chi)^{1 / 6} \prod_{\substack{\chi \neq \neq \chi_{0} \\ \chi_{3}^{2}=\chi_{0}}} L(1, \chi)^{-1 / 12} \prod_{\chi \neq \chi_{0}} L(1, \chi)^{1 / 24} \approx 0.9354960209
$$

Finally, the method of the previous section allows us to approximate

$$
\begin{aligned}
A_{\mathcal{B}_{5}}(1)^{1 / 24}= & \prod_{\substack{p \equiv 19,35,37,53, 55,71(\bmod 72)}}\left(1-p^{-2}\right)^{1 / 2} \prod_{\substack{p \equiv 5,7,11,13,23,29,31,43, 47,59,61,67(\bmod 72)}}\left(1-p^{-6}\right)^{1 / 6} \prod_{p \equiv 25,49(\bmod 72)}\left(1-p^{-3}\right)^{1 / 3} \\
& \times \prod_{p \equiv 41,65(\bmod 72)}\left(1-p^{-6}\right)^{1 / 6}\left(1-p^{-2}\right)^{1 / 2} \approx 0.9980828307,
\end{aligned}
$$

and the error analysis from the previous section is valid without change for this product. We conclude that $C_{5} \approx 0.2095133578 \cdot 0.9354960209 \cdot 0.9980828307 \approx 0.2095134$ accurate rounded to the indicated seven decimal places.
