# Longtime behaviors of $\theta$ -Euler–Maruyama method for stochastic functional differential equations

# Abstract

This paper investigates longtime behaviors of the  $\theta$ -Euler-Maruyama method for the stochastic functional differential equation with superlinearly growing coefficients. We focus on the longtime convergence analysis in mean-square sense and weak sense of the  $\theta$ -Euler-Maruyama method, the convergence of the numerical invariant measure, the existence and convergence of the numerical density function, and the Freidlin–Wentzell large deviation principle of the method. The main contributions are outlined as follows. First, we obtain the longtime mean-square convergence of the  $\theta$ -Euler-Maruyama method and show that the mean-square convergence rate is  $\frac{1}{2}$ . A key step in the proof is to establish the time-independent boundedness of high-order moments of the numerical functional solution. Second, based on the technique of the Malliavin calculus, we present the longtime weak convergence of the  $\theta$ -Euler–Maruyama method, which implies that the invariant measure of the  $\theta$ -Euler–Maruyama functional solution converges to the exact one with rate 1. Third, by the analysis of the test-functional-independent weak convergence and negative moment estimates of the determinant of the corresponding Malliavin covariance matrix, we derive the existence, convergence, and the logarithmic estimate of the density function of the  $\theta$ -Euler–Maruyama solution. At last, utilizing the weak convergence method, we obtain the Freidlin–Wentzell large deviation principle for the  $\theta$ -Euler–Maruyama solution on the infinite time horizon.

### CHAPTER 1

## Introduction

The stochastic functional differential equation (SFDE) is commonly used to model systems that depend not only on the present state but also on the past ones, which has wide applications in diverse fields such as biology, epidemiology, mechanics, neural networks, economics, finance and so on. The numerical method of the SFDE serves as a powerful tool to qualitatively and quantitatively study stochastic phenomena and time-lag effect prevalent in these fields. There is a growing interest in the study of longtime behaviors of numerical methods, which provides effective approaches for investigating the intrinsic properties of the exact solution. However, many problems on this topic remain unsolved. This paper focuses on the investigation of longtime behaviors for the  $\theta$ -Euler–Maruyama ( $\theta$ -EM) method of the SFDE.

#### **1.1** Stochastic functional differential equation

In this paper, we consider the following SFDE on  $t \in [-\tau, +\infty)$ ,

$$\begin{cases} \mathrm{d}x^{\xi}(t) = b(x_t^{\xi})\mathrm{d}t + \sigma(x_t^{\xi})\mathrm{d}W(t), \quad t > 0, \\ x^{\xi}(t) = \xi(t), \quad t \in [-\tau, 0], \end{cases}$$
(1.1)

where the delay  $\tau > 0$ , the initial datum  $\xi \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ , the drift coefficient  $b : \mathcal{C}([-\tau, 0]; \mathbb{R}^d) \to \mathbb{R}^d$  is locally Lipschitz continuous, the diffusion coefficient  $\sigma : \mathcal{C}([-\tau, 0]; \mathbb{R}^d) \to \mathbb{R}^{d \times m}$  is globally Lipschitz continuous,  $\{W(t), t \geq 0\}$  is an *m*-dimensional standard Brownian motion on a filtered probability space  $(\Omega, \mathcal{F}, \{\mathcal{F}_t\}_{t\geq 0}, \mathbb{P})$ , and  $x_t^{\xi} : r \mapsto x^{\xi}(t+r)$  is the  $\mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ -valued functional solution for  $t \geq 0$ . The well-posedness of (1.1) has been deeply studied, see e.g. [51, 49, 61, 54] and references therein for details.

The longtime behavior of the SFDE on the infinite time horizon is a recent and ongoing research subject. There are now a certain number of papers devoted to this research. For instance, the stability of the exact solution has been established in e.g. [1, 46, 36, 55]; The theory on the existence and uniqueness of the invariant measure of the functional solution has been well studied in e.g. [8, 4, 60, 5, 59]. We recall some results on the functional solution of (1.1), including the second moment boundedness, the exponential attractiveness, and the existence and uniqueness of the invariant measure. Suppose that the coefficients satisfy the following two assumptions, which are globally Lipschitz condition of the diffusion coefficient  $\sigma$  and the dissipative condition of the drift coefficient b.

**Assumption 1.1** There exist a constant L > 0 and a probability measure  $\nu_1$  on  $[-\tau, 0]$  such that for any  $\phi_1$ ,  $\phi_2 \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ ,

$$|\sigma(\phi_1) - \sigma(\phi_2)|^2 \le L\Big(|\phi_1(0) - \phi_2(0)|^2 + \int_{-\tau}^0 |\phi_1(r) - \phi_2(r)|^2 \mathrm{d}\nu_1(r)\Big).$$

Assumption 1.2 The drift coefficient b is continuous and there exist a probability measure  $\nu_2$  on  $[-\tau, 0]$  and positive constants  $a_1, a_2$  satisfying  $a_1 > a_2 + L$  such that for any  $\phi_1, \phi_2 \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ ,

$$\langle \phi_1(0) - \phi_2(0), b(\phi_1) - b(\phi_2) \rangle \le -a_1 |\phi_1(0) - \phi_2(0)|^2 + a_2 \int_{-\tau}^0 |\phi_1(r) - \phi_2(r)|^2 \mathrm{d}\nu_2(r).$$

Note that under Assumption 1.2, the drift coefficient b may grow superlinearly, in particular, the classical example  $b(x) = \frac{1}{\tau} \int_{-\tau}^{0} x(s) ds - |x(0)|^2 x(0) - x(0), x \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$  is included.

**Remark 1.1** By Assumption 1.2, we obtain that for any  $\phi \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ ,

$$\langle \phi(0), b(\phi) \rangle \le |\phi(0)| |b(0)| - a_1 |\phi(0)|^2 + a_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r).$$
 (1.2)

Since  $a_1 > a_2 + L$ , by the Young inequality, we have

$$2|\phi(0)||b(0)| \le \frac{1}{a_1 - a_2 - (1 + \varepsilon)L} |b(0)|^2 + (a_1 - a_2 - (1 + \varepsilon)L)|\phi(0)|^2, \quad (1.3)$$

where the positive constant  $\varepsilon$  satisfies  $a_1 - a_2 - (1 + \varepsilon)L > 0$ . Inserting (1.3) into (1.2) leads to

$$2\langle \phi(0), b(\phi) \rangle \leq \frac{1}{a_1 - a_2 - (1 + \varepsilon)L} |b(0)|^2 - (a_1 + a_2 + (1 + \varepsilon)L) |\phi(0)|^2 + 2a_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r).$$

This, along with Assumption 1.1 implies that

$$2\langle \phi(0), b(\phi) \rangle + |\sigma(\phi)|^{2}$$

$$\leq \frac{1}{a_{1} - a_{2} - (1 + \varepsilon)L} |b(0)|^{2} + (1 + \frac{1}{\varepsilon})|\sigma(0)|^{2} - (a_{1} + a_{2})|\phi(0)|^{2}$$

$$+ (1 + \varepsilon)L \int_{-\tau}^{0} |\phi(r)|^{2} d\nu_{1}(r) + 2a_{2} \int_{-\tau}^{0} |\phi(r)|^{2} d\nu_{2}(r).$$

Letting  $\varepsilon = \frac{a_1 - (a_2 + L)}{2L}$ , we have

$$2\langle\phi(0), b(\phi)\rangle \le K - \frac{3a_1 + a_2 + L}{2} |\phi(0)|^2 + 2a_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r)$$
(1.4)

and

$$2\langle \phi(0), b(\phi) \rangle + |\sigma(\phi)|^2 \le K - (a_1 + a_2) |\phi(0)|^2 + \frac{a_1 - a_2 + L}{2} \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_1(r) + 2a_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r), \qquad (1.5)$$

where the positive constant K depends on  $a_1$ ,  $a_2$ , L, b(0), and  $\sigma(0)$ .

Under Assumptions 1.1 and 1.2, the SFDE (1.1) with the initial datum  $\xi \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$  has a unique strong solution  $x^{\xi}(\cdot)$  on  $[-\tau, \infty)$  according to [54, Theorem 2.3]. Below, we list the second moment boundedness, the exponential attractiveness, and the existence and uniqueness of the invariant measure for the functional solution of (1.1). The proofs are similar to [4, Lemma 3.1, Lemma 3.2, and Theorem 1.3], which are omitted.

**Lemma 1.1** Under Assumptions 1.1 and 1.2, the functional solution of (1.1) satisfies

$$\sup_{t \ge 0} \mathbb{E}[\|x_t^{\xi}\|^2] \le K(1 + \|\xi\|^2)$$

and

$$\mathbb{E}[\|x_t^{\xi} - x_t^{\eta}\|^2] \le K \|\xi - \eta\|^2 e^{-\lambda t} \quad \forall \ t \ge 0,$$

where  $\xi, \eta \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ , K > 0, and  $\lambda > 0$  is a sufficiently small constant satisfying

$$c_{\lambda} := 2a_1 - L - (2a_2 + L)e^{\lambda \tau} - \lambda > 0.$$
(1.6)

For any  $\xi \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$  and  $t \ge 0$ , denote by  $\mu_t^{\xi}$  the probability measure generated by  $x_t^{\xi}$ , namely,

$$\mu_t^{\xi}(A) = \mathbb{P}\{\omega \in \Omega : x_t^{\xi} \in A\} \quad \forall A \in \mathcal{B}(\mathcal{C}([-\tau, 0]; \mathbb{R}^d)).$$

Define the bounded-Wasserstein distance  $\mathbb{W}_q$   $(q \in [1, \infty))$  as

$$\mathbb{W}_{q}(\mathfrak{u}_{1},\mathfrak{u}_{2}) := \left(\inf_{\pi \in \Pi(\mathfrak{u}_{1},\mathfrak{u}_{2})} \int_{\mathcal{C}([-\tau,0];\mathbb{R}^{d}) \times \mathcal{C}([-\tau,0];\mathbb{R}^{d})} 1 \wedge \|\phi_{1} - \phi_{2}\|^{q} \pi(\mathrm{d}\phi_{1},\mathrm{d}\phi_{2})\right)^{\frac{1}{q}}, \quad (1.7)$$

where  $\Pi(\mathfrak{u}_1,\mathfrak{u}_2)$  denotes the collection of all probability measures on  $\mathcal{C}([-\tau,0];\mathbb{R}^d) \times \mathcal{C}([-\tau,0];\mathbb{R}^d)$  with marginal measures  $\mathfrak{u}_1$  and  $\mathfrak{u}_2$ ; see [58, Chapter 6] for details.

**Lemma 1.2** Under Assumptions 1.1 and 1.2, the functional solution  $x^{\xi}$  is asymptotically stable in distribution and admits a unique invariant measure  $\mu$  satisfying

$$\mathbb{W}_2(\mu_t^{\xi},\mu) \le K(1+\|\xi\|)e^{-\frac{\Lambda}{2}t}.$$

### 1.2 $\theta$ -Euler–Maruyama method

The numerical study of the SFDE on the infinite time horizon has attracted a great deal of attention in the past decades. For instance, authors in [62, 44] obtain the stability of the Euler–Maruyama (EM) method and the backward Euler–Maruyama (BEM) method for the linearly growing coefficients case and the superlinearly growing coefficients case, respectively; Authors in [4] present the existence, uniqueness, and convergence of the invariant measure of the EM method for the SFDE with Markov switching; [56] proves that for the SFDE with superlinearly growing coefficients, the numerical invariant measure of the BEM method converges to the exact one.

In this paper, we introduce a general class of numerical methods, namely, the  $\theta$ -Euler– Maruyama ( $\theta$ -EM) method ( $\theta \in [0, 1]$ ), and investigate the longtime behaviors of numerical solutions for the SFDE. The  $\theta$ -EM method includes the EM method (for which  $\theta = 0$ ) and the BEM method (for which  $\theta = 1$ ). Concerning that for the SFDE with superlinearly growing coefficients, the explicit method such as the EM method often fails to converge strongly or weakly to the exact solution; see e.g. [35]. To overcome the divergence, we consider the implicit case with  $\theta \in (\frac{1}{2}, 1]$  in this paper. We also remark that for the case of  $\theta \in [0, \frac{1}{2}]$ , results in this paper can also be obtained under a stronger condition on coefficients *b* and  $\sigma$ . Without loss of generality, we take a sufficiently large integer  $N \geq \tau$ such that  $\Delta = \frac{\tau}{N} \in (0, 1]$ . Let  $t_k = k\Delta$  for  $k = -N, -N + 1, \ldots$  Define the  $\theta$ -EM method as follows: for any  $\xi \in \mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ ,

$$\begin{cases} y^{\xi,\Delta}(t_k) = \xi(t_k), \quad k = -N, -N+1, \dots, 0, \\ y^{\xi,\Delta}(t_{k+1}) = y^{\xi,\Delta}(t_k) + (1-\theta)b(y^{\xi,\Delta}_{t_k})\Delta + \theta b(y^{\xi,\Delta}_{t_{k+1}})\Delta + \sigma(y^{\xi,\Delta}_{t_k})\delta W_k, \quad k \in \mathbb{N}, \end{cases}$$
(1.8)

where  $\theta \in (\frac{1}{2}, 1]$ ,  $\delta W_k = W(t_{k+1}) - W(t_k)$ , and  $y_{t_k}^{\xi, \Delta}$  is a  $\mathcal{C}([-\tau, 0]; \mathbb{R}^d)$ -valued random variable defined by

$$y_{t_k}^{\xi,\Delta}(r) = \frac{t_{j+1} - r}{\Delta} y^{\xi,\Delta}(t_{k+j}) + \frac{r - t_j}{\Delta} y^{\xi,\Delta}(t_{k+j+1})$$
(1.9)

for  $r \in [t_j, t_{j+1}]$ ,  $j \in \{-N, \ldots, -1\}$ . We call  $\{y^{\xi, \Delta}(t_k)\}_{k=-N}^{\infty}$  the  $\theta$ -EM solution and  $\{y^{\xi, \Delta}_{t_k}\}_{k=0}^{\infty}$  the  $\theta$ -EM functional solution. Without particular clarifications, we always assume  $\theta \in (\frac{1}{2}, 1]$ .

The following lemma shows the solvability of the  $\theta$ -EM method.

**Lemma 1.3** Under Assumptions 1.1 and 1.2, the solution of the implicit method (1.8) exists uniquely for any  $\Delta \in (0, 1]$ .

**Proof.** Fix  $\Delta \in (0,1]$  and  $\theta \in (\frac{1}{2},1]$ . For any  $\phi \in \mathcal{C}([-\tau,0];\mathbb{R}^d)$  and  $u \in \mathbb{R}^d$ , define continuous functions  $\Phi_{\phi,u}^{\Delta}: [-\tau,0] \to \mathbb{R}^d$  and  $F_{\theta,\phi}^{\Delta}: \mathbb{R}^d \to \mathbb{R}^d$ , respectively, by

$$\Phi^{\Delta}_{\phi,u}(r) = \begin{cases} \phi(r+\Delta), & r \in [-\tau, -\Delta), \\ \frac{-r}{\Delta}\phi(0) + \frac{\Delta+r}{\Delta}u, & r \in [-\Delta, 0] \end{cases}$$
(1.10)

and

$$F^{\Delta}_{\theta,\phi}(u) = u - \theta b(\Phi^{\Delta}_{\phi,u})\Delta.$$

Moreover, by virtue of (1.4) and the convex property of  $|\cdot|^2$ , we have

$$\begin{split} &\lim_{|u| \to \infty} \frac{\langle u, F_{\theta,\phi}^{\Delta}(u) \rangle}{|u|^2} = 1 - \theta \Delta \lim_{|u| \to \infty} \frac{\langle \Phi_{\phi,u}^{\Delta}(0), b(\Phi_{\phi,u}^{\Delta}) \rangle}{|u|^2} \\ &\geq 1 - \theta \Delta \lim_{|u| \to \infty} \frac{K - \frac{3a_1 + a_2 + L}{2} |\Phi_{\phi,u}^{\Delta}(0)|^2 + 2a_2 \int_{-\tau}^{0} |\Phi_{\phi,u}^{\Delta}(r)|^2 \mathrm{d}\nu_2(r)}{2|u|^2} \\ &\geq 1 - \theta \Delta \lim_{|u| \to \infty} \frac{K - \frac{3a_1 + a_2 + L}{2} |u|^2 + 2a_2(||\phi||^2 + |u|^2)}{2|u|^2} \\ &= 1 + \theta \Delta \frac{3(a_1 - a_2) + L}{4} > 1, \end{split}$$

which implies that  $F_{\theta,\phi}^{\Delta}$  is coercive. In addition, for any  $u_1, u_2 \in \mathbb{R}^d$  with  $u_1 \neq u_2$ , by Assumption 1.2 and (1.10), we derive

$$\langle u_1 - u_2, F^{\Delta}_{\theta,\phi}(u_1) - F^{\Delta}_{\theta,\phi}(u_2) \rangle$$
  
=  $|u_1 - u_2|^2 - \theta \Delta \langle \Phi^{\Delta}_{\phi,u_1}(0) - \Phi^{\Delta}_{\phi,u_2}(0), b(\Phi^{\Delta}_{\phi,u_1}) - b(\Phi^{\Delta}_{\phi,u_2}) \rangle$ 

$$\geq |u_1 - u_2|^2 + \theta \Delta a_1 |\Phi_{\phi, u_1}^{\Delta}(0) - \Phi_{\phi, u_2}^{\Delta}(0)|^2 - \theta \Delta a_2 \int_{-\tau}^{0} |\Phi_{\phi, u_1}^{\Delta}(r) - \Phi_{\phi, u_2}^{\Delta}(r)|^2 d\nu_2(r)$$
  
=  $(1 + \theta \Delta a_1) |u_1 - u_2|^2 - \theta \Delta a_2 \int_{-\Delta}^{0} \frac{\Delta + r}{\Delta} |u_1 - u_2|^2 d\nu_2(r)$   
 $\geq (1 + \theta \Delta a_1 - \theta \Delta a_2) |u_1 - u_2|^2 > |u_1 - u_2|^2 > 0,$ 

which shows the monotone property of  $F_{\theta,\phi}^{\Delta}$ . Hence according to [50, Lemma 3.1], we arrive at that for any  $v \in \mathbb{R}^d$ , the equation  $F_{\theta,\phi}^{\Delta}(u) = v$  has a unique solution  $u \in \mathbb{R}^d$ , and the inverse  $(F_{\theta,\phi}^{\Delta})^{-1}$  of  $F_{\theta,\phi}^{\Delta}$  exists. For the fixed integer  $k \geq 0$  and  $y_{t_k}^{\xi,\Delta}$ , we observe

$$F^{\Delta}_{\theta, y^{\xi, \Delta}_{t_k}}(y^{\xi, \Delta}(t_{k+1})) = y^{\xi, \Delta}(t_{k+1}) - \theta b(\Phi^{\Delta}_{y^{\xi, \Delta}_{t_k}, y^{\xi, \Delta}(t_{k+1})}) \Delta = y^{\xi, \Delta}(t_{k+1}) - \theta b(y^{\xi, \Delta}_{t_{k+1}}) - \theta b(y^{\xi, \Delta}_{t_{k$$

Then (1.8) can be rewritten as

$$F^{\Delta}_{\theta, y^{\xi, \Delta}_{t_k}}(y^{\xi, \Delta}(t_{k+1})) = y^{\xi, \Delta}(t_k) + (1 - \theta)b(y^{\xi, \Delta}_{t_k})\Delta + \sigma(y^{\xi, \Delta}_{t_k})\delta W_k.$$

By virtue of the existence of  $(F^{\Delta}_{\theta, y^{\xi, \Delta}_{t_k}})^{-1}$ , we derive that  $y^{\xi, \Delta}(t_{k+1})$  exists uniquely and satisfies

$$y^{\xi,\Delta}(t_{k+1}) = (F^{\Delta}_{\theta,y^{\xi,\Delta}_{t_k}})^{-1} (y^{\xi,\Delta}(t_k) + (1-\theta)b(y^{\xi,\Delta}_{t_k})\Delta + \sigma(y^{\xi,\Delta}_{t_k})\delta W_k) \quad \text{a.s}$$

Thus, the proof is finished.

The following lemma shows the Markov property of the numerical functional solution, whose proof is similar to that of [56, Theorem 6.1] and is omitted.

**Lemma 1.4** The  $\theta$ -EM functional solution is a time-homogenous Markov chain.

### 1.3 Outline and notations

#### 1.3.1 Outline

Our objective is to investigate longtime behaviors of the numerical solution of  $\theta$ -EM method (1.8), including the longtime mean-square convergence and weak convergence, the convergence of the numerical invariant measure, the existence and convergence of the numerical density function, and the large deviation principle of the numerical solution. To be specific,

- (1) In Chapter 2, we obtain the longtime mean-square convergence of the  $\theta$ -EM functional solution for the SFDE (1.1), and show that the mean-square convergence rate is  $\frac{1}{2}$ .
- (2) In Chapter 3, we present a quantitative estimate of the invariant measure of the  $\theta$ -EM functional solution, based on the investigation of the time-independent weak convergence rate of the considered numerical method.

- (3) In Chapter 4, we show the existence of density functions of the exact solution and  $\theta$ -EM solution for SFDE (1.1), and further establish the convergence of the numerical density function.
- (4) In Chapter 5, we investigate the Freidlin–Wentzell large deviation principle (LDP) of the  $\theta$ -EM solution, and further present the logarithmic estimate of the numerical density function for the SFDE (1.1) with small noise.

We proceed with the main results obtained in this paper:

**Chapter 2:** The mean-square convergence is one of the crucial features for the accuracy of a stochastic numerical method. Over the past decades, much attention has been paid to this topic for SFDEs on the finite time horizon. For instance, for SFDE with the globally Lipschitz continuous coefficients, when the delay argument is of the discrete type, authors in [33] develop a strong Milstein scheme and show that the strong convergence rate is 1; Authors in [9] use the Wong–Zakai approximation as an intermediate step to derive three numerical schemes and analyze their mean-square convergence. For the distributed type of delay argument, the author in [48] obtains the mean-square convergence of the EM method and further proves that the convergence rate is  $\frac{1}{2}$ ; The author in [6] provides a systematic approach to investigating the mean-square convergence of drift-implicit onestep schemes. For the superlinear growing coefficients case, when the delay argument is of the discrete type, authors in [25] construct the tamed EM method and analyze its meansquare convergence. Recently, for the distributed type of delay argument, authors in [43] design a truncated EM method and show that the mean-square convergence rate is  $\frac{1}{2}$ . By contrast, the research on the longtime mean-square convergence for numerical methods of SFDEs remains rare. And we are aware of a recent paper [15], in which the mean-square convergence rate of the EM method for the SFDE on the infinite time horizon is proved to be  $\frac{1}{2}$  under the globally Lipschitz condition. However, for the superlinearly growing coefficients case, how can one obtain the longtime mean-square convergence of numerical methods for the SFDE?

In Chapter 2, we focus on the  $\theta$ -EM method of the SFDE (1.1) with superlinearly growing coefficients, and study the longtime mean-square convergence of the method. We first establish the time-independent boundedness of high-order moments of the  $\theta$ -EM functional solution. Then we derive the inheritance of the exponential attractiveness and the exponential stability of the exact functional solution by the  $\theta$ -EM method. Armed with these preparations, we prove that the mean-square convergence rate of the  $\theta$ -EM method on the infinite time horizon is  $\frac{1}{2}$ . As applications, we derive the probabilistic limit behaviors, including the strong law of large numbers and the central limit theorem, for the  $\theta$ -EM functional solution.

**Chapter 3:** Invariant measure is an important characteristic for describing longtime dynamical behaviors of Markov processes. For SFDEs with either discrete or distributed delay arguments, it is known that the solution is non-Markovian due to the dependence on the past. Hence, the functional solution, which is proved to be Markovian, becomes the objective to study the existence and uniqueness of the invariant measure of the underlying SFDE. Numerical approximation of the unique invariant measure of the functional solution for SFDEs with different types of delay arguments has been studied in the existing literature. For example, for a kind of discrete delay arguments case, authors in [17] prove

that the numerical solution of the BEM method at integer time admits a unique invariant measure, and further prove that the convergence rate of the numerical invariant measure is 1. For the case of the distributed delay argument, authors in [4] demonstrate that the functional solution of the EM method of the SFDE with Markov switching admits a unique numerical invariant measure which converges to the exact one in the Wasserstein distance; Authors in [56] concern the approximation of invariant measure of the functional solution for the SFDE by the BEM method and reveal the convergence of the numerical invariant measure in the Wasserstein distance. Natural questions arise: For the distributed delay argument case, does the numerical invariant measure of a numerical method converge to the original one with rate 1? In particular, is this convergence result applicable to the superlinealy growing coefficients case? Less is known about these questions to our knowledge.

To take a step towards answering the above questions, in Chapter 3, we focus on the  $\theta$ -EM method for the SFDE (1.1) with superlinearly growing coefficients, and investigate the existence, uniqueness, and the convergence rate of the invariant measure for the numerical functional solution. We first obtain the existence and uniqueness of the numerical invariant measure by means of the time-independent moment boundedness and the exponential attractiveness of the  $\theta$ -EM functional solution. A common approach to obtaining the convergence rate of the numerical invariant measure is based on the longtime weak convergence of the numerical method, which can be established by means of the Malliavin calculus. The prerequisite is to derive the time-independent estimates for Malliavin derivatives and Gâteaux derivatives of both the exact and numerical functional solutions. We show that the moments of these derivatives decay exponentially in time. Based on the set properties, we obtain the weak convergence rate with order 1 of the  $\theta$ -EM method on the infinite time horizon, which is twice the mean-square one. As a by-product, the convergence rate for the numerical invariant measure of the  $\theta$ -EM functional solution is derived, which is the same as the weak convergence rate.

Chapter 4: The density function of the solution of a stochastic differential equation, characterizing all the relevant probabilistic information, is one of the most essential characteristics that reveals the probabilistic behavior of the underlying solution. The Malliavin calculus, as a powerful tool to prove the existence and smoothness of density functions, was first introduced by P. Malliavin in [47] with the aim of giving a probabilistic proof of the Hörmander hypoellipticity theorem; see e.g. [19, 2, 53, 10, 52] and references therein for further development and application of the Malliavin calculus. In order to approximate the density function of the stochastic differential equation, the study on the numerical density function of a numerical method has received much attention recently. For instance, for the stochastic ordinary differential equation (SODE) with globally Lipschitz coefficients, the convergence of the density of the numerical solution is proved in e.g. [30, 3, 34, 41] based on Itô–Taylor type dicretizations under the Hörmander condition, and in e.g. [39] based on the kernel density estimation and the Malliavin calculus. For the stochastic Langevin equation with non-globally coefficients, [23] proves the existence, smoothness, and convergence of the numerical density function of the splitting method. For the stochastic partial differential equation, authors in [13, 31] investigate the existence and convergence of the numerical density function for the stochastic heat equation and the stochastic Cahn–Hilliard equation, respectively. However, less is known about the case of SFDEs.

The main aim in Chapter 4 is to investigate the existence and convergence of the density function of the  $\theta$ -EM method for the SFDE (1.1). We first present the nondegeneracy of the numerical solution and prove the existence of the corresponding numerical density function by means of the Malliavin calculus. For the SFDE driven by the multiplicative noise, combining the mean-square convergence result of the  $\theta$ -EM method, the convergence of the numerical density function is proved. While for the case of the additive noise, the convergence rate of the numerical density function is derived, based on the test-functionalindependent weak convergence analysis for the  $\theta$ -EM method. The major obstacle in the proof lies in the estimates of the negative moments of the determinant of the corresponding Malliavin covariance matrix of the numerical solution, which is overcome by presenting a discrete comparison principle for the SFDE with additive noise. Combining the full use of the Malliavin integration by parts formula, the test-functionalindependent weak convergence rate and further the convergence rate of numerical density function are both proved to be 1.

**Chapter 5:** The LDP for the stochastic differential equation with small noise is also called the Freidlin–Wentzell LDP, which characterizes the exponential decay probabilities that sample paths of the solution of the stochastic differential equation deviate from that of the corresponding deterministic equation as the intensity of the noise tends to zero. Fruitful results appear on the Freidlin–Wentzell LDP for both the SODE and the stochastic partial differential equation (SPDE). In contrast, the research for the case of the numerical method is still at its infancy. We are aware of [18, 32] for the numerical study of the LDP for SFDEs on the finite time horizon has received much attention in recent years; see e.g. [40, 5, 37] and references therein. To our knowledge, there are few results for both the SFDE (1.1) and its numerical method on the infinite time horizon case.

The main contribution of Chapter 5 is to present the Freidlin–Wentzell LDP for the  $\theta$ -EM method of the SFDE with small noise on the infinite time horizon. A well-known approach to presenting the LDP, through its equivalence to the Laplace principle, is proposed by [27], where the finite time horizon case is considered. Such method is also known as the weak convergence method, and has further been developed to prove the LDP on the infinite time horizon (see [29]). The key in the analysis lies in establishing the compactness of solutions for both the skeleton equation and the stochastic controlled equation in Banach space  $C_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ . In this regard, by analyzing the time-independent moment estimats of the solution of the stochastic controlled equation, we prove that the  $\theta$ -EM solution satisfies the LDP on  $C_{\xi}([-\tau, +\infty); \mathbb{R}^d)$  with the rate function given by the corresponding skeleton equation. Moreover, combining the technique of the Malliavin calculus, we present the logarithmic estimate of the numerical density function and establish the relation between the logarithmic limit and the rate function of the LDP.

### Chapter $\mathbf{2}$

# Mean-square convergence analysis

In this chapter, we analyze the longtime mean-square convergence of the  $\theta$ -EM method (1.8) of the SFDE (1.1) with superlinearly growing coefficients. A prerequisite is to prove the time-independent moment boundedness of the numerical solution. Then we derive the exponential attractiveness and the exponential stability of the  $\theta$ -EM method. With these preparations, the time-independent mean-square convergence rate of the  $\theta$ -EM method is shown to be  $\frac{1}{2}$ .

# 2.1 Time-independent moment boundedness of numerical solution

In this section, we investigate the time-independent moment boundedness of the  $\theta$ -EM functional solution, which is the key to obtain the longtime mean-square convergence rate of the considered numerical method.

#### 2.1.1 Time-independent boundedness of second moment

This subsection is devoted to proving the time-independent boundedness of the second moment of the  $\theta$ -EM functional solution. Before that, we show that the *p*th moment for any p > 0 of the numerical solution in any finite time horizon is bounded, which ensures that the stochastic integral with respect to the numerical solution is a martingale.

For this purpose, we define an auxiliary process as follows:

$$\begin{cases} z^{\xi,\Delta}(t_k) = \xi(t_k), \quad k = -N, -N+1, \dots, -1, \\ z^{\xi,\Delta}(t_k) = y^{\xi,\Delta}(t_k) - \theta b(y^{\xi,\Delta}_{t_k})\Delta, \quad k = 0, \\ z^{\xi,\Delta}(t_k) = z^{\xi,\Delta}(t_{k-1}) + b(y^{\xi,\Delta}_{t_{k-1}})\Delta + \sigma(y^{\xi,\Delta}_{t_{k-1}})\delta W_{k-1}, \quad k \in \mathbb{N}_+. \end{cases}$$
(2.1)

The continuous version  $\{z^{\xi,\Delta}(t)\}_{t\geq -\tau}$  is given by

$$z^{\xi,\Delta}(t) = \begin{cases} z^{\xi,\Delta}(t_k) + b(y_{t_k}^{\xi,\Delta})(t-t_k) + \sigma(y_{t_k}^{\xi,\Delta})(W(t) - W(t_k)), & t \in [t_k, t_{k+1}), & k \in \mathbb{N}, \\ \frac{t_{j+1}-t}{\Delta} z^{\xi,\Delta}(t_j) + \frac{t-t_j}{\Delta} z^{\xi,\Delta}(t_{j+1}), & t \in [t_j, t_{j+1}], & j \in \{-N, \dots, -1\}. \end{cases}$$

We see clearly that

$$z^{\xi,\Delta}(t) = z^{\xi,\Delta}(0) + \int_0^t b(y_s^{\xi,\Delta}) ds + \int_0^t \sigma(y_s^{\xi,\Delta}) dW(s), \quad t > 0,$$
(2.2)

where

$$y_s^{\xi,\Delta} := \sum_{k=0}^{\infty} y_{t_k}^{\xi,\Delta} \mathbf{1}_{[t_k,t_{k+1})}(s).$$

Denote by  $\{z_t^{\xi,\Delta}\}_{t\geq 0}$  the segment process with respect to  $\{z^{\xi,\Delta}(t)\}_{t\geq -\tau}$ , namely, for any  $t\geq 0$  and  $r\in [-\tau,0]$ , we have  $z_t^{\xi,\Delta}(r)=z^{\xi,\Delta}(t+r)$ .

**Proposition 2.1** Under Assumptions 1.1 and 1.2, for any T > 0 and integer  $p \ge 2$ , it holds that

$$\sup_{\Delta \in (0,1]} \mathbb{E} \Big[ \sup_{t_k \in [0,T]} \left( |z^{\xi,\Delta}(t_k)|^{2p} + |y^{\xi,\Delta}(t_k)|^{2p} \right) \Big] \le K_T (1 + ||\xi||^{2p}),$$

where the positive constant  $K_T$  depends on p and T.

**Proof.** We divide the proof into two steps.

Step 1. We shall show that for any T > 0 and  $p \in \mathbb{N}_+$ ,

To simplify notations, we introduce the following abbreviations

$$\leq \frac{1}{4}\mathbb{E}\Big[\sup_{0 \leq t_{k} \leq \lfloor T \rfloor} |z(t_{k})|^{2p}\Big] + K\Delta(T^{\frac{p}{2}-1}+1)\sum_{k=0}^{\lfloor T \rfloor} \mathbb{E}[|y(t_{k})|^{2p}]$$

$$+ K(T^{\frac{p}{2}-1}+1)(1+||\xi||^{2p}). \qquad (2.20)$$

Plugging (2.18)–(2.20) into (2.17), a direct computation derives

$$\begin{split} & \mathbb{E} \Big[ \sup_{0 \le t_k \le T} |z(t_k)|^{2p} \Big] \\ & \le 2 \Big( K + K\Delta \sum_{k=0}^{\lfloor T \rfloor} \mathbb{E} [|z(t_k)|^{2p}] + K\Delta + K(T^{p-1} + 1)(1 + \|\xi\|^{2p}) \\ & \quad + K\Delta (T^{p-1} + 1) \sum_{k=0}^{\lfloor T \rfloor} \mathbb{E} [|y(t_k)|^{2p}] \Big) \\ & \le K(T^{p-1} + 1)(1 + \|\xi\|^{2p}) + K\Delta (\frac{T}{\Delta} + 1) \sup_{0 \le t_k \le T} \mathbb{E} [|z(t_k)|^{2p}] \\ & \quad + K\Delta (T^{p-1} + 1)(\frac{T}{\Delta} + 1) \sup_{0 \le t_k \le T} \mathbb{E} [|y(t_k)|^{2p}] \\ & \le K_T (1 + \|\xi\|^{2p}), \end{split}$$

where the positive constant  $K_T$  depends on T and p, but is independent of  $\Delta$ . From the above inequality and (2.15), one obtains that  $\mathbb{E}\left[\sup_{0 \le t_k \le T} |y(t_k)|^{2p}\right] \le K_T(1 + ||\xi||^{2p})$ . Thus the proof is completed.  $\square$ 

Proposition 2.2 Under Assumptions 1.1 and 1.2, it holds that  $\sup_{\Delta \in (0,1]} \sup_{k \ge 0} \mathbb{E} \left[ \|z_{t_k}^{\xi,\Delta}\|^2 + \|y_{t_k}^{\xi,\Delta}\|^2 \right] \le K(1 + \|\xi\|^2 + |b(\xi)|^2 \Delta^2).$ 

**Proof.** We divide the proof into two steps.

Step 1. We shall prove

$$\sup_{\Delta \in (0,1]} \sup_{k \ge -N} \left( \mathbb{E}[|z(t_k)|^2] + \mathbb{E}[|y(t_k)|^2] \right) \le K(1 + \|\xi\|^2 + |b(\xi)|^2 \Delta^2).$$

By  $a_1 > a_2 + L$ , one can choose a sufficiently small  $\kappa > 0$  such that

$$\tilde{c}_{\kappa} := \left(a_1 + a_2 - \left(\frac{a_1 - a_2 + L}{2} + 2a_2\right)e^{\kappa\tau}\right) > 0.$$

For any  $\Delta \in (0,1]$  and  $k \in \mathbb{N}$ , according to (2.4) and  $z(t_k) = y(t_k) - \theta b_k \Delta$ , we have

$$\begin{aligned} |z(t_{k+1})|^2 &\leq |z(t_k)|^2 + \frac{1-2\theta}{\theta^2} |y(t_k) - z(t_k)|^2 + |\sigma_k \delta W_k|^2 + K\Delta \\ &- \frac{3a_1 + a_2 + L}{2} \Delta |y(t_k)|^2 + 2a_2 \Delta \int_{-\tau}^0 |y_{t_k}(r)|^2 \mathrm{d}\nu_2(r) + \mathcal{M}_k \\ &= \frac{(1-\theta)^2}{\theta^2} |z(t_k)|^2 + \frac{1-2\theta}{\theta^2} |y(t_k)|^2 + \frac{2(2\theta-1)}{\theta^2} \langle z(t_k), y(t_k) \rangle + |\sigma_k \delta W_k|^2 \\ &+ K\Delta - \frac{3a_1 + a_2 + L}{2} \Delta |y(t_k)|^2 + 2a_2 \Delta \int_{-\tau}^0 |y_{t_k}(r)|^2 \mathrm{d}\nu_2(r) + \mathcal{M}_k, \end{aligned}$$

Applying the Young inequality yields

$$2\langle z(t_k), y(t_k) \rangle \leq \frac{1}{1 + \tilde{c}_{\kappa} \Delta} |z(t_k)|^2 + (1 + \tilde{c}_{\kappa} \Delta) |y(t_k)|^2.$$

Recall that  $\theta \in (0.5, 1]$ . Then we have

$$|z(t_{k+1})|^{2} \leq \left(\frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta - 1}{\theta^{2}(1+\tilde{c}_{\kappa}\Delta)}\right)|z(t_{k})|^{2} + |\sigma_{k}\delta W_{k}|^{2} + K\Delta - \left(\frac{3a_{1} + a_{2} + L}{2} - \tilde{c}_{\kappa}\right)\Delta|y(t_{k})|^{2} + 2a_{2}\Delta \int_{-\tau}^{0}|y_{t_{k}}(r)|^{2}d\nu_{2}(r) + \mathcal{M}_{k}.$$

Hence for any  $\varepsilon \in (0, \kappa]$ ,

$$e^{\varepsilon t_{k+1}} |z(t_{k+1})|^{2} = |z(0)|^{2} + \sum_{i=0}^{k} (e^{\varepsilon t_{i+1}} |z(t_{i+1})|^{2} - e^{\varepsilon t_{i}} |z(t_{i})|^{2})$$

$$\leq |z(0)|^{2} + \left(\frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta - 1}{\theta^{2}(1+\tilde{c}_{\kappa}\Delta)} - e^{-\varepsilon\Delta}\right) \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} |z(t_{i})|^{2} + \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} |\sigma_{i}\delta W_{i}|^{2}$$

$$+ K\Delta \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} - \left(\frac{3a_{1} + a_{2} + L}{2} - \tilde{c}_{\kappa}\right)\Delta \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} |y(t_{i})|^{2}$$

$$+ 2a_{2}\Delta \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} \int_{-\tau}^{0} |y_{t_{i}}(r)|^{2} \mathrm{d}\nu_{2}(r) + \sum_{i=0}^{k} e^{\varepsilon t_{i+1}} \mathcal{M}_{i}. \qquad (2.21)$$

According to Proposition 2.1 we obtain that  $\mathcal{M}_k$  is a martingale and

$$\mathbb{E}\Big[\sum_{i=0}^{k} e^{\varepsilon t_{i+1}} \mathcal{M}_i\Big] = 0.$$

Taking expectation on both sides of (2.21) and using Remark 1.1, we arrive at

$$e^{\varepsilon t_{k+1}} \mathbb{E}[|z(t_{k+1})|^2] \\ \leq |z(0)|^2 + \left(\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\tilde{c}_{\kappa}\Delta)} - e^{-\varepsilon\Delta}\right) \sum_{i=0}^k e^{\varepsilon t_{i+1}} \mathbb{E}[|z(t_i)|^2] + K\Delta \sum_{i=0}^k e^{\varepsilon t_{i+1}}$$

Mean-square convergence analysis

$$-(a_{1}+a_{2}-\tilde{c}_{\kappa})\Delta\sum_{i=0}^{k}e^{\varepsilon t_{i+1}}\mathbb{E}[|y(t_{i})|^{2}] + \frac{a_{1}-a_{2}+L}{2}\Delta\sum_{i=0}^{k}e^{\varepsilon t_{i+1}}\times \mathbb{E}\Big[\int_{-\tau}^{0}|y_{t_{i}}(r)|^{2}\mathrm{d}\nu_{1}(r)\Big] + 2a_{2}\Delta\sum_{i=0}^{k}e^{\varepsilon t_{i+1}}\mathbb{E}\Big[\int_{-\tau}^{0}|y_{t_{i}}(r)|^{2}\mathrm{d}\nu_{2}(r)\Big].$$
(2.22)

Similar to (2.12), one has

$$\frac{a_1 - a_2 + L}{2} \Delta \sum_{i=0}^k e^{\varepsilon t_{i+1}} \int_{-\tau}^0 |y_{t_i}(r)|^2 \mathrm{d}\nu_1(r) + 2a_2 \Delta \sum_{i=0}^k e^{\varepsilon t_{i+1}} \int_{-\tau}^0 |y_{t_i}(r)|^2 \mathrm{d}\nu_2(r)$$
  
$$\leq \left(\frac{a_1 - a_2 + L}{2} + 2a_2\right) e^{\varepsilon \tau} \tau \|\xi\|^2 + \left(\frac{a_1 - a_2 + L}{2} + 2a_2\right) e^{\varepsilon \tau} \Delta \sum_{i=0}^k e^{\varepsilon t_{i+1}} |y(t_i)|^2.$$

Inserting this into (2.22) yields

$$e^{\varepsilon t_{k+1}} \mathbb{E}[|z(t_{k+1})|^2]$$

$$\leq |z(0)|^2 + \left(\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\tilde{c}_{\kappa}\Delta)} - e^{-\varepsilon\Delta}\right) \sum_{i=0}^k e^{\varepsilon t_{i+1}} \mathbb{E}[|z(t_i)|^2] + \frac{K}{\varepsilon} e^{\varepsilon t_{k+2}}$$

$$- \left(a_1 + a_2 - \tilde{c}_{\kappa} - \left(\frac{a_1 - a_2 + L}{2} + 2a_2\right) e^{\varepsilon\tau}\right) \Delta \sum_{i=0}^k e^{\varepsilon t_{i+1}} \mathbb{E}[|y(t_i)|^2]$$

$$+ \left(\frac{a_1 - a_2 + L}{2} + 2a_2\right) e^{\varepsilon\tau} \tau \|\xi\|^2.$$

It follows from the definition of  $\tilde{c}_{\kappa}$  that

$$a_1 + a_2 - \tilde{c}_{\kappa} - (\frac{a_1 - a_2 + L}{2} + 2a_2)e^{\varepsilon\tau} \ge 0.$$

Moreover, using  $e^{-\varepsilon\Delta} > 1 - \varepsilon\Delta$ , we conclude that

$$\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\tilde{c}_{\kappa}\Delta)} - e^{-\varepsilon\Delta}$$

$$< \frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\tilde{c}_{\kappa}\Delta)} - (1-\varepsilon\Delta)$$

$$= -\frac{(2\theta-1)\tilde{c}_{\kappa}}{\theta^2(1+\tilde{c}_{\kappa}\Delta)}\Delta + \varepsilon\Delta < (\varepsilon - \frac{(2\theta-1)\tilde{c}_{\kappa}}{\theta^2(1+\tilde{c}_{\kappa})})\Delta.$$
(2.23)

Hence, letting  $\varepsilon = \frac{(2\theta - 1)\tilde{c}_{\kappa}}{\theta^2(1 + \tilde{c}_{\kappa})} \wedge \kappa$  yields

$$(1 + \theta \Delta \frac{3a_1 + a_2 + L}{2}) \sup_{\Delta \in (0,1]} \sup_{k \ge -N} \mathbb{E}[|y(t_k)|^2]$$
  
$$\leq K\Delta + \sup_{\Delta \in (0,1]} \sup_{k \ge -N} \mathbb{E}[|z(t_k)|^2] + 2a_2\theta \Delta \sup_{\Delta \in (0,1]} \sup_{k \ge -N} \mathbb{E}[|y(t_k)|^2].$$
(2.24)

Together with  $a_1 > a_2 + L$ , we arrive at

$$\sup_{\Delta \in (0,1]} \sup_{k \ge -N} \mathbb{E}[|y(t_k)|^2] \le K(1 + \|\xi\|^2 + |b(\xi)|^2 \Delta^2).$$

Step 2. It follows from (2.21) that

$$\mathbb{E}\left[\sup_{(k-N)\vee 0\leq i\leq k} e^{\varepsilon t_{i+1}} |z(t_{i+1})|^{2}\right]$$

$$\leq |z(0)|^{2} + K||\xi||^{2} + \mathbb{E}\left[\sup_{(k-N)\vee 0\leq i\leq k} \sum_{l=0}^{i} e^{\varepsilon t_{l+1}} |\sigma_{l}\delta W_{l}|^{2}\right] + K\Delta \sum_{i=0}^{k} e^{\varepsilon t_{i+1}}$$

$$+ \mathbb{E}\left[\sup_{(k-N)\vee 0\leq i\leq k} \sum_{l=0}^{i} e^{\varepsilon t_{l+1}} \mathcal{M}_{l}\right]$$

$$\leq |z(0)|^{2} + K||\xi||^{2} + \Delta \mathbb{E}\left[\sum_{l=0}^{k} e^{\varepsilon t_{l+1}} |\sigma_{l}|^{2}\right] + \frac{K}{\varepsilon} e^{\varepsilon t_{k+2}}$$

$$+ \mathbb{E}\left[\sup_{(k-N)\vee 0\leq i\leq k} \sum_{l=(k-N)\vee 0}^{i} e^{\varepsilon t_{l+1}} \mathcal{M}_{l}\right].$$
(2.25)

Using Assumption 1.1 and <u>Step 1</u>, we obtain

$$\Delta \mathbb{E} \Big[ \sum_{l=0}^{k} e^{\varepsilon t_{l+1}} |\sigma_l|^2 \Big] \leq K \Big( \Delta \sum_{l=0}^{k} e^{\varepsilon t_{l+1}} \mathbb{E} \Big[ |y(t_l)|^2 + \int_{-\tau}^{0} |y_{t_l}(r)|^2 \mathrm{d}\nu_1(r) \Big] + e^{\varepsilon t_{k+2}} \Big)$$
  
$$\leq K \Big( \Delta \sup_{i \geq -N} \mathbb{E} [|y(t_i)|^2] \sum_{l=0}^{k} e^{\varepsilon t_{l+1}} + e^{\varepsilon t_{k+2}} \Big)$$
  
$$\leq K (1 + \|\xi\|^2 + |b(\xi)|^2 \Delta^2) e^{\varepsilon t_{k+2}}.$$
(2.26)

Similar to the estimates of  $I_2$  and  $I_3$  in Proposition 2.1, one has

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0 \leq i \leq k} \sum_{l=(k-N)\vee 0}^{i} e^{\varepsilon t_{l+1}} \mathcal{M}_{l}\Big] \\
\leq \mathbb{E}\Big[\Big(\Big(\sup_{(k-N)\vee 0 \leq i \leq k} e^{\varepsilon t_{i}} |z(t_{i})|^{2}\Big) (Ke^{\varepsilon \Delta} \Delta \sum_{l=(k-N)\vee 0}^{k} e^{\varepsilon t_{l+1}} |\sigma_{l}|^{2})\Big)^{\frac{1}{2}}\Big] \\
+ \mathbb{E}\Big[\Big(\Big(\sup_{(k-N)\vee 0 \leq i \leq k} e^{\varepsilon t_{i}} |y(t_{i})|^{2}\Big) (Ke^{\varepsilon \Delta} \Delta \sum_{l=(k-N)\vee 0}^{k} e^{\varepsilon t_{l+1}} |\sigma_{l}|^{2})\Big)^{\frac{1}{2}}\Big] \\

\leq \frac{1}{2}\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq i\leq k}e^{\varepsilon t_{i+1}}|z(t_{i+1})|^{2}\Big] + K(1+\|\xi\|^{2}+|b(\xi)|^{2}\Delta^{2})e^{\varepsilon t_{k+2}}.$$

Substituting (2.26) and (2.29) into (2.25) we deduce

Combining (2.28), we finishes the proof.  $\Box$ 

#### 2.1.2 Time-independent boundedness of high-order moment

For the SFDE (1.1) with superlinearly growing coefficients, the time-independent boundedness of high-order moment of the numerical solution is required in the longtime meansquare convergence analysis of numerical method. We introduce the following assumptions on the coefficient b and the initial value  $\xi$ . **Assumption 2.1** There exist positive constants  $K, a_3, a_4, \ell$ , and a function  $\nu_2 \in \mathcal{P}$  such that for any  $\phi \in C^d$ ,

$$\langle \phi(0), b(\phi) \rangle \le K - a_3 |\phi(0)|^{2+\ell} + a_4 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r)$$

**Assumption 2.2** There exist positive constants K and  $\beta$  such that for any  $\phi_1, \phi_2 \in C^d$ ,

$$|b(\phi_1) - b(\phi_2)| \le K ||\phi_1 - \phi_2|| (1 + ||\phi_1||^\beta + ||\phi_2||^\beta).$$

**Assumption 2.3** There exist positive constants K and  $\rho \ge 1/2$  such that

$$|\xi(s_1) - \xi(s_2)| \le K |s_1 - s_2|^{\rho}.$$

The following lemma shows that the moments of functional solution of (1.1) are bounded uniformly for  $t \ge 0$ , whose proof is similar to that of [46, Theorem 3] and is omitted.

**Lemma 2.1** Under Assumptions 1.1 and 2.1, the following estimate holds: for integer  $p \geq 2$ ,

$$\sup_{t \ge 0} \mathbb{E}[\|x^{\xi}(t)\|^{p}] \le K(1 + \|\xi\|^{p}).$$
(2.30)

Moreover, the invariant measure  $\mu$  given in Lemma 1.2 satisfies

$$\mu(\|\cdot\|^p) := \int_{\mathcal{C}^d} \|\phi\|^p \mathrm{d}\mu(\phi) \le K.$$
(2.31)

**Lemma 2.2** Under Assumptions 1.1, 2.1, and 2.2, for integer  $p \ge 2$ , it holds that

$$\sup_{\Delta \in (0,1]} \sup_{k \ge -N} (\mathbb{E}[|z^{\xi,\Delta}(t_k)|^p] + \mathbb{E}[|y^{\xi,\Delta}(t_k)|^p]) \le K(1 + \|\xi\|^{p(\beta+1)}).$$

**Proof.** We divide the proof into three steps.

Step 1. We shall show that there exists  $\Delta^* \in (0, 1)$  such that

$$\mathbb{E}[I_{i}] \leq 6\kappa_{1}A_{\theta,\Delta}^{p}\mathbb{E}[|z(t_{k})|^{2p}] + R(\kappa_{1})\Delta + R(\kappa_{1})\Delta^{p}\mathbb{E}[|y(t_{k})|^{2p}] \\ + \frac{(12a_{4}\Delta)^{p}}{\kappa_{1}^{p-i}}\mathbb{E}\Big[\int_{-\tau}^{0}|y_{t_{k}}(r)|^{2p}\mathrm{d}\nu_{2}(r)\Big] \\ + \frac{(24L)^{2p}\Delta^{p}}{\kappa_{1}^{2p-i}}\mathbb{E}\Big[\int_{-\tau}^{0}|y_{t_{k}}(r)|^{2p}\mathrm{d}\nu_{1}(r)\Big] + \frac{24^{p}\Delta}{\kappa_{1}^{p-i}}(1+(2L)^{2p})\mathbb{E}[|y(t_{k})|^{2p}] \\ + \frac{24^{p}(2L)^{2p}\Delta}{\kappa_{1}^{p-i}}\mathbb{E}\Big[\int_{-\tau}^{0}|y_{t_{k}}(r)|^{2p}\mathrm{d}\nu_{1}(r)\Big] \quad \forall i \in \{2,\ldots,p\}.$$

$$\leq e^{\varepsilon t_{(k-N)\vee 0}} \mathbb{E}[|z(t_{(k-N)\vee 0})|^{2p}] + \frac{1}{2} \mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k} e^{\varepsilon t_{j+1}} |z(t_{j+1})|^{2p}\Big] \\ + K(\tau+1)^{p-1} \Delta \sum_{l=(k-N)\vee 0}^{k} e^{\varepsilon t_{l+1}} \mathbb{E}[|\sigma_l|^{2p}] + K(\tau+1)^{\frac{p}{2}-1} \Delta \sum_{l=(k-N)\vee 0}^{k} e^{\varepsilon t_{l+1}} \mathbb{E}[|y(t_l)|^{2p}].$$

According to Assumption 1.1, Lemma 2.2, and (2.51), we deduce

$$p\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}\sum_{l=(k-N)\vee 0}^{j}e^{\varepsilon t_{l+1}}A_{\theta,\Delta}^{p-1}|z(t_{l})|^{2(p-1)}\mathcal{M}_{l}\Big]$$

$$\leq K(1+\|\xi\|^{2p(\beta+1)})e^{\varepsilon t_{k+1}}+\frac{1}{2}\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}e^{\varepsilon t_{j+1}}|z(t_{j+1})|^{2p}\Big]$$

$$+K\Delta\sum_{l=(k-N)\vee 0}^{k}e^{\varepsilon t_{l+1}}\mathbb{E}\Big[|y(t_{l})|^{2p}+\int_{-\tau}^{0}|y_{t_{l}}(r)|^{2p}d\nu_{1}(r)\Big]$$

$$\leq K(1+\|\xi\|^{2p(\beta+1)})e^{\varepsilon t_{k+1}}+\frac{1}{2}\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}e^{\varepsilon t_{j+1}}|z(t_{j+1})|^{2p}\Big]$$

$$+K\sup_{j\geq -N}\mathbb{E}[|y_{t_{j}}(r)|^{2p}]\sum_{l=(k-N)\vee 0}^{k}e^{\varepsilon t_{l+1}}\Delta$$

$$\leq K(1+\|\xi\|^{2p(\beta+1)})e^{\varepsilon t_{k+2}}+\frac{1}{2}\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}e^{\varepsilon t_{j+1}}|z(t_{j+1})|^{2p}\Big]. \tag{2.58}$$

Inserting (2.57) and (2.58) into (2.56) yields

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0 \le j \le k} e^{\varepsilon t_{j+1}} |z(t_{j+1})|^{2p}\Big] \le K_{\varepsilon_1}(1 + \|\xi\|^{2p(\beta+1)}) e^{\varepsilon t_{k+2}}$$

This implies that for any  $\Delta \in (0, \Delta^*]$ ,

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k} |z(t_{j+1})|^{2p}\Big] \leq e^{-\varepsilon t_{(k-N)\vee 0+1}} K_{\varepsilon_1}(1+\|\xi\|^{2p(\beta+1)}) e^{\varepsilon t_{k+2}}$$
$$\leq K(1+\|\xi\|^{2p(\beta+1)}).$$

<u>Case 2</u>:  $\Delta \in [\Delta^*, 1]$ . Similar arguments to <u>Case 1</u> yield that for any  $\Delta \in [\Delta^*, 1]$ ,

$$e^{\kappa t_{k+1}} |z(t_{k+1})|^{2p} \leq |z(0)|^{2p} + \sum_{l=0}^{k} \left( (1 + 3p\kappa_1 + 5\kappa_1 \sum_{i=2}^{p} C_p^i) A_{\theta,\Delta}^p e^{\kappa \Delta} - 1 \right) e^{\kappa t_l} |z(t_l)|^{2p} + \sum_{l=0}^{k} e^{\kappa t_{l+1}} \tilde{J}_{l,2} + p \sum_{l=0}^{k} A_{\theta,\Delta}^{p-1} |z(t_l)|^{2(p-1)} \mathcal{M}_l,$$
(2.59)

where

$$\begin{split} \tilde{J}_{l,2} &:= 5^p \Delta^p \sum_{i=1}^p \frac{C_p^i}{\varepsilon_1^{p-i}} \Big( R_1^p + (2a_4)^p \int_{-\tau}^0 |y_{t_l}(r)|^{2p} \mathrm{d}\nu_2(r) \Big) + 5^p \sum_{i=1}^p \frac{C_p^i}{\varepsilon_1^{p-i}} |\sigma_l \delta W_l|^{2p} \\ &+ 5^p \sum_{i=2}^p \frac{C_p^i}{\varepsilon_1^{p-i}} (4|y(t_l)| |\sigma_l \delta W_l|)^p + \sum_{i=2}^p \frac{C_p^i (10|\sigma_l \delta W_l|)^{2p}}{\varepsilon_1^{2p-i}}. \end{split}$$

Similar to (2.57) and (2.58), we derive

$$\mathbb{E}\Big[\sum_{l=0}^{k} e^{\kappa t_{l+1}} \tilde{J}_{l,2}\Big] \le K_{\kappa_1} (1 + \|\xi\|^{2p(\beta+1)}) \frac{e^{\kappa t_{k+2}}}{\kappa},$$

$$p\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}\sum_{l=(k-N)\vee 0}^{j} A_{\theta,\Delta}^{p-1}|z(t_{l})|^{2(p-1)}\mathcal{M}_{l}\Big]$$
  
$$\leq K_{\kappa_{1}}(1+\|\xi\|^{2p(\beta+1)})\frac{e^{\kappa t_{k+2}}}{\kappa}+\frac{1}{2}\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq j\leq k}e^{\kappa t_{j+1}}|z(t_{j+1})|^{2p}\Big].$$

Plugging these into (2.59), and combining (2.47), we have

$$e^{\kappa t_{k+1}} |z(t_{k+1})|^{2p}$$

$$\leq |z(0)|^{2p} + \sum_{l=0}^{k} (1+2^{p} \cdot 6\kappa_{1}) A^{p}_{\theta,\Delta^{*}} e^{\kappa \Delta} - 1) e^{\kappa t_{l}} |z(t_{l})|^{2p}$$

$$+ K(1+\|\xi\|^{2p(\beta+1)}) \frac{e^{\kappa t_{k+2}}}{\kappa} + K e^{\kappa t_{k+2}} + \frac{1}{2} \Big( \sup_{(k-N)\vee 0 \leq j \leq k} e^{\kappa t_{j+1}} |z(t_{j+1})|^{2p} \Big)$$

$$\leq K(1+\|\xi\|^{2p(\beta+1)}) \frac{e^{\kappa t_{k+2}}}{\kappa} + \frac{1}{2} \Big( \sup_{(k-N)\vee 0 \leq j \leq k} e^{\kappa t_{j+1}} |z(t_{j+1})|^{2p} \Big).$$

This implies that for any  $\Delta \in [\Delta^*, 1]$ ,

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0 \le j \le k} |z(t_{j+1})|^{2p}\Big] \le K(1+\|\xi\|^{2p(\beta+1)}).$$

Consequently,

$$\sup_{\Delta \in (0,1]} \sup_{k \ge 0} \mathbb{E} \Big[ \sup_{k-N \le j \le k} |z(t_{j+1})|^{2p} \Big] \le K(1 + \|\xi\|^{2p(\beta+1)}).$$
(2.60)

In addition, by virtue of (2.35), (2.51), and (2.60), we obtain that for any  $\Delta \in (0, 1]$ ,

$$\begin{split} & \mathbb{E}\Big[\sup_{(k-N)\vee 0 \le j \le k} |y(t_j)|^{2p}\Big] \\ & \le K \mathbb{E}\Big[\sup_{(k-N)\vee 0 \le j \le k} |z(t_j)|^{2p}\Big] + K\Delta + K\Delta \mathbb{E}\Big[\sup_{(k-N)\vee 0 \le j \le k} \int_{-\tau}^{0} |y_{t_j}(r)|^{2p} d\nu_2 \\ & \le K(1+\|\xi\|^{2p(\beta+1)}) + K\Delta \mathbb{E}\Big[\sup_{(k-2N)\vee (-N)\le j \le k} |y(t_j)|^{2p}\Big] \\ & \le K(1+\|\xi\|^{2p(\beta+1)}) + K\Delta \cdot (2N) \sup_{k\ge -N} \mathbb{E}[|y(t_k)|^{2p}] \le K(1+\|\xi\|^{2p(\beta+1)}). \end{split}$$

The proof is finished.

**Lemma 2.3** Let Assumptions 1.1–1.2, 2.1–2.3 hold. Then for any  $\Delta \in (0,1]$  and  $p \ge 1$ ,

$$\sup_{t \in [0,\infty)} \mathbb{E}[\|z_t^{\xi,\Delta} - y_t^{\xi,\Delta}\|^p] \le K(1 + \|\xi\|^{p(1+\beta)^2})\Delta^{\frac{p}{2}} \quad \forall \xi \in \mathcal{C}^d.$$

**Proof.** For any  $t \ge 0$  and  $r \in [-\tau, 0]$ , there exist  $k \in \mathbb{N}$  and  $j \in \{-N, -N+1, \ldots, -1\}$  such that  $t \in [t_k, t_{k+1})$  and  $r \in [t_j, t_{j+1}]$ . It is straightforward to see that

$$t+r \in [t_{k+j}, t_{k+j+2}), \quad t_k+r \in [t_{k+j}, t_{k+j+1}).$$

Recall  $z_t^{\xi,\Delta}(r) = z^{\xi,\Delta}(t+r)$  and  $y_t^{\xi,\Delta}(r) = y_{t_k}^{\xi,\Delta}(r) = y^{\xi,\Delta}(t_k+r)$ . We first give estimates of  $|z_t^{\xi,\Delta}(r) - y_t^{\xi,\Delta}(r)|$ , whose proof is divided into four cases.

<u>Case 1:</u>  $t + r \in [t_{k+j}, t_{k+j+1}) \in [0, \infty)$ . By (1.9) and (2.2), we derive

$$\begin{split} z_t^{\xi,\Delta}(r) &- y_t^{\xi,\Delta}(r) = z^{\xi,\Delta}(t+r) - y_{t_k}^{\xi,\Delta}(r) \\ &= z^{\xi,\Delta}(t_{k+j}) + b(y_{t_{k+j}}^{\xi,\Delta})(t+r-t_{k+j}) + \sigma(y_{t_{k+j}}^{\xi,\Delta})(W(t+r) - W(t_{k+j})) \\ &- (\frac{t_{j+1}-r}{\Delta}y^{\xi,\Delta}(t_{k+j}) + \frac{r-t_j}{\Delta}y^{\xi,\Delta}(t_{k+j+1})) \\ &= \frac{t_{j+1}-r}{\Delta}(z^{\xi,\Delta}(t_{k+j}) - y^{\xi,\Delta}(t_{k+j})) + \frac{r-t_j}{\Delta}(z^{\xi,\Delta}(t_{k+j}) - y^{\xi,\Delta}(t_{k+j+1})) \\ &+ b(y_{t_{k+j}}^{\xi,\Delta})(t+r-t_{k+j}) + \sigma(y_{t_{k+j}}^{\xi,\Delta})(W(t+r) - W(t_{k+j})). \end{split}$$

Combining  $z^{\xi,\Delta}(t_l) = y^{\xi,\Delta}(t_l) - \theta b(y_{t_l}^{\xi,\Delta})\Delta$  for all  $l \in \mathbb{N}$  yields

$$\begin{split} z_t^{\xi,\Delta}(r) &- y_t^{\xi,\Delta}(r) \\ = -\frac{t_{j+1} - r}{\Delta} \theta b(y_{t_{k+j}}^{\xi,\Delta}) \Delta - \frac{r - t_j}{\Delta} \theta b(y_{t_{k+j+1}}^{\xi,\Delta}) \Delta + \frac{r - t_j}{\Delta} (z^{\xi,\Delta}(t_{k+j}) - z^{\xi,\Delta}(t_{k+j+1})) \\ &+ b(y_{t_{k+j}}^{\xi,\Delta})(t + r - t_{k+j}) + \sigma(y_{t_{k+j}}^{\xi,\Delta})(W(t + r) - W(t_{k+j})) \\ = -\frac{t_{j+1} - r}{\Delta} \theta b(y_{t_{k+j}}^{\xi,\Delta}) \Delta - \frac{r - t_j}{\Delta} \theta b(y_{t_{k+j+1}}^{\xi,\Delta}) \Delta + b(y_{t_{k+j}}^{\xi,\Delta})(t - t_k) \\ &+ \sigma(y_{t_{k+j}}^{\xi,\Delta}) (W(t + r) - W(t_{k+j}) - \frac{r - t_j}{\Delta} (W(t_{k+j+1}) - W(t_{k+j})). \end{split}$$

This implies that for any  $p \ge 1$ ,

$$|z_{t}^{\xi,\Delta}(r) - y_{t}^{\xi,\Delta}(r)|^{p} \leq K\Delta^{p} (|b(y_{t_{k+j}}^{\xi,\Delta})|^{p} + |b(y_{t_{k+j+1}}^{\xi,\Delta})|^{p}) + K |\sigma(y_{t_{k+j}}^{\xi,\Delta}) (W(t+r) - W(t_{k+j}))|^{p} + K |\sigma(y_{t_{k+j}}^{\xi,\Delta}) (W(t_{k+j+1}) - W(t_{k+j}))|^{p}.$$

$$\underbrace{ \text{Case 2: } t+r \in [t_{k+j}, t_{k+j+1}) \in [-\tau, 0].}_{|z_t^{\xi, \Delta}(r) - y_t^{\xi, \Delta}(r)|^p} = |\frac{t_{k+j+1} - (t+r)}{\Delta} \xi(t_{k+j}) + \frac{t+r - t_{k+j}}{\Delta} \xi(t_{k+j+1}) \\ - \frac{t_{j+1} - r}{\Delta} \xi(t_{k+j}) - \frac{r - t_j}{\Delta} \xi(t_{k+j+1})|^p \\ = \frac{t - t_k}{\Delta} |\xi(t_{k+j+1}) - \xi(t_{k+j})|^p \le K^p \Delta^{\frac{p}{2}},$$

where we used Assumption 2.3.

Case 3: 
$$t + r \in [t_{k+j+1}, t_{k+j+2}) \in [0, \infty)$$
. Similar to Case 1, we obtain

$$\begin{split} &|z_{t}^{\xi,\Delta}(r) - y_{t}^{\xi,\Delta}(r)|^{p} \\ &= |z^{\xi,\Delta}(t_{k+j+1}) + b(y_{t_{k+j+1}}^{\xi,\Delta})(t+r-t_{k+j+1}) + \sigma(y_{t_{k+j+1}}^{\xi,\Delta})(W(t+r) - W(t_{k+j+1}))) \\ &- (\frac{t_{j+1}-r}{\Delta}y^{\xi,\Delta}(t_{k+j}) + \frac{r-t_{j}}{\Delta}y^{\xi,\Delta}(t_{k+j+1}))|^{p} \\ &\leq K\Delta^{p}|b(y_{t_{k+j+1}}^{\xi,\Delta})|^{p} + K|\sigma(y_{t_{k+j+1}}^{\xi,\Delta})(W(t+r) - W(t_{k+j+1}))|^{p} + K|z^{\xi,\Delta}(t_{k+j+1}) \\ &- y^{\xi,\Delta}(t_{k+j+1})|^{p} + K|z^{\xi,\Delta}(t_{k+j+1}) - z^{\xi,\Delta}(t_{k+j})|^{p} + K|z^{\xi,\Delta}(t_{k+j}) - y^{\xi,\Delta}(t_{k+j+1})|^{p} \\ &\leq K\Delta^{p}(|b(y_{t_{k+j}}^{\xi,\Delta})|^{p} + |b(y_{t_{k+j+1}}^{\xi,\Delta})|^{p}) + K|\sigma(y_{t_{k+j+1}}^{\xi,\Delta})(W(t+r) - W(t_{k+j+1}))|^{p} \end{split}$$

$$+ K|z^{\xi,\Delta}(t_{k+j+1}) - z^{\xi,\Delta}(t_{k+j})|^{p} (\mathbf{1}_{\{t_{k+j+1>0}\}} + \mathbf{1}_{\{t_{k+j+1=0}\}})$$

$$\leq K\Delta^{p} (|b(y^{\xi,\Delta}_{t_{k+j}\vee 0})|^{p} + |b(y^{\xi,\Delta}_{t_{k+j+1}})|^{p} + |b(\xi)|^{p}) + K|\sigma(y^{\xi,\Delta}_{t_{k+j+1}}) (W(t+r) - W(t_{k+j+1}))|^{p}$$

$$+ K|\sigma(y^{\xi,\Delta}_{t_{k+j}}) (W(t_{k+j+1}) - W(t_{k+j}))|^{p} \mathbf{1}_{\{t_{k+j+1>0}\}} + K\Delta^{\frac{p}{2}},$$

where we used Assumption 2.3.

$$\frac{\text{Case 4: } t+r \in [t_{k+j+1}, t_{k+j+2}) \in [-\tau, 0).}{|z_t^{\xi, \Delta}(r) - y_t^{\xi, \Delta}(r)|^p} \leq K\Delta^{\frac{p}{2}}.$$

Together with the above cases, we have

$$\mathbb{E}\Big[\sup_{r\in[-\tau,0]} |z_t^{\xi,\Delta}(r) - y_t^{\xi,\Delta}(r)|^p\Big] \\
\leq K(1 + \|\xi\|^{p(1+\beta)})\Delta^{\frac{p}{2}} + K(I_1 + I_2 + I_3),$$
(2.61)

where

$$\begin{split} I_{1} &:= \mathbb{E}\Big[\sup_{j \in \{-N, \dots, -1\}} \left( |b(y_{t_{k+j} \vee 0}^{\xi, \Delta})|^{p} \Delta^{p} + |b(y_{t_{k+j+1} \vee 0}^{\xi, \Delta})|^{p} \Delta^{p}) \Big], \\ I_{2} &:= \mathbb{E}\Big[\sup_{j \in \{-N, \dots, -1\}} \sup_{r \in [t_{j}, t_{j+1}]} |\sigma(y_{t_{k+j+1} \vee 0}^{\xi, \Delta}) \left(W(t+r) - W(t_{k+j+1})\right)|^{p} \times \\ & \mathbf{1}_{\{t+r \in [t_{k+j+1}, t_{k+j+2})\}} \Big], \\ I_{3} &:= \mathbb{E}\Big[\sup_{j \in \{-N, \dots, -1\}} |\sigma(y_{t_{k+j} \vee 0}^{\xi, \Delta}) \left(W(t_{k+j+1} \vee 0) - W(t_{k+j} \vee 0)\right)|^{p} \Big]. \end{split}$$

It follows from Assumption 2.2 that

$$I_{1} \leq 2\Delta^{p} \mathbb{E}\Big[\sup_{j \in \{-N,...,0\}} |b(y_{t_{k+j} \vee 0}^{\xi,\Delta})|^{p}\Big] \leq K\Delta^{p} \mathbb{E}\Big[\sup_{j \in \{-N,...,0\}} (1 + \|y_{t_{k+j} \vee 0}^{\xi,\Delta}\|^{p(\beta+1)})\Big].$$

Since

$$\sup_{j \in \{-N,...,0\}} \|y_{t_{k+j}}^{\xi,\Delta}\| \le \|y_{t_{k-N}}^{\xi,\Delta}\| + \|y_{t_k}^{\xi,\Delta}\|,$$

by (2.52), we have

$$I_{1} \leq K\Delta^{p}\mathbb{E}[1 + \|\xi\|^{p(\beta+1)} + \|y_{t_{k-N}}^{\xi,\Delta}\|^{p(1+\beta)} + \|y_{t_{k}}^{\xi,\Delta}\|^{p(1+\beta)}] \leq K(1 + \|\xi\|^{p(1+\beta)^{2}})\Delta^{p}.$$
(2.62)

Applying the Hölder inequality yields

$$I_{2} \leq \left( \mathbb{E} \Big[ \sup_{j \in \{-N,\dots,-1\}} |\sigma(y_{t_{k+j+1}\vee 0}^{\xi,\Delta})|^{2p} \Big] \Big)^{\frac{1}{2}} \Big( \mathbb{E} \Big[ \sup_{s_{1}-s_{2}\in[0,\Delta]} |W(s_{1})-W(s_{2})|^{2p} \Big] \Big)^{\frac{1}{2}}.$$

Similar to (2.62), by virtue of Assumption 1.1 and (2.52), we arrive at

$$I_2 \le K(1 + \|\xi\|^{p(\beta+1)}) \Big( \mathbb{E}\Big[\sup_{s_1 - s_2 \in [0,\Delta]} |W(s_1) - W(s_2)|^{2p} \Big] \Big)^{\frac{1}{2}}.$$

Applying the Burkholder–Davis–Gundy inequality, we obtain

$$I_2 \le K(1 + \|\xi\|^{p(\beta+1)})\Delta^{\frac{p}{2}}.$$
(2.63)

Similarly,

$$I_3 \le K(1 + \|\xi\|^{p(\beta+1)})\Delta^{\frac{p}{2}}.$$
(2.64)

The desired argument follows from (2.61)–(2.64). The proof is completed.  $\hfill \Box$ 

# 2.2 Attractiveness and stability of numerical solution

In this subsection, we reveal that numerical solutions of the  $\theta$ -EM method can inherit the the exponential attractiveness and the exponential stability of the exact ones.

**Proposition 2.4** Under Assumptions 1.1 and 1.2, for any  $\Delta \in (0,1]$  and  $k \in \mathbb{N}$ , one has

$$\mathbb{E}[\|y_{t_k}^{\xi,\Delta} - y_{t_k}^{\eta,\Delta}\|^2] \le K \Big( |b(\xi) - b(\eta)|^2 + \|\xi - \eta\|^2 \Big) e^{-\lambda_0 t_k} \quad \forall \, \xi, \eta \in \mathcal{C}^d,$$

where  $\lambda_0 \in (0, \frac{(2\theta-1)c_{\lambda}}{\theta^2} \wedge \lambda).$ 

**Proof.** Fix  $\xi, \eta \in C^d$ ,  $\Delta \in (0, 1]$ ,  $k \in \mathbb{N}$ , and  $\lambda_0 \in (0, \lambda]$ , where  $\lambda$  satisfies (1.6). Similar to Step 1 in Proposition 2.2, and using Assumptions 1.1 and 1.2, we deduce

$$e^{\lambda_{0}t_{k+1}}\mathbb{E}[|z^{\xi,\Delta}(t_{k+1}) - z^{\eta,\Delta}(t_{k+1})|^{2}]$$

$$\leq |z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^{2} + (L + 2a_{2})\tau e^{\lambda_{0}\tau}||\xi - \eta||^{2}$$

$$+ (\frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta - 1}{\theta^{2}(1+c_{\lambda}\Delta)} - e^{-\lambda_{0}\Delta})\sum_{i=0}^{k} e^{\lambda_{0}t_{i+1}}\mathbb{E}[|z^{\xi,\Delta}(t_{i}) - z^{\eta,\Delta}(t_{i})|^{2}]$$

$$- (2a_{1} - L - c_{\lambda} - (L + 2a_{2})e^{\lambda_{0}\tau})\Delta\sum_{i=0}^{k} e^{\lambda_{0}t_{i+1}}\mathbb{E}[|y^{\xi,\Delta}(t_{i}) - y^{\eta,\Delta}(t_{i})|^{2}].$$

It follows from (1.6) that

$$2a_1 - L - c_\lambda - (L + 2a_2)e^{\lambda_0 \tau} > 0.$$

Similar to (2.23), we obtain

$$\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+c_\lambda\Delta)} - e^{-\lambda_0\Delta} < (\lambda_0 - \frac{(2\theta-1)c_\lambda}{\theta^2(1+c_\lambda)})\Delta$$

Letting  $\lambda_0 \in (0, \frac{(2\theta-1)c_{\lambda}}{\theta^2(1+c_{\lambda})} \wedge \lambda]$ , we have

$$\mathbb{E}[|z^{\xi,\Delta}(t_k) - z^{\eta,\Delta}(t_k)|^2] \le (1 \vee ((L+2a_2)\tau e^{\lambda_0 \tau}))(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2)e^{-\lambda_0 t_k}.$$
(2.65)

Next, we shall show that  $\{y^{\cdot,\Delta}(t_k)\}_{k\in\mathbb{N}}$  has the similar property by the induction argument. In fact, it follows from  $z^{\xi,\Delta}(t_k) = y^{\xi,\Delta}(t_k) - \theta b(y_{t_k}^{\xi,\Delta})\Delta$  and Assumption 1.2 that

$$(1+2a_{1}\theta\Delta)|y^{\xi,\Delta}(t_{k})-y^{\eta,\Delta}(t_{k})|^{2} \leq |z^{\xi,\Delta}(t_{k})-z^{\eta,\Delta}(t_{k})|^{2}+2a_{2}\theta\Delta\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{k}}(r)-y^{\eta,\Delta}_{t_{k}}(r)|^{2}\mathrm{d}\nu_{2}(r).$$
(2.66)

By virtue of (1.9), we arrive at

$$(1+2a_1\theta\Delta)\mathbb{E}[|y^{\xi,\Delta}(t_k)-y^{\eta,\Delta}(t_k)|^2] \leq \mathbb{E}[|z^{\xi,\Delta}(t_k)-z^{\eta,\Delta}(t_k)|^2] + 2a_2\theta\Delta\int_{-\Delta}^0\frac{r+\Delta}{\Delta}\mathrm{d}\nu_2(r)\mathbb{E}[|y^{\xi,\Delta}(t_k)-y^{\eta,\Delta}(t_k)|^2]$$

Mean-square convergence analysis

$$+2a_2\theta\Delta\Big(\nu_2([-\tau,-\Delta])+\int_{-\Delta}^0\frac{-r}{\Delta}\mathrm{d}\nu_2(r)\Big)\sup_{k-N\leq l\leq k-1}\mathbb{E}[|y^{\xi,\Delta}(t_l)-y^{\eta,\Delta}(t_l)|^2].$$
 (2.67)

For k = 1, according to  $a_2 e^{\lambda_0 \tau} < a_1$  and (2.66), we derive

$$\left(1 + 2a_1\theta\Delta\left(1 - \int_{-\Delta}^0 \frac{r+\Delta}{\Delta} \mathrm{d}\nu_2(r)\right)\right) \mathbb{E}[|y^{\xi,\Delta}(t_1) - y^{\eta,\Delta}(t_1)|^2]$$

$$\leq \mathbb{E}[|z^{\xi,\Delta}(t_1) - z^{\eta,\Delta}(t_1)|^2] + 2a_2\theta\Delta(\nu_2([-\tau, -\Delta]) + \int_{-\Delta}^0 \frac{-r}{\Delta} \mathrm{d}\nu_2(r))\|\xi - \eta\|^2$$

$$\leq \left(1 + 2a_2\theta\Delta\left(1 - \int_{-\Delta}^0 \frac{r+\Delta}{\Delta} \mathrm{d}\nu_2(r)\right)\right) \left(1 \vee \left((L + 2a_2)\tau e^{\lambda_0\tau}\right)\right)$$

$$\times \left(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2\right) e^{-\lambda_0 t_1}.$$

It is clear that

$$\mathbb{E}[|y^{\xi,\Delta}(t_1) - y^{\eta,\Delta}(t_1)|^2] \le (1 \vee ((L+2a_2)\tau e^{\lambda_0 \tau}))(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2)e^{-\lambda_0 t_1}.$$
(2.68)

Assume that for some integer k > 1 and  $l \in \{1, \ldots, k\}$ ,

$$\mathbb{E}[|y^{\xi,\Delta}(t_l) - y^{\eta,\Delta}(t_l)|^2] \le (1 \vee ((L+2a_2)\tau e^{\lambda_0\tau}))(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2)e^{-\lambda_0 t_l}.$$
(2.69)

Then for k + 1, taking into account (2.65), (2.67), and (2.69), we deduce

$$\left(1 + 2a_1\theta\Delta\left(1 - \int_{-\Delta}^{0} \frac{r+\Delta}{\Delta}\mathrm{d}\nu_2(r)\right)\right)\mathbb{E}[|y^{\xi,\Delta}(t_{k+1}) - y^{\eta,\Delta}(t_{k+1})|^2]$$

$$\leq \mathbb{E}[|z^{\xi,\Delta}(t_{k+1}) - z^{\eta,\Delta}(t_{k+1})|^2] + 2a_2\theta\Delta\left(1 - \int_{-\Delta}^{0} \frac{r+\Delta}{\Delta}\mathrm{d}\nu_2(r)\right)$$

$$\times \sup_{k-N+1 \le l \le k} \mathbb{E}[|y^{\xi,\Delta}(t_l) - y^{\eta,\Delta}(t_l)|^2]$$

$$\leq \left(1 \lor \left((L+2a_2)\tau e^{\lambda_0\tau}\right)\right) \left(1 + 2a_2\theta e^{\lambda_0\tau}\Delta\left(1 - \int_{-\Delta}^{0} \frac{r+\Delta}{\Delta}\mathrm{d}\nu_2(r)\right)\right)$$

$$\times \left(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2\right) e^{-\lambda_0 t_{k+1}},$$

which implies

$$\mathbb{E}[|y^{\xi,\Delta}(t_{k+1}) - y^{\eta,\Delta}(t_{k+1})|^2] \le (1 \vee ((L+2a_2)\tau e^{\lambda_0 \tau}))(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2)e^{-\lambda_0 t_{k+1}}.$$
(2.70)

Hence, we conclude from (2.68)-(2.70) that

$$\mathbb{E}[|y^{\xi,\Delta}(t_k) - y^{\eta,\Delta}(t_k)|^2] \le (1 \vee ((L+2a_2)\tau e^{\lambda_0 \tau}))(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + \|\xi - \eta\|^2)e^{-\lambda_0 t_k}.$$
(2.71)

Furthermore, by similar arguments to those in <u>Step 2</u> of Proposition 2.2, we use (2.65) and (2.71) to obtain

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq i\leq k}e^{\lambda_0 t_{i+1}}|z^{\xi,\Delta}(t_{i+1})-z^{\eta,\Delta}(t_{i+1})|^2\Big]$$

$$\leq K(|z^{\xi,\Delta}(0) - z^{\eta,\Delta}(0)|^2 + ||\xi - \eta||^2) + K\Delta \sum_{i=0}^k e^{\lambda_0 t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_i) - y^{\eta,\Delta}(t_i)|^2] \\ + 2a_2\theta\Delta \sum_{i=(k-2N)\vee(-N)}^k e^{\lambda_0 t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_i) - y^{\eta,\Delta}(t_i)|^2] \\ \leq K(|b(\xi) - b(\eta)|^2 + ||\xi - \eta||^2)(1 + t_k).$$

This implies that for any  $\varepsilon \in (0, \lambda_0)$ ,

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq i\leq k} |z^{\xi,\Delta}(t_{i+1}) - z^{\eta,\Delta}(t_{i+1})|^2\Big] \leq K(|b(\xi) - b(\eta)|^2 + \|\xi - \eta\|^2)e^{(\lambda_0 - \varepsilon)t_k}.$$
 (2.72)

Without loss of generality, we redefine  $\lambda_0 \in (0, \frac{(2\theta-1)c_{\lambda}}{\theta^2(1+c_{\lambda})} \wedge \lambda)$ . Then, it follows from (2.71) that

$$\mathbb{E}\Big[\sup_{(k-N)\vee 0\leq i\leq k}|z^{\xi,\Delta}(t_{i+1})-z^{\eta,\Delta}(t_{i+1})|^2\Big]\leq K(|b(\xi)-b(\eta)|^2+\|\xi-\eta\|^2)e^{-\lambda_0 t_k}.$$
 (2.73)

Using (2.66) leads to

$$(1+2a_{1}\theta\Delta)\mathbb{E}\Big[\sup_{(k-N)\vee0\leq i\leq k}|y^{\xi,\Delta}(t_{i})-y^{\eta,\Delta}(t_{i})|^{2}\Big]$$

$$\leq \mathbb{E}\Big[\sup_{(k-N)\vee0\leq i\leq k}|z^{\xi,\Delta}(t_{i})-z^{\eta,\Delta}(t_{i})|^{2}\Big]$$

$$+2a_{2}\theta\Delta\mathbb{E}\Big[\sup_{(k-2N)\vee(-N)\leq i\leq k}|y^{\xi,\Delta}(t_{i})-y^{\eta,\Delta}(t_{i})|^{2}\Big]$$

$$\leq \mathbb{E}\Big[\sup_{(k-N)\vee0\leq i\leq k}|z^{\xi,\Delta}(t_{i})-z^{\eta,\Delta}(t_{i})|^{2}\Big]$$

$$+4a_{2}\theta\tau \sup_{(k-2N)\vee(-N)\leq i\leq k}\mathbb{E}[|y^{\xi,\Delta}(t_{i})-y^{\eta,\Delta}(t_{i})|^{2}]. \qquad (2.74)$$

Then the desired argument follows from (2.71) and (2.73). We finish the proof.

Numerical stability is an important characteristic to measure the reliability of numerical methods in long-term computation. Below, we present the exponential stability of the trivial solution of (1.1). We propose the following condition to ensure the existence of the trivial solution.

Assumption 2.4 The drift and diffusion coefficients satisfy  $b(0) = \sigma(0) = 0$ .

It follows from Assumption 2.4 that  $x^{\mathbf{0}}(t) \equiv 0$ , which implies  $x_t^{\mathbf{0}} \equiv \mathbf{0}$ . By virtue of Lemma 1.1, it is straightforward to obtain the exponential stability of the functional solution of (1.1).

**Theorem 2.1** Let Assumptions 1.1, 1.2, and 2.4 hold. Then the functional solution of (1.1) with the initial datum  $\xi \in C^d$  is mean-square exponential stable and satisfies

$$\mathbb{E}[\|x_t^{\xi}\|^2] \le K(1 + \|\xi\|^2)e^{-\lambda t},$$

where the constant  $\lambda$  satisfies (1.6).

Similarly, by virtue of Proposition 2.4, we can deduce that the  $\theta$ -EM method inherits the mean-square exponential stability.

**Theorem 2.2** Suppose that Assumptions 1.1, 1.2, and 2.4 hold. Then for any  $\Delta \in (0, 1]$ , the numerical functional solution is mean-square exponential stable and satisfies

$$\mathbb{E}[\|y_{t_k}^{\xi,\Delta}\|^2] \le K(1+|b(\xi)|^2+\|\xi\|^2)e^{-\lambda_0 t_k}$$

where the constant  $\lambda_0$  is defined in Proposition 2.4.

**Remark 2.1** In fact, if the coefficients b and  $\sigma$  are locally Lipschitz continuous, and Assumptions 1.1 and 1.2 are relaxed as

$$2\langle \phi(0), b(\phi) \rangle + |\sigma(\phi)|^2 \le -d_1 |\phi(0)|^2 + d_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu(r),$$

we can also deduce the above stability results of the exact functional solution and the numerical one, where  $d_1$  and  $d_2$  are positive constants with  $d_1 > d_2$ , and  $\nu$  is a probability measure on  $[-\tau, 0]$ . The proof is similar to those of Lemma 1.1 and Proposition 2.4.

# 2.3 Mean-square convergence rate

In this subsection, we aim to prove the mean-square convergence rate of  $\theta$ -EM method, based on the estimates of high-order moments.

Lemma 2.4 Let Assumptions 1.1–1.2, 2.1–2.3 hold. Then,

$$\sup_{t \ge 0} \mathbb{E}[\|x_t^{\xi} - z_t^{\xi, \Delta}\|^2] \le K(1 + \|\xi\|^{2(1+\beta)(2\beta+2)})\Delta \quad \forall \xi \in \mathcal{C}^d.$$

**Proof.** It follows from (1.1) and (2.2) that

$$x^{\xi}(t) - z^{\xi,\Delta}(t) = \theta b(\xi)\Delta + \int_0^t b(x_s^{\xi}) - b(y_s^{\xi,\Delta}) \mathrm{d}s + \int_0^t \sigma(x_s^{\xi}) - \sigma(y_s^{\xi,\Delta}) \mathrm{d}W(s).$$

By the Itô formula and the Young inequality, we obtain that for any  $\varepsilon \in (0, 1)$ ,

$$\begin{split} e^{\varepsilon t} |x^{\xi}(t) - z^{\xi,\Delta}(t)|^2 \\ &= \theta^2 |b(\xi)|^2 \Delta^2 + \int_0^t e^{\varepsilon s} \Big(\varepsilon |x^{\xi}(s) - z^{\xi,\Delta}(s)|^2 + 2\langle x^{\xi}(s) - z^{\xi,\Delta}(s), b(x^{\xi}_s) - b(y^{\xi,\Delta}_s) \rangle \\ &+ |\sigma(x^{\xi}_s) - \sigma(y^{\xi,\Delta}_s)|^2 \Big) \mathrm{d}s + \mathcal{N}_t \\ &\leq K (1 + ||\xi||^{2(\beta+1)}) \Delta^2 + \int_0^t e^{\varepsilon s} \Big(\varepsilon |x^{\xi}(s) - z^{\xi,\Delta}(s)|^2 + 2\langle x^{\xi}(s) - z^{\xi,\Delta}(s), b(x^{\xi}_s) - b(z^{\xi,\Delta}_s) \rangle \\ &+ (1 + \varepsilon) |\sigma(x^{\xi}_s) - \sigma(z^{\xi,\Delta}_s)|^2 \Big) \mathrm{d}s + \int_0^t \varepsilon e^{\varepsilon s} |x^{\xi}(s) - z^{\xi,\Delta}(s)|^2 \mathrm{d}s + \mathcal{E}_t + \mathcal{N}_t, \end{split}$$

where

$$\mathcal{E}_t := \int_0^t e^{\varepsilon s} \Big( \frac{1}{\varepsilon} |b(z_s^{\xi,\Delta}) - b(y_s^{\xi,\Delta})|^2 + (1 + \frac{1}{\varepsilon}) |\sigma(z_s^{\xi,\Delta}) - \sigma(y_s^{\xi,\Delta})|^2 \Big) \mathrm{d}s,$$

and  $\mathcal{N}_t$  is a martingale defined by

$$\mathcal{N}_t := 2 \int_0^t e^{\varepsilon s} \langle x^{\xi}(s) - z^{\xi, \Delta}(s), (\sigma(x_s^{\xi}) - \sigma(y_s^{\xi, \Delta})) \mathrm{d}W(s) \rangle.$$

According to Assumptions 1.1 and 1.2, we derive

$$\begin{split} & e^{\varepsilon t} |x^{\xi}(t) - z^{\xi,\Delta}(t)|^{2} \\ & \leq K(1 + \|\xi\|^{2(\beta+1)})\Delta^{2} + \int_{0}^{t} \Big( -(2a_{1} - 2\varepsilon - (1 + \varepsilon)L)e^{\varepsilon s} |x^{\xi}(s) - z^{\xi,\Delta}(s)|^{2} \\ & + 2a_{2} \int_{-\tau}^{0} e^{\varepsilon s} |x^{\xi}_{s}(r) - z^{\xi,\Delta}_{s}(r)|^{2} \mathrm{d}\nu_{2}(r) + (1 + \varepsilon)L \int_{-\tau}^{0} e^{\varepsilon s} |x^{\xi}_{s}(r) - z^{\xi,\Delta}_{s}(r)|^{2} \mathrm{d}\nu_{1}(r) \Big) \mathrm{d}s \\ & + \mathcal{E}_{t} + \mathcal{N}_{t} \\ & \leq K(1 + \|\xi\|^{2(\beta+1)})\Delta^{2} - (2a_{1} - 2\varepsilon - (1 + \varepsilon)L - (2a_{2} + (1 + \varepsilon)L)e^{\varepsilon\tau}) \int_{0}^{t} e^{\varepsilon s} |x^{\xi}(s) \\ & - z^{\xi,\Delta}(s)|^{2} \mathrm{d}s + (2a_{2} + (1 + \varepsilon)L)e^{\varepsilon\tau} \int_{-\tau}^{0} e^{\varepsilon s} |x^{\xi}(s) - z^{\xi,\Delta}(s)|^{2} \mathrm{d}s + \mathcal{E}_{t} + \mathcal{N}_{t}. \end{split}$$

In view of  $a_1 > a_2 + L$ , choose a sufficiently small number  $\varepsilon \in (0, 1)$  such that

$$2a_1 - 2\varepsilon - (1+\varepsilon)L - (2a_2 + (1+\varepsilon)L)e^{\varepsilon\tau} \ge 0.$$

By Assumptions 2.2 and 2.3, we have

$$(2a_2 + (1+\varepsilon)L)e^{\varepsilon\tau} \int_{-\tau}^0 e^{\varepsilon s} |x^{\xi}(s) - z^{\xi,\Delta}(s)|^2 \mathrm{d}s \le K(1 + \|\xi\|^{2(\beta+1)})\Delta.$$

Thus,

$$e^{\varepsilon t} |x^{\xi}(t) - z^{\xi, \Delta}(t)|^2 \le K(1 + ||\xi||^{2(\beta+1)})\Delta + \mathcal{E}_t + \mathcal{N}_t.$$
(2.75)

By virtue of Assumptions 1.1 and 2.2, we apply the Hölder inequality to deduce

$$\mathbb{E}[\mathcal{E}_{t}] \leq K \mathbb{E}\Big[\int_{0}^{t} e^{\varepsilon s} \|z_{s}^{\xi,\Delta} - y_{s}^{\xi,\Delta}\|^{2}(1 + \|z_{s}^{\xi,\Delta}\|^{2\beta} + \|y_{s}^{\xi,\Delta}\|^{2\beta}) \mathrm{d}s\Big] \\ \leq K \int_{0}^{t} e^{\varepsilon s} \big(\mathbb{E}[\|z_{s}^{\xi,\Delta} - y_{s}^{\xi,\Delta}\|^{4}]\big)^{\frac{1}{2}} \big(\mathbb{E}[1 + \|z_{s}^{\xi,\Delta}\|^{4\beta} + \|y_{s}^{\xi,\Delta}\|^{4\beta}]\big)^{\frac{1}{2}} \mathrm{d}s.$$

Making use of (2.52) and Lemma 2.3 yields

$$\mathbb{E}[\mathcal{E}_t] \le K(1 + \|\xi\|^{2(1+\beta)^2})(1 + \|\xi\|^{2\beta(1+\beta)})\Delta \int_0^t e^{\varepsilon s} \mathrm{d}s$$
  
$$\le K(1 + \|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta.$$

This, along with (2.75) implies that

$$\mathbb{E}[|x^{\xi}(t) - z^{\xi,\Delta}(t)|^{2}] \leq e^{-\varepsilon t} (K(1 + \|\xi\|^{2(1+\beta)})\Delta + \mathbb{E}[\mathcal{E}_{t}])$$
  
$$\leq K(1 + \|\xi\|^{2(1+\beta)(2\beta+2)})\Delta, \qquad (2.76)$$

where the positive constant K is independent of  $\Delta$  and t. Furthermore, according to (2.75), we apply the Burkholder–Davis–Gundy inequality to derive

$$\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^2\Big]$$

$$\leq K(1+\|\xi\|^{2(1+\beta)})\Delta + \mathbb{E}[\mathcal{E}_t] + \mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}\mathcal{N}_u\Big]$$

$$\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta$$

$$+ K\mathbb{E}\Big[\Big(\int_{(t-\tau)\vee 0}^t e^{2\varepsilon s}|x^{\xi}(s) - z^{\xi,\Delta}(s)|^2|\sigma(x^{\xi}_s) - \sigma(y^{\xi,\Delta}_s)|^2\mathrm{d}s\Big)^{\frac{1}{2}}\Big]$$

$$\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta + K\mathbb{E}\Big[\Big(\Big(\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u) - z^{\xi,\Delta}(u)|^2\Big)$$

$$\times \int_{(t-\tau)\vee 0}^t e^{\varepsilon s}|\sigma(x^{\xi}_s) - \sigma(y^{\xi,\Delta}_s)|^2\mathrm{d}s\Big)^{\frac{1}{2}}\Big].$$

By virtue of the Young inequality and Assumption 1.1, we arrive at

$$\begin{split} & \mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\ &\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta+\frac{1}{2}\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\ &\quad +K\mathbb{E}\Big[\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}|\sigma(x^{\xi}_{s})-\sigma(y^{\xi,\Delta}_{s})|^{2}\mathrm{d}s\Big] \\ &\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta+\frac{1}{2}\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\ &\quad +K\mathbb{E}\Big[\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}|\sigma(x^{\xi}_{s})-\sigma(z^{\xi,\Delta}_{s})|^{2}\mathrm{d}s\Big] \\ &\quad +K\mathbb{E}\Big[\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}|\sigma(z^{\xi,\Delta}_{s})-\sigma(y^{\xi,\Delta}_{s})|^{2}\mathrm{d}s\Big] \\ &\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta+\frac{1}{2}\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\ &\quad +K\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}\mathbb{E}[|x^{\xi}(s)-z^{\xi,\Delta}(s)|^{2}]\mathrm{d}s+K\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}\mathbb{E}[\|z^{\xi,\Delta}_{s}-y^{\xi,\Delta}_{s}\|^{2}]\mathrm{d}s \\ &\quad +\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}\int_{-\tau}^{0}\mathbb{E}[|x^{\xi}_{s}(r)-z^{\xi,\Delta}_{s}(r)|^{2}]\mathrm{d}\nu_{1}(r)\mathrm{d}s. \end{split}$$

It follows from (2.76) and Lemma 2.3 that

$$\frac{1}{2}e^{\varepsilon(t-\tau)\vee 0}\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\
\leq \frac{1}{2}\mathbb{E}\Big[\sup_{(t-\tau)\vee 0\leq u\leq t}e^{\varepsilon u}|x^{\xi}(u)-z^{\xi,\Delta}(u)|^{2}\Big] \\
\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta+K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})\Delta\int_{(t-\tau)\vee 0}^{t}e^{\varepsilon s}\mathrm{d}s \\
\leq K(1+\|\xi\|^{2(1+\beta)(2\beta+2)})e^{\varepsilon t}\Delta,$$

which implies

$$\mathbb{E}\Big[\sup_{(t-\tau)\vee 0 \le u \le t} |x^{\xi}(u) - z^{\xi,\Delta}(u)|^2\Big] \le K(1 + \|\xi\|^{2(1+\beta)(2\beta+2)})\Delta.$$

The proof is completed.  $\hfill \Box$ 

#### 2.4 Summary and outlook

Utilizing Lemmas 2.3 and 2.4, we conclude the following mean-square convergence rate of the  $\theta$ -EM functional solution.

**Theorem 2.3** Let Assumptions 1.1–1.2, 2.1–2.3 hold. Then for  $\Delta \in (0,1]$  and  $\xi \in C^d$ ,

$$\sup_{k\geq 0} \mathbb{E}[\|x_{t_k}^{\xi} - y_{t_k}^{\xi,\Delta}\|^2] \le K(1 + \|\xi\|^{2(1+\beta)(2\beta+2)})\Delta.$$

In view of Proposition 2.3, Proposition 2.4, Theorem 2.3, and [15, Theorems 3.1–3.2], we present the strong law of large numbers (SLLN) and the central limit theorem (CLT) of the  $\theta$ -EM method. Define the empirical measure as  $\Pi^{m,\Delta} := \frac{1}{m} \sum_{k=0}^{m-1} \delta_{y_{t_k}^{\xi,\Delta}}$  with  $\delta$  being the Dirac function.  $\Pi^{m,\Delta}(f) := \frac{1}{m} \sum_{k=0}^{m-1} f(y_{t_k}^{\xi,\Delta})$  is called the time-average of the  $\theta$ -EM functional solution.

**Corollary 2.1** Under Assumptions 1.1–1.2 and 2.1–2.3, the numerical functional solution  $\{y_{t_k}^{\xi,\Delta}\}_{k\geq 0}$  fulfills the strong law of large numbers (SLLN) and the central limit theorem (CLT), namely, for any  $p \geq 1, \gamma \in (0,1]$ , and  $f \in C_{p,\gamma}$ ,

$$\lim_{\Delta \to 0} \lim_{m_1 \to \infty} \frac{1}{m_1} \sum_{k=0}^{m_1 - 1} f(y_{t_k}^{\xi, \Delta}) = \mu(f) \quad a.s.,$$
(SLLN)

$$\lim_{\Delta \to 0} \frac{1}{\sqrt{m_2 \Delta}} \sum_{k=0}^{m_2-1} (f(y_{t_k}^{\xi,\Delta}) - \mu(f)) \Delta = \mathcal{N}(0, v^2) \quad in \ distribution,$$
(CLT)

where  $m_2 = \lceil \Delta^{-1-2\lambda} \rceil$  with  $\lambda \in (0, \frac{1}{2}\gamma)$ ,  $v^2 = 2\mu((f - \mu(f)) \int_0^\infty (P_t f - \mu(f)))$ . Here,  $\mathcal{C}_{p,\gamma} := \mathcal{C}_{p,\gamma}(\mathcal{C}^d; \mathbb{R})$  is the space of continuous functions f satisfying

$$\sup_{\phi \in \mathcal{C}^d} \frac{|f(\phi)|}{1+\|\phi\|^{\frac{p}{2}}} + \sup_{\substack{\phi_1, \phi_2 \in \mathcal{C}^d \\ \phi_1 \neq \phi_2}} \frac{|f(\phi_1) - f(\phi_2)|}{(1 \wedge \|\phi_1 - \phi_2\|^{\gamma})(1+\|\phi_1\|^p + \|\phi_2\|^p)^{\frac{1}{2}}} < \infty.$$

# 2.4 Summary and outlook

In this chapter, we present the longtime mean-square convergence analysis for the  $\theta$ -EM method for the SFDE (1.1) with the superlinearly growing drift coefficient. The mean-square convergence rate is proved to be  $\frac{1}{2}$ . The time-independent boundedness of high-order moment of the numerical solution is the key to obtain the desired mean-square convergence result. There are some rooms to loose the conditions proposed in this chapter. For example, if we weaken Assumption 2.2 to

$$\langle b(\phi), \phi(0) \rangle \leq K - a_3 |\phi(0)|^{\alpha + \epsilon} + a_4 \int_{-\tau}^0 |\phi(r)|^{\alpha} \mathrm{d}\nu_2(r), \quad \phi \in \mathcal{C}^d,$$

the mean-square convergence result still holds based on the approach used in this chapter, where  $\epsilon > 0, \alpha \ge 2, a_3, a_4 > 0$ . When both the drift and the diffusion coefficients are superlinearly growing, there are some longtime mean-square convergence results of numerical methods for stochastic ordinary differential equations (for BEM method see [45]). However, less is known for the SFDE case. As applications of the longtime mean-square convergence result, we present in Corollary 2.1 the SLLN and the CLT of the time-average of the  $\theta$ -EM functional solution. Following this line, it is interesting to further study the probabilistic asymptotics that the empirical measure deviates from the invariant measure. We leave this as our future work.

# CHAPTER 3

# Invariant measure and weak convergence analysis

In this chapter, we investigate the existence and uniqueness of the invariant measure of the  $\theta$ -EM method. In order to give a quantitative estimate between the numerical invariant measure and the exact one, we analyze the longtime weak convergence of the  $\theta$ -EM method. Finally, it is shown that the convergence rate of the invariant measure of the  $\theta$ -EM method is 1, which is twice the mean-square convergence rate.

# **3.1** Numerical invariant measure

In this section, we show that the  $\theta$ -EM functional solution admits a unique invariant measure. Recall

$$y_t^{\xi,\Delta} := \sum_{k=0}^{\infty} y_{t_k}^{\xi,\Delta} \mathbf{1}_{[t_k,t_{k+1})}(t)$$

and define the measure  $\mu_t^{\xi,\Delta}$  by

$$\mu_t^{\xi,\Delta}(A) := \mathbb{P}\{\omega \in \Omega : y_t^{\xi,\Delta} \in A\} \quad \forall A \in \mathcal{B}(\mathcal{C}^d).$$

Denote by  $P_t^{\xi,\Delta}$  the Markov semigroup associated to  $\mu_t^{\xi,\Delta}$ . According to Propositions 2.2 and 2.4, we can obtain the tightness of the sequence  $\{\mu_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$ .

**Lemma 3.1** Under Assumptions 1.1 and 1.2, for  $\xi \in C^d$  and  $\Delta \in (0,1]$ , the family  $\{\mu_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$  is tight.

**Proof.** Since  $C^d$  is a Polish space and

$$\sup_{k \in \mathbb{N}} \mathbb{E}[\|y_{t_k}^{\xi, \Delta}\|^2] \le K(1 + \|\xi\|^2 + |b(\xi)|^2 \Delta^2),$$

and by virtue of [58, Lemma 6.14], it suffices to prove that the family  $\{\mu_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$  is a Cauchy sequence in the space  $(\mathcal{P}, \mathbb{W}_1)$ . In fact, for any  $k, i \in \mathbb{N}$ , applying [58, Remark 6.5] leads to

$$\mathbb{W}_{1}(\mu_{t_{k+i}}^{\xi,\Delta},\mu_{t_{k}}^{\xi,\Delta}) = \sup_{\|\Psi\|_{Lip} \vee \|\Psi\|_{\infty} \leq 1} \Big| \int_{\mathcal{C}^{d}} \Psi(\phi) \mathrm{d}\mu_{t_{k+i}}^{\xi,\Delta}(\phi) - \int_{\mathcal{C}^{d}} \Psi(\phi) \mathrm{d}\mu_{t_{k}}^{\xi,\Delta}(\phi) \Big|,$$

where  $\Psi : \mathcal{C}^d \to \mathbb{R}$  satisfies the Lipschitz condition and norms  $\|\cdot\|_{Lip}$  and  $\|\cdot\|_{\infty}$  are defined, respectively, by

$$\|\Psi\|_{Lip} = \sup_{\substack{\phi_1, \phi_2 \in \mathcal{C}^d \\ \phi_1 \neq \phi_2}} \frac{|\Psi(\phi_1) - \Psi(\phi_2)|}{\|\phi_1 - \phi_2\|} \text{ and } \|\Psi\|_{\infty} = \sup_{\phi \in \mathcal{C}^d} \frac{|\Psi(\phi)|}{\|\phi\|}$$

By the definition of  $\mu^{\xi,\Delta}_{\cdot,\cdot}$  and the time-homogeneous Markov property of  $\{y_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$ , we deduce

$$\begin{split} \mathbb{W}_{1}(\mu_{t_{k+i}}^{\xi,\Delta},\mu_{t_{k}}^{\xi,\Delta}) &= \sup_{\|\Psi\|_{Lip} \vee \|\Psi\|_{\infty} \leq 1} |\mathbb{E}[\Psi(y_{t_{k+i}}^{\xi,\Delta})] - \mathbb{E}[\Psi(y_{t_{k}}^{\xi,\Delta})]| \\ &= \sup_{\|\Psi\|_{Lip} \vee \|\Psi\|_{\infty} \leq 1} \left| \mathbb{E}\Big[\mathbb{E}\big[\Psi(y_{t_{k+i}}^{\xi,\Delta})|\mathcal{F}_{t_{i}}\big]\Big] - \mathbb{E}[\Psi(y_{t_{k}}^{\xi,\Delta})]\Big| \\ &= \sup_{\|\Psi\|_{Lip} \vee \|\Psi\|_{\infty} \leq 1} \left| \mathbb{E}\Big[\mathbb{E}\big[\Psi(y_{t_{k}}^{\zeta,\Delta})\big]\big|_{\zeta=y_{t_{i}}^{\xi,\Delta}}\Big] - \mathbb{E}[\Psi(y_{t_{k}}^{\xi,\Delta})]\Big| \\ &= \sup_{\|\Psi\|_{Lip} \vee \|\Psi\|_{\infty} \leq 1} \left| \mathbb{E}\Big[\mathbb{E}\big[\Psi(y_{t_{k}}^{\zeta,\Delta}) - \Psi(y_{t_{k}}^{\xi,\Delta})\big]\big|_{\zeta=y_{t_{i}}^{\xi,\Delta}}\Big]\Big|. \end{split}$$

It follows from the Lipschitz property of  $\Psi$  and Proposition 2.4 that for any constant  $M>\|\xi\|,$ 

$$\begin{split} & \mathbb{W}_{1}(\mu_{t_{k+i}}^{\xi,\Delta},\mu_{t_{k}}^{\xi,\Delta}) \leq \mathbb{E}\Big[\mathbb{E}\big[2 \wedge \|y_{t_{k}}^{\xi,\Delta} - y_{t_{k}}^{\xi,\Delta}\|\big]\big|_{\zeta=y_{t_{i}}^{\xi,\Delta}}\Big] \\ & \leq K\mathbb{E}\Big[\big(|b(y_{t_{i}}^{\xi,\Delta}) - b(\xi)| + \|y_{t_{i}}^{\xi,\Delta} - \xi\|\big)\mathbf{1}_{\{\|y_{t_{i}}^{\xi,\Delta}\| \leq M\}}\Big]e^{-\frac{\lambda_{0}t_{k}}{2}} + 2\mathbb{P}\{\|y_{t_{i}}^{\xi,\Delta}\| > M\}. \end{split}$$

According to the Chebyshev inequality and Proposition 2.2, we have

$$\begin{split} \mathbb{W}_{1}(\mu_{t_{k+i}}^{\xi,\Delta},\mu_{t_{k}}^{\xi,\Delta}) &\leq K \sup_{\|\phi\| \leq M} \left( |b(\phi)| + \|\phi\| \right) e^{-\frac{\lambda_{0} t_{k}}{2}} + 2\frac{\mathbb{E}[\|y_{t_{i}}^{\xi,\Delta}\|^{2}]}{M^{2}} \\ &\leq K \sup_{\|\phi\| \leq M} \left( |b(\phi)| + \|\phi\| \right) e^{-\frac{\lambda_{0} t_{k}}{2}} + \frac{K(1 + \|\xi\|^{2} + |b(\xi)|^{2}\Delta^{2})}{M^{2}}. \end{split}$$

For any  $\varepsilon > 0$ , choose a sufficiently large number M > 0 such that

$$\frac{K(1+\|\xi\|^2+|b(\xi)|^2\Delta^2)}{M^2} < \frac{\varepsilon}{2}$$

By virtue of the continuity of  $b(\cdot)$ , choose a sufficiently large number  $k \in \mathbb{N}$  such that

$$K \sup_{\|\phi\| \le M} (|b(\phi)|^2 + \|\phi\|^2) e^{-\frac{\lambda_0 t_k}{2}} < \frac{\varepsilon}{2}.$$

Hence, the family  $\{\mu_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$  is a Cauchy sequence in  $(\mathcal{P}, \mathbb{W}_1)$ . The proof is finished.  $\square$ 

Taking advantage of Proposition 2.4 and Lemma 3.1, we give the existence and uniqueness of the numerical invariant measure of the  $\theta$ -EM functional solution.

**Theorem 3.1** Under Assumptions 1.1 and 1.2, for  $\Delta \in (0, 1]$ , the  $\theta$ -EM functional solution admits a unique invariant measure  $\mu^{\Delta}$ . Furthermore, for any  $\Delta \in (0, 1]$  the numerical invariant measure  $\mu^{\Delta}$  satisfies

$$\sup_{\Delta \in (0,1]} \mu^{\Delta}(\|\cdot\|^p) := \sup_{\Delta \in (0,1]} \int_{\mathcal{C}^d} \|\phi\|^p \mathrm{d}\mu^{\Delta}(\phi) \le K.$$
(3.1)

**Proof.** We divide the proof of the existence and uniqueness of the numerical invariant measure into two steps.

#### 3.1 Numerical invariant measure

<u>Step 1.</u> We present the existence of numerical invariant measure based on the Krylov– Bogoliubov theorem [24, Theorem 3.1.1]. For any  $\xi \in C^d$ ,  $\Delta \in (0, 1]$ , and  $k \in \mathbb{N}$ , it follows from Lemma 3.1 that the family  $\{\mu_{t_k}^{\xi,\Delta}\}_{k=0}^{\infty}$  is tight. Hence we only need to prove that  $P_{t_k}^{\xi,\Delta}$  is Feller, i.e., to show that the mapping

$$\xi \to P_{t_k}^{\xi,\Delta}(\Phi) = \mathbb{E}[\Phi(y_{t_k}^{\xi,\Delta})]$$

is continuous for any bounded continuous functional  $\Phi : \mathcal{C}^d \to \mathbb{R}$ . In fact, for  $\xi, \eta \in \mathcal{C}^d$ , by Proposition 2.4, we have

$$y_{t_k}^{\xi,\Delta} \to y_{t_k}^{\eta,\Delta} \quad \text{in } L^2(\Omega; \mathcal{C}^d)$$

as  $\xi \to \eta$ . By [57, pp.256, Theorem 2], we derive

$$y_{t_k}^{\xi,\Delta} \to y_{t_k}^{\eta,\Delta}$$
 in distribution

as  $\xi \to \eta$ , which implies the Feller property. Hence, for any  $\xi \in C^d$  and  $\Delta \in (0, 1]$ , the  $\theta$ -EM functional solution admits an invariant measure  $\mu^{\Delta}$ .

<u>Step 2.</u> We shall show that for any  $\Delta \in (0, 1]$ , the numerical invariant measure is unique. Assume that there exist two numerical invariant measures  $\mu_1^{\Delta}$  and  $\mu_2^{\Delta}$ . Then in view of the convex property of  $\mathbb{W}_2$  and Proposition 2.4, we obtain that for any  $k \in \mathbb{N}$ ,

$$\mathbb{W}_{2}^{2}(\mu_{1}^{\Delta},\mu_{2}^{\Delta}) \leq \int_{\mathcal{C}^{d}\times\mathcal{C}^{d}} \mathbb{W}_{2}^{2}(\mu_{t_{k}}^{\xi,\Delta},\mu_{t_{k}}^{\eta,\Delta}) \mathrm{d}\mu_{1}^{\Delta}(\xi) \mathrm{d}\mu_{2}^{\Delta}(\eta) \leq \int_{\mathcal{C}^{d}\times\mathcal{C}^{d}} 1 \wedge \left( K(|b(\xi)-b(\eta)|^{2}+\|\xi-\eta\|^{2})e^{-\lambda_{0}t_{k}} \right) \mathrm{d}\mu_{1}^{\Delta}(\xi) \mathrm{d}\mu_{2}^{\Delta}(\eta).$$
(3.2)

It follows from the dominated convergence theorem that

$$\lim_{k \to \infty} \mathbb{W}_2(\mu_1^{\Delta}, \mu_2^{\Delta}) = 0,$$

which finishes the proof of Step 2.

In addition, by means of Proposition 2.3, we have

$$\int_{C} \|\phi\|^{p} \mathrm{d}\mu^{\Delta}(\eta) = \lim_{M \to +\infty} \lim_{k \to \infty} \mathbb{E} \left[ M \wedge \|y_{t_{k}}^{0,\Delta}\|^{p} \right]$$
$$\leq \sup_{k \in \mathbb{N}} \mathbb{E} \left[ \|y_{t_{k}}^{0,\Delta}\|^{p} \right] \leq K.$$

The proof is therefore finished.  $\Box$ 

Taking advantage of Theorem 2.3, we estimate the error between the numerical invariant measure and the exact one.

**Theorem 3.2** Let Assumptions 1.1, 1.2, 2.1–2.3 hold. Then for any  $\Delta \in (0,1]$ ,

$$\mathbb{W}_2(\mu,\mu^{\Delta}) \le K\Delta^{\frac{1}{2}}.$$

**Proof.** For any  $\Delta \in (0,1]$  and  $k \in \mathbb{N}$ , by virtue of Lemma 1.2 and Theorem 2.3, we obtain

$$\mathbb{W}_{2}(\mu,\mu^{\Delta}) \leq \mathbb{W}_{2}(\mu,\mu_{t_{k}}^{\mathbf{0}}) + \mathbb{W}_{2}(\mu_{t_{k}}^{\mathbf{0}},\mu_{t_{k}}^{\mathbf{0},\Delta}) + \mathbb{W}_{2}(\mu_{t_{k}}^{\mathbf{0},\Delta},\mu^{\Delta}) \\
 \leq Ke^{-\frac{\lambda}{2}t_{k}} + \left(\mathbb{E}[\|x_{t_{k}}^{\mathbf{0}} - y_{t_{k}}^{\mathbf{0},\Delta}\|^{2}]\right)^{\frac{1}{2}} + \mathbb{W}_{2}(\mu_{t_{k}}^{\mathbf{0},\Delta},\mu^{\Delta}) \\
 \leq Ke^{-\frac{\lambda}{2}t_{k}} + K\Delta^{\frac{1}{2}} + \mathbb{W}_{2}(\mu_{t_{k}}^{\mathbf{0},\Delta},\mu^{\Delta}),$$
(3.3)

where the positive constant  $\lambda$  satisfies (1.6). Similar to the proof of (3.2), and by Assumption 2.2, we have

$$\begin{aligned} \mathbb{W}_{2}(\mu_{t_{k}}^{\mathbf{0},\Delta},\mu^{\Delta}) &\leq \left(\int_{\mathcal{C}^{d}} K(|b(\mathbf{0}) - b(\eta)|^{2} + \|\eta\|^{2})e^{-\lambda_{0}t_{k}} \mathrm{d}\mu^{\Delta}(\eta)\right)^{\frac{1}{2}} \\ &\leq Ke^{-\frac{\lambda_{0}}{2}t_{k}} \left(\int_{\mathcal{C}^{d}} (1 + \|\eta\|^{2(\beta+1)}) \mathrm{d}\mu^{\Delta}(\eta)\right)^{\frac{1}{2}} \\ &\leq Ke^{-\frac{\lambda_{0}}{2}t_{k}}. \end{aligned}$$

This, along with (3.3) implies that

$$\mathbb{W}_2(\mu,\mu^{\Delta}) \le Ke^{-\frac{\lambda}{2}t_k} + K\Delta^{\frac{1}{2}} + Ke^{-\frac{\lambda_0}{2}t_k}.$$

Letting  $k \to \infty$ , we obtain the desired argument.  $\Box$ 

# 3.2 Weak convergence rate

In this section, we present the longtime weak convergence analysis of the  $\theta$ -EM method based on the Malliavin calculus, and show that the convergence rate of the numerical invariant measure is 1. The key in the analysis is to present time-independent estimates of the Malliavin derivatives and the Gâteaux derivatives of both the exact solution and the numerical solution.

## 3.2.1 Preliminaries

This subsection is devoted to giving a brief introduction to the Malliavin calculus and presenting the decomposition of the weak error for the  $\theta$ -EM method.

#### 3.2.1.1 Brief introduction to Malliavin calculus

Let *H* be the Hilbert space  $L^2([0, +\infty); \mathbb{R}^m)$  endowed with the inner product  $\langle g, h \rangle_H := \int_0^\infty g(t)^\top h(t) dt$  for  $g, h \in H$ . By identifying  $W(t, \omega)$  with the value  $\omega(t)$  at time *t* of an element  $\omega \in \mathcal{C}_0([0, +\infty); \mathbb{R}^m)$ , we take  $\Omega = \mathcal{C}_0([0, +\infty); \mathbb{R}^m)$  as the Wiener space and  $\tilde{\mathbb{P}}$  as the Wiener measure. For  $g = (g^1, \ldots, g^m) \in H$ , we set

$$W(g) := \sum_{k=1}^{m} \int_{0}^{\infty} g^{k}(t) \mathrm{d}W^{k}(t).$$

#### 3.2 Weak convergence rate

Denote by S the class of smooth random variables such that  $G \in S$  has the form  $G = f(W(g_1), \ldots, W(g_n))$ , where  $f \in C^{\infty}_{pol}(\mathbb{R}^n; \mathbb{R}), g_i \in H, i = 1, \ldots, n$ . Here,  $C^{\infty}_{pol}(\mathbb{R}^n; \mathbb{R})$  is the space of all real-valued smooth functions on  $\mathbb{R}^n$  whose partial derivatives have at most polynomial growth. The Malliavin derivative of a smooth random variable G is an H-valued random variable given by

$$DG = \sum_{i=1}^{n} \frac{\partial f}{\partial x_i} (W(g_1), \dots, W(g_n))g_i,$$

which is also an *m*-dimensional stochastic process  $DG = \{D_rG, r \ge 0\}$  with

$$D_r G = \sum_{i=1}^n \partial_i f(W(g_1), \dots, W(g_n)) g_i(r).$$

For any  $p \geq 1$ , we denote the domain of D in  $L^p(\Omega)$  by  $\mathbb{D}^{1,p}$ , meaning that  $\mathbb{D}^{1,p}$  is the closure of S with respect to the norm  $||G||_{1,p} := (\mathbb{E}[|G|^p + ||DG||_H^p])^{\frac{1}{p}}$ . For  $F \in \mathbb{D}^{1,2}(\mathbb{R}^d)$ , the Malliavin covariance matrix is the symmetric nonnegative random matrix defined by

$$\gamma_F := (\langle DF^i, DF^j \rangle_H)_{1 \le i,j \le d}$$

The iterated derivative  $D^{\alpha}G$  is a random variable with values in  $H^{\otimes \alpha}$ . Precisely, for  $\alpha \in \mathbb{N}_+$ ,  $D^{\alpha}G = \{D_{r_1,\ldots,r_{\alpha}}G, r_i \geq 0, i = 1,\ldots,\alpha\}$  is a measurable function on the product space  $[0, +\infty)^{\alpha} \times \Omega$ . For any  $p \geq 1$  and  $\alpha \in \mathbb{N}_+$ , denote by  $\mathbb{D}^{\alpha,p}$  the completion of  $\mathcal{S}$  with respect to the norm

$$\|G\|_{\alpha,p} := \left( \mathbb{E} \Big[ |G|^p + \sum_{j=1}^{\alpha} \|D^j G\|_{H^{\otimes j}}^p \Big] \right)^{\frac{1}{p}}.$$

For  $G \in \mathbb{D}^{\alpha,p}$  and  $g \in H$ , define the directional derivative by  $D^g G := \langle DG, g \rangle_H$  and by induction,  $D^{g_1,\ldots,g_j}G := \langle DD^{g_1,\ldots,g_{j-1}}G, g_j \rangle_H, j = 2,\ldots,\alpha$ , where  $g_i \in H, i = 1,\ldots,\alpha$ .

Define  $L^{\infty-}(\Omega) := \bigcap_{p \ge 1} L^p(\Omega)$ ,  $\mathbb{D}^{\alpha,\infty} := \bigcap_{p \ge 1} \mathbb{D}^{\alpha,p}$ ,  $\mathbb{D}^{\infty} := \bigcap_{p \ge 1} \bigcap_{\alpha \ge 1} \mathbb{D}^{\alpha,p}$ . Similarly, let V be a real separable Hilbert space and define the space  $\mathbb{D}^{\alpha,p}(V)$  as the completion of V-valued smooth random variables with respect to the norm

$$||G||_{\alpha,p,V} = \left(\mathbb{E}\Big[||G||_{V}^{p} + \sum_{j=1}^{\alpha} ||D^{j}G||_{H^{\otimes j} \otimes V}^{p}\Big]\right)^{\frac{1}{p}}.$$

In this case, the corresponding spaces are denoted by  $L^{\infty-}(\Omega; V)$ ,  $\mathbb{D}^{\alpha,\infty}(V)$  and  $\mathbb{D}^{\infty}(V)$ , respectively.

Let  $D^*$  be the adjoint operator of D. If an H-valued random variable  $\phi \in L^2(\Omega; H)$ satisfies  $|\mathbb{E}[\langle \phi, DX \rangle_H]| \leq K(\phi) ||X||_{L^2(\Omega)}$  for all  $X \in \mathbb{D}^{1,2}$ , then  $\phi \in \text{Dom}(D^*)$  and  $D^*(\phi) \in L^2(\Omega)$  is characterized by

$$\mathbb{E}[\langle \phi, DX \rangle_H] = \mathbb{E}[XD^*(\phi)]. \tag{3.4}$$

We refer to [52, Definition 1.3.1] for more details.

We introduce the functional version of the chain rule for Malliavin derivatives, see e.g. [28] for details.

**Lemma 3.2** Let  $G : \mathcal{C}^d \to \mathbb{R}^d$  be a map with bounded continuous Fréchet derivatives of first and second order. Let  $x_t(r) = x(t+r), r \in [-\tau, 0], t \ge 0$  be a d-dimensional continuous  $\mathcal{F}_t$ -adapted process such that  $x_t(r) \in \mathbb{D}^{1,2}$ . If  $\mathbb{E}\left[|G(x_t)|^2 + \|\mathscr{D}G(x_t)(Dx_t)\|_H^2\right] < \infty$ , then  $G(x_t) \in \mathbb{D}^{1,2}$  and

$$D_{t_1}[G(x_t)] = \mathscr{D}G(x_t)(D_{t_1}x_t(\cdot)),$$

where  $D_{t_1}x_t(\cdot) \in \mathcal{C}^d$  denotes the mapping  $r \to D_{t_1}x_t(r) = D_{t_1}x(t+r)$  and  $\mathscr{D}G$  is the Fréchet derivative of G.

#### 3.2.1.2 Decomposition of the weak error

Without loss of generality, let T be a multiple of  $\tau$ , i.e., there exists a number  $N^{\Delta} \in \mathbb{N}_+$ such that  $T = t_{N^{\Delta}}$ . For any  $Y(\cdot) \in \mathcal{C}([t_i, t_k]; \mathbb{R}^d)$  with  $i, k \in \{-N, \ldots, N^{\Delta}\}$ , by  $Y^{Int}(\cdot)$  we denote the linear interpolation with respect to  $Y(t_i), \ldots, Y(t_k)$ . Let  $\varphi(t; t_i, \eta)$  and  $\varphi_t(t_i, \eta)$ denote the solution and functional solution of the SFDE at time t with initial value  $\eta \in \mathcal{C}^d$ at  $t_i$ ,  $\Phi(t_k; t_i, \eta^{Int})$  and  $\Phi_{t_k}(t_i, \eta^{Int})$  denote the solution and functional solution of the  $\theta$ -EM method at time  $t_k$  with initial value  $\eta^{Int}$  at  $t_i$ . Let  $f \in \mathcal{C}^3_b(\mathbb{R}^d; \mathbb{R})$ . We have the following decomposition

$$\mathbb{E}[f(x(T))] - \mathbb{E}[f(y^{\xi,\Delta}(T))] = \mathbb{E}[f(\varphi(T;0,\xi))] - \mathbb{E}[f(\Phi(T;0,\Phi_0))]$$

$$= \mathbb{E}[f(\Phi(T;t_{N\Delta},\varphi_{t_{N\Delta}}^{Int}(0,\xi)))] - \mathbb{E}[f(\Phi(T;0,\Phi_0))]$$

$$= \mathbb{E}[f(\Phi(T;t_{N\Delta},\varphi_{t_{N\Delta}}^{Int}(0,\xi)))] - \mathbb{E}[f(\Phi(T;t_{N\Delta},\varphi_{t_{N\Delta}}^{Int}(0,\Phi_0)))]$$

$$+ \mathbb{E}[f(\Phi(T;t_{N\Delta},\varphi_{t_{N\Delta}}^{Int}(0,\Phi_0)))] - \mathbb{E}[f(\Phi(T;0,\Phi_0))].$$
(3.5)

We split the term  $\mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \Phi_0)))] - \mathbb{E}[f(\Phi(T; 0, \Phi_0))]$  further as

$$\mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \Phi_{0})))] - \mathbb{E}[f(\Phi(T; 0, \Phi_{0}))] \\
= \sum_{i=1}^{N^{\Delta}} \left\{ \mathbb{E}[f(\Phi(T; t_{i}, \varphi_{t_{i}}^{Int}(0, \Phi_{0})))] - \mathbb{E}[f(\Phi(T; t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0})))] \right\} \\
= \sum_{i=1}^{N^{\Delta}} \mathbb{E}\Big[\mathbb{E}\Big[f(\Phi(T; t_{i}, \varphi_{t_{i}}^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0})))) \\
- f(\Phi(T; t_{i}, \Phi_{t_{i}}(t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0})))) \Big| \mathcal{F}_{t_{i}}\Big]\Big] \\
= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[\mathbb{E}\Big[f'(\Phi(T; t_{i}, Y_{i}^{S}))\mathcal{D}\Phi(T; t_{i}, Y_{i}^{S}) \\
- \left(\varphi_{t_{i}}^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0})) - \Phi_{t_{i}}(t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0}))\right)\Big| \mathcal{F}_{t_{i}}\Big]\Big] d\varsigma \\
= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[f'(\Phi(T; t_{i}, Y_{i}^{S}))\mathcal{D}\Phi(T; t_{i}, Y_{i}^{S}) \\
- \left(\varphi_{t_{i}}^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0})) - \Phi_{t_{i}}(t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0}))\right)\Big] d\varsigma, \quad (3.6)$$

where

$$Y_i^{\varsigma} = \varsigma \varphi_{t_i}^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) + (1 - \varsigma) \Phi_{t_i}(t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_0)).$$
(3.7)

It follows from  $\varphi^{Int}(t_j; 0, \Phi_0) = \varphi(t_j; 0, \Phi_0)$  that

$$\varphi_{t_{i}}^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) - \Phi_{t_{i}}(t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0})) \\
= \sum_{j=-N}^{0} I^{j} \Big( \varphi_{t_{i}}^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0}))(t_{j}) - \Phi_{t_{i}}(t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0}))(t_{j}) \Big) \\
= \sum_{j=-N}^{0} I^{j} \Big( \varphi^{Int}(t_{i}+t_{j};t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) - \Phi(t_{i}+t_{j};t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0}))) \Big) \\
= \sum_{j=-N}^{-1} I^{j} \Big( \varphi(t_{i+j};0,\Phi_{0}) - \varphi^{Int}(t_{i+j};0,\Phi_{0}) \Big) \\
+ I^{0} \Big( \varphi(t_{i};t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) - \Phi(t_{i};t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0}))) \Big) \\
= I^{0} \Big( \varphi(t_{i};t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) - \Phi(t_{i};t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0})) \Big),$$
(3.8)

where  $I^{j}(s) = \frac{N}{\tau}(s - t_{j-1})\mathbf{1}_{\Delta_{j-1}}(s) + \frac{N}{\tau}(t_{j+1} - s)\mathbf{1}_{\Delta_{j}}(s)$  with  $\Delta_{j} = [t_{j}, t_{j+1})$  for  $j = -N + 1, \ldots, -1$ , and  $I^{-N}(s) = \frac{N}{\tau}(t_{-N+1} - s)\mathbf{1}_{\Delta_{-N}}(s)$ , and  $I^{0}(s) = \frac{N}{\tau}(s - t_{-1})\mathbf{1}_{\Delta_{-1}}(s)$  with  $\Delta_{-N} = [-t_{-N}, t_{-N+1})$  and  $\Delta_{-1} = [-t_{-1}, 0]$ .

Note that for any  $i \in \mathbb{N}_+$ ,

$$\varphi(t_{i}; t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0})) - \Phi(t_{i}; t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0})) \\
= \int_{t_{i-1}}^{t_{i}} b(\varphi_{r}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0}))) dr + \int_{t_{i-1}}^{t_{i}} \sigma(\varphi_{r}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0}))) dW(r) \\
- \int_{t_{i-1}}^{t_{i}} \left[ (1 - \theta) b(\varphi_{t_{i-1}}^{Int}(0, \Phi_{0})) + \theta b(\Phi_{t_{i}}(t_{i-1}, \varphi_{t_{i-1}}^{Int}(0, \Phi_{0}))) \right] dr \\
- \int_{t_{i-1}}^{t_{i}} \sigma(\varphi_{t_{i-1}}^{Int}(0, \Phi_{0})) dW(r) = \mathcal{I}_{b}^{i} + \mathcal{I}_{b,\theta}^{i} + \mathcal{I}_{\sigma}^{i},$$
(3.9)

where

$$\begin{split} \mathcal{I}_{b}^{i} &:= \int_{t_{i-1}}^{t_{i}} \left[ b(\varphi_{r}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0}))) - b(\varphi_{t_{i-1}}^{Int}(0,\Phi_{0})) \right] \mathrm{d}r, \\ \mathcal{I}_{b,\theta}^{i} &:= \theta \int_{t_{i-1}}^{t_{i}} \left[ b(\varphi_{t_{i-1}}^{Int}(0,\Phi_{0})) - b(\Phi_{t_{i}}(t_{i-1},\varphi_{t_{i-1}}^{Int}(0,\Phi_{0}))) \right] \mathrm{d}r, \\ \mathcal{I}_{\sigma}^{i} &:= \int_{t_{i-1}}^{t_{i}} \left[ \sigma(\varphi_{r}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0}))) - \sigma(\varphi_{t_{i-1}}^{Int}(0,\Phi_{0})) \right] \mathrm{d}W(r). \end{split}$$

According to (3.5)-(3.9), we derive

$$\begin{split} & \mathbb{E}[f(x(T))] - \mathbb{E}[f(y^{\xi,\Delta}(T))] \\ &= \mathbb{E}[f(\Phi(T;t_{N^{\Delta}},\varphi_{t_{N^{\Delta}}}^{Int}(0,\xi)))] - \mathbb{E}[f(\Phi(T;t_{N^{\Delta}},\varphi_{t_{N^{\Delta}}}^{Int}(0,\Phi_{0})))] \\ &+ \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[f'(\Phi(T;t_{i},Y_{i}^{\varsigma}))\mathcal{D}\Phi(T;t_{i},Y_{i}^{\varsigma})\Big(I^{0}(\mathcal{I}_{b}^{i} + \mathcal{I}_{b,\theta}^{i} + \mathcal{I}_{\sigma}^{i})\Big)\Big] \mathrm{d}\varsigma \\ &= \mathbb{E}[f(\Phi(T;t_{N^{\Delta}},\varphi_{t_{N^{\Delta}}}^{Int}(0,\xi)))] - \mathbb{E}[f(\Phi(T;t_{N^{\Delta}},\varphi_{t_{N^{\Delta}}}^{Int}(0,\Phi_{0})))] \\ &+ \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[\Big\langle (\mathcal{D}\Phi(T;t_{i},Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*}f'(\Phi(T;t_{i},Y_{i}^{\varsigma})), \mathcal{I}_{b}^{i} + \mathcal{I}_{b,\theta}^{i} + \mathcal{I}_{\sigma}^{i} \Big\rangle\Big] \mathrm{d}\varsigma \end{split}$$

$$=\mathcal{I}_0 + \mathcal{I}_b + \mathcal{I}_{b,\theta} + \mathcal{I}_{\sigma},\tag{3.10}$$

where

$$\begin{split} \mathcal{I}_{0} &:= \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \xi)))] - \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \Phi_{0})))], \\ \mathcal{I}_{b} &:= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[\Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*}f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \mathcal{I}_{b}^{i}\Big\rangle\Big]\mathrm{d}\varsigma, \\ \mathcal{I}_{b,\theta} &:= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[\Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*}f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \mathcal{I}_{b,\theta}^{i}\Big\rangle\Big]\mathrm{d}\varsigma, \\ \mathcal{I}_{\sigma} &:= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E}\Big[\Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*}f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \mathcal{I}_{\sigma}^{i}\Big\rangle\Big]\mathrm{d}\varsigma. \end{split}$$

## 3.2.2 Estimates of Malliavin derivatives and Gâteaux derivatives

In this subsection, we show some time-independent estimates of Malliavin derivatives and Gâteaux derivatives of both the exact solution and the numerical solution.

Assumption 3.1 Assume that coefficients b and  $\sigma$  have continuous Gâteaux derivatives.

For any  $\phi, \phi_1 \in C^d$ , and  $t \in \mathbb{R}$ , it follows from Assumption 3.1 and the definition of the Gâteaux derivative that  $b(\phi_1 + t\phi) - b(\phi_1) = t\mathcal{D}b(\phi_1)\phi + o(t)$ . Then based on Assumptions 1.1–1.2, we have

$$\langle \mathcal{D}b(\phi_1)\phi,\phi(0)\rangle \le -a_1|\phi(0)|^2 + a_2 \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r),$$
 (3.11)

$$|\mathcal{D}\sigma(\phi_1)\phi|^2 \le L(|\phi(0)|^2 + \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_1(r)), \qquad (3.12)$$

where  $\phi, \phi_1 \in \mathcal{C}^d$ ; see [16, Eq. (2.4)] for a similar proof.

The following lemmas give some regularity estimates of both the exact solution and the numerical solution.

**Lemma 3.3** Let Assumptions 1.1-1.2 with  $a_1 - a_2 - (2p-1)L > 0$  hold for some  $p \ge 1$ . And let Assumption 3.1 hold. Then for any  $t \ge 0$ ,

$$\mathbb{E}[|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}] \le K \|\eta\|^{2p} e^{-\hat{\lambda}_1 pt},$$
$$\mathbb{E}[||\mathcal{D}x_t^{\tilde{\xi}}\cdot\eta\|^{2p}] \le K \|\eta\|^{2p} e^{-\hat{\lambda}_1 pt},$$

where  $\tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d)$ ,  $\eta \in \mathcal{C}^d$ , and constants  $K, \hat{\lambda}_1 > 0$ .

**Proof.** For  $\eta \in \mathcal{C}^d$ ,  $\mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta$  satisfies

$$\mathrm{d}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta=\mathcal{D}b(x_t^{\tilde{\xi}})\mathcal{D}x_t^{\tilde{\xi}}\cdot\eta\mathrm{d}t+\mathcal{D}\sigma(x_t^{\tilde{\xi}})\mathcal{D}x_t^{\tilde{\xi}}\cdot\eta\mathrm{d}W(t),\quad t>0$$

with the initial datum  $\mathcal{D}x^{\tilde{\xi}}(r) \cdot \eta = \eta(r)$  for  $r \in [-\tau, 0]$ . Let  $\hat{\lambda}_1 \in (0, 1)$  be determined later. Applying the Itô formula, we obtain

$$\begin{split} \mathbf{d}(e^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}) \\ &= \hat{\lambda}_{1}pe^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}\mathbf{d}t + 2pe^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p-2}\Big(\langle \mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta,\mathcal{D}b(x_{t}^{\tilde{\xi}})\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta\rangle\mathbf{d}t \\ &+ \langle \mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta,\mathcal{D}\sigma(x_{t}^{\tilde{\xi}})\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta\mathbf{d}W(t)\rangle\Big) \\ &+ 2p(p-1)e^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p-4}|(\mathcal{D}\sigma(x_{t}^{\tilde{\xi}})\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta)^{\top}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2}\mathbf{d}t \\ &+ pe^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p-2}|\mathcal{D}\sigma(x_{t}^{\tilde{\xi}})\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta|^{2}\mathbf{d}t. \end{split}$$

Combining (3.11)–(3.12), we deduce

$$\begin{split} & e^{\hat{\lambda}_{1}pt}|\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p} \\ &\leq |\eta(0)|^{2p} + \int_{0}^{t}\hat{\lambda}_{1}pe^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}\mathrm{d}s + \int_{0}^{t}2pe^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2}\Big[-a_{1}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2} \\ &+ a_{2}\int_{-\tau}^{0}|\mathcal{D}x^{\tilde{\xi}}(s+r)\cdot\eta|^{2}\mathrm{d}\nu_{2}(r)\Big]\mathrm{d}s + \int_{0}^{t}2pe^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2} \times \\ &\langle \mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta,\mathcal{D}\sigma(x^{\tilde{\xi}}_{s})\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta\mathrm{d}W(s)\rangle + \int_{0}^{t}p(2p-1)e^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2} \times \\ &L\Big[|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2} + \int_{-\tau}^{0}|\mathcal{D}x^{\tilde{\xi}}(s+r)\cdot\eta|^{2}\mathrm{d}\nu_{1}(r)\Big]\mathrm{d}s. \end{split}$$

It follows from the Hölder inequality that

$$\begin{split} &\int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p-2} \int_{-\tau}^{0} |\mathcal{D}x^{\tilde{\xi}}(s+r) \cdot \eta|^{2} \mathrm{d}\nu_{2}(r) \mathrm{d}s \\ &\leq \frac{p-1}{p} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p} \mathrm{d}s + \frac{1}{p} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} \int_{-\tau}^{0} |\mathcal{D}x^{\tilde{\xi}}(s+r) \cdot \eta|^{2p} \mathrm{d}\nu_{2}(r) \mathrm{d}s \\ &= \frac{p-1}{p} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p} \mathrm{d}s + \frac{1}{p} \int_{-\tau}^{0} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s+r) \cdot \eta|^{2p} \mathrm{d}s \mathrm{d}\nu_{2}(r) \\ &\leq \frac{p-1}{p} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p} \mathrm{d}s + \frac{1}{p} e^{\hat{\lambda}_{1}p\tau} \int_{-\tau}^{t} e^{\hat{\lambda}_{1}pz} |\mathcal{D}x^{\tilde{\xi}}(z) \cdot \eta|^{2p} \mathrm{d}z \\ &\leq \frac{1}{p} \tau e^{\hat{\lambda}_{1}p\tau} ||\eta||^{2p} + e^{\hat{\lambda}_{1}p\tau} \int_{0}^{t} e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p} \mathrm{d}s. \end{split}$$

We derive

$$\mathbb{E}[e^{\hat{\lambda}_1 p t} | \mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta|^{2p}] \leq |\eta(0)|^{2p} + p \Big( \hat{\lambda}_1 - 2a_1 + 2a_2 e^{\hat{\lambda}_1 p \tau} + (2p-1)L(1+e^{\hat{\lambda}_1 p \tau}) \Big) \times \int_0^t e^{\hat{\lambda}_1 p s} \mathbb{E}[|\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p}] \mathrm{d}s + (2a_2 + (2p-1)L)\tau e^{\hat{\lambda}_1 p \tau} ||\eta||^{2p}.$$

Take a sufficiently small number  $\hat{\lambda}_1 > 0$  such that  $\hat{\lambda}_1 - 2a_1 + 2a_2e^{\hat{\lambda}_1p\tau} + (2p-1)L + (2p-1)Le^{\hat{\lambda}_1p\tau} < 0$ . This gives  $\mathbb{E}[e^{\hat{\lambda}_1pt}|\mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta|^{2p}] \leq K \|\eta\|^{2p}$ . Moreover, applying the Burkholder–Davis–Gundy inequality, we have

$$\mathbb{E}\Big[\sup_{\substack{0\vee(t-\tau)\leq r\leq t}} e^{\hat{\lambda}_{1}pr} |\mathcal{D}x^{\tilde{\xi}}(r)\cdot\eta|^{2p}\Big] \leq |\eta(0)|^{2p} + (2a_{2} + (2p-1)L)\tau e^{\hat{\lambda}_{1}p\tau} ||\eta||^{2p} \\
+ \mathbb{E}\Big[\sup_{\substack{0\vee(t-\tau)\leq r\leq t}} \int_{0}^{r} 2p e^{\hat{\lambda}_{1}ps} |\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2} \langle \mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta, \mathcal{D}\sigma(x^{\tilde{\xi}}_{s})\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta \mathrm{d}W(s) \rangle\Big]$$

$$\leq K \|\eta\|^{2p} + \mathbb{E}\Big[\sup_{0 \lor (t-\tau) \le r \le t} \int_{0 \lor (t-\tau)}^{r} 2p e^{\hat{\lambda}_{1} ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p-2} \langle \mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta, \\ \mathcal{D}\sigma(x_{s}^{\tilde{\xi}}) \mathcal{D}x_{s}^{\tilde{\xi}} \cdot \eta \mathrm{d}W(s) \rangle\Big]$$

$$\leq K \|\eta\|^{2p} + K \mathbb{E}\Big[\Big(\int_{0 \lor (t-\tau)}^{t} e^{2\hat{\lambda}_{1} ps} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{4p-2} |\mathcal{D}\sigma(x_{s}^{\tilde{\xi}}) \mathcal{D}x_{s}^{\tilde{\xi}} \cdot \eta|^{2} \mathrm{d}s\Big)^{\frac{1}{2}}\Big]$$

$$\leq K \|\eta\|^{2p} + K \mathbb{E}\Big[\sup_{0 \lor (t-\tau) \le s \le t} e^{\hat{\lambda}_{1} (p-\frac{1}{2})s} |\mathcal{D}x^{\tilde{\xi}}(s) \cdot \eta|^{2p-1} \times \Big(\int_{0 \lor (t-\tau)}^{t} e^{\hat{\lambda}_{1} s} |\mathcal{D}\sigma(x_{s}^{\tilde{\xi}}) \mathcal{D}x_{s}^{\tilde{\xi}} \cdot \eta|^{2} \mathrm{d}s\Big)^{\frac{1}{2}}\Big].$$

According to the Young inequality, (3.12), and the Hölder inequality, we obtain

$$\begin{split} & \mathbb{E}\Big[\sup_{0\vee(t-\tau)\leq r\leq t}e^{\hat{\lambda}_{1}pr}|\mathcal{D}x^{\tilde{\xi}}(r)\cdot\eta|^{2p}\Big] \\ &\leq K\|\eta\|^{2p} + \frac{1}{2}\mathbb{E}\Big[\sup_{0\vee(t-\tau)\leq s\leq t}e^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}\Big] \\ &+ K\mathbb{E}\Big[\Big(\int_{0\vee(t-\tau)}^{t}e^{\hat{\lambda}_{1}s}(|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2} + \int_{-\tau}^{0}|\mathcal{D}x^{\tilde{\xi}}(s+r)\cdot\eta|^{2}\mathrm{d}\nu_{1}(r))\mathrm{d}s\Big)^{p}\Big] \\ &\leq K\|\eta\|^{2p} + \frac{1}{2}\mathbb{E}\Big[\sup_{0\vee(t-\tau)\leq s\leq t}e^{\hat{\lambda}_{1}ps}|\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}\Big] \\ &+ \tau^{p-1}K\int_{0\vee(t-\tau)}^{t}\sup_{-\tau\leq r\leq s}\mathbb{E}\big[e^{\hat{\lambda}_{1}pr}|\mathcal{D}x^{\tilde{\xi}}(r)\cdot\eta|^{2p}\big]\mathrm{d}s. \end{split}$$

It follows from  $\mathbb{E}[e^{\hat{\lambda}_1 pt} | \mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta|^{2p}] \leq K \|\eta\|^{2p}$  that

$$e^{\hat{\lambda}_1 p(0 \vee (t-\tau))} \mathbb{E}[\|\mathcal{D}x_t^{\tilde{\xi}} \cdot \eta\|^{2p}] \le K \|\eta\|^{2p},$$

which gives

$$\mathbb{E}[\|\mathcal{D}x_t^{\tilde{\xi}} \cdot \eta\|^{2p}] \le K \|\eta\| e^{-\hat{\lambda}_1 p t}.$$

The proof is finished.  $\Box$ 

**Lemma 3.4** Let Assumptions 1.1–1.2 with  $a_1 - a_2 - (2p-1)L > 0$  hold for some  $p \ge 1$ . And let Assumptions 2.1 and 3.1 hold. Then for any  $t \ge 0$  and  $u \ge -\tau$ ,

$$\mathbb{E}[\|D_u x_t^{\tilde{\xi}}\|^{2p}] \le K e^{-\hat{\lambda}_1 p(t-u)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}]),$$

where  $\tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d)$  and  $D_u \tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d \otimes \mathbb{R}^m)$ , K > 0, and  $\hat{\lambda}_1 > 0$  is given in Lemma 3.3.

**Proof.** When  $0 \le u \le t$ ,  $D_u x^{\tilde{\xi}}(t)$  satisfies

$$D_{u}x^{\tilde{\xi}}(t) = \int_{u}^{t} \mathcal{D}b(x_{s}^{\tilde{\xi}})D_{u}x_{s}^{\tilde{\xi}}\mathrm{d}s + \int_{u}^{t} \mathcal{D}\sigma(x_{s}^{\tilde{\xi}})D_{u}x_{s}^{\tilde{\xi}}\mathrm{d}W(s) + \sigma(x_{u}^{\tilde{\xi}})\mathbf{1}_{[0,t]}(u) + D_{u}\tilde{\xi}(0).$$

## 3.2 Weak convergence rate

By the Itô formula, we derive

$$\begin{split} \mathbf{d}(e^{\hat{\lambda}_{1}pt}|D_{u}x^{\tilde{\xi}}(t)|^{2p}) &\leq \hat{\lambda}_{1}pe^{\hat{\lambda}_{1}pt}|D_{u}x^{\tilde{\xi}}(t)|^{2p}\mathbf{d}t + 2pe^{\hat{\lambda}_{1}pt}|D_{u}x^{\tilde{\xi}}(t)|^{2p-2} \times \\ \left( \langle D_{u}x^{\tilde{\xi}}(t), \mathcal{D}b(x^{\tilde{\xi}}_{t})D_{u}x^{\tilde{\xi}}_{t} \rangle \mathbf{d}t + \langle D_{u}x^{\tilde{\xi}}(t), \mathcal{D}\sigma(x^{\tilde{\xi}}_{t})D_{u}x^{\tilde{\xi}}_{t} \mathbf{d}W(t) \rangle \right) \\ &+ p(2p-1)e^{\hat{\lambda}_{1}pt}|D_{u}x^{\tilde{\xi}}(t)|^{2p-2}|\mathcal{D}\sigma(x^{\tilde{\xi}}_{t})D_{u}x^{\tilde{\xi}}_{t}|^{2}\mathbf{d}t. \end{split}$$

Similar to the proof of Lemma 3.3, we have

$$\mathbb{E}[e^{\hat{\lambda}_{1}pt}|D_{u}x^{\tilde{\xi}}(t)|^{2p}] \leq K\mathbb{E}[e^{\hat{\lambda}_{1}pu}(|\sigma(x_{u}^{\tilde{\xi}})|^{2p} + |D_{u}\tilde{\xi}(0)|^{2p})] + p(\hat{\lambda}_{1} - 2a_{1} + 2a_{2}e^{\hat{\lambda}_{1}p\tau} + (2p-1)L(1+e^{\hat{\lambda}_{1}p\tau}))\int_{u}^{t}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}x^{\tilde{\xi}}(s)|^{2p}]ds + (2a_{2} + (2p-1)L)\tau e^{\hat{\lambda}_{1}p\tau}||D_{u}\tilde{\xi}||^{2p} \leq K\mathbb{E}[e^{\hat{\lambda}_{1}pu}(|\sigma(x_{u}^{\tilde{\xi}})|^{2p} + |D_{u}\tilde{\xi}(0)|^{2p}] + (2a_{2} + (2p-1)L)\tau e^{\hat{\lambda}_{1}p\tau}||D_{u}\tilde{\xi}||^{2p},$$

where we used the facts  $D_u x^{\tilde{\xi}}(s) = 0$  for  $u \ge s$  and

$$\int_{u}^{t} \int_{-\tau}^{0} e^{\hat{\lambda}_{1}ps} |D_{u}x_{s}^{\tilde{\xi}}(r)|^{2p} \mathrm{d}\nu_{i}(r) \mathrm{d}s = \int_{0}^{t} \int_{-\tau}^{0} e^{\hat{\lambda}_{1}ps} |D_{u}x_{s}^{\tilde{\xi}}(r)|^{2p} \mathrm{d}\nu_{i}(r) \mathrm{d}s$$
$$\leq \tau e^{\hat{\lambda}_{1}p\tau} \|D_{u}\tilde{\xi}\|^{2p} + e^{\hat{\lambda}_{1}p\tau} \int_{u}^{t} e^{\hat{\lambda}_{1}ps} |D_{u}x^{\tilde{\xi}}(s)|^{2p} \mathrm{d}s, \quad i = 1, 2.$$

This, along with Assumption 1.1 and Lemma 2.1 implies that

$$\mathbb{E}[|D_u x^{\tilde{\xi}}(t)|^{2p}] \le K e^{-\hat{\lambda}_1 p(t-u)} (1 + \mathbb{E}[||D_u \tilde{\xi}||^{2p}]).$$

Moreover,

$$\begin{split} & \mathbb{E}\Big[\sup_{u\vee(t-\tau)\leq r\leq t} e^{\hat{\lambda}_{1}pr} |D_{u}x^{\tilde{\xi}}(r)|^{2p}\Big] \\ &\leq Ke^{\hat{\lambda}_{1}pu} \mathbb{E}[|\sigma(x_{u}^{\tilde{\xi}})|^{2p} + |D_{u}\tilde{\xi}(0)|^{2p}\mathbf{1}_{[-\tau,0]}(u)] + (2a_{2} + (2p-1)L)\tau e^{\hat{\lambda}_{1}p\tau} ||D_{u}\tilde{\xi}||^{2p} \\ &+ \mathbb{E}\Big[\sup_{u\vee(t-\tau)\leq r\leq t} \int_{u}^{r} 2pe^{\hat{\lambda}_{1}ps} \Big\langle |D_{u}x^{\tilde{\xi}}(s)|^{2p-2}D_{u}x^{\tilde{\xi}}(s), \mathcal{D}\sigma(x_{s}^{\tilde{\xi}})D_{u}x_{s}^{\tilde{\xi}}dW(s)\Big\rangle\Big] \\ &\leq Ke^{\hat{\lambda}_{1}pu}(1 + \mathbb{E}[||D_{u}\tilde{\xi}||^{2p}]) + K\mathbb{E}\Big[\Big(\int_{u\vee(t-\tau)}^{t} e^{2\hat{\lambda}_{1}ps} |D_{u}x^{\tilde{\xi}}(s)|^{4p-2} |\mathcal{D}\sigma(x_{s}^{\tilde{\xi}})D_{u}x_{s}^{\tilde{\xi}}|^{2}ds\Big)^{\frac{1}{2}}\Big] \\ &\leq Ke^{\hat{\lambda}_{1}pu}(1 + \mathbb{E}[||D_{u}\tilde{\xi}||^{2p}]) \\ &+ K\mathbb{E}\Big[\Big(\sup_{u\vee(t-\tau)\leq s\leq t} e^{\hat{\lambda}_{1}(p-\frac{1}{2})s} |D_{u}x^{\tilde{\xi}}(s)|^{2p-1}\Big)\Big(\int_{u\vee(t-\tau)}^{t} e^{\hat{\lambda}_{1}s} |\mathcal{D}\sigma(x_{s}^{\tilde{\xi}})D_{u}x_{s}^{\tilde{\xi}}|^{2}ds\Big)^{\frac{1}{2}}\Big]. \end{split}$$

Applying the Young inequality, we derive

$$\begin{split} & \mathbb{E}\Big[\sup_{u\vee(t-\tau)\leq r\leq t}e^{\hat{\lambda}_{1}pr}|D_{u}x^{\tilde{\xi}}(r)|^{2p}\Big]\\ &\leq Ke^{\hat{\lambda}_{1}pu}(1+\mathbb{E}[\|D_{u}\tilde{\xi}\|^{2p}]) + \frac{1}{2}\mathbb{E}\Big[\sup_{u\vee(t-\tau)\leq s\leq t}e^{\hat{\lambda}_{1}ps}|D_{u}x^{\tilde{\xi}}(s)|^{2p}\Big]\\ &+ K\mathbb{E}\Big[\Big(\int_{u\vee(t-\tau)}^{t}e^{\hat{\lambda}_{1}s}|\mathcal{D}\sigma(x^{\tilde{\xi}}_{s})D_{u}x^{\tilde{\xi}}_{s}|^{2}\mathrm{d}s\Big)^{p}\Big]\\ &\leq Ke^{\hat{\lambda}_{1}pu}(1+\mathbb{E}[\|D_{u}\tilde{\xi}\|^{2p}]) + \frac{1}{2}\mathbb{E}\Big[\sup_{u\vee(t-\tau)\leq s\leq t}e^{\hat{\lambda}_{1}ps}|D_{u}x^{\tilde{\xi}}(s)|^{2p}\Big] \end{split}$$

$$+ \tau^{p-1} K \int_{u \vee (t-\tau)}^{t} e^{\hat{\lambda}_1 ps} (\sup_{s-\tau \leq r \leq s} \mathbb{E}[|D_u x^{\tilde{\xi}}(r)|^{2p}]) \mathrm{d}s$$
  
$$\leq K e^{\hat{\lambda}_1 pu} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}]) + \tau^p K e^{\hat{\lambda}_1 pu} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}]).$$

Hence,

$$e^{\hat{\lambda}_1 p(t-\tau)} \mathbb{E}[\|D_u x_t^{\tilde{\xi}}\|^{2p}] \le K e^{\hat{\lambda}_1 p u} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}]),$$

which implies

$$\mathbb{E}[\|D_u x_t^{\tilde{\xi}}\|^{2p}] \le K e^{\hat{\lambda}_1 p(u-t)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}]).$$

We complete the proof.  $\hfill \square$ 

**Lemma 3.5** Let Assumptions 1.1–1.2, 2.2, and 3.1 hold. Then for  $p \in \mathbb{N}_+$ , there exists a number  $a_1^*(L, a_2, \theta, p) > 0$  such that for  $a_1 > a_1^*$  and  $\Delta \in (0, 1]$ ,

$$\mathbb{E}[\|\mathcal{D}y_{t_k}^{\xi,\Delta} \cdot \eta\|^{2p}] \le K e^{-\hat{\lambda}_2 p t_k} \|\eta\|^{2p} (1 + \mathbb{E}[\|\tilde{\xi}\|^{2p\beta}]),$$

where  $\tilde{\xi} \in L^{2p\beta}(\Omega; \mathcal{C}^d), \ \eta \in \mathcal{C}^d, \ and \ K, \hat{\lambda}_2 > 0.$ 

**Proof.** For the case of p = 1, one can obtain the result by using the similar technique to that in Lemma 2.2. We are in the position to show the proof of p > 1.

Step 1: Case of 
$$\Delta \in (0, \Delta^*]$$
 with some  $\Delta^* \in (0, 1]$ . We have that for  $k \in \mathbb{N}$ ,

$$\begin{split} & \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1})\cdot\eta|^{2p}] \\ &\leq A^{p}_{\theta,\Delta}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + p\mathbb{E}[\mathcal{I}_{1}] + \frac{p(p-1)}{2}\mathbb{E}[\mathcal{I}_{2}] + \sum_{i=3}^{p}C^{i}_{p}\mathbb{E}[\mathcal{I}_{i}] \\ &\leq (1+p(2a_{2}+L)\epsilon_{1}\Delta + \frac{16p(p-1)}{2}\epsilon_{1}\Delta + K\Delta^{2})A^{p}_{\theta,\Delta}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] \\ &\quad -\Delta p(1+\epsilon_{1})^{-1}(2a_{1}-\frac{2\theta-1}{\theta^{2}}-L)A^{p-1}_{\theta,\Delta}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] \\ &\quad +\frac{2pa_{2}}{\epsilon_{1}^{p-1}}\Delta \int_{-\tau}^{0}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(r)\cdot\eta|^{2p}]d\nu_{2}(r) + \frac{pL}{\epsilon_{1}^{p-1}}\Delta \int_{-\tau}^{0}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(r)\cdot\eta|^{2p}]d\nu_{1}(r) \\ &\quad +\frac{p(p-1)L}{2}(\frac{8}{\epsilon_{1}^{p-1}} + \frac{4}{\epsilon_{1}^{\frac{p-2}{2}}}\frac{1}{\theta^{p}})\Delta\mathbb{E}\left[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p} + \int_{-\tau}^{0}|\mathcal{D}y^{\tilde{\xi},\Delta}(r)\cdot\eta|^{2p}d\nu_{1}(r)\right] \\ &\quad +\frac{2p(p-1)}{\theta^{p}\epsilon_{1}^{\frac{p-2}{2}}}\Delta\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + (K\Delta^{2} + K(\epsilon_{1})\Delta^{p})\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] \\ &\quad + K\Delta^{2}\mathbb{E}\left[\int_{-\tau}^{0}|\mathcal{D}y^{\tilde{\xi},\Delta}(r)\cdot\eta|^{2p}d\nu_{1}(r)\right] \\ &\quad + (K\Delta^{2} + K(\epsilon_{1})\Delta^{p})\mathbb{E}\left[\int_{-\tau}^{0}|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p} + \Delta J_{1,k} + \Delta^{2}J_{2,k}, \end{split}$$

where

$$\begin{split} J_{1,k} &:= -p(1+\epsilon_1)^{-1}(2a_1 - \frac{2\theta - 1}{\theta^2} - L)A_{\theta,\Delta}^{p-1}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k) \cdot \eta|^{2p}] \\ &+ \frac{2pa_2}{\epsilon_1^{p-1}} \int_{-\tau}^0 \mathbb{E}[|\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}(r) \cdot \eta|^{2p}] \mathrm{d}\nu_2(r) + \frac{pL}{\epsilon_1^{p-1}} \int_{-\tau}^0 \mathbb{E}[|\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}(r) \cdot \eta|^{2p}] \mathrm{d}\nu_1(r) \\ &+ \frac{p(p-1)L}{2} (\frac{8}{\epsilon_1^{p-1}} + \frac{4}{\epsilon_1^{\frac{p-2}{2}}} \frac{1}{\theta^p}) \mathbb{E}\Big[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k) \cdot \eta|^{2p} + \int_{-\tau}^0 |\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}(r) \cdot \eta|^{2p} \mathrm{d}\nu_1(r)\Big] \\ &+ \frac{2p(p-1)}{\theta^p \epsilon_1^{\frac{p-2}{2}}} \mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k) \cdot \eta|^{2p}], \\ J_{2,k} &:= (K + K(\epsilon_1)\Delta^{p-2}) \mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k) \cdot \eta|^{2p}] + K \mathbb{E}\Big[\int_{-\tau}^0 |\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}(r) \cdot \eta|^{2p} \mathrm{d}\nu_1(r)\Big] \\ &+ (K + K(\epsilon_1)\Delta^{p-2}) \mathbb{E}\Big[\int_{-\tau}^0 |\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}(r) \cdot \eta|^{2p} \mathrm{d}\nu_2(r)\Big]. \end{split}$$

$$e^{\hat{\lambda}_{2}pt_{k+1}}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1})\cdot\eta|^{2p}]$$

$$=\sum_{l=0}^{k} \left(e^{\hat{\lambda}_{2}pt_{l+1}}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{l+1})\cdot\eta|^{2p}] - e^{\hat{\lambda}_{2}pt_{l}}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{l})\cdot\eta|^{2p}]\right)$$

$$\leq \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(0)\cdot\eta|^{2p}] + \sum_{l=0}^{k} e^{\hat{\lambda}_{2}pt_{l+1}}(\Delta J_{1,l} + \Delta^{2}J_{2,l})$$

$$+ \left((1 + K(\epsilon_{1} + \Delta)\Delta)A_{\theta,\Delta}^{p}e^{\hat{\lambda}_{2}p\Delta} - 1\right)\sum_{l=0}^{k} e^{\hat{\lambda}_{2}pt_{l}}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{l})\cdot\eta|^{2p}].$$
(3.17)

Similar to (2.12), we deduce

$$\Delta \sum_{l=0}^{k} e^{\hat{\lambda}_2 p t_{l+1}} J_{1,l} \leq -R(\epsilon_1, a_1) \Delta \sum_{l=0}^{k} e^{\hat{\lambda}_2 p t_{l+1}} \mathbb{E}[|\mathcal{D}y^{\tilde{\xi}, \Delta}(t_l) \cdot \eta|^{2p}] + K(\epsilon_1) e^{\hat{\lambda}_2 \tau} \tau \mathbb{E}[||\mathcal{D}y_0^{\tilde{\xi}, \Delta} \cdot \eta|^{2p}]$$

and

$$\begin{split} \Delta^2 \sum_{l=0}^k e^{\hat{\lambda}_2 p t_{l+1}} J_{2,l} &\leq \Delta^2 \left( K + K(\epsilon_1) \Delta^{p-2} \right) \sum_{l=0}^k e^{\hat{\lambda}_2 p t_{l+1}} \mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_l) \cdot \eta|^{2p}] \\ &+ K(\epsilon) e^{\hat{\lambda}_2 \tau} \tau \mathbb{E}[||\mathcal{D}y_0^{\tilde{\xi},\Delta} \cdot \eta||^{2p}], \end{split}$$

where

$$R(\epsilon_1, a_1, \hat{\lambda}_2) := p(1+\epsilon_1)^{-1} (2a_1 - \frac{2\theta - 1}{\theta^2} - L) A_{\theta, \Delta}^{p-1} - \frac{2pa_2 e^{\lambda_2 \tau}}{\epsilon_1^{p-1}} - \frac{pL e^{\lambda_2 \tau}}{\epsilon_1^{p-1}} - \frac{p(p-1)L(1+e^{\hat{\lambda}_2 \tau})}{2} (\frac{8}{\epsilon_1^{p-1}} + \frac{4}{\epsilon_1^{p-2}} \frac{1}{\theta^p}) - \frac{2p(p-1)}{\theta^p \epsilon_1^{p-2}}.$$

Note that

$$A_{\theta,\Delta} = 1 - \frac{(2\theta - 1)\Delta}{\theta^2(1 + \Delta)} \le e^{-\frac{(2\theta - 1)}{\theta^2(1 + \Delta)}\Delta}$$

implies

$$(1 + K(\epsilon_1 + \Delta)\Delta)A^p_{\theta,\Delta}e^{\epsilon p\Delta} - 1 \le e^{K(\epsilon_1 + \Delta + \hat{\lambda}_2 p - \frac{p(2\theta - 1)}{\theta^2(1 + \Delta)})\Delta} - 1.$$

Let  $\epsilon_1 \in (0, \frac{p(2\theta-1)}{2\theta^2})$  and denote

$$R^*(\epsilon_1, a_1, \hat{\lambda}_2) := p(1+\epsilon_1)^{-1} (2a_1 - \frac{2\theta - 1}{\theta^2} - L) \left(\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta - 1}{2\theta^2}\right)^{p-1} - \frac{2pa_2 e^{\hat{\lambda}_2 \tau}}{\epsilon_1^{p-1}} - \frac{pLe^{\hat{\lambda}_2 \tau}}{\epsilon_1^{p-1}} - \frac{p(p-1)L(1+e^{\hat{\lambda}_2 \tau})}{2} \left(\frac{8}{\epsilon_1^{p-1}} + \frac{4}{\epsilon_1^{p-2}}\frac{1}{\theta^p}\right) - \frac{2p(p-1)}{\theta^p \epsilon_1^{p-2}}.$$

Take a sufficiently large number  $a_1^*$  such that  $R^*(\epsilon_1, a_1^*, 0) < 0$ . Choose a sufficiently small number  $\hat{\lambda}_2$  such that  $\epsilon_1 + \hat{\lambda}_2 p < \frac{p(2\theta-1)}{2\theta^2}$  and  $R^*(\epsilon_1, a_1^*, \hat{\lambda}_2) < 0$ . Furthermore, there exists a number  $\Delta^* \in (0, 1]$  such that for any  $\Delta \in (0, \Delta^*]$ ,  $\epsilon_1 + \Delta + \hat{\lambda}_2 p - \frac{p(2\theta-1)}{2\theta^2} < 0$  and  $R(\epsilon_1, \hat{a}_1^*, \hat{\lambda}_2) + \Delta(K + K(\epsilon_1)\Delta^{p-2}) < 0$ . Hence, combining (3.13) we have that for  $a_1 > a_1^*$ ,  $\hat{\lambda}_2 \in (0, \hat{\lambda}_2]$ , and  $\Delta \in (0, \Delta^*]$ ,

$$e^{\hat{\lambda}_2 p t_{k+1}} \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1}) \cdot \eta|^{2p}] \leq \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(0) \cdot \eta|^{2p}] + K e^{\hat{\lambda}_2 \tau} \tau \mathbb{E}[||\mathcal{D}y_0^{\tilde{\xi},\Delta} \cdot \eta||^{2p}] \\ \leq K \|\eta\|^{2p} + K \mathbb{E}[||\mathcal{D}b(\tilde{\xi}) \cdot \eta||^{2p}].$$

According to Assumptions 2.2 and 3.1, we have

$$\|\mathcal{D}b(\tilde{\xi}) \cdot \eta\| \le (1 + \|\tilde{\xi}\|^{\beta}) \|\eta\|,$$

which implies

$$e^{\hat{\lambda}_2 p t_{k+1}} \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1}) \cdot \eta|^{2p}] \le K \|\eta\|^{2p} (1 + \mathbb{E}[\|\tilde{\xi}\|^{2p\beta}]).$$

It follow from (3.13) that

$$e^{\hat{\lambda}_2 p t_{k+1}} \mathbb{E}[|\mathcal{D}y^{\tilde{\xi}, \Delta}(t_{k+1}) \cdot \eta|^{2p}] \le K \|\eta\|^{2p} (1 + \mathbb{E}[\|\tilde{\xi}\|^{2p\beta}]).$$

Step 2: Case of  $\Delta \in [\Delta^*, 1]$ . Similarly, we have that for any  $\epsilon_2 \in (0, 1)$ ,

$$\begin{split} \mathbb{E}[\mathcal{I}_{1}] &\leq -\Delta(1+\epsilon_{2})^{-1}(2a_{1}-\frac{2\theta-1}{\theta^{2}}-L)A_{\theta,\Delta}^{p-1}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + (2a_{2}+L)\times\\ \epsilon_{2}A_{\theta,\Delta}^{p}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + K(\epsilon_{2})(1+\epsilon_{2})^{-1}\Delta^{p}(2a_{1}-\frac{2\theta-1}{\theta^{2}}-L)A_{\theta,\Delta}^{p-1}\times\\ \mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + (K(\epsilon_{2})(1+\epsilon_{2})^{-1}+\frac{2a_{2}}{\epsilon_{2}^{p-1}})\Delta^{p}\int_{-\tau}^{0}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}_{t_{k}}(r)\cdot\eta|^{2p}]d\nu_{2}(r)\\ &+\frac{L}{\epsilon_{2}^{p-1}}\Delta^{p}\int_{-\tau}^{0}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}_{t_{k}}(r)\cdot\eta|^{2p}]d\nu_{1}(r), \end{split}$$

$$\begin{split} \mathbb{E}[\mathcal{I}_{2}] &\leq 17\epsilon_{2}A_{\theta,\Delta}^{p}\mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] + (\frac{8}{\epsilon_{2}^{p-1}}\Delta^{p} + \frac{4}{\epsilon_{2}^{p-2}}\frac{1}{\theta^{p}}\Delta^{\frac{p}{2}})L \times \\ \mathbb{E}\Big[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p} + \int_{-\tau}^{0}|\mathcal{D}y_{t_{k}}^{\tilde{\xi},\Delta}(r)\cdot\eta|^{2p}\mathrm{d}\nu_{1}(r)\Big] \\ &+ \frac{4}{\epsilon_{2}^{p-2}}\frac{1}{\theta^{p}}\Delta^{\frac{p}{2}}|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p} + K(\epsilon_{2})\Delta^{p}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2p}] \\ &+ K(\epsilon_{2})\Delta^{p}\mathbb{E}\Big[\int_{-\tau}^{0}|\mathcal{D}y^{\tilde{\xi},\Delta}_{t_{k}}(r)\cdot\eta|^{2p}\mathrm{d}\nu_{1}(r) + \int_{-\tau}^{0}|\mathcal{D}y^{\tilde{\xi},\Delta}_{t_{k}}(r)\cdot\eta|^{2p}\mathrm{d}\nu_{2}(r)\Big] \end{split}$$

and for  $i \in \{3, \ldots, p\}$ ,

$$\mathbb{E}[\mathcal{I}_i] \leq K \epsilon_2 A^p_{\theta, \Delta} \mathbb{E}[|\mathcal{D}z^{\tilde{\xi}, \Delta}(t_k) \cdot \eta|^{2p}] + K(\epsilon_2) \Delta^{\frac{p}{2}} \mathbb{E}[|\mathcal{D}y^{\tilde{\xi}, \Delta}(t_k) \cdot \eta|^{2p}] \\ + K(\epsilon_2) \Delta^{\frac{p}{2}} \mathbb{E}\Big[\int_{-\tau}^0 |\mathcal{D}y^{\tilde{\xi}, \Delta}_{t_k}(r) \cdot \eta|^{2p} \mathrm{d}\nu_1(r) + \int_{-\tau}^0 |\mathcal{D}y^{\tilde{\xi}, \Delta}_{t_k}(r) \cdot \eta|^{2p} \mathrm{d}\nu_2(r)\Big].$$

Hence,

$$\begin{split} e^{\hat{\lambda}_{2}pt_{k+1}} \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1})\cdot\eta|^{2p}] &\leq \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(0)\cdot\eta|^{2p}] + [(1+K\epsilon_{2})A_{\theta,\Delta}^{p}e^{\hat{\lambda}_{2}p\Delta} - 1] \times \\ \sum_{l=0}^{k} e^{\hat{\lambda}_{2}pt_{l}} \mathbb{E}[|\mathcal{D}z^{\tilde{\xi},\Delta}(t_{l})\cdot\eta|^{2p}] - \left(p(1+\epsilon_{2})^{-1}(2a_{1}-\frac{2\theta-1}{\theta^{2}}-L)A_{\theta,\Delta}^{p-1} - (\frac{2pa_{2}e^{\hat{\lambda}_{2}\tau}}{\epsilon_{2}^{p-1}}\right) \\ &+ \frac{pLe^{\hat{\lambda}_{2}\tau}}{\epsilon_{2}^{p-1}})\Delta^{p-1} - \frac{p(p-1)L(1+e^{\hat{\lambda}_{2}\tau})}{2}(\frac{8}{\epsilon_{2}^{p-1}}\Delta^{p-1} + \frac{4}{\epsilon_{2}^{p-2}}\frac{1}{\theta^{p}}\Delta^{\frac{p-2}{2}}) \\ &- K(\epsilon_{2})\Delta^{\frac{p-2}{2}}\right)\Delta\sum_{l=0}^{k} e^{\hat{\lambda}_{2}pt_{l+1}}\mathbb{E}[|\mathcal{D}y^{\tilde{\xi},\Delta}(t_{l})\cdot\eta|^{2p}] + Ke^{\hat{\lambda}_{2}\tau}\tau\mathbb{E}[||\mathcal{D}y^{\tilde{\xi},\Delta}\cdot\eta||^{2p}]. \end{split}$$

Noting

$$(1+K\epsilon_2)A^p_{\theta,\Delta}e^{\hat{\lambda}_2p\Delta} \le e^{K\epsilon_2+\lambda_2p\Delta-\frac{p(2\theta-1)\Delta^*}{2\theta^2}},$$

choose a sufficiently small number  $\epsilon_2 > 0$  such that  $K\epsilon_2 < \frac{p(2\theta-1)\Delta^*}{2\theta^2}$ . Letting  $a_1^*$  be sufficiently large such that

$$p(1+\epsilon_2)^{-1}(2a_1^* - \frac{2\theta - 1}{\theta^2} - L)\left(\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta - 1}{2\theta^2}\right)^{p-1} - \left(\frac{2pa_2}{\epsilon_2^{p-1}} + \frac{pL}{\epsilon_2^{p-1}}\right)(\Delta^*)^{p-1} - p(p-1)L\left(\frac{8}{\epsilon_2^{p-1}}(\Delta^*)^{p-1} + \frac{4}{\epsilon_2^{\frac{p-2}{2}}}\frac{1}{\theta^p}(\Delta^*)^{\frac{p-2}{2}}\right) - K(\epsilon_2)(\Delta^*)^{\frac{p-2}{2}} > 0.$$

Letting  $\hat{\lambda}_2 \in (0, \hat{\lambda}_2]$  be sufficiently small, we obtain that for  $a_1 \ge a_1^*$  and  $\Delta \in (\Delta^*, 1]$ ,

$$e^{\lambda_2 p t_{k+1}} \mathbb{E}[\|\mathcal{D} z_{t_k}^{\xi, \Delta} \cdot \eta\|^{2p}] \le K(\|\mathcal{D} z_0^{\xi, \Delta} \cdot \eta\|^{2p} + \|\mathcal{D} y_0^{\xi, \Delta} \cdot \eta\|^{2p}) \le K\|\eta\|^{2p}(1 + \mathbb{E}[\|\tilde{\xi}\|^{2p\beta}]).$$

Therefore, similar to the proof of Proposition 2.3, the desired argument follows from Steps 1–2 and (3.15). The proof is completed.  $\Box$ 

**Lemma 3.6** Let Assumptions 1.1–1.2 and 3.1 hold. Then for  $p \in \mathbb{N}_+$ ,  $a_1 > a_1^*$ , and  $\Delta \in (0, 1]$ ,

$$\mathbb{E}[\|D_u y_{t_k}^{\tilde{\xi}, \Delta}\|^{2p}] \le K e^{-\hat{\lambda}_2 p(t_k - u)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{2p}] + \mathbb{E}[|\mathcal{D}b(\tilde{\xi}) D_u \tilde{\xi}|^{2p}]),$$

where  $\tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d)$ ,  $D_u \tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d \otimes \mathbb{R}^m)$ ,  $\mathcal{D}b(\tilde{\xi})D_u \tilde{\xi} \in L^{2p}(\Omega; \mathbb{R}^{d \times m})$ ,  $\eta \in \mathcal{C}^d$ , K > 0, and  $a_1^*$ ,  $\hat{\lambda}_2 > 0$  are given in Lemma 3.5.

**Proof.** The proof is similar to that of Lemma 3.5 and is omitted.

**Assumption 3.2** Assume that coefficients b and  $\sigma$  have continuous derivatives up to order 2 satisfying that for any  $\phi, \phi_1, \phi_2 \in C^d$ ,

$$\begin{aligned} |\mathcal{D}^2 b(\phi)(\phi_1,\phi_2)| &\leq K(1+\|\phi\|^{(\beta-1)\vee 0}) \|\phi_1\| \|\phi_2\|, \\ |\mathcal{D}^2 \sigma(\phi)(\phi_1,\phi_2)| &\leq K \|\phi_1\| \|\phi_2\|, \end{aligned}$$

where K > 0, the constant  $\beta > 0$  is given in Assumption 2.2.

**Lemma 3.7** Let Assumptions 1.1-1.2 with  $a_1 - a_2 - (2p-1)L > 0$  hold for some  $p \ge 1$ . And let Assumptions 2.1-2.2 and 3.1-3.2 hold. Then for any  $t \ge 0$  and  $u \ge -\tau$ ,

$$\mathbb{E}[|D_u \mathcal{D}x^{\xi}(t) \cdot \eta|^{2p}] \le K e^{-\lambda_1 p t} \|\eta\|^{2p} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}]),$$
  
$$\mathbb{E}[\|D_u \mathcal{D}x_t^{\tilde{\xi}} \cdot \eta\|^{2p}] \le K e^{-\hat{\lambda}_1 p t} \|\eta\|^{2p} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}]),$$

where  $\tilde{\xi} \in L^{2p((2\beta-2)\vee 1)}(\Omega; \mathcal{C}^d)$  and  $D_u \tilde{\xi} \in L^{8p}(\Omega; \mathcal{C}^d \otimes \mathbb{R}^m)$ ,  $\eta \in \mathcal{C}^d$ , K > 0, and  $\hat{\lambda}_1 > 0$  is given in Lemma 3.3.

**Proof.** For  $u \leq t$ ,  $D_u \mathcal{D} x^{\tilde{\xi}}(t) \cdot \eta$  satisfies

$$D_u \mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta = \int_u^t \left( \mathcal{D}^2 b(x_s^{\tilde{\xi}}) (D_u x_s^{\tilde{\xi}}, \mathcal{D}x_s^{\tilde{\xi}} \cdot \eta) + \mathcal{D}b(x_s^{\tilde{\xi}}) D_u \mathcal{D}x_s^{\tilde{\xi}} \cdot \eta \right) \mathrm{d}s$$

## 3.2 Weak convergence rate

$$\begin{split} &+ \int_{u}^{t} \left( \mathcal{D}^{2} \sigma(x_{s}^{\tilde{\xi}}) (D_{u} x_{s}^{\tilde{\xi}}, \mathcal{D} x_{s}^{\tilde{\xi}} \cdot \eta) + \mathcal{D} \sigma(x_{s}^{\tilde{\xi}}) D_{u} \mathcal{D} x_{s}^{\tilde{\xi}} \cdot \eta \right) \mathrm{d} W(s) \\ &+ \mathcal{D} \sigma(x_{u}^{\tilde{\xi}}) \mathcal{D} x_{u}^{\tilde{\xi}} \cdot \eta \mathbf{1}_{[0,t]}(u). \end{split}$$

By the Itô formula, we have

$$\begin{split} &\mathrm{d}(e^{\hat{\lambda}_{1}pt}|D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}) \leq \hat{\lambda}_{1}pe^{\hat{\lambda}_{1}pt}|D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}\mathrm{d}t + 2pe^{\hat{\lambda}_{1}pt}|D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p-2}\times\\ &\left[\left\langle D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta, \mathcal{D}^{2}b(x^{\tilde{\xi}}_{t})(D_{u}x^{\tilde{\xi}}_{t},\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta) + \mathcal{D}b(x^{\tilde{\xi}}_{t})D_{u}\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta\right\rangle\mathrm{d}t\\ &+ \left\langle D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta, \left(\mathcal{D}^{2}\sigma(x^{\tilde{\xi}}_{t})(D_{u}x^{\tilde{\xi}}_{t},\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta) + \mathcal{D}\sigma(x^{\tilde{\xi}}_{t})D_{u}\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta\right)\mathrm{d}W(t)\right\rangle\right]\\ &+ p(2p-1)e^{\hat{\lambda}_{1}pt}|D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p-2}|\mathcal{D}^{2}\sigma(x^{\tilde{\xi}}_{t})(D_{u}x^{\tilde{\xi}}_{t},\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta)\\ &+ \mathcal{D}\sigma(x^{\tilde{\xi}}_{t})D_{u}\mathcal{D}x^{\tilde{\xi}}_{t}\cdot\eta|^{2}\mathrm{d}t. \end{split}$$

Taking expectation on both sides, and using Assumptions 3.1 and 3.2, and the Young inequality, we obtain

$$\begin{split} & \mathbb{E}[e^{\hat{\lambda}_{1}pt}|D_{u}\mathcal{D}x^{\tilde{\xi}}(t)\cdot\eta|^{2p}] \leq \mathbb{E}[e^{\hat{\lambda}_{1}pu}|\mathcal{D}\sigma(x^{\tilde{\xi}}_{u})\mathcal{D}x^{\tilde{\xi}}_{u}\cdot\eta|^{2p}] + \int_{u}^{t}\mathbb{E}\left[\hat{\lambda}_{1}pe^{\hat{\lambda}_{1}ps}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p} \\ & + 2pe^{\hat{\lambda}_{1}ps}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2}\Big(-a_{1}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2} + a_{2}\int_{-\tau}^{0}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s+r)\cdot\eta|^{2}d\nu_{2}(r)\Big) \\ & + Ke^{\hat{\lambda}_{1}ps}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-1}(1+\|x^{\xi}_{s}\|^{\beta-1})\|D_{u}x^{\xi}_{s}\|\|\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta\| \\ & + p(2p-1)e^{\hat{\lambda}_{1}ps}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2}\Big((1+\frac{1}{\gamma_{1}})|\mathcal{D}^{2}\sigma(x^{\tilde{\xi}}_{s})(D_{u}x^{\tilde{\xi}}_{s},\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta)|^{2} \\ & + (1+\gamma_{1})L(|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2} + \int_{-\tau}^{0}|D_{u}\mathcal{D}x^{\tilde{\xi}}(s+r)\cdot\eta|^{2}d\nu_{1}(r))\Big)\Big]ds \\ \leq \mathbb{E}[e^{\hat{\lambda}_{1}pu}|\mathcal{D}\sigma(x^{\tilde{\xi}}_{u})\mathcal{D}x^{\tilde{\xi}}_{u}\cdot\eta|^{2p}] + p(\hat{\lambda}_{1}-2a_{1}+2a_{2}e^{\hat{\lambda}_{1}p\tau}+(2p-1)(1+\gamma_{1})L(1+e^{\hat{\lambda}_{1}p\tau})) \times \\ & \int_{u}^{t}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}]ds + K\int_{u}^{t}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-1} \times \\ & (1+\|x^{\xi}_{s}\|^{\beta-1})\|D_{u}x^{\tilde{\xi}}_{s}\|\|\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta\|]ds + p(2p-1)(1+\frac{1}{\gamma_{1}})\int_{u}^{t}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p-2} \\ & \times |\mathcal{D}^{2}\sigma(x^{\tilde{\xi}}_{s})D_{u}x^{\tilde{\xi}}_{s}\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta|^{2}]ds \\ \leq \mathbb{E}[e^{\hat{\lambda}_{1}pu}|\mathcal{D}\sigma(x^{\tilde{\xi}}_{u})\mathcal{D}x^{\tilde{\xi}}_{u}\cdot\eta|^{2p}] + p(\hat{\lambda}_{1}-2a_{1}+2a_{2}e^{\hat{\lambda}_{1}p\tau} + (2p-1)(1+\gamma_{1})L(1+e^{\hat{\lambda}_{1}p\tau})) \times \\ & \int_{u}^{t}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}]ds + \int_{u}^{t}\Big(p\gamma_{2}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}] + pK(\gamma_{2})e^{\hat{\lambda}_{1}ps}\mathbb{E}[(1+|x^{\tilde{\xi}}_{s}\|^{2})\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}]ds + \int_{u}^{t}\Big(p\gamma_{2}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}] + pK(\gamma_{2})e^{\hat{\lambda}_{1}ps}\mathbb{E}[(1+|x^{\tilde{\xi}}_{s}\|^{2})\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}]\Big)ds + \int_{u}^{t}p(2p-1)\gamma_{3}e^{\hat{\lambda}_{1}ps}\mathbb{E}[|D_{u}\mathcal{D}x^{\tilde{\xi}}(s)\cdot\eta|^{2p}] \\ & + p(2p-1)K(\gamma_{3})e^{\hat{\lambda}_{1}ps}\mathbb{E}[\|D_{u}x^{\tilde{\xi}}\|^{2}}\|\mathcal{D}x^{\tilde{\xi}}_{s}\cdot\eta\|^{2p}]ds. \end{split}$$

By taking  $\gamma_1, \gamma_2, \gamma_3$  sufficiently small such that

$$\hat{\lambda}_1 - 2a_1 + 2a_2e^{\hat{\lambda}_1p\tau} + (2p-1)(1+\gamma_1)L(1+e^{\hat{\lambda}_1p\tau}) + \gamma_2 + (2p-1)\gamma_3 \le 0,$$

and combining Lemmas 3.3–3.4, we arrive at

$$\mathbb{E}[e^{\hat{\lambda}_1 p t} | D_u \mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta|^{2p}] \leq \mathbb{E}[e^{\hat{\lambda}_1 p u} | \mathcal{D}\sigma(x_u^{\tilde{\xi}}) \mathcal{D}x_u^{\tilde{\xi}} \cdot \eta|^{2p}] + K \int_u^t e^{\hat{\lambda}_1 p s} \mathbb{E}[(1 + \|x_s^{\tilde{\xi}}\|^{2p} \|\mathcal{D}x_s^{\tilde{\xi}}\|^{2p} \|\mathcal{D}x_s^{\tilde{\xi}} \cdot \eta\|^{2p} + \|D_u x_s^{\tilde{\xi}}\|^{2p} \|\mathcal{D}x_s^{\tilde{\xi}} \cdot \eta\|^{2p}] ds$$

$$\leq \mathbb{E}[e^{\hat{\lambda}_{1}pu} | \mathcal{D}\sigma(x_{u}^{\tilde{\xi}})\mathcal{D}x_{u}^{\tilde{\xi}} \cdot \eta|^{2p}] + K \int_{u}^{t} e^{\hat{\lambda}_{1}ps} e^{-\hat{\lambda}_{1}ps - \hat{\lambda}_{1}p(s-u)} \|\eta\|^{2p} \times \\ (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{8p}]) ds \\ \leq K e^{\hat{\lambda}_{1}pu} \mathbb{E}[\|\mathcal{D}x_{u}^{\tilde{\xi}} \cdot \eta\|^{2p}] + K \|\eta\|^{2p} (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{8p}]) \\ \leq K \|\eta\|^{2p} (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{8p}]),$$

which implies

$$\mathbb{E}[|D_u \mathcal{D}x^{\tilde{\xi}}(t) \cdot \eta|^{2p}] \le K e^{-\hat{\lambda}_1 p t} \|\eta\|^{2p} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}]).$$

Similar to the proof of Lemmas 3.3–3.4, by using the Burkholder–Davis–Gundy inequality, we finish the proof.

**Lemma 3.8** Let Assumptions 1.1-1.2 with  $a_1 - a_2 - (2p-1)L > 0$  hold for some  $p \ge 1$ . And let Assumptions 2.1-2.2 and 3.1-3.2 hold. Then for  $t \ge 0$ ,  $u \ge -\tau$ , and  $w \ge -\tau$ ,

$$\begin{split} & \mathbb{E}[|D_w D_u x^{\tilde{\xi}}(t)|^{2p}] \leq K e^{-\hat{\lambda}_1 p(t-u\vee w)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}] + \mathbb{E}[\|D_w \xi\|^{8p}] + \mathbb{E}[\|D_w D_u \tilde{\xi}\|^{2p}]), \\ & \mathbb{E}[\|D_w D_u x_t^{\tilde{\xi}}\|^{2p}] \leq K e^{-\hat{\lambda}_1 p(t-u\vee w)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}] + \mathbb{E}[\|D_w \xi\|^{8p}] + \mathbb{E}[\|D_w D_u \tilde{\xi}\|^{2p}]), \end{split}$$

where  $\tilde{\xi} \in L^{2p((2\beta-2)\vee 1)}(\Omega; \mathcal{C}^d)$ ,  $D_u \tilde{\xi} \in L^{8p}(\Omega; \mathcal{C}^d \otimes \mathbb{R}^m)$ ,  $D_w D_u \tilde{\xi} \in L^{2p}(\Omega; \mathcal{C}^d)$ , K > 0, and  $\hat{\lambda}_1$  is given by Lemma 3.1.

**Proof.** The proof is similar to that of Lemma 3.7. We only give the sketch of the proof.  $D_w D_u x^{\tilde{\xi}}(t)$  satisfies

$$\begin{split} D_w D_u x^{\tilde{\xi}}(t) &= \int_{u \lor w}^t \left( \mathcal{D}^2 b(x_s^{\tilde{\xi}}) (D_w x_s^{\tilde{\xi}}, D_u x_s^{\tilde{\xi}}) + \mathcal{D} b(x_s^{\tilde{\xi}}) D_w D_u x_s^{\tilde{\xi}} \right) \mathrm{d}s \\ &+ \int_{u \lor w}^t \left( \mathcal{D}^2 \sigma(x_s^{\tilde{\xi}}) (D_w x_s^{\tilde{\xi}}, D_u x_s^{\tilde{\xi}}) + \mathcal{D} \sigma(x_s^{\tilde{\xi}}) D_w D_u x_s^{\tilde{\xi}} \right) \mathrm{d}W(s) + \mathcal{D} \sigma(x_w^{\tilde{\xi}}) D_u x_w^{\tilde{\xi}} \mathbf{1}_{[u,t]}(w) \\ &+ \mathcal{D} \sigma(x_u^{\tilde{\xi}}) D_w x_u^{\tilde{\xi}} \mathbf{1}_{[w,t]}(u) + D_w D_u \tilde{\xi}(0). \end{split}$$

Applying the Itô formula, (3.11)–(3.12), and Assumption 3.2, we deduce

$$\begin{split} & \mathbb{E}[e^{\hat{\lambda}_1 p t} | D_w D_u x^{\tilde{\xi}}(t)|^{2p}] \leq \mathbb{E}\Big[e^{\hat{\lambda}_1 p (u \lor w)} | \mathcal{D}\sigma(x_w^{\tilde{\xi}}) D_u x_w^{\tilde{\xi}} \mathbf{1}_{[u, u \lor w]}(w) \\ &+ \mathcal{D}\sigma(x_u^{\xi}) D_w x_u^{\tilde{\xi}} \mathbf{1}_{[w, u \lor w]}(u) + D_w D_u \tilde{\xi}(0)|^{2p}\Big] \\ &+ K \int_{u \lor w}^t e^{\hat{\lambda}_1 p s} \mathbb{E}[(1 + \|x_s^{\tilde{\xi}}\|^{2p((\beta-1)\lor 0)}) \| D_w x_s^{\tilde{\xi}}\|^{2p} \| D_u x_s^{\tilde{\xi}}\|^{2p}] \mathrm{d}s. \end{split}$$

It follows from Lemmas 2.1 and 3.4 that

 $\mathbb{E}[|D_w D_u x^{\tilde{\xi}}(t)|^{2p}] \le K e^{-\hat{\lambda}_1 p(t-u \vee w)} (1 + \mathbb{E}[||D_u \tilde{\xi}||^{8p}] + \mathbb{E}[||D_w \xi||^{8p}] + \mathbb{E}[||D_w D_u \tilde{\xi}||^{2p}]).$ 

Similarly, one can derive

$$\mathbb{E}[\|D_w D_u x_t^{\xi}\|^{2p}] \le K e^{-\hat{\lambda}_1 p(t-u \lor w)} (1 + \mathbb{E}[\|D_u \tilde{\xi}\|^{8p}] + \mathbb{E}[\|D_w \xi\|^{8p}] + \mathbb{E}[\|D_w D_u \tilde{\xi}\|^{2p}]).$$
  
The proof is completed.  $\Box$ 

In order to derive estimates of high-order derivatives of the numerical solution, we give the following assumption on the third order derivative of coefficients b and  $\sigma$ .
**Assumption 3.3** Assume that coefficients b and  $\sigma$  have continuous derivatives up to order 3 satisfying that for any  $\phi, \phi_1, \phi_2, \phi_3 \in C^d$ ,

$$\begin{aligned} |\mathcal{D}^{3}b(\phi)(\phi_{1},\phi_{2},\phi_{3})| &\leq K(1+\|\phi\|^{(\beta-2)\vee 0})\|\phi_{1}\|\|\phi_{2}\|\|\phi_{3}\|,\\ |\mathcal{D}^{3}\sigma(\phi)(\phi_{1},\phi_{2},\phi_{3})| &\leq K\|\phi_{1}\|\|\phi_{2}\|\|\phi_{3}\|, \end{aligned}$$

where K > 0, the constant  $\beta > 0$  is given in Assumption 2.2.

Similarly, we have the following estimates of the numerical solution.

**Lemma 3.9** Let Assumptions 1.1–1.2, 2.1–2.2, 3.1–3.2 hold. Then for  $p \in \mathbb{N}_+$ , there exists a number  $a_1^{**}(L, a_2, \theta, p) > 0$  such that for  $a_1 > a_1^{**}$  and  $\Delta \in (0, 1]$ ,

$$\begin{split} & \mathbb{E}[\|D_{u}\mathcal{D}y_{t_{k}}^{\xi,\Delta} \cdot \eta\|^{2p}] \leq Ke^{-\hat{\lambda}_{2}t_{k}}\|\eta\|^{2p} (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{16p}]), \\ & \mathbb{E}[\|D_{w}D_{u}y_{t_{k}}^{\tilde{\xi},\Delta}\|^{2p}] \leq Ke^{-\hat{\lambda}_{2}(t_{k}-u\vee w)} (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{16p}] + \mathbb{E}[\|D_{w}\tilde{\xi}\|^{16p}] \\ & + \mathbb{E}[\|D_{w}D_{u}\tilde{\xi}\|^{2p}]), \\ & \mathbb{E}[\|D_{w}D_{u}\mathcal{D}y_{t_{k}}^{\tilde{\xi},\Delta} \cdot \eta\|^{2p}] \leq Ke^{-\hat{\lambda}_{2}t_{k}}\|\eta\|^{2p} (1 + \mathbb{E}[\|D_{u}\tilde{\xi}\|^{32p}] \\ & + \mathbb{E}[\|D_{w}\tilde{\xi}\|^{32p}] + \mathbb{E}[\|D_{w}D_{u}\tilde{\xi}\|^{4p}]), \end{split}$$

where  $\tilde{\xi} \in L^{p'}(\Omega; \mathcal{C}^d)$  with some p' > 0,  $\eta \in \mathcal{C}^d$ , K > 0, and  $\hat{\lambda}_2 > 0$  is a sufficiently small number given in Lemma 3.5.

#### 3.2.3 Weak convergence rate

For the SFDE with the distributed delay argument, under the globally Lipschitz continuous coefficients condition, there have been some works devoted to the weak convergence of numerical methods on the finite time horizon. For instance, authors in [7] investigate the weak convergence of the EM method by using the infinite-dimensional version of the Kolmogorov equation; Authors in [20] obtain the weak convergence rate of the EM method by developing a dual approach. To deepen the study, this subsection is devoted to presenting the weak convergence rate on the infinite time horizon of the  $\theta$ -EM method for the SFDE with superlinearly growing coefficients. Before that, we propose the following assumption on the coefficients b and  $\sigma$ .

**Assumption 3.4** Assume that there exist constants  $n_b, n_\sigma \in \mathbb{N}_+$  and probability measures  $\nu_3^i, \nu_4^j$  on  $[-\tau, 0]$  for  $i \in \{1, \ldots, n_b\}$ ,  $j \in \{1, \ldots, n_\sigma\}$ , such that coefficients b and  $\sigma$  satisfy that for any  $\phi_1, \phi_2 \in C^d$ ,

$$\mathcal{D}b(\phi_1)\phi_2 = \sum_{i=1}^{n_b} \int_{-\tau}^0 k_b^i(\phi_1(s))\phi_2(s) \mathrm{d}\nu_3^i(s),$$
  
$$\mathcal{D}\sigma(\phi_1)\phi_2 = \sum_{j=1}^{n_\sigma} \int_{-\tau}^0 k_\sigma^j(\phi_1(s))\phi_2(s) \mathrm{d}\nu_4^j(s),$$

where  $k_b^i, k_\sigma^j : \mathcal{C}^d \to \mathcal{C}([-\tau, 0]; \mathbb{R}^{d \times d})$  satisfy

$$\begin{split} \left\| \mathcal{D}k_b^i(\phi_1) \right\|_{\mathcal{L}(\mathcal{C}^d;\mathcal{C}([-\tau,0];\mathbb{R}^{d\times d}))} + \|k_b^i(\phi_1)\| \le K(1+\|\phi_1\|^{\beta}), \\ \left\| \mathcal{D}k_{\sigma}^j(\phi_1) \right\|_{\mathcal{L}(\mathcal{C}^d;\mathcal{C}([-\tau,0];\mathbb{R}^{d\times d}))} + \|k_{\sigma}^j(\phi_1)\| \le K. \end{split}$$

Examples satisfying Assumption 3.4 are given as follows.

**Example 3.1** Coefficients b and  $\sigma$  considered in [7, 20] satisfy Assumption 3.4, where the coefficients have the forms:  $b(\int_{-\tau}^{0} \phi(r) d\nu_3(r))$  and  $\sigma(\int_{-\tau}^{0} \phi(r) d\nu_4(r))$ . In fact, it can be calculated that for  $\phi_1 \in C^d$ ,

$$\mathcal{D}b(\int_{-\tau}^{0} \phi(r) d\nu_{3}(r))\phi_{1} = \int_{-\tau}^{0} \mathcal{D}b(\int_{-\tau}^{0} \phi(r) d\nu_{3}(r))\phi_{1}(s) d\nu_{3}(s),$$
  
$$\mathcal{D}\sigma(\int_{-\tau}^{0} \phi(r) d\nu_{4}(r))\phi_{1} = \int_{-\tau}^{0} \mathcal{D}\sigma(\int_{-\tau}^{0} \phi(r) d\nu_{4}(r))\phi_{1}(s) d\nu_{4}(s).$$

**Example 3.2** Let  $b(\phi) = \frac{1}{\tau} \int_{-\tau}^{0} \phi(s) ds - |\phi(0)|^2 \phi(0) - \phi(0), \ \phi \in \mathcal{C}^d$ . Then it can be verified that Assumption 3.4 is satisfied: for  $\phi_1 \in \mathcal{C}^d$ ,

$$\mathcal{D}b(\phi)\phi_1 = \frac{1}{\tau} \int_{-\tau}^0 \phi_1(s) \mathrm{d}s - 2\phi(0)^\top \phi_1(0)\phi(0) - |\phi(0)|^2 \phi_1(0) - \phi_1(0).$$

In this example,  $n_b = 2$ ,  $k_b^1(\phi) = \mathrm{Id}_{d \times d}$ ,  $k_b^2(\phi) = -2\phi\phi^\top - \mathrm{Id}_{d \times d}$ ,  $\nu_3^1(\mathrm{d}s) = \frac{1}{\tau}\mathrm{d}s$ ,  $\nu_3^2(\mathrm{d}s) = \delta_0(\mathrm{d}s)$ .

**Theorem 3.3** Let conditions in Lemma 3.9, Assumption 2.3 with  $\rho \ge 1$ , and Assumption 3.4 hold. Then for  $f \in C_b^3$ ,

$$|\mathbb{E}[f(x^{\xi}(T))] - \mathbb{E}[f(y^{\xi,\Delta}(T))]| \le K\Delta,$$

where K is independent of T.

**Proof.** To simplify the proof, we take parameters  $n_b, n_\sigma$  in Assumption 3.4 to be  $n_b = n_\sigma = 1$ . The case of  $n_b > 1$ ,  $n_\sigma > 1$  can be proved similarly.

**Estimate of term**  $\mathcal{I}_0$ . Term  $\mathcal{I}_0$  is estimated as

$$\begin{split} \mathcal{I}_{0} &= \mathbb{E}[f(\varphi^{Int}(t_{N\Delta}; 0, \xi)] - \mathbb{E}[f(\varphi^{Int}(t_{N\Delta}; 0, \Phi_{0}))] \\ &= \int_{0}^{1} \mathbb{E}\Big[f'(\varphi^{Int}(t_{N\Delta}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0}))\mathcal{D}\varphi^{Int}(t_{N\Delta}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})(\xi - \Phi_{0})\Big]\mathrm{d}\varsigma \\ &\leq K \int_{0}^{1} \|\mathcal{D}\varphi^{Int}(t_{N\Delta}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})(\xi - \Phi_{0})\|_{0,2}\mathrm{d}\varsigma \\ &\leq K\Delta \int_{0}^{1} \|\mathcal{D}\varphi^{Int}(t_{N\Delta}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})\|_{0,2}\mathrm{d}\varsigma \\ &\leq K\Delta, \end{split}$$

where we used  $\sup_{\phi \in \mathbb{R}^d} |f'(\phi)| \leq K$  and Assumption 2.3.

**Estimate of term**  $\mathcal{I}_b$ . By the Taylor formula, we have

$$\begin{split} \mathcal{I}_{b} &= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma}) I^{0} \mathrm{Id}_{d \times d})^{*} f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathcal{D}b(Z_{i,r}^{\beta_{1}}) \\ & \left( \varphi_{r}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_{0})) - \varphi_{t_{i-1}}^{Int}(0, \Phi_{0}) \right) \mathrm{d}\beta_{1} \mathrm{d}r \Big\rangle \Big] \mathrm{d}\varsigma =: \mathcal{I}_{b,1} + \mathcal{I}_{b,2}, \end{split}$$

where 
$$Z_{i,r}^{\beta_1} = \beta_1 \varphi_r(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) + (1 - \beta_1) \varphi_{t_{i-1}}^{Int}(0, \Phi_0)$$
, and  
 $\mathcal{I}_{b,1} = \sum_{i=1}^{N^{\Delta}} \int_0^1 \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T; t_i, Y_i^{\varsigma}) I^0 \mathrm{Id}_{d \times d})^* f'(\Phi(T; t_i, Y_i^{\varsigma})), \int_{t_{i-1}}^{t_i} \int_0^1 \mathcal{D}b(Z_{i,r}^{\beta_1}) \\ (\varphi_r^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) - \varphi_{t_{i-1}}^{Int}(0, \Phi_0)) \mathrm{d}\beta_1 \mathrm{d}r \Big\rangle \Big] \mathrm{d}\varsigma,$   
 $\mathcal{I}_{b,2} = \sum_{i=1}^{N^{\Delta}} \int_0^1 \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T; t_i, Y_i^{\varsigma}) I^0 \mathrm{Id}_{d \times d})^* f'(\Phi(T; t_i, Y_i^{\varsigma})), \int_{t_{i-1}}^{t_i} \int_0^1 \mathcal{D}b(Z_{i,r}^{\beta_1}) \\ (\varphi_r(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) - \varphi_r^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0))) \mathrm{d}\beta_1 \mathrm{d}r \Big\rangle \Big] \mathrm{d}\varsigma.$ 

Estimate of term  $\mathcal{I}_{b,1}$ . We first decompose  $\varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0)) - \varphi_{t_{i-1}}^{Int}(0,\Phi_0)$  for  $r \in [t_{i-1},t_i)$ . For  $s \in [t_j,t_{j+1}] \subset [-\tau,0]$ , we have  $t_{i-1} + s \in [t_{i+j-1},t_{i+j})$ , which implies

$$\varphi_{t_{i-1}}^{Int}(0,\Phi_0)(s) = \frac{t_{j+1}-s}{\Delta}\varphi(t_{i+j-1};0,\Phi_0) + \frac{s-t_j}{\Delta}\varphi(t_{i+j};0,\Phi_0).$$
(3.18)

We also have  $r + s \in [t_{i+j-1}, t_{i+j+1})$ , which leads to the following two cases.

Case 1:  $r + s \in [t_{i+j-1}, t_{i+j})$ . In this case,

$$\varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0))(s) = \frac{t_{i+j} - (r+s)}{\Delta}\varphi(t_{i+j-1};0,\Phi_0) + \frac{(r+s) - t_{i+j-1}}{\Delta}\varphi(t_{i+j};0,\Phi_0).$$

Hence,

$$\varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0))(s) - \varphi_{t_{i-1}}^{Int}(0,\Phi_0)(s)$$
  
=  $\frac{t_{i-1}-r}{\Delta}\varphi(t_{i+j-1};0,\Phi_0) + \frac{r-t_{i-1}}{\Delta}\varphi(t_{i+j};0,\Phi_0)$   
=  $\frac{r-t_{i-1}}{\Delta}(\varphi(t_{i+j};0,\Phi_0) - \varphi(t_{i+j-1};0,\Phi_0)).$ 

Case 2:  $r + s \in [t_{i+j}, t_{i+j+1})$ . In this case,

$$\begin{split} \varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0))(s) \\ &= \frac{t_{i+j+1} - (r+s)}{\Delta}\varphi(t_{i+j};0,\Phi_0) + \frac{r+s-t_{i+j}}{\Delta}\varphi(t_{i+j+1};0,\Phi_0) \\ &= \mathbf{1}_{\{i+j\geq 1\}}\Big\{\frac{t_{i+j+1} - (r+s)}{\Delta}\Big[\varphi(t_{i+j-1};0,\Phi_0) + \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0,\Phi_0))du \\ &+ \int_{t_{i+j-1}}^{t_{i+j+1}} \sigma(\varphi_u(0,\Phi_0))dW(u)\Big] + \frac{r+s-t_{i+j}}{\Delta}\Big[\varphi(t_{i+j};0,\Phi_0) \\ &+ \int_{t_{i+j}}^{t_{i+j+1}} b(\varphi_u(0,\Phi_0))du + \int_{t_{i+j}}^{t_{i+j+1}} \sigma(\varphi_u(0,\Phi_0))dW(u)\Big]\Big\} \\ &+ \mathbf{1}_{\{i+j=0\}}\Big\{\frac{t_{i+j+1} - (r+s)}{\Delta}\xi(0) + \frac{r+s-t_{i+j}}{\Delta}\Big[\xi(0) \\ &+ \int_0^{t_1} b(\varphi_u(0,\Phi_0))du + \int_0^{t_1} \sigma(\varphi_u(0,\Phi_0))dW(u)\Big]\Big\} \\ &+ \mathbf{1}_{\{i+j\leq -1\}}\Big\{\frac{t_{i+j+1} - (r+s)}{\Delta}\xi(t_{i+j}) + \frac{r+s-t_{i+j}}{\Delta}\xi(t_{i+j+1})\Big\}. \end{split}$$

Then,

$$\begin{split} \varphi_{r}^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0}))(s) &- \varphi_{t_{i-1}}^{Int}(0,\Phi_{0})(s) \\ &= \mathbf{1}_{\{i+j\geq 1\}} \Big\{ \frac{t_{j+1}-s}{\Delta} \Big[ \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u + \int_{t_{i+j-1}}^{t_{i+j}} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \Big] \\ &+ \frac{r+s-t_{i+j}}{\Delta} \Big[ \int_{t_{i+j}}^{t_{i+j+1}} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u + \int_{t_{i+j}}^{t_{i+j+1}} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \Big] \Big\} \\ &+ \mathbf{1}_{\{i+j=0\}} \Big\{ \frac{t_{j+1}-s}{\Delta} (\xi(0)-\xi(-\Delta)) + \frac{r+s-t_{i+j}}{\Delta} \Big[ \int_{0}^{t_{1}} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u \\ &+ \int_{0}^{t_{1}} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \Big] \Big\} + \mathbf{1}_{\{i+j\leq -1\}} \Big\{ \frac{t_{j+1}-s}{\Delta} (\xi(t_{i+j})-\xi(t_{i+j-1})) \\ &+ \frac{s+r-t_{i+j}}{\Delta} (\xi(t_{i+j+1})-\xi(t_{i+j})) \Big\}. \end{split}$$

Combining <u>Cases 1-2</u>, we deduce

$$\begin{split} &\varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0)) - \varphi_{t_{i-1}}^{Int}(0,\Phi_0) \\ &= \sum_{j=-N}^{-1} \bigg\{ \mathbf{1}_{\{i+j\geq 1\}} \Big\{ \mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot) \Big[ \frac{t_{j+1}-\cdot}{\Delta} \Big( \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u \\ &+ \int_{t_{i+j-1}}^{t_{i+j}} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) \Big) + \frac{r+\cdot-t_{i+j}}{\Delta} \Big( \int_{t_{i+j}}^{t_{i+j+1}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u \\ &+ \int_{t_{i+j}}^{t_{i+j+1}} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) \Big) \Big] + \mathbf{1}_{[t_{i+j-1}-r,t_{i+j}-r)}(\cdot) \frac{r-t_{i-1}}{\Delta} \Big( \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u \\ &+ \int_{t_{i+j-1}}^{t_{i+j-1}} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) \Big) \Big\} + \mathbf{1}_{\{i+j=0\}} \Big\{ \mathbf{1}_{[t_{i+j-1}-r,t_{i+j}-r)}(\cdot) \times \\ \frac{r-t_{i-1}}{\Delta} \Big( \xi(0) - \xi(-\Delta) \Big) + \mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot) \Big[ \frac{t_{j+1}-\cdot}{\Delta} \Big( \xi(0) - \xi(-\Delta) \Big) \\ &+ \frac{r+\cdot-t_{i+j}}{\Delta} \Big( \int_0^{t_1} b(\varphi_u(0,\Phi_0)) \mathrm{d}u + \int_0^{t_1} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) \Big) \Big] \Big\} \\ &+ \mathbf{1}_{\{i+j\leq-1\}} \Big\{ \mathbf{1}_{[t_{i+j-1}-r,t_{i+j}-r)}(\cdot) \frac{r-t_{i-1}}{\Delta} \Big( \xi(t_{i+j}) - \xi(t_{i+j-1}) \Big) \\ &+ \frac{\cdot+r-t_{i+j}}{\Delta} \Big( \xi(t_{i+j+1}) - \xi(t_{i+j}) \Big) \Big\} \Big\}. \end{split}$$

Inserting the above equality into  $\mathcal{I}_{b,1}$ , we proceed to estimate sub-terms in  $\mathcal{I}_{b,1}$  one-byone. It follows from Assumption 3.4 that  $|\mathcal{D}b(x)y| \leq K(1 + ||x||^{\beta})||y||$ . This, along with Lemmas 2.1 and 3.5, and  $f \in \mathcal{C}_b^3$  implies that

$$\begin{split} &\sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T;t_{i},Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*}f'(\Phi(T;t_{i},Y_{i}^{\varsigma})), \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathcal{D}b(Z_{i,r}^{\beta_{1}}) \\ &\sum_{j=-N}^{-1} \mathbf{1}_{\{i+j\geq1\}} \mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot) \frac{t_{j+1}-\cdot}{\Delta} \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_{u}(0,\Phi_{0}))\mathrm{d}u\mathrm{d}\beta_{1}\mathrm{d}r \Big\rangle \Big]\mathrm{d}\varsigma \\ &\leq K \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \Big\| \mathcal{D}\Phi(T;t_{i},Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d} \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathcal{D}b(Z_{i,r}^{\beta_{1}}) \sum_{j=-N}^{-1} \mathbf{1}_{\{i+j\geq1\}} \Big\} \end{split}$$

$$\begin{split} \mathbf{1}_{[t_{i+j-r},t_{i+j+1}-r)}(\cdot)\frac{t_{j+1}-\cdot}{\Delta} \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u \mathrm{d}\beta_1 \mathrm{d}r \Big\|_{0,2} \mathrm{d}\varsigma \\ &\leq K \sum_{i=1}^{N^{\Delta}} \int_0^1 \left( e^{-\hat{\lambda}_2(T-t_i)} \mathbb{E}\Big[ \Big\| I^0 \mathrm{Id}_{d\times d} \int_{t_{i-1}}^{t_i} \int_0^1 \mathcal{D}b(Z_{i,r}^{\beta_1}) \sum_{j=-N}^{-1} \mathbf{1}_{\{i+j\geq 1\}} \right. \\ & \mathbf{1}_{[t_{i+j-r},t_{i+j+1}-r)}(\cdot)\frac{t_{j+1}-\cdot}{\Delta} \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u \mathrm{d}\beta_1 \mathrm{d}r \Big\|^2 (1+\|Y_i^{\varsigma}\|^{2\beta}) \Big] \Big)^{\frac{1}{2}} \mathrm{d}\varsigma \\ &\leq K \sum_{i=1}^{N^{\Delta}} \int_0^1 e^{-\frac{\hat{\lambda}_2(T-t_i)}{2}} \Big( \mathbb{E}\Big[ \int_{t_{i-1}}^{t_i} \int_0^1 (1+\|Z_{i,r}^{\beta_1}\|^{\beta}) \int_{t_{i+j-1}}^{t_{i+j}} (1+\|\varphi_u(0,\Phi_0)\|^{\beta+1}) \mathrm{d}u \mathrm{d}\beta_1 \mathrm{d}r \Big]^4 \Big(1+\sup_{i\geq 0} \mathbb{E}[\|Y_i^{\varsigma}\|^{4\beta}] \Big) \Big)^{\frac{1}{4}} \mathrm{d}\varsigma \\ &\leq K \Delta^2 \sum_{i=1}^{N^{\Delta}} e^{-\frac{\hat{\lambda}_2(T-t_i)}{2}} (1+\sup_{u\geq 0} \mathbb{E}[\|\varphi_u(0,\Phi_0)\|^{4(2\beta+1)}])^{\frac{1}{4}} \sup_{i\geq 0} (1+\mathbb{E}[\|Y_i^{\varsigma}\|^{4\beta}])^{\frac{1}{4}} \\ &\leq K \Delta, \end{split}$$

where we used the fact that

$$\sup_{T>0} \Delta \sum_{i=1}^{N^{\Delta}} e^{-\frac{\hat{\lambda}_{2}(T-t_{i})}{2}} = \sup_{N^{\Delta}>0} \Delta \sum_{i=1}^{N^{\Delta}} e^{-\frac{\hat{\lambda}_{2}\Delta(N^{\Delta}-i)}{2}} < \infty.$$

For a term with the Brownian motion, by (3.4), we have

For the term  $\mathcal{I}^1_{b,1,2}$ , by virtue of Lemmas 2.1, 3.4, 3.5, and 3.9, we arrive at

Similar to the estimates of  $\mathcal{I}_{b,1,1}^1$  and  $\mathcal{I}_{b,1,2}^1$ , for the term  $\mathcal{I}_{b,1,3}^1$ , we obtain  $\mathcal{I}_{b,1,3}^1 \leq K\Delta$ .

Other terms can be estimated similarly as above. We can derive that  $\mathcal{I}_{b,1} \leq K\Delta$ .

## 3.2 Weak convergence rate

Estimate of term  $\mathcal{I}_{b,2}$ . We first decompose the term  $\varphi_r(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) - \varphi_r^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0))$  for  $r \in [t_{i-1}, t_i)$ . For  $s \in [t_j, t_{j+1}] \subset [-\tau, 0]$ , we have  $r + s \in [t_{i+j-1}, t_{i+j+1})$ , which leads to the following two cases.

$$\begin{split} \underline{\text{Case 1: } r+s \in [t_{i+j-1}, t_{i+j})}_{\varphi_r(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0))(s) - \varphi_r^{Int}(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0))(s)} \\ &= \varphi(r+s; t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) - \left[\frac{t_{i+j} - (r+s)}{\Delta}\varphi(t_{i+j-1}; 0, \Phi_0)\right] \\ &+ \frac{r+s - t_{i+j-1}}{\Delta}\varphi(t_{i+j}; 0, \Phi_0)\right] \\ &= \mathbf{1}_{\{i+j\geq 1\}} \Big\{ \int_{t_{i+j-1}}^{r+s} b(\varphi_u(0, \Phi_0)) \mathrm{d}u + \int_{t_{i+j-1}}^{r+s} \sigma(\varphi_u(0, \Phi_0)) \mathrm{d}W(u) - \frac{r+s - t_{i+j-1}}{\Delta} \times \Big[ \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_u(0, \Phi_0)) \mathrm{d}u + \int_{t_{i+j-1}}^{t_{i+j}} \sigma(\varphi_u(0, \Phi_0)) \mathrm{d}W(u) \Big] \Big\}. \end{split}$$

Case 2:  $r + s \in [t_{i+j}, t_{i+j+1})$ . In this case,

$$\begin{split} \varphi_r(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0))(s) &- \varphi_r^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_0))(s) \\ &= \mathbf{1}_{\{i+j\geq 0\}} \Big\{ \int_{t_{i+j}}^{r+s} b(\varphi_u(0,\Phi_0)) \mathrm{d}u + \int_{t_{i+j}}^{r+s} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) - \frac{r+s-t_{i+j}}{\Delta} \times \\ &\Big[ \int_{t_{i+j}}^{t_{i+j+1}} b(\varphi_u(0,\Phi_0)) \mathrm{d}u + \int_{t_{i+j}}^{t_{i+j+1}} \sigma(\varphi_u(0,\Phi_0)) \mathrm{d}W(u) \Big] \Big\}. \end{split}$$

Combining <u>Cases 1-2</u> gives

$$\begin{split} \varphi_{r}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) &- \varphi_{r}^{Int}(t_{i-1},\varphi_{t_{i-1}}(0,\Phi_{0})) \\ = \sum_{j=-N}^{-1} \Big\{ \mathbf{1}_{\{i+j\geq 1\}} \mathbf{1}_{[t_{i+j-1}-r,t_{i+j}-r)}(\cdot) \Big[ \int_{t_{i+j-1}}^{r+\cdot} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u \\ &+ \int_{t_{i+j-1}}^{r+\cdot} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) - \frac{r+\cdot-t_{i+j-1}}{\Delta} \Big( \int_{t_{i+j-1}}^{t_{i+j}} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u \\ &+ \int_{t_{i+j-1}}^{t_{i+j}} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \Big) \Big] + \mathbf{1}_{\{i+j\geq 0\}} \mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot) \times \\ \Big[ \int_{t_{i+j}}^{r+\cdot} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u + \int_{t_{i+j}}^{r+\cdot} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \\ &- \frac{r+\cdot-t_{i+j}}{\Delta} \Big( \int_{t_{i+j}}^{t_{i+j+1}} b(\varphi_{u}(0,\Phi_{0})) \mathrm{d}u + \int_{t_{i+j}}^{t_{i+j+1}} \sigma(\varphi_{u}(0,\Phi_{0})) \mathrm{d}W(u) \Big) \Big] \Big\}. \end{split}$$

Inserting the above equality into  $\mathcal{I}_{b,2}$ , we are in the position to estimate  $\mathcal{I}_{b,2}$ . We only give the estimate of the term with

$$\mathbf{1}_{\{i+j\geq 1\}}\mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot)\int_{t_{i+j}}^{r+\cdot}\sigma(\varphi_u(0,\Phi_0))\mathrm{d}W(u),$$

since estimates of other terms are similar to those in  $\mathcal{I}_{b,1}$ . Based on Assumption 3.4, we have

$$\mathcal{I}_{b,2,1} := \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma}) I^{0} \mathrm{Id}_{d \times d})^{*} f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathrm{Id}_{d \times d} \Big] \Big]$$

Hence, the term  $\mathcal{I}_{b,2}$  is estimated as  $\mathcal{I}_{b,2} \leq K\Delta$ .

where we used the property

$$\sup_{u \in [t_{i+j}, t_{i+j+1}]} \mathbb{E}\left[\sup_{s \in [-\tau, 0]} |D_u k_{\sigma}^1(Z_{i, r}^{\beta_1}(s))|^{2p_0}\right] + \mathbb{E}\left[\sup_{s \in [-\tau, 0]} |k_{\sigma}^1(Z_{i, r}^{\beta_1}(s))|^{2p_0}\right] \le K$$

for some  $p_0$ .

Combining estimates of terms  $\mathcal{I}_0, \mathcal{I}_b, \mathcal{I}_{b,\theta}$ , and  $\mathcal{I}_{\sigma}$ , we complete the proof.  $\Box$ 

Based on Theorem 3.3, we can derive the convergence rate of the numerical invariant measure, which is stated in the following corollary.

**Corollary 3.1** Under conditions in Theorem 3.3, it holds that for  $f \in \mathcal{C}_{h}^{3}$ ,

$$|\mu(f) - \mu^{\Delta}(f)| \le K\Delta.$$

**Proof.** Let  $\tilde{\xi}, \bar{\xi}$  be initial values with distributions being  $\mu, \mu^{\Delta}$ , respectively. It follows from (2.31) and (3.1) that for any  $p \ge 2$ ,  $\mathbb{E}[\|\tilde{\xi}\|^p + \|\bar{\xi}\|^p] \le K$ . Then for any T > 0,

$$\begin{aligned} |\mu(f) - \mu^{\Delta}(f)| &= |\mathbb{E}[f(x^{\xi}(T))] - \mathbb{E}[f(y^{\Delta,\xi}(T))]| \\ &\leq |\mathbb{E}[f(x^{\bar{\xi}}(T))] - \mathbb{E}[f(x^{\bar{\xi}}(T))]| + |\mathbb{E}[f(x^{\bar{\xi}}(T))] - \mathbb{E}[f(y^{\Delta,\bar{\xi}}(T))]| \\ &\leq K(\mathbb{E}[|x^{\bar{\xi}}(T) - x^{\bar{\xi}}(T)|^2])^{\frac{1}{2}} + K\Delta \\ &\leq Ke^{-KT} + K\Delta, \end{aligned}$$

which implies the result by letting  $T \to \infty$ .

# 3.3 Summary and outlook

In this chapter, we investigate the numerical approximation of the invariant measure of the SFDE (1.1) with the superlinearly growing drift coefficient. We first prove the existence and uniqueness of the invariant measure of the  $\theta$ -EM functional solution. Then based on the Malliavin calculus, we analyze the longtime weak convergence of the SFDE (1.1), and further prove that the convergence rate of the numerical invariant measure is 1. We remark that in our analysis, Assumption 3.4 is proposed for technical reason to pave a way for making use of the dual property of the Malliavin derivative operator (i.e., (3.4), which is usually called the integration by parts formula). In fact, there are still some problems associated with these topics that are challenging and far from being well understood:

- (i) How to weaken or even eliminate Assumption 3.4 to include more general class of SFDEs?
- (ii) Can we obtain the same weak convergence rate if the diffusion coefficient grows superlinearly?
- (iii) For the SFDE driven by the rough path, does the invariant measure of the numerical method exist uniquely?
- (iv) If (iii) holds, does the numerical invariant measure converge to the exact one?

# Chapter 4

# Approximation of density function

In this chapter, we first study the existence of the density function for the solution of the  $\theta$ -EM method with multiplicative noise. Then we investigate the convergence of the numerical density function. For the SFDE (1.1) with the multiplicative noise, the numerical density function is shown to converge to the exact one in  $L^1(\mathbb{R}^d)$  based on the localization argument. For the case of the additive noise, the convergence rate in the point-wise sense of the numerical density function is proved to be 1 based on the test-functional-independent weak convergence analysis.

# 4.1 Existence of numerical density function

In this section, we investigate the existence of density functions of solutions for (1.1) and the  $\theta$ -EM method based on the technique of the Malliavin calculus. The deterministic initial value  $\xi$  is fixed in this section. We focus on the superlinearly growing coefficients case on the finite time horizon. Consider the following assumptions in this section.

**Assumption 4.1** Assume that there exists a constant  $a_5 > 0$  such that for any  $\phi_1, \phi_2 \in C^d$ ,

$$\langle b(\phi_1) - b(\phi_2), \phi_1(0) - \phi_2(0) \rangle \le a_5 \Big( |\phi_1(0) - \phi_2(0)|^2 + \int_{-\tau}^0 |\phi_1(r) - \phi_2(r)|^2 \mathrm{d}\nu_2(r) \Big)$$

**Assumption 4.2** Assume that the coefficient *b* has continuous Gâteaux derivative, and that there exists a constant  $\tilde{\beta} \geq 0$  such that

$$|\mathcal{D}b(\phi_1)\phi_2| \le K(1 + \|\phi_1\|^\beta) \|\phi_2\|,$$

where  $\phi_1, \phi_2 \in \mathcal{C}^d, K > 0.$ 

**Assumption 4.3** Assume that the coefficient  $\sigma$  has continuous Gâteaux derivative, and that there exists some  $\sigma_0 > 0$  such that

$$\inf_{\phi \in \mathcal{C}^d} \min_{u \in \mathbb{R}^d, |u|=1} u^{\top} \sigma(\phi) \sigma(\phi)^{\top} u \ge \sigma_0.$$

Under Assumptions 1.1 and 4.1, the existence and uniqueness of the global solution of (1.1) can be obtained by using [46, Theorem 2]. In addition, the functional solution of (1.1) has the following estimates.

**Lemma 4.1** Let Assumptions 1.1, 4.1–4.2 hold. Assume that the coefficient  $\sigma$  has continuous Gâtueax derivative. Then for any  $p \ge 2$  and T > 0,

$$\mathbb{E}[\sup_{t \in [0,T]} \|x_t^{\xi}\|^p] \le K_T, \qquad \sup_{r \in [0,T]} \mathbb{E}[\sup_{t \in [r,T]} \|D_r x_t^{\xi}\|^p] \le K_T.$$

**Proof.** Similar to the proof of [46, Theorem 2], we can obtain the first inequality. For the second inequality, when  $u \leq t$ ,  $D_u x^{\xi}(t)$  satisfies

$$D_u x^{\xi}(t) = \int_u^t \mathcal{D}b(x_s^{\xi}) D_u x_s^{\xi} \mathrm{d}s + \int_u^t \mathcal{D}\sigma(x_s^{\xi}) D_u x_s^{\xi} \mathrm{d}W(s) + \sigma(x_u^{\xi}) \mathbf{1}_{[0,t]}(u).$$

By the Itô formula, we derive

$$d(|D_u x^{\xi}(t)|^{2p}) \leq p|D_u x^{\xi}(t)|^{2p-2} \Big( 2\langle D_u x^{\xi}(t), \mathcal{D}b(x_t^{\xi}) D_u x_t^{\xi} \rangle dt + (2p-1)|\mathcal{D}\sigma(x_t^{\xi}) D_u x_t^{\xi}|^2 dt + 2\langle D_u x^{\xi}(t), \mathcal{D}\sigma(x_t^{\xi}) D_u x_t^{\xi} dW(t) \rangle \Big).$$
(4.1)

It follows from Assumptions 1.1 and 4.1 that

$$\begin{split} |D_{u}x^{\xi}(t)|^{2p} &\leq |\sigma(x_{u}^{\xi})|^{2p} \mathbf{1}_{[0,t]}(u) + K \int_{u}^{t} \left( |D_{u}x^{\xi}(s)|^{2p} + |D_{u}x^{\xi}(s)|^{2p-2} \times \right. \\ &\left( \int_{-\tau}^{0} |D_{u}x_{s}^{\xi}(r)|^{2} \mathrm{d}\nu_{1}(r) + \int_{-\tau}^{0} |D_{u}x_{s}^{\xi}(r)|^{2} \mathrm{d}\nu_{2}(r) \right) \Big) \mathrm{d}s \\ &+ 2p \int_{u}^{t} |D_{u}x^{\xi}(s)|^{2p-2} \langle D_{u}x^{\xi}(s), \mathcal{D}\sigma(x_{s}^{\xi}) D_{u}x_{s}^{\xi} \mathrm{d}W(s) \rangle. \end{split}$$

Applying the Burkholder–Davis–Gundy inequality, we deduce

$$\mathbb{E}\Big[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}\Big]$$
  
$$\le \mathbb{E}[|\sigma(x_u^{\xi})|^{2p}] + K \int_u^T \mathbb{E}\Big[|D_u x^{\xi}(s)|^{2p} + |D_u x^{\xi}(s)|^{2p-2} \Big(\int_{-\tau}^0 |D_u x^{\xi}_s(r)|^2 d\nu_1(r)$$
  
$$+ \int_{-\tau}^0 |D_u x^{\xi}_s(r)|^2 d\nu_2(r)\Big) \Big] ds + K \mathbb{E}\Big[\Big(\int_u^T |D_u x^{\xi}(s)|^{4p-2} |\mathcal{D}\sigma(x^{\xi}_s) D_u x^{\xi}_s|^2 ds\Big)^{\frac{1}{2}}\Big].$$

According to Assumption 1.1 and the Young inequality, we arrive at

$$\begin{split} & \mathbb{E}\Big[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}\Big] \\ & \le K_T + K \int_u^T \mathbb{E}\Big[|D_u x^{\xi}(s)|^{2p} + \int_{-\tau}^0 |D_u x^{\xi}_s(r)|^{2p} \mathrm{d}\nu_1(r) + \int_{-\tau}^0 |D_u x^{\xi}_s(r)|^{2p} \mathrm{d}\nu_2(r)\Big] \mathrm{d}s \\ & + \frac{1}{2} \mathbb{E}\Big[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}\Big] + K \mathbb{E}\Big[\int_u^T |\mathcal{D}\sigma(x^{\xi}_s) D_u x^{\xi}_s|^{2p} \mathrm{d}s\Big] \\ & \le K_T + K \int_u^T \mathbb{E}\Big[|D_u x^{\xi}(s)|^{2p} + \int_{-\tau}^0 |D_u x^{\xi}_s(r)|^{2p} \mathrm{d}\nu_1(r) \\ & + \int_{-\tau}^0 |D_u x^{\xi}_s(r)|^{2p} \mathrm{d}\nu_2(r)\Big] \mathrm{d}s + \frac{1}{2} \mathbb{E}\Big[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}\Big] \\ & \le K_T + K \int_u^T \mathbb{E}\Big[\sup_{u \le r \le s} |D_u x^{\xi}(r)|^{2p}\Big] \mathrm{d}s + \frac{1}{2} \mathbb{E}\Big[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}\Big]. \end{split}$$

Using the Grönwall inequality, one has

$$\sup_{0 \le u \le T} \mathbb{E}[\sup_{u \le t \le T} |D_u x^{\xi}(t)|^{2p}] \le K_T.$$

The proof is completed.

Based on Lemma 4.1 and  $D_r x^{\xi}(t) = 0$  for r > t, we derive that  $x^{\xi}(t) \in \mathbb{D}^{1,p}$  for all  $p \ge 1$ . Hence, according to [52, Theorem 2.1.2], in order to obtain the existence of the density function of the solution of (1.1), it suffices to show that the Malliavin covariance matrix  $\gamma^E(t) := \int_0^t D_r x^{\xi}(t) (D_r x^{\xi}(t))^\top dr$  of  $x^{\xi}(t)$  for  $t \in [0,T]$  is a.s. invertible. To this end, by virtue of [22, Section 3.3], we first prove that for some q > 0, there exists a small number  $\epsilon_0(q)$  such that for any  $\epsilon < \epsilon_0(q)$ ,  $\sup_{u \in \mathbb{R}^d, |u|=1} \mathbb{P}(u^\top \gamma^E(t)u \le \epsilon) \le \epsilon^q$ ,  $t \in [0,T]$ . This is stated as follows.

**Proposition 4.1** Under Assumptions 1.1, 4.1–4.3, there exists some  $\epsilon_0(q)$  such that for  $\epsilon < \epsilon_0(q)$ , it holds that

$$\sup_{u \in \mathbb{R}^d, |u|=1} \mathbb{P}(u^\top \gamma^E(t) u \le \epsilon) \le \epsilon, \ t \in [0, T].$$

**Proof.** For any  $r \leq t$ ,

$$D_r x^{\xi}(t) = \int_r^t \mathcal{D}b(x_s^{\xi}) D_r x_s^{\xi} \mathrm{d}s + \int_r^t \mathcal{D}\sigma(x_s^{\xi}) D_r x_s^{\xi} \mathrm{d}W(s) + \sigma(x_r^{\xi}) \mathbf{1}_{[0,t]}(r).$$

Fixing  $\epsilon \in (0,1)$  and letting  $\epsilon_1 := \frac{2\epsilon}{\sigma_0}$ , we obtain

$$u^{\top} \gamma^{E}(t) u \geq \int_{t-\epsilon_{1}}^{t} u^{\top} D_{r} x^{\xi}(t) (D_{r} x^{\xi}(t))^{\top} u dr \geq \int_{t-\epsilon_{1}}^{t} u^{\top} \sigma(x_{r}^{\xi}) (\sigma(x_{r}^{\xi}))^{\top} u dr$$
$$+ 2 \int_{t-\epsilon_{1}}^{t} u^{\top} \Big( \int_{r}^{t} \mathcal{D}b(x_{s}^{\xi}) D_{r} x_{s}^{\xi} ds + \int_{r}^{t} \mathcal{D}\sigma(x_{s}^{\xi}) D_{r} x_{s}^{\xi} dW(s) \Big) (\sigma(x_{r}^{\xi}))^{\top} u dr.$$

It follows from Assumption 4.3 that

$$\int_{t-\epsilon_1}^t u^{\top} \sigma(x_r^{\xi}) \sigma(x_r^{\xi})^{\top} u \mathrm{d}r \ge \epsilon_1 \sigma_0 = 2\epsilon.$$

This, along with the Chebyshev inequality, the Hölder inequality, and the Bukerholder– Davis–Gundy inequality implies that for any  $u \in \mathbb{R}^d$  with |u| = 1,

$$\begin{split} & \mathbb{P}(u^{\top}\gamma^{E}(t)u \leq \epsilon) \\ \leq & \mathbb{P}\Big(2\Big|\int_{t-\epsilon_{1}}^{t} u^{\top}\Big(\int_{r}^{t} \mathcal{D}b(x_{s}^{\xi})D_{r}x_{s}^{\xi}\mathrm{d}s + \int_{r}^{t} \mathcal{D}\sigma(x_{s}^{\xi})D_{r}x_{s}^{\xi}\mathrm{d}W(s)\Big)(\sigma(x_{r}^{\xi}))^{\top}u\mathrm{d}r\Big| \geq \epsilon\Big) \\ \leq & 8\epsilon^{-2}\mathbb{E}\Big[\Big|\int_{t-\epsilon_{1}}^{t} u^{\top}\int_{r}^{t} \mathcal{D}b(x_{s}^{\xi})D_{r}x_{s}^{\xi}\mathrm{d}s(\sigma(x_{r}^{\xi}))^{\top}u\mathrm{d}r\Big|^{2}\Big] \\ & + 8\epsilon^{-2}\mathbb{E}\Big[\Big|\int_{t-\epsilon_{1}}^{t} u^{\top}\int_{r}^{t} \mathcal{D}\sigma(x_{s}^{\xi})D_{r}x_{s}^{\xi}\mathrm{d}W(s)(\sigma(x_{r}^{\xi}))^{\top}u\mathrm{d}r\Big|^{2}\Big] \\ \leq & 8\epsilon^{-2}\epsilon_{1}\int_{t-\epsilon_{1}}^{t}\mathbb{E}\Big[\sup_{r\leq s\leq T}|\mathcal{D}b(x_{s}^{\xi})D_{r}x_{s}^{\xi}|^{2}|\sigma(x_{r}^{\xi})|^{2}\Big](t-r)^{2}\mathrm{d}r \\ & + 8\epsilon^{-2}\epsilon_{1}\int_{t-\epsilon_{1}}^{t}\Big(\mathbb{E}\Big[\Big|\int_{r}^{t} \mathcal{D}\sigma(x_{s}^{\xi})D_{r}x_{s}^{\xi}\mathrm{d}W(s)|^{4}\Big]\Big)^{\frac{1}{2}}\Big(\mathbb{E}[|\sigma(x_{r}^{\xi})|^{4}]\Big)^{\frac{1}{2}}\mathrm{d}r \\ \leq & K\epsilon^{2}\Big(\sup_{0\leq r\leq T}\mathbb{E}\Big[\sup_{r\leq s\leq T}|\mathcal{D}b(x_{s}^{\xi})D_{r}x_{s}^{\xi}|^{4}\Big]\Big)^{\frac{1}{2}}\Big(\sup_{0\leq r\leq T}\mathbb{E}[|\sigma(x_{r}^{\xi})|^{4}]\Big)^{\frac{1}{2}}\Big) \end{split}$$

$$+ K\epsilon \Big( \sup_{0 \le r \le T} \mathbb{E} \Big[ \sup_{r \le s \le T} |\mathcal{D}\sigma(x_s^{\xi}) D_r x_s^{\xi}|^4 \Big] \Big)^{\frac{1}{2}} \Big( \sup_{0 \le r \le T} \mathbb{E} [|\sigma(x_r^{\xi})|^4] \Big)^{\frac{1}{2}} \\ \le \epsilon K_T,$$

where in the last inequality we used

$$|\mathcal{D}b(x_s^{\xi})D_r x_s^{\xi}| \le K(1 + \|x_s^{\xi}\|^{\beta}) \|D_r x_s^{\xi}\|, \quad |\mathcal{D}\sigma(x_s^{\xi})D_r x_s^{\xi}| \le K \|D_r x_s^{\xi}\|,$$

Assumption 1.1, and Lemma 4.1. The proof is finished. The existence of the density function of the solution of (1.1) is stated as follows.

**Theorem 4.1** Under Assumptions 1.1, 4.1–4.3, for any T > 0, the law of  $x^{\xi}(T)$  admits a density function.

**Proof.** Based on Proposition 4.1, we have

$$\sup_{u \in \mathbb{R}^d, |u|=1} \mathbb{P}(u^\top \gamma^E(T)u = 0) \le \sup_{u \in \mathbb{R}^d, |u|=1} \mathbb{P}(u^\top \gamma^E(T)u \le \epsilon) \le \epsilon \quad \forall \epsilon \in (0, 1),$$

which shows the a.s. invertibility of  $\gamma^{E}(T)$  due to the arbitrary of  $\epsilon$ . This, together with  $x^{\xi}(T) \in \mathbb{D}^{1,p}$  and [52, Theorem 2.1.2], completes the proof.  $\Box$ 

Now we are in the position to present the existence of the density function of the  $\theta$ -EM solution. We first show the estimates on the  $\theta$ -EM functional solution.

**Lemma 4.2** Let Assumptions 1.1, 4.1, and 4.2 hold. Assume that the coefficient  $\sigma$  has continuous Gâtueax derivative. Then for  $\Delta \in (0, \frac{1}{4\theta a_5})$ ,  $p \ge 2$ , and T > 0,

$$\mathbb{E}\Big[\sup_{0\leq k\Delta\leq T}\|y_{t_k}^{\xi,\Delta}\|^p\Big]\leq K_T,\qquad \sup_{0\leq u\leq T}\mathbb{E}\Big[\sup_{u\leq k\Delta\leq T}\|D_uy_{t_k}^{\xi,\Delta}\|^p\Big]\leq K_T.$$

**Proof.** The proof of  $\mathbb{E}[\sup_{0 \le k \Delta \le T} \|y_{t_k}^{\xi,\Delta}\|^p] \le K_T$  is similar to that of Proposition 2.1 and thus is omitted. Below we prove  $\sup_{0 \le u \le T} \mathbb{E}[\sup_{u \le k \Delta \le T} \|D_u y_{t_k}^{\xi,\Delta}\|^p] \le K_T$ . For any  $k \in \mathbb{N}$  with  $0 \le k \Delta \le T$  and  $u \in [0,T]$ , we have

$$\begin{split} |D_{u}z^{\xi,\Delta}(t_{k+1})|^{2} &= |D_{u}z^{\xi,\Delta}(t_{k})|^{2} + |\mathcal{D}b(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}|^{2}\Delta^{2} + |\mathcal{D}\sigma(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}\delta W_{k}|^{2} \\ &+ |\sigma(y_{t_{k}}^{\xi,\Delta})\mathbf{1}_{[t_{k},t_{k+1}]}(u)|^{2} + 2\langle D_{u}y^{\xi,\Delta}(t_{k}) - \theta\Delta\mathcal{D}b(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta},\mathcal{D}b(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}\Delta\rangle \\ &+ 2\langle D_{u}z^{\xi,\Delta}(t_{k}) + \mathcal{D}b(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}\Delta,\sigma(y_{t_{k}}^{\xi,\Delta})\mathbf{1}_{[t_{k},t_{k+1}]}(u)\rangle + \tilde{\mathcal{M}}_{k} \\ &\leq |D_{u}z^{\xi,\Delta}(t_{k})|^{2} + |\mathcal{D}\sigma(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}\delta W_{k}|^{2} + |\sigma(y_{t_{k}}^{\xi,\Delta})\mathbf{1}_{[t_{k},t_{k+1}]}(u)|^{2} + 2\langle D_{u}y^{\xi,\Delta}(t_{k}), \\ &\mathcal{D}b(y_{t_{k}}^{\xi,\Delta})D_{u}y_{t_{k}}^{\xi,\Delta}\Delta\rangle + \langle \frac{2(\theta-1)}{\theta}D_{u}z^{\xi,\Delta}(t_{k}) + \frac{2}{\theta}D_{u}y^{\xi,\Delta}(t_{k}), \\ &\sigma(y_{t_{k}}^{\xi,\Delta})\mathbf{1}_{[t_{k},t_{k+1}]}(u)\rangle, \end{split}$$

where

$$\tilde{\mathcal{M}}_k := 2 \langle D_u z^{\xi, \Delta}(t_k) + \mathcal{D}b(y_{t_k}^{\xi, \Delta}) D_u y_{t_k}^{\xi, \Delta} \Delta + \sigma(y_{t_k}^{\xi, \Delta}) \mathbf{1}_{[t_k, t_{k+1}]}(u), \mathcal{D}\sigma(y_{t_k}^{\xi, \Delta}) D_u y_{t_k}^{\xi, \Delta} \delta W_k \rangle.$$

By Assumptions 1.1 and 4.1, one has that for any  $\phi, \phi_1 \in \mathcal{C}^d$ ,

$$\langle \phi(0), \mathcal{D}b(\phi_1)\phi \rangle \vee |\mathcal{D}b(\phi_1)\phi|^2 \leq K(|\phi(0)|^2 + \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_1(r) + \int_{-\tau}^0 |\phi(r)|^2 \mathrm{d}\nu_2(r)).$$

This implies that for any  $p \in \mathbb{N}_+$ ,

$$|D_{u}z^{\xi,\Delta}(t_{k+1})|^{2p} = |D_{u}z^{\xi,\Delta}(t_{k})|^{2p} + \sum_{l=1}^{p} C_{p}^{l}I_{k,l} = \sum_{i=0}^{k} \sum_{l=1}^{p} C_{p}^{l}I_{i,l}, \qquad (4.2)$$

where

$$\begin{split} I_{i,l} &:= |D_u z^{\xi,\Delta}(t_i)|^{2(p-l)} \Big( |\mathcal{D}\sigma(y_{t_i}^{\xi,\Delta}) D_u y_{t_i}^{\xi,\Delta} \delta W_i|^2 + |\sigma(y_{t_i}^{\xi,\Delta}) \mathbf{1}_{[t_i,t_{i+1}]}(u)|^2 \\ &+ K\Delta(|D_u y^{\xi,\Delta}(t_i)|^2 + \int_{-\tau}^0 |D_u y_{t_i}^{\xi,\Delta}(r)|^2 \mathrm{d}\nu_2(r)) + \langle \frac{2(\theta-1)}{\theta} D_u z^{\xi,\Delta}(t_i) \\ &+ \frac{2}{\theta} D_u y^{\xi,\Delta}(t_i), \sigma(y_{t_i}^{\xi,\Delta}) \mathbf{1}_{[t_i,t_{i+1}]}(u) \rangle + \tilde{\mathcal{M}}_i \Big)^l. \end{split}$$

+ K\Delta\mathbb{E}\Big[\int_{-\tau}^{0}|D_{u}y_{t_{i}}^{\xi,\Delta}(r)|^{2p}d\nu_{1}(r) + \int_{-\tau}^{0}|D_{u}y_{t_{i}}^{\xi,\Delta}(r)|^{2p}d\nu_{2}(r)\Big] + K_{T}\mathbf{1}_{[t_{i},t_{i+1}]}(u). \quad (4.4)$$

Similarly, we deduce that for any  $l \in \{3, \dots, p\}$ ,

$$\mathbb{E}[|I_{i,l}|] \leq (K\Delta + \mathbf{1}_{[t_i, t_{i+1}]}(u)) \mathbb{E}[|D_u z^{\xi, \Delta}(t_i)|^{2p} + |D_u y^{\xi, \Delta}(t_i)|^{2p}] + K\Delta \mathbb{E}\Big[\int_{-\tau}^0 |D_u y_{t_i}^{\xi, \Delta}(r)|^{2p} \mathrm{d}\nu_1(r) + \int_{-\tau}^0 |D_u y_{t_i}^{\xi, \Delta}(r)|^{2p} \mathrm{d}\nu_2(r)\Big] + K_T \mathbf{1}_{[t_i, t_{i+1}]}(u).$$

Inserting (4.3)-(4.5) into (4.2), we arrive at

$$\mathbb{E}[|D_{u}z^{\xi,\Delta}(t_{k+1})|^{2p}] \le K \sum_{i=0}^{k} (\Delta + \mathbf{1}_{[t_{i},t_{i+1}]}(u)) \mathbb{E}[|D_{u}z^{\xi,\Delta}(t_{i})|^{2p} + |D_{u}y^{\xi,\Delta}(t_{i})|^{2p}] + K_{T} \sum_{i=0}^{k} \mathbf{1}_{[t_{i},t_{i+1}]}(u)$$

$$+ K\Delta \sum_{i=0}^{k} \mathbb{E} \Big[ \int_{-\tau}^{0} |D_{u}y_{t_{i}}^{\xi,\Delta}(r)|^{2p} d\nu_{1}(r) + \int_{-\tau}^{0} |D_{u}y_{t_{i}}^{\xi,\Delta}(r)|^{2p} d\nu_{2}(r) \Big]$$
  
$$\leq K \sum_{i=0}^{k} (\Delta + \mathbf{1}_{[t_{i},t_{i+1}]}(u)) \mathbb{E} \big[ |D_{u}z^{\xi,\Delta}(t_{i})|^{2p} + |D_{u}y^{\xi,\Delta}(t_{i})|^{2p} \big] + K_{T}.$$
(4.6)

Here, we used

$$\sum_{i=0}^{k} \int_{-\tau}^{0} |D_{u}y_{t_{i}}^{\xi,\Delta}(r)|^{2p} \mathrm{d}\nu_{j}(r) \leq \sum_{i=0}^{k} |D_{u}y^{\xi,\Delta}(t_{i})|^{2p}, \quad j = 1, 2,$$

whose proof is similar to (2.12). It follows from

Utilizing the Burkholder–Davis–Gundy inequality, (4.10), and (4.11), we have

$$\mathbb{E}\Big[\sup_{u\leq t_k\leq T}\sum_{i=0}^k I_{i,2}\Big]\leq K_T+\frac{1}{4C_p^2}\mathbb{E}\Big[\sup_{u\leq t_k\leq T}|D_u z^{\xi,\Delta}(t_k)|^{2p}\Big].$$

This, along with (4.12) and (4.13) gives that

$$\sup_{0 \le u \le T} \mathbb{E} \Big[ \sup_{u \le t_{k+1} \le T} |D_u z^{\xi, \Delta}(t_{k+1})|^{2p} \Big] \le K_T.$$

It follows from (4.7) that

$$\sup_{0 \le u \le T} \mathbb{E} \Big[ \sup_{u \le t_{k+1} \le T} |D_u y^{\xi, \Delta}(t_{k+1})|^{2p} \Big] \le K_T.$$

The proof is competed.  $\square$ As a consequence, we obtain  $y^{\xi,\Delta}(t_k) \in \mathbb{D}^{1,p}$ . Below we show the existence of the numerical density function.

**Theorem 4.2** Under Assumptions 1.1, 4.1–4.3, for  $\Delta \in (0, \frac{1}{4\theta a_5})$  and  $k \in \mathbb{N}_+$ , the law of  $y^{\xi,\Delta}(t_k)$  admits a density function.

**Proof.** Similar to the proof of Theorem 4.1, it suffices to show that the Malliavin covariance matrix of  $y^{\xi,\Delta}(t_k)$ , defined by  $\gamma_k := \int_0^{t_k} D_r y^{\xi,\Delta}(t_k) (D_r y^{\xi,\Delta}(t_k))^\top dr$ , is a.s. invertible.

Taking the Malliavin derivative on both sides of the  $\theta$ -EM solution, we derive

$$D_r y^{\xi,\Delta}(t_{k+1}) = D_r y^{\xi,\Delta}(t_k) + (1-\theta) \mathcal{D}b(y_{t_k}^{\xi,\Delta}) D_r y_{t_k}^{\xi,\Delta} \Delta + \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) D_r y_{t_{k+1}}^{\xi,\Delta} \Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta}) D_r y_{t_k}^{\xi,\Delta} \delta W_k + \sigma(y_{t_k}^{\xi,\Delta}) D_r \delta W_k.$$

where  $I^{j}(\cdot) \in \mathcal{C}([-\tau, 0]; \mathbb{R}), j = -N, \ldots, 0$  are given in (3.8). This implies

$$\begin{split} D_r y^{\xi,\Delta}(t_{k+1}) &- \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) D_r y^{\xi,\Delta}(t_{k+1}) I^0 \Delta \\ &= D_r y^{\xi,\Delta}(t_k) + (1-\theta) \mathcal{D}b(y_{t_k}^{\xi,\Delta}) D_r y_{t_k}^{\xi,\Delta} \Delta + \sigma(y_{t_k}^{\xi,\Delta}) D_r \delta W_k \\ &+ \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) \Big( \sum_{j=-N}^{-1} I^j D_r y_{t_{k+1}}^{\xi,\Delta}(s_j) \Big) \Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta}) D_r y_{t_k}^{\xi,\Delta} \delta W_k \\ &= D_r y^{\xi,\Delta}(t_k) + (1-\theta) \mathcal{D}b(y_{t_k}^{\xi,\Delta}) D_r \Big( \sum_{j=-N}^{0} I^j y_{t_k}^{\xi,\Delta}(t_j) \Big) \Delta + \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) I^{-1} D_r y^{\xi,\Delta}(t_k) \Delta \\ &+ \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) \sum_{j=-N}^{-2} I^j D_r y_{t_{k+1}}^{\xi,\Delta}(t_j) \Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta}) D_r \Big( \sum_{j=-N}^{0} I^j y_{t_k}^{\xi,\Delta}(t_j) \Big) \delta W_k \\ &+ \sigma(y_{t_k}^{\xi,\Delta}) D_r \delta W_k. \end{split}$$

It is straightforward to see that

$$\left(\operatorname{Id}_{d\times d} - \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta})I^0 \Delta\right) D_r y^{\xi,\Delta}(t_{k+1})$$
$$= \sum_{j=-N}^0 A_{j,k} D_r y^{\xi,\Delta}(t_{k+j}) + \sigma(y_{t_k}^{\xi,\Delta}) \mathbf{1}_{[t_k,t_{k+1}]}(r),$$
(4.14)

where

$$A_{0,k} := \mathrm{Id}_{d\times d} + (1-\theta)\mathcal{D}b(y_{t_k}^{\xi,\Delta})I^0\Delta + \theta\mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta})I^{-1}\Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta})I^0\delta W_k,$$
  

$$A_{-N,k} := (1-\theta)\mathcal{D}b(y_{t_k}^{\xi,\Delta})I^{-N}\Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta})I^{-N}\delta W_k,$$
  

$$A_{j,k} := (1-\theta)\mathcal{D}b(y_{t_k}^{\xi,\Delta})I^j\Delta + \theta\mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta})I^{j-1}\Delta + \mathcal{D}\sigma(y_{t_k}^{\xi,\Delta})I^j\delta W_k$$

for  $j = -1, \ldots, -N + 1$ . It follows from Assumption 4.1 that for any  $0 \neq u \in \mathbb{R}^d$ ,

$$u^{\top} \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta}) I^0 u \le 2a_5 |u|^2.$$

Then for  $\Delta \in (0, \frac{1}{4\theta a_5})$ ,

$$u^{\top} \Big( \mathrm{Id}_{d \times d} - \theta \mathcal{D}b(y_{t_{k+1}}^{\xi, \Delta}) I^0 \Delta \Big) u \ge (1 - 2\theta a_5 \Delta) |u|^2 > 0.$$

which implies that  $\mathrm{Id}_{d\times d} - \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta})I^0\Delta$  is invertible. Denoting  $A_{1,k} := (\mathrm{Id}_{d\times d} - \theta \mathcal{D}b(y_{t_{k+1}}^{\xi,\Delta})I^0\Delta)^{-1}$ , we derive  $||A_{1,k}||_{\mathcal{L}(\mathbb{R}^d;\mathbb{R}^d)} \in (0, \frac{1}{1-2\theta a_5\Delta})$ . According to (4.14), we arrive at

$$\gamma_{k+1} = \int_{0}^{t_{k+1}} D_r y^{\xi,\Delta}(t_{k+1}) (D_r y^{\xi,\Delta}(t_{k+1}))^{\top} dr$$
  
= 
$$\int_{0}^{t_k} A_{1,k} \sum_{j=-N}^{0} A_{j,k} D_r y^{\xi,\Delta}(t_{k+j}) \Big(\sum_{j=-N}^{0} A_{j,k} D_r y^{\xi,\Delta}(t_{k+j})\Big)^{\top} (A_{1,k})^{\top} dr$$
  
+ 
$$\int_{t_k}^{t_{k+1}} A_{1,k} \sigma(y_{t_k}^{\xi,\Delta}) \sigma(y_{t_k}^{\xi,\Delta})^{\top} (A_{1,k})^{\top} dr, \qquad (4.15)$$

where we used  $D_r y^{\xi,\Delta}(t_k) = 0$  for  $r > t_k$ . Since  $\sigma(x)\sigma(x)^{\top}$  is positive definite, we deduce

$$u^{\top}\gamma_{k+1}u \ge \Delta u^{\top}A_{1,k}\sigma(y_{t_k}^{\xi,\Delta})\sigma(y_{t_k}^{\xi,\Delta})^{\top}(A_{1,k})^{\top}u > 0 \quad a.s.$$

Moreover, utilizing again the invertibility of  $\sigma\sigma^{\top}$ , we have that

$$\gamma_1 = \int_0^{t_1} A_{1,0} \sigma(\xi) \sigma(\xi)^\top (A_{1,0})^\top \mathrm{d}r$$

is also a.s. invertible. This finishes the proof.  $\Box$ 

# 4.2 Convergence of numerical density function

In this section, we investigate the convergence of the numerical density function of the  $\theta$ -EM method on the finite and infinite time horizons, respectively. We first give the convergence of the numerical density function in  $L^1(\mathbb{R}^d)$  on the finite time horizon for the superlinearly growing drift coefficient case. Then we show that the longtime convergence rate of the numerical density function is 1 for the linear growing drift coefficient case.

## 4.2.1 Convergence on the finite time horizon

**Assumption 4.4** Assume that coefficients b and  $\sigma$  have continuous Gâteaux derivatives up to order 2 satisfying

$$\begin{aligned} |\mathcal{D}^2 b(\phi_1)(\phi_2,\phi_3)| &\leq K(1+\|\phi_1\|^{(\beta-1)\vee 0}) \|\phi_2\| \|\phi_3\|, \\ |\mathcal{D}^2 \sigma(\phi_1)(\phi_2,\phi_3)| &\leq K \|\phi_2\| \|\phi_3\|, \end{aligned}$$

where  $\phi_1, \phi_2, \phi_3 \in C^d$ , K > 0, and  $\tilde{\beta}$  is given in Assumption 4.2.

**Theorem 4.3** Let Assumptions 1.1, 2.3, 4.1-4.4 hold. Then for any T > 0,

$$\lim_{\Delta \to 0} \sup_{0 \le k \le T} \int_{\mathbb{R}^d} |\mathfrak{p}^{\Delta}(t_k, x) - \mathfrak{p}(t_k, x)| \mathrm{d}x = 0,$$

where  $\mathfrak{p}(t_k, \cdot)$ ,  $\mathfrak{p}^{\Delta}(t_k, \cdot)$  are density functions of  $x^{\xi}(t_k)$  and  $y^{\xi, \Delta}(t_k)$ , respectively.

**Proof.** The proof is based on the localization argument and is divided into two steps.

<u>Step 1.</u> Introduce the smooth cut-off functional  $\Theta_R : \mathcal{C}^d \to [0,1]$  with continuous derivatives and compact support. For  $R > ||\xi||$ , let  $\Theta_R(x) = 1$  for  $||x|| \le R$  and  $\Theta_R(x) = 0$  for ||x|| > R + 1. Then we consider the truncated version of (1.1) on [0,T],

$$dx^{\xi,R}(t) = b^R(x_t^{\xi,R})dt + \sigma^R(x_t^{\xi,R})dW(t), \quad t \in (0,T],$$

$$x^{\xi,R}(t) = \xi, \quad t \in [-\tau, 0],$$
(4.16)

where  $b^R = \Theta_R b$  and  $\sigma^R = \Theta_R \sigma$  are globally Lipschitz continuous for each R. Moreover, the coefficients  $b^R$  and  $\sigma^R$  satisfy

$$|\mathcal{D}b^{R}(\phi_{1})\phi_{2}|^{2} \vee |\mathcal{D}\sigma^{R}(\phi_{1})\phi_{2}|^{2} \leq K_{R} \Big( |\phi_{2}(0)|^{2} + \int_{-\tau}^{0} |\phi_{2}(r)|^{2} \mathrm{d}\nu_{1}(r) + \int_{-\tau}^{0} |\phi_{2}(r)|^{2} \mathrm{d}\nu_{2}(r) \Big),$$

where  $\phi_1, \phi_2 \in \mathcal{C}^d$ . In addition, the numerical solution, the numerical functional solution, and the auxiliary process of the  $\theta$ -EM method for (4.16) are denoted by  $\{y^{\xi,\Delta,R}(t_k)\}_{k\geq -N}$ ,  $\{y_{t_k}^{\xi,\Delta,R}\}_{k\geq 0}$ , and  $\{z^{\xi,\Delta,R}(t_k)\}_{k\geq -N}$ , respectively. We need to estimate the error between  $x^{\xi,R}(t)$  and  $y^{\xi,\Delta,R}(t)$  in  $\|\cdot\|_{1,2}$ . Similar to the proof of Theorem 2.3, using Lemmas 4.1 and 4.2, we deduce from Assumptions 1.1, 2.2, 4.1, and 4.2 that

$$\mathbb{E}\Big[\sup_{0\leq t_k\leq T}|x^{\xi}(t_k)-y^{\xi,\Delta}(t_k)|^4\Big]\leq K_T\Delta^2.$$
(4.17)

This implies

$$\mathbb{E}\Big[\sup_{0 \le t_k \le T} |x^{\xi,R}(t_k) - y^{\xi,\Delta,R}(t_k)|^4\Big] \le K_{T,R}\Delta^2.$$
(4.18)

Moreover, we have

$$\mathbb{E}[|D_{u}x^{\xi,R}(t) - D_{u}z^{\xi,\Delta,R}(t)|^{2}] \\
\leq K(t-u)\mathbb{E}\Big[\int_{u}^{t} |\mathcal{D}b^{R}(x_{s}^{\xi,R})D_{u}x_{s}^{\xi,R} - \mathcal{D}b^{R}(y_{\lfloor s \rfloor}^{\xi,\Delta,R})D_{u}y_{\lfloor s \rfloor}^{\xi,\Delta,R}|^{2}ds\Big] \\
+ K\mathbb{E}\Big[\int_{u}^{t} |\mathcal{D}\sigma^{R}(x_{s}^{\xi,R})D_{u}x_{s}^{\xi,R} - \mathcal{D}\sigma^{R}(y_{\lfloor s \rfloor}^{\xi,\Delta,R})D_{u}y_{\lfloor s \rfloor}^{\xi,\Delta,R}|^{2}ds\Big] \\
+ \mathbb{E}\Big[|\sigma^{R}(x_{u}^{\xi,R})\mathbf{1}_{[0,t]}(u) - \sigma^{R}(y_{\lfloor u \rfloor}^{\xi,\Delta,R})\mathbf{1}_{[0,t]}(u)|^{2}\Big].$$
(4.19)

It follows from the Taylor formula that

$$\begin{aligned} & \left| \mathcal{D}b^{R}(x_{s}^{\xi,R}) D_{u}x_{s}^{\xi,R} - \mathcal{D}b^{R}(y_{\lfloor s \rfloor}^{\xi,\Delta,R}) D_{u}y_{\lfloor s \rfloor}^{\xi,\Delta,R} \right| \\ & \leq \left| \int_{0}^{1} \mathcal{D}^{2}b^{R}(\varsigma x_{\lfloor s \rfloor}^{\xi,R} + (1-\varsigma)y_{s}^{\xi,\Delta,R}) (x_{s}^{\xi,R} - y_{\lfloor s \rfloor}^{\xi,\Delta,R}, D_{u}x_{s}^{\xi,R}) \mathrm{d}\varsigma \right| \\ & + \left| \mathcal{D}b^{R}(y_{\lfloor s \rfloor}^{\xi,\Delta,R}) (D_{u}x_{s}^{\xi,R} - D_{u}y_{\lfloor s \rfloor}^{\xi,\Delta,R}) \right| \end{aligned}$$

$$\leq K_R \| x_s^{\xi,R} - y_{\lfloor s \rfloor}^{\xi,\Delta,R} \| \| D_u x_s^{\xi,R} \| + K_R \Big( |D_u x^{\xi,R}(s) - D_u y^{\xi,\Delta,R}(\lfloor s \rfloor)|^2 \\ + \int_{-\tau}^0 |D_u x_s^{\xi,R}(r) - D_u y_{\lfloor s \rfloor}^{\xi,\Delta,R}(r)|^2 \mathrm{d}\nu_2(r) \Big)^{\frac{1}{2}}.$$

where in the last inequality we used the boundedness of operators  $\mathcal{D}b^{R}(\cdot)$  and  $\mathcal{D}^{2}b^{R}(\cdot)$  on their compact support  $\{x \in \mathcal{C}^{d} : ||x|| \leq R+1\}$ . Similar to the proof of Lemma 2.3, we obtain

$$\sup_{u \le t \le T} \mathbb{E}[\|D_u y_{\lfloor t \rfloor}^{\xi, \Delta, R} - D_u z_t^{\xi, \Delta, R}\|^2] \le K_{T, R} \Delta.$$

Then

$$\mathbb{E}\Big[\left|\mathcal{D}b^{R}(x_{s}^{\xi,R})D_{u}x_{s}^{\xi,R}-\mathcal{D}b^{R}(y_{\lfloor s\rfloor}^{\xi,\Delta,R})D_{u}y_{\lfloor s\rfloor}^{\xi,\Delta,R}\right|^{2}\Big] \\
\leq K_{R}\mathbb{E}\big[\|x_{s}^{\xi,R}-y_{\lfloor s\rfloor}^{\xi,\Delta,R}\|^{2}\|D_{u}x_{s}^{\xi,R}\|^{2}\big]+K_{R}\mathbb{E}\Big[|D_{u}x^{\xi,R}(s)-D_{u}z^{\xi,\Delta,R}(s)|^{2} \\
+\int_{-\tau}^{0}\left|D_{u}x_{s}^{\xi,R}(r)-D_{u}z_{s}^{\xi,\Delta,R}(r)\right|^{2}\mathrm{d}\nu_{2}(r)\Big]+K_{T,R}\Delta.$$
(4.20)

Similarly, we deduce

$$\left| \mathcal{D}\sigma^{R}(x_{s}^{\xi,R}) D_{u}x_{s}^{\xi,R} - \mathcal{D}\sigma^{R}(y_{\lfloor s \rfloor}^{\xi,\Delta,R}) D_{u}y_{\lfloor s \rfloor}^{\xi,\Lambda,R} \right| \\
\leq K_{R}\mathbb{E}\left[ \|x_{s}^{\xi,R} - y_{\lfloor s \rfloor}^{\xi,\Delta,R}\|^{2} \|D_{u}x_{s}^{\xi,R}\|^{2} \right] + K_{R}\mathbb{E}\left[ |D_{u}x^{\xi,R}(s) - D_{u}z^{\xi,\Delta,R}(s)|^{2} + \int_{-\tau}^{0} |D_{u}x_{s}^{\xi,R}(r) - D_{u}z_{s}^{\xi,\Delta,R}(r)|^{2} d\nu_{2}(r) \right] + K_{T,R}\Delta.$$
(4.21)

Inserting (4.20) and (4.21) into (4.19), and then using Assumption 1.1, Lemmas 4.1 and 4.2, and (4.18), we obtain that for  $\Delta \in (0, \frac{1}{4\theta a_5})$ ,

$$\begin{split} & \mathbb{E}\Big[|D_{u}x^{\xi,R}(t) - D_{u}z^{\xi,\Delta,R}(t)|^{2}\Big] \\ &\leq K_{T,R}\Delta + K_{T,R}\int_{u}^{T} \big(\mathbb{E}[||x_{\lfloor s \rfloor}^{\xi,R} - y_{\lfloor s \rfloor}^{\xi,\Delta,R}||^{4}]\big)^{\frac{1}{2}} \mathrm{d}s + K_{T,R}\int_{u}^{T} \big(\mathbb{E}[||x_{\lfloor s \rfloor}^{\xi,R} - x_{s}^{\xi,R}||^{4}]\big)^{\frac{1}{2}} \mathrm{d}s \\ &+ K_{T,R}\mathbb{E}\Big[\int_{u}^{T} |D_{u}x^{\xi,R}(s) - D_{u}z^{\xi,\Delta,R}(s)|^{2} \mathrm{d}s\Big] + K\sup_{0 \leq s \leq T} \mathbb{E}[||x_{\lfloor s \rfloor}^{\xi,R} - x_{s}^{\xi,R}||^{2}] \\ &\leq K_{T,R}\Delta + K_{T,R}\int_{u}^{T} \mathbb{E}[|D_{u}x^{\xi,R}(s) - D_{u}z^{\xi,\Delta,R}(s)|^{2}] \mathrm{d}s. \end{split}$$

Applying the Grönwall inequality, we arrive at

$$\mathbb{E}\Big[|D_u x^{\xi,R}(t) - D_u z^{\xi,\Delta,R}(t)|^2\Big] \le K_{T,R}\Delta,$$

which implies

$$\int_0^T \mathbb{E}\Big[|D_u x^{\xi,R}(t_k) - D_u y^{\xi,\Delta,R}(t_k)|^2\Big] \mathrm{d}u \le K_{T,R}\Delta.$$
(4.22)

It follows from (4.18) and (4.22) that

$$\sup_{0 \le k\Delta \le T} \|y^{\xi,\Delta,R}(t_k) - x^{\xi,R}(t_k)\|_{1,2} \le K_{T,R}\Delta^{\frac{1}{2}}.$$

Furthermore, similar to [31, Lemma A.5], combining Proposition 4.1, we obtain that for any  $\varrho \in (0,1)$ ,  $\mathbb{E}[(\int_0^T |D_u x^{\xi,R}(t)|^2 du)^{-\varrho}] \leq K_{T,R,\varrho}$ . Similar to the proof of Lemma 4.1, it follows from Assumptions 1.1, 4.1, 4.2, and 4.4 that  $x_t^{\xi} \in \mathbb{D}^{2,4}(\mathcal{C}^d)$  for all  $t \in [0,T]$ . Then, by [31, Lemma A.1], we arrive at

$$\sup_{0 \le k\Delta \le T} \int_{\mathbb{R}^d} |\mathfrak{p}^{\Delta,R}(t_k,x) - \mathfrak{p}^R(t_k,x)| dx = \sup_{0 \le k\Delta \le T} d_{TV}(y^{\Delta,\xi,R}(t_k), x^{\xi,R}(t_k))$$

$$\le K_{T,R} \sup_{0 \le k\Delta \le T} \|y^{\Delta,\xi,R}(t_k) - x^{\xi,R}(t_k)\|_{1,2}^{\frac{2\rho}{2\rho+2}}$$

$$\le K_{T,R} \Delta^{\frac{\rho}{2\rho+2}}, \qquad (4.23)$$

where  $d_{TV}(X, Y)$  denotes the total variation distance between two  $\mathbb{R}^d$ -valued random variables X and Y, and  $\mathfrak{p}^R(t_k, \cdot)$ ,  $\mathfrak{p}^{\Delta, R}(t_k, \cdot)$  are density functions of  $x^{\xi, R}(t_k)$  and  $y^{\xi, \Delta, R}(t_k)$ , respectively.

Step 2. Denoting two sequences of events by

$$\Omega_R := \{ \omega \in \Omega : \sup_{t \in [0,T]} |x^{\xi}(t)| \le R \},$$
  
$$\Omega_{R,y} := \{ \omega \in \Omega : \sup_{t_k \in [0,T]} |y^{\xi,\Delta}(t_k)| \le R \},$$

we have  $\lim_{R\to\infty} \mathbb{P}(\Omega_R) = \mathbb{P}(\Omega) = \lim_{R\to\infty} \mathbb{P}(\Omega_{R,y}) = 1$ . According to [31, Section 6] and [31, (6.3)], we derive

$$\int_{\mathbb{R}^d} |\mathfrak{p}^{\Delta}(t_k, x) - \mathfrak{p}(t_k, x)| dx = d_{TV}(y^{\Delta, \xi}(t_k), x^{\xi}(t_k))$$
  

$$\leq 4\mathbb{P}(\Omega_{R-1}^c) + 2\mathbb{P}(\sup_{0 \le t_k \le T} |x^{\xi}(t_k) - y^{\xi, \Delta}(t_k)| \ge 1) + d_{TV}(y^{\Delta, \xi, R}(t_k), x^{\xi, R}(t_k))$$
  

$$\leq 4\frac{\mathbb{E}[\sup_{0 \le t \le T} |x^{\xi}(t)|^2]}{(R-1)^2} + 2\mathbb{E}[\sup_{0 \le t_k \le T} |x^{\xi}(t_k) - y^{\xi, \Delta}(t_k)|^2] + K_{T, R}\Delta^{\frac{\rho}{2\rho+2}}.$$

Combining (4.17), (4.23), and Lemma 4.1, and letting  $\Delta \to 0, R \to \infty$ , we obtain the desired argument.

**Remark 4.1** It follows from the proof of Theorem 4.3 that when the coefficients b and  $\sigma$  are globally Lipschitz continuous, the convergence rate of the numerical density function is almost 1/4 in  $L^1(\mathbb{R}^d)$ .

## 4.2.2 Convergence on the infinite time horizon

In this subsection, we focus on the additive noise case and study the longtime convergence of the numerical density function based on the test-functional-independent weak convergence of the  $\theta$ -EM method.

**Assumption 4.5** Assume that the noise of (1.1) is of additive type, i.e., there exists some matrix  $\tilde{\sigma}$  such that for any  $\phi \in C^d$ ,  $\sigma(\phi) \equiv \tilde{\sigma}$ .

**Assumption 4.6** Assume that the coefficient b has continuous and bounded derivatives up to order 4 satisfying

$$\sup_{\phi \in \mathcal{C}^d} \left\| \mathcal{D}^k b(\phi) \right\|_{\mathcal{L}\left( (\mathcal{C}^d)^{\otimes k}; \mathbb{R}^d \right)} \le K$$

for  $k \in \mathbb{N}_+$  with  $k \leq 4$ . In addition, assume that b satisfies the following form

$$|b(\phi)|^{2} \leq K (1 + |\phi(0)|^{2} + \int_{-\tau}^{0} |\phi(r)|^{2} \mathrm{d}\nu_{2}(r)), \qquad (4.24)$$

where  $\phi \in \mathcal{C}^d$ .

The longtime convergence rate of the numerical density function is stated as follows.

**Theorem 4.4** Let Assumption 1.2 with  $2a_1 - \frac{2\theta-1}{\theta^2} - 2a_2 > 0$ , Assumption 3.4 with  $L_b := \sup_{i \in \{1,...,n_b\}} \sup_{\phi \in C^d} ||k_b^i(\phi)|| < \infty$ , Assumptions 4.5 and 4.6 hold. In addition, assume that b satisfies

$$\sup_{i \in \{1, \cdots, n_b\}} \sup_{l \in \{1, 2, 3\}} \sup_{\phi \in \mathcal{C}^d} \|D^l k_b^i(\phi)\|_{\mathcal{L}((\mathcal{C}^d)^{\otimes l}; \mathcal{C}([-\tau, 0]; \mathbb{R}^{d \times d}))} \le K.$$

Then there exists a constant  $\tilde{\Delta} \in (0, 1]$  such that for any  $\Delta \in (0, \tilde{\Delta}]$ ,

$$\sup_{T \ge T_0, z \in \mathbb{R}^d} |\mathfrak{p}(T, z) - \mathfrak{p}^{\Delta}(T, z)| \le K\Delta,$$

where  $T_0 = \frac{\ln(\frac{3}{2})}{2L_b n_b(\theta+2)}$ .

Remark 4.2 Theorem 4.4, together with the Scheffé lemma, indicates that

$$\sup_{T \ge T_0} \int_{\mathbb{R}^d} |\mathfrak{p}(T, z) - \mathfrak{p}^{\Delta}(T, z)| \mathrm{d}z \to 0 \ as \ \Delta \to 0;$$

see also [13, Section 3.1] for details.

According to [39, 13], we have the following approximation of density functions for both the exact solution and the numerical solution: for fixed T > 0 and  $z \in \mathbb{R}^d$ ,

$$\begin{split} \mathfrak{p}(T,z) &= \lim_{n \to \infty} \int_{\mathbb{R}^d} g_{n^{-1}}(y-z) \mathfrak{p}(T,y) \mathrm{d}y = \lim_{n \to \infty} \mathbb{E}[g_{n^{-1}}(x^{\xi}(T)-z)], \\ \mathfrak{p}^{\Delta}(T,z) &= \lim_{n \to \infty} \int_{\mathbb{R}^d} g_{n^{-1}}(y-z) \mathfrak{p}^{\Delta}(T,y) \mathrm{d}y = \lim_{n \to \infty} \mathbb{E}[g_{n^{-1}}(y^{\xi,\Delta}(T)-z)], \end{split}$$

where  $g_{\zeta}$  denotes the Gaussian density function with mean 0 and covariance matrix  $\zeta Id_{d \times d}$ . This gives that

$$|\mathfrak{p}(T,z) - \mathfrak{p}^{\Delta}(T,z)| = \lim_{n \to \infty} |\mathbb{E}[g_{n^{-1}}(x^{\xi}(T) - z)] - \mathbb{E}[g_{n^{-1}}(y^{\xi,\Delta}(T) - z)]|.$$
(4.25)

Note that the function  $\{g_{n^{-1}}(\cdot - z)\}_{n \ge 1, z \in \mathbb{R}^d}$  belongs to

$$\mathscr{C} := \left\{ f : \mathbb{R}^d \to \mathbb{R} \left| f \in \mathcal{C}_{pol}^{\infty}(\mathbb{R}^d; \mathbb{R}), \exists F : \mathbb{R}^d \to \mathbb{R} \text{ with } 0 \le F \le 1 \text{ such that} \right. \right.$$

$$F(x_1,\ldots,x_d) = \int_{-\infty}^{x_1} \cdots \int_{-\infty}^{x_d} f(y_1,\ldots,y_d) \mathrm{d}y_d \cdots \mathrm{d}y_1 \Big\}.$$

To obtain the convergence rate of the numerical density function, it suffices to estimate the error  $|\mathbb{E}[f(x^{\xi}(T))] - \mathbb{E}[f(y^{\xi,\Delta}(T))]|$  for any  $f \in \mathscr{C}$ .

We begin with giving some estimates of the exact solution and numerical solution as well as their high-order derivatives.

**Lemma 4.3** Let Assumptions 1.2 and 4.5, and (4.24) hold. Then for any  $p \in \mathbb{N}_+$  with  $p \geq 2$ ,

$$\sup_{t \ge 0} \mathbb{E}[\|x_t^{\xi}\|^{2p}] \le K(1 + \|\xi\|^{2p}).$$
(4.26)

In addition, there exists a constant  $\tilde{\Delta}_p \in (0,1]$  such that for any  $\Delta \in (0,\tilde{\Delta}_p]$ ,

$$\sup_{k \in \mathbb{N}} \mathbb{E}[\|y_{t_k}^{\xi, \Delta}\|^{2p}] \le K(1 + \|\xi\|^{2p}).$$
(4.27)

**Proof.** The proof of (4.26) is similar to that of [46, Theorem 3] and is omitted. Below we show the proof of (4.27). By virtue of (2.1), we have that for any  $k \in \mathbb{N}$ ,

$$|z^{\xi,\Delta}(t_{k+1})|^{2} = |y^{\xi,\Delta}(t_{k}) + (1-\theta)b(y^{\xi,\Delta}_{t_{k}})\Delta + \tilde{\sigma}\delta W_{k}|^{2}$$
  
$$= |y^{\xi,\Delta}(t_{k})|^{2} + (1-\theta)^{2}|b(y^{\xi,\Delta}_{t_{k}})|^{2}\Delta^{2} + |\tilde{\sigma}\delta W_{k}|^{2} + 2(1-\theta)\Delta\langle y^{\xi,\Delta}(t_{k}), b(y^{\xi,\Delta}_{t_{k}})\rangle$$
  
$$+ 2\langle y^{\xi,\Delta}(t_{k}) + (1-\theta)b(y^{\xi,\Delta}_{t_{k}})\Delta, \tilde{\sigma}\delta W_{k}\rangle.$$

Then for any  $p \in \mathbb{N}_+$  with  $p \ge 2$ ,

$$\mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] = \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + \sum_{i=1}^p C_p^i \mathbb{E}[I_i], \qquad (4.28)$$

where

$$I_{i} := |y^{\xi,\Delta}(t_{k})|^{2(p-i)} \left( (1-\theta)^{2} |b(y^{\xi,\Delta}_{t_{k}})|^{2} \Delta^{2} + |\tilde{\sigma}\delta W_{k}|^{2} + 2(1-\theta)\Delta \langle y^{\xi,\Delta}(t_{k}), b(y^{\xi,\Delta}_{t_{k}}) \rangle + 2 \langle y^{\xi,\Delta}(t_{k}) + (1-\theta)b(y^{\xi,\Delta}_{t_{k}})\Delta, \tilde{\sigma}\delta W_{k} \rangle \right)^{i}.$$

For the term  $I_1$ , it follows from the property of the conditional expectation, Assumption 1.2, and (4.24) that for  $\varepsilon_1 \in (0, 1)$ ,

$$\begin{split} \mathbb{E}[I_{1}] &\leq \mathbb{E}\Big[|y^{\xi,\Delta}(t_{k})|^{2(p-1)}\Big((1-\theta)^{2}|b(y^{\xi,\Delta}_{t_{k}})|^{2}\Delta^{2}+|\tilde{\sigma}|^{2}\Delta+K\Delta\\ &-2a_{1}(1-\theta)\Delta|y^{\xi,\Delta}(t_{k})|^{2}+2a_{2}(1-\theta)\Delta\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{k}}(r)|^{2}\mathrm{d}\nu_{2}(r)\Big)\Big]\\ &\leq \mathbb{E}\Big[|y^{\xi,\Delta}(t_{k})|^{2(p-1)}(K\Delta+(1-\theta)^{2}|b(y^{\xi,\Delta}_{t_{k}})|^{2}\Delta^{2})\Big]-2(a_{1}-\frac{a_{2}(p-1)}{p})\times\\ &(1-\theta)\Delta\mathbb{E}[|y^{\xi,\Delta}(t_{k})|^{2p}]+\frac{2a_{2}}{p}(1-\theta)\Delta\mathbb{E}\Big[\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{k}}(r)|^{2p}\mathrm{d}\nu_{2}(r)\Big]\\ &\leq K(\varepsilon_{1})\Delta+K\Delta^{2}\Big(\mathbb{E}[|y^{\xi,\Delta}(t_{k})|^{2p}]+\mathbb{E}\Big[\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{k}}(r)|^{2p}\mathrm{d}\nu_{2}(r)\Big]\Big)-2(a_{1}-\frac{a_{2}(p-1)}{p}) \end{split}$$

## 4.2 Convergence of numerical density function

$$-\varepsilon_1(1-\theta)\Delta\mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + \frac{2a_2}{p}(1-\theta)\Delta\mathbb{E}\Big[\int_{-\tau}^0 |y_{t_k}^{\xi,\Delta}(r)|^{2p} \mathrm{d}\nu_2(r)\Big],\tag{4.29}$$

where we used the Young inequality. For the term  $I_2$ , using (4.24) and the Young inequality again, we have

$$\mathbb{E}[I_2] \leq \mathbb{E}\Big[|y^{\xi,\Delta}(t_k)|^{2(p-2)} \Big((1-\theta)^2 |b(y_{t_k}^{\xi,\Delta})|^2 \Delta^2 + |\tilde{\sigma}|^2 \Delta + 2(1-\theta) \Delta \langle y^{\xi,\Delta}(t_k), b(y_{t_k}^{\xi,\Delta}) \rangle \Big)^2 + |y^{\xi,\Delta}(t_k)|^{2(p-2)} \Big(2 \langle y^{\xi,\Delta}(t_k) + (1-\theta) b(y_{t_k}^{\xi,\Delta}) \Delta, \tilde{\sigma} \delta W_k \rangle \Big)^2\Big] \\
\leq K \Delta^2 \Big(1 + \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + \mathbb{E}\Big[\int_{-\tau}^0 |y_{t_k}^{\xi,\Delta}(r)|^{2p} d\nu_2(r)\Big]\Big) \\
+ K\Big(\Delta \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2(p-1)}] + \Delta^2 \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2(p-2)} |b(y_{t_k}^{\xi,\Delta})|^2]\Big) \\
\leq K(\varepsilon_1)\Delta + K \Delta^2 \Big(\mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + \mathbb{E}\Big[\int_{-\tau}^0 |y_{t_k}^{\xi,\Delta}(r)|^{2p} d\nu_2(r)\Big]\Big) \\
+ \varepsilon_1 \Delta \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}].$$
(4.30)

Similarly, we derive

$$\mathbb{E}[I_i] \leq K(\varepsilon_1)\Delta + K\Delta^2 \Big( \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + \mathbb{E}\Big[\int_{-\tau}^0 |y_{t_k}^{\xi,\Delta}(r)|^{2p} \mathrm{d}\nu_2(r)\Big] \Big) \\ + \varepsilon_1 \Delta \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}], \quad i \in \mathbb{N} \text{ with } 3 \leq i \leq p.$$

$$(4.31)$$

Inserting (4.29)-(4.31) into (4.28), one has

$$\mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] \leq \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] + K(\varepsilon_1)\Delta - \left(2p(1-\theta)\left(a_1 - \frac{a_2(p-1)}{p}\right)\right)$$
$$- K\Delta - K\varepsilon_1 \Delta \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}]$$
$$+ \left(2a_2(1-\theta) + K\Delta\right)\Delta \mathbb{E}\left[\int_{-\tau}^0 |y^{\xi,\Delta}_{t_k}(r)|^{2p} \mathrm{d}\nu_2(r)\right].$$

Then for  $\epsilon \in (0,1)$ ,

$$e^{\epsilon t_{k+1}} \mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] = \sum_{i=0}^{k} \left( e^{\epsilon t_{i+1}} \mathbb{E}[|z^{\xi,\Delta}(t_{i+1})|^{2p}] - e^{\epsilon t_{i}} \mathbb{E}[|z^{\xi,\Delta}(t_{i})|^{2p}] \right)$$

$$\leq \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}] - \sum_{i=0}^{k} e^{\epsilon t_{i}} \mathbb{E}[|z^{\xi,\Delta}(t_{i})|^{2p}] + K(\varepsilon_{1})\Delta \sum_{i=0}^{k} e^{\epsilon t_{i+1}} - \left(2p(1-\theta)\left(a_{1} - \frac{a_{2}(p-1)}{p}\right) - K\Delta - K\varepsilon_{1}\right)\Delta \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}] + \left(2a_{2}(1-\theta) + K\Delta\right)\Delta \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}\left[\int_{-\tau}^{0} |y^{\xi,\Delta}_{t_{i}}(r)|^{2p} \mathrm{d}\nu_{2}(r)\right]$$

$$\leq \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}] - \sum_{i=0}^{k} e^{\epsilon t_{i}} \mathbb{E}[|z^{\xi,\Delta}(t_{i})|^{2p}] + K(\varepsilon_{1},\epsilon)e^{\epsilon t_{k+1}} + K||\xi||^{2p} - \left(2p(1-\theta)\left(a_{1} - a_{2}e^{\epsilon\tau}\right) - K\Delta - K\varepsilon_{1}\right)\Delta \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}]. \tag{4.32}$$

According to  $z^{\xi,\Delta}(t_k) = y^{\xi,\Delta}(t_k) - \theta \Delta b(y_{t_k}^{\xi,\Delta})$  and Assumption 1.2, we obtain

$$|z^{\xi,\Delta}(t_k)|^2 \ge -K\Delta + (1+2a_1\theta\Delta)|y^{\xi,\Delta}(t_k)|^2 - 2a_2\theta\Delta \int_{-\tau}^0 |y^{\xi,\Delta}t_k(r)|^2 \mathrm{d}\nu_2(r).$$

This implies

$$(1+2a_{1}\theta\Delta)^{p}\sum_{i=0}^{k}e^{\epsilon t_{i}}|y^{\xi,\Delta}(t_{i})|^{2p}$$

$$\leq (1+\varepsilon_{1})\sum_{i=0}^{k}e^{\epsilon t_{i}}\left(|z^{\xi,\Delta}(t_{i})|^{2}+2a_{2}\theta\Delta\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{i}}(r)|^{2}d\nu_{2}(r)\right)^{p}+K(\varepsilon_{1})\Delta^{p}\sum_{i=0}^{k}e^{\epsilon t_{i}}$$

$$\leq (1+\varepsilon_{1})\sum_{i=0}^{k}\sum_{l=0}^{p}\frac{C_{p}^{l}(2a_{2}\theta\Delta)^{l}(p-l)}{p}e^{\epsilon t_{i}}|z^{\xi,\Delta}(t_{i})|^{2p}$$

$$+(1+\varepsilon_{1})\sum_{i=0}^{k}\sum_{l=0}^{p}\frac{C_{p}^{l}(2a_{2}\theta\Delta)^{l}l}{p}e^{\epsilon t_{i}}\int_{-\tau}^{0}|y^{\xi,\Delta}_{t_{i}}(r)|^{2p}d\nu_{2}(r)+K(\varepsilon_{1})\Delta e^{\epsilon t_{k}}$$

$$\leq (1+\varepsilon_{1})\sum_{i=0}^{k}\sum_{l=0}^{p}\frac{C_{p}^{l}(2a_{2}\theta\Delta)^{l}(p-l)}{p}e^{\epsilon t_{i}}|z^{\xi,\Delta}(t_{i})|^{2p}$$

$$+(1+\varepsilon_{1})e^{\epsilon\tau}\sum_{i=0}^{k}\sum_{l=0}^{p}\frac{C_{p}^{l}(2a_{2}\theta\Delta)^{l}l}{p}e^{\epsilon t_{i}}|y^{\xi,\Delta}(t_{i})|^{2p}+K||\xi||^{2p}\Delta+K(\varepsilon_{1})\Delta e^{\epsilon t_{k}}.$$

$$(4.33)$$

Owing to  $a_1 > a_2$ , choose sufficiently small numbers  $\varepsilon_1, \epsilon > 0$  such that  $a_1 > a_2(1+\varepsilon_1)e^{\epsilon\tau}$ . Combining (4.33), we arrive at

$$\sum_{i=0}^{k} \sum_{l=0}^{p} \frac{C_{p}^{l} (2a_{1}\theta\Delta)^{l} (p-l)}{p} e^{\epsilon t_{i}} |y^{\xi,\Delta}(t_{i})|^{2p}$$

$$\leq (1+\varepsilon_{1}) \sum_{i=0}^{k} \sum_{l=0}^{p} \frac{C_{p}^{l} (2a_{2}\theta\Delta)^{l} (p-l)}{p} e^{\epsilon t_{i}} |z^{\xi,\Delta}(t_{i})|^{2p}$$

$$+ K ||\xi||^{2p} + K(\varepsilon_{1}) \Delta e^{\epsilon t_{k}}.$$

Plugging above inequality into (4.32), we deduce

$$e^{\epsilon t_{k+1}} \mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] \leq \left(e^{\epsilon\Delta} - \frac{\sum_{l=0}^{p} C_{p}^{l} (2a_{1}\theta\Delta)^{l}(p-l)}{\sum_{l=0}^{p} C_{p}^{l} (2a_{2}(1+\varepsilon_{1})\theta\Delta)^{l}(p-l)}\right) \times$$

$$\sum_{i=0}^{k} e^{\epsilon t_{i}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}] + K(\varepsilon_{1},\epsilon)e^{\epsilon t_{k+1}} + K \|\xi\|^{2p} - \left(2p(1-\theta)(a_{1}-a_{2}e^{\epsilon\tau})\right)$$

$$- K\Delta - K\varepsilon_{1}\right) \Delta \sum_{i=0}^{k} e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_{i})|^{2p}].$$

Since

$$\begin{aligned} &\frac{\sum_{l=0}^{p}C_{p}^{l}(2a_{1}\theta\Delta)^{l}(p-l)}{\sum_{l=0}^{p}C_{p}^{l}(2a_{2}(1+\varepsilon_{1})\theta\Delta)^{l}(p-l)} \\ &\geq 1 + \frac{\sum_{l=0}^{p}C_{p}^{l}(2(a_{1}-a_{2}(1+\varepsilon_{1}))\theta\Delta)^{l}(p-l)}{\sum_{l=0}^{p}C_{p}^{l}(2a_{2}(1+\varepsilon_{1})\theta\Delta)^{l}(p-l)} \end{aligned}$$

$$\geq 1 + \frac{C_p^0 p}{\sum_{l=0}^p C_p^l (4a_2\theta)^l p} = 1 + \frac{1}{(4a_2\theta + 1)^p},$$

it is straightforward to see that

$$e^{\epsilon t_{k+1}} \mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] \leq \left(e^{\epsilon\Delta} - 1 - \frac{1}{(4a_2\theta + 1)^p}\right) \sum_{i=0}^k e^{\epsilon t_i} \mathbb{E}[|y^{\xi,\Delta}(t_i)|^{2p}] \\ + K(\varepsilon_1,\epsilon) e^{\epsilon t_{k+1}} + K ||\xi||^{2p} - \left(2p(1-\theta)(a_1 - a_2e^{\epsilon\tau}) - K\Delta - K\varepsilon_1\right) \Delta \times \sum_{i=0}^k e^{\epsilon t_{i+1}} \mathbb{E}[|y^{\xi,\Delta}(t_i)|^{2p}].$$

There exists a constant  $\tilde{\Delta}_p \in (0, 1]$  such that  $2p(1-\theta)(a_1-a_2) - K\tilde{\Delta}_p > 0$ . Let  $\varepsilon_1, \epsilon > 0$  be sufficiently small such that

$$e^{\epsilon\Delta} - 1 - \frac{1}{(4a_2\theta + 1)^p} < 0,$$
  
$$2p(1-\theta)(a_1 - a_2e^{\epsilon\tau}) - K\tilde{\Delta}_p - K\varepsilon_1 > 0.$$

Thus for any  $\Delta \in (0, \tilde{\Delta}_p]$ ,

$$e^{\epsilon t_{k+1}} \mathbb{E}[|z^{\xi,\Delta}(t_{k+1})|^{2p}] \le K(\varepsilon_1,\epsilon)e^{\epsilon t_{k+1}} + K||\xi||^{2p},$$

which yields  $\sup_{k\geq -N} \mathbb{E}[|z^{\xi,\Delta}(t_k)|^{2p}] \leq K(1+\|\xi\|^{2p})$ . This, along with  $z^{\xi,\Delta}(t_k) = y^{\xi,\Delta}(t_k) - \theta\Delta b(y_{t_k}^{\xi,\Delta})$ , implies that  $\sup_{k\geq -N} \mathbb{E}[|y^{\xi,\Delta}(t_k)|^{2p}] \leq K(1+\|\xi\|^{2p})$ . Furthermore, similar to Step 2 in the proof of Proposition 2.2, we conclude that  $\sup_{k\in\mathbb{N}} \mathbb{E}[\|y_{t_k}^{\xi,\Delta}\|^{2p}] \leq K(1+\|\xi\|^{2p})$ . The proof is completed.  $\Box$ 

**Lemma 4.4** Under Assumptions 1.2, 4.5 and 4.6, there exists a constant  $\hat{\lambda}_3 > 0$  such that for any  $p \in \mathbb{N}_+$  with  $p \ge 2$ ,

$$\begin{split} \mathbb{E}[\|\mathcal{D}x_{t}^{\xi}\cdot\eta\|^{2p}] &\leq Ke^{-\hat{\lambda}_{3}pt}\|\eta\|^{2p}, \ t > 0, \\ \mathbb{E}[\|D_{r_{1}}x_{t}^{\tilde{\xi}}\|^{2p}] &\leq Ke^{-\hat{\lambda}_{3}p(t-r_{1})}(1+\mathbb{E}[\|D_{r_{1}}\tilde{\xi}\|^{2p}]), \ t > r_{1}, \\ \mathbb{E}[\|D_{r_{1}}\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta\|^{2p}] &\leq Ke^{-\hat{\lambda}_{3}pt}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_{1}}\tilde{\xi}\|^{4p}]), \ t > 0, \\ \mathbb{E}[\|D_{r_{1},r_{2}}x_{t}^{\tilde{\xi}}\|^{2p}] &\leq Ke^{-\hat{\lambda}_{3}p(t-r_{1}\vee r_{2})}(1+\mathbb{E}[\|D_{r_{1},r_{2}}\tilde{\xi}\|^{2p}]+\mathbb{E}[\|D_{r_{1}}\tilde{\xi}\|^{4p}] \\ &\quad +\mathbb{E}[\|D_{r_{2}}\tilde{\xi}\|^{4p}]), \ t > r_{1}\vee r_{2}, \\ \mathbb{E}[\|D_{r_{1},r_{2}}\mathcal{D}x_{t}^{\tilde{\xi}}\cdot\eta\|^{2p}] &\leq Ke^{-\hat{\lambda}_{3}pt}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_{1},r_{2}}\tilde{\xi}\|^{4p}]+\mathbb{E}[\|D_{r_{1}}\tilde{\xi}\|^{8p}] \\ &\quad +\mathbb{E}[\|D_{r_{2}}\tilde{\xi}\|^{8p}]), \ t > 0, \end{split}$$

where  $\tilde{\xi} \in \mathbb{D}^{2,8p}(\mathcal{C}^d)$ .

**Proof.** The proofs are similar to those of Lemmas 3.3, 3.4, 3.7 and 3.8, and hence are omitted.

**Lemma 4.5** Let Assumption 1.2 with  $2a_1 - \frac{2\theta-1}{\theta^2} - 2a_2 > 0$ , Assumptions 4.5 and 4.6 hold. Then there exists a constant  $\hat{\lambda}_4 > 0$  such that for any  $p \in \mathbb{N}_+$  and  $\Delta \in (0, \tilde{\Delta}_p]$ ,

$$\begin{split} & \mathbb{E}[\|\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}\cdot\eta\|^{2p}] \leq Ke^{-\hat{\lambda}_4pt_k}\|\eta\|^{2p}, \ t_k > 0, \\ & \mathbb{E}[\|D_{r_1}y_{t_k}^{\tilde{\xi},\Delta}\|^{2p}] \leq Ke^{-\hat{\lambda}_4p(t_k-r_1)}(1+\mathbb{E}[\|D_{r_1}\tilde{\xi}\|^{2p}]), \ t_k > r_1, \\ & \mathbb{E}[\|D_{r_1}\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}\cdot\eta\|^{2p}] \leq Ke^{-\hat{\lambda}_4pt_k}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_1,\tilde{\xi}}\|^{4p}]), \ t_k > 0, \\ & \mathbb{E}[\|D_{r_1,r_2}y_{t_k}^{\tilde{\xi},\Delta}\|^{2p}] \leq Ke^{-\hat{\lambda}_4p(t-r_1\vee r_2)}(1+\mathbb{E}[\|D_{r_1,r_2}\tilde{\xi}\|^{2p}]+\mathbb{E}[\|D_{r_1}\tilde{\xi}\|^{4p}] \\ & +\mathbb{E}[\|D_{r_2}\tilde{\xi}\|^{4p}]), \ t_k > r_1 \vee r_2, \\ & \mathbb{E}[\|D_{r_1,r_2}\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}\cdot\eta\|^{2p}] \leq Ke^{-\hat{\lambda}_4pt_k}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_1,r_2}\tilde{\xi}\|^{4p}] + \mathbb{E}[\|D_{r_1}\tilde{\xi}\|^{8p}] \\ & +\mathbb{E}[\|D_{r_2}\tilde{\xi}\|^{8p}]), \ t_k > 0, \\ & \mathbb{E}[\|D_{r_1,r_2}\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta}\cdot\eta\|^{2p}] \leq Ke^{-\hat{\lambda}_4pt_k}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_1,r_2,r_3}\tilde{\xi}\|^{2p}] + \mathbb{E}[\|D_{r_1,r_2}\tilde{\xi}\|^{4p}] \\ & + \mathbb{E}[\|D_{r_1,r_2}\tilde{\xi}\|^{4p}] + \mathbb{E}[\|D_{r_2,r_3}\tilde{\xi}\|^{4p}] + \mathbb{E}[\|D_{r_1,r_2,r_3}\tilde{\xi}\|^{2p}] + \mathbb{E}[\|D_{r_1,r_2}\tilde{\xi}\|^{8p}] \\ & + \mathbb{E}[\|D_{r_3}\tilde{\xi}\|^{8p}]), \ t_k > r_1 \vee r_2 \vee r_3, \\ & \mathbb{E}[\|D_{r_1,r_2,r_3}\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta} \cdot \eta\|^{2p}] \leq Ke^{-\hat{\lambda}_4pt_k}\|\eta\|^{2p}(1+\mathbb{E}[\|D_{r_1,r_2,r_3}\tilde{\xi}\|^{4p}] \\ & + \sum_{\substack{i_1,i_2\in\{1,2,3\}\\i_1 0, \\ & \mathbb{E}[\|D_{r_1,r_2,r_3,r_4}y_{t_k}^{\tilde{\xi},\Delta}\|^{2p}] \leq Ke^{-\hat{\lambda}_4p(t_k-r_1\vee r_2\vee r_3\vee r_4)}(1+\mathbb{E}[\|D_{r_1,r_2,r_3,r_4}\tilde{\xi}\|^{2p}] \\ & + \sum_{\substack{i_1,i_2,i_3\in\{1,\dots,4\}\\i_1 r_1 \vee \cdots \vee r_4, \end{aligned}$$

where  $\tilde{\xi} \in \mathbb{D}^{4,p''}(\mathcal{C}^d)$  with some p'' > 0.

**Proof.** We only show the estimate of  $\mathcal{D}y_{t_k}^{\tilde{\xi},\Delta} \cdot \eta$ , since estimates of other terms are similar. Similar to the proof of Lemma 3.5, by Assumptions 1.2 and 4.5, we derive

$$\begin{split} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1})\cdot\eta|^2 &= |\mathcal{D}z^{\tilde{\xi},\Delta}(t_k)\cdot\eta|^2 + |\mathcal{D}b(y^{\tilde{\xi},\Delta}_{t_k})\mathcal{D}y^{\tilde{\xi},\Delta}_{t_k}\cdot\eta|^2\Delta^2 \\ &+ 2\langle \mathcal{D}y^{\tilde{\xi},\Delta}(t_k)\cdot\eta - \theta\Delta\mathcal{D}b(y^{\tilde{\xi},\Delta}_{t_k})\mathcal{D}y^{\tilde{\xi},\Delta}_{t_k}\cdot\eta, \mathcal{D}b(y^{\tilde{\xi},\Delta}_{t_k})\mathcal{D}y^{\tilde{\xi},\Delta}_{t_k}\cdot\eta\rangle\Delta \\ &\leq A_{\theta,\Delta}|\mathcal{D}z^{\tilde{\xi},\Delta}(t_k)\cdot\eta|^2 - (2a_1 - \frac{2\theta - 1}{\theta^2})\Delta|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k)\cdot\eta|^2 \\ &+ 2a_2\Delta\int_{-\tau}^0|\mathcal{D}y^{\tilde{\xi},\Delta}(t_k+r)\cdot\eta|^2\mathrm{d}\nu_2(r), \end{split}$$

where  $A_{\theta,\Delta} = \frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\Delta)}$ . For  $\hat{\lambda}_4 > 0$ , we arrive at

$$e^{\hat{\lambda}_{4}t_{k+1}} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k+1})|^{2} \leq ||\eta||^{2} + (A_{\theta,\Delta}e^{\hat{\lambda}_{4}\Delta} - 1) \sum_{i=0}^{k} e^{\hat{\lambda}_{4}t_{i}} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2} \\ - (2a_{1} - \frac{2\theta - 1}{\theta^{2}})\Delta \sum_{i=0}^{k} e^{\hat{\lambda}_{4}t_{i+1}} |\mathcal{D}y^{\tilde{\xi},\Delta}(t_{i})\cdot\eta|^{2}$$

$$+ 2a_{2}\Delta \sum_{i=0}^{k} e^{\hat{\lambda}_{4}t_{i+1}} \int_{-\tau}^{0} |\mathcal{D}y^{\tilde{\xi},\Delta}(t_{i}+r)\cdot\eta|^{2} d\nu_{2}(r)$$

$$\leq K \|\eta\|^{2} + (A_{\theta,\Delta}e^{\hat{\lambda}_{4}\Delta} - 1) \sum_{i=0}^{k} e^{\hat{\lambda}_{4}t_{i}} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{k})\cdot\eta|^{2}$$

$$- (2a_{1} - \frac{2\theta - 1}{\theta^{2}} - 2a_{2}e^{\hat{\lambda}_{4}\tau}) \Delta \sum_{i=0}^{k} e^{\hat{\lambda}_{4}t_{i+1}} |\mathcal{D}y^{\tilde{\xi},\Delta}(t_{i})\cdot\eta|^{2}$$

Note that  $A_{\theta,\Delta} = 1 - \frac{(2\theta-1)\Delta}{\theta^2(1+\Delta)} \leq e^{-\frac{(2\theta-1)\Delta}{2\theta^2}}$ . Choose a sufficiently small number  $\hat{\lambda}_4 > 0$  such that  $A_{\theta,\Delta}e^{\hat{\lambda}_4\Delta} < 1$  and  $2a_1 - \frac{2\theta-1}{\theta^2} - 2a_2e^{\hat{\lambda}_4\tau} > 0$ . Then

$$e^{\hat{\lambda}_4 t_{k+1}} |\mathcal{D}z^{\tilde{\xi}, \Delta}(t_{k+1}) \cdot \eta|^2 \le K ||\eta||^2, \quad \text{a.s.}$$

$$(4.34)$$

According to  $\mathcal{D}z^{\tilde{\xi},\Delta}(t_k) \cdot \eta = \mathcal{D}y^{\tilde{\xi},\Delta}(t_k) \cdot \eta - \theta \Delta \mathcal{D}b(y_{t_k}^{\tilde{\xi},\Delta}) \mathcal{D}y_{t_k}^{\tilde{\xi},\Delta} \cdot \eta$  and Assumption 1.2, we obtain

$$(1+2a_{1}\theta\Delta) \sup_{0\leq i\leq k} e^{\lambda_{4}t_{i}} |\mathcal{D}y^{\xi,\Delta}(t_{i})\cdot\eta|^{2}$$

$$\leq \sup_{0\leq i\leq k} e^{\hat{\lambda}_{4}t_{i}} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{i})\cdot\eta|^{2} + 2a_{2}\theta\Delta \sup_{0\leq i\leq k} e^{\hat{\lambda}_{4}t_{i}} \int_{-\tau}^{0} |\mathcal{D}y^{\tilde{\xi},\Delta}_{t_{i}}(r)|^{2} d\nu_{2}(r)$$

$$\leq K \|\eta\|^{2} + \sup_{0\leq i\leq k} e^{\hat{\lambda}_{4}t_{i}} |\mathcal{D}z^{\tilde{\xi},\Delta}(t_{i})\cdot\eta|^{2} + 2a_{2}\theta e^{\hat{\lambda}_{4}\tau}\Delta \sup_{0\leq i\leq k} e^{\hat{\lambda}_{4}t_{i}} |\mathcal{D}y^{\tilde{\xi},\Delta}(t_{i})\cdot\eta|^{2}.$$

This, along with  $a_2 e^{\hat{\lambda}_4 \tau} < a_1$  and (4.34), implies that

$$\sup_{0 \le i \le k} e^{\hat{\lambda}_4 t_i} |\mathcal{D}y^{\tilde{\xi}, \Delta}(t_i) \cdot \eta|^2 \le K ||\eta||^2, \quad \text{a.s.}$$

The desired argument follows by taking expectations.

**Lemma 4.6** Let Assumption 3.4 with  $L_b = \sup_{i \in \{1,...,n_b\}} \sup_{\phi \in \mathcal{C}^d} ||k_b^i(\phi)|| < \infty$  and Assumption 4.5 hold. Then for any  $u \in \mathbb{R}^d$  with |u| = 1 and  $\Delta \in (0, \frac{1}{2L_b n_b \theta}]$ ,

$$|u^{\top}\gamma_{\Phi(T;t_j,Y_j^{\varsigma})}u| \ge \frac{1}{4}\tilde{\sigma}(T \wedge T_0), \qquad (4.35)$$

where  $T_0 = \frac{\ln(\frac{3}{2})}{2L_b n_b(\theta+2)}$  is given in Theorem 4.4, and  $Y_j^{\varsigma}$  is given in (3.7). In particular, we have  $(\gamma_{\Phi(T;t_i,Y_i^{\varsigma})})^{-1} \in L^{\infty-}(\Omega)$ .

**Proof.** We first prove (4.35) for the case of d = 1. For  $r \in (t_k, t_{k+1}]$  with  $j \le k \le i - 1$ , we have

$$D_r \Phi(t_i; t_j, Y_j^{\varsigma}) = \sum_{n=k}^{i-1} \left[ (1-\theta) \mathcal{D}b(\Phi_{t_n}(t_j, Y_j^{\varsigma})) D_r \Phi_{t_n}(t_j, Y_j^{\varsigma}) \Delta + \theta \mathcal{D}b(\Phi_{t_{n+1}}(t_j, Y_j^{\varsigma})) D_r \Phi_{t_{n+1}}(t_j, Y_j^{\varsigma}) \Delta \right] + \tilde{\sigma}.$$

This, together with  $D_r \Phi_{t_n}(t_j, Y_j^{\varsigma}) = \sum_{l=-N}^0 I^l D_r \Phi(t_{n+l}; t_j, Y_j^{\varsigma})$  and Assumption 3.4, implies that

$$D_{r}\Phi(t_{i};t_{j},Y_{j}^{\varsigma}) = \sum_{n=k}^{i-1} \left[ (1-\theta) \sum_{\ell=1}^{n_{b}} \sum_{l=-N}^{0} \int_{-\tau}^{0} k_{b}^{\ell}(\Phi_{t_{n}}(t_{j},Y_{j}^{\varsigma})(s)) I^{l}(s) \mathrm{d}\nu_{3}^{\ell}(s) D_{r}\Phi(t_{n+l};t_{j},Y_{j}^{\varsigma}) \Delta \right] + \theta \sum_{\ell=1}^{n_{b}} \sum_{l=-N}^{0} \int_{-\tau}^{0} k_{b}^{\ell}(\Phi_{t_{n+1}}(t_{j},Y_{j}^{\varsigma})(s)) I^{l}(s) \mathrm{d}\nu_{3}^{\ell}(s) D_{r}\Phi(t_{n+l+1};t_{j},Y_{j}^{\varsigma}) \Delta \right] + \tilde{\sigma}.$$
(4.36)

<u>Step 1.</u> To derive a lower bound of  $D_r \Phi(t_i; t_j, Y_j^{\varsigma})$ , we need to present a discrete comparison principle. Define a two-parameter nonnegative sequence  $\{A_i^k\}_{0 \le k, i \le N^{\Delta}}$  as follows: when  $i \le k$ , define  $A_i^k = 0$ ; when  $0 \le k \le i - 1$ , define

$$A_{i}^{k} = L_{b}\Delta \sum_{n=k}^{i-1} \sum_{l=-N}^{n_{b}} \sum_{l=-N}^{0} \nu_{3}^{\ell} (\Delta_{l-1} + \Delta_{l}) ((1-\theta)A_{n+l}^{k} + \theta A_{n+l+1}^{k}) + \tilde{\sigma},$$

where we let  $\nu_3^{\ell}(\Delta_{-N-1}) = \nu_3^{\ell}(\Delta_0) = 0$  and  $L_b = \sup_{\ell \in \{1,...,n_b\}} \sup_{\phi \in \mathcal{C}^d} |k_b^{\ell}(\phi)|$ . It follows from the definition that when  $i_1 - k_1 = i_2 - k_2 > 0$ ,  $A_{i_1}^{k_1} = A_{i_2}^{k_2} =: \mathcal{A}_{i_1-k_1}$ . Then

$$\mathcal{A}_{i-k} = A_i^k = L_b \Delta \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \nu_3^\ell (\Delta_{l-1} + \Delta_l) ((1-\theta) A_{i-1+l}^k + \theta A_{i+l}^k) + L_b \Delta \sum_{n=k}^{i-2} \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \nu_3^\ell (\Delta_{l-1} + \Delta_l) ((1\theta) A_{n+l}^k + \theta A_{n+1+l}^k) + \tilde{\sigma} = L_b \Delta \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \nu_3^\ell (\Delta_{l-1} + \Delta_l) ((1-\theta) A_{i-1+l}^k + \theta A_{i+l}^k) + \mathcal{A}_{i-k-1}.$$

This gives that for any  $\Delta \in (0, \frac{1}{L_b \theta n_b})$ ,

$$\mathcal{A}_{i-k} = \left(1 - L_b \Delta \theta \sum_{\ell=1}^{n_b} \nu_3^{\ell}(\Delta_{-1})\right)^{-1} \Big\{ \mathcal{A}_{i-k-1} + L_b \Delta \Big[ (1-\theta) \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \nu_3^{\ell}(\Delta_{l-1} + \Delta_l) \times \mathcal{A}_{i-1-k+l} + \theta \sum_{\ell=1}^{n_b} \sum_{l=-N+1}^{0} \nu_3^{\ell}(\Delta_{l-2} + \Delta_{l-1}) \mathcal{A}_{i-k+l-1} \Big] \Big\}.$$

By the relation  $(1 - L_b \Delta \theta n_b)^{-1} = 1 + \frac{L_b \theta \Delta n_b}{1 - L_b \Delta \theta n_b}$  and by iteration, we obtain

$$\begin{aligned} \mathcal{A}_{i-k} &\leq (1 + \frac{L_b \theta \Delta n_b}{1 - L_b \Delta \theta n_b}) \mathcal{A}_{i-k-1} + (1 - L_b \Delta \theta n_b)^{-1} L_b \Delta \Big[ (1 - \theta) \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \\ \nu_3^{\ell} (\Delta_{l-1} + \Delta_l) \times \mathcal{A}_{i-1-k+l} + \theta \sum_{\ell=1}^{n_b} \sum_{l=-N+1}^{0} \nu_3^{\ell} (\Delta_{l-2} + \Delta_{l-1}) \mathcal{A}_{i-k+l-1} \Big] \\ &\leq \mathcal{A}_1 + \sum_{n=1}^{i-k-1} \frac{L_b \theta \Delta n_b}{1 - L_b \Delta \theta n_b} \mathcal{A}_n + (1 - L_b \Delta \theta n_b)^{-1} L_b \Delta \sum_{\ell=1}^{n_b} \sum_{n=1}^{i-k-1} \Big[ (1 - \theta) \times \\ &\sum_{l=-N}^{0} \nu_3^{\ell} (\Delta_{l-1} + \Delta_l) \mathcal{A}_{n+l} + \theta \sum_{l=-N+1}^{0} \nu_3^{\ell} (\Delta_{l-2} + \Delta_{l-1}) \mathcal{A}_{n+l} \Big]. \end{aligned}$$

Noting that

$$\sum_{n=1}^{i-k-1} \sum_{l=-N}^{0} \nu_{3}^{\ell} (\Delta_{l-1} + \Delta_{l}) \mathcal{A}_{n+l} = \sum_{l=-N}^{0} \sum_{n=1}^{i-k-1} \nu_{3}^{\ell} (\Delta_{l-1} + \Delta_{l}) \mathcal{A}_{n+l}$$
$$\leq \sum_{l=-N}^{0} \sum_{m=-N}^{i-k-1} \nu_{3}^{\ell} (\Delta_{l-1} + \Delta_{l}) \mathcal{A}_{m} \leq 2 \sum_{n=1}^{i-k-1} \mathcal{A}_{n}$$

and  $\mathcal{A}_1 = (1 - L_b \sum_{\ell=1}^{n_b} \nu_3^\ell (\Delta_{-1}) \Delta \theta)^{-1} \tilde{\sigma} \leq (1 - L_b \Delta \theta n_b)^{-1} \tilde{\sigma}$ , we arrive at

$$\mathcal{A}_{i-k} \le (1 - L_b \Delta \theta n_b)^{-1} \tilde{\sigma} + \frac{L_b n_b (\theta + 2)}{1 - L_b \Delta \theta n_b} \sum_{n=1}^{i-k-1} \mathcal{A}_n \Delta$$

Combining the discrete Grönwall inequality, we deduce

$$\mathcal{A}_{i-k} \leq (1 - L_b \Delta \theta n_b)^{-1} \tilde{\sigma} \exp\left\{\frac{L_b n_b (\theta + 2) \Delta (i - k - 1)}{1 - L_b \Delta \theta n_b}\right\}$$
$$=: K_0 \exp\left\{\frac{L_b n_b (\theta + 2) \Delta (i - k - 1)}{1 - L_b \Delta \theta n_b}\right\}.$$
(4.37)

We claim that

$$|D_r \Phi(t_i; t_j, Y_j^{\varsigma})| \le A_i^k, \text{ for any } r \in (t_k, t_{k+1}], \ j \le k \le i-1.$$
(4.38)

We prove the claim by the induction argument on i - k. In fact, when  $j \leq i_1 \leq k_1$  and  $r \in (t_{k_1}, t_{k_1+1}]$ , we have  $D_r \Phi(t_{i_1}; t_j, Y_j^\varsigma) = 0 = A_{i_1}^{k_1}$ . This gives  $|D_r \Phi(t_{i_1}; t_j, Y_j^\varsigma)| \leq A_{i_1}^{k_1}$  for  $i_1 - k_1 \leq 0$ . Suppose that (4.38) holds for integers k, i satisfying  $0 \leq i - k \leq i - k' - 1$ . Then we show (4.38) holds for i - k = i - k'. By (4.36) and the induction assumption  $|D_r \Phi(t_i; t_j, Y_j^\varsigma)| \leq A_n^{k'}$ ,  $n \leq i - 1$ , we have

$$\begin{aligned} &|D_{r}\Phi(t_{i};t_{j},Y_{j}^{\varsigma})| \\ &\leq \sum_{n=k'}^{i-2}\sum_{\ell=1}^{n_{b}}\sum_{l=-N}^{0}L_{b}\nu_{3}^{\ell}(\Delta_{l-1}+\Delta_{l})((1-\theta)A_{n+l}^{k'}\Delta+\theta A_{n+l+1}^{k'}\Delta)+\tilde{\sigma} \\ &+(1-\theta)\sum_{\ell=1}^{n_{b}}\sum_{l=-N}^{0}L_{b}\nu_{3}^{\ell}(\Delta_{l-1}+\Delta_{l})A_{i-1+l}^{k'}\Delta+\theta\sum_{\ell=1}^{n_{b}}\sum_{l=-N}^{-1}L_{b}\nu_{3}^{\ell}(\Delta_{l-1}+\Delta_{l})A_{i+l}^{k'}\Delta \\ &+L_{b}\theta\Delta\sum_{\ell=1}^{n_{b}}\nu_{3}^{\ell}(\Delta_{-1})|D_{r}\Phi(t_{i};t_{j},Y_{j}^{\varsigma})|, \end{aligned}$$

which yields

$$|D_r \Phi(t_i; t_j, Y_j^{\varsigma})| \le (1 - L_b \Delta \theta \sum_{\ell=1}^{n_b} \nu_3^{\ell} (\Delta_{-1}))^{-1} \Big[ A_{i-1}^{k'} + L_b \Delta (1 - \theta) \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \nu_3^{\ell} (\Delta_{l-1} + \Delta_l) A_{i+l}^{k'} \Big] = A_i^{k'}, \quad r \in (t_{k'}, t_{k'+1}].$$

This finishes the proof of the claim (4.38).

<u>Step 2.</u> From (4.36) and (4.37), we obtain  $|D_r\Phi(t_i; t_j, Y_j^{\varsigma})|$ 

$$\begin{split} &\geq \tilde{\sigma} - L_b \Delta \Big[ \sum_{n=k}^{i-1} \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \Big( (1-\theta) \nu_3^\ell (\Delta_{l-1} + \Delta_l) A_{n+l}^k + \theta \nu_3^\ell (\Delta_{l-1} + \Delta_l) A_{n+l+1}^k \Big) \Big] \\ &\geq \tilde{\sigma} - L_b \Delta \Big[ \sum_{n=k}^{i-1} \sum_{\ell=1}^{n_b} \sum_{l=-N}^{0} \Big( (1-\theta) \nu_3^\ell (\Delta_{l-1} + \Delta_l) K_0 e^{-\frac{L_b n_b (\theta+2) \Delta}{1-L_b \Delta \theta n_b}} + \theta \nu_3^\ell (\Delta_{l-1} + \Delta_l) K_0 \Big) \\ &\qquad \times \exp\{\frac{L_b n_b (\theta+2) \Delta (n+l-k)}{1-L_b \Delta \theta n_b}\} \Big] \\ &\geq \tilde{\sigma} - 2L_b n_b \Delta \Big( (1-\theta) K_0 e^{-\frac{L_b n_b (\theta+2) \Delta}{1-L_b \Delta \theta n_b}} + \theta K_0 \Big) \frac{\exp\{\frac{L_b n_b (\theta+2) \Delta (i-k)}{1-L_b \Delta \theta n_b}\} - 1}{\exp\{\frac{L_b n_b (\theta+2) \Delta (i-k)}{1-L_b \Delta \theta n_b}\} - 1} \\ &\geq \tilde{\sigma} - \frac{2}{\theta+2} \Big( \exp\{\frac{L_b n_b (\theta+2) \Delta (i-k)}{1-L_b \Delta \theta n_b}\} - 1 \Big) \tilde{\sigma} \\ &\geq \tilde{\sigma} - \Big( \exp\{\frac{L_b n_b (\theta+2) \Delta (i-k)}{1-L_b \Delta \theta n_b}\} - 1 \Big) \tilde{\sigma}, \end{split}$$

where we used  $e^x \ge x + 1, x \ge 0$ . Then,

$$|D_r\Phi(t_i;t_j,Y_j^{\varsigma})| \ge \frac{1}{2}\tilde{\sigma},$$

when  $\Delta \leq \frac{1}{2L_b \theta n_b}$  and  $i - k \leq \frac{\ln(\frac{3}{2})}{2L_b n_b (\theta + 2)\Delta}$ . Thus,

$$\begin{split} \gamma_{\Phi(T;t_j,Y_j^\varsigma)} &:= \int_0^T D_r \Phi(T;t_j,Y_j^\varsigma) (D_r \Phi(T;t_j,Y_j^\varsigma))^\top \mathrm{d}r \\ &\geq \int_{(T-T_0)\vee 0}^T |D_r \Phi(T;t_j,Y_j^\varsigma)|^2 \mathrm{d}r \geq \frac{1}{4} \tilde{\sigma}^2 (T \wedge T_0) \end{split}$$

where  $T_0 := \frac{\ln(\frac{3}{2})}{2L_b n_b(\theta+2)}$ . This finishes the proof of (4.35) for d = 1.

For the case of  $d \ge 2$ , by replacing  $D_r \Phi$  with  $u^{\top} D_r \Phi$  in the above argument, one can obtain (4.35).

Moreover, it follows from (4.35) that

$$\lambda_{\min}(\gamma_{\Phi(T;t_j,Y_j^\varsigma)}) = \min_{u \in \mathbb{R}^d, |u|=1} u^\top \gamma_{\Phi(T;t_j,Y_j^\varsigma)} u \ge \frac{1}{4} \tilde{\sigma}(T \wedge T_0),$$

which implies

$$|(\gamma_{\Phi(T;t_j,Y_j^{\varsigma})})^{-1}| \le K |\det(\gamma_{\Phi(T;t_j,Y_j^{\varsigma})})^{-1}| \le K [\frac{1}{4}\tilde{\sigma}(T \wedge T_0)]^{-d}.$$

Thus the proof is completed.  $\Box$ 

As a consequence, one can obtain the following Malliavin integration by parts formula.

**Lemma 4.7** Let  $\alpha \in \{1, \ldots, d\}^4$  be the multi-index,  $f \in \mathscr{C}$ , and  $G_1 \in \mathbb{D}^{\alpha+1,\infty}$ . Then under conditions in Lemmas 4.5 and 4.6, for  $\Delta \in (0, \frac{1}{2L_b n_b \theta}]$ ,  $i \in \mathbb{N}$  with  $i\Delta \leq \lfloor T - \Delta \rfloor$ , there exists a random variable  $H_{|\alpha|+1}(\Phi(T; t_i, Y_i^\varsigma), G_1)$  such that

$$\mathbb{E}[\partial_{\alpha}f(\Phi(T;t_i,Y_i^{\varsigma}))G_1] = \mathbb{E}[F(\Phi(T;t_i,Y_i^{\varsigma}))H_{|\alpha|+1}(\Phi(T;t_i,Y_i^{\varsigma}),G_1)].$$
(4.39)

Moreover,

$$\sup_{T \ge T_0} |\mathbb{E}[\partial_{\alpha} f(\Phi(T; t_i, Y_i^{\varsigma}))G_1]| \le K ||G_1||_{|\alpha|+1,2},$$
(4.40)

where  $T_0$  is given in Theorem 4.4, and  $Y_i^{\varsigma}$  is given in (3.7).

**Proof.** According to the definition of  $\mathscr{C}$ , and applying [52, Proposition 2.1.4, (2.29)–(2.32)] give (4.39). Moreover, for  $q > q_1 \ge 1$ , there exist constants  $\eta_1, \eta_2 > 0$  and integers  $n_1, n_2 > 0$  such that

$$\begin{aligned} &\|H_{|\alpha|+1}(\Phi(T;t_{i},Y_{i}^{\varsigma}),G_{1})\|_{q_{1}} \\ &\leq K(q_{1},q)\|\gamma_{\Phi(T;t_{i},Y_{i}^{\varsigma})}^{-1}\|_{0,\eta_{1}}^{n_{1}}\|D\Phi(T;t_{i},Y_{i}^{\varsigma})\|_{|\alpha|+1,\eta_{2}}^{n_{2}}\|G_{1}\|_{|\alpha|+1,q} \\ &\leq K\left[\frac{1}{4}\tilde{\sigma}(T\wedge T_{0})\right]^{-dn_{1}}\|G_{1}\|_{|\alpha|+1,q},\end{aligned}$$

where in the last inequality we used Lemmas 4.5 and 4.6. Taking  $q_1 = 1, q = 2$  and supremum for  $T \ge T_0$ , we finishes the proof.

Now we give the test-functional-independent weak convergence rate of the  $\theta$ -EM method.

**Theorem 4.5** Let conditions in Theorem 4.4 hold. Then for  $\Delta \in (0, \tilde{\Delta}]$ ,

$$\sup_{f \in \mathscr{C}} \sup_{T \ge T_0} \left| \mathbb{E}[f(x^{\xi}(T))] - \mathbb{E}[f(y^{\xi,\Delta}(T))] \right| \le K\Delta,$$

where  $T_0$  is given in Theorem 4.4.

**Proof.** In order to obtain the test-functional-independent weak convergence rate, we need to reestimate the sub-terms in Theorem 3.3 one-by-one by means of the Malliavin integration by parts formula (4.39) and the inequality (4.40).

Recalling (3.10), for the term

$$\mathcal{I}_0 = \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \xi)))] - \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \Phi_0)))],$$

it follows from (4.40) that

$$\begin{split} & \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \xi)))] - \mathbb{E}[f(\Phi(T; t_{N^{\Delta}}, \varphi_{t_{N^{\Delta}}}^{Int}(0, \Phi_{0})))] \\ &= \mathbb{E}[f(\varphi^{Int}(t_{N^{\Delta}}; 0, \xi)] - \mathbb{E}[f(\varphi^{Int}(t_{N^{\Delta}}; 0, \Phi_{0}))] \\ &= \int_{0}^{1} \mathbb{E}\Big[f'(\varphi^{Int}(t_{N^{\Delta}}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0}))\mathcal{D}\varphi^{Int}(t_{N^{\Delta}}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})(\xi-\Phi_{0})\Big]\mathrm{d}\varsigma \\ &\leq K \int_{0}^{1} \|\mathcal{D}\varphi^{Int}(t_{N^{\Delta}}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})(\xi-\Phi_{0})\|_{2,2}\mathrm{d}\varsigma \\ &\leq K\Delta \int_{0}^{1} \|\mathcal{D}\varphi^{Int}(t_{N^{\Delta}}; 0, \varsigma\xi + (1-\varsigma)\Phi_{0})\|_{2,2}\mathrm{d}\varsigma \\ &\leq K\Delta, \end{split}$$

where K is independent of T, and we used Assumption 2.3 with  $\rho \ge 1$ .

**Reestimate of term**  $\mathcal{I}_b$ . Recall

and  $Z_{i,r}^{\beta_1} = \beta_1 \varphi_r(t_{i-1}, \varphi_{t_{i-1}}(0, \Phi_0)) + (1 - \beta_1) \varphi_{t_{i-1}}^{Int}(0, \Phi_0).$ 

Reestimate of term  $\mathcal{I}_{b,1}$ . We only reestimate the sub-term

$$\sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T; t_{i}, Y_{i}^{\varsigma}) I^{0} \mathrm{Id}_{d \times d})^{*} f'(\Phi(T; t_{i}, Y_{i}^{\varsigma})), \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathcal{D}b(Z_{i,r}^{\beta_{1}}) \Big]$$

$$\begin{split} \mathcal{I}_{b,1}^{1} &= \sum_{i=1}^{N^{\Delta}} \int_{0}^{1} \mathbb{E} \Big[ \Big\langle (\mathcal{D}\Phi(T;t_{i},Y_{i}^{\varsigma})I^{0}\mathrm{Id}_{d\times d})^{*} f'(\Phi(T;t_{i},Y_{i}^{\varsigma})), \int_{t_{i-1}}^{t_{i}} \int_{0}^{1} \mathcal{D}b(Z_{i,r}^{\beta_{1}}) \\ &\sum_{j=-N}^{-1} \mathbf{1}_{\{i+j\geq 1\}} \mathbf{1}_{[t_{i+j}-r,t_{i+j+1}-r)}(\cdot) \frac{t_{j+1}-\cdot}{\Delta} \int_{t_{i+j-1}}^{t_{i+j}} \tilde{\sigma} \mathrm{d}W(u) \mathrm{d}\beta_{1} \mathrm{d}r \Big\rangle \Big] \mathrm{d}\varsigma, \end{split}$$

Hence, we have  $\mathcal{I}_{b,2} \leq K\Delta$ .

**Reestimate of**  $\mathcal{I}_{b,\theta}$ . Similar to the proof of  $\mathcal{I}_b$ , we can derive that  $\mathcal{I}_{b,\theta} \leq K\Delta$ .

**Reestimate of**  $\mathcal{I}_{\sigma}$ . When the noise of (1.1) is additive, the term  $\mathcal{I}_{\sigma} \equiv 0$ .

Combining the above terms, we complete the proof.  $\hfill \Box$ 

**Proof.** [Proof of Theorem 4.4] Based on the combination of Theorem 4.5 and (4.25), we complete the proof.  $\Box$ 

## 4.3 Summary and outlook

This chapter presents the numerical approximation of the density function of the SFDE. We first prove the existence of the density function for the  $\theta$ -EM solution. For the SFDE with the multiplicative noise, we show the convergence of the numerical density function by the localization argument. Then by establishing the test-functional-independent weak convergence, we show that for the additive noise case, the numerical density function converges to the exact one with the convergence rate 1. There are some problems that remain to be solved, for example,

- (i) can we obtain the convergence rate with order 1 of the numerical density function for the multiplicative noise case?
- (ii) For the SFDE driven by the rough path, does the density function of the exact solution exist, and further is it smooth?
- (iii) If (ii) holds, can we obtain the approximation result for the underlying density function?

These problems are challenging. We would like to mention that authors in [10] prove the existence of the density function for the rough stochastic differential equation under the Hörmander condition. But there is no work for the case of the SFDE. We leave them as open problems and attempt to solve them in the future.

## CHAPTER 5

# Large deviation principle of numerical solution

In this chapter, we focus on the  $\theta$ -EM method of the SFDE (1.1) with small noise and investigate the LDP of the underlying numerical solution. By the weak convergence approach, we deduce the Freidlin–Wentzell LDP of the  $\theta$ -EM solution on the infinite time horizon under the suplerlinearly growing drift coefficient condition. Based on the estimates of negative moments of the determinant of the corresponding Malliavin covariance matrix, we prove the existence and smoothness of the numerical density function for the  $\theta$ -EM method of (1.1) with small noise. Combining the technique of the Malliavin calculus, we present the logarithmic estimates of the numerical density function and reveal the relation between the logarithmic limit and the rate function of the LDP.

# 5.1 The Freidlin–Wentzell large deviation of numerical solution

In this section, we consider the SFDE (1.1) with small noise on the infinite time horizon, which is written as follows

$$\begin{cases} \mathrm{d}x^{\xi,\epsilon}(t) = b(x_t^{\xi,\epsilon})\mathrm{d}t + \sqrt{\epsilon}\sigma(x_t^{\xi,\epsilon})\mathrm{d}W(t), \quad t > 0, \\ x_0^{\xi,\epsilon} = \xi \in \mathcal{C}^d, \end{cases}$$
(5.1)

where  $\epsilon \in (0, 1)$ . The aim is to study the Freidlin–Wentzell large deviation of the  $\theta$ -EM method of (5.1) by means of the weak convergence approach. The  $\theta$ -EM method of (5.1) reads as

$$\begin{cases} y^{\Delta,\epsilon}(t_{k+1}) = y^{\Delta,\epsilon}(t_k) + (1-\theta)b(y_{t_k}^{\Delta,\epsilon})\Delta + \theta b(y_{t_{k+1}}^{\Delta,\epsilon})\Delta + \sqrt{\epsilon}\sigma(y_{t_k}^{\Delta,\epsilon})\delta W_k, \ k \in \mathbb{N}, \\ y^{\Delta,\epsilon}(t_k) = \xi(t_k), \quad k = -N, \dots, 0. \end{cases}$$
(5.2)

We denote

$$L^2_{\Delta}([0,+\infty);\mathbb{R}^m) := \Big\{ v : [0,+\infty) \to \mathbb{R}^m \text{ is measurable } \Big| \int_0^{+\infty} |v(\lfloor s \rfloor)|^2 \mathrm{d}s < \infty \Big\}.$$

$$\mathcal{P}_M := \{ v : \Omega \times [0, +\infty) \to \mathbb{R}^m | v \text{ is } \mathcal{F}_t \text{-measurable and } v \in \mathcal{S}_M \text{ a.s.} \}.$$

It follows from [42, Chapter III, Section 28, Theorem 1'] that  $\mathcal{S}_M$  is a Polish space endowed with the weak topology. Introduce the space  $\mathcal{C}_{\xi} := \mathcal{C}_{\xi}([-\tau, +\infty); \mathbb{R}^d)$  consisting of

continuous functions  $u: [-\tau, \infty) \to \mathbb{R}^d$  with  $u(r) = \xi(r), r \in [-\tau, 0]$ , which is a polish space endowed with the norm

$$\|u\|_{\mathcal{C}_{\xi}} := \sum_{k=1}^{\infty} e^{-\mathfrak{a}t_k} \left( \sup_{t \in [-\tau, t_k]} |u(t)| \right) \Delta$$

for some constant a > 0.

Denote  $\{y^{\Delta,\epsilon}(\cdot)\}$  by the linear interpolation with respect to  $y^{\Delta,\epsilon}(-t_N), \ldots, y^{\Delta,\epsilon}(t_k), \ldots$ We will prove in Lemma 5.2 that  $\{y^{\Delta,\epsilon}(\cdot)\}$  belongs to  $\mathcal{C}_{\xi}$ .

In order to present the LDP for the solution of (5.2), we consider the following stochastic controlled equation

$$\begin{cases} y^{\Delta,v^{\epsilon}}(t_{k+1}) = y^{\Delta,v^{\epsilon}}(t_{k}) + (1-\theta)b(y^{\Delta,v^{\epsilon}}_{t_{k}})\Delta + \theta b(y^{\Delta,v^{\epsilon}}_{t_{k+1}})\Delta \\ + \sigma(y^{\Delta,v^{\epsilon}}_{t_{k}})(\sqrt{\epsilon}\delta W_{k} + v^{\epsilon}(t_{k})\Delta), \ k \in \mathbb{N}, \\ y^{\Delta,v^{\epsilon}}(t_{k}) = \xi(t_{k}), \quad k = -N, \dots, 0, \end{cases}$$
(5.3)

and the skeleton equation

$$\begin{cases} w^{\Delta,v}(t_{k+1}) = w^{\Delta,v}(t_k) + (1-\theta)b(w^{\Delta,v}_{t_k})\Delta + \theta b(w^{\Delta,v}_{t_{k+1}})\Delta + \sigma(w^{\Delta,v}_{t_k})v(t_k)\Delta, \ k \in \mathbb{N}, \\ w^{\Delta,v}(t_k) = \xi(t_k), \quad k = -N, \dots, 0, \end{cases}$$
(5.4)

where  $v^{\epsilon}, v \in L^2_{\Delta}([0, +\infty); \mathbb{R}^m)$ , and  $y^{\Delta, v^{\epsilon}}_{t_k}$  and  $w^{\Delta, v}_{t_k}$  are defined by : for  $r \in [t_j, t_{j+1}]$ ,  $j \in \{-N, \ldots, -1\}$ ,

$$y_{t_k}^{\Delta,v^{\epsilon}}(r) := \frac{t_{j+1}-r}{\Delta} y^{\Delta,v^{\epsilon}}(t_{k+j}) + \frac{r-t_j}{\Delta} y^{\Delta,v^{\epsilon}}(t_{k+j+1}),$$
$$w_{t_k}^{\Delta,v}(r) := \frac{t_{j+1}-r}{\Delta} w^{\Delta,v}(t_{k+j}) + \frac{r-t_j}{\Delta} w^{\Delta,v}(t_{k+j+1}).$$

The continuous versions for solutions of (5.3) and (5.4) are defined by the linear interpolations of the solutions, respectively. Define measurable maps  $\mathcal{G}^{\Delta,\epsilon}, \mathcal{G}^{\Delta}: \mathcal{C}([0,+\infty);\mathbb{R}^m) \to \mathcal{C}_{\xi}([-\tau,+\infty);\mathbb{R}^d)$  respectively, by

$$\mathcal{G}^{\Delta,\epsilon}\left(\sqrt{\epsilon}W + \int_0^{\cdot} v^{\epsilon}(\lfloor s \rfloor) \mathrm{d}s\right) = y^{\Delta,v^{\epsilon}}, \quad \mathcal{G}^{\Delta}\left(\int_0^{\cdot} v(\lfloor s \rfloor) \mathrm{d}s\right) = w^{\Delta,v}.$$

Introduce the auxiliary process

$$\begin{cases} z^{\Delta,v}(t_k) = \xi(t_k), \quad k = -N, \dots, -1, \\ z^{\Delta,v}(t_k) = w^{\Delta,v}(t_k) - \theta b(w_{t_k}^{\Delta,v})\Delta, \quad k = 0, \\ z^{\Delta,v}(t_k) = z^{\Delta,v}(t_{k-1}) + b(w_{t_{k-1}}^{\Delta,v})\Delta + \sigma(w_{t_{k-1}}^{\Delta,v})v(t_{k-1})\Delta, \quad k \in \mathbb{N}_+ \end{cases}$$
(5.5)

and the continuous version  $\{z^{\Delta,v}(t)\}_{t\geq 0}$  as follows: for  $t\in[t_k,t_{k+1})$  with  $k\in\mathbb{N}$ ,

$$z^{\Delta,v}(t) = z^{\Delta,v}(t_k) + b(w_{t_k}^{\Delta,v})(t-t_k) + \sigma(w_{t_k}^{\Delta,v})v(t_k)(t-t_k),$$

for  $t \in [-\tau, 0], \ z^{\Delta, v}(t) = \xi(t)$ .

**Theorem 5.1** Let Assumptions 1.1, 1.2, 2.1 and 2.2 hold. Then for any  $\Delta \in (0, \frac{1}{4\theta a_2}]$ , the family of random variables  $\{y^{\Delta,\epsilon}(\cdot)\}_{\epsilon \in (0,1)}$  satisfies the LDP in  $\mathcal{C}_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ , i.e.,

(i) for each closed subset F of  $C_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ ,

$$\limsup_{\epsilon \to 0} \epsilon \log \mathbb{P}(y^{\Delta,\epsilon}(\cdot) \in F) \le - \inf_{x \in F} I(x);$$

(ii) for each open subset O of  $C_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ ,

$$\liminf_{\epsilon \to 0} \epsilon \log \mathbb{P}(y^{\Delta,\epsilon}(\cdot) \in O) \ge -\inf_{x \in O} I(x),$$

where the good rate function is given by

$$I(f) = \inf_{\{v \in L^2_{\Delta}([0,+\infty); \mathbb{R}^m) : f = \mathcal{G}^{\Delta}(\int_0^\cdot v(\lfloor s \rfloor) \mathrm{d}s)\}} \frac{1}{2} \int_0^{+\infty} |v(\lfloor s \rfloor)|^2 \mathrm{d}s.$$

According to the contraction principle (see e.g. [26, Theorem 4.2.1]), we obtain the following LDP for the family  $\{y^{\Delta,\epsilon}(t)\}_{\epsilon\in(0,1)}$  for each t > 0.

**Corollary 5.1** Under conditions in Theorem 5.1, for any t > 0, the family of random variables  $\{y^{\Delta,\epsilon}(t)\}_{\epsilon \in (0,1)}$  satisfies the LDP in  $\mathbb{R}^d$  with the good rate function given by

$$\tilde{I}(z) = \inf\{I(f) : f \in \mathcal{C}_{\xi}([-\tau,\infty); \mathbb{R}^d), z = f(t)\},\$$

where  $I(\cdot)$  is given in Theorem 5.1.

The proof of Theorem 5.1 is based on the equivalence of the LDP and the Laplace principle. According to [29, Condition 2.1, Theorem 2.10], it suffices to prove the compactness of solutions of the skeleton equation and the stochastic controlled equation (i.e., Propositions 5.1 and 5.2). We first give the *a priori* estimates of  $w^{\Delta,v}$  and  $z^{\Delta,v}$ .

**Lemma 5.1** Let M > 0 and  $v \in S_M$ . Under Assumptions 1.1, 1.2 and 2.2, it holds that for any  $\Delta \in (0, \frac{1}{4\theta a_2}]$ ,

$$\sup_{k \ge 0} |w^{\Delta,v}(t_k)| + \sup_{k \ge 0} |z^{\Delta,v}(t_k)| \le (1 + ||\xi||^{\beta+1}) K(M).$$

**Proof.** By the definition of  $z^{\Delta,v}$ , we have

$$\begin{split} &\frac{1}{2} \mathrm{d} |z^{\Delta,v}(t)|^2 = \langle b(w_{\lfloor t \rfloor}^{\Delta,v}), z^{\Delta,v}(t) \rangle \mathrm{d} t + \langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor), z^{\Delta,v}(t) \rangle \mathrm{d} t \\ &= \left\langle b(w_{\lfloor t \rfloor}^{\Delta,v}), w^{\Delta,v}(\lfloor t \rfloor) - \theta b(w_{\lfloor t \rfloor}^{\Delta,v}) \Delta + b(w_{\lfloor t \rfloor}^{\Delta,v})(t - \lfloor t \rfloor) + \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor)(t - \lfloor t \rfloor) \right\rangle \mathrm{d} t \\ &+ \left\langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor), z^{\Delta,v}(\lfloor t \rfloor) + b(w_{\lfloor t \rfloor}^{\Delta,v})(t - \lfloor t \rfloor) + \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor)(t - \lfloor t \rfloor) \right\rangle \mathrm{d} t \\ &= \left[ (t - \lfloor t \rfloor - \theta \Delta) |b(w_{\lfloor t \rfloor}^{\Delta,v})|^2 + \langle b(w_{\lfloor t \rfloor}^{\Delta,v}), w^{\Delta,v}(\lfloor t \rfloor) \rangle + 2\langle b(w_{\lfloor t \rfloor}^{\Delta,v}), \sigma(w_{\lfloor t \rfloor}^{\Delta,v}) \\ v(\lfloor t \rfloor)(t - \lfloor t \rfloor) \rangle + |\sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor)|^2(t - \lfloor t \rfloor) + \langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor), z^{\Delta,v}(\lfloor t \rfloor) \rangle \right] \mathrm{d} t. \end{split}$$

This implies

where in the second equality we used  $z^{\Delta,v}(\lfloor t \rfloor) = w^{\Delta,v}(\lfloor t \rfloor) - \theta b(w^{\Delta,v}_{\lfloor t \rfloor})\Delta$  and  $\int_{t_k}^{t_{k+1}}(t - t_k)dt = \frac{1}{2}\Delta^2$ , and in the last step we used the inequality  $2\langle a, b \rangle \leq (1 + \tilde{c}\Delta)|a|^2 + \frac{1}{1 + \tilde{c}\Delta}|b|^2$  for  $\tilde{c} > 0$ . Therefore, by iterating, we arrive at that for  $\iota \in (0, 1)$ ,

On account of (2.23), take sufficiently small numbers  $\iota, \tilde{c} > 0$  independent of  $\Delta$  such that  $\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\tilde{c}\Delta)} - e^{-\iota\Delta} \leq 0$ . Then, utilizing the Hölder inequality, (1.5), and Assumption 2.2, we see that

$$\leq e^{\iota \tau} \tau \|\xi\| e^{\iota \tau} + e^{\iota \tau} \int_{0}^{t_{k+1}} e^{\iota \lceil t \rceil} |w^{\Delta, v}(\lfloor t \rfloor)|^{2} \mathrm{d}t \quad \text{for } i = 1, 2,$$

whose proof is similar to that of (2.12). Analogously to the proof of Proposition 2.2, parameters  $\tilde{c}$  and  $\iota$  can further be taken such that  $\frac{2\theta-1}{\theta^2}\tilde{c}-a_1-a_2+(\frac{a_1-a_2+L}{2}+2a_2)e^{\iota\tau} \leq 0$ . Consequently,

$$e^{\iota t_{k+1}} |z^{\Delta,v}(t_{k+1})|^{2} \leq K(1 + \|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) + K \int_{0}^{t_{k+1}} \Big( \sup_{r \in [-\tau,t]} e^{\iota \lfloor r \rfloor} |w^{\Delta,v}(\lfloor r \rfloor)|^{2} + \sup_{r \in [0,t]} e^{\iota \lfloor r \rfloor} |z^{\Delta,v}(\lfloor r \rfloor)|^{2} \Big) |v(\lfloor t \rfloor)|^{2} dt.$$
(5.6)

It follows from (1.2) and (5.5) that

$$|z^{\Delta,v}(t_{k+1})|^{2} \geq |w^{\Delta,v}(t_{k+1})|^{2} - 2\theta\Delta \langle w^{\Delta,v}(t_{k+1}), b(w^{\Delta,v}_{t_{k+1}}) \rangle$$
  
$$\geq |w^{\Delta,v}(t_{k+1})|^{2} - \theta\Delta \Big(K - 2a_{1}|w^{\Delta,v}(t_{k+1})|^{2} + 2a_{2}\int_{-\tau}^{0} |w^{\Delta,v}_{t_{k+1}}(r)|^{2} \mathrm{d}\nu_{2}(r)\Big)$$
  
$$\geq |w^{\Delta,v}(t_{k+1})|^{2} - K\theta\Delta - 2\theta a_{2}\Delta \int_{-\tau}^{0} |w^{\Delta,v}_{t_{k+1}}(r)|^{2} \mathrm{d}\nu_{2}(r),$$

which implies

$$e^{\iota t_{k+1}} |z^{\Delta,v}(t_{k+1})|^{2} \\ \geq e^{\iota t_{k+1}} |w^{\Delta,v}(t_{k+1})|^{2} - K\theta \Delta e^{\iota t_{k+1}} - 2\theta a_{2}e^{\iota \tau} \Delta \sup_{t \in [-\tau, t_{k+1}]} e^{\iota \lfloor t \rfloor} |w^{\Delta,v}(\lfloor t \rfloor)|^{2}.$$

Then we arrive at

$$\begin{split} e^{\iota t_{k+1}} |w^{\Delta,v}(t_{k+1})|^2 &\leq K\theta \Delta e^{\iota t_{k+1}} + 2\theta a_2 e^{\iota \tau} \Delta \sup_{t \in [-\tau, t_{k+1}]} e^{\iota \lfloor t \rfloor} |w^{\Delta,v}(\lfloor t \rfloor)|^2 \\ &+ K(1 + \|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) + K \int_0^{t_{k+1}} \Big( \sup_{r \in [-\tau, t]} e^{\iota \lfloor r \rfloor} |w^{\Delta,v}(\lfloor r \rfloor)|^2 \\ &+ \sup_{r \in [0, t]} e^{\iota \lfloor r \rfloor} |z^{\Delta,v}(\lfloor r \rfloor)|^2 \Big) |v(\lfloor t \rfloor)|^2 \mathrm{d}t. \end{split}$$

Choose a sufficiently small number  $\iota$  such that  $e^{\iota\tau} \leq \frac{3}{2}$ . Then for  $\Delta \in (0, \frac{1}{4\theta a_2}]$ ,

$$\begin{split} &\frac{1}{4} \sup_{t \in [-\tau, t_{k+1}]} e^{\iota \lfloor t \rfloor} |w^{\Delta, v}(\lfloor t \rfloor)|^2 \\ &\leq K(1 + \|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) + K \int_0^{t_{k+1}} \Big( \sup_{r \in [-\tau, t]} e^{\iota \lfloor r \rfloor} |w^{\Delta, v}(\lfloor r \rfloor)|^2 \\ &+ \sup_{r \in [0, t]} e^{\iota \lfloor r \rfloor} |z^{\Delta, v}(\lfloor r \rfloor)|^2 \Big) |v(\lfloor t \rfloor)|^2 \mathrm{d}t, \end{split}$$

which, together with (5.6) gives that

$$\begin{split} \sup_{t\in[-\tau,t_{k+1}]} e^{\iota\lfloor t\rfloor} |w^{\Delta,v}(\lfloor t\rfloor)|^2 + \sup_{t\in[0,t_{k+1}]} e^{\iota\lfloor t\rfloor} |z^{\Delta,v}(\lfloor t\rfloor)|^2 \\ \leq K(1+\|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) + K \int_0^{t_{k+1}} \Big(\sup_{r\in[-\tau,t]} e^{\iota\lfloor r\rfloor} |w^{\Delta,v}(\lfloor r\rfloor)|^2 \\ + \sup_{r\in[0,t]} e^{\iota\lfloor r\rfloor} |z^{\Delta,v}(\lfloor r\rfloor)|^2 \Big) |v(\lfloor t\rfloor)|^2 \mathrm{d}t. \end{split}$$

Applying the Grönwall inequality and using  $v \in S_M$ , we deduce

$$\sup_{t \in [-\tau, t_{k+1}]} e^{\iota \lfloor t \rfloor} |w^{\Delta, v}(\lfloor t \rfloor)|^2 + \sup_{t \in [0, t_{k+1}]} e^{\iota \lfloor t \rfloor} |z^{\Delta, v}(\lfloor t \rfloor)|^2$$
  
$$\leq K(1 + \|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) e^{K \int_0^{t_{k+1}} |v(\lfloor t \rfloor)|^2 \mathrm{d}t} \leq K(1 + \|\xi\|^{2(\beta+1)} + e^{\iota t_{k+1}}) e^{KM}.$$

This implies that  $\sup_{k\geq 0} |w^{\Delta,v}(t_k)| + \sup_{k\geq 0} |z^{\Delta,v}(t_k)| \leq (1+||\xi||^{\beta+1})K(M)$ . The proof is finished.  $\square$ 

**Proposition 5.1** Let M > 0. Under Assumptions 1.1, 1.2, and 2.2, for any  $\Delta \in (0, \frac{1}{4\theta a_2}]$ ,  $\mathcal{K}_M := \{\mathcal{G}^{\Delta}(\int_0^{\cdot} v(\lfloor s \rfloor) ds) | v \in \mathcal{S}_M\}$  is compact in  $\mathcal{C}_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ .

**Proof.** Since  $S_M$  is compact with respect to the weak topology, it suffices to show that the mapping  $\mathcal{G}^{\Delta} \circ F$  is continuous, where  $F : L^2_{\Delta}([0, +\infty); \mathbb{R}^m) \to \mathcal{C}([0, \infty); \mathbb{R}^m)$  is defined by  $F(v)(\cdot) := \int_0^{\cdot} v(\lfloor s \rfloor) ds$ . Namely, letting  $v^{\epsilon} \to v$  in  $S_M$ , we shall prove  $w^{\Delta, v^{\epsilon}} \to w^{\Delta, v}$  in  $\mathcal{C}_{\xi}([-\tau, +\infty); \mathbb{R}^d)$ . First, we show that for any  $k \in \mathbb{N}_+$ ,  $\sup_{t \in [0, t_k]} |w^{\Delta, v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta, v}(\lfloor t \rfloor)| \to$ 0. By (5.5) and the continuous version of  $z^{\Delta, v}(\cdot)$ , we have

$$\begin{split} &\frac{1}{2} \mathrm{d} |z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t)|^{2} \\ &= \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \rangle \mathrm{d} t \\ &+ \langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) v^{\epsilon}(\lfloor t \rfloor) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}) v(\lfloor t \rfloor), z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \rangle \mathrm{d} t \\ &= \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}) \rangle(t - \lfloor t \rfloor) \mathrm{d} t \\ &+ \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), \sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) v^{\epsilon}(\lfloor t \rfloor) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}) v(\lfloor t \rfloor) \rangle(t - \lfloor t \rfloor) \mathrm{d} t \\ &+ \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor) \rangle \mathrm{d} t \\ &- \theta \Delta \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}) \rangle \mathrm{d} t \\ &+ \langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) v^{\epsilon}(\lfloor t \rfloor) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}) v(\lfloor t \rfloor), z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \rangle \mathrm{d} t. \end{split}$$

This implies

$$\begin{split} |z^{\Delta,v^{\epsilon}}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^{2} \\ &= |z^{\Delta,v^{\epsilon}}(t_{k}) - z^{\Delta,v}(t_{k})|^{2} + (1 - 2\theta)\Delta^{2}|b(w_{t_{k}}^{\Delta,v^{\epsilon}}) - b(w_{t_{k}}^{\Delta,v})|^{2} \\ &+ \int_{t_{k}}^{t_{k+1}} 2\langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)\rangle \mathrm{d}t \\ &+ \int_{t_{k}}^{t_{k+1}} 2\langle (\sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}))v^{\epsilon}(\lfloor t \rfloor), z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \end{split}$$

$$\begin{split} &+ \frac{1}{2} \Delta \left( b(w_{\lfloor t \rfloor}^{\Delta, v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta, v}) \right) \right\rangle \mathrm{d}t \\ &+ \int_{t_{k}}^{t_{k+1}} 2 \left\langle \sigma(w_{\lfloor t \rfloor}^{\Delta, v})(v^{\epsilon}(\lfloor t \rfloor) - v(\lfloor t \rfloor)), z^{\Delta, v^{\epsilon}}(t) - z^{\Delta, v}(t) \right. \\ &+ \frac{1}{2} \Delta \left( b(w_{\lfloor t \rfloor}^{\Delta, v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta, v}) \right) \right\rangle \mathrm{d}t, \end{split}$$

where we used

$$b(w_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t\rfloor}^{\Delta,v}) = \frac{1}{\theta\Delta} \Big( w^{\Delta,v^{\epsilon}}(\lfloor t\rfloor) - z^{\Delta,v^{\epsilon}}(\lfloor t\rfloor) - \big( w^{\Delta,v^{\epsilon}}(\lfloor t\rfloor) - z^{\Delta,v}(\lfloor t\rfloor) \big) \Big).$$
(5.7)

Taking into account  $1-2\theta \leq 0$  and

$$(1-2\theta)\Delta^2 |b(w_{t_k}^{\Delta,v^{\epsilon}}) - b(w_{t_k}^{\Delta,v})|^2$$
  

$$\leq \frac{(1-2\theta)}{\theta^2} (1-\frac{1}{(1+c_\lambda\Delta)}) |z^{\Delta,v^{\epsilon}}(t_k) - z^{\Delta,v}(t_k)|^2$$
  

$$+ \frac{(1-2\theta)}{\theta^2} (1-(1+c_\lambda\Delta)) |w^{\Delta,v^{\epsilon}}(t_k) - w^{\Delta,v^{\epsilon}}(t_k)|^2,$$

we obtain

$$\begin{aligned} |z^{\Delta,v^{\epsilon}}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^{2} \\ &\leq \left(\frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta-1}{\theta^{2}(1+c_{\lambda}\Delta)}\right)|z^{\Delta,v^{\epsilon}}(t_{k}) - z^{\Delta,v}(t_{k})|^{2} + c_{\lambda}\Delta|w^{\Delta,v^{\epsilon}}(t_{k}) - w^{\Delta,v}(t_{k})|^{2} \\ &+ \int_{t_{k}}^{t_{k+1}} 2\langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)\rangle dt \\ &+ \int_{t_{k}}^{t_{k+1}} 2\Big\langle (\sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}))v^{\epsilon}(\lfloor t \rfloor), z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \\ &+ \frac{1}{2}\Delta(b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}))\Big\rangle dt + \int_{t_{k}}^{t_{k+1}} 2\Big\langle \sigma(w_{\lfloor t \rfloor}^{\Delta,v})(v^{\epsilon}(\lfloor t \rfloor) - v(\lfloor t \rfloor)), \\ z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) + \frac{1}{2}\Delta(b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}))\Big\rangle dt, \end{aligned}$$

where the constant  $c_{\lambda}$  is defined by (1.6). Utilizing (5.5) and the continuous version of  $z^{\Delta,v}(\cdot)$  again, and applying the Young inequality, one has

where we used  $\int_{t_k}^{t_{k+1}} (t - \lfloor t \rfloor) dt = \frac{1}{2}\Delta^2$ . Inserting (5.9) into (5.8), and then by iterating, we obtain that for  $\gamma \in (0, 1)$ ,

$$\begin{split} & e^{\gamma t_{k+1}} |z^{\Delta,v^{\epsilon}}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^{2} \\ &= \sum_{i=0}^{k} \left( e^{\gamma t_{i+1}} |z^{\Delta,v^{\epsilon}}(t_{i+1}) - z^{\Delta,v}(t_{i+1})|^{2} - e^{\gamma t_{i}} |z^{\Delta,v^{\epsilon}}(t_{i}) - z^{\Delta,v}(t_{i})|^{2} \right) \\ &\leq \sum_{i=0}^{k} e^{\gamma t_{i+1}} \left[ \left( \frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta-1}{\theta^{2}(1+c_{\lambda}\Delta)} - e^{-\gamma\Delta} \right) |z^{\Delta,v^{\epsilon}}(t_{i}) - z^{\Delta,v}(t_{i})|^{2} \right. \\ &+ c_{\lambda}\Delta |w^{\Delta,v^{\epsilon}}(t_{i}) - w^{\Delta,v}(t_{i})|^{2} \right] + \int_{0}^{t_{k+1}} e^{\gamma [t]} \left[ 2 \langle b(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v)}, w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) \right. \\ &- w^{\Delta,v}(\lfloor t \rfloor) \rangle + |\sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v})|^{2} \right] dt + K \int_{0}^{t_{k+1}} e^{\gamma [t]} |v^{\epsilon}(\lfloor t \rfloor)|^{2} \times \\ & \left[ |z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - z^{\Delta,v}(\lfloor t \rfloor)|^{2} + |w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)|^{2} \right] dt + \int_{0}^{t_{k+1}} e^{\gamma [t]} |\sigma(w_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v})|^{2} |v^{\epsilon}(\lfloor t \rfloor)|^{2} \Delta dt + J(t_{k+1}), \end{split}$$

where J is defined by

$$\begin{split} J(s) &:= \int_0^s 2e^{\gamma \lceil t \rceil} \Big\langle \sigma(w_{\lfloor t \rfloor}^{\Delta, v})(v^{\epsilon}(\lfloor t \rfloor) - v(\lfloor t \rfloor)), \frac{1}{2} \Delta(\sigma(w_{\lfloor t \rfloor}^{\Delta, v^{\epsilon}}) - \sigma(w_{\lfloor t \rfloor}^{\Delta, v}))v^{\epsilon}(\lfloor t \rfloor) \\ &+ z^{\Delta, v^{\epsilon}}(t) - z^{\Delta, v}(t) + \frac{1}{2} \Delta(b(w_{\lfloor t \rfloor}^{\Delta, v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta, v})) \Big\rangle \mathrm{d}t. \end{split}$$

It follows Assumptions 1.1 and 1.2 that

$$\begin{split} & e^{\gamma t_{k+1}} |z^{\Delta,v^{\epsilon}}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^{2} \\ & \leq \sum_{i=0}^{k} e^{\gamma t_{i+1}} \left(\frac{(1-\theta)^{2}}{\theta^{2}} + \frac{2\theta-1}{\theta^{2}(1+c_{\lambda}\Delta)} - e^{-\gamma\Delta}\right) |z^{\Delta,v^{\epsilon}}(t_{i}) - z^{\Delta,v}(t_{i})|^{2} \\ & + \sum_{i=0}^{k} -(2a_{1} - L - c_{\lambda} - (L + 2a_{2})e^{\gamma\tau})\Delta e^{\gamma t_{i+1}} |w^{\Delta,v^{\epsilon}}(t_{i}) - w^{\Delta,v}(t_{i})|^{2} \right] \\ & + K \int_{0}^{t_{k+1}} e^{\gamma \lceil t \rceil} |v^{\epsilon}(\lfloor t \rfloor)|^{2} \Big[ |z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - z^{\Delta,v}(\lfloor t \rfloor)|^{2} + |w^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)|^{2} \Big] \\ & + 2Le^{\gamma\Delta} \int_{0}^{t_{k+1}} \sup_{s \in [0,t]} e^{\gamma \lfloor s \rfloor} |w^{\Delta,v^{\epsilon}}(\lfloor s \rfloor) - w^{\Delta,v}(\lfloor s \rfloor)|^{2} |v^{\epsilon}(\lfloor t \rfloor)|^{2} \Delta dt + J(t_{k+1}). \end{split}$$

Similar to the proof of Proposition 2.4, one can take a sufficiently small number  $\gamma$  independent of  $\Delta$  such that  $\frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+c_\lambda\Delta)} - e^{-\gamma\Delta} \leq 0$  and  $2a_1 - L - c_\lambda - (L+2a_2)e^{\gamma\tau} \geq 0$ . Then, we see that

$$\leq K \int_{0}^{t_{k+1}} |v^{\epsilon}(\lfloor t \rfloor)|^{2} \sup_{s \in [0,t]} \left[ e^{\gamma \lfloor s \rfloor} |z^{\Delta,v^{\epsilon}}(\lfloor s \rfloor) - z^{\Delta,v}(\lfloor s \rfloor)|^{2} + e^{\gamma \lfloor s \rfloor} |w^{\Delta,v^{\epsilon}}(\lfloor s \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)|^{2} \right] dt + J(t_{k+1}).$$

Denote  $E^{\epsilon}(t) = \int_0^t \sigma(w_{\lfloor s \rfloor}^{\Delta,v})(v^{\epsilon}(\lfloor s \rfloor) - v(\lfloor s \rfloor)) ds$ . Applying the integration by parts formula,  $v^{\epsilon}(\cdot) \in \mathcal{S}_M$ , Assumptions 1.1 and 2.2, and Lemma 5.1, we arrive at

By virtue of

$$\int_{r_1}^{r_2} \sigma(w_{\lfloor s \rfloor}^{\Delta, v})(v^{\epsilon}(\lfloor s \rfloor) - v(\lfloor s \rfloor)) \mathrm{d}s| \le K(M)\sqrt{|r_2 - r_1|},$$

we deduce the equicontinuity of  $\{E^{\epsilon}(t), t \in [0, +\infty)\}_{\epsilon \in (0,1)}$ . According to Assumption 1.1, Lemma 5.1,  $v^{\epsilon}(\cdot), v(\cdot) \in S_M$ , and the Hölder inequality, one has

$$\sup_{\epsilon \in (0,1)} \sup_{t \in [0,+\infty)} \left| \int_0^{+\infty} \sigma(w_{\lfloor s \rfloor}^{\Delta,v})(v^{\epsilon}(\lfloor s \rfloor) - v(\lfloor s \rfloor)) \mathrm{d}s \right| \le K(M)(1 + \|\xi\|^{\beta+1}),$$

which implies the uniform boundedness of  $\{E^{\epsilon}(\cdot)\}_{\epsilon \in (0,1)}$ . Hence, according to the Ascoli– Arzela theorem, we obtain that  $\{E^{\epsilon}(\cdot)\}_{\epsilon \in (0,1)}$  is compact in  $\mathcal{C}([0, t_{k+1}]; \mathbb{R}^d)$ . Note that

with respect to the weak topology of  $S_{M'}$  for  $M' = MK(M)(1 + ||\xi||^{2(\beta+1)})$ . By [21, Chapter VI, Proposition 3.3], we conclude that  $\sup_{t \in [0, t_{k+1})} |E^{\epsilon}(t)| \to 0$ . This, together with (5.12) implies that for each  $k \in \mathbb{N}_+$ ,

This finishes the proof.  $\Box$ 

In order to obtain the boundedness of the moments of  $y^{\Delta,v^{\epsilon}}$ , we introduce the auxiliary process

Define the continuous version  $Z^{\Delta,v^{\epsilon}}(\cdot)$  as follows: for  $t \in [t_k, t_{k+1})$  with  $k \in \mathbb{N}$ ,

$$Z^{\Delta,v^{\epsilon}}(t) := Z^{\Delta,v^{\epsilon}}(t_k) + b(y_{t_k}^{\Delta,v^{\epsilon}})(t-t_k) + \sqrt{\epsilon}\sigma(y_{t_k}^{\Delta,v^{\epsilon}})(W(t) - W(t_k)) + \sigma(y_{t_k}^{\Delta,v^{\epsilon}})v^{\epsilon}(t_k)(t-t_k),$$

and for  $t \in [-\tau, 0], Z^{\Delta, v^{\epsilon}}(t) := \xi(t).$ 

**Lemma 5.2** Let M > 0 and  $\{v^{\epsilon}\}_{\epsilon \in (0,1)} \subset \mathcal{P}_M$ . Under Assumptions 1.1, 1.2, 2.1 and 2.2, for any  $\Delta \in (0,1]$  and  $p \in \mathbb{N}_+$ , we have

$$\mathbb{E}\Big[\sup_{t\in[0,t_{k+1}]}|Z^{\Delta,v^{\epsilon}}(\lfloor t\rfloor)|^{2p}\Big] + \mathbb{E}\Big[\sup_{t\in[0,t_{k+1}]}|y^{\Delta,v^{\epsilon}}(\lfloor t\rfloor)|^{2p}\Big]$$
  
$$\leq K(M)(1+\|\xi\|^{2p(\beta+1)})e^{\sqrt{\epsilon}K(M)t_{k+1}}.$$

As a consequence, for sufficiently small  $\epsilon > 0$ ,  $Z^{\Delta,v^{\epsilon}}(\cdot)$  and  $y^{\Delta,v^{\epsilon}}(\cdot)$  belong to  $L^{2p}(\Omega; \mathcal{C}_{\xi})$ .

**Proof.** Step 1. We show that for  $\Delta \in (0, \Delta^*]$  with some sufficiently small  $\Delta^* \in (0, 1)$ ,

where  $\widetilde{M}_k := \langle \sqrt{\epsilon} \sigma(y_{t_k}^{\Delta,v^{\epsilon}}) \delta W_k, \sigma(y_{t_k}^{\Delta,v^{\epsilon}}) v^{\epsilon}(t_k) \Delta + Z^{\Delta,v^{\epsilon}}(t_k) + b(y_{t_k}^{\Delta,v^{\epsilon}}) \Delta \rangle$ . Recalling the notation  $A_{\theta,\Delta} := \frac{(1-\theta)^2}{\theta^2} + \frac{2\theta-1}{\theta^2(1+\Delta)}$  and using Assumptions 1.1 and 2.1, we have

Similar to the proof of Lemma 2.2, take sufficiently small  $\gamma_1$  and  $\gamma_2$  independent of  $\Delta$  such that  $(1 + K\gamma_1\Delta)A^p_{\theta,\Delta}e^{\gamma_2\Delta} - 1 \leq 0$ . Choose R sufficiently large and further choose  $\Delta^*$  sufficiently small. We obtain that for  $\Delta \leq \Delta^*$ ,

$$\sup_{t \in [0, t_{k+1}]} e^{\gamma_2 \lfloor t \rfloor} |Z^{\Delta, v^{\epsilon}}(\lfloor t \rfloor)|^{2p} + \sup_{t \in [0, t_{k+1}]} e^{\gamma_2 \lfloor t \rfloor} |y^{\Delta, v^{\epsilon}}(\lfloor t \rfloor)|^{2p}$$

$$\leq e^{K(M)M} \Big( K(1 + \|\xi\|^{2p(\beta+1)}) + Ke^{\gamma_2 t_{k+1}} + K \sup_{j \leq k} \sum_{l=0}^{j} e^{\gamma_2 t_l} |Z^{\Delta, v^{\epsilon}}(t_l)|^{2(p-1)} \times (\epsilon |\sigma(y_{t_l}^{\Delta, v^{\epsilon}}) \delta W_l|^2 + \widetilde{\mathcal{M}}_l) + K \sum_{l=0}^{k} e^{\gamma_2 t_l} \sum_{i=2}^{p} C_p^i |Z^{\Delta, v^{\epsilon}}(t_l)|^{2(p-i)} \times (\epsilon |\sigma(y_{t_l}^{\Delta, v^{\epsilon}}) \delta W_l|^{2i} + |\widetilde{\mathcal{M}}_l|^i) \Big).$$
(5.17)

Applying the Burkholder–Davis–Gundy inequality and the Young inequality, we arrive at that for  $\gamma_3 \in (0, 1)$ ,

$$\begin{split} & \mathbb{E}\Big[\sup_{j\leq k}\sum_{l=0}^{j}e^{\gamma_{2}t_{l}}|Z^{\Delta,v^{\epsilon}}(t_{l})|^{2(p-1)}(\epsilon|\sigma(y_{t_{l}}^{\Delta,v^{\epsilon}})\delta W_{l}|^{2}+\widetilde{\mathcal{M}}_{l})\Big] \\ &\leq \epsilon\Delta\mathbb{E}\Big[\sum_{l=0}^{k}e^{\gamma_{2}t_{l}}|Z^{\Delta,v^{\epsilon}}(t_{l})|^{2(p-1)}|\sigma(y_{t_{l}}^{\Delta,v^{\epsilon}})|^{2}\Big]+K\mathbb{E}\Big[\Big(\sum_{l=0}^{k}e^{2\gamma_{2}t_{l}}|Z^{\Delta,v^{\epsilon}}(t_{l})|^{4(p-1)}\times\\ &\epsilon|\sigma(y_{t_{k}}^{\Delta,v^{\epsilon}})|^{2}\Big(|\sigma(y_{t_{k}}^{\Delta,v^{\epsilon}})|^{2}M+|Z^{\Delta,v^{\epsilon}}(t_{k})|^{2}+|y^{\Delta,v^{\epsilon}}(t_{k})|^{2}\Big)\Delta\Big)^{\frac{1}{2}}\Big]\\ &\leq \sqrt{\epsilon}K(M,\gamma_{3})\int_{0}^{t_{k+1}}\mathbb{E}\Big[\sup_{r\in[0,s]}e^{\gamma_{3}\lfloor r\rfloor}|Z^{\Delta,v^{\epsilon}}(\lfloor r\rfloor)|^{2p}+\sup_{r\in[0,s]}e^{\gamma_{3}\lfloor r\rfloor}|y^{\Delta,v^{\epsilon}}(\lfloor r\rfloor)|^{2p}\Big]\mathrm{d}s \end{split}$$

#### 5.1 The Freidlin–Wentzell large deviation of numerical solution

$$+\gamma_3 K(M) \Big( \sup_{t \in [0,t_{k+1}]} e^{\gamma_3 \lfloor t \rfloor} |Z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor)|^{2p} + \sup_{t \in [0,t_{k+1}]} e^{\gamma_3 \lfloor t \rfloor} |y^{\Delta,v^{\epsilon}}(\lfloor t \rfloor)|^{2p} \Big) + K \|\xi\|^{2p}.$$

Similarly,

$$\begin{split} & \mathbb{E}\Big[\sum_{l=0}^{k} e^{\gamma_{2}t_{l}} \sum_{i=2}^{p} C_{p}^{i} |Z^{\Delta,v^{\epsilon}}(t_{l})|^{2(p-i)} (\epsilon |\sigma(y_{t_{l}}^{\Delta,v^{\epsilon}}) \delta W_{l}|^{2i} + |\widetilde{\mathcal{M}}_{l}|^{i})\Big] \\ &\leq \epsilon K(M) \int_{0}^{t_{k+1}} \mathbb{E}\Big[\sup_{r\in[0,s]} e^{\gamma_{3}\lfloor r \rfloor} |Z^{\Delta,v^{\epsilon}}(\lfloor r \rfloor)|^{2p} + \sup_{r\in[0,s]} e^{\gamma_{3}\lfloor r \rfloor} |y^{\Delta,v^{\epsilon}}(\lfloor r \rfloor)|^{2p}\Big] \mathrm{d}s \\ &+ \gamma_{3} K(M) \Big(\sup_{t\in[0,t_{k+1}]} e^{\gamma_{3}\lfloor t \rfloor} |Z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor)|^{2p} + \sup_{t\in[0,t_{k+1}]} e^{\gamma_{3}\lfloor t \rfloor} |y^{\Delta,v^{\epsilon}}(\lfloor t \rfloor)|^{2p}\Big) + K \|\xi\|^{2p}. \end{split}$$

Taking expectation on both sides of (5.17), inserting the above two inequalities into (5.17), letting  $\gamma_3 > 0$  be sufficiently small, and using the Grönwall inequality again, we deduce

$$\leq K(M)(1+\|\xi\|^{2p(\beta+1)})e^{\sqrt{\epsilon}K(M)t_{k+1}}.$$

We finishes the proof of  $\underline{\text{Step 1}}$ .

<u>Step 2.</u> We show that for  $\Delta \in [\Delta^*, 1]$ ,

$$\leq K(M)(1+\|\xi\|^{2p(\beta+1)})e^{\sqrt{\epsilon}K(M)t_{k+1}}.$$

The proof is similar to that of  $\underline{\text{Step 2}}$  in Lemma 2.2, and thus we only give the sketch of the proof.

Similar to the estimate of  $\mathcal{I}_i^{\epsilon}$ , we have

$$\begin{split} \mathcal{I}_{1}^{\epsilon} &\leq \gamma_{1} A_{\theta,\Delta}^{p} |Z^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + K(\gamma_{1})\Delta - \frac{1}{2} R \Delta A_{\theta,\Delta}^{p-1} |y^{\Delta,v^{\epsilon}}(t_{k})|^{2p} \\ &+ K(\gamma_{1})\Delta^{p} \Big( |y^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + \int_{-\tau}^{0} |y_{t_{k}}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_{2}(r) + \int_{-\tau}^{0} |y_{t_{k}}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_{1}(r) \Big) \\ &+ K(M)\Delta |v^{\epsilon}(t_{k})|^{2} \Big( |Z^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + |y^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + \int_{-\tau}^{0} |y_{t_{k}}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_{1}(r) \Big) \\ &+ A_{\theta,\Delta}^{p-1} |Z^{\Delta,v^{\epsilon}}(t_{k})|^{2(p-1)} (\epsilon |\sigma(y_{t_{k}}^{\Delta,v^{\epsilon}}) \delta W_{k}|^{2} + 2\widetilde{\mathcal{M}}_{k}), \end{split}$$

and for  $i \in \{2, ..., p\}$ ,

$$\mathcal{I}_i^{\epsilon} \leq \gamma_1 A_{\theta,\Delta}^p |Z^{\Delta,v^{\epsilon}}(t_k)|^{2p} + K(\gamma_1) \Delta^p \Big( |y^{\Delta,v^{\epsilon}}(t_k)|^{2p} + \int_{-\tau}^0 |y_{t_k}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_1(r)$$

$$+ \int_{-\tau}^{0} |y_{t_k}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_2(r) + K(M)\Delta |v^{\epsilon}(t_k)|^2 (|Z^{\Delta,v^{\epsilon}}(t_k)|^{2p} + |y^{\Delta,v^{\epsilon}}(t_k)|^{2p} + \int_{-\tau}^{0} |y_{t_k}^{\Delta,v^{\epsilon}}|^{2p} \mathrm{d}\nu_1(r) + KA_{\theta,\Delta}^{p-i} |Z^{\Delta,v^{\epsilon}}(t_k)|^{2(p-i)} (\epsilon |\sigma(y_{t_k}^{\Delta,v^{\epsilon}})\delta W_k|^{2i} + |\widetilde{\mathcal{M}}_k|^i).$$

It follows from  $(|a| + |b|)^p \ge |a|^p + |b|^p$  for  $p\mathbb{N}_+$  that

$$\begin{split} &|Z^{\Delta,v^{\epsilon}}(t_{k+1})|^{2p} + a_{3}^{p}\Delta^{p}|y^{\Delta,v^{\epsilon}}(t_{k+1})|^{p(2+l)} \\ &\leq (1+K\gamma_{1})A_{\theta,\Delta}^{p}|Z^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + K\Delta + \widetilde{\mathcal{J}}_{k1}(R) + \widetilde{\mathcal{J}}_{k2} \\ &+ K\Delta|v^{\epsilon}(t_{k})|^{2} \Big(|Z^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + |y^{\Delta,v^{\epsilon}}(t_{k})|^{2p} + \int_{-\tau}^{0}|y_{t_{k}}^{\Delta,v^{\epsilon}}|^{2p}\mathrm{d}\nu_{1}(r)\Big) \\ &+ K|Z^{\Delta,v^{\epsilon}}(t_{k})|^{2(p-1)}(\epsilon|\sigma(y_{t_{k}}^{\Delta,v^{\epsilon}})\delta W_{k}|^{2} + 2\widetilde{\mathcal{M}}_{k}) \\ &+ K\sum_{i=2}^{p}C_{p}^{i}|Z^{\Delta,v^{\epsilon}}(t_{k})|^{2(p-i)}(\epsilon|\sigma(y_{t_{k}}^{\Delta,v^{\epsilon}})\delta W_{k}|^{2i} + |\widetilde{\mathcal{M}}_{k}|^{i}), \end{split}$$

where

$$\begin{split} \widetilde{\mathcal{J}}_{k1}(R) &= -\frac{1}{2} R A^{p-1}_{\theta,\Delta} \Delta |y^{\Delta,v^{\epsilon}}(t_k)|^{2p}, \\ \widetilde{\mathcal{J}}_{k2} &= K(\gamma_1)(R) \Delta^p \big( |y^{\Delta,v^{\epsilon}}(t_k)|^{2p} + \int_{-\tau}^0 |y^{\Delta,v^{\epsilon}}_{t_k}(r)|^{2p} \mathrm{d}\nu_1(r) + \int_{-\tau}^0 |y^{\Delta,v^{\epsilon}}_{t_k}(r)|^{2p} \mathrm{d}\nu_2(r) \big). \end{split}$$

By taking  $\gamma_1$  and  $\gamma_2$  sufficiently small such that  $(1 + K\gamma_1)A^p_{\theta,\Delta^*}e^{\gamma_2} - 1 \leq 0$ , we obtain that for  $\Delta \in (\Delta^*, 1]$ ,

$$\begin{split} e^{\gamma_{2}t_{k+1}}|Z^{\Delta,v^{\epsilon}}(t_{k+1})|^{2p} &\leq |Z^{\Delta,v^{\epsilon}}0)|^{2p} + Ke^{\gamma_{2}t_{k+1}} + \sum_{l=0}^{k} e^{\gamma_{2}t_{l+1}}\widetilde{\mathcal{J}}_{l1}(R) \\ &+ \sum_{l=0}^{k} e^{\gamma_{2}t_{l+1}}(\widetilde{\mathcal{J}}_{l2} - a_{3}^{p}\Delta^{p}|y^{\Delta,v^{\epsilon}}(t_{l})|^{p(2+l)}) + K(M)\sum_{l=0}^{k} e^{\gamma_{2}t_{l}}\Delta|v^{\epsilon}(t_{l})|^{2} \times \\ &\left(|Z^{\Delta,v^{\epsilon}}(t_{l})|^{2p} + |y^{\Delta,v^{\epsilon}}(t_{l})|^{2p} + \int_{-\tau}^{0} |y_{t_{l}}^{\Delta,v^{\epsilon}}(r)|^{2p} \mathrm{d}\nu_{1}(r)\right) \\ &+ K\sum_{l=0}^{k} e^{\gamma_{2}t_{l}}|Z^{\Delta,v^{\epsilon}}(t_{l})|^{2(p-1)}(\epsilon|\sigma(y_{t_{l}}^{\Delta,v^{\epsilon}})\delta W_{l}|^{2} + 2\widetilde{\mathcal{M}}_{l}) \\ &+ K\sum_{l=0}^{k} \sum_{i=2}^{p} C_{p}^{i}|Z^{\Delta,v^{\epsilon}}(t_{l})|^{2(p-i)}(\epsilon|\sigma(y_{t_{l}}^{\Delta,v^{\epsilon}})\delta W_{l}|^{2i} + |\widetilde{\mathcal{M}}_{l}|^{i}). \end{split}$$

Then by the similar procedure to the proofs of (2.49) and (2.50), and choosing a sufficiently large number R independent of  $\Delta$ , we conclude that

  $\leq K(||\xi||^{2p} + 1).$ 

The remaining proof is similar to that of Step 1 and is omitted.

Combining Steps 1–2 finishes the proof.  $\hfill \Box$ 

**Proposition 5.2** Let M > 0 and  $\{v^{\epsilon}\}_{\epsilon \in (0,1)} \subset \mathcal{P}_M$  such that  $v^{\epsilon} \xrightarrow{d} v$  as  $\mathcal{S}_M$ -valued random variables. Under Assumptions 1.1, 1.2, 2.1, and 2.2, it holds that for any  $\Delta \in (0, \frac{1}{4a_2\theta}]$ ,

$$\mathcal{G}^{\Delta,\epsilon}\Big(\sqrt{\epsilon}W + \int_0^{\cdot} v^{\epsilon}(\lfloor s \rfloor) \mathrm{d}s\Big) \xrightarrow[\epsilon \to 0]{d} \mathcal{G}^{\Delta}\Big(\int_0^{\cdot} v(\lfloor s \rfloor) \mathrm{d}s\Big).$$

**Proof.** To show  $y^{\Delta,v^{\epsilon}} \xrightarrow[\epsilon \to 0]{d} w^{\Delta,v}$  as  $v^{\epsilon} \xrightarrow[\epsilon \to 0]{d} v$ , by the duality formula for the Kantorovich–Rubinstein distance (see e.g. [58, Remark 6.5]), it suffices to prove that  $\mathbb{E}[||y^{\Delta,v^{\epsilon}} - w^{\Delta,\nu}||_{\mathcal{C}_{\xi}} \wedge 1] \to 0$  as  $\epsilon \to 0$ . Note that

$$\begin{split} &\lim_{\epsilon \to 0} \mathbb{E} \left[ \| y^{\Delta, v^{\epsilon}} - w^{\Delta, \nu} \|_{\mathcal{C}_{\xi}} \wedge 1 \right] \\ &\leq \sum_{k=1}^{\infty} \lim_{\epsilon \to 0} \mathbb{E} \left[ \left( \Delta e^{-\mathfrak{a}t_{k}} \sup_{t \in [0, t_{k}]} | y^{\Delta, v^{\epsilon}}(t) - w^{\Delta, v}(t) | \right) \wedge 1 \right] \\ &\leq \sum_{k=1}^{\infty} \Delta e^{-\mathfrak{a}t_{k}} \lim_{\epsilon \to 0} \mathbb{E} \left[ \left( \sup_{t \in [0, t_{k}]} | y^{\Delta, v^{\epsilon}}(t) - w^{\Delta, v}(t) | \right) \wedge (e^{\mathfrak{a}t_{k}} \Delta^{-1}) \right] \end{split}$$

Hence, we only need to show that for any  $k \in \mathbb{N}_+$ ,

$$\lim_{\epsilon \to 0} \mathbb{E} \Big[ \sup_{t \in [0, t_k]} |y^{\Delta, v^{\epsilon}}(t) - w^{\Delta, v}(t)| \wedge (e^{\mathfrak{a} t_k} \Delta^{-1}) \Big] = 0.$$

It follows from definitions of  $Z^{\Delta,v^{\epsilon}}$  and  $z^{\Delta,v}$ , and the Itô formula that

$$\begin{split} \mathbf{d} |Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t)|^{2} &= \left[ 2 \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), b(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}) \rangle \right. \\ &+ \epsilon |\sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}})|^{2} + 2 \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), \sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) v^{\epsilon}(\lfloor t \rfloor) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v}) v(\lfloor t \rfloor) \rangle \right] \mathbf{d}t \\ &+ 2 \sqrt{\epsilon} \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), \sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) \mathbf{d}W(t) \rangle. \end{split}$$

On account of

$$Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) = Z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - z^{\Delta,v}(\lfloor t \rfloor) + (b(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}))(t - \lfloor t \rfloor) + \sqrt{\epsilon}\sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}})(W(t) - W(\lfloor t \rfloor)) + (\sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}})v^{\epsilon}(\lfloor t \rfloor) - \sigma(w_{\lfloor t \rfloor}^{\Delta,v})v(\lfloor t \rfloor))(t - \lfloor t \rfloor)$$

and

$$Z^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - z^{\Delta,v}(\lfloor t \rfloor) = y^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor) - \theta \Delta \big( b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}) \big),$$

we deduce

$$\begin{split} \mathbf{d} | Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) |^{2} &= \Big[ 2 \langle y^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor), b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}) \rangle \\ &- 2\theta \Delta | b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}) |^{2} + 2 \langle (b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}))(t - \lfloor t \rfloor), b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}) \rangle \\ &+ 2 \langle \sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) v^{\epsilon}(\lfloor t \rfloor) - \sigma(w^{\Delta,v}_{\lfloor t \rfloor})v(\lfloor t \rfloor), (b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}))(t - \lfloor t \rfloor) \\ &+ Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t) \rangle + \epsilon |\sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor})|^{2} \Big] \mathrm{d}t + 2\sqrt{\epsilon} \langle b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}), \\ &\sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor})(W(t) - W(\lfloor t \rfloor)) \rangle \mathrm{d}t + 2\sqrt{\epsilon} \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), \sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) \mathrm{d}W(t) \rangle. \end{split}$$

By the Young inequality, we have

$$\begin{split} &\frac{1}{2} \sup_{t \in [0,t_k]} e^{\gamma t} |Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t)|^2 + \frac{1}{8} \sup_{t \in \{0,\dots,t_k\}} e^{\gamma t} |y^{\Delta,v^{\epsilon}}(t) - w^{\Delta,v}(t)|^2 \\ &\leq K \int_0^{t_k} \left(1 + |v^{\epsilon}(\lfloor t \rfloor)|^2\right) \Big(\sup_{r \in [0,t]} \left(|y^{\Delta,v^{\epsilon}}(\lfloor r \rfloor) - w^{\Delta,v}(\lfloor r \rfloor)|^2 + |Z^{\Delta,v^{\epsilon}}(r) \\ &- z^{\Delta,v}(r)|^2\right) \Big) \mathrm{d}t + 2\epsilon \int_0^{t_k} \sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor})|^2 \mathrm{d}t + 4\sqrt{\epsilon} \sup_{r \in [0,t_k]} \left(\int_0^r \langle b(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) - b(w^{\Delta,v}_{\lfloor t \rfloor}), \\ &\sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor})(W(t) - W(\lfloor t \rfloor)) \rangle \mathrm{d}t + \int_0^r \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), \sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) \mathrm{d}W(t) \rangle \Big) \\ &+ K \sup_{t \in [0,t_k]} |E^{\epsilon}(t)|^2 + 2\sqrt{\epsilon} \sup_{r \in [0,t_k]} \int_0^r \langle E^{\epsilon}(t), \sigma(y^{\Delta,v^{\epsilon}}_{\lfloor t \rfloor}) \mathrm{d}W(t) \rangle. \end{split}$$

Applying the Grönwall inequality and  $v^{\epsilon}(\cdot) \in \mathcal{P}_M$ , we arrive at

$$\begin{split} &\sup_{t\in[0,t_k]} |Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t)|^2 + \sup_{t\in[0,t_k]} |y^{\Delta,v^{\epsilon}}(\lfloor t \rfloor) - w^{\Delta,v}(\lfloor t \rfloor)|^2 \\ &\leq Ke^{K(M+1)t_k} \Big[\epsilon \int_0^{t_k} |\sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}})|^2 \mathrm{d}t + \sqrt{\epsilon} \sup_{r\in[0,t_k]} \Big(\int_0^r \langle b(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t \rfloor}^{\Delta,v}), \\ &\sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}})(W(t) - W(\lfloor t \rfloor)) \rangle \mathrm{d}t + \int_0^r \langle Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t), \sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) \mathrm{d}W(t) \rangle \Big) \\ &+ \sup_{t\in[0,t_k]} |E^{\epsilon}(t)|^2 + \sqrt{\epsilon} \sup_{r\in[0,t_k]} \int_0^r \langle E^{\epsilon}(t), \sigma(y_{\lfloor t \rfloor}^{\Delta,v^{\epsilon}}) \mathrm{d}W(t) \rangle \Big]. \end{split}$$

Utilizing Lemmas 5.1 and 5.2, the Burkholder–Davis–Gundy inequality, and the Young inequality, we obtain

$$\begin{split} & \mathbb{E}\Big[\sup_{t\in[0,t_k]}|y^{\Delta,v^{\epsilon}}(\lfloor t\rfloor) - w^{\Delta,v}(\lfloor t\rfloor)|^2 \wedge (e^{\mathfrak{a} t_k}\Delta^{-1})\Big] \\ &\leq Ke^{K(M+1)t_k}\bigg\{\epsilon\int_0^{t_k}\mathbb{E}[1+\|y_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}}\|^2]\mathrm{d} t + \sqrt{\epsilon}\int_0^{t_k}\mathbb{E}\Big[|b(y_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}}) - b(w_{\lfloor t\rfloor}^{\Delta,v})| \times \\ & |\sigma(y_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}})||W(t) - W(\lfloor t\rfloor)|\Big]\mathrm{d} t + \sqrt{\epsilon}\mathbb{E}\Big[\Big(\int_0^{t_k}|Z^{\Delta,v^{\epsilon}}(t) - z^{\Delta,v}(t)|^2|\sigma(y_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}})|^2\mathrm{d} t\Big)^{\frac{1}{2}}\Big] \\ & + \sup_{t\in[0,t_k]}\mathbb{E}\big[|E^{\epsilon}(t)|^2 \wedge (e^{\mathfrak{a} t_k}\Delta^{-1})\big] + \sqrt{\epsilon}\mathbb{E}\Big[\int_0^{t_k}|E^{\epsilon}(t)|^2|\sigma(y_{\lfloor t\rfloor}^{\Delta,v^{\epsilon}})|^2\mathrm{d} t\Big)^{\frac{1}{2}}\Big]\bigg\} \\ &\leq K(M)e^{K(M+1)t_k}\Big[(1+\|\xi\|^{2(\beta+1)}))(\epsilon+\sqrt{\epsilon}) + \mathbb{E}\big[\sup_{t\in[0,t_k]}|E^{\epsilon}(t)|^2 \wedge (e^{\mathfrak{a} t_k}\Delta^{-1})\big]\Big]. \end{split}$$

It follows from  $v^{\epsilon} \xrightarrow{d} v$  that  $\lim_{\epsilon \to 0} \mathbb{E} \left[ \sup_{t \in [0, t_k]} |E^{\epsilon}(t)|^2 \wedge (e^{\mathfrak{a}t_k} \Delta^{-1}) \right] = 0$ . Consequently, letting  $\epsilon \to 0$  finishes the proof.  $\Box$ 

# 5.2 Logarithmic estimate for numerical density function

This section is devoted to the logarithmic estimate on the finite time horizon for the density function of the  $\theta$ -EM method (5.2) of (5.1), based on the smoothness of the numerical

density function and the technique of the Malliavin calculus. The constant T > 0 is fixed in this section. For the numerical solution  $y^{\Delta,\epsilon}$ , under Assumptions 1.1, 4.1–4.3, it follows from Theorem 4.2 that for any  $\Delta \in (0, \frac{1}{4\theta a_5})$  and  $k \in \mathbb{N}_+$ ,  $y^{\Delta,\epsilon}(t_k)$  admits a density function denoted by  $\mathfrak{p}^{\Delta,\epsilon}(t_k, \cdot)$ . We introduce the following assumption to ensure the smoothness of  $\mathfrak{p}^{\Delta,\epsilon}(t_k, \cdot)$ .

**Assumption 5.1** Assume that coefficients b and  $\sigma$  are smooth with bounded derivatives of arbitrary orders.

The proof of the smoothness of the density  $\mathfrak{p}^{\Delta,\epsilon}(t_k,\cdot)$  depends on the estimate of the Malliavin covariance matrix  $\gamma_k^{\epsilon}$  of the numerical solution  $y_{t_k}^{\Delta,\epsilon}$  and the result that  $y_{t_k}^{\Delta,\epsilon} \in \mathbb{D}^{\infty}(\mathbb{R}^d)$ .

**Lemma 5.3** Let Assumptions 1.1, 4.1, 4.3 and 5.1 hold. Then for any  $p \ge 1$  and  $\Delta \in (0, \frac{1}{4\theta a_5}) \land (0, \frac{1}{4\theta \|\mathcal{D}b\|_{\mathcal{L}(C^d; \mathbb{R}^d)}}]$ ,

$$\|\det(\gamma_{N^{\Delta}}^{\epsilon})^{-1}\|_{L^{p}(\Omega)} \leq K\epsilon^{-d}\Delta^{-d}.$$

**Proof.** Since det $(\gamma_{N\Delta}^{\epsilon})^{-1} = \prod_{i=1}^{d} \lambda_i^{-1} \leq (\lambda_{\min}^{-1})^d$ , where  $\lambda_i, i = 1, \ldots, d$  are the eigenvalues of  $\gamma_{N\Delta}^{\epsilon}$  and  $\lambda_{\min} := \min\{\lambda_i, i = 1, \ldots, d\}$ , it suffices to estimate the smallest eigenvalue of  $\gamma_{N\Delta}^{\epsilon}$ . For the Malliavin covariance matrix  $\gamma_k^{\epsilon}$  of the numerical solution  $y^{\Delta,\epsilon}(t_k)$ , similar to the recursive relation (4.15), for any  $\Delta \in (0, \frac{1}{4\theta a_5})$ , using the equality

$$A_{1,N^{\Delta}-1}^{\epsilon} := (\mathrm{Id}_{d\times d} - \theta \mathcal{D}b(y_{t_{N^{\Delta}}}^{\Delta,\epsilon})I^{0}\Delta)^{-1} = \mathrm{Id}_{d\times d} + A_{1,N^{\Delta}-1}^{\epsilon}\theta \mathcal{D}b(y_{t_{N^{\Delta}}}^{\Delta,\epsilon})I^{0}\Delta,$$
(5.18)

we derive

$$\begin{split} \lambda_{\min}(\gamma_{N\Delta}^{\epsilon}) &= \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \gamma_{N\Delta}^{\epsilon} u \\ \geq \epsilon \Delta \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} A_{1,N\Delta-1}^{\epsilon} \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} (A_{1,N\Delta-1}^{\epsilon})^{\top} u \\ &= \epsilon \Delta \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \Big[ \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} + A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \\ \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} \Delta + \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} (A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \Delta)^{\top} \\ &+ A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \Delta \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} (A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \Delta)^{\top} \Big] u \\ \geq \frac{1}{2} \epsilon \Delta \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} u \\ &+ \epsilon \Delta \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \Big[ (\frac{1}{4} \mathrm{Id}_{d\times d} + A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \Delta)^{\top} \Big] u \\ \geq \frac{1}{2} \epsilon \Delta \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon}) \sigma(y_{t_{N\Delta-1}}^{\Delta,\epsilon})^{\top} u + \epsilon \Delta \sigma_{0} \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \Big( \frac{1}{2} \mathrm{Id}_{d\times d} \\ &+ A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0} \Delta + (A_{1,N\Delta-1}^{\epsilon} \theta \mathcal{D} b(y_{t_{N\Delta}}^{\Delta,\epsilon}) I^{0})^{\top} \Delta \Big) u \\ \geq \frac{1}{2} \epsilon \Delta \inf_{\phi \in \mathcal{C}^{d}} \min_{u \in \mathbb{R}^{d}, |u|=1} u^{\top} \sigma(\phi) \sigma(\phi)^{\top} u \end{split}$$

Large deviation principle of numerical solution

$$+\epsilon\Delta\sigma_0\min_{u\in\mathbb{R}^d,|u|=1}\left(\frac{1}{2}|u|^2-2|u|^2|A^{\epsilon}_{1,N^{\Delta}-1}\theta\mathcal{D}b(y^{\Delta,\epsilon}_{t_{N^{\Delta}}})I^0|\Delta\right)$$
(5.19)

$$\geq \frac{1}{2} \epsilon \Delta \sigma_0, \tag{5.20}$$

where we used Assumption 4.3, the fact  $\|A_{1,N^{\Delta}-1}^{\epsilon}\|_{\mathcal{L}(\mathbb{R}^{d};\mathbb{R}^{d})} \leq 1$  showed in the proof of Theorem 4.2, and the inequality  $2|A_{1,N^{\Delta}-1}^{\epsilon}\theta\mathcal{D}b(y_{t_{N^{\Delta}}}^{\Delta,\epsilon})I^{0}|\Delta \leq \frac{1}{2}$  for  $\Delta \in (0, \frac{1}{4\theta a_{5}}) \land (0, \frac{1}{4\theta \|\mathcal{D}b\|_{\mathcal{L}(\mathcal{C}^{d};\mathbb{R}^{d})})}]$ . This gives that  $\det(\gamma_{N^{\Delta}}^{\epsilon})^{-1} \leq (\frac{1}{2}\sigma_{0}\epsilon\Delta)^{-d}$ .

Similar to proofs of Lemmas 4.2 and 5.1 with  $\iota = 0$ , we obtain the following regularity estimates of  $y^{\Delta,\epsilon}$  and  $w^{\Delta,v}$ .

**Proposition 5.3** Under the conditions in Lemma 5.3, for any T > 0,  $p \in \mathbb{N}_+$ , and  $\Delta \in (0, \frac{1}{4\theta a_5})$ ,

$$\sup_{0 \le t_k \le T} |w^{\Delta,\epsilon}(t_k)|^{2p} \le K_T, \qquad \mathbb{E}\Big[\sup_{0 \le t_k \le T} |y^{\Delta,\epsilon}(t_k)|^{2p}\Big] \le K_T$$

Moreover, for  $n \in \mathbb{N}_+$ ,

$$\sup_{r_1,\dots,r_n\in[0,T]} \mathbb{E}\Big[\sup_{r_1\vee\cdots\vee r_n\leq t_k\leq T} |D_{r_1,\dots,r_n}y^{\Delta,\epsilon}(t_k)|^p\Big]\leq K_T.$$

Therefore,  $y^{\Delta,\epsilon}(t_k) \in \mathbb{D}^{\infty}(\mathbb{R}^d)$  for  $k = 1, 2, \dots, N^{\Delta}$ .

**Proposition 5.4** Under the conditions in Lemma 5.3, for any  $k \in \mathbb{N}_+$  and  $\Delta \in (0, \frac{1}{4\theta a_5}) \land (0, \frac{1}{4\theta \|\mathcal{D}b\|_{\mathcal{L}(\mathcal{C}^d; \mathbb{R}^d)}}]$ ,  $y^{\Delta, \epsilon}(t_k)$  admits a smooth density  $\mathfrak{p}^{\Delta, \epsilon}(t_k, \cdot)$ .

**Proof.** The proof follows from Lemma 5.3, Proposition 5.3, and [52, Theorem 2.1.4]. The limit of the logarithmic estimate on the finite time horizon of the numerical density function is closed related to the rate function of the LDP of  $\{y^{\Delta,\epsilon}(t)\}_{\epsilon \in (0,1)}$  for  $t \in [0,T]$ . To proceed, we list the LDPs of  $\{y^{\Delta,\epsilon}(\cdot)\}_{\epsilon \in (0,1)}$  and  $\{y^{\Delta,\epsilon}(t)\}_{\epsilon \in (0,1)}$  in the following proposition, whose proofs are similar to those of Theorem 5.1 and Corollary 5.1 and thus are omitted. Denote by  $\mathcal{C}_{\xi}([-\tau,T];\mathbb{R}^d)$  the space of all continuous functions  $u: [-\tau,T] \to \mathbb{R}^d$  with  $u(r) = \xi(r)$  for  $r \in [-\tau, 0]$ , endowed with the norm  $\|u\|_{\mathcal{C}_{\xi}([-\tau,T];\mathbb{R}^d)} := \sup_{t \in [-\tau,T]} |u(t)|$ .

**Proposition 5.5** Under the conditions in Lemma 5.3, it holds that:

(i) The family of random variables  $\{y^{\Delta,\epsilon}(\cdot)\}_{\epsilon \in (0,1)}$  satisfies the LDP in  $\mathcal{C}_{\xi}([-\tau,T];\mathbb{R}^d)$  with the good rate function given by

$$I_T(f) = \inf_{\{v \in L^2_{\Delta}([0,T];\mathbb{R}^m): f = \mathcal{G}^{\Delta}(\int_0^{\cdot} v(\lfloor s \rfloor) \mathrm{d}s)\}} \frac{1}{2} \int_0^T |v(\lfloor s \rfloor)|^2 \mathrm{d}s.$$

(ii) For any  $t \in [0,T]$ , the family of random variables  $\{y^{\Delta,\epsilon}(t)\}_{\epsilon \in (0,1)}$  satisfies the LDP in  $\mathbb{R}^d$  with the good rate function given by

$$\tilde{I}_t(z) = \inf\{I_T(f) : f \in \mathcal{C}_{\xi}([-\tau, T]; \mathbb{R}^d), z = f(t)\}.$$
(5.21)

Now we state our main result as follows.

**Theorem 5.2** Under the conditions in Lemma 5.3, for any  $k \in \mathbb{N}_+$  and sufficiently small  $\Delta > 0$ ,

$$\lim_{\epsilon \to 0} \epsilon \ln \mathfrak{p}^{\Delta,\epsilon}(t,y) = -\tilde{I}_t(y), \quad y \in \mathbb{R}^d.$$

We prove Theorem 5.2 by introducing the following equation

$$\begin{cases} y^{\Delta,\epsilon,v}(t_{k+1}) = y^{\Delta,\epsilon,v}(t_k) + (1-\theta)b(y_{t_k}^{\Delta,\epsilon,v})\Delta + \theta b(y_{t_{k+1}}^{\Delta,\epsilon,v})\Delta + \sqrt{\epsilon}\sigma(y_{t_k}^{\Delta,\epsilon,v})\delta W_k \\ + \sigma(y_{t_k}^{\Delta,\epsilon,v})v(t_k)\Delta, \quad k \in \mathbb{N}, \\ y^{\Delta,\epsilon,v}(t_k) = \xi(t_k), \quad k = -N, \dots, 0, \end{cases}$$

where  $y_{t_k}^{\Delta,\epsilon,v}$  is the linear interpolation with respect to  $y^{\Delta,\epsilon}(t_{k-N}), \ldots, y^{\Delta,\epsilon}(t_k)$ , and  $v \in L^2_{\Delta}$ . Define  $\mathbb{Z}^{\Delta,v}$  as follows:

$$\begin{cases} \mathbb{Z}^{\Delta,v}(t_{k+1}) = \mathbb{Z}^{\Delta,v}(t_k) + (1-\theta)\mathcal{D}b(w_{t_k}^{\Delta,v})\mathbb{Z}_{t_k}^{\Delta,v}\Delta + \theta\mathcal{D}b(w_{t_{k+1}}^{\Delta,v})\mathbb{Z}_{t_{k+1}}^{\Delta,v}\Delta + \mathcal{D}\sigma(w_{t_k}^{\Delta,v})\mathbb{Z}_{t_k}^{\Delta,v}v(t_k)\Delta + \sigma(w_{t_k}^{\Delta,v})\delta W_k, \quad k \in \mathbb{N}, \\ \mathbb{Z}^{\Delta,v}(t_k) = 0, \quad k = -N, \dots, 0, \end{cases}$$

where  $w^{\Delta,v}$  is the solution of (5.4).

Introduce the auxiliary processes associated to  $y^{\Delta,\epsilon,v}$  and  $\mathbb{Z}^{\Delta,v}$ , respectively as

$$\begin{cases} Z^{\Delta,\epsilon,v}(t_k) = \xi(t_k), \quad k = -N, \dots, -1, \\ Z^{\Delta,\epsilon,v}(t_k) = y^{\Delta,\epsilon,v}(t_k) - \theta b(y_{t_k}^{\Delta,\epsilon,v})\Delta, \quad k = 0, \\ Z^{\Delta,\epsilon,v}(t_{k+1}) = Z^{\Delta,\epsilon,v}(t_k) + b(y_{t_k}^{\Delta,\epsilon,v})\Delta + \sqrt{\epsilon}\sigma(y_{t_k}^{\Delta,\epsilon,v})\delta W_k \\ + \sigma(y_{t_k}^{\Delta,\epsilon,v})v(t_k)\Delta, \quad k \in \mathbb{N}, \end{cases}$$

and

$$\begin{aligned} \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) &= 0, \quad k = -N, \dots, -1, \\ \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) &= \mathbb{Z}^{\Delta,v}(t_k) - \theta \mathcal{D}b(w_{t_k}^{\Delta,v}) \mathbb{Z}_{t_k}^{\Delta,v} \Delta, \quad k = 0, \\ \widetilde{\mathbb{Z}}^{\Delta,v}(t_{k+1}) &= \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) + \mathcal{D}b(w_{t_k}^{\Delta,v}) \mathbb{Z}_{t_k}^{\Delta,v} \Delta + \mathcal{D}\sigma(w_{t_k}^{\Delta,v}) \mathbb{Z}_{t_k}^{\Delta,v} v(t_k) \Delta \\ &+ \sigma(w_{t_k}^{\Delta,v}) \delta W_k, \quad k \in \mathbb{N}. \end{aligned}$$

Moreover, define the continuous versions  $Z^{\Delta,\epsilon,v}(\cdot)$  and  $\widetilde{\mathbb{Z}}^{\Delta,v}(\cdot)$  by

$$Z^{\Delta,\epsilon,v}(t) := Z^{\Delta,\epsilon,v}(t_k) + b(y_{t_k}^{\Delta,\epsilon,v})(t-t_k) + \sqrt{\epsilon}\sigma(y_{t_k}^{\Delta,\epsilon,v})(W(t) - W(t_k)) + \sigma(y_{t_k}^{\Delta,\epsilon,v})v(t_k)(t-t_k),$$
$$\widetilde{Z}^{\Delta,v}(t) := \widetilde{Z}^{\Delta,v}(t_k) + \mathcal{D}b(w_{t_k}^{\Delta,v})\mathbb{Z}_{t_k}^{\Delta,v}(t-t_k) + \mathcal{D}\sigma(w_{t_k}^{\Delta,v})\mathbb{Z}_{t_k}^{\Delta,v}v(t_k)(t-t_k) + \sigma(w_{t_k}^{\Delta,v})(W(t) - W(t_k))$$

for  $t \in [t_k, t_{k+1})$  with  $k \in \mathbb{N}$ , and  $Z^{\Delta, \epsilon, v}(t) := \xi(t), \ \widetilde{\mathbb{Z}}^{\Delta, v}(t) := 0$  for  $t \in [-\tau, 0]$ .

Similar to the proof of Lemma 4.2, we obtain the following regularity estimates of  $y^{\Delta,\epsilon,v}$ .

**Proposition 5.6** Let Assumptions 1.1, 4.1, 4.3 and 5.1 hold. Then for any T > 0,  $p \in \mathbb{N}_+$ , and  $\Delta \in (0, \frac{1}{a\theta a_5})$ ,

$$\mathbb{E}\Big[\sup_{0\leq t_k\leq T}|y^{\Delta,\epsilon,v}(t_k)|^{2p}\Big]\leq K_T$$

Proof. [Proof of Theorem 5.2.] We first give the proof of

$$\limsup_{\epsilon \to 0} \epsilon \ln \mathfrak{p}^{\Delta,\epsilon}(t,y) \le -\tilde{I}_t(y).$$
(5.22)

By Lemma 5.3 and the boundedness of the *p*th moment of  $y^{\Delta,\epsilon}$ , we obtain

$$\|(\gamma_{N^{\Delta}}^{\epsilon})^{-1}\|_{L^{p}(\Omega)} \leq K \|\det(\gamma_{N^{\Delta}}^{\epsilon})^{-1}\|_{L^{2p}(\Omega)} \leq K \epsilon^{-d} \Delta^{-d}.$$

This, combining (5.21), Proposition 5.3, and [28, Proposition 4.1] finishes the proof of (5.22).

Next, we show that  $\liminf_{\epsilon \to 0} \epsilon \ln \mathfrak{p}^{\Delta,\epsilon}(t,y) \ge -\tilde{I}_t(y)$ , whose proof is divided into the following five steps.

<u>Step 1.</u> Prove that for any  $p \ge 1$  and  $\Delta \in (0, \frac{1}{8\theta a_5}] \land (0, \frac{1}{4\theta \|\mathcal{D}b\|_{\mathcal{L}(\mathcal{C}^d; \mathbb{R}^d)})}],$  $\lim_{\epsilon \to 0} \mathbb{E} \Big[ \sup_{0 \le k \le N^{\Delta}} |y^{\Delta, \epsilon, v}(t_k) - w^{\Delta, v}(t_k)|^p \Big] = 0.$ 

By the definitions of  $Z^{\Delta,\epsilon,v}$  and  $z^{\Delta,v}$ , we have that for  $p \ge 2$ ,

$$\begin{split} |Z^{\Delta,\epsilon,v}(t) - z^{\Delta,v}(t)|^p &\leq K \Big| \int_0^t b(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) - b(w_{\lfloor s \rfloor}^{\Delta,v}) \mathrm{d}s \Big|^p + K \Big| \int_0^t \sigma(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) v(\lfloor s \rfloor) \\ &- \sigma(w_{\lfloor s \rfloor}^{\Delta,v}) v(\lfloor s \rfloor) \mathrm{d}s \Big|^p + K \Big| \sqrt{\epsilon} \int_0^t \sigma(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) \mathrm{d}W(s) \Big|^p. \end{split}$$

It follows from the boundedness of derivatives of  $b,\,\sigma,$  and the Burkholder–Davis–Gundy inequality that

$$\begin{split} & \mathbb{E}\Big[\sup_{t\in[0,T]}|Z^{\Delta,\epsilon,v}(t)-z^{\Delta,v}(t)|^p\Big] \leq K_T \int_0^T \mathbb{E}[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}-w_{\lfloor s\rfloor}^{\Delta,v}\|^p]\mathrm{d}s + K_T \int_0^T \mathbb{E}[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}-w_{\lfloor s\rfloor}^{\Delta,v}\|^p]\mathrm{d}s + K_T \int_0^T \mathbb{E}[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^p]\mathrm{d}s \\ & -w_{\lfloor s\rfloor}^{\Delta,v}\|^p]\mathrm{d}s \Big(\int_0^T |v(\lfloor s\rfloor)|^2\mathrm{d}s\Big)^{\frac{p}{2}} + K_T \epsilon^{\frac{p}{2}} \int_0^T (1+\mathbb{E}[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^p])\mathrm{d}s \\ & \leq K_T \int_0^T \mathbb{E}[\sup_{r\in[0,s]} |y^{\Delta,\epsilon,v}(\lfloor r\rfloor)-w^{\Delta,v}(\lfloor r\rfloor)|^p]\mathrm{d}s + K_T \epsilon^{\frac{p}{2}} \int_0^T (1+\mathbb{E}[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^p])\mathrm{d}s. \end{split}$$

Moreover, we have

$$\begin{aligned} &|y^{\Delta,\epsilon,v}(t_{k+1}) - w^{\Delta,v}(t_{k+1})|^2 \le |Z^{\Delta,\epsilon,v}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^2 \\ &+ 2\theta\Delta\langle y^{\Delta,\epsilon,v}(t_{k+1}) - w^{\Delta,v}(t_{k+1}), b(y^{\Delta,\epsilon,v}_{t_{k+1}}) - b(w^{\Delta,v}_{t_{k+1}})\rangle \\ &\le |Z^{\Delta,\epsilon,v}(t_{k+1}) - z^{\Delta,v}(t_{k+1})|^2 + 4\theta a_5 \Delta \sup_{0 \le k \le N^{\Delta}} |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^2. \end{aligned}$$

By  $\Delta \leq \frac{1}{8\theta a_5}$ , we obtain

$$\sup_{0 \le k \le N^{\Delta}} |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^2 \le 2 \sup_{0 \le k \le N^{\Delta}} |Z^{\Delta,\epsilon,v}(t_k) - z^{\Delta,v}(t_k)|^2,$$
(5.23)

which implies that

$$\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}}|y^{\Delta,\epsilon,v}(t_k)-w^{\Delta,v}(t_k)|^p\Big]\leq K_T\int_0^T\mathbb{E}[\sup_{r\in[0,s]}|y^{\Delta,\epsilon,v}(\lfloor r\rfloor)-w^{\Delta,v}(\lfloor r\rfloor)|^p]\mathrm{d}s$$
$$+K_T\epsilon^{\frac{p}{2}}\int_0^T\left(1+\sup_{s\in[0,T]}E[\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^p]\right)\mathrm{d}s.$$

According to Proposition 5.6 and the Grönwall inequality, one has

$$\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}}|y^{\Delta,\epsilon,v}(t_k)-w^{\Delta,v}(t_k)|^p\Big]\leq K_T\epsilon^{\frac{p}{2}},$$

which finishes the proof of Step 1 by taking  $\epsilon \to 0$ .

<u>Step 2.</u> Prove that for any  $p \ge 1$ ,

$$\lim_{\epsilon \to 0} \mathbb{E} \Big[ \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k) - \mathbb{Z}^{\Delta,v}(t_k)|^p \Big] = 0,$$

where  $Y^{\Delta,\epsilon,v}(t_k) := \frac{1}{\sqrt{\epsilon}} (y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)).$ 

By the definitions of  $Z^{\Delta,\epsilon,v}(t), z^{\Delta,v}(t)$ , and  $\widetilde{\mathbb{Z}}^{\Delta,v}(t)$ , we arrive at

$$\frac{1}{\sqrt{\epsilon}}(Z^{\Delta,\epsilon,v}(t) - z^{\Delta,v}(t)) - \widetilde{\mathbb{Z}}^{\Delta,v}(t) = \mathscr{A}_1(t) + \mathscr{A}_2(t) + \mathscr{A}_3(t),$$

where

$$\begin{aligned} \mathscr{A}_{1}(t) &:= \int_{0}^{t} \Big[ \frac{1}{\sqrt{\epsilon}} \big( b(y_{\lfloor s \rfloor}^{\Delta, \epsilon, v}) - b(w_{\lfloor s \rfloor}^{\Delta, v}) \big) - \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta, v}) \mathbb{Z}_{\lfloor s \rfloor}^{\Delta, v} \Big] \mathrm{d}s, \\ \mathscr{A}_{2}(t) &:= \int_{0}^{t} \Big[ \frac{1}{\sqrt{\epsilon}} \big( \sigma(y_{\lfloor s \rfloor}^{\Delta, \epsilon, v}) v(\lfloor s \rfloor) - \sigma(w_{\lfloor s \rfloor}^{\Delta, v}) v(\lfloor s \rfloor) \big) - \mathcal{D}\sigma(w_{\lfloor s \rfloor}^{\Delta, v}) \mathbb{Z}_{\lfloor s \rfloor}^{\Delta, v} v(\lfloor s \rfloor) \Big] \mathrm{d}s, \\ \mathscr{A}_{3}(t) &:= \int_{0}^{t} \Big[ \sigma(y_{\lfloor s \rfloor}^{\Delta, \epsilon, v}) - \sigma(w_{\lfloor s \rfloor}^{\Delta, v}) \Big] \mathrm{d}W(s) =: \mathscr{A}_{1}(t) + \mathscr{A}_{2}(t) + \mathscr{A}_{3}(t). \end{aligned}$$

For the term  $\mathscr{A}_3$ , utilizing the Burkholder–Davis–Gundy inequality, we deduce that for  $p \geq 2$ ,

$$\mathbb{E}\Big[\sup_{t\leq T}|\mathscr{A}_{3}(t)|^{p}\Big] \leq K_{T}\mathbb{E}\Big[\int_{0}^{T}\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s\rfloor}^{\Delta,v}\|^{p}\mathrm{d}s\Big]$$
$$\leq K_{T}\int_{0}^{T}\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}}|y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})|^{p}\Big]\mathrm{d}s \leq K_{T}\epsilon^{\frac{p}{2}},$$

where in the last step we used Step 1.

For the term  $\mathscr{A}_1,$  by the Taylor formula, we obtain

$$b(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) - b(w_{\lfloor s \rfloor}^{\Delta,v}) = \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta,v})(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}) + \int_0^1 (1-\varsigma)\mathcal{D}^2b((1-\varsigma)w_{\lfloor s \rfloor}^{\Delta,v})$$

$$+ \varsigma y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) \mathrm{d}\varsigma (y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}, y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}),$$

which implies

$$\frac{1}{\sqrt{\epsilon}} \left( b(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) - b(w_{\lfloor s \rfloor}^{\Delta,v}) \right) - \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta,v}) \mathbb{Z}_{\lfloor s \rfloor}^{\Delta,v} \\
= \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta,v}) \left(Y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - \mathbb{Z}_{\lfloor s \rfloor}^{\Delta,v}) + \int_{0}^{1} (1-\varsigma) \mathcal{D}^{2}b((1-\varsigma)w_{\lfloor s \rfloor}^{\Delta,v} \\
+ \varsigma y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) d\varsigma \left(Y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}, y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}) \right).$$
(5.24)

It follows from the Hölder inequality, Assumption 5.1, and Step 1 that for  $p \ge 2$ ,

$$\begin{split} & \mathbb{E}\Big[\sup_{t\leq T}|\mathscr{A}_{1}(t)|^{p}\Big]\leq K_{T}\mathbb{E}\Big[\int_{0}^{T}\|Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}-\mathbb{Z}_{\lfloor s\rfloor}^{\Delta,v}\|^{p}+\|Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^{p}\|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}-w_{\lfloor s\rfloor}^{\Delta,v}\|^{p}\mathrm{d}s\Big]\\ &\leq K_{T}\int_{0}^{T}\mathbb{E}\Big[\sup_{r\leq s}|Y^{\Delta,\epsilon,v}(\lfloor r\rfloor)-\mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\Big]\mathrm{d}s+K_{T}\Big(\int_{0}^{T}\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}}|Y^{\Delta,\epsilon,v}(t_{k})|^{2p}\Big]\mathrm{d}s\Big)\\ &\times\int_{0}^{T}\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}}|y^{\Delta,\epsilon,v}(t_{k})-w^{\Delta,v}(t_{k})|^{2p}\Big]\mathrm{d}s\Big)^{\frac{1}{2}}\\ &\leq K_{T}\int_{0}^{T}\mathbb{E}\Big[\sup_{r\leq s}|Y^{\Delta,\epsilon,v}(\lfloor r\rfloor)-\mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\Big]\mathrm{d}s+K_{T}\epsilon^{\frac{p}{2}}. \end{split}$$

Similarly, for the term  $\mathscr{A}_2$ , by virtue of the Taylor formula and the Hölder inequality, we have that for  $p \geq 2$ ,

$$\begin{split} & \mathbb{E}\Big[\sup_{t\leq T} |\mathscr{A}_{2}(t)|^{p}\Big] \leq \mathbb{E}\Big[\Big(\int_{0}^{T} \left|\mathcal{D}\sigma(w_{\lfloor s\rfloor}^{\Delta,v})(Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - \mathbb{Z}_{\lfloor s\rfloor}^{\Delta,v}) + \int_{0}^{1}(1-\varsigma) \times \mathcal{D}^{2}\sigma((1-\varsigma)w_{\lfloor s\rfloor}^{\Delta,v} + \lambda y_{\lfloor s\rfloor}^{\Delta,\epsilon,v})d\varsigma(Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}, y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s\rfloor}^{\Delta,v})\Big||v(\lfloor s\rfloor)|ds\Big)^{p}\Big] \\ &\leq K_{T}\int_{0}^{T} \mathbb{E}\Big[\sup_{r\leq s} |Y^{\Delta,\epsilon,v}(\lfloor r\rfloor) - \mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\Big]ds\Big(\int_{0}^{T} |v(\lfloor s\rfloor)|^{2}ds\Big)^{\frac{p}{2}} \\ &+ K\Big(\int_{0}^{T} \mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_{k})|^{2p}\Big]ds\int_{0}^{T} \mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}} |y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})|^{2p}\Big]ds\Big)^{\frac{1}{2}}\Big(\int_{0}^{T} |v(\lfloor s\rfloor)|^{2}ds\Big)^{\frac{p}{2}} \\ &\leq K_{T}\int_{0}^{T} \mathbb{E}\Big[\sup_{r\leq s} |Y^{\Delta,\epsilon,v}(\lfloor r\rfloor) - \mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\Big]ds + K_{T}\epsilon^{\frac{p}{2}}. \end{split}$$

Combining estimates of terms  $\mathscr{A}_1, \mathscr{A}_2$ , and  $\mathscr{A}_3$ , we arrive at that for  $p \geq 2$ ,

$$\mathbb{E}\left[\sup_{t\leq T}\left|\frac{1}{\sqrt{\epsilon}}(Z^{\Delta,\epsilon,v}(t)-z^{\Delta,v}(t))-\widetilde{\mathbb{Z}}^{\Delta,v}(t)\right|^{p}\right] \\
\leq K_{T}\int_{0}^{T}\mathbb{E}\left[\sup_{r\leq s}|Y^{\Delta,\epsilon,v}(\lfloor r\rfloor)-\mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\right]\mathrm{d}s+K_{T}\epsilon^{\frac{p}{2}}.$$
(5.25)

Noting that

$$\left|\frac{1}{\sqrt{\epsilon}}(Z^{\Delta,\epsilon,v}(t_k) - z^{\Delta,v}(t_k)) - \widetilde{\mathbb{Z}}^{\Delta,v}(t_k)\right|^2 \\ \ge \left|\frac{1}{\sqrt{\epsilon}}(y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)) - \mathbb{Z}^{\Delta,v}(t_k)\right|^2 - 2\theta\Delta\left\langle\frac{1}{\sqrt{\epsilon}}(y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k))\right\rangle$$

$$-\mathbb{Z}^{\Delta,v}(t_k), \frac{1}{\sqrt{\epsilon}}(b(y_{t_k}^{\Delta,\epsilon,v}) - b(w_{t_k}^{\Delta,v})) - \mathcal{D}b(w_{t_k}^{\Delta,v})\mathbb{Z}_{t_k}^{\Delta,v}\Big\rangle,$$

we derive from (5.24), Assumption 5.1, and the Young inequality that for  $\Delta \leq \frac{1}{8\theta a_5}$ ,

$$\begin{split} & \left| \frac{1}{\sqrt{\epsilon}} (y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)) - \mathbb{Z}^{\Delta,v}(t_k) \right|^2 \\ & \leq \left| \frac{1}{\sqrt{\epsilon}} (Z^{\Delta,\epsilon,v}(t_k) - z^{\Delta,v}(t_k)) - \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) \right|^2 + 5\theta a_5 \Delta \sup_{0 \leq k \leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)| \\ & - \mathbb{Z}^{\Delta,v}(t_k)|^2 + K \Delta \sup_{0 \leq k \leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^2 |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^2. \end{split}$$

This indicates

$$\begin{split} \sup_{0 \le k \le N^{\Delta}} & \left| Y^{\Delta,\epsilon,v}(t_k) - \mathbb{Z}^{\Delta,v}(t_k) \right|^2 \\ \le 3 \sup_{0 \le k \le N^{\Delta}} & \left| \frac{1}{\sqrt{\epsilon}} (Z^{\Delta,\epsilon,v}(t_k) - z^{\Delta,v}(t_k)) - \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) \right|^2 \\ & + K \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^2 |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^2, \end{split}$$

which together with (5.25), and Propositions 5.3 and 5.6, yields that for  $p \ge 2$ ,

$$\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}} \left| Y^{\Delta,\epsilon,v}(t_{k}) - \mathbb{Z}^{\Delta,v}(t_{k}) \right|^{p} \Big] \\
\leq K_{T} \int_{0}^{T} \mathbb{E}\Big[\sup_{r\leq s} |Y^{\Delta,\epsilon,v}(\lfloor r \rfloor) - \mathbb{Z}^{\Delta,v}(\lfloor r \rfloor)|^{p} \Big] \mathrm{d}s + K_{T}\epsilon^{\frac{p}{2}} \\
+ K\Big(\mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_{k})|^{2p} \Big] \mathbb{E}\Big[\sup_{0\leq k\leq N^{\Delta}} |y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})|^{2p} \Big]\Big)^{\frac{1}{2}} \\
\leq K_{T} \int_{0}^{T} \mathbb{E}\Big[\sup_{r\leq s} |Y^{\Delta,\epsilon,v}(\lfloor r \rfloor) - \mathbb{Z}^{\Delta,v}(\lfloor r \rfloor)|^{p} \Big] \mathrm{d}s + K_{T}\epsilon^{\frac{p}{2}}.$$

Applying the Gröwall inequality completes the proof of  $\underline{\text{Step 2}}$ .

Large deviation principle of numerical solution

$$\leq K_T \int_0^T \mathbb{E}\Big[\sup_{r\leq s} |D_{\alpha}y^{\Delta,\epsilon,v}(\lfloor r \rfloor)|^p\Big] \mathrm{d}s + K\epsilon^{\frac{p}{2}} (1 + \mathbb{E}[\|y_{\lfloor \alpha \rfloor}^{\Delta,\epsilon,v}\|^p]).$$

Moreover, similar to the proof of (5.23), we have

$$\sup_{0 \le k \le N^{\Delta}} |D_{\alpha} y^{\Delta,\epsilon,v}(t_k)|^2 \le 2 \sup_{0 \le k \le N^{\Delta}} |D_{\alpha} Z^{\Delta,\epsilon,v}(t_k)|^2,$$

which together with the Grönwall inequality finishes the proof of Step 3.

Step 4. Prove that for any  $p \ge 1$  and sufficiently small  $\Delta > 0$ ,

$$\lim_{\epsilon \to 0} \mathbb{E} \Big[ \sup_{\alpha \le t_k \le T} |D_{\alpha} Y^{\Delta, \epsilon, v}(t_k) - D_{\alpha} \mathbb{Z}^{\Delta, v}(t_k)|^p \Big] = 0.$$

Since  $D_{\alpha} \widetilde{\mathbb{Z}}^{\Delta, v}$  satisfies

we derive from (5.26) that

$$\frac{1}{\sqrt{\epsilon}}D_{\alpha}Z^{\Delta,\epsilon,v}(t) - D_{\alpha}\widetilde{\mathbb{Z}}^{\Delta,v}(t) = \widetilde{\mathscr{A}}_{1}(t) + \widetilde{\mathscr{A}}_{2}(t) + \widetilde{\mathscr{A}}_{3}(t) + \widetilde{\mathscr{A}}_{4}(t),$$

where

$$\begin{split} \tilde{\mathscr{A}}_{1}(t) &:= \int_{0}^{t} \Big( \frac{1}{\sqrt{\epsilon}} \mathcal{D}b(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) D_{\alpha} y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta,v}) D_{\alpha} \mathbb{Z}_{\lfloor s \rfloor}^{\Delta,v} \Big) \mathrm{d}s, \\ \tilde{\mathscr{A}}_{2}(t) &:= \int_{0}^{t} \Big( \frac{1}{\sqrt{\epsilon}} \mathcal{D}\sigma(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) D_{\alpha} y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - \mathcal{D}\sigma(w_{\lfloor s \rfloor}^{\Delta,v}) D_{\alpha} \mathbb{Z}_{\lfloor s \rfloor}^{\Delta,v} \Big) v(\lfloor s \rfloor) \mathrm{d}s, \\ \tilde{\mathscr{A}}_{3}(t) &:= (\sigma(y_{\lfloor \alpha \rfloor}^{\Delta,\epsilon,v}) - \sigma(w_{\lfloor \alpha \rfloor}^{\Delta,v})) \mathbf{1}_{[0,t]}(\alpha), \\ \tilde{\mathscr{A}}_{4}(t) &:= \int_{0}^{t} \mathcal{D}\sigma(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) D_{\alpha} y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} \mathrm{d}W(s). \end{split}$$

By the Taylor formula, we obtain

$$(\mathcal{D}b(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) - \mathcal{D}b(w_{\lfloor s \rfloor}^{\Delta,v})) D_{\alpha}y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} = \mathcal{D}^{2}b(w_{\lfloor s \rfloor}^{\Delta,v})(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}, D_{\alpha}y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) + \int_{0}^{1} \mathcal{D}^{3}b((1-\varsigma)w_{\lfloor s \rfloor}^{\Delta,v} + \varsigma y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}) \mathrm{d}\varsigma(y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}, y_{\lfloor s \rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s \rfloor}^{\Delta,v}, D_{\alpha}y_{\lfloor s \rfloor}^{\Delta,\epsilon,v}).$$

$$\begin{split} & \mathbb{E}\Big[\sup_{t\leq T} |\tilde{\mathscr{A}}_{1}(t)|^{p}\Big] = \mathbb{E}\Big[\sup_{t\leq T} \Big| \int_{0}^{t} \frac{1}{\sqrt{\epsilon}} (\mathcal{D}b(y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}) - \mathcal{D}b(w_{\lfloor s\rfloor}^{\Delta,v})) D_{\alpha}y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} \\ &+ \mathcal{D}b(w_{\lfloor s\rfloor}^{\Delta,v}) (\frac{1}{\sqrt{\epsilon}} D_{\alpha}y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - D_{\alpha}\mathbb{Z}_{\lfloor s\rfloor}^{\Delta,v}) \mathrm{d}s\Big|^{p}\Big] \\ &\leq K_{T} \int_{0}^{T} \mathbb{E}\Big[ \|Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^{p} \|D_{\alpha}y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^{p} + \|Y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^{p} \|y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - w_{\lfloor s\rfloor}^{\Delta,v}\|^{p} \|D_{\alpha}y_{\lfloor s\rfloor}^{\Delta,\epsilon,v}\|^{p} \\ &+ \|\frac{1}{\sqrt{\epsilon}} D_{\alpha}y_{\lfloor s\rfloor}^{\Delta,\epsilon,v} - D_{\alpha}\mathbb{Z}_{\lfloor s\rfloor}^{\Delta,v}\|^{p} \Big] \mathrm{d}s \end{split}$$

$$\leq K_T \Big( \mathbb{E} \Big[ \sup_{0 \leq k \leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^{2p} \Big] \mathbb{E} \Big[ \sup_{0 \leq k \leq N^{\Delta}} |D_{\alpha}y^{\Delta,\epsilon,v}(t_k)|^{2p} \Big] \Big)^{\frac{1}{2}} \\ + K_T \Big( \mathbb{E} \Big[ \sup_{0 \leq k \leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^{2p} \Big] \Big)^{\frac{1}{2}} \Big( \mathbb{E} \Big[ \sup_{0 \leq k \leq N^{\Delta}} |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^{4p} \Big] \times \\ \mathbb{E} \Big[ \sup_{0 \leq k \leq N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^{4p} \Big] \Big)^{\frac{1}{4}} \\ + K_T \int_0^T \mathbb{E} \Big[ \sup_{r \leq s} |\frac{1}{\sqrt{\epsilon}} D_{\alpha}y^{\Delta,\epsilon,v}(\lfloor r \rfloor) - D_{\alpha}\mathbb{Z}^{\Delta,v}(\lfloor r \rfloor)|^p \Big] \mathrm{d}s.$$

Similarly,

$$\mathbb{E}\left[\sup_{t\leq T}\left|\frac{1}{\sqrt{\epsilon}}D_{\alpha}Z^{\Delta,\epsilon,v}(t) - D_{\alpha}\widetilde{Z}^{\Delta,v}(t)\right|^{p}\right] \leq K_{T}\left(\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}|Y^{\Delta,\epsilon,v}(t_{k})|^{2p}\right]\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}|D_{\alpha}y^{\Delta,\epsilon,v}(t_{k})|^{2p}\right]\right)^{\frac{1}{2}}$$
(5.27)  

$$+ K_{T}\left(\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}|Y^{\Delta,\epsilon,v}(t_{k})|^{2p}\right]\right)^{\frac{1}{2}}\left(\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}|y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})|^{4p}\right]\times\right]$$

$$\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}|Y^{\Delta,\epsilon,v}(t_{k})|^{4p}\right]\right)^{\frac{1}{4}} + K_{T}\int_{0}^{T}\mathbb{E}\left[\sup_{r\leq s}\left|\frac{1}{\sqrt{\epsilon}}D_{\alpha}y^{\Delta,\epsilon,v}(\lfloor r\rfloor)\right| - D_{\alpha}\mathbb{Z}^{\Delta,v}(\lfloor r\rfloor)|^{p}\right]ds + \mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}\left|y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})\right|^{p}\right] + K_{T}\int_{0}^{T}\mathbb{E}\left[\sup_{0\leq k\leq N^{\Delta}}\left|D_{\alpha}y^{\Delta,\epsilon,v}(t_{k})\right|^{p}\right]ds.$$
(5.28)

Moreover, we have

$$\begin{split} \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} y^{\Delta,\epsilon,v}(t_k) - D_{\alpha} \mathbb{Z}^{\Delta,v}(t_k) \right|^2 &\leq \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} Z^{\Delta,\epsilon,v}(t_k) - D_{\alpha} \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) \right|^2 \\ &+ 2\theta \Delta \left| \mathcal{D}b(y_{t_k}^{\Delta,\epsilon,v}) \frac{1}{\sqrt{\epsilon}} D_{\alpha} y_{t_k}^{\Delta,\epsilon,v} - \mathcal{D}b(w_{t_k}^{\Delta,v}) D_{\alpha} \mathbb{Z}_{t_k}^{\Delta,v} \right|^2, \end{split}$$

According to the Taylor formula, we have

$$\sup_{0 \le k \le N^{\Delta}} \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} y^{\Delta,\epsilon,v}(t_k) - D_{\alpha} \mathbb{Z}^{\Delta,v}(t_k) \right|^2$$
$$\leq \sup_{0 \le k \le N^{\Delta}} \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} Z^{\Delta,\epsilon,v}(t_k) - D_{\alpha} \widetilde{\mathbb{Z}}^{\Delta,v}(t_k) \right|^2$$

$$+ K\Delta \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^2 |D_{\alpha}y^{\Delta,\epsilon,v}(t_k)|^2 + K\Delta \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_k)|^2 |y^{\Delta,\epsilon,v}(t_k) - w^{\Delta,v}(t_k)|^2 |D_{\alpha}y^{\Delta,\epsilon,v}(t_k)|^2 + 4\theta\Delta \|^2 \mathcal{D}b\|_{\mathcal{L}(\mathcal{C}^d;\mathbb{R}^d)} \sup_{0 \le k \le N^{\Delta}} \left|\frac{1}{\sqrt{\epsilon}} D_{\alpha}y^{\Delta,\epsilon,v}(t_k) - D_{\alpha}\mathbb{Z}^{\Delta,v}(t_k)\right|^2.$$

Then, for sufficiently small  $\Delta$ ,

$$\begin{split} \sup_{0 \le k \le N^{\Delta}} \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} y^{\Delta,\epsilon,v}(t_{k}) - D_{\alpha} \mathbb{Z}^{\Delta,v}(t_{k}) \right|^{2} \\ \le K \sup_{0 \le k \le N^{\Delta}} \left| \frac{1}{\sqrt{\epsilon}} D_{\alpha} Z^{\Delta,\epsilon,v}(t_{k}) - D_{\alpha} \widetilde{\mathbb{Z}}^{\Delta,v}(t_{k}) \right|^{2} \\ + K\Delta \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_{k})|^{2} |D_{\alpha} y^{\Delta,\epsilon,v}(t_{k})|^{2} \\ + K\Delta \sup_{0 \le k \le N^{\Delta}} |Y^{\Delta,\epsilon,v}(t_{k})|^{2} |y^{\Delta,\epsilon,v}(t_{k}) - w^{\Delta,v}(t_{k})|^{2} |D_{\alpha} y^{\Delta,\epsilon,v}(t_{k})|^{2}. \end{split}$$

Making use of (5.27), the Grönwall inequality and Steps 1–3 finishes the proof of Step 4.

Step 5. Prove that for any  $p \ge 1$ ,  $l \in \mathbb{N}_+$ , and sufficiently small  $\Delta > 0$ ,

$$\lim_{\epsilon \to 0} \mathbb{E} \Big[ \sup_{\alpha_1 \lor \cdots \lor \alpha_l \le t_k \le T} |D_{\alpha_1 \cdots \alpha_l} Y^{\Delta, \epsilon, v}(t_k) - D_{K \cdots \alpha_l} \mathbb{Z}^{\Delta, v}(t_k)|^p \Big] = 0.$$

The case of l = 1 is proved in <u>Step 4</u>, and the case of l > 1 can be proved by the induction argument on l. We omit the proof.

Combining Steps 1–5, and according to [28, Proposition 5.1], we obtain

$$\liminf_{\epsilon \to 0} \epsilon \ln \mathfrak{p}^{\Delta,\epsilon}(t,y) \ge -\tilde{d}_t(y)$$

with  $\tilde{d}_t(y) := \inf\{I_T(f) : f \in \mathcal{C}_{\xi}([-\tau, T]; \mathbb{R}^d), y = f(t), \det(\bar{\gamma}_{w^{\Delta, v}(t)}) > 0\}$ , where  $\bar{\gamma}_{\Phi(v)} = (\langle \mathscr{D}(\Phi(v))^i, \mathscr{D}(\Phi(v))^j \rangle_H)_{1 \le i,j \le d}$  with functional  $\Phi : L^2([0, T]; \mathbb{R}^m) \to \mathbb{R}^d$ .

At last, we show that  $\tilde{I}_t = \tilde{d}_t$ , which is equivalent to prove that  $\det(\bar{\gamma}_{w^{\Delta,v}(t)}) > 0$  for each  $t \in (0,T]$ . Noticing

$$\mathcal{D}_{\alpha}w^{\Delta,v}(t_{k+1}) = \mathcal{D}_{\alpha}w^{\Delta,v}(t_{k}) + (1-\theta)\mathcal{D}b(w_{t_{k}}^{\Delta,v})\mathcal{D}_{\alpha}w_{t_{k}}^{\Delta,v}\Delta + \theta\mathcal{D}b(w_{t_{k+1}}^{\Delta,v})\mathcal{D}_{\alpha}w_{t_{k+1}}^{\Delta,v}\Delta + \mathcal{D}\sigma(w_{t_{k}}^{\Delta,v})v(t_{k})\Delta + \sigma(w_{t_{k}}^{\Delta,v})\mathbf{1}_{[t_{k},t_{k+1})}(\alpha)\Delta,$$

the proof of  $\det(\bar{\gamma}_{w^{\Delta,v}(t)}) > 0$  is similar to that of Theorem 4.2 and is omitted. Hence the proof of Theorem 5.2 is finished.  $\Box$ 

### 5.3 Summary and outlook

This chapter investigates the LDP for the  $\theta$ -EM method of the SFDE. For the SFDE with small noise, under the superlinearly growing drift coefficient condition, we first present
the Freidlin–Wentzell LDP for the  $\theta$ -EM solution on the infinite time horizon. In fact, the exact solution of the considered equation can also be proved to satisfy the LDP by the approach used in this chapter. Natural questions arise: What is the relation between rate functions for the numerical solution case and the exact solution case? How to apply the result on the LDP of the  $\theta$ -EM method to solving some problems in statistics, engineering, statistical mechanics, and applied probability?

Another result obtained in this chapter is the logarithmic estimate for the density function of the  $\theta$ -EM solution provided that drift and diffusion coefficients of the SFDE are smooth and have arbitrary order bounded derivatives. The relation between the logarithmic limit and the rate function of the LDP is given. It would be interesting to further study the logarithmic estimate for the numerical density function for the SFDE with superlinearly growing coefficients.
