# FIRST EIGENVALUE OF JACOBI OPERATOR AND RIGIDITY RESULTS FOR CONSTANT MEAN CURVATURE HYPERSURFACES

ABSTRACT. In this paper, we obtain geometric upper bounds for the first eigenvalue  $\lambda_1^J$  of the Jacobi operator for both closed and compact with boundary hypersurfaces having constant mean curvature (CMC). As an application, we derive new rigidity results for the area of CMC hypersurfaces under suitable conditions on  $\lambda_1^J$  and the curvature of the ambient space. We also address the Jacobi-Steklov problem, proving geometric upper bounds for its first eigenvalue  $\sigma_1^J$  and deriving rigidity results related to the length of the boundary. Additionally, we present some results in higher dimensions related to the Yamabe invariants.

#### 1. Introduction

In the context of the theory of minimal surfaces, stable surfaces or those of index one play a very special role. For instance, the well-known theorem by Schoen and Yau [29] states that if  $\Sigma$  is a closed orientable stable minimal surface in a Riemannian manifold  $M^3$  with non-negative scalar curvature, then  $\Sigma$  is either a sphere or a torus. Moreover, infinitesimal rigidity is verified when  $\Sigma$  is a torus.

The stability index of a minimal surface can be defined as the number of negative eigenvalues of the Jacobi operator J associated with  $\Sigma$ . Geometrically, this index corresponds to the number of linearly independent normal directions in which infinitesimal variations result in a decrease in area. Indeed, controlling the index well often leads to a better understanding of the surface's geometry.

In this setting, it becomes natural to investigate geometric relationships involving the eigenvalues of J, in particular the first non-zero eigenvalue, denoted by  $\lambda_1^J$ . In [26], Perdomo obtained an estimate for  $\lambda_1^J$  for minimal surfaces in the sphere  $\mathbb{S}^3$ , along with a rigidity result in the case of equality. More precisely, he demonstrated that if  $\Sigma$  is a compact, oriented minimal surface that is not totally geodesic in  $\mathbb{S}^3$ , then the first eigenvalue of the Jacobi operator,  $\lambda_1^J$ , satisfies  $\lambda_1^J \leq -4$ . Furthermore,  $\lambda_1^J$  equals -4 if and only if  $\Sigma$  is isometric to the Clifford torus  $\mathbb{S}^1\left(\frac{1}{\sqrt{2}}\right) \times \mathbb{S}^1\left(\frac{1}{\sqrt{2}}\right) \subset \mathbb{S}^3$ .

From this work, several other estimates for  $\lambda_1^J$  have been obtained, but always in the case of closed submanifolds. We cite, for example, the works [1, 2, 10, 11, 12, 13, 24, 33], to name a few. We highlight the work of the first name author and Santos in [6], where they obtained general estimates for  $\lambda_1^J$  of closed constant mean curvature (CMC) surfaces, assuming only a bound on the curvature of the ambient manifold.

In this paper, we obtain new rigidity results for both closed and compact free boundary surfaces  $\Sigma \subset M$  with constant mean curvature, and involving the first eigenvalue  $\lambda_1^J$ . Our results are related with some previous classical results, as for instance [4, 7, 25]. We recall that a CMC free-boundary surfaces are critical points for the area functional among volume-preserving variations that preserve the boundary  $\partial \Sigma$  within  $\partial M$ . Notably,  $\partial \Sigma$  intersects  $\partial M$  orthogonally. In this context, we obtain the following result.

**Theorem 1.1.** Let  $M^3$  be a Riemannian manifold with Ricci curvature  $\operatorname{Ric}_M \geq 2$  and convex boundary in the sense that its second fundamental form satisfies  $\Pi^{\partial M} \geq 0$ . Let  $\Sigma^2 \subset M^3$  be an immersed and orientable surface with constant mean curvature and free boundary in M. If  $\lambda_1^J \geq -2$ , then  $\Sigma$  has genus 0, a single connected boundary component, and  $|\Sigma| \leq 2\pi$ . If equality holds, then  $\Sigma$  is isometric to  $\mathbb{S}^2_+$ . Moreover, if the Gaussian curvature of the boundary satisfies  $K_{\partial M} \geq 1$ , then  $M^3$  is isometric to  $\mathbb{S}^3_+$ .

This theorem follows from a general geometric inequality for the first eigenvalue  $\lambda_1^J$ , as proved in Theorems 2.3 and 2.4. In the rigidity part, we use the Hang-Wang Theorem [20].

In the case of surfaces without boundary, immersed in manifolds with nonnegative scalar curvature, we get:

**Theorem 1.2.** Let  $M^3$  be a Riemannian manifold with scalar curvature  $S \geq 0$ . Let  $\Sigma^2 \subset M^3$  be a closed, immersed, and orientable surface with constant mean curvature  $H \geq 2$  and  $\lambda_1^J \geq -2$ . Then  $\Sigma$  has genus 0 and  $|\Sigma| \leq 4\pi$ .

Furthermore, if equality holds, then  $\Sigma$  is isometric to the unit sphere, and  $M^3$  contains a subset isometric to the unit Euclidean ball whose boundary is  $\Sigma$ .

We obtain a similar result in the case of scalar curvature bounded from below by a negative constant:

**Theorem 1.3.** Let  $M^3$  be a Riemannian manifold with scalar curvature  $S \geq -6$ . Let  $\Sigma^2 \subset M^3$  be an immersed, closed, and orientable surface with constant mean curvature  $H \geq 2\sqrt{2}$  and  $\lambda_1^J \geq -2$ . Then  $\Sigma$  has genus 0 and  $|\Sigma| \leq 4\pi$ .

Furthermore, if equality holds, then  $\Sigma$  is isometric to a sphere, and  $M^3$  contains a subset isometric to the unit ball in hyperbolic space  $\mathbb{H}^3$ .

We also derive theorems that holds in higher dimensions.

**Theorem 1.4.** Let  $M^{n+1}$  be a closed orientable Riemannian manifold with scalar curvature  $S \geq n(n+1)$ , and let  $\Sigma^n \subset M^{n+1}$  be a closed, immersed, orientable hypersurface with constant mean curvature H. If  $\lambda_1^J \geq -n$ , then

(1.1) 
$$n(n-1)|\Sigma| \le \int_{\Sigma} S_{\Sigma} dA.$$

Moreover, the equality holds if, and only if,  $\Sigma$  is totally geodesic,  $S|_{\Sigma} = n(n+1)$ , and Ric(N,N) = n.

Furthermore, in the equality case with  $K_M \geq 1$  and either

- (1) n is even, or
- (2) n is odd and  $\Sigma$  is simply connected,

then  $M^{n+1}$  is isometric to  $\mathbb{S}^{n+1}$  with the canonical metric.

In the case of hypersurfaces with boundary, we introduce a new eigenvalue problem, namely the Jacobi-Steklov problem, which utilizes the Jacobi operator instead of the Laplacian operator (see Section 4 for details). We denote the first eigenvalue of this problem by  $\sigma_1^J$  and provide upper estimates for  $\sigma_1^J$  in terms similar to those we obtained for  $\lambda_1^J$  (See Theorem 4.2).

As a consequence of our estimates and inspired by Mendes Theorem (see [23, Theorem 1.4]), we obtain the following rigidity theorem for the length of the boundary  $\partial \Sigma$ . In the rigidity part, we used a recent result by Mazet and Mendes [22].

**Theorem 1.5.** Let  $M^3$  be a Riemannian manifold with a non-empty boundary such that  $\mathrm{Ric}_M \geq 0$  and  $\mathrm{II}^{\partial M} \geq g\big|_{\partial M}$ . Let  $\Sigma^2 \subset M^3$  be an immersed and orientable surface with constant mean curvature and free boundary such that  $\sigma_1^J \geq -1$ . Then,  $\Sigma$  has genus 0, a single connected boundary component, and  $|\partial \Sigma| \leq 2\pi$ .

Furthermore, if equality holds,  $\Sigma$  is isometric to the disk  $\mathbb{D}$  and  $M^3$  is isometric to the unit ball  $\mathbb{B}^3 \subset \mathbb{R}^3$ .

We also obtain the following estimate in higher dimensions. Here  $H^{\partial \Sigma, \Sigma}$  denotes the mean curvature of  $\partial \Sigma$  as a hypersurface of  $\Sigma$ .

**Theorem 1.6.** Let  $(M^{n+1}, g)$  be a compact orientable Riemannian manifold with scalar curvature  $S \geq 0$  and mean curvature of the boundary  $H^{\partial M} \geq n$ . Let  $\Sigma^n \subset M^{n+1}$  be a compact, immersed, orientable hypersurface with constant mean curvature and free boundary. If  $\sigma_1^J \geq -1$ , then,

(1.2) 
$$2(n-1)|\partial \Sigma| \le \int_{\Sigma} S_{\Sigma} dA + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} da.$$

Moreover, equality holds if and only if  $\Sigma$  is totally geodesic,  $\operatorname{Ric}_M(N,N) = 0$ ,  $\operatorname{II}^{\partial M}(N,N) = 1$ , and  $S|_{\Sigma} = 0$ . In particular,  $S_{\Sigma} = 0$  and  $H^{\partial \Sigma,\Sigma} = n-1$ . Furthermore, assuming  $K_M \geq 0$ ,  $\operatorname{II}^{\partial M} \geq g|_{\partial M}$ , and the equality in (1.2), then  $\Sigma$  is isometric to  $\mathbb{B}^n$  and M is isometric to  $\mathbb{B}^{n+1}$ .

To conclude this paper, in Section 5 inspired in the work of Cai and Galloway [8] we present some geometric relations involving the eigenvalues  $\lambda_1^J$  and  $\sigma_1^J$  with the Yamabe invariants for manifolds with boundary introduced by Escobar in [16, 17].

### 2. The First Eigenvalue of the Jacobi Operator

Let  $M^{n+1}$  be an orientable Riemannian manifold with a (possibly empty) smooth boundary, and let  $\Sigma$  be a two-sided compact hypersurface with constant mean curvature, immersed in  $M^{n+1}$ . We denote by N the unit normal field along  $\Sigma$ .

If  $\partial \Sigma \neq \emptyset$ , we assume that  $\partial \Sigma$  intersects  $\partial M$  orthogonally. In such case,  $\Sigma$  is a critical point of the area functional for variations that maintain the boundary of  $\Sigma$  within the boundary of M, and it is referred as a free-boundary hypersurface. Moreover, denoting  $\nu$  as the unit conormal vector along  $\partial \Sigma$ , the formula for the second variation (see [27]) is given by the quadratic form

$$\mathcal{I}(\phi, \rho) = -\int_{\Sigma} \phi J \rho \, dv + \int_{\partial \Sigma} \phi \left\{ \frac{\partial \rho}{\partial \nu} - \Pi^{\partial M}(N, N) \rho \right\} da,$$

where  $J = \Delta + \operatorname{Ric}_M(N, N) + |A|^2$  is the Jacobi operator of  $\Sigma$  and  $\operatorname{II}^{\partial M}$  denotes the second fundamental form of  $\partial M$ . Here  $\operatorname{Ric}_M$  stands for the Ricci curvature of M, and A is the shape operator of  $\Sigma$ .

We say that  $\rho \in C^{\infty}(\Sigma)$  is an eigenfunction of the Jacobi operator associated with the eigenvalue  $\lambda^J$ , if  $\rho$  is not identically zero and solves the Robin type boundary problem

(2.1) 
$$\begin{cases} J\rho + \lambda^{J}\rho = 0, & \text{in } \Sigma, \\ \frac{\partial\rho}{\partial\nu} = \Pi^{\partial M}(N,N)\rho, & \text{on } \partial\Sigma. \end{cases}$$

Note that this is equivalent to saying that  $\mathcal{I}(\rho,\phi) = \lambda^J \langle \rho, \phi \rangle_{L^2(\Sigma)}$ , for every  $\phi \in C^{\infty}(\Sigma)$ . From standard elliptic theory, we know that the eigenvalues of the problem (2.1) are given by a diverging sequence denoted by

$$\lambda_1^J < \lambda_2^J \le \lambda_3^J \le \dots \nearrow \infty.$$

We recall that the index of  $\Sigma$  is defined as the number of negative eigenvalues,  $\lambda_k^J$ . In other words, it is the maximal dimension of a linear subspace V in  $C^{\infty}(\Sigma)$  for which  $\mathcal{I}(\rho,\rho) < 0$  for all  $\rho \in V \setminus \{0\}$ . This index is an important geometric invariant of  $\Sigma$ . For further details and significant results related to this topic, we refer to [3, 9, 27, 28].

The first eigenvalue  $\lambda_1^J$  can be obtained variationally by the Rayleigh formula

(2.2) 
$$\lambda_1^J = \inf_{\phi \in C^{\infty}(\Sigma) \setminus \{0\}} \frac{\mathcal{I}(\phi, \phi)}{\int_{\Sigma} \phi^2 dv}.$$

In particular,

$$\lambda_1^J \le \frac{\int_{\Sigma} |\nabla \phi|^2 - (\operatorname{Ric}_M(N, N) + |A|^2) \phi^2 \, dv - \int_{\partial \Sigma} \operatorname{II}^{\partial M}(N, N) \phi^2 \, da}{\int_{\Sigma} \phi^2 \, dv},$$

for every  $\phi \in C^{\infty}(\Sigma) \setminus \{0\}$ .

Remark 2.1. It is important to observe that all the above facts still hold if we are considering a hypersurface  $\Sigma$  without boundary, just omitting the boundary terms.

Tracing twice the Gauss equation we get the Schoen-Yau trick (cf. [29]), that is, the Ricci curvature in the normal direction can be written as

(2.3) 
$$\operatorname{Ric}_{M}(N,N) = \frac{1}{2}(S - S_{\Sigma} + H^{2} - |A|^{2}),$$

where  $H = \operatorname{tr} A$  is the mean curvature of  $\Sigma$ , S is the scalar curvature of M and  $S_{\Sigma}$  is the scalar curvature of  $\Sigma$ .

Let us assume that  $\Sigma$  is a two dimensional surface immersed in  $M^3$ . In this case, the Gauss curvature is given by  $K_{\Sigma} = \frac{1}{2}S_{\Sigma}$ . We will take the test function  $\phi = 1$  in the variational characterization (2.2) of  $\lambda_1^J$  (see [29, Teorema 5.1]). Thus, using the equation (2.3) we have

$$\lambda_1^J \leq \frac{\mathcal{I}(1,1)}{\int_{\Sigma} 1 \, dv} = -\frac{\int_{\Sigma} \left( \operatorname{Ric}_M(N,N) + |A|^2 \right) \, dv + \int_{\partial \Sigma} \operatorname{II}^{\partial M}(N,N) \, da}{|\Sigma|}$$
$$= -\frac{1}{2|\Sigma|} \int_{\Sigma} \left( S - 2K_{\Sigma} + H^2 + |A|^2 \right) \, dv - \frac{1}{|\Sigma|} \int_{\partial \Sigma} \left( H^{\partial M} - \kappa \right) \, da,$$

where  $H^{\partial M} = \operatorname{tr} \Pi^{\partial M}$  is mean curvature of  $\partial M$  in M,  $\kappa = \langle \nabla_T \nu, T \rangle = \Pi^{\partial M}(T,T)$  is the geodesic curvature of  $\partial \Sigma$  in  $\Sigma$  and T is a unit vector tangent to  $\partial \Sigma$ .

Finally, using the Gauss-Bonnet Theorem, we have

$$(2.4) \quad \lambda_1^J \le -\frac{1}{2|\Sigma|} \int_{\Sigma} \left( S + H^2 + |A|^2 \right) \, dv - \frac{1}{|\Sigma|} \int_{\partial \Sigma} H^{\partial M} \, da + \frac{2\pi \chi(\Sigma)}{|\Sigma|}.$$

Note that if  $\rho$  is a first eigenfunction, using (2.1) and the Gauss equation (2.3), we have that

(2.5) 
$$\Delta \rho = -\left(\lambda_1^J + \operatorname{Ric}_M(N, N) + |A|^2\right) \rho$$
$$= -\left(\lambda_1^J + \frac{1}{2}S - \frac{1}{2}S_{\Sigma} + \frac{1}{2}H^2 + \frac{1}{2}|A|^2\right) \rho.$$

The following lemma is well-known among experts, but we include a proof here for the completeness of our work. This result will be fundamental in characterizing the equality in our estimates.

**Lemma 2.2.** Assume there exists  $\rho \in C^{\infty}(\Sigma) \setminus \{0\}$  such that  $\mathcal{I}(\rho, \rho) = \lambda_1^J \int_{\Sigma} \rho^2 dv$ . Then,  $\rho$  is an eigenfunction of  $\mathcal{I}$  associated with the eigenvalue  $\lambda_1^J$ .

*Proof.* Given  $\phi \in C^{\infty}(\Sigma)$ , consider the function

$$f(t) := \mathcal{I}(\rho + t\phi, \rho + t\phi) - \lambda_1^J \int_{\Sigma} (\rho + t\phi)^2 dv, \quad t \in \mathbb{R}.$$

From the definition of  $\lambda_1^J$ , it follows that  $f(t) \geq 0$  for all  $t \in \mathbb{R}$ . Moreover, by hypothesis, f(0) = 0, and therefore, t = 0 is a global minimum point of f. Hence,

$$0 = f'(0) = 2\mathcal{I}(\rho, \phi) - 2\lambda_1^J \int_{\Sigma} \rho \phi \, dv.$$

That is, for every  $\phi \in C^{\infty}(\Sigma)$ , we have

$$-\int_{\Sigma} \phi J \rho \, dv + \int_{\partial \Sigma} \phi \left\{ \frac{\partial \rho}{\partial \nu} - \Pi^{\partial M}(N, N) \rho \right\} da = \lambda_1^J \int_{\Sigma} \rho \phi \, dv.$$

In particular, taking functions  $\phi \in C^{\infty}(\Sigma)$  with compact support inside  $\Sigma$ , we conclude that  $-J\rho = \lambda_1^J \rho$  and thus

$$\int_{\partial \Sigma} \phi \left\{ \frac{\partial \rho}{\partial \nu} - \Pi^{\partial M}(N, N) \rho \right\} da = 0,$$

for  $\phi \in C^{\infty}(\Sigma)$ . And once again, by the arbitrariness of  $\phi \in C^{\infty}(\Sigma)$ , we conclude that

$$\frac{\partial \rho}{\partial \nu} - \mathrm{II}^{\partial M}(N, N)\rho = 0,$$

and therefore  $\rho$  is an eigenfunction associated with the eigenvalue  $\lambda_1^J$ .

Using this terminology, we obtain the following estimate for  $\lambda_1^J$  with infinitesimal rigidity in the case of equality.

**Theorem 2.3.** Let  $M^3$  be a Riemannian manifold with boundary such that the scalar curvature and the mean curvature of the boundary satisfy  $\inf S =$  $a > -\infty$  and inf  $H^{\partial M} = b > -\infty$ , respectively. Let  $\Sigma^2 \subset M^3$  be a compact two-sided surface with constant mean curvature H and free boundary. Then

$$\lambda_1^J \leq -\frac{1}{2} \left( \frac{3}{2} H^2 + a \right) - b \frac{|\partial \Sigma|}{|\Sigma|} + \frac{2\pi \chi(\Sigma)}{|\Sigma|}.$$

Moreover, equality holds if and only if the following conditions occur:

- (1)  $\Sigma$  is totally umbilical and the geodesic curvature of  $\partial \Sigma$  in  $\Sigma$  is constant and equal to b.
- (2)  $S|_{\Sigma} = a$ ,  $H^{\partial M}|_{\partial \Sigma} = b$ , and K is constant. (3)  $\operatorname{Ric}_{M}(N, N) = -\lambda_{1}^{J} \frac{1}{2}H^{2}$  and  $\operatorname{II}^{\partial M}(N, N) = 0$  along  $\partial \Sigma$ .

*Proof.* From the inequality (2.4), along with the assumptions  $a \leq S$ ,  $b \leq S$  $H^{\partial M}$  and the fact that  $|A|^2 \geq \frac{1}{2}H^2$ , we have

$$\begin{split} \lambda_1^J &\leq -\frac{1}{2|\Sigma|} \int_{\Sigma} \left(S + H^2 + |A|^2\right) dv - \frac{1}{|\Sigma|} \int_{\partial \Sigma} H^{\partial M} da + \frac{2\pi\chi(\Sigma)}{|\Sigma|} \\ &\leq -\frac{1}{2|\Sigma|} \int_{\Sigma} \left(a + \frac{3H^2}{2}\right) dv - b \frac{|\partial \Sigma|}{|\Sigma|} + \frac{2\pi\chi(\Sigma)}{|\Sigma|} \\ &\leq -\frac{a}{2} - \frac{3H^2}{4} - b \frac{|\partial \Sigma|}{|\Sigma|} + \frac{2\pi\chi(\Sigma)}{|\Sigma|}. \end{split}$$

Furthermore, if equality occurs, then equality holds in all the inequalities we used. In particular,  $|A|^2 = \frac{1}{2}H^2$  and we have that  $\Sigma$  is totally umbilical. We also have that

$$\lambda_1^J = \frac{\mathcal{I}(1,1)}{\int_{\Sigma} 1 dv}$$

and thus, by Lemma 2.2, the constant function 1 is an eigenfunction associated with  $\lambda_1^L$ . Specifically,  $S|_{\Sigma} = a$ ,  $H^{\partial M}|_{\partial \Sigma} = b$ , and by (2.5) we have that  $\mathrm{Ric}_M(N,N) = -\lambda_1^J - \frac{1}{2}H^2$  and  $K_{\Sigma}$  is constant equal to  $a/2 + 3H^2/4 + \lambda_1^J$ . Again, by (2.1) we have that  $\mathrm{II}(N,N) = 0$  and therefore  $\mathrm{II}(T,T) = H^{\partial M}|_{\partial \Sigma} = b$ . The converse is immediate.

Next, by making a less refined estimate, we obtain a stricter constraint in the case of equality. More precisely:

**Theorem 2.4.** Under the same conditions as Theorem 2.3, we have

$$\lambda_1^J \leq -\frac{1}{2}(H^2+a) - \frac{b}{|\Sigma|}|\partial \Sigma| + \frac{2\pi\chi(\Sigma)}{|\Sigma|}.$$

Moreover, equality holds if, and only if,

- (1)  $\Sigma$  is totally geodesic and  $\partial \Sigma$  consists of geodesics of  $\partial M$ , and the geodesic curvature of  $\partial \Sigma$  in  $\Sigma$  is constant and equal to b.
- (2)  $S|_{\Sigma} = a$ ,  $H^{\partial M}|_{\partial \Sigma} = b$ , and K is constant. (3)  $Ric_M(N,N) = -\lambda_1^J$  and  $II^{\partial M}(N,N) = 0$  along  $\partial \Sigma$ .

Proof. The proof follows in the same manner as the previous theorem, but using the estimate  $|A|^2 \geq 0$ . In the case of equality, it follows that  $\Sigma$  is totally geodesic.

Furthermore, since  $\Sigma$  is totally geodesic and N is the normal vector of  $\partial \Sigma$  in  $\partial M$ , it follows that the geodesic curvature of  $\partial \Sigma$  in  $\partial M$ , given by  $\langle -\nabla_T N, T \rangle$ , is zero, where T is the unit tangent vector to  $\partial \Sigma$ . The converse is immediate.

We point out that the results in this present paper also hold in the case of manifolds with density (see [18] for a good introduction to this subject). In particular, in the case of surfaces without boundary (see Remark 2.1), we reobtain the main result in [6]. For constant density, the results read as follows.

Corollary 2.5 (Batista-Santos [6]). Let  $(M^3, g)$  be a Riemannian manifold without boundary such that inf  $S \ge a > -\infty$ . Let  $\Sigma^2 \subset M^3$  be a closed surface with constant mean curvature H. Then, the first eigenvalue  $\lambda_1^J$  satisfies

$$\lambda_1^J \le -\frac{1}{2}(H^2 + a) + \frac{2\pi\chi(\Sigma)}{|\Sigma|}.$$

Moreover, equality holds if and only if  $\Sigma$  is totally geodesic,  $S|_{\Sigma} = a$ , and  $K_{\Sigma}$  is constant.

# 3. RIGIDITY RESULTS FOR THE AREA OF CMC SURFACES

In this section, as an application of our estimates for  $\lambda_1^J$ , we present the proofs of the area rigidity results for constant mean curvature surfaces, as cited in the Introduction.

We need the following characterization of the hemisphere of the 2-sphere. Although it is essentially proved in [20], we include the proof here for the sake of completeness.

**Lemma 3.1.** Let  $(\Sigma^2, g)$  be a compact, orientable Riemannian surface with genus 0, constant Gaussian curvature equal to 1, and totally geodesic boundary. Then  $\Sigma$  is isometric to  $\mathbb{S}^2_+$ .

Proof. From the Gauss-Bonnet formula, we conclude that  $\Sigma$  is simply connected, in particular,  $\partial \Sigma^2$  has only one component. Thus, using the Riemann Mapping Theorem , it follows that we can consider  $(\Sigma^2,g)$  as  $(\overline{B},g=e^{2u}|dz|^2)$ , where  $\overline{B}=\{z\in\mathbb{C};|z|\leq 1\}$  and  $|dz|^2$  is the canonical metric. Since  $(\overline{B},g=e^{2u}|dz|^2)$  has curvature 1 and the boundary is a convex circle, it can be isometrically embedded as a domain of the sphere  $\mathbb{S}^2$  (see [20, Theorem 4]). As the boundary is totally geodesic, we conclude that  $(\overline{B},g=e^{2u}|dz|^2)$  is isometric to a hemisphere.

#### 3.1. Proof of Theorem 1.1.

*Proof.* By assumption, we can apply Theorem 2.4 with  $a \ge 6$  and  $b \ge 0$ . Writing  $\chi(M) = 2 - 2g - r$ , where g is the genus of  $\Sigma$  and r is the number of connected components of the boundary, we have:

$$\lambda_1^J \le -\frac{1}{2} \left(H^2 + 6\right) + \frac{2\pi \left(2 - 2g - r\right)}{|\Sigma|},$$

and therefore,

$$-2 \le \lambda_1^J \le -3 + \frac{2\pi (2 - 2g - r)}{|\Sigma|} \le -3 + \frac{2\pi}{|\Sigma|},$$

which proves our area estimate.

If equality holds, then by Theorem 2.4,  $\Sigma$  is totally geodesic, has constant Gaussian curvature equal to 1, and the geodesic curvature of  $\partial \Sigma$  is zero. By Lemma 3.1,  $\Sigma$  is isometric to  $\mathbb{S}^2_+$  and  $\partial \Sigma$  is isometric to a circle of radius 1.

Furthermore, if the Gaussian curvature of  $\partial M$  is  $K_{\partial M} \geq 1$  and contains geodesic which is a circle of radius 1, by Topogonov theorem [31] (see also

[20, Corollary 1]) we have that  $\partial M = \mathbb{S}^2$ . Now Hang-Wang theorem [20, Theorem 2] implies that M is isometric to the hemisphere  $\mathbb{S}^3_+$ .

#### 3.2. Proof of Theorem 1.2.

*Proof.* By Theorem 2.3, we have

$$\lambda_1^J \leq -\frac{1}{2} \left( \frac{3}{2} H^2 + a \right) + \frac{2\pi \chi(\Sigma)}{|\Sigma|}.$$

Given that  $S \ge a = 0$ ,  $H \ge 2$ , and  $\lambda_1^J \ge -2$ , we obtain

(3.1) 
$$-2 \le \lambda_1^J \le -3 + \frac{4\pi}{|\Sigma|}$$

and the estimate follows.

If equality occurs, then H=2 and  $\Sigma$  is an immersed surface, totally umbilical with constant Gaussian curvature K=1 and genus 0. Therefore, it is isometric to  $\mathbb{S}^2$ . It follows from the Hang-Wang Theorem [19] that the region bounded by  $\Sigma$  is isometric to the unit Euclidean ball.

### 3.3. Proof of Theorem 1.3.

*Proof.* As in the previous theorem, we have

$$\lambda_1^J \le -\frac{1}{2} \left( \frac{3}{2} H^2 + a \right) + \frac{2\pi(2 - 2g)}{|\Sigma|},$$

and given that  $S \geq a = -6, H \geq 2\sqrt{2}$ , and  $\lambda_1^J \geq -2$ , we obtain

(3.2) 
$$-2 \le \lambda_1^J \le -3 + \frac{4\pi}{|\Sigma|}.$$

If equality occurs, then  $H = 2\sqrt{2}$  and  $\Sigma$  is totally umbilical with constant Gaussian curvature K = 1 and genus 0. Therefore, it is isometric to  $\mathbb{S}^2$ . It follows by Shi and Tam theorem, see [30, Theorem 3.8], that the region bounded by  $\Sigma$  is isometric to the unit hyperbolic ball.

## 3.4. Proof of Theorem 1.4.

*Proof.* Taking  $\phi = 1$  in the variational characterization of  $\lambda_1^J$  and using the Gauss equation as given by (2.3), we obtain

$$\lambda_1^J \leq -\frac{\int_{\Sigma} \left( \operatorname{Ric}(N, N) + |A|^2 \right) dv}{|\Sigma|}$$
$$= -\frac{1}{2|\Sigma|} \int_{\Sigma} \left( S - S_{\Sigma} + H^2 + |A|^2 \right) dv.$$

Given the condition on the first eigenvalue and the hypothesis on the scalar curvature  $S \ge n(n+1)$ , we have

$$(3.3) -n \le \lambda_1 \le -\frac{n(n+1)}{2} + \frac{1}{2} \frac{\int_{\Sigma} S_{\Sigma} dv}{|\Sigma|},$$

which proves the inequality.

The equality holds if, and only if,  $\Sigma$  is totally geodesic, the scalar curvature of M along  $\Sigma$  is constant and equal to  $S|_{\Sigma} = n(n+1)$ , and  $\mathrm{Ric}(N,N) = n$ .

If we further assume that  $K_M \geq 1$ . For n even, we use Synge theorem and the orientability of  $\Sigma$  with the Gauss equation to deduce that  $\Sigma$  is isometric to the round sphere  $\mathbb{S}^n$ . For n odd and  $\Sigma$  simply connected, then the Gauss equation implies that  $\Sigma$  is also isometric to the round sphere  $\mathbb{S}^n$ . In particular,  $\Sigma$  is embedded.

Under the previous conclusions, we have that  $M \setminus \Sigma$  consists of two connected components, say  $\Omega_1$  and  $\Omega_2$  (see [21]). Now, applying Hang-Wang theorem [20, Theorem 2] to each of these components, we conclude that  $\Omega_1 = \Omega_2 = \mathbb{S}_+^{n+1}$ , and the desired result follows.

#### 4. The Jacobi-Steklov Problem

In this section we consider the Steklov problem associated with the Jacobi operator of a free boundary hypersurface  $\Sigma$  in  $M^{n+1}$ . More precisely, we say that  $\rho \in C^{\infty}(\Sigma)$  is a *Steklov eigenfunction* associated with the Jacobi operator with eigenvalue  $\sigma$  if it solves the boundary value problem

(4.1) 
$$\begin{cases} J\rho = 0, & \text{in } \Sigma, \\ B\rho = \sigma\rho, & \text{on } \partial\Sigma, \end{cases}$$

where J is the Jacobi operator and  $B = \partial_{\nu} - \Pi^{\partial M}(N, N)$  is the boundary term operator in the second variation formula of the area (cf. Section 2).

Note that this is equivalent to saying that

$$\mathcal{I}(\rho,\phi) = \sigma \langle \rho, \phi \rangle_{L^2(\partial \Sigma)},$$

for all  $\phi \in C^{\infty}(\Sigma)$ .

Similarly to the eigenvalue problem for the Jacobi operator, the Steklov eigenvalues of problem (4.1) form a divergent sequence

$$\sigma_1^J \le \sigma_2^J \le \sigma_3^J \dots \nearrow \infty$$

and the first eigenvalue can be characterized variationally as

(4.2) 
$$\sigma_1^J = \inf_{\phi \in C^{\infty}(\Sigma) \setminus \{0\}} \frac{\mathcal{I}(\phi, \phi)}{\int_{\partial \Sigma} \phi^2 da}.$$

We also have the characterization of the first eigenfunctions, analogous to what we did for the first eigenvalue of the Jacobi operator. The proof follows exactly the same scheme as Lemma 2.2, and will be omitted.

**Lemma 4.1.** Suppose there exists  $\rho \in C^{\infty}(\Sigma) \setminus \{0\}$  such that  $\mathcal{I}(\rho, \rho) = \sigma_1^J \int_{\partial \Sigma} \rho^2 da$ . Then,  $\rho$  is an eigenfunction of problem (4.1) associated with eigenvalue  $\sigma_1^J$ .

We have the following estimate for the first eigenvalue  $\sigma_1^J$ :

**Theorem 4.2.** Let  $M^3$  be a Riemannian manifold with boundary such that  $a = \inf S$  and  $b = \inf H^{\partial M}$  are finite. Let  $\Sigma^2 \subset M^3$  be a compact two-sided surface with constant mean curvature H and free boundary. Then

(4.3) 
$$\sigma_1^J \le -\left(\frac{a}{2} + \frac{3}{4}H^2\right) \frac{|\Sigma|}{|\partial \Sigma|} + \frac{2\pi\chi(\Sigma)}{|\partial \Sigma|} - b.$$

Moreover, equality holds if, and only if,

- (1)  $\Sigma$  is totally umbilical and has constant Gaussian curvature.

(2) 
$$S|_{\Sigma} = a$$
,  $H^{\partial M}|_{\partial \Sigma} = b$ .  
(3)  $\operatorname{Ric}_{M}(N, N) = -\frac{1}{2}H^{2}$  along  $\Sigma$  and  $\operatorname{II}^{\partial M}(N, N) = -\sigma_{1}^{J}$  along  $\partial \Sigma$ .

*Proof.* Taking the function  $\phi = 1$  in the variational characterization of  $\sigma_1^J$ and using the Gauss equation and Gauss-Bonnet theorem, we have

$$\sigma_{1}^{J}|\partial\Sigma| \leq -\int_{\Sigma} \left\{ \left( \operatorname{Ric}_{M}(N,N) + |A|^{2} \right) \right\} dv - \int_{\partial\Sigma} \operatorname{II}^{\partial M}(N,N) da$$

$$= -\frac{1}{2} \int_{\Sigma} \left( S - 2K_{\Sigma} + H^{2} + |A|^{2} \right) dv - \int_{\partial\Sigma} \left( H^{\partial M} - \kappa \right) da$$

$$\leq -\frac{1}{2} (a + \frac{3}{2} H^{2}) |\Sigma| + 2\pi \chi(\Sigma) - b |\partial\Sigma|.$$

If equality holds, then all the inequalities are equalities. In particular,  $\Sigma$  is totally umbilical, and by Lemma 4.1, the function  $\phi = 1$  is an eigenfunction, and therefore satisfies the problem (4.1). Thus, we have  $Ric_M(N,N)$  +  $H^2/2 = 0$  and  $\sigma_1^J = -\mathrm{II}^{\partial M}(N, N)$ . The converse is immediate. 

# 4.1. Proof of Theorem 1.5.

*Proof.* Since  $II^{\partial M} \geq 1$ , it follows that  $b = \inf H^{\partial M} \geq 2$ . Therefore, using inequality (4.3), we have

$$-1 \le \sigma_1^J \le \frac{2\pi\chi(\Sigma)}{|\partial\Sigma|} - 2,$$

which proves the first part.

If  $|\partial \Sigma| = 2\pi$ ,  $\chi(\Sigma) = 1$ , that is, r = 1 and g = 0. Moreover, the geodesic curvature of the boundary  $\partial \Sigma$  is  $\kappa = \langle \nabla_T \nu, T \rangle = \Pi^{\partial M}(T,T) = 1$ , which impliest that  $K_{\Sigma} = 0$ . Thus,  $\Sigma$  is isometric to the disk  $\mathbb{D}$ . Moreover,  $\partial \Sigma$  is a simple closed geodesic of  $\partial M$ , since  $\langle \nabla_T N, T \rangle = A(T,T) = 0$ . We are in conditions to apply Mazet-Mendes Theorem [22, Theorem 5.1] and conclude the result.

# 4.2. Proof of Theorem 1.6.

*Proof.* We first observe that we can derive an estimate for  $\sigma_1^J$  in higher dimensions using the equation (2.3). Specifically,

$$(4.4) \sigma_1^J |\partial \Sigma| \le -\frac{1}{2} \int_{\Sigma} \left( S - S_{\Sigma} + H^2 + |A|^2 \right) dv - \int_{\partial \Sigma} \Pi^{\partial M}(N, N) da.$$

Now, recall that  $H^{\partial \Sigma, \Sigma}$  denotes the mean curvature of  $\partial \Sigma$  as a hypersurface of  $\Sigma$ . Since  $\Sigma$  is free-boundary, we have  $H^{\partial M} = H^{\partial \Sigma, \Sigma} + \Pi^{\partial M}(N, N)$ . So, inequality (1.2) follows directly from (4.4) and our assumptions.

If equality holds, then we have directly that  $\Sigma$  is totally geodesic,  $S|_{\Sigma} = 0$ ,  $H^{\partial M} = n$ , and  $\phi = 1$  is an eigenfunction. Thus, using (4.1), we have  $\mathrm{Ric}_M(N,N) = 0$  and  $\mathrm{II}^{\partial M}(N,N) = 1$ , and so  $H^{\partial \Sigma,\Sigma} = n-1$ .

Furthermore, if  $K_M \geq 0$  and  $\Pi^{\partial M} \geq g|_{\partial \Sigma}$ , then  $K_{\Sigma} = 0$  and  $\Pi^{\partial \Sigma, \Sigma} = g|_{\partial \Sigma}$ . Therefore, we can use the exponential map to construct an isometry between a star-shaped domain in the tangent space and  $\Sigma$ . In particular,  $\Sigma$  and  $\partial \Sigma$  are simply connected. By the Gauss equation, the sectional curvature of  $\partial \Sigma$  is constant equal to one, and thus we conclude that  $\partial \Sigma$  is isometric to  $\mathbb{S}^{n-1}$  and  $\Sigma$  is isometric to the ball  $\mathbb{B}^n$  by Xia's theorem [32].

Using again  $K_M \geq 0$  and  $\Pi^{\partial M} \geq g | \partial M$ , and the Gauss equation, we obtain that  $\operatorname{Ric}_{\partial M} \geq ng$ . Given that  $\Sigma$  is a free boundary hypersurface and the previous conclusions, we have that  $\partial \Sigma$  in  $\partial M$  is a totally geodesic round sphere, which divides  $\partial M$  into two components  $\Omega_+$  and  $\Omega_-$  that are isometric to  $\mathbb{S}^n_+$  by the Hang-Wang theorem (see [20, Theorem 2]). Therefore,  $\partial M$  is isometric to  $\mathbb{S}^n$  and, applying again Xia's theorem, we obtain the desired result.

Remark 4.3. We observe that we can also apply the Mazet-Mendes theorem [22] to conclude the rigidity in the theorem above.

Remark 4.4. It is an interesting problem to obtain the rigidity part in Theorem 1.6 under a condition on the Ricci curvature.

#### 5. Estimates involving the Yamabe invariants

It is noteworthy that the first eigenvalue of the Jacobi operator,  $\lambda_1^J$ , and the first eigenvalue of the Jacobi-Steklov problem,  $\sigma_1^J$ , for hypersurfaces with boundary are related to the Yamabe invariants. These geometric invariants were introduced by Escobar in [14] and [15], and play a crucial role in solving the Yamabe Problem with boundary.

Let  $(\Sigma^n, g)$  be a compact Riemannian manifold with boundary  $\partial \Sigma$  and dimension  $n \geq 3$ . Following Escobar [15], we define the functional

$$Q_g(\varphi) = \frac{\int_{\Sigma} \left( a_n |\nabla \varphi|^2 + S_{\Sigma} \varphi^2 \right) dv + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} \varphi^2 da}{\left( \int_{\Sigma} \varphi^{\frac{2n}{n-2}} dv \right)^{\frac{n-2}{n}}},$$

where  $\varphi$  is a non-zero smooth function on  $\Sigma$ , and  $a_n = \frac{4(n-1)}{n-2}$ .

The first Yamabe constant for manifolds with boundary is then defined as

$$Q_g(\Sigma) = \inf_{\varphi \in C^{\infty}(\Sigma) \setminus \{0\}} Q_g(\varphi).$$

It is not difficult to see that  $Q_g(\Sigma)$  is invariant under conformal changes, and therefore, depends only on the conformal class [g] of g (cf. [15]). Moreover, we have that  $Q_g(\Sigma) \leq Q_g(\mathbb{S}_+^n)$ .

The first Yamabe invariant of  $\Sigma$  is the supremum of the Yamabe constants over all conformal classes. That is,

$$\sigma(\Sigma) = \sup_{[g] \in \mathcal{C}(\Sigma)} Q_g(\Sigma),$$

where  $C(\Sigma)$  is the space of all conformal classes of  $\Sigma$ . Note that, by definition,  $\sigma(\Sigma)$  is a differentiable invariant of  $\Sigma$ .

Armed with these new invariants, we have the following result, which can be viewed as a boundary version of [8, Theorem 6] due to Cai and Galloway.

**Theorem 5.1.** Let  $(M^{n+1}, g)$  be an orientable Riemannian manifold with boundary,  $n \geq 3$ , with scalar curvature  $S \geq a$ , and mean-convex boundary,  $H^{\partial M} \geq 0$ . Let  $\Sigma^n \subset M^{n+1}$  be a compact, orientable hypersurface with constant mean curvature H and free boundary.

If 
$$\sigma(\Sigma) < 0$$
, then  $2\lambda_1^J + a + H^2 < 0$  and

(5.1) 
$$|\Sigma| \ge \left(\frac{\sigma(\Sigma)}{2\lambda_1^J + a + H^2}\right)^{\frac{n}{2}}.$$

Moreover, the equality in (5.1) holds if and only if  $\sigma(\Sigma) = Q_g(1)$ ,  $\Sigma$  is totally geodesic in M,  $S|_{\Sigma} = a$ ,  $H^{\partial M}|_{\partial \Sigma} = 0$ ,  $II^{\partial M}(N,N)|_{\partial \Sigma} = 0$ , and  $Ric_M(N,N) = -\lambda_1^J$ . In particular,  $S_{\Sigma} = a + 2\lambda_1^J < 0$ ,  $H^{\partial \Sigma,\Sigma} = 0$ , and  $(\Sigma,g|_{\Sigma})$  is Einstein with totally geodesic boundary.

*Proof.* Using the variational characterization of  $\lambda_1^J$  given in (2.2), and noting that  $a_n = \frac{4(n-1)}{n-2} > 2$ , and using our assumptions about the curvatures, we have that

$$\begin{split} 2\lambda_1^J \int_{\Sigma} \varphi^2 dv & \leq & 2 \int_{\Sigma} \left\{ |\nabla \varphi|^2 - \left( \mathrm{Ric}_M(N,N) + |A|^2 \right) \varphi^2 \right\} dv \\ & - 2 \int_{\partial \Sigma} \mathrm{II}^{\partial M}(N,N) \varphi^2 da \\ & \leq & \int_{\Sigma} \left\{ a_n |\nabla \varphi|^2 - \left( S - S_{\Sigma} + H^2 + |A|^2 \right) \varphi^2 \right\} dv \\ & - 2 \int_{\partial \Sigma} \left( H^{\partial M} - H^{\partial \Sigma, \Sigma} \right) \varphi^2 da \\ & \leq & \int_{\Sigma} (a_n |\nabla \varphi|^2 + S_{\Sigma}) \varphi^2 dv - \int_{\Sigma} (a + H^2) \varphi^2 dv + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} \varphi^2 da. \end{split}$$

That is,

$$(2\lambda_1^J + a + H^2) \int_{\Sigma} \varphi^2 dv \leq \int_{\Sigma} (a_n |\nabla \varphi|^2 + S_{\Sigma}) \varphi^2 dv + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} \varphi^2 da$$
$$= Q_g(\varphi) \left( \int_{\Sigma} \varphi^{\frac{2n}{n-2}} dv \right)^{\frac{n-2}{n}}.$$

Using that  $Q_g(\Sigma) < 0$ , we can take a sequence of smooth function  $\{\varphi_l\}$  such that  $Q_g(\varphi_l) < 0$  and  $Q_g(\varphi_l) \to Q_g(\Sigma)$ , when  $l \to \infty$ . In particular,  $2\lambda_1^J + a + H^2 < 0$ . On the other hand, using the Hölder inequality we have

$$\int_{\Sigma} \varphi_l^2 \, dv \le |\Sigma|^{\frac{2}{n}} \left( \int_{\Sigma} \varphi_l^{\frac{2n}{n-2}} \, dv \right)^{\frac{n-2}{n}},$$

and using again  $Q_q(\varphi_l) < 0$ , we obtain

$$(2\lambda_1^J + a + H^2)|\Sigma|^{\frac{2}{n}} \le Q_q(\varphi_l).$$

Making  $l \to \infty$  and using the definition of  $\sigma(\Sigma)$  we conclude the estimate.

If equality holds, all inequalities become equalities, and in particular,  $\varphi$  is constant. The remaining assertions follow straightforwardly. The converse is immediate.

In particular,  $S_{\Sigma} = S\big|_{\Sigma} - 2\mathrm{Ric}_{M}(N,N) = a + 2\lambda_{1}^{J}$ , using the free boundary condition we have  $H^{\partial \Sigma, \Sigma} = H^{\partial M}\big|_{\partial \Sigma} - \mathrm{II}^{\partial M}(N,N) = 0$ , and arguing as in the proof of Theorem 2.1 of [5] we conclude that  $(\Sigma, g\big|_{\Sigma})$  is Einstein with totally geodesic boundary.

Escobar also introduced another invariant (see [14]) which we now describe. Consider the functional

(5.2) 
$$Y(\varphi) = \frac{\int_{\Sigma} \left( a_n |\nabla \varphi|^2 + S_{\Sigma} \varphi^2 \right) dv + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} \varphi^2 da}{\left( \int_{\partial \Sigma} \varphi^{\frac{2(n-1)}{n-2}} da \right)^{\frac{n-2}{n-1}}},$$

where  $\varphi$  is a smooth function not vanishing on the boundary.

The second  $\it Yamabe\ constant\ for\ manifolds\ with\ boundary$  is then defined as

$$Y(\Sigma, \partial \Sigma) = \inf_{\varphi \in C^{\infty}(\Sigma) \setminus \{0\}} Y(\varphi).$$

It is not difficult to see that  $Y(\Sigma, \partial \Sigma)$  is invariant under conformal changes, and thus depends only on the conformal class [g] of g (cf. [14]). Moreover, we have that  $Y(\Sigma, \partial \Sigma) \leq Y(\mathbb{B}^n, \partial \mathbb{B}^n)$ .

In this setting, the second Yamabe invariant of  $\Sigma$  is the supremum of these Yamabe constants over all conformal classes:

$$\tau(\Sigma,\partial\Sigma)=\sup_{[g]\in\mathcal{C}(\Sigma)}Y(\Sigma,\partial\Sigma).$$

Using this invariant we obtain the following estimate.

**Theorem 5.2.** Let  $(M^{n+1}, g)$  be an orientable Riemannian manifold with boundary,  $n \geq 3$ , with scalar curvature  $S \geq 0$ , and  $H^{\partial M} \geq b$ . Let  $\Sigma^n \subset M^{n+1}$  be a compact, orientable hypersurface with constant mean curvature H and free boundary. Assume that  $\tau(\Sigma, \partial \Sigma) < 0$ , then  $\sigma_1^J + b < 0$  and

(5.3) 
$$|\partial \Sigma| \ge \left(\frac{\tau(\Sigma, \partial \Sigma)}{2(\sigma_1^J + b)}\right)^{n-1}.$$

Moreover, the equality in (5.3) holds if and only if  $\tau(\Sigma, \partial \Sigma) = Y(1)$ ,  $\Sigma$  is totally geodesic in M,  $S|_{\Sigma} = 0$ ,  $H^{\partial M}|_{\partial \Sigma} = b$ ,  $\Pi^{\partial M}(N, N)|_{\partial \Sigma} = -\sigma_1^J$ , and  $\mathrm{Ric}_M(N, N) = 0$ . In particular,  $S_{\Sigma} = 0$ ,  $H^{\partial \Sigma, \Sigma} = b + \sigma_1^J$ , and  $(\Sigma, g|_{\Sigma})$  is Ricci-flat with totally umbilical boundary.

*Proof.* Using Holder inequality and the hypothesis on the Yamabe invariant we obtain:

$$(5.4) Y(\varphi) \int_{\partial \Sigma} \varphi^2 \, da \ge Y(\varphi) \, |\partial \Sigma|^{\frac{1}{n-1}} \left( \int_{\partial \Sigma} \varphi^{\frac{2(n-1)}{n-2}} \, da \right)^{\frac{n-2}{n-1}}.$$

By (4.2), we have:

$$\begin{split} 2\sigma_1^J \int_{\partial \Sigma} \varphi^2 \, da & \leq & 2 \int_{\Sigma} \left\{ |\nabla \varphi|^2 - \left( \mathrm{Ric}(N,N) + |A|^2 \right) \varphi^2 \right\} dv \\ & - 2 \int_{\partial \Sigma} \mathrm{II}^{\partial M}(N,N) \varphi^2 da \\ & \leq & \int_{\Sigma} \left\{ a_n |\nabla \varphi|^2 - \left( S - S_{\Sigma} + H^2 + |A|^2 \right) \varphi^2 \right\} dv \\ & - 2 \int_{\partial \Sigma} \left( H^{\partial M} - H^{\partial \Sigma, \Sigma} \right) \varphi^2 da, \end{split}$$

where we used  $a_n = \frac{4(n-1)}{n-2} > 2$ . Thus,

$$(2\sigma_1^J + 2b) \int_{\partial \Sigma} \varphi^2 da \leq \int_{\Sigma} \left[ a_n |\nabla \varphi|^2 + S_{\Sigma} \varphi^2 \right] dv + 2 \int_{\partial \Sigma} H^{\partial \Sigma, \Sigma} da$$
$$= Y(\varphi) \left( \int_{\partial \Sigma} \varphi^{\frac{2(n-1)}{n-2}} da \right)^{\frac{n-2}{n-1}}$$

By (5.4) we have

$$2(\sigma_1 + b) |\partial \Sigma|^{\frac{1}{n-1}} \le Y(\varphi).$$

Using (5.2) and definitions after that, we get the estimate (5.3).

The analysis of the equality case is similar to the previous case.
