## ON SOME RINGS OF DIFFERENTIABLE TYPE

ABSTRACT. Let K be a field of characteristic 0 and  $S = K[x_1, \ldots, x_m]/I$  be an affine domain. Consider  $R = S_P$  where  $P \in Spec(S)$  such that R is regular. In this paper we construct a field  $F$  which is contained in  $R$  such that

- (1) The residue field of  $R$  is a finite extension of  $F$ .
- (2)  $D_F(R)$ , the ring of F-linear differential operators on R is left and right Noetherian with finite global dimension.
- (3) The Bernstein class of  $D_F(R)$  is closed under localization at one element of R.

We also prove a similar result for  $R<sup>h</sup>$ , the Henselization of R. As an application we prove that  $\frac{D_F(R)}{D_F(R)P} \cong E(\kappa(P))$  where  $E(\kappa(P))$  is the injective hull of the residue field of R.

## 1. INTRODUCTION

Let K be a field of characteristic zero, and R be a K-algebra. let  $D(R) = D_K(R)$ be the ring of K-linear differential operators on  $R$ . There has been a lot of research on the finiteness properties of rings of differential operators. The following are example of R related to  $D(R)$  as a left and right Noetherian with finite global dimension:

- (1) Polynomial rings over K in n variables. In this case  $D(R) = A_n(K)$ , the  $n<sup>th</sup>$ -Weyl algebra over K. We have that global dimension of  $D(R)$  is equal to n; see [\[3,](#page-9-0) Chapter 2, Theorem 3.15].
- (2) Power series rings over K in n variables. In this case global dimension is n; see [\[3,](#page-9-0) Chapter 3, Proposition 1.8].
- (3) The ring of convergent power series over  $\mathbb C$  in n variables; see [\[3,](#page-9-0) Page 197].
- (4) Let  $(V, \pi V, K)$  be a DVR of mixed characteristic  $p > 0$ , and Let F denote its fraction field. Let  $S = V[[x_1, \ldots, x_{n+1}]] \otimes_V F$  be the tensor product of the power series ring with coefficients in V and F. Let  $R = S/(f)S$  be a regular ring where  $f = \pi - h$  for an element h in the square of maximal ideal of  $V[[x_1,\ldots,x_{n+1}]]$ . In this case also  $D(R)$  is Noetherian with finite global dimension; see [\[2,](#page-9-1) Page 4].

(5) Localization of complete local domains of equal characteristic zero at certain elements; see [\[10\]](#page-9-2).

However  $D(R)$  is not always Noetherian. Consider in the space  $\mathbb{C}^3$  with the coordinates  $x_1, x_2, x_3$  the surface X defined by the equation  $x_1^3 + x_2^3 + x_3^3 = 0$ , then the ring of differential operator on  $X$  is not Noetherian. This example is due to Bernstein- Gelfand[\[1,](#page-9-3) Theorem 1]. In this article we provide a new infinite class of Noetherian domains R with  $D(R)$  is both left and right Noetherian and with finite global dimension.

<span id="page-1-0"></span>We now state the following results of this paper.

1.1. Setup: Let K be a field of characteristic 0 and  $S = K[x_1, \ldots, x_m]/I$  be an affine domain. Consider  $R = S_P$  where  $P \in Spec(S)$  such that R is regular. We shall show that R contains a field F with  $\kappa(P) = S_P / PS_P$  a finite extension of F. Let  $Der_F(R)$  be the set of F-linear derivations of R and  $D_F(R)$  be the ring of  $F$ -linear differential operators on  $R$ . Our result is as follows:

<span id="page-1-2"></span>**Theorem 1.2.** Let  $R$  and  $F$  be as in Setup [1.1.](#page-1-0) Then,

- (1) The residue field of  $R$  is a finite extension of  $F$ .
- (2)  $\text{Der}_F(R)$  is a finitely generated projective R-module of rank equals to dim R.
- (3) The ring  $D_F(R)$  is a left and right Noetherian and the Bernstein class of  $D_F(R)$ is closed under localization at one element of R.

<span id="page-1-1"></span>**1.3.** Setup: Let R and S be as in Setup [1.1.](#page-1-0) Denote by  $R<sup>h</sup>$ , the Henselization of R. Since  $R \hookrightarrow R^h$ , the field F in [1.1](#page-1-0) is contained in  $R^h$ . We prove a similar result.

<span id="page-1-3"></span>Theorem 1.4. For the setup [1.3,](#page-1-1) we have the following;

- (1) The residue field of  $R^h$  is a finite extension of F.
- (2)  $\text{Der}_F(R^h)$  is a finitely generated projective  $R^h$ -module of rank same as dimension of  $R^h$ .
- (3) The ring  $D_F(R^h)$  is a left and right Noetherian and the Bernstein class of  $D_F(R^h)$  is closed under localization at one element of  $R^h$ .

<span id="page-1-4"></span>We also prove the following result as an application of [1.2;](#page-1-2)

**Theorem 1.5.** Let  $R$  and  $F$  be as in Setup [1.1.](#page-1-0) Then,

- (1)  $H_P^{\dim R}(R) \cong E(\kappa(P))$  is a  $D_F(R)$ -module in the Bernstein class.
- (2)  $\frac{D_F(R)}{D_F(R)P} \cong E(\kappa(P))$ , where  $E(\kappa(P))$  is the injective hull of the residue field of R.

Our paper comprises six sections. Section 2 provides an overview of D-modules. In section 3, we present crucial theorems essential for proving our results. Sections 4, 5, 6 and 7 are where we explain our proofs.

#### 2. Background on D-modules

Let  $R$  be a commutative  $A$ -algebra. The ring of  $A$ -linear differential operators of R is a subring  $D_A(R) \subseteq \text{Hom}_A(R, R)$  whose elements are defined inductively as follows: the differential operators of order zero are defined by the multiplication by elements of R, i.e.  $D^0(R) \cong R$ . Suppose we have defined operators of order  $\lt n$ . An operator  $\delta \in \text{Hom}_{A}(R, R)$  is of order less than or equal to n if  $[\delta, r] = \delta r - r\delta$  is an operator of order less than or equal to  $n-1$  for all  $r \in R$ . We have a filtration  $D_A^0(R) \subset D_A^1(R) \subset \ldots$  and ring of differential operators is defined as

$$
D_A(R) = \bigcup_{m \ge 0} D_A^m(R).
$$

**Example 2.1.** If R is either a polynomial ring  $A[x_1, \ldots, x_n]$  or the formal power series ring  $A[[x_1,\ldots,x_n]]$  with coefficients in A, then ring of A-linear differential operators is :

$$
D_A(R) = R\left\langle \frac{1}{t!} \frac{d^t}{dx_i^t} \middle| i = 1, \dots, n; t \in \mathbb{N} \right\rangle.
$$

**2.2.** Let M be a  $D_A(R)$ -module and  $f \in R$ . Then  $M_f$  is also a  $D_A(R)$ -module, where the action of a differential operator  $\partial \in D_A(R)$  on  $\frac{v}{f^t} \in M_f$  is defined inductively as follows: If  $\partial \in D_A^0(R)$  has order 0 then  $\partial \cdot \frac{v}{f^t} = \frac{\partial \cdot v}{f^t}$ . Now suppose that action of every element in  $D_A^n(R)$  has been defined. Let  $\partial \in D_A^{n+1}(R)$ . Then,

$$
\partial \cdot \frac{v}{f^t} = \frac{\partial \cdot v - [\partial, f^t] \cdot \frac{v}{f^t}}{f^t}
$$

With this  $D_A(R)$ -module structure on  $M_f$ , the map  $M \to M_f$  is a morphism of  $D_A(R)$ -modules.

**2.3.** Let  $I \subseteq R$  be an ideal of R generated by  $f = f_1, f_2, \ldots, f_r \in R$ , and let M be an R-module. Then the Čech complex of  $M$  with respect to  $f$  is defined by

$$
\check{C}^{\bullet}(\underline{f},M): 0 \to M \to \bigoplus_{i} M_{f_i} \to \bigoplus_{i,j} M_{f_i f_j} \to \dots \to M_{f_1 \dots f_r} \to 0
$$

where the maps on every summand are localization map upto a sign. The local cohomology module of  $M$  with support on  $I$  is defined by

$$
H^i_I(M)=H^i(\check{C}^\bullet(\underline{f},M))
$$

It follows from this construction that every local cohomology module over a  $D_A(R)$ module is again a  $D_A(R)$ -module.

**Definition 2.4.** We say that a associative ring  $R$  is filtered if there exists an ascending filtration  $\Sigma_0 \subset \Sigma_1 \subset \Sigma_2 \ldots$  of additive subgroups such that  $1 \in \Sigma_0$ ,  $\bigcup \Sigma_i = R$  and  $\Sigma_i \Sigma_j \subset \Sigma_{i+j}$  for every i and j. We denote by  $gr^{\Sigma}(R)$  the associated graded ring  $\Sigma_0 \oplus \Sigma_1/\Sigma_0 \oplus \Sigma_2/\Sigma_1 \oplus \ldots$ 

We have the following definition of a ring of differentiable type from [\[7\]](#page-9-4);

**Definition 2.5.** A filtered ring R is a ring of differentiable type if its associated graded ring is commutative Noetherian regular with unity and pure graded dimension.

**2.6.** Let R be a filtered ring of differentiable type with filtration  $\{\Sigma_i\}$ . A filtration  ${\{\Gamma_i\}}$  compatible with  ${\{\Sigma_i\}}$  on a left R-module M is called good if the associated graded  $gr^{\Sigma}(R)$ -module  $gr^{\Gamma}(M)$  is finitely generated. It is well known that a left R-module M can be equipped with good filtration iff it is finitely generated. If M is a finitely generated left R-module we can choose some good filtration  $\Gamma$  on M. Now the associated graded  $gr^{\Sigma}(R)$ -module  $gr^{\Gamma}(M)$  is finitely generated. Then we define:

$$
d_{\Gamma}(M) = \dim \text{Supp}(gr^{\Gamma}(M))
$$

In general, M can be equipped with many good filtrations. But it turns out that the integer  $d_{\Gamma}(M)$  do not depend on the choice of Γ, i.e. we have the equalities  $d_{\Gamma}(M) = d_{\Gamma}(M)$  for all pairs of good filtrations  $\Gamma$  and  $\Gamma'$  on M. This common integer is therefore denoted by  $d(M)$  and called the dimension of R-module M.

**Definition 2.7.** A ring R has finite weak global dimension w if  $\text{Tor}_v^R(N, M) = 0$  for all  $v > w$  and every right R-module N and left R-module M, while  $\text{Tor}_w^R(N, M) \neq 0$ for some pair.

Let R be a ring of differentiable type with pure graded dimension  $\mu$  and assume that weak global dimension of R is  $w$ . We recall the following corollary from [\[3,](#page-9-0) Chapter 2, 7.2],

Corollary 2.8.  $d(M) \geq \mu - w$  for every non-zero finitely generated R-module M.

**Definition 2.9.** The Bernstein class consists of all finitely generated R-modules M for which equality holds in the above corollary i.e.  $d(M) = \mu - w$  (or if  $M = 0$ ).

# 3. Preliminaries

If A is a k-algebra,  $\Omega_{A/k}$  denotes the module of Kähler differentials and let the universal derivation be  $d_{A/k}: A \to \Omega_{A/k}$ . For A-module M we have that  $Der_k(A, M) \cong Hom_A(\Omega_{A/k}, M).$ 

<span id="page-3-0"></span>The following two results are useful:

**Theorem 3.1.** (First fundamental exact sequence)[\[6,](#page-9-5) Theorem 25.1] A composite  $k \stackrel{f}{\rightarrow} A \stackrel{g}{\rightarrow} B$  of ring homomorphisms leads to an exact sequence of B-modules

$$
\Omega_{A/k} \otimes_A B \xrightarrow{\alpha} \Omega_{B/k} \xrightarrow{\beta} \Omega_{B/A} \to 0
$$

where the maps are given by  $\alpha(d_{A/k}a\otimes b) = b \ d_{B/k}g(a)$  and  $\beta(d_{B/k}b) = d_{B/A}b$ for  $a \in A$  and  $b \in B$ .

<span id="page-4-3"></span>Theorem 3.2. (Second fundamental exact sequence)[\[6,](#page-9-5) Theorem 25.2] Consider  $k \stackrel{f}{\to} A \stackrel{g}{\to} B$  when g is surjective; set ker  $g = \mathfrak{m}$ , so  $B = A/\mathfrak{m}$ . Then we have an exact sequence as follows:

$$
\mathfrak{m}/\mathfrak{m}^2\xrightarrow{\delta}\Omega_{A/k}\otimes_A B\xrightarrow{\alpha}\Omega_{B/k}\to 0
$$

where  $\delta$  is the B-linear map defined by  $\delta(\bar{x}) = d_{A/k} x \otimes 1$ .

<span id="page-4-1"></span>In general  $\Omega_{A/F}$  need not be finitely generated A-module. However we have the following result for  $Der_F(A)$ .

**Theorem 3.3.** [\[6,](#page-9-5) Theorem 30.7]  $(R, \mathfrak{m})$  be an n-dimensional Noetherian local integral domain containing Q, and  $F \subset R$  be a subfield such that  $tr.deg_F(R/\mathfrak{m})=$  $r < \infty$ . Then  $\text{Der}_F(R)$  is isomorphic to a submodule of  $R^{n+r}$ , and is therefore a finite R-module, with

$$
rank \, Der_F(R) \leq \dim R + tr.deg_F(R/\mathfrak{m})
$$

<span id="page-4-0"></span>The following result gives a sufficient condition for  $\text{Der}_F(R)$  to be free.

**Theorem 3.4.** [\[6,](#page-9-5) Theorem 30.6] Let  $(R, m, F)$  be a regular local commutative Noetherian ring with unity of dimension n containing a field  $F_0$ . Suppose that F is an algebraic separable extension  $F_0$ . Let  $\widehat{R}$  denote the m-adic completion of R. Let  $x_1, \ldots, x_n$  be a regular system of parameters of R. Then,  $\widehat{R} = F[[x_1, \ldots, x_n]]$ is the power series ring with coefficients in F, and  $\text{Der}_F \widehat{R}$  is a free  $\widehat{R}$ -module with basis  $\partial/\partial x_i$  for  $1 \leq i \leq n$ . Moreover, the following conditions are equivalent:

- (1)  $\partial/\partial x_i$  maps R into R for  $1 \leq i \leq n$ , so that they can be considered as elements of  $\mathrm{Der}_{F_0}(R)$ ;
- (2)  $\mathrm{Der}_{F_0}(R)$  is a free R-module of rank n;
- <span id="page-4-4"></span>(3) rank  $\text{Der}_{F_0}(R) = n$ .

Corollary 3.5. [\[8,](#page-9-6) Corollary 1.2.2.3] Under the hypotheses above, assume that any of the equivalent conditions in theorem [3.4](#page-4-0) are satisfied. Then the following holds:

$$
\widehat{R} \otimes_R D_{F_0}(R) \cong D_{F_0}(\widehat{R}) \cong D_{F_0}(R) \otimes_R \widehat{R}
$$

<span id="page-4-5"></span>The following result is due to Lyubeznik;

**Theorem 3.6.** [\[4,](#page-9-7) Proposition 2.3] Let K be a field of characteristic 0, let  $R =$  $K[[x_1, \ldots, x_n]]$  be the ring of formal power series ring in n variables over K and let **m** be maximal ideal of R. Then, as an R-module  $\frac{D_K(R)}{D_K(R)$  is isomorphic to  $E_R(K)$ , the injective hull of the residue field of R.

<span id="page-4-2"></span>**Remark 3.7.** Let R be an integral domain and L be quotient field of R.

(1) Let M be R-module of rank r. Then  $M \otimes L \cong L^r$ . But  $\text{Hom}_R(M, R) \otimes L \cong$  $\text{Hom}_L(L^r, L) \cong L^r$ . Hence  $\text{Hom}_R(M, R)$  and M have the same rank.

(2) Let M is R-module and  $P \in Spec(R)$ . We note that R and  $R_P$  have same quotient field, denoted as L. Since  $M_P \otimes_{R_P} L \cong M \otimes_R R_P \otimes_{R_P} L \cong M \otimes_R L$ , so  $M$  and  $M_P$  have the same rank.

**Definition 3.8.** A local homomorphism  $\phi : (R, \mathfrak{m}, k) \to (S, \mathfrak{n}, l)$  of local rings is unramified provided S is essentially of finite type over  $R(\text{that is}, S \text{ is localization})$ of some finitely generated R-algebra) and the following properties hold.

- $(1)$  m $S = n$ , and
- (2)  $S/mS$  is a finite separable field extension of  $R/m$ .

If, in addition,  $\phi$  is flat, then we say  $\phi$  is étale. (We say also that S is an unramified, respectively, étale extension of  $R$ .) A pointed étale neighborhood is an étale extension  $(R, \mathfrak{m}, k) \rightarrow (S, \mathfrak{n}, l)$  inducing an isomorphism on residue fields.

The isomorphism classes of pointed étale neighborhoods form a direct system. The reason for this is that if  $R \to S$  and  $R \to T$  are pointed étale neighborhoods then there is at most one homomorphism  $S \to T$  making the obvious diagram commute. We refer [\[5,](#page-9-8) Chapter 3] for details.

**Definition 3.9.** The Henselization  $R<sup>h</sup>$  of R is the direct limit of a set of representatives of isomorphism classes of pointed étale neighborhoods of  $R$ .

<span id="page-5-1"></span>**Theorem 3.10.** [\[9,](#page-9-9) Theorem 43.9] Let  $(R, \mathfrak{m})$  be a local ring and let  $R^h$  be its Henselization. For a finite number of elements  $b_i$  of  $R^h$ , there is an element a of  $\mathfrak{m}R^{h}$  which is a root of a monic polynomial  $f(x) = x^{r} + c_{1}x^{r-1} + \ldots + c_{r}$  over R with  $c_{r-1} \notin \mathfrak{m}, c_r \in \mathfrak{m}$ , such that the ring  $R' = R[a]_{(\mathfrak{m}+aR[a])}$  contains  $b_i$ . Furthermore  $R<sup>h</sup>$  contains  $R'$ .

<span id="page-5-0"></span>We recall the following two results from [\[2\]](#page-9-1).

**Theorem 3.11.** Let R be a regular commutative Noetherian ring with unity that contains a field  $F$  of characteristic  $\theta$  satisfying the following conditions:

- (1) R is equidimensional of dimension  $n$ ;
- (2) every residual field with respect to a maximal ideal is an algebraic extension of  $F$ ;
- (3)  $\text{Der}_F(R)$  is a finitely generated projective R-module of rank n such that  $R_m \otimes_R R$  $Der_F(R) = Der_F(R_m)$  for each maximal ideal m of R.

Then, the ring of F-linear differential operators  $D_F(R)$  is a ring of differentiable type of weak global dimension equal to  $\dim(R)$ . Moreover, the Bernstein class of  $D_F(R)$  is closed under localization at one element of R.

<span id="page-5-2"></span>Let  $D_F(R)$  be as in the last theorem. Then,

**Theorem 3.12.** If M is a left  $D_F(R)$ -module in the Bernstein class. Then, each local cohomology module has a natural structure of  $D_F(R)$ -module and it belongs to Bernstein class of  $D_F(R)$ -module.

# 4. Existence of the field of [1.1](#page-1-0)

Let  $R$  be as in setup [1.1.](#page-1-0) We first show the existence of a field  $F$  contained in R with  $\kappa(P)$  a finite extension of F. As  $S/P$  is a finitely generated K-algebra, there exist variables  $y_1, \ldots, y_r$  such that  $T = K[y_1, \ldots, y_r] \hookrightarrow S/P$  and  $S/P$  is integral over  $K[y_1, \ldots, y_r]$  (By Noether normalization). So quotient field of  $S/P$  is a finite extension of quotient field of  $K[y_1, \ldots, y_r]$ . Set F to be the quotient field of  $K[y_1, \ldots y_r]$ . Therefore  $S_P/PS_P$  is a finite extension of F. We claim that F is contained in  $R = Sp$ . Let  $\phi$  denotes the inclusion map between T and  $S/P$ . If  $\phi(y_i) = \overline{a_i}$  then the map  $\psi : T \to S$  given by  $\psi(y_i) = a_i$  is injective. Composition of  $\psi$  with the natural map from S to  $S_P$  is injective. Let this map be  $h: T \to S_P$ .



Every non zero element in T is non zero in  $S/P$  and hence unit in  $S_P$ . So by universal property of localization there exists a map  $g: T_{(0)} \to S_P$  such that the above diagram is commutative. Hence  $T_{(0)} = F$  is contained in  $S_P$  as g is injective.

## 5. Proof of theorem [1.2](#page-1-2)

<span id="page-6-0"></span>From the discussions above we can see that  $Sp/PS_P$  is finite extension of F and this proves first part of [1.2.](#page-1-2) To prove second part of [1.2,](#page-1-2) it is enough to prove that  $Der_F(R)$  is free of rank  $n = \dim R$  because R is local ring.

*Proof.* If S is not regular, let  $Sing(S)$ , the singular locus of S, be defined by an ideal J in S. Note that  $J \neq 0$  and  $J \not\subset P$ . So there exists  $\alpha \in J$  such that  $\alpha \notin P$ . Then  $S_{\alpha} = V$  is a regular affine domain and  $R = S_P = V_{PV}$ . From this observation we may assume that  $S$  is regular affine domain.

It suffices to show rank  $\text{Der}_F(R) = n$  by [3.4.](#page-4-0) Using [3.3,](#page-4-1) rank  $\text{Der}_F(R) \leq n$ . We have that  $T = K[y_1, \ldots, y_r] \subset S$  and  $K \hookrightarrow T \hookrightarrow S$ . By [3.1](#page-3-0) we get the following exact sequence of S-modules

$$
\Omega_{T/K} \otimes_T S \to \Omega_{S/K} \to \Omega_{S/T} \to 0
$$

 $\Omega_{T/K} = T^r$  and  $\Omega_{S/K}$  is a projective S-module of rank equals to dim  $S = m$ . So the exact sequence becomes

$$
S^r = T^r \otimes_T S \to \Omega_{S/K} \to \Omega_{S/T} \to 0
$$

Let L be quotient field of S and  $t = \text{rank}\Omega_{S/T}$ . Tensoring the above sequence with L we get the exact sequence

$$
L^r \to L^m \to L^t \to 0
$$

Hence  $t \geq m - r = \dim S - \dim S/P = \text{ht } P = \dim R = n$ . Hence rank  $\Omega_{S/T} \geq$ n. Since  $\text{Der}_T(S) \cong \text{Hom}_S(\Omega_{S/T}, S)$ , remark [3.7](#page-4-2) implies that rank  $\text{Der}_T(S) =$ rank  $\Omega_{S/T} \ge n$ . Therefore using [3.7](#page-4-2) we get rank  $\text{Per}_T(S)_P \ge n$ . This implies that rank  $\text{Der}_T(S_P) \geq n$  as  $\text{Der}_T(S_P) \subset \text{Der}_T(S_P)$ . Clearly  $\text{Der}_F(S_P) \subset \text{Der}_T(S_P)$ . We claim that this is an equality. Let  $D \in \text{Der}_T(S_P)$  and  $\frac{a}{s} \in F$ ,  $u \in S_P$ . If

$$
v = -\frac{a}{s} u \implies sv = au \implies D(sv) = D(au) \implies sD(v) = aD(u)
$$

Hence we get that  $D(v) = \frac{a}{s}D(u)$ . Thus  $D \in \text{Der}_F(S_P)$ . So  $\text{Der}_F(S_P) = \text{Der}_T(S_P)$ . Therefore rank  $Der_F(R) \geq n$ . Hence rank  $Der_F(R) = n$  and this proves that  $\text{Der}_F(R)$  is a free R module by [3.4.](#page-4-0)

As a corollary of Theorem [3.11](#page-5-0) we get 3 of [1.2](#page-1-2) that is  $D(R)$  is a left and right Noetherian with global dimension n. Moreover, the Bernstein class of  $D(R)$  is closed under localization at one element of R.

## 6. Proof of theorem [1.4](#page-1-3)

Since the residue fields of  $R<sup>h</sup>$  and R are same, the residue field of  $R<sup>h</sup>$  is finite extension of F. Only thing is to prove that  $Der_F(R^h)$  is a finitely generated free  $R<sup>h</sup>$ -module of rank same as dim  $R<sup>h</sup>$  = dim  $R = n$ .

*Proof.* Using [3.10,](#page-5-1) if  $a \in R^h$ , then  $a \in \frac{R[x]_{(m_R,x)}(x)}{f(x)} = T \subseteq R^h$  for some  $f(x) =$  $x^{n} + a_{n-1}x^{n-1} + ... + a_{1}x + a_{0}$  with  $a_{0} \in \mathfrak{m}, a_{1} \notin \mathfrak{m}$ .

Let  $L = R[x]_{(\mathfrak{m}_R,x)} = S[x]_{(P,x)}$  and  $T = \frac{R[x]_{(\mathfrak{m},x)}}{(f(x))} = L/(f)$ . Since  $F \hookrightarrow R$ , we have that  $F \hookrightarrow L$  and  $L/\mathfrak{m}_L = R/\mathfrak{m}$  is a finite extension of F.

Using [3.2](#page-4-3) for  $F \to L \to L/(f)$ , we get the exact sequence

$$
(f)/(f)^2 \to \Omega_{L/F} \otimes_L T \to \Omega_{T/F} \to 0
$$

Applying  $\text{Hom}_T(\_,T)$ , the exact sequence becomes

$$
0 \to \text{Hom}_T(\Omega_{T/F}, T) \to \text{Hom}_T(\Omega_{L/F} \otimes_L T, T) \to \text{Hom}_T((f)/(f)^2, T)
$$

Since  $\text{Hom}_T(\Omega_{T/F}, T) \cong \text{Der}_F(T, T)$ ,  $\text{Hom}_T(\Omega_{L/F} \otimes_L T, T) \cong \text{Hom}_L(\Omega_{L/F}, T) \cong$  $\text{Der}_F(L, T)$  and  $(f)/(f)^2 \cong T$ , we have the exact sequence

$$
0 \to \mathrm{Der}_F(T,T) \to \mathrm{Der}_F(L,T) \to \mathrm{Hom}_T(T,T) = T
$$

We claim that  $\text{rank}_T \text{Der}_F (L, T) \geq n + 1$ . Assume the claim for the moment. The last exact sequence implies  $\text{rank}_T \text{Der}_F(T) \geq n$ . Hence  $\text{rank} \text{Der}_F(T) = n$  as [3.3](#page-4-1) implies rank  $\text{Der}_F(T) \leq n$ . If  $a \in T$ , then  $\frac{\partial}{\partial x_i}(a) \in T$  using [3.4](#page-4-0) for all *i*. Therefore,  $\frac{\partial}{\partial x_i}(a)$  ∈  $R^h$  because  $T \subseteq R^h$ . Since this is true for all  $a \in R^h$ , we get  $\frac{\partial}{\partial x_i}$  ∈  $Der_F(R^h)$  for each *i*. Again using [3.4,](#page-4-0)  $Der_F(R^h)$  is free  $R^h$ -module of rank *n*.

Now we prove our claim that  $\text{rank}_T \text{Der}_F (L, T) \geq n + 1$ . Consider the sequence  $0 \to L \xrightarrow{f} L \to T \to 0$ . This gives the following exact sequence

$$
0\to \mathrm{Hom}_L(\Omega_{L/F},L)\xrightarrow{f} \mathrm{Hom}_L(\Omega_{L/F},L)\to \mathrm{Hom}_L(\Omega_{L/F},T)
$$

That is,

$$
0 \to \mathrm{Der}_F(L, L) \xrightarrow{f} \mathrm{Der}_F(L, L) \to \mathrm{Der}_F(L, T)
$$

By our result in [5,](#page-6-0)  $Der_F(L)$  is a free L-module of rank equals to  $(\dim R + 1)$ . Therefore, the last exact sequence becomes

$$
0 \to L^{n+1} \xrightarrow{f} L^{n+1} \to \text{Der}_F(L, T)
$$

Since cokernal of f is  $T^{n+1}$ , rank<sub>T</sub> Der<sub>F</sub> $(L, T) \ge n + 1$ .

As a corollary of Theorem [3.11](#page-5-0) we get that  $D(R<sup>h</sup>)$  is left and right Noetherian ring with global dimension n. Moreover, the Bernstein class of  $D(R<sup>h</sup>)$  is closed under localization at one element of  $R<sup>h</sup>$ .

### 7. Proof of theorem [1.5](#page-1-4)

In this section, we present the proof of Theorem [1.5.](#page-1-4) Since  $R$  is regular of dimension n,  $E_R(\kappa(P)) \cong H_P^n(R)$ . We note that R is a  $D_F(R)$ -module in the Bernstein class, so is  $H_P^n(R)$  by [3.12](#page-5-2) and this prove first part of [1.5.](#page-1-4) We now prove the second part.

*Proof.* Let  $\kappa(P) = K$ ,  $D = D_F(R)$  and  $\hat{D} = D_F(\hat{R})$ . We note that  $E_R(K) \cong$  $H_P^n(R)$  has socle dimension 1. Let the socle be spanned by t. Let  $\phi$  be the map between D and  $E_R(K)$  defined by  $\phi(1) = t$ . Since  $\phi(DP) = 0$ , so it induces a map  $\bar{\phi}: \frac{D}{DP} \to E_R(K).$ 

Now

$$
E_R(K) \otimes_R \widehat{R} \cong H_P^n(R) \otimes_R \widehat{R}
$$

$$
\cong H_{P\widehat{R}}^n(\widehat{R})
$$

$$
\cong E_{\widehat{R}}(\frac{\widehat{R}}{P\widehat{R}})
$$

And

$$
\frac{D}{DP} \otimes_R \widehat{R} \cong (D \otimes_R \frac{R}{P}) \otimes_R \widehat{R}
$$

$$
\cong (D \otimes_R \widehat{R}) \otimes_R \frac{R}{P}
$$

Using [3.5,](#page-4-4)  $(D \otimes_R \widehat{R}) \cong \widehat{D}$ . Hence we get the following

$$
\frac{D}{DP} \otimes_R \hat{R} \cong \hat{D} \otimes_R \frac{R}{P}
$$

$$
\cong \hat{D} \otimes_{\hat{R}} (\hat{R} \otimes_R \frac{R}{P})
$$

$$
\cong \hat{D} \otimes_{\hat{R}} \frac{\hat{R}}{P\hat{R}}
$$

$$
\cong \frac{\hat{D}}{\hat{D}\hat{P}}
$$

[3.6](#page-4-5) implies  $\frac{\widehat{D}}{\widehat{D}\widehat{P}} \cong E_{\widehat{R}}(\frac{\widehat{R}}{P\widehat{P}})$  $\frac{\widehat{R}}{P\widehat{R}}$ . Therefore,  $E_R(K) \otimes_R \widehat{R} \cong \frac{D}{DP} \otimes_R \widehat{R}$ . Since  $R \to \widehat{R}$  is faithfully flat map we get  $\frac{D}{DP} \cong E_R(K)$  and this proves our result.
