### CATEGORIFICATION OF QUANTUM BORCHERDS-BOZEC ALGEBRAS

Abstract. We categorify the quantum Borcherds-Bozec algebras by constructing their associated Khovanov-Lauda-Rouquier algebras.

#### Introduction

The Khovanov-Lauda-Rouquier algebras (quiver Hecke algebras) were independently discovered by Khovanov-Lauda [\[9,](#page-26-0) [10\]](#page-26-1) and Rouquier [\[13\]](#page-26-2). In Kac-Moody type, the category of finitely generated graded projective modules over Khovanov-Lauda-Rouquier algebras provides a categorification of the corresponding quantum groups, and for symmetric Cartan datum, the indecomposable projective modules correspond to Lusztig's canonical basis [\[14,](#page-26-3) [16\]](#page-26-4). The cyclotomic quotients of Khovanov-Lauda-Rouquier algebras provides a categorification of the irreducible highest weight representations of quantum groups and their crystals [\[8,](#page-25-0) [11,](#page-26-5) [17\]](#page-26-6).

The quantum Borcherds-Bozec algebras were introduced by T. Bozec [\[1\]](#page-25-1) in his study of perverse sheaves on arbitrary quiver representation varieties, possibly with loops. He showed that the Grothendieck group arising from Lusztig sheaves is generated by the elementary simple perverse sheaves, answering a question posed by Lusztig in [\[12\]](#page-26-7).

In this paper, we apply Khovanov-Lauda's categorification theory to quantum Borcherds-Bozec algebras. By construction, a quantum Borcherds-Bozec algebra  $U_q(\mathfrak{g})$  is determined by a Borcherds-Cartan datum, consisting of an index set  $I$  and a symmetrizable Borcherds-Cartan matrix  $A = (a_{ij})_{i,j\in I}$  where diagonal elements can be 0 and negative. For an index i with  $a_{ii} \leq 0$ , there are infinitely many generators  $E_{i\ell}, F_{i\ell}$  ( $\ell \in \mathbb{Z}_{>0}$ ) associated with it. The comultiplications of these generators are of 'higher orders', but sometimes simpler comultiplication generators are needed, known as primitive generators denoted by  $a_{i\ell}, b_{i\ell}$ . Using these primitive generators, we show that the half part  $U^-$  of  $U_q(\mathfrak{g})$  is isomorphic as bialgebras to a quantum Borcherds algebra introduced in [\[7\]](#page-25-2), considering each pair  $(i, \ell)$  as a simple root. The categorification of quantum Borcherds algebras has been studied in [\[15\]](#page-26-8) and [\[6\]](#page-25-3), which we

directly apply here. The Khovanov-Lauda-Rouquier algebra defined in this view is denoted by  $\mathcal{R}$ .

In the Jordan quiver case, it is more natural to connect the quantum Borcherds-Bozec algebra (which coincides with the classical Hall algebra) with the representations of symmetric groups. We provide another construction of the Khovanov-Lauda-Rouquier algebra R, such that for each i with  $a_{ii} = 0$ , the degenerate algebra  $R(ni)$  is a deformation of the symmetric group algebra. Let  $K_0(R)$  be the category of finitely generated graded projective modules. We prove there is a bialgebra isomorphism  $\Gamma$  of  $U^-$  with  $K_0(R)$ . Composing with an automorphism  $\Psi$  of  $U^-$ , we obtain a  $\mathbb{Z}[q, q^{-1}]$ -algebra isomorphism

$$
\Phi = \Psi \Gamma^{-1} : K_0(R) \xrightarrow{\sim} {}_{\mathcal{A}}U^-,
$$

where  ${}_{\mathcal{A}}U^-$  is the A-form of  $U^-$ . We conjecture that:

**Conjecture.** Under  $\Phi$ , the indecomposable projective modules of  $K_0(R)$  coincides with the canonical basis of  $_{\mathcal{A}}U^{-}$  in [\[1\]](#page-25-1).

As an application, we show in the Jordan quiver case that the cyclotomic algebra  $R^{\Lambda}$  $(\Lambda \in P^+)$  provides a categorification of the irreducible highest weight module  $V(\Lambda)$ . Indeed, we categorify the commutation relations of the generators  $E_{i\ell}$  and  $F_{it}$  for  $a_{ii} = 0$ .

### 1. Quantum Borcherds-Bozec algebras

## 1.1. Borcherds-Cartan datum and  $U^-$ .

Let I be an index set possibly countably infinite. A symmetrizable Borcherds-Cartan matrix is an integer-valued matrix  $A = (a_{ij})_{i,j \in I}$  satisfying

- (i)  $a_{ii} = 2, 0, -2, -4, \ldots,$
- (ii)  $a_{ij} \in \mathbb{Z}_{\leq 0}$  for  $i \neq j$ ,
- (iii) there is a diagonal matrix  $D = \text{diag}(r_i \in \mathbb{Z}_{>0} \mid i \in I)$  such that DA is symmetric.

We set  $I^+ = \{i \in I \mid a_{ii} = 2\}, I^0 = \{i \in I \mid a_{ii} = 0\}, I^- = \{i \in I \mid a_{ii} < 0\}$  and  $I^{\leq 0} = I^0 \cup I^-$ . The elements in  $I^+$  (resp.  $I^{\leq 0}$ ) are called real indices (resp. imaginary indices).

# A Borcherds-Cartan datum  $(I, A, P, P^{\vee})$  is given by

a symmetrizable Borcherds-Cartan matrix A

a free abelian group  $P$ , called the weight lattice,

 $P^{\vee} = \text{Hom}_{\mathbb{Z}}(P, \mathbb{Z}),$  called the dual weight lattice,

 $\alpha_i \in P$  for  $i \in I$ , called the simple roots,

 $h_i \in P^{\vee}$  for  $i \in I$ , called the simple coroots,

a symmetric bilinear form  $( , ) : P \times P \rightarrow \mathbb{Z}$ .

such that  $\alpha_i(h_i) = a_{ij}$  for all  $i, j \in I$ , and  $(\lambda, \alpha_i) = r_i \lambda(h_i)$  for all  $\lambda \in P, i \in I$ . In particular,

$$
(\alpha_i, \alpha_j) = r_i a_{ij} = r_j a_{ji}
$$
 for all  $i, j \in I$ .

Let  $P^+ = \{\Lambda \in P \mid \Lambda(h_i) \geq 0 \text{ for all } i \in I\}$  be the set of dominant integral weights. The free abelian group  $Q = \bigoplus_{i \in I} \mathbb{Z} \alpha_i$  is called the root lattice. We identify the positive root lattice  $Q_+ = \sum_{i \in I} \mathbb{N} \alpha_i$  with  $\mathbb{N}[I]$ .

Let q be an indeterminate. For each  $i \in I$ , we set

$$
q_i = q^{r_i}, \quad q_{(i)} = q^{\frac{(\alpha_i, \alpha_i)}{2}}.
$$

For each  $i \in I^+$  and  $n \in \mathbb{N}$ , we set

$$
[n]_i = \frac{q_i^n - q_i^{-n}}{q_i - q_i^{-1}}
$$
 and  $[n]_i! = [n]_i[n-1]_i \cdots [1]_i$ .

<span id="page-2-0"></span>**Definition 1.1.** Let  $I^{\infty} = I^+ \sqcup (I^{\leq 0} \times \mathbb{Z}_{> 0})$ . The negative part  $U^- (U_q^- (\mathfrak{g}))$  of the quantum Borcherds-Bozec algebra associate with a given Borcherds-Cartan datum  $(I, A, P, P^{\vee})$  is the associative algebra over  $\mathbb{Q}(q)$  generated by  $F_{i,\ell}$   $((i,\ell) \in I^{\infty})$ , satisfying the following relations

$$
\sum_{r+s=1-\ell a_{ij}} (-1)^r F_i^{(r)} F_{j\ell} F_i^{(s)} = 0 \text{ for } i \in I^+, (j,\ell) \in I^{\infty} \text{ and } i \neq (j,\ell),
$$
  

$$
F_{i\ell} F_{jk} - F_{jk} F_{i\ell} = 0 \text{ for } a_{ij} = 0.
$$

Here we denote  $F_i^{(n)} = F_i^n/[n_i!$  for  $i \in I^+$  and  $n \in \mathbb{N}$ . The algebra  $U^-$  is  $Q$ -graded by assigning  $|F_{i\ell}| = -\ell \alpha_i$ .

Define a twisted multiplication on  $U^- \otimes U^-$  by

$$
(x_1 \otimes x_2)(y_1 \otimes y_2) = q^{-(|x_2|, |y_1|)} x_1 y_1 \otimes x_2 y_2,
$$

for homogeneous  $x_1, x_2, y_1, y_2$ . By [\[1,](#page-25-1) Proposition 14], we have an algebra homomorphism  $\rho: U^- \to U^- \otimes U^-$  (with respect to the twisted multiplication on  $U^- \otimes U^-$ ) given by

$$
\rho(F_{i\ell}) = \sum_{m+n=\ell} q_{(i)}^{-mn} F_{im} \otimes F_{in} \text{ for } (i,\ell) \in I^{\infty},
$$

and a nondegenerate symmetric bilinear form {, } :  $U^{-} \times U^{-} \rightarrow \mathbb{Q}(q)$  determined by

- (i)  $\{x, y\} = 0$  if  $|x| \neq |y|$ ,
- (ii)  $\{1, 1\} = 1$ ,
- (iii)  ${F_{i\ell}, F_{i\ell} \equiv 1 \pmod{q}$  for all  $(i, \ell) \in I^{\infty}$ ,
- (iv)  $\{x, yz\} = \{\rho(x), y \otimes z\}$  for  $x, y, z \in U^{-}$ .

There exists a set of primitive generators  $\mathbf{b}_{i\ell}$   $((i,\ell) \in I^{\infty})$  of  $U^-$  such that  $\mathbf{b}_{i\ell} \in U^-_{-i}$  $\bar{\ }_{-\ell\alpha_i}^-,$  $\mathbf{b}_{i\ell} - F_{i\ell} \in \mathbb{Q}(q) \langle F_{ik} | k \langle \ell \rangle \text{ and } \{\mathbf{b}_{i\ell}, z\} = 0 \text{ for all } z \in \mathbb{Q}(q) \langle F_{i1}, \cdots, F_{i,\ell-1} \rangle.$ For any  $\mathbf{c} = (c_1, \dots, c_t) \in \mathbb{N}^t$ , we set  $\mathbf{b}_{i,\mathbf{c}} = \mathbf{b}_{ic_1} \cdots \mathbf{b}_{ic_t}$ .

Let  $^-$  be the Q-algebra involution of  $U^-$  given by  $\overline{F}_{i\ell} = F_{i\ell}$  for all  $(i, \ell) \in I^{\infty}$  and  $\overline{q} = q^{-1}$ . Let <sup>\*</sup> be the  $\mathbb{Q}(q)$ -algebra anti-involution of  $U^-$  given by  $F_{i\ell}^* = F_{i\ell}$  for all  $(i, \ell) \in I^{\infty}$ .

<span id="page-3-0"></span>For each  $\ell \geq 0$ , we denote by  $\mathcal{C}_{\ell}$  (resp.  $\mathcal{P}_{\ell}$ ) the set of compositions (resp. partitions) of  $\ell$ .

Proposition 1.2. [\[1,](#page-25-1) [2\]](#page-25-4) The primitive generators satisfy the following properties:

- (1)  $\rho(\mathbf{b}_{i\ell}) = \mathbf{b}_{i\ell} \otimes 1 + 1 \otimes \mathbf{b}_{i\ell}, \overline{\mathbf{b}}_{i\ell} = \mathbf{b}_{i\ell} \text{ and } \mathbf{b}_{i\ell}^* = \mathbf{b}_{i\ell} \text{ for all } (i,\ell) \in I^{\infty}.$
- (2)  $\{b_{i\ell}, b_{i\ell}\} \equiv 1/l \pmod{q}$  for  $i \in I^0$ ,  $\{b_{i\ell}, b_{i\ell}\} \equiv 1 \pmod{q}$  for  $i \in I^-$ .
- (3) If  $i \in I^0$ , the set  $\{b_{i,c} \mid c \in \mathcal{P}_{\ell}\}\)$  forms a basis of  $U_{-i}^ \bar{e}_{-\ell\alpha_i}$  and  $\{b_{i,\mathbf{c}}, b_{i,\mathbf{c}'}\}=0$  when  $\mathbf{c} \neq \mathbf{c}'$ . If  $i \in I^-$ , the set  $\{\mathbf{b}_{i,\mathbf{c}} \mid \mathbf{c} \in \mathcal{C}_{\ell}\}\)$  forms a basis of  $U^-$ .  $\begin{bmatrix} -\ell_{\alpha_i} & \text{and} & {\mathfrak{b}}_{i,\mathbf{c}}, {\mathfrak{b}}_{i,\mathbf{c}'} \end{bmatrix} = 0$ when  $c$  and  $c'$  determine different partitions.
- (4) Let  $i \in I^0$ . If we write  $\lambda \in \mathcal{P}_{\ell}$  into the form  $\lambda = 1^{\lambda_1} 2^{\lambda_2} \cdots \ell^{\lambda_{\ell}}$ , where  $\lambda_k$  are nonnegative integers such that  $\lambda_1 + 2\lambda_2 + \cdots + \ell \lambda_\ell = \ell$ , then

$$
\mathtt{b}_{i\ell}=F_{i\ell}-\sum_{\lambda\in\mathcal{P}_\ell\setminus(\ell)}\frac{1}{\prod_{k=1}^\ell\lambda_k!}\mathtt{b}_{i,\lambda}.
$$

Let  $(i, \ell) \in I^{\infty}$  and  $x \in U^{-}$  be homogeneous. We define  $e'_{i\ell}(x)$  by the decomposition

$$
\rho(x) = \mathbf{b}_{i\ell} \otimes e'_{i\ell}(x) + \sum_{\mathbf{c} \neq (\ell)} \mathbf{b}_{i,\mathbf{c}} \otimes y_{\mathbf{c}} + \text{terms of bidegree not in } -\ell \alpha_i \times Q_-.
$$

The operator  $e'_{i\ell}: U^- \to U^-$  is uniquely determined by the following

$$
e'_{i\ell}(1) = 0
$$
,  $e'_{i\ell}(b_{jk}) = \delta_{ij}\delta_{\ell k}$  and  $e'_{i\ell}(xy) = e'_{i\ell}(x)y + q^{\ell(|x|, \alpha_i)}xe'_{i\ell}(y)$ .

The property (3) above implies that  $\{b_{i\ell}x, y\} = \{b_{i\ell}, b_{i\ell}\}\{x, e'_{i\ell}(y)\}\$  for any  $x, y \in U^-$ .

For any family  $(t_{i\ell})_{(i,\ell)\in I^{\infty}}$  of non-zero elements in  $\mathbb{Q}(q)$ , there exists a unique nondegenerate symmetric bilinear form  $( , )_K : U^- \times U^- \to \mathbb{Q}(q)$  such that

(1.1) \qquad (1,1)_K=1, \; (\mathbf{b}_{i\ell}x,y)_K=t_{i\ell}(x,e'_{i\ell}(y))_K \text{ for all } (i,\ell)\in I^\infty \text{ and } x,y\in U^-.
$$

<span id="page-4-0"></span>Note that  $(x, yz)_K = (\rho(x), y \otimes z)_K$  for all  $x, y, z \in U^-$ .

**Proposition 1.3.** [\[5,](#page-25-5) Theorem 2.4] The algebra  $U^-$  is freely generated by  $b_{i\ell}$   $((i,\ell) \in I^{\infty})$ with the same relations as  $F_{i\ell}$ 's.

<span id="page-4-2"></span>Therefore, we have an algebra automorphism  $\Psi: U^- \to U^-$  given by

$$
(1.2) \quad \Psi(F_i) = F_i \text{ for } i \in I^+; \ \Psi(F_{i\ell}) = F_{i\ell} \text{ for } i \in I^0, \ell \ge 1; \ \Psi(\mathbf{b}_{i\ell}) = F_{i\ell} \text{ for } i \in I^-, \ell \ge 1.
$$

### 1.2. Quantum Borcherds-Bozec algebra  $U_q(\mathfrak{g})$ .

Assume we are given a Borcherds-Cartan datum  $(I, A, P, P^{\vee})$ . We denote by  $\widehat{U}$  the  $\mathbb{Q}(q)$ algebra generated by the elements  $q^h$   $(h \in P^{\vee})$  and  $E_{i\ell}, F_{i\ell}$   $((i, \ell) \in I^{\infty})$ , satisfying

$$
q^{0} = 1, \quad q^{h}q^{h'} = q^{h+h'} \text{ for } h, h' \in P^{\vee}
$$
  
\n
$$
q^{h}E_{j\ell}q^{-h} = q^{\ell\alpha_{j}(h)}E_{j\ell}, \quad q^{h}F_{j\ell}q^{-h} = q^{-\ell\alpha_{j}(h)}F_{j\ell} \text{ for } h \in P^{\vee}, (j,\ell) \in I^{\infty},
$$
  
\n
$$
\sum_{r+s=1-\ell a_{ij}} (-1)^{r}E_{i}^{(r)}E_{j\ell}E_{i}^{(s)} = 0 \text{ for } i \in I^{+}, (j,\ell) \in I^{\infty} \text{ and } i \neq (j,\ell),
$$
  
\n
$$
\sum_{r+s=1-l a_{ij}} (-1)^{r}F_{i}^{(r)}F_{j\ell}F_{i}^{(s)} = 0 \text{ for } i \in I^{+}, (j,\ell) \in I^{\infty} \text{ and } i \neq (j,\ell),
$$
  
\n
$$
E_{ik}E_{j\ell} - E_{j\ell}E_{ik} = F_{ik}F_{j\ell} - F_{j\ell}F_{ik} = 0 \text{ for } a_{ij} = 0.
$$

We extend the grading by setting  $|q^h| = 0$  and  $|E_{i\ell}| = \ell \alpha_i$ .

The algebra  $\widehat{U}$  is endowed with a co-multiplication  $\Delta : \widehat{U} \to \widehat{U} \otimes \widehat{U}$  given by

$$
\Delta(q^h) = q^h \otimes q^h,
$$
  
\n
$$
\Delta(E_{i\ell}) = \sum_{m+n=\ell} q_{(i)}^{mn} E_{im} K_i^n \otimes E_{in},
$$
  
\n
$$
\Delta(F_{i\ell}) = \sum_{m+n=\ell} q_{(i)}^{-mn} F_{im} \otimes K_i^{-m} F_{in},
$$

where  $K_i = q_i^{h_i}$   $(i \in I)$ .

Let  $\omega : \widehat{U} \to \widehat{U}$  be the  $\mathbb{Q}(q)$ -algebra involution given by

$$
\omega(q^h) = q^{-h}, \ \omega(E_{i\ell}) = F_{i\ell}, \ \omega(F_{i\ell}) = E_{i\ell} \ \text{ for } h \in P^{\vee}, \ (i,\ell) \in I^{\infty},
$$

and let  $\hat{U}^+$  (resp.  $\hat{U}^-$ , resp.  $\hat{U}^{\geq0}$ ) be the subalgebra of  $\hat{U}$  generated by  $E_{i\ell}$  ( $(i,\ell) \in I^{\infty}$ ) (resp.  $F_{i\ell}$   $((i,\ell) \in I^{\infty})$ , resp.  $E_{i\ell}$   $((i,\ell) \in I^{\infty})$  and  $q^h$   $(h \in P^{\vee})$ ). We identify  $\widehat{U}^-$  with the  $U^-$  defined in Section [1.1,](#page-2-0) and define a symmetric bilinear form  $\{\ ,\ \}$  on  $\hat{U}^{\geq 0}$  by setting

$$
\{x, y\} = \{\omega(x), \omega(y)\} \text{ for } x, y \in \widehat{U}^+,
$$
  

$$
\{q^h, 1\} = 1, \{q^h, E_{i\ell}\} = 0, \{q^h, K_j\} = q^{\alpha_j(h)}.
$$

Definition 1.4. By the Drinfeld double process, we define the quantum Borcherds-Bozec algebra  $U\left(U_q(\mathfrak{g})\right)$  as the quotient of  $\widehat{U}$  by the relations

\sum \{a_{(1)}, b_{(2)}\} \omega(b_{(1)}) a_{(2)} = \sum \{a_{(2)}, b_{(1)}\} a_{(1)} \omega(b_{(2)}) \text{ for all } a, b \in \widehat{U}^{\geq 0}.
$$

Here we use the Sweedler's notation and write  $\Delta(x) = \sum x_{(1)} \otimes x_{(2)}$ .

Let  $U^+$  (resp.  $U^-$ ) be the subalgebra of U generated by  $E_{i\ell}$  (resp.  $F_{i\ell}$ ) for  $(i, \ell) \in I^{\infty}$ . The subalgebra  $U^-$  is coincide with Definition [1.1.](#page-2-0) Set  $a_{i\ell} = \omega(b_{i\ell}) \in U^+_{\ell \alpha}$  $t_{\alpha_i}^+$  for each  $(i, \ell) \in I^{\infty}$ . The equation [\(1.3\)](#page-5-0) yields

$$
\mathtt a_{i\ell}\mathtt b_{jk} - \mathtt b_{jk}\mathtt a_{i\ell} = \delta_{ij}\delta_{\ell k}\{\mathtt b_{i\ell},\mathtt b_{i\ell}\}(K_i^{-\ell} - K_i^{\ell}).

Let  $\Lambda \in P^+$ . The irreducible highest weight  $U_q(\mathfrak{g})$ -module  $V(\Lambda)$  is given by (1.4)

V(\Lambda) \cong U \Bigg/ \Big( \sum_{(i,\ell) \in I^{\infty}} U E_{i\ell} + \sum_{h \in P^{\vee}} U(q^h - q^{\Lambda(h)}) + \sum_{i \in I^+} U F_i^{\Lambda(h_i)+1} + \sum_{i \in I^{\leq 0} \text{ with } \Lambda(h_i) = 0; \ \ell \geq 1} U F_{i\ell} \Big)
$$
  

$$
\cong U^- \Bigg/ \Big( \sum_{i \in I^+} U^- F_i^{\Lambda(h_i)+1} + \sum_{i \in I^{\leq 0} \text{ with } \Lambda(h_i) = 0; \ \ell \geq 1} U^- F_{i\ell} \Big).
$$

## 2. Categorification of  $U^-$  via primitive generators

## 2.1. Identify  $U^-$  with a quantum Borcherds algebra.

Let  $A = (a_{ij})_{i,j\in I}$  be a Borcherds-Cartan matrix that can be symmetrized by  $D = \text{diag}(r_i \in$  $\mathbb{Z}_{>0}$  |  $i \in I$ ). Denote by  $\tilde{A} = (a_{(i,\ell)(j,k)})_{(i,\ell),(j,k)\in I^{\infty}}$  the matrix indexed by  $I^{\infty}$  with each  $a_{(i,\ell)(j,k)} = k \ell a_{ij}$ . It is also a Borcherds-Cartan matrix with symmetrizer  $\tilde{D} = \text{diag}(r_{i\ell})$  $(i, \ell) \in I^{\infty}$ ) such that  $r_{i\ell} = r_i$  for all  $\ell \geq 1$ . Assign a symmetric bilinear form  $\alpha, \alpha' \mapsto \alpha \cdot \alpha'$ on  $\mathbb{Z}[I^{\infty}]$  such that

$$
(i, \ell) \cdot (j, k) = r_i k \ell a_{ij} = r_j k \ell a_{ji}
$$
 for all  $(i, \ell), (j, k) \in I^{\infty}$ .

For such a Borcherds-Cartan datum  $(I^{\infty}, \tilde{A}, \cdot)$ , we can define a quantum Borcherds algebra  $\widetilde{U}^-$  which is generated by  $\vartheta_{i,\ell}$   $((i,\ell) \in I^{\infty})$ , satisfying

$$
\sum_{r+s=1-\ell a_{ij}} (-1)^r \vartheta_i^{(r)} \vartheta_{j\ell} \vartheta_i^{(s)} = 0 \text{ for } i \in I^+, (j,\ell) \in I^{\infty} \text{ and } i \neq (j,\ell),
$$
  

$$
\vartheta_{i\ell} \vartheta_{jk} - \vartheta_{jk} \vartheta_{i\ell} = 0 \text{ for } a_{(i,\ell)(j,k)} = 0 \text{ (equivalently for } a_{ij} = 0).
$$

The algebra  $\tilde{U}^-$  is N[I∞]-graded by assigning  $|\vartheta_{i\ell}| = (i, \ell)$ .

Define a twisted multiplication on  $\widetilde{U}^- \otimes \widetilde{U}^-$  by

$$
(x_1 \otimes x_2)(y_1 \otimes y_2) = q^{-|x_2|\cdot|y_1|} x_1 y_1 \otimes x_2 y_2,
$$

for homogeneous  $x_1, x_2, y_1, y_2$  in  $\widetilde{U}^-$ . We have an algebra homomorphism  $\widetilde{\rho}: \widetilde{U}^- \to \widetilde{U}^- \otimes \widetilde{U}^$ given by  $\tilde{\rho}(\vartheta_{i\ell}) = \vartheta_{i\ell} \otimes 1 + 1 \otimes \vartheta_{i\ell}$  ( $(i, \ell) \in I^{\infty}$ ) and a nondegenerate symmetric bilinear form  $\langle , \rangle : \tilde{U}^- \times \tilde{U}^- \to \mathbb{Q}(q)$  satisfying the following properties

- (i)  $\langle x, y \rangle = 0$  if  $|x| \neq |y|$ ,
- (ii)  $\langle 1, 1 \rangle = 1$ ,
- (iii)  $\langle \vartheta_{i\ell}, \vartheta_{i\ell} \rangle = (1 q_i^2)^{-1}$  for all  $(i, l) \in I^{\infty}$ ,
- (iv)  $\langle x, yz \rangle = \langle \widetilde{\rho}(x), y \otimes z \rangle$  for  $x, y, z \in \widetilde{U}$ .

Let  $\mathcal{A} = \mathbb{Z}[q, q^{-1}]$  be the ring of Laurent polynomials. The  $\mathcal{A}$ -form  $\mathcal{A}\overline{U}^-$  is the  $\mathcal{A}$ -subalgebra of  $\widetilde{U}^-$  generated by the divided powers  $\vartheta_i^{(n)}$  $i^{(n)}$  for  $i \in I^+, n \in \mathbb{Z}_{>0}$  and  $\vartheta_{i\ell}$  for  $i \in I^{\leq 0}, \ell \geq 1$ .

Denote by  $\bar{ }$  the Q-algebra involution of  $\tilde{U}^-$  given by  $\bar{q} = q^{-1}$  and  $\bar{\vartheta}_{i\ell} = \vartheta_{i\ell}$  for all  $(i, l) \in I^{\infty}$ . By Proposition [1.2](#page-3-0) and Proposition [1.3,](#page-4-0) we have the following theorem.

<span id="page-6-0"></span>**Theorem 2.1.** There exists a twisted bialgebras isomorphism from  $U^-$  to  $\widetilde{U}^-$  which sends  $\mathbf{b}_{i\ell}$ to  $\vartheta_{i\ell}$  for all  $(i,\ell) \in I^{\infty}$ . Under this isomorphism, the comultiplication  $\rho$  of  $U^-$  corresponds to  $\widetilde{\rho}$  of  $\widetilde{U}^-$ . If we set  $t_{i\ell} = (1 - q_i^2)^{-1}$  in [\(1.1\)](#page-4-1) for all  $(i, \ell) \in I^{\infty}$ , then the form  $( , )_K$  on  $U^$ corresponds to  $\langle , \rangle$  on  $\tilde{U}$ <sup>−</sup>. Moreover, this map preserves the bar-involutions and send the  $\mathcal{A}\text{-subalgebra of } U^-$  generated by  $\mathtt{b}^{(n)}_i$  $i^{(n)}$  for  $i \in I^+$  and  $\mathbf{b}_{i\ell}$  for  $i \in I^-$  to  $\mathcal{A}\widetilde{U}^-$ .

## 2.2. Categorification of  $\tilde{A}U^-$ .

From now on, we fix an algebraically closed field  $\mathbb K$  with char $\mathbb K = 0$ . Let A be a Z-graded K-algebra. For a graded A-module  $M = \bigoplus_{n \in \mathbb{Z}} M_n$ , its graded dimension is defined to be

$$
\mathbf{Dim} M = \sum_{n \in \mathbb{Z}} (\dim_{\mathbb{K}} M_n) q^n,
$$

where q is a formal variable. For  $m \in \mathbb{Z}$ , the degree shift  $M\{m\}$  is the graded A-module obtained from M by putting  $(M{m})_n = M_{n-m}$ . More generally, for  $f(q) = \sum_{m \in \mathbb{Z}} a_m q^m$  $\mathbb{N}[q, q^{-1}],$  we set  $M^f = \bigoplus_{m \in \mathbb{Z}} (M\{m\})^{\oplus a_m}.$ 

Given two graded A-modules M and N, we denote by  $\text{Hom}_{A\text{-}\text{gr}}(M, N)$  the K-vector space of grading-preserving homomorphisms and form the Z-graded vector space

$$
\mathrm{HOM}_A(M,N) = \bigoplus_{n \in \mathbb{Z}} \mathrm{Hom}_{A\text{-}\mathrm{gr}}(M\{n\},N) = \bigoplus_{n \in \mathbb{Z}} \mathrm{Hom}_{A\text{-}\mathrm{gr}}(M,N\{-n\}).
$$

A categorification of quantum Borcherds algebra associated with an arbitrary Borcherds Cartan datum has been built in [\[15\]](#page-26-8). We can apply the construction there directly to the Borcherds Cartan datum  $(I^{\infty}, \tilde{A}, \cdot)$  to categorify  ${}_{\mathcal{A}}\tilde{U}^-$ , and then  $U^-$  immediately.

Denote by X the set of equivalence classes of sequences in  $I^{\infty}$ , two sequences are equivalent if they permute each others. Let  $\nu \in \mathcal{X}$ . If  $(i_1, \ell_1) \dots (i_n, \ell_n) \in \nu$ , then we set  $|\nu| = (i_1, \ell_1) +$  $\cdots + (i_n, \ell_n) \in \mathbb{N}[I^{\infty}]$ . We could identify  $\nu$  with  $|\nu|$  since  $\nu$  is uniquely determined by it.

For  $\nu, \nu' \in \mathcal{X}$ , we set  $\nu + \nu'$  (or  $\nu \cup \nu'$ ) to be the concatenation of  $\nu$  and  $\nu'$ . If  $\nu'$  is a part of v, we set  $\nu - \nu'$  (or  $\nu\setminus\nu'$ ) to be the equivalence class obtained from v by removing  $\nu'$ .

Fix an  $\nu \in \mathcal{X}$  of length n. We define the algebra  $\mathcal{R}(\nu)$  to be the K-algebra with the homogeneous generators given by diagrams (see [\[9\]](#page-26-0) for a detailed explanation of the braidlike planar diagrams):

For  $i, j \in \nu$ , we set  $i \mathcal{R}(\nu)j = 1_i \mathcal{R}(\nu)1_j$ . Then  $i \mathcal{R}(\nu)j$  has a basis

where  $\widehat{\omega}_j \in i\mathcal{R}(\nu)_j$  is uniquely determined by a fixed reduced expression of  $\omega$ .

Denote by

 $\mathcal{R}(\nu)$ -Mod : the category of finitely generated graded  $\mathcal{R}(\nu)$ -modules,  $\mathcal{R}(\nu)$ -fMod : the category of finite-dimensional graded  $\mathcal{R}(\nu)$ -modules,  $\mathcal{R}(\nu)$ -pMod : the category of projective objects in  $\mathcal{R}(\nu)$ -Mod.

Let  $K_0(\mathcal{R}(\nu))$  (resp.  $G_0(\mathcal{R}(\nu))$  be the Grothendieck group of  $\mathcal{R}(\nu)$ -pMod (resp.  $\mathcal{R}(\nu)$ -fMod). They are free  $\mathbb{Z}[q, q^{-1}]$ -module with  $q[M] = [M\{1\}]$ . Set  $\mathcal{R} = \bigoplus_{\nu \in \mathcal{X}} \mathcal{R}(\nu)$  and form

$$
G_0(\mathcal{R}) = \bigoplus_{\nu \in \mathcal{X}} G_0(\mathcal{R}(\nu)), \ K_0(\mathcal{R}) = \bigoplus_{\nu \in \mathcal{X}} K_0(\mathcal{R}(\nu)).
$$

The  $K_0(\mathcal{R})$  and  $G_0(R)$  are equipped with twisted bialgebras structure induced by the induction and restriction functors:

$$
\operatorname{Ind}_{\nu,\nu'}^{\nu+\nu'}: \mathcal{R}(\nu) \otimes \mathcal{R}(\nu')\text{-Mod} \to \mathcal{R}(\nu+\nu')\text{-Mod}, \ M \mapsto \mathcal{R}(\nu+\nu')1_{\nu,\nu'} \otimes_{\mathcal{R}(\nu)\otimes \mathcal{R}(\nu')} M,
$$

\operatorname{Res}_{\nu,\nu'}^{\nu+\nu'}: \mathcal{R}(\nu+\nu')\text{-Mod} \to \mathcal{R}(\nu) \otimes \mathcal{R}(\nu')\text{-Mod}, \ N \mapsto 1_{\nu,\nu'}N,
$$

where  $1_{\nu,\nu'} = 1_{\nu} \otimes 1_{\nu'}$ . More precisely, we set  $|x| = |\nu| \in \mathbb{N}[I^{\infty}]$  for  $x \in \mathcal{R}(\nu)$ -Mod and equip  $K_0(\mathcal{R}) \otimes K_0(\mathcal{R})$  (resp.  $G_0(R) \otimes G_0(R)$ ) with a twisted algebra structure via

$$
(x_1 \otimes x_2)(y_1 \otimes y_2) = q^{-|x_2|\cdot|y_1|} x_1 y_1 \otimes x_2 y_2,
$$

then Res is a  $\mathbb{Z}[q, q^{-1}]$ -algebra homomorphism by Mackey's Theorem [\[9,](#page-26-0) Proposition 2.18].

The  $K_0(\mathcal{R})$  and  $G_0(\mathcal{R})$  are dual to each other with respect to the bilinear pairing (,):  $K_0(\mathcal{R}) \times G_0(\mathcal{R}) \to \mathbb{Z}[q, q^{-1}]$  given by

where  $\psi$  is the anti-involution of  $\mathcal{R}(\nu)$  obtained by flipping the diagrams about horizontal axis and it turns a left  $\mathcal{R}(\nu)$ -module into right,  $\overline{P} = \text{HOM}(P, \mathcal{R}(\nu))^{\psi}$ . There is also a symmetric bilinear form (, ) :  $K_0(\mathcal{R}) \times K_0(\mathcal{R}) \to \mathbb{Z}((q))$  defined in the same way.

<span id="page-9-0"></span>For  $i \in \nu$ , we set  $P_i = \mathcal{R}(\nu)1_i \in \mathcal{R}(\nu)$ -pMod. For  $i \in I^+$  and  $n \geq 0$ , we set

$$

where  $e_{i,n}$  is the primitive idempotent  $x_{1,ni}^{n-1}x_{2,ni}^{n-2}\cdots x_{n-1,ni} \cdot \tau_{\omega_0}$  of  $\mathcal{R}(ni)$  with  $\omega_0$  being the longest element in  $S_n$ .

**Theorem 2.2.** [\[15\]](#page-26-8) There is a A-bialgebras isomorphism  $\gamma : A\widetilde{U}^- \to K_0(\mathcal{R})$  which sends  $\mathcal{A} \widetilde{U}_{|\nu|}$  onto  $K_0(\mathcal{R}(\nu))$  for each  $\nu \in \mathcal{X}$ , given by

$$
\vartheta_i^{(n)} \mapsto [P_{i^{(n)}}] \quad \text{for } i \in I^+, n \ge 0,
$$

\vartheta_{i\ell} \mapsto [P_{(i,\ell)}] \quad \text{for } i \in I^-, \ell \ge 1.

Under this isomorphism, the form  $\langle , \rangle$  on  $\mathcal{A}\tilde{U}^-$  corresponds to the form  $( , \cdot )$  on  $K_0(\mathcal{R})$ , the bar-involution of  $\tilde{A}U^-$  corresponds to the involution  $P \mapsto \overline{P}$  of  $K_0(\mathcal{R}(\nu))$ .

It follows from Theorem [2.1](#page-6-0) that the quantum Borcherds-Bozec algebra  $U^-$  is isomorphic to  $K_0(\mathcal{R})_{\mathbb{Q}(q)} = \mathbb{Q}(q) \otimes_{\mathbb{Z}[q,q^{-1}]} K_0(\mathcal{R})$  as bialgebras, which sends the primitive generators  $\mathbf{b}_{i\ell}$ to  $[P_{(i,\ell)}]$  for all  $(i,\ell) \in I^{\infty}$ . If we take the values  $t_{i\ell} = (1 - q_i^2)^{-1}$  for all  $(i,\ell) \in I^{\infty}$  in  $(1.1)$ , then the form (, )<sub>K</sub> on  $U^-$  corresponds to the Khovanov-Lauda's form on  $K_0(\mathcal{R}(\nu))_{\mathbb{Q}(q)}$ .

## 3. Categorification of  $U^-$  via  $F_{il}$  for  $i \in I^0$

We give another way to categorify the  $U^-$ .

#### 3.1. Khovanov-Lauda-Rouquier algebras  $R(\nu)$ .

Given a Bocherds-Cartan datum  $(I, A, P, P^{\vee})$ . Let  $U^-$  be the associated quantum Borcherds-Bozec algebra. We use the nondegenerate symmetric bilinear form  $\{\ ,\ \}$  on  $U^-$  which takes some specific values for  $F_{i\ell}$   $((i,\ell) \in I^{\infty})$ :

$$
\{F_{i\ell}, F_{i\ell}\} = \begin{cases} 1/(1-q_i^2) & \text{for } i \in I^+, \\ 1/(1-q_i^2)(1-q_i^4)\cdots(1-q_i^{2\ell}) & \text{for } i \in I^0 \text{ and } \ell \ge 1, \end{cases}
$$

and if  $i \in I^-$ , the value  $\{F_{i\ell}, F_{i\ell}\}\)$  for each  $\ell \geq 1$  leads to  $\{\mathbf{b}_{i\ell}, \mathbf{b}_{i\ell}\} = 1/(1 - q_i^2)$ .

Note that this setting satisfy the requirement  $\{F_{i\ell}, F_{i\ell}\} \equiv 1 \pmod{q}$  for all  $(i, \ell) \in I^{\infty}$ .

Let  $\mathbb{I} = I^+ \cup I^0 \cup (I^- \times \mathbb{Z}_{>0})$ . We assign a graph  $\Upsilon$  with vertices set  $\mathbb{I}$  and an edge between  $(i, \ell) \neq (j, k)$  when  $a_{ij} \neq 0$ . Denote by Y the set of equivalence classes of sequences in I, two sequences are equivalent if they permute each others. Let  $\nu \in \mathcal{Y}$ . If  $(i_1, \ell_1) \dots (i_n, \ell_n) \in \nu$ , then we set  $\ell(\nu) = n$  and  $|\nu| = \ell_1 \alpha_{i_1} + \cdots + \ell_n \alpha_{i_n} \in Q_+$ .

Fix an  $\nu \in \mathcal{Y}$  of length n. We define the algebra  $R(\nu)$  to be the K-algebra with the homogeneous generators given by diagrams:

$$

For  $i, j \in \nu$ , we set  $iR(\nu)_i = 1_jR(\nu)1_i$ , then  $R(\nu) = \bigoplus_{i,j} iR(\nu)_i$ . Denote by  $P_i = R(\nu)1_i$ (resp.  $jP = 1_jR(\nu)$ ) the gr-projective left (resp. right)  $R(\nu)$ -module.

For  $i \in \nu$ , set  $\mathscr{P}_i = \mathbb{K}[x_1(i), \ldots, x_n(i)]$  and form the K-vector space  $\mathscr{P}_\nu = \bigoplus_{i \in \nu} \mathscr{P}_i$ . Each  $\omega \in S_n$  acts on  $\mathscr{P}_{\nu}$  by sending  $x_a(i)$  to  $x_{\omega(a)}(\omega(i))$ .

Choose an orientation for each edge of  $\Upsilon$ . We define an action of  $R(\nu)$  on  $\mathscr{P}_{\nu}$  as follows.  $jR(\nu)_i$  acts by 0 on  $\mathscr{P}_k$  if  $i \neq k$ . For  $f \in \mathscr{P}_i$ , we set  $1_i \cdot f = f$ ,  $x_{k,i} \cdot f = x_k(i)f$  and then suppose  $i_k = (i, \ell), i_{k+1} = (j, t)$ , we set

It's easy to check  $\mathscr{P}_{\nu}$  is an  $R(\nu)$ -module with the action defined above.

### 3.2. Algebras  $R(n(i, \ell))$  and their gr-irreducible modules.

Fix  $(i, \ell) \in \mathbb{I}$  and  $n \geq 0$ . Let  $\nu = n(i, \ell) \in \mathcal{Y}$  that has only one sequence  $\mathbf{i} = (i, \ell) \dots (i, \ell)$  $\overbrace{\qquad \qquad n}$ . The algebra  $R(n(i, \ell))$  is generated by  $x_{1,i}, \ldots, x_{n,i}$  of degree  $2r_i$  and  $\tau_{1,i}, \ldots, \tau_{n-1,i}$  of degree  $-\ell^2 r_i a_{ii}$ , subject to the following local relations:

$$

We will abbreviate  $x_{k,i}$  (resp.  $\tau_{k,i}$ ) to  $x_k$  (resp.  $\tau_k$ ). In all cases,  $R(n(i, \ell))$  has a basis  ${x_1^{r_1} \cdots x_n^{r_n} \tau_\omega \mid \omega \in S_n, r_1, \ldots, r_n \geq 0}.$  Indeed, for instance, if  $i \in I^0$  or  $I^-$ , we just need consider the actions of these elements on  $x_1^N x_2^N \cdots x_n^{nN}$  for  $N \gg 0$ .

Therefore, we could identify the polynomial algebra  $P_n = \mathbb{K}[x_1, \ldots, x_n]$  with the subalgebra of  $R(n_i)$  generated by  $x_1, \ldots, x_n$ . Then the center of  $R(n(i, \ell))$  is  $Z_n$ , the algebra of symmetric polynomials in  $x_1, \ldots, x_n$ .

Let  $i \in I^+$ . By the representation theory of the nil-Hecke algebras,  $R(ni)$  has a unique gr-irreducible module  $V(i^n)$  of graded dimension [n]<sub>i</sub>!, which is isomorphic to  $R(ni) \otimes_{P_n}$  $\mathbf{1}_n \left\{ \frac{n(n-1)}{2} \right\}$  $\left\{\frac{n-1}{2}\cdot r_i\right\}$ , where  $\mathbf{1}_n$  is the one-dimensional trivial module over  $P_n$  with each  $x_k$  acts by 0. The gr-projective cover of  $V(i^n)$  is  $P_{i^{(n)}}$  (see [\(2.7\)](#page-9-0)).

Let  $i \in I^-$ , since  $R(n(i, \ell))$  has only trivial idempotents, it has a unique gr-irreducible module  $V((i,\ell)^n)$ , which is the one-dimensional trivial module with the gr-projective cover  $R(n(i, \ell)).$ 

Now let  $i \in I^0$ . Note that  $R(ni)_0$  is just the symmetric group algebra  $\mathbb{K}S_n$ . Since char $\mathbb{K} =$ 0, it's well known that  $K\mathcal{S}_n$  has  $|\mathcal{P}_n|$  many irreducible modules that can be labelled by the partitions of n.

Let V be an irreducible  $K\mathcal{S}_n$ -module (also an indecomposable projective module). Then

$$
\widetilde{V} := R(ni) \otimes_{R(ni)_0} V \Big/ R(ni)_{>0} \otimes_{R(ni)_0} V
$$

is a gr-irreducible  $R(ni)$ -module. In other words,  $\tilde{V}$  is obtained form V with the actions of  $x_1, \ldots, x_n$  by 0. All gr-irreducible  $R(ni)$ -modules obtained in this way. When no confusion arises, we still write  $V$  for  $\overline{V}$ .

We have shown the following:

**Proposition 3.1.** If  $V_1, \ldots, V_{|\mathcal{P}_n|}$  is a complete set of non-isomorphic classes of irreducible  $\mathbb{K}S_n$ -modules, then  $V_1,\ldots,V_{|\mathcal{P}_n|}$  is a complete set of non-isomorphic classes of gr-irreducible  $R(ni)$ -modules. In particular, the gr-Jacoboson radical  $J^{gr}(R(ni)) = R(ni)_{>0}$ .

Let  $V_{i,n}$  be the one-dimensional trivial module over  $\mathbb{K}S_n$ . Then

$$
V_{i,n} = \mathbb{K}S_n \cdot e_{i,n} = \mathbb{K} \cdot e_{i,n},
$$

where  $e_{i,n} = \frac{1}{n}$  $\frac{1}{n!} \sum_{\omega \in S_n} \omega$ . If  $r + t = n$ , then the restriction to  $\mathbb{K}S_r \otimes \mathbb{K}S_t$ -modules gives

$$
\mathrm{Res}^n_{r,t}V_{i,n}\cong V_{i,r}\otimes V_{i,t}=\mathbb{K}S_n\cdot e_{i,r}\otimes \mathbb{K}S_n\cdot e_{i,t}.
$$

The gr-projective cover of  $R(ni)$ -module  $V_{i,n}$  is  $P_{i,n} = R(ni)e_{i,n}$ , which has a basis  $\{x_1^{r_1} \cdots x_n^{r_n} \cdot$  $e_{i,n} | r_1, \ldots, r_n \geq 0$ . The restriction of  $P_{i,n}$  to  $R(ri) \otimes R(ii)$ -modules gives

(3.6) 
$$
\operatorname{Res}_{r,t}^n P_{i,n} \cong P_{i,r} \otimes P_{i,t}.
$$

Since  $e_{i,n}R(ni)e_{i,n}$  is spanned by  $\{f \cdot e_{i,n} | f \in Z_n\}$ , we see that

(3.7) \qquad (P_{i,n}, P_{i,n}) = \mathbf{Dim}(e_{i,n}R(ni)e_{i,n}) = \mathbf{Dim}\ Z_n = 1/(1-q_i^2)(1-q_i^4)\cdots(1-q_i^{2n}).
$$

Here, ( , ) is the Khovanov-Lauda's form defined in [\(2.6\)](#page-9-1).

#### 3.3. Grothendieck groups  $K_0(R)$  and  $G_0(R)$ .

Let  $i, j \in \nu$ . Using the polynomial representation  $\mathcal{P}_{\nu}$  of  $R(\nu)$ , one can obtain by a similar argument in [\[9,](#page-26-0) Theorem 2.5] that  $\mathscr{P}_{\nu}$  is a faithful  $R(\nu)$ -module and  $iR(\nu)$  has a basis

$$
\{x_{1,i}^{u_1}\cdots x_{n,i}^{u_n}\cdot\widehat{\omega}_j\mid u_1,\ldots,u_n\in\mathbb{N},\ \omega\in S_n\ \text{such that}\ \omega(j)=i\},\
$$

where  $\widehat{\omega}_j \in iR(\nu)_j$  is uniquely determined by a fixed reduced expression of  $\omega$ .

Assume  $\nu$  contains a sequence  $(i_1, \ell_1)^{m_1} \cdots (i_t, \ell_t)^{m_t}$  such that  $(i_1, \ell_1), \ldots, (i_t, \ell_t)$  are all distinct. Similar to [\[9,](#page-26-0) Theorem 2.9], the center  $Z(R(\nu))$  of  $R(\nu)$  can be described as

$$
Z(R(\nu)) \cong \bigotimes_{k=1}^t \mathbb{K}[z_1,\ldots,z_{m_k}]^{S_{m_k}},
$$

the latter is a tensor product of symmetric polynomial algebras such that the generators in  $\mathbb{K}[z_1,\ldots,z_{m_k}]$  are of degree  $2r_{i_k}$ . Moreover,  $R(\nu)$  is a free  $Z(R(\nu))$ -module of rank  $((m_1 +$  $\cdots + m_t)!$ ? It is also a gr-free  $Z(R(\nu))$ -module of finite rank. So we have

$$
\mathbf{DimZ}(R(\nu)) = \prod_{k=1}^t \left( \prod_{c=1}^{m_k} \frac{1}{1 - q_{i_k}^{2c}} \right)
$$

and  $\text{Dim}_R(\nu) \in \mathbb{Z}[q, q^{-1}] \cdot \text{Dim}_Z(R(\nu)).$ 

Up to isomorphism and degree shifts, each  $R(\nu)$  has only finitely many gr-irreducible modules, all of which are finite-dimensional and are irreducible  $R(\nu)$ -modules by forgetting the grading. Let  $\mathbb{B}_{\nu}$  be the set of equivalence classes of gr-irreducible  $R(\nu)$ -modules. Choose one representative  $S_b$  from each equivalence class and denote by  $P_b$  the gr-projective cover of  $S_b$ . The Grothendieck group  $G_0(R(\nu))$  (resp.  $K_0(R(\nu))$ ) of  $R(\nu)$ -fMod (resp.  $R(\nu)$ -pMod) are free  $\mathbb{Z}[q, q^{-1}]$ -modules with a basis  $\{[S_b]\}_{b \in \mathbb{B}_{\nu}}$  (resp.  $\{[P_b]\}_{b \in \mathbb{B}_{\nu}}$ ).

Let  $R = \bigoplus_{\nu \in \mathcal{Y}} R(\nu)$  and form

$$
G_0(R) = \bigoplus_{\nu \in \mathcal{Y}} G_0(R(\nu)), \ K_0(R) = \bigoplus_{\nu \in \mathcal{Y}} K_0(R(\nu)).
$$

If we set  $|x| = |\nu| \in \mathbb{N}[I]$  for  $x \in R(\nu)$ -Mod and equip  $K_0(R) \otimes K_0(R)$  (resp.  $G_0(R) \otimes G_0(R)$ ) with a twisted algebra structure via

$$
(x_1 \otimes x_2)(y_1 \otimes y_2) = q^{-(|x_2|, |y_1|)} x_1 y_1 \otimes x_2 y_2.
$$

Then by Mackey's Theorem [\[9,](#page-26-0) Proposition 2.18],  $G_0(R)$  and  $K_0(R)$  are twisted bialgebras induced by the induction and restriction functors:

$$
\text{Ind}_{\nu,\nu'}^{\nu+\nu'}: R(\nu) \otimes R(\nu')\text{-Mod} \to R(\nu+\nu')\text{-Mod}, \ M \mapsto R(\nu+\nu')1_{\nu,\nu'} \otimes_{R(\nu)\otimes R(\nu')} M,
$$
  

$$
\text{Res}_{\nu,\nu'}^{\nu+\nu'}: R(\nu+\nu')\text{-Mod} \to R(\nu) \otimes R(\nu')\text{-Mod}, \ N \mapsto 1_{\nu,\nu'}N.
$$

The  $K_0(R)$  and  $G_0(R)$  are  $\mathbb{Z}[q, q^{-1}]$ -modules with respect to the bilinear pairing defined in [\(2.6\)](#page-9-1). By [\(3.7\)](#page-13-0) and [\[9,](#page-26-0) Proposition 3.3], the symmetric bilinear form (, ):  $K_0(R) \times K_0(R) \rightarrow$  $\mathbb{Z}((q))$  satisfies

- (1)  $([M], [N]) = 0$  if  $M \in R(\nu)$ -Mod,  $N \in R(\mu)$ -Mod with  $\nu \neq \mu$ .
- (2)  $(1, 1) = 1$ , where  $1 = K$  as a module over  $R(0) = K$ . (3)  $([P_i], [P_i]) = 1/(1 - q_i^2)$  for  $i \in I^+$  and  $P_i = R(i)1_i$ ;  $([P_{(i,\ell)}],[P_{(i,\ell)}]) = 1/(1-q_i^2) \text{ for } i \in I^- \text{ and } P_{(i,\ell)} = R((i,\ell))1_{(i,\ell)};$  $([P_{i,\ell}], [P_{i,\ell}]) = 1/(1 - q_i^2)(1 - q_i^4) \cdots (1 - q_i^{2\ell}) \text{ for } i \in I^0 \text{ and } P_{i,\ell} = R(\ell i) e_{i,\ell}.$ (4)  $(x, yz) = (\text{Res}(x), y \otimes z)$  for  $x, y, z \in K_0(R)$ .

A sequence with 'divided powers' for  $i \in I^+$  is of the form

$$
\mathbf{i}=(j_1,a_1)\ldots(j_{p_0},a_{p_0})i_1^{(m_1)}(k_1,b_1)\ldots(k_{p_1},b_{p_1})i_2^{(m_2)}\ldots i_t^{(m_t)}(h_1,c_1)\ldots(h_{p_t},c_{p_t}),
$$

where  $i_1, \ldots, i_t \in I^+$  and the others belong to I. For such an  $i$ , assign the following idempotent

$$
1_{\mathbf{i}} = 1_{(j_1, a_1)\dots(j_{p_0}, a_{p_0})} \otimes e_{i_1, m_1} \otimes 1_{(k_1, b_1)\dots(k_{p_1}, b_{p_1})} \otimes e_{i_2, m_2} \otimes \dots \otimes e_{i_t, m_t} \otimes 1_{(h_1, c_1)\dots(h_{p_t}, c_{p_t})},
$$
  
where  $e_{i,m} = x_1^{m-1} x_2^{m-2} \cdots x_{m-1} \tau_{\omega_0}$ , and set  $\langle \mathbf{i} \rangle = \sum_{k=1}^t \frac{m_k(m_k-1)}{2} r_{i_k}$  and  

$$
{}_{\mathbf{i}} P = 1_{\mathbf{i}} R(\nu) \{-\langle \mathbf{i} \rangle\}, P_{\mathbf{i}} = R(\nu) \psi(1_{\mathbf{i}}) \{-\langle \mathbf{i} \rangle\}.
$$

<span id="page-15-0"></span>**Proposition 3.2.** Assume  $i \in I^+$ ,  $j \in I$  and  $i \neq j$ . Let  $n \in \mathbb{Z}_{>0}$  and  $m = 1 - na_{ij}$ . We have isomorphisms of graded left  $R(\nu)$ -modules

$$
\label{eq:2.1} \begin{split} &\lfloor \tfrac{m}{2} \rfloor \\ \bigoplus_{c=0}^{\lfloor \tfrac{m}{2} \rfloor} P_{i^{(2c)}j^{n}i^{(m-2c)}} \cong \bigoplus_{c=0}^{\lfloor \tfrac{m-1}{2} \rfloor} P_{i^{(2c+1)}j^{n}i^{(m-2c-1)}} \quad if \: j \in I^+, \\ &\lfloor \tfrac{m}{2} \rfloor \\ \bigoplus_{c=0}^{\lfloor \tfrac{m}{2} \rfloor} P_{i^{(2c)}(j,n)i^{(m-2c)}} \cong \bigoplus_{c=0}^{\lfloor \tfrac{m-1}{2} \rfloor} P_{i^{(2c+1)}(j,n)i^{(m-2c-1)}} \quad if \: j \in I^-, \end{split}

\bigoplus_{c=0}^{\lfloor \frac{m}{2} \rfloor} R(i^m j^n) \psi(e_{i,2c} \otimes e_{j,n} \otimes e_{i,m-2c}) \langle i^{(2c)} i^{(m-2c)} \rangle \cong

\bigoplus_{c=0}^{\lfloor \frac{m-1}{2} \rfloor} R(i^m j^n) \psi(e_{i,2c+1} \otimes e_{j,n} \otimes e_{i,m-2c-1}) \langle i^{(2c+1)} i^{(m-2c-1)} \rangle \quad \text{if } j \in I^0.

Moreover, assume  $a_{ij} = 0$ , then

$$
P_{(i,\ell)(j,k)} \cong P_{(i,\ell)(j,k)} \quad \text{if } (i,\ell), (j,k) \in \mathbb{I},

R(i^{\ell}(j,k)) \cdot e_{i,\ell} \otimes 1_{(j,k)} \cong R(i^{\ell}(j,k)) \cdot 1_{(j,k)} \otimes e_{i,\ell} \quad \text{if } i \in I^0, (j,k) \in \mathbb{I},
$$

$$
R(i^{\ell}j^{k}) \cdot e_{i,\ell} \otimes e_{j,k} \cong R(i^{\ell}j^{k}) \cdot e_{j,k} \otimes e_{i,\ell} \quad \text{if } i, j \in I^0.

Proof. The proof is the same as the 'Box' calculations in [\[10\]](#page-26-1). We only explain the last isomorphism. Let  $i, j \in I^0$  with  $a_{ij} = 0$ . Note that



The right multiplication by

is a map from  $R(i^{\ell} j^k) \cdot e_{i,\ell} \otimes e_{j,k}$  to  $R(i^{\ell} j^k) \cdot e_{j,k} \otimes e_{i,\ell}$ , which has the obvious inverse by flipping this diagram.  $\Box$

Let  $K_0(R)_{\mathbb{Q}(q)} = \mathbb{Q}(q) \otimes_{\mathbb{Z}[q,q^{-1}]} K_0(R)$ . By [\(3.6\)](#page-13-1), Proposition [1.3](#page-4-0) and Proposition [3.2,](#page-15-0) we have a well-defined bialgebra homomorphism

$$
\Gamma_{\mathbb{Q}(q)} : U^- \to K_0(R)_{\mathbb{Q}(q)}
$$
\n
$$
F_i \mapsto [P_i] \qquad \text{for } i \in I^+
$$
\n
$$
F_{i\ell} \mapsto [P_{i,\ell}] \qquad \text{for } i \in I^0, \ell \ge 1
$$
\n
$$
\flat_{i\ell} \mapsto [P_{(i,\ell)}] \qquad \text{for } i \in I^-, \ell \ge 1
$$

Now, the bilinear form  $\{\ ,\ \}$  on  $U^-$  and the Khovanov-Lauda's form  $(\ ,\ )$  on  $K_0(R)_{\mathbb{Q}(q)}$ coincide under the map  $\Gamma_{\mathbb{Q}(q)}$ , that is

$$
(\Gamma_{\mathbb{Q}(q)}(x), \Gamma_{\mathbb{Q}(q)}(y)) = \{x, y\} \text{ for } x, y \in U^-.
$$

Thus  $\Gamma_{\mathbb{Q}(q)}$  is injective by the non-degeneracy of  $\{\ ,\ \}$ . Moreover, we have

$$
\Gamma_{\mathbb{Q}(q)}(\overline{x}) = \overline{\Gamma_{\mathbb{Q}(q)}(x)}.
$$

Let  $_{\mathcal{A}}U_1^-$  be the A-subalgebra of  $U^-$  generated by  $F_i^{(n)}$  $i^{(n)}$  for  $i \in I^+$ ,  $F_{i\ell}$  for  $i \in I^0, \ell \geq 1$ and  $\mathbf{b}_{i\ell}$  for  $i \in I^-$ ,  $\ell \geq 1$ . Then  $\Gamma_{\mathbb{Q}(q)}$  induces an injective  $\mathbb{Z}[q, q^{-1}]$ -bialgebra homomorphism  $\Gamma: {}_{\mathcal{A}}U_1^- \to K_0(R).$ 

# 3.4. Surjectivity of  $\Gamma_{\mathbb{Q}(q)}$  and  $\Gamma$ .

Let  $\nu \in \mathcal{Y}$ . Define  $\underline{\nu}$  to be the set of sequence **i** of type  $\nu$  with 'parameters' for  $i \in I^0$ . Such a sequence is of the form

$$
\mathbf{i}=(j_1,a_1)\ldots(j_{p_0},a_{p_0})(\mathbf{i_1},\mathbf{n_1})(k_1,b_1)\ldots(k_{p_1},b_{p_1})(\mathbf{i_2},\mathbf{n_2})\ldots(\mathbf{i_t},\mathbf{n_t})(h_1,c_1)\ldots(h_{p_t},c_{p_t}),
$$

with  $(i_1, n_1), \ldots, (i_t, n_t) \in I^0 \times \mathbb{Z}_{>0}$  and such that the expended sequence

$$
(j_1, a_1) \ldots (j_{p_0}, a_{p_0}) \underbrace{i_1 \ldots i_1}_{n_1} (k_1, b_1) \ldots (k_{p_1}, b_{p_1}) \underbrace{i_2 \ldots i_2}_{n_2} \ldots \underbrace{i_t \ldots i_t}_{n_t} (h_1, c_1) \ldots (h_{p_t}, c_{p_t})
$$

belongs to  $\nu$ . For each  $\mathbf{i} \in \underline{\nu}$ , we assign the following idempotent of  $R(\nu)$ 

$$
1_{i} = 1_{(j_{1},a_{1})... (j_{p_{0}},a_{p_{0}})} \otimes e_{i_{1},n_{1}} \otimes 1_{(k_{1},b_{1})... (k_{p_{1}},b_{p_{1}})} \otimes e_{i_{2},n_{2}} \otimes \cdots \otimes e_{i_{t},n_{t}} \otimes 1_{(h_{1},c_{1})... (h_{p_{t}},c_{p_{t}})}.
$$

We define the character of  $M \in R(\nu)$ -fMod as

$$
\text{Ch}M = \sum_{i \in \underline{\nu}} \text{Dim}(1_i M) i \in \mathbb{Z}[q, q^{-1}] \underline{\nu}.
$$

Each  $i \in \underline{\nu}$  determines a monomial  $\Theta_i$  in  $U^-$  under the correspondence

$$
i \mapsto F_i \ (i \in I^+), \quad (i, \ell) \mapsto F_{i, \ell} \ (i \in I^0), \quad (i, \ell) \mapsto \mathbf{b}_{i, \ell} \ (i \in I^-).
$$

Let  $U_{\nu}^-$  be the  $\mathbb{Q}(q)$ -subspace of  $U^-$  spanned by  $\Theta_i$  for all  $i \in \nu$ . Combine with  $\Gamma_{\mathbb{Q}(q)}$ , we obtain a  $\mathbb{Q}(q)$ -linear map

$$
\mathbb{Q}(q)\underline{\nu} \longrightarrow U_{\nu}^{-} \stackrel{\Gamma_{\mathbb{Q}(q)}}{\longrightarrow} K_0(R(\nu))_{\mathbb{Q}(q)},
$$

which has the dual map

$$
G_0(R(\nu))_{\mathbb{Q}(q)} \xrightarrow{\text{Ch}} \mathbb{Q}(q)\underline{\nu}.
$$

We next show that the character map Ch is injective.

Let  $i \in I^0$  and  $\nu = ni$ . Then  $\underline{\nu} = \{(i, \ell_1) \dots (i, \ell_s) \mid (\ell_1, \dots, \ell_s) \in C_n\}$  and  $U_{\nu}^- = U_{-n\alpha_i}^-$ . Since  $\Gamma_{\mathbb{Q}(q)} : U^-_{-n\alpha_i} \to K_0(R(\nu))_{\mathbb{Q}(q)}$  is injective and they have the same dimension  $|\mathcal{P}_n|$ , we see that  $\Gamma_{\mathbb{Q}(q)}$  is an isomorphism and therefore Ch:  $G_0(R(ni))_{\mathbb{Q}(q)} \to \mathbb{Q}(q)$  is injective.

<span id="page-17-0"></span>**Lemma 3.3.** Let  $i \in I^0$ . The characters of all non-isomorphic gr-irreducible  $R(ni)$ -modules are  $\mathbb{Q}(q)$ -linear independent.

For instance, the irreducible  $K_3$ -modules and their characters are

$$
S^{(3)} = P_{i,3} = \mathbb{K}S_3 \cdot e_{i,3}, \quad \text{Ch } S^{(3)} = e_{i,3} + e_{i,1} \otimes e_{i,2} + e_{i,2} \otimes e_{i,1} + e_{i,1} \otimes e_{i,1} \otimes e_{i,1}
$$
\n
$$
S^{(21)} = \mathbb{K}S_3 \cdot 1/3(1 + s_1 - s_2s_1 - s_1s_2s_1), \quad \text{Ch } S^{(21)} = e_{i,1} \otimes e_{i,2} + e_{i,2} \otimes e_{i,1} + 2e_{i,1} \otimes e_{i,1} \otimes e_{i,1}
$$
\n
$$
S^{(111)} = \mathbb{K}S_3 \cdot 1/6(1 - s_1 - s_2 + s_1s_2 + s_2s_1 - s_1s_2s_1), \quad \text{Ch } S^{(111)} = e_{i,1} \otimes e_{i,1} \otimes e_{i,1}
$$

For  $(i, \ell) \in \mathbb{I}$  and  $n \geq 0$ , define the functor

$$
\Delta_{(i,\ell)^n}: R(\nu)\text{-Mod} \to R(\nu\setminus n(i,\ell))\otimes R(n(i,\ell))\text{-Mod},\ M\mapsto (1_{\nu\setminus n(i,\ell)}\otimes 1_{n(i,\ell)})M.
$$

<span id="page-18-1"></span>and set  $\varepsilon_{(i,\ell)}M = \max\{n \geq 0 \mid \Delta_{(i,\ell)^n}M \neq 0\}$  for each  $M \in R(\nu)$ -fMod. The following lemma can be proved by the same manner in [\[9,](#page-26-0) Section 3.2].

**Lemma 3.4.** Let  $(i, \ell) \in \mathbb{I}$  and  $M \in R(\nu)$ -fMod be a gr-irreducible module with  $\varepsilon_{i,\ell} M = n$ . Then  $\Delta_{(i,\ell)^n}M$  is isomorphic to  $K \otimes V$  for some gr-irreducible  $K \in R(\nu \setminus n(i,l))$ -fMod with  $\varepsilon_{(i,\ell)}K=0$  and some gr-irreducible  $V \in R(n(i,\ell))$ -fMod. Moreover, we have

<span id="page-18-0"></span>
$$
M \cong hd\ Ind_{\nu \setminus n(i,\ell),n(i,\ell)} K \otimes V.
$$

Recall that a gr-irreducible  $R(n(i, \ell))$ -module V is as follows: if  $i \in I^+$ , we have  $V = V(i^n)$ , the unique gr-irreducible module of the nilHecke algebra; if  $i \in I^-$ , then  $V = V((i, \ell)^n)$  is the one-dimensional trivial module; if  $i \in I^0$ , then V has  $|\mathcal{P}_n|$  many choices.

**Theorem 3.5.** The map  $Ch: G_0(R(\nu))_{\mathbb{Q}(q)} \to \mathbb{Q}(q)$  is injective.

*Proof.* We show that the characters of elements in  $\mathbb{B}_{\nu}$  are linearly independent over  $\mathbb{Q}(q)$  by induction on  $\ell(\nu)$ . The case of  $\ell(\nu) = 0$  is trivial. Assume for  $\ell(\nu) < n$ , our assertion is true. Now, suppose  $\ell(\nu) = n$  and we are given a non-trivial linear composition

(3.8) 
$$
\sum_{M} c_M \text{Ch} M = 0
$$

for some  $M \in \mathbb{B}_{\nu}$  and some  $c_M \in \mathbb{Q}(q)$ . Choose  $(i, \ell) \in \mathbb{I}$ . We prove by a downward induction on  $k = n, \ldots, 1$  that  $c_M = 0$  for all M with  $\varepsilon_{(i,\ell)}M = k$ .

If  $k = n$  and  $M \in \mathbb{B}_{\nu}$  with  $\varepsilon_{(i,\ell)}M = n$ , then  $\nu = n(i,\ell)$  and M is a gr-irreducible  $R(n(i,\ell))$ module, our assertion is trivial when  $i \in I^+ \sqcup I^-$ , and when  $i \in I^0$ , it follows from Lemma [3.3.](#page-17-0) Assume for  $1 \leq k < n$ , we have  $c_L = 0$  for all L with  $\varepsilon_{(i,\ell)} L > k$ . Taking out the terms with  $(i, \ell)^k$ -tail in the rest of [\(3.8\)](#page-18-0), we obtain

<span id="page-18-2"></span>(3.9) 
$$
\sum_{M:\varepsilon_{(i,\ell)}M=k} c_M \text{Ch}(\Delta_{(i,\ell)^k}M) = 0.
$$

By Lemma [3.4,](#page-18-1) we can assume  $\Delta_{(i,\ell)^k} M \cong K_M \otimes V_M$  for gr-irreducible  $K_M \in R(\nu \setminus k(i,\ell))$ fMod with  $\varepsilon_{i,\ell} K_M = 0$  and gr-irreducible  $V \in R(k(i,\ell))$ -fMod, then [\(3.9\)](#page-18-2) becomes

$$
\sum_{M: \varepsilon_{(i,\ell)}M=k} c_M \text{Ch} K_M \otimes \text{Ch} V_M = 0.
$$

Note that if  $[M] \neq [M']$  in  $\mathbb{B}_{\nu}$ , then we have  $[K_M] \neq [K_{M'}]$  or  $[V_M] \neq [V_{M'}]$ .

By the inductive hypothesis, Ch $K$  ( $K \in \mathbb{B}_{\nu \setminus k(i,\ell)}$ ) are linearly independent, and by Lemma [3.3](#page-17-0) if  $i \in I^0$ , ChV  $(V \in \mathbb{B}_{ki})$  are linearly independent. It follows that  $c_M = 0$  for all M with  $\varepsilon_{i,\ell}M = k$ . Since each gr-irreducible  $R(\nu)$ -modules M has  $\varepsilon_{(i,\ell)}M > 0$  for at least one  $(i, \ell) \in \mathbb{I}$ , the theorem has been proved.

We see from the proof that the map Ch :  $G_0(R(\nu)) \to \mathbb{Z}[q, q^{-1}] \nu$  is also injective. If we set ch = Ch|<sub>q=1</sub>, then by a similar argument, the ungraded characters of elements in  $\mathbb{B}_{\nu}$  are linearly independent over Z.

**Corollary 3.6.**  $\Gamma_{\mathbb{Q}(q)} : U^- \to K_0(R)_{\mathbb{Q}(q)}$  is an isomorphism.

We next consider the surjectivity of  $\Gamma : \mathcal{A}U_1^- \to K_0(R)$ .

For  $\lambda \vdash n$ , we denote by  $S^{\lambda}$  the irreducible  $\mathbb{K}S_n$ -module corresponding to the Young diagram of shape  $\lambda$ . For  $\mu \prec \lambda$ , we denote by  $S^{\lambda/\mu}$  the shew representation of  $\mathbb{K}S_n$  corresponding to the skew diagram  $\lambda/\mu$ .

<span id="page-19-0"></span>**Lemma 3.7.** [\[3,](#page-25-6) Proposition 3.5.5] Let  $\lambda \vdash n$  and  $(b_1, \ldots, b_\ell)$  be a composition of n. Then

$$
Res^{n}_{b_1,\ldots,b_{\ell}} = \bigoplus (S^{\lambda^{(1)}} \otimes S^{\lambda^{(2)}/\lambda^{(1)}} \otimes \cdots \otimes S^{\lambda/\lambda^{(\ell-1)}}),
$$

where the sum runs over all sequences  $\lambda^{(1)} \prec \lambda^{(2)} \prec \cdots \prec \lambda^{(\ell)} = \lambda$  such that  $|\lambda^{(j)}/\lambda^{(j-1)}| = b_j$ for all  $j = 1, \ldots, \ell$ .

<span id="page-19-1"></span>**Lemma 3.8.** [\[3,](#page-25-6) Proposition 3.5.12] Assume  $|\lambda/\mu| = k$ . The multiplicity of the trivial representation  $S^{(k)}$  in  $S^{\lambda/\mu}$  is equal to 1 if  $\lambda/\mu$  is totally disconnected, 0 otherwise.

<span id="page-19-2"></span>**Proposition 3.9.** Let  $\lambda \vdash n$ . Let **c** be a composition of n, which determines a partition  $\lambda_c \vdash n$ . Then

$$
dim_{\mathbb{K}}(e_{i,\mathbf{c}} \cdot S^{\lambda}) = \begin{cases} 1 & \text{if } \lambda_{\mathbf{c}} = \lambda, \\ 0 & \text{if } \lambda_{\mathbf{c}} > \lambda, \end{cases}
$$

where  $>$  is the lexicographical order of partitions.

Proof. The proposition follows from Lemma [3.7](#page-19-0) and Lemma [3.8,](#page-19-1) using the fact that the Kostka number

$$
K_{\lambda, \mathbf{c}} = K_{\lambda, \lambda_{\mathbf{c}}} = \begin{cases} 1 & \text{if } \lambda_{\mathbf{c}} = \lambda, \\ 0 & \text{if } \lambda_{\mathbf{c}} > \lambda. \end{cases}
$$

Note that Lemma [3.3](#page-17-0) can be derived directly from the proposition above.

For  $i \in I^0$  and  $\lambda = (c_1, \ldots, c_r) \vdash n$ , we set

$$
P_{i,\lambda} = P_{i,c_1} \cdots P_{i,c_r} = R(ni) \cdot e_{i,\lambda}.
$$

Then  $(P_{i,\lambda}, S^{\mu}) = \dim_{\mathbb{K}}(e_{i,\lambda} \cdot S^{\mu})$  and according to Proposition [3.9,](#page-19-2) the matrix

$$
\left\{(P_{i,\lambda},S^\mu)\right\}_{\lambda,\mu \vdash n}
$$

is triangular with all 1s on the diagonal. It follows that each  $[P] \in K_0(R(ni))$  can be written as a  $\mathbb{Z}[q, q^{-1}]$ -linear combination of  $[P_{i,\lambda}]$  for  $\lambda \vdash n$ .

More generally, we write the set  $\mathbb I$  as

$$
\mathbb{I} = \{ (i_1, \ell_1), (i_2, \ell_2), \ldots, (i_k, \ell_k), \ldots \}.
$$

For a gr-irreducible  $R(\nu)$ -module  $M,$  we let  $c_1=\varepsilon_{(i_1,\ell_1)}M$  and assume  $\Delta_{(i_1,\ell_1)^{c_1}}M=M_1\otimes V_M$ for gr-irreducible  $M_1$  with  $\varepsilon_{(i_1,\ell_1)}M_1 = 0$  and gr-irreducible  $V_M \in R(c_1(i_1,\ell_1))$ -Mod. If  $i_1 \in I^0$ , then  $V_M = S^{\lambda^{(1)}}$  for some  $\lambda^{(1)} \vdash c_1$ . So we get a pair  $(c_1, \lambda^{(1)})$ , where we set  $\lambda^{(1)} = 0$ when  $i_1 \notin I^0$ . Inductively,  $c_k = \varepsilon_{(i_k,\ell_k)} M_{k-1}$  and  $\Delta_{(i_k,\ell_k)^{c_k}} M_{k-1} = M_k \otimes V_{M_{k-1}}$ , and we obtain  $(c_k, \lambda^{(k)})$ . If we do not get  $M_k = 0$  after I exhausted, we can continue the process from  $(i_1, \ell_1)$ . Therefore, each  $b \in \mathbb{B}_{\nu}$  is assigned by a sequence

$$
W_b = (c_1, \lambda^{(1)})(c_2, \lambda^{(2)}) \cdots (c_k, \lambda^{(k)}) \cdots,
$$

and we see from Lemma [3.4](#page-18-1) that b is uniquely determined by  $W_b$ . We set

$$
P_{(c_k,\lambda^{(k)})} = \begin{cases} P_{i_k(c_k)} & \text{ if } i_k \in I^+, \\ P_{(i_k,\ell_k)^{c_k}} & \text{ if } i_k \in I^-, \\ P_{i_k,\lambda^{(k)}} & \text{ if } i_k \in I^0, \end{cases}
$$

and  $P_{W_b} = \cdots P_{(c_k,\lambda^{(k)})} \cdots P_{(c_2,\lambda^{(2)})} P_{(c_1,\lambda^{(1)})}$ .

Let  $b, b' \in \mathbb{B}_{\nu}$  with  $W_b = (c_1, \lambda^{(1)})(c_2, \lambda^{(2)}) \cdots$  and  $W_{b'} = (d_1, \mu^{(1)})(d_2, \mu^{(2)}) \cdots$ . We denote  $W_b > W'_b$  if for some  $t, (c_1, \lambda^{(1)}) = (d_1, \mu^{(1)}), \ldots, (c_{t-1}, \lambda^{(t-1)}) = (d_{t-1}, \mu^{(t-1)})$  but

$$
c_t > d_t \text{ or } c_t = d_t, \lambda^{(t)} > \mu^{(t)}
$$

.

 $\Box$ 

**Proposition 3.10.**  $HOM(P_{W_b}, S_{b'}) = 0$  if  $b > b'$  and  $HOM(P_{W_b}, S_b) \cong \mathbb{K}$ , up to a degree shift.

*Proof.* For  $i \in I^+$ , we have  $\text{HOM}(P_{i^{(n)}}, V(i^n)) \cong \mathbb{K}$  since  $P_{i^{(n)}}$  is the graded projective cover of  $V(i^n)$ . For  $i \in I^-$ ,  $\text{HOM}(R(n(i, \ell)), V((i, \ell)^n)) \cong \mathbb{K}$  as graded vector spaces. The results follow immediately from the Frobenius reciprocity and Proposition [3.9,](#page-19-2) which deals with the case where  $i \in I^0$ . By proposition above, each  $[P] \in K_0(R(\nu))$  can be written as a  $\mathbb{Z}[q,q^{-1}]$ -linear combination of  $[P_{W_b}]$  for  $b \in \mathbb{B}_{\nu}$ . Therefore,  $\Gamma$  is surjective.

**Theorem 3.11.**  $\Gamma: {}_{\mathcal{A}}U_1^- \to K_0(R)$  is an isomorphism.

For  $M \in R(\nu)$ -fMod, let  $M^* = \text{HOM}_{\mathbb{K}}(M, \mathbb{K})^{\psi}$  be the dual module in  $R(\nu)$ -fMod with the action given by

$$
(zf)(m) := f(\psi(z)m) \text{ for } z \in R(\nu), f \in \text{HOM}_{\mathbb{K}}(M, \mathbb{K}), m \in M.
$$

As proved in [\[9,](#page-26-0) Section 3.2], for each gr-irreducible  $R(\nu)$ -module S, there is a unique  $r \in \mathbb{Z}$ such that  $(L{r})^* \cong L{r}$ , and the graded projective cover of  $L{r}$  is stable under the bar-involution <sup>−</sup>.

Let  ${}_{\mathcal{A}}U^-$  be the A-subalgebra of  $U^-$  generated by  $F_i^{(n)}$  $i^{(n)}$  for  $i \in I^+, F_{i\ell}$  for  $i \in I^{\leq 0}, \ell \geq 1$ . Combining  $\Psi$  in [\(1.2\)](#page-4-2), we obtain a  $\mathbb{Z}[q, q^{-1}]$ -algebra isomorphism

$$
\Phi = \Psi \Gamma^{-1} : K_0(R) \xrightarrow{\sim} {}_{\mathcal{A}}U^-.
$$

**Conjecture 3.12.** Under  $\Phi$ , the bar-invariant indecomposable projective modules of  $K_0(R)$ coincides with the canonical basis of  $_{\mathcal{A}}U^{-}$  given in [\[1\]](#page-25-1).

#### 4. Categorification of irreducible highest weight module for Jordan quiver

Throughout this chapter, we assume that  $I = I^0 = \{i\}$  and U is the quantum Borcherds-Bozec associated to I. By [\[4,](#page-25-7) Appendix], if we define  $\{\alpha_p\}_{p\geq 1}$  inductively:

$$
\alpha_p = \nu_p(K_i^{-p} - K_i^p) - \nu_1 K_i \alpha_{p-1} - \nu_2 K_i^2 \alpha_{p-2} - \dots - \nu_{p-1} K_i^{p-1} \alpha_1,
$$

where  $\alpha_1 = \nu_1 (K_i - K_i^{-1})$ , then for any  $\ell, t \ge 1$ , the equation [\(1.3\)](#page-5-0) yields

(4.1) 
$$
[E_{i\ell}, F_{it}] = \sum_{p=0}^{\min\{\ell, t\}} \alpha_p F_{i, t-p} E_{i, \ell-p}.
$$

Define the functors

$$
\mathcal{F}_{i\ell}: R(ni)\text{-Mod} \to R((n+\ell)i)\text{-Mod}, M \mapsto (R((n+\ell)i)1_{ni} \otimes e_{i,\ell}) \otimes_{R(ni)} M,
$$
  

$$
\mathcal{E}_{i\ell}: R(ni)\text{-Mod} \to R((n-\ell)i)\text{-Mod}, M \mapsto 1_{(n-\ell)i} \otimes e_{i,\ell}M.
$$

<span id="page-22-1"></span>**Lemma 4.1.** Let  $\ell, t \geq 1$ . We have the following natural isomorphisms

$$
\mathcal{E}_{i\ell}\mathcal{F}_{it} \simeq \bigoplus_{p=0}^{\min\{\ell,t\}}\mathcal{F}_{i,t-p}\mathcal{E}_{i,\ell-p}\otimes Z_p,
$$

where  $Z_p$  is the algebra of symmetric polynomials in p indeterminates, each of degree  $2r_i$ .

*Proof.* We prove the case where  $t = \ell$  only, the other cases are similar. For simplicity, we omit the symbol "i". Assume first that  $n \geq \ell$  and denote by  $D_{n,\ell}$  (resp.  $D_{n,\ell}^{-1}$ ) the set of minimal length left (resp. right)  $S_n \times S_\ell$ -coset representatives in  $S_{n+\ell}$ . Then  $D_{n,\ell} \cap D_{n,\ell}^{-1} = \{v_0, \ldots, v_\ell\}$ is the set of minimal length  $S_n \times S_{\ell}$ -double coset representatives, where  $v_k$  can be expressed graphically



Note that

(4.2) 
$$
1_n \otimes e_{\ell} \cdot R(n+\ell) \cdot 1_n \otimes e_{\ell} = \sum_{u \in D_{n,\ell}} 1_n \otimes e_{\ell} \cdot u \cdot R(n) \otimes R(\ell) \cdot 1_n \otimes e_{\ell}.
$$

Any  $u \in D_{n,\ell}$  can be decomposed into  $u = v \otimes v' \cdot v_k$  for some  $0 \leq k \leq \ell, v \in D_{n-k,k}$  and  $v' \in D_{k,\ell-k}$ . Since  $e_{\ell} \cdot v' = e_{\ell}$ , we have (4.3)

<span id="page-22-0"></span>
$$
1_n \otimes e_{\ell} \cdot R(n+\ell) \cdot 1_n \otimes e_{\ell} = \sum_{k=0}^{\ell} \sum_{v \in D_{n-k,k}} 1_n \otimes e_{\ell} \cdot v \cdot v_k \cdot R(n) \otimes R(\ell) \cdot 1_n \otimes e_{\ell}
$$

$$
= \bigoplus_{k=0}^{\ell} \sum_{v \in D_{n-k,k}} v \otimes e_{\ell} \cdot v_k \cdot R(n) \otimes R(k) \otimes R(\ell-k) \cdot 1_n \otimes e_{\ell}
$$

On the other hand,

$$
(R(n)\cdot 1_{n-k}\otimes e_k)\otimes_{R(n-k)}(1_{n-k}\otimes e_k\cdot R(n))=\sum_{v\in D_{n-k,k}}v\cdot (1_{n-k}\otimes R(k)e_k)\otimes_{R(n-k)}(1_{n-k}\otimes e_k\cdot R(n)).
$$

Since  $(1_{n-k} \otimes R(k)e_k) \cdot v_k = v_k \cdot (1_n \otimes R(k)e_k)$  and  $v_k \cdot 1_{n-k} \otimes e_k \cdot R(n) = 1_n \otimes e_k \cdot v_k \cdot R(n)$ , we see that

$$
1_n \otimes e_{\ell} \cdot \left( v \cdot (1_{n-k} \otimes R(k)e_k) \right) \cdot v_k \cdot 1_{n+k} \otimes e_{\ell-k} R(\ell-k)e_{\ell-k} \cdot \left( (1_{n-k} \otimes e_k \cdot R(n)) \right) \cdot 1_n \otimes e_{\ell}
$$
  
=  $1_n \otimes e_{\ell} \cdot \left( v \cdot v_k \cdot R(n) \otimes R(k)e_k \otimes e_{\ell-k} R(\ell-k)e_{\ell-k} \right) \cdot 1_n \otimes e_{\ell}$ .  
=  $v \otimes e_{\ell} \cdot v_k \cdot R(n) \otimes R(k) \otimes R(\ell-k) \cdot 1_n \otimes e_{\ell}$ 

Hence for each  $z \in e_{\ell-k}R(\ell-k)e_{\ell-k}$ , the map

$$
(R(n) \cdot 1_{n-k} \otimes e_k) \otimes_{R(n-k)} (1_{n-k} \otimes e_k \cdot R(n)) \to 1_n \otimes e_\ell \cdot R(n+\ell) \cdot 1_n \otimes e_\ell
$$

<span id="page-23-0"></span>
$$
x\otimes y\mapsto 1_n\otimes e_{\ell}\cdot x\cdot 1_{n+k}\otimes z\cdot y\cdot 1_n\otimes e_{\ell}
$$

is an injective  $(R(n), R(n))$ -bimodule homomorphism. Since  $e_{\ell-k}R(\ell-k)e_{\ell-k} \cong Z_{\ell-k}$ , we have proved that

(4.4) 
$$
\mathcal{E}_{\ell} \mathcal{F}_{\ell} \simeq \bigoplus_{k=0}^{\ell} \mathcal{F}_{k} \mathcal{E}_{k} \otimes Z_{\ell-k}
$$

on  $R(n)$ . If  $n < \ell$ , then the direct sum in [\(4.3\)](#page-22-0) ranging from  $k = 0$  to n, while the right hand side of [\(4.4\)](#page-23-0) only makes sense for  $k \leq n$ .

Choose  $\Lambda \in P^+$  and set  $a = \Lambda(h_i) \geq 0$ . We define the cyclotomic algebra  $R^{\Lambda}(n)$  to be the quotient of  $R(n)$  by the two sided ideal generated by  $x_1^a$ , and form

$$
R^{\Lambda} = \bigoplus_{n \geq 0} R^{\Lambda}(n), \ K_0(R^{\Lambda}) = \bigoplus_{n \geq 0} K_0(R^{\Lambda}(n)).
$$

If  $a = 0$ , then  $R^{\Lambda} = R^{\Lambda}(0) = \mathbb{K}$  and  $V(\Lambda)$  is the one dimensional trivial module by [\(1.4\)](#page-5-1). So we assume  $a > 0$  in the following.

Note that  $R^{\Lambda}(n)$  has a basis  $\{x_1^{r_1}\cdots x_n^{r_n}\tau_{\omega} \mid \omega \in S_n, 0 \leq r_1,\ldots,r_n \leq a\}$ . Define the functors

$$
\mathcal{F}_{i\ell}^{\Lambda}: R^{\Lambda}(n)\text{-Mod} \to R^{\Lambda}(n+\ell)\text{-Mod}, \ M \mapsto (R^{\Lambda}(n+\ell)1_n \otimes e_{\ell}) \otimes_{R^{\Lambda}(n)} M,
$$
  

$$
\mathcal{E}_{i\ell}^{\Lambda}: R^{\Lambda}(n)\text{-Mod} \to R^{\Lambda}(n-\ell)\text{-Mod}, \ M \mapsto 1_{n-\ell} \otimes e_{\ell}M.
$$

Similar to Lemma [4.1,](#page-22-1) for  $\ell, t \geq 1$ , we have the following natural isomorphisms

(4.5) 
$$
\mathcal{E}_{i\ell}^{\Lambda} \mathcal{F}_{it}^{\Lambda} \simeq \bigoplus_{p=0}^{\min\{\ell,t\}} \mathcal{F}_{i,t-p}^{\Lambda} \mathcal{E}_{i,\ell-p}^{\Lambda} \otimes Z_{p}^{\Lambda},
$$

where  $Z_p^{\Lambda}=\big(\mathbb{K}[x_1,\ldots,x_p]/(x_1^a,\ldots,x_p^a)\big)^{S_p},$  i.e., the symmetric polynomials in  $x_1,\ldots,x_p$  such that no  $x_k^m$  ( $m \geq a$ ) appears. Thus  $Z_p^{\Lambda}$  determined by all partitions  $\lambda$  with  $\ell(\lambda) \leq p$  and  $\lambda_1 \leq a - 1$ . We know that the generating function for such partitions is

$$
\begin{bmatrix} a+p-1 \ p \end{bmatrix} = \frac{(1-q^a)(1-q^{a+1})\cdots(1-q^{a+p-1})}{(1-q)(1-q^2)\cdots(1-q^p)},
$$

and therefore

$$
\mathbf{Dim}Z_p^{\Lambda} = \frac{(1 - q_i^{2a})(1 - q_i^{2(a+1)}) \cdots (1 - q_i^{2(a+p-1)})}{(1 - q_i^2)(1 - q_i^4) \cdots (1 - q_i^{2p})} := \beta_p.
$$

**Lemma 4.2.** Let  $\nu_k = 1/(1 - q_i^2)(1 - q_i^4) \cdots (1 - q_i^{2k})$  for any  $k \ge 1$ . Then for any  $p \ge 1$ ,

<span id="page-24-1"></span>(4.6) 
$$
\beta_p = \nu_p (1 - q_i^{2pa}) - \nu_1 q_i^{2a} \beta_{p-1} - \nu_2 q_i^{4a} \beta_{p-2} - \dots - \nu_{p-1} q_i^{2(p-1)a} \beta_1.
$$

Proof. Using the notations

<span id="page-24-0"></span>
$$
\begin{bmatrix} n \\ m \end{bmatrix} = \frac{(1-q^n)(1-q^{n-1})\cdots(1-q^{n-m+1})}{(1-q)(1-q^2)\cdots(1-q^m)}
$$

for  $n \ge m \ge 1$  and  $(x;q)_n = (1-x)(1-xq) \cdots (1-xq^{n-1})$  for  $n \ge 1$ . We have

(4.7) 
$$
\begin{bmatrix} n+1 \\ m \end{bmatrix} = q^m \begin{bmatrix} n \\ m \end{bmatrix} + \begin{bmatrix} n \\ m-1 \end{bmatrix}, \quad (xq^m; q)_{n-m} = \frac{(x;q)_n}{(x;q)_m}.
$$

To show the identity in the lemma, it's enough to show the following

$$
(1 - q^{pa}) = \sum_{k=0}^{p-1} q^{ka} \begin{bmatrix} p \\ k \end{bmatrix} (q^a; q)_{p-k},
$$

which can be proved easily by an induction on p and using  $(4.7)$ .

Let  $\alpha_k = q_i^{-ka} \beta_k$  for all  $k \ge 1$ . By [\(4.6\)](#page-24-1), for  $p \ge 1$ , we have

$$
q_i^{-pa}\beta_p = \nu_p(q_i^{-pa} - q_i^{pa}) - \sum_{k=1}^{p-1} q_i^{-(p-k)a} \nu_k q_i^{ka}\beta_{p-k}.
$$

Thus,

$$
\alpha_p = \nu_p(q_i^{-pa} - q_i^{pa}) - \sum_{k=1}^{p-1} \nu_k q_i^{ka} \alpha_{p-k}.
$$

Define the functors  $E_{i\ell}^{\Lambda}, F_{i\ell}^{\Lambda}, K_i$  on  $K_0(R^{\Lambda})$  by

$$
E_{i\ell}^{\Lambda} = \mathcal{E}_{i\ell}^{\Lambda}, \ F_{i\ell}^{\Lambda} = q_i^{-\ell a} \mathcal{F}_{i\ell}^{\Lambda}, \ K_i = q_i^a.
$$

Then [\(4.5\)](#page-23-1) gives

$$
E_{i\ell}^{\Lambda}F_{it}^{\Lambda}=\sum_{p=0}^{\min\{\ell,t\}}q_i^{-pa}\beta_pF_{i,t-p}^{\Lambda}E_{i,\ell-p}^{\Lambda}=\sum_{p=0}^{\min\{\ell,t\}}\alpha_pF_{i,t-p}^{\Lambda}E_{i,\ell-p}^{\Lambda},
$$
  
where  $\alpha_p=\nu_p(K_i^{-p}-K_i^p)-\sum_{k=1}^{p-1}\nu_kK_i^k\alpha_{p-k}.$ 

Let  $K_0(R^{\Lambda})_{\mathbb{Q}(q)} = \mathbb{Q}(q) \otimes_{\mathbb{Z}[q,q^{-1}]} K_0(R^{\Lambda})$ . Then by [\(4.1\)](#page-21-0), the  $K_0(R^{\Lambda})_{\mathbb{Q}(q)}$  is a weight Umodules (the weight spaces are  $K_0(R^{\Lambda})_{\Lambda-ni} = K_0(R^{\Lambda}(n))$ ) with the action of  $E_{i\ell}$  (resp.  $F_{i\ell}$ ) by  $E_{i\ell}^{\Lambda}$  (resp.  $F_{i\ell}^{\Lambda}$ ). The  $\mathbb{Z}[q, q^{-1}]$ -linear map

$$
\varphi: K_0(R) \to K_0(R^{\Lambda}), \ \ [P] \mapsto R^{\Lambda}(n) \otimes_{R(n)} [P],
$$

is an isomorphism. For  $[P] \in K_0(R(n))$ , we have

$$
\varphi(F_{i\ell}[P]) = \varphi(\text{Ind}_{n,\ell}^{n+\ell} P \otimes R(\ell)e_{\ell})
$$
  
=  $R^{\Lambda}(n+\ell) \otimes_{R(n+\ell)} R(n+\ell) \otimes_{R(n) \otimes R(\ell)} P \otimes R(\ell)e_{\ell}$   
=  $R^{\Lambda}(n+\ell) \otimes_{R(n) \otimes R(\ell)} P \otimes R(\ell)e_{\ell}$   
=  $(R^{\Lambda}(n+\ell)1_n \otimes e_{\ell}) \otimes_{R(n)} P$   
=  $\mathcal{F}_{i\ell}^{\Lambda} \varphi([P]).$ 

It follows that  $\varphi$  is  $U^-$ -linear and  $K_0(R^{\Lambda})$  is generated by  $1_{\Lambda}$ , the trivial module over  $R^{\Lambda}(0)$ . Hence  $K_0(R^{\Lambda})_{\mathbb{Q}(q)}$  is isomorphic to the irreducible highest weight module  $V(\Lambda)$  given in [\(1.4\)](#page-5-1), which can be identified with  $U^-$  as  $U^-$ -modules.
