# COTILTING MODULES AND GORENSTEIN HOMOLOGICAL DIMENSIONS

ABSTRACT. For a dualizing module  $D$  over a commutative Noetherian ring  $R$  with identity, it is known that its Auslander class  $\mathscr{A}_D(R)$  (respectively, Bass class  $\mathscr{B}_D(R)$ ) is characterized as those R-modules with finite Gorenstein flat dimension (respectively, finite Gorenstein injective dimension). We establish an analogue of this result in the context of cotilting modules over general Noetherain rings.

# 1. INTRODUCTION

<span id="page-0-0"></span>Semidualizing modules serve as a common generalization of dualizing modules and projective modules of rank one over commutative Noetherian rings with identity. Let C be a semidualizing module over a commutative Noetherian ring  $R$  with identity. The two classes of R-modules  $\mathscr{A}_{C}(R)$  and  $\mathscr{B}_{C}(R)$ , known as the Auslander and Bass classes, correspond to C. They are intimately related through an equivalence of categories

that known as Foxby equivalence.

Recall that a semidualizing R-module with finite injective dimension is called dualizing. When C is a dualizing R-module, there is a well-known characterization of the classes  $\mathcal{A}_{C}(R)$ and  $\mathscr{B}_{C}(R)$  via Gorenstein homological dimensions. Specifically, in this case,  $\mathscr{A}_{C}(R)$  (respectively,  $\mathcal{B}_C(R)$  consists precisely of all R-modules with finite Gorenstein flat (respectively, Gorenstein injective) dimension; see e.g. [\[8\]](#page-25-2). It is natural to expect an analogous result for general Noetherian (not necessarily commutative) rings. While some results exist in this direction under additional assumptions, including the perfection of the underlying ring([\[9\]](#page-25-3), [\[5\]](#page-25-4)), our aim in this paper is to relax this strong assumption.

In 2007, Holm and White [\[13\]](#page-25-5) defined semidualizing bimodules over associative rings with identity. For a semidualizing bimodule  ${}_ST_R$ , they defined the Auslander and Bass classes  $\mathscr{A}_T(S)$  and  $\mathscr{B}_T(R)$ . An enhanced theory of Wakamatsu tilting modules exists over an associative ring  $R$  with identity. Surprisingly, Wakamatsu tilting modules can be classified as semidualizing bimodules; see Lemma [2.3.](#page-4-0) In addition, parallel to the theory of dualizing modules, a rich theory of cotilting modules exists within the representation theory of algebras.

Tilting theory plays a remarkable role in the representation theory of algebras. The classical tilting modules were introduced in the context of finitely generated modules over finitedimensional algebras by Brenner and Butler [\[6\]](#page-25-6) and Happel and Ringel [\[12\]](#page-25-7). Miyashita [\[21\]](#page-26-0) extended this notion to encompass finitely presented modules of finite projective dimension over arbitrary rings. In his seminal work, Wakamatsu [\[22\]](#page-26-1) further generalized the concept of tilting modules by allowing for the possibility of infinite projective dimension. These modified tilting modules are now commonly referred to as "Wakamatsu tilting modules", officially adopting the terminology established in [\[11\]](#page-25-8).

Cotilting modules, as an analogous to dualizing modules, were first introduced by Auslander and Reiten in the context of finitely generated modules over Artin algebras; see [\[2\]](#page-25-9) and [\[3\]](#page-25-10). Hügel and Coelho [\[17\]](#page-25-11) extended this notion to (not necessary finitely generated) modules over general associative rings with identity. There are several other definitions for cotilting modules. We examine only two of them that are introduced by Miyashita [\[21\]](#page-26-0) and Aihara et. al. [\[1\]](#page-25-12). Interestingly, by Miyashita's definition a cotilting module is a Wakamatsu tilting module that satisfies some additional conditions. We demonstrate that over an Artin algebra, these four definitions coincide; see Remark [5.7.](#page-23-0) In general setting, we adopt the Hügel and Coelho definition for cotilting modules.

For certain cotilting modules, we derive the following results to precisely describe the classes  $\mathscr{A}_T(S)$  and  $\mathscr{B}_T(R)$ :

<span id="page-2-1"></span>**Theorem 1.1.** Let  $C_R$  be a tensorly faithful cotiliting R-module, and let  $S = \text{End}(C)$ . Assume *that the ring*  $R$  *is right coherent, the ring*  $S$  *is left coherent, and both modules*  $C_R$  *and*  $S$ are finitely generated. Then, for an S-module  $N_S$ , the following are equivalent:

- (i)  $N \in \mathscr{A}_C(S)$ .
- (ii) Gpd $(N_S) < \infty$ .
- <span id="page-2-2"></span>(iii) Gfd $(N_S) < \infty$ .

**Theorem 1.2.** Let  $C_R$  be a tensorly faithful cotilting R-module, and let  $S = \text{End}(C)$ . Assume *that the ring*  $R$  *is right Noetherian, the ring*  $S$  *is left coherent, and both modules*  $C_R$  *and*  $S$ C *are finitely generated. Then, for an* R*-module* MR*, the following are equivalent:*

- (i)  $M \in \mathscr{B}_C(R)$ .
- (ii) Gid $(M_R) < \infty$ .

The paper is organized as follows: In Section 2, we provide an overview of the background related to Wakamatsu tilting modules. Sections 3 and 4 focus on proving slightly stronger versions of Theorems [1.1](#page-2-1) and [1.2,](#page-2-2) specifically for Wakamatsu tilting modules; see Theorems [3.7](#page-10-0) and [4.6.](#page-14-0) Section 5 delves into the comparison of the above-mentioned four definitions of cotilting modules. Finally, by combining this comparison and using Theorems [3.7](#page-10-0) and [4.6,](#page-14-0) we deduce Theorems [1.1](#page-2-1) and [1.2.](#page-2-2)

# 2. Preliminaries

<span id="page-2-0"></span>In this paper, we consider associative rings with identity, and all modules are assumed to be unitary. We use the notation  $M_R$  (respectively,  $_R M$ ) to denote a right (respectively, left) R-module. The category of all right R-modules (respectively, finitely generated right R-modules) is denoted by Mod-R (respectively,  $mod-R$ ), while R-Mod (respectively, R-mod) represents the category of all left R-modules (respectively, finitely generated left R-modules). Let  $M_R$  be an R-module. We denote by  $\text{Add}(M)$  (respectively,  $\text{add}(M)$ ) the class of right R-modules which are isomorphic to a direct summand of a direct sum of copies (respectively, finitely many copies) of M. Dually,  $Prod(M)$  stands for the class of right R-modules which are isomorphic to a direct summand of a direct product of copies of  $M$ . Also, we write Cogen(M) for the subcategory of all modules  $N_R$  admitting an R-monomorphism  $N \to X$ with  $X \in \text{Prod}(M)$ .

All subcategories that are considered throughout are full and closed under finite direct sums, direct summands, and isomorphisms. A subcategory C of Mod-R is said to be *resolving* if it is closed under extensions and kernels of epimorphisms, and it contains all the projective modules. Similarly, a subcategory C of Mod-R is called *co-resolving* if it is closed under extensions and cokernels of monomorphisms, and it contains all the injective modules.

Let C be a subcategory of Mod-R. Let  $\hat{C}$  denote the subcategory of modules  $N_R$  admitting an exact sequence

$$
0 \to C_r \to \cdots \to C_1 \to C_0 \to N \to 0
$$

with each  $C_i$  in C. The notation  $C^{\perp}$  refers to the subcategory of R-modules  $N_R$  such that  $\mathrm{Ext}^{i\geqslant 1}_R(X, N)=0$  for all  $X\in\mathcal{C}$ . Similarly, the notation  $\bot\mathcal{C}$  stands for the subcategory of *R*-modules  $N_R$  such that  $\text{Ext}_R^{i \geq 1}(N, X) = 0$  for all  $X \in \mathcal{C}$ .

For an R-module  $T_R$ , the symbol Gen<sup>\*</sup>( $T_R$ ) (respectively, gen<sup>\*</sup>( $T_R$ )) stands for the class of R-modules  $N_R$  for which there exists an exact sequence of the form

$$
\cdots \xrightarrow{f_2} T_1 \xrightarrow{f_1} T_0 \xrightarrow{f_0} N \to 0
$$

with each  $T_i \in \text{Add}(T)$  (respectively,  $T_i \in \text{add}(T)$ ) and  $\text{Ext}^1_R(T, \text{Ker}f_i) = 0$  for all  $i \geq 0$ . Dually, the class Cogen<sup>\*</sup>( $T_R$ ) (respectively, cogen<sup>\*</sup>( $T_R$ )) is consisting of R-modules  $N_R$  for which there exists an exact sequence of the form

$$
0 \to N \stackrel{f^{-1}}{\to} T^0 \stackrel{f^0}{\to} T^1 \stackrel{f^1}{\to} \cdots
$$

with each  $T^i \in \text{Prod}(T)$  (respectively,  $T^i \in \text{add}(T)$ ) and  $\text{Ext}^1_R(\text{Coker}f^i, T) = 0$  for all  $i \geq -1$ .

**Definition 2.1.** Let  $T_R$  be an R-module and  $n \in \mathbb{N}$ . We say that  $T_R$  is n-tilting if

- (i)  $T_R \in \text{gen}^*(R)$  and  $\text{pd}(T_R) \leq n$ ,
- (ii)  $\operatorname{Ext}^i_R(T,T) = 0$  *for all*  $i > 0$ *, and*
- (iii) *There is an exact sequence*

$$
0 \to R \to T_0 \to T_1 \to \cdots \to T_n \to 0,
$$

*where*  $T_i \in \text{add}_R T$  *for all*  $0 \leq i \leq n$ *.* 

**Definition 2.2.** *(See* [\[22,](#page-26-1) Section 3].*)* Let  $T_R$  be an R-module. We say that  $T_R$  is a Waka*matsu tilting module if the following conditions hold:*

- (i)  $T_R \in \text{gen}^*(R)$ ,
- (ii)  $\operatorname{Ext}^i_R(T,T) = 0$  *for all*  $i > 0$ *,*
- (ii)  $R_R \in \text{cogen}^*(T_R)$ .

It is easy to verify that every tilting module is also a Wakamatsu tilting module. The notion of Wakamatsu tilting left modules is defined similarly. It is worth mentioning that the concept of Wakamatsu cotilting modules over Artin algebras is also defined. For a right module  $T$  over an Artin algebra  $A$ ,  $T$  being a Wakamatsu cotilting module is equivalent to T being a Wakamatsu tilting module.

By [\[22,](#page-26-1) Corollary 3.2], we have the following characterization of the Wakamatsu tilting modules.

<span id="page-4-0"></span>**Lemma 2.3.** *The following are equivalent for a bimodule*  $_{S}T_{R}$ *:* 

- (1)  $T_R$  *is a Wakamatsu tilting module with*  $\text{End}(T_R) \cong S$ ;
- (2)  $sT$  *is a Wakamatsu tilting module with*  $\text{End}(sT) \cong R$ ;
- p3q *One has*
	- (i)  $T_R \in \text{gen}^*(R)$  and  $sT \in \text{gen}^*(S)$ .
- (i) End $(T_R) \cong S$  *and* End $(sT) \cong R$ *.*
- (iii)  $\text{Ext}^i_R(T,T) = 0$  *and*  $\text{Ext}^i_S(T,T) = 0$  *for all*  $i > 0$ *.*

Note that by Lemma [2.3,](#page-4-0) a Wakamatsu tilting module is a semidualizing bimodule in the sense of Holm and White [\[13\]](#page-25-5).

**Definition 2.4.** Let  $\mathscr C$  be a class of right R-modules. A homomorphism  $f: C \to M$  with  $C \in \mathscr{C}$  *is a*  $\mathscr{C}$ -precover if for any homomorphism  $g: C_0 \to M$  with  $C_0 \in \mathscr{C}$ , there exists a *homomorphism satisfying*  $h: C_0 \to C$  *such that*  $g = fh$ . A  $\mathscr{C}\text{-}precover f: C \to M$  *is called a*  $\mathscr C$ -cover if every endomorphism  $\varphi : C \to C$  with  $f = f\varphi$  is an automorphism. The class  $\mathscr C$ *is called (pre)covering if every right* R*-module has a* C*-(pre)cover.*

Dually, C-(pre)envelope and (pre)enveloping classes were defined.

Now, we recall the definitions of the Auslander and Bass classes.

**Definition 2.5.** *Let*  $_{S}T_{R}$  *be a Wakamatsu tilting module.* 

(i) The Auslander class  $\mathscr{A}_{T}(S)$  with respect to T consists of all S-modules  $N_S$  satisfying  $\operatorname{Tor}_{i\geqslant1}^S(N,T)=0, \, \operatorname{Ext}_R^{i\geqslant1}(T,N\otimes_ST)=0$  and the natural map

$$
\theta_N^T : N \to \text{Hom}_R(T, N \otimes_S T)
$$

*is an isomorphism.*

(ii) *The Bass class*  $\mathcal{B}_T(R)$  *with respect to* T *consists of all* R-modules  $M_R$  *satisfying*  $\text{Ext}_{R}^{i\geqslant 1}(T,M)=0, \text{Tor}_{i\geqslant 1}^{S}(\text{Hom}_{R}(T,M), T)=0$  and the natural map

$$
\nu_M^T : \text{Hom}_R(T, M) \otimes_S T \to M
$$

*is an isomorphism.*

<span id="page-4-1"></span>The following lemma summarizes some of the well-known properties of the Auslander and Bass classes with respect to a Wakamatsu tilting module.

**Lemma 2.6.** Let  $_{S}T_{R}$  be a Wakamatsu tilting module. Then

- (1) The class  $\mathcal{A}_T(S)$  is resolving. Furthermore, the class  $\mathcal{A}_T(S)$  contains all flat right S*-modules.*
- (2) The class  $\mathcal{B}_T(R)$  is co-resolving. In particular, the class  $\mathcal{B}_T(R)$  contains all injective *right* R*-modules.*

(3) *There ia an equivalence of categories*

$$
\mathscr{A}_{T}(S) \xrightarrow{\begin{array}{c}\n-\otimes_{S}T\end{array}} \mathscr{B}_{T}(R).
$$

- (4) If  $N_S, N'_S \in \mathscr{A}_T(S)$ , then  $\text{Ext}^i_S(N, N') \cong \text{Ext}^i_R(N \otimes_S T, N' \otimes_S T)$  for all  $i \geq 0$ .
- (5) If  $M_R$ ,  $M'_R \in \mathscr{B}_T(R)$ , then  $\text{Ext}^i_R(M, M') \cong \text{Ext}^i_S(\text{Hom}_R(T, M), \text{Hom}_R(T, M'))$  for *all*  $i \geqslant 0$ *.*

*Proof.* For (1) and (2), see [\[13,](#page-25-5) Theorem 6.2 and Lemma 4.1].

For  $(3)$ ,  $(4)$ , and  $(5)$ , see, respectively, Proposition 4.1, Theorem 6.4(1) and Theorem 6.4(2) in [\[13\]](#page-25-5).

<span id="page-5-0"></span>**Lemma 2.7.** Let  $_{S}T_{R}$  be a bimodule.

- (i) If R is right coherent, then  $\text{id}((F \otimes_S T)_R) \leq \text{id}(T_R)$  for every flat S-module  $F_S$ .
- (ii) If S is left coherent, then  $\text{fd}(\text{Hom}_R(T, I)_S) \leq \text{id}(sT)$  for every injective R-module  $I_R$ .

*Proof.* It is straightforward by [\[8,](#page-25-2) Theorems 3.2.15 and 3.2.13 and Remarks 3.2.25 and 3.2.27].  $\Box$ 

**Definition 2.8.** A bimodule  $_{S}T_{R}$  is called tensorly faithful if it satisfies the following condi*tions for all modules*  $_R M$  *and*  $N_S$ .

- (i) If  $T \otimes_R M = 0$ , then  $M = 0$ .
- (ii) If  $N \otimes_S T = 0$ , then  $N = 0$ .

The concept of tensorly faithful modules was originally introduced in [\[13\]](#page-25-5) under the name "faithfully modules". To avoid ambiguity with faithful modules, we renamed this notion.

Note that, if R is a commutative Noetherian ring and  $S = R$ , then every Wakamatsu tilting R-module is tensorly faithful; see [\[13,](#page-25-5) Proposition 3.1]. We are unaware if this result carries over to the non-commutative setting. Also, in [\[13\]](#page-25-5) many examples of tensorly faithful Wakamatsu tilting modules were provided over a wide class of non-commutative rings.

<span id="page-5-1"></span>**Lemma 2.9.** Let  $_{S}T_{R}$  be a Wakamatsu tilting module. If T is tensorly faithful, then the *classes*  $\mathscr{A}_T(S)$  and  $\mathscr{B}_T(R)$  have the property that if two of three modules in a short exact *sequence are in the class, then so is the third.*

*Proof.* See [\[13,](#page-25-5) Corollary 6.3]. □

#### 3. Auslander classes

<span id="page-6-0"></span>We begin this section by reviewing the definitions of Gorenstein projective and Gorenstein flat modules.

**Definition 3.1.** (i) *An S*-module  $N<sub>S</sub>$  *is said to be Gorenstein projective if there exists an exact complex*

$$
\mathbf{P} : \cdots \to P_1 \to P_0 \to P^0 \to P^1 \to \cdots
$$

*of projective right* S-modules such that  $N \cong \text{Ker}(P^0 \to P^1)$ , and  $\text{Hom}_S(\mathbf{P}, P)$  is exact *for every projective* S-module  $P_S$ . The exact complex **P** *is referred to as a complete projective resolution of* N*.*

(ii)  $An S-module N<sub>S</sub> is said to be Gorenstein flat if there exists an exact complex$ 

$$
\mathbf{F} : \cdots \to F_1 \to F_0 \to F^0 \to F^1 \to \cdots
$$

*of flat right* S-modules such that  $N \cong \text{Ker}(F^0 \to F^1)$ , and  $\mathbf{F} \otimes_S I$  is exact for every *injective* S*-module* <sup>S</sup>I*. The exact complex* F *is referred to as a complete flat resolution of* N*.*

Definition 3.2. *The Gorenstein projective (respectively, Gorenstein flat) dimension of a nonzero* S-module  $N_S$ , denoted by  $Gpd(N_S)$  (respectively,  $Gfd(N_S)$ ), is the least non-negative *integer* n *such that there exists an exact complex*

$$
0 \to A_n \to \cdots \to A_1 \to A_0 \to N \to 0,
$$

<span id="page-6-1"></span>*where each* A<sup>i</sup> *is a Gorenstein projective (respectively, Gorenstein flat) right* S*-module.*

**Lemma 3.3.** Let S be a left coherent ring and  $N_S$  an S-module. Let  $\mathcal{L}$  be the class of all *right* S-modules with finite flat dimension. If  $\text{Ext}^i_S(N, L) = 0$  for every  $L \in \mathcal{L}$  and all  $i > 0$ , *then there exists a L-preenvelope*  $N \rightarrow P$ *, where*  $P_S$  *is a projective* S-module.

*Proof.* As S is a left coherent, there exists a flat-preenvelope  $\alpha : N \to F$  by [\[8,](#page-25-2) Proposition 6.5.1]. Consider a short exact sequence

$$
0 \to W \to P \xrightarrow{\beta} F \to 0,
$$

where  $P_S$  is a projective S-module. From this sequence, it easily follows that W is flat. Then, by the assumption  $\text{Ext}^1_S(N, W) = 0$ . Hence,

$$
Hom_S(N, \beta) : Hom_S(N, P) \to Hom_S(N, F)
$$

is surjective. So,  $\alpha : N \to F$  is lifted to a map  $f : N \to P$ , i.e.  $\alpha = \beta f$ . This implies that

 $\text{Hom}_S(\alpha, F') = \text{Hom}_S(f, F') \text{Hom}_S(\beta, F')$ 

for every flat right S-module F'. Since  $\text{Hom}_S(\alpha, F')$  is surjective, then so does  $\text{Hom}_S(f, F')$ . Consequently,  $f : N \to P$  is a flat-preenvelope.

Next, we show that  $f : N \to P$  is an  $\mathcal{L}$ -preenvelope. Indeed, we have to show that for every  $Y \in \mathcal{L}$ , the map

$$
Hom_S(f, Y) : Hom_S(P, Y) \to Hom_S(N, Y)
$$

is surjective. Let  $Y \in \mathcal{L}$ . We can consider a short exact sequence

$$
0 \to K \to Q \to Y \to 0,
$$

in which  $Q_S$  is projective and  $K \in \mathcal{L}$ . Applying the functor  $\text{Hom}_S(N, -)$  to it induces the following exact sequence

$$
0 \to \text{Hom}_S(N, K) \to \text{Hom}_S(N, Q) \to \text{Hom}_S(N, Y) \to 0.
$$

Thus, we have the following commutative diagram

$$
Hom_S(P,Q) \longrightarrow Hom_S(P,Y)
$$
  
\n
$$
\downarrow \qquad \qquad \downarrow
$$
  
\n
$$
Hom_S(N,Q) \longrightarrow Hom_S(N,Y).
$$

As the left vertical map and the bottom map are surjective, it follows that the right vertical map is also surjective.  $\Box$ 

<span id="page-7-0"></span>**Lemma 3.4.** Let  $_{S}T_{R}$  be a Wakamatsu tilting module, where  $R$  is a right coherent ring. *Suppose that*  $n = \text{id}(T_R) < \infty$ . Then, for every flat *S*-module  $F_S$ , we have  $\text{pd}(F_S) \leq n$ .

*Proof.* Let

$$
\mathbf{Q}_{\bullet}: \cdots \to P_{i-1} \to P_{i-2} \to \cdots \to P_1 \to P_0 \to F \to 0
$$

be a projective resolution of  $F<sub>S</sub>$ , and denote the complex

$$
\cdots \to P_{i-1} \to P_{i-2} \to \cdots \to P_1 \to P_0 \to 0
$$

by  $P_{\bullet}$ . Putting, for simplicity,  $P_{-1} = F$ ,  $K_0 = F$  and  $K_i = \text{Ker}(P_{i-1} \to P_{i-2})$  for all  $i \geq 1$ . Splitting  $Q_{\bullet}$  into short exact sequences yields that each  $K_i$  is flat, and so  $K_i \in \mathscr{A}_{T}(S)$  by Lemma  $2.6(1)$  $2.6(1)$ . To obtain the desired result, it suffices to show that the short exact sequence

$$
0 \to K_{n+1} \to P_n \to K_n \to 0
$$

splits. Indeed, we need to show that  $\text{Ext}^1_S(K_n, K_{n+1}) = 0$ . We have the following isomorphisms:

$$
\operatorname{Ext}_{S}^{1}(K_{n}, K_{n+1}) \cong \operatorname{Ext}_{S}^{n+1}(F, K_{n+1})
$$
  
\n
$$
\cong \operatorname{Ext}_{S}^{n+1}(F, \operatorname{Hom}_{R}(T, K_{n+1} \otimes_{S} T))
$$

$$
= \operatorname{H}^{n+1}(\operatorname{Hom}_{S}(\mathbf{P}_{\bullet}, \operatorname{Hom}_{R}(T, K_{n+1} \otimes_{S} T)))
$$

$$
\cong \operatorname{H}^{n+1}(\operatorname{Hom}_{R}(\mathbf{P}_{\bullet} \otimes_{S} T, K_{n+1} \otimes_{S} T))
$$

$$
\cong \operatorname{Ext}_{R}^{n+1}(F \otimes_{S} T, K_{n+1} \otimes_{S} T).
$$

The first isomorphism follows by dimension shift and the second isomorphism holds, because  $K_{n+1} \in \mathscr{A}_T(S)$ . The third isomorphism uses of tensor-hom adjunction. The fourth isomorphism follows from the fact the complex  $\mathbf{Q}_{\bullet} \otimes_S T$  is exact, and also

$$
\operatorname{Ext}_{R}^{i\geqslant 1}(P\otimes_{S}T, K_{n+1}\otimes_{S}T)\cong \operatorname{Ext}_{S}^{i\geqslant 1}(P, K_{n+1})=0
$$

for every projective S-module  $P_S$  by Lemma [2.6\(](#page-4-1)4). Since, by Lemma [2.7\(](#page-5-0)i),

$$
id((K_{n+1} \otimes_S T)_R) \le id(T_R) = n,
$$

we conclude that

$$
\operatorname{Ext}^{n+1}_R(F \otimes_S T, K_{n+1} \otimes_S T) = 0.
$$

This completes the proof.  $\Box$ 

Part (i) of the next result provides an answer to [\[10,](#page-25-13) Question 2].

Lemma 3.5. Let  $_{S}T_{R}$  be a Wakamatsu tilting module and  $N_{S}$  a Gorenstein flat S-module. *If either*

- (i)  $\text{pd}(sT) < \infty$ ; or
- (ii)  $id({}_ST) < \infty$ ,

*then*  $N \in \mathscr{A}_T(S)$ *.* 

*Proof.* As  $N_S$  is a Gorenstein flat  $S$ -module, there is an exact complex of flat modules

<span id="page-8-0"></span> $\mathbf{F}_{\bullet}: \cdots \to F_1 \to F_0 \to F^0 \to F^1 \to \cdots$ 

such that  $N \cong \text{Ker}(F^0 \to F^1)$  and it remains exact after applying  $-\otimes_S I$  for every injective S-module sI. It readily follows that for every S-module sL such that either  $\text{pd}(sL) < \infty$  or  $\text{id}(sL) < \infty$ , the complex  $\mathbf{F}_{\bullet} \otimes_R L$  is exact, and so  $\text{Tor}_i^S(N, L) = 0$  for all  $i \geq 1$ . In particular,  $Tor_i^S(N,T) = 0$  for all  $i \geq 1$ .

Since the complex  $\mathbf{F}_{\bullet} \otimes_R T$  is exact, we have the following exact sequence

(3.1) 
$$
0 \to N \otimes_S T \to F^0 \otimes_S T \to F^1 \otimes_S T.
$$

Applying the functor  $\text{Hom}_R(T, -)$  to [\(3.1\)](#page-8-0), gives rise to the following commutative diagram with exact rows:

$$
\begin{array}{ccc}\n0 & \xrightarrow{\hspace{1cm}} & N \xrightarrow{\hspace{1cm}} & F^{0} \xrightarrow{\hspace{1cm}} & F^{1} \\
\downarrow \theta_{N}^{T} & & \downarrow \theta_{F^{0}}^{T} & & \downarrow \theta_{F^{1}}^{T} \\
0 & \xrightarrow{\hspace{1cm}} & \text{Hom}_{R}(T, N \otimes_{S} T) \xrightarrow{\hspace{1cm}} & \text{Hom}_{R}(T, F^{0} \otimes_{S} T) \xrightarrow{\hspace{1cm}} & \text{Hom}_{R}(T, F^{1} \otimes_{S} T)\n\end{array}
$$

But each  $\theta_{F_i}^T$  is an isomorphism, because  $F^i \in \mathscr{A}_T(S)$  for  $i = 0, 1$ . Consequently,  $\theta_N^T$  is also an isomorphism.

For showing that  $N \in \mathscr{A}_T(S)$ , it remains to prove that  $\text{Ext}^i_R(T, N \otimes_S T) = 0$  for all  $i \geq 1$ . To this end, by induction on i, we show that  $\text{Ext}^i_R(T, G \otimes_S T) = 0$  for every Gorenstein flat S-module  $G_S$  and all  $i \geq 1$ . Let  $G_S$  be a Gorenstein flat S-module. We can consider a short exact sequences

$$
0 \to G \to F \to K \to 0,
$$

in which  $F<sub>S</sub>$  is a flat S-module and  $K<sub>S</sub>$  is a Gorenstein flat S-module. From the above, we get that

(3.2) 
$$
0 \to G \otimes_S T \to F \otimes_S T \to K \otimes_S T \to 0.
$$

is exact and that for every Gorenstein flat  $S$ -module  $L_S$ , the natural map

<span id="page-9-0"></span>
$$
\theta_L^T: L \to \text{Hom}_R(T, L \otimes_S T)
$$

is an isomorphism. Thus applying the functor  $\text{Hom}_R(T, -)$  to [\(3.2\)](#page-9-0), yields the following long exact sequence

$$
0 \to G \to F \to K \to \text{Ext}^1_R(T, G \otimes_S T) \to \text{Ext}^1_R(T, F \otimes_S T) \to \cdots
$$

 $\cdots \to \text{Ext}_{R}^{i-1}(T, F \otimes_{S} T) \to \text{Ext}_{R}^{i-1}(T, K \otimes_{S} T) \to \text{Ext}_{R}^{i}(T, G \otimes_{S} T) \to \text{Ext}_{R}^{i}(T, F \otimes_{S} T) \to \cdots$ But  $\text{Ext}_{R}^{i\geqslant 1}(T, F\otimes_{S} T)=0$ , since  $F\in \mathscr{A}_{T}(S)$ . Thus  $\text{Ext}_{R}^{1}(T, G\otimes_{S} T)=0$  and

$$
\operatorname{Ext}^i_R(T, G \otimes_S T) \cong \operatorname{Ext}^{i-1}_R(T, K \otimes_S T)
$$

for all  $i \geq 2$ . So, the claim holds for  $i = 1$ .

Assume that  $i \geq 2$  and  $\text{Ext}_{R}^{i-1}(T, K \otimes_{S} T) = 0$  for all Gorenstein flat S-modules  $K_S$ . Then from the above isomorphism and the induction hypothesis, it follows that  $\mathrm{Ext}^i_R(T, G \otimes_S T)$  $\Box$ 

<span id="page-9-1"></span>Lemma [2.9](#page-5-1) yields:

**Corollary 3.6.** Let  $_{S}T_{R}$  be a tensorly faithful Wakamatsu tilting module and  $N_{S}$  an S-module *with*  $Gfd(N_S) < \infty$ . If either  $pd(sT) < \infty$  or  $id(sT) < \infty$ , then  $N \in \mathscr{A}_T(S)$ .

Now, we are ready to prove the main result of this section.

<span id="page-10-0"></span>**Theorem 3.7.** Let  $_{STR}$  be a tensorly faithful Wakamatsu tilting module, where the ring R *is right coherent and the ring* S *is left coherent. Assume that*  $id(T_R) < \infty$  *and*  $id(sT) < \infty$ *. Then, for an S-module*  $N_S$ *, the following are equivalent:* 

- (i)  $N \in \mathscr{A}_T(S)$ .
- (ii) Gpd $(N_S) < \infty$ .
- (iii) Gfd $(N_S) < \infty$ .

*Proof.* (i) $\Rightarrow$ (ii) Let

$$
\cdots \to P_i \xrightarrow{f_i} P_{i-1} \to \cdots \to P_1 \xrightarrow{f_1} P_0 \xrightarrow{f_0} N \to 0
$$

be a projective resolution of N and let  $n = id(T_R)$ . In order to obtain the desired result, it suffices to show that  $D := \text{Ker}(f_n)$  is a Gorenstein projective S-module. To do this, by [\[14,](#page-25-14) Proposition 2.3, we have to show that  $\text{Ext}_{S}^{i\geqslant 1}(D, P) = 0$  for all projective S-module  $P_S$  and there exists an exact complex

$$
\mathbf{P}^{\bullet}: 0 \to D \to P^0 \to P^1 \to P^2 \to \cdots,
$$

in which each  $P^i$  is a projective right S-module and it remains exact after applying  $\operatorname{Hom}_S(-, Q)$ for every projective S-module  $Q_S$ .

For the first assertion, it suffices to show that  $\text{Ext}^i_S(D, F) = 0$  for every flat S-modules  $F_S$ and all  $i \geq 1$ . Let  $F_S$  be a flat S-module. For each  $i \geq 1$ , we have

$$
\text{Ext}^i_S(D, F) \cong \text{Ext}^{i+n+1}_S(N, F) \cong \text{Ext}^{i+n+1}_R(N \otimes_S T, F \otimes_S T).
$$

The first isomorphism follows from dimension shift and the second isomorphism holds by Lemma  $2.6(4)$  $2.6(4)$ . By Lemma  $2.7(i)$  $2.7(i)$ , we have

<span id="page-10-1"></span>
$$
id((F \otimes_S T)_R) \le id(T_R) = n.
$$

Hence,

$$
\operatorname{Ext}_{S}^{i}(D,F) = 0
$$

for all  $i \geqslant 1$ .

Next, we prove the second assertion. By using [\(3.3\)](#page-10-1), it easily follows that  $\text{Ext}_{S}^{i\geqslant 1}(D,L)=0$ for all  $L \in \mathcal{L} = \{L \mid \text{fd}(L_S) < \infty\}$ . So, by Lemma [3.3,](#page-6-1) there exists a projective right S-module  $P^0$  and S-homomorphism  $\mu : D \to P^0$ , which is an  $\mathcal{L}$ -preenvelope. As N and  $P_i$ s are in  $\mathscr{A}_{T}(S)$ , by Lemma [2.6\(](#page-4-1)1) so does D. Thus, by [\[13,](#page-25-5) Theorem 2], there exists an injective R-module  $I_R$  such that D embeds in  $\text{Hom}_R(T, I)$ . On the other hand, by the assumption and Lemma  $2.7(ii)$  $2.7(ii)$ , we have

$$
\mathrm{fd}(\mathrm{Hom}_R(T,I)_S) \leq \mathrm{id}({}_S T) < \infty.
$$

Hence,  $\text{Hom}_R(T, I) \in \mathcal{L}$ . As  $\text{Hom}_R(T, I) \in \mathcal{L}$ , it follows that  $\mu$  is monic. Now, we consider the short exact sequence

(3.4) 
$$
0 \to D \stackrel{\mu}{\to} P^0 \to P^0/D \to 0.
$$

Since  $P^0$  and D are in  $\mathscr{A}_T(S)$ , Lemma [2.9](#page-5-1) implies that  $P^0/D \in \mathscr{A}_T(S)$ . Let us take  $L \in \mathcal{L}$ , applying the functor  $\text{Hom}_S(-, L)$  to [\(3.4\)](#page-11-1), gives rise to the following exact sequence:

 $0 \to \text{Hom}_S(P^0/D, L) \to \text{Hom}_S(P^0, L) \stackrel{f}{\to} \text{Hom}_S(D, L) \to \text{Ext}^1_S(P^0/D, L) \to 0,$ 

and the isomorphisms

<span id="page-11-1"></span>
$$
\mathrm{Ext}^{i+1}_S(P^0/D, L) \cong \mathrm{Ext}^i_S(D, L)
$$

for all  $i \geq 1$ . Since the map f is surjective, it turns out that  $\text{Ext}^1_S(P^0/D, L) = 0$ . Thus,  $\text{Ext}_{S}^{i}(P^{0}/D, L) = 0$  for all  $i \geq 1$ . So, by the above argument, there exist a projective Smodule  $P^1$  and an S-monomorphism  $P^0/D \to P^1$  which is an *L*-preenvelope. We proceed in this manner to construct an exact complex

$$
0 \to D \to P^0 \to P^1 \to P^2 \to \cdots,
$$

in which each  $P^i$  is a projective right S-module and it remains exact after applying  $\operatorname{Hom}_S(-, Q)$ for every projective S-module Q.

(ii)  $\Rightarrow$  (iii) By Lemma [3.4,](#page-7-0) one has pd( $F_S$ )  $< \infty$  for every flat S-module  $F_S$ . This fact and the proof of [\[14,](#page-25-14) Proposition 3.4] yield that every Gorenstein projective right S-module is Gorenstein flat. So,  $Gfd(N_S) < \infty$ .

<span id="page-11-0"></span>(iii)  $\Rightarrow$  (i) is obvious by Corollary [3.6.](#page-9-1)

## 4. Bass classes

We start this section by reviewing the definition of Gorenstein injective modules.

Definition 4.1. *An* R*-module* M<sup>R</sup> *is said to be Gorenstein injective if there exists an exact complex*

$$
\mathbf{E} : \cdots \to E_1 \to E_0 \to E^0 \to E^1 \to \cdots
$$

*of injective right* R-modules such that  $M \cong \text{Ker}(E^0 \to E^1)$ , and  $\text{Hom}_R(I, \mathbf{E})$  is exact for *every injective* R*-module* IR*. The exact complex* E *is called a complete injective resolution of* M*.*

Definition 4.2. *The Gorenstein injective dimension of a nonzero* R*-module* MR*, denoted by*  $Gid(M_R)$ , is the least non-negative integer n such that there exists an exact complex

$$
0 \to M \to B^0 \to B^1 \to \cdots \to B^n \to 0,
$$

*where each* B<sup>i</sup> *is a Gorenstein injective right* R*-module.*

<span id="page-12-1"></span>**Lemma 4.3.** Let R be a right Noetherian ring and  $M_R$  an R-module. Let E denote the class *of all right* R-modules with finite injective dimension. If  $\text{Ext}^i_R(L, M) = 0$  for all  $L \in \mathcal{E}$  and *all*  $i > 0$ , then there exists an  $\mathcal{E}\text{-precover } E \to M$ , where  $E_R$  is an injective R-module.

*Proof.* Since  $R$  is a right Noetherian, by [\[8,](#page-25-2) Theorem 5.4.1], there exists an injective-precover  $\alpha : E \to M$ . We have to show that the map

$$
Hom_R(X, \alpha) : Hom_R(X, E) \to Hom_R(X, M)
$$

is surjective for every  $X \in \mathcal{E}$ . Let  $X \in \mathcal{E}$ . We can consider a short exact sequence

$$
0 \to X \to E' \to W \to 0,
$$

where E' is an injective right R-module and  $W \in \mathcal{E}$ . Applying the functor  $\text{Hom}_R(-, M)$  to this short exact sequence, yields the following exact sequence

$$
0 \to \text{Hom}_R(W, M) \to \text{Hom}_R(E', M) \to \text{Hom}_R(X, M) \to 0.
$$

Thus, we have the following commutative diagram

$$
Hom_R(E', E) \longrightarrow Hom_R(X, E)
$$
  
\n
$$
\downarrow \qquad \qquad \downarrow
$$
  
\n
$$
Hom_R(E', M) \longrightarrow Hom_R(X, M).
$$

As the left vertical map and the bottom map are surjective, it follows that the right vertical map is also surjective.  $\Box$ 

Recently, Gao and Zhao [\[10,](#page-25-13) Theorem 4.11] proved that if  $sT_R$  is tensorly faithful Wakamatsu tilting module with  $pd(T_R) < \infty$ , then every Gorenstein injective right R-module is in  $\mathscr{B}_{T}(R)$ . Next, we show that the assumption "tensorly faithfulness" is unnecessary.

<span id="page-12-0"></span>**Lemma 4.4.** Let  $_{S}T_{R}$  be a Wakamatsu tilting module and  $M_{R}$  a Gorenstein injective R*module. If either*

- (i)  $pd(T_R) < \infty$ ; or
- (ii)  $id(T_R) < \infty$ ,

*then*  $M \in \mathcal{B}_T(R)$ *.* 

*Proof.* Let

$$
\mathbf{E}_{\bullet} : \cdots \to E_1 \to E_0 \to E^0 \to E^1 \to \cdots
$$

be a complete injective resolution of M. So,  $M \cong \text{Ker}(E^0 \to E^1)$ . It easily follows that for each R-module  $L_R$  such that either  $\text{pd}(L_R) < \infty$  or  $\text{id}(L_R) < \infty$ , the complex  $\text{Hom}_R(L, \mathbf{E}_\bullet)$ is exact, and so  $\text{Ext}^i_R(L,M) = 0$  for all  $i \geq 1$ . In particular,  $\text{Ext}^i_R(T,M) = 0$  for all  $i \geq 1$ .

<span id="page-13-0"></span>Since the complex  $\text{Hom}_R(T, \mathbf{E}_{\bullet})$  is exact, the sequence

(4.1) 
$$
\text{Hom}_R(T, E_1) \to \text{Hom}_R(T, E_0) \to \text{Hom}_R(T, M) \to 0
$$

is exact. Applying the functor  $-\otimes_S T$  to [\(4.1\)](#page-13-0) gives rise to the following commutative diagram with exact rows:

$$
\operatorname{Hom}_R(T, E_1) \otimes_S T \longrightarrow \operatorname{Hom}_R(T, E_0) \otimes_S T \longrightarrow \operatorname{Hom}_R(T, M_1) \otimes_S T \longrightarrow 0
$$

$$
\downarrow \iota_{E_1}^T \qquad \qquad \downarrow \iota_{E_0}^T \qquad \qquad \downarrow \iota_M^T
$$

$$
E_1 \longrightarrow E_0 \longrightarrow M \longrightarrow 0
$$

Each  $\nu_{E_i}^T$  is an isomorphism, because  $E_i \in \mathscr{B}_T(R)$  for  $i = 0, 1$ . Consequently,  $\nu_M^T$  is also an isomorphism.

To complete the proof, by induction on i, we show that  $\text{Tor}_i^S(\text{Hom}_R(T, G), T) = 0$  for every Gorenstein injective R-module  $G_R$  and all  $i \geq 1$ . Let  $G_R$  be a Gorenstein injective R-module. We can consider a short exact sequence

$$
0 \to K \to E \to G \to 0,
$$

where  $E_R$  is an injective R-module and  $K_R$  is a Gorenstein injective R-module. From the above, we get that

(4.2) 
$$
0 \to \text{Hom}_R(T, K) \to \text{Hom}_R(T, E) \to \text{Hom}_R(T, G) \to 0
$$

is exact and that for every Gorenstein injective  $R$ -module  $L_R$ , the natural map

<span id="page-13-1"></span>
$$
\nu_L^T : \text{Hom}_R(T, L) \otimes_S T \to L
$$

is an isomorphism. Hence applying the functor  $-\otimes_S T$  to [\(4.2\)](#page-13-1), implies the following long exact sequence

$$
\cdots \to \operatorname{Tor}_{1}^{S}(\operatorname{Hom}_{R}(T, E), T) \to \operatorname{Tor}_{1}^{S}(\operatorname{Hom}_{R}(T, G), T) \to K \to E \to G \to 0
$$

$$
\to \operatorname{Tor}_{i}^{S}(\operatorname{Hom}_{R}(T, G), T) \to \operatorname{Tor}_{i-1}^{S}(\operatorname{Hom}_{R}(T, K), T) \to \operatorname{Tor}_{i-1}^{S}(\operatorname{Hom}_{R}(T, E), T)
$$

$$
\cdots \to \operatorname{Tor}_{i}^{S}(\operatorname{Hom}_{R}(T, E), T)
$$

But  $\text{Tor}_{i\geq 1}^S(\text{Hom}_R(T, E), T) = 0$ , since  $E \in \mathscr{B}_T(R)$ . Thus,  $\text{Tor}_1^S(\text{Hom}_R(T, G), T) = 0$  and  $Tor_i^S(\text{Hom}_R(T, G), T) \cong \text{Tor}_{i-1}^S(\text{Hom}_R(T, K), T)$ 

for all  $i \geq 2$ . In particular, the claim hold for  $i = 1$ .

Assume that  $i \geq 2$  and  $\text{Tor}_{i-1}^S(\text{Hom}_R(T, K), T) = 0$  for all Gorenstein injective Rmodules  $K_R$ . Then from the above isomorphism and the induction hypothesis, it follows that  $\operatorname{Tor}_i^S(\operatorname{Hom}_R(T, G), T) = 0.$ 

<span id="page-14-1"></span>As an immediate consequence of Proposition [4.4](#page-12-0) and Lemma [2.9,](#page-5-1) we have the following result:

Corollary 4.5. Let  $_{S}T_{R}$  be a tensorly faithful Wakamatsu tilting module and  $M_{R}$  an  $R$ *module with*  $\text{Gid}(M_R) < \infty$ . If either  $\text{pd}(T_R) < \infty$  or  $\text{id}(T_R) < \infty$ , then  $M \in \mathcal{B}_T(R)$ .

<span id="page-14-0"></span>We are now prepared for proving the main result of this section.

**Theorem 4.6.** Let  $_{S}T_{R}$  be a tensorly faithful Wakamatsu tilting module, where the ring  $R$  is *right Noetherian and the ring* S *is left coherent. Assume that*  $id(T_R) < \infty$  *and*  $id(sT) < \infty$ *. Then, for an* R*-module* MR*, the following are equivalent:*

- (i)  $M \in \mathscr{B}_T(R)$ .
- (ii) Gid $(M_R) < \infty$ .

*Proof.* (i) $\Rightarrow$ (ii) Let

$$
0 \longrightarrow M \xrightarrow{g^{-1}} E^0 \xrightarrow{g^0} E^1 \longrightarrow \cdots \longrightarrow E^{i-1} \xrightarrow{g^{i-1}} E^i \longrightarrow \cdots
$$

be an injective resolution of M,  $n = id(T_R)$  and  $d = id({}_S T)$ . To conclude the desired result, it suffices to show that  $D := \text{Coker}(g^{(n+d)-1})$  is a Gorenstein injective right R-module.

For this purpose, it suffices to show that  $\text{Ext}_R^{i\geqslant 1}(I,D)=0$  for every injective R-module  $I_R$  and that there exists an exact complex

$$
\mathbf{E}^{\bullet}: \cdots \to E_n \to E_{n-1} \to \cdots \to E_1 \to E_0 \to D \to 0,
$$

in which each  $E_i$  is an injective right R-module and it remains exact after applying  $\operatorname{Hom}_R(I,-)$ for every injective  $R$ -module  $I_R$ .

For the first assertion, let  $I_R$  be an injective R-module. For each  $i \geq 1$ , we have

$$
\operatorname{Ext}^i_R(I, D) \cong \operatorname{Ext}^{i+(d+n)+1}_R(I, M) \cong \operatorname{Ext}^{i+(d+n)+1}_S(\operatorname{Hom}_R(T, I), \operatorname{Hom}_R(T, M)).
$$

The first isomorphism follows from dimension shift and the second isomorphism holds by Lemma  $2.6(5)$  $2.6(5)$ . On the other hand,

$$
\mathrm{fd}(\mathrm{Hom}_R(T,I)_S) \leq \mathrm{id}({}_S T) = d
$$

by Lemma  $2.7$ (ii). By applying Lemma  $3.4$ , we conclude that

$$
\mathrm{pd}(\mathrm{Hom}_R(T,I)_S) \leqslant n + d.
$$

Consequently,  $\text{Ext}_{R}^{i}(I, D) = 0$  for all  $i \geq 1$ . From this, we can easily deduce that

$$
\operatorname{Ext}^{i\geqslant 1}_R(L,D)=0
$$

for every  $L \in \mathcal{E}$ , where  $\mathcal{E}$  is the class of all right R-modules with finite injective dimension.

Next, we establish the second assertion. By Lemma [4.3,](#page-12-1) there exist an injective right R-module  $E_0$  and an R-homomorphism  $\rho : E_0 \to D$ , which is an  $\mathcal{E}$ -precover. As M and  $E^i$ s are in  $\mathcal{B}_T(R)$ , then by Lemma [2.6\(](#page-4-1)2) so does D. Therefore, by [\[13,](#page-25-5) Theorem 6.1], there exists a projective S-module  $P_S$  and an epimorphism  $P \otimes_S T \to D$ . On the other hand, by the assumption and Lemma  $2.7(i)$  $2.7(i)$ , we have

<span id="page-15-0"></span>
$$
\mathrm{id}_R((P \otimes_S T)_R) \leq \mathrm{id}(T_R) < \infty,
$$

and so  $P \otimes_S T \in \mathcal{E}$ . As  $P \otimes_S T \in \mathcal{E}$ , it follows that the map  $\rho$  is epic. Now, we consider the short exact sequence

(4.3) 
$$
0 \to K \to E_0 \stackrel{\rho}{\to} D \to 0.
$$

Since  $E_0$  and D are in  $\mathscr{B}_T(R)$ , Lemma [2.9](#page-5-1) implies that  $K \in \mathscr{B}_T(R)$ . Let us take  $L \in \mathcal{E}$ , applying the functor  $\text{Hom}_R(L, -)$  to [\(4.3\)](#page-15-0) gives rise to the following exact sequence

$$
0 \to \text{Hom}_R(L, K) \to \text{Hom}_R(L, E_0) \overset{g}{\to} \text{Hom}_R(L, D) \to \text{Ext}^1_R(L, K) \to 0,
$$

and the isomorphisms

$$
\operatorname{Ext}^{i+1}_R(L, K) \cong \operatorname{Ext}^{i}_R(L, D)
$$

for all  $i \geq 1$ . As the map g is surjective, we get  $\text{Ext}^1_R(L, K) = 0$ . Thus,  $\text{Ext}^i_R(L, K) = 0$  for all  $i \geq 1$ . Hence, by the above argument, there exists an injective right R-module  $E_1$  and an epimorphism  $E_1 \to K$  which is  $\mathcal{E}_2$ -precover. We proceed in this manner to construct an exact complex

$$
\cdots \to E_n \to E_{n-1} \to \cdots \to E_1 \to E_0 \to D \to 0,
$$

in which each  $E_i$  is an injective right R-module and it remains exact after applying  $\operatorname{Hom}_R(I,-)$ for every injective  $R$ -module  $I_R$ .

<span id="page-15-1"></span>(ii)  $\Rightarrow$  (i) is immediate by Corollary [4.5.](#page-14-1)

Remark 4.7. *Considering Theorems [3.7](#page-10-0) and [4.6,](#page-14-0) one may wonder if we can characterize the classes*  $\mathscr{A}_T(S)$  and  $\mathscr{B}_T(R)$  in the case  ${}_S T_R$  is a Wakamatsu tilting module with  $pd(T_R)$  $\infty$  and  $\text{pd}(sT) < \infty$ . It is straightforward to observe that if  $sT_R$  is a Wakamatsu tilting *module with*  $pd(T_R) < \infty$  *and*  $pd(sT) < \infty$ *, then*  $sT_R$  *is a tilting module. Furthermore, by* [\[21,](#page-26-0) Lemma 1.21]*, for any tilting module*  ${}_S T_R$ *, it is known that*  $\mathscr{A}_T(S) = \{N \in Mod\text{-}S \mid \text{and } S\}$  $Tor_{i\geq 1}^S(N,T)=0$ } and  $\mathscr{B}_T(R)=T^{\perp}$ .

Example 4.8. *Let* Γ *be a commutative Gorenstein ring and* Q *a finite acyclic quiver. By* [\[4,](#page-25-15) Corollary 2.14] *the path algebra*  $\Gamma \mathcal{Q}$  *is also Gorenstein. Take*  $T = R = \Gamma \mathcal{Q}$ *. Then*  $S = \text{End}_R(T) = R$  and T is a tilting module. Specifically, T is a tensorly faithful Wakamatsu *tilting module satisfying the assumptions of Theorems [3.7](#page-10-0) and [4.6.](#page-14-0) Therefore, by Remark* [4.7,](#page-15-1) we have  $\mathscr{A}_T(S) = \mathscr{B}_T(R) = Mod-R$ .

#### 5. Cotilting modules

<span id="page-16-0"></span>Let A be a commutative Artinian ring with identity. Let  $\mathscr E$  be the minimal injective cogenerator of A, and set  $D(-) = \text{Hom}_{A}(-, \mathscr{E})$ . Let R be an Artin A-algebra. In 1991, Auslander and Reiten introduced cotilting modules, as analogous to dualizing modules; see [\[2\]](#page-25-9) and [\[3\]](#page-25-10). By their definition, an R-module  $C_R$  is *cotilting* if  $\text{Ext}_R^{i \geq 1}(C, C) = 0$ , id $(C_R) < \infty$ , and there exists an exact sequence

$$
0 \to C_r \to \cdots \to C_0 \to D(R) \to 0
$$

with each  $C_i$  in add(C). It is easy to verify that an R-module  $C_R$  is cotilting if and only if  $RDC$  is a tilting R-module. This definition was extended to (not necessarily finitely generated) modules over general associative rings with identity by Hügel and Coelho [\[17\]](#page-25-11) in 2001; see Definition [5.1.](#page-16-1) Also, two more definitions for cotilting modules were introduced in [\[21\]](#page-26-0) and [\[1\]](#page-25-12). In this section, we compare these four definitions for cotilting modules; see Remark [5.7.](#page-23-0)

<span id="page-16-1"></span>Next, we recall the Hügel and Coelho definition of cotilting modules.

Definition 5.1. *An* R*-module* C<sup>R</sup> *is called cotilting if*

- (i) id $(C_R) < \infty$ ,
- (ii)  $\operatorname{Ext}_{R}^{i\geqslant 1}(C^{I}, C) = 0$  *for every set I, and*
- (iii) *there exists an injective cogenerator* Q<sup>R</sup> *of* R *and an exact sequence*

$$
0 \to C_r \to \cdots \to C_0 \to Q \to 0
$$

*with each*  $C_i$  *in*  $\text{Prod}(C)$ *.* 

<span id="page-16-3"></span>Theorem [5.6](#page-21-0) is the main result of this section. To prove it, we need the following four lemmas.

**Lemma 5.2.** Let R be a right coherent ring, S a left coherent ring and  ${}_{S}C_{R}$  a Wakamatsu *tilting module. Assume that both*  $id(C_R)$  *and*  $id({}_{S}C)$  *are finite. Then for any injective cogenerator* Q<sup>R</sup> *of* R*, there exists an exact sequence*

$$
0 \to C_n \to \cdots \to C_0 \to Q \to 0
$$

*with each*  $C_i \in \text{Add}(C)$ *.* 

*Proof.* Let  $Q_R$  be an injective cogenerator of R and  $m = id({}_{S}C)$ . One has  $id(\text{Hom}_R(C, Q)_S)$  $id(sC) = m$  by [\[8,](#page-25-2) Theorem 3.2.19 and Remarks 3.2.25 and 3.2.27]. Thus, we have an exact sequence

<span id="page-16-2"></span>
$$
(5.1) \t 0 \to F_{m+1} \to S^{(I_m)} \to S^{(I_{m-1})} \to \cdots \to S^{(I_0)} \to \text{Hom}_R(C, Q) \to 0,
$$

where  $F_{m+1}$  is a flat right S-module. As  $Q \in \mathscr{B}_C(R)$ , we have  $\text{Tor}_{i\geq 1}^S(\text{Hom}_R(C, Q), C) = 0$ and  $\text{Hom}_R(C, Q) \otimes_S C \cong Q$ , and so applying the functor  $-\otimes_S C$  to [\(5.1\)](#page-16-2) yields the following exact sequence

<span id="page-17-0"></span>
$$
0 \longrightarrow F_{m+1} \otimes_S C \longrightarrow C^{(I_m)} \xrightarrow{d_m} C^{(I_{m-1})} \longrightarrow \cdots \longrightarrow C^{(I_0)} \xrightarrow{d_0} Q \longrightarrow 0.
$$

Showing that  $F_{m+1} \otimes_S C \in \text{Add}(C)$ , would complete the proof.

Set  $K_{-1} = Q$  and  $K_j = \text{Ker } d_j$  for every  $j = 0, ..., m$ . From the exact sequences

(5.2) 
$$
0 \to K_j \to C^{(I_j)} \to K_{j-1} \to 0 \quad j = 0, ..., m,
$$

and [\[8,](#page-25-2) Theorem 3.2.15 and Remarks 3.2.25 and 3.2.27], we conclude that

(5.3)  
\n
$$
\operatorname{Ext}_{R}^{i\geqslant 1}(C^{(I_{j})}, K_{m}) \cong \operatorname{Ext}_{R}^{i\geqslant 1}(C, K_{m})^{I_{j}}
$$
\n
$$
\cong \operatorname{Ext}_{R}^{i\geqslant 1}(C, F_{m+1} \otimes_{S} C)^{I_{j}}
$$
\n
$$
\cong (F_{m+1} \otimes_{S} \operatorname{Ext}_{R}^{i\geqslant 1}(C, C))^{I_{j}}
$$
\n
$$
= 0.
$$

By Lemma  $2.7(i)$  $2.7(i)$  and [\[15,](#page-25-16) Theorem 2.7], we have

<span id="page-17-1"></span>
$$
id((K_m)_R) = id((F_{m+1} \otimes_S C)_R) \le id(C_R) = id({_S}C) = m.
$$

Hence, using the exact sequences  $(5.2)$  and the isomorphisms  $(5.3)$  yield that

$$
\operatorname{Ext}^1_R(K_{m-1}, K_m) \cong \operatorname{Ext}^{m+1}_R(Q, K_m) = 0.
$$

Thus the short exact sequence

$$
0 \to K_m \to C^{(I_m)} \to K_{m-1} \to 0
$$

splits, and so  $K_{m-1} \in \text{Add}(C)$ .

<span id="page-17-2"></span>In the proof of Lemma [5.4,](#page-18-0) we will use the following lemma several times.

**Lemma 5.3.** Let  $C_R$  be an R-module, and set  $\mathcal{H} = {}^{\perp}C$ .

- (i) Assume that  $n = \text{id}(C_R) < \infty$ . Then  $\widehat{\mathcal{H}} = Mod-R$ .
- (ii) Assume that  $\text{Ext}_{R}^{i\geqslant 1}(C^{I}, C) = 0$  for every sets I, and  $\mathscr{H} \subseteq Cogen(C)$ . Then  $\mathscr{H} \bigcap \mathscr{H}^{\perp} = \text{Prod}(C)$ , and for any  $X \in \mathscr{H}$ , there exists a short exact sequence

$$
0 \to X \to C_0 \to X' \to 0
$$

*with*  $C_0 \in \text{Prod}(C)$  *and*  $X' \in \mathcal{H}$ *.* 

*Proof.* (i) See [\[17,](#page-25-11) Lemma 2.2(b)].

(ii) See [\[17,](#page-25-11) Lemma 2.4(b)].

<span id="page-18-0"></span>**Lemma 5.4.** Assume that an R-module  $C_R$  satisfies the following conditions:

 $(i)$  id $(C_R) < \infty$ *.* (*ii*)  $\operatorname{Ext}^{i \geq 1}_R(C^I, C) = 0$  *for every set* I.

*Then the following are equivalent:*

(a) *There exists an injective cogenerator* Q<sup>R</sup> *of* R *and an exact sequence*

$$
0 \to C_r \to \cdots \to C_0 \to Q \to 0
$$

*with each*  $C_i \in \text{Prod}(C)$ *.* 

(b) For any  $X \in {}^{\perp}C$ , there exists a short exact sequence

$$
0 \to X \to C_0 \to X' \to 0
$$

*with*  $C_0 \in \text{Prod}(C)$  *and*  $X' \in {}^{\perp}C$ *.* 

*Proof.* (a)  $\Longrightarrow$  (b) In view of (ii) and (a), [\[17,](#page-25-11) Lemma 2.3(b)] implies that  $\bot$  C  $\subseteq$  Cogen(C). Now, as C satisfies (ii) and  $\perp C \subseteq \text{Cogen}(C)$ , by Lemma [5.3\(](#page-17-2)ii), it follows that for any  $X \in {}^{\perp}C$ , there exists a short exact sequence

<span id="page-18-1"></span>
$$
0 \to X \to C_0 \to X' \to 0
$$

with  $C_0 \in \text{Prod}(C)$  and  $X' \in {}^{\perp}C$ .

(b)  $\Longrightarrow$  (a) Suppose that  $Q_R$  is an injective cogenerator of R, and set  $\mathcal{H} = {}^{\perp}C$  and  $\mathscr{W} = \text{Prod}(C)$ . Clearly  $\mathscr{W} \subseteq \mathscr{H}$ , because (ii) holds. Since id $(C_R) < \infty$ , by Lemma [5.3\(](#page-17-2)i), we conclude that  $\widehat{\mathscr{H}} = \text{Mod-}R$ . As C satisfies (b) and  $\mathscr{W} \subseteq \mathscr{H}$ , by [\[17,](#page-25-11) Theorem 3.2(i)], there is a short exact sequence

(5.4) 
$$
0 \to K_Q \to C_Q \to Q \to 0
$$

with  $C_Q \in \mathcal{H}$  and  $K_Q \in \widehat{\mathcal{W}}$ . As  $K_Q \in \widehat{\mathcal{W}}$ , by definition, there is an exact sequence

$$
(5.5) \t\t 0 \to C_r \to \cdots \to C_1 \to K_Q \to 0
$$

with each  $C_j \in \mathscr{W}$ . Splitting this exact sequence into short exact sequences and noting that  $\mathscr{W} \subseteq \mathscr{H}$ <sup> $\perp$ </sup> implies that  $K_Q \in \mathscr{H}$ <sup> $\perp$ </sup>. Now, as both  $K_Q$  and Q belong to  $\mathscr{H}$ <sup> $\perp$ </sup>, from [\(5.4\)](#page-18-1), we deduce that  $C_Q \in \mathcal{H}^{\perp}$ . Hence,  $C_Q \in \mathcal{H} \cap \mathcal{H}^{\perp}$ . By (b), we get  $\mathcal{H} \subseteq \mathrm{Cogen}(C)$ , and so Lemma [5.3\(](#page-17-2)ii) yields that  $\mathscr{H} \bigcap \mathscr{H}^{\perp} = \mathscr{W}$ . So,  $C_Q \in \mathscr{W}$ . Now, by splicing the exact sequences  $(5.4)$  and  $(5.5)$ , we get the exact sequence

<span id="page-18-2"></span>
$$
0 \to C_r \to \cdots \to C_1 \to C_0 \to Q \to 0,
$$

where  $C_0 = C_Q$ .

 $\Box$ 

<span id="page-19-1"></span>**Lemma 5.5.** Let  $C_R$  be an R-module and  $S = \text{End}(C_R)$ . Assume that:

- *(i) The ring* S *is left coherent.*
- $(ii) \text{Ext}_{R}^{i \geq 1}(C, C) = 0.$
- *(iii)* There exists an injective cogenerator  $Q_R$  of R and an exact sequence

$$
0 \to C_n \stackrel{d_n}{\to} \cdots \to C_0 \stackrel{d_0}{\to} Q \to 0
$$

*with each*  $C_i \in \text{Prod}(C)$ *.* 

*Then, we have:*

- (a) id( $_{S}C$ )  $\leqslant n$ .
- (b) If sC is finitely generated, then  $\text{Ext}_{S}^{\infty,1}(C, C) = 0$  and the natural homothety map  $\chi: R \to \text{Hom}_S(C, C)$  *is an isomorphism.*
- (c) If the ring R is right coherent and both modules  $C_R$  and  $C_R$  are finitely generated, *then*  $\text{id}(sC) < \infty$  *and*  $sC_R$  *is a Wakamatsu tilting module.*

*Proof.* (a) For each  $i = 1, ..., n - 1$ , set  $X_i = \text{Im}(d_i)$ . Then we get the following short exact sequences:

$$
0 \to C_n \to C_{n-1} \to X_{n-1} \to 0,
$$
  

$$
0 \to X_i \to C_{i-1} \to X_{i-1} \to 0, \quad i = n-1, n-2, \dots, 2
$$

and

$$
0 \to X_1 \to C_0 \to Q \to 0.
$$

From these exact sequences, we infer that  $\text{Ext}^1_R(C, X_i) = 0$  for all  $i = n - 1, n - 2, ..., 1$ , and so the sequence

<span id="page-19-0"></span>
$$
(5.6) \qquad \qquad 0 \to \text{Hom}_R(C, C_n) \to \cdots \to \text{Hom}_R(C, C_0) \to \text{Hom}_R(C, Q) \to 0
$$

is exact. For each i, as  $C_i \in \text{Prod}(C)$ , it follows that  $C_i$  is a direct summand of  $C^{I_i}$  for some set  $I_i$ , and so, as S is coherent,  $\text{Hom}_R(C, C_i)$  is a flat right S-module. Thus,  $\text{fd}(\text{Hom}_R(C, Q)_S)$ n. This completes the proof of (a), because by [\[8,](#page-25-2) Theorem 3.2.19 and Remarks 3.2.25 and 3.2.27], we have  $\mathrm{id}({}_{S}C) = \mathrm{fd}(\mathrm{Hom}_{R}(C, Q)_{S}).$ 

(b) For any R-module  $M_R$ , let  $\nu_M$ :  $\text{Hom}_R(C, M) \otimes_S C \to M$  denote the evaluation map. Given a set I, it is straightforward to check that  $\nu_{\mathcal{C}^I}$  is the composition of the following natural isomorphisms

$$
\operatorname{Hom}_R(C, C^I) \otimes_S C \xrightarrow{\cong} \operatorname{Hom}_R(C, C)^I \otimes_S C \xrightarrow{\cong} (\operatorname{Hom}_R(C, C) \otimes_S C)^I \xrightarrow{\cong} (S \otimes_S C)^I \xrightarrow{\cong} C^I.
$$

Note that, as S is left coherent, the functor  $-\otimes_S C$  commutes with arbitrary direct products, and so, in the above display, the second natural map is an isomorphism. Let  $X_R \in \text{Prod}(C)$ .

Then there are a set I and an R-module  $Y_R$  such that  $X \oplus Y = C^I$ . The split short exact sequence

$$
0 \to X \xrightarrow{\lambda} C^I \xrightarrow{\pi} Y \to 0
$$

yields the following commutative diagram with split exact rows:

$$
0 \longrightarrow \operatorname{Hom}_R(C, X) \otimes_S C \longrightarrow \operatorname{Hom}_R(C, C^I) \otimes_S C \longrightarrow \operatorname{Hom}_R(C, Y) \otimes_S C \longrightarrow 0
$$

$$
\downarrow_{\nu_X} \qquad \qquad \downarrow_{\nu_Y} \qquad \qquad \downarrow_{\nu_Y}
$$

$$
0 \longrightarrow X \longrightarrow C^I \longrightarrow Y \longrightarrow 0.
$$

Since  $\nu_{C^I}$  is an isomorphism, it follows that  $\nu_X$  is injective and  $\nu_Y$  is surjective. By interchanging the roles of X and Y in the above argument, it follows that  $\nu_X$  is also surjective. Hence,  $\nu_X$  is an isomorphism.

From the exact sequence

$$
0 \longrightarrow C_n \xrightarrow{d_n} \cdots \longrightarrow C_0 \xrightarrow{d_0} Q \longrightarrow 0,
$$

we can induce the following commutative diagram:

$$
0 \longrightarrow \text{Hom}_{R}(C, C_{n}) \otimes_{S} C \longrightarrow \cdots \longrightarrow \text{Hom}_{R}(C, C_{0}) \otimes_{S} C \longrightarrow \text{Hom}_{R}(C, Q) \otimes_{S} C \longrightarrow 0
$$

$$
\downarrow \nu_{C_{n}} \qquad \qquad \downarrow \nu_{C_{0}} \qquad \qquad \downarrow \nu_{Q}
$$

$$
0 \longrightarrow C_{n} \longrightarrow \cdots \longrightarrow C_{0} \longrightarrow Q \longrightarrow 0.
$$

As the two maps  $\nu_{C_0}$  and  $\nu_{C_1}$  are isomorphisms, applying the Five Lemma to the right side of the above diagram implies that the map  $\nu_Q$  is also an isomorphism. Since in the above diagram the bottom row is exact and each vertical map is an isomorphism, it follows that the top row is also exact. Thus, as  $(5.6)$  is a flat resolution of the right S-module Hom $_R(C, Q)$ , we conclude that

$$
\text{Hom}_R(\text{Ext}^i_S(C, C), Q) \cong \text{Tor}_i^S(\text{Hom}_R(C, Q), C) = 0
$$

for all  $i \geq 1$ . Since Q is an injective cogenerator of R, it follows that  $\text{Ext}^i_S(C, C) = 0$  for all  $i \geqslant 1$ .

Let

$$
\theta_Q : \text{Hom}_R(C, Q) \otimes_S C \to \text{Hom}_R(\text{Hom}_S(C, C), Q)
$$

be the Hom-evaluation isomorphism. Also, let  $\mu: Q \to \text{Hom}_R(R, Q)$  be the natural isomorphism and  $\alpha = \text{Hom}_R(\chi, \text{id}_Q)$ . We have the following commutative diagram:



Thus the map  $\alpha$  is an isomorphism, because the two maps  $\theta_Q$  and  $\mu\nu_Q$  are so. As Q is an injective cogenerator of R, it follows that  $\chi$  is also an isomorphism.

(c) is trivial by (a) and (b).  $\square$ 

<span id="page-21-0"></span>Now, we are ready to present the main result of this section.

**Theorem 5.6.** Let A be a commutative Artinian ring with identity. Let  $\mathscr E$  be the minimal *injective cogenerator of* A, and set  $D(-) = \text{Hom}_A(-, \mathscr{E})$ . Let R be an Artin A-algebra and  $C_R$  *a finitely generated* R-module with  $S = \text{End}(C_R)$ . The following are equivalent:

- (a)  $\text{id}(C_R) < \infty$ ,  $\text{Ext}_{R}^{i \geq 1}(C^I, C) = 0$  *for every set I*, and there exists an injective cogen*erator*  $Q_R$  *and an exact sequence*  $0 \to C_r \to \cdots \to C_0 \to Q \to 0$  *with each*  $C_i$  *in*  $Prod(C)$ *.*
- (b)  $\text{id}(C_R) < \infty$ ,  $\text{Ext}_{R}^{i \geq 1}(C, C) = 0$ , and for any  $X \in L^{\perp} C \cap \text{mod-}R$ , there exists a short *exact sequence*  $0 \to X \to C_0 \to X' \to 0$  *with*  $C_0 \in \text{add}(C)$  *and*  $X' \in {}^{\perp}C$ *.*
- (c)  $\text{id}(C_R) < \infty$ ,  $\text{Ext}_{R}^{i \geq 1}(C, C) = 0$ , and there exists an exact sequence

$$
0 \to C_r \to \cdots \to C_0 \to D(R) \to 0
$$

*with each*  $C_i$  *in* add $(C)$ *.* 

(d)  $\text{id}(C_R) < \infty$ ,  $\text{id}(sC) < \infty$ , and  $C_R$  *is a Wakamatsu tilting* R-module.

*Proof.* Since  $R$  is an Artin algebra, by [\[18,](#page-25-17) page 543], we have: **Fact** ( $\star$ ): Prod(C) = Add(C) and consequently,  $\text{Ext}_{R}^{i\geq 1}(C, C) = 0$  if and only if

<span id="page-21-2"></span><span id="page-21-1"></span>
$$
\operatorname{Ext}^{i\geq 1}_R(C^I,C)=0
$$

for every set  $I$ .

(a)  $\Longrightarrow$  (b) Let  $X \in {}^{\perp}C \cap \text{mod-}R$ . By Lemma [5.4,](#page-18-0) there exists a short exact sequence

$$
(5.7) \t\t 0 \to X \to C_0 \to X' \to 0
$$

with  $C_0 \in \text{Prod}(C)$  and  $X' \in {}^{\perp}C$ . Hence, by  $(\star)$ , there is a set I and an R-module  $K_R$  such that  $C_0 \oplus K \cong C^{(I)}$ . Utilizing [\(5.7\)](#page-21-1), we obtain a short exact sequence

(5.8) 
$$
0 \to X \xrightarrow{f} C^{(I)} \to X'' \to 0,
$$

where  $X'' = X' \oplus K$ .

Since X is finitely generated, there exists a finite subset J of I such that  $\pi'(\text{Im } f) = 0$ , where  $\pi' : C^{(I)} \to C^{(I \setminus J)}$  is the natural projection. Let  $\pi : C^{(I)} \to C^{(J)}$  be the natural projection and set  $g = \pi f$ . So, we get the following short exact sequence

(5.9) 
$$
0 \to X \xrightarrow{g} C^{(J)} \to \text{Coker } g \to 0.
$$

Since  $C^{(J)} \in \text{add}(C)$ , it remains to show that Coker  $g \in {}^{\perp}C$ . Clearly  $X'' \in {}^{\perp}C$ , and so by applying the functor  $\text{Hom}_R(-, C)$  to [\(5.8\)](#page-21-2), we deduce that the map  $\text{Hom}_R(f, C)$  is surjective. Let  $\lambda: C^{(J)} \to C^{(I)}$  be the natural inclusion map. Then  $f = \lambda g$ , and so

<span id="page-22-0"></span>
$$
\operatorname{Hom}_R(f, C) = \operatorname{Hom}_R(g, C) \operatorname{Hom}_R(\lambda, C).
$$

As  $\text{Hom}_R(f, C)$  is surjective, it follows that  $\text{Hom}_R(g, C)$  is also surjective. Using this, from the Ext long exact sequence that obtained by applying the functor  $\text{Hom}_R(-, C)$  to [\(5.9\)](#page-22-0), we deduce that  $\text{Ext}^i_R(\text{Coker } g, C) = 0$  for all  $i \geq 1$ , and so Coker  $g \in {}^{\perp}C$ .

(b)  $\Rightarrow$  (c) It is easy to verify that the finitely generated right R-module  $Q = D(R)$  is an injective cogenerator of R. Set  $\mathcal{H} = {}^{\perp}C$ ,  $\mathcal{X} = {}^{\perp}C \cap \text{mod-}R$  and  $\mathcal{W} = \text{add}(C)$ . By adopting the proof of [\[17,](#page-25-11) Lemma 2.2(b)], we can show that  $\widehat{\mathscr{X}} = \text{mod-}R$ . Since (b) holds, the assumptions of [\[17,](#page-25-11) Theorem 3.2(i)] are satisfied for the pair  $\mathscr{W} \subseteq \mathscr{X}$ . Hence, there is a short exact sequence

<span id="page-22-1"></span>(5.10) 
$$
0 \to K_Q \to C_Q \to Q \to 0,
$$

with  $C_Q \in \mathcal{X}$  and  $K_Q \in \widehat{\mathcal{W}}$ . As  $K_Q \in \widehat{\mathcal{W}}$ , there is an exact sequence

$$
(5.11) \t\t 0 \to C_r \to \cdots \to C_1 \to K_Q \to 0
$$

with each  $C_j \in \mathscr{W}$ , and so  $K_Q \in \mathscr{H}^{\perp}$ . Since also Q belongs to  $\mathscr{H}^{\perp}$ , by [\(5.10\)](#page-22-1), it follows that  $C_Q \in \mathcal{H}^{\perp}$ . As (b) holds and  $C_Q \in \mathcal{X}$ , there is a short exact sequence

<span id="page-22-2"></span>(5.12) 
$$
0 \to C_Q \to C_0 \to X' \to 0,
$$

with  $C_0 \in \text{add}(C)$  and  $X' \in \mathcal{H}$ . Since  $X' \in \mathcal{H}$  and  $C_Q \in \mathcal{H}^{\perp}$ , we deduce that  $\text{Ext}^1_R(X', C_Q) =$ 0, and so [\(5.12\)](#page-22-2) splits. So,  $C_Q \in \text{add}(C)$ . Now, splicing the exact sequences [\(5.10\)](#page-22-1) and [\(5.11\)](#page-22-3) yields the claim.

 $(c) \rightarrow(a)$  Clearly,  $D(R)$  is an injective cogenerator of R and add $(C) \subseteq \text{Prod}(C)$ . On the other hand, ( $\star$ ) implies that  $\text{Ext}_{R}^{i\geqslant 1}(C^{I}, C) = 0$  for every set I. Thus, (a) holds.

(a)  $\Longrightarrow$  (d) Since R is an Artin algebra, it follows that S is also an Artin algebra. In particular, the ring  $R$  is right Noetherian and the ring  $S$  is left Noetherian. As  $C$  is a finitely generated A-module, it follows that  ${}_{S}C$  is finitely generated. Hence, the claim follows from Lemma  $5.5(c)$  $5.5(c)$ .

(d)  $\Longrightarrow$  (a) As we saw above, the ring R is right Noetherian and the ring S is left Noetherian. Thus, the claim is immediate by Lemma [5.2](#page-16-3) and  $(\star)$ .

<span id="page-23-0"></span>Next, we compar four definitions of cotilting modules.

**Remark 5.7.** Let  $C_R$  be a finitely generated R-module and  $S = \text{End}(C_R)$ . We already *recalled two definitions of cotilting modules at the beginning of this section. Below, in (i) and (ii), we recall two more definitions of cotilting modules. Then in (iii), (iv) and (v), we compare these four definitions of cotilting modules.*

- (i) *Assume that the ring* R *is right Noetherian and the ring* S *is left Noetherian. Miyashita* [\[21,](#page-26-0) page 142] *call*  $C_R$  *cotilting if it is a Wakamatsu tilting* R-module,  $id(C_R) < \infty$ and  $\text{id}(sC) < \infty$ . This definition of cotiling modules are used in [\[20,](#page-26-2) [19,](#page-25-18) [16\]](#page-25-19)*.*
- (ii) *Aihara et. al.* [\[1\]](#page-25-12) *call*  $C_R$  *cotilting if*  $id(C_R) < \infty$ ,  $Ext_R^{i \geq 1}(C, C) = 0$ , and for any  $X \in$ <sup>1</sup>  $C \cap \text{mod-}R$ , there exists a short exact sequence  $0 \to X \to C_0 \to X' \to 0$  with  $C_0 \in \text{add}(C) \text{ and } X' \in {}^{\perp}C.$
- (iii) *By* [\[22,](#page-26-1) Proposition 5.6]*, we have*  $\perp C \cap \text{mod-}R \subseteq \text{cogen}^*(C)$ *, and so Definition (i) implies Definition (ii).*
- (iv) *Assume that the ring* R *is right Noetherian, the ring* S *is left Noetherian and the S*-module  ${}_{S}C$  *is finitely generated. In view of Lemma [5.5\(](#page-19-1)c), if*  $C_R$  *is cotilting by Definition [5.1,](#page-16-1) then it is also cotilting by Definition (i).*
- (v) If  $R$  *is an Artin algebra, then by Theorem [5.6,](#page-21-0) for the*  $R$ *-module*  $C_R$  *being cotilting in each of these four definitions are equivalent.*
- Example 5.8. (i) *Let* R *be a connected finite-dimensional hereditary algebra over an algebraically closed field* k *of infinite representation type. Let* M *be a finitely generated R*-module, we define Tr  $(M) := \text{Coker}(\text{Hom}_R(f, R)),$  where  $P_1 \xrightarrow{f} P_0 \to M \to 0$  is a *minimal projective presentation of*  $M$ , and  $D(-) := \text{Hom}_k(-,k)$ . Then  $(\text{Tr } D)^n(R)$ *is a cotilting* R-module for all  $n \geq 0$ ; see [\[20,](#page-26-2) page 592].
	- (ii) Let  $\Gamma$  be a commutative Cohen-Macaulay local ring with a dualizing module  $\omega$ , and R *be a* Γ*-order (i.e.* R *is a* Γ*-algebra and* R *is a finitely generated maximal Cohen-Macaulay as a* Γ*-module). Then, by* [\[20,](#page-26-2) Proposition 2.12],  $\text{Hom}_{\Gamma}(R,\omega)$  *is a cotilting* R*-module, in the sense of Miyashita; see Remark [5.7\(](#page-23-0)i).*
	- (iii) Let R be an Artin algebra and  $C_R$  a cotiling R-module with  $\text{id}(C_R) = r$ . Assume *that*  $RQ$  *is the path algebra of the quiver*  $Q: 1 \rightarrow 2 \rightarrow 3$ *. It is easy to see that*  $RQ$  *is an Artin algebra. By* [\[23,](#page-26-3) Lemma 3.7]*,*

 $\mathbf{C} := (0 \to 0 \to C) \oplus (0 \to C \to C) \oplus (C \to C \to C)$ 

*is a cotilting*  $RQ$ *-module with*  $id(C_{RQ}) = r + 1$ *.* 

<span id="page-24-0"></span>In view of Lemma  $5.5(c)$  $5.5(c)$  and Theorems [3.7](#page-10-0) and [4.6,](#page-14-0) the following conclusions are immediate.

**Corollary 5.9.** Let  $C_R$  be a tensorly faithful cotilting module, and let  $S = \text{End}(C_R)$ . Assume *that the ring*  $R$  *is right coherent, the ring*  $S$  *is left coherent, and both modules*  $C_R$  *and*  $S$ C are finitely generated. Then, for an S-module  $N_S$ , the following are equivalent:

- (i)  $N \in \mathscr{A}_C(S)$ .
- (ii) Gpd $(N_S) < \infty$ .
- <span id="page-24-1"></span>(iii) Gfd $(N_S) < \infty$ .

**Corollary 5.10.** Let  $C_R$  be a tensorly faithful cotilting module, and let  $S = \text{End}(C_R)$ . *Assume that the ring* R *is right Noetherian, the ring* S *is left coherent, and both modules* C<sup>R</sup> and  $_{S}C$  are finitely generated. Then, for an R-module  $M_R$ , the following are equivalent:

- (i)  $M \in \mathscr{B}_C(R)$ .
- (ii) Gid $(M_R) < \infty$ .

We end the paper by the following remark on the assumption "tensorly faithfulness" in the above corollaries.

Remark 5.11. *Since over a Noetherian commutative ring, every dualizing module is tensorly faithful, there is not the assumption "tensorly faithfulness" in the commutative rings analogues of the above corollaries. This raises the following three natural questions:*

(i) *Under the assumptions of Corollaries* [5.9](#page-24-0) and [5.10,](#page-24-1) *is any cotilting* R-module  $C_R$ *necessarily tensorly faithful? This is not the case. To this end, let* k *be a field and*  $R = \mathbb{k}Q$  be the finite-dimensional  $\mathbb{k}$ -algebra that corresponds to the quiver

$$
Q: 1 \to 2 \to 3.
$$

*It is easy to see that the right* R-module  $C = P(1) \oplus P(3) \oplus S(3)$  *is both tilting and cotilting, and it is not projective. As*  $C_R$  *is a non-projective tilting* R-module, by [\[7,](#page-25-20) Theorem 2.11],  $C_R$  *couldn't be tensorly faithful.* 

- (ii) *Are there enough examples of tensorly faithful cotilting modules over non-commutative Noetherian rings? The answer is yes; in fact, there are plenty of examples of tensorly faithful cotilting modules over non-commutative Noetherian rings. For instance, if* R *is either a left Artinian local ring or the group ring of a finite group* G *over a commutative Artinian ring, then any cotilting module*  $C_R$  *is tensorly faithful; see* [\[7,](#page-25-20) Lemma 2.14 and the proof of Remark 2.15]*.*
- (iii) *Can the assumption "tensorly faithful" in Corollaries 5.8 and 5.9 be relaxed? We do not yet know the answer to this question.*
