NNSIGHT AND NDIF: DEMOCRATIZING ACCESS TO FOUNDATION MODEL INTERNALS

ABSTRACT

The enormous scale of state-of-the-art foundation models has limited their accessibility to scientists, because customized experiments on large models require costly hardware and complex engineering that is impractical for most researchers. To alleviate these problems, we introduce NNsight, an open-source Python package with a simple, flexible API that can express interventions on any PyTorch model by building computation graphs. We also introduce NDIF, a collaborative research platform providing researchers access to foundation-scale LLMs via the NNsight API. Code, documentation, and tutorials are available at <https://nnsight.net/>.

1 INTRODUCTION

Research on large-scale AI currently faces two practical challenges: *lack of transparent model access*, and *lack of adequate computational resources*. This paper introduces the NNsight library and the *National Deep Inference Fabric* (NDIF), which together aim to address both of these challenges.

Model access is limited by the secrecy of state-of-the-art commercial model parameters [\(OpenAI](#page-12-0) [et al., 2023;](#page-12-0) [Anthropic, 2024;](#page-9-0) [Gemini Team et al., 2024\)](#page-11-0). Commercial application programming interfaces (APIs) offer frontier models "as a service," allowing thousands of concurrent users to share model instances and thus reducing computational costs. However, these APIs lack transparency for scientists studying model internals, such as intermediate activations or gradients used during neural network inference and training.

Models with openly downloadable parameters provide partial transparency [\(Scao et al., 2022;](#page-14-0) [Black](#page-10-0) [et al., 2021;](#page-10-0) [Touvron et al., 2023;](#page-15-0) [Jiang et al., 2023\)](#page-12-1). However, the adoption of these models is often limited to smaller sizes because models with tens of billions of parameters exceed a single GPU's memory capacity. When scaled to hundreds of billions of parameters, these models are too large even for the combined GPU memory of a single node. For example, inference on a 530 billion parameter LLM requires about 1TB of GPU memory just to load the model parameters in 16-bit precision [\(Aminabadi et al., 2022\)](#page-9-1). Even if a scientist has access to such resources, evaluating large models blocks others from using the same resources concurrently, preventing their efficient utilization. The problem is worse still when we wish to perform deeper analyses of model internals, as such experiments are generally even more compute- and time-intensive. Thus, despite evidence that key capabilities emerge only in the largest models [\(Wei et al., 2022;](#page-16-0) [Patel & Pavlick, 2022;](#page-13-0) [Rae et al.,](#page-13-1) [2021;](#page-13-1) [Brown et al., 2020\)](#page-10-1), studying them can often seem unattainable.

As a result, most researchers are limited to studying model internals using smaller models [\(Hernandez](#page-11-1) [et al., 2024;](#page-11-1) [Marks et al., 2024b;](#page-12-2) [Brinkmann et al., 2024;](#page-10-2) [Hanna et al., 2023;](#page-11-2) [Wang et al., 2022\)](#page-16-1). Research on large models is also typically limited to "black-box" investigations using commercial APIs. In other words, research into the internal mechanisms of the largest (and most capable) models has been hindered by multiple infrastructural barriers.

Surveys of AI research needs have documented this unsatisfactory situation [\(Shevlane, 2022;](#page-15-1) [Bucknall](#page-10-3) [& Trager, 2023;](#page-10-3) [Casper et al., 2024\)](#page-10-4): Specifically, [Bucknall & Trager](#page-10-3) [\(2023\)](#page-10-3) highlights the need for *structured model access APIs* that offer greater transparency than existing commercial AI APIs.

Users can run on their local infrastructure or remotely on NDIF (Section [3\)](#page-2-0) by setting the remote flag; this can be helpful for running interventions on very large models. This code example sets neuron activations to a high value, which causes the model to output the opposite word to the subject in the prompt.

This paper describes two technologies, NNsight and NDIF, co-designed to address these barriers to large-scale AI research. NNsight is a structured model access API that standardizes a flexible programming idiom for expressing fully transparent model access without requiring user custody of model parameters. NDIF supports this idiom by providing a remote-execution service, which facilitates behind-the-scenes sharing of large model instances. NNsight and NDIF are both opensource projects, distributed under a permissive MIT license. Together, these resources provide a turn-key serverless infrastructure for studying (large) open models, and a reusable component-based architecture suitable for commercial deployment.

NNsight is an extension to PyTorch [\(Paszke et al., 2019\)](#page-13-2) that builds an intervention graph for remote hooks, leveraging the same modular graph idiom that deep learning frameworks have used to support automatic differentiation [\(Bottou & Le Cun, 1988;](#page-10-5) [Bottou & Gallinari, 1990;](#page-10-6) [Abadi et al., 2016;](#page-9-2) [Al-Rfou et al., 2016;](#page-9-3) [Bradbury et al., 2018\)](#page-10-7), and extending it to support remote execution instead.

NDIF is an online service supporting remote NNsight requests. Like commercial inference services, it allows many users to share instances of large-scale models, which would otherwise be costly for individual users to host. But unlike commercial inference services, NDIF provides the transparency necessary for comprehensive AI research.

2 TRANSPARENT AND FLEXIBLE MODEL INTERACTIONS

NNsight minimizes the learning curve for researchers by providing transparent access to PyTorchbased models. Our approach combines a novel tracing context with programming idioms that will be familiar to PyTorch users.

NNsight's core API uses a tracing context that encapsulates model interactions within a defined scope, building and executing its intervention graph upon exiting the scope. Inside this context, users can employ standard PyTorch operations to manipulate model internals, probe activations, and implement custom interventions.

Consider Code Example 1^1 1^1 , which loads the Llama-3-8B language model [\(AI@Meta, 2024\)](#page-9-4) from HuggingFace [\(Wolf et al., 2020\)](#page-16-2), then uses NNsight to activate three neurons that invert its output:

Code Example 1: Using NNsight to activate three neurons that cause the model to invert the meaning of its output, producing "lie" rather than "truth."

Inside the tracing context, a forward pass is run, the activations are altered, and the output of the model is saved. The tracing context window—with model.trace(...)—delineates the scope of interventions, while operations within the window use PyTorch syntax and idioms to investigate and manipulate model internals. NNsight uses the scope to lazily build the intervention graph, and then executes the optimized graph upon exiting the context window.

Because model interactions are specified through user-written code, NNsight enables a wide range of interventions beyond simple probing and manipulation. That includes supporting custom attention mechanisms, gradient flow modifications, and dynamic computational graph alterations, all using familiar PyTorch constructs.

Access to intermediate inputs, outputs, and gradients also enables other common (interpretability) methods such as pruning ablations [\(Li et al., 2024\)](#page-12-3), causal mediation analysis [\(Vig et al., 2020;](#page-16-3) [Meng](#page-12-4) [et al., 2022;](#page-12-4) [Geva et al., 2023\)](#page-11-3), fine-tuning-based methods [\(Lester et al., 2021;](#page-12-5) [Wu et al., 2023\)](#page-16-4), gradient-based attribution [\(Sundararajan et al., 2017;](#page-15-2) [Ancona et al., 2019;](#page-9-5) [Bastings et al., 2022;](#page-9-6) Kramár et al., 2024), sparse dictionary learning [\(Templeton et al., 2024;](#page-15-3) [Marks et al., 2024a;](#page-12-7) [Gao](#page-10-8) [et al., 2024\)](#page-10-8), and others.

NNsight's design principles embody a "minimal learning, maximal flexibility" philosophy. This lowers the barrier for entry to advanced deep learning research by providing a transparent interface to the underlying model's architecture.

3 REMOTE EXECUTION ON NDIF

On its own, NNsight empowers researchers to explore the internals of models running on their own hardware. Combining with the National Deep Inference Fabric (NDIF), however, allows them to work with foundation models hosted on remote GPUs by toggling a single keyword argument. Code Example [2](#page-2-1) shows the forward pass from Code Example [1](#page-1-0) being run remotely.

Code Example 2: Passing remote=True into a tracing context runs the model on NDIF infrastructure. This example assumes all objects are the same as in Code Example [1.](#page-1-0)

The intervention graph generated by NNsight is then transmitted to NDIF for execution, where the interventions it defines are hooked into the model and run. Results that are explicitly requested to be copied to the client side via .save() are then seamlessly sent back to the user. There is no overhead on the user's part to set up the large model or allocate computational resources.

The remote API works exactly the same way as the local API. This is a key design benefit, because it allows users to efficiently develop and debug their experiments locally on smaller models before executing them remotely on large models. The user experience is designed to be the same as if the user had a large model running on their own machine.

NDIF hosts a predefined set of models with the weights preloaded into the remote cache. It can run inference for multiple users in batches at any given time, and an autoscaling feature dynamically

The model is executed with the input from the request, interleaving the intervention graph alongside the model's normal computation graph. The saved results are sent back to the user.

adjusts the allocation of GPU memory and computational power for each model deployment, while also managing the number of operational replicas to isolate different requests.

4 DESIGN

One of the core goals of NNsight is to create a common, highly-legible notation for expressing changes to models. Previously, researchers accessing model internals have "forked" code to add customization or have used *callback hooks*, but these ad-hoc conventions create diverse codebases which may be hard to read and understand. NNsight addresses this problem by introducing a workflow based on Python context managers that organizes model modifications in a way that is concise and easy to understand.

Within a context, NNsight exposes the inputs, outputs, and gradients of PyTorch Modules. Users can leverage this to modify computation anywhere in a PyTorch Module's forward or backward pass. Upon exiting the context manager, the interventions generate a computation graph which is hooked into a PyTorch Module. Users can extract PyTorch objects like activations, model outputs, or gradients from a given forward or backward pass using a save method. If the code is executed remotely, save will download and store the value in a local variable that the user can access.

4.1 INTERVENTIONS ARE PYTORCH CODE

Interventions are defined using basic PyTorch operations, which are written with regular PyTorch code (Figure [1,](#page-1-2) left). This is accomplished by overloading Python and PyTorch code within the tracing context. This setup allows users already familiar with PyTorch and NumPy syntax to create sophisticated interventions quickly, with as little overhead as possible.

4.2 GRAPH REPRESENTATION

Once interventions are defined, they can be represented as an intervention graph (Figure [1,](#page-1-2) middle). This allows for a number of flexible downstream use cases. For instance, when executing remotely, the graph is sent to a remote server through an intermediate custom json format (see Figure [2,](#page-3-0) Serialisation). Users can share their interventions with other users by exporting the graph to json or to a visualization, creating an ecosystem of shareable model interventions.

An intervention graph setup also allows for graph-based optimizations. By manipulating the graph, intermediate operations within user code can be trimmed, combined, and substituted to reduce computational costs. This is especially helpful for large models, where memory and performance savings can be significant.

4.3 FLEXIBILITY

NNsight directly hooks into the PyTorch nn.Module object, allowing it to work with any torch model, Module, or architecture. To support common use cases, we include infrastructure for accessing custom models distributed by popular platforms like HuggingFace and Meta. However, the core package is architecture-agnostic: Interventions on custom models are a core use-case. For example, [Sharma et al.](#page-15-4) [\(2024\)](#page-15-4) used NNsight to investigate the mechanisms of factual recall in the Mamba state space model Gu $\&$ Dao [\(2023\)](#page-11-4). This flexibility, along with the shareable graph idiom, enforces a common language across codebases: Regardless of input modality or model architecture, intervention graphs are saved using the same json specification.

4.4 TRANSPARENCY

The computation graph is fully accessible to the user during runtime. This allows users to inspect, debug, and understand the sequence and nature of operations being applied to the model. Each node in the graph contains information about the operation it represents.

5 IMPLEMENTATION

NNsight is built on a few core components that define a compositional language for modifying models. These components include the tracing context for building computation graphs, an envoy system for wrapping PyTorch modules, and an intervention graph for representing and executing operations. This section details the implementation of these elements and how they interact to provide NNsight's functionality.

5.1 THE TRACING CONTEXT

The core workflow in NNsight uses tracing contexts to build computation graphs, defined by an NNsight class object or one of its subclasses. When an NNsight object wraps a PyTorch Module, the tracing context exposes intermediate inputs and outputs. Within this context, user-specified operations, written in Python and PyTorch become nodes in an intervention graph. The graph's execution is deferred until the context exits.

This deferred execution scheme allows for debugging user specified operations and compute-efficient tracking of model operations without immediate execution. Code Example [3](#page-4-0) shows basic usage of the tracing context to run a forward pass on a model and save the output.

Code Example 3: Basic usage of the trace context manager and the NNsight class. The initial model object can be any Torch Module. The output method accesses the activations in a forward pass with the "Hello World" prompt. trace can take input of any type, not just strings.

Upon exiting the context window, the intervention graph is interleaved with the PyTorch Module computation graph. To enable efficient debugging, NNsight also includes a scanning and validation mode. These use PyTorch's FakeTensor system. FakeTensors are lightweight tensor objects that mimic the behavior of real tensors without allocating memory for actual data. Before execution, scanning passes FakeTensors through the model in order to find information about the future inputs and outputs of modules. Then during validation, interventions added in the tracing context are executed using the FakeTensors created durring scanning. This verifies the intervention's executability, raising errors if bugs are detected, all provinf the same information as scanning, but with

When the scan flag is enabled, NNsight scans the modules in the PyTorch model instance to gather related data shapes, creating FakeTensors that are included in the respective intervention graph nodes and returned to the user.

downstream intervention proxies. This enables rapid iteration and debugging without incurring the full computational cost of model execution. Unless the save method is used, intermediate values are discarded to conserve memory by default.

5.2 THE ENVOY SYSTEM

When a PyTorch model is initialized with the NNsight class, each module in the model's hierarchy is recursively wrapped with an Envoy object. Envoy objects allow for access to model inputs and outputs, for deferred execution, and for additional interventions as illustrated in Figure [3.](#page-5-0)

Modules wrapped with an Envoy class define .input and .output properties. Accessing either property creates a Proxy object, which serves as a placeholder for the tensor data that will flow through the Module during model execution. Proxy objects allow users to define operations and interventions on the model's computation graph without immediately executing them. Proxy objects serve as entry points into the intervention graph; they enable tracking of dependencies between different parts of the computation, as each operation on a proxy creates a new node in the graph. Input and output proxies propagate into all further nodes on the graph.

The Envoy class also implements custom attribute handling and iteration methods to seamlessly integrate with the underlying PyTorch Module structure. It can wrap any PyTorch Module, regardless of its internal complexity. This includes custom modules, nested structures, and even dynamic architectures. This system enables NNsight to support interventions on *any* model architecture built with PyTorch.

5.3 INTERVENTION GRAPH

The intervention graph is implemented through a Graph class in NNsight. The Graph class maintains a dictionary of nodes (self.nodes), each representing an operation or intervention.

The graph supports a validation mode (self.validate), which can execute nodes with proxy values as they are added. This allows for early detection of issues like shape mismatches without running the full model, and for validating each operation in the graph. The graph automatically generates unique names for each node so that each operation can be uniquely identified and referenced.

Upon execution, dead nodes are removed for optimization and the computation graph is compiled. The intervention graph is interleaved with the underlying Module, so that execution occurs alongside the existing computation graph at the right points. Upon exiting the tracing context, the graph is executed with real values rather than FakeTensors.

5.3.1 INVOCATION

Multiple tracing contexts can be used with an invoke method, allowing for complex, multi-stage interventions. Code Example [4](#page-6-0) uses invoke to implement activation patching - an intervention technique where neural network activations are replaced across a pair of inputs - which is a fundamental method for model interventions. Using NNsight 's invoke contexts, we can access and then replace a hidden state between a pair of prompts.

Code Example 4: Using invoke allows for precise control over the computation of individual prompts within a tracing context. In this example, token indices $5 \& 6$ correspond to last token of subject entities in the edit and the base prompt (i.e., *Colosseum* and *Louvre*). The edit prompt's subject representation is accessed at an early layer (layer 5) and inserted in place of the subject representation of the base prompt at the corresponding layer. This intervention changes the LM prediction for the base prompt from *Paris* to respond with *Rome* instead.

Prompts passed to different invokes are combined into a single batch for forward execution, so that multiple invokes only require a single forward pass. This design allows researchers to define interventions that can access and modify data across different prompts within the same tracing context. The intervention graph is still populated upon exiting the tracing context, with a single intervention graph built across all invoke contexts.

5.4 THE SESSION CONTEXT

The session context in NNsight extends functionality for scenarios involving multiple traces. Unlike standard trace contexts where values are destroyed after execution, session tracks and preserves these values across multiple traces. The values can then be used for interventions that require information from previous executions of the intervention graph.

The session context enables an environment for multiple forward passes on remote infrastructure. Sessions are particularly valuable when working with very large models, as it allows researchers to perform complex analyses and interventions without the need to transfer large amounts of intermediate data between passes.

Because the session context allows multiple forward and backward passes, it can be used it for things like remote training and fine-tuning, including parameter-efficient fine-tuning [\(Lester et al.,](#page-12-5) [2021\)](#page-12-5), Low-Rank Adapters [\(Hu et al., 2021\)](#page-11-5), and probing methods [\(Belinkov, 2022\)](#page-10-9).

6 PERFORMANCE

In this section we compare the performance of NNsight with other libraries that enable interventions on model internals. To ensure a fair comparison, we focus on libraries that use PyTorch as the underlying deep learning framework. We find that NNsight achieves competitive time efficiency across a range of tasks.

Our performance comparison includes runtime measurements for activation patching and attribution patching across models with varying parameter counts and architectures. Specifically, we consider GPT-2 [\(Radford et al., 2019\)](#page-13-3), Gemma-7B [\(Team et al., 2024\)](#page-15-5), and Llama3-70B [\(AI@Meta, 2024\)](#page-9-4), and use a single batch with 32 examples. For activation patching, we focus on a single MLP layer, whereas for attribution patching, we consider all MLP layers. The tests were conducted on a server with eight NVIDIA A100-SXM4-80GB with CUDA version 12.4 and an Intel(R) Xeon(R) Platinum 8468 48-Core CPU.

Table [1](#page-7-0) presents the runtime results. Overall, we find that all libraries achieve comparable performance across both activation patching and attribution patching. This suggests that the choice of library should be based on factors such as usability, feature set, and compatibility with existing workflows—rather than purely based on performance considerations.

We will update the results once this issue is fixed.

7 RELATED WORK

Research model hosting frameworks. The most similar previous works are Garcon [\(Elhage et al.,](#page-10-10) [2021\)](#page-10-10) and Petals [\(Borzunov et al., 2022\)](#page-10-11). Garcon is a proprietary internal research system at Anthropic that supports remote inspection and customization of large models hosted on a remote cluster. Unlike the computation-graph approach of NNsight, Garcon operates by allowing researchers to hook models via arbitrary-code execution. As a result, co-tenancy is unsafe, so unlike the NDIF server which shares model instances between many users, Garcon requires each user to allocate their own model instance, which is computationally expensive. The Petals system has similar goals, but instead of distributing experiment code, it distributes foundation-model computation across user-contributed nodes in a BitTorrent-style swarm. Petals achieves co-tenancy by leaving researcher-defined computations on the user's own system. Unlike Petals, NNsight can avoid costly model-internal data transfers by executing computation graphs on NDIF servers.

Several other solutions for sharing hosted model resources have been developed, including VLLM [\(Kwon et al., 2023\)](#page-12-8), Huggingface TGI [\(Dehaene et al., 2024\)](#page-10-12) and Nvidia TensorRT-LLM [\(Nvidia,](#page-12-9) [2024\)](#page-12-9). These are systems for LLM inference acceleration that support large-scale multiuser model sharing. However, unlike NDIF, these systems only provide black-box API access to models, and do not permit model inspection or modification, which limits their utility for interpretability research.

Frameworks for model internals. Numerous efforts have been made to create robust tools for exploring and manipulating model internals. TransformerLens [\(Nanda & Bloom, 2022\)](#page-12-10) is designed to facilitate the exploration of GPT-style decoder-only language models. It allows users to apply custom functions to outputs of specific model modules. Unlike NNsight which operates on arbitrary PyTorch networks, TransformerLens is limited to autoregressive transformers. Pyvene [\(Wu et al.,](#page-16-5) [2024\)](#page-16-5) supports configurable intervention schemes on PyTorch modules, decorating a PyTorch module with hooks that allow activations to be collected and overwritten. Pyvene operates at a higher level of abstraction, and can be configured as a layer over NNsight. Baukit [\(Bau, 2022\)](#page-9-7), a spiritual predecessor to NNsight, provides a range of utilities which simplify tracing and editing activations. But unlike NNsight, it lacks an intermediate representation for user actions on models. Penzai [\(Johnson, 2024\)](#page-12-11) is an open-source functional library which provides a modular system that allows for introspection, visualization, and manipulation of neural network computation graphs; Penzai works within the JAX framework, in contrast to NNsight which works with PyTorch models.

These frameworks are all designed to support *local* experiments, executed on compute resources controlled by the researcher conducting them. NNsight, however, is designed to support both local and remote experiments.

8 ECOSYSTEM

The NNsight project encourages community participation. Interested researchers can join the NDIF Discord for updates, feedback, and collaboration opportunities. We welcome open-source participation via the project github page. For more information, visit [our website,](https://nnsight.net) which contains detailed documentation, tutorials, and links to NNsight's GitHub repository and Discord server.

More information on NDIF can be found at <https://ndif.us>. Requests for early access to NDIF resources can be made through the Discord community. They are available to educational and research users with a U.S. affiliation after a short application. Other researchers with private GPU clusters may also deploy their own instance of NDIF, as the implementation is open-sourced with a permissive MIT license.

9 LIMITATIONS

NNsight and NDIF are limited in several areas:

Intervention graph optimization. The intervention graph can be optimized by removing unnecessary operations, fusing operations, and applying other optimizations that are difficult to do in the dynamic Python environment. Libraries like TorchScript [\(DeVito, 2022\)](#page-10-13) and TorchFX incorporate many such optimizations out-of-the-box.

High-level abstractions. NNsight operates at a low level, using PyTorch operations within tracing contexts. This is a conscious design choice, because the tensor manipulation design choices in PyTorch are a familiar idiom going all the way back to APL [\(Iverson, 1962\)](#page-12-12), minimizing user overhead to get started. However, packages like pyvene [\(Wu et al., 2024\)](#page-16-5) or TransformerLens [\(Nanda & Bloom, 2022\)](#page-12-10) provide abstractions which build functionality on top of PyTorch, and provide a common set of abstractions regardless of the underlying model's implementation details.

Closed-source model support. NNsight cannot run closed-source, proprietary models like GPT-4 or Claude. However, the API is designed to be technically feasible for companies to support without giving up custody of their proprietary model parameters.

10 CONCLUSION

We introduce NNsight, an open-source Python library that provides access to the internals of foundation models, including those too large to analyze on most individual or academic hardware. By leveraging NDIF infrastructure, NNsight enables researchers to perform complex interventions and explore neural networks at a scale previously limited by computational and financial constraints. NNsight supports a range of research activities focussed on model interpretability, including probing, intervention, and optimization; it is designed to be intuitive, architecture-agnostic, and capable of both local and remote execution.

NNsight and NDIF provide tooling to run interpretability analyses in a standardized way and the ability to do so on (very) large models hosted remotely, respectively. Our hope is that this helps to democratize large model access and ultimately facilitate rapid progress on research into large generative models and their inner-workings.
