Accelerated Primal-Dual Proximal Gradient Splitting Methods for Convex-Concave Saddle-Point Problems*

Abstract

In this paper, based a novel primal-dual dynamical model with adaptive scaling parameters and Bregman divergences, we propose new accelerated primal-dual proximal gradient splitting methods for solving bilinear saddle-point problems with optimal nonergodic convergence rates. For the first, using the spectral analysis, we show that a naive extension of Nesterov acceleration to a quadratic game is unstable. Motivated by this, we present an accelerated primal-dual gradient (APDG) flow which combines acceleration with careful velocity correction. To work with non-Euclidean distances, we also equip our APDG model with general Bregman divergences and prove the exponential decay of a Lyapunov function. Then, new primal-dual splitting methods are developed based on proper semi-implicit Euler schemes of the continuous model, and the theoretical convergence rates are nonergodic and optimal with respect to the matrix norms, Lipschitz constants and convergence analysis cover automatically the convex and (partially) strongly convex objectives. Moreover, the use of Bregman divergences not only unifies the standard Euclidean distances and general cases in an elegant way, but also makes our methods more flexible and adaptive to problem-dependent metrics.

1 Introduction

Consider the convex-concave saddle-point problem

$$\min_{x \in \mathbb{R}^n} \max_{y \in \mathbb{R}^m} \mathcal{L}(x, y) = f(x) + \langle Ax, y \rangle - g(y), \tag{1}$$

where $f : \mathbb{R}^n \to \mathbb{R} \cup \{+\infty\}$ and $g : \mathbb{R}^m \to \mathbb{R}\{\infty\}$ are properly closed convex functions and $A \in \mathbb{R}^{m \times n}$ is a linear operator. This model problem arises from many practical applications such as image processing [13], numerical partial differential equations [8], machine learning [40], and optimal transport [7]. We are mainly interested in first-order methods that involve the (proximal) gradient information of the objective f/g; see the *proximal algorithm class* [81, Definition 2.1] for instance.

The saddle-point problem (1) is closely related to many convex optimization problems. Obviously, it contains the unconstrained composite convex minimization

$$\min_{x \in \mathbb{R}^n} P(x) := f(x) + g^*(Ax), \tag{2}$$

for which the dual problem reads equivalently as

$$\min_{y \in \mathbb{R}^m} D(y) := g(y) + f^*(-A^\top y).$$
(3)

When g^* (or f^*) is the indicator function of a simple convex set \mathcal{K} , the primal problem (2) (or the dual problem (3)) also corresponds to the standard affinely constrained problem

$$\min_{x \in \mathbb{R}^n} f(x) \quad \text{s.t. } Ax \in \mathcal{K}.$$
(4)

Besides, one can replace Ax (or $A^{\top}y$) with an auxiliary variable, and the unconstrained minimization (2) (or (3)) becomes a special case of the two-block separable problem

$$\min_{x_1 \in \mathbb{R}^n, \, x_2 \in \mathbb{R}^m} f_1(x_1) + f_2(x_2) \quad \text{s.t. } A_1 x_1 + A_2 x_2 = b,$$
(5)

which can be recast into the saddle-point problem (1) by using the Lagrange function.

1.1 Literature review

As mentioned before, the minimax formulation (1) is usually equivalent to the unconstrained composite problem (2). In this regard, classical first-order methods include proximal gradient [65], forward-backward splitting [42], Douglas–Rachford splitting (DRS) [23], and accelerated gradient methods [6, 16, 45, 51, 61]. As for linearly constrained problems (4) and (5), prevailing algorithms are quadratic penalty methods [41, 71], Bregman iteration [11], augmented Lagrangian methods (ALM) [5, 46, 47, 49] and alternating direction methods of multipliers (ADMM) [25, 52, 63, 68, 79, 82].

1.1.1 Primal-dual splitting

In the following, we mainly review existing primal-dual splitting methods that applied directly to the saddlepoint problem (1). Zhu and Chan [84] proposed the primal-dual hybrid gradient (PDHG) method:

$$\begin{cases} x_{k+1} = \underset{x \in \mathbb{R}^{n}}{\operatorname{argmin}} \mathcal{L}(x, y_{k}) + \frac{1}{2\tau} \|x - x_{k}\|^{2}, \quad \tau > 0, \\ y_{k+1} = \underset{y \in \mathbb{R}^{m}}{\operatorname{argmax}} \mathcal{L}(x_{k+1}, y) - \frac{1}{2\sigma} \|y - y_{k}\|^{2}, \quad \sigma > 0, \end{cases}$$
(6)

which actually corresponds to the well-known Arrow–Hurwicz method [1]. However, even for extremely small steplengths, PDHG is not necessarily convergent unless one of the objectives is strongly convex; see the counterexamples in [27]. Later on, Chambolle and Pock [12] presented a generalized version (CP for short)

$$\begin{cases} x_{k+1} = \underset{x \in \mathbb{R}^n}{\operatorname{argmin}} \mathcal{L}(x, y_k) + \frac{1}{2\tau} \|x - x_k\|^2, \\ \bar{x}_{k+1} = x_{k+1} + \theta(x_{k+1} - x_k), \\ y_{k+1} = \underset{y \in \mathbb{R}^m}{\operatorname{argmax}} \mathcal{L}(\bar{x}_{k+1}, y) - \frac{1}{2\sigma} \|y - y_k\|^2, \end{cases}$$
(7)

where $\theta \in (0, 1]$ denotes the relaxation parameter. When $\theta = 0$, CP amounts to PDHG, and it is also closely related to many existing methods such as the extra-gradient method [38], DRS [62], and the preconditioned ADMM [67, 69]. In [28], He and Yuan discovered that CP can be reformulated as a tight proximal point algorithm (PPA), and the relaxation parameter $\theta \in (0, 1]$ can be further extended to $\theta \in [-1, 1)$, with proper correction steps (see [28, Algorithms 1 and 2]). However, these extra steps involve additional matrix-vector multiplications. As discussed in [76, Remark 2.3], it is possible to extend the PPA framework of CP to the non-Euclidean setting with general Bregman distances. This is in line with the spirit of the mirror-descent method by Nemirovski [55]; see [14, 19, 20, 73] and the references therein. For more extensions of CP, with preconditioning, extrapolation/correction and inexact variants, we refer to [26, 36, 43, 85].

According to [12, 14], CP converges with an *ergodic* sublinear rate O(1/k) for generic convex-concave problems, and fast (ergodic) sublinear/linear rates can also be achieved for (partially) strongly convex case

Here, μ_f , $\mu_g \ge 0$ are respectively the strong convexity constants of f and g, and $\kappa_P := ||A||^2 / (\mu_f \mu_g)$ stands for the condition number of the primal problem (2).

 $\mu_f + \mu_g > 0$; see Table 1 for a summary of related works on convergence rates. However, from the literature, it is rare to see *nonergodic* results, which, as mentioned by Chambolle and Pock in [14, Section 8], converge very often much faster than the sense of ergodic. We mention that linear convergence can still be obtained even for non-strongly convex problems [24, 39, 44] and nonergodic convergence with respect to fixed-point type residual can be found in [26, 37].

Recently, based on the PPA structure of CP and the *testing* approach [76], Valkonen [75] proposed the inertial corrected primal-dual proximal splitting (IC-PDPS), which achieves the optimal sublinear/linear nonergodic rates (cf.Table 1). In [48], we provided a continuous-time perspective on IC-PDPS, which can be viewed as an implicit-explicit time discretization of a novel primal-dual dynamics.

When the primal (dual) objective f(g) in (1) possesses the composite structure $f = f_1 + f_2$ ($g = g_1 + g_2$), where the smooth part $f_1(g_1)$ has Lipschitz continuous gradient, some existing primal-dual splitting methods [17, 19, 34, 39, 78] possess optimal mixed-type complexity bounds; see Table 2. Compared with these works, our methods cover both convex ($\mu_f = \mu_g = 0$) case and partially convex case ($\mu_f + \mu_g > 0$). Especially, it is rare to see the mixed-type result for $\mu_f > 0$ and $\mu_g = 0$.

1.1.2 Smoothing

Except primal-dual splitting methods based on the PPA framework mentioned above, let us also review other works with smoothing technique. For nonsmooth composite convex optimization problems with the minimax structure (like (1)), Nesterov [60] combined his accelerated gradient [57] with smoothing and improved the iteration complexity of subgradient-type methods from $O(1/\epsilon^2)$ [56] to $O(1/\epsilon)$. Afterwards, there are primal-dual methods based on the excessive gap technique (double smoothing approach) [22, 59] and homotopy strategy

(adaptively changing smoothing parameters) [70].

In [73], Tran-Dinh *et al.* proposed two accelerated smoothed gap reduction (ASGARD) algorithms and established the optimal sublinear rate O(1/k) for the primal objective residual. The unified variant of ASGARD in [72] and two primal-dual algorithms in [74] achieve optimal sublinear/linear rates for the primal-dual gap, the primal objective residual, and the dual objective residual. However, it should be noticed that (i) both [73, Algorithm 2] and [74, Algorithm 2] involve *three* proximal operations per iteration; (ii) the convergence results in [72, 74] are *semi-ergodic*. In other words, the primal sequence is in nonergodic sense while the dual sequence is averaging; (iii) the extra dual steps in [74, Algorithms 1 and 2] require additional matrix-vector multiplications.

1.2 Main contribution

In this work, combining acceleration with velocity correction, we propose a novel accelerated primal-dual gradient (APDG) flow (32). Based on proper time discretizations, we obtain new primal-dual splitting methods for solving the saddle-point problem (1). More specifically, we highlight our main contributions as follows.

- By using the spectral analysis, we prove that a naive extension of acceleration model to a quadratic game does not work. With careful velocity correction, we propose a novel accelerated primal-dual dynamical system (28) and prove the improved spectral radials of the Gauss-Seidel splitting ; see Theorem 3.1.
- We then equip the template model (28) with adaptively scaling parameters and general Bregman divergence (cf.(32) and (38)). This allows us to handle both convex and (partially) strongly convex cases in a unified way, and make the dynamical model work for non-Euclidean distances. Also, we establish the exponential decay rate of a tailored Lyapunov function, which provides important guidance for the discrete analysis; see Theorems 4.1 and 4.2.
- After that, new primal-dual splitting methods are developed based on proper semi-implicit Euler schemes of the continuous model (38). Our methods (Algorithms 1, 2 and 3) belong to the first-order (proximal) algorithm classes (see [81, Section 2]), which involve the matrix-vector multiplications of A and A^T and the proximal calculations of f and g only once in each iteration. In addition, the theoretical rates are nonergodic and optimal with respect to the matrix norm ||A||, the Lipschitz constant L_f and the convexity parameter μ_f(μ_g), as mentioned in Tables 1 and 2. For instance, to achieve the accuracy L(x_k, ŷ) − L(x̂, y_k) ≤ ε, the iteration complexity bound of Algorithm 1 is (cf.Theorem 5.2)

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\epsilon}, \frac{\|A\|}{\sqrt{\mu_f \epsilon}}, \frac{\|A\|}{\sqrt{\mu_g \epsilon}}, \sqrt{\kappa_P} \left|\ln \epsilon\right|\right\}\right),$$

and for the composite objective $f = f_1 + f_2$, we have (cf. Theorem 6.2)

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\epsilon} + \frac{\sqrt{L_f}}{\epsilon}, \frac{\|A\|}{\sqrt{\mu_f \epsilon}} + \sqrt{\frac{L_f}{\mu_f}} \left|\ln\epsilon\right|, \frac{\|A\|}{\sqrt{\mu_g \epsilon}} + \frac{\sqrt{L_f}}{\epsilon}, \sqrt{\kappa_P} \left|\ln\epsilon\right|\right\}\right)$$

Thanks to the primal and dual scaling parameters, both the algorithm designing and convergence analysis
cover automatically the convex and (partially) strongly convex objectives. The use of Bregman divergences not only unifies the analysis of standard Euclidean distances and general cases in an elegant way,
but also makes our methods more flexible and adaptive to problem-dependent metrics that might better
than the Euclidean one (like the entropy).

1.3 Organization

The rest of this paper is organized as follows. In Section 2, we prepare essential preliminaries including basic notations, the definition of Bregman distance, two auxiliary functions and some useful Lyapunov functions. Next, in Section 3, we study a simple quadratic game via spectral analysis and find some dynamical template

system with provable stability and acceleration. This leads to two novel primal-dual flow models in Section 4 with adaptive scaling parameters and Bregman divergences. After that, in Sections 5 and 6, we propose our two main primal-dual splitting algorithms from numerical discretizations of the continuous model and prove the nonergodic mixed-type convergence rate via a tailored discrete Lyapunov function. Finally, some concluding remarks are given in Section 8.

2 Preliminaries

2.1 Notations

For a proper, closed and convex function h, denote by dom h and $\partial h(x)$ its domain and its subdifferential at x, respectively. We say $h : \operatorname{dom} h \to \mathbb{R}$ is C^1 -smooth if it is continuous differentiable, and it is called C_L^1 -smooth when its gradient ∇h is L-Lipschitz continuous. In particular, we use dom $\mathcal{L} := \operatorname{dom} f \times \operatorname{dom} g$ as the domain of the minimax function in (1).

Throughout, the bracket $\langle \cdot, \cdot \rangle$ stands for the standard Euclidean inner product. Given any $R : \mathbb{R}^{n \times n}$, if $\langle Rx, x \rangle \geq 0$ for all $x \in \mathbb{R}^n$, then we say R is symmetric positive semi-definite (SPSD), and the induced seminorm is defined by $||x||_R := \sqrt{\langle Rx, x \rangle}$. For any $A \in \mathbb{R}^{m \times n}$, we use $\sigma(A)$ to denote the set of all eigenvalues of A and let $\rho(A) := \max_{\lambda \in \sigma(A)} |\lambda|$ be the spectral radius of A. Given any SPSD operator R, the spectral condition number is defined by $\kappa(R) := \lambda_{\max}(R)/\lambda_{\min}(R)$, where $\lambda_{\max}(R)$ and $\lambda_{\min}(R)$ are respectively the largest and smallest eigenvalues.

2.2 Bregman distance

Let us first recall the definitions of prox-function and Bregman distance.

Definition 2.1 (Prox-function). We call $\phi : \mathbf{dom} \phi \to \mathbb{R}$ a prox-function if it is C^1 -smooth and 1-strongly convex, *i.e.*,

$$\phi(x) - \phi(v) - \langle \nabla \phi(v), x - v \rangle \ge \frac{1}{2} \|x - v\|^2, \quad \forall x, v \in \operatorname{dom} \phi.$$

Definition 2.2 (Bregman distance). Let $\phi : \operatorname{dom} \phi \to \mathbb{R}$ be a prox-function. Define the Bregman distance induced by ϕ :

$$D_{\phi}(x,v) := \phi(x) - \phi(v) - \langle \nabla \phi(v), x - v \rangle, \quad \forall x, v \in \operatorname{\mathbf{dom}} \phi$$

When $\phi(x) = 1/2 \|x\|_R^2$ with an SPSD operator $R \in \mathbb{R}^{n \times n}$, we obtain $D_{\phi}(x, v) = 1/2 \|x - v\|_R^2$. In addition, we have the three-term identity [49, Lemma 2.1].

Lemma 2.1 ([49]). Let $\phi : \mathbf{dom} \phi \to \mathbb{R}$ be a prox-function, then

$$\langle \nabla \phi(x) - \nabla \phi(v), v - \bar{x} \rangle = D_{\phi}(\bar{x}, x) - D_{\phi}(\bar{x}, v) - D_{\phi}(v, x), \quad \forall x, v, \bar{x} \in \operatorname{\mathbf{dom}} \phi.$$
(8)

In particular, for $\phi(x) = 1/2 \|x\|_{B}^{2}$, we have

$$\langle R(x-v), v-\bar{x}\rangle = \frac{1}{2} \|x-\bar{x}\|_{R}^{2} - \frac{1}{2} \|v-\bar{x}\|_{R}^{2} - \frac{1}{2} \|x-v\|_{R}^{2}.$$
(9)

For convergence analysis, we need the conception of relative convexity w.r.t. Bregman distance. Clearly, for $\phi(x) = 1/2 ||x||^2$, the relative μ -convexity coincides with the standard μ -convexity.

Definition 2.3 (Relatively strong convexity). Let ϕ : dom $\phi \to \mathbb{R}$ be a prox-function and h a closed proper convex function such that dom $h \subset \text{dom } \phi$. We say h is relatively μ -convex with respect to (w.r.t. for short) ϕ if there exists $\mu \ge 0$ such that

$$h(x) \ge h(v) + \langle p, x - v \rangle + \mu_f D_\phi(x, v), \quad \forall x, v \in \operatorname{dom} h, \quad p \in \partial h(v).$$
(10)

Lemma 2.2. Let $\phi : \operatorname{dom} \phi \to \mathbb{R}$ be a prox-function and h a closed proper convex function such that $\operatorname{dom} h \subset \operatorname{dom} \phi$. If h is C_L^1 -smooth and relatively μ -convex w.r.t. ϕ , then

$$\langle \nabla h(\bar{x}), v - x \rangle \leq h(x) - h(v) - \mu D_{\phi}(x, \bar{x}) + \frac{L}{2} \|\bar{x} - v\|^2, \quad \forall x, v, \bar{x} \in \mathbf{dom} h.$$

Proof. Observe that

$$-\langle \nabla h(\bar{x}), v - \bar{x} \rangle \le h(\bar{x}) - h(v) + \frac{L}{2} \|\bar{x} - v\|^2,$$

$$-\langle \nabla h(\bar{x}), \bar{x} - x \rangle \le h(x) - h(\bar{x}) - \mu D_{\phi}(x, \bar{x}).$$

Collecting these two estimates leads to the desired result.

2.3 Two auxiliary functions

For later use, we introduce two auxiliary functions related to the min-part f and the max-part g of the saddlepoint problem (1). Given $\hat{z} = (\hat{x}, \hat{y}) \in \text{dom } \mathcal{L}$, define

$$\widehat{f}(x;\widehat{z}) := f(x) + \left\langle A^{\top}\widehat{y}, x - \widehat{x} \right\rangle, \quad \widehat{g}(y;\widehat{z}) := g(y) - \left\langle A\widehat{x}, y - \widehat{y} \right\rangle, \tag{11}$$

for all $(x, y) \in \operatorname{dom} \mathcal{L}$. It is clear that both $\widehat{f}(\cdot, \widehat{z}) : \mathbb{R}^n \to \mathbb{R} \cup \{+\infty\}$ and $\widehat{g}(\cdot, \widehat{z}) : \mathbb{R}^m \to \mathbb{R} \cup \{+\infty\}$ are properly closed convex, and we have the relations:

$$\partial f(x;\hat{z}) = \partial_x \mathcal{L}(x,\hat{y}), \quad \partial \widehat{g}(y;\hat{z}) = -\partial_y \mathcal{L}(\hat{x},y).$$
 (12)

Since $\widehat{f}(\widehat{x};\widehat{z}) = f(\widehat{x})$ and $\widehat{g}(\widehat{y};\widehat{z}) = g(\widehat{y})$, a simple calculation implies

$$\mathcal{L}(x,\widehat{y}) - \mathcal{L}(\widehat{x},y) = \widehat{f}(x;\widehat{z}) - f(\widehat{x}) + \widehat{g}(y;\widehat{z}) - g(\widehat{y}).$$
(13)

Throughout we equip two prox-functions ϕ and ψ respectively for the primal and dual variables, and make the following assumption:

Assumption 1. ϕ : dom $\phi \to \mathbb{R}$ and ψ : dom $\psi \to \mathbb{R}$ are two prox-functions such that dom $\mathcal{L} \subset \operatorname{dom} \phi \times \operatorname{dom} \psi$.

Invoking Definitions 2.1 and 2.3 and (12) and (13) gives the lemma below.

Lemma 2.3. Assume (f,g) are relatively (μ_f, μ_g) -convex w.r.t. (ϕ, ψ) with $\mu_f, \mu_g \ge 0$.

- (i) For any $\hat{z} = (\hat{x}, \hat{y}) \in \text{dom } \mathcal{L}$, $\hat{f}(\cdot, \hat{z})$ and $\hat{g}(\cdot, \hat{z})$ are also relatively convex w.r.t. ϕ and ψ with constants μ_f , $\mu_g \ge 0$.
- (ii) If $\hat{z} = (\hat{x}, \hat{y})$ is a saddle point to (1), then we have

$$\widehat{f}(x;\widehat{z}) \ge f(\widehat{x}) + \frac{\mu_f}{2} \|x - \widehat{x}\|^2, \quad \widehat{g}(y;\widehat{z}) \ge g(\widehat{y}) + \frac{\mu_g}{2} \|y - \widehat{y}\|^2.$$

for all $(x, y) \in \text{dom } \mathcal{L}$. In particular, by (13), it holds that

$$\mathcal{L}(x,\widehat{y}) - \mathcal{L}(\widehat{x},y) \ge \frac{\mu_f}{2} \|x - \widehat{x}\|^2 + \frac{\mu_g}{2} \|y - \widehat{y}\|^2.$$

2.4 Lyapunov functions

To prove the convergence rates of our continuous models and discrete algorithms, we need some technical Lyapunov functions.

For simplicity, let $\mathcal{Z} := (\operatorname{\mathbf{dom}} f)^2 \times (\operatorname{\mathbf{dom}} g)^2$. Given $\widehat{z} = (\widehat{x}, \widehat{y}) \in \operatorname{\mathbf{dom}} \mathcal{L}$, define a Lyapunov function $\mathcal{E} : \mathbb{R}^2_+ \times \mathcal{Z} \to \mathbb{R}_+$ by that

$$\mathcal{E}(\Theta, Z; \widehat{z}) := \mathcal{L}(x, \widehat{y}) - \mathcal{L}(\widehat{x}, y) + \frac{\gamma}{2} \|v - \widehat{x}\|^2 + \frac{\beta}{2} \|w - \widehat{y}\|^2,$$
(14)

where $\Theta = (\gamma, \beta) \in \mathbb{R}^2_+$ and $Z = (x, v, y, w) \in \mathbb{Z}$. To work with Bregman distances, we also introduce a generalized Lyapunov function $\mathcal{E}_D : \mathbb{R}^2_+ \times \mathbb{Z} \to \mathbb{R}_+$:

$$\mathcal{E}_D(\Theta, Z; \hat{z}) := \mathcal{L}(x, \hat{y}) - \mathcal{L}(\hat{x}, y) + \gamma D_\phi(\hat{x}, v) + \beta D_\psi(\hat{y}, w).$$
(15)

Clearly, when $\phi(x) = 1/2 ||x||^2$ and $\psi(y) = 1/2 ||y||^2$, \mathcal{E}_D is identical to \mathcal{E} .

The previous two (14) and (15) are mainly applied to analyzing continuous models (cf. Theorems 4.1 and 4.2). For discrete algorithms, however, some additional careful correction is required. Let $\{\alpha_k\} \subset \mathbb{R}_+$, $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}_+^2$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathcal{Z}$ be given, define a discrete Lyapunov function

$$\mathcal{H}_k(\widehat{z}) := \mathcal{E}_D(\Theta_k, Z_k; \widehat{z}) - \alpha_k \left\langle A(v_k - \widehat{x}), w_k - \widehat{y} \right\rangle, \tag{16}$$

with any $\hat{z} \in \operatorname{dom} \mathcal{L}$. Thanks to Lemma 2.4, the extra cross term in (16) can be controlled by the Bregman distances in \mathcal{E}_D as long as $||A||^2 \alpha_k^2 \leq \gamma_k \beta_k$.

Lemma 2.4. Let $\alpha \in \mathbb{R}_+$ and $(\gamma, \beta) \in \mathbb{R}^2_+$ be given. If $||A||^2 \alpha^2 \leq \gamma \beta$, then

$$\alpha \left| \langle A(v-x), w-y \rangle \right| \le \gamma D_{\phi}(x,v) + \beta D_{\psi}(y,w), \quad \forall (x,v,y,w) \in \mathcal{Z}.$$

Proof. Since ψ and ϕ are 1-strongly convex (cf.Definition 2.1 and Assumption 1), applying the standard mean-value inequality gives the desired result.

For convergence analysis, the key is to establish the upper bound of

$$\mathcal{H}_{k+1}(\widehat{z}) - \mathcal{H}_k(\widehat{z}) + \alpha_k \mathcal{H}_{k+1}(\widehat{z}) = \mathbb{I}_1 + \mathbb{I}_{21} + \mathbb{I}_{22} + \mathbb{I}_{31} + \mathbb{I}_{32}, \tag{17}$$

where the decomposition on the right hand side consists of

$$\begin{split} \mathbb{I}_{1} &:= \alpha_{k} \left\langle A(v_{k} - \widehat{x}), w_{k} - \widehat{y} \right\rangle - \alpha_{k+1} (1 + \alpha_{k}) \left\langle A(v_{k+1} - \widehat{x}), w_{k+1} - \widehat{y} \right\rangle, \\ \mathbb{I}_{21} &:= \widehat{f}(x_{k+1}; \widehat{z}) - \widehat{f}(x_{k}; \widehat{z}) + \alpha_{k} \left(\widehat{f}(x_{k+1}; \widehat{z}) - f(\widehat{x}) \right), \\ \mathbb{I}_{22} &:= \gamma_{k+1} (1 + \alpha_{k}) D_{\phi}(\widehat{x}, v_{k+1}) - \gamma_{k} D_{\phi}(\widehat{x}, v_{k}), \\ \mathbb{I}_{31} &:= \widehat{g}(y_{k+1}; \widehat{z}) - \widehat{g}(y_{k}; \widehat{z}) + \alpha_{k} \left(\widehat{g}(y_{k+1}; \widehat{z}) - g(\widehat{y}) \right), \\ \mathbb{I}_{32} &:= \beta_{k+1} (1 + \alpha_{k}) D_{\psi}(\widehat{y}, w_{k+1}) - \beta_{k} D_{\psi}(\widehat{y}, w_{k}). \end{split}$$

Lemma 2.5. Let $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}^2_+$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathcal{Z}$ be given. Assume $||A||^2 \alpha_k^2 \leq \gamma_k \beta_k$ and

$$\mathcal{H}_{k+1}(\widehat{z}) - \mathcal{H}_k(\widehat{z}) + \alpha_k \mathcal{H}_{k+1}(\widehat{z}) \le -\Omega_k, \tag{18}$$

where $\{\Omega_k\} \subset \mathbb{R}_+$ is some nonnegative sequence and $\hat{z} = (\hat{x}, \hat{y})$ is a saddle point to (1), then we have

$$\mathcal{L}(x_k, \hat{y}) - \mathcal{L}(\hat{x}, y_k) + \frac{\mu_f}{2} \|x_k - \hat{x}\|^2 + \frac{\mu_g}{2} \|y_k - \hat{y}\|^2 + \theta_k \sum_{i=0}^{k-1} \frac{\Omega_i}{\theta_i} \le 2\theta_k \mathcal{H}_0(\hat{z}),$$
(19)

where $\{\theta_k\}$ is defined by

$$\theta_0 = 1, \quad \theta_k = \prod_{i=0}^{k-1} \frac{1}{1+\alpha_i} \quad \forall k \ge 1.$$
(20)

Proof. It is not hard to obtain from (20) that

$$\theta_{k+1} - \theta_k = -\alpha_k \theta_{k+1}. \tag{21}$$

According to our assumption (18), it follows that

$$\mathcal{H}_k(\widehat{z}) + \theta_k \sum_{i=0}^{k-1} \frac{\Omega_i}{\theta_i} \le \theta_k \mathcal{H}_0(\widehat{z}), \quad k \ge 0.$$

Since $||A||^2 \alpha_k^2 \leq \gamma_k \beta_k$, applying Lemma 2.4 gives $\mathcal{L}(x_k, \hat{y}) - \mathcal{L}(\hat{x}, y_k) \leq \mathcal{H}_k(\hat{z})$. Consequently, invoking Lemma 2.3 (ii) proves (19).

Remark 2.1. Compared with (14) and (15), the discrete version (16) has an extra cross term, which is crucial to establish the key estimate (18) for our methods. However, this is very different from the discrete Lyapunov analysis for affinely constrained problems [18, 31, 46, 47, 50, 52], where NO cross term is needed.

3 Spectral Analysis of a Quadratic Game

In this section, we follow the main idea from [51, Section 2] to seek proper lifting system of a quadratic game. By using the tool of spectral analysis, we verify the stability and better dependence on the condition number. This provides the key guidance for desinging our continuous models for saddle-point problems.

3.1 The unconstrained case

Let us start from the quadratic programming

$$\min_{x \in \mathbb{R}^n} f(x) = \frac{1}{2} \|x\|_Q^2,$$
(22)

where $Q \in \mathbb{R}^{n \times n}$ is SPD. Note that the optimal solution is $x^* = 0$. The classical gradient flow reads as $x' = -\nabla f(x) = -Qx$, which is converges exponentially. The explicit Euler discretization, i.e., the gradient descent method $x_{k+1} = x_k - \alpha \nabla f(x_k) = (I - \alpha Q)x_k$, converges at a linear rate $\mathcal{O}(1 - 1/\kappa(Q))$ with $\alpha = O(1/\kappa(Q))$, which is suboptimal.

To seek acceleration, the basic idea in [51, Section 2] is to find some lifting vector field $x' = \mathcal{G}x$, where x = (x, v) and \mathcal{G} is preferably a block matrix with $\Re(\lambda) < 0$ for all $\lambda \in \sigma(\mathcal{G})$. The block matrix \mathcal{G} transforms $\sigma(-Q)$ from the negative real line to the left half complex plane and hopefully provides better dependence on the condition number.

Especially, a nice candidate has been given in [51, Section 2]:

$$\mathcal{G} = \begin{pmatrix} -I & I\\ I - Q/\lambda_{\min}(Q) & -I \end{pmatrix},$$
(23)

which leads to the continuous NAG flow model

$$x' = v - x, \quad v' = x - v - \frac{Qx}{\lambda_{\min}(Q)}.$$
 (24)

It is proved via spectral analysis that [51, Theorem 2.1], a suitable Gauss–Seidel splitting of (24) possesses a smaller spectral radius $\mathcal{O}(1 - 1/\sqrt{\kappa(Q)})$ with larger step size $\alpha = \mathcal{O}(1/\sqrt{\kappa(Q)})$, which matches the optimal rate [58].

3.2 A quadratic game

Let us then consider the saddle-point problem (1) with simple quadratic objectives $f(x) = \mu/2 ||x||^2$ and $g(y) = \mu/2 ||y||^2$, which corresponds to a quadratic game

$$\min_{x \in \mathbb{R}^n} \max_{y \in \mathbb{R}^m} \frac{1}{2} (x^\top, -y^\top) \mathcal{Q} \begin{pmatrix} x \\ y \end{pmatrix}, \quad \text{where } \mathcal{Q} = \mu I + \begin{pmatrix} O & A^\top \\ -A & O \end{pmatrix}.$$
(25)

Note that Q is strongly monotone and $\sigma(Q) = \mu \pm i \sqrt{\sigma(AA^{\top})}$. The optimality condition is $Qz^* = 0$, and the unique saddle point is $z^* = (x^*, y^*) = (0, 0)$. Analogously to the unconstrained case, the explicit Euler scheme

$$\frac{z_{k+1} - z_k}{\alpha} = -\mathcal{Q}z_k \tag{26}$$

of the saddle-point dynamics z' = -Qz results in a large spectral radius $\mathcal{O}(1 - \mu^2 / ||A||^2)$ with the step size $\alpha = \mathcal{O}(\mu^2 / ||A||^2)$; see Appendix A.1. However, according to the theoretical lower complexity bound [3, 35, 81], this is suboptimal.

Following [51, Section 2], we aim to find some lifting system $\boldsymbol{\xi}' = \mathcal{G}\boldsymbol{\xi}$ with $\boldsymbol{\xi} = (z, u)$, which realizes the improved spectral radius $\mathcal{O}(1 - \mu/||A||)$ with larger step size $\alpha = \mathcal{O}(\mu/||A||)$. Motivated by the NAG model (23), a natural one shall be

$$\mathcal{G}_{\mathrm{nag}} = \begin{pmatrix} -I & I \\ I - \mathcal{Q}/\mu & -I \end{pmatrix}.$$

Expanding the system $\boldsymbol{\xi}' = \mathcal{G}_{nag} \boldsymbol{\xi}$ with z = (x, y) and u = (v, w) gives

$$\begin{pmatrix} x'\\y' \end{pmatrix} = \begin{pmatrix} v-x\\w-y \end{pmatrix}, \quad \begin{pmatrix} v'\\w' \end{pmatrix} = \begin{pmatrix} x-v\\y-w \end{pmatrix} - \frac{1}{\mu} \begin{pmatrix} \mu x + A^{\top}y\\\mu y - Ax \end{pmatrix}.$$
(27)

This is very close to the saddle-point dynamics in [54, Eq.(3.2) in Chapter 3], which has one more time rescaling factor. Asymptotic stability of (27) has been proved by [54, Theorem 4.1.1], under the assumption that *the coupling matrix* A *is not dominated*. Otherwise, we will see *instability*. In other words, the *naive* model (27) is unstable; see Fig. 1.

Proposition 3.1. If $||A|| > 2\mu$, then there must be some $\lambda \in \sigma(\mathcal{G}_{nag})$ with $\Re(\lambda) > 0$.

Proof. Let $\lambda \in \sigma(\mathcal{G}_{nag})$, then a primal calculation gives $(\lambda + 1)^2 = \pm i\sqrt{\delta}/\mu$, where $\delta \in \sigma(A^{\top}A)$. Since $\lambda_{\max}(A^{\top}A) = ||A||^2 > 4\mu^2$, there exists at least one $\delta^* \in \sigma(A^{\top}A)$ satisfying $\delta^* > 4\mu^2$. This results in a trouble eigenvalue $\lambda^* \in \sigma(\mathcal{G}_{nag})$ such that

$$\lambda^* = -1 + \sqrt{\frac{\sqrt{\delta^*}}{2\mu}} \pm i\sqrt{\frac{\sqrt{\delta^*}}{2\mu}}, \quad \text{with } \Re(\lambda^*) = -1 + \sqrt{\frac{\sqrt{\delta^*}}{2\mu}} > 0.$$

This finishes the proof.

3.3 NAG with velocity correction

Motivated by the velocity correction of the continuous models in [46, 47], we modify (27) as follows

$$\begin{pmatrix} x'\\y' \end{pmatrix}' = \begin{pmatrix} v-x\\w-y \end{pmatrix}, \quad \begin{pmatrix} v'\\w' \end{pmatrix} = \begin{pmatrix} x-v\\y-w \end{pmatrix} - \frac{1}{\mu} \begin{pmatrix} \mu x + A^{\top}(y+y')\\\mu y - A(x+x') \end{pmatrix}, \quad (28)$$

which is related to $\boldsymbol{\xi}' = \mathcal{G}_{new} \boldsymbol{\xi}$ with

$$\mathcal{G}_{\text{new}} = \begin{pmatrix} -I & I \\ O & -\mathcal{Q}/\mu \end{pmatrix}.$$
(29)

Similarly with Proposition 3.1, any $\lambda \in \sigma(\mathcal{G}_{new})$ satisfies

$$(\lambda+1)(\lambda+1\pm i\sqrt{\delta}/\mu) = 0, \tag{30}$$

with some $\delta \in \sigma(A^{\top}A)$. This means the modified one (28) is stable since $\sigma(\mathcal{G}_{new})$ is located at the straight line $-1 + i \mathbb{R}$; see Fig. 1.



Figure 1: Numerical illustrations of the spectrum and the trajectories of (27) and (28).

Write $\mathcal{G}_{\text{new}} = -I + \mathcal{L} + \mathcal{U}$, where \mathcal{L} and \mathcal{U} are respectively the strictly lower triangular and upper triangular part of \mathcal{G}_{new} . Let $\alpha > 0$ be the step size, we now consider the Gauss–Seidel splitting

$$\frac{\boldsymbol{\xi}_{k+1} - \boldsymbol{\xi}_k}{\alpha} = (-I + \mathcal{L})\boldsymbol{\xi}_{k+1} + \mathcal{U}\boldsymbol{\xi}_k, \tag{31}$$

where the lower triangular part adopts the implicit discretization. A direct computation gives

$$\boldsymbol{\xi}_{k+1} = \widehat{\mathcal{G}}\boldsymbol{\xi}_k, \quad \widehat{\mathcal{G}} = \left[(1+\alpha)I - \alpha \mathcal{L} \right]^{-1} \left(I + \alpha \mathcal{U} \right).$$

Theorem 3.1. If $0 < \alpha \le 2\mu / ||A||$, then $\rho(\widehat{\mathcal{G}}) = \frac{1}{1+\alpha}$. In particular, taking $\alpha = \mu / ||A||$ gives

$$\rho(\widehat{\mathcal{G}}) = \frac{1}{1 + \mu/ \|A\|}.$$

Proof. See Appendix A.2.

Recall that for the unconstrained case (22), we see acceleration from $\mathcal{O}(1 - 1/\kappa(Q))$ to $\mathcal{O}(1 - 1/\sqrt{\kappa(Q)})$. For the quadratic game (25), it has $\mu \leq \Re(\lambda)$ and $|\lambda| \leq \sqrt{\mu^2 + \|A\|^2}$ for all $\lambda \in \sigma(Q)$. From Theorem 3.1, we see a larger step size $\alpha = \mathcal{O}(\mu/\|A\|)$ leads to the improved spectral radius $\mathcal{O}(1 - \mu/\|A\|)$, which is optimal [3, 35] and brings acceleration.

4 Continuous Model and Exponential Decay

4.1 Accelerated primal-dual gradient flow

Based on the template (28), we propose an accelerated primal-dual gradient (APDG) flow:

$$f x' = v - x, (32a)$$

$$\mathbf{y}' = w - y, \tag{32b}$$

$$\gamma v' \in \mu_f(x-v) - \partial_x \mathcal{L}(x,w), \tag{32c}$$

$$\bigcup \beta w' \in \mu_g(y - w) + \partial_y \mathcal{L}(v, y). \tag{32d}$$

Here and in the sequel, the primal parameter γ and the dual parameter β satisfy

$$\gamma' = \mu_f - \gamma, \quad \beta' = \mu_g - \beta, \tag{33}$$

with arbitrary positive initial conditions. Eliminating the inertial variables v and w from (32) leads to a novel second-order ODE model

$$\int \gamma x'' + (\mu_f + \gamma) x' + \partial_x \mathcal{L}(x, y + y') = 0, \qquad (34a)$$

$$\int \beta y'' + (\mu_g + \beta)y' - \partial_y \mathcal{L}(x + x', y) = 0.$$
(34b)

Under proper smooth setting, our APDG flow (32) admits a unique global C^1 -smooth solution $Z = (x, v, y, w) : [0, \infty) \to \mathcal{Z}$. This allows us to establish the exponential decay property of the Lyapunov function along the continuous trajectory.

Theorem 4.1. Assume f/g are $C_{L_f}^1/C_{L_g}^1$ -smooth and relatively μ_f/μ_g -convex with respect to ϕ/ψ . There is a unique global C^1 -smooth solution $Z : [0, \infty) \to \mathcal{Z}$ to the APDG model (32). Moreover, we have

$$\frac{\mathrm{d}}{\mathrm{d}t}\mathcal{E}(\Theta, Z; \hat{z}) \le -\mathcal{E}(\Theta, Z; \hat{z}),\tag{35}$$

where $\mathcal{E}(\Theta, Z; \hat{z})$ is defined by (14) with any $\hat{z} = (\hat{x}, \hat{y}) \in \mathbf{dom} \mathcal{L}$. This leads to the exponential decay

 $\mathcal{E}(\Theta(t), Z(t); \widehat{z}) \le e^{-t} \mathcal{E}(\Theta(0), Z(0); \widehat{z}), \quad \forall \, 0 < t < \infty.$

Proof. According to the Lipschitz assumption son ∇f and ∇g , the right hand side of (32) is Lipschitz continuous over bounded sets. Thus, following the argument in [9, Theorem 4.1], we conclude that the unique C^1 -smooth solution Z = (x, v, y, w) exists globally on $[0, \infty)$.

It remains to establish (35). Invoking (32) and (33), a direct computation gives

$$\frac{\mathrm{d}}{\mathrm{d}t}\mathcal{E}(\Theta, Z; \hat{z}) = \langle \nabla_{\Theta} \mathcal{E}, \Theta' \rangle + \langle \nabla_{Z} \mathcal{E}, Z' \rangle := \mathbb{A}_{1} + \mathbb{A}_{2} + \mathbb{A}_{3} + \mathbb{A}_{4},$$
(36)

where

$$\begin{cases} \mathbb{A}_{1} = \frac{\mu_{f} - \gamma}{2} \|v - \widehat{x}\|^{2} + \frac{\mu_{g} - \beta}{2} \|w - \widehat{y}\|^{2}, \\ \mathbb{A}_{2} = \mu_{f} \langle x - v, v - \widehat{x} \rangle + \mu_{g} \langle y - w, w - \widehat{y} \rangle, \\ \mathbb{A}_{3} = \langle \nabla_{y} \mathcal{L}(v, y), w - \widehat{y} \rangle - \langle \nabla_{y} \mathcal{L}(\widehat{x}, y), w - y \rangle, \\ \mathbb{A}_{4} = \langle \nabla_{x} \mathcal{L}(x, \widehat{y}), v - x \rangle - \langle \nabla_{x} \mathcal{L}(x, w), v - \widehat{x} \rangle. \end{cases}$$

Applying the three-term identity (9) gives that

$$\begin{aligned} \mathbb{A}_2 &= \frac{\mu_f}{2} \left(\|x - \widehat{x}\|^2 - \|v - \widehat{x}\|^2 - \|x - v\|^2 \right) \\ &+ \frac{\mu_g}{2} \left(\|y - \widehat{y}\|^2 - \|w - \widehat{y}\|^2 - \|y - w\|^2 \right). \end{aligned}$$

For \mathbb{A}_3 , by (12) and the strong convexity of $\widehat{g}(\cdot; \widehat{z})$, there follows

$$\begin{split} \mathbb{A}_{3} &= \langle A(v-\widehat{x}), w-\widehat{y} \rangle + \langle \nabla_{y}\mathcal{L}(\widehat{x},y), w-\widehat{y} \rangle - \langle \nabla_{y}\mathcal{L}(\widehat{x},y), w-y \rangle \\ &= \langle A(v-\widehat{x}), w-\widehat{y} \rangle + \langle \nabla_{y}\mathcal{L}(\widehat{x},y), y-\widehat{y} \rangle \\ &= \langle A(v-\widehat{x}), w-\widehat{y} \rangle - \langle \nabla\widehat{g}(y), y-\widehat{y} \rangle \quad (\text{by (12)}) \\ &\leq \langle A(v-\widehat{x}), w-\widehat{y} \rangle + g(\widehat{y}) - \widehat{g}(y;\widehat{z}) - \frac{\mu_{g}}{2} \|y-\widehat{y}\|^{2} \,, \end{split}$$

and similarly

$$\mathbb{A}_4 \leq -\left\langle A^{\top}(w-\widehat{y}), v-\widehat{x}\right\rangle + f(\widehat{x}) - \widehat{f}(x;\widehat{z}) - \frac{\mu_f}{2} \left\|x-\widehat{x}\right\|^2.$$

This together with the fact (13) gives

$$A_{3} + A_{4} \leq g(\hat{y}) - \hat{g}(y;\hat{z}) - \frac{\mu_{g}}{2} \|y - \hat{y}\|^{2} + f(\hat{x}) - \hat{f}(x;\hat{z}) - \frac{\mu_{f}}{2} \|x - \hat{x}\|^{2}$$

$$= -\left(\mathcal{L}(x,\hat{y}) - \mathcal{L}(\hat{x},y)\right) - \frac{\mu_{g}}{2} \|y - \hat{y}\|^{2} - \frac{\mu_{f}}{2} \|x - \hat{x}\|^{2}.$$
(37)

Therefore, combining this with \mathbb{A}_1 and \mathbb{A}_2 leads to

$$\frac{\mathrm{d}}{\mathrm{d}t}\mathcal{E}(\Theta, Z; \widehat{z}) \leq -\mathcal{E}(\Theta, Z; \widehat{z}) - \frac{\mu_g}{2} \|y - w\|^2 - \frac{\mu_f}{2} \|x - v\|^2.$$

Using the substitutions x' = v - x and y' = w - y, we obtain (35) and complete the proof.

4.2 Accelerated Bregman primal-dual gradient flow

Motivated by the accelerated Bregman primal-dual flow [49] for solving linearly constrained optimization, to work with general non-Euclidean distances, we propose the following *accelerated Bregman primal-dual gradient (ABPDG) flow*:

$$Y x' = v - x, \tag{38a}$$

$$y' = w - y, \tag{38b}$$

$$\begin{cases} \gamma \frac{\mathrm{d}}{\mathrm{d}t} \nabla \phi(v) \in \mu_f(\nabla \phi(x) - \nabla \phi(v)) - \partial_x \mathcal{L}(x, w), \end{cases}$$
(38c)

$$\left(\beta \frac{\mathrm{d}}{\mathrm{d}t} \nabla \psi(w) \in \mu_g(\nabla \phi(y) - \nabla \psi(w)) + \partial_y \mathcal{L}(v, y),\right)$$
(38d)

where γ and β are still governed by (33). Analogously to (34), we can drop v and w to obtain

$$\gamma \frac{\mathrm{d}}{\mathrm{d}t} \nabla \phi(x+x') \in \mu_f(\nabla \phi(x) - \nabla \phi(x+x')) - \partial_x \mathcal{L}(x,y+y'),$$

$$\beta \frac{\mathrm{d}}{\mathrm{d}t} \nabla \psi(y+y') \in \mu_g(\nabla \phi(y) - \nabla \psi(y+y')) + \partial_y \mathcal{L}(x+x',y).$$

Remark 4.1. Let us discuss the relation and difference among our models and existing works. We mainly focus on primal-dual dynamical systems for the saddle-point problem (1) and the equality constrained problem (4) with Ax = b, which is a special case of (1) with $g(y) = \langle b, y \rangle$.

- Linearly constrained problem (4): Looking at the equations for the primal variable and the dual variable (Lagrange multiplier), most works adopt either second-order + second-order [2, 10, 30, 80, 83] or first-order + first-order structures [15, 18, 47]. Besides, in [32, 46, 52, 49], the hybrid second-order + first-order combination has been considered. When g(y) = (b, y), both of our APDG flow (34) and ABPDG flow (38) provide new second-order + second-order models for the equality constrained problem (4). Especially, the latter is equipped with general Bregman distances respectively for the primal variable and the Lagrange multiplier, which can be adapted to proper metrics and brings further preconditioning effect.
- Saddle-point problem (1): We are aware of some recent works [17, 29]. Compared with these, ours combine Bregman distances with subtlety time rescaling parameters for primal and dual variables. This paves the way for designing new (nonlinear) primal-dual splitting methods for both convex and (partially) strongly convex problems in a unified way.

Theorem 4.2. Assume (f,g) are C^1 -smooth and relatively (μ_f, μ_g) -convex with respect to (ϕ, ψ) . Let $Z = (x, v, y, w) : [0, \infty) \to \mathcal{Z}$ be a global C^1 -smooth solution to the ABPDG flow (38), then for the Lyapunov function (15), we have

$$\frac{\mathrm{d}}{\mathrm{d}t}\mathcal{E}_D(\Theta, Z; \hat{z}) \le -\mathcal{E}_D(\Theta, Z; \hat{z}) - \mu_f D_\psi(v, x) - \mu_g D_\psi(w, y), \tag{39}$$

which implies

$$\mathcal{E}_D(\Theta(t), Z(t); \hat{z}) \le e^{-t} \mathcal{E}_D(\Theta(0), Z(0); \hat{z}), \quad \forall \, 0 < t < \infty,$$
(40)

for any $\widehat{z} = (\widehat{x}, \widehat{y}) \in \operatorname{\mathbf{dom}} \mathcal{L}$.

Proof. Observing Definition 2.2, a direct calculation gives

$$\frac{\mathrm{d}}{\mathrm{d}t}D_{\phi}(\widehat{x},v) = \left\langle \frac{\mathrm{d}}{\mathrm{d}t}\nabla\phi(v), v - \widehat{x} \right\rangle, \quad \frac{\mathrm{d}}{\mathrm{d}t}D_{\psi}(\widehat{y},w) = \left\langle \frac{\mathrm{d}}{\mathrm{d}t}\nabla\psi(w), w - \widehat{y} \right\rangle.$$

Therefore, similarly with (36), we take the time derivative on (38) and use the right hand side of (38) to obtain the expansion

$$\frac{\mathrm{d}}{\mathrm{d}t}\mathcal{E}_D(\Theta, Z; \widehat{z}) = \mathbb{A}_1 + \mathbb{A}_2 + \mathbb{A}_3 + \mathbb{A}_4,$$

where

$$\begin{cases} \mathbb{A}_1 = (\mu_f - \gamma) D_{\phi}(\widehat{x}, v) + (\mu_g - \beta) D_{\psi}(\widehat{y}, w), \\ \mathbb{A}_2 = \mu_f \left\langle \nabla \phi(x) - \nabla \phi(v), v - \widehat{x} \right\rangle + \mu_g \left\langle \nabla \psi(y) - \nabla \psi(w), w - \widehat{y} \right\rangle, \\ \mathbb{A}_3 = \left\langle \nabla_y \mathcal{L}(v, y), w - \widehat{y} \right\rangle - \left\langle \nabla_y \mathcal{L}(\widehat{x}, y), w - y \right\rangle, \\ \mathbb{A}_4 = \left\langle \nabla_x \mathcal{L}(x, \widehat{y}), v - x \right\rangle - \left\langle \nabla_x \mathcal{L}(x, w), v - \widehat{x} \right\rangle. \end{cases}$$

Following the proof of (35) and using the relatively strong convexity (cf.Definition 2.3), the estimate of \mathbb{A}_3 and \mathbb{A}_4 becomes (cf.(37))

$$\mathbb{A}_3 + \mathbb{A}_4 \leq \mathcal{L}(\widehat{x}, y) - \mathcal{L}(x, \widehat{y}) - \mu_g D_{\psi}(\widehat{y}, y) - \mu_f D_{\phi}(\widehat{x}, x).$$

For the second term \mathbb{A}_2 , applying Lemma 2.1 yields that

$$\mathbb{A}_2 = \mu_f \left(D_\phi(\widehat{x}, x) - D_\phi(\widehat{x}, v) - D_\phi(v, x) \right) + \mu_g \left(D_\psi(\widehat{y}, y) - D_\psi(\widehat{y}, w) - D_\psi(w, y) \right).$$

Consequently, collecting all the terms implies (39) and finishes the proof.

Remark 4.2. Since (40) holds for any $\hat{z} = (\hat{x}, \hat{y}) \in \operatorname{dom} \mathcal{L}$, a further argument leads to the exponential convergence of the Lagrangian gap $\mathcal{L}(x(t), \hat{y}) - \mathcal{L}(\hat{x}, y(t))$ and the partial duality gap $\sup_{\hat{z} \in X \times Y} \mathcal{L}(x(t), \hat{y}) - \mathcal{L}(\hat{x}, y(t))$ over any compact subset $X \times Y \subset \operatorname{dom} \mathcal{L}$. For simplicity, we omit the details.

5 Accelerated Bregman Primal-Dual Proximal Splitting

In this section, we propose an accelerated Bregman primal-dual proximal splitting for solving the saddle-point problem (1) under the following setting.

Assumption 2. (f, g) are relatively (μ_f, μ_g) -convex w.r.t. (ϕ, ψ) with $\mu_f, \mu_g \ge 0$.

5.1 Discretization

Let us consider a semi-implicit Euler (SIE) scheme for the ABPDG flow system (38). Given $Z_k = (x_k, v_k, y_k, w_k) \in \mathbb{Z}$ and $\Theta_k = (\gamma_k, \beta_k) \in \mathbb{R}^2_+$, find $\alpha_k > 0$ and update $Z_{k+1} = (x_{k+1}, v_{k+1}, y_{k+1}, w_{k+1}) \in \mathbb{Z}$ by that

$$\int \frac{x_{k+1} - x_k}{\alpha_k} = v_{k+1} - x_{k+1},\tag{41a}$$

$$\frac{y_{k+1} - y_k}{\alpha_k} = \eta_k (w_{k+1} - y_{k+1}), \tag{41b}$$

$$\gamma_k \frac{\nabla \phi(v_{k+1}) - \nabla \phi(v_k)}{\alpha_k} \in \mu_f(\nabla \phi(x_{k+1}) - \nabla \phi(v_{k+1})) - \partial_x \mathcal{L}(x_{k+1}, w_k),$$
(41c)

$$\beta_k \frac{\nabla \psi(w_{k+1}) - \nabla \psi(w_k)}{\alpha_k} \in \mu_g(\nabla \psi(y_{k+1}) - \nabla \psi(w_{k+1})) + \eta_k \partial_y \mathcal{L}(\bar{v}_{k+1}, y_{k+1}),$$
(41d)

where

$$\eta_k := \frac{\alpha_{k+1}}{\alpha_k} (1 + \alpha_k), \quad \bar{v}_{k+1} := v_{k+1} + \frac{v_{k+1} - v_k}{\eta_k}.$$
(42)

To update $\Theta_{k+1} = (\gamma_{k+1}, \beta_{k+1}) \subset \mathbb{R}^2_+$, the continuous parameter equation (33) is discretized by

$$\frac{\gamma_{k+1} - \gamma_k}{\alpha_k} = \mu_f - \gamma_{k+1}, \quad \frac{\beta_{k+1} - \beta_k}{\alpha_k} = \mu_g - \beta_{k+1}, \tag{43}$$

with arbitrary positive initial values γ_0 , $\beta_0 > 0$. We mention that the factor $\eta_k \ge 1$ in (41b) and (41d) is actually a perturbation (cf.(46)) and \bar{v}_{k+1} depends only on v_k and v_{k+1} . Both two are chosen technically for the Lyapunov analysis in Section 5.2. Later in Algorithm 1, we reformulate the SIE scheme (41) as a primal-dual proximal splitting method.

5.2 Lyapunov analysis

In this part, we aim to establish the Lyapunov analysis of the SIE scheme (41) by using the discrete Lyapunov function $\mathcal{H}_k(\hat{z})$ defined by (16). Motivated by the decomposition given in Lemma 2.5, in the next, we shall focus on $\mathbb{I}_{21} + \mathbb{I}_{22}$ and $\mathbb{I}_{31} + \mathbb{I}_{32}$ and prove the corresponding upper bounds separately in Lemmas 5.2 and 5.3.

Lemma 5.1. Let $\{\gamma_k\}$ and $\{\beta_k\}$ be defined by (43) with any $\alpha_k > 0$, then

$$\max\{\gamma_0\theta_k, \min\{\mu_f, \gamma_0\}\} \le \gamma_k \le \max\{\mu_f, \gamma_0\}, \tag{44a}$$

$$\max\{\beta_0\theta_k, \min\{\mu_g, \beta_0\}\} \le \beta_k \le \max\{\mu_g, \beta_0\}, \tag{44b}$$

where $\{\theta_k\}$ is defined by (20). If $||A||^2 \alpha_k^2 = (1-\chi)\gamma_k\beta_k$ with any $\chi \in [0,1)$, then $\eta_k = \alpha_{k+1}(1+\alpha_k)/\alpha_k \ge 1$. *Proof.* By (43), we have

$$\gamma_{k+1} = \frac{\mu_f \alpha_k + \gamma_k}{1 + \alpha_k}, \quad \beta_{k+1} = \frac{\mu_g \alpha_k + \beta_k}{1 + \alpha_k}.$$
(45)

In view of this and (21), a standard induction argument verifies (44). Furthermore, if $||A||^2 \alpha_k^2 = (1 - \chi)\gamma_k\beta_k$, then it follows that

$$\eta_{k} = \frac{1 + \alpha_{k}}{\alpha_{k}} \alpha_{k+1} = \frac{1 + \alpha_{k}}{\alpha_{k} \|A\|} \sqrt{(1 - \chi)\gamma_{k+1}\beta_{k+1}}$$

$$= \frac{\sqrt{1 - \chi}}{\alpha_{k} \|A\|} \sqrt{(\mu_{f}\alpha_{k} + \gamma_{k})(\mu_{g}\alpha_{k} + \beta_{k})}$$

$$= \frac{1}{\sqrt{\gamma_{k}\beta_{k}}} \sqrt{(\mu_{f}\alpha_{k} + \gamma_{k})(\mu_{g}\alpha_{k} + \beta_{k})} \ge 1.$$
(46)

This completes the proof of this lemma.

Lemma 5.2. Given $\Theta_k = (\gamma_k, \beta_k) \in \mathbb{R}^2_+$ and $Z_k = (x_k, v_k, y_k, w_k) \in \mathbb{Z}$, let $\Theta_{k+1} = (\gamma_{k+1}, \beta_{k+1}) \in \mathbb{R}^2_+$ and $Z_{k+1} = (x_{k+1}, v_{k+1}, y_{k+1}, w_{k+1}) \in \mathbb{Z}$ be the outputs of the SIE scheme (41) and the parameter equation (43) at the k-th step with any step size $\alpha_k > 0$. Then we have

$$\mathbb{I}_{21} + \mathbb{I}_{22} \le -\alpha_k \left\langle A^\top (w_k - \widehat{y}), v_{k+1} - \widehat{x} \right\rangle - \gamma_k D_\phi(v_{k+1}, v_k), \tag{47}$$

where \mathbb{I}_{21} and \mathbb{I}_{22} are defined in (17) with any $\hat{z} = (\hat{x}, \hat{y}) \in \operatorname{dom} \mathcal{L}$.

Proof. According to Assumption 2, f is relatively μ_f -convex w.r.t. ϕ and so is $\hat{f}(\cdot; \hat{z})$ by Lemma 2.3 (i). This implies that

$$\mathbb{I}_{21} = \widehat{f}(x_{k+1}; \widehat{z}) - \widehat{f}(x_k; \widehat{z}) + \alpha_k \left(\widehat{f}(x_{k+1}; \widehat{z}) - f(\widehat{x}) \right) \\
\stackrel{\text{by (10)}}{\leq} \left\langle \partial \widehat{f}(x_{k+1}; \widehat{z}), x_{k+1} - x_k \right\rangle + \alpha_k \left\langle \partial \widehat{f}(x_{k+1}; \widehat{z}), x_{k+1} - \widehat{x} \right\rangle - \mu_f \alpha_k D_\phi(\widehat{x}, x_{k+1}) \\
\stackrel{\text{by (41a)}}{=} \alpha_k \left\langle \partial \widehat{f}(x_{k+1}; \widehat{z}), v_{k+1} - \widehat{x} \right\rangle - \mu_f \alpha_k D_\phi(\widehat{x}, x_{k+1}).$$
(48)

Notice that $\partial \hat{f}(x_{k+1}; \hat{z}) = \partial_x \mathcal{L}(x_{k+1}, \hat{y}) = \partial_x \mathcal{L}(x_{k+1}, w_k) - A^\top(w_k - \hat{y})$, which together with (41c) gives

$$\begin{aligned} &\alpha_k \left\langle \partial \widehat{f}(x_{k+1}; \widehat{z}), v_{k+1} - \widehat{x} \right\rangle \\ &= -\alpha_k \left\langle A^\top(w_k - \widehat{y}), v_{k+1} - \widehat{x} \right\rangle + \gamma_k \left\langle \nabla \phi(v_k) - \nabla \phi(v_{k+1}), v_{k+1} - \widehat{x} \right\rangle \\ &+ \mu_f \alpha_k \left\langle \nabla \phi(x_{k+1}) - \nabla \phi(v_{k+1}), v_{k+1} - \widehat{x} \right\rangle. \end{aligned}$$

Plugging this into the previous estimate (48) and using the three-term identity (8), we obtain

$$\begin{split} \mathbb{I}_{21} &\leq -\mu_{f} \alpha_{k} D_{\phi}(\widehat{x}, x_{k+1}) - \alpha_{k} \left\langle A^{\top}(w_{k} - \widehat{y}), v_{k+1} - \widehat{x} \right\rangle \\ &+ \gamma_{k} \left(D_{\phi}(\widehat{x}, v_{k}) - D_{\phi}(\widehat{x}, v_{k+1}) - D_{\phi}(v_{k+1}, v_{k}) \right) \\ &+ \mu_{f} \alpha_{k} \left(D_{\phi}(\widehat{x}, x_{k+1}) - D_{\phi}(\widehat{x}, v_{k+1}) - D_{\phi}(v_{k+1}, x_{k+1}) \right) \\ &= - \mu_{f} \alpha_{k} D_{\phi}(v_{k+1}, x_{k+1}) - \alpha_{k} \left\langle A^{\top}(w_{k} - \widehat{y}), v_{k+1} - \widehat{x} \right\rangle \\ &+ \gamma_{k} D_{\phi}(\widehat{x}, v_{k}) - (\gamma_{k} + \mu_{f} \alpha_{k}) D_{\phi}(\widehat{x}, v_{k+1}) - \gamma_{k} D_{\phi}(v_{k+1}, v_{k}). \end{split}$$

In view of (45), it follows that $\gamma_k + \mu_f \alpha_k = \gamma_{k+1}(1 + \alpha_k)$ and

$$\mathbb{I}_{21} \le -\gamma_k D_{\phi}(v_{k+1}, v_k) - \alpha_k \left\langle A^{\top}(w_k - \hat{y}), v_{k+1} - \hat{x} \right\rangle \\ -\mu_f \alpha_k D_{\phi}(v_{k+1}, x_{k+1}) + \underbrace{\gamma_k D_{\phi}(\hat{x}, v_k) - \gamma_{k+1}(1 + \alpha_k) D_{\phi}(\hat{x}, v_{k+1})}_{= -\mathbb{I}_{22}}$$

This implies (47) and completes the proof of this lemma.

Lemma 5.3. Given $\Theta_k = (\gamma_k, \beta_k) \in \mathbb{R}^2_+$ and $Z_k = (x_k, v_k, y_k, w_k) \in \mathcal{Z}$, let $\Theta_{k+1} = (\gamma_{k+1}, \beta_{k+1}) \in \mathbb{R}^2_+$ and $Z_{k+1} = (x_{k+1}, v_{k+1}, y_{k+1}, w_{k+1}) \in \mathcal{Z}$ be the outputs of the SIE scheme (41) and the parameter equation (43) with $||A||^2 \alpha_k^2 = (1 - \chi) \gamma_k \beta_k$ and $\chi \in [0, 1)$. Then we have

$$\mathbb{I}_{31} + \mathbb{I}_{32} \le \alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle - \beta_k D_\psi(w_{k+1}, w_k), \tag{49}$$

where \mathbb{I}_{31} and \mathbb{I}_{32} are defined in (17) with $\hat{z} = (\hat{x}, \hat{y})$ being a saddle point to (1).

Proof. By Lemma 2.3 (ii) we have $\hat{g}(y_{k+1}; \hat{z}) \ge g(\hat{y})$. Analogously to (48), using (10) and Lemma 2.3 (i) and (41b) implies that

$$\begin{split} \mathbb{I}_{31} &= \widehat{g}(y_{k+1}; \widehat{z}) - \widehat{g}(y_k; \widehat{z}) + \alpha_k \left(\widehat{g}(y_{k+1}; \widehat{z}) - g(\widehat{y}) \right) \\ &\leq \widehat{g}(y_{k+1}; \widehat{z}) - \widehat{g}(y_k; \widehat{z}) + \alpha_k \eta_k \left(\widehat{g}(y_{k+1}; \widehat{z}) - g(\widehat{y}) \right) \\ &\leq \langle \partial \widehat{g}(y_{k+1}; \widehat{z}), y_{k+1} - y_k \rangle + \alpha_k \eta_k \left\langle \partial \widehat{g}(y_{k+1}; \widehat{z}), y_{k+1} - \widehat{y} \right\rangle - \mu_g \alpha_k \eta_k D_{\psi}(\widehat{y}, y_{k+1}) \\ &\leq \alpha_k \eta_k \left\langle \partial \widehat{g}(y_{k+1}; \widehat{z}), w_{k+1} - \widehat{y} \right\rangle - \mu_g \alpha_k D_{\psi}(\widehat{y}, y_{k+1}), \end{split}$$

where in the second and the last lines, we used the fact $\eta_k \ge 1$, which holds true indeed by Lemma 5.1 and the step size condition $||A||^2 \alpha_k^2 = (1 - \chi) \gamma_k \beta_k$. Observing that $\partial \hat{g}(y_{k+1}; \hat{z}) = \partial_y \mathcal{L}(\bar{v}_{k+1}, y_{k+1}) + A(\bar{v}_{k+1} - \hat{x})$, we get

$$\begin{split} \mathbb{I}_{31} & \stackrel{(5)}{\leq} & -\mu_g \alpha_k D_{\psi}(\widehat{y}, y_{k+1}) + \alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \widehat{x}), w_{k+1} - \widehat{y} \right\rangle \\ & +\mu_g \alpha_k \left(D_{\psi}(\widehat{y}, y_{k+1}) - D_{\psi}(\widehat{y}, w_{k+1}) - D_{\psi}(w_{k+1}, y_{k+1}) \right) \\ & +\beta_k \left(D_{\psi}(\widehat{y}, w_k) - D_{\psi}(\widehat{y}, w_{k+1}) - D_{\psi}(w_{k+1}, w_k) \right) \\ & \stackrel{\text{by (8)}}{=} -\mu_g \alpha_k D_{\psi}(w_{k+1}, y_{k+1}) + \alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \widehat{x}), w_{k+1} - \widehat{y} \right\rangle \\ & + \underbrace{\beta_k D_{\psi}(\widehat{y}, w_k) - (\beta_k + \mu_g \alpha_k) D_{\psi}(\widehat{y}, w_{k+1})}_{= -\mathbb{I}_{32}} - \beta_k D_{\psi}(w_{k+1}, w_k) \end{split}$$

We mention that $\beta_k + \mu_g \alpha_k = \beta_{k+1} (1 + \alpha_k)$ (cf.(45)). This finishes the proof of (49).

Theorem 5.1. Given $\Theta_k = (\gamma_k, \beta_k) \in \mathbb{R}^2_+$ and $Z_k = (x_k, v_k, y_k, w_k) \in \mathcal{Z}$, let $\Theta_{k+1} = (\gamma_{k+1}, \beta_{k+1}) \in \mathbb{R}^2_+$ and $Z_{k+1} = (x_{k+1}, v_{k+1}, y_{k+1}, w_{k+1}) \in \mathcal{Z}$ be the outputs of the SIE scheme (41) and the parameter equation (43) with $||A||^2 \alpha_k^2 = (1 - \chi) \gamma_k \beta_k$ and $\chi \in [0, 1)$. Then we have

$$\mathcal{H}_{k+1}(\hat{z}) - \mathcal{H}_{k}(\hat{z}) + \alpha_{k} \mathcal{H}_{k+1}(\hat{z}) \leq -\chi \left(\frac{\gamma_{k}}{2} \|v_{k+1} - v_{k}\|^{2} + \frac{\beta_{k}}{2} \|w_{k+1} - w_{k}\|^{2}\right),$$
(50)

where $\mathcal{H}_k(\hat{z})$ is define by (16) with $\hat{z} = (\hat{x}, \hat{y})$ being a saddle point to (1).

Proof. Thanks to Lemmas 5.2 and 5.3 and the decomposition (17), we obtain

$$\mathcal{H}_{k+1}(\widehat{z}) - \mathcal{H}_k(\widehat{z}) + \alpha_k \mathcal{H}_{k+1}(\widehat{z}) \le \Delta_k - \gamma_k D_\phi(v_k, v_{k+1}) - \beta_k D_\psi(w_k, w_{k+1}), \tag{51}$$

where

$$\Delta_{k} = \alpha_{k} \eta_{k} \left\langle A(\bar{v}_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle - \alpha_{k} \left\langle A(v_{k+1} - \hat{x}), w_{k} - \hat{y} \right\rangle + \alpha_{k} \left\langle A(v_{k} - \hat{x}), w_{k} - \hat{y} \right\rangle - \alpha_{k+1} (1 + \alpha_{k}) \left\langle A(v_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle.$$
(52)

Recalling (42), we expand the first term as follows

$$\alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle = \alpha_{k+1} (1 + \alpha_k) \left\langle A(\bar{v}_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle$$
$$= \alpha_k \eta_k \left\langle A(v_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle + \alpha_k \left\langle A(v_{k+1} - v_k), w_{k+1} - \hat{y} \right\rangle,$$

which yields that $\Delta_k = \alpha_k \langle A(v_{k+1} - v_k), w_{k+1} - w_k \rangle$. Hence, using the fact $||A||^2 \alpha_k^2 = (1 - \chi)\gamma_k\beta_k$ and the mean value inequality gives

$$\Delta_{k} \leq (1-\chi) \left(\frac{\gamma_{k}}{2} \| v_{k+1} - v_{k} \|^{2} + \frac{\beta_{k}}{2} \| w_{k+1} - w_{k} \|^{2} \right).$$

In view of (51) and the 1-strongly convex property of the prox-functions (cf.Definition 2.1), we obtain (50) and conclude the proof of this theorem.

5.3 The overall algorithm and iteration complexity

The overall SIE scheme (41) with the step size condition $||A||^2 \alpha_k^2 \le \gamma_k \beta_k$ is listed in Algorithm 1, which is called the Accelerated Bregman Primal Dual Proximal Splitting (ABPD-PS). By Assumption 2, the objectives of the proximal steps in Lines 7 and 11 of Algorithm 1 are (strongly) convex.

Algorithm 1 ABPD-PS for solving (1) under Assumptions 1 and 2 **Input:** Problem parameters: μ_f , $\mu_g \ge 0$ and ||A||. Initial guesses: $x_0, v_0 \in \operatorname{dom} f$ and $y_0, w_0 \in \operatorname{dom} g$. Initial parameters: γ_0 , $\beta_0 > 0$. 1: for k = 0, 1, ... do Take $\alpha_k \leq \sqrt{\gamma_k \beta_k} / \|A\|$. 2: Update $\gamma_{k+1} = (\mu_f \alpha_k + \gamma_k)/(1 + \alpha_k)$ and $\beta_{k+1} = (\mu_g \alpha_k + \beta_k)/(1 + \alpha_k)$. 3: Compute $\alpha_{k+1} = \sqrt{\gamma_{k+1}\beta_{k+1}} / ||A||$ and $\eta_k = \alpha_{k+1}(1+\alpha_k)/\alpha_k$. 4: 5: Define $f_k(x,v) := f(x) + \gamma_{k+1} D_{\phi}(v,v_k) + \langle A^{\top} w_k, x \rangle.$ 6: Update $x_{k+1} = \underset{x \in \mathbb{R}^n}{\operatorname{argmin}} \left\{ f_k(x, v) - \mu_f D_{\phi}(x, v_k) : v = x + \frac{x - x_k}{\alpha_k} \right\}.$ Update $v_{k+1} = x_{k+1} + (x_{k+1} - x_k)/\alpha_k$ and $\bar{v}_{k+1} = v_{k+1} + (v_{k+1} - v_k)/\eta_k.$ 7: 8: 9: $\begin{aligned} \text{Define } g_k(y,w) &:= g(y) + \frac{1+\alpha_k}{1+\alpha_k\eta_k} \beta_{k+1} D_{\psi}(w,w_k) - \langle A\bar{v}_{k+1},y \rangle. \\ \text{Update } y_{k+1} &= \operatorname*{argmin}_{y \in \mathbb{R}^m} \Big\{ \eta_k g_k(y,w) - \mu_g D_{\psi}(y,w_k) : w = y + \frac{y-y_k}{\alpha_k\eta_k} \Big\}. \end{aligned}$ 10: 11: Update $w_{k+1} = y_{k+1} + (y_{k+1} - y_k)/(\alpha_k \eta_k)$. 12: 13: end for

Remark 5.1. Let $R \in \mathbb{R}^{n \times n}$ and $S \in \mathbb{R}^{m \times m}$ be SPD. If we choose quadratic prox-functions

$$\phi(x) = 1/2 \|x\|_R^2, \quad \psi(y) = 1/2 \|y\|_S^2, \tag{53}$$

then the proximal steps in Lines 7 and 11 become

$$x_{k+1} = \operatorname{argmin}_{x \in \mathbb{R}^n} \left\{ f(x) + \left\langle A^\top w_k, x \right\rangle + \frac{\delta_k}{2\alpha_k^2} \left\| x - \widetilde{x}_k \right\|_R^2 \right\},\tag{54}$$

$$y_{k+1} = \operatorname*{argmin}_{y \in \mathbb{R}^m} \left\{ g(y) - \langle A\bar{v}_{k+1}, y \rangle + \frac{\tau_k}{2\eta_k \alpha_k^2} \left\| y - \widetilde{y}_k \right\|_S^2 \right\},\tag{55}$$

where

$$\delta_k = \mu_f \alpha_k + \gamma_k (1 + \alpha_k), \qquad \widetilde{x}_k = \frac{1}{\delta_k} \left((\mu_f \alpha_k + \gamma_k) x_k + \gamma_k \alpha_k v_k \right),$$

$$\tau_k = \mu_g \alpha_k + \beta_k (1 + \eta_k \alpha_k), \qquad \widetilde{y}_k = \frac{1}{\tau_k} \left((\mu_g \alpha_k + \beta_k) y_k + \eta_k \beta_k \alpha_k w_k \right).$$

Theorem 5.2. Assume that $\{(x_k, y_k)\} \subset \operatorname{dom} \mathcal{L}$ is generated by Algorithm 1 with $||A||^2 \alpha_k^2 = (1 - \chi)\gamma_k\beta_k$ and $\chi \in [0, 1)$. Then we have

$$\begin{cases} \mathcal{L}(x_k, \widehat{y}) - \mathcal{L}(\widehat{x}, y_k) + \frac{\mu_f}{2} \|x_k - \widehat{x}\|^2 + \frac{\mu_g}{2} \|y_k - \widehat{y}\|^2 \le 2\theta_k \mathcal{H}_0(\widehat{z}), \\ \sum_{i=0}^{k-1} \frac{\chi}{\theta_i} \left(\gamma_i \|v_{i+1} - v_i\|^2 + \beta_i \|w_{i+1} - w_i\|^2 \right) \le 4\mathcal{H}_0(\widehat{z}), \end{cases}$$
(56)

where $\{\theta_k\}$ is defined by (20) and $\hat{z} = (\hat{x}, \hat{y})$ a saddle point to (1). Moreover, if $\gamma_0 \ge \mu_f$, $\beta_0 \ge \mu_g$ and $\gamma_0 \beta_0 \le ||A||^2$, then

$$\theta_k \le \min\left\{\frac{\|\widehat{A}\|}{\sqrt{\gamma_0\beta_0}k}, \frac{64\|\widehat{A}\|^2}{\mu_g\gamma_0k^2}, \frac{64\|\widehat{A}\|^2}{\mu_f\beta_0k^2}, \left(1 + \frac{1-\chi}{\sqrt{\kappa_P}}\right)^{-k}\right\},\tag{57}$$

for all $k \geq 1$, where $\kappa_P = \|A\|^2 / (\mu_f \mu_g)$ and $\widehat{A} = A / (1 - \chi)$.

Proof. Applying Lemma 2.5 and Theorem 5.1 proves (56). Recall the difference equation (21) of $\{\theta_k\}$.

To establish (57), the key is to find the upper bound and lower bound of α_k . Since $\gamma_0 \ge \mu_f$ and $\beta_0 \ge \mu_g$, by (44) we have $\gamma_k \le \gamma_0$ and $\beta_k \le \beta_0$, which implies

$$\alpha_k = \frac{\sqrt{1-\chi}}{\|A\|} \sqrt{\gamma_k \beta_k} = \sqrt{\gamma_k \beta_k} / \|\widehat{A}\| \le \sqrt{\gamma_0 \beta_0} / \|A\| \le 1$$

The lower bound of α_k is more subtle. From (44), both γ_k and β_k have two under estimates. Hence, we consider four situations.

- (i) First of all, for $\alpha_k \ge \sqrt{\gamma_0 \beta_0} \theta_k / \|\widehat{A}\| = \alpha_0 \theta_k$, it follows from (21) that $\theta_{k+1} \theta_k \le -\alpha_0 \theta_k \theta_{k+1}$. This also implies $1/\theta_{k+1} 1/\theta_k \ge \alpha_0$ and yields that $\theta_k \le 1/(1 + \alpha_0 k) \le \|\widehat{A}\| / (\sqrt{\gamma_0 \beta_0} k)$.
- (ii) Secondly, for $\alpha_k \geq \sqrt{\mu_f \beta_0 \theta_k} / \|\widehat{A}\|$, we have $\theta_{k+1} \theta_k \leq -\sqrt{\mu_f \beta_0} \sqrt{\theta_k} \theta_{k+1} / \|\widehat{A}\|$. Notice that $\theta_{k+1}/\theta_k = 1/(1+\alpha_k) \geq 1/(1+\alpha_0) \geq 1/2$. Hence, invoking Lemma C.1 implies $\theta_k \leq 64 \|\widehat{A}\|^2 / (\mu_f \beta_0 k^2)$.
- (iii) Similarly, for $\alpha_k \ge \sqrt{\mu_g \gamma_0 \theta_k} / \|\widehat{A}\|$, we get $\theta_k \le 64 \|\widehat{A}\|^2 / (\mu_g \gamma_0 k^2)$.
- (iv) Finally, for $\alpha_k \ge \sqrt{\mu_f \mu_g} / \|\widehat{A}\| = (1-\chi) / \sqrt{\kappa_P}$, we obtain from (20) that $\theta_k \le \left(1 + (1-\chi) / \sqrt{\kappa_P}\right)^{-k}$.

Note that these estimates hold simultaneously. This leads to (57) and finishes the proof.

According to convergence rate estimate (57), we conclude that Algorithm 1 admits the optimal iteration complexity [64, 81] under the *proximal algorithm class* [81, Definition 2.1] $(x_k, y_k) \in \mathcal{X}^k \times \mathcal{Y}^k$, where

$$\begin{cases} \mathcal{X}^{k+1} := \mathbf{span} \left\{ x_i, \, \mathbf{prox}_{\delta_i f}(\widetilde{x}_i - \delta_i A^\top \widetilde{y}_i) : \, \widetilde{x}_i \in \mathcal{X}^i, \widetilde{y}_i \in \mathcal{Y}^i, \, 0 \le i \le k \right\}, \\ \mathcal{Y}^{k+1} := \mathbf{span} \left\{ y_i, \, \mathbf{prox}_{\tau_i g}(\widetilde{y}_i + \tau_i A \widetilde{x}_i) : \, \widetilde{x}_i \in \mathcal{X}^i, \widetilde{y}_i \in \mathcal{Y}^i, \, 0 \le i \le k \right\}, \end{cases}$$

with $\mathcal{X}^0 := \operatorname{span} \{x_0\}$ and $\mathcal{Y}^0 := \operatorname{span} \{y_0\}$. More precisely, to achieve the accuracy $\mathcal{L}(x_k, \hat{y}) - \mathcal{L}(\hat{x}, y_k) \leq \epsilon$, the iteration complexity is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\epsilon}, \frac{\|A\|}{\sqrt{\mu_f \epsilon}}, \frac{\|A\|}{\sqrt{\mu_g \epsilon}}, \sqrt{\kappa_P} \left|\ln \epsilon\right|\right\}\right).$$

When $\mu_f > 0$, the iteration complexity for finding $||x_k - \hat{x}||^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_f\sqrt{\epsilon}},\sqrt{\kappa_P}\left|\ln\frac{\mu_f}{\epsilon}\right|\right\}\right).$$

When $\mu_g > 0$, the iteration complexity for finding $\left\|y_k - \hat{y}\right\|^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_g\sqrt{\epsilon}}, \sqrt{\kappa_P}\left|\ln\frac{\mu_g}{\epsilon}\right|\right\}\right).$$

Remark 5.2. Thanks to the second estimate in (56), we have fast convergence results on $\{v_{k+1} - v_k\}$ and $\{w_{k+1} - w_k\}$. In view of Lemma 5.1, we have $\gamma_k \ge \theta_k \gamma_0$ and $\beta_k \ge \theta_k \beta_0$. Putting this into (56) implies

$$\sum_{k=0}^{\infty} \left(\gamma_0 \| v_{k+1} - v_k \|^2 + \beta_0 \| w_{k+1} - w_k \|^2 \right) < \infty,$$

which gives $||v_{k+1} - v_k||^2 = o(1/k)$ and $||w_{k+1} - w_k||^2 = o(1/k)$. If $\mu_f > 0$, then by (57) we have

$$\sum_{k=0}^{\infty} \left(\frac{\mu_f^2}{\|\widehat{A}\|^2} k^2 \|v_{k+1} - v_k\|^2 + \|w_{k+1} - w_k\|^2 \right) < \infty.$$

This gives the fast convergence $||v_{k+1} - v_k||^2 = o(1/k^3)$. Similarly, for $\mu_g > 0$, we also have $||w_{k+1} - w_k||^2 = o(1/k^3)$. If $\mu_f \mu_g > 0$, then it follows from (57) that

$$\sum_{k=0}^{\infty} \left(1 + \frac{1-\chi}{\sqrt{\kappa_P}} \right)^k \left(\mu_f \| v_{k+1} - v_k \|^2 + \mu_g \| w_{k+1} - w_k \|^2 \right) < \infty.$$

6 Accelerated Bregman Primal-Dual Proximal Gradient Splitting

In this section, we mainly focus on the composite case $f = f_1 + f_2$ with the smooth + nonsmooth structure that satisfies the following setting.

Assumption 3. g is relatively μ_g -convex w.r.t. ψ and $f = f_1 + f_2$ where f_1 is $C^1_{L_f}$ -smooth and relatively μ_f -convex w.r.t. ϕ .

6.1 Algorithm and Lyapunov analysis

Based on (41), we propose an variant SIE scheme for the continuous ABPDG flow model (38). Given $Z_k = (x_k, v_k, y_k, w_k) \in \mathbb{Z}$ and $\Theta_k = (\gamma_k, \beta_k) \in \mathbb{R}^2_+$, find $\alpha_k > 0$ and update $Z_{k+1} = (x_{k+1}, v_{k+1}, y_{k+1}, w_{k+1}) \in \mathbb{Z}$ as follows

$$\frac{1}{\alpha_k} \frac{x_{k+1} - x_k}{\alpha_k} = v_{k+1} - x_{k+1},$$
(58a)

$$\frac{y_{k+1} - y_k}{\alpha_k} = \eta_k (w_{k+1} - y_{k+1}), \tag{58b}$$

$$\gamma_k \frac{\nabla \phi(v_{k+1}) - \nabla \phi(v_k)}{\alpha_k} \in \mu_f(\nabla \phi(\bar{x}_k) - \nabla \phi(v_{k+1})) - \mathcal{F}(\bar{x}_k, w_k, v_{k+1}),$$
(58c)

$$\beta_k \frac{\nabla \psi(w_{k+1}) - \nabla \psi(w_k)}{\alpha_k} \in \mu_g(\nabla \psi(y_{k+1}) - \nabla \psi(w_{k+1})) + \eta_k \partial_y \mathcal{L}(\bar{v}_{k+1}, y_{k+1}),$$
(58d)

where η_k and \bar{v}_{k+1} is defined by (42) and

$$\mathcal{F}(\bar{x}_k, w_k, v_{k+1}) = \nabla f_1(\bar{x}_k) + \partial f_2(v_{k+1}) + A^\top w_k, \quad \bar{x}_k = \frac{x_k + \alpha_k v_k}{1 + \alpha_k}.$$

Notice that (58b) and (58d) are identical to (41b) and (41d) respectively. The parameter updating template (43) leaves unchanged, but the third step (58c) differs from (41c) since we replace $\partial_x \mathcal{L}(x_{k+1}, w_k) = \partial f(x_{k+1}) + A^\top w_k$ with $\mathcal{F}(\bar{x}_k, w_k, v_{k+1})$.

With the step size condition $(L_f \beta_k + ||A||^2) \alpha_k^2 \le \gamma_k \beta_k$, we rearrange (58) as a primal-dual proximal gradient method and summarize it in Algorithm 2, which is called Accelerated Bregman Primal-Dual Proximal Gradient Splitting (ABPD-PGS).

Algorithm 2 ABPD-PGS for solving (1) under Assumptions 1 and 3

Input: Problem parameters: μ_f , $\mu_g \ge 0$, L_f and ||A||. Initial guesses: $x_0, v_0 \in \operatorname{dom} f$ and $y_0, w_0 \in \operatorname{dom} g$. Initial parameters: γ_0 , $\beta_0 > 0$. 1: for k = 0, 1, ... do Take $\alpha_k \leq \sqrt{\gamma_k \beta_k / (L_f \beta_k + ||A||^2)}$. Update $\gamma_{k+1} = (\mu_f \alpha_k + \gamma_k) / (1 + \alpha_k)$ and $\beta_{k+1} = (\mu_g \alpha_k + \beta_k) / (1 + \alpha_k)$. Compute $\alpha_{k+1} = \sqrt{\gamma_{k+1} \beta_{k+1} / (L_f \beta_{k+1} + ||A||^2)}$ and $\eta_k = \alpha_{k+1} (1 + \alpha_k) / \alpha_k$. 2: 3: 4: 5: Set $\widetilde{v}_k = \nabla f_1(\overline{x}_k) + A^\top w_k - \mu_f(\nabla \phi(\overline{x}_k) - \nabla \phi(v_k)).$ Update $v_{k+1} = \operatorname*{argmin}_{v \in \mathbb{R}^n} \Big\{ f_2(v) + \langle \widetilde{v}_k, v \rangle + \frac{\gamma_k + \mu_f \alpha_k}{\alpha_k} D_\phi(v, v_k) \Big\}.$ Update $x_{k+1} = (x_k + \alpha_k v_{k+1})/(1 + \alpha_k)$ and $\overline{v}_{k+1} = v_{k+1} + (v_{k+1} - v_k)/\eta_k.$ 6: 7: 8: 9:
$$\begin{split} & \text{Define } g_k(y,w) := g(y) + \frac{1+\alpha_k}{1+\alpha_k\eta_k} \beta_{k+1} D_{\psi}(w,w_k) - \langle A\bar{v}_{k+1},y\rangle. \\ & \text{Update } y_{k+1} = \operatorname*{argmin}_{y \in \mathbb{R}^m} \Big\{ \eta_k g_k(y,w) - \mu_g D_{\psi}(y,w_k) : \ w = y + \frac{y-y_k}{\alpha_k\eta_k} \Big\}. \end{split}$$
10: 11: Update $w_{k+1} = y_{k+1} + (y_{k+1} - y_k)/(\alpha_k \eta_k)$. 12: 13: end for

Remark 6.1. As discussed in Remark 5.1, if we choose (53), then the subproblems in Algorithm 2 agree with standard preconditioned proximal calculations. Indeed, the minimization problem in Line 11 coincides with (55) while the proximal step in Line 7 becomes

$$v_{k+1} = \operatorname*{argmin}_{v \in \mathbb{R}^n} \left\{ f_2(v) + \langle \widetilde{v}_k, v \rangle + \frac{\gamma_k + \mu_f \alpha_k}{2\alpha_k} \left\| v - v_k \right\|_R^2 \right\}.$$
(59)

Lemma 6.1. Let $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}^2_+$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathbb{Z}$ be generated by Algorithm 2. It holds that

$$\mathbb{I}_{21} + \mathbb{I}_{22} \le -\alpha_k \left\langle A^\top (w_k - \hat{y}), v_{k+1} - \hat{x} \right\rangle - \gamma_k D_\phi(v_{k+1}, v_k) + \frac{L_f \alpha_k^2}{2(1 + \alpha_k)} \left\| v_{k+1} - v_k \right\|^2, \tag{60}$$

where \mathbb{I}_{21} and \mathbb{I}_{22} are defined in (17) with any $\hat{z} = (\hat{x}, \hat{y}) \in \operatorname{dom} \mathcal{L}$.

Proof. In view of (11) and (58a), it holds that

$$\mathbb{I}_{21} = f(x_{k+1}) - f(x_k) + \alpha_k \left(f(x_{k+1}) - f(\widehat{x}) \right) + \left\langle A^\top \widehat{y}, x_{k+1} - x_k \right\rangle + \alpha_k \left\langle A^\top \widehat{y}, x_{k+1} - \widehat{x} \right\rangle = f(x_{k+1}) - f(x_k) + \alpha_k \left(f(x_{k+1}) - f(\widehat{x}) \right) + \alpha_k \left\langle A^\top \widehat{y}, v_{k+1} - \widehat{x} \right\rangle.$$

Since $f = f_1 + f_2$, let us establish the upper bounds for f_1 and f_2 separately. By Assumption 3 and Lemma 2.2, we have

$$\alpha_{k} \left(f_{1}(x_{k+1}) - f_{1}(\widehat{x}) \right) + f_{1}(x_{k+1}) - f_{2}(x_{k}) \leq \alpha_{k} \left(\left\langle \nabla f_{1}(\bar{x}_{k}), x_{k+1} - \widehat{x} \right\rangle - \mu_{f} D_{\phi}(\widehat{x}, \bar{x}_{k}) + \frac{L_{f}}{2} \|x_{k+1} - \bar{x}_{k}\|^{2} \right) + \left\langle \nabla f_{1}(\bar{x}_{k}), x_{k+1} - x_{k} \right\rangle + \frac{L_{f}}{2} \|x_{k+1} - \bar{x}_{k}\|^{2} ^{\text{by (58a)}} = \alpha_{k} \left\langle \nabla f_{1}(\bar{x}_{k}), v_{k+1} - \widehat{x} \right\rangle - \mu_{f} \alpha_{k} D_{\phi}(\widehat{x}, \bar{x}_{k}) + \frac{L_{f}(1 + \alpha_{k})}{2} \|x_{k+1} - \bar{x}_{k}\|^{2}.$$
(61)

For the nonsmooth part f_2 , we use convexity to obtain

$$\begin{aligned} \alpha_k \left(f_2(x_{k+1}) - f_2(\widehat{x}) \right) + f_2(x_{k+1}) - f_2(x_k) \\ \stackrel{\text{by (58a)}}{=} & \alpha_k \left(f_2 \left(\frac{x_k + \alpha_k v_{k+1}}{1 + \alpha_k} \right) - f_2(\widehat{x}) \right) + f_2 \left(\frac{x_k + \alpha_k v_{k+1}}{1 + \alpha_k} \right) - f_2(x_k) \\ & \leq & \alpha_k \left(\frac{1}{1 + \alpha_k} f_2(x_k) + \frac{\alpha_k}{1 + \alpha_k} f_2(v_{k+1}) - f_2(\widehat{x}) \right) \\ & + \frac{1}{1 + \alpha_k} f_2(x_k) + \frac{\alpha_k}{1 + \alpha_k} f_2(v_{k+1}) - f_2(x_k) \\ & = & \alpha_k \left(f_2(v_{k+1}) - f_2(\widehat{x}) \right). \end{aligned}$$

Observing (58c), we find $p_{k+1} \in \partial f_2(v_{k+1})$, where

$$p_{k+1} := \gamma_k \frac{\nabla \phi(v_k) - \nabla \phi(v_{k+1})}{\alpha_k} + \mu_f(\nabla \phi(\bar{x}_k) - \nabla \phi(v_{k+1})) - \nabla f_1(\bar{x}_k) - A^\top w_k$$

Hence, it follows immediately that

$$\alpha_{k} \left(f_{2}(x_{k+1}) - f_{2}(\widehat{x}) \right) + f_{2}(x_{k+1}) - f_{2}(x_{k}) \leq \alpha_{k} \left\langle p_{k+1}, v_{k+1} - \widehat{x} \right\rangle$$

$$= \gamma_{k} \left\langle \nabla \phi(v_{k}) - \nabla \phi(v_{k+1}), v_{k+1} - \widehat{x} \right\rangle + \mu_{f} \alpha_{k} \left\langle \nabla \phi(\overline{x}_{k}) - \nabla \phi(v_{k+1}), v_{k+1} - \widehat{x} \right\rangle$$

$$- \alpha_{k} \left\langle \nabla f_{1}(\overline{x}_{k}) + A^{\mathsf{T}} w_{k}, v_{k+1} - \widehat{x} \right\rangle.$$
(62)

Applying Lemma 2.1 gives

$$\mu_f \alpha_k \left\langle \nabla \phi(\bar{x}_k) - \nabla \phi(v_{k+1}), v_{k+1} - \hat{x} \right\rangle = \mu_f \alpha_k \left(D_\phi(\hat{x}, \bar{x}_k) - D_\phi(\hat{x}, v_{k+1}) - D_\phi(v_{k+1}, \bar{x}_k) \right),$$

$$\gamma_k \left\langle \nabla \phi(v_k) - \nabla \phi(v_{k+1}), v_{k+1} - \hat{x} \right\rangle = \gamma_k \left(D_\phi(\hat{x}, v_k) - D_\phi(\hat{x}, v_{k+1}) - D_\phi(v_{k+1}, v_k) \right).$$

Combining this with (61) and (62), we get

$$\mathbb{I}_{21} \leq -\gamma_k D_{\phi}(v_{k+1}, v_k) + \frac{L_f(1+\alpha_k)}{2} \|x_{k+1} - \bar{x}_k\|^2 - \alpha_k \langle A^\top(w_k - \hat{y}), v_{k+1} - \hat{x} \rangle \\ -\mu_f \alpha_k D_{\phi}(v_{k+1}, \bar{x}_k) + \underbrace{\gamma_k D_{\phi}(\hat{x}, v_k) - (\gamma_k + \mu_f \alpha_k) D_{\phi}(\hat{x}, v_{k+1})}_{= -\mathbb{I}_{22}}.$$

In view of (58a) and the setting $\bar{x}_k = (x_k + \alpha_k v_k)/(1 + \alpha_k)$, we have $x_{k+1} - \bar{x}_k = \alpha_k (v_{k+1} - v_k)/(1 + \alpha_k)$. Since $\gamma_k + \mu_f \alpha_k = \gamma_{k+1}(1 + \alpha_k)$, we can move the second line to the left hand side to get (60). This completes the proof of this lemma.

Theorem 6.1. Let $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}^2_+$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathcal{Z}$ be generated by Algorithm 2. If $\beta_0 \geq \mu_g$ and $(L_f \beta_k + ||A||^2) \alpha_k^2 = (1 - \chi)^2 \gamma_k \beta_k$ with $\chi \in [0, 1)$, then it holds that

$$\mathcal{H}_{k+1}(\hat{z}) - \mathcal{H}_{k}(\hat{z}) + \alpha_{k} \mathcal{H}_{k+1}(\hat{z}) \leq -\chi \left(\frac{\beta_{k}}{2} \|w_{k+1} - w_{k}\|^{2} + \frac{\gamma_{k}}{2} \|v_{k+1} - v_{k}\|^{2}\right),$$
(63)

where $\mathcal{H}_k(\hat{z})$ is define by (16) with $\hat{z} = (\hat{x}, \hat{y})$ being a saddle point to (1).

Proof. Similar with Lemma 5.1, the lower bound $\eta_k \ge 1$ still holds true. Indeed, since $\beta_0 \ge \mu_g$, by (45) and (44), it follows that $\beta_k \ge \beta_{k+1} \ge \mu_g$ and

$$\eta_{k} = \frac{1 + \alpha_{k}}{\alpha_{k}} \alpha_{k+1} = \frac{1 + \alpha_{k}}{\alpha_{k}} \frac{\sqrt{(1 - \chi)\gamma_{k+1}\beta_{k+1}}}{\sqrt{L_{f}\beta_{k+1} + ||A||^{2}}} \ge \sqrt{1 - \chi} \frac{\sqrt{(\mu_{f}\alpha_{k} + \gamma_{k})(\mu_{g}\alpha_{k} + \beta_{k})}}{\alpha_{k}\sqrt{L_{f}\beta_{k} + ||A||^{2}}} = \sqrt{(1 + \mu_{f}\alpha_{k}/\gamma_{k})(1 + \mu_{g}\alpha_{k}/\beta_{k})} \ge 1.$$

Compared with (41), we see that (41b) = (58b) and (41d) = (58d). Also, both (41) and (58) share with the same settings in (42) and (43). Hence, we conclude that the estimate (49) leaves unchanged:

$$\mathbb{I}_{31} + \mathbb{I}_{32} \le \alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \hat{y}), w_{k+1} - \hat{y} \right\rangle - \beta_k D_{\psi}(w_{k+1}, w_k).$$

Collecting this with (17) and Lemma 6.1 yields that

$$\begin{aligned} &\mathcal{H}_{k+1}(\widehat{z}) - \mathcal{H}_{k}(\widehat{z}) + \alpha_{k} \mathcal{H}_{k+1}(\widehat{z}) \\ &\leq \Delta_{k} + \frac{L_{f} \alpha_{k}^{2}}{2(1+\alpha_{k})} \left\| v_{k+1} - v_{k} \right\|^{2} - \gamma_{k} D_{\phi}(v_{k}, v_{k+1}) - \beta_{k} D_{\psi}(w_{k}, w_{k+1}), \end{aligned} \tag{64}$$

where Δ_k is defined by (52) and can be further estimated as follows

$$\Delta_k \stackrel{\text{by}\,(42)}{=} \alpha_k \left\langle A(v_{k+1} - v_k), w_{k+1} - w_k \right\rangle$$

$$\leq \frac{(1-\chi)\beta_k}{2} \|w_{k+1} - w_k\|^2 + \frac{\|A\|^2 \alpha_k^2}{2\beta_k (1-\chi)} \|v_{k+1} - v_k\|^2.$$

Since $(L_f \beta_k + \left\|A\right\|^2) \alpha_k^2 = (1-\chi)^2 \gamma_k \beta_k$, we claim that

$$\frac{\|A\|^2}{\beta_k(1-\chi)} + \frac{L_f}{1+\alpha_k} \le \frac{\|A\|^2 + L_f \beta_k}{\beta_k(1-\chi)} = \frac{\gamma_k(1-\chi)}{\alpha_k^2},$$

which implies

$$\Delta_{k} + \frac{L_{f}\alpha_{k}^{2}}{2(1+\alpha_{k})} \left\| v_{k+1} - v_{k} \right\|^{2} \leq (1-\chi) \left(\frac{\beta_{k}}{2} \left\| w_{k+1} - w_{k} \right\|^{2} + \frac{\gamma_{k}}{2} \left\| v_{k+1} - v_{k} \right\|^{2} \right).$$

Plugging this into (64) leads to the desired result (63) and finishes the proof.

6.2 Convergence rate and iteration complexity

Theorem 6.2. Assume that $\{(x_k, y_k)\} \subset \operatorname{dom} \mathcal{L}$ is generated by Algorithm 2 with $(L_f \beta_k + ||A||^2) \alpha_k^2 = (1-\chi)^2 \gamma_k \beta_k$ and $\chi \in [0,1)$. Then we have

$$\begin{cases} \mathcal{L}(x_{k},\widehat{y}) - \mathcal{L}(\widehat{x},y_{k}) + \frac{\mu_{f}}{2} \|x_{k} - \widehat{x}\|^{2} + \frac{\mu_{g}}{2} \|y_{k} - \widehat{y}\|^{2} \leq 2\theta_{k}\mathcal{H}_{0}(\widehat{z}), \\ \sum_{i=0}^{k-1} \frac{\chi}{\theta_{i}} \left(\gamma_{i} \|v_{i+1} - v_{i}\|^{2} + \beta_{i} \|w_{i+1} - w_{i}\|^{2}\right) \leq 4\mathcal{H}_{0}(\widehat{z}), \end{cases}$$
(65)

where $\{\theta_k\}$ is defined by (20) and $\hat{z} = (\hat{x}, \hat{y})$ a saddle point to (1). Moreover, if $\gamma_0 \ge \mu_f$, $\beta_0 \ge \mu_g$ and $\gamma_0\beta_0 \le L_f\beta_0 + ||A||^2$, then we have two decay estimates for θ_k .

• If $\mu_f = \mu_g = 0$, then it holds that

$$\theta_k \le \frac{64\widehat{L_f}}{\gamma_0 k^2} + \frac{4\|\widehat{A}\|}{\sqrt{\gamma_0 \beta_0 k}},\tag{66}$$

where $\widehat{L_f} = L_f / (1 - \chi)^2$ and $\widehat{A} = A / (1 - \chi)^2$.

• If $\mu_f + \mu_g > 0$, then we have

$$\theta_k \le \min\left\{ \exp\left(-\frac{(1-\chi)k}{4\sqrt{\kappa_{f_1}}}\right) + \frac{64\|\widehat{A}\|^2}{\mu_f \beta_0 k^2}, \frac{64\widehat{L_f}}{\gamma_0 k^2} + \frac{64\|\widehat{A}\|^2}{\mu_g \gamma_0 k^2} \right\},\tag{67}$$

where $\kappa_{f_1} = L_f/\mu_f$.

• If $\mu_f \mu_g > 0$, then

$$\theta_k \le \left(1 + \frac{1 - \chi}{\sqrt{\kappa_P + \kappa_{f_1}}}\right)^{-k},\tag{68}$$

where $\kappa_P = \left\|A\right\|^2 / (\mu_f \mu_g)$.

Proof. Since $||A||^2 \alpha_k^2 \leq \gamma_k \beta_k$ (cf. Line 2 of Algorithm 2), applying Lemma 2.5 and Theorem 6.1 proves (65). Let us establish the decay rate of θ_k , which satisfies the difference equation (21). By (44), we have $\gamma_k \leq \gamma_0$ and $\beta_k \leq \beta_0$ and thus

$$\alpha_k = \frac{(1-\chi)\sqrt{\gamma_k\beta_k}}{\sqrt{L_f\beta_k + \|A\|^2}} = \frac{\sqrt{\gamma_k\beta_k}}{\sqrt{\widehat{L_f}\beta_k + \|\widehat{A}\|^2}} \le \frac{\sqrt{\gamma_0\beta_0}}{\sqrt{L_f\beta_0 + \|A\|^2}} \le 1.$$

Similarly with the proof of (57), according to the lower bounds of γ_k and β_k , we consider four scenarios.

(i) Firstly, for $\alpha_k \ge \sqrt{\gamma_0 \beta_0} \theta_k / \sqrt{\widehat{L_f} \beta_0 \theta_k + \|\widehat{A}\|^2}$, we have

$$\theta_{k+1} - \theta_k \stackrel{\text{by (21)}}{\leq} - \frac{\sqrt{\gamma_0 \beta_0} \theta_k \theta_{k+1}}{\sqrt{\widehat{L_f} \beta_0 \theta_k} + \|\widehat{A}\|^2} \stackrel{\text{by Lemma C.1}}{\Longrightarrow} \theta_k \leq \frac{64\widehat{L_f}}{\gamma_0 k^2} + \frac{4\|\widehat{A}\|}{\sqrt{\gamma_0 \beta_0} k}.$$

(ii) Secondly, for $\alpha_k \ge \sqrt{\mu_f \beta_0 \theta_k} / \sqrt{\widehat{L_f \beta_0 \theta_k} + \|\widehat{A}\|^2}$, it follows from (21) that

$$\theta_{k+1} - \theta_k \le -\frac{\sqrt{\mu_f \beta_0 \theta_k} \theta_{k+1}}{\sqrt{\widehat{L_f} \beta_0 \theta_k} + \|\widehat{A}\|^2} \stackrel{\text{by Lemma C.1}}{\Longrightarrow} \theta_k \le \exp\left(-\frac{k}{4}\sqrt{\frac{\mu_f}{\widehat{L_f}}}\right) + \frac{64\|\widehat{A}\|^2}{\mu_f \beta_0 k^2}.$$

(iii) Thirdly, for $\alpha_k \ge \sqrt{\mu_g \gamma_0 \theta_k} / \sqrt{\widehat{L_f} \mu_g + \|\widehat{A}\|^2}$, applying Lemma C.1 once gain gives

$$\theta_{k+1} - \theta_k \stackrel{\text{by (21)}}{\leq} - \frac{\sqrt{\mu_g \gamma_0 \theta_k} \theta_{k+1}}{\sqrt{\widehat{L_f} \mu_g + \|\widehat{A}\|^2}} \stackrel{\text{by Lemma C.1}}{\Longrightarrow} \theta_k \leq \frac{64\widehat{L_f}}{\gamma_0 k^2} + \frac{64\|\widehat{A}\|^2}{\mu_g \gamma_0 k^2}$$

(iv) Finally, for $\alpha_k \ge \sqrt{\mu_f \mu_g} / \sqrt{\widehat{L_f} \mu_g + \|\widehat{A}\|^2}$, it follows from (20) that

$$\theta_k \le \left(1 + \frac{\sqrt{\mu_f \mu_g}}{\sqrt{\widehat{L_f} \mu_g + \|\widehat{A}\|^2}}\right)^{-r}$$

Note that the above four estimates hold simultaneously for θ_k . Particularly, the first one (i) proves (67) and combining the second (ii) and the third (iii) implies (67), and the last one gives (68). This finishes the proof of this theorem.

Similarly with the discussion in Remark 5.2, from Theorem 6.2 we have fast convergence results on $\{v_{k+1} - v_{k+1}\}$ v_k and $\{w_{k+1} - w_k\}$. Besides, we claim that Algorithm 2 admits the optimal iteration complexity [64, 81]. Specifically, to obtain $\mathcal{L}(x_k, \hat{y}) - \mathcal{L}(\hat{x}, y_k) \leq \epsilon$, the iteration complexity is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\epsilon} + \frac{\sqrt{L_f}}{\epsilon}, \frac{\|A\|}{\sqrt{\mu_f \epsilon}} + \sqrt{\kappa_{f_1}} \left|\ln\epsilon\right|, \frac{\|A\|}{\sqrt{\mu_g \epsilon}} + \frac{\sqrt{L_f}}{\epsilon}, \sqrt{\kappa_P} \left|\ln\epsilon\right|\right\}\right).$$

When $\mu_f > 0$, the iteration complexity for finding $||x_k - \hat{x}||^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_f\sqrt{\epsilon}}, \sqrt{\kappa_P}\left|\ln\frac{\mu_f}{\epsilon}\right|\right\} + \sqrt{\kappa_{f_1}}\left|\ln\frac{\mu_f}{\epsilon}\right|\right)$$

When $\mu_g > 0$, the iteration complexity for finding $\|y_k - \hat{y}\|^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_g\sqrt{\epsilon}} + \sqrt{\frac{L_f}{\mu_g\epsilon}}, \sqrt{\kappa_P + \kappa_{f_1}} \left|\ln\frac{\mu_g}{\epsilon}\right|\right\}\right).$$

7 A Symmetric ABPD-PGS Method

In this part, we following the last section and further consider the case that both f and q possess the smooth + nonsmooth composite structure.

Assumption 4. $f = f_1 + f_2$ where f_1 is $C^1_{L_f}$ -smooth and relatively strongly convex w.r.t. ϕ with $\mu_f \ge 0$. $g = g_1 + g_2$ where g_1 is $C_{L_g}^1$ -smooth and relatively strongly convex w.r.t. ψ with $\mu_g \ge 0$.

Algorithm presentation and Lyapunov analysis 7.1

We propose a symmetric version of the previous SIE scheme (58):

$$\sum_{k=1}^{N} \frac{x_{k+1} - x_k}{\alpha_k} = v_{k+1} - x_{k+1},$$
(69a)

$$\begin{cases} \frac{y_{k+1} - y_k}{\alpha_k} = \eta_k (w_{k+1} - y_{k+1}), \\ \gamma_k \frac{\nabla \phi(v_{k+1}) - \nabla \phi(v_k)}{\alpha_k} \in \mu_f (\nabla \phi(\bar{x}_k) - \nabla \phi(v_{k+1})) - \mathcal{F}(\bar{x}_k, w_k, v_{k+1}), \end{cases}$$
(69b)

$$\gamma_k \frac{\nabla \phi(v_{k+1}) - \nabla \phi(v_k)}{\alpha_k} \in \mu_f(\nabla \phi(\bar{x}_k) - \nabla \phi(v_{k+1})) - \mathcal{F}(\bar{x}_k, w_k, v_{k+1}),$$
(69c)

$$\beta_k \frac{\nabla \psi(w_{k+1}) - \nabla \psi(w_k)}{\alpha_k} \in \mu_g(\nabla \psi(\bar{y}_k) - \nabla \psi(w_{k+1})) - \eta_k \mathcal{G}(\bar{y}_k, \bar{v}_{k+1}, w_{k+1}), \tag{69d}$$

where η_k and \bar{v}_{k+1} are defined by (42) and

$$\mathcal{F}(\bar{x}_k, w_k, v_{k+1}) = \nabla f_1(\bar{x}_k) + \partial f_2(v_{k+1}) + A^\top w_k, \quad \bar{x}_k = \frac{x_k + \alpha_k v_k}{1 + \alpha_k},$$
$$\mathcal{G}(\bar{y}_k, \bar{v}_{k+1}, w_{k+1}) = \nabla g_1(\bar{y}_k) + \partial g_2(w_{k+1}) - A\bar{v}_{k+1}, \quad \bar{y}_k = \frac{y_k + \eta_k \alpha_k w_k}{1 + \eta_k \alpha_k}.$$

Similarly with (58), the parameter updating relation (43) leaves unchanged.

We take the step size $\alpha_k^2(L_f\beta_k + L_g\gamma_k + ||A||^2) = \gamma_k\beta_k$ and rearrange (69) as a primal-dual proximal gradient splitting method and list it below in Algorithm 3, which is called the Symmetric Accelerated Bregman Primal-Dual Proximal Gradient Splitting (Symmetric ABPD-PGS for short).

Remark 7.1. As discussed in Remark 6.1, when we choose (53), the subproblems in Algorithm 3 reduce to standard preconditioned proximal steps. In this case, the inner problem in Line 7 agrees with (59) and the proximal problem in Line 11 becomes

$$w_{k+1} = \operatorname*{argmin}_{w \in \mathbb{R}^m} \left\{ g_2(w) + \langle \nabla g_1(\bar{y}_k) - A\bar{v}_{k+1} - \widetilde{w}_k, w \rangle + \frac{\beta_k + \mu_g \alpha_k}{2\alpha_k \eta_k} \left\| w - w_k \right\|_S^2 \right\}.$$

Lemma 7.1. Let $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}^2_+$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathbb{Z}$ be generated by Algorithm 3. If $\gamma_0 \geq \mu_f$ and $\beta_0 \geq \mu_g$, then we have

$$\mathbb{I}_{31} + \mathbb{I}_{32} \le \alpha_k \eta_k \left\langle A(\bar{v}_{k+1} - \hat{x}), w_{k+1} - \hat{y} \right\rangle - \beta_k D_{\psi}(w_{k+1}, w_k) + \frac{L_g \alpha_k^2 \eta_k^2}{2(1 + \alpha_k \eta_k)} \left\| w_{k+1} - w_k \right\|^2, \tag{70}$$

where \mathbb{I}_{31} and \mathbb{I}_{32} are defined in (17) with $\hat{z} = (\hat{x}, \hat{y})$ being a saddle point to (1).

Proof. By Lemma 2.3 (ii) we have $\widehat{g}(y_{k+1}; \widehat{z}) \ge g(\widehat{y})$. Since $\alpha_k^2(L_f\beta_k + L_g\gamma_k + \|A\|^2) = \gamma_k\beta_k$, using (45)

gives

$$\eta_{k} = \frac{1 + \alpha_{k}}{\alpha_{k}} \alpha_{k+1} = \frac{1 + \alpha_{k}}{\alpha_{k}} \frac{\sqrt{\gamma_{k+1}\beta_{k+1}}}{\sqrt{L_{f}\beta_{k+1} + L_{g}\gamma_{k+1} + \|A\|^{2}}}$$
$$\geq \frac{\sqrt{(\gamma_{k} + \mu_{f}\alpha_{k})(\beta_{k} + \mu_{g}\alpha_{k})}}{\alpha_{k}\sqrt{L_{f}\beta_{k} + L_{g}\gamma_{k} + \|A\|^{2}}} = \sqrt{(1 + \mu_{f}\alpha_{k}/\gamma_{k})(1 + \mu_{g}\alpha_{k}/\beta_{k})} \geq 1$$

Above, we used the monotone relations $\gamma_k \ge \gamma_{k+1}$ and $\beta_k \ge \beta_{k+1}$, which holds true by (44) and our assumption: $\gamma_0 \ge \mu_f$ and $\beta_0 \ge \mu_g$. Following the proof of Lemma 6.1, we shall split $g = g_1 + g_2$ into two parts. For the sake of completeness, we provide the detailed proof in Appendix B.

Theorem 7.1. Let $\{\Theta_k = (\gamma_k, \beta_k)\} \subset \mathbb{R}^2_+$ and $\{Z_k = (x_k, v_k, y_k, w_k)\} \subset \mathcal{Z}$ be generated by Algorithm 3. If $\gamma_0 \geq \mu_f$ and $\beta_0 \geq \mu_g$, then we have

$$\mathcal{H}_{k+1}(\hat{z}) - \mathcal{H}_k(\hat{z}) + \alpha_k \mathcal{H}_{k+1}(\hat{z}) \le 0, \tag{71}$$

where $\mathcal{H}_k(\hat{z})$ is define by (16) with $\hat{z} = (\hat{x}, \hat{y})$ being a saddle point to (1).

Proof. Compared with (58), we see that (58a) = (69a) and (58c) = (69c). Also, both (58) and (69) adopt the same templates (42) and (43). Thus, we conclude that the estimate (60) still holds true:

$$\mathbb{I}_{21} + \mathbb{I}_{22} \le -\alpha_k \left\langle A^\top (w_k - \hat{y}), v_{k+1} - \hat{x} \right\rangle - \gamma_k D_\phi(v_{k+1}, v_k) + \frac{L_f \alpha_k^2}{2(1 + \alpha_k)} \|v_{k+1} - v_k\|^2,$$

Combining this with (17) and Lemma 7.1 gives

$$\begin{aligned} \mathcal{H}_{k+1}(\hat{z}) - \mathcal{H}_{k}(\hat{z}) + \alpha_{k}\mathcal{H}_{k+1}(\hat{z}) &\leq \frac{L_{f}\alpha_{k}^{2}}{2(1+\alpha_{k})} \left\| v_{k+1} - v_{k} \right\|^{2} + \frac{L_{g}\alpha_{k}^{2}\eta_{k}^{2}}{2(1+\alpha_{k}\eta_{k})} \left\| w_{k+1} - w_{k} \right\|^{2} \\ &+ \Delta_{k} - \gamma_{k}D_{\phi}(v_{k}, v_{k+1}) - \beta_{k}D_{\psi}(w_{k}, w_{k+1}), \end{aligned}$$

where Δ_k is the same as (52) and is equivalent to $\Delta_k = \alpha_k \langle A(v_{k+1} - v_k), w_{k+1} - w_k \rangle$. Since ϕ and ψ are 1-strongly convex, we obtain that

$$\mathcal{H}_{k+1}(\widehat{z}) - \mathcal{H}_k(\widehat{z}) + \alpha_k \mathcal{H}_{k+1}(\widehat{z}) \le -\frac{1}{2} \left\langle Q(v_{k+1} - v_k), w_{k+1} - w_k \right\rangle,$$

where

$$Q = \begin{pmatrix} \frac{\gamma_k (1+\alpha_k) - L_f \alpha_k^2}{1+\alpha_k} I & -\alpha_k A^\top \\ -\alpha_k A & \frac{\beta_k (1+\eta_k \alpha_k) - L_g \eta_k^2 \alpha_k^2}{1+\eta_k \alpha_k} I \end{pmatrix}$$

According to our choice $\gamma_k \beta_k = \alpha_k^2 \left(\|A\|^2 + L_f \beta_k + L_g \gamma_k \right)$, a direct calculation verifies that Q is positive semidefinite. This yields (71) and concludes the proof.

7.2 Convergence rate and iteration complexity

Theorem 7.2. Let $\{(x_k, y_k)\} \subset \operatorname{dom} f \times \operatorname{dom} g$ be generated by Algorithm 3. We have

$$\mathcal{L}(x_k, \widehat{y}) - \mathcal{L}(\widehat{x}, y_k) + \frac{\mu_f}{2} \left\| x_k - \widehat{x} \right\|^2 + \frac{\mu_g}{2} \left\| y_k - \widehat{y} \right\|^2 \le 2\theta_k \mathcal{H}_0(\widehat{z}),$$
(72)

where $\{\theta_k\}$ is defined by (20) and $\hat{z} = (\hat{x}, \hat{y})$ a saddle point to (1). If $\gamma_0 \ge \mu_f$, $\beta_0 \ge \mu_g$ and $\gamma_0\beta_0 \le L_f\beta_0 + L_g\gamma_0 + \|A\|^2$, then we have two decay estimates of θ_k .

• If $\mu_f = \mu_g = 0$, then

$$\theta_k \le \frac{64L_f}{\gamma_0 k^2} + \frac{64L_g}{\beta_0 k^2} + \frac{4\|A\|}{\sqrt{\gamma_0 \beta_0 k}}.$$
(73)

• *If* $\mu_f + \mu_g > 0$, then

$$\theta_k \le \min\left\{ \exp\left(-\frac{k}{4\sqrt{\kappa_{f_1}}}\right) + \frac{64L_g}{\beta_0 k^2} + \frac{64\|A\|^2}{\mu_f \beta_0 k^2}, \exp\left(-\frac{k}{4\sqrt{\kappa_{g_1}}}\right) + \frac{64L_f}{\gamma_0 k^2} + \frac{64\|A\|^2}{\mu_g \gamma_0 k^2} \right\},$$
(74)

where $\kappa_{f_1} = L_f/\mu_f$ and $\kappa_{g_1} = L_g/\mu_g$.

• If $\mu_f \mu_g > 0$, then

$$\theta_k \le \left(1 + \frac{1}{\sqrt{\kappa_P + \kappa_{f_1} + \kappa_{g_1}}}\right)^{-k},\tag{75}$$

where $\kappa_P = \left\|A\right\|^2 / (\mu_f \mu_g)$.

Proof. Applying Lemma 2.5 and Theorem 7.1 proves (72). Recall the relation (21) for the sequence $\{\theta_k\}$. According to the lower bound of α_k , we consider four cases:

(i) Firstly, for $\alpha_k \ge \sqrt{\gamma_0 \beta_0} \theta_k / \sqrt{(L_f \beta_0 + L_g \gamma_0) \theta_k + \|A\|^2}$, it follows from (21) and Lemma C.1 that $64(L_f \beta_0 + L_f \gamma_0) = 4\|A\|$

$$\theta_k \le \frac{64(L_f\beta_0 + L_g\gamma_0)}{\gamma_0\beta_0k^2} + \frac{4\|A\|}{\sqrt{\gamma_0\beta_0k}}$$

(ii) Secondly, for $\alpha_k \ge \sqrt{\mu_f \beta_0 \theta_k} / \sqrt{L_f \beta_0 \theta_k + L_g \mu_f + \|A\|^2}$, we obtain

$$\theta_k \le \exp\left(-\frac{k}{4}\sqrt{\frac{\mu_f}{L_f}}\right) + \frac{64(L_g\mu_f + ||A||^2)}{\mu_f\beta_0k^2},$$

(iii) Thirdly, for $\alpha_k \ge \sqrt{\mu_g \gamma_0 \theta_k} / \sqrt{L_g \gamma_0 \theta_k + L_f \mu_g + \|A\|^2}$, applying Lemma C.1 again yields

$$\theta_k \le \exp\left(-\frac{k}{4}\sqrt{\frac{\mu_g}{L_g}}\right) + \frac{64(L_f\mu_g + ||A||^2)}{\mu_g\gamma_0k^2}$$

(iv) Finally, for $\alpha_k \ge \sqrt{\mu_f \mu_g} / \sqrt{L_f \mu_g + L_g \mu_f + \|A\|^2}$, we obtain from (20) that

$$\theta_k \le \left(1 + \frac{\sqrt{\mu_f \mu_g}}{\sqrt{L_f \mu_g + L_g \mu_f + \|A\|^2}}\right)^{-k}.$$

Collection the above four estimates finishes the proof.

Thanks to Theorem 7.2, our Algorithm 3 also achieves the optimal iteration complexity [64, 81] under the *pure first-order algorithm class* [81, Definition 2.2]. That is, to get $\mathcal{L}(x_k, \hat{y}) - \mathcal{L}(\hat{x}, y_k) \leq \epsilon$, the iteration complexity is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\epsilon} + \sqrt{\frac{L_f + L_g}{\epsilon}}, \frac{\|A\|}{\sqrt{\mu_f \epsilon}} + \sqrt{\frac{L_g}{\epsilon}} + \sqrt{\kappa_{f_1}} \left|\ln\epsilon\right|, \frac{\|A\|}{\sqrt{\mu_g \epsilon}} + \sqrt{\frac{L_f}{\epsilon}} + \sqrt{\kappa_{g_1}} \left|\ln\epsilon\right|, \sqrt{\kappa_P + \kappa_{f_1} + \kappa_{g_1}} \left|\ln\epsilon\right|\right\}\right)$$

When $\mu_f > 0$, the iteration complexity for finding $||x_k - \hat{x}||^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_f\sqrt{\epsilon}}+\sqrt{\frac{L_g}{\mu_f\epsilon}},\sqrt{\kappa_P+\kappa_{g_1}}\left|\ln\frac{\mu_f}{\epsilon}\right|\right\}+\sqrt{\kappa_{f_1}}\left|\ln\frac{\mu_f}{\epsilon}\right|\right).$$

When $\mu_g > 0$, the iteration complexity for finding $\|y_k - \hat{y}\|^2 \le \epsilon$ is

$$\mathcal{O}\left(\min\left\{\frac{\|A\|}{\mu_g\sqrt{\epsilon}}+\sqrt{\frac{L_f}{\mu_g\epsilon}},\sqrt{\kappa_P+\kappa_{f_1}}\left|\ln\frac{\mu_g}{\epsilon}\right|\right\}+\sqrt{\kappa_{g_1}}\left|\ln\frac{\mu_g}{\epsilon}\right|\right).$$

8 Conclusion

In this work, we start with the spectral analysis of a quadratic game and show that a *naive* application of the unconstrained model (27) to saddle-point problems does not work. We then propose a new template model (28) and prove its stability and improved spectral radius that matches the theoretical optimal convergence rate. After that, we combine general Bregman distances with proper time rescaling parameters and present two novel continuous models called APDG flow (34) and ABPDG flow (38), for which the exponential convergence of the Lagrange gap along the continuous trajectory is established via a compact Lyapunov analysis.

Based on the ABPDG flow, we consider three SIE time discretizations and obtain three first-order primaldual splitting methods for solving the convex-concave saddle-point problem (1), as summarized in Algorithms 1, 2 and 3. By using careful discrete Lyapunov analysis, we establish the optimal convergence rate of the Lagrange gap with sharp dependence on the Lipschitz and convexity constants. This also matches the theoretical lower iteration complexity bound of first-order primal-dual methods.

A Spectral Analysis

A.1 Analysis of the explicit Euler scheme (26)

Let $\mathcal{Q}(\alpha) := I - \alpha \mathcal{Q}$ with $\alpha > 0$. For any $\lambda \in \sigma(\mathcal{Q}(\alpha))$, we have

$$\left|\lambda\right|^{2} = [1 - \alpha \Re(\delta))]^{2} + \alpha^{2} \Im(\delta)^{2} = \left|\delta\right|^{2} \alpha^{2} - 2\Re(\delta)\alpha + 1,$$

for some $\delta \in \sigma(\mathcal{Q})$. It is not hard to see $\delta = \mu \pm i\sqrt{\tau}$ with $\tau \in \sigma(AA^{\top})$. This leads to

$$\left|\lambda\right|^{2} = \left(\mu^{2} + \tau\right)\alpha^{2} - 2\mu\alpha + 1.$$

As a function of τ , $|\lambda(\tau)|$ is nondecreasing and it follows that

$$\rho(\mathcal{Q}(\alpha)) = \max_{\tau \in \sigma(AA^{\top})} |\lambda(\tau)| = \sqrt{\left(\mu^2 + \|A\|^2\right)\alpha^2 - 2\mu\alpha + 1},$$

which implies $\rho(\mathcal{Q}(\alpha)) < 1 \iff 0 < \alpha < \alpha_0 := 2\mu/(\mu^2 + ||A||^2)$. Additionally, the minimal spectral radius is

$$\min_{\alpha \in (0,\alpha_0)} \rho(\mathcal{Q}(\alpha)) = \sqrt{1 - \frac{\mu^2}{\mu^2 + \|A\|^2}} \le 1 - \frac{\mu^2}{2\mu^2 + 2\|A\|^2} = \mathcal{O}(1 - \mu^2 / \|A\|^2).$$

with optimal step size $\alpha_{opt} = \alpha_0/2 = \mu/(\mu^2 + ||A||^2)$. With the scaling $\mathcal{Q} = \mathcal{Q}/\mu$, the minimal spectral radius $\mathcal{O}(1 - \mu^2/||A||^2)$ leaves invariant but we obtain $\alpha_{opt} = \mu^2/(\mu^2 + ||A||^2) = \mathcal{O}(\mu^2/||A||^2)$.

A.2 Proof of Theorem 3.1

Let us first look at the structure of \mathcal{G}_{new} (cf.(29)):

$$\mathcal{G}_{\text{new}} = \begin{pmatrix} -I & O & I & O \\ O & -I & O & I \\ O & O & -I & -A^{\top}/\mu \\ O & O & A/\mu & -I \end{pmatrix}.$$

A key property is that $\mathcal{G}_{\mathrm{new}}$ can be transferred into a block tridiagonal matrix

$$\mathcal{P}\mathcal{G}_{\text{new}}\mathcal{P}^{\top} = \begin{pmatrix} -I & I & O & O \\ O & -I & A/\mu & O \\ O & -A^{\top}/\mu & -I & O \\ O & O & I & -I \end{pmatrix}, \text{ with } \mathcal{P} = \begin{pmatrix} O & I & O & O \\ O & O & O & I \\ O & O & I & O \\ I & O & O & O \end{pmatrix}.$$

Note that \mathcal{P} is a permutation matrix and $\mathcal{G}_{new} = -I + \mathcal{L} + \mathcal{U}$, where \mathcal{L} and \mathcal{U} are respectively the strictly lower triangular part and upper triangular part. According to [77, Chapter 4.1], we find that $\mathcal{L} + \mathcal{U}$ is consistently ordered, weakly cyclic of index 2, which yields the spectrum relation

$$\sigma(\mathcal{L} + \mathcal{U}) = \sigma\left(\alpha \mathcal{L} + \mathcal{U}/\alpha\right), \quad \forall \, \alpha \in \mathbb{C} \setminus \{0\}.$$

Moreover, by [77, Theorem 4.4], we have

$$\det\left(\gamma I - \alpha \mathcal{L} - \beta \mathcal{U}\right) = \det\left(\gamma I - \sqrt{\alpha \beta} \left(\mathcal{L} + \mathcal{U}\right)\right), \quad \forall \gamma, \alpha, \beta \in \mathbb{C}.$$
(76)

We then compute the eigenvalues of $\widehat{\mathcal{G}} = \left[(1+\alpha)I - \alpha \mathcal{L}\right]^{-1} (I + \alpha \mathcal{U})$. For any $\lambda \in \sigma(\widehat{\mathcal{G}})$, it holds that

$$0 = \det\left(\lambda I - \widehat{\mathcal{G}}\right) = \det\left[((1+\alpha)\lambda - 1)I - \alpha\lambda\mathcal{L} - \alpha\mathcal{U}\right]$$

In view of (76), we obtain

$$0 = \det \left[\left((1+\alpha)\lambda - 1 \right) I - \alpha \sqrt{\lambda} \left(\mathcal{L} + \mathcal{U} \right) \right]$$
$$= \det \left[\left((1+\alpha)\lambda - \alpha \sqrt{\lambda} - 1 \right) I - \alpha \sqrt{\lambda} \mathcal{G}_{\text{new}} \right]$$

From this we claim that $\lambda \neq 0$. Then it follows

$$(1+\alpha)\lambda - \alpha(1+\tau)\sqrt{\lambda} - 1 = 0, \quad \tau \in \sigma(\mathcal{G}_{new}).$$
 (77)

By (30), we have either $\tau = -1$ or $\tau = -1 \pm i\sqrt{\delta}/\mu$, with $\delta \in \sigma(A^{\top}A)$. If $\tau = -1$, then $\lambda = (1 + \alpha)^{-1}$. Otherwise, (77) becomes

$$(1+\alpha)\lambda \pm i\frac{\alpha\sqrt{\delta}}{\mu}\sqrt{\lambda} - 1 = 0 \quad \iff \quad (1+\alpha)\lambda - 1 = \pm i\frac{\alpha\sqrt{\delta}}{\mu}\sqrt{\lambda}.$$

This further implies that $\lambda \in \sigma(\widehat{\mathcal{G}})$ satisfies the quadratic equation (with real coefficients)

$$(1+\alpha)^2 \lambda^2 + (\delta \alpha^2 / \mu^2 - 2(1+\alpha))\lambda + 1 = 0.$$
(78)

Since $\alpha \leq 2\mu/||A|| \leq 2\mu/\sqrt{\delta}$ for any $\delta \in \sigma(A^{\top}A)$, we find that

$$\tau = \delta^2 \alpha^4 / \mu^4 - 4\delta(1+\alpha)\alpha^2 / \mu^2 = \frac{\delta\alpha^2}{\mu^2} \left(\frac{\delta\alpha^2}{\mu^2} - 4(1+\alpha)\right) \le 0.$$

Hence, the quadratic equation (78) has two complex roots and thus by Vieta's theorem, we get $|\lambda| = (1 + \alpha)^{-1}$. This implies $\rho(\hat{\mathcal{G}}) = (1 + \alpha)^{-1}$ and completes the proof of Theorem 3.1.

B Proof of Lemma 7.1

The proof is almost in line with that of Lemma 6.1 but with subtle difference for handling the perturbation η_k in (69b) and (69d). By (11) and (69b) and Lemma 2.3 (ii), it is clear that

$$\begin{split} \mathbb{I}_{31} &= \widehat{g}(y_{k+1}; \widehat{z}) - \widehat{g}(y_k; \widehat{z}) + \alpha_k \left(\widehat{g}(y_{k+1}; \widehat{z}) - g(\widehat{y}) \right) \\ &\leq \widehat{g}(y_{k+1}; \widehat{z}) - \widehat{g}(y_k; \widehat{z}) + \alpha_k \eta_k \left(\widehat{g}(y_{k+1}; \widehat{z}) - g(\widehat{y}) \right) \\ &= g(y_{k+1}) - g(y_k) + \alpha_k \eta_k \left(g(y_{k+1}) - g(\widehat{y}) \right) - \langle A \widehat{x}, y_{k+1} - y_k \rangle - \alpha_k \eta_k \left\langle A \widehat{x}, y_{k+1} - \widehat{y} \right\rangle \\ &= g(y_{k+1}) - g(y_k) + \alpha_k \eta_k \left(g(y_{k+1}) - g(\widehat{y}) \right) - \alpha_k \eta_k \left\langle A \widehat{x}, w_{k+1} - \widehat{y} \right\rangle. \end{split}$$

In the following, we consider g_1 and g_2 subsequently. By Lemma 2.2 and (69b), we have

$$\alpha_{k}\eta_{k}\left(g_{1}(y_{k+1}) - g_{1}(\widehat{y})\right) + g_{1}(y_{k+1}) - g_{2}(y_{k}) \\
\leq \alpha_{k}\eta_{k}\left(\left\langle \nabla g_{1}(\bar{y}_{k}), y_{k+1} - \widehat{y} \right\rangle - \mu_{g}D_{\psi}(\widehat{y}, \bar{y}_{k}) + \frac{L_{g}}{2} \left\| y_{k+1} - \bar{y}_{k} \right\|^{2} \right) \\
+ \left\langle \nabla g_{1}(\bar{y}_{k}), y_{k+1} - y_{k} \right\rangle + \frac{L_{g}}{2} \left\| y_{k+1} - \bar{y}_{k} \right\|^{2} \\
= \alpha_{k}\eta_{k}\left\langle \nabla g_{1}(\bar{y}_{k}), w_{k+1} - \widehat{y} \right\rangle - \mu_{g}\alpha_{k}\eta_{k}D_{\psi}(\widehat{y}, \bar{y}_{k}) + \frac{L_{g}(1 + \alpha_{k}\eta_{k})}{2} \left\| y_{k+1} - \bar{y}_{k} \right\|^{2}.$$
(79)

On the other hand, it follows that

$$\begin{aligned} \alpha_k \eta_k \left(g_2(y_{k+1}) - g_2(\widehat{y}) \right) + g_2(y_{k+1}) - g_2(y_k) \\ \stackrel{\text{by (69b)}}{=} & \alpha_k \eta_k \left(g_2 \left(\frac{y_k + \alpha_k \eta_k w_{k+1}}{1 + \alpha_k \eta_k} \right) - g_2(\widehat{y}) \right) + g_2 \left(\frac{y_k + \alpha_k \eta_k w_{k+1}}{1 + \alpha_k \eta_k} \right) - g_2(y_k) \\ & \leq \alpha_k \eta_k \left(\frac{1}{1 + \alpha_k \eta_k} g_2(y_k) + \frac{\alpha_k \eta_k}{1 + \alpha_k \eta_k} g_2(w_{k+1}) - g_2(\widehat{y}) \right) \\ & + \frac{1}{1 + \alpha_k \eta_k} g_2(y_k) + \frac{\alpha_k \eta_k}{1 + \alpha_k \eta_k} g_2(w_{k+1}) - g_2(y_k) \\ & = \alpha_k \eta_k \left(g_2(w_{k+1}) - g_2(\widehat{y}) \right). \end{aligned}$$

Observing (69d), we find $q_{k+1} \in \partial g_2(w_{k+1})$, where

$$q_{k+1} := \frac{1}{\eta_k} \left[\beta_k \frac{\nabla \psi(w_k) - \nabla \psi(w_{k+1})}{\alpha_k} + \mu_g(\nabla \psi(\bar{y}_k) - \nabla \psi(w_{k+1})) \right] - \nabla g_1(\bar{y}_k) + A\bar{v}_{k+1}.$$

Hence, we obtain

$$\alpha_k \eta_k \left(g_2(y_{k+1}) - g_2(\widehat{y}) \right) + g_2(y_{k+1}) - g_2(y_k) \le \alpha_k \eta_k \left\langle q_{k+1}, w_{k+1} - \widehat{y} \right\rangle$$

= $\beta_k \left\langle \nabla \psi(w_k) - \nabla \psi(w_{k+1}), w_{k+1} - \widehat{y} \right\rangle + \mu_g \alpha_k \left\langle \nabla \psi(\overline{y}_k) - \nabla \psi(w_{k+1}), w_{k+1} - \widehat{y} \right\rangle$ (80)
 $- \alpha_k \eta_k \left\langle \nabla g_1(\overline{y}_k) - A\overline{v}_{k+1}, w_{k+1} - \widehat{y} \right\rangle.$

Invoking the tree-term identity (8) yields that

$$\begin{split} \mu_g \alpha_k \left\langle \nabla \psi(\bar{y}_k) - \nabla \psi(w_{k+1}), w_{k+1} - \widehat{y} \right\rangle &= \mu_g \alpha_k \left(D_\psi(\widehat{y}, \bar{y}_k) - D_\psi(\widehat{y}, w_{k+1}) - D_\psi(w_{k+1}, \bar{y}_k) \right), \\ \beta_k \left\langle \nabla \psi(w_k) - \nabla \psi(w_{k+1}), w_{k+1} - \widehat{y} \right\rangle &= \beta_k \left(D_\psi(\widehat{y}, w_k) - D_\psi(\widehat{y}, w_{k+1}) - D_\psi(w_{k+1}, w_k) \right). \end{split}$$

Combining these two estimates with (79) and (80) gives

$$\mathbb{I}_{31} \leq \underbrace{\beta_k D_{\psi}(\widehat{y}, w_k) - (\beta_k + \mu_f \alpha_k) D_{\psi}(\widehat{y}, w_{k+1})}_{= -\mathbb{I}_{32}} + \alpha_k \eta_k \langle A(\overline{v}_{k+1} - \widehat{x}), w_{k+1} - \widehat{y} \rangle$$

$$- \beta_k D_{\psi}(w_{k+1}, w_k) + \frac{L_g(1 + \alpha_k \eta_k)}{2} \|y_{k+1} - \overline{y}_k\|^2 - \mu_g \alpha_k D_{\psi}(w_{k+1}, \overline{y}_k).$$

Notice that by (69b) and the setting $\bar{y}_k = (y_k + \alpha_k \eta_k w_k)/(1 + \alpha_k \eta_k)$, we have $y_{k+1} - \bar{y}_k = \alpha_k \eta_k (w_{k+1} - w_k)/(1 + \alpha_k \eta_k)$. Since $\beta_k + \mu_g \alpha_k = \beta_{k+1}(1 + \alpha_k)$, we can move the first line to the left hand side to get (70). This completes the proof of Lemma 7.1.

C A Technical Estimate

We list a useful estimate of the positive sequence $\{\theta_k\}$ that satisfy

$$\theta_{k+1} - \theta_k \le -\frac{\theta_k^{\nu} \theta_{k+1}}{\sqrt{Q\theta_k + R^2}}, \quad \theta_0 = 1,$$
(81)

where Q > 0, $R \ge 0$ and $\nu \ge 1/2$. The detailed proof can be found in [52, Lemma C.2].

Lemma C.1 ([52]). Let $\{\theta_k\}$ be a positive real sequence satisfying (81). If $\theta_{k+1}/\theta_k \ge \delta > 0$ for $k \in \mathbb{N}$, then for all $k \ge 0$, it holds that

$$\theta_k \leq \begin{cases} \left(\frac{4\sqrt{Q}}{4\sqrt{Q}+\delta(2\nu-1)k}\right)^{\frac{2}{2\nu-1}} + \left(\frac{2R}{2R+\delta\nu k}\right)^{\frac{1}{\nu}}, & \text{if } \nu > 1/2, \\ \exp\left(-\frac{\delta k}{2\sqrt{Q}}\right) + \left(\frac{4R}{4R+\delta k}\right)^2, & \text{if } \nu = 1/2. \end{cases}$$
