# MALLIAVIN CALCULUS FOR THE ONE-DIMENSIONAL STOCHASTIC STEFAN PROBLEM

#### Abstract

We consider the one-dimensional outer stochastic Stefan problem with reflection which models the short-time prediction of the price or spread of one volatile asset traded in a financial market. The problem admits maximal solutions as long as the velocity of the moving boundary stays bounded, [3, 6, 7. We apply Malliavin calculus on the transformed equation and prove first that its maximal solution $u$ has continuous paths a.s. In the case of the unreflected problem, the previous enables localization of a proper approximating sequence of the maximal solution. Then, we derive there locally the differentiability of maximal $u$ in the Malliavin sense. The novelty of this work, apart from the derivation of continuity of the paths for the maximal solution with reflection, is that for the unreflected case we introduce a localization argument on maximal solutions and define efficiently the relevant sample space. More precisely, we present a methodology suitable for the proof of the expected local only (in the sample space) existence of the Malliavin derivative.


## 1. Introduction

1.1. The Stochastic Stefan problem. We consider two well separated phases $\Omega_{\text {Sol }}$ and $\Omega_{\text {Liq }}$, the solid and liquid phase respectively, occupying a static bounded domain $\Omega$ of $\mathbb{R}$ defined by the interval $\Omega:=(a, b)$. Let $\Omega_{\text {Sol }}(t):=\left(s^{-}(t), s^{+}(t)\right)$ be the solid phase at time $t$, then

We shall assume that the initial solid phase is in $\Omega$ and far from its boundary, i.e., that $\lambda \gg s^{+}(0)-s^{-}(0)$, for $\lambda:=b-a$ the length of $\Omega$.

The outer parabolic Stochastic Stefan problem is defined by

Here, $w=w(y, t)$ is a density, $\alpha>0$ is a positive constant, and $\sigma$ is a function of the distance of $y$ from the solid phase boundary, $\operatorname{dist}\left(y, \partial \Omega_{\mathrm{Sol}}(t)\right):=\min \left\{\left|y-s^{+}(t)\right|,\left|y-s^{-}(t)\right|\right\}$. The noise term is given by

[^0]where $\dot{W}\left( \pm y \mp s^{ \pm}(t), t\right)$ is a space-time white noise, see for example in [10. The initial condition $w(y, 0)=$ $w_{0}(y)$ is a sufficiently smooth deterministic function compactly supported in the liquid phase. The moving boundary of (1.3) is the union for all $t \geq 0$ of the curves $y=s^{+}(t), \quad y=s^{-}(t)$ enclosing the solid phase with midpoint $s(t):=\left(s^{-}(t)+s^{+}(t)\right) / 2$ and length $s^{+}(t)-s^{-}(t)$ defining the spread. The solution $w(y, t)$ vanishes when $y$ is in the closure of the solid phase. The Stefan condition describes the change of liquidity; $V$ there is the velocity of the interface, and for $(\nabla \cdot)^{ \pm}$denoting the derivative from the right $\left(y>s^{+}\right)$and left $\left(y<s^{-}\right)$it follows that

The term on (1.3) is given by

where $\eta_{1}, \eta_{2}$ are reflections.
In the context of the financial setting, $y$ is the 'price' of one asset ( $y$ is derived after a logarithmic transformation and can take negative values also), while the coefficient $\alpha \gg 0$ of the Laplacian describes the liquidity of the asset, and $w(y, t)$ is the density of sell and buy orders traded in the market with price $y$ at time $t$. The solid phase encloses the prices for which no trade occurs and its length $s^{+}(t)-s^{-}(t)$ defines the financial spread. We refer to [1, 3] and the references therein for more details on the financial parameters.
1.2. The transformed problem. The liquid phase consists of two separate bounded linear segments which enables the splitting of the Stefan problem equation in two equations posed for on $y \geq s^{+}$and on $y \leq s^{-}$. After the change of variables

cf. [3], the stochastic equation of (1.3) is transformed by the use of the Stefan condition into two independent ones each posed on the fixed space domain $\mathcal{D}:=(0, \lambda)$ with Dirichlet b.c. The value $x=0$ occurs when the price $y$ is $s^{ \pm}$, while $x=\lambda$ when the spread is zero and $s^{+}=s^{-}$hits the boundary of $\Omega$. These equations are of the form

with $\eta(d x, d t)$ a random measure on $D \times \mathbb{R}_{+}$(reflection) keeping $u$ a.s. non-negative, and a space-time white noise $\dot{W}(x, t)$ where $W=W(x, t)$ is a Wiener process. We also note that when a system is considered in place of the Stefan problem (1.3) with different liquidity coefficients $\alpha_{1}, \alpha_{2}$ on the diffusion term $\Delta w$, a problem analyzed in [6] when the spread is zero, the same equation of the above general form (1.4) will appear after the change of variables for $\alpha=\alpha_{1}, \alpha_{2}$.

Without restricting the generality, we shall consider one of the cases for the spde which yields the following transformed initial and boundary value problem

As in [3], we assume that

and, since $w_{0}$ is compactly supported on the initial liquid phase, that $u_{0}$ is a deterministic and non-negative function in $C_{c}^{\infty}(\overline{\mathcal{D}})$.

The reflection measure $\eta$ keeps $u$ non-negative and satisfies

for $\mathcal{F}_{t}$ the filtration generated by $\{W(x, s): 0 \leq s \leq t, x \in \mathcal{D}\}$, and the constraint

The problem (1.5), (1.8), with $\sigma, u_{0}$ satisfying (1.6) and (1.7) respectively, has a unique maximal solution $(u, \eta)$ in the time interval $\left[0, T^{*}\right)$, where

see in [3]. An analogous result for the same stopping time $T^{*}:=\sup _{M>0} \tau_{M}$ was derived in [6] for a system of such spdes when $\alpha=\alpha_{1}, \alpha_{2}$.

The solution $u$ of problem (1.5) is written in integral representation $\forall x \in \mathcal{D}, t \in\left[0, T^{*}\right)$ as

for $G$ the Green's function of the Dirichlet problem on $\overline{\mathcal{D}}$ of the Heat equation $v_{t}=\alpha v_{x x}$.
We recall the Banach space $\left(\mathcal{H},\|\cdot\|_{\mathcal{H}}\right)$, introduced in [6], where

Let us consider $M>0$ deterministic and $T>0$ deterministic, and for a positive integer $n$ define the stopping time

where we used that in our problem $h\left(u_{y}(0, s)\right)=u_{y}(0, s)$ which has a linear growth as in the result of [6].
Remark 1.1. Note that the bound of the above expectation depends on the choice of $M$. In case where the term $u_{y}(0, s)$ was replaced by some $h\left(u_{y}(0, s)\right)$ uniformly bounded for any $M>0$ then the solution $u$ would be global, cf. Corollary 5.7 of [6], and it would hold that

Remark 1.2. As we assume that the initial condition $u_{0}$ satisfies (1.7), then it follows that for $t=0$ $u(x, 0)=u_{0}(x)$ satisfies the bounds in the definitions of $\Omega_{M}$, and of $\Omega_{M}^{n}$ for $M$ large enough and for all $n \geq n_{0}$ respectively. This yields that the sets $\Omega_{M}$ and $\Omega_{M}^{n}$ are not empty for $M$ large enough such that $\nabla u_{0}(0)<M$ and for all $n \geq n_{0}$ for $n_{0}$ large enough such that $\left\|u_{0}(\cdot)\right\|_{\mathcal{H}}^{p}<n_{0}$, where of course $M$, $n_{0}$ depend on the initial condition $u_{0}$.
1.3. Main Results. At Section 2, we consider the problem with reflection and prove that the paths of the sample space $\Omega_{M}$, where $M>0$ is an arbitrary deterministic constant, are space-time continuous, i.e., for all realizations in $\Omega_{M}$ where as proven in [6, 3] the solution exists, it is also space-time continuous. The next Section 3 is devoted to the localization of $u$ in the given sample space $\Omega_{M}$ when the unreflected problem is considered. We present there some important definitions of the spaces where we investigate the Malliavin differentiability. We then define a proper approximation $u_{n}$ of $u$ for which $u_{n}=u$ on $\Omega_{M}^{n}$ and prove that $u_{n}$ exists uniquely as a solution of a cut-off spde. Finally, at Section 4, we consider $M_{\mathrm{d}}>0$ deterministic and arbitrary. We prove that the Malliavin derivative of $u$ exists for times up to which the Malliavin derivative of the term in the definition of $\Omega_{M}$ (i.e., $u_{x}\left(0^{+}, t, \omega\right)$ ) not only is bounded by $M$ but also stays differentiable in the Malliavin sense with derivative upper bounded by $M_{\mathrm{d}}$. We additionally prove some estimates for the derivative and discuss on the restrictions appearing in a possible proof of existence of a density which occur by the assumption that $\sigma$ vanishes on the boundary of $\mathcal{D}$.

## 2. Space-Time Continuity for the paths of $\Omega_{M}$

In this section we prove the next very useful theorem establishing the space-time continuity of $u(\cdot, \cdot, \omega)$ for any $\omega \in \Omega_{M}$, which is essential for the localization argument.
Theorem 2.1. Let $u_{0}, \sigma$ satisfy (1.7) and (1.6) respectively and $M>0, T>0$ deterministic fixed values, and $M$ large enough such that $\nabla u_{0}(0)<M$. Consider $\omega \in \Omega_{M}$ for $\Omega_{M}$ defined by (1.16). The unique maximal solution $u(x, t, \omega)$ of (1.11) is continuous in space-time for any $x \in \overline{\mathcal{D}}$ and any $t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)$ for $\tau_{M}$ the stopping time defined in (1.10).

Proof. Since $u(\cdot, t) \in \mathcal{H}$ for any fixed $t \in\left[0, \tau_{M}\right)$, 3 , then by the definition of $\mathcal{H}, u(\cdot, t, \omega) \in C(\overline{\mathcal{D}})$ i.e., $u$ is space-continuous for any fixed $t \in\left[0, \tau_{M}\right)$, where note that $u_{0}(x)=u(x, 0) \in C_{c}^{\infty}(\overline{\mathcal{D}}) \subset \mathcal{H}$.
Let $t_{1}, t_{2} \in\left[0, \min \left\{T, \tau_{M}\right\}\right)$ with $t_{2} \geq t_{1}$. In order to ease notation we will use $u(x, t)$ in place of $u(x, t, \omega)$. By the integral representation (1.11) of $u$, we get

Observe first that $v(x, t)$ the solution of the parabolic problem

$$
\sup _{(x, t) \in \mathcal{D} \times(0, T)}\left|v_{t}(x, t)\right| \leq c\left\|v_{t}\right\|_{H^{2}(\mathcal{D} \times(0, T))} \leq c \sup _{t \in(0, T)}\|v\|_{H^{6}(\mathcal{D})}
$$

where we used that in dimensions 2 ( 1 for time, 1 for space) the $L^{\infty}$ norm is upper bounded by the $H^{2}$ norm. Noting that

$$
v_{x x x x t}=\alpha v_{x x x x x x}, \quad \text { and so } \quad w_{t}=\alpha w_{x x}, \quad \text { for } \quad w:=v_{x x x x}
$$

we obtain that if $u_{0} \in H^{6}(\mathcal{D})$, then $v \in H^{6}(\mathcal{D})$.
Of course as we assume a stronger initial value regularity, $u_{0} \in C^{\infty}(\overline{\mathcal{D}})$, we may get directly, see [5] Theorem 7 of $\S 7.1$ at pg. 367, that

$$
\left|\int_{\mathcal{D}} u_{0}(y)\left(G\left(x, y, t_{2}\right)-G\left(x, y, t_{1}\right)\right) d y\right| \leq c\left|t_{2}-t_{1}\right|
$$

uniformly for all $(x, t) \in \mathcal{D} \times(0, T)$, where $c=c(\omega)$ if $u_{0}$ was stochastic. In our case we considered $u_{0}$ deterministic and so $c$ is not depending on the realization.

For the second term, according to Proposition A6 from [7], $\exists C>0$ such that, for $p>4$

$$
\left(\int_{t_{1}}^{t_{2}}\left(\int_{\mathcal{D}}\left|G_{y}\left(x, y, t_{2}-s\right)\right| d y\right)^{\frac{p}{p-2}} d s\right)^{\frac{p-2}{p}} \leq C\left|t_{2}-t_{1}\right|^{\frac{p-4}{4 p}}, \forall x, y \in[0, \lambda]
$$

thus, using Hölder's inequality, we get

$$
C(M, p, T, \omega) \int_{t_{1}}^{t_{2}} \int_{\mathcal{D}}\left|G_{y}\left(x, y, t_{2}-s\right)\right| d y d s \leq C(M, p, T, \omega) C\left|t_{2}-t_{1}\right|^{(p+4) / 4 p} \rightarrow 0
$$

almost surely in $\Omega_{M}$ as $t_{2} \rightarrow t_{1}$.
For the third term, according again to Proposition A6 from [7], $\exists \tilde{C}>0$ such that, for $p>4$

$$
\left(\int_{0}^{t_{1}}\left(\int_{\mathcal{D}}\left|G_{y}\left(x, y, t_{2}-s\right)-G_{y}\left(x, y, t_{1}-s\right)\right| d y\right)^{\frac{p}{p-2}} d s\right)^{\frac{p-2}{p}} \leq \tilde{C}\left|t_{2}-t_{1}\right|^{\frac{p-4}{4 p}}, \forall x, y \in[0, \lambda]
$$

thus, using again Hölder's inequality, we get

$$
\begin{aligned}
C(M, p, T, \omega) \int_{0}^{t_{1}} \int_{\mathcal{D}} \mid G_{y}\left(x, y, t_{2}-s\right) & -G_{y}\left(x, y, t_{1}-s\right) \mid d y d s \leq \\
& \leq C(M, p, T, \omega) \tilde{C} t_{1}^{\frac{2}{p}}\left|t_{2}-t_{1}\right|^{\frac{p-4}{4 p}} \rightarrow 0
\end{aligned}
$$

almost surely in $\Omega_{M}$ as $t_{2} \rightarrow t_{1}$.
Lastly, regarding the process $A(x, t)$, according to Proposition 3.11 in [7], the first term is almost surely continuous as a function of $(x, t)$ whereas the second term, according to [3, coincides with the solution of a specific Heat equation Obstacle problem which, by Theorem 3.2 of [6], admits a Hölder continuous solution both in space and time. Thus $A(x, t)$ is almost surely continuous in space and time and so

$$
\left|A\left(x, t_{2}\right)-A\left(x, t_{1}\right)\right| \rightarrow 0 \text { almost surely in } \Omega_{M} \text { as } t_{2} \rightarrow t_{1}
$$

From all the above arguments, we conclude that

$$
\left|u\left(x, t_{2}\right)-u\left(x, t_{1}\right)\right| \rightarrow 0 \text { almost surely in } \Omega_{M} \text { as } t_{2} \rightarrow t_{1}
$$

which proves the almost sure in $\Omega_{M}$ continuity of $u$ in time.

## 3. Localization of the unreflected $u$ in $\Omega_{M}$

Let $(\tilde{\Omega}, \mathcal{F}, P)$ be a probability space and $X: \tilde{\Omega} \rightarrow \mathbb{R}$ a random variable, recall that the sample space $\tilde{\Omega}$ consists of all the possible outcomes $\omega \in \tilde{\Omega}$ (simple events) of a random experiment. The Malliavin derivative measures the rate of change of $X$ as a function of $\omega \in \tilde{\Omega}$.

### 3.1. Basic definitions.

Definition 3.1. The set $L^{2}(\tilde{\Omega} \times \mathcal{D} \times[0, T])$ consists of the stochastic processes $v(\omega ; x, t),(x, t) \in \mathcal{D} \times[0, T]$ such that

$$
\|v\|_{L^{2}(\tilde{\Omega} \times \mathcal{D} \times[0, T])}:=\left(E\left(\int_{0}^{T} \int_{\mathcal{D}}|v(x, t)|^{2} d x d t\right)\right)^{\frac{1}{2}}<+\infty .
$$

Definition 3.2. We denote by $D^{1,2}(\mathcal{D} \times[0, T])$ the set of stochastic processes $v(\omega ; x, t),(x, t) \in \mathcal{D} \times[0, T]$ such that the Malliavin derivative (in space and time), $D_{y, s} v(x, t)$, exists for any $y \in \mathcal{D}$ and $s \geq 0$ and any $(x, t) \in \mathcal{D} \times[0, T]$, and satisfies

$$
\|v\|_{D^{1,2}(\mathcal{D} \times[0, T])}:=\left(\|v\|_{L^{2}(\tilde{\Omega})}^{2}+\left\|D_{., .} v\right\|_{L^{2}(\tilde{\Omega} \times \mathcal{D} \times[0, T])}^{2}\right)^{\frac{1}{2}}<+\infty .
$$

Remark 3.3. Recall that $D^{1,2}$ is a Hilbert space.
Definition 3.4. The set $L^{1,2}(\mathcal{D} \times[0, T])$ is defined as the class of all stochastic processes $v \in D^{1,2}(\mathcal{D} \times[0, T])$ that satisfy

$$
\|v\|_{L^{1,2}(\mathcal{D} \times[0, T])}:=\left(\|v\|_{L^{2}(\tilde{\Omega} \times \mathcal{D} \times[0, T])}^{2}+\|D v\|_{L^{2}\left(\tilde{\Omega} \times(\mathcal{D} \times[0, T])^{2}\right)}^{2}\right)^{\frac{1}{2}}<+\infty
$$

where

$$
\|D v\|_{L^{2}\left(\tilde{\Omega} \times(\mathcal{D} \times[0, T])^{2}\right)}:=\left(E\left(\int_{0}^{T} \int_{\mathcal{D}} \int_{0}^{T} \int_{\mathcal{D}}\left|D_{y, s} v(x, t)\right|^{2} d y d s d x d t\right)\right)^{\frac{1}{2}}
$$

We set $\tilde{\Omega}:=\Omega_{M}$ defined by (1.16).
Definition 3.5. The local versions of the sets $D^{1,2}(\mathcal{D} \times[0, T])$ and $L^{1,2}(\mathcal{D} \times[0, T])$ are defined as follows $L_{\text {loc }}^{1,2}(\mathcal{D} \times[0, T]):=\left\{\right.$ stoc. proc. $v: \exists\left\{\left(\Omega_{M}^{n}, v_{n}\right)\right\}_{n \in \mathbb{N}} \subset \mathcal{F} \times L^{1,2}$ such that $\Omega_{M}^{n} \uparrow \Omega_{M}$ a.s. $\& v=v_{n}$ a.s. on $\left.\Omega_{M}^{n}\right\}$, $D_{\text {loc }}^{1,2}(\mathcal{D} \times[0, T]):=\left\{\right.$ stoc. proc. $v: \exists\left\{\left(\Omega_{M}^{n}, v_{n}\right)\right\}_{n \in \mathbb{N}} \subset \mathcal{F} \times D^{1,2}$ such that $\Omega_{M}^{n} \uparrow \Omega_{M}$ a.s. \& $v=v_{n}$ a.s. on $\left.\Omega_{M}^{n}\right\}$, where recall that

$$
\Omega_{M}^{n} \uparrow \Omega_{M} \text { a.s. } \Longleftrightarrow \Omega_{M}^{1} \subseteq \Omega_{M}^{2} \subseteq \cdots \subseteq \Omega_{M} \quad \text { such that } \quad \lim _{n \rightarrow+\infty} P\left(\Omega_{M}^{n}\right)=P\left(\Omega_{M}\right)=1
$$

Recall now that it holds that $L^{1,2} \subseteq L_{\text {loc }}^{1,2} \subseteq D_{\text {loc }}^{1,2}$ as well as $L^{1,2} \subseteq D^{1,2} \subseteq D_{\text {loc }}^{1,2} \subseteq D_{\text {loc }}^{1,1}$. Also recall that if $v \in D_{\text {loc }}^{1,2}$ and $\left(\Omega_{M}^{n}, v_{n}\right)$ localizes $v$ in $D^{1,2}$, then the Malliavin derivative $D_{y, s} v$ is defined without ambiguity by $D_{y, s} v=D_{y, s} v_{n}$ on $\Omega_{M}^{n}, \forall n \in \mathbb{N}$.
Since $L^{1,2} \subseteq D^{1,2}$, a constructed localization $\left(\Omega_{M}^{n}, v_{n}\right)$ of $v$ in $L^{1,2}$ is also a localization in $D^{1,2}$ and thus, will define well the Malliavin derivative of $v$ through the Malliavin derivative of $v_{n}$.

Let us consider the unreflected problem, i.e., we set $\eta=0$ in (1.11). Here, we note that the bound (1.14), holds also true, i.e.,

$$
E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}, \sup _{n>0} \tilde{\tau}_{n}\right\}\right)}\|u(\cdot, t)\|_{\mathcal{H}}^{p}\right) \leq C(T, M, p)<\infty
$$

but we need to define for $\tau_{M}:=\inf \left\{T \geq 0: \sup _{r \in[0, T)}\left|u_{x}\left(0^{+}, r\right)\right| \geq M\right\}$ (which is here $\neq \inf \{T \geq 0$ : $\left.\left.\sup _{r \in[0, T)} u_{x}\left(0^{+}, r\right) \geq M\right\}\right), \Omega_{M}$ as follows

$$
\begin{equation*}
\Omega_{M}:=\left\{\omega \in \Omega: \sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left|u_{x}\left(0^{+}, t, \omega\right)\right|<M\right\} . \tag{3.1}
\end{equation*}
$$

The absolute value over $u_{x}$ is introduced in the definition as done in places in 3 wherein the unreflected problem was also analyzed (since $u_{x}\left(0^{+}, t, \omega\right)$ may be negative in the unreflected case where $u$ changes sign in general).
3.2. The cut-off solution $\mathbf{u}_{\mathbf{n}}=\mathbf{u}$ a.s. on $\Omega_{\mathrm{M}}^{\mathrm{n}}$. For fixed $n \in \mathbb{N}$, we define as in [4, 2] the cut-off function $H_{n}: \mathbb{R} \rightarrow \mathbb{R}^{+}, H_{n}$ smooth (in $\left.C^{1}(\mathbb{R})\right)$ such that for all $n, 0 \leq H_{n} \leq 1$ and $\left|H_{n}^{\prime}\right| \leq 2$ with

$$
H_{n}(v)= \begin{cases}1, & \text { if }|v|<n^{1 / p} \\ 0, & \text { if }|v|>n^{1 / p}+1\end{cases}
$$

We now define $T_{n}(v):=H_{n}(v) v$.
Let $T>0$ deterministic and $M>0$ deterministic. We recall the definition of the stopping time $\tau_{M}$ (given in (1.10)) $\tau_{M}:=\inf \left\{T \geq 0: \sup _{r \in[0, T)}\left|u_{x}\left(0^{+}, r\right)\right| \geq M\right\}$.

We define $\forall x \in \mathcal{D}, t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)$, the cut-off stochastic integral equation

$$
\begin{align*}
u_{n}(x, t, \omega)= & \int_{\mathcal{D}} u_{0}(y) G(x, y, t) d y+\int_{0}^{t} \int_{\mathcal{D}} u_{y}(0, s) G_{y}(x, y, t-s) y T_{n}\left(y^{-1} u_{n}(y, s, \omega)\right) d y d s \\
& +\int_{0}^{t} \int_{\mathcal{D}} G(x, y, t-s) \sigma(y) W(d y, d s) \tag{3.2}
\end{align*}
$$

for $\omega \in \Omega_{M}$. It then follows that when $\omega \in \Omega_{M}^{n}$ (where recall that $\Omega_{M}^{n} \subset \Omega_{M}$ ) then for all $n$ and all $s$ with $0<s<t$, it holds that

$$
n^{1 / p}>\|u(\cdot, s, \omega)\|_{\mathcal{H}}=\sup _{y \in \mathcal{D}} \frac{|u(y, s, \omega)|}{y}
$$

and so the term in the integral satisfies

$$
y T_{n}\left(y^{-1} u(y, s, \omega)\right)=y H_{n}\left(y^{-1} u(y, s, \omega)\right) y^{-1} u(y, s, \omega)=y \cdot 1 \cdot y^{-1} u(y, s, \omega)=u(y, s, \omega)
$$

The above yields that $u$ and $u_{n}$ satisfy both the same integral representation ((3.2) coincides to (1.11)) and so $u_{n}(x, t, \omega)=u(x, t, \omega)$ on $\Omega_{M}^{n}$ a.s. if the problem (3.2) is well posed.

We are now in position to prove this section's main theorem which is the well-posedness of the cut-off problem (3.2).

Theorem 3.6. Equation (3.2) has a unique solution $u_{n}$ which belongs in $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ for $p \geq 2$. Moreover, there exists a constant $c=c(n, p, M, T)>0$ such that $u_{n}$ satisfies:

$$
\begin{equation*}
\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)} E\left(\left\|u_{n}(\cdot, t)\right\|_{L^{\infty}(\mathcal{D})}^{p}\right) \leq c . \tag{3.3}
\end{equation*}
$$

Proof. The basic idea is the construction of a Cauchy sequence, through a Picard iteration scheme, which converges, at a certain norm, to the solution $u_{n}$ of (3.2). For given $n \in \mathbb{N}$, we define $\forall x \in \overline{\mathcal{D}}, t \in$ $\left[0, \min \left\{T, \tau_{M}\right\}\right)$

$$
u_{n, 0}(x, t):=G_{t} u_{0}(x) \text { where } G_{t} u_{0}(x):=\int_{\mathcal{D}} u_{0}(y) G(x, y, t) d y \text { for } t>0 \quad \text { and } \quad G_{0} u_{0}(x):=u_{0}(x)
$$

and $\forall k \in \mathbb{N}$

$$
\begin{align*}
u_{n, k+1}(x, t):= & \int_{\mathcal{D}} u_{0}(y) G(x, y, t) d y+\int_{0}^{t} \int_{\mathcal{D}} u_{y}(0, s) G_{y}(x, y, t-s) y T_{n}\left(y^{-1} u_{n, k}(y, s)\right) d y d s  \tag{3.4}\\
& +\int_{0}^{t} \int_{\mathcal{D}} G(x, y, t-s) \sigma(y) W(d y, d s)
\end{align*}
$$

So for $k \geq 1$,

$$
u_{n, k+1}(x, t)-u_{n, k}(x, t)=\int_{0}^{t} \int_{\mathcal{D}} u_{y}(0, s) G_{y}(x, y, t-s) y\left(T_{n}\left(y^{-1} u_{n, k}(y, s)\right)-T_{n}\left(y^{-1} u_{n, k-1}(y, s)\right)\right) d y d s
$$

and therefore, applying the $\|\cdot\|_{\mathcal{H}}$-norm at both sides, then taking $p$-powers, next taking the supremum on $t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)$, and then taking expectation, we obtain for any $k \in \mathbb{N}$ :

\begin{align*}
& \text { (3.5) } E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n, k+1}(\cdot, t)-u_{n, k}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right)=  \tag{3.5}\\
& E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|\int_{0}^{t} \int_{\mathcal{D}} u_{y}(0, s) G_{y}(\cdot, y, t-s) y\left(T_{n}\left(y^{-1} u_{n, k}(y, s)\right)-T_{n}\left(y^{-1} u_{n, k-1}(y, s)\right)\right) d y d s\right\|_{\mathcal{H}}^{p}\right]\right)
\end{align*}
$$

Since $H_{n}$ is $C^{1}$ then for arbitrary $\tilde{v}, T_{n}(\tilde{v})$ is uniformly Lipschitz on $\tilde{v}$, and so for $y>0$, it holds that $\left|T_{n}\left(y^{-1} v\right)-T_{n}\left(y^{-1} w\right)\right| \leq c y^{-1}|v-w|$. By taking supremum on $y \in \mathcal{D}$ we have

$$
\left\|T_{n}\left(y^{-1} v\right)-T_{n}\left(y^{-1} w\right)\right\|_{L^{\infty}(\mathcal{D})} \leq c\|v-w\|_{\mathcal{H}}
$$

Thus, using Inequality 5 in [6, Proposition 4.2] and since $\left|u_{y}(0, s)\right| \leq M$, equation (3.5) can be bounded as follows, for $p>2$,

\begin{aligned}
& E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n, k+1}(\cdot, t)-u_{n, k}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) \leq \\
& c(T, M, p) M^{p} \int_{0}^{\min \left\{T, \tau_{M}\right\}} E\left(\sup _{t \in[0, s)}\left[\left\|u_{n, k}(\cdot, t)-u_{n, k-1}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) d s
\end{aligned}
$$

By repeatedly applying the above inequality for the integrand in the right-hand side, we get

$$
\begin{aligned}
& \left\|u_{n, k+1}(\cdot, t)-u_{n, k}(\cdot, t)\right\|_{L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)}^{p} \\
& \quad=E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n, k+1}(\cdot, t)-u_{n, k}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) \\
& \quad \leq\left(c(T, M, p) M^{p}\right)^{k} \int_{0}^{\min \left\{T, \tau_{M}\right\}} \int_{0}^{s_{k}} \int_{0}^{s_{k-1}} \cdots \int_{0}^{s_{2}} E\left(\sup _{t \in\left[0, s_{1}\right)}\left[\left\|u_{n, 1}(\cdot, t)-u_{n, 0}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) d s_{1} \ldots d s_{k} \\
& \quad \leq\left\|u_{n, 1}-u_{n, 0}\right\|_{L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)}^{p}\left(c(T, M, p) M^{p}\right)^{k} \frac{\left(\min \left\{T, \tau_{M}\right\}\right)^{k}}{k!} \rightarrow 0 \quad \text { as } \quad k \rightarrow+\infty
\end{aligned}
$$

Therefore, $\left\{u_{n, k}\right\}_{k \in \mathbb{N}}$ is a Cauchy sequence in $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ and so, by the completeness of the Banach space $\mathcal{H}$ in this norm, it converges in $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ to some unique $u_{n} \in$ $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ as $k \rightarrow+\infty$.

Since $u_{n, k} \rightarrow u_{n}$ in the norm $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ as $k \rightarrow+\infty$ and since the mapping $T_{n}$ is Lipschitz (and therefore uniformly continuous), by a standard argument, where we take limits in the $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ norm in equation (3.4), we derive that $u_{n}$ satisfies equation (3.2).

Lastly, if we suppose that there exists another solution $w_{n}$ of (3.2), then by subtracting their respective equations we get

$$
u_{n}(x, t)-w_{n}(x, t)=\int_{0}^{t} \int_{\mathcal{D}} u_{y}(0, s) G_{y}(x, y, t-s) y\left(T_{n}\left(y^{-1} u_{n}(y, s)\right)-T_{n}\left(y^{-1} w_{n}(y, s)\right)\right) d y d s
$$

and, by following a similar process as above, we obtain

$$
E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n}(\cdot, t)-w_{n}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) \leq c(T, M, p) M^{p} \int_{0}^{\min \left\{T, \tau_{M}\right\}} E\left(\sup _{t \in[0, s)}\left[\left\|u_{n}(\cdot, t)-w_{n}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) d s
$$

Hence, by applying Gronwall's Lemma to the previous inequality, we get

$$
E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n}(\cdot, t)-w_{n}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right) \leq 0 \quad \text { and so } \quad E\left(\sup _{t \in\left[0, \min \left\{T, \tau_{M}\right\}\right)}\left[\left\|u_{n}(\cdot, t)-w_{n}(\cdot, t)\right\|_{\mathcal{H}}^{p}\right]\right)=0
$$

This yields $u_{n}(x, t)=w_{n}(x, t)$ almost surely in $\Omega_{M}$ and in $\Omega_{M}^{n}$ for any $(x, t) \in \overline{\mathcal{D}} \times\left[0, \min \left\{T, \tau_{M}\right\}\right)$, i.e.,

$$
P\left(\left\{\omega \in \Omega_{M}\left(\text { or } \Omega_{M}^{n}\right): u_{n}(x, t ; \omega)=w_{n}(x, t ; \omega)\right\}\right)=1, \forall(x, t) \in \overline{\mathcal{D}} \times\left[0, \min \left\{T, \tau_{M}\right\}\right)
$$

and so by definition $u_{n}, w_{n}$ are equivalent in $\Omega_{M}$ and in $\Omega_{M}^{n}$.
By Theorem 2.1, we know that $u$ has almost surely in $\Omega_{M}$ continuous trajectories in $\overline{\mathcal{D}} \times\left[0, \min \left\{T, \tau_{M}\right\}\right.$ ) and the approximations $u_{n}, w_{n}$ satisfy equation (1.11) almost surely in $\Omega_{M}^{n}$. So, $u_{n}, w_{n}$ are also almost surely continuous in $\Omega_{M}^{n}$ and thus indistinguishable in $\Omega_{M}^{n}$, i.e.

which proves the uniqueness of solution of equation (1.11) with uniquely defined paths almost surely on $\Omega_{M}^{n}$.
The only thing remaining in order to complete the proof of the theorem is to prove (3.3). Firstly we note that, for any $f \in \mathcal{H}$, it holds $\|f\|_{L^{\infty}(\mathcal{D})} \leq\|f\|_{\mathcal{H}}$ and so

&=\left\|u_{n, 1}-u_{n, 0}\right\|_{L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)}^{p} e^{c(T, M, p) M^{p} \min \left\{T, \tau_{M}\right\}} \\
&=c(n, p, M, T) .
\end{aligned}
$$

Secondly, since $u_{n, k} \rightarrow u_{n}$ in $L^{p}\left(\Omega_{M} ; C\left(\left[0, \min \left\{T, \tau_{M}\right\}\right) ; \mathcal{H}\right)\right)$ as $k \rightarrow+\infty, \exists c=c(n, p, M, T)>0$ such that

## 4. The Malliavin derivative of the solution $u$ for the unreflected problem

We will prove that the Malliavin derivative of solution $u_{n}$ of equation (3.2) for $\eta:=0$, is well defined as the solution of an s.p.d.e. Moreover, we shall prove its regularity in $D^{1,2}$ and in $L^{1,2}$ by the next proposition.

In what follows, the notation $D_{y, s} f(x, t)$ for a general function $f$ is used to denote $D_{y, s}(f(x, t))$ which is a function of the variables $y, s, x, t$. Additionally due to the independence of the variables $y, s$ from $x, t$ we may commute the limit as $x \rightarrow 0$ with $D_{y, s}$ if the terms are well defined, i.e., $D_{y, s}\left(\lim _{x \rightarrow 0} f(x, t)\right)=\lim _{x \rightarrow 0} D_{y, s}(f(x, t))$. So, as $x$ is not depending on the realization obviously, and as the Malliavin derivative is linear, we have, when the terms are well defined, that $D_{y, s}\left(u_{x}\left(0^{+}, t\right)\right)=D_{y, s}\left(\lim _{x \rightarrow 0^{+}} x^{-1} u(x, t)\right)=\lim _{x \rightarrow 0^{+}} x^{-1} D_{y, s}(u(x, t))=$ : $\nabla_{x}\left(D_{y, s} u\right)\left(0^{+}, t\right)$.

Proposition 4.1. Let $u_{n}$ be the unique solution of equation (3.2). Let $M_{\mathrm{d}}>0$ a fixed deterministic value. We define the stopping time $\tau_{M_{\mathrm{d}}}:=\inf \left\{T>0: \sup _{r \in[0, T)}\left|D_{y, s}\left(u_{x}\left(0^{+}, r\right)\right)\right| \geq M_{\mathrm{d}}\right\}$ (note that at $r=0$ $u_{x}\left(0^{+}, 0\right)=\left(u_{0}\right)_{x}\left(0^{+}\right)$is deterministic, and so its Malliavin derivative is zero and so less than $\left.M_{\mathrm{d}}\right)$. Also let $T>0$ be a deterministic time value.

It holds that:
(i) $u_{n}(x, t) \in D^{1,2}\left(\mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right)$.
(ii) The Malliavin derivative of $u_{n}$ satisfies for all $(x, t) \in \mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)$ and for any $s \leq t$, uniquely the stochastic equation

\end{aligned}

and also for any $s>t$ it holds that $D_{y, s} u_{n}(x, t)=0$. In the above, $\mathcal{G}_{n}$ is a stochastic process which satisfies, for $c_{L}>0$ a deterministic constant, that

Proof. (i) We will prove that the Cauchy sequence $\left\{u_{n, k}\right\}_{k \in \mathbb{N}}$ (as we described in Theorem (3.6) belongs to $D^{1,2}\left(\mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right), \forall(x, t) \in \mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right.$, by using induction and the Picard iteration scheme.

For $k=0$, the function $u_{n, 0}=u_{0}$ is deterministic and bounded (since $u_{0} \in \mathcal{H}$ ) with Malliavin derivative $D u_{n, 0}=0$ and so $u_{n, 0} \in D^{1,2}$.

Let $k \in \mathbb{N}$ be fixed and $2<p<3$. We suppose that, $\forall i \in \mathbb{N} \cap[0, k]$, it holds that

We shall prove that the above also holds for $u_{n, k+1}$, i.e.,

= & 0+\int_{s}^{t} \int_{\mathcal{D}} G_{\tilde{y}}(x, \tilde{y}, t-\tilde{s}) D_{y, s}\left(u_{\tilde{y}}(0, \tilde{s}) \tilde{y} T_{n}\left(\tilde{y}^{-1} u_{n, k}(\tilde{y}, \tilde{s})\right)\right) d \tilde{y} d \tilde{s}+G(x, y, t-s) \sigma(y) \\

& +\int_{s}^{t} \int_{\mathcal{D}} G_{\tilde{y}}(x, \tilde{y}, t-\tilde{s}) D_{y, s}\left(u_{\tilde{y}}(0, \tilde{s})\right) \tilde{y} T_{n}\left(\tilde{y}^{-1} u_{n, k}(\tilde{y}, \tilde{s})\right) d \tilde{y} d \tilde{s}+G(x, y, t-s) \sigma(y),

where we used Proposition 1.3.8 from Nualart [9, for the stochastic integral term and the fact that the Malliavin derivative is zero when applied to the deterministic terms $u_{0}, G, G_{\tilde{y}}, \tilde{y}$, and also zero for any $\tilde{s}<s$.

By the induction hypothesis $u_{n, k}(x, t) \in D^{1,2}$ and recall that since $H_{n}$ is $C^{1}$ with $\left|H_{n}^{\prime}\right| \leq 2$, then for arbitrary $\tilde{v}, T_{n}(\tilde{v})$ is uniformly Lipschitz on $\tilde{v}$, with (deterministic) Lipschitz constant $c_{L}$, and so it holds that $\left.\left|T_{n}\left(y^{-1} v\right)-T_{n}\left(y^{-1} w\right)\right| \leq c_{L} \mid y^{-1} v-y^{-1} w\right) \mid$ so, Proposition 1.2.4 from Nualart 9 (analogous to chain rule) ensures that

& =c_{3}\left(\int_{s}^{t} \frac{1}{|t-\tilde{s}|^{\frac{1}{2}}}\left\|D_{y, s}\left(u_{n, k}(\cdot, \tilde{s})\right)\right\|_{L^{\infty}(\mathcal{D})} d \tilde{s}\right)^{p} \\
& \leq c_{3}\left(\int_{s}^{t} \frac{1}{|t-\tilde{s}|^{\frac{p}{2(p-1)}}} d \tilde{s}\right)^{p-1} \int_{s}^{t}\left\|D_{y, s}\left(u_{n, k}(\cdot, \tilde{s})\right)\right\|_{L^{\infty}(\mathcal{D})}^{p} d \tilde{s} \\
& \leq c_{3} c(p, t, s) \int_{s}^{t}\left\|D_{y, s}\left(u_{n, k}(\cdot, \tilde{s})\right)\right\|_{L^{\infty}(\mathcal{D})}^{p} d \tilde{s} \\
& =c_{3} c(p, t, s) \int_{0}^{t}\left\|D_{y, s}\left(u_{n, k}(\cdot, \tilde{s})\right)\right\|_{L^{\infty}(\mathcal{D})}^{p} d \tilde{s}

It remains to show is the uniqueness of solution of (4.1).

& :=\left(\left\|u_{n}\right\|_{L^{2}\left(\Omega_{M} \times \mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right)}^{2}+\left\|D u_{n}\right\|_{L^{2}\left(\Omega_{M} \times\left(\mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right)^{2}\right)}^{2}\right)^{1 / 2} \\
& <+\infty
\end{aligned}
$$

which yields $u_{n} \in L^{1,2}\left(\mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right)$.

This section's main theorem is a direct consequence of the previous arguments.

Theorem 4.2. The solution $u$ of (1.11) for $\eta:=0$ belongs to $L_{\text {loc }}^{1,2}\left(\mathcal{D} \times\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right) \subseteq D_{\text {loc }}^{1,2}(\mathcal{D} \times$ $\left.\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)\right)$.

Proof. The proof follows since we constructed a localization of $u$, by $\left(\Omega_{M}^{n}, u_{n}\right), n \in \mathbb{N}$ with $u_{n} \in L^{1,2} \subseteq$ $D^{1,2}$.
4.1. Remarks. In order to establish existence of a density for the solution $u$ of (1.11) for $\eta:=0$, we must first prove two very important estimates needed for this as in [4. 2]. Unfortunately, even if we do so in the sequel, as we conclude, we can not proceed further since $\sigma$ vanishes for at least two values.

We keep the definitions of $\Omega_{M}$ and $\tau_{M}$, and $\tau_{M_{d}}$ of the previous sections.
Proposition 4.3. Let a given deterministic $T>0$. For any $b \in\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)$ and any $\epsilon \in(0, b]$, there exists constant $c=c(n)>0$ such that the following estimates hold true for $2<p<3$ and $\frac{1}{p}+\frac{1}{q}=1(q<2)$,

\leq c(n) \epsilon^{1+\frac{3-p}{2}+\left(-\frac{q}{2}+1\right) \frac{p}{q}}
\end{gather*}

In (4.17), we integrate in $y \in \mathcal{D}$, and then integrate for $s \in[b-\epsilon, t]$, and take supremum in $x$, and then take expectation, to arrive at

& +E\left(\int_{b-\epsilon}^{t} \sup _{x \in \mathcal{D}} \int_{\mathcal{D}} c|A|^{p} d y d s\right)  \tag{4.18}\\
\quad \leq & c \int_{b-\epsilon}^{t} \sup _{x \in \mathcal{D}} \int_{\mathcal{D}}|G(x, y, t-s) \sigma(y)|^{p} d y d s \\
& +c E\left(\int_{b-\epsilon}^{t} \int_{\mathcal{D}} \sup _{x \in \mathcal{D}}\left|\int_{s}^{t} \int_{\mathcal{D}} G_{\tilde{y}}(x, \tilde{y}, t-\tilde{s})\left[u_{\tilde{y}}(0, \tilde{s}) \mathcal{G}_{n}(\tilde{y}, \tilde{s}) D_{y, s} u_{n}(\tilde{y}, \tilde{s})\right] d \tilde{y} d \tilde{s}\right|^{p} d y d s\right) \\
& +c E\left(\int_{b-\epsilon}^{t} \sup _{x \in \mathcal{D}} \int_{\mathcal{D}}|A|^{p} d y d s\right)=: \mathcal{B}_{1}+\mathcal{B}_{2}+\mathcal{B}_{3} .

Now, we use the estimate (2.21) of Mora [8]

& \leq c E\left(\int_{b-\epsilon}^{t} \int_{\mathcal{D}} \sup _{x \in \mathcal{D}}\left|\int_{s}^{t} \sup _{\tilde{y} \in \mathcal{D}}\right| D_{y, s} u_{n}(\tilde{y}, \tilde{s})\left|\int_{\mathcal{D}}\right| G_{\tilde{y}}(x, \tilde{y}, t-\tilde{s})|d \tilde{y} d \tilde{s}|^{p} d y d s\right) \\
& \leq c E\left(\int_{b-\epsilon}^{t} \int_{\mathcal{D}}\left|\int_{s}^{t}\right| t-\left.\left.\tilde{s}\right|^{-1 / 2} \sup _{\tilde{y} \in \mathcal{D}}\left|D_{y, s} u_{n}(\tilde{y}, \tilde{s})\right| d \tilde{s}\right|^{p} d y d s\right)  \tag{4.25}\\
& \leq c E\left(\int_{b-\epsilon}^{t} \int_{\mathcal{D}}|t-s|^{(-q / 2+1) p / q} \int_{s}^{t} \sup _{\tilde{y} \in \mathcal{D}}\left|D_{y, s} u_{n}(\tilde{y}, \tilde{s})\right|^{p} d \tilde{s} d y d s\right) \\

where we used for the first inequality the uniform upper-boundedness of $\left|\mathcal{G}_{n}\right|$ by the deterministic constant $C_{L}$, and also the upper-boundedness of $\left|u_{\tilde{y}}(0, \tilde{s})\right|$ by $M$, and the estimate (4.24) of the space integral of $\left|G_{y}\right|$ for the third and Hölder for the fourth inequality for $1 / p+1 / q=1$.

Note that in the previous estimates the first power is positive and the second strictly greater than 1.

Let $\sigma$ in $C^{\infty}$ and $x \in \mathcal{D}$ far from the boundary and a given deterministic $T>0$ small enough so that the solution $v(x, t)$ of the deterministic Dirichlet heat equation with coefficient $\alpha$ and initial condition $\sigma$ satisfies $|v(x, t)| \geq c(x)>0$ for all $t<T$. For any $t \in\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)$ the following hold true for any $p \in(2,3)$,

& =c \int_{t-\epsilon}^{t}|v(x, t-s)|^{p} d s
\end{aligned}
$$

Since $x$ is far from the Dirichlet boundary, if $T$ is small enough, we may identify a class of selections for $\sigma$ so that

$$
|v(x, \tau)| \geq c(x)>0, \quad \text { for all } \tau<T
$$

This gives that

$$
\begin{equation*}
\int_{t-\epsilon}^{t}\left[c_{1} \int_{\mathcal{D}}|A|^{p} d y\right] d s \geq c \int_{t-\epsilon}^{t} c d s=c_{0} \epsilon \tag{4.32}
\end{equation*}
$$

We also have, from (4.1) and (4.15), that

$$
\begin{align*}
c_{2} E\left(\int_{t-\epsilon}^{t} \int_{\mathcal{D}}|B|^{p} d y d s\right) & =c_{2} E\left(\int_{t-\epsilon}^{t} \int_{\mathcal{D}}\left|D_{y, s} u_{n}(x, t)-G(x, y, t-s) \sigma(y)\right|^{p} d y d s\right)  \tag{4.33}\\
& \leq c(n) \epsilon^{1+\frac{3-p}{2}+(-q / 2+1) p / q},
\end{align*}
$$

for $1 / p+1 / q=1$.
Gathering all the above, we get using Markov inequality

$$
\begin{aligned}
& P\left(\int_{0}^{\left[0, \min \left\{T, \tau_{M}, \tau_{M_{\mathrm{d}}}\right\}\right)} \int_{\mathcal{D}}\left|D_{y, s} u_{n}(x, t)\right|^{p} d y d s>0\right) \geq P\left(c_{1} \int_{t-\epsilon}^{t} \int_{\mathcal{D}}|A|^{p} d y d s-c_{2} \int_{t-\epsilon}^{t} \int_{\mathcal{D}}|B|^{p} d y d s>0\right) \\
& \quad \geq P\left(c_{2} \int_{t-\epsilon}^{t} \int_{\mathcal{D}}|B|^{p} d y d s<\frac{c_{0}}{2} \epsilon\right) \geq 1-c \epsilon^{-1} E\left(\int_{t-\epsilon}^{t} \int_{\mathcal{D}}|B|^{p} d y d s\right) \\
& \quad \geq 1-c \epsilon^{-1} \epsilon^{1+\frac{3-p}{2}+(-q / 2+1) p / q} \rightarrow 1 \quad \text { as } \epsilon \rightarrow 0
\end{aligned}
$$

which yields (4.30), and then (4.31) (see for the second in [2] Remark 3.1.).

A main difference of the equation (1.11) when $\eta:=0$ from the problems treated in [4] and [2] is that in our case as in [3, 6, 7] the noise diffusion coefficient $\sigma(y)$ is zero for at least two values of $y$, i.e., when $y=0, \lambda$.
