INVERSE PROBLEMS FOR SUMSET SIZES OF FINITE SETS OF INTEGERS

ABSTRACT. Let A be a finite set of integers and let hA be its h -fold sumset. This paper investigates the sequence of sumset sizes $(|hA|)_{h=1}^{\infty}$ and the relations between these sequences for affinely inequivalent sets A and B.

1. The sequence of sumset sizes

Let A be a nonempty finite set of integers. The h-fold sumset of the set A , denoted hA , is the set of all sums of h not necessarily distinct elements of A . Let |hA| denote the size (or cardinality) of the set $|hA|$. A *direct problem* for sumset sizes in additive number theory is to compute the infinite sequence $(|hA|)_{h=1}^{\infty}$. For sufficiently large h , this sequence is completely determined by Theorem [2](#page-1-0) and is eventually an arithmetic progression. For small h, there is a lower bound for $|hA|$ from Theorem [3.](#page-1-1)

Sets of integers A and B are *affinely equivalent* if there exist rational numbers λ and μ with $\lambda \neq 0$ such that

$$
B = \lambda * A + \mu = \{\lambda a + \mu : a \in A\}.
$$

For example, the sets $\{0, 2\}$ and $\{1, 4\}$ are affinely equivalent because

$$
\{0,2\} = \frac{2}{3} * \{1,4\} - \frac{2}{3}.
$$

With $\lambda = -1$ and $a_0 \in \mathbb{Z}$, the set A is affinely equivalent to its reflection $a_0 - A =$ $(-1) * A + a_0$. All 1-element sets of integers are affinely equivalent and all 2-element sets of integers are affinely equivalent. The sets $[0, k-1]$ and $[0, k-2] \cup \{k\}$ are affinely inequivalent sets of integers of size k for all $k \geq 3$. If A and B are affinely equivalent sets with $B = \lambda * A + \mu$, then

$$
h = h(\lambda * A + \mu) = \lambda * hA + h\mu
$$

and so $|hA| = |hB|$ for all $h \ge 1$. Thus, the size of a sumset is an *affine invariant*.

It is natural to consider *inverse problems* for the sequence of sumset sizes $(|hA|)_{h=0}^{\infty}$ $h=1$ of a nonempty finite set A of integers. To what extent does the sequence of positive integers $(|hA|)_{h=1}^{\infty}$ determine A? If A and B are affinely equivalent sets, then $(|hA|)_{h=1}^{\infty} = (|hB|)_{h=1}^{\infty}$. What are the relations between the sequences $(|hA|)_{h=1}^{\infty}$ $\frac{(|hA|)_{h=1} - (|hB|)_{h=1}^n}{\text{and } (|hB|)_{h=1}^{\infty}}$ for affinely inequivalent sets of the same size? Do there exist affinely inequivalent finite sets of integers A and B such that $(|hA|)_{h=1}^{\infty} = (|hB|)_{h=1}^{\infty}$? For every positive integer h_1 , do there exists finite sets of integers A and B such that

 $|hA| = |hB|$ for all $h \leq h_1$ but $|hA| < |hB|$ for all $h > h_1$? Do there exists finite sets of integers A and B such that $|hA| > |hB|$ for all $h \leq h_1$ but $|hA| < |hB|$ for all $h > h_1$? We answer some of these question in this paper, but many problems remain open.

2. The direct problem for sumset sizes

Every finite set A' of integers with $|A'| \geq 2$ is affinely equivalent to a unique normalized set A of integers such that $min(A) = 0$ and $gcd(A) = 1$. The *interval* of integers [u, v] is the set of all integers n such that $u \le n \le v$.

The following result is fundamental in additive number theory.

Theorem 1 (Nathanson [\[5,](#page-6-0) [6\]](#page-6-1)). Let A be a finite set of $k \geq 2$ integers with $min(A) = 0$, $max(A) = a$, and $gcd(A) = 1$. There exist integers C and D and subsets $C \subseteq [0, C - 2]$ and $D \subseteq [0, D - 2]$ such that

$$
hA = \mathcal{C} \cup [C, ha - D] \cup (ha - \mathcal{D})
$$

for all $h \geq h_0(A)$.

The original result in [\[5\]](#page-6-0) was $h_0(A) = a^2(k-1)$. Recently, Andrew Granville, George Shakan, and Aled Walker [\[1,](#page-6-2) [2\]](#page-6-3) obtained $h_0(A) = a - k + 2$. Vsevolod Lev [\[4\]](#page-6-4) gives another proof of this result.

Theorem [1](#page-1-2) immediately implies the following.

Theorem 2. Let A be a finite set of $k \geq 2$ integers with $\min(A) = 0$, $\max(A) = a$, and $gcd(A) = 1$. There exists an integer $\Delta(A)$ such that

$$
|hA| = ha - \Delta(A)
$$

for all $h \geq h_0(A)$ and so the sequence of sumset sizes $(|hA|)_{h=1}^{\infty}$ is eventually an arithmetic progression with difference a.

The hard part of the direct problem is to understand $|hA|$ for small h. For this, the following result is useful.

Theorem 3 (Lev [\[3\]](#page-6-5)). Let A be a finite set of $k \geq 2$ integers with $\min(A) = 0$, $max(A) = a$, and $gcd(A) = 1$. For all $h \geq 2$,

$$
|hA| \ge |(h-1)A| + \min(a, h(k-2) + 1).
$$

This is weaker than Theorem [2](#page-1-0) for $h \ge a - k + 2$.

3. Inverse problems for sumset size

Let A be a finite set of integers. The next result shows that the sumset size sequence $(|hA|)_{h=1}^{\infty}$ does not determine the affine equivalence class A.

Theorem 4. For all $k \geq 3$, there exist affinely inequivalent sets A and B such that $|A| = |B| = k$ and $|hA| = |hB|$ for all $h \geq 2$.

Proof. The proof is by explicit construction.

Let $k = 3$. The sets

.

are affinely inequivalent with $|A| = |B| = 3$. We have

$$
2A = \{0, 2, 4, 7, 9, 14\}
$$

\n
$$
2B = \{0, 3, 6, 7, 10, 14\}
$$

\n
$$
3A = \{0, 2, 4, 6, 7, 9, 11, 14, 16, 21\}
$$

\n
$$
3B = \{0, 3, 6, 7, 9, 10, 13, 14, 17, 21\}
$$

\n
$$
4A = \{0, 2, 4, 6, 7, 8, 9, 11, 13, 14, 16, 18, 21, 23, 28\}
$$

\n
$$
4B = \{0, 3, 6, 7, 9, 10, 12, 13, 14, 16, 17, 20, 21, 24, 28\}
$$

and so

$$
|2A| = |2B| = 6
$$

$$
|3A| = |3B| = 10
$$

$$
|4A| = |4B| = 15.
$$

Applying Theorems [1](#page-1-2) and [2,](#page-1-0) we obtain finite sets

$$
C_A = \{0, 2, 4\}
$$
 and $D_A = \{0, 5, 7, 10, 12, 14, 15, 17, 19, 20, 21, 22\}$ and

$$
C_B = \{0, 3, 6, 7, 9, 10\}
$$
 and $D_B = \{0, 4, 7, 8, 11, 12, 14, 15, 16\}$

such that

$$
|\mathcal{C}_A| + |\mathcal{D}_A| = |\mathcal{C}_B| + |\mathcal{D}_B| = 15.
$$

For all $h\geq 5$ we have

$$
hA = C_A \cup [6, 7h - 18] \cup (7h - \mathcal{D}_A)
$$

and

$$
hB = \mathcal{C}_B \cup [18, 7h - 18] \cup (7h - \mathcal{D}_B)
$$

and so

$$
|hA| = |hB| = 7h - 14.
$$

It follows that $|hA| = |hB|$ for all $h \geq 1$. Let $k = 4$. The sets

$$
A = \{0, 3, 5, 6\}
$$
 and $B = \{0, 4, 5, 6\}$

are affinely inequivalent with $|A| = |B| = 4$. For all $h \geq 2$ we have \overline{A} \overline{A} \overline{B} \overline{C} $\overline{$

$$
hA = A \cup [8, 6h]
$$

and

$$
h = B \cup [8, 6h]
$$

and so $|hA| = |hB| = 6h - 3$ for all $h \ge 2$. For all $k \geq 5$, the sets

 $A = \{0, 3, 5, 6\} \cup [8, k + 3]$ and $B = \{0, 4, 5, 6\} \cup [8, k + 3]$ are affinely inequivalent with $|A| = |B| = k$. For all $h \geq 2$ we have

$$
hA = A \cup [8, h(k+3)]
$$

and

$$
hB=B\cup [8,h(k+3)]
$$

and so $|hA| = |hB| = h(k+3) - 3$ for all $h \ge 2$. This completes the proof. \Box

A useful experimental class of finite sets of integers consists of sets that are the union of a finite interval of integers and one additional element. The following theorem computes the sumset sizes of these sets. In Appendix [4,](#page-6-6) there is a table of sumset sizes |hA| for such sets of size 6, that is, sets of the form $A = \{0, 1, 2, 3, 4\} \cup$ $\{w\}$ for $w \geq 5$.

Theorem 5. Let h and ℓ be positive integers. For every integer $w \geq \ell + 1$, let

$$
A_w = [0,\ell] \cup \{w\}
$$

and

$$
j_0 = j_0(w) = [h + 1 - \frac{w}{\ell}].
$$

If $w \leq h\ell$, then

(1)
$$
|hA_w| = j_0w + 1 + \frac{(h - j_0)(2 + \ell(h - j_0 + 1))}{2}.
$$

If $w \geq h\ell + 1$, then

(2)
$$
|hA_w| = \frac{(h+1)(\ell h + 2)}{2}.
$$

Proof. This is true for $h = 1$ and all $\ell \geq 1$ because $|A_w| = \ell + 2$. Let $h \geq 2$. For all $j \in [0, h]$, consider the interval of integers

$$
I_j = jw + (h - j)[0, \ell] = [jw, jw + (h - j)\ell].
$$

Then

$$
hA_w = h([0, \ell] \cup \{w\}) = \bigcup_{j=0}^h (jw + (h-j)[0, \ell]) = \bigcup_{j=0}^h I_j.
$$

For all $j \in [1, h]$, we have

$$
\min(I_{j-1}) = (j-1)w < jw = \min(I_j).
$$

The intervals I_{j-1} and I_j intersect if and only if

$$
\min(I_j) \le \max(I_{j-1})
$$

if and only if

$$
jw \le (j-1)w + (h-j+1)\ell
$$

if and only if

$$
w \le (h - j + 1)\ell
$$

if and only if

$$
j \leq j_0 = \left[h + 1 - \frac{w}{\ell}\right].
$$

If $\ell + 1 \leq w \leq h\ell$, then $j_0 \geq 1$, the $j_0 + 1$ intervals $I_0, I_1, \ldots, I_{j_0}$ overlap, and

$$
L = \bigcup_{j=0}^{j_0} I_j = [0, j_0 w + (h - j_0)\ell].
$$

The $h + 1 - j_0$ intervals $L, I_{j_0+1}, \ldots, I_h$ are pairwise disjoint and so

$$
|hA_w| = \left| \bigcup_{j=0}^h I_j \right| = |L| + \sum_{j=j_0+1}^h |I_j|
$$

= $j_0w + (h - j_0)\ell + 1 + \sum_{j=j_0+1}^h ((h - j)\ell + 1)$
= $j_0w + 1 + \frac{(h - j_0)(2 + \ell(h - j_0 + 1))}{2}$.

If $w \ge h\ell + 1$, then the intervals I_0, I_1, \ldots, I_h are pairwise disjoint and

$$
|hA_w| = \sum_{j=0}^h |I_j| = \sum_{j=0}^h ((h-j)\ell + 1)
$$

=
$$
\frac{(h+1)(\ell h + 2)}{2}.
$$

This completes the proof.

Note that if $w = \ell q + r$ with $r \in [1, \ell]$, then $j_0(w) = h - q$.

It is interesting to consider the "experimental" data in Appendix [4.](#page-6-6) For $k = 6$ and $h \in \{2, 3, 4, 5\}$, there are the following pairs of sets.

For $h_1 = 2$, we have $|2A_9| = |2A_{10}| = 15$ and $|hA_9| < |hA_{10}|$ for all $h \ge 3$. For $h_1 = 3$, we have $|2A_{13}| = |2A_{14}| = 15$, $|3A_{13}| = |3A_{14}| = 28$, and $|hA_{13}| <$ $|hA_{14}|$ for all $h \geq 4$.

For $h_1 = 4$, we have $|2A_{17}| = |2A_{18}| = 15$, $|3A_{17}| = |3A_{18}| = 28$, $|4A_{17}| =$ $|4A_{18}| = 45$, and $|hA_{17}| < |hA_{18}|$ for all $h \ge 5$.

For $h_1 = 5$, we have $|2A_{21}| = |2A_{22}| = 15$, $|3A_{21}| = |3A_{22}| = 28$, $|4A_{21}| =$ $|4A_{22}| = 45$, $|5A_{21}| = |5A_{22}| = 66$, and $|hA_{21}| < |hA_{22}|$ for all $h \ge 6$.

These examples suggest the following result.

Theorem 6. For all integers $k \geq 3$ and $h_1 \geq 1$, there exist finite sets A and B with $|A| = |B| = k$ such that $|hA| = |hB|$ for all $h \leq h_1$ and $|hA| < |hB|$ for all $h > h_1$.

Proof. The proof is by explicit construction.

For $k = 3$ and $h_1 \ge 1$, let $A = \{0, 1, h_1 + 1\}$ and $B = \{0, 1, h_1 + 2\}$. For $k \geq 4$, let $\ell = k - 2$ and $w = (h_1 + 1)\ell$. Note that $\ell \geq 2$. Consider the sets

$$
A = A_w = [0, \ell] \cup \{w\}
$$

and

$$
B = A_{w+1} = [0, \ell] \cup \{w+1\}.
$$

For all $h \in [1, h_1]$ we have

$$
h\ell + 1 \le h_1\ell + 1 < (h_1 + 1)\ell = w
$$
\n
$$
< w + 1 = (h_1 + 1)\ell + 1
$$
\n
$$
< (h_1 + 2)\ell.
$$

Applying formula [\(2\)](#page-3-0) of Theorem [5,](#page-3-1) for all $h \in [1, h_1]$ we obtain

$$
|hA| = |hB| = \frac{(h+1)(\ell h + 2)}{2}
$$

and

$$
|(h_1 + 1)B| = \frac{(h_1 + 2)(\ell(h_1 + 1) + 2)}{2}
$$

$$
= \frac{(h_1 + 2)(w + 2)}{2}
$$

For $h = h_1 + 1$ and $w = (h_1 + 1)\ell$, we have

$$
j_0 = [h + 1 - \frac{w}{\ell}] = [h_1 + 2 - \frac{(h_1 + 1)\ell}{\ell}] = 1.
$$

Because $w \leq (h_1 + 1)\ell$, formula [\(1\)](#page-3-2) of Theorem [5](#page-3-1) gives

$$
|(h_1 + 1)A| = j_0 w + 1 + \frac{(h_1 + 1 - j_0)(2 + \ell(h_1 + 2 - j_0))}{2}
$$

= $w + 1 + \frac{h_1(2 + w)}{2}$
= $\frac{(h_1 + 2)(w + 2)}{2} - 1$
= $|(h + 1)B| - 1$

and so $|(h_1 + 1)A| < |(h_1 + 1)B|$. This completes the proof.

4. Open problems

Problem 1. There are finite sets A and B with $|h_1A| > |h_1B|$, $|h_2A| = |h_2B|$, and $|h_3A| < |h_3B|$ for some $h_1 < h_2 < h_3$. For example, if

 $A = \begin{bmatrix} 0, 4 \end{bmatrix}$ $B = \{0, 1, 3, 6\}$ $C = \{0, 13, 7\}$

then

$$
2A = [0, 8] \qquad 2B = [0, 4] \cup \{6, 7, 9, 12\} \qquad 2C = [0, 4] \cup \{6, 7, 8, 10, 14\}
$$

and

 $3A = \begin{bmatrix} 0, 12 \end{bmatrix}$ $3B = \begin{bmatrix} 0, 10 \end{bmatrix} \cup \{12, 13, 15, 18\}$ $3C = \begin{bmatrix} 0, 11 \end{bmatrix} \cup \{13, 14, 15, 17, 21\}$ and

 $4A = [0, 16]$ $4B = [0, 16] \cup \{18, 19, 21, 24\}$ $4C = [0, 18] \cup \{20, 21, 22, 24, 28\}$ We have

$$
|A| = 5 > 4 = |B| = |C|
$$

\n
$$
|2A| = 9 = |2B| \t |2C| = [0, 11] \cup \{13, 14, 15, 17, 21\}
$$

\n
$$
|3A| = 13 < 15 = |3B| \t |3C| = 17
$$

\n
$$
|4A| = 17, \t |4B| = 21, \t |4C| = 24.
$$

Do there exist finite sets of integers A and B with $|h_1A| > |h_1B|$ and $|h_2A| <$ | $|h_2B|$ and $|hA_3| > |h_3B|$ for some $h_1 < h_2 < h_3$?

Problem 2. Let A and B be finite sets of integers with $|A| = |B|$. Prove or disprove: If $|h_1A| > |h_1B|$, then $|hA| > |hB|$ for all $h > h_1$.

Problem 3. Let A and B be nonempty finite sets of integers with $|A| = |B|$. Prove that if $|h_0A| < |h_0B|$, then $|hA| < |hB|$ for all $h > h_0$. Note that this implies that if $|h_0A| < |h_0B|$, then $|hA| \leq |hB|$ for all $h \leq h_0$.

Problem 4. Let A be a finite set of integers. What structural information about A can be deduced from the sumset size sequence $(|hA|)_{h=1}^{\infty}$?

Problem 5. Consider analogous inverse problems for restricted sumsets, that is, sumsets of the form

$$
hA = \{a_1 + \cdots + a_h : a_i \in A \text{ and } a_i \neq a_j \text{ for } i \neq j\}.
$$

Problem 6. Consider analogous inverse problems for sums of finite subsets of the additive group of lattice points \mathbf{Z}^n .
