# $\alpha$-Pfaffian, pfaffian point process and shifted Schur measure

#### Abstract

For any complex number $\alpha$ and any even-size skew-symmetric matrix $B$, we define a generalization $\operatorname{pf}_{\alpha}(B)$ of the pfaffian $\operatorname{pf}(B)$ which we call the $\alpha$-pfaffian. The $\alpha$-pfaffian is a pfaffian analogue of the $\alpha$-determinant studied in ST] and [V]. It gives the pfaffian at $\alpha=-1$. We give some formulas for $\alpha$-pfaffians and study the positivity. Further we define point processes determined by the $\alpha$-pfaffian. Also we provide a linear algebraic proof of the explicit pfaffian expression obtained in $M$ for the correlation function of the shifted Schur measure. 2000 Mathematics Subject Classification :Primary 15A15, Secondary 15A48, 05E05, 60G55 Key Words: $\alpha$-pfaffian, $\alpha$-determinant, pfaffian, pfaffian point process, Schur $Q$-function, shifted Schur measure.


## 1 Introduction

Let $\alpha$ be a complex number and $A=\left(a_{i j}\right)_{1 \leq i, j \leq n}$ be a square matrix. Then the $\alpha$-determinant of $A$ is introduced in [ST] and is given by

$$
\begin{equation*}
\operatorname{det}_{\alpha}(A)=\sum_{\sigma \in \mathfrak{S}_{n}} \alpha^{n-\nu(\sigma)} \prod_{i=1}^{n} a_{i \sigma(i)}, \tag{1.1}
\end{equation*}
$$

where $\nu(\sigma)$ stands for the number of cycles in $\sigma \in \mathfrak{S}_{n}$ (see also [ $\mathbb{V}$ ). Remark that in $\overline{\mathrm{V}}$ it is called the $\alpha$-permanent. This gives a determinant at $\alpha=-1$ or a permanent at $\alpha=1$ :

\operatorname{det}_{-1}(A)=\sum_{\sigma \in \mathfrak{S}_{n}} \operatorname{sgn}(\sigma) \prod_{i=1}^{n} a_{i \sigma(i)}=\operatorname{det}(A), \quad \operatorname{det}_{1}(A)=\sum_{\sigma \in \mathfrak{S}_{n}} \prod_{i=1}^{n} a_{i \sigma(i)}=\operatorname{per}(A)
$$

For a sequence $\boldsymbol{i}=\left(i_{1}, i_{2}, \ldots, i_{k}\right) \in\{1,2, \ldots, n\}^{k}$, we put

$$
A_{\boldsymbol{i}}=\left(\begin{array}{ccc}
a_{i_{1} i_{1}} & \ldots & a_{i_{1} i_{k}} \\
\vdots & \ddots & \vdots \\
a_{i_{k} i_{1}} & \ldots & a_{i_{k} i_{k}}
\end{array}\right) .
$$

Define a norm $\|A\|$ of $A$ by

$$
\|A\|=\sup _{\|v\|=1, v \in \mathbb{C}^{n}}\|A v\|
$$

where $\|v\|$ stands for the standard norm in $\mathbb{C}^{n}$. Then it is proved in $\mathbb{V}$ (see also [ST]) that if $z \in \mathbb{C}$ satisfies $\|\alpha z A\|<1$, we have

$$
\begin{equation*}
\operatorname{det}\left(I_{n}-\alpha z A\right)^{-1 / \alpha}=\sum_{k=0}^{\infty} \frac{z^{k}}{k!} \sum_{1 \leq i_{1}, i_{2}, \ldots, i_{k} \leq n} \operatorname{det}_{\alpha}\left(A_{i_{1} i_{2} \ldots i_{k}}\right), \tag{1.2}
\end{equation*}
$$

where $I_{n}$ is the $n$ by $n$ unit matrix. Note that if $\alpha \in\{-1 / m ; m=1,2, \ldots\}$, the equation (1.2) holds without the condition for $z$ since $\operatorname{det}\left(I_{n}+\frac{1}{m} z A\right)^{m}$ is a polynomial for $z$. In particular, when $\alpha=-1$, the formula (1.2) provides the expansion of the characteristic polynomial:

\begin{equation*}
\operatorname{det}\left(I_{n}+z A\right)=\sum_{k=0}^{n} z^{k} \sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n} \operatorname{det}\left(A_{i_{1} i_{2} \ldots i_{k}}\right) . \tag{1.3}
\end{equation*}
$$

Our first aim in this paper is to obtain a pfaffian version of (1.2). For that purpose, we define a pfaffian analogue $\operatorname{pf}_{\alpha}(B)$ of the $\alpha$-determinant for a skew-symmetric matrix $B$ whose size is even. This analogue $\operatorname{pf}_{\alpha}(B)$, which we will call the $\alpha$-pfaffian of $B$, the $\alpha$-pfaffian gives a new expression of the usual pfaffian at $\alpha=-1$, i.e., $\mathrm{pf}_{-1}(B)=\mathrm{pf}(B)$ (see Section 2.2). Further, for a particular skew-symmetric matrix, the $\alpha$-pfaffian gives the $\alpha$-determinant. Therefore we can regard the $\alpha$-pfaffian as a generalization of the pfaffian and the $\alpha$-determinant.

The second aim is to construct a point process determined by the $\alpha$-pfaffian. It covers the $\alpha$-determinantal point process studied in [ST] and the usual pfaffian point process studied in [BR, [ R , and [ S .

The third aim is to regard the shifted Schur measure as a pfaffian point process and to obtain a linear algebraic proof of the explicit pfaffian expression of its correlation function by the same technique in BR . The shifted Schur measure is the measure which gives the probability $2^{-\ell(\lambda)} Q_{\lambda}(u) Q_{\lambda}(v)$ to each strict partition $\lambda$, where $\ell(\lambda)$ is the length of $\lambda$ and $Q_{\lambda}(u)$ (resp. $Q_{\lambda}(v)$ ) is the Schur $Q$-function associated with $\lambda$ in the variables $u=\left(u_{1}, u_{2}, \ldots\right)$ (resp. $v=\left(v_{1}, v_{2}, \ldots\right)$ ). Its correlation function was obtained by using vertex operators on the exterior algebra in (M). We give a new and more direct proof.

The fourth aim is to study the positivity of $\alpha$-pfaffians. The positivity is important for existences of the point processes determined by $\alpha$-pfaffians. In [ST], the following conjecture for $\alpha$-determinants is established.

Conjecture $1.1([\mathbf{S T}])$. Let $\alpha \in[0,2] \cup\{-1 / m ; m=1,2, \ldots\}$. Then $\operatorname{det}_{\alpha}(A) \geq 0$ whenever $A$ is a non-negative definite hermitian matrix.

This is true if $\alpha \in\{2 / m ; m=1,2, \ldots\} \cup\{0\} \cup\{-1 / m ; m=1,2, \ldots\}$. We study an $\alpha$-pfaffian version of this conjecture.

## $2 \alpha$-Pfaffian

### 2.1 Basic facts of the pfaffian

We recall the definition of the pfaffian. For a skew-symmetric matrix $B=\left(b_{k l}\right)_{1 \leq k, l \leq 2 m}$, the pfaffian of $B$ is defined by

$$
\begin{equation*}
\operatorname{pf}(B)=\sum_{\sigma \in \widetilde{\mathcal{F}}_{2 m}} \operatorname{sgn}(\sigma) \prod_{j=1}^{m} b_{\sigma(2 j-1) \sigma(2 j)}, \tag{2.1}
\end{equation*}
$$

where $\mathfrak{F}_{2 m}$ is the subset of $\mathfrak{S}_{2 m}$ given by

$$
\begin{align*}
& \mathfrak{F}_{2 m}=\left\{\sigma=(\sigma(1), \sigma(2), \ldots, \sigma(2 m)) \in \mathfrak{S}_{2 m} ;\right.  \tag{2.2}\\
& \\
& \quad \sigma(2 j-1)<\sigma(2 j)(1 \leq j \leq m), \sigma(1)<\sigma(3)<\cdots<\sigma(2 m-1)\} .
\end{align*}
$$

For convenience, we define $\operatorname{pf}(\emptyset)=1$ if $m=0$. We consider a matrix of the form

$$
B=\left(\begin{array}{ccc}
B(1,1) & \ldots & B(1, m) \\
\vdots & \ddots & \vdots \\
B(m, 1) & \ldots & B(m, m)
\end{array}\right)
$$

where each $B(r, s)$ is a 2 by 2 block given by

$$
B(r, s)=\left(\begin{array}{cc}
B_{00}(r, s) & B_{01}(r, s) \\
B_{10}(r, s) & B_{11}(r, s)
\end{array}\right)=\left(\begin{array}{cc}
b_{2 r-1,2 s-1} & b_{2 r-1,2 s} \\
b_{2 r, 2 s-1} & b_{2 r, 2 s}
\end{array}\right) \quad \text { for } 1 \leq r, s \leq m .
$$

We call $B(r, s)$ the $(r, s)$-block of $B$. Since $b_{k l}=-b_{l k}$ for $1 \leq k, l \leq 2 m$, it holds that $B_{i j}(r, s)=$ $-B_{j i}(s, r)$ for $i, j \in\{0,1\}$ and $1 \leq r, s \leq m$. For a finite sequence $S=\left(s_{1}, s_{2}, \ldots, s_{k}\right) \in\{1, \ldots, m\}^{k}$, we put

$$
B[S]=\left(\begin{array}{ccc}
B\left(s_{1}, s_{1}\right) & \ldots & B\left(s_{1}, s_{k}\right) \\
\vdots & \ddots & \vdots \\
B\left(s_{k}, s_{1}\right) & \ldots & B\left(s_{k}, s_{k}\right)
\end{array}\right) .
$$

Then $B[S]$ is also skew-symmetric.
Let $J_{m}$ be the $2 m$ by $2 m$ skew-symmetric matrix whose $(r, s)$-block is given by

$$
\left(\begin{array}{cc}
0 & \delta_{r s} \\
-\delta_{r s} & 0
\end{array}\right) .
$$

The following proposition is a pfaffian analogue of (1.3).
Proposition 2.1. Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix and $J_{m}$ be above. For any $z$, we have

$$
\begin{equation*}
\operatorname{pf}\left(J_{m}+z B\right)=\sum_{k=0}^{m} z^{k} \sum_{1 \leq s_{1}<s_{2}<\cdots<s_{k} \leq m} \operatorname{pf}\left(B\left[s_{1}, s_{2}, \ldots, s_{k}\right]\right) . \tag{2.3}
\end{equation*}
$$

Proof. By the definition (2.1) of the pfaffian, we have

$$
\begin{aligned}
\operatorname{pf}\left(J_{m}+z B\right) & =\sum_{\sigma \in \mathfrak{F}_{2 m}} \operatorname{sgn}(\sigma) \prod_{j=1}^{m}\left(z b_{\sigma(2 j-1) \sigma(2 j)}+\left(J_{m}\right)_{\sigma(2 j-1) \sigma(2 j)}\right) \\
& =\sum_{\sigma \in \widetilde{\mathfrak{F}}_{2 m}} \operatorname{sgn}(\sigma) \sum_{k=0}^{m} z^{k} \sum_{\substack{S \subset\{1, \ldots, m\} \\
\# S=k}}\left(\prod_{j \in S} b_{\sigma(2 j-1) \sigma(2 j)}\right)\left(\prod_{j \in\{1, \ldots, m\} \backslash S}\left(J_{m}\right)_{\sigma(2 j-1) \sigma(2 j)}\right) .
\end{aligned}
$$

Since $\prod_{j \in\{1, \ldots, m\} \backslash S}\left(J_{m}\right)_{\sigma(2 j-1) \sigma(2 j)}=0$ unless $\sigma(2 j-1)=2 j-1$ and $\sigma(2 j)=2 j$ for all $j \in$ $\{1, \ldots, m\} \backslash S$, we have

$$
\operatorname{pf}\left(J_{m}+z B\right)=\sum_{k=0}^{m} z^{k} \sum_{1 \leq s_{1}<\cdots<s_{k} \leq m} \sum_{\tau \in \widetilde{\mathfrak{F}}_{2 k}} \operatorname{sgn}(\tau) \prod_{i=1}^{k} b_{\tau\left(2 s_{i}-1\right) \tau\left(2 s_{i}\right)}=\sum_{k=0}^{m} z^{k} \sum_{\substack{S \subset\{1, \ldots, m\}, \# S=k}} \operatorname{pf}(B[S]),
$$

where $\mathfrak{F}_{2 k}$ acts on $\left\{2 s_{1}-1,2 s_{1}, \ldots, 2 s_{k}-1,2 s_{k}\right\}$.

### 2.2 Definition of $\alpha$-pfaffian

Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. For a cycle $\tau=\left(k_{1}, k_{2}, \ldots, k_{r}\right)$, we put

$$
\begin{align*}
& P(B)(\tau)=P(B)\left(k_{1}, k_{2}, \ldots, k_{r}\right) \\
= & \frac{1}{2} \sum_{i_{1}, i_{2}, \ldots, i_{r} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{1}+i_{2}+\cdots+i_{r}} B_{i_{1}, i_{2}+1}\left(k_{1}, k_{2}\right) B_{i_{2}, i_{3}+1}\left(k_{2}, k_{3}\right) \cdots B_{i_{r}, i_{1}+1}\left(k_{r}, k_{1}\right), \tag{2.4}
\end{align*}
$$

where $\mathbb{Z} / 2 \mathbb{Z}=\{0,1\}$. This is independent of the way of expressions of the cycle $\tau$ :

$$
P(B)\left(k_{1}, k_{2}, \ldots, k_{r}\right)=P(B)\left(k_{2}, \ldots, k_{r}, k_{1}\right)=\cdots .
$$

For any complex number $\alpha$, we define the $\alpha$-pfaffian of $B$ by

$$
\begin{equation*}
\operatorname{pf}_{\alpha}(B)=\sum_{\sigma \in \mathfrak{S}_{m}} \alpha^{m-\nu(\sigma)} \prod_{j=1}^{\nu(\sigma)} P(B)\left(\sigma^{(j)}\right), \tag{2.5}
\end{equation*}
$$

where $\sigma=\sigma^{(1)} \sigma^{(2)} \cdots \sigma^{(\nu(\sigma))}$ is the cycle decomposition of $\sigma$.
We now provide another expression of the $\alpha$-pfaffian. Let $\tau=\left(k_{1}, k_{2}, \ldots, k_{r}\right)$ be a cycle and suppose that $k_{1}$ is the smallest among $k_{1}, k_{2}, \ldots, k_{r}$. Then we put

$$
\begin{aligned}
Q(B)(\tau) & =Q(B)\left(k_{1}, k_{2}, \ldots, k_{r}\right) \\
& =\sum_{i_{2}, \ldots, i_{r} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{2}+\cdots+i_{r}} B_{0, i_{2}+1}\left(k_{1}, k_{2}\right) B_{i_{2}, i_{3}+1}\left(k_{2}, k_{3}\right) \cdots B_{i_{r}, 1}\left(k_{r}, k_{1}\right)
\end{aligned}
$$

if $r \geq 2$, or $Q(B)(\tau)=B_{01}\left(k_{1}, k_{1}\right)$ if $r=1$. For $\tau^{-1}=\left(k_{1}, k_{r}, k_{r-1}, \ldots, k_{2}\right)$, we have

$$
Q(B)\left(\tau^{-1}\right)=\sum_{i_{2}, \ldots, i_{r} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{2}+\cdots+i_{r}} B_{0, i_{2}+1}\left(k_{1}, k_{r}\right) B_{i_{2}, i_{3}+1}\left(k_{r}, k_{r-1}\right) \cdots B_{i_{r}, 1}\left(k_{2}, k_{1}\right) .
$$

Since $B_{i j}(r, s)=-B_{j i}(s, r)$, changing the indices of $i_{2}, \ldots, i_{r}$, we see that

$$
=\sum_{i_{2}, \ldots, i_{r} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{2}+\cdots+i_{r}+r} B_{1, i_{2}}\left(k_{1}, k_{2}\right) B_{i_{2}+1, i_{3}}\left(k_{2}, k_{3}\right) \cdots B_{i_{r}+1,0}\left(k_{r}, k_{1}\right) .
$$

Further, if we change indices as $j_{p}=i_{p}+1$, we obtain

$$
=\sum_{j_{2}, \ldots, j_{r} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{j_{2}+\cdots+j_{r}} B_{1, j_{2}+1}\left(k_{1}, k_{2}\right) B_{j_{2}, j_{3}+1}\left(k_{2}, k_{3}\right) \cdots B_{j_{r}, 0}\left(k_{r}, k_{1}\right) .
$$

Therefore we get the equality $2 P(B)(\tau)=Q(B)(\tau)+Q(B)\left(\tau^{-1}\right)$. Hence we have the
Proposition 2.2. We have

$$
\begin{equation*}
\operatorname{pf}_{\alpha}(B)=\sum_{\sigma \in \mathfrak{S}_{m}} \alpha^{m-\nu(\sigma)} \prod_{j=1}^{\nu(\sigma)} Q(B)\left(\sigma^{(j)}\right) \tag{2.6}
\end{equation*}
$$

Example 2.1. We abbreviate $Q(B)(\tau)$ to $Q(\tau)$.

- The case where $m=1$. We have $\operatorname{pf}_{\alpha}(B)=Q(1)=B_{01}(1,1)=b_{12}$ for any $\alpha$.
- The case where $m=2$. Since $Q(1,2)=\sum_{i \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i} B_{0, i+1}(1,2) B_{i, 1}(2,1)$, we have

$$
\begin{aligned}
\operatorname{pf}_{\alpha}(B) & =Q(1) Q(2)+\alpha Q(1,2) \\
& =B_{01}(1,1) B_{01}(2,2)+\alpha\left(B_{01}(1,2) B_{01}(2,1)-B_{00}(1,2) B_{11}(2,1)\right) \\
& =b_{12} b_{34}+\alpha\left(b_{14} b_{32}-b_{13} b_{42}\right)=b_{12} b_{34}+\alpha\left(b_{13} b_{24}-b_{14} b_{23}\right) .
\end{aligned}
$$

We compare the number of terms in the expression (2.6) with that in the definition (2.1) of the pfaffian. The number of terms in (2.6) as a polynomial of $\alpha$ is at most $\sum_{\sigma \in \mathfrak{S}_{m}} 2^{m-\nu(\sigma)}$. On the other hand, the number of terms in (2.1) equals $(2 m-1)!!$. We can show that

$$
\begin{equation*}
\sum_{\sigma \in \mathfrak{S}_{m}} 2^{m-\nu(\sigma)}=(2 m-1)!! \tag{2.7}
\end{equation*}
$$

in the following Proposition 2.3] Therefore the number of terms in the $\alpha$-pfaffian is equal to the number of them in the pfaffian (when $\alpha=-1$ ).

Proposition 2.3. For any complex number $x$, we have

$$
\begin{equation*}
\sum_{\sigma \in \mathfrak{S}_{m}} x^{m-\nu(\sigma)}=\prod_{k=0}^{m-1}(k x+1) \tag{2.8}
\end{equation*}
$$

In particular, $\sum_{\sigma \in \mathfrak{S}_{m}} x^{m-\nu(\sigma)}=0$ if $x=-\frac{1}{k}(k=1,2, \ldots, m-1)$.
Proof. We prove (2.8) by induction on $m$. When $m=1$, both sides in (2.8) equal 1. Assume that the equality holds for $m-1$. Put $\mathfrak{S}_{m}(m, k)=\left\{\sigma \in \mathfrak{S}_{m} ; \sigma(m)=k\right\}$ for $1 \leq k \leq m$. We define a bijective map $s$ from $\mathfrak{S}_{m}(m, k)$ to $\mathfrak{S}_{m-1}$ by removing $m$ from the cycle decomposition of $\sigma \in \mathfrak{S}_{m}(m, k)$. For example, we see that $s((124)(365))=(124)(35)$ for $(124)(365) \in \mathfrak{S}_{6}(6,5)$.

Since $\nu(s(\sigma))$ is equal to $\nu(\sigma)$ if $\sigma \in \mathfrak{S}_{m}(m, k)(1 \leq k \leq m-1)$, or to $\nu(\sigma)-1$ if $\sigma \in \mathfrak{S}_{m}(m, m)$, we have

$$
\begin{aligned}
& \sum_{\sigma \in \mathfrak{S}_{m}} x^{m-\nu(\sigma)}= \\
= & \sum_{k=1}^{m} \sum_{\sigma \in \mathfrak{S}_{m}(m, k)} x^{m-\nu(\sigma)}=\sum_{k=1}^{m-1} \sum_{\pi \in \mathfrak{S}_{m-1}} x^{m-\nu(\pi)}+\sum_{\pi \in \mathfrak{S}_{m-1}} x^{m-1-\nu(\pi)} \\
=((m-1) x+1) & \sum_{\pi \in \mathfrak{S}_{m-1}} x^{m-1-\nu(\pi)} .
\end{aligned}
$$

By the assumption of the induction, (2.8) follows immediately.
The $\alpha$-pfaffian has the following invariance.
Proposition 2.4. Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. Then we have

$$
\operatorname{pf}_{\alpha}\left({ }^{t} J_{m} B J_{m}\right)=\operatorname{pf}_{\alpha}(B) .
$$

Proof. Put $\widetilde{B}={ }^{t} J_{m} B J_{m}$. Then it is easy to see that $\widetilde{B}_{i j}(r, s)=(-1)^{i+j} B_{i+1, j+1}(r, s)$ for $i, j=0,1$ and $r, s=1,2, \ldots, m$. Therefore we see that $P(\widetilde{B})(\tau)=P(B)(\tau)$ for any cycle $\tau$ so that $\operatorname{pf}_{\alpha}(\widetilde{B})=$ $\operatorname{pf}_{\alpha}(B)$.

Remark 2.1. For the usual pfaffian, the equality $\operatorname{pf}\left({ }^{t} T B T\right)=\operatorname{pf}(B) \operatorname{det}(T)$ holds for any $2 m$ by $2 m$ skew-symmetric matrix $B$ and for any $2 m$ by $2 m$ matrix $T$. But we cannot expect a similar formula for general $\alpha$-pfaffians.

### 2.3 Expansions of the power of a pfaffian

Now we give a pfaffian version of (1.2).
Theorem 2.5. Let $\alpha$ be a non-zero complex number and $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. If $z \in \mathbb{C}$ satisfies $\|\alpha z B\|<1$, then we have

$$
\begin{equation*}
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha}=\sum_{k=0}^{\infty} \frac{z^{k}}{k!} \sum_{1 \leq s_{1}, s_{2}, \ldots, s_{k} \leq m} \operatorname{pf}_{\alpha}\left(B\left[s_{1}, s_{2}, \ldots, s_{k}\right]\right) . \tag{2.9}
\end{equation*}
$$

Here if $\alpha \in\{-1 / p ; p=1,2, \ldots\}$, the equation (2.9) holds without the condition for $z$.
To prove the theorem, we need a lemma.
Lemma 2.6. For a cycle $\tau=\left(k_{1}, k_{2}, \ldots, k_{r}\right)$, we have

$$
\operatorname{tr}\left(\left(-J_{1}\right) B\left(k_{1}, k_{2}\right)\left(-J_{1}\right) B\left(k_{2}, k_{3}\right) \cdots\left(-J_{1}\right) B\left(k_{r}, k_{1}\right)\right)=2 P(B)(\tau)
$$

Proof. Since

$$
-J_{1} B(r, s)=\left(\begin{array}{cc}
-B_{10}(r, s) & -B_{11}(r, s) \\
B_{00}(r, s) & B_{01}(r, s)
\end{array}\right),
$$

the claim follows immediately from the definition (2.4) of $P(B)(\tau)$.

Proof of Theorem 2.5. Since $\operatorname{pf}(B)^{2}=\operatorname{det}(B), \operatorname{det}\left( \pm J_{m}\right)=1$ and $J_{m}^{2}=-I_{2 m}$, we have

$$
\begin{aligned}
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha} & =\operatorname{det}\left(J_{m}-\alpha z B\right)^{-1 /(2 \alpha)}=\left(\operatorname{det}\left(-J_{m}\right) \operatorname{det}\left(J_{m}-\alpha z B\right)\right)^{-1 /(2 \alpha)} \\
& =\operatorname{det}\left(I_{2 m}-\alpha z\left(-J_{m} B\right)\right)^{-1 /(2 \alpha)}
\end{aligned}
$$

By the assumption on $z$, we have $\left\|\alpha z J_{m} B\right\| \leq\left\|J_{m}\right\| \cdot\|\alpha z B\|<1$. Thus we obtain

$$
\operatorname{det}\left(I_{2 m}-\alpha z\left(-J_{m} B\right)\right)^{-1 /(2 \alpha)}=\exp \left(\frac{1}{2 \alpha} \sum_{p=1}^{\infty} \frac{(\alpha z)^{p}}{p} \operatorname{tr}\left(T^{p}\right)\right)
$$

where we put $T=-J_{m} B$. If we expand the right hand side, then

$$
\begin{align*}
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha} & =1+\sum_{l=1}^{\infty} \frac{(2 \alpha)^{-l}}{l!} \sum_{p_{1}, p_{2}, \ldots, p_{l} \geq 1}(\alpha z)^{p_{1}+p_{2}+\cdots+p_{l}} \frac{\operatorname{tr}\left(T^{p_{1}}\right) \operatorname{tr}\left(T^{p_{2}}\right) \cdots \operatorname{tr}\left(T^{p_{l}}\right)}{p_{1} p_{2} \cdots p_{l}} \\
& =1+\sum_{k=1}^{\infty}(\alpha z)^{k} \sum_{l=1}^{k} \frac{(2 \alpha)^{-l}}{l!} \sum_{\substack{p_{1}, p_{2}, \ldots, p_{l} \geq 1, p_{1}+p_{2}+\cdots+p_{l}=k}} \frac{\operatorname{tr}\left(T^{p_{1}}\right) \operatorname{tr}\left(T^{p_{2}}\right) \cdots \operatorname{tr}\left(T^{p_{l}}\right)}{p_{1} p_{2} \cdots p_{l}} \tag{2.10}
\end{align*}
$$

For a partition $\rho=\left(\rho_{1}, \rho_{2}, \ldots, \rho_{l}\right)$ of weight $k$ and of length $\ell(\rho)=l$, we denote by $C_{\rho}$ the conjugate class of cycle type $\rho$ in $\mathfrak{S}_{k}$. It is easy to see that

$$
\frac{1}{l!} \sum_{\substack{p_{1}, p_{2}, \ldots, p_{l} \geq 1 \\ p_{1}+p_{2}+\cdots+p_{l}=k \\\left\{p_{1}, p_{2}, \ldots, p_{l}\right\}=\left\{\rho_{1}, \rho_{2}, \ldots, \rho_{l}\right\}}} \frac{k!}{p_{1} p_{2} \cdots p_{l}}=\# C_{\rho}=\sum_{\sigma \in C_{\rho}} 1
$$

where the sum in the left hand side is all over the sequence $\left(p_{1}, p_{2}, \ldots, p_{l}\right)$ of $l$ positive integers satisfying the conditions $p_{1}+\cdots+p_{l}=k$ and $\left\{p_{1}, \ldots, p_{l}\right\}=\left\{\rho_{1}, \ldots, \rho_{l}\right\}$. Hence we have

$$
\begin{equation*}
\frac{1}{l!} \sum_{\substack{p_{1}, p_{2}, \ldots, p_{l} \geq 1 \\ p_{1}+p_{2}+\cdots+p_{l}=k}} \frac{\operatorname{tr}\left(T^{p_{1}}\right) \operatorname{tr}\left(T^{p_{2}}\right) \cdots \operatorname{tr}\left(T^{p_{l}}\right)}{p_{1} p_{2} \cdots p_{l}}=\frac{1}{k!} \sum_{\substack{\rho \vdash k \\ \ell(\rho)=l}} \sum_{\sigma \in C_{\rho}} \operatorname{tr}\left(T^{\rho_{1}}\right) \operatorname{tr}\left(T^{\rho_{2}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right) . \tag{2.11}
\end{equation*}
$$

By (2.10) and (2.11), we have

$$
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha}=1+\sum_{k=1}^{\infty} \frac{(\alpha z)^{k}}{k!} \sum_{l=1}^{k}(2 \alpha)^{-l} \sum_{\substack{\rho \vdash k \\ \ell(\rho)=l}} \sum_{\sigma \in C_{\rho}} \operatorname{tr}\left(T^{\rho_{1}}\right) \operatorname{tr}\left(T^{\rho_{2}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right)
$$

Since

$$
\operatorname{tr}\left(T^{p}\right)=\operatorname{tr}\left(\left(-J_{m} B\right)^{p}\right)=\sum_{1 \leq s_{1}, \ldots, s_{p} \leq m} \operatorname{tr}\left(\left(-J_{1} B\left(s_{1}, s_{2}\right)\right) \cdots\left(-J_{1} B\left(s_{p}, s_{1}\right)\right)\right)
$$

it follows from Lemma 2.6 that

$$
\begin{aligned}
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha} & =1+\sum_{k=1}^{\infty} \frac{(\alpha z)^{k}}{k!} \sum_{1 \leq s_{1}, \ldots, s_{k} \leq m} \sum_{l=1}^{k}(2 \alpha)^{-l} \sum_{\substack{\rho \vdash k \\
\ell(\rho)=l}} \sum_{\sigma \in C_{\rho}} 2^{l} \prod_{j=1}^{l} P\left(B\left[s_{1}, \ldots, s_{k}\right]\right)\left(\sigma^{(j)}\right) \\
& =1+\sum_{k=1}^{\infty} \frac{z^{k}}{k!} \sum_{1 \leq s_{1}, \ldots, s_{k} \leq m} \sum_{l=1}^{k} \alpha^{k-l} \sum_{\substack{\rho \vdash k \\
\ell(\rho)=l}} \sum_{\sigma \in C_{\rho}} \prod_{j=1}^{l} P\left(B\left[s_{1}, \ldots, s_{k}\right]\right)\left(\sigma^{(j)}\right) .
\end{aligned}
$$

If $\sigma \in C_{\rho}$, then $\nu(\sigma)=\ell(\rho)$ so that we obtain

$$
\operatorname{pf}\left(J_{m}-\alpha z B\right)^{-1 / \alpha}=1+\sum_{k=1}^{\infty} \frac{z^{k}}{k!} \sum_{1 \leq s_{1}, \ldots, s_{k} \leq m} \operatorname{pf}_{\alpha}\left(B\left[s_{1}, \ldots, s_{k}\right]\right)
$$

This completes the proof of the theorem.
Remark 2.2. It is clear that

$$
\exp \left(z \sum_{s=1}^{m} B_{01}(s, s)\right)=\sum_{k=0}^{\infty} \frac{z^{k}}{k!} \sum_{1 \leq s_{1}, \ldots, s_{k} \leq m} \prod_{j=1}^{k} B_{01}\left(s_{j}, s_{j}\right)
$$

for any $z$. We may regard this formula as a limit of (2.9) as $\alpha \rightarrow 0$.
From Proposition 2.1 and Theorem 2.5 we obtain a new expression of the pfaffian.
Corollary 2.7. For any $2 m$ by $2 m$ skew-symmetric matrix $B$ we have

$$
\begin{equation*}
\operatorname{pf}(B)=\operatorname{pf}_{-1}(B)=\sum_{\sigma \in \mathfrak{S}_{m}} \operatorname{sgn}(\sigma) \prod_{j=1}^{\nu(\sigma)} Q(B)\left(\sigma^{(j)}\right) \tag{2.12}
\end{equation*}
$$

### 2.4 Connections to $\alpha$-determinants and some formulas

Let $\mathfrak{g l}_{m}=\mathfrak{g l}_{m}(\mathbb{C})$ be the set of all $m$ by $m \mathbb{C}$-matrices and $\mathfrak{o}_{2 m}=\mathfrak{o}_{2 m}(\mathbb{C})$ be the set of all $2 m$ by $2 m$ skew-symmetric $\mathbb{C}$-matrices. For $A=\left(a_{i j}\right)_{1 \leq i, j \leq m} \in \mathfrak{g l}_{m}$, we denote by $\omega(A) \in \mathfrak{o}_{2 m}$ the skew-symmetric matrix whose $(r, s)$-block is given by

$$
\left(\begin{array}{cc}
0 & a_{r s} \\
-a_{s r} & 0
\end{array}\right)
$$

In other words,

$$
\omega(A)=\left(\begin{array}{ll}
0 & 1  \tag{2.13}\\
0 & 0
\end{array}\right) \otimes A+\left(\begin{array}{cc}
0 & 0 \\
-1 & 0
\end{array}\right) \otimes^{t} A
$$

where $\otimes$ is the Kronecker product. It is clear that the map $\omega: \mathfrak{g l}_{m} \rightarrow \mathfrak{o}_{2 m}$ is linear and injective. The following proposition assures that the $\alpha$-pfaffian is a generalization of $\alpha$-determinant.

Proposition 2.8. For $A \in \mathfrak{g l}_{m}$, we have $\operatorname{pf}_{\alpha}(\omega(A))=\operatorname{det}_{\alpha}(A)$.
Proof. It is easy to see that $Q(\omega(A))(\tau)=a_{k_{1} k_{2}} a_{k_{2} k_{3}} \cdots a_{k_{r} k_{1}}$ for a cycle $\tau=\left(k_{1}, k_{2}, \ldots, k_{r}\right)$. Therefore by (2.6) and (1.1) we have $\mathrm{pf}_{\alpha}(\omega(A))=\operatorname{det}_{\alpha}(A)$.

Remark 2.3. It is well known that $\operatorname{pf}(B)^{2}=\operatorname{det}(B)$ in the case of $\alpha=-1$. But we cannot expect a similar formula for general $\alpha$.

Theorem 2.5 reduces (1.2) by Proposition 2.8. Now we describe some formulas for $\alpha$-pfaffians and $\alpha$-determinants.
$\alpha$-Pfaffian

Proposition 2.9. Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. Then we have

$$
\operatorname{pf}_{\alpha}\left(J_{m}+z B\right)=\sum_{S \subset\{1, \ldots, m\}} z^{\# S} \operatorname{pf}_{\alpha}(B[S]) .
$$

In particular, for any $m$ by $m$ matrix $A$

$$
\operatorname{det}_{\alpha}\left(I_{m}+z A\right)=\sum_{S \subset\{1, \ldots, m\}} z^{\# S} \operatorname{det}_{\alpha}\left(A_{S}\right) .
$$

Proof. The first formula is obtained in a similar way to Proposition 2.1 The second formula is clear from the first formula and Proposition 2.8

Proposition 2.10. Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. Then we have

$$
\operatorname{pf}_{\alpha}(B)=\frac{1}{2^{m}} \sum_{i_{1}, \ldots, i_{m} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{1}+\cdots+i_{m}} \operatorname{det}_{2 \alpha}\left(B_{i_{r}, i_{s}+1}(r, s)\right)_{1 \leq r, s \leq m} .
$$

Proof. By the definition (2.5) of the $\alpha$-pfaffian, we have

$$
\begin{aligned}
\operatorname{pf}_{\alpha}(B) & =\sum_{\sigma \in \mathfrak{S}_{m}} \alpha^{m-\nu(\sigma)} 2^{-\nu(\sigma)} \sum_{i_{1}, i_{2}, \ldots, i_{m} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{1}+i_{2}+\cdots+i_{m}} \prod_{k=1}^{m} B_{i_{k}, i_{\sigma(k)}+1}(k, \sigma(k)) \\
& =\frac{1}{2^{m}} \sum_{i_{1}, i_{2}, \ldots, i_{m} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{1}+\cdots+i_{m}} \sum_{\sigma \in \mathfrak{S}_{m}}(2 \alpha)^{m-\nu(\sigma)} \prod_{k=1}^{m} B_{i_{k}, i_{\sigma(k)}+1}(k, \sigma(k)) \\
& =\frac{1}{2^{m}} \sum_{i_{1}, i_{2}, \ldots, i_{m} \in \mathbb{Z} / 2 \mathbb{Z}}(-1)^{i_{1}+\cdots+i_{m}} \operatorname{det}_{2 \alpha}\left(B_{i_{r}, i_{s}+1}(r, s)\right)_{1 \leq r, s \leq m} .
\end{aligned}
$$

For an arbitrary matrix $T \in \mathfrak{g l}_{n}$ and a non-negative integer $k$, we define $\mathbb{T}_{k}^{(\alpha)}(T)$ by $\mathbb{T}_{k}^{(\alpha)}(T)=$ $\frac{1}{2^{k}!} \operatorname{det}_{\alpha}\left(Z_{k}(T)\right)$, where

$$
Z_{k}(T)=\left(\begin{array}{cccccc}
\operatorname{tr}(T) & 2 & 0 & \ldots & 0 & 0 \\
\operatorname{tr}\left(T^{2}\right) & \operatorname{tr}(T) & 4 & \ldots & 0 & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\
\operatorname{tr}\left(T^{k-2}\right) & \operatorname{tr}\left(T^{k-3}\right) & \operatorname{tr}\left(T^{k-4}\right) & \ldots & 2(k-2) & 0 \\
\operatorname{tr}\left(T^{k-1}\right) & \operatorname{tr}\left(T^{k-2}\right) & \operatorname{tr}\left(T^{k-3}\right) & \ldots & \operatorname{tr}(T) & 2(k-1) \\
\operatorname{tr}\left(T^{k}\right) & \operatorname{tr}\left(T^{k-1}\right) & \operatorname{tr}\left(T^{k-2}\right) & \ldots & \operatorname{tr}\left(T^{2}\right) & \operatorname{tr}(T)
\end{array}\right)
$$

for $k \geq 1$ and $\mathbb{T}_{0}(T)=1$.
Then we have
Proposition 2.11. Let $B$ be any $2 m$ by $2 m$ skew-symmetric matrix. Then we have

$$
\mathbb{T}_{m}^{(\alpha)}\left(-J_{m} B\right)=\frac{1}{m!} \sum_{1 \leq s_{1}, \ldots, s_{m} \leq m} \operatorname{pf}_{\alpha}\left(B\left[s_{1}, \ldots, s_{m}\right]\right)
$$

In particular, $\mathbb{T}_{m}^{(-1)}\left(-J_{m} B\right)=\operatorname{pf}(B)$.

The case of $\alpha=-1$ is obtained in Lemma 2.5 in $K W$. We need a lemma to prove the proposition. Denote by $z_{m}(T)_{i j}$ the $(i, j)$-entry of the matrix $Z_{m}(T)$.

Lemma 2.12. Let $\rho=\left(\rho_{1}, \ldots, \rho_{l}\right)$ be a partition of $m$ whose length is $l$ and $C_{\rho}$ be a conjugate class of $\mathfrak{S}_{m}$ indexed by $\rho$. For the matrix $Z_{m}(T)$, we have

$$
\begin{equation*}
\sum_{\sigma \in C_{\rho}} \prod_{j=1}^{m} z_{m}(T)_{j \sigma(j)}=2^{m-l} \operatorname{tr}\left(T^{\rho_{1}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right) \sum_{\sigma \in C_{\rho}} 1 \tag{2.14}
\end{equation*}
$$

Proof. For a cycle $\tau=\left(12 \ldots \rho_{1}\right)\left(\rho_{1}+1 \ldots \rho_{1}+\rho_{2}\right) \cdots$ in $C_{\rho}$, we see that

$$
\begin{aligned}
\prod_{j=1}^{m} z_{m}(T)_{j \tau(j)} & =2 \cdot 4 \cdots 2\left(\rho_{1}-1\right) \cdot \operatorname{tr}\left(T^{\rho_{1}}\right) \cdot 2\left(\rho_{1}+1\right) \cdots 2\left(\rho_{1}+\rho_{2}-1\right) \operatorname{tr}\left(T^{\rho_{2}}\right) \cdots \\
& =2^{m-l} \frac{m!}{\rho_{1}\left(\rho_{1}+\rho_{2}\right) \cdots\left(\rho_{1}+\rho_{2}+\cdots+\rho_{l}\right)} \operatorname{tr}\left(T^{\rho_{1}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right)
\end{aligned}
$$

Since $z_{m}(T)_{i j}=0$ if $j>i+1$, only the terms for the permutations whose forms are $\sigma=$ $\left(12 \ldots a_{1}\right)\left(a_{1}+1 \ldots a_{1}+a_{2}\right) \ldots$ remain in the left hand side of (2.14), where $a_{1}, a_{2}, \ldots$ are permutations for $\rho_{1}, \rho_{2}, \ldots$ Therefore

$$
\begin{aligned}
& \sum_{\sigma \in C_{\rho}} \prod_{j=1}^{m} z_{m}(T)_{j \sigma(j)} \\
= & 2^{m-l} m!\operatorname{tr}\left(T^{\rho_{1}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right)\left(\prod_{r \geq 1} \frac{1}{m_{r}(\rho)!}\right) \sum_{\pi \in \mathfrak{S}_{l}} \frac{1}{\rho_{\pi(1)}\left(\rho_{\pi(1)}+\rho_{\pi(2)}\right) \cdots\left(\rho_{\pi(1)}+\rho_{\pi(2)}+\cdots+\rho_{\pi(l)}\right)},
\end{aligned}
$$

where $m_{r}(\rho)$ is the multiplicity of $r$ in $\rho=\left(\rho_{1}, \ldots, \rho_{l}\right)$. It is easy to see that this equals

$$
=2^{m-l} m!\operatorname{tr}\left(T^{\rho_{1}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right)\left(\prod_{r \geq 1} \frac{1}{m_{r}(\rho)!}\right) \frac{1}{\rho_{1} \cdots \rho_{l}}=2^{m-l} \operatorname{tr}\left(T^{\rho_{1}}\right) \cdots \operatorname{tr}\left(T^{\rho_{l}}\right) \# C_{\rho}
$$

We have proved the lemma.
Proof of Proposition 2.11. We have

$$
\mathbb{T}_{m}^{(\alpha)}\left(-J_{m} B\right)=\frac{1}{2^{m} m!} \sum_{\rho \vdash m} \alpha^{m-\ell(\rho)} \sum_{\sigma \in C_{\rho}} \prod_{j=1}^{m} z_{m}\left(-J_{m} B\right)_{j \sigma(j)}
$$

where $\rho \vdash m$ means that $\rho$ is a partition of $m$. By Lemma 2.12,

$$
=\frac{1}{m!} \sum_{\rho \vdash m} \alpha^{m-\ell(\rho)} 2^{-\ell(\rho)} \operatorname{tr}\left(\left(-J_{m} B\right)^{\rho_{1}}\right) \cdots \operatorname{tr}\left(\left(-J_{m} B\right)^{\rho_{l}}\right) \sum_{\sigma \in C_{\rho}} 1
$$

In a similar way to the proof of Theorem 2.5, we can obtain the first claim in the proposition.
In the case of $\alpha=-1$, we see that

$$
\mathbb{T}_{m}^{(-1)}\left(-J_{m} B\right)=\frac{1}{m!} \sum_{\substack{1 \leq s_{1}, \ldots, s_{m} \leq m, s_{1}, \ldots, s_{m} \text { are distinct }}} \operatorname{pf}\left(B\left[s_{1}, \ldots, s_{m}\right]\right)=\operatorname{pf}(B)
$$

Remark 2.4. Let $\lambda$ be a partition of $n$ and $A=\left(a_{i j}\right)$ be a matrix in $\mathfrak{g l}_{n}$. Then the immanant of $A$ is defined by $\operatorname{Imm}_{\lambda}(A)=\sum_{\sigma \in \mathfrak{S}_{n}} \chi^{\lambda}(\sigma) \prod_{i=1}^{n} a_{i \sigma(i)}$, where $\chi^{\lambda}$ is the irreducible character of $\mathfrak{S}_{n}$ associated with $\lambda$, see [J]. It is easy to see that $\operatorname{Imm}_{(n)}(A)=\operatorname{per}(A)$ and $\operatorname{Imm}_{\left(1^{n}\right)}(A)=\operatorname{det}(A)$. We can define a pfaffian analogue of the immanant by

$$
\operatorname{pf}^{\lambda}(B)=\sum_{\sigma \in \mathfrak{S}_{m}} \chi^{\lambda}(\sigma) \prod_{j=1}^{\nu(\sigma)} Q(B)\left(\sigma^{(j)}\right),
$$

where $B \in \mathfrak{o}_{2 m}$ and $\lambda$ is a partition of $m$. We immediately see $\mathrm{pf}^{(m)}(B)=\mathrm{pf}_{1}(B)$ and $\mathrm{pf}^{\left(1^{m}\right)}(B)=$ $\operatorname{pf}_{-1}(B)=\operatorname{pf}(B)$. As like Proposition [2.8] we obtain $\operatorname{pf}^{\lambda}(\omega(A))=\operatorname{Imm}_{\lambda}(A)$ for $A \in \mathfrak{g l}_{m}$ and a partition $\lambda$ of $m$, that is, $\mathrm{pf}^{\lambda}$ is an extension of the immanant.

## $3 \alpha$-Pfaffian point processes

Let $\mathfrak{X}$ be a countable set. Let $L$ be a map

$$
L: \mathfrak{X} \times \mathfrak{X} \rightarrow \mathfrak{g l}_{2}(\mathbb{C}) ;(x, y) \mapsto L(x, y)=\left(\begin{array}{ll}
L_{00}(x, y) & L_{01}(x, y) \\
L_{10}(x, y) & L_{11}(x, y)
\end{array}\right)
$$

such that $L_{i j}(x, y)=-L_{j i}(y, x)$ for any $i, j \in\{0,1\}$ and $x, y \in \mathfrak{X}$. Such $L$ is called a skewsymmetric matrix kernel on $\mathfrak{X}$, see [ $\mathbb{R}$, $\underline{[ }$. We regard the map $L$ as an operator on the Hilbert space $\ell^{2}(\mathfrak{X}) \oplus \ell^{2}(\mathfrak{X})$. Then $L$ is a matrix whose blocks are indexed by elements in $\mathfrak{X} \times \mathfrak{X}$. For $n$-point $x_{1}, x_{2}, \ldots, x_{n} \in \mathfrak{X}$, we denote by $L\left[x_{1}, x_{2}, \ldots, x_{n}\right]$ the $2 n$ by $2 n$ skew-symmetric matrix $\left(L\left(x_{i}, x_{j}\right)\right)_{1 \leq i, j \leq n}$.

Let $J$ be the skew-symmetric matrix kernel determined by $J(x, y)=J_{1} \delta_{x, y}$ and $\alpha$ be a real number. Suppose that $\operatorname{pf}_{\alpha}\left(L\left[x_{1}, \ldots, x_{n}\right]\right)$ are non-negative for all $\left(x_{1}, x_{2}, \ldots, x_{n}\right) \in \mathfrak{X}^{n}(n \geq 1)$ and that $\|\alpha L\|<1$, where $\|\cdot\|$ is the operator norm with respect to the Hilbert space $\ell^{2}(\mathfrak{X}) \oplus \ell^{2}(\mathfrak{X})$. By Theorem [2.5. we have

$$
\begin{equation*}
\operatorname{pf}(J-\alpha L)^{-1 / \alpha}=\sum_{n=0}^{\infty} \frac{1}{n!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \operatorname{pf}_{\alpha}\left(L\left[x_{1}, \ldots, x_{n}\right]\right) \tag{3.1}
\end{equation*}
$$

Here if $\# \mathfrak{X}=\infty$ then we put $\operatorname{pf}(J+L):=\sum_{\substack{X \subset \mathfrak{x},\\}} \operatorname{pf}(L[X])$. We consider a probability density on $\bigcup_{n=0}^{\infty} \mathfrak{X}^{n}$ defined by

$$
\begin{equation*}
p_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=\frac{1}{n!} \operatorname{pf}(J-\alpha L)^{1 / \alpha} \operatorname{pf}_{\alpha}\left(L\left[x_{1}, \ldots, x_{n}\right]\right) \quad \text { on } \mathfrak{X}^{n} . \tag{3.2}
\end{equation*}
$$

By (3.1), we have $\sum_{n=0}^{\infty} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} p_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=1$.
Put $\mathfrak{Q}(\mathfrak{X})=\bigcup_{n=0}^{\infty} \mathfrak{X}^{n} / \sim$, where we write $\left(x_{1}, \ldots, x_{n}\right) \sim\left(y_{1}, \ldots, y_{n}\right)$ for two elements in $\mathfrak{X}^{n}$ if and only if there exists a permutation $\sigma \in \mathfrak{S}_{n}$ such that $y_{j}=x_{\sigma(j)}(1 \leq j \leq n)$. We define a point process $\pi_{L}^{(\alpha)}$ on $\mathfrak{X}$ by the equality

$$
\begin{equation*}
\sum_{X \in \mathfrak{Q}(\mathfrak{X})} \pi_{L}^{(\alpha)}(X) f(X)=\sum_{n=0}^{\infty} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} p_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right) f\left(x_{1}\right) \cdots f\left(x_{n}\right) \tag{3.3}
\end{equation*}
$$

for any test function $f$ on $\mathfrak{X}$. Here we write $f(X)=f\left(x_{1}\right) \cdots f\left(x_{n}\right)$ for any sequence ( $x_{1}, \ldots, x_{n}$ ) in a class $X$. More explicitly, $\pi_{L}^{(\alpha)}$ is a probability measure on $\mathfrak{Q}(\mathfrak{X})$ defined by

$$
\begin{equation*}
\pi_{L}^{(\alpha)}(X)=\frac{1}{\prod_{x \in \mathfrak{X}} m_{x}(X)!} \operatorname{pf}(J-\alpha L)^{1 / \alpha} \operatorname{pf}_{\alpha}(L[X]) \quad \text { for } X \in \mathfrak{Q}(\mathfrak{X}), \tag{3.4}
\end{equation*}
$$

where $m_{x}(X)$ is the multiplicity of $x$ in $X$. We call this measure $\pi_{L}^{(\alpha)}$ the $\alpha$-pfaffian point process on $\mathfrak{X}$ determined by a skew-symmetric matrix kernel $L$.

The $n$-point correlation function is defined by

$$
\begin{equation*}
\rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=\sum_{k=0}^{\infty} \frac{(n+k)!}{k!} \sum_{x_{n+1}, \ldots, x_{n+k} \in \mathfrak{X}} p_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}, x_{n+1}, \ldots, x_{n+k}\right) \tag{3.5}
\end{equation*}
$$

for $\left(x_{1}, \ldots, x_{n}\right) \in \mathfrak{X}^{n}$.
Theorem 3.1. Let $L$, $p_{L}^{(\alpha)}$, and $\rho_{L}^{(\alpha)}$ be as above. Put $K_{\alpha}=-\alpha^{-1}\left(J+(J-\alpha L)^{-1}\right)$ and $\widetilde{K}_{\alpha}=$ $L(I+\alpha J L)^{-1}$. Assume that $\operatorname{pf}_{\alpha}\left(K_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right)$ is non-negative for any $x_{1}, \ldots, x_{n} \in \mathfrak{X}$. Then we have $\rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=\operatorname{pf}_{\alpha}\left(K_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right)=\operatorname{pf}_{\alpha}\left(\widetilde{K}_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right)$.

Proof. Put $K_{\alpha}^{\prime}=-J \widetilde{K}_{\alpha} J$. Then it follows that $\left(J+\alpha K_{\alpha}^{\prime}\right)(J-\alpha L)=-I-\alpha J L+\alpha\left(-J \widetilde{K}_{\alpha} J\right) J(I+$ $\alpha J L)=-I$ so that $K_{\alpha}^{\prime}=-\alpha^{-1}\left(J+(J-\alpha L)^{-1}\right)=K_{\alpha}$. Therefore by Proposition 2.4 it is enough to prove $\rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=\operatorname{pf}_{\alpha}\left(\widetilde{K}_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right)$.

We abbreviate $p_{L}^{(\alpha)}$ to $p$ simply. Let $f(x)$ be a function on $\mathfrak{X}$ such that $f_{0}(x)=f(x)-1$ is finitely supported. We have

$$
\begin{aligned}
& \sum_{m=0}^{\infty} \sum_{y_{1}, \ldots, y_{m} \in \mathfrak{X}} p\left(y_{1}, \ldots, y_{m}\right) \prod_{j=1}^{m} f\left(y_{j}\right)=\sum_{m=0}^{\infty} \sum_{y_{1}, \ldots, y_{m} \in \mathfrak{X}} p\left(y_{1}, \ldots, y_{m}\right) \prod_{j=1}^{m}\left(1+f_{0}\left(y_{j}\right)\right) \\
= & \sum_{m=0}^{\infty} \sum_{n=0}^{m}\binom{m}{n} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \prod_{j=1}^{n} f_{0}\left(x_{j}\right) \sum_{x_{n+1}, \ldots, x_{m} \in \mathfrak{X}} p\left(x_{1}, \ldots, x_{n}, x_{n+1}, \ldots, x_{m}\right) \\
= & \sum_{n=0}^{\infty} \sum_{k=0}^{\infty} \frac{(n+k)!}{n!k!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X} j=1} \prod_{j}^{n} f_{0}\left(x_{j}\right) \sum_{x_{n+1}, \ldots, x_{n+k} \in \mathfrak{X}} p\left(x_{1}, \ldots, x_{n}, x_{n+1}, \ldots, x_{n+k}\right) \\
= & \sum_{n=0}^{\infty} \frac{1}{n!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right) \prod_{j=1}^{n} f_{0}\left(x_{j}\right) .
\end{aligned}
$$

When we put $\sqrt{f}(x)=\sqrt{f(x)}$ and identify $\sqrt{f}$ with the matrix with $(x, y)$-block $\sqrt{f}(x) I_{2} \delta_{x, y}$, we have $\operatorname{det}\left(\sqrt{f}\left[x_{1}, \ldots, x_{n}\right]\right)=f\left(x_{1}\right) \cdots f\left(x_{n}\right)$. Therefore we get

$$
\begin{aligned}
& \sum_{m=0}^{\infty} \sum_{y_{1}, \ldots, y_{m} \in \mathfrak{X}} p\left(y_{1}, \ldots, y_{m}\right) \prod_{j=1}^{m} f\left(y_{j}\right) \\
= & \sum_{m=0}^{\infty} \frac{1}{m!} \sum_{y_{1}, \ldots, y_{m} \in \mathfrak{X}} \operatorname{pf}_{\alpha}\left((\sqrt{f} L \sqrt{f})\left[y_{1}, \ldots, y_{m}\right]\right) \operatorname{pf}(J-\alpha L)^{1 / \alpha} \\
= & \operatorname{pf}(J-\alpha \sqrt{f} L \sqrt{f})^{-1 / \alpha} \operatorname{pf}(J-\alpha L)^{1 / \alpha}
\end{aligned}
$$

by (3.1). Further we see that

$$
\begin{aligned}
& \operatorname{det}(J-\alpha \sqrt{f} L \sqrt{f}) \operatorname{det}(J-\alpha L)^{-1}=\operatorname{det}\left((J-\alpha f L)(J-\alpha L)^{-1}\right) \\
= & \operatorname{det}\left((-J)(J-\alpha f L)(J-\alpha L)^{-1} J\right)=\operatorname{det}\left(\left(I+\alpha\left(1+f_{0}\right) J L\right)(I+\alpha J L)^{-1}\right) \\
= & \operatorname{det}\left(I+f_{0} J \widetilde{K}_{\alpha}\right)=\operatorname{det}\left(J-\alpha f_{0} \widetilde{K}_{\alpha}\right)=\operatorname{det}\left(J-\alpha \sqrt{f_{0}} \widetilde{K}_{\alpha} \sqrt{f_{0}}\right) .
\end{aligned}
$$

Hence, by (3.1) again,

$$
\begin{aligned}
& \sum_{m=0}^{\infty} \sum_{y_{1}, \ldots, y_{m} \in \mathfrak{X}} p\left(y_{1}, \ldots, y_{m}\right) \prod_{j=1}^{m} f\left(y_{j}\right)=\operatorname{pf}\left(J-\alpha \sqrt{f_{0}} L \sqrt{f_{0}}\right)^{-1 / \alpha} \operatorname{pf}(J-\alpha L)^{1 / \alpha} \\
= & \operatorname{pf}\left(J-\alpha \sqrt{f_{0}} \widetilde{K}_{\alpha} \sqrt{f_{0}}\right)^{-1 / \alpha}=\sum_{n=0}^{\infty} \frac{1}{n!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \operatorname{pf}_{\alpha}\left(\widetilde{K}_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right) \prod_{j=1}^{n} f_{0}\left(x_{j}\right) .
\end{aligned}
$$

Finally we have

$$
\sum_{n=0}^{\infty} \frac{1}{n!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right) \prod_{j=1}^{n} f_{0}\left(x_{j}\right)=\sum_{n=0}^{\infty} \frac{1}{n!} \sum_{x_{1}, \ldots, x_{n} \in \mathfrak{X}} \operatorname{pf}_{\alpha}\left(\widetilde{K}_{\alpha}\left[x_{1}, \ldots, x_{n}\right]\right) \prod_{j=1}^{n} f_{0}\left(x_{j}\right)
$$

for any finitely supported function $f_{0}$. This implies the theorem.
In general, we call the matrix $K$ such that $\rho\left(x_{1}, \ldots, x_{n}\right)=\operatorname{pf}\left(K\left[x_{1}, \ldots, x_{n}\right]\right)$ the correlation kernel for a correlation function $\rho$. The correlation kernel is not uniquely determined.

The $\alpha$-determinant version of the theorem above is obtained in [ST].
Example 3.1. Let $A$ be a trace class operator on $\mathfrak{X}$. Define a skew-symmetric matrix kernel $L$ by

$$
L(x, y)=\left(\begin{array}{cc}
0 & A(x, y) \\
-A(y, x) & 0
\end{array}\right)
$$

for $x, y \in \mathfrak{X}$. Then $\operatorname{pf}_{\alpha}(L[X])=\operatorname{det}_{\alpha}\left(A_{X}\right)$ by Proposition 2.8 where $A_{X}=(A(x, y))_{x, y \in X}$. Therefore the probability measure $\pi_{L}^{(\alpha)}$ is nothing but the $\alpha$-determinantal point process determined by $A$, which studied in [ST]. The correlation function is given as $\rho_{L}^{(\alpha)}\left(x_{1}, \ldots, x_{n}\right)=$ $\operatorname{det}_{\alpha}\left(B_{\alpha}\left(x_{i}, x_{j}\right)\right)_{1 \leq i, j \leq n}$, where $B_{\alpha}=A(I-\alpha A)^{-1}=-\alpha^{-1}\left(I-(I+A)^{-1}\right)$.

Remark 3.1. If $\operatorname{pf}_{\alpha}\left(L\left[x_{1}, \ldots, x_{n}\right]\right)$ is non-negative for $x_{1}, \ldots, x_{n} \in \mathfrak{X}$ and $\operatorname{pf}_{\alpha}(J+L)$ is nonnegative, then we can also define the point process on $\mathfrak{P}(\mathfrak{X})=\{X \subset \mathfrak{X} ; \# X$ is finite $\}$ from Proposition 2.9 by $\Pi_{L}^{(\alpha)}(X)=\operatorname{pf}_{\alpha}(J+L)^{-1} \operatorname{pf}_{\alpha}(L[X])$ for $X \in \mathfrak{P}(\mathfrak{X})$.

## 4 Shifted Schur measure and pfaffian point process

In this section, we obtain a linear algebraic proof of the explicit pfaffian expression of the correlation function for the shifted Schur measure. It is obtained in [M] via the vertex operators on the exterior algebra.

### 4.1 Definition of the shifted Schur measure

Let $u=\left(u_{1}, u_{2}, \ldots\right)$ and $v=\left(v_{1}, v_{2}, \ldots\right)$ be variables. Let $\mathcal{D}$ be the set of all strict partitions and $\ell(\lambda)$ be the length of a partition $\lambda \in \mathcal{D}$ (see Mac). Put

$$
Q_{u}(z)=\prod_{j=1}^{\infty} \frac{1+u_{j} z}{1-u_{j} z}
$$

The Schur $Q$-function $Q_{\lambda}(u)$ associated with $\lambda \in \mathcal{D}$ is defined as a coefficient of $z_{1}^{\lambda_{1}} \cdots z_{n}^{\lambda_{n}}$ in the formal series expansion of

$$
Q_{u}\left(z_{1}\right) \cdots Q_{u}\left(z_{n}\right) \prod_{1 \leq i<j \leq n} \frac{z_{i}-z_{j}}{z_{i}+z_{j}}
$$

where $n \geq \ell(\lambda)$ and $\frac{z-w}{z+w}=1+2 \sum_{k=1}^{\infty}(-1)^{k} z^{-k} w^{k}$.
The shifted Schur measure (see [M, TW]) is the probability measure on $\mathcal{D}$ given by

$$
\mathrm{P}_{\mathrm{SS}}(\lambda)=\frac{1}{Z_{\mathrm{SS}}} 2^{-\ell(\lambda)} Q_{\lambda}(u) Q_{\lambda}(v),
$$

where $Z_{\mathrm{SS}}$ is the constant determined by the Cauchy identity ([Mac, III-8])

$$
Z_{\mathrm{SS}}=\sum_{\lambda \in \mathcal{D}} 2^{-\ell(\lambda)} Q_{\lambda}(u) Q_{\lambda}(v)=\prod_{i, j=1}^{\infty} \frac{1+u_{i} v_{j}}{1-u_{i} v_{j}} .
$$

The correlation function for the shifted Schur measure is defined by

$$
\rho_{\mathrm{SS}}(\lambda)=\mathrm{P}_{\mathrm{SS}}(\{\mu \in \mathcal{D} ; \mu \supset \lambda\})=\sum_{\mu \in \mathcal{D}, \mu \supset \lambda} \mathrm{P}_{\mathrm{SS}}(\mu) \quad \text { for } \lambda \in \mathcal{D},
$$

where $\mu \supset \lambda$ means $\left\{\mu_{1}, \ldots, \mu_{\ell(\mu)}\right\} \supset\left\{\lambda_{1}, \ldots, \lambda_{\ell(\lambda)}\right\}$. The aim in this section is to obtain a new proof of the following theorem in M .

Theorem 4.1. For any strict partition $\lambda=\left(\lambda_{1}, \ldots, \lambda_{l}\right) \in \mathcal{D}$, we have

$$
\rho_{\mathrm{SS}}(\lambda)=\operatorname{pf}\left(\mathcal{K}\left[\lambda_{1}, \ldots, \lambda_{l}\right]\right),
$$

where $\mathcal{K}$ is a skew-symmetric matrix kernel whose blocks are

$$
\mathcal{K}(r, s)=\left(\begin{array}{ll}
\mathcal{K}_{00}(r, s) & \mathcal{K}_{01}(r, s) \\
\mathcal{K}_{10}(r, s) & \mathcal{K}_{11}(r, s)
\end{array}\right) \quad \text { for } r, s \geq 1 .
$$

The each entry is given as follows:

$$
\mathcal{K}_{00}(r, s)=\frac{1}{2}\left[z^{r} w^{s}\right] \frac{Q_{u}(z) Q_{u}(w)}{Q_{v}\left(z^{-1}\right) Q_{v}\left(w^{-1}\right)} \frac{z-w}{z+w},
$$

where $\frac{z-w}{z+w}=1+2 \sum_{k=1}^{\infty}(-1)^{k} z^{-k} w^{k}$ and $\left[z^{r} w^{s}\right]$ stands for the coefficient of $z^{r} w^{s}$, and

$$
\mathcal{K}_{01}(r, s)=-\mathcal{K}_{10}(s, r)=\frac{1}{2}\left[z^{r} w^{s}\right] \frac{Q_{u}(z) Q_{v}(w)}{Q_{v}\left(z^{-1}\right) Q_{u}\left(w^{-1}\right)} \frac{z w+1}{z w-1},
$$

where $\frac{z w+1}{z w-1}=-\left(1+2 \sum_{k=1}^{\infty} z^{k} w^{k}\right)$. Finally,

$$
\mathcal{K}_{11}(r, s)=\frac{1}{2}\left[z^{r} w^{s}\right] \frac{Q_{v}(z) Q_{v}(w)}{Q_{u}\left(z^{-1}\right) Q_{u}\left(w^{-1}\right)} \frac{w-z}{w+z},
$$

where $\frac{w-z}{w+z}=-\left(1+2 \sum_{k=1}^{\infty}(-1)^{k} z^{-k} w^{k}\right)$.
We regard the shifted Schur measure as a pfaffian point process. For that purpose, we recall the pfaffian point process, which is the case of $\alpha=-1$ in the $\alpha$-pfaffian point process defined in Section 3

Let $\mathfrak{P}(\mathfrak{X})=\{X \subset \mathfrak{X} ; \# X$ is finite $\}$. We define the pfaffian point process $\pi_{L}$ on $\mathfrak{X}$ determined by a skew-symmetric matrix kernel $L$ as the measure on $\mathfrak{P}(\mathfrak{X})$ given by

$$
\pi(X)=\pi_{L}(X)=\frac{\operatorname{pf}(L[X])}{\operatorname{pf}(J+L)} \quad \text { for } X \in \mathfrak{P}(\mathfrak{X}) .
$$

Then by Theorem 3.1 its correlation function is

$$
\begin{equation*}
\rho(X)=\sum_{Y \in \mathfrak{P}(\mathfrak{X}), Y \supset X} \pi(Y)=\operatorname{pf}(K[X]), \tag{4.1}
\end{equation*}
$$

where $K=J+(J+L)^{-1}$.
More generally, let $\mathfrak{Y}$ be a subset in $\mathfrak{X}$ such that $\mathfrak{Y}^{c}=\mathfrak{X} \backslash \mathfrak{Y}$ is finite. Then we can define a point process on $\mathfrak{Y}$ by

$$
\begin{equation*}
\pi_{L, \mathfrak{Y}}(X)=\frac{\operatorname{pf}\left(L\left[X \cup \mathfrak{Y}^{c}\right]\right)}{\operatorname{pf}(J[\mathfrak{Y}]+L)} \quad \text { for } X \in \mathfrak{P}(\mathfrak{Y}) . \tag{4.2}
\end{equation*}
$$

Here we identify $J[\mathfrak{Y}]$ with the block matrix $\left(\begin{array}{ll}J & 0 \\ 0 & 0\end{array}\right)$, where the blocks correspond to the partition $\mathfrak{X}=\mathfrak{Y} \sqcup \mathfrak{Y}{ }^{c}$. This process is called the conditional pfaffian point process determined by $L$. The correlation function is given as follows.

Proposition $4.2([\mathbf{B R}])$. Let $\rho_{L, \mathfrak{Y}}$ be the correlation function on $\mathfrak{Y}$ determined by a skewsymmetric matrix kernel $L$. Then we have $\rho_{L, \mathfrak{Y}}(X)=\operatorname{pf}(K[X])$ for $X \in \mathfrak{P}(\mathfrak{Y})$, where

$$
K=J[\mathfrak{Y}]+\left.(J[\mathfrak{Y}]+L)^{-1}\right|_{\mathfrak{Y} \times \mathfrak{Y}} .
$$

### 4.2 Proof of Theorem 4.1: 1st step

Let $u=\left(u_{1}, \ldots, u_{n}\right)$ and $v=\left(v_{1}, \ldots, v_{n}\right)$, where $n$ is even. The case that $n$ is odd is similar. We define a bijective map $\phi$ from $\mathcal{D}$ to $\mathfrak{P}^{\text {even }}\left(\mathbb{Z}_{\geq 0}\right)=\left\{X \in \mathfrak{P}\left(\mathbb{Z}_{\geq 0}\right) ; \# X\right.$ is even $\}$ by

$$
\phi(\lambda)= \begin{cases}\left\{\lambda_{1}, \ldots, \lambda_{\ell(\lambda)}\right\}, & \text { if } \ell(\lambda) \text { is even, } \\ \left\{\lambda_{1}, \ldots, \lambda_{\ell(\lambda)}, 0\right\}, & \text { if } \ell(\lambda) \text { is odd. }\end{cases}
$$

First we prove the following proposition.

Proposition 4.3. Define a skew-symmetric matrix kernel L on $\mathfrak{X}=\{1,2, \ldots, n\} \sqcup \mathfrak{Y}$ by

$$
L=\left(\begin{array}{cc}
\mathcal{V} & \mathcal{W} \eta^{-\frac{1}{2}} \\
-\eta^{-\frac{1}{2} t} \mathcal{W} & O
\end{array}\right)
$$

where $\mathfrak{Y}=\mathbb{Z}_{\geq 0}, \mathcal{V}=(\mathcal{V}(i, j))_{1 \leq i, j \leq n}$ and $\mathcal{W}=(\mathcal{W}(i, r))_{1 \leq i \leq n, r \in \mathbb{Z}_{\geq 0}}$. Their entries are given by

$$
\mathcal{V}(i, j)=\left(\begin{array}{cc}
-\frac{u_{i}-u_{j}}{u_{i}+u_{j}} & 0 \\
0 & \frac{v_{i}-v_{j}}{v_{i}+v_{j}}
\end{array}\right), \quad \mathcal{W}(i, r)=\left(\begin{array}{cc}
-u_{i}^{r} & 0 \\
0 & v_{i}^{r}
\end{array}\right) .
$$

Further $\eta$ is the matrix whose block is given by

$$
\eta(r, s)=\delta_{r s}\left(\begin{array}{cc}
\eta(r) & 0 \\
0 & \eta(r)
\end{array}\right) \quad \text { for } r, s \in \mathbb{Z}_{\geq 0}
$$

where $\eta(r)$ is equal to 1 if $r=0$, or to $\frac{1}{2}$ if $r \geq 1$. Then for $X \in \mathfrak{P}\left(\mathbb{Z}_{\geq 0}\right)$ we have

$$
\operatorname{pf}(L[X \cup\{1,2, \ldots, n\}])=2^{-\ell(\lambda)} Q_{\lambda}(u) Q_{\lambda}(v) \prod_{1 \leq i<j \leq n}\left(\frac{u_{i}-u_{j}}{u_{i}+u_{j}}\right) \prod_{1 \leq i<j \leq n}\left(\frac{v_{i}-v_{j}}{v_{i}+v_{j}}\right)
$$

if $\# X$ is even and $X=\phi(\lambda)$, and $\operatorname{pf}(L[X \cup\{1,2, \ldots, n\}])=0$ if $\# X$ is odd.
In order to prove the proposition, we need the lemma (see [Mac, III-8]).
Lemma 4.4 ([ $\mathbb{N}])$. The Schur $Q$-function can be written as

for $X \in \mathfrak{P}\left(\mathbb{Z}_{\geq 0}\right)$. Here $V(u)=\left(\frac{u_{i}-u_{j}}{u_{i}+u_{j}}\right)_{1 \leq i, j \leq n}$ and $W(u)_{X}=\left(u_{i}^{x}\right)_{1 \leq i \leq n, x \in X}$.
Proof of Proposition 4.3. Put $\mathcal{W}[X]=(\mathcal{W}(i, x))_{1 \leq i \leq n, x \in X}$ for $X \in \mathfrak{P}\left(\mathbb{Z}_{\geq 0}\right)$. Since

-^{t} \mathcal{W}[X] & O_{X}
\end{array}\right)\left(\begin{array}{cc}
I_{2 n} & O \\
O & \eta^{-\frac{1}{2}}[X]
\end{array}\right)
\end{aligned}
$$

for $X \in \mathfrak{P}\left(\mathbb{Z}_{\geq 0}\right)$, we have

\begin{aligned}
\operatorname{pf}(L[X \cup\{1,2, \ldots, n\}]) & =\operatorname{pf}\left(\begin{array}{cc}
\mathcal{V} & \mathcal{W}[X] \\
-{ }^{t} \mathcal{W}[X] & O_{X}
\end{array}\right) \operatorname{det}\left(\begin{array}{cc}
I_{2 n} & O \\
O & \eta^{-\frac{1}{2}}[X]
\end{array}\right) \\
& =\prod_{x \in X} \eta(x)^{-1} \cdot \operatorname{pf}\left(\begin{array}{cc}
\mathcal{V} & \mathcal{W}[X] \\
-{ }^{t} \mathcal{W}[X] & O_{X}
\end{array}\right)
\end{aligned}
$$

Changing orders of rows and columns, we have

\operatorname{pf}\left(\begin{array}{cc}
\mathcal{V} & \mathcal{W}[X] \\
-{ }^{t} \mathcal{W}[X] & O_{X}
\end{array}\right) & =(-1)^{(n+\# X)(n+\# X-1) / 2} \operatorname{pf}\left(\begin{array}{cc}
-A_{u}(X) & O \\
O & A_{v}(X)
\end{array}\right) \\
& =(-1)^{(n+\# X)(n+\# X-1) / 2+(n+\# X) / 2} \operatorname{pf}\left(A_{u}(X)\right) \operatorname{pf}\left(A_{v}(X)\right)
\end{aligned}
$$

Here if $\# X$ is odd then $\operatorname{pf}\left(A_{u}(X)\right)=0$. Hence we may assume $\# X$ is even. Put $\lambda=\phi^{-1}(X)$. Then it follows from Lemma 4.4 that

\end{aligned}

Since $\prod_{x \in X} \eta(x)=2^{-\ell(\lambda)}$ for $X=\phi(\lambda)$, we get the proposition.

### 4.3 Proof of Theorem 4.1: 2nd step

The shifted Schur measure is nothing but the conditional pfaffian point process determined by $L$ in Proposition 4.3. Thus from Proposition 4.2 we have to obtain an explicit expression of $K=J[\mathfrak{Y}]+\left.(J[\mathfrak{Y}]+L)^{-1}\right|_{\mathfrak{Y} \times \mathfrak{Y}}$.

Lemma 4.5. We have

where $\mathcal{M}=B D^{-1} C-A$, if $D$ and $\mathcal{M}$ are invertible.

Proof. This is straightforward, see e.g. BR.

By this lemma, the kernel $K=J[\mathfrak{Y}]+\left.(J[\mathfrak{Y}]+L)^{-1}\right|_{\mathfrak{Y} \times \mathfrak{Y}}$ is equal to $K=J[\mathfrak{Y}] \eta^{-\frac{1}{2} t} \mathcal{W} \mathcal{M}^{-1} \mathcal{W} \eta^{-\frac{1}{2}} J[\mathfrak{Y}]$, where $\mathcal{M}=\mathcal{W} \eta^{-\frac{1}{2}} J[\mathfrak{Y}] \eta^{-\frac{1}{2} t} \mathcal{W}-\mathcal{V}$. We may replace $K$ by

\mathcal{M}_{01}^{-1}(k, l) & =-\mathcal{M}_{10}^{-1}(l, k)  \tag{4.4}\\
& =\prod_{j=1}^{n}\left(\frac{1-u_{k} v_{j}}{1+u_{k} v_{j}} \frac{1-u_{j} v_{l}}{1+u_{j} v_{l}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{u_{k}+u_{i}}{u_{k}-u_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{v_{l}+v_{j}}{v_{l}-v_{j}}\right) \frac{1+u_{k} v_{l}}{1-u_{k} v_{l}} ; \\
\mathcal{M}_{11}^{-1}(k, l) & =-\prod_{j=1}^{n}\left(\frac{1-u_{j} v_{k}}{1+u_{j} v_{k}} \frac{1-u_{j} v_{l}}{1+u_{j} v_{l}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{v_{k}+v_{i}}{v_{k}-v_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{v_{l}+v_{j}}{v_{l}-v_{j}}\right) \frac{v_{k}-v_{l}}{v_{k}+v_{l}} . \tag{4.5}

We recall some formulas for pfaffians, which are obtained in IW.
Lemma 4.7 ([IW]). Let $n$ be any even number. Let $A$ and $B$ be $n$ by $n$ skew-symmetric matrices.

where we put $|\boldsymbol{i}|=i_{1}+i_{2}+\cdots+i_{p}$ and $\boldsymbol{i}^{c}=\left\{1, \ldots, \hat{i_{1}}, \ldots, \hat{i_{2}}, \ldots, \hat{i_{p}}, \ldots, n\right\}$ for an increasing sequence $\boldsymbol{i}=\left(i_{1}<i_{2}<\cdots<i_{p}\right)$.

Lemma 4.8 (Minor summation formula [IW]). Let $m \leq n$. Let $B$ be any $n$ by $n$ skewsymmetric matrix and $T$ be any $m$ by $n$ matrix. Then

where $T_{\boldsymbol{i}}^{1, \ldots, m}=\left(t_{k, i_{j}}\right)_{1 \leq k \leq m, 1 \leq j \leq m}$ for $T=\left(t_{i j}\right)_{1 \leq i \leq m, 1 \leq j \leq n}$ and $\boldsymbol{i}=\left(i_{1}<\cdots<i_{m}\right)$.
Lemma 4.9. Let $A$ be any $2 n$ by $2 n$ skew-symmetric matrix and $B$ be any $2 n$ by $2 m$ matrix. Assume that $n$ is even. Then we have

& =\sum_{\substack{\boldsymbol{i} \subset\{1, \ldots, 2 n\}, \# \boldsymbol{k} \subset\{1, \ldots, 2 m\}, \# \boldsymbol{i}, \ldots \text { even }}}(-1)^{|\boldsymbol{i}|+|\boldsymbol{k}|+(\# \boldsymbol{i}+\# \boldsymbol{k}) / 2} \operatorname{pf}\left(A_{\boldsymbol{i}}\right) \operatorname{pf}\left(\left(J_{m}\right)_{\boldsymbol{k}}\right) \operatorname{pf}\left(\left(\begin{array}{cc}
O & B \\
-{ }^{t} B & O
\end{array}\right)_{\left(\boldsymbol{i}^{c}, n+\boldsymbol{k}^{c}\right)}\right) \\
& =\sum_{\substack{\boldsymbol{i} \subset\{1, \ldots, 2 n\}, \boldsymbol{k} \subset\{1, \ldots, 2 m\}, \# \boldsymbol{i}: \text { even } \\
\# \boldsymbol{k}^{c}=\# \boldsymbol{i}^{c}}}(-1)^{|\boldsymbol{i}|+|\boldsymbol{k}|+(\# \boldsymbol{i}+\# \boldsymbol{k}) / 2+\# \boldsymbol{i}^{c} / 2} \operatorname{pf}\left(A_{\boldsymbol{i}}\right) \operatorname{pf}\left(\left(J_{m}\right)_{\boldsymbol{k}}\right) \operatorname{det}\left(B_{\boldsymbol{k}^{c}}^{\boldsymbol{i}^{c}}\right) .
\end{aligned}

Since it is easy to see that $\left(\# \boldsymbol{i}+\# \boldsymbol{i}^{c}\right) / 2=n \equiv 0(\bmod 2)$ and that $\operatorname{pf}\left(\left(J_{m}\right)_{\boldsymbol{k}}\right)=0$ unless $\boldsymbol{k}=$ $\left(2 r_{1}-1,2 r_{1}, \ldots, 2 r_{p}-1,2 r_{p}\right)$ for an increasing sequence $\left(r_{1}, \ldots, r_{p}\right)$, we have

$$

On the other hand, by Lemma 4.7 and Lemma 4.8

\mathrm{RHS} & =\sum_{\substack{\boldsymbol{i} \subset\{1, \ldots, 2 n\}, \# \boldsymbol{i}: \text { even }}}(-1)^{|\boldsymbol{i}|+\frac{\# \boldsymbol{i}}{2}} \operatorname{pf}\left(-A_{\boldsymbol{i}}\right) \operatorname{pf}\left(\left(B J_{m}{ }^{t} B\right)_{\boldsymbol{i}^{c}}\right) \\
& =\sum_{\substack{\boldsymbol{i} \subset\{1, \ldots, 2 n\}, \# \boldsymbol{i}: \text { even }}}(-1)^{|\boldsymbol{i}|} \operatorname{pf}\left(A_{\boldsymbol{i}}\right) \sum_{\substack{\boldsymbol{j} \subset\{1, \ldots, 2 m\}, \# \boldsymbol{j}=\# \boldsymbol{i}^{c}}} \operatorname{pf}\left(\left(J_{m}\right)_{\boldsymbol{j}}\right) \operatorname{det}\left(B_{\boldsymbol{j}}^{\boldsymbol{i}^{c}}\right) .
\end{aligned}
$$

Hence we obtain the lemma.
Proof of Proposition 4.6. It follows from Lemma 4.9 and Proposition 4.3 that

& =\prod_{1 \leq i, j \leq n}\left(\frac{1+u_{i} v_{j}}{1-u_{i} v_{j}}\right) \prod_{1 \leq i<j \leq n}\left(\frac{u_{i}-u_{j}}{u_{i}+u_{j}}\right) \prod_{1 \leq i<j \leq n}\left(\frac{v_{i}-v_{j}}{v_{i}+v_{j}}\right) \tag{4.6}
\end{align*}
$$

We write

\mathcal{M}_{00}(k, l) & \mathcal{M}_{01}(k, l) \\
\mathcal{M}_{10}(k, l) & \mathcal{M}_{11}(k, l)
\end{array}\right)=\left(\begin{array}{cc}
\frac{u_{k}-u_{l}}{u_{k}+u_{l}} & -\frac{1+u_{k} v_{l}}{1-u_{k} v_{l}} \\
\frac{1+v_{k} u_{l}}{1-v_{k} u_{l}} & -\frac{v_{k}-v_{l}}{v_{k}+v_{l}}
\end{array}\right)
$$

and $\mathcal{M}_{i j}=\left(\mathcal{M}_{i j}(k, l)\right)_{1 \leq k, l \leq n}$ for $i, j=0,1$. The skew-symmetric matrix

\widetilde{\mathcal{M}}=\left(\begin{array}{ll}
\mathcal{M}_{00} & \mathcal{M}_{01} \\
\mathcal{M}_{10} & \mathcal{M}_{11}
\end{array}\right)
$$

is obtained by changing orders of rows and columns from $\mathcal{M}$ and it satisfies $\operatorname{pf}(\widetilde{\mathcal{M}})=(-1)^{\frac{n}{2}} \operatorname{pf}(\mathcal{M})$. The pfaffian of the matrix $\widetilde{\mathcal{M}}^{[k, l]}$ obtained by removing the $k$-th row, $l$-th row, $k$-th column and $l$-th column from $\widetilde{\mathcal{M}}$, where $1 \leq k, l \leq n$, equals the value removed variables $u_{k}$ and $u_{l}$ from (4.6), up to sign. Namely, we have

$$

Thus for $k<l$

& \mathcal{M}_{00}^{-1}(k, l)=\left(\widetilde{\mathcal{M}}^{-1}\right)_{k, l}=\frac{(-1)^{k+l} \operatorname{pf}\left(\widetilde{\mathcal{M}}^{[k, l]}\right)}{\operatorname{pf}(\widetilde{\mathcal{M}})} \\
= & \prod_{j=1}^{n}\left(\frac{1-u_{k} v_{j}}{1+u_{k} v_{j}} \frac{1-u_{l} v_{j}}{1+u_{l} v_{j}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{u_{k}+u_{i}}{u_{k}-u_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{u_{l}+u_{j}}{u_{l}-u_{j}}\right) \frac{u_{k}-u_{l}}{u_{k}+u_{l}} .
\end{aligned}
$$

This equality holds also if $k \geq l$ so that we obtain (4.3).
Similarly, since $\widetilde{\mathcal{M}}^{[k, n+l]}$ is the matrix removed variables $u_{k}$ and $v_{l}$ from $\widetilde{\mathcal{M}}$ we see that

$$

Thus for $1 \leq k, l \leq n$ we have

= & \prod_{j=1}^{n}\left(\frac{1-u_{k} v_{j}}{1+u_{k} v_{j}} \frac{1-u_{j} v_{l}}{1+u_{j} v_{l}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{u_{k}+u_{i}}{u_{k}-u_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{v_{l}+v_{j}}{v_{l}-v_{j}}\right) \frac{1+u_{k} v_{l}}{1-u_{k} v_{l}},
\end{aligned}
$$

and so we obtain (4.4). We also have (4.5) in a similar way.

\end{array}\right) .

We prove that $\mathcal{K}(r, s)=K(r, s)$ for $r, s \geq 1$, where $\mathcal{K}$ is defined in Theorem 4.1 Assume that variables $u_{1}, \ldots, u_{n}, v_{1}, \ldots, v_{n}$ are $2 n$ distinct complex numbers in the unit open disc.

By the residue theorem we express $\mathcal{K}_{00}(r, s)$ as

\mathcal{K}_{00}(r, s)=\frac{1}{2} \frac{1}{(2 \pi \sqrt{-1})^{2}} \iint_{|z|>|w|>1} \frac{Q_{u}(z) Q_{u}(w)}{Q_{v}\left(z^{-1}\right) Q_{v}\left(w^{-1}\right)} \frac{z-w}{z+w} \frac{d z d w}{z^{r+1} w^{s+1}},
$$

where the contours in the integral are two circles around 0 near the unit circle such that $|z|>|w|>$ 1. But since the integral for the residue at $z=-w$ equals

we may let the contours $|z|=|w|=1$. Changing variables $z \rightarrow z^{-1}$ and $w \rightarrow w^{-1}$, we have
$\mathcal{K}_{00}(r, s)=\frac{1}{2} \frac{1}{(2 \pi \sqrt{-1})^{2}} \iint_{|z|=|w|=1} \prod_{i=1}^{n}\left(\frac{z+u_{i}}{z-u_{i}} \frac{1-v_{i} z}{1+v_{i} z} \frac{w+u_{i}}{w-u_{i}} \frac{1-v_{i} w}{1+v_{i} w}\right)\left(-\frac{z-w}{z+w}\right) z^{r-1} w^{s-1} d z d w$.
The integrand has simple poles at $z=u_{k}$ and $w=u_{l}$ for $k, l=1, \ldots, n$. Thus it follows from (4.7) and Proposition 4.6 that

$$
\begin{aligned}
\mathcal{K}_{00}(r, s) & =-2 \sum_{k, l=1}^{n} u_{k}^{r} u_{l}^{s} \prod_{j=1}^{n}\left(\frac{1-u_{k} v_{j}}{1+u_{k} v_{j}} \frac{1-u_{l} v_{j}}{1+u_{l} v_{j}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{u_{k}+u_{i}}{u_{k}-u_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{u_{l}+u_{j}}{u_{l}-u_{j}}\right) \frac{u_{k}-u_{l}}{u_{k}+u_{l}} \\
& =K_{00}(r, s) .
\end{aligned}
$$

Similarly, we have

$$
\mathcal{K}_{01}(r, s)=\frac{1}{2} \frac{1}{(2 \pi \sqrt{-1})^{2}} \iint \frac{Q_{u}(z) Q_{v}(w)}{Q_{v}\left(z^{-1}\right) Q_{u}\left(w^{-1}\right)} \frac{z w+1}{z w-1} \frac{d z d w}{z^{r+1} w^{s+1}}
$$

Here the contours are two circles such that $|z|<1,|w|<1$. Thus as like the calculation for $\mathcal{K}_{00}$ we have

$$
\begin{aligned}
\mathcal{K}_{01}(r, s) & =\frac{1}{2} \frac{1}{(2 \pi \sqrt{-1})^{2}} \iint \prod_{i=1}^{n}\left(\frac{z+u_{i}}{z-u_{i}} \frac{1-v_{i} z}{1+v_{i} z} \frac{w+v_{i}}{w-v_{i}} \frac{1-u_{i} w}{1+u_{i} w}\right) \frac{1+z w}{1-z w} z^{r-1} w^{s-1} d z d w \\
& =2 \sum_{k, l=1}^{n} u_{k}^{r} v_{l}^{s} \prod_{j=1}^{n}\left(\frac{1-u_{k} v_{j}}{1+u_{k} v_{j}} \frac{1-u_{j} v_{l}}{1+u_{j} v_{l}}\right) \prod_{\substack{1 \leq i \leq n, i \neq k}}\left(\frac{u_{k}+u_{i}}{u_{k}-u_{i}}\right) \prod_{\substack{1 \leq j \leq n, j \neq l}}\left(\frac{v_{l}+v_{j}}{v_{l}-v_{j}}\right) \frac{1+u_{k} v_{l}}{1-u_{k} v_{l}} \\
& =K_{01}(r, s) .
\end{aligned}
$$

We can prove $\mathcal{K}_{11}(r, s)=K_{11}(r, s)$ in a similar way. Hence we obtain $\mathcal{K}(r, s)=K(r, s)$. Though we have assumed that $u_{i}, v_{j}$ belong to the unit open disc, it is in fact unnecessary, see e.g. [BR. This completes the proof of Theorem 4.1.

## 5 Positivity of pfaffians

We study the sufficient condition that the pfaffian is non-negative.
Let $\mathbf{S H}_{2 m}$ be the set of all $2 m$ by $2 m$ skew-symmetric $\mathbb{C}$-matrices $B$ satisfying $B_{00}(r, s)=$ $\overline{B_{11}(r, s)}$ and $B_{01}(r, s)=-\overline{B_{10}(r, s)}$ for each block $B(r, s)(1 \leq r, s \leq m)$. Equivalently, $\mathbf{S H}_{2 m}$ is the set of all $2 m$ by $2 m$ skew-symmetric $\mathbb{C}$-matrices $B$ such that $-J_{m} B$ is hermitian, i.e., $B J_{m}=J_{m} \bar{B}$. Put

$$
\mathbf{S H}_{2 m}^{\geq 0}=\left\{B \in \mathbf{S H}_{2 m} ;-J_{m} B \text { is non-negative definite }\right\} .
$$

Similarly, let $\mathbf{S H}_{2 m}^{>0}$ be all elements in $\mathbf{S H}_{2 m}$ such that $-J_{m} B$ is positive definite.
Proposition 5.1. Let $B \in \mathbf{S H}_{2 m}^{\geq 0}$. Then $\operatorname{pf}(B[S])$ is non-negative for any subset $S \subset\{1, \ldots, m\}$. In particular, $\operatorname{pf}(B) \geq 0$.

Proof. Since submatrix $-J_{n} B[S](S \subset\{1, \ldots, m\}, \# S=n)$ of $-J_{m} B$ is a non-negative definite hermitian matrix by the assumption, the roots of the polynomial $\operatorname{det}\left(z I_{2 n}+J_{n} B[S]\right)$ are all nonnegative real numbers. Since $\operatorname{pf}\left(z J_{n}-B[S]\right)^{2}=\operatorname{det}\left(z I_{2 n}+J_{n} B[S]\right)$, the roots of $\operatorname{pf}\left(z J_{n}-B[S]\right)$ are also non-negative. Hence if we look as the constant term in the polynomial above we obtain that $\operatorname{pf}(B[S])$ is non-negative.

Now we state the relation between elements in $\mathbf{S H}_{2 m}^{\geq 0}$ and non-negative definite hermitian matrices. Let $\mathbf{H e r}_{m}$ be the set of all $m$ by $m$ hermitian matrices. Let $\mathbf{H e r}_{m}^{\geq 0} \subset \mathbf{H e r}_{m}$ be all non-negative definite hermitian matrices.

Proposition 5.2. Let $\omega: \mathfrak{g l}_{m}(\mathbb{C}) \rightarrow \mathfrak{o}_{2 m}(\mathbb{C})$ be an injective linear map defined in Section 2.4. Then we have $\omega\left(\mathbf{H e r}_{m}\right) \subset \mathbf{S H}_{2 m}$ and $\omega\left(\mathbf{H e r}_{m}^{\geq 0}\right) \subset \mathbf{S H}_{2 m}^{\geq 0}$.

Proof. For $A=\left(a_{r s}\right)_{1 \leq r, s \leq m} \in \operatorname{Her}_{m}$ the $(r, s)$-block of $\omega(A)$ is

$$
\omega(A)(r, s)=\left(\begin{array}{cc}
0 & a_{r s} \\
-\overline{a_{r s}} & 0
\end{array}\right)
$$

so that $\omega(A) \in \mathbf{S H}_{2 m}$. Let $\lambda$ be an eigenvalue of $-J_{m} \omega(A)$. Then since

$$
\begin{aligned}
0 & =\operatorname{det}\left(\lambda I_{2 m}+J_{m} \omega(A)\right)=\operatorname{pf}\left(\lambda J_{m}-\omega(A)\right)^{2}=\operatorname{det}\left(\begin{array}{cc}
O_{m} & \lambda I_{m}-A \\
-\lambda I_{m}+\bar{A} & O_{m}
\end{array}\right) \\
& =\operatorname{det}\left(\lambda I_{m}-A\right) \operatorname{det}\left(\lambda I_{m}-A^{*}\right)
\end{aligned}
$$

and $A$ and $A^{*}$ are non-negative definite, the eigenvalue $\lambda$ is non-negative.
Hence we may treat elements in $\mathbf{S H}_{2 m}$ as generalizations of hermitian matrices. Proposition 5.1 indicates us the following problem.

Problem 5.1. What is the range for $\alpha$ such that $\mathrm{pf}_{\alpha}(B) \geq 0$ whenever $B \in \mathbf{S H}_{2 m}^{\geq 0}$.
This problem is an extension of the problem for the positivity of $\alpha$-determinants of a nonnegative definite hermitian matrix (recall Conjecture 1.1). It relates to the existence of $\alpha$-pfaffian point processes defined in Section 3

Proposition 5.3. Let $L$ be a skew-symmetric matrix kernel on a countable set $\mathfrak{X}$ and $\alpha$ be a real number. Assume that $-J L$ is hermitian and non-negative definite and satisfies $\|\alpha L\|<1$. Then $-J K_{\alpha}$ is also hermitian and non-negative definite, where $K_{\alpha}=L(I+\alpha J L)^{-1}=(I+\alpha L J)^{-1} L$.

Proof. Put $\mathcal{L}=-J L$ and $\mathcal{K}_{\alpha}=-J K_{\alpha}$. It is easy to see that $\mathcal{K}_{\alpha}=\mathcal{L}(I-\alpha \mathcal{L})^{-1}=(I-\alpha \mathcal{L})^{-1} \mathcal{L}$ so that $\mathcal{K}_{\alpha}$ is hermitian if $\alpha$ is a real number. If $\lambda$ is an eigenvalue of $\mathcal{L}$, then $|\alpha \lambda|<1$ since $\|\alpha \mathcal{L}\|<1$. Therefore $\mathcal{K}_{\alpha}$ is non-negative definite.

For an $\alpha$, we suppose that $\operatorname{pf}_{\alpha}(L[X])$ is non-negative for all $X \in \mathfrak{P}(\mathfrak{X})$ whenever $-J L$ is hermitian and non-negative definite. Then, by the proposition above, the $\alpha$-pfaffian $\operatorname{pf}_{\alpha}\left(K_{\alpha}[X]\right)$ is also non-negative. Therefore the correlation function in Theorem 3.1 exists in this case.

We study Problem 5.1. It follows from Proposition 5.1] that $\mathrm{pf}_{-1}(B)=\operatorname{pf}(B) \geq 0$ and $\mathrm{pf}_{0}(B) \geq$ 0 for $B \in \mathbf{S H}_{2 m}^{\geq 0}$. More strongly, we obtain the following inequality.

Theorem 5.4. Let $B \in \mathbf{S H}_{2 m}^{>0}$. Then we have

$$
\operatorname{pf}_{0}(B)=\prod_{r=1}^{m} B_{01}(r, r) \geq \operatorname{pf}(B)
$$

The equality holds if and only if $B(r, s)=O_{2}$ for $r \neq s$.
If we let $B=\omega(A)$ for $A=\left(a_{i j}\right) \in \mathbf{H e r}_{m}$, then Theorem 5.4 provides the well-known formula

$$
\prod_{i=1}^{m} a_{i i} \geq \operatorname{det}(A)
$$

We need some preparations to prove the theorem. Put

$$
\mathcal{S}_{2 m, 2}=\left\{X=\left(\begin{array}{c}
X^{(1)} \\
\vdots \\
X^{(m)}
\end{array}\right) ; X^{(j)} \in \mathbf{S H}_{2}(1 \leq j \leq m)\right\}
$$

It is easy to see that $J_{m} X=\bar{X} J_{1}$ for $X \in \mathcal{S}_{2 m, 2}$. Let $O_{r, s}$ be the $r$ by $s$ zero matrix.
Lemma 5.5. For $B \in \mathbf{S H}_{2 m}^{>0}$ and $X \in \mathcal{S}_{2 m, 2} \backslash\left\{O_{2 m, 2}\right\}$, we have $\operatorname{pf}\left({ }^{t} X B X\right)>0$.
Proof. Since the matrix ${ }^{t} X B X$ is a 2 by 2 skew-symmetric matrix, it is easy to see that $\left.\operatorname{pf}^{t} X B X\right)=$ $\frac{1}{2} \operatorname{tr}\left(-J_{1}{ }^{t} X B X\right)$. Therefore it is sufficient to prove $\operatorname{tr}\left(-J_{1}{ }^{t} X B X\right)>0$. By the commutation relation $J_{m} X=\bar{X} J_{1}$, we have $\operatorname{tr}\left(-J_{1}{ }^{t} X B X\right)=\operatorname{tr}\left({ }^{t} \bar{X}\left(-J_{m} B\right) X\right)$. If we write $X=\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2} \in \mathbb{C}^{2 m}\right)$, we have $\operatorname{tr}\left({ }^{t} \bar{X}\left(-J_{m} B\right) X\right)={ }^{t} \overline{\boldsymbol{x}_{1}}\left(-J_{m} B\right) \boldsymbol{x}_{1}+{ }^{t} \overline{\boldsymbol{x}_{2}}\left(-J_{m} B\right) \boldsymbol{x}_{2}>0$ since $-J_{m} B$ is positive definite and $\boldsymbol{x}_{1} \neq \mathbf{0}$ or $\boldsymbol{x}_{2} \neq \mathbf{0}$.

Lemma 5.6. If $B \in \mathbf{S H}_{2 m}^{>0}$, then $\left(B^{*}\right)^{-1} \in \mathbf{S H}_{2 m}^{>0}$.
Proof. Let $B \in \mathbf{S H}_{2 m}^{>0}$. Since $-J_{m} B$ is positive definite and hermitian, the inverse $\left(-J_{m} B\right)^{-1}=$ $B^{-1} J_{m}=J_{m} \bar{B}^{-1}=-J_{m}\left(B^{*}\right)^{-1}$ is also. Therefore $\left(B^{*}\right)^{-1} \in \mathbf{S H}_{2 m}^{>0}$.

Proof of Theorem 5.4. Write $B$ in the form

$$
B=\left(\begin{array}{cc}
B_{m-1} & X \\
-{ }^{t} X & B(m, m)
\end{array}\right), \quad B_{m-1} \in \mathbf{S H}_{2 m-2}, \quad X=\left(\begin{array}{c}
B(1, m) \\
\vdots \\
B(m-1, m)
\end{array}\right) \in \mathcal{S}_{2 m-2,2}
$$

Then $B_{m-1} \in \mathbf{S H}_{2 m-2}^{>0}$. In fact, if $B \in \mathbf{S H}_{2 m}^{>0}$, then $-J_{m} B$ is positive definite. We immediately see that $-J_{m-1} B_{m-1}$ is also positive definite, hence $B_{m-1} \in \mathbf{S H}_{2 m-2}^{>0}$.

Put

$$
P=\left(\begin{array}{cc}
I_{2 m-2} & \left(B_{m-1}\right)^{-1} X \\
O_{2,2 m-2} & I_{2}
\end{array}\right)
$$

Then it is easy to see that

$$
B={ }^{t} P\left(\begin{array}{cc}
B_{m-1} & O_{2 m-2,2} \\
O_{2,2 m-2} & B(m, m)+{ }^{t} X\left(B_{m-1}\right)^{-1} X
\end{array}\right) P
$$

We have

$$
\begin{aligned}
\operatorname{pf}(B) & =\operatorname{pf}\left(B_{m-1}\right) \operatorname{pf}\left(B(m, m)+{ }^{t} X\left(B_{m-1}\right)^{-1} X\right) \operatorname{det}(P) \\
& =\operatorname{pf}\left(B_{m-1}\right)\left\{\operatorname{pf}(B(m, m))-\operatorname{pf}\left({ }^{t} X\left(-B_{m-1}\right)^{-1} X\right)\right\}
\end{aligned}
$$

Since $B_{m-1} \in \mathbf{S H}_{2 m-2}^{>0}$, it follows from Lemma 5.5 and Lemma 5.6 that $\left.\operatorname{pf}\left({ }^{t} \bar{X}\left(B_{m-1}^{*}\right)^{-1}\right) \bar{X}\right)>0$. Hence $\operatorname{pf}\left({ }^{t} X\left(-B_{m-1}\right)^{-1} X\right)>0$ for any $X \in \mathcal{S}_{2 m-2,2}$ if and only if $X \neq O_{2 m-2,2}$. Therefore we have

$$
\operatorname{pf}(B) \leq \operatorname{pf}\left(B_{m-1}\right) \operatorname{pf}(B(m, m))
$$

and the equality holds if and only if $X=O_{2 m-2,2}$. By the induction on $m$, we have the theorem.
