I. DILUTE SOLUTION ZERO SHEAR RATE VISCOSITY

Pan et al. [1] have previously determined the zero shear rate solution viscosity, η_0 , for dilute 25 kbp and T4 DNA solutions by least-square fitting the values of viscosity in the plateau region of very low shear rates, across a range of temperatures and concentrations below c^* , and extrapolating to zero shear rate. For details, see the supplementary information in Ref. [1]. The zero shear rate solution viscosity for λ -phage DNA has been determined here using the same procedure. Data for the all the three DNA samples, for various values of c/c^* and T, are displayed in Table I (with the data for the 25 kbp and T4 DNA solutions reproduced here from Ref. [1]).

Since the viscosity of the solvent for DNA solutions (containing 10 mM Tris, 1 mM EDTA, and 0.5 M NaCl), is almost identical to the viscosity of water at 20°C, the solvent viscosity at any other temperature was considered to be equal to that of the viscosity of water at that temperature. Water viscosities reported at https://www.thermexcel.com/english/tables/eau_atm.htm were used since they are tabulated at intervals of 1°C, for an extended range of temperatures. Note that where temperatures coincide, these values of viscosity are identical to those reported by Howe et al. [2]. Values of viscosity at intermediate temperatures were obtained by linear interpolation between the nearest two temperatures. The polymer contribution to steady state zero shear rate viscosity, $\eta_{p0} = \eta_0 - \eta_s$, for all the dilute and semidilute DNA solutions, can then be obtained.

The steady state solution shear viscosity, η , was measured by Hua and Wu [3] for solutions of four different molecular weights of polystyrene in dioctyl phthalate (denoted PS1 to PS4), for a range of temperatures. The zero shear rate viscosities η_0 at each temperature have been extracted (as in the case of DNA solutions) by leastsquare fitting the values of viscosity in the plateau region of very low shear rates, and extrapolating to zero shear rate. The procedure for determining the solvent viscosity η_s as a function of temperature for the dioctyl phthalate solutions has been described in Appendix A of the main paper. Using these values, the polymer contribution to steady state zero shear rate viscosity, $\eta_{p0} = \eta_0 - \eta_s$, has been obtained for all the polystyrene solutions, and is displayed in Table II for various values of c/c^* (calculated as described in Appendix A of the main paper) and T.

II. SEMIDILUTE SOLUTION ZERO SHEAR RATE VISCOSITY

The steady state shear viscosities η of the three DNA solutions were measured for a variety of concentrations in the semidilute regime and across a temperature range of 15–35°C. Examples of the dependence of measured solution shear viscosity on shear rate $\dot{\gamma}$ are displayed in Figs. 1 (a) and (b). The former displays the viscosity of 25 kbp DNA at a fixed concentration c = 0.441 mg/mland at various temperatures ranging from T = 15.8 to 44.6°C. Since c^* varies with temperature, this corresponds to values of c/c^* ranging from 2.12 to 8.65 (see Table III), all of which are in the semidilute regime. In Fig. 1 (b), the dependence of η on $\dot{\gamma}$ of T4 DNA at a fixed temperature $T = 25^{\circ}$ C, is shown at various concentrations, varying from 0.059 to 0.214 mg/ml. This corresponds to a c/c^* range of 2.98 to 10.82, as displayed in Table III. As in the case of dilute polymer solutions, the zero shear rate viscosity η_0 was determined by leastsquare fitting the values of viscosity in the plateau region of very low shear rates, at each temperature and concentration, and extrapolating to zero shear rate. Details are given in our earlier work [4]. Values obtained in this way for the three DNA samples, across the range of concentrations and temperatures, are displayed in Table III, reproduced here from Ref. [4].

The steady state shear viscosities η were measured for the polystyrene solutions PS1.1M and PS15.4M across a range of concentrations and temperatures. Values of $\eta_{p,0}$ for these solutions have been determined identically as in

the case of all the other solutions considered here, and are displayed in Table IV.

III. DEPENDENCE OF RELAXATION TIME λ_η ON TEMPERATURE

The temperature dependence of λ_{η} has been discussed in the main paper, with data indicating a linear relationship between λ_{η} and 1/T. Additional data displaying similar behaviour, at other concentrations, is shown in Figs. 2 and Figs. 3, for the three DNA and for the
