Cookie Policy

This Cookie Policy applies to any websites, branded pages on third party platforms (such as Facebook or YouTube), and applications accessed or used through such websites or third party platforms ("**CHECK CAP Websites**") which are operated by or on behalf of the CHECK CAP group of companies.

By consulting the CHECK CAP Websites, you are consenting to our use of cookies in accordance with this Cookie Policy. If you do not agree to our use of cookies in this way or/and if you set your browser settings accordingly to disable the cookies that we use, this may impact your user experience while on the CHECK CAP Websites.

The table below summarizes the different types of cookie we use on CHECK CAP Websites, together with their respective purpose and duration (i.e. how long each cookie will remain on your device).

What is a cookie?

Cookies are files or pieces of information that may be stored on your computer (or other internet enabled devices, such as a smartphone or tablet) when you visit our Websites. A cookie will usually contain the name of the website from which the cookie has come from, the "lifetime" of the cookie (i.e. how long it will remain on your device), and a value, which is usually a randomly generated unique number.

What do we use cookies for?

We use cookies to make the CHECK CAP Websites easier to use and to better tailor the CHECK CAP Websites and our products to your interests and needs. Cookies may also be used to help speed up your future activities and experience on our Websites. We also use cookies to compile anonymous, aggregated statistics that allow us to understand how people use our Websites and to help us improve their structure and content. We cannot identify you personally from this information.

What types of cookies do we use?

Four types of cookies gathered in two categories may be used on the CHECK CAP Websites - "session cookies" and "persistent cookies". Session cookies are temporary cookies that remain on your device until you leave the CHECK CAP Website. A persistent cookie remains on your device for much longer or until you manually delete it (how long the cookie remains on your device will depend on the duration or "lifetime" of the specific cookie and your browser settings).

Some of the pages you visit may also collect information using pixel tags (also called clear gifs) that may be shared with third parties which directly support our promotional activities and website development. For example, website usage information about visitors to CHECK CAP Websites may be shared with our third party advertising agency to better target Internet banner advertisements on our websites.

Do we use third party cookies?

We use a number of suppliers that may also set cookies on your device on our behalf when you visit the CHECK CAP Websites to allow them to deliver the services they are providing. When you visit the CHECK CAP Websites you may receive cookies from third party websites or domains. We endeavor to identify these cookies before they are used so that you can decide whether or not you wish to accept them. How can I control or delete cookies?

Most internet browsers are initially set up to automatically accept cookies. You can change the settings to block cookies or to alert you when cookies are being sent to your device. There are a number of ways to manage cookies. Please refer to your browser instructions or help screen to learn more about how to adjust or modify your browser settings.

If you disable the cookies that we use, this may impact your experience while on the CHECK CAP Websites, for example you may not be able to visit certain areas of a CHECK CAP Website or you may not receive personalised information when you visit a CHECK CAP Website.

If you use different devices to view and access the CHECK CAP Websites (e.g. your computer, smartphone, tablet, etc.) you will need to ensure that each browser on each device is adjusted to suit your cookie preferences. Click here for more information.*

Session / temporary - These cookies are deleted from your device after you leave our Website.

Permanent / persistent - These cookies are not deleted from your device after you leave the website. They remain on your device for a longer period of time.

First party cookies – These cookies are set by the website owner or service provider.

Third party cookies – These cookies are set by parties other than the website owner.

Clear Gifs (Web Beacons/Web Bugs)

We employ and our third party advertising partner employs a software technology called clear gifs (a.k.a. Web Beacons/Web Bugs), that help us better manage content on our site by informing us what content is effective. Clear gifs are tiny graphics with a unique identifier, similar in function to cookies, and are used to track the online movements of Web users. In contrast to cookies, which are stored on a user’s computer hard drive, clear gifs are embedded invisibly on Web pages and are about the size of the period at the end of this sentence. We do not tie the information gathered by clear gifs to our customers’ personal information.
