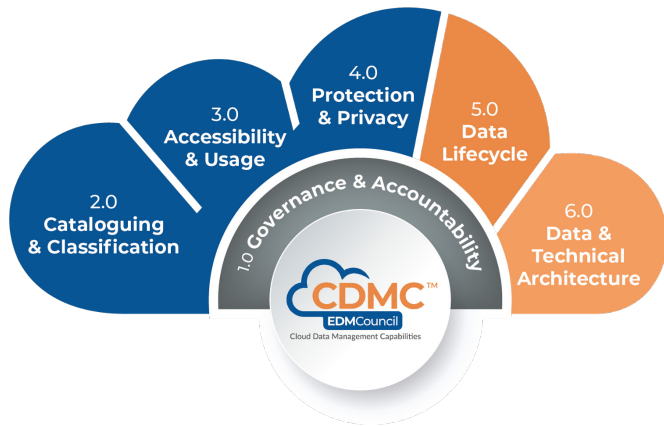


Business Challenge
