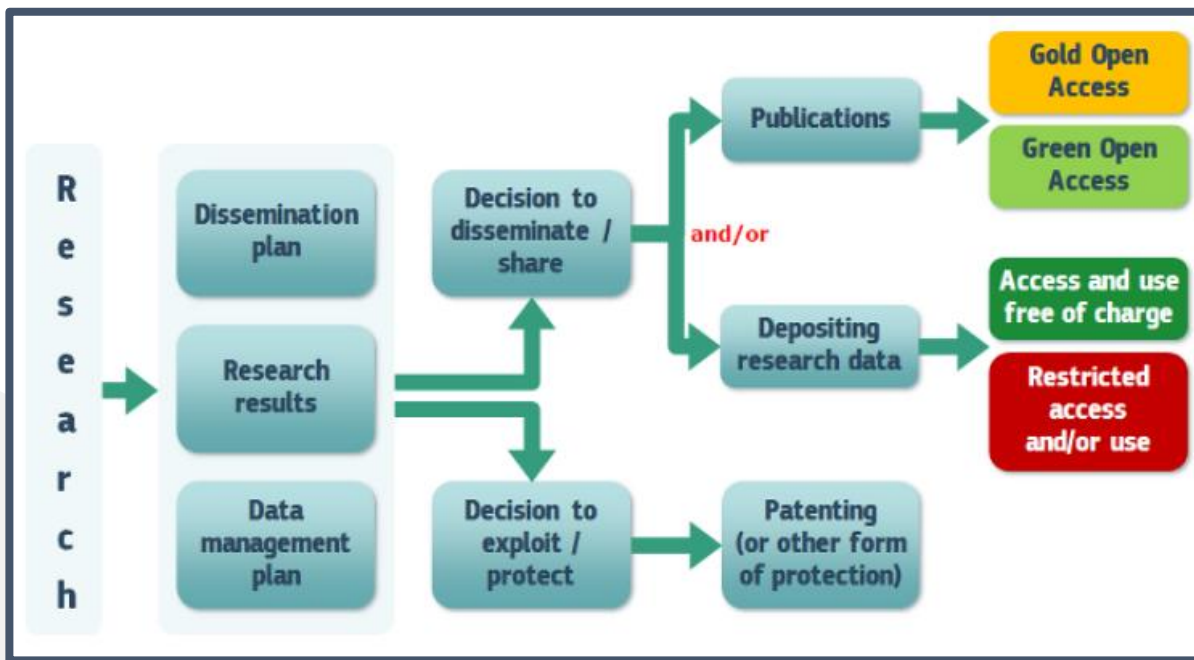

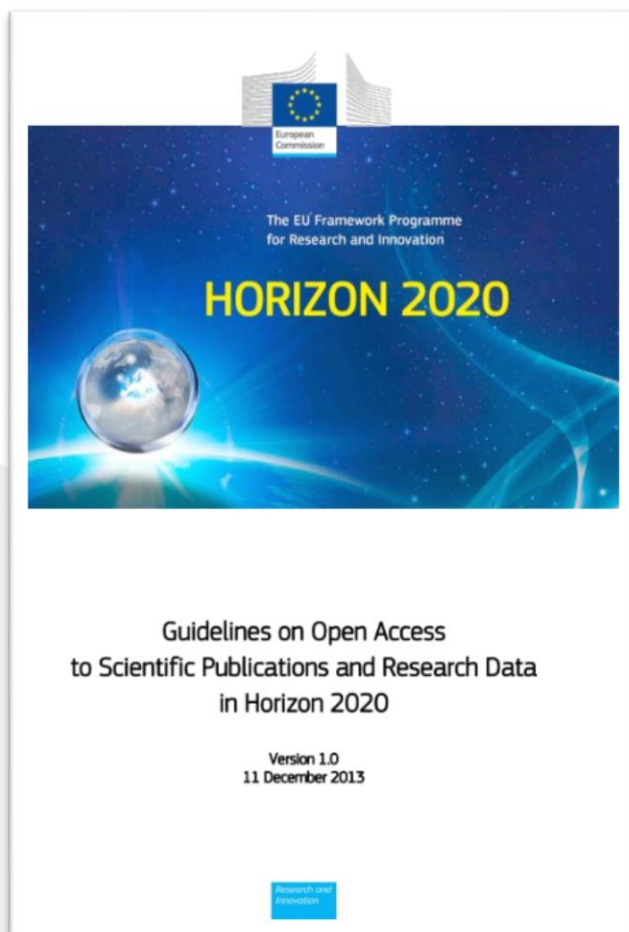

L'objectif de l'action est de couvrir tous les aspects FAIR dans Horizon 2020

FAIR DATA

Findable

- discoverable with metadata, identifiable and locatable by means of a standard identification mechanism

Accessible

- always available and obtainable

Interoperable

- both syntactically and semantically understandable, allowing data exchange and reuse between researchers, institutions, organisations or countries

Reusable

- sufficiently described and shared with the least restrictive licences, allowing the widest reuse possible and the least cumbersome integration with other data source

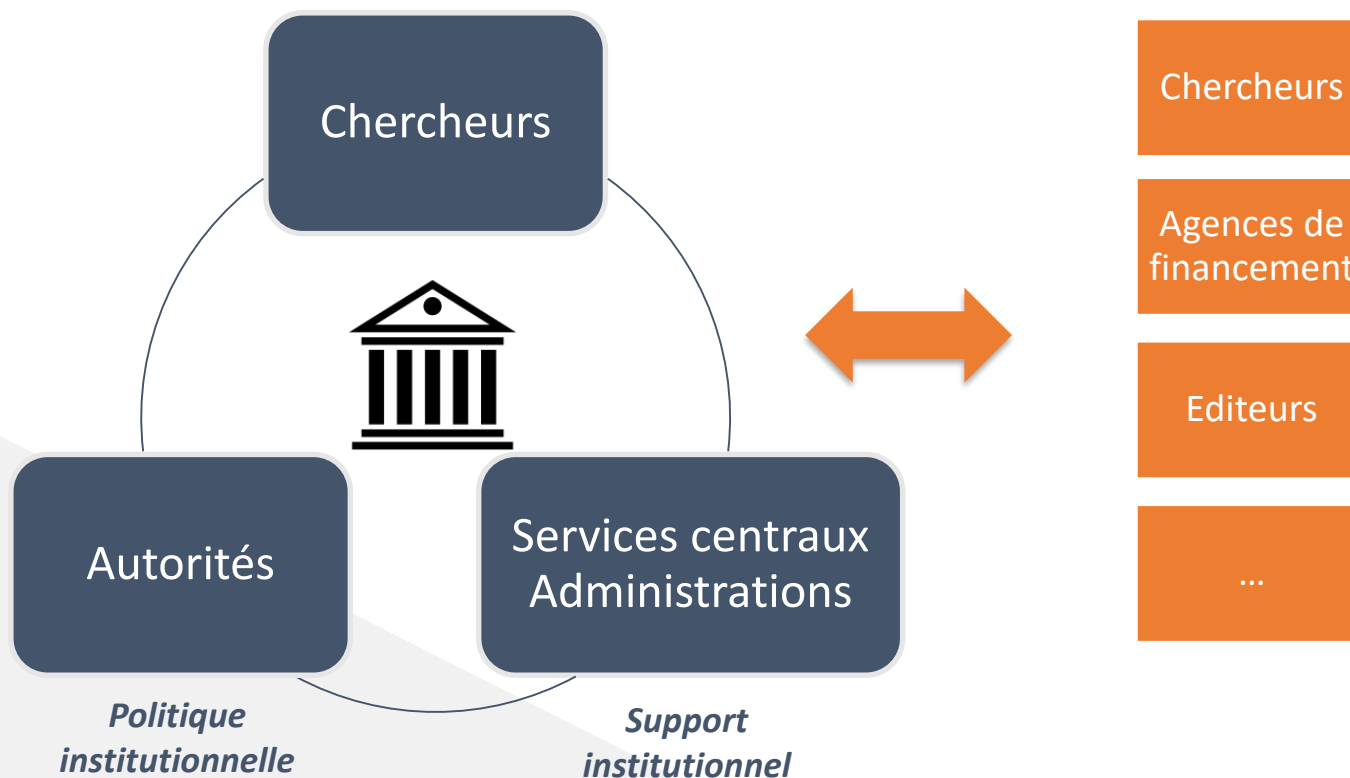
