The Hallbars Awards 2022

- August 18 - The Hallbars Awards « Best in the World » list is published August 16 this year. It is communicated first to all winners. The list is public from August 30 on www.hallbars.org
- October 21 - Alfred Nobel House, Karlskoga, Sweden : Hallbars 2022 new website launch. It is Alfred Nobel birthday. Most of the Best in the World Hallbars 2022 reports will be available for download from www.hallbars.org. Last year, we had over 6.000 downloads for the Hallbars Awards 2021 book.
- November 26 - Hallbars Awards Ceremony in Angkor, Cambodia. The Best in the World are all welcome and invited to the stage at the awards ceremony, one by one, followed by the gala dinner.

Sustainability reports are books. They give important updates on sustainability development. All the reports on the list are free to download. Over 90% are digital only. The rest are digital and paper.

There were over 1500 entries from 94 countries competing this year. There are only 294 entries selected for the Best in the World, from 51 countries.

All those selected on the list are Best in the Word winners, and have the right to a Hallbars Best in the World 2022 certificate.
