The North Carolina Education Lottery meeting was held on Tuesday, December 4, 2018, at 10:00 a.m. at the NCEL headquarters located at 2728 Capital Blvd, Raleigh, NC.

Chairman Tony Rand opened the meeting and greeted all Commissioners and meeting attendees.

Commissioners stood and recited pledge of allegiance.

Chairman Rand asked for a moment of silence in remembrance of President Bush.

Approval of September 11, 2018 Minutes

Chairman Rand presented the minutes from the September 11, 2018 Commission meeting for Commission approval. Commissioner Bengel made a motion to approve the minutes. Commissioner Crowder seconded. The minutes were unanimously approved.

Problem Gambling Helpline report

Smith Worth, Allison Drain, Dr. Tracey Poe presented statics and research findings to commissioners from the Problem Gambling Helpline.

• From July 2017-June 2018 there were a total of 6,133 intake/clinical calls. Of those calls 667 were intake/clinical calls.

Committee Reports

*Financial Matters Committee

Fiscal Year to Date Financial Reports for the four months of fiscal year 2019 ended October 31, 2018:

- In the Statement of Net Position, October 2018 ended with Total Assets of \$205 million which included \$111 million in cash and \$77.7 million in Annuity Award Investments.
- Accounts Receivable totaled \$11.6 million of which \$9.5 million represents net receipts from the gaming system to be collected via electronic funds transfer in November.
- Total liabilities of \$245 million included \$50 million in outstanding prize awards and vendor accounts payable, \$77.7 million in long term annuity prize awards payable and \$78 million due to the State of North Carolina for Education.
- Total Revenue for the four months of fiscal year 2019 totaled \$913 million. Ticket sales for the four (4) months of fiscal year 2019 totaled \$911.2 million, a 9.4% increase or \$78.2 million over the four (4) months of fiscal year 2018.
- Total gaming expenses including player prizes (\$579 m) retailer commissions and incentives (\$63.3 m) and Gaming System Services & Licenses (\$13.8 m) for the four (4) month of fiscal year 2019 totaled \$657 million or 71.9% of total revenue.
- Total administrative expenses, including salaries & benefits, advertising & marketing and operational overhead totaled \$20.6 million or 2.25% of total revenue.
- As a result of these numbers, the NCEL's administrative expenses, as identified in G.S. 18C-162-3.3 which limits expenditures to 8% of total revenue, were \$34.8 million or 3.8% of total revenue.
- Net Revenue earned for the Education Lottery Fund for the four (4) months of fiscal year 2019 totaled \$234.8 million or 25.7% of total revenue an increase of \$18.4 million or 8.5% over the four (4) months of fiscal year 2018. The total net revenue is running \$19.4 million or 9% ahead of our estimated budget target as approved by the commission in June.
- Fiscal 2019 year to date cash transfers to OSBM total \$211.9 million and include \$24.4 million in FY 2018 surplus funds dedicated toward Needs Based School Construction.
- This brings the total funds transferred to the State to \$6.1 billion since inception.
- Governor Cooper advised the NCEL in October that \$25 million in Lottery Reserve Funds would be utilized to assist in School Repair Hurricane Relief. As a result of this transfer, the balance in the Lottery Fund totals \$87.7 million. It is anticipated that the Lottery Reserve Fund will be reimbursed once the State receives the Hurricane Relief FEMA dollars from the Federal Government.

April Adams, Cherry Bekaert CPAs & Advisors, gave a brief overview of the external audit report completed in October of 2018.

Summary:

- NCEL was issued a clean opinion
- There were no adjusted journal entries
- There were no past adjusted journal entries
- GASB 75 was successfully implemented

- There were no internal control findings
- NCEL management cooperated fully with auditors

*Internal Operations Committee

Commissioner Shew gave a brief explanation of the discussion from the November committee meeting.

Mike Suggs, Director of Internal Audit, gave commissioners a brief overview of the committee meeting report and findings for the Recruitment, Salary Administration, Benefits, Payroll and Leave Audit and the Audit of Draw Games. He reviewed successes and also areas of improvement for both areas that were audited.

*Games & Marketing Committee

Commissioner Bengel gave commissioners a brief overview of what was discussed during the committee meeting on November 19th.

*Community Matters Committee

Commissioner Crowder gave a brief overview of the committee discussion from November's meeting.

Hayden Bauguess explained to commissioners his key focus will be educating the general assembly on the NCEL and its operations. The General Assembly was back in session on November 27, 2018.

The committee will create blurbs on positions of what the NCEL supports and why. The statements will be presented to the commission for approval.

Draw Auditing and Related Services RFP Report and Recommendation for Contract Award Tim Rink, Information Security Manager, provided a summary of the RFP process and recommendation report to the commission. The review committee consisted of team members Joe Cosgriff, George Alfonso and Tim Rink.

The RFP was issued on Sept. 5, 2018. The current contract expires at the end of the calendar year (2018). The review committee received one proposal from NCEL's current vendor Thomas and Gibbs. The Committee recommended the award of the draw auditing contract to Thomas Gibbs. A motion was made by Commissioner Tyson to accept the recommendation by the review

committee. The motion was seconded by Commissioner Picerno. The motion was unanimously passed.

Executive Report

Mark Michalko, Executive Director, asked Commissioners to review the HUB and the Contracts over \$90,000 reports provided in their packets. There were no questions or additional comments.

Closed session

A motion to go into closed session was made by Commissioner Tyson. Motion seconded by Commissioner Roth. By unanimous decision, the commission went into closed session for the annual audit discussion.

The Commission meeting reconvened in open session at 12:13pm.
