Community Partnerships

Building partnerships with industry, Southwest Tech helped secure \$53,000 in Workforce Advancement Training (WAT) grants in 2007. These grants resulted in increased plant safety, efficiency, and retention of regional jobs. Corporations that received these grants were Cummins Emissions Solutions, Nu-Pak, MSC, Mil-3, Woodward Printing Services, Cabelas, Swiss Valley Farms, Quantum Devices, Prairie Industries, and Cummins Filtration, Inc. Area high school technical education instructors look toward Southwest Tech to provide continuing education needed for teaching certification. Southwest Tech also provides training to stay current with industry trends in welding and other skilled disciplines.

Serving You Better

Responding to Wisconsin's workforce needs, Southwest Tech graduated 647 highly-skilled individuals in 2006-07. Annually, Southwest Tech serves approximately 12,000 students, or about

10 percent of the total population of southwest Wisconsin.



Over 370 sewing enthusiasts gathered at Southwest Tech for the annual Sewing & Quilting Expo. Southwest Tech serves a diverse group of learners throughout the year. Low to moderate income taxpayers look to Southwest Tech for tax preparation assistance through the Volunteer Income Tax Assistance (VITA) program. The College will again be offering free tax services for qualified individuals in 2008.

A recent study by the Wisconsin Taxpayers Alliance found that every \$1 invested in the Wisconsin Technical College System pays \$6 in additional state and local tax revenue.



Responding to Your Needs

Maximizing taxpayer dollars, Southwest Tech partnered with UW–Richland to enable students to transition to any UW baccalaureate program with credit for all completed general studies courses.

Addressing regional needs for healthcare specialists, Southwest Tech will be offering an associate degree in midwifery beginning January 2008. Over 3,200 emergency response volunteers received training at Southwest Tech during the year. Southwest Wisconsin relies upon the dedication and skills of our region's emergency volunteers. In turn, these individuals look to Southwest Tech for the necessary training to help them serve the public.

Southwest Tech's impact on regional healthcare is felt when you consider that 76 percent of the registered nurses and 94 percent of



Southwest Tech serves on the front line of changing people's lives. Research by the Wisconsin Council on Children and Families organization points out that there is a "tipping point" where education and training levels achieved bring a significant labor market payoff. This is typically at about a year of postsecondary schooling like a certificate, technical diploma, or an associate's degree.

Keeping current with technology, Southwest Tech students began learning specialized auto technology training through lab exercises utilizing a hybrid vehicle. Access to hybrid technology is also critical for emergency responders and fire fighters since special considerations must be made when responding to hybrid vehicle accidents. Southwest Tech agriculture students taught farm safety to



more than 400 fourth and fifth graders during Rural Safety Days.

College News

Southwest Tech *is* Here. Now. Look for the College's new slogan emphasizing accessible education pertinent to our region's changing needs.

Accessibility to education is a key factor for Southwest Tech to be able to fulfill its important mission. The college distributed student financial aid totaling nearly \$1,525,000 in grants and more than \$1,960,000 in loans. Additionally, through the generosity of donors, the Southwest Tech Foundation was able to award \$120,900 in scholarship support during 2006-07.

Southwest Tech celebrated 40 years of changing lives in 2007 by having four open houses during Technical Education Month that were attended by hundreds of area residents and potential new students.

Southwest Tech graduates enjoy great careers with excellent benefits. In 2007, the top ten paying full-time programs for entry level income averaged \$17.29 per hour.





Property Tax Impact

The tax rate for the 2007–08 budget was \$1.7237 per thousand dollars of equalized valuation, including \$1.3746 per thousand for operations and \$0.3491 per thousand for debt service. In other words, in 2007–08, the owner of a house with an equalized value of \$100,000 would have paid \$172.37 to support the educational programs and services at Southwest Tech.

Communities Communicate...Here. Now.

Between June 25 and October 18, 2007, Southwest Wisconsin Technical College (Southwest Tech) convened nine focus groups across the Southwest Tech District over the summer and into early fall to gain public insight on three specific issues that impact the college's future direction. In order, these focus groups were conducted on the Southwest Tech campus and in Richland Center, Cuba City, Darlington, Boscobel, Dodgeville, Prairie du Chien, Platteville, and Lancaster. Except for the focus group on the Southwest Tech campus,



participants came to the community events in response to direct mail or public announcements appearing in area newspapers

and on Southwest Tech's website. The campus focus group involved Southwest Tech faculty and staff only.

Three issues were discussed at each focus group and the responses of participants recorded. Participants were asked to comment on critical issues affecting their communities, the most critical public health and safety issues their communities were facing, and the most critical technical education or training opportunities for their communities. What follows is a compilation and distillation of all feedback provided, listed in descending order of importance.

<u>Question I</u>: List the CRITICAL ISSUES affecting your community.

- Meeting the need for high-paying jobs with benefits
- 2. Recruiting business and industry to the region and retaining it
- 3. Addressing the changing demographics and loss of young families
- Maintaining a quality pre-K through 12 system and making it a funding priority
- 5. Providing support for an aging population, including long-term health care.
- 6. Sustaining the agricultural infrastructure, including the family farm
- 7. Providing workforce development and training for incumbent workers



Question II: List the most critical PUBLIC HEALTH AND SAFETY issues facing your community.

- 1. Having insufficient local access to medical and dental services
- Providing support and training for volunteer emergency services (e.g., EMT and fire)
- 3. Meeting the need for affordable health care
- 4. Meeting the need for wellness education and programs
- 5. Increasing the level of services available to address AODA and mental health issues
- 6. Recruiting and retaining qualified health care workers to address a regional shortage
- 7. Addressing quality of life issues of senior citizens, including assisted living and care options, transportation, wellness, and personal enrichment activities
- 8. Increasing conservation and improving stewardship of natural resources
- 9. Addressing transportation safety issues (e.g., road quality and maintenance, speed, vehicle diversity on roads, and cell phone use among drivers)
- 10. Developing better emergency plans for area municipalities

<u>Question III</u>: List the TECHNICAL EDUCATION or TRAINING OPPORTUNITIES most critical to your community.

- 1. Training more nurses and allied health workers
- 2. Providing alternative options for delivery of learning
- 3. Increasing training in the trades (e.g., electrical, plumbing, and carpentry)
- 4. Providing more foreign language and cultural awareness training
- 5. Providing more customized training for business and industry
- 6. Providing more agriculture training
- 7. Providing more wellness and life skills training
- 8. Providing more training for fire and emergency medical services professionals
- Offering more youth apprenticeship opportunities and career exploration for K-12 as well as better integrating K-12 education with that provided in the technical college and area university
- Increasing educational opportunities in the areas of green technology, biofuels, and renewable energy

Dear Friends,

The Foundation Board works on behalf of our college community and is one of its champions in the communities that make up our district.

In March more than \$120,000 was distributed in scholarships—an increase of 11% from last year.



Student Residence Halls

Since 1997, the Southwest Wisconsin Technical College Foundation has provided on-campus student housing. Annually, the Foundation houses 60 students from various communities inside and outside the College's district. The Foundation has three types of apartment complexes: fourplex, duplex, and sixplex. These apartments were purchased or built with the assistance of Rural Development and several generous contributions. Currently, four of the six buildings are proudly represented by a sign indicating that a significant contribution was made by a donor. The Foundation is proud to have Rogers Hall, Koenecke Hall, Bemis Hall, and Design

Homes Hall. The primary focus for the on-campus student housing is safety, affordability, and convenience. Only 2 of the 16 technical colleges in Wisconsin have on-



campus student housing; Southwest Tech's is the only one owned and operated by the College's Foundation. The on-campus student housing is a center for group living, learning, and social and academic growth.

Managing Your Retirement Plan...Here. Now.

Like many Americans, you may have wisely saved for retirement Resource Development in a 401(k) plan. You likely did a good job of

accumulating your savings, but you may not have thought much about how to use those savings during retirement. Here are some important points to keep in mind about managing your 401(k) plan:

I. Tax Deferral: Your 401(k)

contributions were made with pre-tax dollars, so the money in this account has never been taxed. Because of this tax deferral, you will owe income taxes on the money you withdraw from your 401(k) account. Your plan is required by the IRS to withhold 20% of each withdrawal for income taxes.

2. Withdrawal Rules: Once you reach age 59 $\frac{1}{2}$, you may begin withdrawing funds from your 401(k) without penalty. Before that, you will pay a 10% early withdrawal penalty. You must begin your required minimum distributions by age 70 $\frac{1}{2}$. If you fail to withdraw the minimum amount each year after age 70 $\frac{1}{2}$, you face a stiff penalty. Make sure you consult with your financial advisor to plan your required minimum withdrawals.

- 3. Withdrawal Options: You have several options for managing your 401(k) once you retire. You may leave your funds in your 401(k) plan, if your plan allows it. You may transfer your 401(k) funds over into an Individual Retirement Account (IRA). A third option is to take lump sum cash distribution. Some plans also allow you to annuitize your savings. This means that you receive a fixed annuity payment for life. You need to carefully consider each of these options before making a decision.
- 4. Your Beneficiary Designations: Your spouse is generally your beneficiary while you are married. Update your beneficiaries if your situation changes. For example, some people accidentally leave 401(k) funds to a former spouse. Consider leaving part of your 401(k) to the American Air Museum in Britain or other charities, which are tax-exempt and will receive the full amount. Regularly review and update your beneficiaries to avoid unintended mistakes.
- **5.** Alternative Beneficiary Designations: Make sure to include alternative beneficiary designations. Many people will make a spouse the primary beneficiary, but will name a charity such as the Southwest Wisconsin Technical College Foundation for all or part of the retirement fund if their spouse passes away before the plan owner does.

6. 401(k) Gifts to Charity: If you plan to make any charitable bequests or gifts through your estate, it is often a good idea to make the gift specifically from your retirement plan since the charity will not pay any income tax on such a gift. The same gift given to a friend, family member, or directly to your estate, will require full income taxes to be paid. Retirement funds such as IRAs or 401(k) plans, US Savings Bonds, and a variety of other funds that the IRS considers to be earned prior to death but paid out after death may generate income taxes on your estate in addition to any estate taxes that might be due.

If you are considering any charitable gifts in your estate plans to the Southwest Wisconsin Technical College Foundation, Inc., or any other organization, you should consider including the wording below in your will or trust. Without this wording, even charitable gifts of these assets through your will or trust will mean that the IRS may well require additional income taxes that can easily be avoided.

"I instruct that all charitable gifts, bequests and devises should be made, to the extent possible, from assets that constitute Income in Respect of a Decedent (IRD), as that term is defined in the Internal Revenue Code."

If there are no charitable gifts, no harm is done. If there are, this could mean significant income tax savings. For more information, contact the Southwest Wisconsin Technical College Foundation.

Additionally, if you are age 70 $\frac{1}{2}$ or older, new legislation now allows you to make cash gifts totaling up to \$100,000 per year from your traditional or Roth IRA to qualified charities without incurring income tax on the withdrawal. This is good news for people who want to make a charitable gift during their lifetime from their retirement assets, but have been discouraged from doing so because of the income tax penalty. The provision is effective until tax year 2007, so you must act by December 31 to take full advantage. Efforts are being made to extend this tax provision.

7. Getting Assistance: As you can see, the rules governing 401(k) plans are somewhat complicated. For most people, it makes sense to obtain professional assistance from a gualified financial planner who can assist you in analyzing your options and making the best decision.



Revenue and Expenditures for Fiscal Year 2006-2007


