Said principal intends to file applications for the issuance of multi-year vehicle registration for those vehicles identified on the attached multi-year vehicle registration report which by reference hereto becomes a part hereof and, as a condition thereof, is required to provide Surety in an amount equal to, or greater than, the annual registration fees for all vehicles so registered.

WHEREAS, said Principal and Surety are held and firmly bound unto the State of Utah and to the Utah State Tax Commission in the penal sum of \_\_\_\_\_ dollars (\$\_\_\_\_\_), lawful money of the United States of America, being the amount equal to, or greater than, the total annual registration fees for all vehicles identified on the attached Utah multi-year vehicle registration report as incorporated herein. Said fees become due and payable prior to the 31st day of January, 20\_\_\_\_ and each successive 31st day of January every year thereafter for the tenure of this obligation.

NOW, THEREFORE, the conditions of this obligation are such that if the Principal named herein shall fail to pay the registration fees due on demand, said Surety shall immediately remit the total amount due to the Utah State Tax Commission, at which time this obligation shall become null and void, otherwise, this obligation shall remain in force and effective for a period not exceeding 8 years from the date hereof. It is further agreed by Principal and Surety that the principal amount of this obligation shall include any increase in annual registration fees which the Utah State Legislature shall hereafter enact into law.
