



***2024 Treaty Event:  
Strengthening the Multilateral Treaty Framework***

***Final Report***

***24<sup>th</sup> – 27<sup>th</sup> September 2024***

During the 2024 Treaty Event, twenty-five (25) **States** undertook a total of thirty-two (32) **treaty actions**. Two (2) participated at the level of **Head of State**, one (1) participated at the level of **Head of Government**, nineteen (19) participated at the **ministerial level**, one (1) participated at the **ambassadorial level** and two (2) participated at **other level**.

There were a total of one (1) acceptance, four (4) accessions, eleven (11) ratifications, and sixteen (16) signatures.
