Working experience

I have been a University teacher since 1990. First as an Adjunct, later as Assistant Professor and now as an Associate Professor. Main subject in both teaching and research is Applied Ethics. I have focused on ethics and disability studies, as well as on the role of the professional. Further I have concentrated on aspects of multiculturalism and ethics and on the role of the interpreter. Main fields of research are: Autonomy and minority groups, communication and interpretation, professionalism, ethics and disability studies, ethics of science, health care ethics and ethics and public health.

I have worked in diverse fields as a Medical Doctor. I acquired a licence to practice medicine in 1989. In the years 1998-2007 I worked part time as a Physician (Ass.Chief of Medicine) in the Dept. Of Lung diseases and Tuberculosis (Reykjavik Primary Health Care Centre). This is an ambulatory clinic for immigrants, where they are screened and treated for infectious diseases.

In the years 1997-98 I was Chief of the department of sign language interpretation at The Communication Centre for The Deaf and Hard of Hearing.
